### 500 fruit laden trucks among 3,000 vehicles stranded on Kashmir side of Sgr-Jmu highway

Qazigund, Sept 04: More than 3000 vehicles, including 500 fruit-laden trucks, are stranded on the Kashmir side of the Jammu-Srinagar National Highway, officials told the news agency-Kashmir News

Observer (KNO) on Thursday. They said that the landslides and roads caving in at many places along the 260-km highway have led to the blockade of this arterial road. "Efforts are on to make the highway motorable and restoration works are going on in full swing" an official told

He said, "Vehicles, including 500 fruit-laden trucks, are

stuck between Qazigund and Wanpoh. As soon as the highway reopens fruit-laden trucks will be cleared on priority."

Pertinently, the highway has not been fully restored for almost ten days after it suffered massive damages at Udhampur on August 26. "A 10-kilometre stretch of the highway between Sarmoli and Udhampur has been sinking, posing a major challenge for road maintenance agencies. Multiple stretches of the 250-kilometre highway have also been blocked due to debris, boulder slides, and sunken patches, particularly in the Ramban-Baniha sector," said an official.

Srinagar, Sept 04: Following the floods in several areas of Kashmir, Power Development Department (PDD) Wednesday said that it has restored electricity in 98 percent affected

Officials of the department further said that nearly a dozen DT transformers were washed away by the floods.

A top official of the department informed the news agency-Kashmir News Observer (KNO) that floods in several areas of Kashmir have caused

a huge damage to the power infrastructure.

"Out of 1292 power feeders in Kashmir valley 1230 are operational. Some feeders have been closed as a precautionary measure mostly in those areas where flood water has entered the residential areas," the official said.

The official further said that in district Anantnag six receiving stations were off. "Our team restored all the receiving stations in the district and they are all functional now."

### Curb sale of unsafe meat in **J&K: High Court directs IGPs**

Srinagar, Sept 04: The High Court of Jammu and Kashmir and Ladakh on Thursday issued a series of directions to curb the alleged sale of rotten and unsafe meat in the Union Territory.

A Division Bench of Chief Justice Arun Palli and Justice Rajnesh Oswal, according to the news agency-Kashmir News Observer (KNO) was hearing a Public Interest Litigation (PIL) concerning food safety when it ordered multiple departments and senior officials to file responses by September 10, the next date of hearing. The court

impleaded several top-ranking officers as party respondents, including the Commissioner Secretary Husbandry, Commissioner Secretary of Housing and Urban Development, Commissioner of Sales Tax, Inspector General of Police (IGP) Kashmir, and IGP Jammu.

The Commissioner, Food Safety, has also been tasked with ensuring that no unsafe meat enters or is sold within Jammu and Kashmir.

### CS assesses post-flood restoration across J&K

Urges for health awareness, school safety audits

JAMMU, September 04: Chief Secretary, Atal Dulloo Thursday chaired two separate meetings with Administrative Secretaries, which were also attended by the concerned Divisional Commissioners and Deputy Commissioners of the districts, to review the situation in flood-affected areas and assess the progress of ongoing restoration efforts.

Urges public to stay away of low-lying areas

SRINAGAR, SEPTEMBER 04: Following breaches in the embankments of the River Jhelum at Zonipora and Shalina in Budgam, which led to flooding in several low-lying areas of Srinagar and Budgam districts, Divisional Commissioner (Div Com) Kashmir, Anshul Garg, visited the affected regions to oversee relief and rescue operations.

Accompanied by IGP Kashmir and the Deputy Commissioners of Srinagar & Budgam, Div Com visited Lasjan and Nowgam to assess the situation and ensure that coordinated efforts were underway to safeguard residents.

Speaking on the occasion, Div Com said, "Early this morning, breaches occurred in the Jhelum embankments at Zonipora in Budgam, resulting in flooding of nearby areas. He further added that the weather conditions have started to improve, especially in South Kashmir, and most areas are currently experiencing clear skies.

### BRO Chief discusses post-flood scenario with CS

Assures swift restoration of road connectivity

JAMMU, SEPTEMBER 4: Lt Gen Raghu Srinivasan, PVSM, VSM, Director General Border Roads (DGBR) Thursday called on Chief Secretary, Atal Dulloo, at the Civil Secretariat here.

### SC concerned over deforestation in Himalayan region

New Delhi, Sep 04: The Supreme Court on Thursday raised concern over reports of timber logs floating in floodwaters across Himachal Pradesh, observing that illegal tree felling appeared rampant in the Himalayan region.

The Apex Court has issued notices not only to Himachal Pradesh and Uttarakhand but also to the Jammu and Kashmir government, underlining that fragile mountain ecosystems across the northern belt are under severe strain.

A bench of Chief Justice of India B.R. Gavai and Justice K. Vinod Chandran was hearing a Public Interest Litigation on environmental degradation in the Himalayas. The judges said that the scale of landslides and floods being reported in recent weeks had exposed the vulnerability in hilly

"In the flood, huge number of wooden logs were flowing around. Prima facie, it appears that illegal felling of trees has been going on up hills," the bench said.

"The inclusion of Jammu and Kashmir in the notice reflects the court's concern that the problem is not confined to Himachal alone. J&K has also witnessed a sharp increase in deforestation in recent years, particularly in areas of north Kashmir and the Pir Panjal range, where timber smuggling has repeatedly been flagged by local communities and activists," an environmentalist said, while welcoming the court's

move. With the Union Territory also facing recurring flash floods and mudslides, the court's

intervention could push for tighter scrutiny of forest protection measures, he said.

The bench directed notices to the Centre through the Ministries of Environment and Jal Shakti, the National Disaster Management Authority, the National Highways Authority of India, as well as the governments of Himachal Pradesh, Uttarakhand and Jammu and Kashmir. Chief Justice Gavai, addressing Solicitor General Tushar Mehta said that "It is a serious issue. In the media we have seen a large number of wooden logs flowing in Himachal, Uttarakhand. Illegal

### Zainpora residents recount flood horror

Srinagar, Sep 04: For the people of Zainpora, Pampore, last night will be remembered not only for the breach of the Jhelum bund but also for the heartbreak of watching their homes "slowly drowning before their eyes."

"We built this house brick by brick over many years. In just one night, it drowned before us," said Ghulam Hassan, pointing to the water-filled courtyard of what was once his two-storey home.

He said a lifetime of effort was

washed away in just a few hours. The bund breach came with little warning. Residents recalled hearing "three loud bangs" before water rushed in like a monster, flooding alleys and fields.

Some families ran barefoot into the darkness, carrying children and the elderly on their shoulders. Others climbed to rooftops and upper stories, watching helplessly as the river swallowed everything in its

"My dowry floated out like a toy. I could do nothing but watch," said Rafiqa, her hands trembling. "That chest had my daughter's future. How will I face her now?"

For many, the memories of 2014 resurfaced instantly. "Back then we thought it was once in a lifetime. But this... this feels worse," said Abdul Majid, a farmer. "In 2014 we lost crops. This time we saw our homes drown.

Meanwhile, the residents said what makes the trauma unbearable is not just the loss itself, but the helplessness of watching it unfold. On higher ground, women huddled in groups, recalling the night in broken sentences—(KNO)

### NHM, SKIMS issue public health advisory

Srinagar, Sep 04: As the flood-like situation in several parts of Jammu and Kashmir continues, the Health and Medical Education Department, in coordination with the Department of Community Medicine, SKIMS, and the Na-tional Health Mission (NHM), has issued a comprehensive Public Health Advisory.

The advisory highlights measures to prevent the outbreak of water-borne and vector-borne diseases, ensure food and water safety, and address mental health needs during this crisis.

Health experts have cautioned that contaminated water and food sources pose a grave risk of diseases such as diarrhoea, cholera, dysentery, typhoid, and hepatitis A and E.

They said the foremost priority should be access to safe water. "People should drink only boiled or chlorinated water (rolling boil for at least 5–10 minutes), sealed and packaged bottled water from reliable sources remains the safest option, if water appears mud-dy, it must be filtered through a clean cloth before boiling or treating and water should be stored in clean, covered containers, and hands or unclean objects should not be dipped into stored water, instead, a ladle or small vessel should be used."

Doctors have urged that only fresh-ly cooked, hot food should be consumed. "Raw vegetables, cut fruits, or uncovered food must be avoided. Any food that has come into con-tact with floodwater should be discarded immediately. Dry rations should be stored at elevated levels inside homes to protect them from

According to the advisory, people must maintain strict hand hygiene – wash hands with soap and clean water after defecation and before meals, and avoid wading in floodwaters. If unavoidable, use rubber boots and clean and dry skin folds properly to prevent fungal infections.

contamination."

In endemic areas, authorities have advised people to sleep under insecticide-treated bed nets, wear full-sleeved clothing in the eve-nings, use mosquito repellents and prevent stagnation of water in containers or surroundings. "People must avoid

walking in floodwaters, especially at night without adequate lighting, be alert for snakes seeking shelter in dry areas and in case of a snake bite, immediate medical care is essen-

tial," they said. Doctors have urged people to dispose of solid waste only at designated sites, avoid dumping garbage into water sources and use temporary latrines if regular sanitation facilities are submerged.

The advisory also highlighted the psychological toll of natural disasters.

Children and the elderly should be reassured and provided with emotional support, and for anxiety, depression, or trauma, people have been encouraged to seek help from men-tal health services.

The Tele MANAS helpline (14416) has been activated to provide mental health assistance.

The NHM advisory further urged residents to seek early medical help in case of fever, diarrhoea, vomiting, jaundice, skin infections, or injuries and continue routine immunisations and ensure patients with chronic illnesses like diabetes and hypertension continue their treatments without interruption.

For emergencies, the helpline numbers 104, 102, and 108 remain functional.

Neglecting these precautions could lead to a secondary health crisis of preventable diseases, medical experts warned—(KNO)

### Jammu Railway division faces massive losses

Jammu, Sep 04: Torrential rains and the flooding of rivers and streams across the Jammu division have inflicted heavy damage on the infrastructure and revenue streams of the Jammu Railway Division, leading to a near-complete halt in train operations and mounting financial losses. Rail services in the region were severely disrupted from August 26 to August 31, with both passenger and goods trains coming to a standstill in the wake of relentless weather.

Railway officials said that the Jammu Railway Division has already suffered losses exceeding Rs 25 crore due to the suspension of rail operations over the past seven days. Some revenue estimates place the figure even higher, at more than Rs 50 crore.

"If the suspension continues losses could soar past Rs 100 crore," said an official.

A senior railway official were free of charge. for resuming goods train services before September 30 look bleak, given the extent of track damage caused by floods and landslides. "It is not possible to operate goods trains till the end of September if the current situation persists," the official said. Indian Railways data indicates that the Jammu Railway Division earns an average of Rs 2.5 crore per day from passenger ticket sales, over Rs 1 crore from freight, and around Rs 3 lakh from parcel services amounting to a daily revenue of more than Rs 3.5 crore. The week-long suspension of train operations has therefore resulted in substantial financial setbacks, affecting everything from ticketing to freight and parcel revenues. Despite the disruptions, the Railways managed to run five special trains for stranded passengers during the crisis, including three that

of the suspension of goods trains has been particularly severe. On an average day, about 45 goods trains arrive in the Jammu Railway Division with 35 inbound and 10 outbound, carrying raw materials, cement, iron rods, government rations, fertilizers, and other essential commodities to Jammu and Kashmir from across the country. With 50 passenger trains, including premium services like the Vande Bharat Express, also affected, the logistical challenges have multiplied. The halt in goods train operations has led to acute shortages in essential supplies, with industries and traders bearing the brunt. The disruption comes at a

particularly critical time for the region's apple growers. This is peak apple season in Jammu and Kashmir, and apples destined for markets across India have been stranded. –(KNO)

### Shopkeepers shift belongings in dead of night

Srinagar, Sep 04: As the water levels rise above danger mark in Srinagar, the markets witnessed the sound of shop shutters in Lal chowk and adjacent areas with the owners along with the helpers moving the belongings to safer places in the dead of night.

The shopkeepers, haunted by memories of the devastating 2014 floods, rushed to shift their belongings, fearing that the rising waters of the river Jhelum could once again swallow their livelihoods. In Lal Chowk, Maisuma

and surrounding commercial areas, the shopkeepers were seen reopening their outlets, to shift the belongings.

Huzaif Ahmad Wani, a ready-made garment shop owner said that as soon as the water crossed the danger mark in river Jhelum, they along with the other

shopkeepers in Palladium Lane rushed to the shops again, not for business, but for the survival. 'We didn't want to face

losses. The situation was similar to 2014," Wani said, adding that "we lost everything that year. We can't afford to wait for a warning this time." Many of these traders

are still recovering from economic setbacks over the past decade—first the floods, then prolonged lockdowns, and now, yet another threat. Meanwhile, he said that

the majority of the shopkeepers have shifted their belongings to the safer places.

Pertinently, the heavy rainfall led to the rise in water levels in different rivers and streams, causing the flood-like situation in Jammu and Kashmir second time in the last two weeks—(KNO)

### Fearing breach, people spend night on river banks

Srinagar, Sep 04: As the Jhelum swelled with floodwaters on Wednesday-Thursday night, thousands of residents in different parts of Srinagar, Pulwama and areas of South Kashmir were seen standing along the river bunds, their anxious eyes fixed on the rising current.

"We couldn't sleep. Every hour, we came out to see if the water had crossed the bund," said Shabir

He said the sound of the river was like a roar in the dark. "No one had the courage to close their eyes."

"My children kept asking, 'Will our house also drown?' I had no answer," said Haleema, a mother of three from Soiteng.

The administration, however, has urged people not to venture close to the bunds, citing the dangers of sudden breach or spillage. "All necessary measures have

Ahmad, a resident of Lasjan said. been taken, and continuous monitoring is underway. People are requested to avoid unnecessary gatherings along riverbanks,' officials told KNO. For many, the sight of the swol-

len Jhelum brought back haunting memories of September 2014. "I still remember the night when water broke through like a monster. Watching the river rise now feels like reliving that nightmare," said Abdul Gani, a schoolteacher from Pampore. Meanwhile, officials said preventive evacuations are being carried out in vulnerable areas, with teams of SDRF, police, and other departments stationed near sensitive spots. Relief camps have also been kept ready.

Despite the reassurances, fear still looms in the air. "We trust the administration, but when the river swells like this, who can really sleep?" Shabir added, his gaze still fixed on the restless waters—(KNO)

### **Purification Of Soul: A Path To Divine Proximity**

In Islam, the purification of the soul stands as one of the core objectives of revelation and prophethood. The Quran emphatically states, "He has certainly succeeded who purifies it, and he has failed who instils it with corruption" (Surah Ash-Shams 91:9–10). This spiritual process transcends mere ritualism—it represents the essence of human purpose and the foundation of eternal success. The significance of tazkiyah manifests on multiple levels. Firstly, it

serves as the prerequisite for divine acceptance. The Ouran reveals that Allah only accepts from "the righteous" (5:27)—those whose hearts are free from shirk, hypocrisy, and moral disease. The Prophet (Peace Be Upon Him) reinforced this by comparing a pure heart to a clear mirror reflecting divine light, while a corrupted soul resembles a rusty vessel incapable of holding wisdom. Secondly, soul purification enables correct worship. Islam teaches that deeds

are judged by intentions (Bukhari), and intentions spring from the heart's condition. Rituals like prayer and fasting become transformative when performed with a heart free from arrogance, greed, and distraction. The Prophet (Peace Be Upon Him) warned that a morsel of doubtful food could invalidate forty days of worship, highlighting how physical and spiritual purity are intertwined. Thirdly, tazkiyah fosters societal harmony. A purified individual naturally

embodies justice, compassion, and honesty, becoming a source of benefit to others. The Quran describes such believers as those "who avoid major sins and indecencies, and when angered, they forgive" (42:37). This ethical transformation creates ripple effects, promoting trust, cooperation, and mercy within communities. Ultimately, soul purification is the bridge to divine love. Allah declares, "Indeed, Allah loves the repentant and loves those who purify themselves"

(2:222). Through constant repentance, dhikr (remembrance), and self-reflection, believers polish their hearts until they become worthy vessels of divine presence, achieving the state of "the peaceful soul" (89:27) that returns contentedly to its Creator. In a world increasingly dominated by materialism and anxiety, Islam's emphasis on inner purification offers a timeless antidote—a journey back to one's fitrah (primordial nature) and toward eternal fulfilment.

# 'India will have its own space station by 2035' India's Gaganyaan Mission set to transform the nation's space future

Gaganyaan is poised to be a pivotal moment for India's space aspirations, reaffirming its human spaceflight capabilities and advancing scientific knowledge with Earthbenefiting applications, added Dr Jitendra Singh, Union minister of state, science and technology

Q/ What will be the biggest outcome of Gaganyaan for India's space future?

India's ascent in the space sector has already begun and is recognised globally. We are no longer followers, we are equal partners in international collaborations. The Gaganyaan mission will mark another defining moment. It will not just reaffirm India's capabilities in human spaceflight but add to our scientific knowledge. Alongside experiments like those performed by astronaut Shubhanshu Shukla aboard the International Space Station on microgravity, agriculture and life sciences, the mission will provide insights with applications on earth. This will further establish India as a leader in space exploration while we continue to use space technology for infrastructure, development and ease of living.

Q/ With young astronauts like Shukla coming in, how crucial is the role of youth in shaping our human spaceflight journey?

Youth are indispensable to India's future in every sector, including space. More than 70 per cent of our population is below the age of 40, so naturally, they are the torchbearers of Viksit Bharat. In space, youth have an edge because of the physical and mental adaptability required. For instance, among the four astronauts trained for Gaganyaan, Shubhanshu was the youngest and that was an advantage. Space missions demand quick acclimatisation, something younger individuals can handle more efficiently.

Q/ Do you think Gaganyaan will open doors for scientists, engineers and women astronauts?



Absolutely. There is no distinction between men and women in space science. When Prime Minister Narendra Modi first announced Gaganyaan on August 15, 2018, he said Bharat ka ek beta ya beti would go to space. At present, the four selected astronauts happen to be men from the Air Force, largely because they possessed advanced training. But going forward, we will see astronauts from outside the forces, including women. Globally, women have been at the forefront of space exploration. Even in India, many ISRO projects have been led by women scientists, whether it was Chandrayaan, Aditya or others.

Q/ Will Gaganyaan pave the way for India to join international human spaceflight missions or set up its own space station?

India is scheduled to set up its own space station, named Bharatiya Antariksha Station, by 2035. The prime minister has also referred to the "Sudarshan suraksha chakra", where space technology will play a key role in national security. So, 2035 will be a landmark year.... Five years after that, India aims to send missions to the surface of the

moon with humans on board.

Q/ With India advancing in semiconductor and AI technologies, how is the government aligning the semiconductor mission with space-grade needs for projects like the Bharatiya Antariksha Station?

Semiconductors will have wide applications, including in space missions. Similarly, small modular reactors will be vital, not just in dense or inaccessible regions on earth but also for long-duration space expeditions. These technologies will be crucial for sustaining future projects like the space station.

Q/ What kind of experiments would you like to see Indian astronauts perform during missions to the moon or Mars?

In the recent mission, experiments were grouped into seven categories. Life sciences were especially important. For instance, the study of myogenesis-muscle wasting and regeneration in microgravity-has direct relevance for conditions like cancer, diabetes or even recovery from fractures on earth. Another set studied cognitive effects of prolonged screen exposure, which is highly relevant in

today's digital era. We also experimented with growing seedlings like fenugreek in microgravity, which could aid research in regenerative biology and genetic applications.

The key point is that space experiments are not limited to astronauts in orbit, they yield benefits for people on earth and advance the idea of 'Vishwaguru Bharat'.

O/ After SpaDeX, when will India begin monetising space docking and satellite servicing for global clients?

We have already started gaining experience with docking and undocking through SpaDeX. The upcoming Chandrayaan-4 mission, expected around 2028, will involve multiple modules performing complex docking and undocking manoeuvres. This will give us the expertise required for larger projects like the space station. Once space tourism becomes viable, docking technology will also be critical for passenger safety. Over time, monetisation will follow as India offers docking, servicing and tourism infrastructure for global clients.

Q/ India plans to launch 52 spy satellites in five years through public-private partnerships. How will national security be ensured in such collaborations?

Safeguards are already in place. We have created IN-SPACe (Indian National Space Promotion and Authorization Centre), which regulates public-private partnerships in space. It determines the scale and nature of collaborations, ensuring security considerations are fully addressed. At the same time, we have liberalised the sector by permitting foreign direct investment. This balance of regulation and openness allows innovation without compromising national interests.

Q/ A Rs 1,000-crore venture capital fund has been cleared, but space-tech funding fell last year. How will this fund support startups? Until a few years ago, startups in space were almost unheard of. Today, we have nearly 400, with some already becoming successful entrepreneurs. Startups are not just about launching rockets, they span areas like mapping, smart cities, agriculture, telemedicine and telecommunications.

This fund is meant to give them the financial support needed to scale up. Space has suddenly become a lucrative career option. Aerospace engineering, once a niche stream, is now among the most sought-after branches in IITs. That shift itself shows the rising opportunities in this sector.

Q/ India has targeted 8 per cent of the global space market by 2033. Beyond satellite launches, what technologies will help India compete with SpaceX and China?

Much of the focus is on rockets and launches, but nearly half of space applications are on earth. Space technology is integrated into agriculture, infrastructure and even warfare. Take the PM Gati Shakti scheme; it uses satellite imagery to save time, money and paperwork, directly contributing to economic growth. Similarly, space inputs help farmers decide the timing of sowing and cropping. These savings are as valuable as wealth generation. That is why we expect India's space economy, currently around \$8 billion, to grow fivefold in the next decade to \$40-45 billion, helping India climb global rankings.

Q/ Would you encourage civilians, not just Air Force pilots, to join India's astronaut pool?

Definitely. At the moment, Air Force pilots are better prepared because of their training in high-altitude jets, but this is just the beginning. In the future, our astronaut pool will expand to include civilians, women, biotechnologists, space physicians and even media professionals to record missions in real time. As the ecosystem grows, India will need a larger and more diverse pool of astronauts to meet its ambitious plans.

# The Income Tax Act, 2025: Reshaping Tax Framework A landmark overhaul streamlines legal language, enhances digital compliance, and aims to foster transparency, simplicity, and fairness in India's tax framework

Understanding The Income Tax Act, 2025 The passage of the New Income Tax Act, 2025 is a landmark development towards building a streamlined, simplified tax framework aimed at enhancing transparency, equity, and economic efficiency. Enacted by Parliament after intensive deliberation, the legislation reflects the Government of India's commitment to modernizing the tax architecture in alignment with global best practices and domestic aspirations. By simplifying tax slabs, rationalizing exemptions, and integrating digital compliance mechanisms, the Act seeks to reduce administrative burdens while

fostering a culture of voluntary compliance. To modernize and simplify India's outdated tax laws, the government announced a comprehensive review of the Income-tax Act, 1961. This led to the introduction of the Income-tax Bill, 2025, which was referred to a Select Committee of Parliament for detailed examination. After receiving extensive recommendations and suggestions from stakeholders, the government decided to withdraw the original Bill and introduce a revised version - The Income-Tax (No. 2) Bill, 2025. This updated Bill incorporated most of the committee's inputs along with improvements in legal clarity and drafting. It was passed by both Houses of Parliament in the monsoon session and now forms

the foundation of India's new tax framework From Complexity to Clarity: Rationale

Behind the New Income Tax Act The Income-tax Act, 1961 was introduced to replace the earlier 1922 legislation, based on recommendations from the Law Commission (1958) and the Direct Tax Administration **Enquiry Committee.** 

Here are the factors contributing to the complexity of India's Income-tax Act, 1961:

Extensive Amendments: The Act has been amended nearly 65 times with more than 4000 amendments over six decades through annual Finance Acts and 19 separate Taxation Laws

Amendment Bills. While these changes were

intended to keep the law relevant, they significantly increased its length and complexity.

Numerous Exemptions and Deductions: Over the years, the Act was repeatedly amended to include various exemptions and deductions to support socio-economic goals, such as encouraging savings, boosting exports, promoting balanced growth, and advancing social equity. These provisions included benefits for export income, investments in specific sectors or regions, and spending on rural development.

Reduced Tax Base and Increased Litigation: The numerous exemptions and incentives significantly reduced the tax base, which in turn contributed to increased litigation, higher administrative costs, and greater compliance burdens.

Traditional Legal Language: The Act was written in traditional legal language, characterized by long sentences, numerous provisos, and extensive explanations, making it difficult for the average taxpayer to understand.

Fragmented Structure and Outdated Provisions: The accumulation of amendments and additions led to a fragmented structure. This complexity was further compounded by the presence of outdated provisions that were no longer in use.

Reform Process for the New Tax Legislation In July 2024, the Finance Minister announced the Government's intent to overhaul the Income-tax Act, 1961, aiming to simplify its language, reduce disputes, and eliminate outdated provisions. To lead this effort, an internal Departmental Committee was constituted by Central Board of Direct Taxes (CBDT) for comprehensive review of the existing Act.

The Committee actively engaged with stakeholders - industry bodies, professional associations, and field officers of tax department - through consultations and brainstorming sessions. It also drew insights from international best practices, including tax reforms in the UK and Australia. The focus extended beyond language to include structural streamlining of the law itself.

To reframe Income Tax law framework, the simplification exercise followed three guiding

Textual and structural simplification for improved clarity and coherence.

No major tax policy changes to ensure continuity and certainty.

No modifications of tax rates, preserving predictability for taxpayers.

The drafting process of the Income Tax Act, 2025 was anchored in a threefold framework, each component playing a critical role in shaping the legislation's structure, intent, and implementation strategy:

Eliminating intricate language to enhance readability.

Removing redundant and repetitive provisions for better navigation.

Reorganizing provisions logically to facilitate ease of reference

It also seeks to minimize disputes through clearer definitions and harmonized assessment timelines. The reform reflects India's commitment to align with global best practices, improving ease of doing business, and fostering a trust-based tax environment. In essence, the

Simplified Framework of Income Tax Act, 2025 The new Income Tax Act has been significantly simplified, with fewer sections and chapters, making it easier to understand and implement. It includes structured schedules along with helpful tables and formulae to improve clarity. Overall, the language and layout have been streamlined for better accessibility and transparency. Importantly, the Act preserves existing taxation principles, ensuring continuity while enhancing usability. These reforms reflect the Government's commitment to improving the ease of doing business by establishing a tax framework that is both simple and transparent.

Key Features of Income Tax Act, 2025 The Income Tax Act, 2025 introduces a streamlined and modernized framework for direct taxation in India. It focuses on clarity, simplification, and improved compliance through structural and procedural reforms. The Act is designed to enhance transparency, reduce litigation, and align with technological developments. Introduction of 'Tax Year'

The Act simplifies tax terminology by replacing the previously used and often confusing terms 'Assessment Year' and 'Previous Year' with a single, unified concept called the 'Tax Year'. It has been defined as the twelve-month period of the financial year commencing on the 1st April. This change is aimed at improving clarity and making it easier for taxpayers to understand which financial period their income and tax filings relate to, thereby reducing ambiguity in compliance and interpretation.

Power to Frame Schemes The Act authorizes the Central Government to design new schemes aimed at improving efficiency, transparency, and accountability in tax administration (S. 532). This can be done by:

Eliminating the interface with the assessee or any other person to the extent technologically feasible, and

Optimising utilisation of the resources through economies of scale and functional

Simplified Compliance

Multiple provisions have been brought together for more clarity. For example, the provisions related to Tax Deducted at Source (TDS), which were earlier distributed across multiple sections, have now been streamlined and grouped under a single section - Section 393. This consolidation is intended to simplify the legal framework, making it easier for taxpayers, professionals, and authorities to locate and interpret TDS related rules without navigating through numerous scattered clauses.

Digital-First Enforcement

Virtual Digital Space has been defined as an environment, area, or realm that is constructed and experienced through computer technology. It includes email servers, cloud servers, social media accounts, online investment and trading accounts, and websites for storing details of asset ownership.

The scope of Virtual Digital Assets has been broadened to cover any asset that holds value in digital form and operates using cryptographic ledger systems such as cryptocurrencies or similar technologies.

### Rana calls for enhanced inter-departmental coordination

SEPTEMBER 04: Minister for Jal Shakti, Forest, Ecology & Environment and Tribal Affairs, Javed Ahmed Rana Thursday held a detailed discussion with Chief Secretary, Atal Dulloo to review inter-departmental coordination and monitoring mechanisms related to tribal welfare schemes and development projects in Jammu & Kashmir.

The Deputy Commissioner emphasized the urgent need to ensure supply of safe drinking water to all affected areas. He directed the Hydraulic Department to intensify chlorination, repair of damaged pipelines and water quality testing.

The Health Department was asked to strengthen surveillance of vulnerable areas, deploy medical teams, and stock essential medicines to deal with any potential outbreak. The Education Department was directed to spread awareness among students regarding hygiene and safe drinking practices, while the Social Welfare and Rural Development Departments were tasked with communitylevel sensitization campaigns.

DC Harvinder Singh informed the officers about the government guidelines for handling water-borne diseases and directed the XEN PHE to initiate a district-wide water testing drive. He also instructed them to start mobile campaign to spread awareness. The CMO was directed to mobilise ASHA workers for household visits to educate people about using safe and treated drinking water. The ACP was asked to create awareness in every Panchayat about the possible spread of water-borne diseases. The CEO Doda was directed

to organize hygiene awareness and WASH campaigns through students in schools, while Principals of Degree Colleges were instructed to conduct similar campaigns and practices in their institutions. The DC also directed ACP to take immediate action to start dewatering and mud clearance in the colleges and schools that were submerged due to the recent heavy rains. The District Social Welfare Officer was asked to organize WASH awareness campaigns in institutions under the department's supervision, while the District Programme Officer was directed to conduct awareness drives on hygiene and water safety in all Anganwadi Centres.

Nearly 9500 people evacuated

Earlier in the day, Divisional Commissioner Kashmir, Anshul Garg said that nearly 9,000 people have been evacuated from affected areas in Budgam as a precautionary measure following a breach in the Jhelum embankment.

He also urged people not to panic, assuring that the situation is under control as the water level is receding. "Some areas of Budgam were inundated, but as a precautionary measure, we carried out evacuations last night itself. Around 9,000 people were safely shifted to avoid any loss of life," Garg told reporters.

Similarly, the Police in Srinagar said they rescued and evacuated nearly 200 families from flood-affected areas of the district.

The district police have formed quick reaction teams to actively assist stranded citizens, a police spokesperson said.

"In response to the ongoing flood-like situation and heavy waterlogging in various parts of the city, Srinagar Police, in close coordination with SDRF and River Police, has activated a comprehensive evacuation and relocation plan to safeguard the lives and well-being of affected citizens." he said.

The spokesperson said teams from concerned police stations, along with River Police and SDRF units, have been deployed under the supervision of territorial officers across multiple vulnerable locations in the district.

"These teams have successfully evacuated and relocated nearly 200 families and individuals from the severely impacted areas, which included 24 families and houseboat dwellers who were rescued from Peerzo Island and Basant Bagh," he said.

According to the spokesperson, 39 families were evacuated from Bonyarbal, SR Gunj, Malik Sahib, Safakadal, Pamposh Colony, Noorbagh Guzarbal, and Madanyar Fateh Kadal. "Around 20 families and individuals were evacuated and relocated from Dedi Kadal, Habba Kadal, Zaindar Mohalla, Tankipora, Karan Nagar, Kursoo, Iqbal Colony, and Aramwari, while 20 families were rescued from Tailbal and vulnerable areas of Hazratbal," he added.

The spokesperson said 63 individuals were rescued and relocated from Panzinara-Mujgund, Bund Side, Maloora Bund, Khawajabagh Bund, Parimpora Bund, Bilal Colony Bund, Qamarwari, Rampora Chattabal Bund, Zenpora, and Tengan.

Landslides damage infrastructure

Moreover, a series of landslides disrupted life and infrastructure across parts of Jammu and Kashmir, damaging projects, transport links, and border fencing while prompting multiple rescue operations.

In Kishtwar district, a landslide struck temporary tin structures at the Ratle power project site in Dhrabshala. The sheds, which had been erected for use as washrooms, collapsed under the impact

Five people who were inside at the time were trapped. They were pulled out by the local administration and rescue teams. Three among them were shifted to the Government Medical College Hospital in Doda for treat-

ment, officials said. Union Minister of State in the Prime Minister's Office, Dr Jitendra Singh, said he had spoken with Deputy Commissioner Kishtwar Pankaj Sharma following the incident. He wrote on X that the timely response by the district administration had prevented further harm. Singh added that the rescued individuals were receiving medical attention and other required support.

#### Trapped in Kullu rains

"We are stuck here without our children and families. On one side there is water and on the other there are broken roads. Where can we go? He said they left their rented quarters after repeated landslides and now have no shelter. "People who had relatives here moved in with them, but we are left with nothing except Allah. If anything happens, who will even know?" another survivor, Nasir Ahmad Khan, said.

Other workers described how relentless rains have worsened the situation. "It has been nearly two months of continuous rain, and in the past 15 days it has become even more dangerous. Just yesterday, a big patch of land collapsed near us. We live in constant fear," they

Three radars are already operational in the region, and the new installations aim to provide more precise monitoring of extreme weather events.

Dr Singh directed the Ministry of Earth Sciences and IMD to issue dedicated, districtspecific forecasts for North Indian states including Jammu and Kashmir, Himachal Pradesh, Uttarakhand, and Punjab. He also instructed round-the-clock monitoring of weather patterns to ensure timely alerts and minimize loss of life and property.

The Minister commended the efforts of district administrations and civil society, noting that despite challenging weather conditions, officials have worked tirelessly to provide rations, medicines, and shelter to affected families.

Dr Singh, who is also the Lok Sabha MP from Udhampur, confirmed that additional consignments of ration kits, advanced water filters, and essential medicines are being dispatched from his own MP funds to supplement government relief measures. He also highlighted measures taken to prevent water-borne diseases by ensuring access to potable drinking water and medical kits.

Prime Minister Narendra Modi and Home Minister Amit Shah are closely monitoring the situation, with an inter-ministerial committee set to visit Kathua to assess damages and coordinate assistance, Dr Singh added.

In Doda, DC Harvinder Singh said that timely intervention prevented large-scale inundation in Bhaderwah by clearing blocked culverts and diverting water channels during peak floods.

In Udhampur, 38 relief camps accommodate over 2,000 people, while around 190 of the 380 damaged roads have been restored. In Kathua, 26 relief camps shelter 1,900 people, with restoration of roads and water supply schemes ongoing. Ramban and Kishtwar also saw swift response operations, including the rescue of five people trapped in a landslide at the Rattle Power Project.

Dr Singh assured that no effort would be spared in providing relief and rehabilitation across all affected districts, praising the role of local authorities and community volunteers as integral to a coordinated government response. (KNO)

Besides rescue efforts, police personnel plugged potential breaches at multiple embankments, preventing further escalation of the situation. Quick Response Teams (QRTs) and contingency squads have been activated across all police establishments to regulate traffic, provide frontline assistance, and reach stranded families in time.

Srinagar Police have also set up dedicated 24×7 helplines while publishing contact numbers of district officers to ensure immediate public access during emergencies.

Meanwhile, people have been urged to avoid unnecessary travel during heavy rains, report waterlogging, fallen trees, or electrical hazards, and cooperate fully with emergency services.

IGP Bidhuri, speaking to reporters here, said all departments, including the Police, Army, SDRF, NDRF and civil administration, are working in close coordination to ensure timely rescue and relief.

"Our forces are on the ground wherever water entered residential areas. Rescue teams remain on standby, and whenever a call is received, the nearest unit responds immediately," he said.

He added that police units have been directed to patrol along Jhelum's embankments to detect seepages or breaches. "If such situations arise, they are reported to flood control authorities, and plugging operations are initiated without delay," Bidhuri said.

The IGP urged people to remain calm, fol-

low advisories, and cooperate with authorities. "Weather is showing signs of improvement, and water levels are expected to recede. All agencies are united in this mission to safeguard lives and property," he added.

#### safeguard lives amid the heavy rains. (KNO) **J&K's SDRF struggles**

is the State Disaster Response Force (SDRF) the only specialised unit trained and equipped to deal with such emergencies. However, this crucial force today stands severely understaffed and under-resourced, raising serious concerns about its ability to respond effectively in times of crisis.

Currently, SDRF operates with just two battalions, one each stationed in Jammu and Srinagar; however, these battalions have witnessed no enhancement in sanctioned strength since their inception, despite growing challenges and in contrast, their mannower is far less than that of a typical armed battalion and pales in comparison to the capacity of an NDRF

"Adding to the crisis, most of the existing personnel are over the age of 50, with little to no fresh recruitment taking place over the vears. This ageing workforce is directly impacting ground-level service delivery, especially during high-intensity disasters like the recent cloudbursts that struck several parts of J&K," an official said. "In many districts, SDRF has only 20-25 personnel, a number too meagre to provide meaningful intervention when thousands of lives and properties are at risk.'

The Commandant General of Home Guards, Civil Defence & SDRF has repeatedly highlighted the urgent requirement to strengthen the force. Proposals to create fresh posts and expand the force have been submitted, but the files continue to languish in the corridors of bureaucracy, he said.

During a review meeting of the Home Department in December 2024, the Lieutenant Governor acknowledged the urgent need to augment SDRF's strength and called for immediate steps. However, the proposal remains stuck in the Finance Department, which continues to raise queries "in instalments", delaying the process indefi-

nitely, the official said. Experts and officials said J&K needs at least four more battalions of SDRF to cope with its disaster-prone geography. Yet, the government has so far not even approved the creation of around 300 posts, let alone larger structural reforms, a senior official said. "This administrative apathy has left the force crippled, with its numbers dwindling each year. If the current trend persists, the SDRF could be left with only a handful of men in the next decade."

Ironically, while the executive and armed wings of the J&K Police have seen the creation of thousands of posts over the past decade, the SDRF has not been granted a single new post in its executive cadre, the official said, adding that this neglect has left disaster preparedness in the UT hanging by a thread.

He said the SDRF has the potential to save countless lives and protect property during disasters, but instead of being strengthened, it is being allowed to wither away. The issue, he stressed, requires immediate intervention from the highest levels of government.

The onus, the official said, now lies on the Lieutenant Governor and Chief Minister to step in and ensure that the long-pending file for augmentation of SDRF strength is cleared without further delay. (KNO)

### SC asks replies from Centre, NDMA, flood-affected states

New Delhi, Sept 04: Considering the unprecedented landslides and flooding in states like Himachal Pradesh and Uttarakhand, the Supreme Court on Thursday sought the stand of the Centre, National Disaster Management Authority and others, and observed "illegal felling of trees led to the disasters".

Observing a balance ought to be struck between "development and environment", a bench of Chief Justice B R Gavai and Justice K Vinod Chandran also issued notices to the Union Ministry of Environment, Forest and Climate Change, the National Highway Authorities of India (NHAI), as well as the governments of Himachal Pradesh, Uttarakhand, Jammu and Kashmir and Punjab.

"We have seen unprecedented landslides and floods in Uttarakhand, Himachal Pradesh and Punjab. From the media reports, it is noticed that in the flood, a huge amount of wood was flowing along. Prima facie, it appears that there has been illegal felling of trees. Thus, issue notice to respondents," the CJI said.

The bench granted advocates Akash Vashishtha and Shubham Upadhyay, appearing for petitioner Anamika Rana, to serve



petition at the central agency. The CJI during the hearing asked Solicitor General Tushar Mehta, who was present in the court in connection with another case, to take note of the grim situation and ensure

remedial steps. "Please take note of this. It appears to be a serious issue. A large number of wooden logs are seen to be falling around... it shows illegal felling of trees. We have seen pictures of Punjab. Entire fields and crops are inundated...Development has to be balanced with mitigating measures," the CII said.

governments, in spite of having dedicated Disaster Authorities, have no plan in place to prevent or mitigate the losses due to these disasters whose frequency has increased alarmingly of late," it said.

It said the ministries of Environment, Forests and Climate Change and Jal Shakti have failed in their duty to protect the "pristine Ecology and the Rivers of the Himalayan region from degradation".

"The Petition is being filed bona fide in the larger public interest to ensure and to uphold the Constitutional Right to Life (Article 21) and access to justice of the residents of these Himalayan States," it said.

Seeking appropriate directions, the plea sought to constitute an independent expert committee to carry out geological, geo-technical or environmental/ecological investigation into all road/highway projects where landslides have occurred and assess the causes of floods and flash floods in the rivers, rivulets, streams, water courses, channels in the Himalayan states, particularly Himachal Pradesh, Uttarakhand besides Jammu

and Kashmir. The plea also sought a direction to the Centre and others to ensure emergency relief, rescue, safety, and first-aid for affected citizens

### **GST** cut on drugs, medical devices to provide relief to patients: Industry players

New Delhi, Sept 04: The government's move to cut GST on medicines and medical devices while exempting lifesaving drugs from the levy is a bold step that will bring direct relief to patients and families while significantly reducing financial strain on them, pharmaceuticals and healthcare industry players said on Thursday.

The bold reforms will improve accessibility of medicines, ensure accessibility to quality healthcare and contribute positively to the government's vision of affordable healthcare for all, they said.

The government's decision to exempt life-saving and cancer medicines from GST is a step that will bring direct relief to patients and their families, Indian Pharmaceutical Alliance Secretary General Sudarshan Jain said. "Equally, the reduction in GST on a wide range of medicines from 12 per cent to 5 per cent will help ease the overall treatment burden and make essential therapies more affordable,"

Similarly, Organisation of Pharmaceutical Producers of India (OPPI) Director General Anil Matai said. "The decision to reduce GST on lifesaving medicines -- bringing 33 essential drugs from 12 per cent to nil and three critical drugs for cancer, rare diseases, and other severe chronic conditions from 5 per cent to nil -- is both historic



and compassionate. This bold step will significantly reduce the financial strain on patients and families." Equally impactful are the reductions in GST on all other medicines to 5 per cent and on a wide range of medical apparatus, diagnostic kits, surgical devices, and healthcare supplies, he added.

"This move will make healthcare more affordable and accessible at every level, from hospitals to households. By realigning the GST structure, the government has sent out a strong signal of prioritising patient well-being and strengthening India's journey towards universal health coverage," Matai said. The reduction in GST would be passed down to patients, helping reduce the cost of treatment. while also improving access and creating greater demand for quality healthcare, he added.

NATHEALTH President and

Executive Chairperson Metropolis Healthcare Ltd Ameera Shah said, "By easing costs and improving affordability, the measure will enhance access to quality healthcare services, support early disease detection, and bring greater consistency by standardising GST rates across preventive, curative and rehabilitative care." Apollo Health Co Ltd Executive Chairperson Shobana Kamineni said, "Zero GST on health and life insurance is a masterstroke, making protection a right, not a privilege.

Stating that reductions in medicines and supplies bring affordable care to every household, she said, 'By putting empathy and the middle class at the centre, the government has enabled millions to access healthcare with dignity."

Similarly, Poly Medicure Ltd Managing Director Himanshu Baid welcomed the landmark decision to reduce GST from 12 per cent to 5 per cent on a wide range of medical products, including diagnostic kits, reagents, surgical apparatus and other critical medtech products.

### Centre seeks transfer of pleas against online gaming law from HCs to SC

New Delhi, Sept 04: The Centre has sought the transfer of pleas challenging the Promotion and Regulation of Online Gaming Act, 2025 from three high courts to the Supreme Court to avoid conflicting verdicts.
A bench comprising Chief

Justice B R Gavai and Justice K Vinod Chandran has agreed to list for hearing next week the plea of Ministry of Electronics and Information Technology (MeitY) for transfer of three pending cases from the high courts of Karnataka, Delhi and Madhya Pradesh to the apex

"(The) Union has filed a transfer plea... The Online Gaming Regulation Act has been challenged before three high courts. If it can be listed on Monday since it's listed for interim orders before the Karnataka High Court," the Centre's counsel said.



Besides seeking the transfer of pleas, the Centre sought a stay of all proceedings in the writ petitions" in different high courts till the transfer petition was disposed of.

Due to multiple litigat pending before various High Courts involving same or substantially similar question of law and challenging the vires of the same Impugned Act, it is imperative that the same is transferred to this court or any High Court to avoid any divergence of opinions or

multiplicity of proceedings, the plea said.

It said after the law got President's assent, multiple petitions were filed in the high courts challenging the validity of the Act.

The impugned Act ha enacted with the objective of promoting and strategically regulating the online gaming sector, while safeguarding citizens from the adverse effects of online money games, and simultaneously encouraging and regulating other forms of online gaming, it said.

### In 2021, over a billion people were affected by mental health conditions: WHO

New Delhi, Sept 04: More than a billion people around the world around one in every seven - were living with mental health conditions in 2021, with anxiety and depressive disorders accounting for over two-thirds of all cases, the World Health Organisation (WHO) said.

The disorders exact immense human and economic tolls, the United Nations' health agency added. Suicide is a major cause of death among youths, accounting for over one in 100 deaths across the globe and about 20 attempts made for each death, the WHO said in reports titled 'World Mental Health Today' and 'Mental Health Atlas 2024'.

Authors of the reports also said that schizophrenia and bipolar disorder affecting about 1 in 200 and 1 in 150 adults, respectively – are a primary concern.

"Schizophrenia in its acute state is modelled to be the most impairing of all health conditions" and is the "costliest mental disorder per person to society," they wrote. The condition is marked by hallucinations and a disorganised way of



thinking

The findings are based on the analysis of databases 'Global Health Estimates 2021' - managed by the WHO – and 'Global Burden of Diseases, Injuries and Risk Factors Study 2021', which is co-ordinated by the Institute of Health Metrics and Evaluation at the University of Washington.

The U.N. health agency said the estimates are the latest on the prevalence and burden of mental disorders and also reveal country-wise information on gaps in mental health care - the first such estimates since the COVID-19 pandemic that broke out

The reports highlight that a sustained investment in mental health and care is urgently needed, with a scale-up in services to protect and promote people's mental health, it said. "Transforming mental

health services is one of the most pressing public health challenges," WHO Director-General Dr. Tedros Adhanom Ghebreyesus said. "Investing in mental health means investing in people, communities, and economies – an investment no country can afford to neglect. Every government and every leader have a responsibility to act with urgency and to ensure that mental health care is treated not as a privilege, but as

a basic right for all," he said. The authors also drew attention to the "staggering" and "enormous" economic impacts of mental health disorders, with losses in productivity and indirect costs to society far outstripping health care costs. Depression and anxiety, whilst being less

costly per person, collectively contribute majorly to overall national costs because of a wider, more common prevalence yearly losses in the world's productivity linked to the conditions are estimated at \$one trillion, the team Since 2020, countries

have made significant strides in strengthening mental health policies and planning. However, the progress has not translated into a legal reform, the authors said.

Typically, govern-ments around the world were found to spend only 2% of total health budgets on mental health "unchanged since 2017". Disparities in expenditure ranged from \$65 per person in high-income countries to \$0.04 in low-income countries.



# India-Singapore relations go far beyond diplomacy: PM Modi

New Delhi, Sept 04: India and Singapore on Thursday unveiled a roadmap to expand their comprehensive strategic partnership with Prime Minister Narendra Modi and his Singaporean counterpart Lawrence Wong underlining the need to bolster the ties to navigate the current geopolitical turbulence in the world.

Modi and Wong, who arrived in New Delhi on Tuesday, held wide-ranging talks covering the entire expanse of the bilateral ties.

India-Singapore relations go far beyond diplomacy, Modi said in Wong's presence. The prime minister said both sides decided that cooperation between the two countries in areas of artificial intelligence, quantum and other digital technologies will be enhanced.

"We share common concerns regarding terrorism," Modi said in his statement to the media.

"We believe that fighting against terrorism with unity is the duty of all countries which believe in humanity," he added.

Modi said the partnership between the two countries is rooted in shared



values and it is guided by mutual interests and a common vision for peace and prosperity.

On his part, Wong said in a world marked by uncertainty and turbulence, the partnership between India and Singapore becomes even more important. A number of pacts were signed between the two sides following the Modi-Wong talks,

An agreement on digital asset innovation between the Reserve Bank of India and the Monetary Authority of Singapore is one of them.

### Afghanistan earthquake death toll rises, survivors face aid crunch

Kabul/Mazar Dara, Sept 04: Rescue workers battled to pull bodies from the rubble of homes razed in Afghanistan's earthquakes this week, as time runs out for survivors, who face a bleak future with global aid agencies warning of dwindling funds for food, shelter and medicines.

Search operations ran late into Wednesday in the quake-hit mountainous eastern areas as more bodies were dug out, the Taliban administration said, adding that the death toll had crossed 1,457 but exact numbers had yet to be compiled.

"Everything we had has been destroyed," said Aalem Jan, a survivor in the worst affected province of Kunar.

"Our house collapsed, and all our belongings and possessions were lost. The only remaining things are these clothes on our backs."

The first earthquake of magnitude 6, one of Afghanistan's deadliest in recent years, unleashed widespread damage and destruction in the provinces of Kunar and Nangarhar on Sunday, when it struck at a shallow depth of 10 km (6 miles).

A second quake of magnitude 5.5 on Tuesday caused panic and interrupted rescue efforts as it sent rocks sliding down mountains and cut off roads to villages in remote areas.

About 3,400 more have been injured and more than 6,700 homes have been destroyed, authorities have said. The United Nations has warned the toll could rise with people still trapped under rubble as time runs out for survivors.

# IPL tickets to become more expensive with govt's 40% GST decision

New Delhi, Sept 04: Indian cricket fans, who love turning up for IPL matches across the country, will have to shell out more for tickets next season with government raising the Goods and Services Tax (GST) on admission to these games from 28 per cent to 40 per cent.

According to a Ministry of Finance release issued late on Wednesday, "Admission to casinos, race clubs, any place having casinos or race clubs or sporting events like IPL will have GST of 40 percent with ITC (Input Tax Credit).

An IPL ticket with a base price
Rs 500 before GST till last season would ultimately cost Rs
640 with GST levied at 28 per
cent. However, during the 2026
edition, the same ticket will now
cost Rs 700 after imposition of 40

per cent GST by the government. This is because IPL tickets have been classified in the 'Luxury Goods' category.

However, India's international games have been classified under other sporting events and would invite a lesser GST of 18 per cent on tickets priced above Rs 500.

Any tickets priced below Rs 500 will be exempted from GST.

The rule states: "Admission to other sporting events including recognised sporting events where the ticket price is not more than '500 continues to be exempt, and if the ticket price is more than Rs. 500, it continues to be taxed at the standard rate of 18 per cent."

As far as IPL is concerned, the ticketing is not controlled by the BCCI and every franchise decides the rates at their respective home grounds.
