# Kashmir's Rs 1,623 Crore Flood Plan Hits Roadblock

Management plan for Jhelum faces delays over financial, technical disputes

### **KNO Special Correspondent**

Srinagar, Sept 08: Despite recurrent flood threats in Kashmir, two critical components of the Rs 1623 crore comprehensive flood management plan for Jhelum River remain untouched. The delay in executing work on these components arises from additional financial implications triggered by alterations recommended by the Central Water Commission (CWC), following conflicting assessments in two separate studies regarding their efficacy. As a result, the ambitious project-meant to safeguard lives and infrastructure from future flood disasters-finds itself mired in financial and technical gridlock.

Details available with the news agency—Kashmir News Observer (KNO) reveal that the Union Ministry of Water Resources, River



Development and Ganga Rejuvenation approved Phase-II (Part A) of the flood management project for the Jhelum River and its tributaries in March 2022.

The Union Ministry recommended the project for inclusion under the Flood Management Project (FMP) component of the Flood Management Project & Border Areas Programme (FMPBAP) for the period 2021–26, with percent central funding and 10 percent Union Territory funding.
After Union Government's

approval, the administrative council gave its go-ahead to the project in July 2022.

# AIIMS Awantipora site chosen on political grounds, not feasibility: CM

'Location was not backed by thorough ground assessment'

Pulwama, Sept 08: Chief Minister Omar Abdullah on Monday said that the site for setting up the All India Institute of Medical Sciences (AIIMS) at Awantipora was selected on political considerations rather than on the basis of feasibility.

Speaking to reporters during his visit to the under-construction campus at Awantipora, CM Omar Abdullah, as per the news agency—Kashmir News Observer (KNO), said that the decision to establish AIIMS at the current location was not backed by thorough ground assessment.

"Unfortunately, the site was chosen on the basis of poli-tics, and it was never checked whether this location was actually feasible or not," Omar said.

He pointed out that soon after the project was finalized, the army raised security-related concerns, which delayed the process by almost a year. This, he said, led to a change in the Detailed Project Report (DPR) and subsequently caused cost escalation. "The project lost



valuable time in the initial stage due to these complications," Omar added.

Despite these challenges, the Chief Minister said that work was later started and it picked up pace over the last one year. "According to AIIMS authorities, the institute will be fully functional by the end of 2026, while the OPD services and MBBS classes are expected to begin by April 2026," he said

During his visit, Abdullah also reviewed the ongoing construction and available facilities at the site, expressing hope that the project would be completed within the revised timelines.

# J&K receives excess rainfall of 41% in 3 months

MeT predicts briefs spells of rains till Sept 12

Srinagar, Sept 08: Amid frequent flood threats Jammu and Kashmir has received an excess rainfall of 41 per cent from June to September this year.

According Meteorological department (MeT) data, accessed by the news agency—Kashmir News Observer (KNO), five stations in Jammu region have recorded the large excess rainfall from June 01, 2025 to September 03, 2025. The stations include Udhampur, Samba, Rajouri, Ramban and Doda. (Areas where rainfall exceeds 60% above the normal are categorized as experiencing 'Large Excess Rainfall'.)

The large excess rainfall came at a time when the region experienced back-to-back years of deficit rainfall.

Pertinently, Jammu and Kashmir experienced its driest year in five decades in 2024, witnessing a significant deficit of 29%. In 2023, J&K recorded 7% deficit, in 2022 16% deficit, 2021 saw 28% deficit and 2020 experienced 20% deficit.

The data reveals that Srinagar & Jammu, summer and winter capitals of Jammu and Kashmir, are among the five stations where excess rainfall has been recorded during the period. The other three | More on P6

# Artisans fear extinction of Sozni embroidery as demand for handmade Pashmina declines

Veteran artist Mohammad Aslam Khan seeks govt intervention for its revival

Srinagar, Sept 08: The centuries-old art of Sozni embroidery on Pashmina and Toshe shawls is facing a steep decline, with artisans warning that the craft may soon disappear if urgent measures are not taken.

Among those raising alarm 70-year-old Mohammad Aslam Khan, a resident of Kathidarwaza, Rainawari, who has been practicing Sozni for the last 55 years.

Khan, regarded as one of the senior craftsmen in his locality, says that the demand for



authentic handmade embroidery has drastically fallen due to machine-made imitations,

lack of government support and exploitation by middlemen. Notably, veteran

Mohammad Aslam Khan's picture was used as the cover picture in a book 'Shawls and Shawlbafs of Kashmir -Legends of Unsung Heroes' by Dr-Abdul Ahad. "I inherited this art from

For generations, our family kept this tradition alive, but most of my relatives have now left it as they found other sources of livelihood. Addressing the officers in the meeting, the IMCT said that the observations and recommendations as well as damage report will be shared with the Union Government to ensure immediate relief as well as long-term resilience planning for the district.

Later, the IMCT team also visited various flood affected areas of the district including Khudwani and Qaimoo to gather on-ground assessment of the damages caused. The team also interacted with the general public and took stock of their demands and suggestions.

They assured the locals that these observations and suggestions will be shared with the Government of India to ensure immediate relief as well as long-term resilience planning for Kulgam district.

The Inter-Ministerial

has suffered damages to public infrastructure including Roads, Bridges, Water Supply Schemes, Power assets and standing crops and houses of lower riparian villages in Zainapora sub division.

DC Shopian also briefed on immediate restoration of services which were disrupted during floods and relief and rescue measures carried out in the district.

DC Shopian informed the IMCT that in Shopian district, 2 out of 6 major 33 KV lines,16 feeders,13 transformers and 19 electric poles were affected and have been restored: 55 out of 92 drinking water supply schemes were impacted and all have been restored, 25 roads were damaged of which 24 stand restored and 1 is under restoration besides PMGSY road length of about 860 metres was damaged.

The DC also apprised the IMCT that Mughal Road at KM 24 witnessed severe damage due to sliding and efforts are

on to keep it open 24\*7. It was further informed that 28 villages in low lying areas covering 4284 hectares with a population of 17,200 were impacted, 4 villages namely Hydergund, Zainapora, Melahura/Wandina and Reshipora were directly hit, 21 shelter sheds were established, 129 families evacuated and 644 persons rescued.

He was accompanied by Deputy CEO Jammu (HQ Akhnoor), Sardar Harjeet Singh.

The recent rains and floods caused damage to school infrastructure across Jammu and Kashmir, prompting a thorough review to ensure the safe resumption of classes and continuity of learning.

During the visit, CEO Jammu

inspected the following institutions: HSS Jhiri (Zone Marh), HSS Boys Akhnoor, HSS Girls Akhnoor, HSS Sohal (Zone Akhnoor), HS Dhok Khalsa (Zone Jourian), HSS Pallanwalan (Zone Khour), MS Platan (Zone Khour), HSS Khour (Zone Khour), MS Thallian (Zone Jourian), and HSS Jourian (Zone Jourian).

The CEO interacted with Heads of Institutions and staff members, issuing on-the-spot directions to address safety, infrastructure, and academic concerns.

At HSS Jhiri, the Head of Insti-tution was instructed to conduct classes only in the safe portions of the building, with repairs to be carried out immediately and a safety certificate obtained before reopening the affected portions.

At HSS Pallanwalan, where part of the school building is being used as a camp for border migrants, the CEO directed the management to make suitable arrangements to ensure smooth functioning of classes in the remaining portion of the premises.

He further instructed all staff members to continue online teaching until offline classes fully resume so that students' learning is not disrupted. He also encouraged Heads of Institutions to motivate students of Classes 1 to 8 to actively use the SwiftChat application, a chatbot-based learning tool provided by J&K Samagra Shiksha under Vidhya Samiksha Kendra (VSK), to support continuous learning.

# NH closure sparks mutton shortage in Kashmir

Srinagar, Sep 08: As the Srinagar-Jammu National Highway remained closed for another consecutive day, the Kashmir Valley is on the verge of facing an acute mutton shortage, with dealers warning of complete stock exhaustion from Tuesday-Wednesday onwards.

Thunder

Dealers said the crisis has already forced the likely postponement of multiple events, including several weddings and other key functions.

"This is an extremely alarming situation, and if the government does not take it seriously, we might face an acute shortage of mutton across Kashmir," Mehraj-Ud-Din Ganai, General Secretary of the Mutton Dealers Association said.

He added that if supplies do not reach within the next 24–48 hours



via the Mughal Road, there will be zero availability of mutton across the valley.

Despite government assurances of routing essentials through the

Mughal Road, trucks are repeatedly halted at Lakhanpur, Nowshera, Surankote and Poonch for several days, resulting in heavy financial losses.

"The stoppages and continuous

halts are killing our livestock and crippling our trade," Ganai said, adding that over the past week, mutton dealers have faced losses exceeding

"We appeal to the administration to intervene immediately and ensure hassle-free passage of vehicles through the Mughal Road," he added.

Notably, mutton is a key component of Kashmir's food culture, with weddings and other functions heavily dependent on its availability. Moreover, the Srina-gar-Jammu Highway—the valley's only all-weather road link with the rest of the country, has been hit by multiple landslides and damage in Udhampur and other areas following heavy rains over the past two weeks, while restoration work is underway—(KNO)

# Mounting vegetable prices across markets

Srinagar, Sep 08: In Kashmir's bustling marketplaces, once affordable and easily available vegetables have now become a luxury as prices soar sharply. The recent memories of rotten mutton and their lingering impact continue to cast a shadow over the region, and now even vegetables, which were once staples, are out of reach for many Kashmiris.

The public's fondness for mutton has turned into frustration, and people are now approaching vegetable markets with a sense of despair. Locals said that outrage



over rising prices has transformed into open anger, with the cost of essential items increasing dramatically. For instance, live chicken, once affordable at Rs 120–130 per kilogram, is now selling for

over Rs 200 per kilogram. "Even chicken, which used to be a fallback option, is now beyond the reach of the poor," said Shahzada, a

resident of Bemina. She added that vegetable prices have also surged, with items like onions, tomatoes, potatoes, and beans being sold at double or more their previous rates, making simple meals feel like a luxury.

# Students skipping regular classes: DSEK

Orders strict enforcement of student attendance in all Govt, private schools

Srinagar, Sep 08: School Education Department (SED) Monday said that students of 11th and 12th standard in Kashmir division were skipping regular classes and the trend was spreading to lower classes.

The department said that the irregularity was impacting the objective of student development as envisioned by NEP 2020.

Director of School Education Kashmir (DSEK) G N Itoo ordered strict vigilance regarding regular attendance of students in all high and higher secondary schools.

DSEK in a circular issued in this regard said that the National Education Policy 2020 (NEP 2020) envisions education not merely as academic instruction but as a holistic journey nurturing students' intellectual curiosity, emotional intelligence, creative expression, ethical awareness and social skills.

"To realize this vision, especially through experiential learning and collaborative projects, regular class attendance is not only essential but the backbone to achieve competency-based learning, critical hands-on activities, teacher interactions and peer engagement, which NEP 2020 aims to cultivate among students" reads the circular.

DSEK said, "It has been observed that a number of students of classes 11th and 12th are skipping regular classes and the trend is spreading to class 9th and 10th. This is a matter of serious concern as it will impact to achieve the objectives of student development as envisioned by NEP 2020."

The directorate also said that regular school attendance is mandatory and the school curriculum is designed to provide comprehensive learning and missing classes can



effective learning.

"To ensure that the goals of NEP 2020 with regard to holistic development of students are achieved, it is enjoined upon all stakeholders to ensure strict enforcement of student attendance in all government and private recognised schools through VSK attendance Chatbot, Aadhaar based attendance," DSEK said.

Itoo further said that principals must ensure that practical classes in science subjects are conducted regularly as these are crucial for hands-on learning.

"All Principals and faculty shall take proactive measures to ensure students attend regular classes and create an engaging, academically enriching environment in schools in line with National Education Policy (NEP) 2020 which emphasizes on experiential learning," it reads.

The director directed all joint directors, Chief Education Officers (CEOs), cluster heads, and Zon-al Education Officers (ZEOs) to personally monitor compliance of circular instructions. "Non-compliance with the above instructions shall be viewed seriously and may attract disciplinary action as warranted."—(KNO)

# Water crisis persists in Srinagar

ter crisis, as residents across multiple localities continue to face severe shortages despite repeated assurances from authorities.

From Batamaloo and Khanyar to Lal Bazaar, Nawa Kadal, Bemina, and parts of the outskirts, including Bagh-e-Methab, people are enduring long waits for water tankers or resorting to unsafe, muddy water sources.

On September 5, 2025, officials said the disruption was due to recent floodlike conditions in the valley, which caused increased cloudiness in water sources and affected supply from several treatment plants.

When contacted on September 5, the PHE exchange helpline officials reiterated that supply would be restored "by late evening", a promise residents now see as routine and unfulfilled. "We have multiple complaints. Requests for tanker services are pending, and it's impossible to send tankers everywhere,' said an official after KNO asked about the ongoing water shortage in one of the affected areas.

The crisis has already led to protests. Last month, residents of Batamaloo blocked the main road, accusing authorities of ignoring their suffering. "We have been without water for weeks. Our children go to school without bathing, and our kitchens are dry. How long should we wait?" questioned Ghulam Rasool, a local.

# **Western Command** launches 'Operation Rahat' in flood-hit regions

Jammu, Sep 08: Following the recent floods, the Indian Army's Western Command has launched Operation Rahat to provide assistance and relief to and disaster hit areas in Jammu & Kashmir, Punjab, and Himachal Pradesh.

Since August 26, the Army has carried out 82 missions with the deployment of 59 columns, including 17 Engineer Task Forces. These efforts have focused on evacuation, medical aid, and restoration of infrastructure. Over 6,000 citizens have been evacuated across the three states, including 300 personnel from the PMF.

"Medical support has been provided to more than 13,000 individuals, including critically ill patients requiring emergency transport," it

"The Army has delivered deployed to support

48 tons of essential supplies, including rations, medicines, and drinking water, through both air-drops and ground convoys. Aviation assets deployed in the operation include 3 ALHs, 6 MI-17s, 6 Cheetah helicopters, and 1 Chinook, which have collectively flown over 250 hours of sorties to support relief missions," it said.

In coordination with civil administration, National Disaster Response Force (NDRF), and State Disaster Response Force (SDRF), the Army has focused on restoring connectivity and essential infrastructure.

Engineering teams have worked on diverting floodwaters, repairing bridges, restoring washed-away roads, and strengthening embankments. At Madhopur

"Notable measures in Jammu & Kashmir include laying over 2 kilometers of optical fiber cable in Bhagwati Nagar to restore mobile connectivity on August 27 and constructing a Bailey bridge at Jammu Tawi within 12 hours on August 29 to reopen a key route," it added.

Medical camps and community kitchens have been established across affected districts to provide first aid, preventive care, and cooked meals to stranded populations. Flood Control and Water Monitoring Cells have been set up at headquarters to track water levels at critical points, including Ranjit Sagar and other major dams, ensuring timely deployment of resources—(KNO)

# How long shall Kashmir depend on single vital route for supplies

ver a week-long closure of the Jammu-Srinagar National Highway (NH-44) amid ongoing heavy rains has exposed the fragile supply chain of Kashmir. This has led to a sharp spike in food prices and deepening the hardships faced by residents. As the valley's primary all-weather road remains blocked at multiple points due to landslides and shooting stones, essential commodities like vegetables, poultry, mutton, and fruits have become increasingly scarce and expensive. The immediate consequence is a surge in prices, with residents reporting vegetables

costing nearly double. Locally grown items like Haakh and beans are now unaffordable for many, and even imported fruits like apples and bananas are selling at 30-40% higher prices. Poultry and eggs have also seen steep increases, with chicken prices hitting around Rs 200 per kilogram and eggs soaring to Rs 240 per tray. Mutton, already costly, has reached nearly Rs 1,000 per kilogram, further burdening households, especially amid the ongoing marriage season, which heightens demand and scarcity. This crisis underscores a broader issue: dependence on a single vital route

for supplies. With trucks stranded and livestock unable to reach markets, traders are forced to sell limited stocks at inflated rates, creating a perfect storm of supply shortages and profiteering. Residents are calling for urgent government intervention, demanding market regulation to prevent hoarding and black marketing, which only worsens their plight. Authorities have begun monitoring markets and conducting checks, but experts point out that enforcement is limited to packaged goods with MRP labels. Without a standardised rate list for bulk items, controlling

prices in open markets remains challenging. Trade bodies have urged traders to exercise restraint, and officials from the Food, Civil Supplies and Consumer Affairs Department have assured the public that stock levels are sufficient and that measures are in place to stabilise prices once supplies resume. This situation highlights the critical need for better infrastructure resilience and diversified supply routes. Relying solely on NH-44 leaves Kashmir vulnerable to disruptions, which have severe social and economic repercussions. Until the highway reopens, residents will

continue to suffer from inflated prices and limited access to essentials. This demands strategic planning and proactive market regulation. The ongoing crisis reveals how infrastructure failures can rapidly translate into economic distress for ordinary people. The government must act decisively, not only to restore the highway but also to implement sustainable measures that protect consumers from exploitation during such emergencies. The people of Kashmir deserve assurance that their basic needs will be safeguarded, whatever the weather or roadblocks ahead.

According to the World Economic Forum, bioeconomy uses renewable resources like plants, animals, and microorganisms to produce food, energy, and industrial goods. It helps cut emissions, reduce dependence on fossil fuels, and support sustainability. With innovations such as gene editing and bioprinting, bioeconomy is creating solutions that protect the planet while driving economic growth and human well-being.

Marking the first anniversary of the

BioE<sup>3</sup> Policy (Biotechnology for Economy, Environment and Employment), on 25th August 2025, Union Minister of Science and Technology Dr Jitendra Singh launched the BioE<sup>3</sup> Challenge for Youth and the country's first National Biofoundry Network, calling these initiatives vital to making biotechnology a driver of India's economy, environment, and employment.

Key Drivers of India's Bioeconomy Success India's BioEconomy, valued at \$165.7 billion in 2024, is powered by four major subsectors. Each reflects India's strength in science, innovation, and sustainability.

## **BioIndustrial**

The BioIndustrial segment, representing nearly half of the total BioEconomy, is valued at \$78.2 billion in 2024. With a significant 35.2% share, valued at \$58.4 billion, this segment is crucial to healthcare and medical innovation. This sector develops pharmaceuticals, medical devices, diagnostics, biologics, and lab-grown organoids. It focuses on areas like cancer immunotherapy, gene editing, precision medicine, and MedTech solutions. India is recognized globally for affordable biopharmaceuticals.

## **BioAgri**

Contributing 8.1% to the total BioEconomy, valued at \$13.5 billion,BioAgri centres on agricultural biotechnology. This subsector drives agricultural biotechnology. It covers genetically modified crops, precision farming, and bio-based products. A key success story is Bt Cotton, which has boosted yields and improved sustainability.

## **BioResearch and BioIT (BioServices)**

The BioIT and Research Services segment holds a 9.4% share of India's BioEconomy, with a value of \$15.6 billion. As in 2024, Maharashtra leads India's Bioeconomy with a value of \$35.45 billion, representing 21.4% of the total Bioeconomy value of \$165.7 billion. Karnataka follows closely with \$32.4 billion (19.5%), while Telangana contributes \$19.9 billion (12%). Gujarat adds \$12.9 billion (7.8%), Andhra Pradesh \$11.1 billion (6.7%), Tamil Nadu \$9.9 billion (6%) and Uttar Pradesh contributes \$7.7 billion (4.7%) respectively. The "Others" category, which includes various smaller states, totals \$36.4 billion, accounting for 21.9% of the Bioeconomy value.

The regional distribution of India's BioEconomy highlights the dominance of the Southern region, which contributed 45.4% (\$75.2 billion), reflecting its strong biotechnology base and innovation ecosystem. The Western region followed with 30.3% (\$50.2) billion), supported by major industrial hubs. The Northern region accounted for 18.5% (\$30.6 billion), showcasing steady growth in biotech enterprises. Meanwhile, the Eastern region contributed 5.8% (\$9.7 billion), indicating emerging opportunities and potential for expansion. This regional spread underscores the pivotal role of the South and West, while also pointing towards the growing significance of the North and East in shaping India's Bioeconomy.

## **BioE3 Policy to Boost Biomanufacturing**

The Union Cabinet approved the proposal of the Department of Biotechnology (DBT) on 24 August 2024 for India's first biotechnology policy, the BioE3 Policy (Biotechnology for Economy, Environment and Employment). The policy focuses on fostering high-performance biomanufacturing and lays down the framework for the Biomanufacturing and Biofoundry Initiative. This initiative aims to promote green growth by shifting from consumptive manufacturing to regenerative and

At an interactive meet of DBT and Biotechnology Industry Research Assistance Council (BIRAC) with industry stakeholders, Dr. Jitendra Singh noted that India now accounts for 21 of the 121 Bio-Companies globally, positioning the country among the early movers in institutionalizing biomanufacturing policy. He emphasized that biomanufacturing is central to India's vision of self-reliance, adding that "BioEnablers are the foundation of India's next wave of biotechnology-led growth."

To drive this growth, 21 advanced BioEnabler facilities have been launched across the country, offering shared infrastructure for startups, SMEs, industries, and academic institutions. Their focus areas in clude microbial biomanufacturing, smart proteins, sustainable agriculture, functional foods, carbon capture, marine biotechnology, and next-generation cell and gene therapies.

Nationwide BioE3 Challenge to Drive Youth-Led Biotech Solutions

The BioE3 Challenge for Youth is a nationwide programme launched by Dr. Jitendra Singh to encourage young innovators under the theme "Design Microbes, Molecules and More". Organised by the Department of Biotechnology, it invites participation from school students (Classes 6-12) and university students, researchers, faculty, startups and Indian nationals. The focus is on developing safe biological solutions to address challenges in health, agriculture, environment and industry.

Starting from October 2025, the challenge will be announced on the first of every month. The ten best entries each month will receive a cash prize of Rs 1 lakh along with recognition and mentoring. In addition, 100 participants will be selected for funding support of up to Rs 25 lakh through BIRAC to convert their ideas into proof-of-concept solutions. These participants will also get access to incubation facilities and infrastructure at BRIC+ institutions across India.

By empowering young talent and promoting grassroots innovation, the BioE3 Challenge aims to build a culture of problem solving and creativity while contributing to India's journey towards a sustainable and self-reliant bioeconomy.

## **SIGNIFICANT BIOTECH MILESTONE OF 2025**

India Increased its Influence in Global

India has consolidated its position as a top vaccine manufacturer. According to the WHO Global Vaccine Market Report, the Serum Institute of India's share of the global vaccine market, excluding COVID-19 vaccines, rose from 19% in 2021 to 24% in 2024. This was driven by higher production of pneumococcal conjugate vaccine (PCV), measles-rubella (MR), and tetanus-diptheria (Td) vaccines.

The global vaccine market is highly concentrated, with 10 manufacturers supplying over 80% of vaccines. Three of these are

Serum Institute, Bharat Biotech, and Biological E—are from India. Indian firms supplied 40% of WHO's vaccine purchases, with a large share used domestically. About 20% of India's vaccine exports went to the WHO African Region.

## India Achieved 20% Ethanol Blending

India has achieved 20 per cent ethanol blending (E20) in petrol in 2025, five years ahead of the original target. This is a steep rise from 1.5 per cent in 2014 and reflects the country's progress towards building a sustainable bio-economy. The blending initiative, launched as a pilot in 2001, has accelerated in recent years through comprehensive policy reforms that unlocked ethanol production potential.

# The programme has delivered multiple

Farmer income security: Between Ethanol Supply Year (ESY) 2014-15 and June 2025, farmers received Rs 1,21,000 crore for ethanol feedstock, eliminating sugarcane arrears and improving the viability of maize cultivation.

Annual impact: At 20 per cent blending, it is expected that payment to the farmers in this year alone will be to the tune of Rs.40,000 crore and forex savings will be around Rs. 43,000 crores.

Energy independence: Till July 2025, ethanol blending substituted 245 lakh metric tonnes of crude oil and conserved Rs 1,44,087 crore in foreign exchange, significantly strengthening energy security.

This achievement underscores the role of ethanol blending in integrating energy, agriculture and sustainability, thereby contributing to India's bio-economy.

## **Precision Medicine and Preventive Care**

Healthcare is shifting towards personalized and preventive care. India launched Nafithromycin, an indigenous antibiotic targeting antimicrobial resistance (AMR), which addresses Community-Acquired Bacterial Pneumonia caused by drug-resistant bacteria. New vaccines include a quadrivalent influenza vaccine and a 14-valent PCV. Gene sequencing is enabling tailored treatments in oncology and immunology. CAR T-cell therapies are creating new options for blood cancer patients. Al-driven diagnostics and remote monitoring are transforming healthcare delivery.

## Bioeconomy's Global Impact by 2050

The Bioeconomy contributes significantly to many economies. Italy and Spain have a 22% GDP share, while the US and China record 5% and 4%. India's share is 4.25%. By 2050, the global Bioeconomy is projected to grow from \$4 trillion to \$30 trillion, about 12% of world GDP. According to PwC's The World in 2050 report, emerging markets like India, China, and Indonesia will drive this

By 2050, the global BioEconomy is

expected to expand significantly, with its contribution to the world economy growing from approximately \$2.9 trillion in 2020 to \$30 trillion. Representing nearly 12% of the projected global GDP of \$228 trillion.

India's Bioeconomy could range between \$1.4 trillion and \$2.7 trillionby 2050, up from \$165.7 billion in 2024. With India's GDP projected at \$22 trillion, the sector's contribution may range from 6.5% to 12%. This growth is poised to play a critical role as India and other nations work toward achieving netzero carbon emissions, with sustainability initiative expected to drive economic growth and create millions of high-quality jobs.

### India Plans to Develop its Bioeconomy to \$300 Billion by 2030

India's Bioeconomy is set to double from \$151 billion in 2023 to \$300 billion by 2030, with a CAGR of 12.3%. BioMedical is expected to reach \$128 billion. BioAgriculture could grow to \$39.3 billion. BioIndustrial is projected at \$121 billion, while BioServices may rise to \$42.4 billion. This growth highlights the Bioeconomy's role in innovation and sustainable development.

### India's Biotech Startup Ecosystem reached 13,000 in 2025

India's biotech startups grew from 5,365 in 2021 to 13,000 in 2025, an 142% rise. Growth has been steady since 2016, with a sharp rise after 2020. BIRAC support programmes and increased investments have fuelled this momentum. Startups have developed over 800 products and raised \$600 million in follow-on funding.

FDI in MedTech sector rose from \$370 million in 2022 to \$618 million in 2024. Although funding fluctuated, the ecosystem ibrant Domestic innovation and global collaborations position India as a key player in biotech and health-tech.

As a dynamic and rapidly expanding sector, India's bioeconomy reflects the country's preparedness to lead in the era of sustainable growth. From ethanol blending and vaccine leadership to breakthroughs in precision medicine and biomanufacturing, the sector reflects the nation's ability to turn challenges into opportunities. With an ambitious target of reaching USD 300 billion by 2030 and projected growth of up to USD 2.7 trillion by 2050, India is set to emerge as a global bioeconomy powerhouse. The continued focus on biotechnology, green energy, and youthled innovation ensures that the bioeconomy will play a central role in achieving the twin goals of economic prosperity and environmental stewardship, making India a model for the world in building a sustainable future.

Dean, Faculty and Research, IIM Jammu Prof. Jabir Ali stated that this initiative provides a unique opportunity to integrate rigorous academic research with field-level interventions for MSME development. He emphasized that insights generated from this program will not only help rehabilitate distressed units but also contribute toward policy design and knowledge creation in the MSME sector.

The Jammu & Kashmir MSME Health Clinic will serve as a dedicated institutional mechanism to identify early signs of stress in MSMEs and provide tailored solutions through financial and non-financial interventions. A Project Management Unit (PMU), to be hosted at IIM Iammu, will comprise experts in branding, marketing, finance, technology and strategy, supported by young professionals and data analysts.

The primary objective of establishing the Jammu & Kashmir

MSME Health Clinic (JKMHC) under the RAMP Programme is to create a proactive mechanism for the early identification and prevention of stress in Micro and Small Enterprises (MSMEs). This initiative aims to provide both financial and non-financial support to MSMEs that exhibit signs of stress and are on the verge of slipping into sickness. It is designed as a preventive measure to address the developmental needs of MSMEs, focusing on diagnostic and clinical support exclusively for enterprises showing early signs of stress. The program has been struc-

tured to run over a two-year duration from FY 2024-25 to FY 2026–27, with a total outlay of

30.64 crore. It will cover nearly 959 identified MSMEs across Jammu & Kashmir and will be implemented in three distinct phases. Phase I will focus on diagnostic studies and identification of vulnerable enterprises, Phase II will implement financial and non-financial interventions and Phase III will establish long-term monitoring and sustainability frameworks.

Financial interventions under the program will include working capital loans, technology

house receipt financing and export promotion grants, while non-financial interventions will emphasize capacity building, skill training, quality certification and strategic mentoring.

Pune-based Central Water & Power Research Station (CWPRS) and EPTISA, a multinational engineering company specializing in engineering, consultancy, information technology, and institutional development.

The communication states that the action was taken on grounds of his activities being "prejudicial to the maintenance of public

order"

"After examining relevant materials, reports, and circumstances, authorities concluded that the continuance of such activities posed a 'grave threat' to peace, public order and tranquillity in the district." it reads.

The government said preventive detention under the PSA was found necessary "in the interest of maintaining public order and safeguarding law and order in the region".

The arrest has drawn criticism from political

leaders across the region.

Chief Minister Omar Abdullah voiced his opposition through social media, calling the detention unjustified. "There is no justification for detaining Mehraj Malik under PSA. He's not a threat to public safety, and using this discredited law against an elected representative is wrong. If the unelected government can use its powers against an elected representative like this, how can the people of J&K continue to have faith in democracy?" he wrote.

Reacting to the arrest, Arvind Kejriwal, National Convenor and Chief of the Aam Aadmi Party (AAP), said, "Is it a serious offense to request a hospital for one's constituency that an elected MLA is imprisoned? Mehraj Malik is a committed leader of the AAP. He will continue to represent the people and fight for their rights. Jail, threats, or conspiracies will not deter any dedicated member of AAP."

People's Conference President and Handwara MLA Sajad Lone condemned the move, saying it undermines democratic processes. "We strongly condemn the use of the PSA against MLA Mehraj Malik. This is a soulless democracy," Lone said, adding that such actions reduce

the people's mandate to a symbolic exercise.

He added that the will of the people remains subservient when elected representatives are denied the right to express their views, warning that such measures damage the credibility of democratic institutions in the region.

PDP leader and MLA Waheed Parra also denounced the arrest, describing the use of PSA as a tool to silence political voices. "Draconian laws are being weaponised to crush dissent. Such authoritarian measures are no way to resolve political differences in a democracy,"

"Invoking the Public Safety Act (PSA) against MLA Mehraj Malik is unjustifiable. If an elected representative has erred, he must be questioned and dealt with under due process of law. That is how accountability works in a democracy," Srinagar MP, Aga Syed Ruhullah Mehdi said.

The PSA, he said, intended for exceptional cases of grave security threats, has been repeatedly misused in Jammu & Kashmir to detain individuals on vague and arbitrary grounds. "It has effectively become a tool to silence voices. Such misuse erodes public trust in institutions and reduces a legal safeguard into an instrument of suppression. We strongly condemn the use of abusive language by Mehraj Malik, but this is not justice; it is repression," he added.

NC legislator Salman Ali Sagar said Malik's arrest under the PSA sets "a dangerous precedent" in Jammu and Kashmir. Terming the move as an attempt to "stifle democracy" and "silence dissent", he added, "Free speech and political voices must be protected, not suppressed.

Senior Awami Ittehad Party (AIP) leader and MLA from Langate, Sheikh Khursheed, also condemned the detention of fellow MLA.

Addressing a press conference, Khursheed urged the Lieutenant Governor to review the decision immediately and appealed to the Chief Minister to convene an all-party meeting to formulate a collective response.

"This decision is not just against Mehraj Malik, but against all the people of Doda who elected him through democratic means," Khursheed said, demanding immediate revocation of the order.

The legislator said that any objectionable remarks or actions attributed to Malik should have been dealt with through judicial or parliamentary channels, not through draconian laws.

The MLA also raised serious questions over what he termed as 'discriminatory use' of the PSA in Jammu and Kashmir. "Is this law meant only for the people of J&K? Is there any other region in India where such action is taken against elected representatives?" he asked. (KNO)

## Artisans fear extinction

Over his long career, Khan has trained more than 200 artisans in Sozni work. But despite this, he fears the younger generation is no longer willing to take it forward. "Sozni requires extreme patience and months of hard work. A single shawl can take years to complete. But today's youth prefer faster, more lucrative professions, while markets are being taken over by machine-made replicas," he explained.

Khan says that while genuine Sozni embroidery on real pashmina is unmatched in quality and cultural value, the artisans receive very little in return for their efforts. "Middlemen exploit the craft. They sell our work for high profits in national and international markets, while we barely get enough to sustain ourselves," he lamented.

Recalling his association with the government emporium in earlier years, Khan said that Kashmiri shawls once had a strong global presence. "There was a time when our designs traveled across continents and symbolized Kashmir's identity. Today, markets are flooded with fake products that misrepresent our culture. The government must restore those original patterns and revive this sector, otherwise it will disappear forever," he warned.

Khan particularly remembered the efforts of former Director of Handicrafts Mehmood Ahmad Shah, who had introduced initiatives to safeguard the industry. "He took some steps to promote artisans and ensure fair trade, but his transfer left those initiatives incomplete. That was a setback for us," he said.

Expressing his concern, Khan appealed to the government to act decisively. "It is now or never. If authorities don't step in, Sozni embroidery will survive only in memories. The legacy of generations deserves revival, respect, and recognition. Otherwise, the market of machine-made fakes will erase everything." (KNO)

# Highway halt

fruit mandi in Sopore to suspend operations for two days.

The Kashmir fruit growers and dealers association president, Fayaz Ahmad Malik, @ Kaka Ji, speaking to the news agency — Kashmir News Observer (KNO), said that hundreds of fruit-laden trucks are stuck on the highway.

"We are already staring at losses worth over Rs 200 crore. If the highway doesn't reopen, it may touch Rs 400 crore," he said. "We have decided to halt all trading activities on Tuesday and Wednesday to prevent further damage. We cannot afford more consignments to be wasted."

Malik said highly perishable produce, particularly Bagogosha pears and Gala apples, has suffered the worst damage. "We had already appealed to growers to stop harvesting and packing until the situation improves. Unfortunately, the stranded stock is deteriorating fast," he informed

ing fast," he informed.

Growers across the valley are in despair. "It feels like 2022 all over again. We suffered huge losses then, and today we are staring at an even bigger disaster", Fayaz Ahmed, a grower from

Sopore, said.
"What used to be sold at Rs 600 per box is now down to Rs 400", said Abdul Rashid, a grower from Rafiabad, adding that if authorities don't intervene immediately, the industry will collapse.

Authorities, however, have allowed partial movement of vehicles through the Mughal Road. "Six-tyre trucks have been permitted to move, but we are demanding permission for 10-tyre vehicles as well. Only then can the stranded load be cleared", Mandi president said.

Traders and growers have jointly appealed to the government to treat fruit trucks as a priority for movement, warning that prolonged disruption will devastate the sector that sustains lakhs of families across the valley.

"Kashmir's economy is horticulture-driven. If this highway remains shut, the backbone of our economy will break," the growers said.

## Valley's apple

even failing to provide the much-needed alternative to transport the perishable produce and other fruits, especially apples, out of the

"The market is completely closed. For 15 days, the National Highway has been closed," Bashir Ahmad Basheer, Chairman of the Kashmir Valley Fruit Growers and Dealers Union (KVFGDU), told the news agency—Kashmir News Observer (KNO). "This is the beginning of the whole season and the loss has increased considerably. Fruit growers can't tolerate it."

As per the growers, September marks the peak time for harvesting apple varieties like Gala, Red Delicious, and other mid-season crops. According to Bashir, nearly 90 per cent of Gala apple varieties have already been harvested, and other varieties were nearing completion. However, with road blockages and with no railway movement support, the produce was piling up and on the verge of getting rotten.

"When there is a skid or delay, it is a loss for everyone. This is a highly perishable item, and the damage is already around 100 per cent in some areas," he said.

Bashir said growers had pinned their hopes on the recently expanded railway operations to ease the crisis but said that too has failed to make a difference. "The train service was expected to provide relief, but it is not operating as required. So that hope too is fading now,"

Mughal Road Remains Underutilised

Bashir said that despite repeated pleas, the Mughal Road has not been fully opened for heavy fruit-laden trucks but for smaller trucks and other vehicles. "The Mughal Road could have served as a crucial alternative when the National Highway was blocked, but limitations have made it unreliable. At a time when every day counts, this route remains underutilised, adding to the losses of fruit growers," he said. Call for Fast-Track Highway Repairs

The apex fruit growers' body has urged the government to work on the National Highway on a war footing and ensure 24x7 restoration so that the fruit can reach outside markets on time. "If work is carried out round the clock, it will save the season," Bashir said.

The delay is also affecting the quality of the fruit, leading to price drops in available markets. Freight costs have surged as well.

ets. Freight costs have surge Ripple Effect on Economy

The apple industry is a vital and primary part of Jammu and Kashmir's horticultural and overall region's economy, supporting lacs of families. Bashir said prolonged disruptions were creating a cascading effect, with cold storages filling up, market commitments being missed, and growers unable to meet financial

"The effect means our society is in a bad situation. "All of us are worried," Bashir said. "And if this continues, the entire season will suffer, and our sector will collapse."

The NH-44, the road link to Kashmir, has been repeatedly closed for traffic since August 26 after landslides triggered by rain damaged a portion of it. (KNO)

# SC directs EC to accept Aadhaar as 12th ID proof in Bihar voter roll revision

New Delhi, Sept 08: The Supreme Court on Monday asked the Election Commission to include Aadhaar as a 12th prescribed document for establishing the identity of a voter in special intensive revision (SIR) exercise of electoral roll in pollbound Bihar.

At the moment for Bihar SIR, there are 11 prescribed documents which electors have to submit with their enumeration forms.

A bench of Justices Surya Kant and Joymalya Bagchi, however, clarified Aadhaar will not be a proof of citizenship and the commission can ascertain the genuineness of Aadhaar card number submitted by an elector for inclusion in the electoral roll.

Observing nobody wants the EC to include illegal immigrants in the electoral roll, the bench said it should be clear that only genuine citizens will be allowed to vote and those claiming to be genuine on the basis of forged documents will be excluded from the electoral roll.

The bench asked the poll panel to issue necessary directions



during the course of the day for acceptance of Aadhaar as a doc-

ument for proof of identity.

The top court also sought EC's explanation on showcause notices it issued to poll officials for not accepting Aadhaar card from the voters.

Senior advocate Rakesh Dwivedi, appearing for poll panel, submitted 99.6 per cent of the 7.24 crore voters in the draft roll had submitted documents and petitioners seeking inclusion of Aadhaar as 12th document would not serve any practical

September 1 but these would be considered once the electoral roll is finalised.

It said claims and objections in the draft roll can be filed till the last date of nomination forms in each assembly constituency.

The top court also termed the confusion over the Bihar SIR as "largely a trust issue" and directed the state legal service authority to deploy paralegal volunteers to assist individual voters and political parties in fil-ing claims and objections to the draft roll, which was published on August 1.

The poll panel, which opposed any extension of the September 1 deadline for filing of claims and objections as per the SIR schedule, had submitted that post the top court's August 22 order, till August 30, only 22,723 claims had been filed for inclusion and 1,34,738 objections had been filed for exclusion.

According to the June 24 schedule of the poll panel for the Bihar SIR, the deadline for filing claims and objections to the draft roll ended on September 1, and the final electoral roll will be published on September 30.

# PM to visit flood-hit Punjab today, State seeks Rs 20,000 cr relief package



Chandigarh, Sept 08: Punjab Cabinet Minister Aman Arora on Monday appealed dra Modi to announce a relief package of at least Rs 20,000 crore for the flood-ravaged State during his visit. The Prime Minister will visit Puniab on September 9 to take stock of the flood situation.

"Even though the PM has not uttered a word yet for the flood-hit Punjab, he is our PM and I welcome him with folded hands for his visit.I also expect that he should be seen standing by Punjab during his visit," Mr. Arora told reporters in Chandigarh.

Referring to Chief Minister Bhagwant Mann's recent letter to the Prime Minister demanding Rs 60,000 crore of the State's funds, Arora said it is Punjab's right and it should be released.

A few days ago, Mr. Mann had written to Mr. Modi to release Rs 60,000 crore of the State's funds, which he claimed were "stuck" with the government of India while highlighting that Punjab was grappling with one of the worst flood disasters in decades. Noting that the

prevailing flood situation was even worse than the 1988 deluge, Mr. Arora said, "the Centre should announce a relief package of at least Rs

He stated that over 4.50 lakh acres of crops have been damaged in the floods, besides loss of livestock and damage to houses.

There is going to be a challenge for farmers for growing the next crop as the silt is deposited in the floodhit fields, Arora, who is also the president of the AAP's Punjab unit, said.

"We welcome your (PM) arrival but you should also announce release of State's Rs 60,000 crore and a relief package of Rs 20,000 crore in the hour of crisis," he said.

Punjab is currently facing one of its worst flood disasters in decades. The floods are a result of swollen Sutlej, Beas, and Ravi rivers along with seasonal rivulets caused by heavy rainfall in their catchment areas in Himachal Pradesh and Jammu and Kashmir.

# US probes malware email targeting trade talks with China, WSJ reports

- Malware reportedly traced to APT41, linked to Chinese intelligence
- WSJ: Email targeted US trade groups, law firms, government agencies
- · Chinese embassy says it is not familiar with reported attack, opposes cybercrime

WASHINGTON: US authorities are investigating a bogus email purportedly from a Republican lawmaker that contained malware apparently aimed at giving China insights into the Trump administration's trade talks with Beijing, the Wall Street Journal reported on Sunday.

The malware in the email that appeared to be sent by Representative John Moolenaar in July to US trade groups, law firms and government agencies was traced by cyber analysts to a hacker group — APT41 — believed to be working for Chinese intelligence, the newspaper said.

Moolenaar, a harsh critic of Beijing, is the chairman of a congressional committee focused on strategic competition between China and the United States, including threats to US national security.

The email was the latest alleged Beijing-linked hacking operation aimed at giving China insight into recommendations to the White House for contentious trade talks with China.



said the Journal, quoting people familiar with the matter.

The Chinese embassy in Washington said it was not familiar with the details of the reported attack and that all countries face cyberattacks that are difficult to trace.

"China firmly opposes and combats all forms of cyberattacks and cybercrime," it said in an emailed statement. "We also firmly oppose smearing others without solid evidence." The Journal said the first malware email was sent just before US-China trade talks in Sweden that led to an extension of a truce on tariffs until early November, when US President Donald Trump and Chinese leader Xi Jinping could meet at an Asian economic summit. "Your insights are essential," said the email that asked recipients to review

proposed legislation attached to it. Opening the draft legislation would have allowed the malware to give the hackers extensive access to the targeted groups, the newspaper said, adding that it could not be determined if the attacks had succeeded.

The newspaper said that the FBI and the US Capitol Police were investigating the email.

It quoted an FBI spokeswoman as saying that the bureau was aware of the email and was "working with our partners to identify and pursue those responsible." The Capitol Police declined to comment, it said.

In a statement to the Journal, Moolenaar called the attack another example of Chinese cyber operations aimed at stealing US strategy. "We will not be intimidated," he said.

The fake email came to light when staffers of Moolenaar's committee started receiving puzzling inquiries about it, said the Journal, quoting people familiar with the matter.

# Shooting attack at Jerusalem bus stop kills 5

Jerusalem, Sept 08: Paramedics said at least five people were killed in a shooting attack in Jerusalem after two attackers opened fire at a bus stop at a busy intersection in north Jerusalem.

Paramedics said an additional 15 people were injured, including six in serious condition.

Police said the attackers shot people waiting at a bus stop, while Israeli media reported the attackers also boarded a bus and opened fire inside.

Police a security officer and a civilian shot the attackers soon after the incident began halted the attack. Police did not immediately respond to a request for comment on the status of the attackers or their identity.

The shooting took place at a major inter-section at the northern entrance to Jerusalem, on a road that leads to Jewish settlements located in east Jerusalem. Footage of the

attack showed dozens of people fleeing from a bus stop at the busy intersection during the morning rush hour. Paramedics who responded to the scene said the area was chaotic and covered in broken glass,

# WHO asks Taliban to lift female aid worker restrictions following earthquakes

Islamabad, Sept 08: The World Health Organization has asked Taliban authorities to lift restrictions on Afghan female aid workers, allowing them to travel without male guardians and help women struggling to access care after a powerful earthquake killed 2,200 people in eastern Afghanistan.

"A very big issue now is the increasing paucity of female staff in these places," Dr. Mukta Sharma, the deputy representative of WHO's Afghanistan office, told Reuters.

She estimated around 90 percent of medical staff in the area were male, and the remaining 10 percent were often midwives and nurses, rather than doctors, who could treat severe wounds. This was hampering care as women were uncomfortable or afraid to interact with male staff and travel alone to receive care. The September 1 magnitude 6 quake and its aftershocks



injured more than 3,600 people and left thousands homeless in a country already dealing with severe aid cuts and a slew of humanitarian crises since the Taliban took over in 2021 as foreign forces left.

The Afghan health ministry and a spokesperson for the Taliban administration did not immediately respond to a

Two-time Olympic medallist PV Sindhu, who showed flashes of her best form with na's Wang Zhi Yi at the Worlds before falling in the quarterfinals, opens her campaign against Denmark's Line Christophersen.

Former world No. 6 Lak-shya Sen, still searching for form after finishing fourth at the Paris Olympics, takes on Wang Tzu Wei of Chinese Taipei. Sen has endured a series of narrow losses and fitness setbacks, including a first-round exit at the Worlds against top seed Shi Yu Qi.

Veteran HS Prannoy, who pushed Denmark's Anders Antonsen to the limit in Paris, will meet Japan's fifth seed Kodai Naraoka, in another challenging opener. Young-ster Ayush Shetty, crowned US Open champion earlier this year, faces a tough test first up against China's Lu Guang Zu.
