# **PNGRB** proposes LPG pipeline for J&K

Invites bids for 230-km corridor; project to save crores, cut tanker traffic, carbon emissions

Srinagar, Sept 12: In a significant development, the Petroleum and Natural Gas Regulatory Board (PNGRB) has initiated the process for laying a petroleum and petroleum products (LPG) pipeline to Jammu & Kashmir.

As part of its ambitious plan to expand the LPG pipeline network to the region, PNGRB has proposed a 230-kilometre-long LPG pipeline from Jalandhar (Punjab) to Jammu (Jammu & Kashmir).

To begin with, PNGRB has invited bids for the authorization

of a petroleum and petroleum products (LPG) pipeline connecting Jalandhar in Punjab to Jammu in Jammu & Kashmir.

Documents accessed news agency–Kashmir Observer (KNO) reveal that the proposed pipeline is designed to operate with a minimum system capacity of 0.30 million metric tonnes per annum (MMTPA) from its first year of operation and throughout its economic life.

### J&K Govt allocates Rs 124.83 cr for diagnostic, critical care upgrades

Patients expect relief from travel, long waiting hours

Srinagar, Sept 12: In a significant step towards strengthening healthcare infrastructure in Jammu and Kashmir, the government has announced an allocation of Rs 124.83 crore for key upgrades in the health sector, fulfilling an assurance made by the Chief Minister Omar Abdullah in the recent Budget

Health Minister Sakina Itoo, in a post on X, said, "As assured by the Hon'ble CM in the Budget Speech, we have allocated 124.83 Cr for key upgrades in J&K's health sector: CT Scan at

GMC Jammu, MRI machines at GMC Baramulla, GMC Kathua & GMC Rajouri, Cath Lab at GMC Doda, PET Scan at GMC Srinagar, and strengthening Telemedicine across I&K (80 units). We remain committed to stronger, accessible healthcare."

Currently, Kashmir has only a single PET scan facility at SKIMS Soura, which caters to thousands of cancer patients from across the valley. The installation of a second PET scan at GMC Srinagar is being widely welcomed. Meanwhile, a PET scan at GMC Jammu was made functional recently.

"This is a huge relief for us.

Earlier, I had to wait for over a month for my PET scan at SKIMS. Now, with GMC Srinagar getting one more machine, patients like me won't have to face such delays," said Ghulam Nabi, a cancer patient from Pulwama.

Similarly, GMC Jammu currently has only one CT scan machine at GMC Jammu, leading to overcrowding. With an additional CT scan sanctioned, patients and attendants believe the waiting time will be reduced.

"My father had to be shifted to a private clinic last month because of the long queue at the GMC. It was | More on P6

# Border residents welcome LG Manoj Sinha's initiative to rebuild houses damaged by Pak shelling, recent floods



### LMD imposes Rs 1.5 lakh penalty on erring traders

**SEPTEMBER** JAMMU, 12: The Legal Metrology Department has intensified its enforcement drive against violations of the Legal Metrology Act, 2009, and the Legal Metrology (Packaged Commodities) Rules, 2011 across the Union Territory. In recent actions, the Legal Metrology Unit Sam-ba imposed penalties of ₹50,000 on four violators for non-compliance with provisions of the Act.

The Deputy Controller Enforcement Jammu levied a penalty of ₹50,000 on a manufacturer of packed beverages for failing to provide mandatory declarations. Similarly, the LMD Unit Kupwara recovered ₹50,000 from a company for not disclosing statutory information and for non-registration under Rule 27 of the Packaged Commodities Rules, 2011.

The Department cautioned all manufacturers, packers, and traders to strictly comply with mandatory labeling requirements such as Maximum Retail Price (MRP), net quantity and Unit Sale Price (USP). It stressed that violations mislead consumers. constitute unfair trade practices and will be dealt with firmly under

Jammu, Sep 12: Minister of State in the Prime Minister's Office, Dr Jitendra Singh, on Friday said that efforts are on to develop early warning systems for cloudbursts and earthquakes in Jammu and Kashmir.

Addressing the media workshop 'Vartalap' organized by the Press Information Bureau (PIB), Ministry of Information & Broadcasting here, Dr Singh said, "Scientific initiatives are underway to study cloudbursts and earthquakes and provide timely early warning alerts to citizens in Jammu and Kashmir."

Pertinently, more than 150 people lost their lives due to sudden flash floods and landslides triggered by cloudbursts in Jammu's Kishtwar and Katra Districts last month.

Dr. Singh said that while precise forecasting of earthquakes and cloudbursts remains a challenge, scientific efforts are underway to identify contributing factors and provide possible early warnings.

He explained that cloudbursts typically occur when heat and humidity accumulate

# HC junks 35-yr legal battle of Pak couple

Asks them to leave immediately

Srinagar, Sep 12: The High Court of Jammu & Kashmir and Ladakh has dismissed a 35-year long legal battle of a Pakistani couple to allow them to stay in Srinagar and has directed them to leave the country forthwith.

According to the details, an 80-year-old man, Mohammad Khalil Qazi, and his 61-year-old wife, Arifa were residing in Srinagar since 1988 on Pakistani passports. They had challenged a 1989 deportation order, claiming Indian citizenship and rights to ancestral property. The High Court ruled that the couple had concealed facts to extend their stay in India and must leave the country immediately.

The court examined records, including a school certificate indicating that Qazi attended a Srinagar school from 1955 to 1957. This contradicted the couple's claim that he was stranded in Pakistan after the 1948 India-Pakistan war. The division bench, led by Chief Justice Arun Palli and Justice Rajnesh Oswal, noted that the couple entered India on short-term visas that expired in 1988.

The judges stated that the appellants had not approached the court with clean hands and had attempted to manipulate the system by providing false information to prolong their stay.

The judgment referred to recent legal precedents, including Supreme Court rulings warning against the use of falsehood in litigation. The court said that the couple's interim relief order in 1990 allowed them to remain in Srinagar for over three decades, but as of June 28, 2025, they were directed to leave India. The bench added that under India's Immigration and Foreigners Act, 2025, foreign nationals cannot enter, stay, or reside in India without valid visas or permits.

The court clarified that foreign nationals are entitled only to rights under Article 21 of the Constitution, which covers life and liberty, and not the right to settle in the country. The couple had arrived in India in July 1988 with their minor son, Nayeem, and had obtained short-term residential permits. Multiple extensions were granted, but the 1989 deportation order had curtailed their stay.

The High Court upheld the legality of the original deportation order and dismissed the appeal, stating that the appellants had failed to provide any valid grounds for staying in India.

The court also reinforced that the government has absolute authority to expel foreign nationals. (KNO)

# **Upset Apple growers** say fruit fall hits orchard

Srinagar, Sep 12: Apple growers across Kashmir are reeling under fresh distress as large-scale fruit fall has been reported from orchards at the peak of the harvesting season.

Already battered by extreme weather, pest infestations, and transport disruptions, farmers say this unexpected phenomenon is pushing them toward massive financial losses.

For months, the valley's orchardists have struggled against prolonged dry spells, hailstorms, high-velocity winds, and diseases such as spider mite and rusting. Highway closures further choked the supply chain, leading to delays and rising freight costs. Now, when growers were finally ready to reap the fruits of their year-long toil, the sudden drop in apples has left them shocked.

"This is the first time in my life I am seeing apples falling from trees like this." Abdul Rashid, an orchardist from Shopian. "We worked hard the whole year, fought pests and dry weather, but now prolonged rain spells during harvest have caused the fruit to drop in large numbers. It



is heartbreaking."

Growers say the fallen apples lose their quality instantly and are downgraded to second-grade produce, fetching extremely low pric-

and pest damages earlier too, but this sudden fruit fall is something entirely new," said Ghulam Nabi, a grower from Pulwama. "If it continues, we may lose a major chunk of our produce. Our families depend solely on these orchards, and such losses threaten our very survival." Agricultural experts point to the unusual weather pattern as the main reason behind the crisis. Prolonged wet conditions, they say, weaken the fruit's stem and attachment, causing premature drop.

"Continuous rainfall during the harvest period leads to physiological stress on trees. The moisture imbalance in soil and air directly impacts fruit holding capacity," said Dr Shabir Ahmad Dar, a hor-"We have faced weather ticulture scientist. "But we need systematic field surveys to assess the extent and suggest preventive measures

for the future." Officials from the Horticulture Department acknowledged receiving distress calls from multiple

"While excessive rainfall seems to be the immediate trigger, we will work to find out other contributing factors like soil nutrition and orchard management practices," said a senior horticulture officer. Growers, however, say the

government must go beyond assessments. "We urge immediate intervention. The authorities should not only study the problem but also announce compensation This season has turned into a nightmare for us," said Mohammad Yousuf, a farmer from Kulgam.

The crisis has cast a shadow over Kashmir's apple industry, which is the backbone of the region's horticulture sector. Employing lakhs of people and contributing thousands of crores to the economy, the industry was already struggling with transport bottlenecks and rising input costs.

Farmers fear that if the fruit fall persists, the valley's apple output—and their livelihoods-will take another severe hit this year. (KNO)

### Ramban: 18 houses develop cracks amid land sinking

Ramban, Sep 12: Incessant rains, inclement weather conditions and flash floods that caused massive landslides in Ramban District last month have led to increase in land sinking and slipping incidents in the area, with a significant portion of land in Panchayat Tangar reportedly sliding to-wards the Chenab River. According to the details, the

slipping and sinking of land has created fear and panic in the

kilometers from Ramban near the Sawlakote Power Project said that cracks had been appearing in the area for at least a year. However, after the recent rains, land sliding has accelerated. "So far, cracks have appeared in at least 18 residential houses, one shop, and the High School Tangar in several wards of Panchayat Tangar, with the high school building declared unsafe," they said, adding, "If the land sliding continues, more than 13 additional houses and other infrastructure in the area will be at severe risk."

Locals added that a 2.5 to 3-kilometer stretch of the Tangar

area is gradually sliding down towards the Chenab River, causing concern for nearly the entire population.

Due to the cracks, Ward No. 1, Ward No. 2, Ward No. 3, and other areas are at risk, while in Ward No. 7 (New Baas), there have been recent incidents of house collapses and fresh land sliding.

Since last night, several electric poles have collapsed due to the shifting land, causing a power outage in Ward No. 2. They also noted that land from the mountain above has slid several hundred feet downhill, and if the ongoing land movement could spell a major catastrophe for large parts of Tangar.

Deputy Commissioner Ramban, Muhammad Ilyas Khan the Member of the Assembly for Ramban, Additional SP Mujeeb ur Rahman. along with district officers and engineers, visited Tangar to assess the situation and the extent of the damage.

The Deputy Commissioner instructed Tehsildar Rahmat to remain stationed in the area. while teams of Revenue Department, Police, and SDRF teams have been placed on alert in the affected areas to respond to any situation. (KNO)

### Qazi Hamam street in shambles, locals seeks action

Baramulla, Sep 12: The residents of Qazi Hamam in Baramulla here have expressed strong resentment over the decades-long neglect of the vital street leading to Ziyarat Dastageer Sahab, saying that despite repeated pleas to the authorities, no repair work has been carried out since 2004.

Locals said that the vital street, which houses more than 300 households, has been lying in a dilapidated condition for years, yet no concrete repair or developmental work has been initiated.

Despite repeated representations to the Roads & Buildings (R&B) department and Municipal Council Baramulla, the residents say the issue has been left lingering with only estimates prepared over the last five years.

"Only tall claims of development

are being made on social media, but on the ground, nothing changes. This road has not seen any proper renair for decades. Every t approach the authorities, we only get assurances, never action," said a local resident.

Muzamil Mushtag, the Mohalla head, said that the lane was last repaired in 2004 and ever since, no official has visited the area to review its condition. "It is unfortunate that a street located barely a kilometre from the district headquarters has been left in such neglect."

Residents noted that the street provides access to Masjid Shareef and the revered Ziyarat Dastageer Sahab while also serves as a major connecting route for the entire mohalla. They appealed to the authorities for immediate intervention to avert further hardship and damage.

Meanwhile, the officials at Municipal Council Baramulla said the matter will be looked into. (KNO)

# 15 September 2025: ITR Deadline What Every Taxpayer Should Know

The 15 September 2025 deadline (extended from the usual 31 July) is for non-audit cases. This includes filers under ITR-1 to ITR-4.

Filing an Income Tax Return (ITR) is an important compliance requirement under the Income Tax Act. It enables individuals and entities to declare their income, report taxes paid, and claim refunds where applicable. Timely filing helps avoid penalties, ensures faster processing of refunds, and also serves as an official financial record for availing loans, obtaining visas, and fulfilling other financial requirements.

For FY 2024-25 (AY 2025-26), the Central Board of Direct Taxes (CBDT) has extended the due date for non-audit taxpayers, including most individuals, Hindu Undivided Family (HUFs), and other entities not subject to audit, to 15 September 2025.

Non-Audit Tax Filing

A non-audit case is when a taxpayer's accounts are not required to be audited under the Income Tax Act. This generally includes: Individuals and HUFs with income from salary, pension, house property, capital

gains, or other sources. Small businesses and professionals who opt for the presumptive taxation scheme (Sections 44AD, 44ADA, 44AE) and whose turnover does not cross the limit requiring

Financial Year (FY):

The Financial Year is the year in which you earn your income. For example, if you earn income between 1 April 2024 and 31 March 2025, that period is called Financial Year

2024-25 (FY 2024-25) Assessment Year (AY):

The Assessment Year is the year immediately after the Financial Year, in which you file your Income Tax Return (ITR) and the government assesses (checks) the income earned in the previous year. For example, income earned in FY 2024–25 will be reported and assessed in Assessment Vear 20 (AY 2025-26)

IMPORTANCE OF FILING ITR What is ITR and Who Should File?

An ITR (Income Tax Return) is a form to declare your income and taxes. You should

Filing ITR goes beyond a statutory requirement and plays a vital role in strengthening both personal financial credibility and the nation's economy. It reflects rising incomes, employment, and the growing formalisation of the economy. For individuals, regular filing helps build creditworthiness, which is essential for availing loans, securing visas, and entering business contracts. It also enables taxpayers to claim refunds for excess taxes paid and ensures the carry-forward of losses for future setoffs.

For the government, ITR data is an important tool for policy planning, subsidy targeting, and broadening the tax base. It provides valuable insights into income patterns and economic activity, aiding in better governance. Subsequently, timely and accurate ITR filing contributes to a transparent, documented, and accountable economy, strengthening both compliance and financial inclusion.

Late Filing Fees

A late filing fee is levied if the return is furnished after the specified due date. A fee of Rs 5,000 is payable for returns filed after the due date. However, in cases where the total income does not exceed Rs 5 lakh, the late fee is restricted to Rs 1,000.

In addition, a delay in filing attracts 1% interest per month on the pending tax amount, in addition to the late filing fee. Categories of ITR

The Income Tax Department notifies different ITR forms each year to suit various categories of taxpayers. Selecting the correct form is essential, as filing in an incorrect form may render the return defective. For FY 2024–25 (AY 2025–26), the following

forms are applicable to non-audit taxpayers, including individuals and small entities: ITR-1 (Sahaj) – For Salaried Individuals

AY 2025-26) When filing an Income Tax Return (ITR), taxpayers are required to choose between the Old Tax Regime and the New Tax Regime. This choice determines how income will be taxed and whether deductions and exemp-

tions can be claimed. The Old Regime continues the traditional system of higher tax rates but provides a wide range of exemptions and deductions under the Income Tax Act, making it more suitable for individuals who plan their finances through investments and savings. In contrast, the New Regime, introduced in the Union Budget 2020, aims to simplify taxation by offering reduced slab rates with minimal exemptions. It is especially helpful for taxpayers who prefer a straightforward system without the need for detailed tax planning or documentation. From FY 2023-24 onwards, the New Regime has been made the default option, though taxpayers retain the flexibility to opt for wh benefits them more.

The old tax regime features higher slab rates, while the new tax regime offers lower slab rates.

Under the old regime, taxpayers could avail of a standard deduction of Rs 50.000. along with a wide range of exemptions such as those for investments, insurance, home loan interest, and others. In contrast, the new regime provides limited exemptions, including a standard deduction of Rs 75,000, deductions for employer's NPS contributions, and family pension deductions.

Regarding investments under Section 80C, the old regime allows deductions for investments in Provident Fund (PF), Life Insurance

ings have shown consistent growth over the years, reflecting rising compliance and widening of the tax base. For AY 2024–25, a record 7.28 crore ITRs were filed up to 31 July 2024, compared to 6.77 crore in AY 2023-24, registering a 7.5% year-on-year growth.

Out of the total filings, 72% of taxpayers (5.27 crore) opted for the New Tax Regime, while 28% (2.01 crore) continued with the Old Regime. The e-filing portal also handled record activity on the due date (31 July 2024), with 69.92 lakh returns filed in a single day. Importantly, the tax base continued to expand, with 58.57 lakh first-time filers joining in AY 2024–25.

Conclusion

The extension of the due date for filing Income Tax Returns for FY 2024-25 (AY 2025–26) to 15 September 2025 provides additional time for taxpayers to complete their compliance obligations. Data from CBDT shows that ITR filings have recorded steady growth, with 7.28 crore returns filed up to 31 July 2024, reflecting both increased digital adoption and widening of the tax base. The growing participation of first-time filers, alongside the majority opting for the New Tax Regime, indicates a shift towards simplified compliance and greater formalisation of the economy. Timely and accurate filing of returns con-

tinues to play an important role in strengthening financial credibility for individuals and in supporting effective governance for the country. Rising ITR filings demonstrate the success of government initiatives aimed at ease of compliance, transparency, and expanding taxpayer participation in India's

# Empowering sanitation workers for safety and dignity

Action for National Sanitation Mechanised Ecosystem (NAMASTE) scheme, launched in July 2023 by the Ministry of Social Justice and Empowerment (MoSJE) and Ministry of Housing and Urban Affairs (MoHUA), aims to ensure the safety and dignity of sanitation workers by preventing hazardous cleaning and promoting safe, mechanized practices through trained and certified workers.

The scheme targets zero fatalities in sanitation work, eliminates direct contact with human faecal matter, ensures all cleaning is done with safety devices by skilled workers, strengthens Emergency Response Sanitation Units (ERSUs) and empowers workers through Self-Help Groups (SHGs) and

entrepreneurship.

The scheme is to be implemented in all 4800+ Urban Local Bodies (ULBs) of the country, during the three years up to 2025-26 with an

outlay of Rs. 349.70 crore[1]. Key Components of NAMASTE Scheme

Profiling of SSWs (Sewer/Septic Tank Workers): NAMASTE compiles a comprehensive database of SSWs by collecting their details from Urban Local Bodies (ULBs). Detailed profiling is conducted through dedicated profiling camps to gather essential information about SSWs.

Occupational Safety Training and PPE Kits Distribution: SSWs receive training on occupational safety and provided with Personal Protective Equipment (PPE) kits to ensure their safety during work.

Support for Safety Devices to Sanitation Response Units (SRUs): SRUs engaged in hazardous cleaning operations are being equipped with necessary safety devices to enhance their safety and efficiency.

Health Insurance Coverage under Ayushman Bharat-PMJAY: Identified SSWs and their families are being enrolled under the Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) to provide a health safety net. The premium for those not previously covered, including manual scavengers and SSWs, to be funded through NAMASTE.

Livelihood Support and Enterprise Development: The Action Plan emphasizes mechanization and entrepreneurship by offering funding supal subsidies through the National Safai Karamcharis Finance & Development Corporation (NSKFDC). This includes assistance for SSWs, manual scavengers, and their dependents to acquire sanitation-related equipment and vehicles under the Swachhata Udyami Yojana (SUY), fostering their transformation into Sanipreneurs. Additionally, capital subsidies for self-employment projects and skill development training (up to two years with a monthly stipend of Rs. 3,000) to be provided to identified manual scavengers and their dependents.

Convergence of MoSJE and

MoHUA Programs: NAMASTE aims to enhance coordination between the Ministry of Social Justice and Empowerment (MoSJE) and the Ministry of Housing and Urban Affairs (MoHUA) to ensure the safety and welfare of SSWs. The Action Plan integrates financial resources from existing programs like Self Employment Scheme for Rehabilitation of Manual Scavengers (SRMS), Swachh Bharat Mission Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM), and National Safai Karamcharis Finance & Development Corporation (NSKFDC) to provide comprehensive occupational, social, and financial support

Information, Education, and Communication (IEC) Campaign: Extensive awareness campaigns being conducted by ULBs and NSKFDC, utilizing electronic and print media, hoardings at prominent locations, and social media platforms. These campaigns are in local languages, English, and Hindi to maximize outreach and inform SSWs about NAMASTE's interventions.

MIS and Dedicated Website: A robust Management Information System (MIS) being implemented, supported by a dedicated NAMASTE website, to ensure effective monitoring and data management of the program's initiatives.

Relevance of NAMASTE Scheme The NAMASTE scheme is a critical initiative addressing the dire challenges faced by Sewer and Septic Tank Sanitation Workers (SSWs) in India, aiming to transform their occupational safety, health, and dignity through systemic interventions. The necessity and transformative impact of the NAMASTE scheme can be further exemplified through the following[2]:

Waste Pickers are vital to India's solid waste management (SWM) ecosystem, significantly contributing to recycling efforts and reducing landfill waste, yet they face challenges like lack of formal recognition, poor working conditions, and limited access to social security. Despite being acknowledged in regulations such as the Second Labour Commission and the SWM Rules, 2016, Urban Local Bodies (ULBs) have not fully integrated Waste Pickers into waste collection, segregation, and recycling activities through Material Recovery Facilities (MRFs). The Waste Pickers component of the NAMASTE scheme seeks to address these gaps by formally integrating Waste Pickers into the solid waste value chain, enhancing waste management efficiency, promoting environmental sustainability, and improving their livelihoods. This initiative aims to provide formal recognition, access to financing, appropriate technologies, and a safe, sustainable work environment, while also linking Waste Pickers to social security and welfare schemes to enhance their overall well-being.

The Waste Pickers component of the NAMASTE scheme is tailored to tackle the challenges and needs of individuals engaged in collecting, sorting, and managing solid waste. It focuses on supporting Waste Pickers, Collectors, and Sorters, who are vital to the solid waste management system but frequently operate in informal and precarious conditions[3].

# **Finding Inspiration In Hard Times**

# What hurts can also heal—if we dare to face it fully

The news is relentless at the moment. In just the last few days, there have been headlines about price rises and job losses, about Israel bombing Qatar, the French government crumbling, Russian drones in Poland, and a new political assassination in the U.S.

Technology, which was supposed to make our lives easier, seems instead to be magnifying our problems. Serious people warn of the risk of AI taking over the world and making human beings extinct—and still we develop it unchecked. Social media is alive with howls of rage and polarization. Our phones buzz and ping without reprieve, external manifestations of the chaos inside.

We are exhausted and we are frightened. And we face our troubles alone. more alone than we have ever been, as community fractures and loneliness rises.

When Struggling Makes Sense There is a taboo in our culture against struggling. Being unhappy is perhaps

the last mortal sin. And this taboo is actually one of the most exhausting parts of the hard times we live in right now. It's the source of the voice that tells us we shouldn't

be finding things hard. It's the source of the internal critic who tells us that we should always be grateful, that we should be calm, that we need to stay positive and upbeat and use a growth mindset to turn exploding bombs into a learning opportunity.

I've got nothing against gratitude or a growth mindset. As a matter of fact, I practice both daily and have written about it a fair amount. But there is also a place for grief and anger.

The truth is that life is hard right now. In a world turned upside down, a world in which black is sold as white and good is insulted as evil, suffering is not a character flaw. Exactly the op-

Suffering is evidence that there is still something pure and true inside us. It tells us that our eyes can still see and our hearts can still feel

In a world like ours, suffering is evidence that we remain alive to love and beauty and hope.

Staying With What Hurts In Buddhism, there's a story about the two arrows that pierce human be-

ings. We can think of the first arrow as

the suffering that life directly throws up.

It consists of things like physical pain,

grief when we lose someone we love, anger when we see injustice, and so on. In our context, the first arrow is the pain and anger and fear and sorrow we feel right now about how the world is.

The first arrow is inevitable. The second arrow isn't. The second arrow consists of the suffering we cause ourselves by how we react to the pain of the first arrow. Instead of simply feeling angry, we add the pain of thinking that we shouldn't feel angry. Instead of only the suffering of sorrow, we add the pain of resisting it, of thinking we are bad or weak for feeling it.

Our usual reflex, says the Buddhist teacher Pema Chodron, is to avoid the first arrow. We distract ourselves. We numb ourselves. We try to talk ourselves into feeling better.

But we all know how that goes: badly. The more we push it away, the more we distract ourselves, the more we will eventually suffer.

So instead, suggests Chodron, we might try leaning into the pain. What does this mean? It means having the courage to simply experience our suffering without pushing it away. One way of doing this is to try to meet our experience with curiosity instead of commentary. If fear arises, we notice it: This is fear; I notice my breath is shorter. If grief swells, we give it space: This is grief, heavy in my throat.

And this kind of attention also reduces the suffering of the second arrow. Pain is unavoidable, but the layers of resistance, denial, and shame can be softened. The Power of Pain

When we stay with our pain, something begins to happen.

Pain, you see, isn't just a weight. It's also information. Our feelings- as philosophers and psychologists have long recognized-

aren't just natural. They're also useful and even necessary for a well-lived life. This is true of "negative" feelings as much as positive ones; for example, anger is hard to feel, but sometimes it is the right response, and it can motivate

fighting against injustice. When we stay with our grief and our anger, when we face it with honesty and tenderness, it ripens into a path to meaning. It tells us what matters and lights the path forward.

And that is why it matters that we stay with the pain. To stay with the pain means to stay with what matters. It means that we do not abandon our values; instead, we have the courage to suffer for them.

This is not abstract theory. I write from hard-won experience. As I've written about before, this is exactly what happened to me when my teenage son was diagnosed with cancer. From pain came purpose.

The Gift of Meaning

Human beings have incredible, unimaginable strength. And the key to unlocking it is meaning.

Viktor Frankl gives us the most breathtaking proof of this when he writes of his experience in the concentration camps. The people who survived, he says, the people who remained whole, were those who found meaning in even those surroundings.

A person to love, a duty to fulfill, a vision of the future—just a single thread of meaning gives us the strength we need to endure almost anything.

Meaning doesn't erase or deny suffering. In fact, it may even magnify it. But meaning situates that suffering in a larger story. It roots us in what we love and reminds us why we fight.

Meaning is love refusing to give up. It is a candle lit in the darkness, a fist waved at the heavens. It is the strength that allows us to say: This matters—and so do we.

Here are three small, ordinary practices that can help you access the power of meaning in your daily life:

Return to your body. Take three slow breaths, unclench your jaw, and place both feet firmly on the floor. Remind yourself: I am here. I can meet this moment.

Name your "why." When you feel overwhelmed, pause to recall what matters most-a person, a value, a cause. Write it down or speak it aloud.

Take one deliberate step. Choose a small action aligned with your values: Check in on someone vulnerable, offer time or resources, or protect an hour for genuine rest.

The world may still feel heavy. But meaning gives us the strength to bear its weight—and the energy to change it.

# India-EU working to finalise ground-breaking FTA by year-end

New Delhi, Sept 12: India and the European Union are working with sincerity and commitment to finalize a comprehensive and balanced Free Trade Agreement that will benefit businesses and consumers on both sides, said Union Minister of Commerce and Industry Piyush Goyal addressed the 65th Annual Session of the Automotive Component Manufacturers Association (ACMA) today. The Minister noted that such an agreement cannot be a one-sided arrangement, as every negotiation involves a

The Minister said that it is important not to let the search for a perfect deal become the enemy of progress, and stressed that the direction in which the negotiations are moving is extremely positive. He expressed confidence that the possibilities being unlocked through this process are immense and will open up opportunities for trade, investment, technology transfer, and deeper economic

engagement. The Minister said he is confident that a bold and forwardlooking industry such as the automotive component sector, which has consistently demonstrated strength in earlier FTA negotiations, will find the

provisions being crafted under the India-EU partnership to be attractive and full of potential.

He expressed confidence that automotive component sector, which has always lent strength in FTA negotiations, will find the arrangements being worked out between India and the EU attractive, exciting, and full of potential for businesses to grow, collaborate, innovate, and engage in research and development. The Minister underlined that the sector has consistently demonstrated resilience and foresight, not only by supporting India's domestic manufacturing base but also by integrating with global value

Goyal said that the FTA will open new avenues for Indian manufacturers to partner with their European counterparts and with companies from other parts of the world, thereby encouraging joint ventures, technology partnerships, and collaborative innovation. He noted that India offers significant advantages in terms of cost competitiveness be it in design, development, or R&D-and combined with the country's skilled talent pool, this will make India an increasingly attractive hub for global automotive companies. He added that such partnerships will help bring down costs, enhance productivity, create jobs



for Indian youth, and further position India as a leading centre for high-quality automotive component manufacturing.

The session was also addressed by the H.E. Maroš Šef ovi , Commissioner for Trade and Economic Security, Interinstitutional Relations and Transparency, European Union. He observed that India and the EU are negotiating a groundbreaking Free Trade Agreement with unprecedented momentum, describing the ongoing discussions as some of the most intensive and constructive ever held between the two partners. He noted that while negotiations on an FTA had been attempted in the past, never before had the process reached such a level of seriousness, mutual trust, and shared ambition. The Commissioner said that efforts are being maximised to finalise the negotiations by the end of the year, in line with the commitment made earlier by Prime Minister Narendra Modi and European Commission President Ursula von der Leyen.

He underlined that both sides are striving to put in place an economically meaningful package that balances the interests of producers, exporters, and consumers in equal measure. He stressed that the objective is to arrive at a truly win-win agreement that not only facilitates the exchange of goods and services but also promotes investment, innovation, sustainable practices, and deeper cooperation between the two regions. He added that India is fast becoming a key engine of the global economy and that a strong economic partnership with India will add significant value to the European Union, just as Europe's technology and scale will benefit India's growth story. Goyal further underlined that the India-EU FTA will be a comprehensive economic partnership with strategic elements. He said that India will benefit from Europe's technology and innovation, while the EU will benefit from India's growth story, scale, and resilience. He also noted India's aspiration to increase vehicle penetration from 34 cars per thousand people today to significantly higher levels, creating opportunities for the auto component industry to expand

globally. The Minister recalled that as Prime Minister Narendra Modi has said, the automobile industry has been the torchbearer of the Make in India programme. As India marks 10 years of Make in India, the Minister said this is an opportune time to aim higher, strengthen supply chains, build resilience, and contribute significantly to jobs, exports, and high-quality

manufacturing.
The Minister praised India's resilience during the COVID-19 pandemic, noting that the country upheld every global commitment, from providing medicines and vaccines to over 100 countries, many free of cost, to ensuring availability of essential goods without profiteering. He said this earned India the trust of the world,

and today the country is looked upon as a reliable and trusted partner.

The Minister commended the recent GST reforms announced under the leadership of Prime Minister Narendra Modi. He said that reducing GST rates from 28 percent to 18 percent is a landmark reform and a huge relief for the auto industry. For tractors, GST has been reduced to 5 percent, giving a major boost to the agriculture sector. He said this reform deserves a standing ovation for the Prime Minister, as it will make spare parts more affordable, strengthen formalisation, generate jobs, and expand demand across the value chain. He stressed that the benefits must be fully passed on to consumers.

The Minister said that this round of GST reform is the biggest reform since Independence and every Indian stands to gain. He emphasised that there will not be a single citizen out of 1.4 billion who will not benefit from these reforms.

The Minister concluded by quoting Ratan Tata: "Take the stones people throw at you and build a monument." He said the sector and the nation must not be deterred by challenges, and with confidence, resilience and collective effort, India will continue to grow stronger.

"After completing the public consultation process and holding discussions with entities and stakeholders during the Open House, PNGRB has decided to invite online Application-cum-Bid for authorization of the Petroleum Product LPG pipeline to be developed from Jalandhar to Jammu, spanning approximately 230 km with a minimum system capacity of 0.30 MMTPA, including common carrier capacity throughout its economic life,' the documents state.

An analysis of the project by Deloitte estimates that the pipeline will generate savings of Rs 231 crore, eliminate 0.4 million road tanker trips, and reduce carbon emissions by 0.42 mil-

The study further reveals that the pipeline project would require an expenditure of Rs 830 crore. (KNO)

### CP Radhakrishnan

On Tuesday, when he was elected as the vice president, his mother Janaki Ammal fondly recalled the story behind his name.

"When my son was born, the then President Radhakrishnan was in office. He was a teacher. and I too was a teacher. In his memory, I named my son after him. At that time, my husband looked at me and asked, 'are you giving this name because you want your son to become the President one day?'

After 62 years, just as my husband had said, it has come true," she had told reporters in Tamil Nadu.

Radhakrishnan on Tuesday described his election to the second-highest Constitutional post as a victory of the nationalistic ideology and vowed to work towards making India a developed nation by 2047.

He won the vice presidential election by bagging 452 votes, while the opposition candidate, B Sudershan Reddy, polled 300 votes.

"The other side camp (opposition alliance) said that this (election) is an ideological fight, but from the voting pattern, we understand that the nationalistic ideology has emerged victorious," Radhakrishnan said in his first public remarks after the win.

"It is a victory for every Indian; we all have to work together. If we have to develop Viksit Bharat by 2047, which means we should not do politics in everything, now we will have to concentrate on development," he had said.

A two-term member of the Lok Sabha from Coimbatore during the tenure of prime minister Atal Bihari Vajpayee, Radhakrishnan came close to becoming a Union minister, but had to lose out to fellow Tamilian Pon Radhakrishnan in 1998 after some confusion over his name by the then floor managers of the BJP.

Radhakrishnan joined the Rashtriya Swayamsevak Sangh (RSS) as a teenager and rose through the ranks in the organisation and later in the BJP, gaining acceptability in the party and the state.

A member of the socially dominant and economically prosperous Kongu Vellalar Gounder community, he became the secretary of the BJP's Tamil Nadu unit in 1996 and served as the party's state unit president between 2003 and

An avid sportsperson, Radhakrishnan was a college champion in table tennis and a long-distance runner.

He also enjoys cricket and volleyball. Radhakrishnan is considered an untainted leader with rich political and administrative experience for the vice president's office and this would also prove useful as the chairman of the Rajya Sabha.

"Thiru CP Radhakrishnan Ji has rich experience as MP and Governor of various states. His Parliamentary interventions were always

During his gubernatorial tenures, he focused on addressing challenges faced by common

It is worth mentioning that a Cath Lab at GMC Anantnag has already been made functional, and work is underway to start an MRI facility there by year-end.

The government has also decided to strengthen Telemedicine services across J&K with 80 new units, aiming to connect patients in far-flung areas with specialists at tertiary care hospitals. "This will bridge the gap between rural areas and advanced medical care. Patients in border and hilly regions will be able to consult doctors without having to travel long distances," a senior health official said.

The series of diagnostic and treatment facility upgrades is being seen as a crucial step in reducing the dependence on private hospitals and easing the burden on existing government medical colleges.

# Stage set for PM's maiden visit to Manipur since 2023 ethnic clashes

Imphal, Sept 12: Prime Minister Narendra Modi is scheduled to set foot in Manipur on Saturday, over two years after a deadly ethnic violence swept the northeastern state, and unveil projects to the tune of Rs 8,500 crore, officials said.

Modi will lay foundation stones for various development projects worth Rs 7,300 crore from Peace Ground in Churachandpur, where Kukis are in the majority. The PM will also inaugurate infrastructure projects totalling Rs 1,200 crore from Meitei-majority Imphal, they said. The prime minister's visit comes amid repeated criticism by opposition parties for not coming to the state following the ethnic strife between the Kuki and Meitei communities, which has left over 260 people dead and thousands homeless since May 2023.

The Manipur government had on Thursday evening put up a large billboard, announcing the PM's programmes at Churachandpur's Peace Ground and Kangla Fort in Imphal on Saturday.



The hoarding came up at Keisampat Junction, a key location in Imphal, which is also close to the BJP's state headquarters.

More such billboards were put up in the state's capital Imphal, aĥead of Modi's visit.

Manipur has been under the President's Rule since February, following the resignation of chief minister N Biren Singh.

Both state and central forces' personnel were deployed in large numbers in and around the nearly 237-acre Kangla Fort in Imphal and the Peace Ground in Churachandpur, where a grand stage is being readied for the event. Central security teams, accompanied by state personnel, are conducting round-the-clock inspection of the Kangla Fort, and boats of the Manipur disaster management force have been engaged for patrolling the moats that surround the fort, they said.

Police and paramilitary forces have also been deployed and bamboo barricades constructed along the route leading to the Peace Ground.

Manipur's lone Rajya Sab-ha MP Leishemba Sanajaoba described the PM's visit as a "very fortunate" one for the people and the state.

"It's a great fortune that Modi

will be listening to the hardships faced by the people...Manipur has had a history of violent clashes in the past. However, no prime minister has visited the state during such times and listened to people," the BJP MP said. Leading Kuki-Zo groups have also welcomed the Prime Minister's visit to Manipur, terming it as a "historic and rare occasion".

The Kuki-Zo Council, one of the organisations representing the community, claimed that the scheduled visit comes nearly four decades after a prime minister last came to the region.

"We place our trust in your leadership to heal our wounds, restore our dignity, and safeguard the future of the Kuki-Zo people," the council said, referring to Modi's visit.

Several other organisations representing the Kuki-Zo community also hailed the PM's visit, but opposed a planned dance programme as part of a ceremony to welcome him.

A women's organisation 'Imagi Meira' stated that Modi should direct officials to allow Meiteis to move along the National Highway and ensure their safety.

### Fear of India's strength fuels tariffs: Bhagwat

# SC flags hostile discrimination against persons with disabilities

New Delhi, Sept 12: Flagging the hostile discrimination against persons with disabilities in employment, the Supreme Court on Friday asked the Centre whether measures were taken to provide "upward movement" of such meritorious candidates if they secured more than the cut-off for the unreserved category.

The apex court also directed a nationwide monitoring of all state-run care institutions housing persons with cognitive disabilities to be undertaken under the name and style of "Project Ability Empowerment" by eight National Law Universities.

A bench of Justices Vikram Nath and Sandeep Mehta delivered its verdict on the pleas seeking judicial intervention for addressing the systemic barriers faced by persons with disabilities and ensuring enforcement of statutory safeguards.

The bench dealt with the aspect of reservation under the Rights of Persons with Disabilities Act, 2016, and said it was imperative to make a positive interpretation



of "reservation" as provided under Section 34 of the Act.

Section 34 of the Act deals with reservation in employment for persons with disabilities.

The bench referred to an important facet of reservation to persons with disabilities and the grave discrimination being faced by them, as against those who face discrimination as a result of a societal setup.

"The latter category of persons is entitled to social reservation under Article 16 of the Constitution of India, which provides an upward movement in case the person belonging to such reserved category performs well in the evaluation process and stands higher in merit above the cut-off for the unreserved category," the bench said in its 65-page verdict.

It noted such a meritorious candidate would automatically move up to the unreserved category, leaving the reserved seat vacant to be occupied by a candidate from the reserved category who scored less in the evaluation process.

### Govt announces annual licensing policy for opium poppy cultivation for 2025-26 crop year

New Delhi, Sept 12: The Union Government on Friday announced the annual licensing policy for crop year 2025-26 during the Opium Crop Year from 1st October 2025 to 30th September, 2026, of license for cultivation of opium poppy, for the farmers in the states of Madhya Pradesh, Rajasthan and Uttar Pradesh

As per the general conditions enshrined in the policy, nearly 1.21 lakh farmers are estimated to be eligible for the grant of licenses for opium cultivation in these states. This represents a 23.5% increase over the number of licenses actually issued in the previous crop year. The policy thus brings approximately 15,000 additional farmers into the fold, who are expected to benefit from opium cultivation this year.

The Central Government continues to ensure adequate supply of alkaloids to meet medical and palliative care the Concentrate of Poppy



needs. Concurrently, efforts are underway to augment processing capacity through indigenous and self-reliant measures, with a view to meeting the requirements of alkaloids for the production of essential narcotic drugs.

Key features of the annual license policy include: Retention of existing opium gum cultivators who have achieved an average morphine yield (MQY-M) of 4.2 kg per hectare or above; and existing opium gum cultivators with morphine yields between 3.0 kg and 4.2 kg per hectare are now eligible to cultivate unlanced poppy straw under

Straw (CPS) method, with a five-year license validity Furthermore, the digiti-

zation of cultivators' data since 1995-96 has enhanced inclusivity, enabling marginal farmers from past years to access licenses by meeting the prescribed eligibility and relaxed criteria

The Government proposes to incentivise high-performing farmers, who have achieved yields of 900 kg/ hectare and above of unlanced poppy straw, by offering them the option to switch to the traditional method of opium gum cultivation. This transition is intended to promote higher yields of opium from

their holdings, while also serving as a positive reinforcement mechanism to reduce the risk of diversion from the field. Simultaneously, the Government will suspend licenses for the crop vear 2025-26 for farmers under CPS cultivation who did not meet the prescribed Minimum Qualifying Yield (MQY) of 800 kg/hectare during the previous crop year (2024-25).

The Government has been actively working to upgrade the capacities of its Opium and Alkaloid Factories. Notably, this year, the Government Alkaloid Factory at Neemuch has achieved WHO GMP certification. The policy seeks to balance Atmanirbharta (self-reliance) for government-regulated alkaloid units, while simultaneously supporting Indian pharmaceutical companies in alkaloid APIs and formulations. By leveraging their technical expertise and brand credibility, the initiative aims to promote the "Make for World" vision.

# **Blood Cholesterol vs Brain Cholesterol:** Difference and impact on memory & health

New Delhi, Sept 12: Cholesterol gets painted as the villain in health conversations. It's linked to clogged arteries, heart disease, and lifestyle diseases that scare many households. But here's the twist: cholesterol is not just a "bad fat." In fact, without it, the brain wouldn't work the way it does. Nearly a quarter of the body's cholesterol lives inside the brain, where it powers memory, learning, and nerve cell communication. The interesting part? Blood cholesterol and brain cholesterol are two very different players, each with its own role in health and disease

Two different worlds: Blood vs brain cholesterol

Cholesterol in the bloodstream and cholesterol inside the brain may share the same name, but they don't interact directly. The

brain is sealed off by a protective shield called the blood-brain barrier, which does not allow cholesterol from the blood to pass through. This means the brain manufactures its own cholesterol independently. In short, blood cholesterol is the courier for the body, while brain cholesterol is the architect for the mind. Brain cholesterol

About 20-25% of the body's cholesterol sits in the brain. Its main task is to support synapses - the connections between nerve cells. These connections act like bridges where signals jump from one neuron to another, making it possible to learn new skills, recall a childhood song, or even recognise a familiar face. If brain cholesterol drops too low, these bridges weaken, and memory begins to falter. Scientists have linked imbalances in brain cholesterol to serious conditions like Alzheimer's and



Parkinson's disease, where memory and movement both break down.

Blood cholesterol While the brain makes its own supply, blood cholesterol cannot be ignored. Low-density lipoprotein (LDL), commonly referred to as "bad cholesterol," builds up in blood vessels and restricts oxygen-rich blood

from reaching organs, including the brain. Over time, this raises the risk of strokes and memory decline. But, research adds another layer: in older adults, slightly higher cholesterol levels sometimes appear protective. This suggests that the story of cholesterol and cognition is not just black and white, but age-dependent.

The age factor

In midlife, high cholesterol is a strong risk factor for cognitive decline and dementia later on. But in later years, some studies hint that higher cholesterol may actually support brain resilience. One explanation is that the ageing brain may use cholesterol differently, perhaps needing more of it to maintain its nerve connections. This is why cholesterol's role in memory and health is best understood through the lens of time; what harms a 45-year-old might help a 75-year-old.

Statins and the memory debate

Evidence now shows that statins do not cause dementia or long-term brain changes. In fact, by controlling high cholesterol, they may indirectly lower the risks of stroke and vascular dementia. This reminds us that context matters: treatment for blood cholesterol often protects the brain, even if the connection isn't immediately obvious.

# **British Parliament** panel opens inquiry into impact of India-UK FTA

London, Sept 12: The House of Lords International Agreements Committee has opened an inquiry this week into the impacts and implications of the UK-India Free Trade Agreement (FTA), concluded during Prime Minister Narendra

Modi's visit to Britain in July.
The cross-party panel, which includes British Indian Conservative peer Baroness Sandy Verma, is seeking evidence from experts and stakeholders as part of the parliamentary process before the Comprehensive Economic and Trade Agreement (CETA) can come into effect.

With a target to double bilateral trade to USD 120 billion by 2030, the CETA has been pitched by the Prime Minister Keir Starmer-led government as a "landmark agreement" that will increase trade by 25.5 billion pounds and UK GDP by 4.8 billion pounds annually in the long run.

"As we undertake a new programme of evidence gathering, covering the terms of the FTA, its potential benefits and disadvantages, and provisions for key UK sectors, among other issues, we encourage anyone with experience or expertise in this area to come forward and share their views with the full knowledge that they will have value and are welcome," said Lord Peter Goldsmith, chair of the International Agreements Committee. It comes as



Starmer prepares for his first visit to India as UK PM next month, when he is set to join Modi at the Global Fintech Fest (GFF) scheduled for October 7-9. The House of Lords committee is seeking evidence on a set of specific aspects including: the potential benefits and risks of the FTA for the UK; how the agreement will affect sectors across the whole of the UK; the impact on consumers in the UK; the broader economic, social, and environmental impacts of the agreement; interaction with the UK's trade and industrial strategies; the implications for the UK-India relationship; and the wider geopolitical context of the agreement. The deadline for the public call for submissions in

writing is October 14, with the committee highlighting that it is keen to hear from a diverse range of individuals and organisations.

In the following stage, a select group of individuals and trade representatives will be invited to give oral evidence on a tailored set of topics before the committee.

The House of Lords International Agreements Committee is tasked with scrutinising all of the country's treaties that are laid before Parliament under the terms of the UK's Constitutional Reform and Governance Act. Its inquiries result in the publication of a report to be tabled in Parliament as part of the ratifica-

# China's newest aircraft carrier, the Fujian, sails through Taiwan Strait

Beijing, Sept 12: China said on Friday that its third and newest aircraft carrier, the Fujian, recently sailed through the sensitive Taiwan Strait to carry out "scientific research trials and training missions" in the South China Sea.

Beijing has ploughed billions of dollars into modernizing its military in recent years, a trend that has unnerved some governments in East Asia despite China insisting its aims are peaceful.

China has two carriers in operation – the Liaoning and Shandong – with the Fujian currently undergoing sea trials. China's navy said on Friday that undertaking cross-regional trials "is a normal part of the aircraft carrier's construction process". It is "not directed at any specific target", a spokesman for the Chinese navy, Leng Guowei, said in a statement.

However, its transit through the sensitive Taiwan Strait was intended to signal "China's rise as a strong military power, and beyond that, a maritime great power", said Collin Koh, a senior fellow at the S. Rajaratnam School of International Studies in Singapore. "It's to flex China's newfound military strength and send a veritable signal



to potential adversaries," he said. Taiwan's Ministry of National Defense said Friday it had used "joint intelligence, surveillance and reconnaissance means to fully grasp the situation and responded accordingly".

Japan's defense ministry said that on Thursday afternoon it had identified three Chinese naval ships advancing southwest in waters approximately 200 kilometers (124 miles) northwest of one of the disputed Senkaku Islands, known in Chinese as the Diaoyu Islands.

"Among these, the Fujian aircraft carrier was confirmed by the Japan Maritime Self-Defense Force for the first time," it said in a statement.

Japan said in July that China's intensifying military activities could "seriously impact" its security, citing the first confirmed incursion by a Chinese military aircraft into its airspace last August in

an annual threat assessment.

China said that a coastguard fleet had "patrolled within the territorial waters of the Diaoyu Islands" on Friday. Last year, Chinese vessels sailed near the Japanese-administered islands a record 355 times, according to Tokyo.

Expanding its reach

Compared to the other seas, the South China Sea "presents a more challenging environment with harsher conditions, making the trials more rigorous" for the Fujian, said Song Zhongping, a Chinese military commentator.

After undergoing sea trials and completing further adaptive training, the Fujian will likely be commissioned into active service, Song said.

The Soviet-built Liaoning is China's oldest aircraft carrier, commissioned in 2012, while the Shandong entered service

Analysts at Washington-based think tank CSIS have said the Fujian is expected to feature more advanced take-off systems, allowing the Chinese air force to deploy jets carrying larger payloads and more fuel.

China has stepped up a massive expansion of its naval forces in recent years as it seeks to grow its reach in the Pacific and challenge a US-led alliance.

The US Department of Defense said in a December report that China numerically has the largest navy in the world, with a battle force of more than 370 ships and submarines.

Beijing said in June that its Liaoning and Shandong carrier formations conducted combat drills in the western Pacific Ocean, unsettling regional neighbors including Japan.

A Taiwanese security official also said that month Beijing had deployed its two aircraft carrier groups around the island in May.

The Chinese Communist Party has refused to rule out using force to seize control of Taiwan, a democratic, selfruled island that China insists is part of its territory.

### Nepal protest death toll rises to 51: Police

Kathmandu, Sept 12: At least 51 people were killed during violent anti-corruption pro-tests in Nepal this week, police said on Friday (September 12, 2025) in an updated toll, as the full scale of chaos that toppled the government emerges. Talks continue among the President, protest representatives, key potential figures who may lead an interim administration and the army -- which has imposed a curfew and taken charge of the streets.

At least 21 protesters were among those killed, mainly on Monday (September 8, 2025) during a police crackdown on demonstrations on social media, corruption which protesters were seen and poor governance. On brandishing automatic rifles.



Tuesday, protesters set the Parliament ablaze, KP Sharma Oli resigned as Prime Minister, and the army then took charge of the streets.

### Rs 25 billion loss to Nepal's hotel industry

Kathmandu, Sept 12: Nepal's hotel industry, a vital revenue earner of its tourism-driven economy, has suffered a loss of over Rs 25 billion after nearly two dozen hotels across the country were vandalised, looted, or torched during recent student-led anti-government protests, according to a media report on Friday.

Among the worst hit is the Hilton Hotel in Kathmandu, which alone reported damages exceeding Rs 8 billion, My Republica news portal reported, quoting a statement issued by the Hotel Association Nepal (HAN). Many other leading domestic and international brand hotels located in Kathmandu Valley, Pokhara, Butwal, Bhairahawa, Jhapa, Biratnagar, Dhangadhi, Mahottar Dang-Tulsipur also bore the brunt of the

# Australia failing to combat persistent anti-Muslim hate: Report

Sydney, Sept 12: Australia has failed to tackle persistent and intensifying Islamophobia, a government envoy said Friday, calling anti-Muslim hate a "deeply ingrained societal challenge".

At a news conference in Sydney unveiling the results of a year-long inquiry, Special Envoy to Combat Islamophobia Aftab Malik said that incidents had soared in recent years. "The reality is that Islamophobia in Australia has been persistent, at times ignored and other times denied, but never fully addressed," he said.

Without any remedies, "Islamophobia has intensified over the past two decades". Among the report's 54 recommendations to parliament and government were stronger measures to ensure accountability for hate speech and

greater support for victims. "Islamopĥobia is not only interperson-

al, it is also institutional and structural," It also called for an "independent

review" of the country's counter-terrorism laws as well as an inquiry into the cause and solutions of anti-Pales-"From vile, hate-filled graffiti, the

vandalism of Muslim property, and the verbal, as well as physical, violence towards Muslim bodies, Islamophobia is a part of everyday life for Muslim communities in Australia," the report said.

Malik, appointed last year as the inuagural holder of the envoy post, shared the experiences of a Muslim family who were approached by a stranger on the train telling them he would "love to kill them all".

# Mandaviya sets athlete-first vision, aims for India among top-10 sporting nations

New Delhi, Sept 12: Union sports minister Mansukh Mandaviya on Thursday said Indian sport must place athletes at the centre of every decision, as he set out a long-term roadmap to push the country into the world's top-10 sporting nations.

Mandaviya said the government's ongoing reforms from Fit India and Khelo India to the Target Olympic Podium Scheme (TOPS) were designed to build a holistic ecosystem where athletes, not administrators, remain the priority.

"Earlier, federations often focused more on their disputes than on athletes, but now our priority is to make athletes the epicentre of sports," Mandaviya said at the PlayCom Business of Sports Summit 2025.

"The Bill also ensures greater representation of women in sports, as we are committed to increasing women's participation.

"Sports governance should not be about creating disputes but about resolving them. That is why we have included provisions for immediate dispute redressal in the Sports Governance Bill. Special provisions have been created for athletes to safeguard their interests," he

The National Sports Governance Bill, 2025, which received presidential assent last month,



mandates the creation of a National Sports Board to oversee all federations, including the BCCI. It also ensures greater representation for women and clearer dispute resolution mechanisms.

"We want the best model, but it must be our own model. There is abundant talent across the country, and this talent must be given opportunities through the creation of a strong sports ecosystem. To ensure good governance, we introduced the Sports Governance Bill, which is athlete-centric," said the Minister.

He further outlined India's

long-term ambition. 'We have also laid out a 10-year plan and a 25-year plan

in line with the vision given by

Prime Minister Modi ji-our tar-

get is to make India a developed

nation and to place India among the top 10 sporting nations in the world. These plans are ready and will be implemented soon, with corresponding policy changes to support them," he added. Indian Olympic Association president PT Usha urged that India's future lies in grass-

roots development. "Talent is not confined to big cities or academies. It is in the smallest towns and remotest villages. A child running barefoot to school. A girl playing kabaddi in her backyard. What they need is opportunity, proper training, nutrition, facilities and above all encouragement from parents and teachers," Usha added. Mandaviya, who inaugurated the summit, later visited different sports stalls to take a look and feel of the innovations and facilities on display.
