Inaugurates Rs 35.67 cr water supply schemes in Tangmarg

Tangmarg, Sept 18: Chief Minister Omar Abdullah on Thursday inaugurated and dedicated to the public five major water supply schemes of the Jal Shakti Department in Tangmarg, promising that these schemes mark only the beginning of a broad transformation of the Gulmarg-Tangmarg Assembly constituency.

Constructed at a cost of Rs 35.67 crore, the schemes will provide clean drinking water through modern Rapid Sand Filtration Plants to 40 habitations, covering 5,473 households and over 10,000 families with a population of 32,838. The projects inaugurated today include Lalpora,

# Trucks move but fear looms

Srinagar, Sep 18: President of the Kashmir Valley Fruit Growers and Dealers Association, Bashir Ahmad Basheer, on Thursday said the movement of fruit-laden trucks, which had been stranded due to the prolonged closure of the Jammu-Srinagar National Highway, has now resumed.

### **Political leaders** decry 'house arrests' **WARIS FAYAZ**

Srinagar, Sep 18: Political leaders in Jammu and Kashmir on Thursday alleged they were put under house arrest and barred from attending the condolence meet of former Hurriyat chairman Prof Abdul Gani Bhat in Sopore. Chief Minister Omar Abdullah also criticised the move as "not good for J&K".

CM Abdullah, as per the news agency-Kashmir News Observer (KNO), called it unnecessary and damaging for the region. "What should have happened if Mehbooba Mufti or Sajad Lone had been allowed to visit Sopore? Nothing adverse could have happened. They would have offered condolences and returned. Are the security agencies so frightened that they won't even allow people to share grief? This is not good for Jammu and Kashmir," he said.

Several political leaders, including People's Democratic Party's Mehbooba Mufti, People's Conference's chief Sajad Gani Lone and others earlier claimed that they were confined to their homes and barred from visiting Sopore after the death of Prof Bhat.

Lone, taking to X, said he was put under house arrest to stop him from visiting Botingoo, Prof Bhat's ancestral village. "I have been put under house arrest in order to prevent me from visiting Botingoo, the ancestral village of Professor Ghani sahib. I fail to understand what is the need for this. Professor sahib was a pacifist and literally long retired. A final good bye is something which we all deserved", Lone posted.

Mufti too expressed anguish, saying she was locked inside her home. In a post on X, Mehbooba said the decision to place political leaders under house arrest to prevent them from visiting Sopore "lays bare the harsh and undemocratic reality in Jammu and Kashmir". She said what unfolded at Hazratbal Dargah was "a loud, unmistakable message from a people pushed to the edge" and alleged that the BJP remained "willfully blind" to the anguish and suppressed emotions of Kashmiris.

"It is becoming increasingly clear that the BJP has no interest in peace or healing in Kashmir. Instead, they seem determined to keep the region in a constant state of turmoil, weaponising pain and unrest for political mileage across the rest of the country. This cynical approach is not just irresponsible; it is dangerous and utterly reprehensible," she wrote.

Earlier, Mirwaiz Umar Farooq paid tributes and shared his condolences, describing Bhat as a seasoned voice who contributed to Kashmir's political and social landscape. "It is extremely unfortunate that when Prof Bhat's final journey came, he, his colleagues and the thousands who wished to attend his funeral, offer condolences to the bereaved family and share in the collective grief were denied this basic right. Being locked inside their homes, prevented from paying their last respects, was a cruelty that has only deepened the sorrow of his passing," the Mirwaiz Manzil said in a statement.

Prof Bhat passed away on Wednesday evening after a brief illness. He was laid to rest late evening, with leaders across the spectrum paying tributes to his "pacifist approach" and "decades-long contribution" to public life—(KNO)

Jammu, Sep 18: The verification of Electronic Voting Machines (EVMs) for the Chenani Assembly Constituency in Udhampur district of Jammu and Kashmir was conducted on Thursday under tight security, officials said.

The verification was held at the Government Degree College for Boys in Udhampur. The process involves a thorough examination of EVMs used in the recent assembly elections to verify their functionality and rule out any potential irregularities.

Officials said that the process is being carried out under the supervision of election officials to ensure transparency and accuracy of results.

Seems fuming over the entire exercise, Harsh Dev Singh told media that three out of six EVMs shown up for the verification remained non functional, while the fourth machine had some timing error. He, however, welcomed the re-verification and said that this is his first step towards the larger fight against alleged electoral discrepancies.

# Friday Brief | Obedience To Parents Holds Paramount Importance

Islam frames gratitude to parents as a lifelong duty, extending beyond their death through prayers, charity, and fulfilling their unmet commitments. In today's fast-paced world, where individualism often overshadows familial

bonds, these teachings serve as a timeless reminder. Respect for parents is not a cultural preference but a divine mandate – an act of worship that cultivates empathy, social cohesion, and spiritual purity. # Healing The Skies: Celebrating Success And Urging Action On Ozone And Climate

India's leadership in phasing out ozone-depleting substances ahead of schedule, pioneering policies, and advancing global efforts exemplify its commitment to environmental protection and climate action

orld Ozone Day is observed every year on 16 September to remind us about the ozone layer, which protects life on Earth from harmful ultraviolet rays.

The United Nations started this day in 1994 to celebrate the success of the Montreal Protocol of 1987. This agreement came after the Vienna Convention of 1985, when scientists warned about the dangers of chemicals called chlorofluorocarbons (CFCs). These steps turned scientific warnings into global action, and today the ozone layer has started slowly healing.

The theme for 2025 World Ozone Day is "From science to global action." It highlights how science alerted the world about the threat of ozone depletion, and how unity among nations led to real progress.

Every fraction of a degree matters, and every action counts. -Antonio Gueterres, UN Secretary General

UN Secretary-General António Guterres said the healing of the ozone layer shows that countries can achieve real progress when they work together and follow science. But he warned that the same urgency is now needed to fight climate change, as the world is close to crossing the 1.5°C warming limit. He urged governments to cut down harmful cooling gases under the Kigali Amendment, which could help prevent up to 0.5°C of warming by the end of the century.

Kigali Amendment

The Parties to the Montreal Protocol on Substances that Deplete the Ozone Layer reached agreement at their 28th Meeting of the Parties on 15 October 2016 in Kigali, Rwanda to phase-down hydrofluorocarbons (HFCs).

The Vienna Convention (1985) is an international agreement where countries agreed to cooperate and share information to protect the ozone layer from human activit ing its depletion

Montreal Protocol

The Montreal Protocol, adopted in 1987, is a global treaty to phase out chemicals that harm the ozone layer, such as CFCs, halons, carbon tetrachloride, HCFCs, and methyl bromide. It has been ratified by all countries and is considered the most successful

international environmental treaty, leading to the global phase-out of major ozonedepleting substances by 2010 and protecting both the ozone layer and the climate system. Role of the Global Environment Facility

The Global Environment Facility (GEF) was created to help developing countries tackle ozone depletion, climate change, biodiversity loss, and international water issues. It also supports projects to phase out ozone-depleting substances in countries with economies in transition, which are often not eligible for Multilateral Fund assistance. Between 1996 and 2000, GEF approved over \$160 million to assist 17 countries including Azerbaijan, Belarus, Bulgaria, Czech Republic, Estonia, Hungary, Kazakhstan, Latvia, Lithuania, Poland, Russia, Slovakia, Slovenia, Tajikistan, Turkmenistan, Ukraine, and Uzbekistan. Additionally, \$60 million has been earmarked to help these countries phase out HCFCs and

Methyl Bromide. India's Key Achievements under the Montreal Protocol

India has demonstrated strong commit-ment to the Montreal Protocol by phasing out key ozone-depleting substances ahead of schedule, establishing robust policies, and taking on a leadership role in global negotiations

Early ODS Phase-Out: Phased out Chlorofluorocarbons (CFCs), Carbon Tetrachloride (CTC), and halons for controlled use by 2010, ahead of Montreal Protocol

Policy Framework: Enacted Ozone Depleting Substances (ODS) (Regulation and Control) Rules in 2000, banning CFCs and halons in new equipment by 2003.

Global Leadership: Advocated for developing nations since 1989, securing the Multilateral Fund (MLF) in 1990 for technical

Phase-Out: 2013 (HCFC) Hydrochlorofluorocarbon and 2015 10% reduction targets under HCFC Phase-out Management Plan (HPMP) Stage-I, phasing out 341.77 Ozone Depleting Potential (ODP) tonnes.

RAC Servicing: Trained over 20,000 technicians in the Refrigeration and Air Conditioning (RAC) sector under the National CFC Consumption Phase-out Plan (NCCoPP) to shift to non-ODS technologies.

India – Ahead of Schedule India proactively ceased the production and consumption of CFCs from 1st August 2008, 17 months ahead of the Montreal Protocol schedule, while ensuring the supply of pharmaceutical-grade CFCs for asthma and COPD patients during the transition period. By 2010, India was approved for 343.6 MT of pharmaceutical CFCs for manufacturing MDIs, and by 2011, no CFCs were requested as CFCfree formulations were successfully developed and placed in the market. Recognizing India's progress, the 19th Meeting of the Parties (2007) decided to advance the phaseout of HCFCs by 10 years. The HCFC Phaseout Management Plan (HPMP) was prepared in close collaboration with industry, research institutions, and other stakeholders, with a Roadmap launched in 2009 to guide the accelerated phase-out schedule.

OZONE LAYER The ozone layer is a part of the stratosphere, found about 15-50 km above the Earth's surface, where most atmospheric ozone is concentrated. Ozone is a molecule made of three oxygen atoms, and its special property allows the ozone layer to act like Earth's sunscreen. It absorbs most of the Sun's ultraviolet (UV) rays, especially UV-B, which can cause skin cancer, cataracts, damage to crops, materials, and marine life. Without the ozone layer, life on Earth could not have developed as it has.

**Causes of Ozone Depletion** Ozone depletion is mainly caused by human-made chemicals such as chlorofluorocarbons (CFCs), halons, carbon tetrachloride, methyl chloroform, and methyl bromide. These substances are very stable and do not dissolve in rain, so they reach the stratosphere, where strong UV radiation breaks them down and releases chlorine or bromine. A single chlorine atom can destroy over 100,000 ozone molecules, reducing ozone faster than it can be naturally replaced. About 85% of the chlorine in the stratosphere comes from these man-made chemicals, while natural sources contribute only a small part. Volcanic eruptions can also worsen ozone loss by releasing aerosols, which make chlorine from CFCs more effective at destroying ozone.

Environmental Effects of Ozone Depletion Ozone layer depletion intensifies harmful ultraviolet (UV) radiation, triggering a cascade of environmental effects across human health, agriculture, ecosystems, animals, and

Human Health Risks: Ozone depletion increases UV radiation, raising risks of skin cancer, sunburn, premature skin aging, cataracts, blindness, and weakened immune systems. A 1% ozone decrease boosts harmful UV by ~2%, potentially causing 2 million new cataract cases yearly.

Agricultural Impacts: Higher UV levels harm crops like rice, wheat, corn, and soybeans, reducing growth, photosynthesis, and flowering. A 1% UV-B increase could cut food production by 1%, significantly affecting India's agriculture.

Marine Life Damage: Increased UV threatens plankton, disrupting aquatic food chains. Young fish, shrimp, and crab larvae face risks, potentially reducing fish yields and ocean biodiversity. Animal Health: UV overexposure may

cause eye and skin cancers in domestic and marine animals, especially under the Antarctic ozone hole.

Material Degradation: UV radiation damages wood, plastic, rubber, fabrics, and construction materials, leading to costly replacements or protection measures. OZONE-DEPLETING SUBSTANCES AND

THEIR INDUSTRY USES India's Initiatives in Addressing Ozone

Îndia has undertaken proactive initiatives to combat ozone depletion, focusing on sustainable cooling, phasing down harmful refrigerants, strengthening infrastructure, and raising public awareness.

India Cooling Action Plan (ICAP): It was launched in 2019 and is world's first cooling action plan targeting a 20-25% reduction in cooling demand, 25-40% in energy use, and 25-30% in refrigerant demand by 2037-38. It promotes energy efficiency and low GWP technologies in the RAC sector.

HFC Phase-Down Strategy: India's National Strategy for HFC phase-down, finalized in 2023, prioritizes sectors based on HFC use and low GWP alternatives, aligning with Kigali Amendment goals.

Thematic Working Groups: Six groups focus on space cooling, cold chain, RAC servicing, refrigerant demand, and R&D to implement ICAP, enhancing cooling efficiency and infrastructure.

Awareness Efforts: Ozone Cell's campaigns use multilingual videos and social media (YouTube, Facebook, X) to educate on ozone depletion and ODS phase-out.

Individual Actions to Protect the Ozone

Individuals can play a vital role in protecting the ozone layer by adopting ozonefriendly practices at home, in agriculture, in technical services, and as informed consumers and citizens.

Ozone-Friendly Consumer: Buy "CFC-free" or "ozone-friendly" products like refrigerators, air conditioners, and aerosols, and verify with sellers.

Ozone-Friendly Homeowner: Dispose Ozone-Friendiy Homeowicki of old appliances responsibly, en-Chlorofluorocarbons (CFCs)/ Hydrochlorofluorocarbons (HCFCs) are removed, and recycle halon fire extinguishers. Ozone-Friendly Farmer: Switch from

methyl bromide to safe alternatives like integrated pest management for soil fumigation. Ozone-Friendly Technician: Recover refrigerants from Refrigeration and Air Conditioning (RAC) units without venting, check for leaks, and promote recycling programs. Ozone-Friendly Citizen: Learn about ozone depletion effects and national Montreal Protocol strategies, and engage

with your National Ozone Unit (NOU).

Conclusion World Ozone Day reminds us that global cooperation and science-led action can achieve remarkable results. The recovery of the ozone layer shows that when nations unite, progress is possible, as demonstrated by the Montreal Protocol India's proactive measures early phase-outs, and sustained commitment reflect how countries can contribute to both environmental protection and climate action. As we face new challenges like climate change, every action matters—by continuing to reduce ozone-depleting and greenhouse gases, we can protect our planet and ensure a healthier. safer future for generations to come.

# Why Friends Don't Always Text Back And why you might struggle to respond to texts, too

Texting back can sometimes feel like a task too big to tackle, even when it comes to friends we value and conversations we genuinely want to have. As it turns out, not texting back is a relatively commonplace phenomenon: According to the World Economic Forum, 31 percent of people experience daily stress related to texting. Nearly 1 in 5 struggle to keep up with replies, and almost 1 in 6 admit to ignoring all messages because they receive so many.

So, why is it so hard to text back?

1. Cognitive and Emotional Overload We live in a busy world: Juggling work, family, and life means our cognitive and emotional capacity is constantly stretched. Especially for those working in professions such as teaching, social work, clinical care, or even people management, emotional labor-the act of managing both our own and others' feelings and expressions as part of a professional role-requires significant psychological energy. Compounding this is decision fatigue, a concept described by Baumeister et al. (1998), which refers to the mental exhaustion that accumulates after making decisions all day.

At the end of a long day, receiving even a welcome text from a good friend or family member requires both emotional care and decisions to be made: What tone should I use? How much should I say? Am I ready to engage in a way that's sincere? Can I emotionally be there for my friend?

As a result, we may delay responding not out of neglect but because we lack the mental and emotional resources to engage: When our mental and emotional resources are depleted, by the time we get around to responding to a personal message, we may simply have nothing left to give.

2. Texting Feels Like a Task

Unlike in-person or telephone chats, texting is asynchronous: There's no immediate back-and-forth required, which makes replying right away feel like it's optional. So, there's often a socially accepted delay between receiving a message and replying to it. This disrupts natural reciprocity, making the act of replying feel optional rather than expected (Turkle, 2011).

Because of this, texting can start to feel like a task we can do later, when we have more time or energy. But this delay activates the Zeigarnik Effect, a psychological phenomenon in which we remember unfinished tasks more acutely than completed ones. We might read a message, mentally respond, and intend to write back, yet once the moment of emotional urgency passes, the message slips into the background, buried among a long todo list, especially at the end of the day.

3. Social Burnout and Resulting Avoidance Constant communication demands, like receiving too many texts or messages throughout the day, can lead to social burnout. Social burnout is a condition where emotional energy becomes depleted from trying to maintain too many interactions, which can cause a familiar loop: You meant to reply but didn't, and now it feels like too much time has passed, and it's awkward. That awkwardness turns into guilt, and that guilt leads to

further avoidance of responding. Over time, this pattern can become a cycle of procrastination (Tangney et al., 2007). "Texting fatigue" is a real phenomenon, even for people trying to conserve their limited capacity for meaningful connection (Barley et al., 2011).

4. Individual Factors

Brown (2005) explains that the mental processes involved in initiating, organizing, prioritizing, and completing tasks can be difficult for some people.

Even when someone may want to reply, the multiple micro-steps required (like opening the text, remembering the context, formulating a response, deciding when and how to send it) can feel overwhelming. This disconnect between intention and action isn't a sign of indifference but rather a reflection of how neurodivergent brains process tasks differently. Texting back may get unintentionally deprioritized, even if the relationship behind it deeply matters. What You Can Do

If you've ever left a message unanswered for hours, days, or even weeks, you're far from alone. The act of not replying doesn't always signal a lack of care—sometimes it means you may be overwhelmed, overthinking, or simply trying to make space.

If you're on the receiving end of a friend who doesn't regularly text back right away, consider what else might be going on beneath the surface, and offer to have a conversation about it if it is beginning to affect your friendship. And if you're the one who hasn't replied yet or have difficulty texting back, tell your friend what they mean to you and why you might take a while to reply. A simple message, like "Even though I'm slow to respond and not great at texting, please know that I care about you," can help fill the

Remember, a text delayed doesn't have to mean a connection lost.

## **Babila Rakwal reviews functioning of FPOs**

SRINAGAR, SEPTEMBER 18: Commissioner Secretary Cooperative department, Babila Rakwal Thursday chaired a meeting to review the functioning and performance of Farmer Producer Organizations (FPOs) across Jammu and Kashmir and identify areas for their improvement.

The meeting was attended by Registrar Cooperative Societies, Mohammad Shafiq Special Secretary Cooperative Department, Additional Registrar Cooperative Societies Jammu, Director Finance Cooperative Department, Deputy Registrar from Jammu And Kashmir besides, Representative of NCDC, GM Anantnag Central Cooperative Bank, GM Jammu Central Cooperative Bank, MD KAMCO Bank, Chairman JKDCF and other concerned officers.

Speaking during the meetthe Commissioner Secretary directed CBBOs to put up issues and difficulties being faced by them to the department for taking up the matter with appropriate authorities. She stressed on them to maintain transparency and accountability in financial transactions and urged for strengthening governance, management structures, enhance capacity building and training for FPO

She also asked the CBBOs of ACCB and JCCB to work in coordination with their allotted mentors, so that their FPOs can start business activities by ending FY 2025-26.

The Commissioner Secretary instructed the concerned officers to provide strong institutional and financial backing to FPOs, enhancing marketing linkages, branding and value addition for farm produce. She further directed them to ensure timely monitoring and reporting of FPO activities, and maintaining robust coordination between the cooperative Department, NABARD, NCDC, and CBBOs for sustainable growth.

the meeting, Registrar Cooperative Societies gave a brief presentation on 61 Primary Agricultural Credit Societies (PACS) that have been registered as FPOs, 32 in Jammu Division and 29 in Kashmir Division. He further briefed that 25 FPOs are doing business as on date while as 7 FPOs have been provided market linkage/credit linkage

facilities by CBBOs. He also said that this review meeting is expected to lead to improved functioning of FPOs, enhanced transparency and accountability, and better achievement of targets, ultimately benefiting farmers and the agricultural community in Jammu and Kashmir.

# **Sebi clears Adani of Hindenburg allegations** | Says those behind 'fraudulent' report owe apology

New Delhi, Sept 18: In a big boost to tycoon Gautam Adani, markets regulator Sebi on Thursday cleared the billionaire and his group of stock manipulation allegations made by US short-seller Hindenburg Research, saying fund transfer between group companies did not fall foul of any regulation.

The Securities and Exchange Board of India (Sebi) in two separate detailed orders said the allegations of insider trading, market manipulation, and violations of public shareholding norms were found to be unsubstantiated after a detailed investigation.

Hindenburg, which has since shut down, in January 2023 published a damning report against the Adani Group, alleging Adicorp Enterprises Pvt Ltd, Milestone Tradelinks Pvt Ltd, and Rehvar Infrastructure Pvt Ltd were used as a conduit to route funds from various Adani Group companies to fund publicly listed Adani Power Ltd and Adani Enterprises Ltd.

Sebi said fund transfer between the stated companies was loan which was repaid with interest in various tranches before the start of its investigation.

These transactions cannot be classified as related party transactions which require disclosure, as was alleged by Hindenburg.

There was no violation of Sebi's disclosure norms as the transactions between Adicorp, Milestone Tradelinks, and Rehvar Infrastructure with the conglomerate's firms did not meet the definition of a related party, Sebi board member Kamlesh C Varshney said in the two orders.

It also found no violations involving substantial acquisition of securities or control that

could mislead investors.

As a result, Sebi concluded that there was no basis for assigning liability or imposing penalties on the Adani entities or executives.

Adani reacted to the clean chit by calling for an apology by those who spread false narratives using Hindenburg Research's "fraudulent and motivated" report.

In a post on X accompanied by the national tricolour, Adani said the Sebi clean chit has reaffirmed what his group has always maintained -- "that the Hindenburg claims were baseless". "Transparency and integrity have always defined the Adani Group," the Adani Group Chairman said. "We deeply feel the pain of the investors who lost money because of this fraudulent and motivated report. Those who spread false narratives owe the nation an apology," he said.

He signed off the post with, "Satyamev Jayate! JAI HIND!"

The regulatory clean chit follows months of scrutiny and speculation triggered by Hindenburg's damning report of January 2023, which triggered a stock rout of the listed Adani

Group companies, eroding more than USD 150 billion in value at its lowest point.

Adani Group has repeatedly denied all allegations made in the Hindenburg report and its stocks recovered most of the losses before the a broader index meltdown set in.

A Supreme Court-appointed expert panel had previously echoed similar findings, noting no prima facie evidence of wrongdoing. The apex court in January 2024 had said that no further probes into this were needed after Sebi closed its investigation. While the Sebi clean chit is a

# Climate-driven health risks may cost USD 1.5 trn to global economy by 2050: WEF

New Delhi, Sept 18: Cli-mate-related health risks can cost the global economy at least USD 1.5 trillion (over Rs 131 lakh crore) in lost productivity in the next 25 years due to rising illness and labour shortages across key sectors, a new study showed on Thursday.

The World Economic Forum report, developed in collaboration with Boston Consulting Group, assessed climate-driven health impacts in four of the most affected economic sectors: food and agriculture; the built environment; health and healthcare; and insurance. The USD 1.5 trillion estimate reflects losses in only the first three sectors, under a mid-range scenario, suggesting the burden on the global economy could be far higher, it said.

The study encourages companies to act now to protect workforce health, build operational resilience and safeguard productivity before the costs of climate adaptation become unmanageable. The findings highlighted that adapting to extreme heat, infectious diseases and other health risks accelerating due to climate change is now a strategic



business imperative.

"We are entering an era in which protecting worker health is prov-ing essential to business continuity and long-term resilience," said Eric White, Head of Climate Resilience, World Economic Forum.

"Every year we delay embedding resilience into business decisions, the risks to human health and productivity climb and the costs of adaptation rise," White added. Alongside shared disruptions, the analysis also outlined sector-specific vulnerabilities.

en disease rates among the wider population could compound demand pressures. The insurance industry, meanwhile, is projected to experience a sharp rise in climate health claims.

"As temperatures rise, millions of jobs become more dangerous - or disappear entirely – pushing families deeper into poverty and changing where and how people can live and thrive," said Naveen Rao, Vice-President for Health, Rockefeller Foundation, which supported this research.

However, the report also indicated that companies investing early in climate health adaptation can benefit beyond risk mitigation, unlocking new opportunities for innovation and growth while meeting emerging market needs.

Each sector is uniquely positioned to develop and scale solutions to emerging climate health challenges. From climate-resilient crops that protect food systems, heat-stable medications that expand medicine availability, cooling technologies that keep construction workers safe and new insurance

models protecting communities against climate health shocks, examples of innovation are already tak-

ing shape.
"Momentum on health adaptation is building, but financing and implementation are still far below what's needed," said Elia Tziambazis, Managing Director and Partner, BCG.

The report sourced health data from scientific literature and employment data, and economic cost from the International Labour Organisation and World Bank data.

The report pointed out that a global shift to health resilience must be underpinned by supportive policies, interoperable climate health data systems and innovative financing to mobilise capital.

The findings, pub-

lished ahead of the World Economic Forum's Sustainable Development Impact Meetings 2025, come as preparations intensify for COP30 in Belem, Brazil.

This year's climate negotiations are set to bring health adaptation to the forefront of the global climate agenda, signalling a unique opportunity to align private sector innovation with policy action.

# Trump declares 'Antifa' a 'major terrorist organisation'

Washington, Sept 18: US President Donald Trump on Thursday (Indian time) officially designated Antifa as a "major terrorist organisation", days after the killing of his close aide and right-wing political activist Charlie Kirk.

"I am pleased to inform our many USA Patriots that I am designating Antifa, a sick, dangerous, radical left disaster, as a major terrorist organisation. I will also be strongly recommending that those funding Antifa be thoroughly investigated in accordance with the highest legal standards and practices. Thank you for your attention to this matter!" Trump wrote in a post on his social media platform, Truth Social.

Trump did not elaborate on what parameters his administration would use to make the characterisation and what actions he would take to target a left-leaning movement. Antifa does not seem to have a centralised structure or any defined leadership. Last week, the US President

repeatedly blamed the left for rising political violence in the country, including for the murder of conservative commentator Charlie Kirk.

On Tuesday, prosecutors in Utah charged Tyler Robinson, the main accused in Kirk's killing, with aggravated murder and six other charges and announced that they will seek the death penalty. According to the prosecu-

tors. Robinson's mother told investigators that "over the last year or so, Robinson had become more political and had started to lean more to the left - becoming more pro-gay and trans-rights oriented." The document also noted that the mother stated Robinson had begun dating his roommate, a biological male transitioning to become a woman. Kirk, who was 31 years old, was delivering remarks during a campus event at Utah Valley University on September 10 when he was shot in the neck. He was rushed to the hospital but succumbed to his injuries

Kirk was the founder of Turning Point USA (TPUSA), the country's most prominent conservative student organisation.

He launched the Arizona-based group in 2012 at the age of 18, building it into a political powerhouse with over 800 chapters across US colleges.

TPUSA became a central force in mobilising young conservative voters, particularly in the 2024 election, where it played a pivotal role in boosting Trump's re-election campaign.

# Bangladesh EC bars deposed PM Hasina from voting

Dhaka, Sept 18: Bangladesh's Election Commission (EC) on Wednesday said it has "locked" the national identity cards of deposed Prime Minister Sheikh Hasina, effectively barring her from voting in the general elections scheduled for February next year. "Anyone whose national identity (NID) card has been locked cannot vote from abroad," EC Secretary Akhtar Ahmed told reporters at his office in Nirbachon Bhavan in Dhaka.

"Her (Hasina's) NID is locked," he added. Though Ahmed did not mention any other name, UNB news agency and the Dhaunnamed EC officials, reported that NIDs of Hasina's younger sister Sheikh Rehana, son Sajeeb Wazed Joy and daughter Saima Wazed Putul have also been "locked" or "blocked".

Rehana's children Tulip Rizwana Siddiq, Azmina Siddiq and nephew Radwan Mujib Siddiq Bobby, her brother-in-law and Hasina's former security adviser retired major

This season, he ranks second in MLS with 20 goals in 21 league games. Messi is also tied for sixth with 11 assists. Last season, he amassed 20 goals (tied for second in the league) and 16 assists (tied for third).

In 46 league games for the Herons overall, Messi has 41 goals and 27 assists. Across all competitions, Messi has 54 goals in 62 games.

An eight-time winner of the Ballon d'Or, Messi starred for Barcelona from 2004-21 and for Paris Saint-Germain from 2021-23. He was part of 10 league-title-winning teams in Spain and two in France, in addition to helping Barcelona capture the UEFA Champions League trophy four

# In UAE team, there is no Indian or Pakistani, we are family: Skipper M Waseem

Dubai, Sept 18: The India-Pakistan tensions have had no impact on the bonhomie within the UAE cricket team, which is a mix of expatriates from the two countries, insisted skipper Muhammad Waseem as he ducked queries on their rather dramatic and delayed Asia Cup clash against Pakistan here.

The UAE cricket team has an equal number of players of Indian and Pakistani origin with Simranjeet Singh, Rahul Chopra, Harshit Kaushik, Dhruv Parashar, and Alishan Sharafu on one side and Multan-born skipper Waseem, Haider Ali, Junaid Siddique, Muhammad Rohid, and Asif Khan making the other half. The team is like a family, said Waseem despite the tense relations between the two countries. who recently had a military showdown following the Pahalgam terror attack that claimed 26 Indian lives.

Asked if the ongoing tensions has had any effect on the inter-personal relationships within the team or if there have been any conversations in the change room,



Waseem replied in the negative. "No, we are not talking about that (Indo-Pak tensions) as we play a lot of cricket together. We are like a family here. There is no Indian and no Pakistani. We play for UAE team. We play as a family and live as a family," he said. The frosty relations caused a stir at the ongoing tournament when India skipper Suryakumar Yadav did not shake hands with his Pakistan counterpart Salman Ali Agha at the toss of their match on Sunday. There were no pleasantries exchanged even after the game as the Indians took the decision to show solidarity with Pahalgam attack victims.

An irate Pakistan threatened to pull out and blamed match referee Andy Pycroft for the fiasco, accusing him of prohibiting the traditional

exchanges. The team even delayed the start of the match against the UAE on Wednesday after the ICC rejected its demand to remove Pycroft.

The players eventually showed up after claiming to have got an apology from Pycroft even though the ICC insisted that the Zimbabwean veteran had done no wrong and that Pakistan had failed to back its allegations with any proof. UAE lost to Pakistan by 41 runs despite doing a good job with the ball, restricting the opposition to 146 for 9. Waseem's men could have appealed for a walkover after the delay caused by Pakistan as the hosts had reported to the stadium on time, which is two hours before sched-

uled start. However, the Pakistan-born Waseem made it

clear that he never thought of asking for such a decision. "First of all, this is not our

responsibility or our work. We were focusing on our game. We came here to play the game, and we did that,"

He insisted that his team was not affected by the delay caused by the Pakistani team.

"Didn't matter if we were playing on time or we were playing late. Doesn't matter if we are playing at 6:30 or 7:30 pm. This is not our work. This is organiser's work. We came here to play the game and we played the game," he said.

Waseem's bid to steer clear from any controversy was palpable as he didn't want unnecessary attention.

When asked if their pre-match routine was disturbed, he asked a counter-question, "Watching our bowling performance, did you feel that?" Waseem played in the Pakistan Super League in 2021 as a replacement player for Multan Sultans while in 2024 he was picked by Islamabad United but couldn't take part due to international commitments.
