# Industrial growth must create youth, artisan livelihoods: CM

Calls for revival of stressed MSMEs

Srinagar, Sept 19: Chief Minister Omar Abdullah on Friday directed the Industries & Commerce Department to adopt a proactive and inclusive approach in strengthening Jammu and Kashmir's industrial ecosystem, with a special focus on employment generation, sustainability and competitiveness.

Chief Minister emphasized the need for handholding of MSME units which are in distress but still revivable with minimal government intervention. He asked officials to identify such units at an early stage so these do not become defunct. "Such units can generate significant employment if supported in time," he said.

Chief Minister expressed concern on slow progress under capital expenditure during current fiscal particularly under PMEGP & REGP schemes asking the department to at least match the last year's progress.

Chief Minister also reviewed the New Central Sector Scheme aimed at encouraging new

investments and incentives provided under the scheme. CM assessed the claim wise progress achieved under the scheme and called for completion of targets fixed under the NCSS.

He also asked Industries Department to prioritize setting up of industries for which either raw material is readily available or the market is locally available for finished products.

Calling for a review of the land policy in industrial estates, Omar Abdullah stressed on ensuring early allotment

of land to Units which have deposited premium but their proposals for land transfer remain in limbo. CM gave directions for early completion of 46 new Industrial Estates and to take up development of existing industrial estates to ensure judicious and productive use of industrial land.

# India shaping its destiny through decisive action: Rajnath Singh


Says 'Op Sindoor' sent clear message

New Delhi, Sept 19: Asserting that India shapes its destiny through decisive action and preparedness, Defence Minister Rajnath Singh on Friday said that success of 'Operation Sindoor' has sent a clear message to the world that victory is a routine outcome for Bharat in any operation.

Speaking at an event held in South Block, New Delhi, to mark 60 years since the 1965 India-Pakistan war, the Defence Minister, according to the news agency—Kashmir News Observer (KNO), referred to the military response to the April 2025 terror attack in Pahalgam. "The Indian armed forces acted with firm resolve during 'Operation Sindoor'."

Pertinently, the operation was launched to avenge the Pahalgam terror attack that left 26 civilians dead. Indian armed forces destroyed the headquarters of terror outfits deep inside Pakistan and Pakistan occupied Kashmir (PoK). The skirmishes between the two countries continued till May 10. Indian forces hit 13 military and airbase targets and eliminated over 100 terrorists at nine separate locations. The hostilities ended after



Pakistan Director General of Military Operations (DGMO) called his Indian counterpart and requested for a ceasefire. Singh said, "The Pahalgam

Singh said, "The Pahalgam terror attack pushed the entire nation into mourning but did not weaken the country's will to act. The leadership decided that those responsible must face consequences that would be remembered by one and all."

Singh said, "Operation Sindoor reflects a broader shift in the country's approach towards national security. India's growing focus is on modernising its defence infrastructure, improving training, and equipping the forces to deal with any challenge. # EC axes 12 more J&K parties for failing to contest elections

Poll body enforces 6-yr inactivity rule

Srinagar, Sept 19: Nearly a month after delisting three J&K-based parties, the Election Commission on Friday deregistered 12 more political parties from the Union Territory.

According to an official order, a copy of which is in possession of the news agency—Kashmir News Observer (KNO), the poll body struck off the registration of 12 parties that failed to contest any election in Jammu & Kashmir over the past six years.

These parties did not participate in the 2019 Lok Sabha elections, the 2024 Lok Sabha

elections, or the 2024 Assembly polls—the three electoral exercises conducted by the Election Commission since 2019 in J&K.

# Apple growers reel under losses as bulk supply floods markets

Srinagar, Sept 19: The demand for Kashmiri apples has started declining in outside markets as thousands of trucks carrying the fruit arrived simultaneously after being stuck for days on the Srinagar–Jammu National Highway.

Speaking to news agency—Kashmir News Observer (KNO), growers said that not only has the bulk supply lowered the rates drastically, but the prolonged halts have also deteriorated the quality of the fruit, leaving them to count heavy

osses.

For over a week, fruit-laden trucks were stranded along the highway due to repeated closures caused by landslides and repair work.

With the road now partially

restored, nearly 5,500 apple trucks were released over the past two days, according to officials.

Growers thanked the government for allowing all vehicles and requested them to work in a way so that such a bad situation won't come to fore again.

President of Fruit

Growers-cum-Dealers Union, Bashir Ahmad Basheer, explained this: "Whenever produce in bulk quantity reaches mandis, it disturbs the entire supply-and-demand chain.

Prices are bound to go down."

He added, "This time the problem is worse, because most of this produce had remained stuck on the highway for almost a week. The fruit condition has deteriorated, yet the freight charges remain extremely high. It is a double loss

# August 14 flash floods wash away over 45 kanals of farmland in Chishoti, 350 kanals in Wadwan

Life has lost meaning, say survivors; admin promises relief after survey

Jammu, Sept 19: The remote village of Chishoti in Kishtwar district is still reeling under the devastation caused by the massive flash floods that struck the hamlet on August

According to the details available with the news agency—Kashmir News Observer (KNO) what began as another rainy day in the Monsoon turned into the darkest chapter in the village's history,



as a torrent of water, mud, and boulders swept through homes and fields, leaving more than a hundred people dead and dozens of families displaced. Those who managed to survive now find themselves staring into an uncertain and grim future.

The fury of the disaster was such that 38 farmers of Chishoti lost their entire agricultural land. For fourteen of them, the tragedy was even more merciless, their homes were flattened into rubble

by the surging waters. Today, these families neither have roofs over their heads nor land to cultivate. They are forced to live under the open sky, counting days with despair. For them, life after the flood is nothing but a long night with no sign of dawn.

According to estimates, nearly 45 kanals of land in Chishoti were washed away. The destruction extended beyond this small village; in the Wadwan area of the Madhwa subdivision, | More on P6

# CS for strengthening Nursing Education Calls it backbone of healthcare system

SRINAGAR, SEPTEMBER 19: Chief Secretary, Atal Dulloo Friday chaired a meeting to comprehensively review the quality and standards of nursing education across the Union Territory, emphasizing that nursing forms the backbone of the healthcare delivery system.

The meeting was attended by Secretary, Health & Medical Education; Principals of GMC Jammu and Srinagar; Chairperson, J&K Allied & Healthcare Council (A&HCC); Registrar, J&K Nursing Council; Principals of Nursing Colleges, and other senior officers

During the review, the Chief Secretary took stock of the functioning of newly established Nursing Colleges across districts, including the range of courses offered and the enrolment of students. He directed that diploma-level courses should be progressively upgraded to degree and postgraduate programmes in order to build advanced capacities in the nurs-

He further instructed for early completion and operationalization of Nursing Colleges at Sopore, Kulgam, Shopian, and Budgam, besides exploring the feasibility of establishing such colleges at few left out



districts. The Chief Secretary also stressed on the need to phase out obsolete courses that do not contribute meaningfully to patient care, and to introduce new courses aligned with emerging healthcare needs.

Highlighting the crucial role of quality teaching, he underscored that only well-qualified faculty should be engaged in these institutions. He called for framing Recruitment Rules for Nursing Colleges, filling up vacancies through recruitment agencies, and creating posts wherever required to ensure that standards of teaching and training remain uncompromised.

Reviewing the functioning of the recently established

J&K State Allied & Healthcare Council (SA&HC), the Chief Secretary directed that it be further strengthened with adequate manpower and robust monitoring mechanisms, in line with the National Commission for Allied & Healthcare Professions (NCAHP) guidelines and checklists for institutional

readiness. The Secretary, H&ME, Dr. Syed Abid Rashid Shah, while presenting an overview, informed that significant progress has been achieved in nursing education. Over the past year, 360 new B.Sc Nursing seats, 80 Post Basic B.Sc Nursing seats, and 25 M.Sc Nursing seats have been added across colleges in the UT.

From the next academic session, Nursing College Jammu will also offer 60 additional Post Basic B.Sc Nursing seats, he added.

It was further revealed that J&K presently has around 50 Nursing Colleges with a total intake capacity of 3,040 seats. In addition, 8 institutions are offering 233 M.Sc Nursing seats, 14 institutions 805 Post Basic B.Sc Nursing seats, while dozens of institutes collectively cater to more than 5,600 GNM, 5,200 FMPHW, and 2,300 MMPHW students across the UT.

Registrar, J&K Nursing Council, Dr. Sandeep Singh, apprised that examinations for 14,738 candidates in paramedical courses had been successfully conducted. He also reported

cy institutions with an intake of 1,800 seats in Diploma in Pharmacy, which is now a mandatory qualification for obtaining drug

Chairperson, J&K A&HCC, Dr.Sabhiya Majid, elaborated on the mandate of the NCAHP Act, 2021, which came into force as per the Hon'ble Supreme Court's directions. She explained that the NCAHP and State Councils are responsible for regulation and maintenance of standards in allied and healthcare education and services, assessment of institutions, maintaining central and state registers of professionals, and fostering research and adoption of latest scientific advancements.

She further elucidated that presently, 10 recognized categories spanning 57 professions fall under its ambit, with the scope set to expand in order to uphold the quality, dignity, and recognition of allied healthcare professionals nationwide.

Reiterating the government's commitment, the Chief Secretary emphasized that strengthening nursing education and allied healthcare systems is pivotal for enhancing patient care, meeting the growing healthcare demands, and creating a skilled workforce to serve the people of J&K.

# PDD launches massive parallel training sessions across J&K

780 linemen receive hands-on training on electrical safety

JAMMU, SEPTEMBER 19: With a view to foster safety-first culture in the power sector, and in line with the Government's emphasis on conducting employee training in a structured and regular manner, the Electrical Inspectorate of the Power Development Department (PDD) has a top priority, line staff have launched massive parallel districts of J&K.

The training programs are carefully structured so that each district is covered, ensuring that all linemen and contract workers engaged on the electrical system are trained with the basic safety practices, during this first phase. This initiative marks a significant step toward institutionalized capacity building, aimed at improving operational efficiency and prioritizing safety, aligning with the department's future plan of establishing dedicated Power Training Institute for all power employees across J&K.

The said training sessions, which commenced last month, are currently in progress and so far, 780 linemen have been trained through a combination of theoretical sessions and hands-on demonstrations,

with a special focus on use of safety gears and other essential workplace precautions. These sessions have so far been conducted in the districts of Budgam, Srinagar, Pulwama, Shopian, Bandipora, Jammu, Kathua, while the remaining districts are scheduled for the coming weeks.

Considering human safety also been instructed to raise al public regarding electrical hazards—particularly those arising from weather vagaries such as snapped wires or infrastructure damage caused by flash floods. A general safety advisory, along with detailed Do's and Don'ts, has been clearly communicated during the training to ensure electrical safety not only for humans but also for animals across the UT.

The entire schedule has been prepared under the guidance of Principal Secretary, PDD, H. Rajesh Prasad, who reiterated that human safety must always remain a top priority. He firmly underscored the importance of adhering strictly to SOPs, with no tolerance for shortcuts during work execution. He further stated that regular monthly reviews on safety compliance will be

conducted by each corporations and detailed reports in this regard will be submitted to the department for monitoring purpose.

Highlighting the challenges faced by linemen in J&K, he mentioned that these linemen operate in challenging environments, including harsh weather conditions, snow-bound areas, and tough mountainous terrains often during emergencies tions. The recent restoration of power in record time during the incessant rains in Jammu stands as a testament to their commitment and resilience. Such a dedicated workforce must be provided with specialized trainings and adequate facilities to enable expeditious restoration of the system in difficult terrains while ensuring that their safety

remains uncompromised. The training sessions were organized and conducted by officers of the Electrical Inspectorate. The master trainers for the training sessions were Er. Anil Abrol in Jammu, and Er. Manzoor Ahmad& Er. Adil Bashir in Kashmir—all three from the Electrical Inspectorate I&K. Additionally. Er. Gulshan Bhagat, Er. Sanjeev Pathania, Er. Navneet Singh Raina, Er. Mudasar Amin Tibet, Er. Sajad

Tariq, Er. Sandeep Kohli, Er. Divya Gupta, along with other officers, officials, and supporting staff of the Inspectorate, actively participated in conducting the proceedings.

The Chief Electrical Inspector, Sanjay Sharma, in his opening remarks during the session, stressed the critical importance of electrical safety both in execution of works as well as in managing day to day operations. power sector of J&K is currently undergoing complete transformation with conventional systems rapidly being replaced with modern technologies to ensure better service delivery to the consumers. He also informed that

the Electrical Inspectorate of PDD has been entrusted with the responsibility of organizing regular training programs and workshops to upgrade skill of power employees for improving the overall efficiency of the department.He added that in this regard, an annual training calendar has been prepared and MoUs have also been signed with reputed national-level power training institutions to adopt a collaborative approach in imparting trainings by inviting the best experts from across the country to J&K.

Kulgam, Sep 19: Deputy Chief Minister, Surinder Kumar Choudhary, on Friday said the biggest issue confronting the people of Jammu and Kashmir is getting back whatever was snatched from them, including statehood.

Addressing a gathering on the sidelines of the function here, the Dy CM said some people expect the ruling elected regime to step down. "But the government is committed to fighting for the restoration of the rights of people that have been snatched," he said.

Choudhary said the National Conference has always fought for the rights of the people and will continue to do so. He said that restoring statehood is crucial for J&K, not for the government, but for the people whose livelihoods and opportunities have been affected.

Today, outsiders are getting



jobs, while locals are pushed aside," he said, vowing to continue the fight against those responsible for the removal of Article 370 and the downgrading of the state into a Union Territory.

About the National Highway closure and subsequent losses to the fruit growers, the Dy CM said the growers never faced losses when J&K was a state, but today the highway remained closed for a longer period, causing extensive losses to the growers. "Unfortunately, the Lieutenant Governor didn't utter even a single word on it." he said.

Choudhary said those responsible for the state's downgrading have met the LG, but not the elected Chief Minister Omar Abdullah, who was elected by the people.

"The PDP leader (Iltija Mufti) needs to clarify why she met the

LG instead of the elected government. The LG's tenure has already ended, and she did so despite claiming that nothing is in his hands," he said.

He said the biggest issue at present was the restoration of the identity snatched from the J&K people. "If anyone is responsible for this, it is PDP," he said.

The Deputy Chief Minister said the elected government in Jammu and Kashmir has done whatever was under its domain, following the recent floods trig-

gered by heavy rainfall.

"The Chief Minister visited almost every area affected by the floods, and the government has extended every possible support under its domain. J&K doesn't want any healing, but wants compensation for those affected by the floods," Choudhary said. "It is the Centre that has to provide compen-

# **Omar-led Govt working for** public welfare: Raina

The BJP leader said that in the last 24 hours alone, over 10,000 fruit-laden trucks had crossed Jammu and the pace would increase further in the coming days. "Hopefully, within the next 10 days, packed apples will be transported to different parts of the country," he assured.

Raina admitted that apple growers and traders suffered huge losses due to prolonged heavy rains and landslides. "The mandi leadership has put forth their demands, including priority for the national high-way. I have witnessed lakhs of apple boxes ready for transportation. These issues will be taken up with the government, including the LG and if required, I will take up them with Home Minister Amit Shah."

Reiterating the central government's resolve, Raina said both Prime Minister Narendra Modi and Home Minister Amit Shah have consistently assured that the people of Jammu and Kashmir will not be allowed to face hardships. "A special cargo train was mobilised earlier and if required, more such measures will be taken. Whatever possible efforts the Centre has to undertake, they will, to ensure smooth transportation and ease the pain of people" he said

Raina said that both essential supplies and apple transportation were moving smoothly again. "The last few days were tough, but now the weather is favourable, transportation is moving and the efforts will continue. Whatever the issues are, we will ensure their early redressal," he added. (KNO)

# **SMC** enforces 'strict livestock taxation' at Bypass toll Post

Srinagar, Sep 19: With the aim of streamlining livestock taxation and ensuring public health safety, the Srinagar Municipal Corporation (SMC) has intensified enforcement at its Bypass toll post, Dr. Fazil Bashir, a senior official overseeing

the department said. He said that under the Jammu and Kashmir Municipal Corporation Act, 2000, a toll post was established earlier, where vehicles are required to pay

taxes upon entering Srinagar city. "The tax rates are specified as Rs 400 per truck for poultry items, Rs 600 for sheep, and Rs 1,000 for cattle such as cows and oxen. These measures aim to regulate the movement of livestock and ensure compliance with health and safety standards," he added, noting that a drive was recently conducted to strengthen livestock monitoring and health

Dr. Fazil said the toll post has been operational for years and all trucks entering the city are mandated to stop, pay the requisite tax and undergo inspection. "However, recent incidents where some vehicles bypassed the

checkpost prompted the SMC to establish mobile checking units near Tengpora Bypass and impose penalties on defaulters," he added.

"At our checkpost, we also inspect for dead or unfit animals such as poultry and sheep. Any such carcasses are scientifically disposed of in

our facilities," Dr. Fazil said, mentioning that defaulters are only allowed to proceed after payment of fines.

Moreover, officials said that in addition to SMC inspections, departments such as Sheep Husbandry conduct health checkups of live-



stock to ensure compliance with safety and health standards.

They say this collaborative effort aims to prevent the entry of diseased or unsafe animals into the market, thereby safeguarding public

# ECI revises guidelines, makes EVM more readable

New Delhi, Sep 19: The Election Commission of India (ECI) has revised the existing guidelines under Rule 49B of the Conduct of Elections Rules, 1961, for the design and printing of EVM Ballot Papers to enhance their clarity and readability.

The initiative is in line with the 28 initiatives already taken by the ECI in the past 6 months to

streamline and improve election processes and enhance convenience for voters.

Henceforth, photographs of candidates will be printed in colour on the EVM Ballot Paper. The candidate's face will occupy three-fourths of the photo space for better visibility.

Serial numbers of candidates/NOTA will be printed in the international form of Indian numerals. The font size will be 30 and in bold

To ensure uniformity, the names of all candidates/NOTA will be printed in the same font type and font size large enough for easy readability.

The EVM Ballot Papers will be printed on 70 GSM paper. For Assembly Elections, pink-coloured paper of specified RGB values shall be used.

The upgraded EVM Ballot Papers will be used in the upcoming elections, starting

# RTC trucks roll out to valley mandis

Srinagar, Sep 19: After weeks of anxiety for Kashmir's apple growers, the Jammu and Kashmir Road Transport Corporation (JKRTC) has rolled out 55 trucks to major fruit mandis in Sopore and Shopian after weeks of crisis marked by a shortage of vehicles and soaring freight charges.

General Manager, Loads & Cargo, JKRTC, Bashir Ahmed Sofi said the deployment followed direct instructions from the government after persistent appeals from growers.

"The minister instructed us to ensure there is no shortage of trucks for fruit transportation. Today, we have mobilised 55 vehicles, including 14 big trailers and other small trucks, to Sopore mandi and 10 trucks to Shopian. These will carry fruit to Delhi, Punjab, Haryana, Chandigarh and other stations," he said.

He said concessional freight had been fixed to protect growers. "For Delhi, the charge is Rs 130 per box and Rs 120 for Punjab, compared to the usual Rs 240–250. A margin of Rs 10 has been left so that labourers can be paid

For the past several weeks, apple growers had struggled with no transport availability, as frequent closures of the Srinagar-Jammu National Highway left thousands of fruit-laden trucks

stranded. With RTC absent from the scene, private transporters exploited the situation by hiking freight abnormally. Freight to Delhi and Punjab nearly doubled, forcing many growers to sell their produce at throwaway rates or risk losses as apples piled up in mandis.

The President of Asia's

second-largest, Sopore Fruit Mandi, Fayaz Ahmed Malik @ Kaka Ji, said the relief came late but was welcome. "Thousands of apple boxes were lying stranded here with no vehicles to lift them. Private truckers were charging at will. The 40 RTC trucks that have come today will help, but our requirement is at least 200-300 trucks daily to clear the back-log", he said, urging the government to prioritise horticulture transport the way it does during the Amarnath Yatra.

Orchardists voiced relief but stressed that the crisis was far from over.

"At least now there is some support from RTC. But unless trucks are deployed consistently every day, our losses will continue", said Ghulam Rasool, a grower from Rafiabad. Similarly, Abdul Majid,

another grower said they cannot afford highway closures. "When fruit doesn't reach Delhi or Kolkata on time, buyers turn elsewhere, and it is the grower who bears the loss," he said.

said the corporation will closely monitor the situation and increase the fleet as more vehicles become free from food supply duty.

"The minister has instructed that strict action be taken against any private trucker found overcharging. RTC will continue deputing trucks daily so that the fruit industry, which is the backbone of our economy, is not made to suffer," he said.

Private Secretary to Minister Satish Sharma, Sanjeev Sharma, said the government has issued strict directions to prevent any exploitation of fruit growers during the apple season.

He said private truckers will face action if found overcharging, par-ticularly during highway closures when freight rates often shoot up. "The minister has made it clear that strict action will be taken against such practices," he said.

Sanjeev said the Motor Vehicle Department (MVD) will inspect trucks to ensure fair freight charges and to keep transport accessible to growers.

With apple harvest at its peak, growers have appealed to the government to ensure uninterrupted transport availability and smooth highway connectivity, warning that any delay could devastate the Valley's horticulture economy and the livelihood of lakhs of General Manager Sofi orchardists. (KNO)

# Soaring freight charges continue

Pulwama, Sep 19: High freight charges and an acute shortage of transport continue to haunt Kashmir's fruit sector despite repeated assurances from the government.

Growers said they are being forced to pay triple the usual rates to send their produce to outside markets, leaving them on the verge of massive losses. Kashmir Valley Fruit Growers Cum Dealers Union president, Bashir Ahmad Basheer, said that apart from the highway crisis, low demand and other issues, the profits of growers are being eaten away by soaring transport costs.

He appealed to the administration to intervene immediately by deploying RTC (Road Transport Corporation) vehicles at every mandi to stabilise

Basheer said that RTC vehicles have been deployed at Fruit Mandi in Shopian and Sopore, but they must also be deployed at other mandis.

'Éarlier, we used to pay around Rs 60 per box via the National Highway route, but this year the rates have skyrocketed to Rs 200. On the Mughal Road, the charges are even higher—over 200 per box," said Abdul Rashid, a grower from Shopian. "At these rates, how can a farmer survive? We are not traders with multiple sources of income. For us, apples are the

Another grower, Mohammad Yousuf from Pulwama, stated that private transporters were taking advantage of the crisis. "We were assured that freight charges would be kept under check, but the ground reality is completely different. If the government is serious, it should immediately deploy RTC trucks at every mandi. That will automatically bring down the rates," he said. Fruit growers' associations accused transporters of creating a shortage. "The government must step in. Unless RTC trucks are made available, private transporters will continue to loot the growers. Every day of delay is pushing farmers towards bankruptcy," Basheer said.

He added that the soaring costs come at a time when growers are already facing uncertainty due to highway closures and market volatility. "If immediate action is not taken, not only will growers suffer, but the entire horticulture economy of Kashmir will be hit hard," he said.

Growers said the government should not only ensure free movement of trucks on highways but also regulate freight rates. "We want the administration to fix uniform charges and deploy RTC vehicles at mandis across Kashmir. This is the only way to save us from exploitation," said Ghulam Nabi, a grower from Baramulla.

The apple industry, which provides livelihood to nearly 3.5 million people in J&K, is seen as the backbone of the region's economy. But with freight charges spiralling and transport shortage persisting, growers fear that their season's hard work will go in vain. (KNO)

# PM Vishwakarma Scheme: Honouring Heritage, Powering Progress

# Recognition, skill upgradation, credit, and market linkages for artisans

In the quiet village of Khanapur in Amravati lived a mason, Prateek Prakash Rao Jamadkar, without any identity of his own. He lacked essential tools for his work and was struggling to complete his projects on time, which was directly affecting his livelihood. With the introduction of the PM Vishwakarma Scheme in his village, his life changed. He got a loan of Rs 1 lakh, with which he bought new advanced tools, which helped him in completing his tasks on time. The training provided under the scheme made him aware of the new technology. The scheme also boosted his self-esteem as it provided him with something more valuable than an ID card and certificate, his dignity and recognition.

Artisans and craftsmen like Prateek are attached to their roots. The skills or occupations they are following are being passed down to them following a guru-shishya model of traditional training. They want to continue with their legacy but with pride and honour. These artisans and craftsmen, who are referred to as 'Vishwakarmas' in India, are working at the grassroots level, with their hands and tools, No matter how much the world advances, how technology reaches everywhere, their role and significance will always remain. They are usually self-employed but in the unorganised sector of the economy. They are generally engaged in occupations like carpenter, Blacksmith, Potter, Washerman, and others.


The Pradhan Mantri Vishwakarma Kaushal Samman Yojana was launched to uplift the lives of these artisans and craftsperson by enhancing their skills and increasing the reach of their products and services. It aims to provide endto-end holistic support to artisans and craftspeople for their respective trades. It emphasises encouraging the trades in rural and urban areas, with special attention to women empowerment and marginalised or underserved groups like the Scheduled Castes, Scheduled Tribes, OBCs, Specially Abled, Transgenders, residents of NER states, Island Territories, and Hilly Areas.

The scheme is being jointly implemented by the Ministry of Micro, Small, and Medium Enterprises (MoMSME), the Ministry of Skill Development and Entrepreneurship (MSDE), and the Department of Financial Services (DFS) under the Ministry of Finance (MoF), Government of India

To expand the reach in every district, District Project Management Units (DPMUs) have been appointed in almost all the districts. The role of DPMUs is to generate awareness about the scheme benefits, and also inform the Vishwakarmas about training dates, batch timings, location of training centres, stakeholder coordination, and regularly monitoring the training centres to ensure adherence and compliance with the training guidelines. The total number of DPMUs appointed under the scheme is 497 (as of July 2025), who are covering 618 Districts of the country.

With the support of ministries and DPMUs, the scheme focuses on achieving the goal of recognizing artisans as Vishwakarmas, providing them with skill training, modern tools, and easy access to collateral-free credit, along with incentives for digital transactions. It also focuses on brand promotion and market linkages, enabling artisans to enhance productivity, quality, and growth opportunities.

Who Can Apply? Vishwakarma Scheme **Eligibility Explained** 



The PM Vishwakarma Yojana lays down specific eligibility criteria to ensure the benefits reach the intended artisans and craftsmen. The scheme focuses on supporting individuals engaged in traditional skills and manual trades which has been passed down through

#### **Big Gains for Small Artisans**

PM Vishwakarma Scheme brings small artisans under one umbrella and empowers them with recognition. The initiative also focuses on financial support, skill upgradation, and connects them with global markets. With this initiatives, age-old traditions can thrive in a competitive world, while preserving their traditional art and knowledge.

Recognition: Artisan and craftspersons are provided with the PM Vishwakarma certificate and ID Cards, which give them the acknowledgement of their work and acceptance of their traditional trade.

Skill Upgradation: To enhance the capabilities of Vishwakarmas and to make them aware of the modern tools and machinery, skill intervention is organised, where every craftsman and artisan receives a stipend of Rs 500 per day. Toolkit Incentive: The government provides

with financial incentive of Rs 15,000 in the form of an e-voucher to help the artisans and craftsperson so that they can purchase quality tools for their trade. This supports the beneficiaries in getting access to modern tools, which can result in increasing their productivity. With the toolkit incentive, toolkit manuals were also released so that they have a comprehensive list of essential tools and equipment designed to empower the craft of beneficiaries.

Credit Support: Under the scheme, to support Vishwakarmas, collateral-free 'Enterprise Development Loans' are provided. The credit assists them in business expansion and also frees them from the reliance on unregulated moneylenders who charge high interest.

The first tranche of the loan amounts to Rs 1 lakh, with a repayment duration of 18 months. The condition for this tranche is that the borrower must have completed basic training.

The second tranche is Rs 2 lakhs, with a repayment period of 30 months. To qualify for this tranche, the borrower must have availed the first tranche of the loan, maintained a standard loan account, and either adopted digital transactions in their business or undergone ad-

Concessional rate of interest fixed at 5% with Government of India subvention to the extent of 8% is charged from artisans and craftsmen. making the overall cost of the loan extremely favourable for the beneficiaries.

Incentive for digital transaction: To build the reliance of Vishwakarmas on the digital payment system, Re.1 per digital transaction is given to them. The incentive is given for up to a maximum of 100 transactions monthly. These transactions include digital payouts and receipts, which are credited to the beneficiary's account. This initiative prepares them for digital reforms in the country, increases their customer base to urban buyers with UPI/QR codes, and reduces cash dependency.

Marketing support: Artisans also get marketing support in the form of quality certification, market linkages with fairs, exhibitions & trade shows, branding and promotion of their products, advertisement, publicity and onboarding them on e-commerce platforms such as GeM with other marketing activities.

This helps them in gaining a wider base of consumers, recognising their brands, and gives them cultural recognition.

Including the above benefits, the artisans also get assistance while onboarding on Udyam Assist Platform as entrepreneurs. UAP is an online system developed by MSME to register the informal micro enterprises and provide them with Udyam Registration Number and

The PM Vishwakarma Scheme has emerged as a transformative initiative of the government that has supported traditional artisans and empowered them. The scheme in 2 years is on the path of achieving its 5-year target of 30 lakhs proposed beneficiaries. As on 31 August 2025, there are around 30 lakhs registered artisans and craftsmen, with skill verification completed for over 26 Lakhs beneficiaries out of which around 86% them have completed their basic

To directly equip the skilled worker with the necessary equipment and encourage the promotion of modern technologies, more than 23 lakhs e-vouchers have been issued as a toolkit

For the support in business development, more than 4.7 lakhs loans have been approved, including both the trenches, with Rs 41,188 crore as the value of the total loans.

The PM Vishwakarma Scheme is catering to a large base of traditional artisans and is every corner of the country, from the southern states of Karnataka and Andhra Pradesh to the western states, like Rajasthan and Maharashtra. The scheme also accommodated Vishwakarmas of various trades such as Raaimistri (Mason). Tailor, Garland Maker, Carpenter, and Cobbler. Raajmistri (Mason) is the highest registered traditional trade among all of them.

Ajay Prakash Vishwakarma, a Carpenter in Darekhu Village, Varanasi, UP, is holding on to his roots and continuing with his traditional profession, which has been followed for generations. The high interest rate of 15-20% charged by local loan providers was getting in between his dream of buying modern tools and excelling in his business. However, with the introduction of the PM Vishwakarma Scheme in his life, he got a loan at 5% interest rate with which he bought modern tools. He got an ID Card, a certificate, and was trained for 5 days, where he got stipends too.

In Nagaon, Assam, Rashida Khatoon, a female mat maker, works hand in hand with her husband to sustain their small business. Through the PM Vishwakarma Scheme, she received 7 days of training and a Rs 1 lakh loan, which proved fruitful in expanding her work. With two instalments received and one more yet to come, her business is steadily growing. The scheme not only strengthened her livelihood

but also provided her family with a home to live in, bringing security and dignity.

In Samastipur, Bihar, barber Siyaram Thakur has carried forward his father's profession. He has been in the same profession for the past 30 years and used to look for work by roaming on a bicycle. However, under the PM Vishwakarma Scheme, he received training in modern salon skills like hair-cutting and massage, which helped him open his own shop. His wife, Nutan Devi, recalls the struggles of running the household and educating their children before the scheme. Today, Siyaram earns Rs 500-1000 a day, ensuring stability and a better life for his family.

Feeling privileged, the beneficiaries thanked Prime Minister Narendra Modi for the lifechanging opportunity.

#### **Conclusion**

The PM Vishwakarma scheme connects beneficiaries' existing skills and future opportunities by providing them with recognition, skill intervention, credit facility, and marketing guidance. With the wide facilities provided under the scheme, it reached different states of the country, catering to 18 traditional trades, showcasing promising achievements. By turning artisans into entrepreneurs and giving them a global stage, the initiative ensures these Vishwakarma companions continue to play a significant role in our societal life.

# Food safety enforcement drive conducted in Doda town

The purpose of the inspection was to check the quality, hygiene standards and compliance with the legal provisions of different departments. Encouragingly, no rotten meat or unsafe food items were found during the inspection.

However, to further strengthen food safety practices, 12 improvement notices were served to meat sellers for compliance with hygiene and regulatory parameters.

The Legal Metrology Department imposed a penalty of 5,000 for violation of LMD norms, while the FCS&CA Department levied a fine of

800 against those using domestic LPG cylinders for commercial purposes.

The District Administration has reiterated its commitment to ensuring safe, hygienic and quality food for the public. Regular inspections will continue in the coming days and strict action will be taken against violators to protect the health and rights of consumers in Doda.

### DM calls for intensifying surveillance against drug trafficking

REASI, SEPTEMBER 19: District Magistrate Reasi Nidhi Malik chaired a meeting of the District Level Committee on Narco Coordination Centre (NCORD) to review progress achieved in curbing the drug menace in the district. The DM reviewed the status of surveillance, intelligence sharing, and new NDPS cases, directing the police department to intensify vigilance and ensure that offenders are brought to the book.

She instructed the Drug Control Department to carry out intensive inspections across the district to cover all pharmacies



to thwart any violations. The Assistant Drug Controller informed that 36 pharmacies were inspected this month, with

one shop sealed for violations. DM Nidhi Malik laid special emphasis on awareness generation under Nasha Mukt J&K Abhiyaan, directing that the anti-drug awareness camps cancelled earlier due to bad weather be rescheduled and conducted effectively.

She also asked the Health Department to organize clinical consultation camps in schools and colleges, involving psychiatrists to highlight the harmful effects of drugs. She further directed procurement of drug testing kits and enhancement of counselling sessions.

The Education Department was instructed to declare schools as tobacco-free zones. The Police were directed to conduct regular inspections to ensure that no tobacco products

are sold within 100 meters of educational institutions. In addition, the DM directed

SDMs, ACD and CMO to identify 40 villages to be declared tobacco-free under the National Tobacco Control Programme.

The District Magistrate reiterated that a multi-pronged approach involving strict enforcement, awareness, health intervention and community participation is vital to make Reasi a drug-free district.

SSP Reasi Paramvir Singh, ADC Rakesh Kumar, ACR Nitin Verma, ACD Vijay Kumar, DySP HQ, CEO, CMO, DSWO, DIO and other concerned officers were present in the meeting.



# Pahalgam attack: Special court extends period of probe, accused's custody

Jammu, Sept 19: A special NIA court in Jammu has extended by 45 days - beyond the stipulated 90-day period - the custodial remand of two accused arrested for allegedly harbouring Pakistani terrorists involved in the deadly Pahalgam terror attack in April.

Special NIA judge Sandeep Gandotra on September 18 extended the investigation and remand period of Bashir Ahmad Jothat, who hails from Baisaran in Pahalgam and Parvaiz Ahmad from Batkote in Pahalgam.

The court held a prima facie case in favour of the extension of the remand and the investigation in view of the allegations, progress of investigation and pending forensic and DNA profiling reports.

"Accordingly, the extension for a period of 45 days is given to the investigating officer for the investigation of the case beyond the period of 90 days in favour of accused Bashir Ahmad Jothat and Parvaiz Ahmad with direction to complete the investigation of the case as soon as possible," the order said.

The court directed the investigating officer to expedite and complete the investigation at the earliest. The 90-day period of remand for investigation as well as 10 days of judicial remand in respect of the two accused persons was due to expire on Friday.

After the expiry of the earlier remand, Parvaiz Ahmad Jothat and Bashir Ahmad Jothat were produced through virtual

According to the NIA, the accused disclosed the identities of the three armed terrorists involved in the attack and confirmed that they were Pakistani nationals affiliated with the banned terrorist outfit Lashkare-Taiba (LeT).

The federal agency alleged that Parvaiz and Bashir had knowingly harboured the terrorists at a seasonal "dhok" (hut) in Hill Park in Pahalgam before the April 22 attack that left 26 people, mostly tourists, dead and 16 others

### 'Govt working on five-year action plan, country-specific strategies'

Bengaluru, Sept 19: The Ministry of Tourism is developing a "five-year action plan" for 2026-30 to be jointly implemented with other key stakeholders, as the government seeks to "overhaul" the 'Incredible India' brand to enrich the experience of both domestic and foreign tourists.

Union Tourism Secretary V Vidyavathi made a presentation on the roadmap envisioned for her ministry at a national conference here on Friday. She said that the ministry is also working on "country-specific strategies" to draw foreign travellers, and underlined that "we cannot have a one-size-fits-all approach".

In her presentation, titled 'Tourism Together', made to a gathering of representatives from leading hotels, hospitality giants, and tourism business stakeholders, she emphasised that her ministry's role is to "catalyse" and "converge", and urged the industry to be a "copartner in every effort".

To make the country a global travel destination, India has set an ambitious target of a USD 3 trillion tourism economy by 2047.

In her presentation, it was mentioned in an opening slide that, "For 2026-30, the (Tourism) Ministry is developing a five-year action plan to be jointly implemented by: Ministry of Tourism, Government of India, all states and Union Territories, all Government of India ministries, overseas Indian Missions, tourism industry, Indian diaspora and Indian citizens".

"We are now working in the ministry on what we call the 'tourism business plan'. What do we mean by that? What we mean by that is how do we, together as the Government of India, as a state government, as the local government, as the industry, as all of us associated with the sector... how do we create value for the tourist," she said.

The 55th annual convention of the Federation of Hotel and Restaurant Associations of India (FHRAI) is being held in Bengaluru from September 18-20.

The convention's theme is 'Future Scape 2047: Redefining Hospitality for a New Era', and brings together a large number of industry leaders, policymakers, investors, and global experts to deliberate on the future roadmap of India's hospitality and tourism sector.

"What we are trying to do is to brand refresh and overhaul the entire 'Incredible India' brand, which, all of you agree with me, has still a very, very huge top of the mind recall. How do we refurbish the entire brand? How do we focus on our core offerings?" Vidyavathi said.

One of the slides mentioned that for promotion and marketing, the ministry will focus on "culture and nature (Indiaonly offerings) to attract highvalue tourists", and on country-specific strategies based on product-market fit and targetbased implementation.

It envisions joint promotions by the tourism ministry, Indian missions, states and UTs, tour operators, airlines and hotels, among others. The goals are to increase foreign arrivals, diversify domestic visits, and retain outbound departures.

Besides, "digital-first -- global influencers programme" is to begin shortly, and under the vision, the industry will create packages for lesser-known destinations apart from wellestablished ones.

"We're working on countryspecific strategies in terms of... this is more for the inbound tourist. What does a tourist of say, Germany want ?"

'What does a tourist from Spain want? Therefore, how do we cater to that segment? What we realise is that we cannot have a one-size-fits-all approach and therefore, should we be having country-specific strategies?" she said.

"While we are working on this, we have been talking to people, we have been talking to the industry, but once we have some kind of a draft ready, we will be sharing it with you for your inputs as well, because we cannot have a tourism business plan for India without the cooperation and without the inputs of the industry, without all of you as part of that," the Union tourism secretary said.

Her presentation began with a reference to the 'Viksit Bharat' vision, and it quoted Prime Minister Narendra Modi's earlier statement on the sector.

"By 2047, our goal is to be a Viksit Bharat - a developed India. We have the potential to increase the contribution of tourism to 10% of our National GDP – and it is my wish that we create and implement a strong roadmap to achieve this vision," Modi has said.

officials to design policies that attract new industries in the wake of new GST rate slabs announced by Central Government, with a clear differentiation of how J&K can uniquely position itself compared to neighboring states.

To ensure stronger policy implementation, Omar Abdullah asked the department to seek structured feedback from new industries that have applied under Single Window Clearance or begun operations under the SWC system. so that operational gaps can be identified and addressed.

With regard to GI certification of crafts, the Chief Minister called for augmenting GI certification testing facilities so that dealers do not suffer due to limited capacity of Handicrafts department, cautioning that without adequate systems in place, the very purpose of GI tagging would be undermined.

"Industrial development in J&K must not only attract investment but also ensure it translates into jobs, livelihoods, and sustainable growth for our youth and artisans," Omar Abdullah said.

Earlier, Commissioner Secretary Industries & Commerce Vikramjit Singh made a detailed presentation highlighting the department's

He informed that investment realization in J&K during FY 2024-25 has reached Rs 4145 crore, nearly 10 times higher than the pre-2021 average, while the current fiscal (up to August 2025) has already seen Rs 4001 crore worth of projects grounded, generating 5,111 jobs in the formal industrial sector. For the first time, multiple units with investment exceeding Rs 500 crore have been set up across sectors such as metals, plastics, pharmaceuticals, textiles, and

food processing. The presentation further revealed that MSMEs contribute 8% to J&K's GDP and employ over 10.88 lakh people, including 15% women. Initiatives such as the MSME Health Clinic, Udyam registration drives across 4914 blocks, and capacity-building programmes under the RAMP scheme have been launched to support this backbone of the economy.

On the startup ecosystem, Singh informed that registrations have surged from just 69 in 2020 to 1,127 in 2025, with a marked shift towards technology and service-based ventures. The meeting was informed that J&K is also set to host a Startup Summit in collaboration with Startup India, MEITY, and SIDBI in October this year in Srinagar.

The Union Minister also announced compensation for farmers who lost domestic animals due to the flood. As per the Jammu and Kashmir administration's preliminary data, approximately 5,000 houses have been damaged. "We will provide Rs 1,30,000 under the Pradhan Mantri Awas Yojana for rebuilding each house. Each will include a separate toilet,"

Addressing losses faced by local Self Help Groups, Chouhan said Rs 76,000 crore will be released to support them.

He said that the sand deposited in fields by floodwaters should be retained by the farmers for personal use, and suggested that the Jammu and Kashmir Mining Department relax regulations to allow this.

"The Jammu and Kashmir Government currently has Rs 2,499 crore available under the disaster management fund. These funds will be used for immediate relief and rehabilitation. He added that if the need arises, the Centre will provide additional support," he said, adding, "Damaged irrigation canals and embankments will also be repaired in coordination with the Centre." (KNO)

#### **Apple growers**

was stuck en route, the buyers in mandis such as Delhi, Chandigarh, and Azadpur know that this fruit has remained stuck on the highway for days together and they are giving very low returns, further pushing Kashmiri apples growers in losses.

Abdul Rashid, President of Fruit Mandi Jablipora, said the arrival of thousands of trucks at a time has created oversupply. "On top of that, the fruit is no longer fresh due to the long delays. Farmers will inevitably suffer heavy losses because buyers will negotiate at throwaway prices," he said.

Many growers lament that they have invested heavily in cultivation this year. fertilisers, pesticides, packaging, and labour. "We are entirely dependent on this harvest for our livelihood. If we don't even recover our input costs, how will we sustain ourselves?" one farmer added.

Meanwhile, the administration said that efforts are underway to normalise the situation.

Divisional Commissioner Kashmir, Anshul Garg, told reporters that the highway restoration work is progressing swiftly. "In the last two days, nearly 5,500 fruit trucks have been allowed to move. Similarly, the movement of vehicles carrying essentials is also being ensured," he said.

The Kashmir apple industry, which provides livelihood to over 3.5 million people, has already been hit hard by erratic weather, rising freight costs, and falling market prices. This latest disruption, growers fear, could further break their backbone. (KNO)

about 350 kanals of land were completely destroved.

Crops such as maize and potatoes that villagers had painstakingly sown were wiped out in minutes. Even local representative Zafarullah Sheikh, DDC member for Madhwa, admitted that more than 350 kanals of land in Wadwan were lost and said that a detailed report is being compiled to assess the full scale of damage.

In Chishoti, farmers speak of despair that words barely capture. Jamil Singh, who saw both his home and his fields vanish, says, 'When both land and house are destroyed in a disaster, life seems to have no purpose. There seems to be no dawn for the darkness that has descended upon our lives after the disaster."

Another farmer, Thakur Chand, echoes the same hopelessness. "I see no way out. I have no home to live in, and farming was my only source of livelihood. The flood from the mountains has swept away all hopes for our lives," he said. Like him, many of the affected farmers demand to be resettled in safer areas and provided cultivable land so they can rebuild their lives with dignity.

The administration acknowledges the magnitude of the crisis. Deputy Commissioner of Kishtwar, Pankaj Kumar, told reporters that the district administration has assured compensation for the affected farmers. Teams from

the Agriculture and Revenue departments are already on the ground conducting surveys. "Assistance will be provided based on the report once the survey is completed," Kumar said. However, he added that the question of providing alternate land in exchange for what was lost rests with a central government team whose evaluation is still pending.

For the farmers, however, immediate relief feels like a distant promise. The torrent of August 14 not only washed away their possessions but also shook their faith in the future. # Rahul Gandhi systematically, deliberately trying to weaken democracy: BJP

Patna, Sept 19: Senior BJP leader Ravi Shankar Prasad on Friday accused Congress' Rahul Gandhi of "systematically and deliberately trying to weaken democracy in the country" over his 'vote chori' (vote theft) allegations against the Election Commission. Speaking to reporters here, the former Union law minister dismissed the claims of the leader of the opposition in the Lok Sabha.

"Rahul Gandhi is trying to create anarchy in the country... he is systematically and deliberately trying to weaken the democracy in the country," Prasad alleged.

Referring to Gandhi's X post on Thursday on 'vote chori' allegations against the EC, Prasad said, "He (Gandhi) wrote that the youth, students and 'Gen Z' will save the Constitution, protect democracy, and stop 'vote theft'. What does he (Gandhi) mean? He is simply trying to promote violence in the country... this is highly condemna-

ble," he added. Gandhi has been repeatedly levelling false, mischievous and misleading allegations against the government and constitutional bodies in the country, Prasad alleged.



"He is lowering the dignity of the post of the leader of the opposition in the Lok Sabha," the BJP leader alleged.

Prasad claimed that Gandhi's repeated allegations against the EC reflected Congress' lack of faith in Indian democracy.

The Congress leader on Thursday alleged that names were deleted through software manipulation and fake applications in Karnataka's Aland seat in

"I must advise Rahul Gandhi to do proper homework before levelling such

allegations," Prasad said. The EC has already clarified that the issue was thoroughly investigated in

2023. Whatever questions

he is raising today, had been replied to by the EC earlier, he said.

"Congress is in power in Karnataka... what was his government doing? The Congress candidate won from Aland and Rahul Gandhi is raising questions about the victory of his own party MLA?! Anyway, the matter is pending before the court," Prasad said. "Gandhi is abusing the democratic choice of the voters of India by questioning parliamentary elections held in 2014, 2019 and 2024. The Congress leaders will have to face the consequences for this... We will give him and Congress leaders a proper reply through the democratic

humiliating defeat in the coming polls," Prasad said.

In his fresh offensive against the EC, Gandhi had said on Thursday that the poll panel must stop protecting "vote chors' (vote thieves) and provide, within a week, information sought by the Karnataka CID in an investigation into deletions of electors' names. Gandhi had cited details of alleged attempts to delete 6,018 votes in Karnataka's Aland constituency in the run-up to the 2023 assembly polls. He also gave the example of Maharashtra's Rajura constituency, where he claimed 6,850 voters were added in a "fraudulent" manner using automated software.

#### India, New Zealand to hold next round of trade talks in Oct

New Delhi, Sept 19: The third round of negotiations for the India-New Zealand Free Trade Agreement (FTA) concluded successfully on 19th September, 2025, in Queenstown, New Zealand. The discussions reaffirmed the shared commitment of both nations to strengthen economic ties and work towards the early conclusion of a balanced and mutually beneficial agreement.

Guided by the vision of Prime Minister Shri Narendra Modi and on, Prime Minister of New Zealand, the negotiations reflected a common resolve to deepen bilateral trade, investment, and economic cooperation. The FTA was formally launched on 16th March, 2025, during the meeting between Union Minister of Commerce and Industry, Shri Piyush Goyal, and New Zealand's Minister for Trade and Investment, Mr. Todd McClay.

The third round, held from 15th to 19th September, 2025, witnessed constructive discussions across all areas of the agreement. Several chapters were concluded and significant progress was

achieved in other key domains. India's bilateral merchandise trade with New Zealand stood at USD 1.3 billion in FY 2024-25, registering a growth of nearly 49 percent over the previous year. The proposed FTA is expected to further boost trade flows, promote investment linkages, strengthen supply chain resilience, and create a predictable framework for businesses in both countries.

Both sides agreed to maintain momentum through inter-sessional engagements. The next round of in-person negotiations is scheduled to be held in New Delhi on 13-14 October, 2025.

## Nepal observes 10th Constitution Day, PM Karki calls for dialogue for finding solutions

Kathmandu, Sept 19: Nepal Prime Minister Sushila Karki on Friday said the protection and successful implementation of the Constitution adopted 10 years ago is the responsibility of all Nepalis, as-serting that democracy is a system of dialogue and finding solutions.

Karki was speaking at the main event organised here in view of the Constitution Day, also celebrated as the National Day across Nepal. However, unlike in the past, the celebrations this year are scaled down as the country mourns the death of 72 people in the violent protests by Gen Z that led to regime change last week.

Nepal's Constituent Assembly delivered the Constitution on Asoj 3, 2072 Bikram Samvat, as per the country's national calendar, or September 20, 2015, years after the erstwhile monarchy was abolished.

"Listening to the voice of the

people is the soul of democracy," Karki, Nepal's first woman prime minister, said.

Recalling that the Constitution of Nepal is the result of "the sacrifice, struggle, and movement" of the Nepali people, Karki said "its protection and successful implementation is the common responsibility of all Nepalis."

The recent Gen Z movement was a result of the dissatisfaction and expectations of the younger generation, Karki explained and made it clear that her government is committed "to listening to and



addressing the voices of the people, as democracy is a system of dialogue and finding solutions."

Karki, 73, became prime minister on September 12, ending days of political uncertainty after the ouster of Prime Minister K P Sharma Oli following youth-led Gen Z protests against his government over cor-

ruption and a ban on social media. The main celebrations were held at Tundikhel Open Ground here. Besides President Ramchandra Paudel, who was the chief guest. and Prime Minister Sushila Karki, the function was attended by Chief Justice Prakash Man Singh Raut, Speaker Devraj Ghimire, National Assembly Chairman Narayan Prasad Dahal and other dignitaries.

President Paudel said the present Constitution has integrated Nepali society having ethnic, lingual, religious, cultural and geographical diversities into the broader national unity by ending all forms of discrimination and oppression resulting from centralised state systems.

He also called on all Nepalis to stay united to realise the aspira-tions of sustainable peace, good governance, development and prosperity through the federal democratic republic systems.

"The Constitution has set a broader goal to create an egalitarian society based on social justice and socialism-oriented economy," he pointed out.

Separately, a group of Gen Z members too organised a rally at Maitighar Mandala, the same place where the protests had gathered on September 8 and 9, and vowed to safeguard the achievements made by the Gen Z movement.

The two main political parties, the Communist Party of Nepal-Unified Marxist Leninist (CPN-UML) and the Communist Party of Nepal-Maoist Centre also organised separate programmes at their respective party head offices in Kathmandu.

While former Prime Minister Pushpakamal Dahal 'Prachanda' addressed the programme at the Maoist Centre party's central office, deposed Prime Minister Oli was absent during his party's programme.

Later in the afternoon, President Paudel hosted a special function at the President's Office, which was attended by Prime Minister Karki, ministers and other dignitaries.

# Afghanistan rebuffs Trump's bid to retake Bagram air base

Insists on sovereignty

KABUL: The United States seeks to regain control of Bagram air base in Afghanistan, President Donald Trump said on Thursday during a press conference with British Prime Minister Keir Starmer, but an Afghan official dismissed the need for any U.S. presence. The historic Soviet-built airstrip was the main base for American forces in the mountainous South Asian nation following the attacks of September 11, 2001, until their 2021 withdrawal led to a takeover by the Islamist Taliban movement.

"We're trying to get it back," Trump said of Bagram, citing what he called its strategic location near China. "We want that base back." Kabul said it was not open to any such deal,

"Afghanistan and the United States need to engage with

one another ... without the United States maintaining any military presence in any part of Afghanistan," Zakir Jalal, an Afghan foreign ministry official, posted on X.

The two nations could establish economic and political ties on the basis of mutual respect and shared interests,

he added. China respects Afghanistan's independence, sovereignty and territorial integrity, a spokesperson of its foreign ministry said, urging all parties to play a construc-

tive role for regional peace

and stability. "The future and

destiny of Afghanistan should

be held in the hands of the

Afghan people," Lin Jian told a regular press conference on Friday, when asked about Trump's comments.

"I want to stress that stoking tensions and creating confrontation in the region wins no popular support.

Engaging with Kabul to free citizens wrongly detained abroad, U.S. officials held talks on Saturday with Afghan authorities regarding Americans held in Afghanistan.

Adam Boehler, the Trump administration's special hostage envoy, and Zalmay Khalilzad, a former U.S. special envoy for Afghanistan, met the Taliban's foreign minister, Amir Khan Muttaqi.

Washington does not recognise the Taliban administration, which seized power in 2021 after 20 years of U.S. military intervention in

### **US** revokes sanctions waiver for Iran's Chabahar Port, effective Sept 29

Washington, Sept 19: The Trump administration, in yet another hard move against India, has announced the revocation of its waiver of sanctions over the Iranian port of Chabahar, in almost ten days, terminating a special waiver granted to India in 2018.

According to a statement issued by the US Department of State on Tuesday, the operators of the Chabahar Port in Iran will face US sanctions starting September 29.

"Additionally, consistent with President Trump's maximum pressure policy to isolate the Iranian regime, the Secretary of State has revoked the sanctions exception issued in 2018 under the Iran Freedom and Counter-Proliferation Act (IFCA) for Afghanistan reconstruction assistance and economic development, effective September 29, 2025. Once the revocation is effective, persons who operate the Chabahar Port or engage in other activities described in IFCA may expose themselves to sanctions under IFCA," State Department's Principal Deputy Spokesperson Thomas Pigott said in the statement.

The move was announced to target Iran's financial network for its sure" on the Islamic State. "Today, the United States is countering Iran's destabilizing activities by designating an international illicit financial network, along with several individuals and entities based in Hong Kong and the United Arab Emirates. These networks have facilitated the sale of Iranian oil, with proceeds benefiting Iran's Islamic Revolutionary Guard Corps Qods Force (IRGC-QF) and Ministry



of Defense and Armed Forces Logistics (MODAFL). These funds are used to support regional terrorist proxies and advance weapons systems that pose a direct threat to U.S. forces and our allies," the statement read.

'This action is being taken pursuant to the counterterrorism authority E.O. 13224, as amended, and marks the fourth round of sanctions targeting Iran's shadow banking infrastructure since the President issued National Security Presidential Memorandum 2, directing a campaign of maximum pressure on Iran," it added.

This was made to isolate the Iranian regime and could significantly impact India's strategic investments in the port. Chabahar Port, located in southeastern Iran near the China-controlled Gwadar Port, stands out due to its strategic and logistical advantages. It includes two main terminals, Shahid Kalantari and Shahid Beheshti, each equipped with five berths, facilitating significant cargo handling capabilities.

In 2024, India signed a 10-year agreement with Iran for the operation of the Chabahar Port. This long-term deal, signed between Indian Ports Global Ltd. (IPGL) and Iran's Port and Maritime Organisation (PMO), grants India operational control over the Shahid Beheshti terminal, a key component of Chabahar's port infrastructure.

#### France warns mayors against flying Palestinian flag next week

Paris, Sept 19: France's interior ministry has ordered prefects to oppose the display of Palestinian flags on town halls and other public buildings next week when Paris is set to formally recognize the Palestinian state.

"The principle of neutrality in public service prohibits such displays," the interior ministry said in a telegram, a copy of which was seen by AFP on Friday.

Any decisions by mayors to fly the Palestinian flag should be referred to courts, the interior ministry said. Israel's war on Gaza is a hot-button issue in France, and several French mayors have already announced their intention to display the Palestinian flag on their town halls next week. On Monday, France is set to formally recognize a Palestinian state at the United Nations General Assembly.

The warning from the interior ministry came after Socialist leader Olivier Faure called for the Palestinian flag to be flown on town halls on Monday, when Jewish worshippers also celebrate the Rosh Hashanah holiday, the Jewish New Year. However, the telegram said any such display would amount to "taking sides in an international conflict."

"It is therefore appropriate," the telegram said, "to ask mayors who display such flags on their public buildings to cease doing so and, in the event of refusal or non-compliance" to refer those mayors' decisions to administrative courts. Israel has been under mounting pressure to wrap up its campaign in Ga: where the war has created a humanitarian crisis and devastated much of the territory, and to bring home Israeli hostages held there.

Israeli Prime Minister Benjamin Netanyahu has accused Macron of pursuing a policy of "appeasement" of the Hamas militants. Macron said Thursday that recognizing a Palestinian state would isolate Hamas.

Several other leaders have announced their intent to formally recognize the Palestinian state during the UN summit.


