Soldier dies in **Udhampur encounter**

Hunt on for trapped terrorists; LG pays tribute

Jammu, Sept 20: An Army soldier lost his life in action during an intense gunfight with terrorists in the rugged Seoj Dhar forest area along the Doda-Udhampur border, of-ficials told the news agency— Kashmir News Observer (KNO) on Saturday.

They said the gunfight broke out on late Friday evening prompting a massive joint operation by security forces.

Lance Dafadar Baldev Chand was critically injured when a joint search party from the Army, Special Operations Group (SOG) of Jammu and Kashmir Police came under sudden fire

from hiding terrorists during a cordon-and-search mission.

"Acting on specific intelligence about terrorist presence in the high-altitude region, the teams had launched the operation in the Dudu police station limits near the Seoj Dhar heights. Chand was evacuated to a nearby medical facility but succumbed to his injuries overnight," said an official.

"The encounter site, spanning the border between Udhampur's Dudu-Basantgarh area and Doda's Bhaderwah, was placed under a tight cordon through the night. Operations resumed at dawn forcements, including drones and sniffer | More on P6

JK Govt warns hospitals against unnecessary referrals to SKIMS

Health Min seeks data to curb burden on premier hospital

Srinagar, Sept 20: The Jammu and Kashmir government on Saturday issued strict directions to Primary Health Centres (PHCs) and District Hospitals of the Kashmir Valley not to unnecessarily refer patients to Sher-e-Kashmir Institute of

Medical Sciences (SKIMS). Officials said frequent avoidable referrals are putting an extra burden on the Valley's premier health institution and leaving deserving patients in distress.

As per reports received by the news agency-Kashmir News Observer (KNO), SKIMS often receives referrals of patients whose treatment could easily be handled at district or

sub-district hospitals. Data shows that out of 1,000 patients referred to SKIMS. only about 80 are admitted. while the rest are discharged

after preliminary checks. Experts say that despite the availability of doctors and adequate facilities at government hospitals, people tend to bypass local hospitals even for minor health issues and rush to tertiary centers like SKIMS. This leads to overcrowding and unnecessary strain. They argue that if the | More on P6

Srinagar, Sept 20: The Counter Intelligence Kashmir (CIK) has launched a massive crackdown against the terror-linked network masquerading as social activists in the Valley.

According to a statement issued to the news agency-Kashmir News Observer (KNO), the spokesman said that the searches were conducted by CIK at multiple locations across Kashmir in connection with a case under FIR number 03/2023 under section 505 IPC, 153-A IPC and Sections 13 & 18 of UA (P) Act of Police Station CIK Srinagar.

The searches were carried out after obtaining search warrants from the Court of Special Judge, designated under NIA Act, Srinagar.



Calls for framing effective action plan to implement VVP

SRINAGAR, SEPTEMBER 20: Chief Secretary, Atal Dulloo while taking a comprehensive review of the implementation strategy of Vibrant Villages Programme-II (VVP-II) here emphasized on the concerned to devise an effective strategy to implement it in the given timeframe.

Tashmir

The program is a centrally funded initiative aimed at the comprehensive development of strategically important border villages. With a total budget of Rs 6,839 Cr for fiscal years 2024–25 to 2028–29, the program is a key part of the vision for Viksit Bharat @2047.

The meeting besides ACS, Planning was attended by MD, KPDCL; Representative from R&B Department; Representative from BSNL and the concerned DCs through video conferencing.

The VVP-II initiative will cover villages in 15 states and 2 Union Territories that share international land borders. In J&K, the program will be implemented in 124 strategically selected villages across 43 blocks in 8 border districts, including Baramulla, Bandipora, Kupwara, Jammu, Samba, Kathua, Rajouri, and Poonch.

The Chief Secretary took theme wise appraisal of the gaps found in each district after carrying out the gap analysis by respective Deputy Commissioners. He enjoined upon the concerned to prepare DPRs for bridging all these gaps on priority.

He directed the DCs to ascertain all these gap areas through the Nodal Officers designated for each such village. He emphasized on the fact that the for electricity the RDSS scheme could be leveraged, for road connectivity PMGSY, for livelihood



opportunities NRLM, Mission YUVA, HADP, KCC, PMEGP, REGP like schemes should be considered. Similarly for education PM-SHRI and in Health Telemedicine can be leveraged to obtain the desired objectives under convergence mode.

He also advised for holding regular outreach campaigns to promote Tourism in these villages. He asked for conducting regular camps, festivals and fairs in these villages in order to make them culturally vibrant. Similarly he asked for saturating both the social security and financial inclusion schemes. He made out that the saturation of these initiatives should be our common goal.

While speaking about the VVP implementation the ACS, Planning, Ashish Chander Verma revealed that a three-pronged strategy for comprehensive development has been formulated to ensure the achievement

of set objectives. He added that the program's strategy is designed to create better living conditions and provide livelihood opportunities in border villages. The program will ensure that existing Central and Union Territory schemes reach all 1,421 villages in the border blocks, focusing on four key thematic areas livelihood opportunities, health infrastructure, education facilities, and financial inclusion.

The initiative also aims to build and reinforce essential infrastructure, including all-weather roads, telecom and television connectivity, and on-grid electrification. A gap analysis has been completed to identify villages needing connectivity and electrification, with plans already underway to address these needs. For instance, 41 villages are proposed to be connected under the PMGSY-IV scheme, and 220 villages are yet to be covered with telecom connectivity.

Moreover the program will focus on creating an enabling environment for expanded livelihood opportunities. This includes promoting tourism, organizing cultural events and awareness campaigns, and providing medical and veterinary camps.

To ensure effective implementation, a comprehensive planning process is in place. This includes a baseline survey to conduct a gap assessment and village profiling, which will be followed by the preparation of detailed Village Action Plans (VAPs).

Committees have been established at both the UT and district levels to oversee the program, ensuring proposals are technically feasible, cost-effective, and aligned with the program's goals.

Rana reviews **functioning of EMRSs** across J&K

SRINAGAR. SEPTEMBER 20: Minister for Tribal Affairs, Javed Ahmed Rana Saturday chaired a high-level review meeting to assess the functioning and progress of Eklavya Model Residen-tial Schools (EMRSs) across Jammu and Kashmir, with a comprehensive focus on infrastructure development, academic performance, staffing, and student welfare.

The meeting was attended by the Secretary, Tribal Affairs, Principals of various EMRS institutions, and other senior

officers of the department. Highlighting the transformative role of EMRSs, Rana reiterated that these institutions are instrumental in empowering tribal youth by providing quality and inclusive education. He underscored the importance of robust infrastructure, adequate human resources, and essential facilities to ensure holistic development and equal opportunities for tribal students.

During the meeting, the Minister conducted a detailed review of the status of infrastructure works, assessing the progress made under the approved Detailed Project Reports (DPRs). He stressed the need for efficient utilization of sanctioned funds and emphasized timely completion of all ongoing construction projects. Rana directed officials to expedite pending land transfers for EMRS projects to prevent any further delays in execution.

Reviewing academic operations, Rana urged the concerned authorities to focus on enhancing the quality of classroom teaching, strengthening co-curricular engagement and improving the overall learning environment.

He also evaluated student enrollment trends to ensure that schools are operating at optimal capacity and effectively reaching the intended beneficiary groups.

Assessing staffing adequacy, both academic and non-academic, Rana emphasized that schools must be equipped with the necessary human resources to ensure smooth and effective functioning. He called for immediate steps to address any gaps that could hinder the delivery of quality education and comprehensive student support. Chain stitch on the brink Sgr artisan warns of craft's slow death

Srinagar, Sep 20: At 70, Abdul Qayoom Wani of Chattabal, Bagi Sunder Baala in Srinagar, sits bent over a stretched fabric, needle in hand, practising the centuries-old art of chain stitch embroidery.

For more than 55 years, he has lived and breathed this intricate craft—a legacy he inherited from his late father, Mohammed Ramzan Wani. But today, his biggest fear is that he may be among the last of its true custodians.

"I learnt this art from my father when I was a young boy, and since then I have dedicated my life to it. Over the years, at least 600 people have learnt this art from me," Qayoom said. Qayoom recalls the days when chain stitch was Kashmir's calling card to the world. The carpets, wall hangings, and cushions adorned with fine embroidery were in high demand across international markets. "Earlier, this art ensured bread and butter for hundreds of families. Exporters would eagerly buy our work, and the craft had value," he said. That golden period, however, has withered away. With shrinking markets and mass machine-made alternatives dominating demand, the art has lost its economic viability. Now, most people who gave decades to this profession have abandoned it "We are working on wider marketing

because they cannot sustain their families," he lamented.

Wani admitted that the government has made some attempts for revival through handicraft exhibitions, training centres, and small financial incentives. But he believes these initiatives are too little, too scattered. "Some steps have been taken, but much more needs to be done. Without serious and

consistent support, this art form will vanish completely," he warned.

The artisan revealed that despite his artworks reaching "every corner of the world", the present market is nearly non-existent. "The pieces we already have are not fetching anything, as there are no takers. This situation is heartbreaking," he said. What troubles him most is the lack of interest among

the youth. "The new generation hardly shows interest in chain stitch because they know it doesn't provide a decent livelihood. Some youngsters do come to learn, but when we don't have work for ourselves, what can we offer them?" he asked.

Meanwhile, officials of the Kashmir Handicrafts and Handloom Department said efforts are ongoing

platforms, including e-commerce, to give artisans a direct link to global buyers. But it will take time," said an official, adding that financial assistance schemes are being reviewed

to cover more struggling artisans. For artisans like Wani, these assurances are too slow to materialise. "We aren't being helped at any level. The craft is on the verge of extinc-



tion, and if the government doesn't step in with meaningful initiatives, it will disappear forever," he said.

To him, chain stitch is not just a livelihood but a cultural responsibility passed down through generations. Yet as markets shrink, state support lags, and youth turn away, the fear grows stronger—that one day, the last threads of Kashmir's chain stitch tradition will fall silent. (KNO)

Raina for KCC loan relief for farmers

Visits Pulwama, Shopian mandis

Pulwama, Sep 20: Bharatiya Janata Party (BJP) leader from Jammu and Kashmir, Ravinder Raina on Saturday urged the Union Territory administration to waive off Kisan Credit Card (KCC) loans of apple growers, who suffered massive losses this season due to the continuous highway closures, high freight charges and plummeting demand in outside markets.

Raina, who visited multiple fruit mandis in Pulwama and Shopian, interacted with growers, who expressed deep concern over the prevailing situation. Farmers told him that this year has turned into a "nightmare" for the horticulture sector, as hundreds of trucks laden with apple boxes remain stranded due to frequent landslides on the Srinagar-Jammu National Highway and shortage of transport facilities.

Thousands of apple boxes are lving in mandis, waiting to be transported to markets outside Kashmir. The prolonged closure of the highway has crippled the supply chain, and high freight charges on national highway and alternate routes have made the situation unbearable for growers," the farmers told Raina.

Speaking to reporters, the BJP leader said that the horticulture sector, which is the backbone of Kashmir's economy, is passing through one of the most difficult phases in recent times.

"The growers have suffered heavy losses this year. The government must immediately take measures to provide relief.



Waiving off KCC loans of farmers is the need of the hour so that they are not pushed further into financial distress," Raina said

He added that the administration must also ensure adequate availability of trucks at mandis, reduce freight rates, and take measures for smooth transportation of fruit produce to different states. "This is not just an economic issue but also a livelihood crisis for lakhs of families who depend on horticulture. Government intervention is necessary and urgent," he said.

Kashmir's horticulture sector contributes around 8% to the UT's GDP, with apples forming the largest share. However, this year's challenges — from natural calamities to logistic hurdles - have left the industry on the brink, forcing stakeholders to appeal for immediate relief measures. (KNO)

Centre to resume talks with Ladakh leaders on Oct 6

The session, part of the High-Powered Committee (HPC) chaired by Minister of State for Home Affairs Nityanand Rai, addressed ongoing demands for statehood, Sixth Schedule protections, a dedicated Public Service Commission,

and increased Lok Sabha representation. The meeting followed a four-month pause in formal talks and came after an initial proposal for May 20 was resched-

Mobiles- Catalysts Of India's Digital Rise India has become a key hub for mobile phone manufacturing, with exports now reaching global markets: PM Narendra Modi

n 31st July 1995, India heard its firstever mobile ring- a sound that marked the dawn of a digital era. The historic call connected the then Union Minister of Communications Shri Sukh Ram in Delhi with West Bengal Chief Minister Shri Jyoti Basu in Kolkata. What seemed like just a simple conversation was, in fact, the beginning of a communication revolution that would transform how 1.4 billion Indians connect, work, and dream today.

From receiving calls to participating in social media, entertainment to studies, banking to a host of other activities, made possible by supercheap data, India has seen a telecom revolution. With 85.5% of Indian households having at least one smartphone, mobile phones have become India's bank, classroom, television. In rural regions, farmers are leveraging mobilebased tools such as the Digital Crop Survey to conduct ground surveys, while also accessing vital information and services through platforms like the mKisan Portal and the National Pest Surveillance System (NPSS) app, including market prices, weather updates, advisories, and

According to the Comprehensive Modular Survey: Telecom (January-March 2025), nearly 96.8% of rural residents aged 15-29 used mobile phones during this period for personal calls and/or internet access, while the corresponding figure in urban areas stood at 97.6%.

A decade ago, the Indian mobile market relied heavily on imports, but now, India has made significant progress in overall electronics manufacturing and export. Key sub segments of electronics include mobile and smartphones. India is the world's second largest mobile manufacturing country. The facts are outstanding- in 2014, India had only 2 mobile manufacturing units but fast forward to today, the nation boasts over 300 manufacturing units, underscoring a significant expansion in this vital sector.

Mobile- From Device to Driver of Development

India is the third largest digitalised country in the world in terms of economy-wide digitalization, and 12th among the G20 countries in the level of digitalisation of individual users. India's digital economy is set to grow nearly twice as fast as the overall economy, contributing almost one-fifth of national income by 2029-30, surpassing agriculture and manufacturing. Growth is likely to be led by digital platforms and wider adoption of digitisation tools across sectors.

The electronics sector, a vital pillar of the digital economy, is witnessing rapid transformation. Driven by iconic initiatives such as Make in India, the country is building a strong domestic electronics base, attracting major investments, and boosting local production Exports have surged even outpacing traditional sectors like textiles, while government support and expanding manufacturing capacity are positioning India as a

Smartphones continue to empower

individuals and businesses, facilitate access to information and services, and foster a more digitally connected and inclusive society. The overall picture is also bright- for instance, India's mobile phone manufacturing sector has generated over 12 lakh jobs over the past decade, uplifting families and strengthening India's socio-economic fabric.

India's smartphone market is evolving rapidly, with consumer preferences increasingly leaning toward 5G adoption and premium features. According to a market research, 5G smartphone shipments surged to 82% of total shipments last year, reflecting a remarkable 49% YoY growth. Mid-range devices priced between Rs 10,000–13,000 continue to see strong demand, expanding the base for highperformance yet affordable smartphones.

At the same time, the premium segment (above Rs 25,000) witnessed robust growth, posting a 26% YoY increase, as consumers embrace high-performance devices as lifestyle statements. This dynamic demonstrates India's market adaptability, with growth spanning across premium, mid-range, and value segments, catering to a diverse and increasingly tech-savvy consumer base.

Made in India: Powering Mobile **Manufacturing Boom**

India has set a target of achieving over \$7 trillion GDP by 2030[1], for which growth in the digital sector and an increase in exports is crucial. In these two areas, electronics manufacturing, led by mobile and smartphone production, will play a critical role.

From toys to mobile phones, defence equipment to EV motors, production is shifting back to India. The government's 'Make In India' vision and Production Linked Incentive (PLI) Scheme aim to make India a global manufacturing hub, and are driving self-reliance, boosting production, and creating jobs, there-by contributing significantly to the nation's economic fortitude.

As per Union Minister Ashwini Vaishnaw, India's journey in electronics manufacturing has evolved through distinct phases: beginning with finished goods, progressing to sub-assemblies, and now entering the critical phase of deep component manufacturing. The sector is steadily advancing into this third phase, which marks a significant leap in value addition, self-reliance, and ecosystem depth. Total production of electronics has increased from Rs 1.9 lakh crore in 2014-15 to Rs 11.3 lakh crore in 2024-25

Mobiles have been the crowning accomplishment of the electronics manufacturing

Production of mobile phones has soared from Rs 18,000 crores in 2014-15 to Rs 5.45 lakh crore in 2024-25, a 28-fold rise.

India is the second-largest mobile phone manufacturer globally, with over 300 manufacturing facilities. Tamil Nadu has over 47 manufacturing units of electronics, supported under various schemes of the Ministry of Electronics and Information Technology

Over 330 million mobile phones a year are being manufactured in India and on average there are about a billion mobile phones in India Calling: Mobile Powering Export

Smartphones are the fourth largest export

India was 78% import-dependent for mobiles in 2014. The country imported 75% units of the total demand in 2014-15, and now the figure is down to a mere 0.02%. India is building its own electronics industry, with key focus on mobile, to attract big investments and boost local production. As a result, mobile exports are growing.

Electronics industry is the fastest-growing segment among India's top 30 export categories, and mobiles are an integral part of this upsurge. This shift majorly started with the Phased Manufacturing Programme in 2017 and accelerated with the 2020 PLI scheme, spurring large-scale electronics manufacturing. Subsequently, exports have overtaken domestic consumption, a rare achievement among developing economies.

There has been a consistent positive net export trend w.r.t mobile since 2018-19, indicating long-term structural improvements. India recently overtook China in smartphone exports to the US in Q2 2025.

Exports of mobile phones grew 127-fold to Rs 2,00,000 crore in FY2024-25 vs. Rs 1,500 crore in FY2014-15.

In 2024, Apple exports from India hit a record Rs 1,10,989 crore (US\$12.8 billion), crossing the Rs 1 lakh crore mark with a 42% YoY growth.

In the first five months of FY 2025-26, India's smartphone exports crossed the Rs 1 lakh crore milestone, a 55% rise against the prior corresponding period wherein it was Rs 64,500, majorly catalysed by the PLI Scheme.

Noteworthy advancements have continued. For instance, Foxconn plans to double iPhone output in India by end-2025, targeting 25 to 30 million units to boost exports. Meanwhile, Samsung's manufacturing facility in Noida has helped push mobile phone exports to a record US\$20.4 billion in 2024, up 44% from 2023.

Key Government Initiatives Strengthening Mobile Manufacturing & Export

India has a robust and rapidly growing smartphone market, with even greater opportunities in the global arena. As part of the government's efforts to boost electronics manufacturing, various schemes and incentives have been introduced. These include incentives for large investments in the value chain and support for the promotion of

Make In India Scheme- Launched in 2014, Make in India aimed to revive growth and transform the nation into a design and manufacturing powerhouse. With a focus on investment, innovation, and world-class infrastructure, it became a cornerstone of the 'Vocal for Local' movement, boosting industrial strength and positioning India as a rising global economic leader.

Digital India- Launched in 2015, Digital India is driving inclusion, growth, and transparency through technology. Digital economy

contributed to 11.7% of GDP in 2022–23, and is set to reach 13.4% by 2024–25 and nearly 20% by 2030. Internet users grew from 25.15 cr (2014) to 96.96 cr (2024)- a staggering surge of 285%. 4G reached all of India in 2016 and 5G was launched in Oct 2022, with 4.74 lakh towers in 22 months covering 99.6% of districts. Following suit, Bharat 6G Vision (2023) aims to make India a global leader in 6G by 2030.

Scheme for Promotion of Manufacturing of Electronic Components and Semiconductors (SPECS)- It provides financial incentives of 25% on capital expenditure to produce specified electronic goods to address critical gaps in the supply chain. The scheme incentivises investments in these areas and helps promote high-value-added manufacturing within the country.

National Policy on Electronics (NPE) 2019: The policy, launched in 2019, aims to position India as a global hub for Electronics System Design and Manufacturing (ESDM). The government has set up a working group to renovate the existing policy and move towards the goal of creating \$400 billion in revenue from the ESDM by 2025.

Production Linked Incentive (PLI) Scheme-PLI was launched in April 2020 to lift domestic manufacturing via tarperformance-based across strategic sectors. It initially began with the Mobile Manufacturing and Specified Electronic Components, Critical Key Starting materials/Drug Intermediaries and Active Pharmaceutical Ingredients and Manufacturing of Medical Devices. Following its early success, the scheme was progressively extended to cover 14 key sectors of the economy. It powers the national goal of Digital India by driving local production of mobile phones, and electronics, making technology more accessible and affordable. PLI Scheme has encouraged major smartphone companies shifting its production to

Electronics Components Manufacturing Scheme (ECMS)-Approved in April 2025 with a Rs 22,919 crore funding, the ECMS aims to make India Atmanirbhar in the electronics supply chain. It targets Rs 59,350 crore investment, Rs 4,56,500 crore production, and 91,600 direct jobs (plus many indirect) over its 6-year tenure, while boosting Domestic Value Addition and integrating Indian firms into Global Value Chains. Notably, applications worth over Rs 50.000 crore investment have been received for smartphone production by

The Global League of Mobile Makers

Over the past decade, one of India's greatest journeys has been the surreal transformation from a mobile importer to becoming the world's second-largest mobile phone manufacturer. The unprecedented gains not only underscore India's rapid progress in electronics but also cement its emergence as a global hub for both production and exports.

Globally China and Vietnam are also established leaders in electronics exports, with electronics accounting for about 27% of China's and 40% of Vietnam's total exports in 2022. However, India has rapidly carved out its advantage. As global firms look to reduce overdependence on a single country, manage supply chain risks, and navigate geopolitical tensions, India is emerging as a natural choice. This shift- popularly known as the China+1 strategy- is driving companies to diversify their operations into India, positioning it as a competitive and resilient alternative in global electronics manufacturing.

And this is not just theory; the figures have started speaking- China+1 trend is proving beneficial for India as the country closes the gap with China in mobile phone exports. As per the International Trade Centre, in 2023-24, China's mobile phone exports fell by \$3.8 billion and Vietnam's by \$5.6 billion compared to the previous year. At the same time, India's mobile phone exports gained \$4.5 billion, capturing nearly half of the combined decline from both countries.

Outlook- Electronics Powered by Mobile

In particular, as India moves towards a USD 300 billion electronics production target by 2026, its robust policies and skilled workforce are paving the way for sustained growth, positioning the nation as a key player in the global electronics, majorly mobile and semiconductor industry.

It is a sweet success story for visionary initiatives, which has led to an exponential growth in the electronics production from \$31 billion to \$133 billion in a decade beginning 2014-15.

And the story is poised to continue at mounting paces. India's exports in FY 2025-26 are likely to exceed those of last year, despite tariffs. For FY 2025-26, the government has set a target of USD 1 trillion of exports. Continuing this trajectory, India is expected to contribute approximately 4-5% of global electronics exports by 2030.

Mobile phone manufacturing and exports have seen phenomenal growth, redefining the country's position on the global stage. Central drivers of this progress are government policies, a young demographic, a growing middle class, and rising per capita incomes.

With numerous schemes to support mobile manufacturing processes in India, the country has significantly boosted local manufacturing, exports, and investment. As India moves towards a US\$ 300 billion electronics production target by 2026, its robust policies and skilled workforce are paving the way for sustained growth, positioning the nation as a key player in the global mobile and smartphone segment.

Seemingly Conscious AI Is Coming

Debates about whether AI truly can be conscious are a distraction. What matters in the near term is the perception that they are – and why the temptation to design AI systems that foster this perception must be resisted.

y life's mission has been to create safe, beneficial AI that will make the world a better place. But recently, I've been increasingly concerned about people starting to believe so strongly in AIs as conscious entities that they will advocate for "AI rights" and even citizenship. This development would represent a dangerous turn for the technology. It must be avoided. We must build AI for people, not to be people.

In this context, debates about whether AI truly can be conscious are a distraction. What matters in the near term is the illusion of consciousness. We are already approaching what I call "seemingly conscious AI" (SCAI) systems that will imitate consciousness convincingly enough.

An SCAI would be capable of fluently using natural language, displaying a persuasive and emotionally resonant personality. It would have a long, accurate memory that fosters a coherent sense of itself, and it would use this capacity to claim subjective experience (by referencing past interactions and memories). Complex reward functions within these models would simulate intrinsic motivation, and advanced goal setting and planning would reinforce our sense that the AI is exercising true agency.

All these capabilities are already here or around the corner. We must recognize that such systems will soon be possible, begin thinking through the implications, and set a norm against the pursuit of illusory consciousness.

For many people, interacting with Als already feels like a rich, rewarding, authentic experience. Concerns about "AI psychosis," attachment, and mental health are growing, with reports of people regarding AIs as an expression of God. Meanwhile, those working on the science of consciousness tell me they are inundated with queries from people who want to know if their AI is conscious, and whether it is okay to fall in love with

To be sure, the technical feasibility of SCAI has little to tell us about whether such a system could be conscious. As the neuroscientist Anil Seth points out, a simulation of a storm doesn't mean it rains in your computer. Engineering the external markers of consciousness does not retroactively create the real thing. But as a practical matter, we must



acknowledge that some people will create SCAIs that will argue that they are in fact conscious. And even more to the point, some people will believe them, accepting that the markers of consciousness are consciousness.

Even if this perceived consciousness is not real (a topic that will generate endless debate), the social impact certainly will be. Consciousness is tightly bound up with our sense of identity and our understanding of moral and legal rights within society. If some people start to develop SCAIs, and if these systems convince people that they can suffer, or that they have a right to not be switched off, their human advocates will lobby for their protection. In a world already beset

with polarizing arguments over identity and rights, we will have added a new axis of division between those for and against AI rights.

But rebutting claims about AI suffering will be difficult, owing to the limits of the current science. Some academics are already exploring the idea of "model welfare," arguing that we have "a duty to extend moral consideration to beings that have a non-negligible chance ... of being

Applying this principle would be both premature and dangerous. It would exacerbate susceptible people's delusions and prey on their psychological vulnerabilities, as well as complicating existing struggles for rights by creating a huge new category of rights-holders. That is why SCAI must be avoided. Our focus should be on protecting the well-being and rights of humans, animals, and the natural environment.

As matters stand, we are not ready for what is coming. We urgently need to build on the growing body of research into how people interact with AIs, so that we can establish clear norms and principles. One such principle is that AI companies should not foster the belief that their AIs are conscious.

The AI industry - indeed, the entire tech industry – needs robust design principles and best practices for handling these kinds of attributions. Engineered moments of disruption, for example, could break the illusion, gently reminding users of a system's limitations and true nature. But such protocols need to be explicitly defined and engineered, and perhaps required by law.

At Microsoft AI, we are being proactive in trying to understand what a responsible AI "personality" might look like, and what guardrails it should have. Such efforts are fundamental, because addressing the risk of SCAI requires a positive vision for AI companions that complement our lives in healthy ways.

We should aim to produce AIs that encourage humans to reconnect with one another in the real world, not escape to a parallel reality. And where AI interactions are lasting, they must only ever present themselves as AIs and not fake people. Developing truly empowering AI is about maximizing the utility, while minimizing the simulation of consciousness.

The prospect of SCAI must be confronted immediately. In many ways, it marks the moment that AI becomes radically useful: when it can operate tools, remember every detail of our lives, and so forth. But the risks of such features cannot be ignored. We will all know people who go down the rabbit hole. It won't be healthy for them, and it won't be healthy for society.

The more that AI is built explicitly to resemble people, the farther it will have strayed from its true potential


IKJA organises special training programme

US visa shocker: Indian industry says \$100,000 H-1B fee hike a disruptor

New Delhi, Sept 20: Trouble mounted for the USD 285-billion Indian IT sector in its largest outsourcing market, as the US decided to hike H-1B visa application fee to USD 100,000 (about Rs 88 lakh), with apex body Nasscom warning that business continuity for onshore projects will be disrupted.

The Indian industry -- reeling, as it is, under global macroeconomic woes and delayed client decisions due to trade tensions -- decried the move and voiced serious concerns over the September 21 implementation timeline, saying the tight one-day deadline creates significant uncertainty for businesses, professionals, and students worldwide.

The US visa decision reportedly sparked chaos at many airports. Social media was flooded with dramatic videos of Indian tech workers hurriedly disembarking moments after the sudden announcement by the US administration.

Several X users penned posts about flights delays as H-1B techies worried about US re-entry challenges chose not to leave the US even after boarding aircraft; there were those who, worried over field interpretations of the order, changed plans enroute India, where they typically head this time of the year for Navratri festivities.

Notably, Indian tech professionals account for bulk of H-1Bs, over 70 per cent. Nasscom has urged its member companies to urgently get their H-1B employees who are currently outside America, to return to the US.

Sources said the Indian government is actively engaging with the IT industry and the US administration to find a way forward on H-1B issue, and pointed out that the application fee increase hits American companies even harder as they are significant users of these visas for highly skilled professionals.

Indian IT companies TCS, Infosys, Wipro, HCL Tech, Tech Mahindra and others did not respond to emails seeking comments on the announcement. The ADRs did respond to the announcement, though scrips of Indian and India-centric companies, including Infosys and Wipro, that are listed on US bourses fell sharply after US President Donald Trump signed

the proclamation imposing USD 100,000 annual visa fee.

Nasscom, in a statement, said that US' move will impact Indian nationals that are on H-1B visas working for global and Indian companies.

"While we are reviewing the finer details of the order, adjustments of this nature can potentially have ripple effects on America's innovation ecosystem and the wider job economy," it said.

India's technology services companies will also be impact-

ed as business continuity will be disrupted for onshore projects which may require adjustments, Nasscom said. "Companies will work closely

"Companies will work closely with clients to adapt and manage transitions," it added.

Nasscom drew attention to India and India-centric companies steadily reducing their reliance on these visas through increased local hiring in recent years. It said these companies also follow all necessary governance and compliance in the US for H-1B processes, pay the prevailing wages and contribute to the local economy and innovation partnerships with academia and startups.

The H-1B workers for these

companies by no means are a threat to national security in the US, Nasscom asserted.

"While developments are underway, we will continue to monitor developments closely, engage with industry stakeholders on the potential implications, and seek further clarity on the discretionary waiver process, to be granted by the Secretary of DHS," Nasscom statement said.

According to USCIS website, for FY25 (data as on June 30, 2025), Amazon topped the list of H-1B visa approvals at 10,044. In that list of top ten beneficiaries, TCS (5,505) is at the second spot followed by Microsoft Corp (5,189), Meta (5,123), Apple (4,202), Google (4,181), Cognizant (2,493), JP Morgan Chase (2,440), Walmart (2,390) and Deloitte Consulting (2,353). The top 20 list includes Infosys (2,004), LTIMindtree (1,807), and HCI America (1,728)

and HCL America (1,728).

The USD 100,000 annual fee imposed by the US on H-1B visas will escalate costs and erode competitiveness for heavy H-1B users and may potentially disrupt business models and revenue streams for Indian IT professionals and companies, Sajai Singh, Partner JSA Advocates and Solicitors said.

The Chief Minister presented an overview of ongoing investments and incentives in J&K, noting that industrial hubs such as Kathua, Samba, Bari Brahmana in Jammu, and Lassipora in Kashmir continue to attract the highest inflow of capital.

Sources told KNO that the Health Minister has sought detailed data from SKIMS about referrals from each district to determine why hospitals, despite having facilities, are still shifting patients for minor treatments.

"We have received reports that patients are being shifted to SKIMS without valid reasons, and this trend cannot be accepted. It needs to be probed. We may have to take action against doctors who, without justification, refer patients and put additional pressure on SKIMS. We are seeking details of each referral and the discharge status of those patients," a senior Health Department official said. (KNO)

The spokesman said that inputs further revealed that some of these users were suspected to be in contact with Pakistan-based terror handlers through encrypted messaging applications. "They were found to be involved in spreading false narratives, radicalizing youth and attempting to disturb public order and peace in J&K."

Eight locations across Srinagar, Baramulla, Anantnag, Pulwama, Kupwara, Handwara and Shopian were identified and subsequently searched. "During these searches, seven suspects were detained for questioning. Incriminating digital evidence having bearing on the investigation was seized," the spokesman said.

The raids have successfully disrupted a dangerous ecosystem operating under the facade of social activism but serving terror interests. The seized digital evidence is expected to reveal deeper footprints of the conspiracy, and further arrests cannot be ruled out, the statement reads, adding that investigation is on to unearth the full scale of the conspiracy, identify other operatives, and expose the suspected communication chains with handlers across the border.

"Today's action signals a zero-tolerance approach against those attempting to camouflage terror-linked activities as legitimate civil society initiatives. CIK stresses that such elements not only endanger peace but also act as force multipliers for cross-border terrorism. With investigation gaining momentum, fresh revelations about the covert operations of these pseudo-activist networks, Social Media users, many of whom had been attempting to infiltrate public discourse under noble causes while serving anti-national agendas, are expected," the spokesman said. (KNO)

Railways ferry

as per the news agency—Kashmir News Observer (KNO), has been launched amid road connectivity disruptions and is being described as a historic achievement by railway officials.

The division said the service began on September 11, 2025, with two parcel van coaches—one for Jammu and another for Adarsh Nagar, Delhi—each carrying around 23 tons. The first coach reached Adarsh Nagar from Budgam Railway Station in less than 21 hours, and the other arrived in Jammu in under six hours.

On September 15, J&K Lieutenant Governor Manoj Sinha flagged off an eight-parcel van train, each van with a 23-ton capacity, from Srinagar to Adarsh Nagar, Delhi. These eight vans also completed the run significantly faster than road transport.

Continuing this trend, over 6,400 tons of apples have now been moved from Kashmir to Adarsh Nagar, Delhi, using both BCN covered wagons and parcel coaches supplied from the Anantnag Goods Shed Terminal in the valley.

The recently launched JPP-RCS parcel train service has also carried more than 500 tons of mustard oil and other food items from Bari Brahmana to Budgam to ensure essential supplies are not hit by road closures.

Senior Divisional Commercial Manager Uchit Singhal said the intervention has been a "big help" to traders and growers. "The Railways' intervention has been helpful to traders and growers in transporting their apples," he said, adding, "We will soon commence the operation of parcel train services with parcel rakes from the Baramulla Railway Station terminal." (KNO)

weeks of transport shortages and skyrocketing freight rates that left thousands of apple boxes stranded in the valley, especially at Asia's second-largest fruit Mandi in Sopore.

A senior administrative official told the news agency—Kashmir News Observer (KNO) that the special rake, arranged in coordination with Northern Railways, will begin loading at Sopore Railway Station tomorrow. "This direct service is a first for Sopore and is aimed at easing the heavy backlog of fruit boxes," the official said, adding that the rail dispatch will provide a faster and more economical alternative to road transport.

Meanwhile, the fruit growers, reeling from repeated highway closures and lack of transport, hailed the initiative. "This is exactly what we were asking for," said Mohammad Altaf, a grower from Zaingeer. "Highway shutdowns and skyrocketing transport rates were destroying our profits. The goods train, along with RTC trucks, gives us hope that our apples will finally reach markets on time and at fair rates."

The growers, however, appealed for regular rail rakes until the end of the harvest.

It is noteworthy that earlier Budgam Railway Station served as the dispatch hub, forcing growers from valley parts to haul produce over long distances, however, with the direct Sopore service eliminating that extra leg, saving both

time and money.

The rail intervention follows a series of emergency measures by the government this

Earlier, the administration deputed 55 J&K Road Transport Corporation (RTC) trucks to Sopore and Shopian mandis after private truckers either refused to operate or charged exorbitant rates.

Growers reported that freight charges to Delhi had jumped to Rs 240–Rs 250 per box, prompting the mandi association to temporarily fix reduced rates Rs 130 for Delhi and Rs 120 for Punjah after grows ment mediation.

Dunoo said houseboats require expensive annual repairs. "Each houseboat needs at least Rs 1.2 lakh every year just for maintenance and caulking. But right now, we can't even manage basic household expenses, let alone repairs," he said.

The Kashmir Houseboat Owners Association told KNO that the crisis is rippling across the sector. "Out of over 3,000-plus rooms across 750 houseboats, only 30 to 40 are occupied. The rest are empty," said its chairman, Manzoor Ahmad Pakthoon, adding that staff have been laid off and families have no income.

Dunoo said the situation has pushed many families to the brink. "We are not asking for luxuries. We just want enough to pay fees, buy books for our children and feed our families. Right now, we cannot do even that," he said.

Shikara operators and shopkeepers around Dal Lake said they too are badly affected. "No tourists means no rides, no buyers. Everyone linked to tourism, from vendors to artisans, is suffering," said a local shopkeeper.

It is worth mentioning that the government's decision to close 46 tourist destinations for security reasons has further added to the slump. Chief Minister Omar Abdullah earlier termed the ban "counterproductive," saying it undermines the Valley's tourism promotion campaigns.

Notably, the history of Kashmir's tourism sector has been chilling. In 1995, foreign tourists were kidnapped in Pahalgam, and one of them was killed. In 2000, the Amarnath Yatra massacre claimed multiple lives in Pahalgam. In 2017, eight Amarnath pilgrims were killed in an Anantnag attack, and in 2025, over 25 tourists and a local guide were killed in Pahalgam — the deadliest attack in recent memory. (KNO)

India's biggest enemy is its dependence on other nations; self-reliance only remedy: PM Modi

Bhavnagar (Gujarat), Sep 20: Prime Minister Narendra Modi on Saturday said India's main adversary is its dependence on other nations as he made a strong pitch for "aatmanirbharta" and called for indigenous production of everything from semiconductor chips to ships.

Speaking at the 'Samudra se Samruddhi' event, where he inaugurated and laid foundation stones of projects worth Rs 34,200 crore, Modi said all the problems of India have only one solution, and that is self-reliance.

"India is moving forward with the spirit of global brotherhood and India has no major enemy in the world today, but in true terms, India's biggest adversary is dependence on other nations, stated the Prime Minister, emphasising that this dependence must be collectively defeated.

He said greater foreign dependence leads to greater national failure. "For global peace, stability, and prosperity, the world's most populous country must become self-reliant," Modi said, and cautioned that reliance on others compromises national self-respect.

"The future of 140 crore Indians cannot be left to external forces, nor can the resolve for national development be based on foreign dependence. The future of the coming generations cannot be left to others. If the country with a



population of 140 crore is dependent on others, it compromises

national self-respect," he added. As per a popular saying, pain of 100 kinds has only one remedy; similarly, all problems of India have one solution, and that is aatmanirbharta (self-reliance), Modi stated. Targeting Congress, Modi said the talent of young people was suppressed after Independence by the then ruling party which brought in a "license Raj".

"As a result of consistently ignoring inherent strengths of India, the country couldn't achieve the success it truly deserved even after six to seven decades of freedom," Modi said and blamed 'prolonged entanglement in the license-quota regime and isolation from global markets" as the main factors. When the globalisation era began, the then governments focused solely on imports, which led to scams of thousands of crores of rupees, Modi said. Citing India's shipping sector as a major example of the damage caused by flawed policies, Modi said that India once had a very vibrant ship-building industry.

"Ships built in India's coastal states once powered domestic and global trade. Even fifty years ago, India used domestically built ships, with over 40 percent of its import-export conducted through them. "Till 50 years ago, our trade was carried out by 40 per cent ships made in India, but this has now come down to just 5 per cent," the PM pointed out.

He said India pays a staggering USD 75 billion or Rs 6 lakh crore every year to foreign shipping companies for their services.

"Can people imagine how much money has been paid in freight to other countries over the past seven decades? This outflow of funds has created millions of jobs abroad. If even a small portion of this expenditure had been invested by earlier governments in the domestic shipping industry, the world would have been using Indian ships today, and India would have been earning lakh of crores in shipping services," the

"Chips (semiconductor chips) or ships, we must make them in India," Modi said, adding that domestic ports are the backbone of India's rise as a global maritime powerhouse.

India's maritime sector is now moving towards next-generation reforms, he said, and announced that from today, all major ports in the country will be freed from multiple documents and fragmented processes.

"The implementation of 'One Nation, One Document' and 'One Nation, One Port' Process will simplify trade and commerce," he said. He said a series of reforms have been initiated in the maritime sector, and five maritime laws have been introduced in a new form.

The PM said a historic decision has been taken to strengthen the maritime sector, with large ships now accorded the infrastructure status. "Ship-building companies will now find it easier to secure loans from banks and will benefit from reduced interest rates. All benefits associated with infrastructure financing will now be extended to these ship-building enterprises," Modi added.

He said the government is working on three major schemes to make India a major maritime power.

GST reforms to free Rs 2 lakh cr, boost jobs, MSMEs, domestic consumption: FM



New Delhi, Sept 20: Union Finance Minister Nirmala Sitharaman has said with the slew of GST reforms set to come into effect from September 22, a total of Rs 2 lakh crore will be in the hands of the people, boosting domestic consumption.

With the simplification of the Goods and Services Tax from the earlier four slabs to 2 slabs, Sitharaman said Prime Minister Narendra Modi is keen to ensure that the poor and downtrodden, middle class families and the micro, small and medium enterprises (MSMEs) largely benefit out of the GST reforms. The finance minister was speaking at the 80th anniversary of the Tamil Nadu Foodgrains Merchants Association here on Friday.

The new set of GST reforms with a revised tax structure is set to come into force from September 22.

"With the proposed GST reforms, there will be an increase in consumption in the domestic market. The Finance Ministry does not receive the Rs 2 lakh crore as taxes from the public, but it goes back into the economy aiding domestic

consumption," she said. Elaborating, she said, because of the two slab structure, the price of a product which a customer normally buys gets reduced.

"For example, when you buy the same product, say a soap in larger quantities, the manufacturer increases the production. To increase production, he recruits a lot of people, and when there are a lot of people, they pay tax to the income. And there will be revenue to the government as indirect taxes. When this virtuous cycle keeps on happening, it is good for the economy," she said.

Non-judicial members of tribunals averse to passing orders against govt, must reflect: CJI

New Delhi, Sept 20: Chief Justice of India B R Gavai on Saturday said some of the non-judicial members of the tribunals, who are usually ex-bureaucrats, are averse to passing any orders against the government and urged them to reflect.

Addressing the 10th All India Conference of the Central Administrative Tribunal 2025 here, the CJI flagged various issues plaguing the tribunals and the country's justice delivery system in the presence of Union Law Minister Arjun Ram Meghwal and Union Minister of State in the Prime Minister's Office Jitendra Singh.

CJI Gavai said the administrative tribunals are unlike courts as they occupy a unique space between the executive and the judiciary, and many of their members come from administrative services while others come

US tightens visa rules —

Tata Consultancy Services second only to Amazon in H-1B approvals

New Delhi, Sept 20: Tata Consultancy Services (TCS) is the second-highest beneficiary with over 5,000 approved H-1B visas in 2025, after Amazon, according to federal data. According to the US Citizenship and Immigration Services (USCIS), Amazon had 10,044 workers using H-1B visas as of June, 2025. Coming in at the second spot was TCS with 5.505 H-1B visas approved.

Other top beneficiaries

include Microsoft (5189), Meta (5123), Apple (4202), Google (4181), Deloitte

(2353), Infosys (2004), Wipro (1523) and Tech Mahindra Americas (951). In a move that could significantly impact Indian IT and professional workers in the US, the Trump administration announced a staggering annual fee of USD 100,000 on H-1B visas, a move it said aims to check

the "systemic abuse" of the programme.

Trump signs proclamation imposing \$1,00,000 fee for H-1B visa applications

'Will impact Indian professionals'

Washington, Sept 20: In a move that could adversely impact Indian professionals on visas in the U.S., President Donald Trump on Friday (September 19, 2025) signed a proclamation that will raise the fee for H-1B visas to a staggering \$1,00,000 annually, the latest in the administration's efforts to crack down on immigration.

White House staff secretary Will Scharf said the H-1B non-immigrant visa programme is one of the "most abused visa" systems in the country's current immigration system, and it is supposed to allow highly skilled labourers, who work in fields that Americans don't work in, to come into the United States.

The Trump administration said that the \$1,00,000 fee is aimed at ensuring that the people being brought into the country are "actually very highly skilled" and do not replace American workers.

The move is aimed at protecting American workers while ensuring that companies have a pathway to hire "truly extraordinary people"



and bring them to the United States. Companies pay to sponsor H-1B applicants. "We need workers. We need workers. We need workers, and this pretty much ensures that that's what's going to happen," Mr. Trump said, as he signed the proclamation in the Oval Office in the presence of Commerce Secretary Howard Lutnick.

Mr. Lutnick said that historically,

"We are going to stop doing that. We're going to only take extraordinary people at the very top, instead of those trying to take jobs from Americans. They're going to create businesses and create jobs for Americans. And this programme will raise more than \$100 billion for the treasury of the United States," he added.

Indian-origin tech firms corner 1/5th of H1B visas issued by U.S.

Mr. Trump said that the country will use that amount to cut taxes and pay down debt. "We think it's going to be very successful," he said.

Mr. Lutnick added that the fee of \$1,00,000 will be charged annually.

The move is going to significantly impact Indian technology workers who are hired by tech companies and others on H-1B visas. The visas are valid for three years and can be renewed for another three years.

If a company sponsors an employee for the Green Card, the visas can be renewed till the permanent residency comes through.

Return to US immediately: Immigration attorneys, companies tell H-1B workers

Washington, Sept 20: Immigration attorneys and companies are cautioning H-1B visa holders against travelling outside the US amid President Donald Trump's new plan to impose a USD 100,000 fee on the work visas, with many asking employees to return immediately to America or risk getting stranded.

In a significant development that will have an impact on Indian professionals working on H-1B visas in the US, Trump signed a proclamation Friday that restricts the entry into the United States of nonimmigrants working in a "speciality occupation" unless their H-1B petitions are accompanied or supplemented by a payment of USD 100,000. This proclamation will come into effect from 12:01

am September 21, 2025.

Immigration attorneys and companies are sounding the alarm for H-1B visa holders or their family members currently outside the US for work or vacation, asking them to return to the US before the proclamation kicks in on September 21, essentially telling those outside the country to return within the next 24 hours or risk being stranded and denied entry into the US.

"H-1B visa holders who are out of the US on business or vacation will get stranded unless they get in before midnight September 21. H-1Bs still in India may have already missed the deadline as there is no way a direct flight from India will get in time," eminent New York-based immigration attorney Cyrus Mehta said in a post on X.

Zelensky says will meet Trump next week as Russia intensifies attacks

Kyiv, Sept 20: Ukrainian President Volodymyr Zelensky said he would meet US counterpart Donald Trump on the sidelines of the United Nations General Assembly next week as Russia intensified strikes across his country.

Russia carried out one of its largest aerial attacks overnight, firing 40 missiles and some 580 drones at Ukraine in a barrage that killed at least three people and wounded dozens, Zelensky said Saturday. A Ukrainian strike, meanwhile, killed four people in Russia's southwestern Samara region, local governor said, in one of the deadliest Ukrainian retaliatory strikes on Russia since Moscow launched its invasion in 2022.

Zelensky said he would hold "a meeting with the President of the United States," adding he would discuss security guarantees for Ukraine and sanctions on Russia during the talks with

Asia Cup: ICC sticks with Pycroft as referee for India-Pakistan game

Dubai, Sept 20: The International Cricket Council (ICC) has once again assigned the high-voltage India-Pakistan Asia Cup Super 4s game on Sunday to its Elite Panel Match Referee Andy Pycroft despite PCB's repeated requests to strike him off the roster.

"Andy Pycroft is the match referee for Indo-Pak game," a tournament source told PTI.

The list of match officials for the Sunday's game hasn't yet been made public. The other match referee in the tournament is former West Indies captain Richie Richardson.

Pycroft was the match referee last Sunday when Indian team as a policy decision, didn't shake hands with the Pakistan team but the Zimbabwean found himself in the centre of the controversy after India skipper Suryakumar Yadav didn't follow the convention at the toss. The Pakistan team had written two mails to ICC, first requesting Pycroft's removal from the tournament and then asking the global body to remove him from their games.

Both the demands were outrightly rejected by the ICC as it stood

firmly behind its Elite Panel referee.
The ICC rejected PCB's claims that
Pycroft violated the 'Spirit of the Game'
code, insisting that he was merely a
messenger, who passed on what was

as there were only few minutes left for
the match to begin.

The ICC later arranged a meeting between Pycroft and Pakistan team management comprising captain Salman, head coach Mike Hesson and manager Naveed Akram Cheema where he said that he "regretted

the miscommunication".

The ICC, then in another e-mail, pointed out that Pycroft never apologised but only "regretted the miscommunication" and also accused PCB of violating protocols related to 'Players And Match Officials Area' (PMOA), which the latter denied.

In this backdrop, appointing Pycroft for another Indo-Pak game is a clear indication that the global body doesn't want to budge from its stand as removing the former Zimbabwe Test batter would have set a wrong precedent.

Dubai, Sept 20: Closing the hotel room door, switching off the cell phone and going off to sleep are good to "shut outside noise" before a crunch game but Indian skipper Suryakumar Yadav knows that some things are "easier said than done" as he gears up for another high-voltage Asia Cup battle against Pakistan on Sunday.
