## CDS calls for making India global leader in next-gen defence tech

Urges academia to scale innovation, seeks whole-of-nation approach to achieve goals

New Delhi, Sept 22: Calling for a whole-of-nation approach to make India a global leader in next-generation defence technologies Chief of Defence Staff (CDS) General Anil Chauhan on Monday urged academia to scale innovation for making the country self-reliant.

Addressing a tri-services symposium here, CDS Chauhan, according to the news agency—Kashmir News Observer (KNO) said, "The changing nature of modern warfare driven by convergence across kinetic and non-kinetic domains has necessitated advanced and technological

He emphasised the critical role of academia, start-ups and industry in developing indigenous capabilities across platforms, weapons, networks and doctrines to meet future operational



demand.

Meanwhile, in a statement, a Defence Ministry spokesman said that the inaugural edition of the Tri-Services Academia Technology Symposium (T-SATS) was held at the Manekshaw Centre at Delhi Cantonment, synergising the services-academia R&D ecosystem for development of niche and futuristic technologies tailored for the Indian armed forces.

It said that the symposium was inaugurated by

Gen Chauhan and the event witnessed participation from directors and heads of departments of academic and premier R&D institutions, along with students from 62 institutes including IISc, IITs, IIITs and private technology

The CDS also inaugurated a technology exhibition show-casing 43 selected innovative exhibits by academia.

'These innovations were evaluated by subject matter experts from various

technology domains of the three services for their potential military applications. Projects showing promise will be considered for R&D collaboration and funding support in future," the statement said.

A major highlight of the day was a series of 95 structured one-on-one meetings between academic innovators and service representatives. These closed-door sessions provided a platform for academia to pitch R&D proposals and receive strategic guidance on converting ideas into military-use cases, fostering a collaborative and results-oriented environment, it said, adding that these meetings will continue on Tuesday.

'Freight relief fails to lift sluggish market'

Srinagar, Sept 22: Despite some respite in freight charges following the deployment of RTC trucks, Kashmir's apple growers continue to grapple with one of the toughest seasons in recent memory, as plummeting demand in outside markets overshadows the relief.

Kashmir, often called the "Apple Bowl of India", contributes nearly 75–78% of the



country's total apple produc-According to official figures, tion, producing about 2 million the valley harvested 20.64 lakh metric tonnes of apples

in 2023-24, with a similar projection of 20.56 lakh metric tonnes for the ongoing 2024– 25 season.

However, instead of boosting confidence among growers, this year's marketing season has been marred by weak demand, oversupply in man-dis, and prices that continue to nosedive.

SRINAGAR, SEPTEMBER 22: A comprehensive 15 days campaign for Prevention of Water-borne diseases and intensification of Water quality testing in flood/ landslide affected areas of I&K concluded on Monday.

The campaign was launched on 4th September 2025 to prevent the outbreak of water borne diseases after devastating floods in many districts of UT. The campaign reflects the commitment of the Jal Jeevan Mission of Jal Shakti department in restoring water supply infrastruc-ture and improving service delivery to citizens.

Intensive Water Quality testing of samples in affected areas was carried out through district and sub-divisional lab staff of Public Health Engineering Divisions. The main focus was to check contamination (if any) at both the Source and Consumer point level with at least three tests in each affected village.

Local communities and line departments like health, education and RDD played a critical role in testing of water samples in schools, anganwadi centre's and Health



Institutions. Onspot testing was carried out in Schools and AWCs and awareness camps were conducted for educating the children in this regard. Activities were organized in 6,486 schools and 1,940 Anganwadi Centre's (AWCs) to spread awareness on common WASH practices, besides 5,945 AWCs in affected areas were covered, with 2,563 centre's conducting activ-



Srinagar, Sep 22: In Jammu and Kashmir, 87 percent of students are paying course fees in schools. However, on the contrary only 57.1 percent students pay such charges at the national level.The official figures reveal that at least 87 percent of students reported expenditure on course fees by level of current enrolment for Jammu and Kashmir including 89.3 percent among the male and

84.3 percent among the female students. It also said that the national percentage of students reported expenditure on course fees by level of current enrollment for each state and UT was 57.1 percent in 2025.

According to the official figures, in the



rural areas of Jammu and Kashmir, 85 percent persons including 87.7 percent males and 81.7 percent females enrolled in school reported expenditure on course fees by level of current enrolment.

Likewise, in the urban areas of Jammu and Kashmir at least 96.1 percent persons enrolled in school reported expenditure on course fees by level of current enrolment. This includes 95.9 percent of male and 96.3 percent female students

At higher secondary level, the official figures reveal that the students in Jammu and Kashmir reported 100 percent expenditure on course fees by level of current enrolment. However, the national average at the senior secondary level is only 85.9 percent.

Similarly, at the secondary level 98.7 percent of students at both rural and urban areas reported expenditure on course fees by level of current enrolment—(KNO)

## Wular welcomes over 3 lakh migratory birds

Bandipora, Sep 22: Wular Lake, India's largest freshwater lake, has witnessed a significant rise in migratory bird arrivals this year, with the Asian Water Bird Census 2025 registering more than three lakh birds—a fourfold increase from last year's count of 75,000.

An official said that this is just the beginning of their arrival. By late October, the numbers are expected to rise further as more migratory birds continue to reach Wular Lake, he said.

The official said the surge reflects the success of conservation and restoration measures undertaken in recent years. "Cleaning, desilting, habitat restoration, and the installation of CCTV monitoring have greatly improved the ecological conditions of the lake, making it a more suitable environment for migratory birds,"

The census data shows that the highest numbers were recorded among



species such as Northern Shoveller, Mallard, and Gadwall. Other species, like Pintail and several rare migratory birds, were also spotted in large flocks. Wular Lake has become a preferred wintering ground for these birds, many of which travel thousands of kilometres from Central Asia, Europe, and Siberia.

Bird enthusiasts from across India have been flocking to Bandipora to observe the spectacle. "This year, the diversity and sheer number of birds is unlike anything habitat for globally significant bird populations. Wular's revival is not

### Growers struggle as freight cost sore, cold storages full

on the lake.

Srinagar, Sep 22: With the Srinagar–Jammu National Highway witnessing frequent closures, coupled with low demand and soaring freight charges, hundreds of apple growers in Kashmir have been turning to cold storage facilities to save their produce. However, much to their frustration, all cold storage units across the valley are already booked in advance, leaving them with no option but to sell at distress rates.

Growers from Shopian, Pulwama and other areas said they are facing one of the toughest seasons in recent memory. They said the traditional supply chain has been disrupted due to

gered by landslides, and whatever produce reaches outside markets is being sold at a lower price because of its deteriorated condition.

"We had pinned our hopes on cold storage facilities this year so that we could wait for the right market rates. But when we approached the units, they told us all slots were pre-booked months ago," said Abdul Rashid, an orchardist from Pulwama. "This means small and middle-class growers like us are left helpless. Big traders who can book storage space in advance are safe, but the ordi-

nary grower is left to suffer." Another grower from Shopian, Ghulam Ahmad, said the government should step in immediately. "Every

are told to make use of cold storage. But the reality is different—there simply isn't enough capacity. If new units are not built, this crisis will keep repeating year

after year." he told KNO. Fruit growers' associations also raised concerns about high freight charges. They said that even when trucks are available, transporters demand nearly triple the usual rates, further eating into growers' earnings.

"Imagine the plight of a grower—he can neither send his produce outside due to high freight costs, nor can he store it in cold storage due to advance bookings. What option is left except to sell apples at throwaway prices?" asked Bashir

The growers appealed to the administration to address the dual issues of transport shortage and lack of cold storage capacity. "Without immediate government intervention, Kashmir's apple industry— which sustains lakhs of families—will continue to bleed," they said.

Cold storage unit owners explained that growers, after earning handsome returns from their stored produce in controlled atmosphere (CA) units, had already booked slots months before the season began. They added that since all slots are now fully booked, allowing others to reserve or store produce is not feasible—(KNO)

## India's Manufacturing Momentum: Performance And Policy

## Reforms, resilience, and roadmap to global manufacturing leadership

Manufacturing at a Turning Point

Every great economy has a story of factories at its core and for India, that story is rapidly unfolding. Over the past few years, manufacturing has increasingly emerged as a central pillar of the nation's growth model, not just meeting domestic demand but also strengthening India's position in global value chains.

The Index of Industrial Production (IIP), which tracks the volume of output across manufacturing, mining, and electricity, is a snapshot of how industry is performing and its contribution to GDP growth.In July 2025, the IIP recorded a growth of 3.5% year-on-year, rising significantly from 1.5% in June 2025.Manufacturing Growth also grew by 5.40% in July 2025 yearon-year, up from 3.7% of June 2025.

India's growth story is increasingly powered by the hum of modern factory floors. From Electronics Manufacturing Cluster (EMC)in Pune, to laptop assembly line in Chennai, it reflects the spread of industrial activity across regions. Behind the scenes, policies like PLI, National Manufacturing Mission and others are turning these hubs into high-performance nodes.

With global supply chains shifting and India's domestic market expanding, the sector is well positioned to play a pivotal role in driving and sustaining overall growth.

#### **The Pulse of Performance**

The growth in IIP in July, 2025 was driven largely by manufacturing, underscoring rising demand and stronger capacity utilization across industries.

The momentum was also mirrored in the HSBC India Manufacturing Purchasing Managers' Index (PMI) for manufacturing. In June 2025, PMI stood at 58.4, climbing to 59.1 in July- it's highest in 16 months, before inching up further to 59.3 in August. This latest reading signalled the fastest improvement in operating conditions in over 17 years.

The uptick was driven by a sharp acceleration in production volumes-the quickest pace in nearly five years alongside robust grow in new factory orders. Companies responded by scaling up input purchases and expanding their workforce, underscoring confidence in the sector's near-term prospects.

The IIP's uptick reflects India's broader industrial ambition. By 2047, in the Amrit Kaal of independence, the goal is not just participation but leadership in global manufacturing, creating millions of jobs, and boosting exports.

Together, these indicators show a clear trajectory: India is laying the foundation for its economic growth, with manufacturing at its core.

#### **Engines of Growth: Sectors on the Move**

India's manufacturing export engine is firing on multiple cylinders as broader merchandise trade stabilizes.

The contribution of manufacturing sector in the economy is evident with the rise in exports. In April-August 2025, total exports rose 6.18%YoY to US\$ 349.35 Billion. The cumulative value of merchandise exports during April-August 2025 was US\$ 184.13 Billion, as compared to US\$ 179.60 Billion during April-August

2024, registering a positive growth of 2.52%. With the visible development in manufacturing sector, it shows that the sector has potential to reach Rs. 87,57,000 crore (US\$ 1 trillion) in FY26 and potentially add more than Rs. 43,43,500 crore (US\$ 500 billion) annually to the global economy by 2030, which indicates that India is steadily cementing its position as a global manufacturing hub.

While July's IIP surge was powered primarily by basic metals, electrical equipment, and nonmetallic minerals, the broader story of India's manufacturing ascent goes beyond these categories. Alongside these high-performing industries, a set of strategic sectors- electronics, pharmaceuticals, automobiles and textiles are driving long-term structural growth and shaping India's global competitiveness.

Together, these sectors not only anchor India's export momentum but also reinforce its ambition to become a US\$ 1 trillion manufacturing economy by FY26. The following highlights showcase how these industries are emerging as the engines of India's manufacturing renaissance.

#### **Electronics: India's Factory Floor Goes**

India's electronics manufacturing sector has seen a sixfold rise in production and an eightfold surge in exports over the past 11 years. Electronics value addition has jumped from 30% to 70%, with targets to reach 90% by FY27.

Production of electronic goods has increased from Rs 1.9 lakh crore in 2014-15 to Rs 11.3 lakh crore in 2024-25, approximately a sixfold rise. Similarly, exports of electronic goods have surged from Rs 38,000 crore to Rs 3.27 lakh crore, an eightfold increase. The number of mobile manufacturing units has grown from just 2 in 2014-15 to 300 in 2024-25, a 150-fold rise. Production of mobile phones has expanded from Rs 18,000 crore to Rs 5.45 lakh crore, about 28 times more. Export of mobile phones has increased from Rs 1,500 crore to Rs 2 lakh crore, a 127-fold jump. Additionally, mobile phones imported as a percentage of total demand have dramatically decreased from 75% to just 0.02%. Overall, electronics value addition has risen from 30% to 70%, with a goal to reach 90% by fiscal year 2027.

One of the most striking shifts has been in mobile manufacturing. From just two units a decade ago, India now houses around 300 units, reflecting a 150-fold expansion in production capacity. Exports of mobile phones tell even more dramatic story, expanding from a modest Rs 1,500 crore to nearly Rs 2 lakh crore, an increase of 127 times. At the same time, dependence on imports has almost disappeared from 75% of domestic demand being met through imports in 2014-15 to just 0.02% in 2024-25. Overall, these numbers underscore India's transition from being a large importer to becoming a global hub of electronics and India is now the world's second-largest mobile manufacturer.

India has attracted more than USD 4 billion FDI Inflow in the field of electronics manufacturing since FY2020-21 and nearly 70% of this FDI is ontributed by the beneficiaries of PLI Scheme.

#### Pharma: The "Pharmacy of the World"

India's pharmaceutical industry is a global powerhouse ranking 3rd in the world by volumeand 14th in terms of value of production supplying over 50% of global vaccine demand and nearly 40% of generics to the US. The industry is projected to grow to USD 130 billion by 2030 and US\$ 450 billion market by 2047.

Backed by policy support for Pharmaceuticals like the PLI scheme (Rs 15,000 crore) and Strengthening of Pharmaceuticals Industry (SPI) scheme (Rs 500 crore), the industry continues to expand its global footprint. The PLI scheme is driving investments into 55 projects to make high-end drugs such as cancer and diabetes medicines in India, while the SPI scheme that focuses on raising the quality, competitiveness, and resilience of smaller pharma companies, is funding R&D and modernizing labs, enabling Indian companies to compete globally. Beyond cost efficiency, India has emerged as a hub for affordable, highquality medicines, reinforcing its rightful title as the "Pharmacy of the World."

#### **Automobiles: Shifting into High Gear**

India's automotive industry is a cornerstone of the nation's manufacturing and economic growth, contributing 7.1% to India's Gross Domestic Product (GDP) and 49% to manufacturing GDP, as per NITI Aayog report. During FY25, the total production of passenger vehicles, commercial vehicles, three-wheelers, two-wheelers, and quadricycles was over 3.10 crore units. As the fourth-largest automobile producer globally, India possesses the scale and strategic depth to emerge as a global leader in the automotive value chain.

#### **Textiles: Emerging Leader**

As per economic survey 2024-25, India's textile & apparel industry is among the largest industry globally, contributing around 2.3% to GDP, 13% to industrial production, and 12% to

The sector is set to grow to US\$350 billion by 2030 further strengthening India's position in the global market. This growth is expected to create 3.5 crore jobs. It is also the second largest employment generators, after agriculture, with over 45 million people employed directly, including women and the rural population. As further evidence of the inclusive nature of this industry, nearly 80% of its capacity is spread across Micro, Small and Medium Enterprises (MSME) clusters in the country.

To support the industry further, the government has approved seven PM Mega Integrated Textile Region & Apparel (PM MITRA) Parks backed by Rs 4,445 crore over six years through 2027-28. Under the scheme, the parks aim to attract Rs 70.000 crore in investment and generate nearly 20 lakh direct and indirect jobs. The Prime Minister recently inaugurated the PM MITRA Park in Dhar, Madhya Pradesh on 17th September 2025, where 1,300 acres of land and over 80 industrial units have been allocated. The park is expected to generate about three lakh new jobs.

#### **Investment Flows & Global Confidence**

India has steadily positioned itself as a preferred destination for global investors. Over the past decade, consistent reforms, simpler regulations, and a stable policy environment have attracted significant investments in manufacturing. Initiatives to enhance ease of doing business, coupled with targeted sectoral incentives, have reinforced India's competitiveness as a global manufacturing hub.

Total FDI inflows into India over the last eleven years (2014-25) stood at USD 748.78 billion, up 143% compared to USD 308.38 billion received during 2003-14.

India clocked USD 81.04 billion in gross FDI inflows in FY 2024-25, up by 14% year-onyear growth.

Manufacturing FDI accelerated 18% to USD 19.04 billion in FY 2024-25 (from USD 16.12 billion in FY 2023-24) Maharashtra led the FDI leaderboard with

39% of equity inflows, followed by Karnataka (13%) and Delhi (12%) in 2024-25. Singapore (30%) remained the top origin, ahead of Mauritius (17%) and the United States (11%), reflecting both capital-market intermediation and strategic

ening their India footprint. The Government aims to raise annual FDI

inflows to USD 100 billion. These trends reaffirm India's position as a preferred global investment hub, enabled by a proactive policy framework, an evolving business ecosystem, and rising international confidence in India's economic resilience.

#### **Employment, Skills, and Human Capital**

Manufacturing is not just about machines and assembly lines; it is also about people. As one of the significant employment-generating sectors, manufacturing contributes significantly to India's job market, particularly for semi-skilled and skilled workers.

India's employment has surged, with 17 crore jobs created in the past decade, reflecting the government's focus on youth-centric policies and its Viksit Bharat vision. Recent PLFS data of August 2025 further underlines this positive trend. The Worker Population Ratio (WPR) rose to 52.2%, while the female WPR climbed to 32%, marking steady gains in women's workforce participation. The Labour Force Participation Rate (LFPR) also improved for the second successive month this year, reaching 33.7% for women. The overall unemployment rate eased to 5.1% and Unemployment Rate (UR) among male eased to 5-month low level to 5.0% in August 2025, highlighting broad-based employment creation and inclusivity across sectors, including manufacturing. In the manufacturing sector, job creation stood at 6% between 2004 and

2014, while it rose to 15% in the last decade. The Union Budget 2025–26 provides a strong tailwind to India's manufacturing ecosystem. A key enabler is the restructuring of the Skill India Programme, with an outlay of Rs 8,800 crore (US\$ 1.1 billion) extended until 2026. By integrating Pradhan Mantri Kaushal Vikas Yojana 4.0, the National Apprenticeship Promotion Scheme, and the Jan Shikshan Sansthan Scheme into a unified, industry-aligned framework, the initiative is building a demand-driven, technology-enabled workforce tailored to the evolving needs of modern industry.

Together, these efforts aim to ensure that India's demographic dividend is channeled

effectively into building a competitive, skilled, and adaptive workforce turning human capital into a true engine of industrial growth.

#### **Policy Catalysts Powering the Surge**

On this foundation, a set of complementary policy measures- spanning manufacturing, logistics, industrial growth, urban development, and entrepreneurship are shaping the next phase of India's manufacturing surge. Flagship initiatives have created a strong ecosystem for investment, innovation, and scale, fuelling industrial vibrancy and job creation. Adding further momentum, the recently announced GST 2.0 reforms, with a simplified two-slab structure and reduced rates on essentials, have lowered compliance costs and boosted consumption.

Together, these measures are not just strengthening India's domestic manufacturing base but also positioning the country as a competitive player in global value chains.

Just as factories thrive on steady demand and lean costs, India's recent GST rate cuts arrive as the fuel that keeps the manufacturing engine humming, making goods cheaper for households, inputs lighter for industries, and growth faster for the economy.

#### Key industrial advantages include:

Cost Compression & Stronger Value Chains: Goods like packaging, textiles, leather, wood, and logistics essentials now attract only 5% GST, cutting manufacturing costs and enhancing export competitiveness

MSMEs & Export-Oriented Industries Empowered: Rationalised rates and faster refunds in textiles, handicrafts, food processing, toys, and leather industries ease working capital constraints and support scale-up

Ease of Doing Business & Compliance: Simpler slab structure coupled with procedural simplification like relaxed registration rules for small suppliers will lower regulatory friction and boost formal participation

Auto & Ancillary Ecosystem Acceleration: Slashed GST on vehicles (including twowheelers up to 350cc), auto parts, and tractors will drive consumer affordability and fuel demand and, in turn, increase production.

#### National Manufacturing Mission: The Strategic Compass

National Manufacturing Mission (NMM), announced in the Union Budget 2025–26, is the crown jewel of India's industrial policy. It is a long-term strategic roadmap that integrates policy, execution, and governance into a single, unified vision. Unlike previous fragmented approaches, the NMM is designed as a mission-mode framework that cuts across ministries and states to create a synchronized manufacturing push.

Crucially, the NMM places sustainability at the heart of industrialization. It prioritizes clean-tech manufacturing from solar PV modules and EV batteries to green hydrogen and wind turbines ensuring India's rise in global supply chains aligns with its net-zero 2070 commitment.

In short, the NMM is not just a policy, it is the strategic compass guiding India's transition from incremental gains to manufacturing leadership on the world stage.

#### PLI Scheme: Scale, Speed, Jobs

The Production Linked Incentive (PLI) Scheme, launched in 2020, is one of the Government of India's flagship initiatives to boost domestic manufacturing and enhance India's participation in global supply chains. Covering 14 key sectors ranging from mobile phones, electronics, pharmaceuticals, textiles, to drones the scheme provides financial incentives linked directly to incremental production and sales

Some standout outcomes include:

Pharma: From a deficit of Rs 1,930 crore (FY22) to a Rs 2,280 crore trade surplus (FY25), with exports touching Rs 1.70 lakh crore.

Another record-breaking performance in Smartphone exports under the PLI Scheme. Smartphone exports have crossed INR 1 lakh crore within just five months of FY 2025 - 26 -55% higher than the same period in last fiscal. Solar PV, Auto, Medical Devices, Food Processing - all sectors are showing strong

investment traction and job creation. With an outlay of Rs 1.97 lakh crore, PLI is ensuring Indian manufacturers achieve economies of scale and become globally competitive suppliers.

#### **National Logistics Policy**

Launched in September 2022, it aims to overhaul India's logistics ecosystem by reducing costs, enhancing efficiency, and driving digital integration. Working in tandem with the PM GatiShakti National Master Plan, the NLP sets ambitious goals: bringing down logistics costs, improving India's position in the World Bank's Logistics Performance Index (LPI) to among the top 25 countries by 2030, and building a robust, data-driven decision support mechanism. To operationalize these objectives, the government has rolled out the Comprehensive Logistics Action Plan (CLAP), focusing on digital systems, standardization, human resource development, state-level coordination, and the creation of logistics parks. Together, these initiatives are designed to provide seamless multimodal connectivity and strengthen India's competitiveness in global value chains.

#### Startup India

Launched on January 16, 2016, the Startup India Initiative has rolled out several programs aimed at supporting entrepreneurs, building a robust startup ecosystem, and transforming India into a country of job creators instead of job seekers. India boasts the third-largest startup ecosystem in the world, with 1.91 lakh DPIIT-recognized startups as of September 2025, which have created over 17.69 lakh direct jobs as of January 31, 2025. This remarkable growth underscores the initiative's success in fostering innovation, enhancing employment opportunities, and driving economic development across the nation.

#### **Industrialization and Urbanization**

National Industrial Corridor Development Programme is India's most ambitious infrastructure initiative, aiming to create new industrial cities as "Smart Cities". This program focuses on developing integrated industrial corridors with robust multi-modal connectivity, promoting growth in manufacturing and systematic urbanization. Last year, government approved 12 new project proposals, involving an estimated Rs 28,602 crore investment, marking a significant step in this transformative effort, positioning India as a leading global destination for manufacturing and investment.

As India advances toward its \$35 trillion vision by 2047, manufacturing will be the engine of growth. ## **DDC Reasi reviews** performance of Banks at **DLRC** meeting

REASI, SEPTEMBER 22: District Commissioner (DDC) Reasi Nidhi Malik Monday chaired the District Committee Review (DLRC)-cum-District Consultative Committee (DCC) meeting in the VC Room, DC Office Complex to review the performance of banks for the

quarter ending June 2025. A detailed discussion was held on sector-wise lending in priority and non-priority sectors, bank-wise position of deposits and advances, and the progress of various financial inclusion schemes in the district.

While reviewing the Credit Deposit (CD) Ratio, the DDC appreciated the improvement made as compared to the previous quarter. She, however, directed the banks with low CD ratios to take corrective measures and improve their performance in the upcoming quarter.

The DDC emphasised that the flow of credit to priority sectors such as agriculture, renewable energy, housing and allied activities must be further enhanced to promote inclusive

In terms of financial inclusion, the DDC directed all banks to submit weekly progress reports to the Lead District Manager (LDM), who will also conduct weekly reviews. She called for launching an intensive campaign at the Gram Panchayat level, with specific targets set for the next six months to ensure a net increase in financial inclusion.

The DDC stressed the need for better coordination between banks and line departments to resolve grievances, ensure timely case processing and extend maximum benefits to the public.

Highlighting the need to improve banking access in remote areas, the DDC asked banks to explore possibilities for opening new bank branches in farflung areas such as Jij Bagli, Thakrakote and Gulabgarh. She also directed that ATM facilities and Business Correspondents be made regularly available in these areas.

The meeting was attended by Chief Planning Officer Narinder Kumar, representatives from RBI, NABARD, LDM Reasi Raman, DSHO, CAO and other concerned officers.

## PAC stresses on quality education in Govt schools

Calls for hardship allowances for employees posted in far-flung areas

SRINAGAR, SEPTEMBER 22: The Public Accounts Committee (PAC) of the Jammu and Kashmir Legislative Assembly Monday convened a meeting at the Assembly Complex, Srinagar, to review audit paras pertaining to the School Education Department.

The meeting was chaired by PAC Chairman Sham Lal Sharma and members including Mubarak Gul, Nazir Ahmad Khan (Gurezi), Qaysar Jamshaid Lone, Devinder Kumar Manyal, and Sajad Shaheen also participated in the meeing.

The Committee undertook a detailed examination of Audit Paras 3.5 (2002–03), 2.1 (2018–19), and 4.2 (2019–20) related to the School Education Department.

At the outset, members deliberated on key issues including construction of the DIET at Poonch, establishment of Model Schools, and utilization of funds for infrastructure development and other facilities across Jammu and Kashmir.

Chairman Sham Lal Sharma emphasized the need to formulate a vibrant transfer policy and ensure deployment of category based teachers and lecturers in their local remote areas to uplift the educational scenario in such far- flung

"Those who have benefited on categories including SC and ST should serve their own people and local population first in these remote areas," the chairman said.

The Committee pitched for providing hardship allowance to employees posted in remote areas for their convince.

The Committee stressed the importance of disseminating quality education to students enrolled in government schools for overall improvement of the education scenario in Jammu and Kashmir.

It also called for fast recruitment to fill vacant posts and instructed the concerned departments to expedite the process of referring vacancies to recruitment agencies.

The Committee further underlined the need to fix responsibility on officers for delays in creation of infrastructure, which has caused an undue lag in extending benefits to students under various schemes.

The Chairman directed the concerned authorities to rationalize staff across schools and ensure that students in remote areas have access to quality education and all required facilities.

The Committee also directed the administration to conduct a fresh safety audit of all school buildings and related infrastructure, particularly in

flood-affected areas, and to take immediate safety measures to safeguard lives.

PAC members called for timely completion of ongoing projects and urgent attention to the maintenance of damaged school buildings for the convenience of students.

They asserted that pending works must be expedited and completed within stipulated timeframes.

The Chairman also instructed that accountability be fixed on officers responsible for project delays and sought a comprehensive report on

He reiterated the PAC's mandate to promote transparency, fiscal discipline, and accountability in governance.

Stressing the importance of providing the best possible facilities to students, the Committee recommended adopting vertical construction models for the judicious use of available land.

## CS assesses progress on transit accommodation for migrant employees at Zewan

Srinagar, Sept 22: Chief Atal Dulloo on Monday visited the Zewan site, one of the major locations identified for the construction of transit accommodation under the Prime Minister's Development Package (PMDP), to take first hand assessment of the ongoing works of flats for Kashmiri Migrant employees.

On this occasion besides the Principal Secretary, PWD and Divisional Commissioner, Kashmir he was accompanied by DC, Srinagar; Relief Commissioner; Chief Engineer, R&B (Central) and other concerned officers.

During the visit, the Chief Secretary reviewed in detail the progress made on the construction of 936 one-BHK flats taken up at Zewan. Out of these, 624 flats have already been constructed while another 312 are at different stages of execution. So far, 703 flats have been allotted, marking an increase of 51 allotments since March 2025.

The Chief Secretary also assessed timelines for further completion and was informed that 96 more flats are targeted for completion up to September 2025, followed by 72 flats between October-December 2025, and 144 flats from January-March 2026.

Reviewing the financial progress, it was informed that the revised approved cost of the Zewan project stands at Rs197.37 Cr, out of which Rs124.07 Cr had been utilized up to March 2025. The balance cost of Rs73.30 Cr has been proposed as outlay for 2025-26, with Rs36.65 Cr already released during the current financial year.

Speaking on the occasion, the Chief Secretary emphasized the need to complete the project within the set timelines and ensure early handover of completed flats. "This project must be completed on time and the completed units should be allotted to the employees without any delay," he stressed.

Highlighting the locational advantage of the Zewan site, Dulloo added that the transit accommodations here are ideally suited for employees serving both in Srinagar and Pulwama districts. "This site is feasible for migrant employees posted in Srinagar as well

as Pulwama, and it is therefore imperative that the flats are made ready for occupation at the earliest," he observed.

He directed the concerned executing agencies to maintain high standards of quality in construction and adhere strictly to timelines so that the objective of providing secure and dignified housing to migrant employees working in the Valley is fully realized.

The Chief Secretary is regularly monitoring the progress of all transit accommodations being raised across different districts of the Valley. These projects have witnessed tremendous progress in the last few years and are set to be completed as per the given deadlines.

It Is noteworthy to mention here that at the UT level under the PMDP, a total of 6000 transit accommodations are being constructed for Kashmiri Migrant employees with a revised approved outlay of Rs 1245.38 Cr. With additional commitment from the UT Government, the total availability for the project stands at Rs 1325.85 Cr, including Rs983.28 Cr for construction of flats and Rs 342.57 Cr for allied works.

#### **NH closures during peak** fruit season raise doubts of economic sabotage: Karra

Srinagar, Sept 22: Jammu and Kashmir Pradesh Congress Committee (JKPCC) President, Tariq Hameed Karra voiced strong concern over repeated Srinagar–Jammu National Highway closures during the peak fruit season, saying the disruptions are crippling Kashmir's apple economy and raising "serious doubts of an economic sabotage", aimed at weakening the

Valley's key horticulture sector. Speaking at a party convention in Uri, Karra, as per the news agency-Kashmir News Observer (KNO), hinted at a larger "design" behind the economic disruptions, says the Valley's backbone fruit industry has been badly hit by these highway closures.

"People doubt that whenever the fruit season is at its peak, the road challenges occur. We should investigate whether there is any conspiracy to crush the economy of Jammu and Kashmir, be it horticulture, agriculture or other sectors," the Congress leader said.

He recalled that during the recently concluded assembly elections, the people's "biggest challenge" was to keep the BJP out of power. "The people of Jammu and Kashmir succeeded in keeping the BJP away from the corridors of power. Post government formation, we once again reiterated our demand for the restoration of statehood which was snatched unconstitutionally," he said.

Karra asserted that the Congress deliberately stayed away from joining the new government despite extending "issue-based support" from the outside. "We had promised statehood in our manifesto and until the rights of the people of Jammu and Kashmir are restored, we will not be part of the government. We did support the government but we will continue to speak about the people's miseries", he said, adding that Congress would not shy away from highlighting governance failures even while extending backdoor support.

Pledging to continue the struggle, Karra assured that under the leadership of Mallikarjun Kharge and Rahul Gandhi, the Congress would "not compromise" on issues concerning the rights and economy of the people. "We will raise our voice on every front where people's economy or rights are being obstructed," he said. (KNO)

Chief Minister was informed that slow movement has been on account of poor road conditions in certain stretches of National Highway and not deliberate.

During the meeting, Omar Abdullah expressed concern over damage to the historic Juharak Mandi Heritage Complex in Jammu Divisional Commissioner Jammu, Ramesh Kumar, informed that land subsidence along the Circular Road had damaged the backside of the complex, underscoring the need for urgent protective measures.

The Chief Minister impressed upon his Council of Ministers to finalize departmental projections quickly and for District Authorities to reconcile figures with Departments to arrive at accurate figures so that a consolidated proposal could be submitted to the Government of Îndia for a comprehensive restoration package. He directed officials to ensure robust preparedness, strengthen embankments and put in place effective response mechanisms to safeguard lives and property. He further directed concerned Deputy Commissioners to submit report regarding admissibility of ex-gratia relief in favour of next of kin of families from I&K who lost their lives in Himachal Pradesh in recent land slide.

Earlier, Divisional Commissioner Kashmir Anshul Garg presented a detailed report on the impact of the floods. He informed that losses in Kashmir division included 16 houses which were fully damaged, 57 severely damaged, and 791 partially damaged, with relief already disbursed in all cases. Tragically, one life was lost, for which compensation has been provided, while three other deaths in related incidents in Anantnag were compensated through the Red Cross. The meeting was informed about loss to live-stock, damage to cattle sheds and compensation disbursed in these cases.

Giving details of infrastructure damage, it was informed that nearly 90 km of roads were affected across 279 road stretches, of which 52 have been restored while the rest are under repair. Eighty-seven bridges and culverts were also damaged, with more than half already restored. A breach in the Jhelum at Zoonipora, Shalina in Budgam, is currently being repaired. In the power sector, over 9.34 crore has been proposed for the restoration of damaged poles, conductors, and transformers. Out of 563 affected water supply schemes, 385 have been fully restored, while work is underway on the rest. Safety audits have been conducted on 115 school buildings, with certificates already issued for 43 schools.

Divisional Commissioner Kashmir gave account of agricultural losses with more than 12,500 hectares of land affected and nearly 315 hectares in Horticulture impacted, primarily in Anantnag, Kulgam, and Pulwama, districts with estimated losses of about 59 lakh. On essential supplies, the situation was reported as stable, with stocks of petrol, diesel, and LPG sufficient for several days. Fruit transportation

from Kashmir to Jammu and Delhi is progressing smoothly, with over 1.37 lakh boxes already moved.

Divisional Commissioner Jammu presented the situation in the Jammu Division, reporting several human and heavy material losses. He said the floods claimed 150 lives, left 178 people injured, and 33 missing, with Kishtwar recording the highest casualties. Housing losses were severe, with more than 4,200 homes fully damaged and over 8,600 partially damaged, the worst-hit districts being Udhampur and Jammu. Livestock losses stood at 1,455 and crops over 1,300 hectares were damaged.

It was informed that financial assistance exceeding 40 crore has been disbursed from the State Disaster Response Fund, with an additional 3.35 crore provided from the HCM Relief Fund. Restoration work is underway across sectors, with over 2,700 km of roads and more than half of the damaged bridges already temporarily restored. Permanent restoration of roads and bridges is estimated at nearly 893 crore. The power sector was also badly affected, with over 49,000 distribution transformers hit-almost all of which have now been restored. More than 2,000 water supply works were damaged, with around 1,600 temporarily restored, requiring nearly 195 crore for per-

The education sector also bore the brunt of he floods, with more than 8,800 schools dited for safety. Over 5,500 have been issued safety certificates, of which around 5,200 were deemed safe, while 758 were declared unsafe. In public health, 442 water samples tested and over 1,500 health camps were organized, screening nearly 80,000 people. Encouragingly, no warning signs of disease outbreaks have been reported.

Chief Minister Omar Abdullah reiterated that permanent restoration of infrastructure and restoration of livelihoods would be taken up on a war footing once a comprehensive package is approved by the Government of India.

"The pattern of traffic is streamlined & monitored by the Traffic Police personnel so that if traffic on NH is plying towards Jammu today the traffic will be plying on Mughal Road towards valley & tomorrow the traffic will move towards valley on NH while through Mughal Road the vehicles will move towards Jammu," he said.

The pattern is reversed so that the traffic flow is streamlined & remains uninterrupted,

He added that the restoration of the National Highway is being expedited with the support of local administration and agencies & the IGP Traffic is closely monitoring the traffic movement in coordination with NHAI & local administration which has resulted in fast movement of vehicles.

He informed that as of now movement of trucks has significantly increased from previous 1500-2000 vehicles per day to 4000-4500 vehicles per day now.

He added that 2000 fruit laden trucks have left from Qazigund towards Jammu, and all the fruit laden trucks from the valley shall be despatched towards Jammu by late evening.

Yesterday, around 1800-1900 trucks have reached Jammu via Mughal Road so that the dispatching of fresh fruit is given top priority and growers may not face any inconvenience, Garg said.

"Recently the Parcel train service was inaugurated by HLG of J&K so the fruit is directly taken from Srinagar to Adarsh Nagar Delhi, Div Com said and added that 800 to 1000 tons of fresh fruit are being transported daily through Parcel Train Services to Delhi.

He said that the demand for train loading operations from Baramulla and Anantnag is being processed further to help the farmers.

In response to rumors of shortages of essential supplies, Div Com said that the stock of essential supplies, including petrol, diesel, LPG, and other crucial items is adequately available for at least one week. There is no need for panic buying, he said.

about the slow pace of sales. "So far, only 30–35% of the produce has been transported to markets, while nearly 70% is still lying in godowns and orchards. The government's step of pressing RTC trucks into service did help check skyrocketing freight rates, but the bigger problem this year is demand. The rates in mandis are falling further instead of improving," he said.

Growers across south Kashmir's fruit-rich districts of Shopian and Pulwama echoed the same concerns.

Ghulam Nabi, a grower from Shopian, said: "Our apples are reaching mandis, but buyers are not offering fair prices. After the freight issue was addressed, we hoped for some improvement. Instead, the rates are dropping every single day. It is extremely discouraging."

Abdul Rashid, another orchardist from Pulwama, said quality was not the issue this year: "The produce is excellent, but what is the use if there is no demand? The cost of labour, sprays, and packaging has gone up, and if rates remain so low, growers will suffer heavy financial losses again.' This industry has already suffered heavy

losses due to the highway crisis, followed by high freight charges, diseases and natural calamities.

As per the fruit growers' associations, this industry has suffered a loss of over Rs 1200 crore so far due to highway closure.

The apple industry, regarded as the backbone of the valley's rural economy, directly or indirectly supports more than 3.5 million people. With the sector already battered by frequent highway closures, inadequate cold storage capacity, and rising production costs, growers fear that this year's poor returns could push many families deeper into debt. ## Rs 1.5 lakh crore for investors in renewable energy' PRALHAD JOSHI

'New GST cut to save up to



New Delhi, Sept 22: GST reduction on renewable energy will save up to Rs 1.5 lakh crore for investors till 2030, Union Minister Pralhad Joshi said on Monday.

The comments from the Union New & Renewable Energy Minister assume significance as Monday is the first day of implementation of the Goods and Services Tax reduction.

In a bonanza to consumers, the GST Council, comprising the Centre and states, decided to reduce tax rates on goods and services, from September 22 -- the first day of Navratri.

The GST cut will give a significant boost to India's ambitious target of having 500 GW of renewable energy by 2030.

Talking to reporters on the sidelines of the CII 6th International Energy Conference, Joshi said, "I thank Prime Minister Narendra Modi for cutting GST on renewable equipment from 18 per cent to 5 per cent, especially on the occasion of the Navratri festival."

He further said this will save Rs one lakh crore to Rs 1.5 lakh crore

for investors till 2030. According to the Ministry of New & Renewable Energy, given that India plans to add around 300 GW of renewable energy capacity by 2030, even a modest 2-3 per cent cost reduction can free up Rs 1-1.5 lakh crore in investment

Farmers under PM-KUSUM are expected to save Rs 1,750 crore on 10 lakh solar pumps with the GST cut, the ministry estimates show. Earlier, addressing the confer-

ence, Joshi said at the COP26 in 2021, when Prime Minister Narendra Modi first laid down the roadmap for the country's clean energy journey, he set a target that many thought was impossible: 500 GW of non-fossil fuel capacity by 2030.

Today, I am proud to say that we have already achieved over 50 per cent of our installed power capacity from non-fossil fuel sources, and we have done it five years ahead of the timeline. We have also crossed 50 per cent of the 500 GW target (252 GW)," he said. He informed that nearly 20 lakh homes have benefited from solar power under the PM Surya Ghar: Muft Bijli Yojana.

He further said in a recent clean energy auction, Madhya Pradesh secured India's lowest-ever price for solar power with battery storage at just Rs 2.70 per unit.

He said the transmission system has been planned for about 537 GW of renewable energy capacity by 2030.

## Japanese automaker Nissan to way to develop self-driving technology

Tokyo, Sept 22: Japanese automaker Nissan is developing new self-driving technology as it works to turn around its struggling auto business. In a recent demonstra-

tion of the technology, set to be available in 2027, a Nissan Ariya sedan outfitted with 11 cameras, five radars and a next-generation sensor called LiDAR maneuvered its way through downtown Tokyo, braking for red lights as well as pedestrians and other cars at intersections.

Previous Nissan self-driving technology was designed for freeway driving, where the lanes are clearly marked and



easier to decipher. The new technology is designed for congested, unpredictable city streets.

Ĭt's an already-crowded field. The self-driving car market is estimated to reach \$2 trillion by 2030, according to market researcher IndustryARC, riding on the back of advances in AI, sensor technologies and data processing capabilities.

Japan's top automaker, Toyota Motor Corp, has a partnership deal with Waymo, another self-driving technology developed by Google. Waymo has also arrived in Japan, in partnership with a cab company, but it's still in the testing stage.

Other automakers are also working on autonomous driving technology, including Honda Motor Co, General Motors and Mercedes-Benz, as well as companies outside the auto industry like Amazon and its subsidiary Zoox.

Nissan's push comes at a time when the overall Japanese auto market is facing serious challenges because of President Donald Trump's tariffs. Nissan especially is struggling.

It has slashed jobs and appointed a new chief executive, Ivan Espinosa, to attempt a turnaround. The maker of the March subcompact, Leaf electric cars and Infiniti luxury brand posted losses for the

of people worldwide and is characterised by persistently high blood sugar levels caused by insufficient insulin production from the pancreas. Managing this condition often requires a combination of medication, diet, and lifestyle changes. Recent research indicates that a common kitchen vegetable, the onion (Allium cepa), may offer additional benefits for diabetes management. A study presented at The Endocrine Society's 97th annual meeting found that onion extract, when administered alongside the antidiabetic drug metformin, significantly reduced blood sugar



by up to 50 percent in diabetic rats. The extract also lowered sandwiches for a crunchy, flavorful addition Cooked in soups, total cholesterol, suggesting that including onions in daily meals could support blood sugar and heart health naturally.

### **Pro-Palestinian strikes**, protests disrupt transport across Italy

Rome, Sept 22: Pro-Palestinian protests, strikes and blockades swept across Italy on Monday, disrupting transport and port operations, as unions and activists demanded an end to Israel's offensive in Gaza and called for sanctions.

The mobilisation coincided with France's and several other countries' intention to recognise the State of Palestine at the United Nations General Assembly in New York, following recognition by the United Kingdom, Australia and Canada on Sunday. But Italy has taken a more cautious stance and will not recognise a Palestinian state for now.

In Rome, hundreds of high school students gathered outside Termini train station, waving Palestinian flags and chanting "Free Palestine!'

Michelangelo, 17, told AFP he was there to support "a population that is being exterminated." Francesca Tecchia, 18, joined her first protest, saying "what is happening (in Gaza) is too important."

"Italy must come to a standstill today," said Federica Casino, a 52-year-old worker demonstrating alongside the students "for Gaza's dead chil-

dren and destroyed hospitals." Strikes also hit Italy's ports. In Genoa, dockworkers blocked access roads early in the morning, waving Palestinian flags and vowing to stop Italy being used as a staging post for arms shipments to Israel. Further down the coast in Livorno, an entrance

to the port was also blocked. "The Palestinian people



continue to give us yet another lesson in dignity and resistance," said Ricky, a protester from the Autonomous Port Workers' Collective. "We learn from them and try to do our part."

Demonstrations were also reported in Milan, Turin, Florence, Naples, Bari and Palermo. In Rome, bus services were disrupted and metro trains faced delays, though in Milan and other cities most underground lines continued to run. Airlines were not affected. Several schools closed after unions joined the strike.

## North Korea's Kim open to US talks, has 'fond memories' of Trump

Seoul, Sept 22: North Korean leader Kim Jong Un says he has "fond memories" of US President Donald Trump and is open to future talks with the United States — if he can keep his nuclear arsenal.

Kim met Trump three times for high-profile summits during Trump's first term, before talks collapsed in Hanoi in 2019 over what concessions Pyongyang was prepared to make on its atomic weapons.

The US demand that Kim give up his banned weapons has long been a sticking point between the two countries, with Pyongyang under successive rafts of UN sanctions over its nuclear and missile programs

"If the United States discards its delusional obsession with denuclearization and, based on recognizing reality, truly wishes for peaceful coexistence with us, then there is no reason we cannot meet it," Kim said, according to a report Monday by the official Korean Central News

"The world already knows well what the United States does after it forces a country to give up its nuclear arms and disarm," he said.

"We will never give up our nuclear weapons.'

Kim said sanctions had only helped the North in "growing stronger, building endurance and resistance that cannot be crushed by any pressure."

Kim also added he had "no reason to sit down with South Korea," even as Seoul's new President Lee Jae-myung has sought to ease tensions with the North.

"We make it clear that we will not deal with them in any form," he said

Kim's speech reiterates Pyongyang's position that it must be recognized as a nuclear state before any talks can take place, Hong Min, a senior analyst at the Korea Institute for National Unification, told AFP. "It reaffirms the North's stance that recognition as a nuclear-armed state, along with a willingness to

improve relations with it, are the prerequisites for dialogue,

"It calls for a fundamental shift toward equal dialogue and improved relations as a nuclear-armed state.'

North Korea has in recent years declared the South its principal enemy and blown up rail links and roads connecting the two countries.

Russia ties "The lengthy and detailed justifications reflect equal parts confidence and desperation," Yang Moo-jin, former president of the University of North Korean Studies in Seoul, told AFP.

"While outwardly aimed at foreign powers, the speech carried a strong domestic message, seeking to pre-empt instability," Yang said.

Kim has been emboldened by the war in Ukraine, according to analysts, securing critical support from Russia after sending thousands of North Korean troops to fight alongside Moscow.

## China silent on US H-1B visa hike, but opens doors to global talent

Beijing, Sept 22: China on Monday declined to comment on US President Donald Trump's move to impose a hefty USD one lakh fee for H-1B visas, but at the same time invited global professionals to work in the country as it prepares to roll out a new employment visa next month.

On Friday last week, the Trump administration announced a USD 1,00,000 fee on H-1B visas. The fee is a one-time fee on submission of a new H-1B petition.

"China will not comment on the US visa policy," Chinese Foreign Ministry spokesperson Guo Jiakun told a media briefing here when asked about Trump's decision.

However, at the same time, he said in the era of globalisation, cross-border talents promote technological and economic progress globally, and Beijing welcomes global professional talent to explore opportunities in the country.

China welcomes "talents from various industries and areas across the world to come and stay in China, jointly contribute to the progress of the human society and achieve success in their careers", Guo said.

Indians account for nearly 71 per cent (over 2.8 lakh) of all H-1B visas, followed by Chinese professionals with around 11.7 per cent or over 46,600. China's K-Visa to take effect

While the US tightens its visa regime, China last month announced a new work permit called K-Visa under which qualified professionals from across the world can come to the country and explore work opportunities.

The K-Visa, set to take effect from Oct 1, is aimed at attracting young science and technology talent and does not require a domestic



employer or entity to issue an

According to the state-run Xinhua news agency, the new visa category was approved by the State Council and signed into law by Premier Li Qiang last month as part of amendments to the country's entry and exit regulations.

China's silence on the H-1B issue comes against the backdrop of trade negotiations with the US, where student and work visas are also under discussion. Trump and Chinese President Xi Jinping last week spoke over the phone, during which they reportedly agreed to the US takeover of the popular Chinese app TikTok.

The US and Chinese trade negotiators concluded their fourth round of talks in Spain last week to reach a trade deal on tariffs.

As per the decision, China will add the K-Visa category to its existing 12 ordinary visa types, available to eligible science and technology professionals.

Compared to the existing visa types, K visas will offer more convenience to holders in terms of the number of permitted entries, validity period, and duration of stay.

K-Visa holders can also engage in education and cultural exchanges, science and technology activities, and entrepreneurship and business.

## Prannoy, Ayush to spearhead Indian challenge at Korea Open

New Delhi, Sept 22: Still searching for consistency this season, HS Prannoy will headline India's challenge alongside rising star Ayush Shetty at the USD 475,000 Korea Open Super 500 badminton tournament beginning in Suwon, Korea on Tuesday.

With two successive finals at the H Kong and China Masters, Satwiksairaj Rankireddy and Chirag Shetty have revived India's season but will skip this week's event, leaving the focus on Prannoy and Ayush to carry the tricolour. Prannoy, a 2023 World Championships bronze medallist, has endured a string of early exits this season but has stretched top opponents, with most matches going

Wins over China's Lu Guang Zu and



narrow defeats to Lakshya Sen and Anders Antonsen underline his ability to still push the best in the business.

Kiran George also features in the men's singles draw and faces a stiff opener against Singapore's fifth seed Loh Kean Yew.



Abhishek went on to score a scintillating 74 off 39 balls, his first fifty in the tournament while Gill shrugged off disappointment of an underwhelming league stage with a facile 47 off 28 balls. "It's like a fire-and-ice combination. They complement each other really well. And that's what I want to see. If someone is batting brilliantly, the other can take the back-seat and rotate the strike. It was required today to have a very good start. And they did (provide that)." Survakumar told mediapersons after India's six-wicket win in the Super 4 game here on Sunday.

Having played together



since Punjab U-12 days, they know each other's game well and switch gears and swap roles long before the opposition can figure what is unfolding.

If one looks at their scoring pattern, Abhishek prefers the aerial route while Gill bisects the fielders on both sides with a surgeon's precision.

If Abhishek prefers heavy hitting, Gill's go-to method is silken grace.

Against spin, Gill looked a million dollars but he could take the tab of Abhishek's dinner bill as his friend bowled an extensive spell of left-arm spin to him prior to


