Union Home Minister Amit Shah on Wednesday said that during his 11-year tenure the Prime Minister has fulfilled the dream of transforming Indian youth from job seekers to job providers.

Addressing the inaugural session of the Startup Conclave 2025 here the Union Home Minister, according to the news agency-Kashmir News Observer (KNO) said, "Before

2014. Indian youth had to leave the country to innovate, conduct research, or implement their ideas in the startup sector. In 2000, there was no concept of startups, systems, or ecosystems in India.

He said, "By 2014, there were fewer than 500 startups, and dreaming of startups was only feasible for children from affluent backgrounds." He emphasized that over the past ten years, PM Modi launched Startup India in 2016, and today, India has become the fastestgrowing country in building a

world-class startup ecosystem. Shah said that through Startup India, PM Modi has fulfilled the dream of transforming Indian youth from job seekers to job creators.

### India must move from 'Make in India' to 'Think in India', says Army Chief

'Op Sindoor demonstrated value of self-reliant defence tech'

New Delhi, Sept 23: Stating that India must move from "Make in India" to "Think in India," Chief of the Army Staff General Upendra Dwivedi on Tuesday said that 'Operation Sindoor' demonstrated the positive impact of self-reliant technology, and the need of the hour is to remain ahead of evolving threats.

Addressing the inaugural session of the Tri Services Academia Technology Symposium (T-SATS) at the Manekshaw Centre, the Army Chief, according to the news agency-Kashmir News Observer (KNO) said, "We have to encourage domestic ideation, innovation, and system development by industry, think tanks, and academia.

He compared technological adaptation in warfare to a game of chess, saying that failing to think ahead would lead to setbacks.

He said, "While indigenous scalability has been shown, further investment in niche



technology and enterpriseimplementation is scale required.

He said India's proposed air defence system, Sudarshan Chakra, would integrate multiple protective layers, starting with counter-drone systems and extending to counter-UAV and counterhypersonic systems. "Some elements cannot not be discussed publicly for security reasons but I assure you that it's one of the best systems in the world," he added.

The Army Chief said the system would combine sensors, missiles, surveillance apparatus, and artificial

intelligence tools to provide both defence and offensive capabilities.

According to him, the concept was in the ideation phase but would be comprehensive in scope. He cautioned that adversaries were also improving their capabilities, pointing to the drones encountered during Operation Sindoor, which had shown advanced features including the use of artificial intelligence and visual navigation even after GPS jamming.

### J&K floods: 150 lives lost, 178 injured, 33 missing

Over 13,000 houses damaged across UT

758 school buildings declared unsafe in Jammu

Srinagar, Sept 23: Flash floods and cloudbursts that struck Jammu and Kashmir in August and September claimed 150 lives, left 33 persons missing, and caused property damage worth crores.

According to the figures available with the news agency— Kashmir News Observer (KNO) Kishtwar District recorded the highest number of casualties where 33 persons are still missing. "A total of 150 people lost their lives while 178 persons

were injured" data reveals, adding, "Over 13600 houses were damaged fully, severely or partially across the region during the recent natural calamities."

According to the figures 864 houses were damaged in Kashmir of which 16 were fully damaged, 57 severely and 791 partially. An official told the KNO that

the relief has already been disbursed in all these cases. On agricultural losses, more than 12,500 hectares of land got affected and nearly 315 hect-

ares were hit in Horticulture sector, primarily in Anantnag, Kulgam and Pulwama districts with estimated losses of about Rs 59 lakh. In Jammu

## SC dismisses petition seeking age-relaxation in jobs for displaced KPs

Srinagar, Sept 23: The Supreme Court on Tuesday dismissed a petition seeking age-relaxation benefits in Central Government recruitment for displaced Kashmiri Pandits.

As per the news agency— Kashmir News Observer (KNO), the plea, filed by Panun Kashmir Trust under Article 32 of the Constitution, asked for parity in age-relaxation for Group C and D posts, similar to what has been extended to victims of the 1984 anti-Sikh riots and the 2002 Guiarat riots

A bench of Justice Vikram Nath and Justice Sandeep

Mehta heard the matter and dismissed the petition at the initial stage. The Court observed that decisions regarding age-relaxation and related benefits fall within the domain of policy-making and are not to be determined through constitutional writ jurisdiction.

At the beginning of the hearing, Justice Nath asked whether such an issue could be adjudicated under Article 32 and questioned if it was appropriate for the judiciary to intervene in a policy matter of this kind.



### UN chief warns world leaders of 'age of relentless human suffering'

Says global peace under siege, calls for cooperation

United Nations, Sept 23: With global peace and progress under siege, the United Nations chief challenged world leaders Tuesday to choose a future where the rule of law triumphs over raw power and where nations come together rather than scramble for

self-interests. Secretary-General Antonio Guterres said the UN's founders faced the same questions 80 years ago, but he told today's world leaders at the opening

of their annual gathering at the General Assembly that the choice of peace or war, law or lawlessness, cooperation or conflict, is "more urgent, more intertwined, more unforgiving."

"We have entered in an age of reckless disruption and relentless human suffering," he said in his annual "state of the World" speech. "The pillars of peace and progress are buckling under the weight of impunity, inequality and indifference."

But despite all the internal and external challenges facing the UN, he and General



pleaded with its

Assembly President Annalena members not to give up. "If we stop doing the right things, evil

will prevail," Baerbock said in

her opening remarks. Guterres said the leaders' first obligation is to choose peace, and without naming any countries, he urged all parties -including those in the Assembly chamber – to stop supporting Sudan's warring parties.

He also didn't name Israel but used his strongest words against its actions in Gaza, saying the scale of death and destruction are the worst in his nearly nine years as secretary-general, and that "nothing can justify the collective punishment of the

Palestinian people."

While Guterres has repeatedly said only a court can determine whether Israel has committed genocide in Gaza, he referred to the case South Africa brought to the UN's highest court under the genocide convention by name – and stressed its legally binding provisional measures, first and foremost to protect Palestinian civilians.

Since the International Court of Justice issued that ruling in January 2024, Guterres said, killings have intensified, and famine has been declared

in parts of Gaza. He said the court's measures "must be implemented fully and immediately.'

The UN also is facing financial cuts as the US and some other nations pulled back funding or have yet to pay their dues. Guterres said aid cuts are "wreaking havoc," calling them "a death sentence for many."

US President Donald Trump, in one of the gathering's most closely watched speeches, said he felt the UN has "tremendous potential" | More on P6

Srinagar, Sep 23: Polycystic Ovary Syndrome (PCOS), one of the most common hormonal disorders among women of reproductive age, is becoming a growing health concern in Kashmir and across the

Doctors warn that the lack of awareness and delayed treatment often worsen the condition, leading to infertility, diabetes, and heart problems later in life.

Dr Shazia, a Gynaecologist at GMC 1 Srinagar explained that PCOS occurs when women's ovaries produce higher-than-normal amounts of male hormones (androgens). "This hormonal imbalance interferes with the regular release of eggs during the menstrual cycle. As a result, multiple small cysts can form in the



Dr Rukhsana Akhter, a gynaecologist posted in south Kashmir, said PCOS does not have a single cause but is linked to several factors. She said that excess androgen production disrupts ovulation, high insulin levels increase androgen production, leading to irregular cycles and weight gain.

"Women with a family history of PCOS are more prone to the disorder, and sedentary lifestyle, poor diet, and stress are major contributors," she added.

Gynaecologists warn that untreated PCOS has both short-term and long-term consequences. "Initially, patients complain of irregular periods, excessive hair growth, acne, or weight gain. But over time, PCOS can lead to infertility, type-2 diabetes, high blood pressure, endometrial cancer, and serious mental health issues like

depression," Dr Rukhsana added

She said that while PCOS cannot be completely cured, its effects can be managed effectively. Lifestyle modification is the first line of treatment. "Weight control through regular exercise and a balanced diet is crucial," Dr Rukhsana added.

Doctors said that women experiencing irregular cycles or excessive hair growth should seek medical advice early. They added that depending on symptoms, doctors may prescribe hormonal therapy, insulin-sensitising agents, or fertility treatment.

According to doctors, counselling helps patients deal with stress and anxiety linked to PCOS. They urged women not to ignore symptoms, adding, "We see a rising trend of PCOS among young girls, even teenagers. Timely consultation and lifestyle changes can prevent lifelong complications."—(KNO)

### Omar-led Govt will fight for people's rights: Dy CM

Talking to reporters here, the Deputy CM said the government will never succumb to the pressure. "Some people want the government to resign, but we won't do that. Choudhary said that all the promises made by the National Conference (NC) leadership will be fulfilled in the fiveyear tenure. "We have been



given five years to fulfil our promises. Only ten months have elapsed so far, and we will fulfil all our promises," he said.

The Dy CM further added that the government has been facing hurdles due to the limited powers in the Union Territory. "The government doesn't have a free hand under the dual governance system. Let the statehood be restored, we will show what the government is capable of doing," he said while replying to the statements of the Leader of Opposition (LoP) Sunil Sharma.

He stated that the government has been working diligently to advocate for the rights of its people.

The Deputy CM said the issue regarding the restoration of statehood and special

status was also discussed in the cabinet meeting today. "Leave statehood aside, the LG has not finalised the business rules," he added.

Choudhary blamed the opposition parties, including BJP and PDP, for neglecting the development during their tenure. He said they must answer why the issues regarding the traffic jams have not been resolved during their rule.

The Deputy Chief Minister, after reviewing the ongoing road-widening project (Boulevard Road at Nehru Park), said that the project would be inaugurated on October 17, which will improve the traffic flow and enhance the tourist experience once the project is completed.

The government is committed to finishing the work within the set deadline, he added—(KNO)

### Fallen apples rot in orchards

Pulwama, Sep 23: In Kashmir's apple heartland, orfallen fruit this year, but instead of offering relief to struggling farmers, the "Giran" apples have turned into a fresh source of worry.

Locally known as "Giran", these are apples that fall prematurely from trees before harvest. Growers said that due to unusual weather and heavy fruit fall this season, nearly 30–40 per cent of the crop is "Giran". Yet, unlike past years, there are no takers for the produce.

Traditionally, small makeshift roadside mandis would spring up across Pulwama, Shopian, and other apple belts where "Giran" apples found ready buyers for juice factories and low-grade processing.

closures of the Srinagar-Jammu National Highway simply stopped coming, have disrupted supplies so explained a trader at Jabli were forced to shut down.

"Earlier, Giran apples at least helped us recover some costs. Even if sold at Rs 100–150 per crate, it was a relief compared to nothing," said Nazir Ahmad, a grower from Pulwama. "But this year, after highway issues, traders closed their mandis. The fruit we had procured rotted in front of us because it could not be transported outside. Now, no one wants to buy it."

The situation has left hundreds of youth, who earned seasonal income by trading in "Giran", without work. "The Giran business relies on quick movement. If the fruit doesn't reach outside mandis within

> For many farmers, "Giran" apples once acted as a lifeline-bringing in modest earnings that supported their expenses on pesticides, labour, and packaging. Now, growers say they are forced to watch helplessly as the fruit rots in their orchards.

> 'This is not just about a low-grade apple; it is about livelihoods," said Abdul Hameed, another grower from Shopian. "Thousands of families, from pickers to packers to transporters, are tied to this trade. If the government doesn't take immediate steps, this part of our economy will collapse completely."

### Law will take its course: Ashok Koul



## Seeds Of The Future: Clean Plant Programme Gaining Momentum

### Transforming Indian horticulture with disease-free planting material

There are growing challenges posed by climate change, as well as biotic and abiotic threats to plant health. These challenges directly translate into agricultural losses, reducing farmers' income and overall productivity. India has invested significantly in boosting farm productivity, yet systemic pathogens (primarily viruses) continue to pose a major threat, causing significant yield losses. These pathogens reduce crop quantity, quality and longevity. By the time symptoms appear, it is often impossible for farmers to manage diseases in the field. Starting with disease-free planting materials has therefore been recognized as the most effective strategy to combat these challenges.

To address this, the importance of preventive measures such as ensuring high standards in seed quality and implementing clean plant programmes- have been widely recognised. Such measures not only safeguard plant health but also come with the added advantage of being free from adverse side effects. Accordingly, on 9th August 2024, the Union Cabinet approved the Clean Plant Programme (CPP) proposed by the Ministry of Agriculture and Farmers Welfare.

Overview: The Imperative for Clean Planting Material

The Clean Plant Programme (CPP) was launched as a major initiative to provide farmers with access to high-quality, virus-free planting material. The National Horticulture Board (NHB) serves as an implementing and executing agency in association with Indian Council of Agricultural Research (ICAR), which oversees technical progress and facilitates capacity building. The initiative involves a significant investment of Rs 1,765.67 crore, which also includes an Asian Development Bank approved loan of \$98 million in December 2023.

What is CPP? India's Clean Plant Program (CPP), conceptualized by the Ministry of Agriculture & Farmers Welfare in collaboration with the Asian Development Bank, is a novel initiative aimed at ensuring healthy, disease-free planting material of key fruit crops. The program seeks to enhance farmers' productivity and profitability, ultimately boosting India's global competitiveness.

The initiative has started to take its shape with the following planned developments:

9 Clean Plant Centres are to be established across the country to ensure disease-free, productive planting material. Of these, 3 will be set up in Maharashtra at a cost of Rs 300 crore—Pune (grapes), Nagpur (oranges), and Solapur (pomegranates).

Modern nurseries are to be developed, with financial support of Rs 3 crore for large nurseries and Rs 1.5 crore for medium ones. These nurseries will provide 8 crore disease-free seedlings to farmers every year.

International cooperation is to be undertaken with countries such as Israel and the Netherlands for implementation of the programme.

A national-level laboratory is to be set up in Pune for research on original plant species

On-Ground Actions and Progress

The following showcase the key onground activities undertaken as part of CPP: CPP Website Launch: The official CPP website has been launched as a central hub for resources, updates, and insights to revo-

lutionize horticulture in India. The link to

Clean Plant Centers.
Grapevine: ICAR-IARI (New Delhi) and ICAR-NRC for Grapes (Pune) surveyed key grape-growing regions (Maharashtra, Karnataka, Telangana, Andhra Pradesh, Tamil Nadu, Jammu & Kashmir, Mizoram). A total of 578 samples were tested, completing

hazard analysis for grapevine.

Apple: 535 samples collected from Jammu and Kashmir, Himachal Pradesh, Uttarakhand, and Punjab are under testing, with hazard analysis in progress.

Citrus: Preparations have begun for hazard analysis, paving the way for healthier, virus-free citrus cultivation.

Clean Plant Center: India's first Clean Plant Center is in progress, with the bidding process for its design currently underway. Nursery Visits:

October 23–24, 2024: National Horticulture Board (NHB) and Asian Development Bank (ADB) officers visited grape, pomegranate, and guava nurseries in Nashik and Ahmednagar (Maharashtra) to study nursery ecosystems, design, operations, and cost structures.

November 18–22, 2024: The same team visited nurseries in Jammu & Kashmir to evaluate apple and temperate crop cultivation practices in cooler climates.

Lab Assessments: A step towards strengthening of diagnostic and computational capabilities

Between January 16–20, 2025, scientists and officials from ICAR, NHB, and ADB visited public and private laboratories across India. These visits evaluated laboratory capabilities for developing a bioinformatics pipeline for HTS data analysis under CPP. This will help scientists more quickly and efficiently check for virus in many types of crops and better test nursery plants to keep them safe and healthy.

From Source to Soil: Producing Clean Planting Material

The following diagram illustrates the step-by-step process of acquiring, testing, and propagating clean planting material under the CPP:

If the acquired plant material tests negative for pathogens, it undergoes re-testing and is then used to produce and maintain disease-free mother plants. These plants provide clean planting material that is distributed through accredited nurseries to farmers. If the material tests positive, virus elimination is carried out using therapies such as tissue culture, heat, or cryo-therapy, followed by plant propagation to ensure disease-free planting stock

Alignment with other initiatives

CPP is set to boost India's horticultural sector while aligning with Mission LiFE and the One Health initiatives to promote sustainable and eco-friendly agricultural practices. Moreover, through plant health management, CPP helps farmers adapt to climate change, as rising temperatures not only trigger extreme weather events but also influence pest and disease behaviour.

Mission LiFE (Lifestyle for Environment)
An India-led global mass movement to
nudge individual and community action
to protect and preserve the environment.
Introduced by PM Narendra Modi at COP26
in Glasgow on 1st November 2021, it draws
from India's rich cultural heritage, which

National One Health Mission

Events like the COVID-19 pandemic, Lumpy Skin Disease in cattle, and Avian Influenza highlight the need to look beyond human health and include livestock, wildlife, and the environment. The Prime Minister's Science, Technology, and Innovation Advisory Council (PM-STIAC), in its 21st meeting, approved setting up the National One Health

Policy Alignment: CPP and MIDH

The Clean Plant Programme complements the Mission for Integrated Development of Horticulture (MIDH)- a centrally sponsored scheme, launched in 2014–15 for holistic growth of horticulture sector.

Quality planting material and micro-irrigation are among the key components under MIDH in boosting productivity of horticulture crops from 12.10 MT/ha in 2019–20 to 12.56 MT/ha in 2024–25 (2nd advance estimates).

Conclusion

The Clean Plant Programme is progressing, with actions already in motion and planned developments set to accelerate its reach and impact. Looking ahead, CPP is set to advance further with concrete on-ground actions including wider consultations with nurseries for certification; development of training programmes for relevant authorities, preparation of a hazard analysis protocol for diagnostic protocols for mango, guava, litchi, avocado and dragon fruit; and the release of matching-grant and cost-norm guidelines for nurseries. CPP is no longer a vision - it is emerging as a transformative step to strengthen India's horticulture, empower farmers, and help the sector truly bloom.

### How Living In A Digital World Changes Kids' Brains

### Neuroimaging data confirms what frustrated parents and teachers have long suspected

recently wrote about how children and adolescents who spend more time in digital environments than they do having real-world experiences (see "Getting Our Kids' Brains Back on Track"). One of the more disturbing aspects of this trend is how neurotypical brains that are not exposed to critical experiences can produce the same symptoms we see in neurodivergent brains.

Studies have shown that neural connections are different in the brains of children with attention disorders—and that early functional changes (meaning those in brain networks, not visible in brain structures) may be precursors to the white matter changes that are plainly visible later on. In any brain, functional differences can become permanent if no one intervenes to change

the environment and behaviors.

We can literally see the results in the intricate frontal lobe connections that appear on advanced neuroimaging scans. Kids who spend time in three-dimensional environments have rich connections between their frontal lobes and other parts of their brains. Kids who spend hours consuming digital content don't. That difference has nothing to do with a diagnosis of ADHD or other



cognitive disorder—the phenomenon exists independent of a diagnosis.

The Effect Starts Early
MRI scans show changes in the gray matter of children as young as 3 to 5 years of age
who consume lots of digital content. The
changes are notable in brain areas responsible for language development, reading,
empathy, and other higher-order cognitive

skills. Over time, as these children continue

to truncate the time spent in real experience, we can expect to see the effects become even more pronounced.

One objective measure can be found in the working memory section of the Wechsler Adult Intelligence Scale (WAIS). Neuropsychologists use WAIS to evaluate many areas of cognitive ability; one section evaluates working memory, which is critical in the processes of decision-making,

reasoning, and behavior. WAIS has been revised several times over the years, and with each edition, we can see the scores that are considered normal for different age groups, extrapolated from thousands of people who took the test.

The WAIS-R was released in 1981; at that time, the working memory raw score (number of correct responses) considered normal for teens ages 18-19 was 14. When WAIS-5 was released in 2024, the normalized raw score for that age group was 12.

A drop of two points over 40 years may not seem worrisome, but it's a telling change—especially when you consider how much technology has intruded into teen lives in the second half of that period. What I see in patients today suggests that the decline is hastening, and the next normed score will show another drop, potentially even larger.

Intervening Earlier Is Better
We cannot wait until a child reaches adulthood and enters an advanced working world
where executive functions are expected to
be top of mind. We could better prepare our
youth for adulthood if we integrated multifaceted executive function into classroom
settings throughout education. (I wrote
about how we might do that in my previous
post.)

Teachers and parents have observed the

changes in children over the past decade; the data now confirms what we all can see. The good news is that, armed with this information, we can reverse the trend and get our kids' brains back on track for developing the skills they need to succeed.

### JMC Commissioner inspects 27 MLD STP at Bhagwati Nagar

JAMMU, SEPTEMBER 23: To ensure timely delivery of urban infrastructure and foster the sewage management system in the city, Commissioner Jammu Municipal Corporation (JMC) Dr. Devansh Yadav Tuesday visited the 27 MLD Capacity Sewage Treatment Plant (STP) developed on Activated Sludge Process (ASP) technology at Bhagwati Nagar, Jammu. The Project, constructed by NBCC (India) Limited in 2016 to improve sewage treatment capacity, has started partial functioning since last month.

During the inspection, the Commissioner took a detailed review of the functioning of the plant and enquired about the status of facilities created under the project. While appreciating the progress made so far, Dr. Yadav noted that certain crucial works are still pending which are necessary to make the plant



fully operational and beneficial for the public. Directing the NBCC officials

to complete all pending works within 15 days, particularly making the in-house laboratory functional and activating the gaseous chlorine system for effective disinfection, Dr. Yadav also stressed the importance of securing operational consent from the Jammu and Kashmir Pollution Control Committee (JKPCC), which is a statutory requirement to ensure compliance with environmental standards.

The Commissioner highlighted that once these steps are completed, the plant will be formally handed over to the Department of Housing and Urban Development, Government of Jammu & Kashmir. This will pave the way for its full-scale operation and provide much-needed sewage treatment facilities to

stake-holders.

"Completion and commissioning of this plant is a critical step towards ensuring cleaner water bodies, reducing environmental hazards and improving public health in Jammu," Dr. Yadav said while interacting with officials.

The Commissioner further emphasized that the IMC is committed to providing modern urban infrastructure for better sanitation and environmental protection. He urged upon the executing agency to adhere to the timeline and assured full cooperation from the Corporation for expediting clearances and facilitating inter-departmental coordination.

Among others, senior officers of JMC, engineers from the executing agency, and representatives of the Housing and Urban Development Department accompanied the commissioner during the visit.

Hindi Films dominate main categories, regional films recognized

President highlights women-centric films and indian cinema's growth

Awards celebrate film diversity, promote 'Make in **India'** initiative

Delhi, Sept 23: President Droupadi Murmu on Tuesday presented the National Awards for acting to Shah Rukh Khan, Vikrant Massey and Rani Mukerji while Malayalam superstar Mohanlal was honoured with the Dadasaheb Phalke lifetime achievement award at a ceremony that doffed its hat to mainstream popular cinema.

Filmmakers Vidhu Vinod Chopra, who took home the best film prize for '12th Fail', and Karan Johar and Apoorva Mehra, who received the award for 'Rocky Aur Rani Kii Prem Kahaani' for best popular film providing wholesome entertainment, completed the starry ensemble at the 71st National Film Awards.

The best director award went to Sudipto Sen for 'The Kerala Story'.

The National Awards for 023 were announced in August. It's the first National Award for friends and frequent collaborators Shah Rukh and Rani as well as for Vikrant. While Shah Rukh got it for his role in 'Jawan', sharing his win with '12th Fail' star Vikrant, Rani bagged it for 'Mrs Chatterjee vs Norway'.

There were whistles and loud cheers as Rani and Shah Rukh went up to receive their awards at the traditionally sober ceremony. Mohanlal, recognised for a remarkable career spanning five decades and more than 360 films, got a standing ovation from the crowd gathered at the city's



'I got to know that when Mohanlal's name was an-nounced for Dadasaheb Phalke, there was a wave of happiness among people. It shows that he has made a space for himself in countless people's hearts," the President said in her address after the award ceremony.

"He has presented the softest of the soft and toughest of the tough emotions quite naturally," Murmu added in a speech in which she congratulated all the winners and touched on various issues, including the plurarity of Indian cinema, Indian sensibility and

women-centric films.
"Now we see women in many places in cinema like actors and producers. I have seen films about mothers, women uniting against societal wrongs, and strong women who raise their voices. I salute these filmmakers on behalf of sisters and

daughters. Please thank your crews for your success, they are behind it,' she said.

Just like Indian literature is created in various Indian languages, the President said Indian cinema is advancing in so many languages, dialects, regions and local environments.

Information Broadcasting Minister Ashwini Vaishnaw spoke of the Make in India initiative of the government.

"Equipment used in the film industry such as big cameras... should be made in India. We will be starting a programme on this soon," he said. The minister also stressed on the need to create a live concert economy with proper policy support, uniform guidelines and easy permissions.

As the recipient of the prestigious Dadasaheb Phalke Award, Mohanlal was the only awardee who spoke.

He said he was deeply humbled to be the youngest recipient, and "only the second ever" from the state to be bestowed with this national recognition.

"This moment is not mine alone. It belongs to the entire Malayalam cinema fraternity. I see this award as a collective tribute to our industry, legacy, creativity and resilience," added the 65-yearold movie legend known for landmark films such as 'Vanaprastham',

'Pulimurugan' and 'Drishyam'. Hindi cinema dominated the awards in the main categories.

Among those presented awards were Meghna Gulzar and Ronnie Screwvala for the biopic on Field Marshal Sam Manekshaw, 'Sam Bahadur', the best film promoting national, social and environmental values.

the best choreography award for 'Rocky Aur Rani Kii Prem song 'Dhindhora baaje'. Shilpa Rao was named best female playback singer for 'Jawan' track 'Chaleya'. Sanya Malhotra-starrer

Regional movies were recognised in categories such best supporting actor and actress and in technical segments.

The best supporting actor trophy was shared by Vijayaraghavan for Malayalam film 'Pookalam' and Muthupettai Somu Bhaskar for Tamil film 'Parking'.

The best supporting actress honour went to Urvashi for the Malayalam movie 'Ullozhokku' and Bodiwala for Gujarati title 'Vash'. Both movies won best films in their respective lan-

He said that in 2015, India's ranking in the Global Innovation Index was 91st, and today it has reached 38th. The Home Minister expressed confidence that within the next three years, India will rank among the top ten countries in the Global Innovation Index and, in the coming years, will lead global innovation.

NEW EDUCATION POLICY OPENED

TREASURE TROVE FOR INDIA'S YOUTH

Shah said that Prime Minister Modi, through the New Education Policy, has created a vertical for research and study on the Indian Knowledge System, opening this treasure trove for India's youth. By leveraging this knowledge, young Indians can conduct world-class

The Union Home Minister said that in the 11 years of the PM Modi led government, significant transformations have been witnessed in the country, with efforts made in every sector to expand the startup ecosystem.

The credit for this expansion goes to the ecosystem created by Prime Minister Modi, as well as to students and youth. He highlighted that the number of startups has grown from 500 in 2014 to 1.92 lakh today, a 380-fold increase. Similarly, the number of unicorn startups has risen from just 4 in 2014 to over 120 today, with a total valuation exceeding \$350 billion. Shri Shah emphasized that this demonstrates how. by leveraging the ecosystem created by Prime Minister Modi, talent can be harnessed to create unicorn startups. He urged industry stakeholders to collaborate with startups to expand in every dimension.

STARTUP ECOSYSTEM HAS PROVIDED SUSTAINABLE EMPLOYMENT TO 17.9 LAKH

Amit Shah said that India currently has 21,000 startups in the IT sector and 17,000 in healthcare. Moreover, there are 11,000 startups each in agriculture, the service sector, and education. He added that startups have expanded their reach to 770 districts in India, showcasing the strength of India's startup ecosystem. Furthermore, 48% of startups are founded by women, and 900 startups in the Northeast are led by women. Shah stated that the startup ecosystem has provided sustainable employment to 17.9 lakh people so far.

Union Home Minister and Minister of Cooperation said that since 2014, Prime Minister Narendra Modi has created a supporting environment for startups and provided financial, policy, infrastructure, banking, and industry support for their growth. He said that a Fund of Funds of Rs 10,000 crore has been established, a Startup India Seed Fund with a corpus of Rs 945 crore has been launched, the maximum loan limit has been increased from Rs 10 crore to Rs 20 crore, support of up to Rs 20 lakh has been approved for Proof of Concept, and funding of up to Rs 50 lakh has been approved for prototype development. He further said that Prime Minister Modi launched Make in India, introduced PLI schemes in 14 key sectors, removed over 40,000 compliances, and removed more than 3400 laws from the category of criminal laws.

APART FROM PM MODI NO ONE ELSE COULD HAVE SIMPLIFIED. REFORMED GST

Amit Shah said that apart from Prime Minister Narendra Modi, no one else could have simplified and reformed GST. After a long time, the country has seen a leader like Prime Minister Modi in whom both taxpayers and the public can place their trust.

He noted that Prime Minister Modi, with great courage and by taking all states along, successfully implemented GST. GST collections began at Rs 80,000 crore and

today have crossed over Rs 2 lakh crore. Shah added that under GST reforms, Prime Minister Modi reduced the prices of

many items by half, by one-third, and even to zero in some cases. Through GST reforms, Prime Minister Modi has shown the public that the government's purpose is to raise revenue to run the country, not to exploit the people.

Union Home Minister and Minister of Cooperation said that since India's independence, the public is witnessing such a massive tax reduction for the first time. He stated that GST reform is a bridge of trust between taxpay-

Shah recalled that when the Modi government came to power, income up to Rs 2.5 lakh was tax-exempt, but today income up to Rs 12 lakh is taxed at zero.

These two examples, he said, demonstrate that the government levies taxes not for exploitation, but for the people, for the country's development, and for self-reliance. Shri Shah said that his move will serve as a bridge of trust between taxpayers and the Government of India for decades to come.

The petition claimed that displaced Kashmiri Hindus, who were forced to leave their homes during the unrest in the valley during the late 1980s and early 1990s, continue to face disadvantage in accessing government jobs due to the lack of special consideration in recruitment

The petition also raised the issue of what it called "hostile discrimination" against Kashmiri Pandits, stating that while other riot-affected communities have been granted concessions, similar treatment has not been extended to this group.

It argued that the victims of the Kashmir violence fall within the same class as those affected by other communal disturbances for whom age-relaxation policies have been framed.

The Supreme Court, however, did not accept this line of reasoning, stating that it was not the proper forum to seek such relief. The bench made it clear that such requests involve executive decisions that are within the scope of government policy and must be taken up with the appropriate authorities. (KNO)

New Delhi, Sept 23: Air India group on Tuesday said it will commence com-mercial flights from the upcoming Navi Mumbai International Airport with its low-cost arm, Air India Express, operating 20 daily departures to over 15 cities in the first phase of operations.

This will be scaled up to 55 daily departures, including five international, by mid-2026, Air India said in a statement.

Jointly owned by Adani Group and Maharashtra's town development authority CIDCO, Navi Mumbai International Airport (NMIA) is set for inauguration later this month.

"We look forward to commencing operations at Navi Mumbai International Airport. We are happy to work with Adani Airports to build NMIA not only as a point that connects to the rest of India, but also as one of the country's key global transit hubs for both

aging Director, Air India. In the initial phase of the new airport's operations, Air India Express will operate 20 daily departures or 40 Air Traffic Movements (ATMs) to and from the new airport, connecting 15 Indi-

By winter 2026, the Air India group aims to further expand its operations to 60

daily departures (120 ATMs) from the facility, seamlessly connecting passengers to key domestic and international destinations.

Air India Express' planned operations at Navi Mumbai International Airport will significantly enhance connectivity to and from the Mumbai Metropolitan Region (MMR) to destinations within and outside India, while facilitating seamless international transit through the new airport, it said.

"This partnership will redefine Mumbai's connectivity landscape and strengthen India's twin-airport strategy. NMIA's adoption of technology for enhancing efficiency and best-in-class experience for passengers will play a pivotal role in delivering seamless and superior passenger journeys for decades to come," said Arun Bansal, Chief Executive Officer, Adani Airport Holdings Ltd.

The greenfield airport in Navi Mumbai International is being built in five phases, with the launch phase expected to accommodate 20 million passengers per annum (MPPA) and handle 0.5 million metric tons (MMT) of cargo.

Upon full completion, NMIA will have the capacity to serve 90 MPPA and handle 3.2 MMT of cargo

### US authorities seize illicit electronics in New York area during UNGA

New York, Sept 23: The US Secret Service said on Tuesday it had dismantled a network of sophisticated electronic devices in the New York area that had been used to threaten US government officials as foreign leaders gather this week for the UN General Assembly.

The agency said the devices were oncentrated within 35 miles (56 km) of the global meeting of the 193-member assembly, where US President Donald Trump was due to deliver a speech on Tuesday.

"Early analysis indicates cellular communications between nation-state threat actors and individuals that are known to federal law enforcement," the Secret Service said in a statement. Authorities seized more than 300 SIM servers and 100,000 SIM cards across multiple sites in an operation the agency said represented an imminent threat to its protective operations. The hardware was used to "conduct multiple telecommunications-related threats directed toward senior US government officials," the Secret Service said.

It said the devices discovered could be used to conduct a range of telecommunications attacks including "disabling cell phone towers, enabling denial of services attacks and facilitating anonymous, encrypted communication between potential threat actors and criminal enterprises.'

The tri-state area where the network was located includes New York, Connecticut and New Jersey.

### Armed forces to test capabilities of drones, counter-drone systems during exercise in Oct

New Delhi, Sept 23: The armed forces will test the capabilities of some of its drones and counter-drone systems during an exercise by the Headquarters Integrated Defence Staff (HQ IDS) in the first week of October, a senior offi-

cial said on Tuesday.

The exercise will be held somewhere in Madhya Pradesh from October 6-10, sources said.

In his address at a conference on air defence systems here, Air Marshal Rakesh Sinha, Deputy Chief of Integrated Defence Staff (OPS) at HQ IDS, also spoke of the lessons drawn from Operation Sindoor and the need to "stay ahead" of the adversary in military thinking and planning.

The conference hosted in Delhi was themed on 'Counter UAVs & Air Defence Systems: The Future of Modern Warfare' and saw participation of senior military officers, representatives of various firms in the defence industry and domain experts

A senior official of the HQ IDS said the exercise is named 'Cold Start'.

Later, interacting with PTI on the sidelines of the event, Air Marshal Sinha said the exercise will be held in the Central Sector and will see participation of all three services.

Besides, industry partners, research and development partners, academia and others will be taking



part in the upcoming exercise.

'We will be testing some of our drones and counter-drone systems during this exercise... with an aim to have an air defence system and Counter-UAS that is more robust," Air Marshal Sinha said.

Counter-UAS refers to Counter-Unmanned Aerial Systems.

### **India emerges as** top destination for global corporate: Report

New Delhi, Sept 23: India is emerging as the leading market of interest for companies looking to realign their trade and manufacturing activities, a report said on Tuesday.

India is the leading market of interest, where almost half of the respondents are looking to ramp up or maintain trade activities with the world's fastest-growing major economy, while two in five intend to ramp up or continue manufacturing activities, Standard Chartered said in a report.

In particular, more than 60 per cent of corporates from the US, the UK, Mainland China and Hong Kong are looking to increase trade with India, the report titled 'Future of Trade: Resilience' said.

The report presents inputs from 1,200 C-suite and senior leaders at multinational corporations based in 17 key markets across four industries, on their views for global trade and their strategies over the next three to five years.

While trade tariffs are top of mind, emerging technologies and global economic growth are equally critical factors, with 53 those as the top strategic drivers shaping the future of global trade, it said.

Corporate leaders believe that Asia will continue to drive trade growth in the next three to five years, with rising prominence from the Middle East and the US remaining as a heavyweight, it said.

The report also revealed corridors that will see increased trade and manufacturing activities, it said.


### Lancet study outlines trends in HMPV outbreak early this year, children most affected

New Delhi, Sept 23: A study that looked into trends of the respiratory infection HMPV that broke out in India early this year has found that children were the most affected, with highest diagnoses among those aged 1-2. Published in The Lancet

Regional Health Southeast Asia journal, the study also found most HMPV-positive cases presented with symptoms similar to those of acute respiratory illness or influenza, with fever and cough being the most common. However, researchers

from Indian Council of Medical Research (ICMR) institutes and the Directorate of Public Health and Preventive Medicine, Government of Tamil Nadu, noted no "recent change in the epidemiological features of HMPV"

The outbreak in India was linked to seasonal one in China triggered in late 2024, attracting significant attention due to an increase in



cases and potential impact. Studies estimate the

Human Metapneumovirus (HMPV) was responsible for over six per cent of respiratory illnesses and five per cent of hospitalisations in China. Cases started to emerge in India during second week of January in states, including Gujarat and Puducherry.

The researchers stressed that strengthening surveillance continues to be critical to understand emerging disease-causing viruses and guiding public

health policies. Data collected during 2019-2023 and in 2024-2025 under the Model for Integrated Influenza Surveillance in Tamil Nadu was analysed.

Diagnostic tests were conducted by labs forming the Virus Research and Diagnostic Laboratory Network, established in 2014 under the Department of Health Research, Ministry of Health and Family Welfare.

Between 2019-2023, over 20,000 were tested for HMPV, of whom 1,030 (3.2 per cent) were positive, and more than 11,100 in 2024, of whom 367 (3.3 per cent) were positive. The authors said, "Majority of tests were conducted among children." "The highest positivi-

ty was observed in those aged 1-2, with 4.5 per cent (128/2864) testing positive in 2019-2023 and 4.6 per cent (70/1508) in 2024," they

Further, "fever and cough were the most common symptoms, reported in 70.3 per cent of cases from 2019 to 2023 and 79.6 per cent (292/8398) in 2024, and in 60.5 per cent (401/12,059) and 60.8 per cent (223/5977) of cases, respectively," the team said.

Duration of sickness was found to typically last for 11 days, with a typical hospital stay of seven days.

The researchers said that the higher testing and positives seen in 2024 highlight that HMPV is being increasingly recognised as a significant respiratory pathogen in India.

"Strengthening surveillance networks remains critical to understanding the burden of such emerging viral pathogens and guiding public health policies," they said.
