CM announces 5-marla land to flood-hit homeless families

Billawar (Kathua), Sept 25: Chief Minister Omar Abdullah on Thursday announced that the government has decided to provide five marlas of land each to all flood-affected families who have been rendered homeless and have suffered both on account of their houses destroyed and left without land due to landslides and flashfloods which has taken away their everything so that they are able to construct their dwelling units on the allotted land.

The Chief Minister made this announcement while interacting with residents of Duggain, Billawar, whose houses and livelihoods were severely impacted by the recent flooding. Earlier, he conducted an aerial survey of the flood-affected areas in the district, accompanied by MLA Bani, Dr. Rameshwar

directed the administration to ensure timely relief and rehabilitation measures. "The year 2025 has brought immense devastation to Jammu and Kashmir-from the dry spell in March-April to incessant rains, flash floods, and landslides in August-September," he said. "From Kathua to Kupwara, the damage has been unprecedented."

The Chief Minister highlighted the scale of destruction, noting that torrential rains have damaged over 350 bridges, around 2,000 km of road network, thousands of hectares of agricultural land, besides washing away standing crops

government and private buildings. "Given the enormity of restoration challenges, Jammu and Kashmir is looking forward to a comprehensive relief and rehabilitation package from the Central Government," he added.

Centre scraps foreign funding license of Wangchuk's NGO

'Accepted donation for study on country's sovereignty'

Sept 25: The Ministry of Home Affairs on Thursday cancelled the foreign funding license of the Students Educational and Cultural Movement of Ladakh (SECMOL), a Non-Governmental Organisation owned by activist Sonam Wangchuk.

The action comes 24 hours after violent protests in the Leh city over statehood and 6th Schedule demand led by Sonam Wangchuk. According to an MHA order, a copy of which lies with news agency-Kashmir News Observer (KNO), SECMOL was granted registration under FCRA to accept foreign contributions for cultural and edu-

cational programs. It stated that the ministry had issued a Show Cause Notice (SCN) on August 20 this year through speed post followed by mail on September 9 to show cause as to why the NGO's FCRA registration should not be cancelled.

CS reviews budget utilization

Stresses on capital expenditure, revenue realization



SRINAGAR, SEPTEMBER 25: Chief Secretary, Atal Dulloo Thursday chaired a high-level meeting to review the performance of departments with regard to utilization of the annual budget and revenue realization in J&K. The meeting was attended by Principal Secretary, Finance Department, Santosh D. Vaidya; Administrative Secretaries of all departments; Director General, Resources; Director General, Accounts & Treasuries; Director General, Budget, besides other senior

During the review, the Chief Secretary took a detailed appraisal of the proportion of revenue and capital expenditure made by each department till date. He emphasized the need for departments to enhance capital expenditure while rationalizing and curtailing avoidable revenue expenditure in order to strengthen the fiscal health of the UT.

The Chief Secretary underscored that capital expenditure not only supports infrastructure creation but also contributes directly to long-term economic growth and livelihood opportunities.

He urged departments to maintain strict adherence to timelines for Centrally Sponsored Schemes (CSS), noting that these schemes are designed to build durable assets and improve public services. He particularly stressed the smooth implementation of flagship programmes such as Samagra Shiksha Abhiyan, PMGSY, NAB-ARD and other key initiatives.

With regard to the newly rolled out SASCI initiative, the Chief Secretary directed departments to expedite the process of Administrative Approval and Technical Sanction for all new works. He further advised that at least 75% of each ongoing work under this scheme should be completed by December this year, while also calling for the expeditious clearance of the remaining 100 mother sanctions to enable timely execution of projects envisaged under Gol's SASCI initiative giving 50-year interest-free loans for completion of capital expenditure projects in a specific timeframe.

He also reviewed the performance of departments in mobilizing tax and non-tax revenues. He directed the Power Development Department (PDD) to improve billing efficiency and asked the State Taxes Department to plug leakages in GST collection. He stressed on leveraging technology to detect tax evasion and take stringent measures against defaulters to ensure full realization of revenues.

In his presentation, Principal Secretary, Finance, Santosh D. Vaidya, provided a detailed account of the expenditure status. He informed that out of the Budget Estimates (BE) of Rs 79,703 Cr in Revenue Expenditure, an amount of Rs 52,085 Cr has been released, with Rs 33,247 Cr spent till date. On the capital side, against a BE of Rs 18,451 Cr, Rs 7,435 Cr has been released to departments, while the expenditure booked so far stands at Rs757 Cr.

Rana calls on Union Jal Shakti Minister C.R. Patil

Seeks central assistance in post-flood restoration in J&K

NEW DELHI, SEPTEMBER 25: Jal Shakti Minister, Javed Ahmed Rana Thursday called on Union Minister for Jal Shakti, Chan-drakant Raghunath Patil, in New Delhi to apprise him of critical issues currently confronting Jammu and Kashmir.

Javed Rana informed the Union Minister about the extensive damage to water supply and irrigation infrastructure caused by recent flash floods in the J&K and the urgent need for sustained financial support to complete ongoing schemes under the Jal Jeevan Mission (JJM).

During the meeting, Javed Rana conveyed the gravity of the situation following the unprecedented flash floods that hit various parts of Jammu & Kashmir during August and September 2025. He informed the Minister that the floods severely disrupted public life, damaged essential infrastructure, and caused large-scale destruction to the water supply, irrigation and flood protection systems.

The Minister highlighted that the damage has deeply impacted access to safe drinking water and irrigation across both Jammu and Kashmir divisions, creating immediate challenges for public health, agriculture and the overall well-being of rural communities.

The Jal Shakti Minister informed the Union Minister that the J&K Jal Shakti Department has taken swift emergency measures to restore basic services in the affected areas.

laved Rana requested a special financial package from the Ministry of Jal Shakti to support full-scale restoration and to invest in long-term resilience-building measures. He emphasized that such support is not only critical for restoring normalcy but also for building infrastructure that can better withstand the growing impacts of climate change and extreme



weather events in the region. In addition to the flood-related concerns, the Minister also raised the issue of the critical funding gap under the Jal Jeevan Mission, which aims to provide safe drinking water to every rural household in Jammu & Kashmir. He informed that while a large number of schemes have made substantial progress, including many nearing completion, the shortfall in Central assistance and delay in fund releases have posed serious constraints on meeting the ambitious timeline of full saturation by March 2025.

The Minister pointed out that despite the J&K's consistent progress and efficient implementation of JJM schemes, including the successful completion of a significant number of projects.

Rana underscored the need for immediate release of additional funds to meet outstanding payments and to maintain the pace of execution. He urged the Union

Minister to personally intervene and facilitate the timely release of central funds and sanction of additional financial support, so that the JJM implementation in J&K does not suffer avoidable delays. Expressing his appreciation for the support received, Javed Rana thanked C.R. Patil for his patient hearing, assurances and positive response to the issues raised.

He reiterated the Jammu & Kashmir Government's firm commitment, under the leadership of Chief Minister, Omar Abdullah, to the goal of "Har Ghar Jal" and to building robust, climate-resilient water infrastructure that ensures the right to safe drinking water for every citizen.

The Union Minister assured Javed Rana of full cooperation from the Government of India and acknowledged the need for urgent and sustained intervention to support the people of Jammu & Kashmir in this time of crisis.

Srinagar, Sep 25: Demand for Kashmiri apples has drasticalplum-meted ly this season, with rates dipping to less than half of what growers earned last year, leaving thou-sands of orchardists across the valley in distress.

Bashir Ahmad Basheer. president of the Kashmir Valley Fruit Growers Cum Dealers Union, said the industry is facing one of its toughest phases in recent history.

"Rates are very low this year - less than even 50 per cent of what we earned last season," Basheer said. "The prima-ry reason is the backlog of produce that remained strand-ed on highways, mandis, orchards, and other storage fa-cilities. This backlog will take nearly a month to clear, and only after that, we

Growers from different districts expressed deep concern over the unprecedented slump. They said that an apple box, which fetched over Rs 1,000 last year, is being sold for barely Rs 400 this season.

"How can we survive when the cost of production itself is higher than the selling price?" asked Abdul Rashid, a grower

disastrous season. It feels like we are work-ing day and night only to incur losses. Many growers are worried about repaying debts taken for orchard manage-ment," he said.

The growers fear that if immediate steps are not taken by the government to stabilise the market, the valley's horti-culture sector — which provides livelihood to lakhs of families - could face

"This is not just about farmers," Basheer added. "If apple growers suffer, the entire rural economy of Kashmir suf-fers with them. We urge the authorities to intervene be-fore it is too late.'

Situation in Ladakh serious matter: Dr Farooq

Says Delhi must pursue dialogue

Srinagar, Sep 25: National Conference (NC) President Dr Farooq Abdullah on Thursday expressed serious concern over the current situation in Ladakh, saying the Centre must stop the use of force and instead pursue a dialogue

to resolve pressing issues.

Addressing a press
conference at the party headquarters here, Dr Abdullah said the people of Ladakh, led by activist Sonam Wangchuk, have been peacefully protesting for the past 15 days, demanding statehood and inclusion under the Sixth Schedule. He said Wangchuk had even walked on foot from Leh to Delhi to draw attention to their demands, but the authorities have failed to address their concerns

adequately. "Initially, the protests were non-violent. The youth of Ladakh believed in the promises made to them. However, when these promises proved hollow, frustration grew, and they resorted to street protests, Dr Farooq said, adding that some incidents during the protests included the



burning of BJP offices, police vehicles, and attempts to set

public offices on fire. The NC chief warned of broader implications, given Ladakh's strategic border location and the Chinese occupation in the region. "Unrest in such sensitive areas is dangerous for our nation. Efforts must be made to resolve these issues through dialogue and prevent further escalation," he urged. When asked about allegations that external forces influenced the protests, the former J&K Chief Minister dismissed such claims. "I do not believe any external group is behind this. These are genuine voices of the local people. They will not wait indefinitely. The government must

remember the promises

made regarding elections,

delimitation, and statehood

for Ladakh," he said. He added that nearly 11 months have passed since promises related to Jammu and Kashmir's statehood were made, yet no progress has been seen. "The people of Ladakh feel betrayed. They were promised jobs and development, but nothing has materialised. Instead, a colony has been established there, which led the youth to take extreme steps to press for their rights," he added.

On BJP's accusations blaming Congress for the violence, the NC leader said, BJP has always blamed others for its failures. They are responsible for the current situation. They are the ruling party in Ladakh, yet they cannot even gather ten people for a rally. This is the

voice of the people. Instead of blaming others, they should focus on resolving

Regarding the Ministry of Home Affairs' statement, Dr Abdullah clarified that Sonam Wangchuk has never shunned Gandhian principles. "It is the youth who have chosen this path; Wangchuk has no role in the violence. The CBI inquiry and the use of force will not resolve anything. I urge New Delhi to stop the use of force and adopt a dialogue-based approach," he appealed.

The NC president fur-ther added on the situation in Ladakh: "The leaders in Delhi are responsible for what has happened in Ladakh. They have been talking without concrete action, and the youth have felt let down after waiting for five years. Delhi must act faster to resolve the issue.'

Dr Farooq said Ladakh is a sensitive area. "Everyone knows how much land China occupies there. We cannot even carry out patrolling in our own territories. It's time to accept reality. If the situation continues, someone else will step in to fill the gap," he

Mehbooba expresses concern over prevailing situation

Srinagar, Sep 25: Former Jammu and Kashmir chief minister and Peoples Democratic Party (PDP) President, Mehbooba Mufti Thursday expressed concern over the prevailing situation in Ladakh, saying the protests reflected growing uneasiness among people about their land, jobs, and cultural identity.

Speaking to reporters in Srinagar, the PDP president said Ladakh, which had historically remained peaceful, was witnessing agitation for the first time after the revocation of Article 370 in 2019.

Mehbooba Mufti said incidents of violence in recent days should serve ment and demography are extremely sensitive. The Centre must act through concrete steps, not words, to reassure the local population," she said—(KNO)

BJP accuses NC Govt of failing on poll promises

Srinagar, Sep 25: The Bharatiya Janata Party (BJP) on Thursday accused the Omar Abdullah-led government of failing to fulfill its election promises and shifting the blame to the Lieutenant Governor's administration.

Senior BJP leader and former minister Sham Lal Sharma said that the National Conference (NC) government is misleading the people instead of delivering on its pledges. Sharma said the domain of the LG administration is lim-ited to transfers of police and civil services officers, while all other administrative and financial powers rest with the elected government. "Tell me where the government is being stopped. They are not fulfilling the promises they made. The Reorganization Act came into force post 2019, and NC knew the LG's domain when it contested elec-tions. Why this drama now? Where is the government be-ing stopped in allocation of funds or in administrative matters? The only restriction is on transfer of DCs and SSPs," Sharma said.

He said the NC had promised major reforms within 90 to 100 days of taking office, but none of the commitments had been implemented even after a year. "The Chief Min-ister listed 12 points in the first press conference after the elections. Not a single one is visible on the ground. The government is transferring its responsibility instead of owning it. Daily life of the people has not improved,

it has become worse," Sharma said.

On the situation in Ladakh, Sharma said that people of Ladakh had long demanded Union Territory status and welcomed the 2019 reorganization. "Now, some political parties are twisting the issue for their own politics. Ladakhis never wanted to remain with Kashmir, they consistently demanded Union Territory," he added.

Sharma also hit out at regional parties like NC and PDP, accusing them of doing issue-based politics without any long-term vision. He said leaders in Kashmir were trying to occupy the political space left vacant after the decline of separatist groups. "This destruction has happened be-cause of politics for the sake of politics. Parties here have never pursued visionary politics, only shortterm gains," he said. On the issue of job reservations and regularization of dai-ly wagers in Jammu and Kashmir, Sharma said the gov-ernment had given commitments on the floor of the as-sembly but failed to deliver. "Committees were constitut-ed, statements were made in the House, and assurances were recorded. Failure to implement these is a breach of privilege. The government is already cornered on these issues, losing credibility every day," he said.

He added that the BJP will play the role of a constructive opposition in the upcoming assembly session. "We will hold the government accountable for its failures. The NC is trying to turn non-issues into issues to hide its inaction. The fact is, the LG is not stopping them from working. They are stopping themselves by not fulfilling their com-mitments," Sharma said-(KNO)

Committee on environment draws a line on environmental damage

Srinagar, Sep 25: The Committee on Environment on Thursday directed all concerned departments to submit detailed action-taken reports within 15 days on measures to curb environmental violations across the Union Territory.

The committee, which convened a high-level review meeting at Dak Bungalow Baramulla emphasised a zero-tolerance approach to environmental degradation, while acknowledging the need to protect the livelihoods of communities dependent on natural resources.

"We will not allow anyone to loot our environment," said committee member and Uri MLA Sajad Shafi, who stressed that laws protecting forests, rivers and other natural assets will be enforced without leniency. "At the same time, we will consider the perspective of those whose survival depends on these resources," he added.

The meeting discussed critical concerns such as illegal mining, unlicensed stone crushers and the desilting of the Jhelum River, directing the Wildlife, Forest, Pollution Control Board, and Urban Local Bodies to implement immediate corrective measures.

Committee members

clarified that while legally operating companies will face no obstruction, any illegal activity that threatens the environment will be met with firm action. "The committee will not compromise on safeguarding the environment or in addressing public grievances arising from illegal practices," he said.

Responding to queries about royalty charges on stone quarries and loose material, MLA Sajad Shafi clarified that extraction of loose material will be allowed only in areas where it is not prohibited, but the fixed quota in metric tons must be strictly adhered to and not exceeded.

He stressed that the committee is pursuing a dual policy aimed at striking a balance between environmental protection and livelihood needs.

"We do not want to create any ecological imbalance. Our approach is clear, no compromise on the environment, but no unnecessary hardship to those earning an honest living," Shafi said.

The panel also instructed department heads to ensure ground-level action and timely compliance. Legislators present used the forum to flag gaps in enforcement and urged for stricter monitoring to protect fragile ecosystems-(KNO)

Friday Brief | The Culture Of Ostentation: A Quranic Warning Against Spiritual Emptiness

n an age dominated by social media flaunting, lavish weddings, and competi-Ltive consumerism, Islam's teachings on humility and moderation offer a powerful antidote to the rising tide of ostentation. The Quran and Hadith repeatedly caution believers against showing off, whether in worship, wealth, or lifestyle, as it corrupts intention, fosters inequality, and distances the heart from Allah. The Quran explicitly condemns extravagance and pride, describing wasteful spenders as the "brothers of Satan" (17:27). In Surah Al-Hadid, Allah warns, "Know that the life of this world is but amusement and diversion and adornment and boasting among you and competition in increase of wealth and children..." (57:20). This verse lays bare the fleeting nature of worldly displays, reminding believers that true value lies in piety, not possessions. Similarly, the concept of "riya" (showing off) is condemned as hidden shirk - a violation of Tawheed because it seeks praise from people rather than pleasure from Allah. The Prophet

Muhammad (SAW) embodied simplicity and warned against vanity. He said, "Allah does not look at your appearance or wealth, but He looks at your hearts and actions" (Sahih Muslim). The Prophet (SAW's) life, marked by modest clothing, humble meals, and unpretentious living, stands in stark contrast to today's culture of excess. He cautioned that those who wear garments of fame and pride will be humiliated in the Hereafter, and advised Muslims to live in such a way that if they die today, they leave behind

little worldly baggage. Islam does not forbid wealth but regulates its expression. Zakat and Sadagah institutionalise sharing, while moderation (wasatiyyah) balances enjoyment with responsibility. Displaying blessings as gratitude is permitted, but with the intent to boast or belittle others is haram. The Prophet (SAW) said, "Eat, drink, give charity, and wear clothes without extravagance or pride" (Sunan An-Nasa'i). In today's context, this means rethinking how we celebrate weddings, use social media, or engage in consumer culture. It calls for redirecting resources toward charity, community welfare, and spiritual growth rather than wasteful competition. True honour in Islam lies in taqwa (God-consciousness), not in luxury cars, designer labels, or Instagram followers. Let us remember that every show of arrogance is a step away from Allah's mercy. By embracing humility, we not only purify our faith but also contribute to a more just and compassionate society, where worth is measured by character, not currency.

Sapno Ka Ghar: Realizing The Dream Of Housing For All In Rural India

Housing is universally recognized as a fundamental human requirement, and addressing rural housing shortages, particularly for the poor, is a vital part of the Government's poverty alleviation strategy.

For Smt. Kakrati Debbarma, a poor tribal woman from South Dhumacherra village of Manu RD Block, Tripura, life was a constant struggle as she and her family lived in a fragile mud-walled house with a weak roof. The home offered little safety or security, leaving the family vulnerable to harsh weather and natural disasters throughout the year, making every day an ordeal.

Everything changed when a house was sanctioned in her name under the Pradhan Mantri Awaas Yojana-Gramin (PMAY-G) scheme during the 2019-20 financial year. With assistance from the Block Administration, she received Rs. 1,30,000/in three installments transferred directly to her bank account. With guidance and support, Kakrati was able to build her own pucca house.

Today, the new home has transformed the family's life. They are now protected from storms and rains, living in comfort and peace. Kakrati expresses her joy, saying the house brings not just safety, but also happiness and dignity to her family.

The Pradhan Mantri Awaas Yojana-Gramin (PMAY-G) launched on 1st April 2016, aims to provide "Housing for All" in rural areas. The scheme helps eligible rural families for the construction of pucca houses with basic facilities like a kitchen, toilet.

The scheme provides financial assistance to eligible rural households, including houseless families and those living in zero, one, or two-room kutcha houses, to construct pucca homes with basic amenities. The beneficiaries also gain access to piped drinking water, LPG, renewable energy, and building materials through conwith other government programs.

PMAY-G has significantly improved rural housing by reducing poverty, enhancing living standards, and promoting social and economic development, reflecting steady progress in strengthening rural housing infrastructure.

Key Features of PMAY-G

Minimum unit size: Each house must have at least 25 sq. m, including a dedicated hygienic cooking area.

Quality construction: Beneficiaries use local materials and trained masons to build durable houses

Design flexibility: A wide selection of house designs-structurally sound, aesthetically pleasing, and culturally & environmentally appropriate-is offered, moving beyond standard cement-concrete models. Scheme Targets and Achievements


Under the Pradhan Mantri Awaas Yojana-Gramin (PMAY-G), the Government initially set a target of 2.95 crore houses for FY 2016–17 to FY 2023–24.

Recognizing the continued rural housing demand, the Union Cabinet has approved the continuation of the scheme for another five years (FY 2024-25 to FY 2028-29) with an additional target of 2 crore houses, bringing the cumulative target to 4.95 crore houses.

As of 4th August 2025, a total target of 4.12 crore has been allocated by the Ministry to states and Union Territories (UTs), out of which 3.85 crore houses have been sanctioned and more than 2.82 crore houses have been completed.

The flagship housing programme continues to demonstrate strong implementation and rising coverage across financial years. For FY 2025-26, as of July 2025, a total of 32.9 lakh houses were targeted under the scheme, of which 25.6 lakh have already been sanctioned. In the previous year, FY 2024–25, the house allocation target was 84.37 lakh, of which 64.70 lakh houses got sanctioned. Over the four-year period from FY 2020-21 to FY 2024-25, a cumulative total of 216.73 lakh houses were sanctioned. out of which 176.47 lakh houses have been completed, reflecting steady progress in housing development.

Beneficiary Selection, Financial Assistance



and Funding Convergence Support Who is Eligible?

One of the most important features of PMAY-G is the robust and transparent selection of beneficiaries.

SECC 2011 Data: The identification of beneficiaries under PMAY-G is carried out on the basis of housing deprivation parameters and exclusion criteria prescribed under the Socio-Economic Caste Census (SECC) 2011. Priority is given to houseless households and those living in dwellings with 0, 1, or 2 kutcha walls and a kutcha roof.

Gram Sabha Verification: The lists genrated from SECC data are verified by the respective Gram Sabhas, followed by an appellate process to ensure fairness.

Awaas+ Surveys: To include eligible families who might have been left out of the SECC 2011 list, an "Awaas+" survey was conducted from January 2018 to March 2019. A new survey using the Awaas+ 2024 mobile app is being conducted for the scheme's next phase (2024-29) with modified exclusion criteria and technology like e-KYC face authentication.

Prioritization: The scheme prioritizes landless beneficiaries and mandates that a minimum of 60% of targets are earmarked for SC/ST households at National level. In view of the provisions of the Rights of the Persons with Disabilities Act 2016, the States to the extent possible may ensure that 5% of beneficiaries at the State Level are from among Persons with Disabilities

Financial Assistance and Funding The scheme provides direct financial support for house construction:

Unit Assistance: Rs 1.20 lakh in plain areas and Rs 1.30 lakh in hilly states (including North Eastern states, J&K, Ladakh, Himachal Pradesh, and Uttarakhand).

Funding Pattern: The cost is shared between the Central and State governments. The ratio is 60:40 for plain areas and 90:10 for North Eastern and Himalayan states. For Union Territories without a legislature, the Centre provides 100% of the funding.

More Than Just a House: Convergence with Other Schemes

PMAY-G integrates with other government schemes to provide comprehensive

amenities, ensuring a better quality of life. Employment under MGNREGS: PMAY-G combine housing provision with large-scale livelihood opportunities. It not only builds houses but also offers jobs. Under Pradhan Mantri Awaas Yojana-Gramin (PMAY-G), it is mandatory to provide 90/95 person-days of unskilled wage employment at current rates (approximately Rs 27,000) to each beneficiary for the construction of their house, through convergence with MGNREGS. The construction of a single house generates about 201 person-days of employment (skilled, semi-skilled, and unskilled). During the last nine years (2016-25), the construction of 2.82 crore houses under PMAY-G has generated approximately 568 crore persondays of employment.

Under the Rural Mason Training programme of PMAY-G, 2.97 lakh candidates have been trained as on August 2025, with some certified masons even securing opportunities to work abroad in the construction sector. In addition, the scheme has generated significant indirect employment through the production of building materials and their transportation for house construction.

Toilets under SBM-G: The beneficiaries receive Rs 12,000 for toilet construction through convergence with Swachh Bharat Mission-Cramin (SRM-C) or MCNRFCS ensuring hetter sanitation facilities in rural homes.

Basic Amenities: The scheme facilitates connections for piped drinking water, electricity, and LPG gas connections, often

through other government programs. Digital & Technological Innovations -

Ensuring Transparency and Quality A robust monitoring framework is in place to ensure transparency, quality, and timely completion.

Digital Monitoring

The entire process is managed through e-governance solutions like the AwaasSoft Management Information System (MIS) and the AwaasApp mobile application.

Management Information AwaasSoft System (MIS) AwaasSoft is the web-based MIS that serves

as the backbone for the PMAY-G scheme.

It provides functionalities for data entry and monitoring of multiple statistics related to implementation aspects of the scheme. These statistics include physical progress (registrations, sanctions, house completion and release of instalments etc.), financial progress, status of convergence etc.

AwaasSoft is the primary platform where all data related to beneficiaries, progress of house construction, fund releases, inspection reports, and photographs are stored.

High-level reports on physical and financial progress are made publicly available on the PMAY-G website (www.pmayg.nic.in) through the AwaasSoft portal, allowing for public transparency. AwaasSoft is integrated with the Public

Financial Management System (PFMS) to create the AwaasSoft-PFMS platform. This enables the payment of financial assistance directly into the bank or post office accounts of beneficiaries through an Aadhaar Based Payment System (ABPS). To improve user experience and acces-

sibility, new modules have been added to the software since its launch in 2016. For making it more accessible and maintain transparency in the implementation of the programme, some of the modules are:

Landless Module: This module helps map landless beneficiaries in the Permanent Wait List (PWL) and captures the status of land provided to them, whether through financial assistance or physical allocation. In the current phase of PMAY-G (2024–29), the Ministry is closely monitoring the provision of land to all landless beneficiaries. As per data entered by various State Governments on AwaasSoft a total of 2,68,480 landless beneficiaries has been sanctioned houses under PMAY-G so far.

E-Ticketing System: This feature was introduced to address technical and non-technical grievances referred by States and UTs.

Online Job Card Module: An online module is available on AwaasSoft for the entry of MGNREGS job card numbers, which are mandatory for beneficiaries to receive wage employment benefits for house construction.

Awaas+ 2024 App The Awaas+ 2024 App has been developed to strengthen the implementation of the Pradhan Mantri Awaas Yojana-Gramin (PMAY-G) by ensuring efficiency, transparency, and accountability. This app has the following features: -

100% Aadhaar-Based Payments

The Aadhaar Based Payment System under PMAY-G enables Direct (ABPS) Benefit Transfer (DBT) directly into the beneficiary's bank account linked with their Aadhaar number, ensuring safe, transparent, and authentic transactions.

Technology-Driven Accountability The new phase of the scheme uses advanced technology, including AI/ML models to curb fraud, face authentication,

e-KYC, and liveliness detection to verify beneficiaries. **Physical Inspections and Audits**

Regular inspections are carried out by officials at all levels-national, state, district, and block. Additionally, a Social Audit is required in every Gram Panchayat at least once a year.

Grievance Redressal

A multi-level grievance redressal mechanism is available, including the Centralized Public Grievance Redress and Monitoring System (CPGRAMS) portal and District-level Appellate Committees.

CS directs enforcement of GST rate reductions to benefit consumers

Sept 25: Chief Atal Dulloo on Srinagar, Secretary Thursday chaired a high-level meeting with concerned Administrative Secretaries to review the implementation of recent Goods and Services Tax (GST) reforms and ensure that the benefits of reduced tax rates directly reach consumers on the ground.

Those who ed this meeting includes Secretary, Finance; Principal Secretary, Commissioner FCS&CA; Director, FCS&CA, Controller, Kashmir/Jammu; Legal Metrology besides other concerned officers.

During the meeting, the Chief Secretary stressed the need for strict enforcement to prevent unjustified pricing and directed the Legal Metrology Department (LMD) to constitute special market-checking



teams. These teams will monitor retail and wholesale markets to ensure that commodity prices are reduced in proportion to the GST rate cuts recently announced by the Central Government.

The Commissioner Secretary, FCS&CA, Saurabh Bhagat informed the meeting that several companies have already initiated revisions in their product pricing in line with the new tax regime. Notably, 169 companies have revised their rates and submitted intimation to the Legal Metrology Department.

The Chief Secretary further emphasized that the reforms, effective from September 22, 2025, must yield visible relief for the common consumers in the coming days. The Legal Metrology Department will intensify inspections to verify compliance and take strict action against any violations.

He maintained that the objective of these reforms is consumer welfare. It is imperative that the reduction in GST rates translates into lower market prices so that people feel the real benefit, he underlined.

Indian team back from US after holding trade talks

New Delhi, Sept 25: The Indian team has returned from the US after holding trade talks with their American counterparts in New York, an official said on Thursday.

Commerce and Industry Minister Piyush Goyal, who led the team, will be back on Friday. The team had arrived in New York on Monday to hold talks over the proposed trade agreement between the two countries. The talks are taking place at various levels, encompassing both trade and nontrade issues.

Goyal was accompanied by senior officials from the ministry, including Special Secretary and India's chief negotiator, Rajesh Agrawal.

"The Indian official team is back from the US," the official said.

Goyal has held discussions with his US counterpart.

This visit comes against the backdrop of recently concluded day-long discussions in New Delhi between US Chief Negotiator Brendan Lynch and Agrawal on the proposed bilateral trade agreement.

On September 16, the commerce ministry stated that the day-long discussions with the visiting US team on a bilateral trade deal were positive, and both sides agreed to push for an early and mutually beneficial conclusion of the agreement.

The visit of high-ranking US trade officials came after the imposition of a 25 per cent tariff and an additional 25 per cent penalty on Indian goods entering the American market for purchasing Russian crude

The visit also assumed significance amid the US administration's sudden decision to hike the application fee for H-1B visas to USD 1.00.000.

He demanded allotment of five marlas of land for such affected families, besides highlighting other pressing concerns, including damages to the Jalana Bridge, delay in tendering of work for High School Lohai, upgradation of High School Sadrota, as well as amnesty from KCC loans and electricity bills for affected families.

The Chief Minister assured that the government would examine all these demands with due seriousness and extend all possible support to the affected families.

Omar says no NC

Abdullah, former minister Sajad Kichloo and the party treasurer Shammi Oberoi are the frontrunners for the party.

They indicate that chances of nomination of Choudhary Muhammad Ramzan, Aga Syed Mehmood and Ajay Sadhotra are very bleak.

Meanwhile president of the Jammu & Kashmir unit of the Congress, Tariq Hamid Karra today said that the party's high command will make the final decision regarding its strategy for the upcoming Rajya Sabha elections.

Speaking to the news agency–KNO, Karra said, "The matter will be discussed with the party leadership, and they will examine all aspects before taking a final call."

In the Rajya Sabha polls, the NC-Congress alliance is poised to comfortably win three out of the four seats. It is widely believed that the Congress, which has six MLAs in J&K, could seek one of the three "safe" seats.

Sources disclosed that the party may field Ghulam Ahmad Mir, MLA from Dooru, who has already been playing a role at the national

Mir, who was appointed as the party's general secretary in charge of Jharkhand in December 2023, is currently serving as general secretary in charge of West Bengal. Under his leadership, the party performed well in both the assembly and Lok Sabha elections in Jharkhand, winning 16 and two seats respectively.

The party may also consider fielding a senior leader from the Jammu mainland, which was once its stronghold but failed to secure even a single assembly or Lok Sabha seat since 2014.

If nobody had extended credit to these conglomerates, India would not have had so many ndustrial houses, Shah added.

It can be noted that as per the official statistics, the MSME growth in FY25 slowed down to 14.1 per cent from over 20 per cent in the previous fiscal. Analysts have of late expressed concerns about the credit quality in the MSME lending segment.

Talking about the global economy, Shah said India has emerged as a bright spot. "While the world is going through difficulties, with polarisation of societies and people losing faith in leadership, India is offering stability, trustworthy leadership and a robust economy," he

He also highlighted India's consistent economic performance. "Many countries are struggling at a one to two per cent growth rate, while India has maintained a steady seven to eight per cent growth. This is a huge achievement," Shah said.

Highlighting investor confidence, Shah added, "We have consistently maintained a 14 per cent increase in foreign direct investment. This reflects global faith in India's economy.

Speaking about structural reforms, the minister said, "Through the PLI scheme, industrial corridors, logistics parks and Start-up India, we have created a new ecosystem. A decade ago we had only 26 start-ups, and today we have 1.92 lakh. In the last ten years, India has moved from 26th to 3rd position globally in this sector."

Shah pointed to future areas of growth "Electric vehicles, battery technology, green growth, fintech, space and defence manufacturing will all strengthen India's growth story in the coming years," he said.

He recalled the state of banks before 2014. "Between 2008 and 2014, loans worth Rs 52 lakh crore were given, many of which turned into bad loans. There is a huge demand for different types of food in India, making it a preferred destination for investors, he noted. The scale at which India is working is "un-

precedented", which has helped lift 25 crore people out of poverty and become part of the neo-middle class, Modi pointed out. The neo-middle class is the country's most

energetic and aspirational class, which is going to set food trends in the coming years, he added. On GST reforms, Modi said the food process-

ing sector has also benefited, with most food

items falling under the zero or 5 per cent slab. The Prime Minister also mentioned that the government has reduced the GST from 18 per cent to 5 per cent on biodegradable packaging to promote environmentally friendly

"The demand now is for biodegradable packaging. It is necessary to ensure the food products remain safe and fresh, but at the same time, there is a responsibility towards nature. Therefore, the government has reduced GST,"

Modi also directed the industry to invest in biodegradable packaging innovations and shift towards it at the earliest.

Modi emphasised that the nation currently possesses strong willpower for reforms, backed by democratic and political stability, along with policy predictability.

Earlier this month, India effected next-generation reforms

Modi said the structural reforms in Goods and Services Tax (GST) are set to give new wings to country's growth story.

Addressing the gathering after inaugurating the Uttar Pradesh International Trade Show 2025 here, Modi said his government has significantly reduced taxes, curbed inflation, and increased both income and savings for the people.

He said that by making income up to Rs 12 lakh tax-free and implementing new GST reforms, citizens are set to save Rs 2.5 lakh crore this year alone.

The Prime Minister said the government introduced reforms in the indirect tax regime by implementing GST in 2017, a significant step towards strengthening the economy, followed by further reforms in September of this year.

"Today, the country is proudly celebrating 'GST Bachat Utsav'. I



going to stop here. In 2017, we brought GST... and then again (brought reforms) in 2025. We will further strengthen the economy. As the economy continues to grow, the tax burden will continue to decrease. With the blessings of the citizens, the reforms in GST will continue,"

The Prime Minister also accused opposition parties of spreading falsehoods to cover up their own governance failures, asserting that during the Congress regime, excessive taxation burdened ordinary citizens.

'The poor, new middle class, and middle class have all benefited with higher savings (due to IT benefits and GST reforms). Despite challenges, he said, India is laying a strong foundation for the coming decades. He reiterated that the nation's

Defence ministry inks Rs 62,370 cr deal with HAL to procure 97 Tejas jets for IAF



New Delhi, Sept 25: The defence ministry on Thursday sealed a Rs 62,370 crore deal with the Hindustan Aeronautics Ltd (HAL) to procure 97 Tejas light combat aircraft for the Indian Air

The signing of the contract came over a month after the Cabinet Committee on Security (CCS) headed by Prime Minister Narendra Modi green-lighted the mega procurement.

It is the second such contract awarded to the state-run aerospace behemoth. In February 2021, the defence ministry sealed a Rs 48,000 crore deal with HAL for procurement of 83 Tejas MK-1A jets for the IAF.

A contract was signed with the HAL for 97 Tejas Light Combat Aircraft- Mk1A

with associated equipment for the IAF at a cost of Rs 62.370 crore (excluding taxes), the ministry said.

The advanced jet will feature Swayam Raksha Kavach and control actuators, with over 64 per cent indigenous content and 67 new indigenous items, it said.

The deliveries will start in 2027-28, it said.

The single-engine Mk-1A will be a replacement for the IAF's MiG-21 fighters.

The IAF is looking at inducting the warplanes as the number of its fighter squadrons have gone down to 31 from officially sanctioned strength of 42.

Tejas is a multi-role fighter aircraft capable of operating in high-threat air environments.It has been designed to undertake air defence, maritime reconnaissance

How drinking the right amount of water can lower risk of stroke & heart disease, according to studies

New Delhi, Sept 25: Chronic illnesses like stroke and cardiovascular disease continue to rank among the leading causes of death worldwide. Medical advancements have brought in better treatment, researchers are turning their attention to more simpler, everyday habits that could potentially play a powerful role in prevention.

Recent scientific studies are shedding light on a common drink that may do more than just quench thirst, it appears to support blood pressure, protect heart tissue and even lower the most life-threatening vascular conditions, and it is none other

than. Water! Two studies are landmarks in understanding this relationship. One is an extended view of how hydration might influence cardiovascular death. The other looks at short-term blood pressure and cardiac function variability following water consumption. Together, they offer an optimistic but still developing picture of how hydration might

benefit the heart and brain. What long-term research

A recent systematic review and dose-response meta-analysis examined the long-term effects of total water and drinking water intake on mortality from all causes and cardiovascular disease (CVD). The study combined data from



seven prospective cohort studies, covering over 116,000 participants followed for up to 19 years. Individuals who consumed more total water had a lower risk of death from cardiovascular disease.

Each additional cup of total water per day was linked to a: 3% lower risk of death from CVD

2% lower risk of death from any While simply drinking more

water may not directly reduce the overall risk of death, higher total water intake appears to play a protective role against cardiovascular disease mortality. This supports the idea that staying hydrated could be an important part of maintaining heart health over time

The short-term cardiovascular effects of water

Additional direct evidence comes from a 2025 study reported in National Health and Nutrition Examination Survey. This experiment tested for immediate cardiovascular responses in healthy adults after being given one glass of water (355 mL).

Results showed a major decrease in systolic blood pressure and decrease in heart rate shortly after consumption. The effects were observed in an hour

and reflected an increased regulation of the autonomic nervous system. Though the effects were temporary, they reflect on the role of hydration in facilitating support of heart function under everyday living conditions.

Temporary reductions in blood pressure, even minimal ones, decrease the heart's workload. For people susceptible to hypertension or cardiovascular stress, this daily habit might offer daily relief. The study also gives validity to the belief that water is not only harmless but actually beneficial.

Under promise, over deliver? China unveils new climate goals

United Nations, Sept 25: China has for the first time made specific emission cut pledges, though its goal of reducing planet-warming greenhouse gases just 7-10 percent by 2035 is seen as far too modest.

But Beijing has often "under-promised and over-delivered," analysts say, and its pledge offers a path toward more ambitious efforts to tackle climate change.

Here's what to know: Why it matters

China is the world's second-biggest economy and the largest polluter. It accounts for nearly 30 percent of global emissions.

It is also a clean energy powerhouse, and sells most of the world's solar panels, batteries and electric cars.

China's trajectory determines whether the world will limit end-of-century warming to 1.5C and avoid the most catastrophic impacts of climate disruption.

Under the Paris Agreement, countries must update their "Nationally Determined Contributions" every five years. Many are racing to do so before the COP climate summit in Brazil this November.

Beijing pledged in 2021 to peak carbon dioxide emissions before 2030 and reach carbon neutrality by 2060. But it gave no near-term numerical targets for reducing emissions. The geopolitical context has



raised the stakes: the United States has again quit the Paris accord under President Donald Trump, who dismisses climate change as a "con job," while a fractious European Union has yet to set new targets.

What China promised Under the new plan, China

pledges to: - Cut economy-wide net greenhouse gas emissions by 7-10 percent from peak levels, while "striving to do better." Some analysts believe China's emissions have already peaked or will do so soon.

To align with 1.5C, Beijing needs to cut emissions around 30 percent within a decade from 2023 levels. The United States peaked CO2 emissions in 2007 and reduced them by approximately 14.7 percent a decade later. - Increase non-fossil fuels in total energy consumption to over 30 percent and expand wind and solar capacity to more than six times 2020 levels, reaching 3,600 gigawatts.

- Increase forest cover to over 24 billion cubic meters. - Make electric vehicles "main-

stream" in new sales.
- Expand the national carbon

trading scheme to cover high-emission sectors and establish a "climate adaptive society."

What experts think

Observers almost universally say the targets are too modest — but that China is likely to surpass them thanks to its booming clean technol-

"China has often under-promised and over-delivered," said Andreas Sieber, associate director of policy

350.org. The new target is "underwhelming," but "it anchors the world's largest emitter on a path where clean-tech defines economic leadership," he added.

Others echoed that sentiment. "What's hopeful is that the actual decarbonization of China's economy is likely to exceed its target on paper," said Yao Zhe of Greenpeace

China is installing renewable energy at a record pace that far outstrips the rest of the world, and it dominates the production chain of many clean-tech sectors.

But it has also continued to install coal capacity, and its decision to use an unspecified "peak" rather than set a baseline year for emissions cuts raised concerns.

That keeps "the door open to near-term increases in emissions," warned Lauri Myllyvirta, lead analyst at the Center for Research on

Energy and Clear Air. The pledges serve as "a floor, not a ceiling, for China's ambition," he added. Still, many observers believe China's economy is now committed to the energy transition and the pledges will cement that.

"The good news is that in a world increasingly driven by self-interest, China is in a stronger position than most to drive climate action forward," said Li Shuo of the Asia

Netanyahu slams leaders recognizing Palestinian state ahead of US trip



Jerusalem, Sept 25: Israeli Prime Minister Benjamin denounced Netanyahu leaders who had recognized a Palestinian state, as he headed to the United States on Thursday for White House talks and an address to the UN General Assembly.

His remarks came three days after France led a special summit on the sidelines of the General Assembly, which saw a slew of Western governments recognize the State of Palestine against the backdrop of the

nearly two-year Gaza war. Netanyahu is due to address the assembly on Friday.

"At the General Assembly, I will speak our truth — the truth of the citizens of Israel, the truth of the (Israeli) soldiers, the truth of our nation," Netanyahu said at Ben Gurion airport ahead of his departure, according to a statement from his office.

"I will condemn those leaders who, instead of condemning the murderers, rapists and burners of children, want to give them a state in the heart of Israel.

This will not happen."
On Wednesday, Netanyahu said the recent flurry of recognitions of Palestinian statehood, including by Britain and France, did "not obligate Israel in any way," calling it a "shameful capitulation of some leaders to Palestinian terror."

On Thursday, he said he would meet with US President Trump for a fourth time in Washington.

"I will discuss with him the great opportunities that our victories have brought, as well as our need to complete the goals of the war: to bring back all our hostages, to defeat Hamas and to expand the circle of peace that has opened up to us," Netanyahu said.

US envoy Steve Witkoff said Wednesday he expectto Gaza in the coming days, saying Trump had presented a plan to Arab and Islamic countries.

"We presented what we call the Trump 21-point plan for peace in the Mideast and Gaza," Witkoff said.

"I think it addresses Israeli concerns as well as the concerns of all the neighbors in the region." he said on the sidelines of the General Assembly, without elaborating on the 21 points. "We're hopeful, and I might say even confident, that in the coming days we'll be able to announce some sort of breakthrough."

An Israeli air strike on a home where displaced people had taken refuge in central Gaza killed at least 11 people on Thursday, the territory's civil defense spokesperson told AFP.

In recent weeks the military has been carrying out a ground assault on Gaza City, the territory's largest urban center, forcing hundreds of ed a breakthrough related thousands of people to flee.

Japan Open: Alcaraz survives ankle injury scare, advances to second round

Tokyo, Japan, Sept 25: Carlos Alcaraz overcame an injury scare to progress to the second round of the ongoing Japan Open competition on Thursday, beating Sebastian Baez in a convincing manner.

Alcaraz produced dead silence from the audience when he went down to the court 20 minutes into the match, needing some help with his left ankle, but nonetheless continued to script an easy 6-4, 6-2 win, as per Olympics.com.

Following the match, he said, as quoted by Olympics.com, "I think I played a great level of tennis besides what happened at the beginning of the match. I am just happy to get the win and happy that I was able to play until the end of the match.

During the fifth game of the first set, with scores level 2-2, Alcaraz's leg gave up as he charged forward from baseline and he fell over his back, clutching his head and grabbing his left ankle in agonising pain. The audience held its breath, waiting for the world number one to get up and continue. Alcaraz got proper treatment and continued to entertain the crowd, converting his second break point to take a 5-4 lead.

Bumrah back in Test squad for WI series; doors shut on Karun, Easwaran

New Delhi, Sept 25: Pace spearhead Jasprit Bumrah was on Thursday named in India's Test squad for the home series against the West Indies, while Devdutt Padikkal replaced Karun Nair, who could not deliver fully on what was "expected" of him in the opportunities offered so far.

While announcing the 15-member squad at the Indian team hotel here, Chairman of Selectors Ajit Agarkar dropped elaborate hints that Nair and Bengal opener Abhimanyu Easwaran are no longer in the scheme of things.

Rishabh Pant's absence has resulted in Ravindra Jadeja's elevation as vice-captain for the West Indies, while stylish Karnataka left-hander Padikkal, 25, is being seen as a long-term investment along with the 23-year-old Sai Sudharsan, who has locked the No.3 slot.

On Bumrah, Agarkar was clear that the pacer is well-rested and good to go in the series that gets underway on October 2 in Ahemdabad.

"This is a team for both the Test matches. So, he's available for both. We've had a fair break after England. He didn't play the fifth Test



either. There's been a month or five weeks of break," he said in response to a PTI query.

"This tournament (the ongoing Asia Cup here where Bumrah is playing) has been fairly spaced out till this last week. He's ready and keen to play both Test matches," Agarkar explained.

However, while speaking on Nair, he was clear that the 30-yearold burly Bengaluru man didn't make full use of opportunities, scoring one fifty in eight innings during the tour of England.

"We feel Padikkal offers a little bit more at this point and I wish we could give everyone 15 or 20 Tests. Unfortunately, it doesn't work that

way," Agarkar said. "Padikkal's been in the Test squad. Frankly, we expected a bit more from Karun in England. Devdutt was in the Test squad in Australia, played in Dharamsala against England, got a 50 there. He's shown some decent form within the race," the former pacer

When asked why Sudharsan got the nod when he and Nair had a similar run in England Agarkar said: "Eventually, it's a little bit about continuity. There were a few changes at No.3 because of the combination that we played.

"But going forward, Sai has shown a lot of promise. We know he's a very good player. Hopefully, we can give him a longish run from now on, at a particular number," he

'Vietnam's top leader to pay rare visit to North Korea in Oct'

Hanoi, Sept 25: Vietnam's Communist Party chief To Lam is expected to visit North Korea next month, two Vietnamese officials said, marking the first visit in nearly 20 years for a Vietnamese leader to the largely isolated nation.

The two Communist countries maintain close diplomatic ties but have currently no trade relations, according to the Vietnamese embassy in Pyongyang.

The possible visit, with still underway, has not been officially announced by either side. Vietnam's ministry of foreign affairs and North Korea's embassy in Hanoi did not respond to requests for comment.

The two officials declined to indicate a precise time frame for the visit and the issues that may be discussed, but one official said Lam would meet North Korea's leader Kim Jong Un.

The last time a Vietnamese leader visited



North Korea was in 2007 when the head of the ruling Communist Party Nong Duc Manh embarked on a three-day trip to the country, marking the first visit by a Vietnamese party chief since the late President Ho Chi Minh in 1957.

In a rare foreign trip, Kim visited Hanoi in 2019 as part of a visit whose highlight was a summit with US President Donald Trump, then serving his first term at the

Padikkal returns as India name Gillled Test squad for West Indies series

Jadeja named vice captain

New Delhi, Sept 25: The Board of Control for Cricket in India (BCCI) on Thursday announced Shubman Gill-led 15-member squad for the two home Tests against the West Indies, starting from October 2, with Devdutt Padikkal making a return and senior all-rounder Ravindra Jadeja named vice captain.

Padikkal's last appearance in Tests came in the first game of the Border-Gavaskar Trophy in November 2024, where he registered scores of 0 and 25 in two innings. Earlier this month, the left-hander scored a century in the first unofficial Test against Australia A in Lucknow.

Shubman Gill, who took over the red-ball captaincy from Rohit Sharma after the latter retired from the format, will lead the side, with Ravindra Jadeja as his deputy.

Dhruv Jurel, who replaced injured Rishabh Pant in the playing XI for the final Test against England in August, has been named the wicketkeeper for the Windies series and N Jagadeesan included as the backup keeper. Pant was the vice-captain during the recent five-match England series; the 27-yearold sustained a serious injury to his foot in the fourth Test and was subsequently ruled out of the fifth and final game. Karun Nair, who had a middling time on the tour of England, which marked



his comeback to Tests after eight years, has been dropped from the setup. Meanwhile, pacer Prasidh Krishna, who suffered a blow to his head while fielding in the second unofficial Test against Australia A on Wednesday, has also been included in the squad.

Shreyas Iyer has not been considered for selection after he requested the BCCI to grant him a six-month break from the red-ball format. He recently led the India A side against Australia A in the first of the two four-day unofficial Tests before handing over the captaincy duties to Jurel

for the second game. The series opener will be played in Ahmedabad, after which the action will move to Delhi from October 10. This will be India's first Test series after the 2-2 draw in England for the first-ever Anderson-Tendulkar Trophy

India are currently placed third, after Australia and Sri Lanka, despite playing more games than the two teams at No. 1 and 2.
