No sedition, religious violence case reported in J&K in 2023 UT emerges as India's most communal-friendly region, reveals NCRB data

Srinagar, Oct 01: Jammu and Kashmir did not record a single case of communal or religious violence in 2023, reveals the annual report of the National Crime Records Bureau (NCRB).

The report which is in possession of the news agency-Kashmir News Observer (KNO) states that while 425 riot cases were registered involving 655 people, none of them were linked to communal tensions. No sedition



cases were registered during the year either.

The report, as per the news agency- Kashmir News Observer (KNO) shows that cases of violence against women were registered in the Union Territory in 2023 compared to 3,937 in 2021. Kidnapping was the most common crime against women with 895 cases, followed by 524 cases of cruelty by husband and 231 cases of rape. A total of 427 women were abducted for forced marriage, including ten mi-Jammu and Kashmir

ranked fourth among Union

Territories in domestic violence cases with a rate of 8.1

The NCRB data recorded 84 murders, 1,004 cases of kidnapping overall, and 673 cases of death due to negligence, most of them road accidents. There were nine cases of dowry, 44 cases of abetment to suicide, 438 cases of attempted murder, and 434 cases of attempted suicide.

JAMMU, OCTOBER 01: Secretary, Rural Development department (RDD) & Panchayati Raj, Mohammad Aijaz Asad Wednesday chaired a meeting to review the physical and financial progress under UT- CAPEX, Scheme for Special Assistance to States for Capital Investment (SASCI), SNA-Sparsh and Swachh Bharat Mission (Gramin).

The meeting was attended by DG Rural Sanitation, Anu Malhotra; Mission Director NRLM, Shubhra Sharma; Director Panchayati Raj, Sham Lal; Director RDD Kashmir, Shabir Hussain Bhat; Director RDD Jammu, Shahnaz Akhtar; Director Finance, Umar Khan; Joint Director Planning, Kamal Kumar Sharma; Additional Secretary, Waseem Raja, besides all ACDs, ACPs, Executive Engineers, and BDOs of various districts.

The Secretary highlighted Finance

Department directives mandating utilization of 75% of sanctioned assistance by December and surrender of

non-viable projects for reallocation. Departments, he said, must demonstrate capacity to incur at least Rs 2 crore expenditure within the financial year, failing which funds may be withdrawn.

While reviewing UT Capex works, Secretary directed that the pace of execution of works be further accelerated.

Aijaz Asad instructed the concerned Executive Engineers to personally visit construction sites, inspect each building and asset, and ensure their completion strictly within the stipulated timelines. The Secretary emphasized that in

the Kashmir division, where developmental activities get slowed down during winter, the pace of work must be doubled to meet targets well in time.

With regard to SNA-Sparsh, the Secretary asked the heads of all schemes to complete critical post-sanction

processes, including integration, FTO generation, and DSC enrolment, so that the implementation of schemes does not face any bottlenecks.

Reviewing progress under SBM-Gramin, Secretary laid special emphasis on timely execution of Gobardhan Plants, Faecal Sludge Treatment Plants (FSTPs), and Decentralized Wastewater Treatment Plants (DEWATs). He directed the officers that Detailed Project Reports (DPRs), feasibility studies, and tendering processes for the remaining Gobardhan projects be completed expeditiously so that all such plants are operational within the next two months.

He added that these projects are a top priority and will be reviewed on a weekly basis.

Secretary observed that many districts of J&K are already running such plants successfully, and stressed the need for ACPs and BDOs of other

districts to undertake exposure visits to these functional units for adopting best practices. Speaking on FSTPs, Aijaz Asad

underlined that as Deputy Commissioners are the Chairpersons of Sanitation Committees, any issues related to execution should be resolved through their direct intervention.

He also called for awareness programmes to sensitize the public about the significance of these projects and the role they play in ensuring cleanliness and sanitation in rural areas.

Similarly, Secretary stressed the timely completion of DEWATs and instructed that restoration of assets damaged during the recent floods must also be included in the planning

The Secretary issued strict directions to ACPs that any delay in the timely completion of these projects would invite disciplinary action.

Paddy yield down by over 40%: Farmers

Srinagar, Oct 01: Farmers across Kashmir have reported massive losses in paddy production this year, with yields dropping by nearly 40-50 per cent. They blame the prolonged dry spell during the crucial growing months, followed by incessant rains and flood-like conditions just before harvest, for the crisis.

Thunder

Growers from several districts said the weather pattern this year has devastated their livelihood. "For three consecutive months—June, July and August—there was hardly any rainfall. The crop did not grow properly, and then just when we were expecting to harvest, heavy rains submerged the fields for days together. The paddy fell flat and started rotting," said Ghulam Nabi, a farmer from Pulwama.

Many said that their produce, already weakened by the dry spell, could not withstand the continuous waterlogging. "Our fields were inundated for almost a week before harvesting. By the time the water receded, the crop



was damaged beyond recovery. In many places, farmers couldn't even collect enough paddy for household use," said another farmer from Anantnag.

According to locals, hundreds of families who are directly dependent on paddy cultivation for sustenance have been left without a secure income this year. "We have lost almost 40 per cent of our crop. Families who rely only on paddy are staring at a financial crisis," said

Abdul Rashid, a farmer from

Farmers also expressed anger over the compensation policy, saying that authorities have informed them that only those insured under the Fasal Bhima Yojna scheme would be eligible for relief. "We have all suffered losses, whether insured or not.

don a large section of farmers at this time. Compensation must be extended to everyone who has faced damage," demanded Bashir Ahmad, a farmer leader from Shopian.

They appealed to the government to intervene immediately and announce a special relief package for paddy growers across the valley. "It is not about one village or one district—this crisis is widespread. If the government doesn't step in now, it will break the backbone of thousands of families dependent on paddy farming," they said.

Agricultural experts also confirmed that the unusual weather pattern—long dry spells followed by excessive rainfallwas detrimental to the paddy crop this season.

Meanwhile, farmers have urged authorities to announce the compensation to affected areas as a priority and ensure timely support. "We cannot wait for months. Our losses are visible in every field. The government must act before it is too late," they said—(KNO)

Centre approves DA, DR 3 % hike for employees, pensioners



New Delhi, Oct 01: The Union Cabinet on Wednesday increased Dearness Allowance (DA) and Dearness Relief (DR) by 3 per cent for about 49.19 lakh central government employees and 68.72 lakh penoners and also approved opening of 57 new Kendriya

Vidyalayas across the country. The DA/DR increase of 3 per cent over the existing rate of 55 per cent of the basic pay/pension to compensate against the price rise will be effective ret-

rospectively from July 1, 2025. Union Information and Broadcasting Minister Ashwini Vaishnaw while briefing on decisions taken in the Cabinet meeting told reporters here that the combined impact on the exchequer on account of an increase in DA and DR will be Rs 10,083.96 crore per annum.

"The increase is in accordance with the accepted formula based on the recommendations of the 7th Central Pay Commission," he added.

CABINET APPROVES OPEN-ING OF 57 NEW KENDRIYA

The Minister said the Union Cabinet also approved the opening of 57 new Kendriya Vidyalayas (KVs) which would benefit over 86,000 students.

Out of the 57 new KVs, seven will be sponsored by the Union Home Ministry, and the rest by the newly approved KVs are proposed to be opened in districts where no KV presently exists despite a significant number of Central Government employees.

"The Cabinet Committee on Economic Affairs, chaired by Prime Minister Narendra Modi, has approved the opening of 57 new Kendriya Vidyalayas under the Civil sector across the country to facilitate the educational needs of the wards of the increased number of central government employees," Vaishnaw said.

The total estimated requirement of funds for establishment of the 57 new KVs is Rs 5862.55 crore spread over a period of nine years from 2026-27. This includes a capital expenditure component of Rs 2585.52 crore and operational expenditure of Rs 3277.03 crore—(KNO)

Northern Railway collects Rs 30 lakh fines in Jammu

Jammu, Oct 01: As the city of temples prepares to immerse itself in the joyous fervor of Dussehra on October 2, the authorities have rolled out comprehensive arrangements to ensure a safe and seamless celebration of the festival.

Thousands of devotees are expected to flock to key venues across Jammu for Ramlila enactments, processions and the iconic burning of Ravana's effigy, marking the culmination of the nine-day Navratri festivities.

Dussehra, also known as Vijayadashami, commemorates Lord Rama's victory over the demon king Ravana, as narrated in the epic Ramayana.
In Jammu, the celebrations

blend deep-rooted spiritual traditions with community spirit, featuring elaborate stage performances, cultural parades and family gathering

Preparations have been in full swing since mid-September, with effigies of Ravana, Kumbhakarna and Meghnath being meticulously crafted at temple complexes and community grounds.

The highlight of tomorrow's

celebrations will be the grand Ramlila performances and the ceremonial effigy burning at major venues such as the Parade Grounds, Gandhi Nagar Dussehra Ground and grounds near historic sites like Kol Kandoli and Bawe Mata Mandir.

According to district administration guidelines, events are slated to begin early in the morning with special pujas and aartis at prominent temples, followed by processions that weave through the city's bustling streets.

Devotional programs and Shobha Yatras (grand processions) starting from local temples including floral tributes to Goddess Durga and Lord Rama.

After culminating Ramlila enactments depicting the final battle between Rama and Ravana at designated open grounds.

The much-anticipated burning of massive Ravana effigies would be accompanied by fireworks and

cultural shows. Fairs (melas) with traditional games, food stalls and handicraft exhibitions will light up areas around the venues until late night. Additional attractions include

community feasts, bhajans and dance performances showcasing Dogra folk arts. The Jammu Municipal Corpora-

Elaborate security and civic arrangements in light of the large gatherings anticipated, the Jammu and Kashmir Police, in coordination with district authorities, have implemented multi-layered security protocols to ensure public safety.

Additional Deputy Commisioner (ADC) Ansuva Jamwal reviewed these preparations earlier this month, emphasizing coordinated efforts from all departments.

As per officials, over 500 police officers, including specialized anti-goon squads will be stationed across 14 sectors in the city, with a focus on high-footfall areas. Quick Response Teams (QRTs) and bomb disposal squads will patrol procession routes.

Stray dogs injure 20 persons in 3 days dogs have launched sudden

Srinagar, Oct 01: Srinagar, the summer capital of Jammu and Kashmir, is facing a growing crisis due to the rising number of stray dogs, instilling fear among residents and restricting their movement, particularly after dark.

The Srinagar Municipal Corporation (SMC), however, has so far failed to act effectively on the ground.

Localities including Jawahar Nagar, Sanat Nagar, Chanapora, and several others have been badly affected. For residents, stray dogs have become a daily menace. Municipal authorities continue to maintain silence over the issue. While the Supreme Court

has banned the killing of stray dogs, residents argue that alternative measures could still be implemented to control their population and ensure public safety. Communities across Kashmir are waiting for concrete steps to address the growing problem.

Sources within the Srinagar Municipal Corporation said that funds earmarked for sterilization of stray dogs have been drastically curtailed, leaving the corporation with little room to act.

"The implementation of the dog sterilization project has been virtually halted due to curtailment of funds. It requires proper planning, mechanisms, and resources to carry out the initiative across Srinagar. But over the past few years, funds under this head have continued to shrink, and we are now struggling to move forward," a senior SMC officer said.

Meanwhile, in the Waliwar area of Tehsil Lar, stray dogs attacked 20 people in the last three days, leaving many injured and creating panic across the locality. Residents told KNO that

Kashmir's Horticulture Sector Needs Systemic Reform

ashmir's horticulture sector, long celebrated as the backbone of its rural economy, is facing a crisis that demands immediate and systemic intervention. The consultative meeting between the horticulture minister and fruit mandi associations highlighted critical challenges, including inadequate cold storage and packaging standards, unreliable transport, and weak market linkages. Growers report mounting losses, frustration, and a growing sense of

despair. The cold storage facilities are full, grading lines are lying idle, and farmers are forced to sell their produce at distress prices. With a storage capacity of just 3,000 lakh metric tonnes against an annual production of 22,000–25,000 lakh metric tonnes, the infrastructure gap is staggering. Growers wait for hours, sometimes days, to unload their harvest, while millions of rupees worth of grading machinery stands unused because farmers see no value in quality packaging

when markets offer no premium for quality. This is a policy failure. The government must move beyond mere meetings and announcements to deliver tangible solutions that effectively address key issues. Firstly, there should be an expansion of cold storage capacity by investing in modern, high-capacity controlled atmosphere stores on a war footing, particularly in horticulture-rich districts like Shopian and Pulwama. Secondly, it is essential to revive market incentives

by strengthening the Market Intervention Scheme and ensuring minimum support prices, which will help make grading and standard packaging financially viable for growers. Thirdly, efforts should be made to improve market access by ensuring smooth transit on national highways, promoting e-NAM trading, and establishing direct market linkages to reduce dependence on intermediaries. Lastly, supporting processing industries is crucial; the government should

encourage agro-processing units to add value and create alternative revenue streams, especially for lower-grade produce, thereby strengthening the overall agricultural economy. The government must treat this not as a seasonal issue, but as an economic priority. By investing in infrastructure, ensuring fair pricing, and empowering farmers with technology and market access, we can transform this sector from a story of struggle to one of resilience and prosperity.

Enhancing Capacities, Enabling Growth

Empowering Farmers Through Skill Development And Training

Skill development is now firmly embedded in India's agricultural landscape. From hands-on training at KVKs and ATMA's state-led programmes to sector-specific skilling under PMKVY, SMAM, RGM, and PMKSY, these initiatives are equipping farmers and rural youth with knowledge, confidence, and practical abilities.

Parmer empowerment has emerged as a cornerstone of India's agricultural strategy. With nearly two-thirds of the population living in rural areas and almost half dependent on agriculture for their livelihoods, strengthening the skills and capacities of farmers is essential for inclusive and sustainable growth. The challenges faced by farmers today go beyond access to credit or inputs; they include adapting to climate variability, managing soil health, embracing mechanization, and securing better market opportunities.

Recognising this, the Government of India has placed skill development and training at the centre of its rural development agenda. Over the past decade, a range of programmes have been launched to equip farmers with practical knowledge, vocational skills, and exposure to modern technologies. These initiatives seek to ensure that farmers are not just cultivators but also innovators, decisionmakers, and active contributors to the agri-value chain.

Institutions such as Krishi Vigyan Kendras (KVKs) and schemes like Agricultural Technology Management Agency (ATMA), Skill Training of Rural Youth (STRY), Sub-Mission on Agricultural Mechanization (SMAM), and The Pradhan Mantri Kaushal Vikas Yojana (PMKVY) have built strong training platforms, while sector-specific interventions in horticulture, livestock, soil management, and food processing are integrating skilling into their frameworks. Collectively, these efforts underline a clear vision: empowering farmers through skill enhancement is vital to boosting productivity, raising incomes, and building a resilient agricultural sector.

Building Institutional Platforms for Farmer Training

strong institutional framework has been created to take skill enhancement directly to farmers, with the Krishi Vigyan Kendras (KVKs) playing a central role. Established by the Indian Council of Agricultural Research (ICAR), KVKs act as frontline extension centres across districts, bridging the gap between research and practice through hands-on training, demonstrations, and vocational courses tailored to local agro-climatic conditions. Between 2021 and 2024, KVKs trained 58.02 lakh farmers, with the outreach steadily rising each year-16.91 lakh farmers in 2021-22, 19.53 lakh in 2022-23, and 21.56 lakh in 2023-24. In 2024-25 alone, up to February 2025, an additional 18.56 lakh farmers had also been trained.

These figures reflect the consistency and scale of the KVK network in empowering farmers with practical skills in crop management, soil health, animal husbandry, and allied activities. By grounding training in local realities while introducing scientific methods, KVKs have become one of the most effective platforms for farmer capacity building, ensuring that scientific knowledge translates into field-level improvements and long-term resilience.

Complementing this, the Agricultural Technology Management Agency (ATMA) has supported states in revitalising their extension systems. This Centrally Sponsored Scheme on 'Support to State Extension Programmes for Extension Reforms' popularly known as Agriculture Technology Management Agency (ATMA) is being

implemented across the country by the Ministry of Agriculture & Farmers Welfare under the component of Sub-Mission on Agriculture Extension (SMAE). The scheme promotes decentralized farmer-friendly Extension system in the country with an objective to support State Government's efforts to revitalize the extension system and making available the latest agricultural technologies and good agricultural practices in different thematic areas of agriculture and allied areas to farmers, farm women and youth, through various interventions like Farmers Training, Demonstrations, Exposure Visits, Kisan Melas etc.

In 2021-22, about 32.38 lakh farmers were trained under ATMA. This increased to 40.11 lakh in 2022-23 and stood at 36.60 lakh in 2023-24. For 2024-25, the figures are still being compiled, but by 30 January 2025, nearly 18.30 lakh farmers had already been trained. Overall, from 2021 to 2025, the scheme has reached around 1.27 Crore farmers.

Skilling Rural Youth and Promoting Mechanization

Special attention has been given to preparing the younger generation of farmers for emerging opportunities in agriculture. The Skill Training of Rural Youth (STRY) programme has been designed to impart short-term, skill-based training of about seven days to rural youth and farmers in agriculture and allied sectors. The aim is to upgrade their knowledge, promote wage and self-employment, and create a pool of skilled manpower in villages. Recently, the programme has been subsumed under the ATMA cafeteria, ensuring closer integration with state-led extension efforts.

STRY provides practical vocational training in areas such as horticulture, dairy, fisheries, and animal husbandry, and is targeted at rural youth aged 18 years and above, including women farmers. Over the past four years, the scheme has steadily expanded its outreach. In 2021–22, 10,456 rural youth were trained, rising to 11,634 in 2022-23 and 20,940 in 2023-24. This brought the cumulative number to more than 43,000 youth trained between 2021 and 2024. The momentum has continued in the current year as well, with an additional 8,761 youth trained up to 31st December 2024. By equipping participants with hands-on skills and encouraging entrepreneurship, the programme is build-ing a new generation of skilled and selfreliant farmers who can strengthen rural

The Sub-Mission on Agricultural Mechanization (SMAM), being implemented as a component of the Rashtriya Krishi Vikas Yojana (RKVY), seeks to expand the reach of farm mechanization among small and marginal farmers and in regions with low farm power availability. Its objectives include promoting Custom Hiring Services to address the challenges of small landholdings and high ownership costs, creating awareness through demonstrations, capacity building and IEC activities, and ensuring quality assurance through performance testing and certification at designated centers across the country.

According to official data, the Sub-Mission on Agricultural Mechanization (SMAM) has trained a total of 57,139 farmers during the four-year period from 2021

Resources and Value Chains

The Soil Health Card Scheme has played a vital role in helping farmers make informed choices on crop planning and fertilizer application. As of 24thJuly 2025, more than 25.17 crore soil health cards have been distributed across the country, alongside the organization of over 93,000 farmer trainings, 6.8 lakh demonstrations, and thousands of awareness campaigns. These initiatives have promoted balanced nutrient management practices among farmers, leading to improved soil health and sustainable enhancement of agricultural productivity.

At the collective level, the Formation and Promotion of Farmer Producer Organizations (FPOs) has created new platforms for farmer capacity building. With 10,000 FPOs registered, farmers are receiving regular training through digital modules and webinars on agri-business management, market linkages, and use of digital platforms like e-NAM and GeM.

digital platforms like e-NAM and GeM.

The government has also embedded skill development within flagship national schemes. The Pradhan Mantri Kaushal Vikas Yojana (PMKVY 4.0) (2022–26) has incorporated agriculture as a priority sector, it integrates agriculture and allied sectors within India's flagship skilling framework. Through accredited training centres, skill hubs, and PM Kaushal Kendras, farmers and rural youth are trained in short-term courses (300–600 hours), Recognition of Prior Learning, and special projects.

Under the PMKVY scheme, since its inception in 2015 till June 30, 2025, more than 1.64 Crore have been trained and more than 1.29 Crore have been certified.

Like PMKVY, sector-specific interventions

such as the Mission for Integrated Development of Horticulture (MIDH), Rashtriya Gokul Mission (RGM), and Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) have dedicated components for capacity building in horticulture, livestock, and food processing respectively.

Mission for Integrated Development of Horticulture (MIDH)

The Mission for Integrated Development of Horticulture (MIDH) is a Centrally Sponsored Scheme aimed at the holistic growth of the horticulture sector covering fruits, vegetables, root and tuber crops, mushrooms, spices, flowers, aromatic plants, coconut, cashew, cocoa and bamboo.

Under Human Resource Development (HRD) Programme, 9.73 lakh farmers have been trained under various horticulture activities from 2014-15 to 2023-24.

Pradhan Mantri Kisan SAMPADA Yojana

The Pradhan Mantri Kisan SAMPADA

Yojana is a comprehensive scheme aimed at developing modern infrastructure for the food processing sector and creating seamless supply chains from the farm gate to retail outlets

Under the Pradhan Mantri Kisan SAMPADA Yojana, one of the seven key components is "Human Resources and Institutions", which focuses on R&D, promotional activities, skill development, and strengthening of institutions. The Skill Development element under this component is designed to create a sector-specific skilled workforce for the food processing industry, ranging from floor-level workers, operators, packaging and assembly line staff to quality control supervisors, thereby meeting the diverse human resource requirements of the sector and supporting its sustainable growth.

As on June 30, 2025, under various component schemes of PM-Kisan SAMPADA Yojana, 1601 projects have been approved, out of which 1133 projects have been completed benefitting more than 34 lakh farmers in the country.

Conclusion

Skill development is now firmly embedded in India's agricultural landscape. From hands-on training at KVKs and ATMA's state-led programmes to sector-specific skilling under PMKVY, SMAM, RGM, and PMKSY, these initiatives are equipping farmers and rural youth with knowledge, confidence, and practical abilities.

By focusing on capacity building, the Government is not only enabling farmers to adopt better practices but also empowering them to become entrepreneurs, agribusiness leaders, and key drivers of rural growth. We often see lists of 'top' schools. But what makes a good school for your child?

Lists of Australia's "top" schools regu-

larly make headlines.

We see this every year with Year 12 and NAPLAN results. Earlier this month,

News Corp papers also ranked public high schools across different states.

Parents are likely to scroll these lists eagerly, scanning for their child's school or the names of schools they might be thinking about. With families understandably keen to ensure their kids get a good education, rankings provide a clear and seemingly easy guide.

But do they really tell us which schools are the best? And more importantly, how do you know if a school is a good fit for your child?

What do league tables measure?

League tables typically rely on academic performance. NAPLAN results compare how students in years 3, 5, 7 and 9 perform in literacy and numeracy tests, while Year 12 results show how senior students fared in final exams.

These measures give a snapshot of achievement and show patterns across time. But standardised testing only offers a partial view of a school. Often, it reflects community demographics and unequal distribution of resources more than teaching quality. For example, students in wealthier suburbs tend to do better than students in disadvantaged areas.

Some other rankings include other measures such as student attendance or parent satisfaction surveys. Even so, they remain narrow.

These tables do not reveal what happens in classrooms. They do not show the quality of relationships between teachers and students. They do not capture whether a school provides strong wellbeing support, fosters creativity, or values diversity. And they certainly cannot tell you whether your child will be happy



there.

On top of this, they assume families always have a choice about where they send their kids.

But popular public schools typically have strict catchment areas, which means only children living locally can enrol. For families outside those boundaries, the options are often limited to a less soughtafter public school, a specialist intake program at their preferred school (such as a music or academic scholarship), or paying for a private education.

They may not have the funds for private education, or they may not have put their names on waiting lists in time.

What research says really matters

Of course academic results matter, but they are only part of the picture when it comes to a "good school". Research shows learning flourishes when students feel safe, respected and inspired.

A truly good school feels good to be in. According to a 2024 UNESCO report, joy, relationships and belonging fuel both wellbeing and achievement. The Australian government's student wellbeing framework similarly says schools must prioritise safety, inclusion and student voice to best support student learning.

So this means opportunities beyond academics also count. This can include arts, sports, vocational pathways and other extracurricular activities to give students chances to develop their talents, build confidence and make social connections.

Personal and family values matter too. A school might be academically strong but highly competitive, which does not suit every child. Conversely, a smaller school with average test scores might offer a nurturing environment where your child can thrive.

What's right for your child?

So how do families put this into practice when weighing up schools?

Visit in person. League tables cannot show you what it feels like to walk through the gates. Notice how staff and students interact. Watch whether students seem engaged.

Talk to the school. Ask staff about their teaching approach, wellbeing policies and how they support diverse learners. For example, how do they respond if a student is struggling academically or emotionally?

Look for balance. A good school is not just about grades. Consider whether it offers music, visual arts, sport or vocational programs alongside academics.

Ask families already there. Parents and carers can share valuable insights into the culture. Do they feel welcome? Do their children enjoy going to school?

their children enjoy going to school?
Think about your child. Some thrive in large, academically competitive schools. Others do better in smaller, community-focused environments. The best school is one where your child feels safe, challenged and supported.

Beyond rankings

League tables will keep appearing because they make good headlines and spark debate. But they should not be the guide for choosing schools.

A truly good school partners with families, supports student wellbeing, and helps young people grow into capable, caring adults. That will not look the same for every child, and it will not be captured neatly in a newspaper list.

So next time you see a headline about the "top" schools, ask yourself: what kind of environment will help my child learn, belong and thrive?

Rajnath hails DAD as silent guardian of India's defence strength

"While the entire world witnessed the valour and courage of the armed forces in achieving a historic and decisive victory during Operation Sindoor, the silent yet crucial role of the Defence Accounts Department ensured efficient resource utilisation, financial management and war preparedness," he said.

Singh described the DAD as an institution that not only ensures fiscal prudence and transparency but also strengthens operational readiness by enabling timely availability of resources to the military. The defence minister was speaking at an event hosted to mark the 278th foundation day of the organisation.

'The DAD is not just an accounting organisation, it is an enabler that ensures the smooth functioning of the nation's economic cycle. It is the invisible bridge that connects finance and the armed forces. Behind the valour of our soldiers lies your silent but decisive contribution," he said.

Blood donation reduces heart attack risk, has multiple health benefits: Doctors

'Uncontrolled diabetes, infections among key deferral reasons for donors'

Srinagar, Oct 01: On the occasion of National Voluntary Blood Donors Day, doctors across Jammu and Kashmir reiterated the importance of voluntary blood donation, calling it not just an act of humanity that saves lives but also a practice that significantly benefits the donor's own health.

Chief Medical Officer (CMO) Anantnag, Dr Khalid Parvaiz, speaking to the news agency— Kashmir News Observer (KNO), said that awareness about blood donation is improving, but more people, especially the youth, need to come forward to make it a regular practice.

'Blood donation is one of the noblest contributions a person can make to society. Apart from saving the lives of patients suffering from cancer, blood disorders, accident victims, and those undergoing surgeries, it also benefits the donor by improving heart health and balancing iron levels in the body," he said.

Dr Parvaiz added that every unit of blood can save up to three lives as it is separated into components like platelets, plasma, and red blood cells that cater to different patients. "Regular donation helps reduce the risk of heart attack,

prevents iron overload, and improves blood circulation. It is also a kind of mini-health checkup for the donor since vitals and haemoglobin are assessed before each donation," he explained.

Dr Mudasir Lone, a general physician at the Directorate of Health Services Kashmir (DHSK), said donating blood once or twice a year plays a crucial role in maintaining cardiovascular health."Studies have shown that regular donation reduces arterial blockages, maintains healthy blood viscosity, and lowers iron overload, all of which are linked to a reduced risk of heart dis-

ease," he said. He further noted that balanced iron levels also lower the chances of developing certain cancers, while the pre-donation screening process often helps identify hidden medical conditions.

Dr Shahnaz Akhter, another senior medical officer, explained the eligibility criteria for donation. "To donate blood, a person must be between 18-65 years of age, weigh at least 50 kg, and have a minimum haemoglobin level of 12.5 g/ dL for women and 13 g/dL for men. Whole blood donation can be done every 12 weeks for men and every 16 weeks for women, while platelet and plasma donations follow shorter intervals," she said.

According to her, people with controlled diabetes can safely donate, but those with uncontrolled diabetes, active infections like HIV or Hepatitis, and individuals who have recently undergone surgery or received certain vaccinations

Doctors cautioned against donating in cases of active infections, flu, cold, uncontrolled hypertension, pregnancy, recent childbirth, or if the donor had a tattoo or piercing in the past 3–6 months.

Medical experts stressed that the demand for blood re-mains constant in hospitals due to surgeries, trauma cases, and chronic illnesses. "Every healthy individual should make it a habit to donate. A single pint of blood can save multiple lives, and the sense of satisfaction one gets from helping others is priceless,' they said.

They appealed to people to spread awareness and encourage voluntary donation. "Blood cannot be manufactured; it only comes from generous donors. By donating, you're giving someone the most precious gift — the gift of life," they add-

MSP hike, launch of National Pulses Mission to help farmers in long term: Chouhan

Oct 01: Bhopal, Union Agriculture Minister Shivraj Singh Chouhan on Wednesday said the Centre's decision to enhance MSP for rabi crops and approval of the National Pulses Mission will have a long-term positive impact on food and nutritional security and farmers'

"The Union Cabinet, chaired by Prime Minister Narendra Modi, took two historic decisions on Wednesday on the eve of Dussehra during the auspicious Navratri festival by approving the National Pulses Mission, and simultaneously increased the MSP (minimum support price) for rabi crops,' Chouhan told reporters here.

Chouhan said these decisions will have long-term positive impacts on food and nutritional security, farmers' welfare, and agricultural production. He said the government has aligned resources

and schemes with farmers' interests as its top priority.

The MSP for Rabi crops, including wheat, has also been increased, with farmers assured of up to 109 per cent returns over cost, he said. Chouhan assured that the

India looks at USD 250 bn investments from EFTA nations: Goyal

New Delhi, Oct 01: India will not only attract USD 100 billion committed investments from the four-nation EFTA bloc under a trade agreement, but also look at an additional USD 150 billion, Commerce and Industry Minister Piyush Goyal said on Wednesdav.

He said that huge opportunities are there for companies from these four countries to invest in India.

Under the India-EFTA trade and economic partnership agreement (TEPA), New Delhi has received a commitment of USD 100 billion FDI from EFTA over the next 15 years.

The European Free Trade Association (EFTA) members are Iceland, Liechtenstein, Norway, and Switzerland. The pact was signed on March 10,

"We have also got a promise from (Swiss State Secretary for Economic Affairs) Helene for another USD 150 billion after

we finalise the data exclusivity in our IP (intellectual property) laws, which I am working towards. So, effectively, we have to get USD 250 billion from the EFTA region," he said.

The minister was speaking at a function to announce the implementation of TEPA from Wednesday. Swiss State Secretary for Economic Affairs Helene Budliger Artieda was present at the event.

the most difficult countries to work in IP and the laws around it. Somehow, there was a lack of

trust for decades between these European countries and India on IP issues, he said. "I am happy to share with

you that we have built that trust by having a very robust IP chapter in EFTA, with free trade agreement with the UK and will have a chapter on this with the EU...we are confident that given the robust IP laws and enforcement in India and the plans to make them even stronger in the future, we will not only attract the committed USD 100 billion investments, but we are hoping to attract much more than

that," Goyal told reporters here. "It is a great day today as TEPA has come into effect from today." India is fast engaging with

the developed world as it has signed trade pacts with the UAE, UK and Australia, he said. With the UK, he said, it was signed in July and the pact is

in the process of ratification in Britain, "and will probably come into effect sometime next year". He described TEPA as a bea-

con of stability and certainty amid global trade volatility, ambiguity and disruption.

The imposition of high tariffs on a number of countries by the US has disrupted global trade.

The minister underlined the wide-ranging opportunities opened by the agreement sciences, clean energy, precision engineering and food processing, technology, artificial intelligence, accountancy and nursing, education, audio-visual services, culture, tourism and recreation, and geothermal

RBI raises FY26 GDP growth projection to 6.8 pc, lowers inflation forecast to 2.6 pc

Mumbai, Oct 01:The Reserve Bank on Wednesday revised upward its growth estimates for the current fiscal year to 6.8 per cent and lowered its inflation projection to 2.6 per cent based on an above-normal monsoon and the rationalisation of GST rates.

In August, the Reserve Bank of India (RBI) projected a 6.5 per cent GDP growth rate for 2025-26, along with an inflation forecast of 3.1 per cent.

Announcing the bi-monthly monetary policy, Reserve Bank Governor Sanjay Malhotra said significant developments on the domestic front, amid a rapidly changing global economic landscape, have altered the narrative on growth-inflation

dynamics in India.
"Buoyed by good monsoon, the Indian economy continues to exhibit strength by registering a higher growth in Q1 2025-26. At the same time, there has been a considerable moderation in headline inflation," he said.

New Delhi, Oct 01: India's billionaire club is growing at a record pace, with the country adding more than one billionaire every week this year, a new report said on Wednesday. The M3M Hurun India

Rich List 2025 shows that India now has 350 billionaires, six times higher than when the list was first released 13 years ago.

The 14th edition of the Hurun list features 1,687 individuals with wealth of over Rs 1,000 crore.

This includes 284 new



entrants, with the total number rising by 148 compared to last year and by 859 in the past five years. "Together, the listers added wealth at the rate of Rs 1,991 crore every single day," as per

Remarkably, the top 10 alone hold wealth equal to 28 per cent of the rest of the entire list, the list showed.

Over 86,000 students to benefit New Delhi, Oct 01: The Union Cabinet on Wednesday new Kendriya Vidyalayas (KVs) which would bene-fit over 86,000 students, Union minister Ashwini

started as a unit of the Ministry of Education of the Government of India.

"Opening of new KVs is a continuous process. The Ministry and KVs regularly receive proposals from various Sponsoring Authorities, including Central Government Ministries, departments, states and UTs for opening of new KVs.

"These proposals are sponsored by the concerned sponsoring authority--state, UTs, Ministries, Departments of Central Government," an official statement said.

There are 1,288 functional KVs at present including three abroad -- Moscow, Kathmandu and Tehran.

The total enrolment of students is around 13.62 lakh. "Together with the earlier sanctioning of 85 KVs, the instant proposal responds to the high demand for KVs while balancing pan-India expansion. The CCEA has approved 7 KVs sponsored by the Ministry of Home Affairs and the remaining 50 by State and UT authorities," it said.

"The 57 new proposals for Kendriya Vidyalayas reflect a strong commitment to reaching underserved and strategically important regions. The proposal demonstrates an approach, which anchors growth in the East while ensuring balanced representation across North, South, and West to strengthen inclusivity and national integration," the statement said.

Continuing with the 85

KVs sanctioned in December 2024, in this proposal, 17 states and UTs are being covered.

Among these 57 KVs, 20 are proposed to be opened in districts where no KV presently exists despite a significant number of Central Government employees.

Furthermore, 14 KVs are proposed in aspirational districts, four KVs in LWE districts and five KVs in NER and hilly areas.

"In continuation of sanction of 85 KVs accorded in December 2024, further 57 new KVs have been approved by prioritising those states which had not been covered since March

The administrative structure for implementing the project will require creation of posts at par with the norms fixed by the Sangathan for running of one full-fledged KV with a capacity of approximately 1,520 students.

Hence, 86,640 students would benefit, it said.

As per norms in vogue, a full-fledged KV (from balvatika to class 12) provides employment to 81 persons and according-ly, with the approval of 57 new KVs, a total of 4,617 direct permanent employment opportunities will be created

Construction and allied activities associated with augmentation of various facilities in all KVs are likely to generate employment opportunities for many skilled and unskilled

US govt shuts down as Republicans, Democrats fail to break impasse

Washington, Oct 01: The United States government has shut down as lawmakers failed to achieve a breakthrough on a funding bill.

As a consequence, the funding for US government departments will be cut and will bring a few federal services to a halt. On Tuesday, Democrats blocked Republicans' plans to pass the spending bill in the Senate.

Democratic leaders met US President Donald Trump on Monday but failed to come to an agreement.

Hours after the meeting, Trump shared an AI-generated video on Truth Social, mocking House Minority Leader Hakeem **Jeffries and Senate Minority** Leader Chuck Schumer.

Trump on Tuesday



continued to blame Democrats, saying that he "didn't see them bend even a little bit." He also threatened to fire more federal workers during the shutdown. "When you

shut it down, you have to do layoffs, we'd be laying off a lot of people," Trump said.

Democrats are demanding to reverse the healthcare cuts in the "Big Beautiful Bill,"

which was passed earlier this year. Republicans assert they would not agree to Democrats' demands and had proposed to extend funding until November 21. While the Republicans control both the Senate and the House of Representatives, they are seven votes short in the Senate as the funding bill requires 60 votes to pass.

It is the first US government shutdown in seven years, as the last one happened under Trump 1.0 and lasted for 35 days - the longest in history.

Essential services such as border protection, law enforcement and air-traffic control would continue to function while food assistance programmes, government-funded preschool, food inspectors and operations at national parks could be adversely affected.

If the shutdown is extended over a long period, air travel could face challenges as many of those workers would be forced to work without pay and may not report for duty.

Trump says it'll be 'big insult' to US if Nobel Prize not awarded to him

Washington, Oct 01: US President Donald Trump has said it will be a "big insult" to America if the Nobel Peace Prize is not awarded to him even though he has ended over seven global conflicts.

Referring to his plan to end the Gaza conflict, Trump said Tuesday in remarks to military leaders in Quantico: "We got it, I think, settled. We'll see. Hamas has to agree, and if they don't, it's going to be very



tough on them. But all of the have agreed. Israel has agreed. Arab nations, Muslim nations,

came together."

Trump said that if his plan, announced Monday, to end the Gaza conflict works out, he would have solved eight conflicts in as many months.

That's pretty good. Nobody's ever done that. 'Will you get the Nobel Prize?' Absolutely not. They'll give it to some guy that didn't do a damn thing. They'll give it to a guy that wrote a book about the mind of Donald Trump and what it took to solve the war... The Nobel Prize will go to a writer, yeah, but we'll see what happens," Trump said.

"But it'll be a big insult to our country. I will tell you that. I don't want it. I want the country to get it. It should get it because there's never been anything like it. Think of it. So if this (plan to end the Gaza conflict) happens, I think it will. I don't say that lightly, because I know more about deals than anybody. This is what my whole life was based

Taliban rejects reports of **Internet ban**

Islamabad, Oct 01: The Taliban government on Wednesday rejected reports of a nationwide Internet ban in Afghanistan, saying old fiber optic cables are worn out and are

The announcement was the Taliban's first public statement on a communications blackout that has disrupted banking, commerce and aviation.

Last month, several provinces confirmed an Internet shutdown because of a decree from the Taliban leader Hibatullah Akhundzada to combat immorality.

"There is nothing like the rumors being spread that we have imposed a ban on the Internet," Taliban officials said in a three-line statement in a chat group with Pakistani journalists.

Zelenskyy, UN atomic agency head warn of heightened risk at huge Ukrainian nuclear plant

Kyiv, Oct 01: Ukraine's president and the UN nuclear agency head are sounding the alarm about increased safety risks at the Russia-occupied Zaporizhzhia Nuclear Power Plant in southern Ukraine, which lost its external power supply more than a week ago as the war raged

around it. Emergency diesel generators are providing power for crucial cooling systems for the facility's six shutdown reactors and spent fuel, and there is no immediate danger to Europe's biggest nuclear plant, according to International Atomic Energy Agency Director-General Rafael Mariano Grossi.


But "it is clearly not a sustainable situation in terms of nuclear safety," he said.

The backup generators have never needed to run for so long, according to Ukrainian President Volodymyr Zelenskyy.

China will resolutely oppose Taiwan independence: Xi Jinping

Beijing, Oct 01: China's President Xi Jinping on Tuesday said China will resolutely oppose "Taiwan independence" separatist activities and external interference and firmly safeguard national sovereignty and territorial integrity.

Xi, also general secretary of the Communist Party of China (CPC) Central Committee and chairman of the Central Military Commission, made the remarks at a

Indian domination: Record-breaking Abhishek, Varun continue to top ICC T20 rankings

Dubai, Oct 01: Rapidly-rising Indian batting star Abhishek Sharma widened the gap between him and the rest by achieving the highest-ever rating points, while Varun Chakravarthy continued to top the bowling charts in the latest ICC T20 International Rankings issued on Wednesday.

However, Pakistan's Saim Ayub has ended Hardik Pandya's run at the top of the T20I all-rounder rankings.

Abhishek broke a record that has lasted for almost five years by reaching the highest-ever rating 931 points in the ICC Rankings following India's title-winning run at the just-concluded Asia Cup here.

The 25-year-old overtook the previous best rating of 919 points, which was achieved by England right-hander Dawid Malan in 2020, the ICC said in a statement.

The left-hander, who was adjudged player of the tournament in Asia Cup for his blazing form that helped him score at a strike rate of over 200, also surpassed the previous best ratings (912) and Virat Kohli (909).

Abhishek only made his international debut last year, but has put together an amazing record amassed a total of 314 runs at an average of 44.85 in the seven Asia Cup games.

He now leads England's Phil Salt in second place by a total of 82 rating points, while his India

teammate Tilak Varma remains in third place in the batter rankings after his 213 runs at the

India won the match by 59 runs


to make a strong start in the event that the team is hoping to win for the first time, riding on home advantage and good recent form.
