Srinagar, Oct 03: Warning Pakistan that it risks losing place on the world map if it continues to sponsor terrorism, Army Chief General Upendra Dwivedi on Friday said that



India will not exercise the restraint it had shown during 'Operation Sindoor 1.0.'

In a sternly-worded address to soldiers at Anupgarh in Rajasthan's Sriganganagar Dwivedi, district, General according to the news

agency-Kashmir Observer (KNO) said, "India, as a country, is fully prepared this time. And this time, it will not show the restraint that it exhibited during Operation Sindoor 1.0. This time we will take a step forward and act

in a manner that will make Pakistan think whether it wants to remain on the world map or not."

Asking soldiers to remain prepared, the Army Chief said, 'Keep yourselves fully prepared now, if god wants, the opportunity will come soon."

General Dwivedi said that 'Operation Sindoor' exposed terrorist hideouts deep inside Pakistan. "India has given evidence to the world. Had we not unearthed this proof, Pakistan would have hidden all of it." he said, adding, "Entire world stood with India when we launched Operation Sindoor to avenge April 22 Pahalgam terror."

He said the Indian military hit nine targets inside Pakistan, of which seven were hit by the

Terms neighbouring country's claims of destroying Indian jets as 'manohar kahaniyan'

New Delhi, Oct 03: Terming Pakistan claims about it destroying Indian jets during 'Operation Sindoor' as "manohar kahaniyan (fascinating tales)" Chief of Air Staff Air Chief Marshal A P Singh on Friday said that at least a dozen Pakistani military aircraft, including F-16 jets were destroyed or damaged in Indian strikes.

While talking to porters here the Air Chief Marshal, according to the news agency—Kashmir News Observer (KNO) outlined the extensive losses suffered by Pakistan during the strikes carried out by the Indian military to avenge the April 22 Pahalgam terror attack that left 26 civilians, mostly tourists dead. "Indian strikes hit radars at least four places, command



and control centres at two places, runways of course damaged at two places, then three of their hangars in three different stations were damaged."

"We have signs of one C-130 class of aircraft...and at least one dozen military aircrafts, including 4 to 5 F-16 jets, because that place happened to be F-16 with whatever was under maintenance at that time," he added. The Air Force Chief Marshal said, "Along with that, one SAM system was destroyed. We have clear evidence of one long-range strike, which I talked about more than 300 km, which happened to be either an AEW&C or a SIGINT aircraft. RS polls: BJP leadership to meet today at Jammu

Srinagar, Oct 03: The Bharatiya Janata Party's (BJP) election committee will hold a meeting on Saturday morning in Jammu to discuss the upcoming Rajya Sabha polls scheduled for October 24.

Sources told the news agency–Kashmir News Observer (KNO) that the party's election committee will convene tomorrow at the party headquarters in Jammu to strategize for the upcoming Rajya Sabha elections.

The meeting will also be attended by Tarun Chugh, BJP National General Secretary and in-charge for J&K, who is exnected to arrive in Jammu late

Sources told KNO that the

party will discuss its overall strategy for the polls.

"The party will deliberate on whether to contest the election for the first two seats, which the ruling alliance is expected to win comfortably, or to field a candidate for only one seat, for which a combined election will take place," they said, adding that the names of probable candidates may also be discussed.

They added that feedback from the meeting will be sent to the party high command, which will finalize the candidate.

Sources disclosed that BIP spokesperson Advocate Sunil Sethi, former state president Ravinder Raina, and former Deputy Chief Minister Nirmal Singh are frontrunners for the seat that the BJP is in a strong position to win. (KNO)



Use cough syrups in children hospitals rationally: Health Ministry advises States, UTs

Warns against use in children under 2 years, stresses non-drug measures first

New Delhi, Oct 03: The Union Health Ministry has issued an advisory to all States and Union Territories on the rational use of cough syrups in the paediatric population, cautioning against their use in children under two years of age.

According to the advisory, a copy of which is in the possession of the news agency-Kashmir News Observer (KNO), "Most acute coughrelated illnesses in children are self-limiting and tend to resolve without medication.



It emphasizes that cough and cold syrups should not be prescribed or dispensed

to children below two years. For children under five years, their use is generally not recommended, and for older children, administration should be based only on clinical evaluation under strict medical supervision.'

The Health Ministry has stressed that, where required, cough syrups should be prescribed in the lowest effective dose and for the shortest duration possible, while avoiding multiple drug combinations.

Instead, the advisory recommends non-pharmacological measures—such as adequate hydration, rest, and supportive care—as the first line of treat-

Div Com reviews preparedness, mitigation plan

Directs Deptts for operational readiness, deployment of machinery

SRINAGAR, OCTOBER 03: In view of the recent weather forecast predicting rain and snowfall from 5th to 7th October issued by the India Meteorological Department (IMD), Divisional Commissioner Kashmir, Anshul Garg, convened an urgent meeting with officials from key departments to review preparedness and mitigation plan.

The meeting was attended by HoDs & representatives from R&B, MED, BEACON, NHIDCL, Urban Local Bodies, IMD, and the Horticulture & Marketing Planning Department.

During the meeting, the Divisional Commissioner instructed concerned departments to ensure immediate deployment of personnel and machinery at critical locations to facilitate swift snow clearance.

He stressed the importance of completing the tendering process for the winter snow clearance plan by October 31, and directed the deployment of trained and experienced machinery operators to avoid damage to road infrastructure.

He urged use of High Molecular Weight Polyethylene plastic in snow plows to enhance efficiency and minimize road wear.

He laid focus on the timely restoration of road connectivity to remote and border areas, including the Mughal Road, which serves as a crucial link during winter months.

Meanwhile, Div Com also directed the Food, Civil Supplies & Consumer Affairs (FCS&CA) department to ensure advance stocking of ration, LPG, and petroleum products in remote border areas. Additionally, he emphasized the need for advance distribution of



October's ration to consumers and instructed that a 15-day buffer stock of LPG be maintained in the Kashmir Valley to prevent shortages.

Director of Horticulture Marketing & Planning was advised to encourage fruit growers and traders to utilize railway services for apple transportation, ensuring faster and more economical

movement.

To ensure coordinated and timely response to any weather-induced emergency, the Divisional Commissioner directed the immediate operationalization of the Divisional Control Room for better coordination and synergy among field departments.

Jammu, Oct 03: The Government of Jammu and Kashmir has commenced the implementation of Next Generation GST Reforms 2.0, effective from September 22, 2025, aligning with the national tax rationalization drive and reinforcing its commitment to consumer welfare. The overhaul simplifies the GST framework by reducing multiple tax slabs to just two primary rates-5% for essentials and 18% for most other goods and services. These measures are poised to lower the cost burden on households, insurance, medicines, education, and key livelihood sectors

To ensure efficient, transparent, and people-centric execution, the Government has adopted Standard Operating Procedures (SoPs) across all key departments: State Taxes, Legal Metrology, Health & Medical Education, and Industries & Commerce. District and divisional enforcement teams will intensify market surveillance, verify accurate price revision, and provide direct citizen support through a network of GST Suvidha Kendras and sectoral helplines in every district.

The Suvidha Kendras are equipped to assist taxpayers in understanding



GST 2.0, filing returns, remapping HSN codes, and resolving grievances. A robust seven-step implemen-

tation protocol anchors the rollout: Policy Communication: Issuance of clear advisories to industry and trade associations regarding rate reductions. Awareness & Capacity Building: Organisation of webinars, publication of brochures, radio and social media campaigns to broaden understanding. Timely rains brighten outlook of saffron crop

Srinagar, Oct 03: After a disappointing saffron season in 2024, when production dropped drastically due to lack of rainfall, Kashmir's saffron growers are finally hopeful of a revival this year.

Adequate showers during the crucial growth phase in September have raised expectations of a significantly better harvest in Pampore and its adjoining saffron belts.

Farmers said the crop is showing visible signs of recovery, with healthier bulbs and longer soil moisture retention.

"Last year was devastating; flowers hardly bloomed. But this season looks promising. If we get one more spell of rain, the yield may reach 80 per cent, which will be a blessing for us," said Abdul Majeed Wani, president of the Kashmir Saffron Growers Association.

Growers in Pampore, famously known as the "saffron town of Kashmir", share similar optimism as they said that plants look much healthier this year, and the bloom is likely to be stronger." Another

farmer, Ashiq Hussian from Chandhara, said, "Even if the production reaches 70-80 per cent, it will give us some relief after many bad seasons."

However, the optimism comes with underlying worries. Saffron cultivation in Kashmir has been steadily declining, with farmers struggling against climate change, reduced irrigation, and, most alarmingly, the smuggling of saffron corms — the very foundation of the crop.

Just two months ago, police and agriculture officials in Awantipora foiled a major attempt to smuggle 1.5 quintals of saffron corms outside the Valley.

Experts say such practices severely harm local farming by creating shortages during the planting season. "Saffron is not just an economic crop but part of our cultural identity. If corm smuggling continues, our heritage is at stake," they said.

Government data reflects the challenges: production fell from 17.33 MT in 2021 to 14.87 MT in 2022, and marginally improved to 14.94 MT in 2023 and in 2024 it was just around 30 per cent of the normal production.

While initiatives under the National Mission on Saffron have helped rejuvenate some fields, experts caution that these gains are undermined when corms are illegally siphoned off.

They demanded intervention of the government to make irrigation facilities functional and take steps for the revival of this project—(KNO)

Police in NKR arrest 155 in illegal mining crackdown

Srinagar, Oct 03: Police across North Kashmir Range have intensified their crackdown on illegal mining, registering 129 FIRs, arresting 155 offenders and seizing 154 vehicles, in a major drive aimed at dismantling the sand mafia and safeguarding riverbeds.

The crackdown, officials said was spear-headed by the Range Police Headquarters Baramulla, comes amid growing concerns over rampant sand mining that has caused severe damage to riverbeds and fragile ecosystems.

Officials said the drive aims to put the so-called sand mafia under sustained

DIG North Kashmir Range emphasized that the campaign would continue with zero tolerance. "Illegal mining is a crime, not a career," he warned, saying offenders would face strict action under law.

Police further stressed that "No License, No Escape" would remain the guiding principle of the operation, making it clear that only those with valid permits would be allowed to extract minerals—(KNO)

23 vehicles seized for illegal transportation of minerals: Police

Srinagar, Oct 03: In a continued drive against illegal mining, Police on Friday said to have seized 23 vehicles found transporting illegally extracted minerals in different areas of Pulwama, Ganderbal and Shopian.

In Pulwama, 02 tippers, bearing registration numbers JK08G-6301 and JK13E-0314, were seized by Police Post Rahmoo. Similarly, 04 more tippers bearing registration numbers JK13J-2378, JK01AN-8100, JK01AP-9093 and JK04B-8285 were seized by Police Station Pulwama, a police spokesman said in a statement.

Meanwhile in Ganderbal, Police said to have registered 03 FIR's, seized 09 tippers, 02 Tata Mobiles & 02 Tractors are involved in illegal mining activities, and accordingly apprehended accused persons in various cases/matters for their direct involvement in the crime. The seized vehicles, illegally loaded with minor minerals extracted from Nallah Sindh, Ganderbal, were intercepted within the jurisdiction of P/S Ganderbal, P/S Safapora P/S Gund and PP Nagbal. The registration numbers of the seized vehicles are JK05B-9529, JK01AF-0052, JK01T-1471, JK13C-8090, JK01J-9411, JK01J-9411, JK09C-5028, JK15C-0729, JK18-1190, JK01AX-1953, PB5AX-7928, JK16B-9334 and JK01R-3970.

In Shopian, 02 dumpers, bearing registration numbers JK13J-6277 and JK13D-7161, were seized by Police Post Turkwangam. Similarly, two more dumphers bearing registration numbers JK13K-1041 & JK13J-7755 were seized by Police Station Shopian, police said.

Accordingly, police said that cases under relevant provisions of law have been registered in respective police stations and

investigation initiated. Meanwhile, J&K Police reiterated its firm commitment to curb illegal mining and safeguard natural resources of the district. "Citizens are urged to extend cooperation by reporting such unlawful activities. Confidentiality of informants will be ensured, and strict action shall be taken against violators as per law," police said—(KNO)

LPG shortage irks domestic consumers

Srinagar, Oct 03: The consumers in different parts of Srinagar here have complained of facing acute shortage of LPG, accusing the agencies of ig-noring their plights. Consumers from different

parts of Srinagar and outskirts claimed that their bookings for the LPG cylinders have been kept on hold for a long time now.

"As we approach the concerned gas agencies, we are being told that there is a shortage of the supply," Irfan Ahmad, one of the consumers said. He said that they are facing such a situation from the last one month, adding that the booking has been done, but the agencies are clearly refusing the delivery due to the shortage of the supply.

'Those associated with the agencies to deliver the LPG cylinders at doorsteps have also switched off their phones,



suffer," Ahmad, who hails from Hyderpora, said.

The situation is no different in city areas like Chattabal where the people have raised concerns after the delivery for the LPG cylinders have come to a halt for unknown reasons.

The consumers demanded immediate redressal of their grievances and urged the administration to look into

Minister Sharma for enhancing supply chain

Jammu. Oct 03: In a decisive move to ensure uninterrupted access to essential commodities, Minister for Food, Civil Supplies & Consumer Affairs (FCS&CA), IT, Transport, Youth Services and Sports, Satish Sharma today directed to enhance the supply chain of LPG cylinders, petrol, and diesel across Jammu and Kashmir.
The Minister made these directions while

reviewing the stock position of essentials during meeting with officers of FCS&CA, legal metrology and representatives of Oil Marketing Companies (OMCs).

Citing the critical need for seamless service delivery, especially in light of the India Meteorological Department's (IMD) recent advisory warning of potential weather disruptions, Minister Sharma directed for strengthening the supply and distribution network including mandatory Doorstep Delivery of LPG Cylinders eliminating any inconvenience caused by collection at distribution points. He further directed for reimbursement of delivery

The Minister further directed FCS&CA department and OMCs to maintain sufficient stocks of LPG cylinders, petrol, and diesel to prevent shortages, with daily monitoring mechanisms in place.

Satish Sharma also directed for enhanced coordination between the department, OMCs, and transport authorities to streamline logistics and address supply chain bottlenecks effectively.

He also directed for setting up a dedicated 24/7 Control and Monitoring Cell at the Heads of Departments (HoDs) and State Logistics Coordinator (SLC) levels to address grievances related to adverse weather conditions and ensure rapid resolution.

The Minister emphasized the urgency of these measures, stating, "With the IMD's warning of possible disruptions due to adverse weather, ensuring buffer stocks and reliable delivery of essential fuels is non-negotiable Any lapse in compliance will result in strict action against defaulters, including Oil Marketing Companies and responsible officials.'

Satish Sharma further directed the officers to commence field inspections immediately in order to enforce compliance. He urged consumers to report any issues through the FCS&CA helpline or department's online portal.

Proposed maternity hospital remains a distant for Pulwama residents

Pulwama, Oct 03: More than seven years have passed since the government identified land for the construction of a 100-bed maternity hospital in Pulwama, but the project remains confined to papers, leaving residents disillusioned and women patients struggling for facilities.

According to officials, around 112 Kanals of land were identified at Sirnoo, on the outskirts of Pulwama town, for the hospital that was meant to address the growing healthcare needs of women in Pulwama and neighbouring Shopian districts. However, beyond the installation of a notice board at the site, no progress has been made.

"It was a long-pending demand of the people of Pulwama and Shopian to have a dedicated maternity hospital. Such a facilihospitals or MCH Anantnag, but it seems the project has been abandoned midway," a health official told the news agency—Kashmir News Observer (KNO).

Locals expressed strong resentment over the delay, saying they have been approaching authorities for years, but their pleas have gone unheard.

"After repeated representations, land at Sirnoo was finalised with assurances that work would start soon. But seven years down the line, there is no progress," said Jahangeer Ahmad, a resident of Pulwama.

He added that the absence of a dedicated maternity hospital forces women patients to travel either to Srinagar or private clinics,

leading to unnecessary delays and extra financial burden.

"Earlier, the government had proposed the hospital at Chandgam, but since it was too far from town, protests were held, and the current location at Sirnoo was identified. Yet, nothing has changed on the ground," he said.

Residents believe the hospital would not only save time and money but also ease the rush at Srinagar's Lal Ded Hospital. "We request the higher authorities to intervene and ensure work begins without further delay so that locals can finally heave a sigh of relief," they said.

Even the District Development Council (DDC) Pulwama had passed a resolution in favour of constructing the maternity hospital, but the matter continues to linger.

Meanwhile, an official said that the roposal has been forwarded to higher authorities but has not received administrative approval yet. "The project is under active consideration of the government, and hopefully it will be approved soon," he maintained.

However, in a contradictory statement, the government recently told the Assembly that "there is no proposal before the government for the construction of a 100-bedded maternity hospital at Sirnoo,

This discrepancy has further deepened the uncertainty, leaving the much-needed project in limbo and the people of south Kashmir waiting for what they call "a basic necessity, not a luxury"—(KNO)

UPSC At 100: Honouring A Legacy Of Trust, Excellence, And Integrity In Public Service

As India marks 75 years of independence, the UPSC celebrates a century of shaping merit, safeguarding fairness, and upholding the ideals of constitutional morality, paving the way for a future of transparent, inclusive governance

s India is celebrating 75th year of Aits Republic, a defining moment in the democratic journey, the Union Public Service Commission (UPSC) stands at a milestone, entering into its 100th year of establishment. The Public Service Commissions (PSCs) were envisioned by our forefathers as Constitutional bodies, guardian of meritocracy in civil services, who shoulder the immense task of governance in a diverse and the biggest democracy in the world. Accordingly UPSC was entrusted a pivotal role the areas of recruiting, promoting and disciplining officials of the Central Civil Services. The story of its evolution therefore, over the period of last one century, is not just an institutional chronicle, but a reflection of India's deep faith in fairness, trust and integrity.

The idea of an independent Commission to oversee recruitment into the higher civil services found its strongest voice way before the making of the Constitution, itself. The Lee Commission report (1924) stated "Wherever democratic institutions exist, experience has shown that to secure an efficient Civil Service it is essential to protect it so far as possible or personal influences and to give it that position of stability and security which is vital to its successful working as the impartial and efficient instrument by which Governments, of whatever political complexion, may give effect to their policies" Thereafter, leaders of the Constituent Assembly, too supported the idea of independent PSCs, arguing that while governments change, the machinery of administration should remain impartial, professional, and anchored in constitutional morality. It was argued with great conviction that recruitment into the civil services could not be left entirely to the discretion of the executive, for such an arrangement risked politicisation and erosion of public trust.

The founding fathers, therefore, enshrined in Part XIV of the Constitution, Articles 315 to 323, a special status for the Union and State PSCs. This was done to safeguard their independence and autonomy, and to ensure that recruitment, promotions and disciplinary matters would be free from fear or favour. It is a testament to their vision that the institution, has been standing tall, for its principles of Merit, Trust and Integrity.

Though open competitive examination for recruitment was introduced in 1850's, those examinations were held in London and conducted by the British Civil Service Commission. Competitive examination for Indian Civil Service preceded that for British Civil Service by many years. These overseas examinations put the Indian aspirants at a significant disadvantage. However, despite hardships, some Indians made their entry into the ICS and significantly contributed to India's freedom struggle movement. Satyendra Nath Tagore (1863) the first Indian to enter ICS, R C Dutt (1869), SurendraNath Banerjee (1869) and others were few early entrants. The persistent demand by Indian leadership for simultaneous examination in England and India fell on deaf ears of the rulers. Though the demographic balance titled after the World War I, civil services remained an instrument of colonial policy.

However the first mention of independent Public Service Commission in India, found its mention in the Government of India Act, 1919, which was then established in October 1926, as the Public Service Commission, following the



of 1924. Headed initially by Sir Ross Barker, the body had limited functions and was a cautious experiment under colonial rule. In 1935, it was reconstituted as the Federal Public Service Commission, a step forward in giving Indians a larger role in administration. With the birth of the Republic in 1950, it acquired its present constitutional status as the UPSC. This historical evolution reflects not just administrative continuity, but also the growing confidence in India's own democratic institutions. From conducting a small number of examinations in its early years, UPSC today manages a vast and varied portfolio ranging from the prestigious Civil Services Examination to specialised services such as Engineering, Forest, Medical and Statistical and other services. Its scope has expanded with the Republic itself, but its core mandate remains unchanged to recruit the finest talent for public service.

If the history of UPSC is its foundation, the principles of trust, integrity and fairness are its pillars. Over the decades, millions of aspirants have placed their faith in the Commission, assured that success or failure depends solely on their merit. This trust is not an accident. It has been built painstakingly through transparency in procedure, impartiality in evaluation, and an uncompromising stance against malpractice. The sanctity of examinations, from the setting of question papers to their secure conduct across the country, is guarded with utmost rigour. The confidentiality is at the core of its processes. This has led to what the institution is today, winning the heart and trust of the Nation. Integrity, meanwhile, has meant protecting the institution from political or external pressures, maintaining confidentiality, and ensuring that those who succeed are genuinely among the most competent. Fairness has meant providing equal opportunity to candidates from every background, urban or rural, privileged or underprivileged, fluent in English or not. In a country as diverse as ours, where inequalities persist, the fact that pation's service and progress. UPSC examinations are regarded as a true "level playing field" is itself one of independent India's proudest achievements. This philosophy finds echo in the timeless wisdom of the Bhagavad Gītā, where Lord Krishna says: "तस्मादसक्तः सततं कार्यं कर्म समाचर। असक्तो ह्याचरन्कर्म परमाप्नोता पूर्षा।" (Tasmadsakt statam karyam karma Samachar. Asakto haracharkarm paramapnoti purushah.)" — or in other words without attachment, constantly perform your duty as it ought to be done; for by performing action without attachment, one attains the Supreme. The UPSC embodies this principle in spirit: it performs its duty with rigour and fairness, without attachment to outcomes.

The UPSC recruitment process has evolved with times. There have been changes in the examination patterns: the introduction of the Civil Preliminary Examination in 1979; the restructuring of the syllabi periodically: the introduction of an Ethics paper and the Civil Services Aptitude Test among others. Each of these reforms were brought in after lot of debate and deliberations, so that civil service officers selected are not only knowledgeable, but also equipped with the skills and integrity demanded by con-

temporary governance. At the heart of UPSC's recruitment journey are the thousands of aspiring youngsters who come forward year after year, driven by dedication, perseverance, and a dream to serve the nation. Once dominated by a select few from elite urban centres, today the Civil Services Examination attracts candidates from nearly every district of India, including the remotest and most underprivileged regions. This extraordinary diversity reflects the true spirit of the 'Indian Dream'—the aspiration that talent, hard work, and commitment can open the doors of opportunity to all. UPSC salutes these courageous aspirants and remains committed to reaching every corner of the country, ensuring that every aspiring citizen has the chance to contribute to the

UPSC takes immense pride in conducting world's biggest and most complex competitive examination- the Civil Service Examination, with remarkable precision and consistency year after year. Starting with nearly 10-12 lakh applicants for the preliminary exam, candidates for the mains exam have the option of choosing from among 48 subjects and writing their answers in English or any of the 22 languages recognized under the Constitution of India. UPSC then evaluates these multiple-subject candidates into a single meritbased ranking—a feat unique in scale and sophistication anywhere in the world. The logistics of the Civil Services examinations are truly extraordinary. The Preliminary examination is held across more than 2,500 venues nationwide. For the Mains examination, the task becomes an intricate challenge: ensuring that each candidate at different centres across the country receives the question paper for the subject they have chosen. This complexity is further compounded by the special arrangements made for differently-abled candidates, including the provision of scribes, while visually impaired candidates are provided question papers in larger fonts. After the exam, answer sheets are evaluated anonymously by top experts in the 48 disciplines, with proficiency in the language in which the answers are written. This seamless, time-bound orchestration typifies India-its ability to manage complexity and diversity with efficiency, fairness, and

As we celebrate a century of UPSC, it is equally fitting to honour the unsung heroes behind its remarkable success—the paper-setters and evaluators who form the faceless backbone of the Commission. These are some of the finest academics and experts in the country, each a master in their own discipline, yet they serve with quiet dedication, without seeking recognition or limelight. Their meticulous work, impartial judgment, and unwavering commitment to excellence have been the bedrock of UPSC's ability to conduct a fair, transparent, and robust selection process—one that has earned the trust of the nation and stood the test of time. I personally thank each one of them for their selfless service, which ensures that the dreams and aspirations of thousands of candidates are judged with fairness, rigor, and integrity.

diagnostic centres operating from upper floors, urging departments to address these infrastructural barriers. She called upon the Social Welfare department to explore ways to support those unable to obtain or update their Aadhaar cards, so that they are not deprived of pensions and other welfare

On the issue of empowerment, the Minister advocated for extending loan facilities to persons with disabilities to help them become self-reliant and economically independent.

"Government has to do more in this sector. The people need us, and it is our responsibility to reach their doorsteps with support, care and dignity," she

Trump sets Hamas Sunday deadline to agree peace deal

Deir Al-Balah, Gaza Strip, Oct 03: US President Donald Trump said Friday that Hamas must agree to a proposed peace deal by Sunday evening, threatening an even greater military onslaught nearly two years into the war sparked by the Oct. 7 attack into Israel.

Trump appears keen to deliver on pledges to end the war and return dozens of hostages ahead of the second anniversary of the attack on Tuesday. His peace plan has been accepted by Israel and welcomed internationally, but key mediators Egypt and Qatar, and at least one Hamas official, have said some elements need further negotiation, without elaborating.

"An Agreement must be eached with Hamas by Sunday Evening at SIX (6) P.M., Washington, D.C. time," Trump wrote Friday on social media. "Every Country has signed on! If this LAST CHANCE agreement is not reached, all HELL, like no one has ever seen before, will break out against Hamas. THERE WILL BE PEACE IN THE MIDDLE EAST ONE WAY OR THE OTHER." Trump's plan would end the

fighting and return hostages Under the plan, which Trump unveiled earlier this week alongside Israeli Prime Minister Benjamin Netanyahu, Hamas would immediately release the remaining 48 hostages



- around 20 of them believed to be alive. It would also give up power and disarm.

In return, Israel would halt its offensive and withdraw from much of the territory, release hundreds of Palestinian prisoners and allow an influx of humanitarian aid and eventual reconstruction. Plans to relocate much of Gaza's population to other countries would be shelved.

The territory of some 2 million Palestinians would be placed under international governance, with Trump himself and former British Prime Minister Tony Blair overseeing it. The plan provides no path for eventual reunification with the Israeli-occupied West Bank in a

future Palestinian state.

A Hamas official told The Associated Press this week that some elements of the plan are unacceptable and need to be amended, without elaborating. Palestinians long for an end to the war, but many view this and previous US proposals as strongly favoring Israel.

US and Israel seek to pressure

Israel has sought to ramp up pressure on Hamas since ending an earlier ceasefire in March. It sealed the territory off from food, medicine and other goods for 2 1/2 months and has seized, flattened and largely depopulated large areas of the

Experts determined that

Gaza City had slid into famine shortly before Israel launched a major offensive aimed at occupying it. An estimated 400,000 people have fled the city in recent weeks, but hundreds of thousands more have stayed

Olga Cherevko, a spokesperson for the UN humanitarian office, said she saw several displaced families staying in the parking lot of Shifa Hospital during a visit on Thursday.

"They are not able to move south because they just can-not afford it," Cherevko told The Associated Press. "One of the families had three children and the woman was pregnant with her fourth. And there were many other vulnerable cases there, including elderly people and people with disabilities."

Trump wrote that most of Hamas' fighters are "surrounded and MILITARILY TRAPPED, just waiting for me to give the word, 'GO,' for their lives to be quickly extinguished. As for the rest, we know where and who you are, and you will be hunted down, and killed.'

Most of Hamas' top leaders in Gaza and thousands of its fighters have already been killed, but it still has influence in areas not controlled by the Israeli military and launches sporadic attacks that have killed and wounded Israeli soldiers.

Hamas has held firm to its position that it will only release the remaining hostages

- its sole bargaining chip and potential human shields - in exchange for a lasting ceasefire and an Israeli withdrawal. Netanyahu has rejected those terms, saying Hamas must surrender and disarm.

approaches Thousands of Hamas-led militants stormed into Israel on Oct. 7, 2023, attacking army bases, farming communities and an outdoor music festival, killing some 1,200 people, mostly civilians. They abducted 251 others, most of them since released in ceasefires or other

Israel's retaliatory offensive has killed more than 66,000 Palestinians, according to Gaza's Health Ministry, which does not say how many were civilians or combatants. It says women and children make up around half the dead.

The ministry is part of the Hamas-run government, and the UN and many independent experts consider its figures to be the most reliable estimate of wartime casualties.

The offensive has displaced around 90 percent of Gaza's population, often multiple times, and left much of the territory uninhabitable.

Both the Biden and Trump administrations have tried to end the fighting and bring back the hostages while providing extensive military and diplomatic support to Israel.

Indian Americans donated over \$3 billion to US universities since 2008: Indiaspora

New York, Oct 03: Indian-Americans have donated over USD 3 billion to US universities since 2008, according to a new study that highlights the multigenerational multiplier effects of the diaspora community's contribution towards strengthening research, innovation and access to higher education across the US.

In a new research, leading nonprofit organisation Indiaspora said Thursday that Indian-Americans, many of whom credit their undergraduate and graduate experiences at US universities as the foundation of their professional success, are giving back in transformative ways.

"Through landmark donations to higher education institutions across the country, the Indian American community is not only honouring the institu-tions that shaped their lives but also ensuring future generations have access to the same opportunities for learning, innovation, and leadership development," Indiaspora said.

It noted that since 2008, Indian-Americans have donated over USD 3 billion to US universities, creating a powerful "fly-wheel effect" that strengthens the US educational ecosystem while reinforcing professional and cultural ties between India and America.

"By investing in universities, Indian American donors who value education are "putting their money where their mouth is. They are also demonstrating a larger commitment to

America, supporting Americans of all races, ethnicities and backgrounds to thrive," Founder and Chairman of Indiaspora MR Rangaswami said.

The research also found that 78 percent of Indian-Americans hold a bachelor's degree or higher-far exceeding the national average, and Indian students contribute nearly USD 10 billion annually to the US economy, supporting an estimated 93,000 American jobs.

It added that approximately 270,000 Indian students are currently enrolled in American universities.

"Through philanthropic donations to US-based educational institutions, Indian Americans are not only transforming lives today-they are building a meaningful legacy in and for this country and the world: one that multiplies across generations and ensures that American universities will continue to shape future leaders, foster innovation, and advance knowledge for the benefit of all," Executive Director of Indiaspora Sanjeev Joshipura said.

The research noted that a vast majority of publicly known donations have gone towards medical and health sciences, engineering, and business education.

In addition to professional fields, USD 140 million has been directed toward cultural programming.

Endowments for South Asian, Hindu, and Indian studies symbolise the community's dedication to preserving their cultural heritage while enriching America's academic landscape,

terrorists. We had aimed to strike their bases. We have no complaints against ordinary Pakistani citizens, so long as their country does not sponsor terrorists. Because terrorists were being sponsored, those terrorist targets were hit," General Dwivedi said.

Referring to the people living near the international border, he said, "We consider the border population not as ordinary civilians but as soldiers. That means they stand shoulder to shoulder with us in the battle. This is crucial because the coming struggle is the nation's struggle, not just the Army's.'

The Army chief said history bears witness that during the 1965 and 1971 wars, ordinary citizens stood shoulder to shoulder with the soldiers. "We would want them to join us in the days ahead as well. I want to thank them -- their zeal boosts the morale of our soldiers,"

Earlier General Dwivedi visited forward areas including Bikaner Military Station to review the operational readiness of troops.

"During the visit he interacted with senior military leadership, veterans, civil dignitaries and soldiers, reiterating the Army's focus on modernisation, combat preparedness, strengthening technological capabilities and operational excellence," an Army statement said, as per KNO.

"The COAS felicitated veterans Lt Col Hem Singh Shekhawat (Retd), Lt Col Birbal Bishnoi (Retd), Risaldar Bhanwar Singh (Retd) and Hav Nakat Singh (Retd) for their valuable contributions towards nation building," it added.

"He also interacted with all ranks, emphasising the rapidly evolving nature of warfare and the Army's commitment to integrating UAS and counter-UAS technologies across the operational spectrum to enhance adaptability and preparedness against emerging threats,' the statement said.

Addressing the formation, including veterans of Bikaner, the Chief Of Army Staff (COAS) commended the troops for their dedication, steadfast commitment to duty and effective multi-agency coordination, while operating in the demanding desert and semi-desert terrain. "A clear directive, clear mandate was given to the Indian Armed Forces. It stands as a lesson which will go down in history that this is one war that was started with a very clear objective and it was terminated in a quick time without just prolonging it," he said.

"We are seeing what is happening in the world, the two wars that are going on, there's no talk about termination. But we could make them (Pakistan) reach a stage where they ask for a ceasefire, ask for termination of hostilities. And also, we took a call as a nation to terminate those hostilities because our own objectives were met. I think this is something that the world needs to learn from us," Singh

The Air Chief Marshal said, "Wars will not be like before. We need to be prepared for current and future challenges with an integrated approach involving all services and agencies.

'Self-reliance remains a central goal for the IAF. The Indian Air Force has placed orders for the LCA Mk1A, with development continuing on the LCA Mk2 and Indian Multi-Role Helicopter projects," he said.

The IAF Chief said that several radars and systems are also being developed domestically. He also spoke about successful joint exercises with countries like the UAE, Egypt, France, and Singapore, with foreign commanders showing interest in continuing these drills.

Sharing details about the forthcoming 93rd Air Force Day that will feature a parade at Hindon Air Base on October 8 with full rehearsal on October 6, Singh said, "A special flypast will include a Mi-17 helicopter carrying the Operation Sindoor flag. Static displays will present Rafale and Su-30 MKI fighters, transport aircraft, the Akash missile system, radars, and other equipment.

"We're showcasing 18 innovations that reflect the IAF's drive for self-reliance and solutions-focused thinking. We've also played a key role in humanitarian operations across multiple Indian states this year," he added. (KNO)

Reviewing the arrangements, the Chief Minister directed the Agriculture and Horticulture Departments to issue timely advisories to farmers and orchardists and ensure the smooth transportation of fruit to terminal markets, particularly during peak harvesting season.

He asked the Public Works Department and national highway agencies, including NHIDCL, NHAI, SAMPARK and BEACON, to keep adequate machinery on standby for snow and debris clearance at vulnerable spots to maintain

uninterrupted road connectivity.

Similarly, the Power Development and Jal Shakti Departments were instructed to deploy quick-response teams for immediate restoration of electricity and water supply in case of disruptions, while the Disaster Management Department was tasked with activating control rooms and maintaining close coordination with the district administrations to monitor the situation round-the-clock.

The Chief Minister also directed police and traffic authorities to regulate vehicular movement on highways and other vital roads, and to issue travel advisories as and when required for the safety of the general public.

Laying special focus on healthcare pre-paredness, Omar Abdullah instructed the Health Department to ensure availability of ambulances at vulnerable spots and to identify patients requiring urgent evacuation so at necessary steps could be taken without delay in the event of an emergency. The Information Department, he said, must ensure that timely updates and weather advisories are widely disseminated through all available channels so that people remain informed and can take precautionary measures in advance

The Chief Minister also reviewed the stock

position of ration, medicines, fuel and LPG. He was informed that sufficient stocks are available till November and supplies are being replenished regularly. Such areas in Jammu division which usually get affected during adverse weather conditions have also been stocked adequately to avoid shortages.

To streamline snow and debris clearance, the Chief Minister directed that different roads be specifically assigned to designated agencies to avoid duplication of efforts and confusion. He called for unified control rooms to be established for better coordination, stressing that clearance operations should be undertaken in a continuous flow to ensure timely restoration of road connectivity.

Underscoring the importance of preparedness, the Chief Minister said: "The government's top priority is to remain fully prepared and responsive to any situation arising from the anticipated weather disturbance. Every department must work in close coordination to safeguard people, prevent loss to crops, and protect vital infrastructure."

The director further said that a brief spell of light rain is expected at a few places on October 8, adding that the weather would remain generally dry from October 9 to 14.

Moreover, the district administration Srinagar has issued an advisory, advising people living near the Left and Right Banks of the River Jhelum, including its tributaries and flood water bodies due to potential safety hazards.

The administration has specifically warned tourists, local Shikara Wallas and sand miners at Dal Lake and River Jhelum not to attempt crossing water bodies without verifying conditions.

Indian legal system governed by rule of law, not by rule of bulldozer: CJI Gavai

New Delhi, Oct 03: Chief Justice of India B R Gavai on Friday said the Indian legal system is governed by rule of law and not by "rule of the bulldozer".

Delivering the inaugural Sir Maurice Rault Memorial Lecture 2025 in Mauritius on 'Rule of Law in the Largest Democracy', he referred to his own verdict deprecating 'bulldozer justice'.

Sir Maurice Rault, a noted jurist, was the Chief Justice of Mauritius from 1978 to 1982.

Highlighting the principle of rule of law and its expansive interpretation by the Supreme Court of India, Justice Gavai, who is on a three-day official visit to the island nation, said, "The judgment sent a clear message that the Indian legal system is governed by the rule of law, not by the rule of the bulldozer.'

In the judgement in the 'bulldozer justice' case, the apex court held that demolition of houses of accused in response to alleged offenses bypasses legal processes, violates the rule of law and



infringes upon the fundamental right to shelter under Article 21.

"It was further held that the executive cannot assume the roles of judge, jury, and executioner simultaneously," the CJI said.

He delivered the lecture in the presence of President of Mauritius Dharambeer Gokhool, Prime Minister Navinchandra Ramgoolam and Chief Justice Rehana Mungly Gulbul among others.

In his address, the CJI referred to various landmark judgements of the apex court including the 1973 Kesavananda Bharati verdict that had brought the basic structure doctrine and clipped the powers of Parliament to amend every bit of the Constitution.

"Over the past 75 years since the adoption of the Indian Constitution, the concept of the Rule of Law has evolved far beyond legal texts, permeating social, political, and constitutional discourse alike," he said.

Justice Gavai said in social sphere, laws have been enacted to redress historical injustices and marginalized communities have frequently invoked them, and the very language of rule of law to assert their rights against entrenched systems of oppression.

"In the political arena, the rule of law serves as a benchmark of good governance and societal progress, misgovernance and lawlessness, where institutions and public officials might otherwise evade accountability," he said. Referring to the contributions of Mahatma Gandhi and B R Ambedkar, Justice Gavai said their vision demonstrated that in

a mere set of rules". "It is an ethical and moral framework designed to uphold equality, protect human dignity, and guide governance in a diverse and complex society," he said.

The CJI referred to recent notable verdicts including the one which abolished the practice of instant triple talaq among Muslims.

He also highlighted the judgements in the case challenging the law on adultery and the electoral bond scheme.

"Taken together, these four judgments demonstrate how the Supreme Court has developed the rule of law as a substantive principle, using it to strike down laws that are manifestly arbitrary or unjust," he said.

Iustice Gavai also emphasised the importance of the to privacy as a fundamental

'This articulation underscores that, when understood as a core principle of constitutionalism, the rule of law operates on both procedural and substantive levels: it restrains arbitrary action by the State, guarantees equality before the law, and embeds democratic accountability across all branches and levels of governance," he said.

Justice Gavai said the principle has animated the legal discourse as the apex court repeatedly invoked the language of rule of law to both legitimise and explain its constitutional role, as well as the constitutional roles of other branches of the state.

"The rule of law is thus not a rigid doctrine but a conversation across generations, between judges and citizens, parliaments and peoples, nations and their histories. It is about how we govern ourselves in dignity, and how we resolve the inevitable conflicts of liberty and authority in a democratic society," he said.

RBI moots rationalising norms for setting up offices by foreign entities

Mumbai, Oct 03: The Reserve Bank on Friday proposed to rationalise norms for establishment of a branch or office in the country by entities resident outside India.

In this regard, the central bank has issued 'Draft Foreign Exchange Management (Establishment in India of a branch or office) Regulations, 2025'

"The draft proposals offer greater operational freedom by shifting from prescriptive to a principle-based framework, which is expected to result in greater operational freedom," the RBI said. Further, the eligibility criteria for establishment of a place of business in India, are proposed to be relaxed, it added.

Regarding opening a branch or office in India, the draft said an Entity Resident Outside India (EROI) should submit an application in a specified form to a bank, who may grant approval as per these proposed regulations.

Post approval and the government of a foreign

lishment of such office to the Reserve Bank of India. "The RBI shall allot a Unique Identification Number (UIN) to the branch or office on the basis of the data submitted by the designated bank," said the draft on which the RBI has sought stakeholders com-

Niti Aayog pitches for presumptive taxation scheme for foreign investors

New Delhi, Oct 03: The government think tank Niti Aayog on Friday suggested the introduction of a presumptive taxation scheme for foreign companies to provide certainty and simplicity.

The Aayog, in a working paper, said the optional presumptive taxation scheme would help resolve disputes concerning PE (permanent establishment), simplifying compliance and protecting revenue.

"The proposed presumptive taxation scheme is a proactive and pragmatic solution to a long-standing problem.

"It balances India's sovereign right to tax with the need to provide certainty and simplicity to



foreign investors," the working paper said.

The paper noted that despite India's inherent appeal and remarkable FDI growth, structural impediments such as ambiguous PE regulations introduce tax uncertainty and dampen investments.

"Codify PE and attribution principles into domestic law, aligned with global norms, while avoiding retrospective amendments.

"...by adopting a presumptive taxation scheme, India can transform its tax regime from a 'minefield' into a 'well-lit path', significantly improving its standing in global business indices," it said.

The presumptive taxation scheme works to provide relief to taxpayers from the tedious work of maintaining regular books of account under certain circumstances.

A company opting for this scheme can declare income at a prescribed rate; in lieu of that, it is relieved from maintaining books of accounts for audit by tax

The paper emphasised that this bold reform would align tax policy with the larger economic vision.

I-T dept imposes Rs 23 crore penalty on Adani Cement entity ACC

New Delhi, Oct 03: The Income Tax (I-T) department has imposed two separate fines on ACC Ltd, totalling Rs 23.07 crore, which will be contested by the Adani Group firm before the appellate au-

The I-T department has slapped a penalty of Rs 14.22 crore allegedly "for furnishing of inaccurate particulars of income" for Assessment Year 2015-16. The department has also levied a penalty

amounting to Rs 8.85 crore "for under-reporting of income" for Assessment Year 2018-19.

"The company will be contesting both orders by filing appeals before the Commissioner of Income Tax (Appeals) within the prescribed timelines and, in parallel, will seek a stay on the penalty demands raised under the respective orders," ACC said in regulator filings on Thursday.

The company received these two demands on October 1, 2025, and said that these penalties will have no impact on financial activity.

Brazil and Indonesia might be the second and third most affected, with impacts due to the disease in India and Brazil accounting for 48 per cent of the global impact on healthcare systems and individuals, the findings show. The study, led by researchers trabuddhe, associate director

at the London School of Hygiene and Tropical Medicine, suggests chronic health impacts will be the biggest concern, with existing evidence suggesting around 50 per cent of the affected possibly grappling with a long-term disability. Around the world, more than 1.40 crore people every year could be at risk of chikungunya infection in the long term, the study estimated.

They estimated "global chikungunya burden annually of 14.4 million (1.44 crore) infections" and "India and Brazil accounted for 48 per cent of the global burden".

"The chronic phase accounts for 54 per cent of chikungunya burden, with relatively higher burden among 40-60-year-old population, with mortality disproportionately affecting children under 10 and adults over 80," the team added.

Lead researcher Hyolim Kang, also a research fellow at Nagasaki University, "It's been widely thought that mosquitoes carrying chikungunya would be confined to subtropical or tropical continents, but our analysis has found that the risk extends way beyond these regions."

"Prevention of the spread of this disease is important for everyone. There are no specific antiviral therapies for chikungunya and treatment relies solely on supportive care. Not only are infections extremely painful, even the healthiest of people can be infected and left with life-long disability," Kang said.

Protests worldwide condemn Israeli interception of Gaza flotilla

Paris, Oct 03: Protesters around the world Thursday railed at Israel's interception of a flotilla carrying aid for Gaza's besieged Palestinians, urging greater sanctions in response.

From Europe to Australia and South America, demonstrators took to the streets to condemn the treatment of the Global Sumud Flotilla, which set sail from Barcelona last month to challenge Israel's blockade of Gaza, where the United Nations reports famine conditions after nearly two years of war.

Forty-one ships with more than 400 people aboard, including politicians and climate campaigner Greta Thunberg, were halted by the Israeli navy from Wednesday and prevented from reaching the coastal territory, an Israeli official said.

A boat carrying former Barcelona mayor Ada Colau was among those prevented from proceeding. Colau and her fellow activists, including Nelson Mandela's grandson Mandla Mandela, face deportation by Israel.

Several hundred protesters also marched outside the Irish parliament in Dublin, where support for the Palestinian cause has often been compared to Ireland's centuries-long struggle against British colonial rule.

Miriam McNally, who said her daughter had set sail with the flotilla, was at the Dublin demonstration.

"I am worried sick for my daughter, but I am so proud of her and of what she's doing," McNally told AFP.

"She is standing up for humanity in the face of grave danger." Around 15,000



people marched through Barcelona in protest at Israel's actions, according to the municipal police force in Spain's second city, chanting slogans including "Gaza, you are not alone," "Boycott Israel" and "Freedom for Palestine."

Riot police beat back a portion of the protesters who attempted to climb over barriers with truncheons, forcing them to retreat, images broadcast on Spanish public television showed.

The protesters then headed to the Swiss city's Mont Blanc bridge, at the end of Lake Geneva, to be met by a line of police in riot gear, who pushed the demonstrators back after brief clashes.



FIFA unveils Trionda, the official ball of the 2026 World Cup



New York, Oct 03: FIFA has unveiled the official match ball for the 2026 World Cup, combining high-tech refinements and design details celebrating the three co-host countries—the United States, Mexico and Canada.

The ball, called Trionda, was again designed by German manufacturer Adidas, provider of the official World Cup balls since the 1970 tournament.

[°]I am delighted and proud to present the Trionda," FIFA president Gianni Infantino said as the ball was revealed at an event in New York on Thursday.

The first World Cup organised by three countries, with 48 teams competing, inspired both the name and the design of the ball featuring red, blue and green colors.

Iconography from each host nation maple leaves from Canada, the eagle from Mexico and stars from the United States also feature, with a triangle referring to the unity of the three countries.

Less visible are technological advancements that include deep seams designed to produce "optimal in-flight stability" and embossed icons that improve grip in wet or humid conditions.

A motion sensor chip will relay information on the ball's movement, sending data to the video assistant referee (VAR) system.

The unveiling marks another step in the countdown to the North American World Cup, which will be held June 11-July 19 next year.

FIFA has launched its online phased ticket sales procedures, with more than 4.5 million fans from 216 countries and territories entering the presale draw.

The tournament draw will be held in Washington on December 5.


