# Two soldiers go missing in Kokernag forests, searches on

Anantnag, Oct 08: Two Army soldiers have gone missing in the Ahlan Gadole forest belt of Kokernag area in south Kashmir's Anantnag district, prompting a massive search operation by security forces.

Official sources told the news agency-Kashmir News Observer (KNO) that the two soldiers went missing on Monday evening during an operation in the dense forests of Ahlan Gadole. "Contact with them could not be established since last evening," they said.

'The missing soldiers were part of a small operational team that was carrying out searches following specific inputs about the presence of terrorists in the area," sources said, adding, "A sudden change in weather

conditions disrupted the operation, and during that time, two soldiers went missing.'

The area has recently witnessed snowfall, and the thick foliage and rough terrain are making the search operation difficult.

Sources said additional Army personnel have been deployed, and every corner of the forest is being combed. "Choppers and drones have been pressed into service to trace the missing soldiers," they said.

Meanwhile, the Army said that two soldiers have gone missing after a severe snowstorm in the Gadole forest area of Kokernag in Anantnag.

#### 100-120 terrorists believed to be near LoC launch pads, says IG BSF Kmr

'Security forces on high alert to prevent infiltration'

Srinagar, Oct 08: The Border Security Force (BSF) on Wednesday said approximately 100 to 120 terrorists are currently stationed across the Line of Control (LoC) and may attempt infiltration before winter sets in.

"Two months are still left before harsh winters. Terrorists can try infiltration during this period. Our intelligence agencies are analysing their activities and we are taking countermeasures from our side," Inspector General (IG) BSF Kashmir Frontier, Ashok Yadav

Speaking to the media after unveiling a statue of Sardar Sector Headquarters in Pantha Chowk, Srinagar, Yadav said



the security along the Line of Control (LoC) in Kashmir remains tight, with constant monitoring and countermeasures in place to prevent any infiltration attempts by terror-

#### SIA searches 8 locations across Kashmir

#### Case linked to terrorist sleeper cell module

Srinagar, Oct 08: In continuation of its unrelenting efforts to crackdown the sleeper cell module, the State Investigation Agency carried out extensive searches at eight locations across seven districts in the Kashmir valley today.

In a statement, issued to news agency-Kashmir News Observer (KNO), a spokesperson said that the searches were conducted as part of an ongoing investigation of case FIR No.

"01/2025 of Police Station CI/ SIA Kashmir. The case is related to the sleeper cell module operof terrorist commanders of proscribed terrorist organisations of Lashkar-e-Taiba and Jaishe-Mohammad. The module is used for spreading secessionist propaganda thereby radicalising and recruiting the youth into the terror fold," reads the statement.

It reads that today's search operation was conducted simultaneously across 7 districts in north, central and south Kashmir. "During raids, substantial incriminating materials have been seized, and the suspects have been rounded up for further questioning," it reads.

It added that preliminary investigation has clearly brought out the active engagement of these entities in a terrorist conspiracy aimed at propagating and furthering anti-India narratives aimed not only at challenging the sovereignty and territorial integrity of India but also at inciting di public disorder, and communal hatred. After the recent torrential rains and floods, the region's fragile road network has suffered severe damage, while funds for restoration remain stuck awaiting government approval.

In the mountainous district of Doda, the condition of link roads has worsened dramatically.

Commuters, who spoke to the news agency-Kashmir News Observer (KNO), describe travelling on these dilapidated routes as sheer torment.

#### 20 years on, earthquake memories still haunt Kashmir's border villages Residents say natural disasters can't be stopped, but suffering was unimaginable

Karnah, Oct 08 Ghulam Nabi Khan, now 80, still lives in a house rebuilt with government aid, but the pain from

that day has never left him. On this day 20 years ago, the Karnah Valley in north Kashmir's Kupwara district faced a devastating earthquake, claiming over 150 lives, destroying thousands of homes, livestock, and vital infrastructure, and leaving deep scars on

the mountains and fields. "It's been 20 years since the deadly earthquake devastated and shook the Karnah Valley, yet people here still carry fresh memories of that day," Khan recalled while speaking to the news agency-Kashmir News Observer (KNO).

He said people lost their loved ones in the tragedy, and the pain that kept us awake for months still haunts us to this day.

"We were busy in the fields when the earth started shaking violently. I ran back home to find the roof collapsing like a deck of cards. My two grandsons were playing inside. They



never came out alive. I still see their faces when I close my eyes," he recalled.

Today, Khan tends a small orchard near his home. "I work every day, but the silence at home reminds me of what I lost," he said, adding, "It was a natural disaster; no one could have stopped it, but we suffered beyond anything imaginable."

Locals said that villages like Tangdhar, Tithwal, and other border areas were among the worst hit.

Almost all the 'kachcha'

houses made of mud and brick collapsed, especially in lowlying areas where over 90% of structures were destroyed.

Even army installations, bridges, and culverts were severely damaged. Roads, including the crucial Karnah-Tangdhar route, were blocked by landslides, isolating the valley for days.

Fatima Begum, 68, was a widow even before the earthquake, but lost her son and many neighbours in the disaster.

was fetching water from the spring when the earth trembled. By the time I reached home, everything had fallen: the walls, the roof, and my son trapped inside."

For days, she searched through the debris alongside others, hoping for a miracle that never came. Now, Fatima lives with her daughter in Tangdhar.

Zubeeda, 35, was newly married and full of hope in 2005. "We had just finished building our mud house when the quake struck at dawn. The walls shook, and then everything fell around us. I held my husband's hand | More on P6

# CS reviews progress on digitization, modernization of land records

Calls for timely completion of exercise to ensure transparency, efficiency

SRINAGAR, OCTOBER 08: Chief Secretary, Atal Dulloo Wednesday reviewed the progress of the ongoing Dig-itization and Modernization of Land Records project in Jammu and Kashmir, emphasizing that although the exercise is complex and arduous, it remains vital for ensuring transparency, accurate land ownership records, efficient planning, and improved agricultural practices across the Union Territory.

The meeting was attended by Secretary, Revenue, Kumar Rajeev Ranjan; Director, Survey & Land Records; Inspector General, Registration; CEO, State Health Agency and other senior officers, while all Deputy Commissioners participated

through video conferencing. The Chief Secretary underscored the importance of completing the digitization process with utmost accuracy, observing that a significant proportion of land-related disputes stem from discrepancies in land records. He directed the



concerned officers to ensure regular monitoring and evaluation of the progress being achieved and to accomplish the modernization process in every respect within the next

six to seven months. Taking a detailed review of the current status, Dulloo instructed the Director, Land Records, to issue clear guidelines to all Deputy Commissioners regarding the procedure for recreation of missing musavis (cadastral maps) in certain villages. He asked that necessary support be extended to districts to ensure completion of this process within two months. so that the subsequent course of action for remaining villages can be determined thereafter.

The Chief Secretary also reviewed the progress under key components of the land records modernization programme, including digitization of Iamabandis (Record of Rights), geo-referencing of cadastral maps, sub-parcelization of survey numbers, end-to-end digitization of registrations, modernization of record rooms, computerization of revenue courts. implementation of NAKSHA in Urban Local Bodies, and the SVAMITVA scheme in rural areas for property card distribution.

Presenting an overview of the achievements, the

Secretary, Revenue informed that data entry of Jamabandis is being carried out in 4519 villages out of 6857, with around 600 villages already completed. He added that a backlog mutation module has been developed to update the

Records of Rights (RoR) and Jamabandis to the year 2025, and a proof of concept (PoC) of the same has been successfully completed in five It was further informed that parcel attribute upda-

tion under the PM Gati Shakti initiative is progressing satisfactorily and is expected to be completed within a month. Out of 6217 geo-referenced maps received by BISAG-N, 4240 have been returned and ground-truthed, while parcel attribution has been completed for 3489 villages using QGIS/ARC GIS tools.

Regarding computerization of the registration process, the meeting was informed that the system is expected to become fully paperless within the next two weeks, with legacy data dating back to 1990 also being digitized in

collaboration with the judicial courts.

Under the SVAMITVA Scheme, it was given out that 52,265 property cards have already been distributed across 1,200 villages, while drone surveys stand almost complete, with work on Map 1.0 and Map 2.0 cur-

rently underway.
It was also informed that the NAKSHA scheme is being implemented on a pilot basis in four Urban Local Bodies of Bishnah, Katra, Pattan, and Awantipora out of which Bishnah is nearing completion, with drone surveys pending in the remaining three municipalities.

Reiterating the government's commitment to bring about a paradigm shift in land governance, the Chief Secretary directed the Revenue Department to maintain momentum and ensure seamless integration of all modules under the Digital Land Records Modernization Programme (DLRMP) for enhanced public service delivery and reduction in

In all, over 1,52,000 students of class 11th (81,000) and 12th (71,000) from Kashmir Division and winter zone areas of Jammu Division including students from District Kargil are taking up the exam in the forthcoming session restored by the Government back to October- November.

As per the Date- sheet, the exams will commence on November 8 for class 12th and November 19 for class 11th and are likely to conclude by the second week o December.

In consideration of the disruptions in the academic calendar caused due to torrential rains/ cloudbursts and floods, the J&K BOSE has decided to grant 15% concession for these classes also making an attempt of 85% marks equivalent to 100%.

The J&K BOSE has urged students to prepare seriously for the examinations while reiterating its commitment to conduct the exams in observance of high standards of transparency and fairness.

The BOSE has exhorted invigilatory staff to be completely professional while discharging their duties in order to safeguard the purity and integrity of exams and requested district administration, police and SED to extend cordial support in smooth, fair and orderly conduct of the examinations. SRINAGAR, OCTOBER 08: Divi-Anshul Garg, chaired a high-level meeting to review the progress of the Comprehensive Sewerage Scheme - Zone III of Greater Srinagar.

The meeting was attended by the Commissioner, Srinagar Municipal Corporation (SMC); Additional Deputy Commissioner Srinagar; Chief Engineer, KPD-CL; Superintending Engineer, UEED; along with officers from R&B, NBCC, and the Revenue Department.

During the meeting, officials from NBCC presented a detailed status report on the project. It was informed that Trunk Sewer Line is 99% complete. Lateral Sewer Line is 100% completed, 60 MLD STP is 98% complete, Household connections have been fully achieved and 60 MLD Infall Pump Station is 100% complete.

It was directed that trial runs

of the completed system shall be started on 16th October 2025, which would cover 2 out of the up under the Project targeting a coverage of over 13000 households in all.

The meeting also discussed key challenges affecting the project, including the relocation of shops, realignment of PHE lines, and shifting of 11KV and 33KV power lines.

Emphasizing timely completion, the Divisional Commissioner called for swift resolution of all outstanding issues, including those hindering household connectivity. He also instructed the concerned departments to explore suitable land for the relocation of shops, which is essential for linking Sector-I to the main sewerage network.

The Div Com directed all executing agencies to ensure that the entire segment of the project is commissioned as per the scheduled timeline.



# Div Com reviews winter preparedness measures

Srinagar, Oct 08: In view of the upcoming winter season, Divisional Commissioner Kashmir, Anshul Garg Wednesday chaired a meeting with Deputy Commissioners and Heads of Departments to review the preparedness for the forthcoming cold months.

The meeting was attended by Deputy Commissioners, Directors of FCS&CA, ULB, and IMD, Commissioner SMC, Chief Engineers of KPDCL, KPTCL, PHE, R&B, PMGSY, and officers from Horticulture, BRO, NH, NHIDCL, and other concerned departments.

Div Com conducted a detailed review of snow clearance strategies of key departments including MED, BRO, PMGSY, SMC, ULB, and R&B. He emphasized prioritizing snow clearance on roads leading to vital installations and habitations, ensuring minimal disruption to public movement and essential services.

He also reviewed buffer stocking of ration, LPG, petroleum products, and distribution transformers besides functioning of water supply schemes, lift stations, and deployment of water tankers.

On the occasion, Div Com instructed Deputy Commissioners to ensure seamless coordination among departments to avoid service disruptions. He called for advance vetting of road stretches to be cleared by respective agencies and stressed the need to



complete tendering and contractor allotments by October-end.

The departments were directed to map manpower and machinery to ensure timely snow clearance.

KPDCL was directed to enhance workshop capacity to reduce transformer repair time besides maintain adequate buffer stock of transformers, poles, and wires. He called for distribution of sufficient transformer oil to all districts to prevent shortages. Also, both KPDCL and KPTCL were instructed to expedite tree branch cutting to prevent power line damage. Director Health Services was instructed to ensure availability of medical staff in all health institutions and to provide 4x4 ambulances to districts and

operation of 108 emergency services. He instructed DCs to identify and map critical patients, elderly individuals, and pregnant women for early evacuation or transfer to safer locations for treatment. Moreover, he directed for deployment of Gynaecologists and Paediatricians to Gurez on a rotational basis.

Regarding Fuel Supplies, he directed agencies to ensure 20 days' buffer stock of LPG by November 20 besides augmentation of buffer

stocks of petrol and diesel. Div Com enjoined Dir FCS&CA to ensure availabilty adequate Buffer stock of ration at distribution places and dumping of stocks in remote

and high-altitude areas. Taking note of increased fire incidents during winters, Div Com directed public awareness campaigns on safe use of electrical appliances and stressed on stationing of fire tenders at critical locations for rapid response.

While reviewing the availability of satellite phones for Nodal Officers and emergency teams, he called for effective usage of communication

He also directed BSNL officers to expedite installation of telecom towers in uncovered areas to ensure uninterrupted connectivity.

Moreover, he advised use of telecom services for dissemination of advisories to the general public, particularly farmers. Div Com directed DC Ganderbal

to ensure continuous operation of Sonmarg Tunnel for winter tourism. SMC and other civic agencies were instructed to ensure prompt snow clearance in city and timely

dewatering of low-lying zones. To streamline coordination, the OSD to Div Com was appointed as the Divisional Level Nodal Officer, while other departments were instructed to appoint their respective nodal officers for information sharing and response.

The Divisional Commissioner reiterated the need for proactive planning, inter-agency coordination, and efficient execution to mitigate public inconvenience and ensure smooth functioning of essential services during the winter season.

# **BRO** restores connectivity to Turtuk

The Gram Panchayat, as the basic unit of the three-tier Panchayati Raj system, holds a central role in rural governance and development. This system was institutionalized through the 73rd Constitutional Amendment Act, 1992, with the objective of strengthening participatory democracy in rural areas. Gram (village) Panchayats not only provide essential services and development at the local level but also play a role in conflict resolution, community meetings, and promoting social well-being.

Development of Panchayats are therefore vital for building a strong foundation for


Article 243G of the Constitution recognizes Panchayats as institutions of local self-government and entrusts them with the preparation of plans for economic development and social justice. Being the closest tier of government to the people, Gram Panchayats are responsible for addressing the needs of marginalized groups and ensuring effective delivery of basic services.

#### **Gram Panchayat Development Plan** (GPDP)

Gram Panchayats have been mandated for the preparation of Gram Panchayat Development Plan (GPDP) for economic development and social justice utilizing the resources available to them. The GPDP planning process has to be comprehensive based on participatory process and Panchayats have a significant role to play in the effective and efficient implementation of schemes.

A well-structured and inclusive planning process lies at the heart of Panchayat functioning. The Gram Panchayat Development Plan (GPDP) is expected to reflect the needs and priorities of the community, align them with available resources, and he prepared in a fair, transparent and participatory manner.

For effective implementation of schemes on subjects of national importance, Panchayat Development Plans (PDPs) must be comprehensive and participatory.



These plans cover the 29 subjects listed in the Eleventh Schedule of the Constitution. While Gram Panchayats prepare GPDPs, Block Panchayats prepare Block Panchayat Development Plans (BPDPs), and District Panchayats prepare District Panchayat Development Plans (DPDPs).

Panchayati Raj Institutions (PRIs) are responsible for delivering services such as water supply, sanitation, roads, drainage, street lighting, health, education, and nutrition at the village level. The 29 subjects of the Eleventh Schedule (To read all the 29 subjects and 73rd Amendment of Panchayati . Raj in India, visit @ https://secforuts.mha. gov.in/73rd-amendment-of-panchayatiraj-in-india/) also align closely with the Sustainable Development Goals (SDGs), thus positioning PRIs as key actors in achieving SDGs through localization.

To carry the SDG agenda to the grassroots, the Ministry of Panchayati Raj has adopted SDGs into nine broad themes. This approach enables Panchayats to prepare development plans under a 'whole of government and whole of society' framework.

Since 2018, Self-Help Groups (SHGs) have

also been engaged in preparing Village Prosperity and Resilience Plans (VPRPs), further supporting holistic development and resilience at the village level.

#### People's Plan Campaign: Sabki Yojana,

To enhance people's participation in pre-paring Panchayat Development Plans, the People's Plan Campaign (PPC) was launched on 2nd October 2018 under the theme "Sabki Yojana, Sabka Vikas". Encouraged by the positive outcomes of Gram Sabhas, stakeholder engagement, and participatory planning, the Campaign has since been conducted annually in a mission mode with active involvement of Elected Representatives, frontline workers, Self Help Groups (SHGs), Community-Based Organizations (CBOs), and other local stakeholders.

#### Objective

The People's Plan Campaign is guided by the objective of preparing participatory, comprehensive and convergent development plans - GPDPs, BPDPs and DPDPs at Gram Panchayat, Intermediate (Block) Panchayat and District Panchayat levels across the country in a time-bound manner. Structured Gram Sabha meetings are organized with active participation of community members and presentations by frontline workers of all related line departments. The campaign seeks to achieve effective localization of SDGs by integrating the nine thematic approaches of LSDGs into Panchayat Development Plans and by incorporating Village Prosperity and Resilience Plans (VPRPs) prepared by Self-Help Group federations. It also promotes gender-responsive governance through the active involvement of Women Elected Representatives (WERs), SHCs and women community members in the planning process. Further, transparency and accountability are strengthened by conducting public information campaigns and disclosing details of schemes, finances and programmes in Gram Panchayat offices and

on public information boards.

#### People's Plan Campaign 2025–26

The Ministry of Panchayati Raj launched the People's Plan Campaign (PPC) 2025–26: "Sabki Yojana, Sabka Vikas" Abhiyaan on 2nd October 2025 across all States and Union Territories, thereby initiating the nationwide process for preparing Panchayat Development Plans (PDPs) for the Financial Year 2026-27.

In the run-up to the launch, extensive preparations were carried out. The Ministry had virtual interactions with State Governments, Union Territories, and State Institutes of Rural Development & Panchayati Raj (SIRD&PRs), to finalize strategies and ensure smooth coordination. To promote convergence and grassroots-level participation, the Ministry is working along with 20 Line Ministries/Departments of the Government of India to direct their respective State/UT counterparts to actively participate in the campaign, particularly through special Gram Sabha meetings. Furthermore, States and UTs has been instructed to appoint nodal officers, train facilitators, finalize schedules for Gram Sabhas, and prominently display Public Information Boards. The Special Gram Sabhas convened on 2nd October 2025 marked the formal launch of the campaign across the country.

The PPC 2025-26 is designed to strengthen participatory, transparent, and accountable local governance. Under this initiative, Gram Sabhas are tasked with reviewing earlier Gram Panchayat Development Plans (GPDPs) using digital platforms such as eGramSwaraj, Meri Panchayat App, and Panchayat NIRNAY. They are expected to assess progress on works, identify delays, and prioritize unfinished projects, especially those linked with unspent Central Finance Commission grants. The planning process will be guided by the Panchayat Advancement Index (PAI), while tools like SabhaSaar will be encouraged to make deliberations more effective. Efforts will also focus on improving Panchayats' Own Source Revenue (OSR) and ensuring deeper community involvement in decision-making.

A special emphasis of the campaign is on tribal empowerment, with focused activities under the Adi Karmayogi Abhiyaan. By ensuring the active participation of Panchayat representatives, line department officials, community members, Self Help Groups (SHGs), and frontline workers, the campaign aims to further deepen transparency, convergence, and accountability in grassroots planning. It is expected to pave the way for stronger service delivery mechanisms, inclusive development, and improved outcomes for rural communities across India.

#### Achievement

Since its launch in 2018, the People's Plan Campaign has helped Panchayats prepare evidence-based and inclusive development plans that reflect local needs while aligning with national priorities.

As per data available on the eGramSwaraj Portal, more than 18.13 lakh Panchayat Development Plans have been uploaded from 2019-20 to 2025-26 (as on 29th July 2025). These include:

Over 17.73 lakh Gram Panchayat Development Plans (GPDPs)

35,755 Block Panchayat Development

3,469 District Panchayat Development Plans (DPDPs)

### How does solitude bolster imagination, unlock ingenuity, and foster inspiration?

sychologists Christopher Long and James Averill once described the longstanding connection between solitude and creativity as "so ubiquitous that it has become almost a cliché: the scientist alone in a laboratory, the writer in a cabin in the woods, or the painter in a bare studio". But how does solitude bolster imagination, unlock ingenuity, and foster inspiration? According to psychological research, here are five ways that solitude really can spark creativity.

1. The Shower Effect

If you do your best thinking in the shower, you are not alone. The most common locations where people have sudden insights ("aha!" moments) include in the shower, during transport, and while exercising. Although you may not always engage in these activities alone, these experiences all typically offer a break from the constant information stream we are exposed to when socially engaging with others. Solitude offers a respite from this input and lets our mind start to wander. Such free thinking seems to stimulate the areas of our brain known as the default mode network, which fosters cognitive flexibility (i.e., thinking outside the box). In short, if you are stuck on something, let your ideas incubate by taking a break (or a shower or a drive or a walk)!

2. Look Forward to Daydreams A meandering mind can be a gateway to creativity. But sometimes our thoughts can wander off to bad places - and ruminating



(repeatedly thinking negative thoughts) can make us feel sad and anxious. To help with this, try to look forward instead of looking back. Florence Ruby and colleagues found that mind wandering about the past and focused on others was more likely to put people in a worse mood. In contrast, daydreaming about the future and with a focus on oneself was found to increase positive mood. Letting your mind wander when you are alone can open up new avenues of thoughts and help you solve problems. However, it is also important to be mindful of your mind wandering. For some people, daydreams can morph into daymares.

3. Playing the Right Solo Are there specific things we can do to get our creative juices flowing when alone?

According to research by Benjamin Baird, you need to find the "sweet spot" between boring and demanding. Participants were asked to list unusual uses for common objects as a test of their creativity, but under different conditions. The results were striking. People who took a break and engaged in a mildly demanding task (labelling odd vs. even numbers on a screen) produced more new ideas than those who engaged in more demanding tasks, did nothing during the break, or who did not have a break at all. Doing something – but something that is not overly demanding – appears to be most helpful in terms of allowing the brain to solve problems. Why? Because during these 'not too demanding' tasks, your mind is free to wander, and it goes places that basically

help you connect the dots in your head.

4. Let it Flow, Let it Flow, Let it Flow Another phenomenon also linked with creativity is flow. This influential concept was conceived of by psychologist Mihalyi Csikszentmihalyi as an "optimal experience" (i.e., being in the zone). Flow is a state of being deeply absorbed in a specific activity, feeling confident and un-self-conscious, and losing track of yourself and your surroundings. Most often described among elite athletes, states of flow have also been documented among writers, artists, outdoor adventures, and gamers. Although some have argued that solitude is necessary to achieve true states of flow, such experiences do also occur in social contexts. However, personality seems to matter here. Liu and Csikszentmihalyi found that participants who were more extroverted reported more frequent flow during social activities, whereas introverts were more likely to experience flow while in solitude. Nevertheless, Csikszentmihalyi noted many other benefits of solitude and offered this advice near the end of this paper, "interacting with others can be a good source of an enjoyable life, but one has to learn to enjoy solitude as well to complete some of life tasks that demand absolute concentration."

5. Getting Your Balance Although solitude provides unique opportunities, we cannot discount the roles of collaboration and discussion in the creative process. As with many things in life, the best option is a balanced one. Runa Korde and Paul

Paulus found that people who alternated between solitary and groups brainstorming sessions generated more new ideas than those who either just brainstormed alone or just brainstormed with a group. In some phases of the creative process, periods of solitude will be helpful to fully develop our ideas, engage in intense research, or allow for mind wandering to encourage new avenues of thinking. However, it is also important to be exposed to others' perspectives, bounce ideas off others, and seek their feedback. There is a good lesson here. Sociable people tend to seek out more collaborative settings, whereas those who prefer being alone retreat to solitude to pursue creative endeavors. However, it seems as though both contexts provide unique benefits for this process.

So, what can we take away from all of this? Solitude is a great incubator for ideas. To help get unstuck with a problem, take a break and spend some time alone. Choose a solo activity that will let your mind wander; ideally, something that is just the right amount between 'not too boring' and 'not too engaging'. And to further help with the creative process, alternate between episodes of being alone and time with others. This "balanced" approach will not only spark creativity, but also bolster your general well-being.

# Health sector directly linked to well-being of people: Sakeena

Reviews progress on recruitments in key departments

bottlenecks be addressed on priority to ensure timely

"The health sector is directly linked to the well-being of our people. Timely filling of medi-cal, paramedical, and support staff positions is essential for improving patient care and reducing the workload on existing employees," Minister Sakeena maintained.

The Minister also took stock of vacancies in the Education department, stressing that schools, especially in rural and far-flung areas, must not suffer due to staff shortages. She called for a transparent and meritbased recruitment process to ensure deserving candidates are given fair opportunities.

The Minister urged the concerned authorities to maintain coordination between recruiting agencies and departments

to avoid unnecessary delays. She reiterated her commitment to ensuring that both the health and education sectors receive focused attention, noting that these are the pillars of a pro-

gressive and inclusive society.

"The youth of Jammu and Kashmir are our strength. Creating employment opportunities through timely and transparent recruitment will not only strengthen institutions but also restore faith in governance," the Minister stated.

While reviewing status of recruitments in Social Welfare department, Sakeena Itoo underscored the need for regular monitoring and inter-departmental coordination to avoid procedural delays. She called upon officials to submit detailed status reports on vacancies, selection progress, and appointment timelines to ensure continuous oversight.

# Nanda reviews progress of development works in Forest sector

SRINAGAR, OCTOBER Commissioner Secretary, Forest, and Environment, Nanda, Wednesday chaired a high-level meeting to review the progress on ongoing development works being executed across the Union Territory in the Forest and allied sectors.

The meeting focused on nitiatives under various schemes including CAPEX, Compensatory Afforestation Fund Management and Planning Authority (CAMPA), Centrally Sponsored Schemes (CSS), and Green India Mission (GIM)

During the detailed review many issues were discussed threadbare including Districtwise physical and financial achievements for the year 2024-25 and 2025-26 under various Centrally sponsored schemes. Also discussion was held on the funds received, expenditure incurred, utilization certificates submitted under CSSs/CSs (2024-25). She also reviewed the Annual Plan of Operations (APOs) approved and funds received for the year 2025-26 as well as work-wise physical and financial prog-ress under UT CAPEX budget (2025-26), Updated progress in respect of budget announcements for the year 2025-26 were also discussed. Latest status of approved projects under Special Assistance to States for



Capital Investment (SASCI) was also reviewed.

Commissioner Secretary exhorted officers to ensure that all schemes, especially the Centrally Sponsored Schemes, are implemented in letter and spirit. She laid stress on intensifying plantation drives and expediting financial bookings especially under CAPEX Budget throughout the

districts. Commissioner Secretary issued strict directives for the timely execution and quality delivery of all departmental projects. She directed various departments under the Forest umbrella to ensure a minimum of 70% of all planned works, including infrastructure upgrades, afforestation and other conservation efforts are completed by December 2025.

The Commissioner Secretary directed that winter plantation activities must commence immediately in temperate zones

of UT. She underlined that this initiative will cover degraded forest areas, urban green spaces and community lands.

Implementing agencies were urged to immediately expedite the installation of Boundary Pillars (BPs) for forest land demarcation as well as in wetlands across UT, to ensure legal protection and clarity of forest boundaries

Recognizing the potential of Ecotourism in promoting sustainable livelihoods, the Commissioner Secretary instructed that all pending Nagar Van (Urban Forest) projects must be finalized and made operational by December 2025. She added that these projects aim to create accessible green spaces in urban areas, fostering community engagement and biodiversity conservation.

The Commissioner Secretary also underscored the need for enhanced inter-departcoordination and

proactive field-level execution. Departments were also encouraged to maintain transparency, adopt modern monitoring tools, and actively engage local communities in plantation and conservation efforts.

The Commissioner Secretary reiterated the government's commitment to ecological preservation, sustainable de-velopment, and climate resilience through community-

driven forestry initiatives. The Minister was speaking at India Mobile Congress and Round table conference of the State IT Ministers, which was inaugurated by Union Minister for Information Technology, Jyotiradtiya Scindia

Minister Sharma said that ongoing initiatives are not just about expanding telecom infrastructure but about building an inclusive, connected,

and secure Jammu & Kashmir. "Digital connectivity today is not a privilege but a necessity, it carries education to a student in Kupwara, healthcare to a patient in Poonch and opportunities to an artisan in Anantnag,' the minister maintained.

Highlighting the digital transformation under the Amended BharatNet Project, the Minister informed that high-speed Optical Fibre Cable is being laid to connect 4,299 Gram Panchayats and 2,574 villages.

He said BSNL will extend Fiber-to-the-Home (FTTH) connections to 2,234 Government Schools and 1,138 Public Health Centres across rural areas, enabling e-learning and telemedicine facilities.

Satish Sharma said that new mobile towers are also being established in remote and border areas to eliminate digital

isolation. The Minister added that preparations for the 5G rollout in key urban centres are underway, which will accelerate entrepreneurship, innovation, and smart governance.

Reaffirming Government's commitment to digital safety, Satish Sharma said, "As we connect every home, we must also secure every byte of data and every citizen's trust." He informed that Jammu & Kashmir's Cyber Security Policy 2022, developed in coordination with MeitY and MHA, provides a strong frame-

work for cyber resilience. Referring to initiatives during 2024, the minister said that the Cyber Police recovered over

4.7 crore for victims of online fraud through the National Cyber Crime Reporting Port while hundreds of cases were successfully resolved.

precise and devastating blows deep inside enemy territory vindicates our faith in homegrown capabilities," he said.

He accused Omar Abdullah's family of having a tradition of sidelining others for personal advancement.

"You were born into Farooq Abdullah's family and went to Mumbai to study at the Chief Minister's residence there. You returned and shoved aside a long list of leaders who had dedicated their lives to the National Conference. They were pushed aside, and you were crowned. This is how you trample others to build your career. You didn't work hard, nor did you struggle. The only criterion was that you were the prince of the Abdullah family and the son of Farooq Abdullah," Sharma

He questioned whether Omar Abdullah's demand for statehood was intended to harm innocent Kashmiri civilians.

He accused Abdullah of harming civilians

during his tenure as Chief Minister. "I want to remind Kashmiris that if we turn back the pages of history, we will find many fabricated stories told in the name of terrorism. Many people would narrate how they were innocent and killed during Omar Abdullah's tenure under the guise of counter-terrorism. Do you want statehood to kill innocent Kashmiris? You didn't eliminate terrorists-you targeted civilians, enforced shutdowns, and closed

schools," Sharma said. He said that Omar Abdullah harmed civilians and failed to protect people during his rule as Chief Minister of the erstwhile state of Jammu and Kashmir.

"Wasn't statehood with National Conference governments between 2008 to 2014 and 1996 to 2008? Wasn't it with your governments that were in power till 1989 and 1982?" Sharma

He further said that Kashmiris do not want a statehood where political rivals of the National Conference are booked under the Public Safety Act (PSA), and parents live in fear for the safety of their school-going children.

Coming down heavily on the National Conference, Sharma accused the party of introducing the PSA and pellet guns.

"You were the ones who introduced pellet guns; you were the ones who imposed the PSA. If we compare the figures, the highest number of innocent civilians were killed during your tenure," he said.

Sharma praised the Government of India for eliminating terrorism from Jammu and Kashmir without harming civilians.

"Nobody can raise a finger at the Ministry of Home Affairs for harming civilians. The biggest achievement of the MHA is that not a single local youth joined terrorism. It shows that the youth of Kashmir have accepted the policies of the Government of India and want to voice their concerns within a democratic setup," he

He accused Omar Abdullah of misleading and hoodwinking the public in the name of statehood to cover up governance failures.

"If you listen to Omar Abdullah's

speeches-whether on August 15, at public functions, or in institutions-he consistently tries to hoodwink the people of Jammu and Kashmir by claiming they lack power," Sharma added.

Responding to the BJP's criticism of the NC's manifesto, which includes promises of free electricity, 12 gas cylinders, and employment opportunities, he said, "Did the unemployed youth take birth in the last one year? This unemployment crisis has been created over the past 11 years by the BJP, PDP, and six years of LG administration.'

several road reconstruction projects under schemes like PMGSY (Pradhan Mantri Gram Sadak Yojana) and R&B (Roads and Buildings Department), many stretches have been left incomplete after excavation. As a result, large rocks and debris continue to accumulate on these unfinished roads, making even light rainfall enough to block vehicular movement.

Residents told KNO that the roads were already in poor shape before the rains. Now, with contractors and departments abandoning work midway, the situation has turned alarming, they said.

The recent downpour has washed away entire patches of link roads, pushing them to the verge of collapse. Frequent landslides and rockfalls have become a daily occurrence along roads. In several areas, the ground beneath the roads has begun to slip, leaving cracks and deep fissures.

"The condition of the roads is miserable. Every time it rains, we get trapped. Vehicles can't move, and landslides continue to block the road. It feels like we are cut off from the rest of the world," said a resident from Thaki. Even on dry days, danger looms large.

On Wednesday morning, a tragic accident occurred when a Bolero vehicle travelling from Bangla Bharat to Doda was hit by a falling rock near Baswal.

Witnesses said the boulder came crashing down from the hillside, crushing the vehicle. As locals rushed to rescue the injured, smaller rocks and soil began tumbling down, injuring several others. The continuous sliding of debris made the rescue operation perilous.

Officials confirm the crisis.

A senior PWD Officer told KNO that the recent rains have caused extensive damage to link roads, leaving them on the edge of destruction. "Our priority is to restore connectivity," he said. "But we need funds for permanent repairs. A proposal has already been sent to higher authorities for approval, and we are awaiting their response. Once funds are sanctioned, restoration work will begin immedi-

beams. Some didn't make it," he said. Ahmad recalled that as a child, he thought it was the end of the world, as everything around him shook violently and buildings collapsed to the ground.

Almost 1,700 families in Karnah were forced into temporary shelters after the quake, surviving without electricity, water, or communication for days. Roads were blocked by landslides, isolating the valley. (KNO)

# No power on earth can stop India from becoming developed nation by 2047: Goyal

Mumbai, Oct 08: Commerce and Industry Minister Piyush Goyal on Wednesday said no power on earth can stop India from becoming a developed nation by 2047, with the government taking a series of initiatives to promote the domestic economy, build infrastructure and expand international trade.

Speaking at the 6th edition of the Global Fintech Fest (GFF) here, the minister also said today, the world looks upon India with trust and confidence as the country guarantees high-quality talent, skill, goods and services, and a commitment to timely delivery.

From being a participant to now being a principal architect of the fintech world, India leads global initiatives, he added.

"I think no power on earth can stop India from becoming a developed and prosperous nation when we celebrate 100 years of independence. And this cannot happen without the adoption of technology, without the digital world keeping abreast with what is happening in the world, without our trade partnerships increasing across the world. And



all of this rests on India being looked upon as a trusted partner of the world," the minister said.

Goyal further said when India aspires to be a USD 30, 32 or 35 trillion economy by 2047, "our friends from the finance world can quickly do the math and you will see that achieving this is very much in the realm of possibility... something that we are all collectively committed to achieve".

The government, on its part, he said, is taking massive steps to promote the domestic economy built upon both the pillars of infrastructure development and consumption-led growth.

Government is committed to

expanding international trade, so much so that despite all the global turbulence that we read about, we see, every single day, we hear about it across the world, he said.

He added the country today is at an inflexion point, with strong macroeconomic fundamentals, expanding trade relations with developed countries around the world, focusing on empowering customers with high-quality, and low taxes. On India's export performance, he said the growth in outward shipments (goods and services combined) is estimated at 4-5 per cent.

#### Poll code applicable to Central govt too for policy decisions on Bihar: EC

New Delhi, Oct 08: The Election Commission on Wednesday said the provisions of model code of conduct are also applicable to the Central government as far as announcements and policy decisions on Bihar are concerned

The poll code came into force immediately after the Election Commission (EC) announced the schedule for the Assembly elections in Bihar on Monday.

The polls will be held on November 6 and 11, and the counting of votes will be taken up on November 14.

In a statement issued here, the EC said, "The MCC shall also be applicable to the Central government so far as announcements/policy decisions for Bihar are concerned." The poll authority also said that privacy of citizens must be respected, with no demonstrations or picketing outside private residences.

"Land, buildings, or walls shall not be used for flags, banners or posters without the owner's consent," it said.

The EC has also issued directives to the Bihar chief secretary related to the removal of defacement from government, public and private property; misuse of official vehicles or government accommodation by any political party, candidate or any other person connected with the elections; and ban on the issuance of advertisements at the cost of the public exchequer.

#### SC to hear issues related to manufacturing, sale of 'green' crackers on Oct 10


New Delhi, Oct 08: The Supreme Court on Wednesday deferred to October 10 the hearing on issues related to manufacturing and sale of 'green' crackers' in Delhi and the national capital region.

The top court on September 26 permitted certified manufacturers to produce 'green' crackers with a condition that they will not sell them in prohibited Delhi-NCR without its approval.

It asked the Centre to take a fresh look at the absolute ban on the manufacture of firecrackers in Delhi-NCR.

It also directed the Ministry of Environment, Forests and Climate Change to consult all stakeholders, including the Delhi government, manufacturers, and sellers, before arriving at a final decision.

On Wednesday, a bench comprising Chief Justice B R Gavai and Justice K Vinod Chandran was to consider the issues including the report of the Centre. The law officer, representing



the Centre, sought an adjournment which was allowed. The court fixed the issue for consideration on Friday after senior advocate Balbir Singh. appearing for few manufacturers of green crackers, said that it be heard before

Earlier, the bench had ordered: "In the meantime, we permit the manufacturers who are having the certification of green crackers as certified by NEERI as well as PESO to manufacture. However, this will be ing by the manufacturers to this court that until further orders passed by this court, they would not sell any of their crackers in the prohibited areas."

The bench issued the conditional order permitting certified manufacturers to produce 'green' crackers till the plea is heard again on October 8. The top court was hearing a batch of petitions filed by firecracker manufacturers seeking relaxation of ban and permission to sell 'green' crackers.

### From addiction to kidney failure: what parents should know about cough syrup risks

New Delhi, Oct 08: At least 20 children have died and five others are battling kidney failure in Madhya Pradesh, after consuming contaminated Coldrif cough syrup manufactured by Sresan Pharmaceuticals, Tamil Nadu. The syrup in guestion was found to contain dangerously high levels of diethylene glycol (DEG), a toxic chemical that is commonly used in antifreeze and industrial solvents, which is lethal when ingested.

Of the children affected, most were from Chhindwara district and developed symptoms such as vomitshortly after. According to the PTI report, the central government, through the Directorate General of Health services, issued an advisory asking all the states and Union Territories NOT to prescribe cough and cold medications to children below the age of two years.The advisory emerged amid reports of child deaths in Madhya Pradesh and Rajasthan allegedly linked to contaminated cough syrups.

The deadly toxin: Diethylene Glycol

According to the



National Institutes of Health, Diethylene Glycol is a colourless, odourless fluid that primarily was used in industrial purposes. It is not meant for human consumption. As to what the NIH says, Diethylene Glycol is a colourless liquid, denser than water. Contact may slightly irritate skin, eyes and mucous membranes. May be slightly toxic by ingestion. Used to make other chemicals.

severe neurological symptoms such as confusion and seizures and metabolic acidosis (where the body's acid-base balance is disrupted), and can ultimately be fatal if left untreated.

Usually, its symptoms appear within 24-72 hours of ingestion, emphasising on the narrow window of medical intervention.

Symptoms of diethylene glycol poisoning

The first phase is acute gastrointestinal toxicity and consists of nausea, vomiting, abdominal pain, and diarrhea.

Second phase: Renal or kidney failure, fluid retention, swelling, back pain, Oliguria (reduced urine output) or anuria (no urine output), Fluid retention or swelling (edema) Historical precedents

Unfortunately, this is not the first time diethylene glycol contamination has caused mass poisoning: Mumbai, India, 1986:

Fourteen patients at J.J. Hospital died due to acute renal failure caused by contaminated glycerol with 90% DEG. The tragedy exposed failures in drug procurement and safety monitoring.

Uzbekistan, 2022: Eighten children died after consuming cough syrup contaminated with DEG and ethylene glycol, produced by an Indian pharmaceutical company.

The current crisis in Madhva Pradesh

The contaminated Coldrif syrup, batch SR-13 with expiry in April 2027, was found to contain approximately 48.6% diethylene glycol. After the first death was reported on September 2, the toll has tragically climbed to 20 children, with multiple others suffering from kidney failure.

#### Skoda evaluates EV launch in India with local supplier base by 2027-28



New Delhi, Oct 08: Skoda Auto India, part of the Volkswagen group, is evaluating the launch of electric car in the country with localised supplier base, an official said on Wednesday. The company plans to enter

the fast-growing Indian electric car market by 2027-28, according to the official. Skoda has a globa portfolio of electric cars positioned in the premium segment. "We are evaluating to launch the

electric car in India during 2027-28 after setting up a localised supplier base. By this time, we will get the time to set up the supplier base, and the charging infrastructure would also develop", brand director of Skoda Auto India Ashis Gupta told reporters here.

He said that the electric car industry comprises 10 per cent to 12 per cent of the total segment and is growing very fast. By 2027-28, the right policy framework for electric cars would also be in place, Gupta said. With four models in India, three sedans and one in the small SUV segment, Skoda Auto India has a market share of 1.7 per cent in terms of volume, Gupta said.

During the period January to September 2025, the company sold 53,000 units of the four models, he said. "The small SUV model helped Skoda Auto India to raise the market share substantially", he said. The four models offered in India

re Kyladi Slavia, Kushad and Kodi ac. Gupta said the lowering of the GST has brought in new customers. While the small SUV attracts a GST of 18 per cent and 40 per cent for the sedans. He said that the company presently has 315 customer touchpoints across the country. Plans are there to raise them to 350 by 2025, with focus on the Tier 2 and Tier 3 cities, Gupta said.

With its production base at Pune, the company exports its products to Middle East and Africa.

Gupta said the aim of the company is to maintain the market share and retain the number seven position as a car manufacturing company in the country.

# 'Ayurvedic cough syrups, home remedies are safe, effective for children'

New Delhi, Oct 08: Amid concerns regarding the quality of cough syrups being ad-ministered to children, experts say Ayurvedic remedies are a completely safe and effective alternative. Dr R P Parasher, the

national president of All India Doctors Association of Indian System, on Tuesday said that Ayurvedic cough syrups, herbs and home remedies can be given to children over two years of age without fear.

The remarks amid the recent deaths of several children in Madhya Pradesh, allegedly due to consumption of contaminated cough syrup.

On October 3, the Director General of Health Services (DGHS) issued an advisory to all states restricting prescription of cough and cold medications to children aged below two years.

The advisory mentioned that cough syrups are generally not recommended for children aged below five years. For those aged above five years, any administration



the shortest effective duration and avoiding multiple drugs combinations, it said. The advisory also

reiterated judicious and rational prescription and dispensation of cough syrups for children. Dr Parasher said that

in case of cough, cold or chills in children aged under six months. their chest should be massaged with slightly warmed ghee or oil.

"Mothers of such children should refrain from consuming foods that are cool in nature and increase 'kapha' and 'dosha' in the body. Children aged above six months could be fed milk boiled with basil, ginger, cloves, black pepper and dates, and then filtered," he said.

This milk will boost their immunity and provide immediate relief from coughs and colds, he said.

Ayurvedic cough syrups are made from herbs such as basil, amaranth, licorice, kakadsingi bharangi, pushkarmool, baheda, mint, long pepper, black pepper, cinnamon, bay leaf and talispatra. These have no side effects on children, Dr Parasher explained.

Additionally, children can be given Sitopaladi powder and Talishadi powder mixed with honey, or prescribed medicines like Vasavaleha and Agastya Haritaki. All these medicines are completely safe and effective for children, he added.

# Shiv Sena symbol row: SC fixes Nov 12 for hearing Uddhav faction's plea

New Delhi, Oct 08: The Supreme Court on Wednesday fixed November 12 for hearing a plea of the Uddhav Thackeray-led faction of the Shiv Sena against the Maharashtra Assembly speaker's decision to allot the 'bow and arrow' party symbol to the Eknath Shinde-led faction.

A bench of Justices Surya Kant and Joymalya Bagchi said the hearing on the plea will start on November 12 and if need arises, it would continue on November 13. Senior advocate Kapil

Sibal, appearing for Shiv Sena-UBT, said that local body elections are likely to be held in January next year and therefore there is a sense of urgency in the matter. He said the court may

hear the matter finally before the local body polls. "We will hear all the parties on November 12

and if need arises, we can



continue the hearing on November 13," the bench said. Senior advocates Mukul Rohatgi and Neeraj Kishan Kaul appeared for the Shinde faction.

On July 14, the top court fixed the matter for final hearing, saying the issue had been pending for long and the uncertainty cannot be allowed to continue.

The Uddhay faction earlier said the speaker's decision to hand over the party symbol to the opposite faction in 2023 based on legislative majority was



bench verdict of the top court. On May 7, the top court asked the Uddhav Thackeray-led faction to concentrate on the local body polls after the party sought an urgent hearing on its plea against the speak-

er's decision. In January 2024, Speaker Rahul Narwekar rejected Shiv Sena-UBT's plea to disqualify 16 MLAs of the ruling camp, includ-

ing Shinde. # Over 850 hikers, guides stranded in Mt Everest blizzard rescued

Beijing, Oct 08: Over 850 hikers, guides and porters who were stranded for three days in a severe blizzard on the Tibetan slopes of Mount Everest have been evacuated by hundreds of villagers and rescue teams, according to Chinese official media.

All the hikers and local service personnel trapped by heavy snowfall in Dingri County at Xigaze City in southwest Tibet Autonomous Region have reached safety, the local government said late Tuesday night.

A total of 580 hikers and over 300 personnel, including local guides and yak herders, have safely reached Qudeng Township and nearby areas, where officials are arranging their return journeys, the state-run Xinhua news agency reported.

Xinhua had earlier reported on Monday that one hiker was killed in the snowstorm, which caught more than 1,000 holiday trekkers off guard on the Tibetan side of



Mount Everest. Thousands of holidaymakers had flocked to Tibet during the eight-day holiday in China from October 1 to celebrate the National Day and Mid-Autumn Festival. The blizzard, which began

on Saturday, brought heavy snow that crushed tents and buried trails, making descent extremely difficult for the hikers, most of whom were Chinese nationals. News of the rescue efforts reached

the mainland slowly due to the remoteness of the area, causing anxiety among the relatives of the stranded trekkers. State-run broadcaster CCTV reported on Wednesday that a dozen more hikers, assisted by rescue personnel from Tingri county, had reached a rendezvous point on their descent.

On Sunday, Shigatse city officials announced on the social media platform, Weibo, that Tingri county authorities had mobilised teams to contact and help stranded trekkers at the base camp to ensure their safety. October, typically known for mild temperatures and clear skies, is considered the peak climbing season for Mount Everest and the surrounding regions. However, the sudden blizzard caught even experienced mountaineers off guard, local media said.

The National Business Daily quoted climbers as saying the blizzard began

on Friday evening and continued through Saturday. According to the media

outlet based in the southwestern city of Chengdu, climbers' tents were crushed and snow accumulated to a depth of over a metre at the base camp, cutting off all descent routes. The trekkers' camps were in the remote Gama Valley, which is home to the largest and one of the best-preserved primeval forests in the Everest area, located between Tingri and Dinggye counties. The route to the eastern side of Mount Everest from Gama Valley involves a 40-km trek and relies solely on yaks and mules for supplies, taking about 10 days for a round trip.

While the northern slope of Everest, accessible by road, is the more popular hiking route, another commercial route lies on the southern slope in Nepal.

Extreme weather has also battered Nepal since last week, with 60 people killed in landslides and flash floods triggered by torrential rain,

Vatican City, Oct 08: Pope Leo told US bishops visiting him at the Vatican on Wednesday that they should firmly address how immigrants are being treated by President Donald Trump's hardline policies, attendees said, in the latest push by the pontiff on the issue.

Leo, the first US pope, was handed dozens of letters from immigrants describing their fears of deportation under the Trump administration's policies during the meeting, which included bishops and social workers from the US-Mexico border.

"Our Holy Father ... is very personally concerned about these matters," El

The pope questioned on September 30 whether the Trump administration's anti-immigration policies were in line with the Catholic Church's pro-life teachings, in comments that drew heated backlash from some prominent conservative Catholics.

The White House has said Trump was elected based on his many promises, including to deport criminal illegal aliens.

One of the letters given to the pope on Wednesday, shared with Reuters, described a family with two members who did not have legal permission to stay in the US and who were afraid to leave the house for fear of deportation.

"I believe the Pope should speak out openly against the raids and the unfair treatment the community is experiencing," read the letter, written in Spanish.

#### EU 'must respond' to Russia's 'hybrid warfare': Ursula von der Leyen

Strasbourg, Oct 08: EU chief Ursula von der Leyen on Wednesday said Europe must ramp up its defenses to deter Russia's "hybrid warfare," after a catalogue of air incursions, cyberattacks and damage to undersea cables. "These incidents are calculated to linger in the twilight of deniability. This is not random harassment. It is a coherent and escalating campaign," the European Commission head said in a speech to EU lawmakers.

"Two incidents are coincidence, but three, five, 10 — this is a deliberate and targeted grey zone campaign against Europe, and Europe must respond," she said.

EU countries Poland, Estonia and Romania have recently been rattled by Russian air incursions, while unidentified drones have been spotted in Denmark, Germany and Belgium.

European countries have already increased defense spending to post-Cold War highs in the face of Moscow's war in Ukraine and doubts over US support under President Donald Trump.

Now the EU is seeking to hammer out plans for joint projects that could be built by the 27-nation bloc — including a "wall" of antidrone defenses. "We must not only react. We must deter because if we



hesitate to act, the grey zone will only expand," von der Leyen said.
"The founding mission of the

European Union is to preserve peace, and today that means having the capacity to deter aggression and provocation." EU leaders will seek at a summit

in Brussels later this month to agree on a "road map" aimed at getting the bloc ready to ward off threats from Russia in the coming years.

"This will not only set common objectives, but also very concrete milestones and timelines on the way to 2030 because we all know only what gets measured gets really done," von der Leyen said.

The commission president insisted that tackling "Russia's hybrid war" requires "a completely new mindset for all of us." "The choice before us is very simple. We either can shy away and watch Russian threats escalate, or we meet them with unity, deterrence and resolve," von der Leyen said.

Perth, Oct 08: Australia captain Pat Cummins is expected to miss the Ashes opener in Perth with a possibility that he may miss the entire Test series against England as the scans revealed his back stress problem had not yet healed.

Cummins had been battling back soreness since featuring during Australia's tour of the Caribbean in July and recent scans confirmed a lumbar bone stress to the affected area. According to Sydney Morning Herald report, Cummins is no chance for the opener in Perth, starting on November 21, and may even miss all five Tests, leaving Steve Smith as the likely stand-in skipper to face England.

#### **Indian ODI squad to leave for** Aus in two batches on Oct 15

New Delhi, Oct 08: The Indian ODI squad will depart for Australia in two separate batches on October 15 from the national capital with logistics and ticket availability determining the final travel schedule.

India will play a three-match ODI series followed by a fivematch T20I affair Down Under. According to sources in the BCCI,

one group of players will leave in the morning while the second batch is likely to fly out later in the evening, depending on the availability of business class tickets for the long-haul flight. Former captains Rohit Sharma and Virat Kohli, along with newly appointed vice-captain Shreyas Iyer, are expected to join the rest of the Test squad members in New Delhi ahead of the team's departure.

"Virat and Rohit will touch down in the capital either on the day of departure or a day prior," a source in the know told PTI.

The team is scheduled to fly to Perth, where the first ODI against Australia will be played on October 19. If the ongoing domestic or international assignments conclude earlier than expected, players featuring in the ODI squad could be given a short break to visit



their respective homes before regrouping in Delhi. India are set to face West Indies in the second and final Test here from October 10-14.

In a significant development, Shubman Gill has been named captain of the ODI side, taking over from Rohit Sharma. Despite mounting speculation regarding their long-term ODI futures, both Rohit and Kohli are believed to have expressed their desire to continue until the 2027 ODI World Cup, even though India will play relatively few 50-over games in the leadup to the marquee event.

#### United Nations panel slams Sri Lanka's slow progress on enforced disappearances

Colombo, Oct 08: A United Nations panel has expressed serious concern over Sri Lanka's lack of progress in addressing cases of enforced disappearances, including the performance of the Office on Missing Persons (OMP), which has traced only a fraction of the nearly 17,000 cases it has received. In a report issued on Tuesday (October 7, 2025), the United Nations Committee on Enforced Disappearances (UNCED) noted the "high level of impunity reflected in the lack of progress in the investigation and prosecution of alleged enforced disappearances."

The UNCED report comes a day after the UN Human Rights Council (UNHRC) on Monday (October 6, 2025) adopted a resolution extending the mandate of the Office of the High Commissioner for Human Rights (OHCHR) on Sri Lanka for two more years. The report also pointed out that of the 16,966 cases received by the OMP, only 23 had been traced so far, raising questions about the effectiveness of the institution established to address long-standing demands for truth and justice by families of the disappeared.
