High-level security meet in Delhi

Modi Govt committed to make J&K terrorism-free: HM Amit Shah

Vows to cripple terror ecosystem, says security forces have full freedom to crush those threatening UT's peace & security

New Delhi, Oct 09: Reaffirming the PM Modi led government's resolve to achieve a terrorismfree Jammu and Kashmir, Union Home Minister Amit Shah on Thursday asserted that security forces will continue to have full operational freedom to eliminate any threat to peace and stability in the region.

Shah, according to the news agency—Kashmir News Observer, chaired a high-level meeting in New Delhi to review the security situation in Jammu and Kashmir.

After the meeting ended the Union Home Minister wrote on X: "Reviewed the security of



Jammu and Kashmir along with the Lt. Governor and other senior officials. We are committed to cripple the terror ecosystem

"Our security forces will continue to have full freedom to crush any attempt to threaten

peace and security in the region. Instructed to further intensify alertness and synergy to accelerate Modi Ji's vision

of a terror-free Jammu and Kashmir," he wrote further.

The security review meeting was attended by J&K Lieutenant Governor Manoj Sinha; the Union Home Secretary; the Director, Intelligence Bureau; the Chief of Army Staff; the J&K Chief Secretary and Director General of Police of Jammu and Kashmir; the Directors General of the Central Armed Police Forces (CAPFs); and senior officers from the Government of India, the Army, and the Jammu and Kashmir administration.

Blitz over private member bills in J&K faces reality check Passage remains elusive; only 3

such bills passed in past 45 years

Srinagar, Oct 09: As political parties in Jammu & Kashmir are blitzing on private member bills submitted by them in the Legislative Assembly, the reality remains that such bills rarely see the light of day.


A Private Member's Bill is a legislative proposal introduced by a member of the Legislative Assembly who is not a minister, and belongs to either the treasury benches or the opposition.

Records available news agency—Kashmir News Observer (KNO) reveal that not a single private member has been passed in Parliament since past 55 years.

According to details, only 14 private member Bills have ever been passed by the Parliament and received Presidential assent, with the last one becoming law in 1970.

The fate of private member also remains similar in J&K Assembly

Since 1980, only three private member bills have been passed in the House. Two of them- Jammu & Kashmir Resettlement Act-1982 and Jammu & Kashmir Jammu and



Kashmir Muslim Personal Law (Shariat) Application Act, 2007were moved by Abdul Rahim Rather, the incumbent speaker. The first was brought by him as MLA of NC in eighties and second as Leader of Opposition during PDP- Congress rule.

Former Lok Sabha General Secretary and expert on legislative matters, P.D.T. Achary told the news agency-Kashmir News Observer (KNO) that the normal attitude of the government is that they don't allow such bills to pass. "In a few cases, they had allowed it to be passed-long, long ago. That was in the 1950s and 1960s. The passage of a bill depends on the attitude of the government, as it | More on P6

SC to hear petitions on statehood foday

Srinagar, Oct 09: The Supreme Court will hear a batch of petitions tomorrow seeking the restoration of Jammu & Kashmir's statehood.

According to the causelist released by the Apex Court's registry, the petitions are listed before the Court of the Chief Justice of India (CJI) on Friday,

"The case is listed for hearing before a bench headed by the Chief Justice of India," advocate Soayib Qureshi told the news agency—Kashmir News Observer (KNO).

He further said that the Union of India has not yet filed any response in the matter.

On August 14, during a hearing of the case, the Supreme Court granted eight weeks' time to the Solicitor General of India to seek instructions from the government regarding the



pleas for restoration of J&K's statehood.

At that time, the CJI emphasized that the real situation on the ground must be considered and that incidents such as the Pahalgam attack cannot be overlooked.

"You must also take into account the ground realities; you cannot ignore what happened in Pahalgam," said the bench

J&K, Ladakh likely to see 3470 MWs peak power demand in Oct

MoP predicts 980 MWs power shortfall



Srinagar, Oct 09: With the onset of cold weather, the Ministry of Power (MoP) has predicted a peak power requirement of 3470 Megawatts (MWs) for Jammu and Kashmir and Ladakh for the ongoing

However, contrary to it the ministry has anticipated that availability of only 2490 MWs

for the month of October. According to the official figures available with the news agency-Kashmir News Observer (KNO), the MoP has predicted that Jammu and Kashmir and Ladakh may have a shortfall of 980 MWs against the total peak requirement.

Stating the anticipated power supply position in the northern region for October 2025,



MoP has said that the representatives of Haryana, SLDC, Punjab SLDC and J&K SLDC informed that the shortfall in J&K would be met through Real time exchanges.

World Sight Day: Prolonged screen time linked to blurred vision, say doctors Recommend regular eye check-ups to combat rising vision issues

Srinagar, Oct 09: As screen time continues to rise in today's digital era, medical experts warn that prolonged exposure to digital devices is emerging as a major cause of visual health issues, particularly among the elderly and

On the occasion of World Sight Day, ophthalmologists urged the public to take preventive steps to protect their vision - including reducing screen time and scheduling regular eye examinations.

Doctors, who spoke to the news agency-Kashmir News Observer (KNO), said that staring at screens for extended periods forces the eyes to focus closely and continuously, resulting in a condition known as digital eye strain or computer vision syndrome. Common symptoms include blurred vision, dry eyes, headaches, and pain in the neck and shoulders.

They further noted that

are particularly

vulnerable, as excessive screen time at a young age increases the risk of developing myopia (nearsightedness) early in life. The condition, if left unmonitored, can lead to long-term complications, they added.

Dr Tariq Dar, an ophthalmologist, highlighted the growing prevalence of age-related macular degeneration (AMD), which they said is a leading cause of vision loss among the

"The number of AMD cases has doubled over the past



decade," he said. "Regular eye check-ups every six months are essential for the elderly to ensure early detection and

He recommended that children should undergo an eye check-up at least once a year, even if they don't display im-

Dr Nusrat, another ophthalmologist, said that a significant number of vision problems are preventable. "Refractive errors, cataracts, glaucoma, and diabetic retinopathy are among the most common causes of preventable blindness in India," she said.

Dr Nusrat advised maintaining a balanced diet rich in green leafy vegetables, fruits, and lean meats such as fish to promote better eye health. "It's important to get your eyes tested regularly," she said.

"Many eye conditions show no symptoms until the advanced stages, when significant damage has already occurred."

The doctor warned that individuals with diabetes, hypertension, and other systemic illnesses are at a higher risk of developing eye complications and should undergo more frequent evaluations.

Meanwhile, doctors highlighted recent technological advancements that have transformed eye care. "Gene therapy is now being | More on P6

On the occasion, he announced that, as part al Conference has already introduced the "Land Grants (Restoration and Protection) Bill" in the Assembly, seeking to nullify the 2022 amendments and reinstate the 1960 Act to ensure extension of leases for local leaseholders.

According to Tanvir, the Bill is designed to safeguard the rights of existing leaseholders, protect local businesses, and ensure that government land continues to serve the people of Jammu and Kashmir rather than speculative or non-local interests. "Any change in land policy must

emanate from the elected Assembly not through unilateral administrative orders," he said.

Speaking to the media, Tanviir said, "Our intention is clear, it's to protect the rights of the poor, small traders, and local businessmen. I have already introduced a private member's bill in the Assembly to restore leases and safeguard people's land. The PDP's press conference on this issue is nothing but

political drama.' He emphasized that no bill or resolution meant for the Assembly can be publicized before being tabled. While we quietly worked for the people, PDP chose to create noise for attention. We act while they act out,"

Responding to statements made by PDP President Mehbooba Mufti and opposition leader Sunil Sharma, Sadiq said both the PDP and BJP appear to be following the same script. FSD seizes 5 quintals of Namkeen snacks, seals unit

SRINAGAR, OCTOBER 09: Continuing its intensified drive against the sale of unsafe and substandard food items, a team of Food Safety Officers, led by the Assistant Commissioner Food Safety Srinagar, conducted an inspection of a snack manufacturing unit operating from Abhanshah, HMT Srinagar.

During the inspection, the unit was found operating without a valid licence and under unsanitary conditions. Around five quintals of Namkeen snacks, including katlam and finni, were seized on the spot. Samples of the seized items were lifted for detailed

analytical testing. Subsequently, the unit was sealed immediately and prohibited from carrying out further manufacturing activities. A complaint under the relevant provisions of the Food Safety and Standards Act, 2006 and Rules & Regulations, 2011 will be submitted before the competent court in due course of time. Commissioner, Food and Drug Administration, Smitha Sethi, has directed all food business operators to strictly comply with the provisions of the Food Safety and Standards Act and maintain proper hygiene and licensing requirements. She warned that stringent action will be taken against violators as per



Boost milk, mutton production in J&K: CS

SRINAGAR, OCTOBER 9: Chief Secretary, Atal Dulloo Thursday chaired a high-level meeting of the Agriculture Production Department (APD) to review the measures being taken to enhance milk and mutton production across the Union Territory. He emphasized that both sectors hold immense potential for growth, value addition, and entrepreneurship if approached with the right policy interventions and sustained departmental support. The meeting was attended by Additional Chief Secretary (ACS), Agriculture Production Department, Shailendra Kumar; Vice Chancellor, SKUAST-Jammu; Managing Director, HADP; Managing Director, Dairy Development; Directors of Agriculture and Sheep Husbandry from both Jammu and Kashmir divisions; and other senior officers of the department.

During the meeting, the Chief Secretary underscored the need to create replicable success stories in these sectors to inspire public participation and entrepreneurship.

He observed that the region, being primarily a consumer state, offers a significant market for milk, mutton, and their processed products. Even in catering to local demand there exists vast potential in exploring commercial expansion and export of its value-added products.

He maintained that the UT must move beyond basic packaging and branding. The focus should be on scientific processing and value addition that can yield high-demand products and sustainable livelihoods. He urged local entrepreneurs to unlock the potential of the region's dairy and livestock sectors for finding the gainful employment.

While speaking in this meeting the ACS, APD, Shailendra Kumar, gave a comprehensive overview of the present status and consumption patterns of milk and mutton in J&K. He noted that dairy products form part of the daily diet across the UT, while mutton consumption is among the highest in the country,

creating steady market demand. The department, he said, has assessed the existing gaps and devised a roadmap to enhance both production and value addition over the next few years. As per the presentation given by the department, J&K produces 28.75 lakh metric tonnes of milk annually, with a per capita availability of 577 grams per day, which is higher than the national average of 471 grams. However, only about 4% of milk production is currently organized, accounting for just 4% of the local production. The department aims to bring at least 20% of production under the organized sector within the next 5–7 years, the meeting was apprised.

To achieve this target, the department plans to expand Artificial Insemination (AI) coverage, secure High Genetic Merit (HGM) bulls, establish facilities for sexed semen, and address fodder deficit issues through scientific feeding practices.

Dy CM calls LoP Sharma a 'lollipop leader'



Srinagar, Oct: A day after Leader of Opposition Sunil Kumar Sharma slammed National Conference over governance and human rights, Deputy Chief Minister Surinder Kumar Choudhary on Thursday called him a "lollipop leader."

Speaking to reporters, Choudhary described him as a lollipop leader. "If you conduct his narco test, he would even demand statehood," he said.

He said the flood-affected people of Jammu have been left in lurch by BJP. "You ask the LoP leader, you should ask the lollipop leader-he talks every day and blames us. 'Big promises, no delivery': Imran Ansari

Srinagar, Oct 09: Ahead of the Supreme Court's hearing regarding the restoration of Jammu & Kashmir's statehood, senior Peoples Conference leader Imran Reza Ansari on Thursday slammed Chief Minister Abdullah over his 'failure' to deliver on the promise of a signature campaign made during his Independence Day speech.

In a social media post, Ansari recalled the Chief Minister's Independence Day speech, where he had pledged to collect lakhs of signatures within eight weeks in support of restoring statehood and submit them to the Supreme Court before the October 10 hearing. "Big talk,



big promises-typical JKNC style," Ansari said in a Facebook post.

"Now here we are, on the eve of October 10. The case is on the Supreme Court's list for tomorrow. But where's that famous signature campaign that was supposed to shake Delhi? Did the lakhs of signatures get lost somewhere between Gupkar and Twitter?"

Ansari questioned whether the Chief Minister, who is currently in Delhi, had gone to submit the collected signatures or merely to gather more photos for his social media accounts.

"So naturally, one wonders has he gone to submit those 'lakhs of signatures' his government collected, or just to collect a few more photos for his next social media post?"

He further added, "Promises were made to the people, press releases were issued to the media, but in the end, it seems only the signatures of silence made it to Delhi.'

Monitoring committee formed for health schemes

Srinagar, Oct 09: The Jammu and Kashmir government has set up a monitoring committee to oversee the implementation of the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB PMJAY) and AB PMJAY SEHAT health insurance schemes.

According to a Government Order under No. 661-JK(HME) of 2025, issued by the Health and Medical Education Department, the committee aims to improve transparency, accountability and regular monitoring of the schemes.

The order has been issued by the Secretary to the Government, Health and Medical Education Department.

The committee will be headed by the Director

of Health Services, Jammu, and will include the Director of Health Services, Kashmir, Chief Medical Officers from various districts, and officials from the State Health Agency.

Its main task will be to review the functioning of the two health schemes, ensure proper delivery of healthcare to beneficiaries, and submit regular progress reports to the government.

Officials said the move shows the administration's commitment to strengthen the public health system and ensure effective health coverage to people across Jammu and Kashmir.

The committee has been asked to send quarterly reports and recommendations to the Health Department for necessary action.

Health sector stakeholders have welcomed the decision, saying it will help identify gaps, improve

The Gift Of Sight: More Than Meets The Eye

A reflection on how genuine vision encompasses understanding, empathy, and the collective responsibility to ensure no one is left in darkness

Sight is often mistaken for the mere ability to see — a function of eyes translating light into form. But true sight is far more intimate; it is the quiet language of perception, the tender dialogue between the visible and the felt. It begins where vision ends — in the spaces where the world is not only observed but understood, where beauty is not simply witnessed but absorbed by the soul.

Sight is the mind's poetry written in light — a symphony that allows one to recognise love in a glance, grief in silence, and hope in a horizon yet unseen. It is the gentle awareness that gives colour to emotion and direction to thought. It is what makes a mother identify her child in a crowd not by sight alone, but by instinct, and what makes a poet see verses in the rain long before words find the page.

To see is not merely to look — it is to connect, to interpret, to feel the pulse of existence in its smallest gestures. Even when eyes fail, sight often lingers — in memory, in imagination, in the heart's own way of perceiving what lies beyond light. It is what transforms darkness from emptiness into depth, what turns absence into presence, and silence into a form of seeing.

Sight, then, is not confined to the act of vision; it is an inward awakening — a harmony between sense and spirit. It is how the world touches us and how we, in turn, touch the world. Yet, amid this natural splendour, countless hearts live in partial or complete darkness, reminding us that the gift of sight must never be taken for granted.

Sight, as profound and personal as it is, thrives only when it is cherished. This year's global theme — "Love Your Eyes" — is more than a slogan; it is a philosophy of gratitude and responsibility. It reminds humanity that caring for our eyes is not merely a medical routine but an emotional and moral act — a recognition of the very gift that connects us to the beauty of life itself. To love your eyes is to pause amid the rush of modern existence and acknowledge how every sunrise we witness, every face we recognise, and every written word we read becomes possible through this unique miracle of vision.

Loving one's eyes means nurturing them with care, protecting them from strain, giving them rest in a sleepless digital world, and seeking timely attention when something feels amiss. It also means creating a society where everyone – regardless of geography, age, or income - has the right to see clearly and live fully. In the context of Kashmir, where the landscape itself teaches the language of light, this theme finds even deeper resonance. To love one's eyes here is to love the colours of the Valley, to protect the sight that beholds its splendour, and to ensure that no child, elder, or worker loses that privilege to neglect or lack of

When the world unites under the banner of "Love Your Eyes," it is, in truth, a collective pledge — a vow that we will not take for granted the light that defines our humanity. For in loving our eyes, we are, in essence, loving our ability to dream, to feel, and to see not just the world before us, but the infinite beauty that lies within. Yet even within these challenges, a



powerful narrative of resilience is being written. A growing trend of achievers is emerging from the Valley, redefining the limits of possibility. We see this in the academic dedication of scholars like Raziya Samoon, Tariq Bashir, and Ruhi Jaan, who, as Assistant Professors, are illuminating minds and proving that insight transcends sight. It is echoed in the legal acumen of Saniya Zehra, a master of law from the prestigious National Law University, Patiala, who is championing the right to education and justice through her advocacy. Meanwhile, technocrats and social workers like Abrar Ahmed are at the forefront of a digital revolution, championing accessibility and digital literacy to bridge the technological divide.

A particularly hopeful signal of this revolution is the pioneering initiative this year, where a couple of students from Kashmir are set to become the first to write their computer-based 12th Class CBSE examinations — a transformative step that promises to revolutionise digitally accessible education for the visually impaired.

This wave of achievement extends beyond these notable names, finding its pulse in a younger generation now receiving degrees in diverse fields like Business Administration, Computer Science, and the Arts. This collective ascent is not a series of isolated successes but a quiet revolution — a definitive statement on the indomitable potential residing within the region's visually impaired community.

Yet, for every achiever, the path is often needlessly steep. A significant hurdle for school-going children with visual impairment is the stark lack of accessible learning materials. The scarcity of audiobooks and the absence of standardised large-print font books in schools create an information famine, leaving young minds hungry for knowledge that their peers access effortlessly. This gap in educational equity dims potential at its very dawn.

Together, these individuals form the

unseen light of Kashmir — the proof that blindness does not reside in the eyes but in the absence of will. Their stories are not just of survival but of triumph; not of darkness, but of the art of finding light where others see none. In their lives, the message of World Sight Day — "Love Your Eyes" — finds its truest meaning: a reminder that vision begins in the heart

long before it reaches the eyes.

It is important to recognise that the struggle of vision loss is not solitary. It extends across families, towns, and districts — across Kashmir. In recent hospital-based studies in Srinagar, nearly 58.36% of patients presented with some form of visual impairment, while 12% were observed to be blind. Yet another district of Kashmir, among people aged 50 and above, the prevalence of bilateral cataract-induced blindness has been found to be around 4.16%.

These numbers are not mere data points — they represent the silent lives of neighbours, elders, and children whose world dims gradually when help is delayed or unreachable.

Many of the causes of visual impairment in Kashmir are common, yet preventable or treatable. Cataracts remain the leading cause of ocular morbidity (about 30%) among patients coming to tertiary eye care centres in the region. Uncorrected refractive errors (problems nearsightedness, farsightedness, or astigmatism) follow close behind. Conditions like diabetic retinopathy, which can rob people of vision over time if blood sugar is not controlled or screenings are neglected, are emerging as serious threats. Glaucoma, often called the "silent thief of sight," lurks undetected in many until damage is advanced.

Yet these conditions do not act alone. Barriers — both tangible and invisible — stand in the way of treatment: the cost of surgery or frequent clinic visits, distance to specialised centres, lack of awareness that some vision loss can be prevented

Hungarian master of absurdist excess László Krasznahorkai wins Nobel literature prize

Stockholm, Oct 09: Hungarian writer László Krasznahorkai, whose surreal and anarchic novels combine a bleak world view with mordant humor, won the Nobel Prize in literature Thursday for work the judges said upholds the power of art in the midst of "apocalyptic terror.

The Nobel judges said the 71-year-old author, whose novels sometimes consist of just one long sentence, is "a great epic writer" whose work "is characterized by absurdism and grotesque excess."


He's the first Nobel literature winner from Hungary since Imre Kertesz in 2002 and joins a list of laureates that includes Ernest Hemingway, Toni Morrison and Kazuo Ishiguro.

"I am calm and very nervous," Krasznahorkai told Radio Sweden after getting news of the prize, which comes with an award of more than \$1 million. "This is the first day in my life when I got a Nobel Prize. I don't know what's coming in the future."

The American writer and critic Susan Sontag once described Krasznahorkai as the "contemporary master of the Apocalypse." His work has echoes of other European writers who explored the absurd tragicomedy of existence, including Franz Kafka and Samuel Beckett.

Varga, Zsuzsanna Hungarian literature expert at the University of Glasgow, said Krasznahorkai's novels probe the "utter hopelessness" of human existence, while also being "incredibly funny."

Krasznahorkai's near-endless sentences made his work the "Hotel California" of literature - once readers get into it, "you can never leave," she said.



Varga suggested readers new to Krasznahorkai's work start with "Satantango," his 1985 debut, which centered around the few remaining residents of a dying collective farm and set the tone for what was to follow.

Krasznahorkai has since written more than 20 books, including "The Melancholy of Resistance," a surreal, disturbing tale involving a traveling circus and a stuffed whale. and "Baron Wenckheim's Homecoming," the sprawling saga of a gambling-addicted

"Herscht 07769," from 2021, is set in a German town riven with unrest. Written as a series of letters to then-German Chancellor Angela Merkel, it has just one period in its 400 pages.

Several works, including "Satantango," and "The Melancholy of Resistance" were turned into films by Hungarian director Béla Tarr.

Krasznahorkai also wrote several books inspired by his travels to China and Japan,

including "A Mountain to the North, a Lake to the South, Paths to the West, a River to the East," published in Hungarian in 2003. How Krasznahorkai came to

Krasznahorkai had been on the Nobel radar for some time, committee member Steve Sem-Sandberg said, calling his literary output "almost half a century of pure excellence."

The writer was born in the southeastern Hungarian city of Gyula, near the border with Romania, and studied law at universities in Szeged and Budapest before shifting his focus to literature.

Varga, the academic, said Krasznahorkai developed a cult following among young Hungarians during the twilight of Communism in the 1980s, when "authors were pretty much like pop stars.'

János Szeg , Krasznahorkai's editor at the Budapest-based publishing house, said that the author's works deal with "life on the periphery,"

and are interested in "the techniques of power.'

"All the populist tendencies of our time can also be found in his novels — from barbarism to the manipulation of the masses," Szeg said.

Krasznahorkai has been a critic of autocratic Hungarian Prime Minister Viktor Orbán, especially his government's lack of support for Ukraine after the Russian invasion.

In an interview with Swedish newspaper Svenska Dagbladet earlier this year, Krasznahorkai expressed criticism both of Orbán's political system and the nationalism present in Hungarian society.

"There is no hope left in Hungary today and it is not only because of the Orbán regime," he told the paper. "The problem is not only political, but also social."

Orbán nonetheless congratu-lated the writer in a Facebook post, saying: "The pride of Hungary, the first Nobel Prize winner from Gyula, László Krasznahorkai."

How Krasznahorkai and others reacted

Krasznahorkai received the 2015 Man Booker International Prize for his body of work and the National Book Award for Translated Literature in the U.S. in 2019 for "Baron Wenckheim's Homecoming.'

He said none of his career was planned.

"I wanted at first to write only one book. And I didn't want to be a writer," he told Swedish radio, but rereading his first novel he discovered it wasn't perfect.

"I started to write another one because I wanted to correct 'Satantango,'" he said, and later "I tried to write a new book to correct the first two. ... My life is a permanent correction.'

The literature prize has been awarded by the Nobel committee of the Swedish Academy 117 times to a total of 121 winners. Last year's winner was South Korean author Han Kang. The 2023 winner was Norwegian writer Jon Fosse, whose work includes a sevenbook epic made up of a single sentence.

The literature prize is the fourth to be announced this week, following the 2025 Nobels in medicine, physics and chemistry.

The winner of the Nobel Peace Prize will be announced Friday. The final Nobel, the Memorial Prize in Nobel Economic Sciences, will be announced Monday.

Nobel Prize award ceremonies are held on Dec. 10, the anniversary of Alfred Nobel's death in 1896. Nobel was a wealthy Swedish industrialist and the inventor of dynamite who founded the prizes.

Each prize carries an award of 11 million Swedish kronor (nearly \$1.2 million). Winners also receive an 18-carat gold medal and a diploma.

Surrogacy law: Age bar won't apply if procedure started before Jan 25, 2022, says SC

New Delhi, Oct 09: In a significant verdict, the Supreme Court on Thursday said age restriction under the 2021 surrogacy law will not apply to intending couples who commenced the procedure, like freezing of embryos, before the law came into effect on January 25, 2022.

The top court dealt with a provision of the Surrogacy (Regulation) Act, 2021, which states that an intending couple requires an "eligibility certificate" certifying that they are married and between the age of 23 and 50 years in case of female, and between 26 and 55 years in case of male, on the day of certification.

A bench of Justices B V Nagarathna and K V Viswanathan noted that the Act came into force with effect from January 25, 2022.

It said before January 25, 2022, there were no binding laws or certifications regarding age restrictions on intending couples wishing to avail surrogacy.

"It is not for the State to question the couple's ability to parent children after they had begun the exercise of surrogacy when there were no restrictions on them to do so," the bench said.

It held that Section 4(iii)(c) (I) of the Act does not have retrospective operation.

Thus, if an intending couple commenced the surrogacy procedure prior to the commencement of the Act, i.e., January 25, 2022, and were at the stage of creation of embryos and freezing after extraction of gametes and on the threshold of transfer of embryos to the uterus of the surrogate mother, the age restriction under Section 4(iii) (c)(I) of the Act would not apply," the top court held.

The bench delivered its verdict on two petitions and an application filed by three intending couples, whose common grievance was related to the upper age limit.

The petitioners argued that they had commenced the surrogacy procedures prior to the enforcement of the Act, and when they were in the middle of the procedure, the law brought in an embargo in the form of age-limit.

Justice Nagarathna, who penned the verdict for the bench, said when the petitioners generated and froze their embryos, they qualified for surrogacy under the prevailing law.

"Thus, they came to possess a right to surrogacy as part of reproductive autonomy and parenthood," the bench said.

It did not accept the Centre's submission that age restrictions under the Act should apply retrospectively to such couples also since the State has an interest in ensuring that children born to such parents receive adequate parenting.

"In this regard, we consider it useful to note that the law does not impose any age restrictions on couples who wish to conceive and bear children naturally," it said.

The bench said prior to the enforcement of the Act, the petitioners were on the same footing as couples who wished to conceive naturally, but the stark distinction was that owing to medical reasons/disadvantages, they could not have children naturally.

"Having exercised this parity in freedom by commencing the surrogacy process, can it be said that they can now be denied the continued exercise of this freedom only because of the age bar under the Act? We are not inclined to believe so," it said.

The bench noted that the relevant age limits under the Act are imposed on the intending couples in the present cases.

Ghosh, one of the most celebrated Indian writers in English, was being touted as a frontrunner to win the coveted prize in 2025, 112 years after Rabindranath Tagore won it in literature

forward to Amitav Ghosh getting the Nobel second time after Tagore. His writings have always focused on the battle of the people in search of livelihood and succour over centuries with historical documentation," eminent Bengali author Sirshendu Mukhopadhyay told PTI.

Mukhopadhyay, a Sahitya kademi award-winner, said he does not think his not getting ting the Nobel in no way lessens

the Nobel Prize will in any way diminish his appeal and popularity among readers cutting across borders.

"He was considered one of the favourites to be awarded the Nobel. That itself should be an honour," the nonagenarian author said.

One of the foremost writers of the present generation, Pracheta Gupta, also said that not getthe popularity of his books or makes his seminal epochal cult works lose their lustre.

He said the government normally advises the members to withdraw the bill so that the government can bring a comprehensive bill.

"A private member's bill may not be very comprehensive; there may be very skeletal provisions in it. The private member doesn't have the technical expertise to draft a very comprehensive bill. It can be done only by the government. That advice is okay, and the government is right in giving it," he said.

Veteran politician and MLA from Bandipora, Nizamuddin Bhat, said the government always likes laws to be passed through them. "If a private member's bill is in the public interest and suits their interests, they can allow its passage," he said. He said such bills have been rarely passed in the House. "A private member is an individual member. He cannot carry the entire House with him," he said.

The bigger question is whether the bills submitted for the session starting on October 23 will be introduced in the House

Officials well-versed with the legislative process told news agency-KNO that the chances of their introduction on October 28-the day reserved for Private Member Bills-are almost impossible given that 33 bills from the budget session are already pending with the Assembly

'The Private Member Bills would be listed in business in the order in which the notices were received. Since 33 private member bills are pending, they will get preference in the list of business for that day in accordance with the Rules of Procedure and Conduct of Business in J&K Legislative Assembly," he said.

He added that all the bills submitted for during the last budget session, as well as those submitted for the upcoming session, will be listed in the business of the House on that day. "Given past functioning of the House, only 10

to 12 bills are likely to be taken up for introduction in the House," he said, adding that the bills which are not taken up will remain active.

He further said that the bills do not lapse with the prorogation of the House; they lapse only upon its dissolution. (KNO)

New energy in **India-UK ties:** PM Modi



Mumbai, Oct 09: India and the UK are natural partners and the partnership between the two countries is becoming a crucial foundation for global stability and economic progress, Prime Minister Narendra Modi said on Thursday.

After wide-ranging talks with visiting British Prime Minister Keir Starmer, Modi said the foundation of India-UK relationship is a shared belief in values such as democracy, freedom, and rule of law.

In the joint briefing after the talks, Starmer said the India-UK relationship is special

"We are creating a new modern partnership focusing on future," he said, while hailing India's growth story as remarkable.

Prime Minister Modi also said that India and the UK have reached an agreement on cooperation in military training.

"We are fully committed to

enhancing maritime security cooperation with UK in Indo-Pacific region," PM Modi said.

On the Ukraine conflict and Gaza issue, he said India supports all efforts to restore peace

through dialogue and diplomacy. The two leaders held talks broadly focusing on boosting the India-UK ties in areas of trade, defence and security and critical technology.

The British leader, accompanied by a delegation of 125 of the UK's most prominent business leaders, entrepreneurs and educationists, landed in Mumbai on Wednesday morning on a two-day visit.

Starmer's visit to India came two-and-half months after the two countries inked a landmark free trade pact that will increase market access, cut tariffs and is expected to result in doubling the bilateral trade by 2030.

The trade deal was firmed up during PM Modi's visit to London

India, Australia ink 3 pacts to expand defence ties

New Delhi, Oct 09: India and Australia on Thursday signed three key pacts including one on information sharing, to further expand their bilateral defence and military ties fol-lowing "productive" talks between Defence Minister Rajnath Singh and his Australian counterpart Richard Marles in Canberra.

Singh, currently on a two-day visit to Australia, also met Prime Minister Anthony Albanese and Foreign Minister Penny Wong, broadly focusing on imparting more dynamism to the relations.

The two defence ministers affirmed the importance of enhancing cooperation with regional partners to help maintain a free, open, peaceful and prosperous Indo-Pacific, underscoring their strong support for freedom of navigation and overflight and unimpeded trade in the region. The resolve came against the backdrop of China's increasing military assertiveness in the strategic waters. Besides the agreement on information sharing, the two sides firmed a Memorandum of Understanding (MoU) that will provide for cooperation on submarine search and another on establishment of a framework for joint staff talks.

The Singh-Marles meeting marked five years of the India-Australia comprehensive strategic partnership, with both sides reaffirming



their shared commitment to deepening defence cooperation across a wide spectrum, including maritime security, defence industry collaboration and joint research in science and technology.

In his remarks, Singh reiterated India's stand with regards to the threat of terrorism that. Terror and talks cannot go together, terror and trade cannot go together and water and blood cannot flow together, he said in clear reference to India's policy towards Pakistan.

The defence minister also urged the international community to come together against all forms of terrorism.

A day after the April 22 Pahalgam attack, India announced a series of punitive measures against Pakistan, including the suspension of the Indus Waters Treaty with New Delhi asserting that "blood and water" cannot flow together.

New Delhi has been maintaining that the Indus Waters Treaty will remain in "abeyance"

"It showcased a demonstration of growing interoperability following last year's implementation arrangement on air-to-air refuelling. Upon arrival at the Australian Parliament House, Singh was accorded a traditional welcome in the presence of Richard Marles," it said.

A joint statement said Singh and Marles were pleased that the India-Australia defence partnership now covers "all domains".

The two ministers also affirmed the importance of enhancing cooperation with regional partners to help maintain a free, open, peaceful, stable and prosperous Indo-Pacific,

Singh and Marles under-scored their strong support for freedom of navigation and overflight, unimpeded trade in the region, and other lawful uses of the sea consistent with international law, particularly the 1982 **United Nations Convention** on the Law of the Sea, the joint statement said.

It said the ministers were pleased with the collaborative maritime domain awareness and anti-submarine warfare activities by Australian and Indian maritime patrol aircraft in the Indian Ocean.

'We will soon release a list of candidates for other seats. If you find Kishor Ji's name on the list, then he will be contesting. It's quite clear. Kishor Ji will launch the party's election campaign from Raghopur on October 11", Singh said.

Of the 51 candidates named, 11 belong to backward classes, 17 to extremely backward classes, nine are from minority communities and the rest from the general category, he added.

Nearly 1 bn people in low-and middle-income countries living with avoidable vision loss: Report

New Delhi, Oct 09: Nearly 1 billion people in low-and middle-income countries are living with avoidable vision loss. according to a new report on World Sight Day on Thursday.

The report by the International Agency for the Prevention of Blindness (IAPB) showed that most of this can be solved with some of the cheapest interventions: cataract surgery and glasses. IAPB works closely with the United Nations to work for eye care.

The report, launched during the UN General Assembly, showed how India can benefit from prioritising eye health, urging everyone to love their eyes by getting an eye test.

It noted that around 70 crore people in India are living with preventable sight loss, which affects employment, education, income and caregiving responsibilities.

It suggested six simple, cost-effective priorities to prevent sight loss, which include early detection; providing reading glasses on the spot; capacity building in the eye health workforce, coupled with surgical productivity and removal of barriers such as costs, easy access, and social stigma associated with glasses.

These could unlock Rs 3.6 lakh crore for the Indian economy every year, with a Rs 16 return for every Rs 1 invested, the report said, while urging nationally coordinated efforts along with the execution of eye health campaigns across the length and breadth of the country.

"India is the first nation to launch the National Programme for Control of Blindness and Visual Impairment (NPCB&VI) policy. It is 100 per cent centrally sponsored and a strong example of eye health for all. More than 98 lakh cataract surgeries were performed in the fiscal year 2024-25 under the NPCB& VI in 2024-25, which is the highest in the last five years," Peter Holland, CEO, IAPB, told IANS.

"Such policies help to build a strong foundation towards positive eye health for every Indian, creating real socio-economic impact that helps to shape the economy of India," he added.

Holland recommended early detection of eye health issues in schools with good follow-up, including near vision glasses to further prevent avoidable sight

The expert also suggested innovative technologies such as mobile eye clinics, tele-consultations, tele-optometry, and preventive screenings for eye health.

"Start-ups, large organisations, government, as well as social institutions need to come forward to ensure widespread access to meet the eye health needs of remote India," Holland told IANS.

Study in over 100 oral cancer patients finds low awareness of early symptoms, free screenings

New Delhi, Oct 09: A study conducted in over 100 patients of oral cancer -- almost all from upper-lower or lower socioeconomic backgrounds -- found that all were unaware of early symptoms of the condition. with a very low awareness of free government screenings.

Over 54 per cent of the participants, recruited from Delhi's Lok Nayak Hospital during August 2023 to June 2024, used smokeless tobacco, 10.3 per cent were smoking, and 27.6 per cent were using both.

Most were found to consume tobacco daily, with 52.6 per cent quitting tobacco consumption following a diagnosis of oral cancer.

The study, by researchers from Maulana Azad Medical College in Delhi, is published in the journal ecancermedicalscience.

The authors wrote, "Totally, 116 adult patients with histopathologically confirmed oral cancer were recruited using convenience

sampling." "All were unaware of the early symptoms of oral cancer and self-examination methods. Awareness of free government screenings was very low (0.9 per cent), and only 7.8 per cent knew of laws regulating tobacco," they said. They added the

highlights critical gaps in awareness about the link between tobacco use and oral cancer, government-led screening programs and early symptoms of the disease. The team recommend-

ed a multi-pronged policy, including intensifying public health campaigns to convey the specific risk of oral cancer from tobacco use.

Screening for oral cancer should be incorporated into routine healthcare visits, especially at primary health centres and outreach camps, they added.

The authors also called for a strengthening of training programmes for frontline health workers and clinicians to ensure they are equipped to educate patients and conduct oral examinations.

New Delhi, Oct 09: Most of India could be receiving fewer hours of sunshine in a year, with the Himalayan region and west coast seeing the highest reductions, according to an analysis of

Researchers from the Banaras Hindu University, Indian Institute of Tropical Meteorology and India Meteorological Department found that on average, sunshine received by the Himalayan region fell by about 9.5 hours every year during the study period, while that in the west coast fell by over 8.5 hours every year.

The analysis, published in the journal Scientific Reports. looked at data collected from over 20 stations in nine geographically diverse regions across India. Areas in the

in most of India declined

Deccan Plateau were found to receive three hours fewer sunshine every years over the three decades, while sunshine received in the north eastern region declined at about 1.5 hours every year. The authors wrote, "The

trend analysis depicted annual negative trend in all geographical regions with different rate (west coast: minus 8.62 hours/year; Deccan plateau: minus 3.05 h/ year; north eastern region: minus 1.33 h/year; Himalayan

region: minus 9.47 h/year)." Sunshine hours in a month increased during October to May, followed by significant reductions during June-July in six regions, except northern inland and Himalayan region that showed comparatively opposite monthly trends, the

"The study reveals persistent decline of (sunshine hours) in Indian subcontinent on all temporal scales excluding north eastern region where mild seasonal levelling off was found," the authors wrote.

Studies have shown that India has experienced persistent solar dimming -- receiving lesser sunshine over time -- in the 21st century, with increase in density of aerosol particles in the earth's atmosphere being the most accepted reason.

Pope Leo blasts economy that marginalises poor while wealthy live in bubble of luxury

Vatican City, Oct 09: Pope Leo XIV blasted how the wealthy elite live in a "bubble of comfort and luxury" while poor people suffer on the margins, confirming in his first teaching document Thursday that he is in perfect lockstep with his predecessor Pope Francis on matters of social and economic injustice.

The Vatican on Thursday released the document, entitled "I have loved you," which Francis had begun to write in his final months but never finished. Leo, who was elected in May, credited Francis with the text, cited him repeatedly, but said he had made the document his own and signed it. The 100-page document traces the history of Christianity's constant concern for poor people, from Biblical citations and the teaching of church fathers to the preaching of recent popes about caring for migrants, prisoners and victims of human trafficking.

Leo credits especially women's religious orders with carrying out God's mandate to care for the sick, feed the poor and welcome the stranger, and also praised lay-led popular movements with advocating for land, housing and work for society's most disadvantaged.

The conclusion Leo draws is that the Catholic Church's "preferential option for the poor" has

existed from the start, is non-negotiable and is in fact the very essence of what it means to be Christian. He calls for a renewed commitment to fixing the structural causes of poverty, while providing unquestioning charity to those who need it.

"When the church kneels beside a leper, a malnourished child or an anonymous dying person, she fulfills her deepest vocation: to love the Lord where he is most disfigured,"

Leo cites Francis frequently, including in some of the Argentine pope's most-quoted talking points about the global "economy that kills" and criticism of trickle down economics. Francis made those points from the very start of his pontificate in 2013, saying he wanted a "church that is poor

"God has a special place in his heart for those who are discriminated against and oppressed, and he asks us, his church, to make a decisive and radical choice in favor of the weakest," Leo writes.

and for the poor."

Echoing Francis, Leo rails against the "illusion of happiness" derived from accumulating wealth. "Thus, in a world where the poor are increasingly numerous, we paradoxically see the growth of a wealthy elite, living in a bubble of comfort and luxury, almost in another world

compared to ordinary people." Francis' frequent criticism of capitalism angered many conservative and wealthy Catholics, especially in the United States, who accused the Argentine Jesuit of being a Marxist. In a recent interview, Leo said such

be leveled against him. "The fact that I am American means, among other things, people can't say, like they did about Francis, he doesn't understand the United States, he just doesn't see what's going on," Leo told Crux, a Catholic site.

As a result, Leo's embrace of Francis' teaching on poverty and the church's obligation to care for the weakest is a significant reaffirmation, especially in Leo's first teaching document.
Leo signed the text on Oct 4,

the feast of St. Francis of Assisi, the 13th-century mendicant friar who renounced his wealth to live poor among the poor. The date was not coincidental.

The late Pope Francis named himself after the saint and one of the pontiff's most important documents "Fratelli Tutti" (Brothers All) was itself published on the Oct 4 feast day in 2020.

Leo, too, seems inspired by the saint's example: As a young priest, the former Robert Prevost left the comforts of home to work as a missionary in Peru as a member of the Augustinian religious order, one of the other ancient mendicant orders that considers community, the sharing of communal property and service to others as central tenets of its spirituality.

"The fact that some dismiss or ridicule charitable works, as part of a few and not the burning heart of the church's mission, convinces me of the need to go back and reread the Gospel, lest we risk replacing it with the wisdom of this world," Leo writes.

Leo's emphasis on the church's age-old "preferential option for the poor," is unusual given the Vatican's troubled history in dealing with liberation theology, the Latin American-inspired Catholic theology that had the 'preferential option for the poor" as its mantra.

The Vatican under St. John Paul II spent much effort battling liberation theology and disciplining some of its most famous defenders, arguing that they had misinterpreted Jesus' preference for the poor as a Marxist call for armed rebellion.

Leo, in contrast, doubled down on the concept, citing several of the Latin American church's fundamental documents on the issue. He praised as an inspiration St Oscar Romero, the Salvadoran archbishop who was killed in 1980 by right-wing death squads opposed to his preaching against the repression of the poor by the army.

Leo's text minimised the dispute over liberation theology by saying the Vatican's 1984 crackdown on its promoters was "not initially well received by everyone".

US opens probe into nearly 2.9 million Tesla vehicles over full selfdriving traffic violations



Washington, Oct 09: The U.S. National Highway Traffic Safety Administration said on Thursday that it is opening an investigation into 2.88 million Tesla vehicles equipped with its Full Self-Driving system over more than 50 reports of traffic-safety violations and a series of crashes.

The auto safety agency said FSD - an assistance system that requires drivers to pay attention and intervene if needed - has "induced vehicle behavior that violated traffic safety laws."

The agency said it has reports of Tesla vehicles using FSD driving through red traffic lights and driving against the proper direction of travel during a lane

RECALL COULD FOLLOW IF NHTSA FINDS SAFETY RISKS

In total, NHTSA is reviewing 58 reports of issues involving traffic safety violations when using FSD, including 14 crashes and 23 injuries.

The new investigation comes amid growing scrutiny of Tesla's advanced driver assistance system from Congress and weeks after a new NHTSA administrator was confirmed.

Tesla, which did not immediately respond to a request for comment, issued a software update to FSD this week.

NHTSA said it has six reports in which a Tesla vehicle, operating with FSD engaged, "approached an intersection with a red traffic signal, continued to travel into the intersection against the red light and was subsequently involved in a crash with other motor

NHTSA said four crashes resulted in one or more injuries. The investigation - a preliminary evaluation - is the first

seek a recall of the vehicles if it believes they pose an unreasonable risk to safety.
A driver in Houston in 2024

told NHTSA that FSD "is not recognizing traffic signals. This results in the vehicle proceeding through red lights, and stopping at green lights."

The complaint added: "Tesla doesn't want to fix it, or even acknowledge the problem, even though they've done a test drive with me and seen the issue with their own eyes."

NHTSA also said it will review FSD behavior when approaching railroad crossings. Last month, **Democrat Senators Ed Markey** and Richard Blumenthal cited a growing number of reported near-collisions in urging the agency to investigate.

Tesla's FSD, which is more advanced than its Autopilot system, has been under investigation by NHTSA for a year. In October 2024, the agency

began an inquiry into 2.4 million Tesla vehicles equipped with FSD after four reported collisions in conditions of reduced roadway visibility, such as sun glare, fog or airborne dust, including a 2023 fatal crash.

Tesla says FSD "will drive you almost anywhere with your active supervision, requiring minimal intervention" but does not make the car self-driving.

Tesla's other automated vehicle features have also drawn agency scrutiny.

In January, NHTSA opened an investigation into 2.6 million Tesla vehicles over reports of crashes involving a feature that lets users move their cars remotely.

Tesla's deployment of self-driving robotaxis in Austin, Texas, launched in June. (Reporting by David Shepardson.

China clamps down more curbs on export of rare-earth technologies

Beijing, Oct 09: China's Commerce Ministry said that it would impose export control measures with immediate effect on technologies related to rare earths.

Exports of technologies and their carriers related to rare earths mining, smelting and separation, as well as metal smelting, magnetic material manufacturing, and the recycling and utilisation of rare earths from secondary sources, will not be permitted without approval, it said

China accounts for about 70 per cent of the world's rare earth mining, but it controls about 90 per cent of their processing, which makes it virtually the sole supplier of the precious metals used in a host of modern equipment including automobiles electronics, wind energy, and

China's rare earth metals are in demand as the US, EU, and India are its top importers.

So much so that US President Donald Trump, who



earlier imposed 145 per cent tariffs against Chinese exports, settled for an interim trade deal after China stopped the rare earths exports, linking them to the lifting of curbs on semiconductor chips by the US.

Rare earths are a key component of current trade talks between the US and Beijing.

China's new curbs on them came ahead of the planned meeting between Trump and Chinese President Xi Jinping on the sidelines of the Asia-Pacific Economic Cooperation forum in South Korea (APEC) later this month.

Rare earths have also become an important part of India-China talks in recent months.

Fair call to promote Shubman Gill as ODI captain: Sourav Ganguly

New Delhi, Oct 09: Former India captain Sourav Ganguly on Thursday backed the decision to hand over India's ODI captaincy to Shubman Gill, calling it a "fair call and not the worst decision".

Ganguly went on to say that Rohit Sharma's removal as ODI captain was likely done in consultation with the Champions Trophy and T20 World Cup winning skipper.

In his debut series as Test captain, Gill-led India drew the five-match series in England.

"I think it has been done in consultation with Rohit, from outside... I don't know what's inside," Ganguly said after being named the national brand ambassador of 'Annap-


"Somewhere down the line, I feel that it's a fair call. Rohit can keep playing and in the meantime, you keep grooming



a young captain. So, I really don't see a problem in that." India will play three ODIs in Australia starting October 19, followed by a five-match T20I series from October 29.

Shanghai Masters: Djokovic

battles past Bergs to record 80th Masters 1000 semis

Shanghai, Oct 09: Novak Diokovic's resilience and experience once again came to the fore as he battled past Belgium's Zizou Bergs 6-3, 6-4 on Thursday to secure a semi-final berth at the 2025 Shanghai Masters.

Despite not being at his physical best, the 38-year-old Serbian extended his dominance on the ATP Masters 1000 stage, becoming the oldest semi-finalist in Masters 1000 history. Djokovic, who endured a leg

issue and heat-related exhaustion in his fourth-round victory over Jaume Munar, was again made to work hard under testing conditions. The World No. 5 appeared to be struggling with discomfort

in his left foot during the opening set but dug deep to clinch his 80th Masters 1000 semi-final appearance - another record in his illustrious career. The Serbian looked poised to seal victory when he broke Bergs to lead 5-4 in the second set, but the 26-year-old Belgian,

playing his first ATP Head2Head

match against Djokovic, showed

impressive resolve to immediately break back. What followed was one of the most thrilling exchanges



surviving four smashes and a daring volley from Bergs before reclaiming the break in a pulsating rally. This time, he made no mistake serving out the match to claim his milestone win.

"I was just trying to stay alive to be honest on the court," Djokovic admitted afterward. "My first encounter with Bergs. He's a great guy. Obviously, a lot of firepower in his game. At times, I just tried to play an extra ball in the court and make him miss the ball, and that's what happened. I should have closed out the match at 5-4. He played a good game, again I was a little bit too passive.'

Having battled through another gruelling encounter, Djokovic acknowledged the challenge of adapting to the conditions in Shanghai. "Very challenging conditions these days for all the players, and I was just trying to stay alive on the court. I'm glad to overcome

this hurdle," he said. The 24-time Grand Slam champion is now just two wins away from a record-extending 41st Masters 1000 title, and his first since the 2023 Paris
