## BSF on alert, watching border threats with AI, drones, says IG Anand

'We've integrated artificial intelligence, drone surveillance to strengthen border security'

JAMMU, OCT 10: Inspector General (IG) of Border Security Force (BSF) for Jammu, Shashank Anand on Friday said that the security forces are alert on the border and are maintaining a

As per the news agency— Kashmir News Observer (KNO), talking to reporters at BSF Headquarters here, IG BSF said, "Cross-border activities remain under constant watch and we are prepared to counter any

activities. Whenever we notice any suspicious movement we develop effective strategies with other agencies," the IG said.

He said the BSF remains vigilant and committed to preventor cross-border activity. "The enemy always tries to infiltrate, but we are vigilant and in close coordination with our sister agencies," he added.

On evolving threats and warfare methods, IG Anand said the BSF is adapting new technologies, including drone warfare and artificial intelligence.

"This 21st century has witused. AI is also being employed. BSF is not lagging behind; we are training our troops in drones for attack and defence purposes, and if there is any opportunity, we will use it," he said.



The IG BSF said that the challenges on the border change with seasons, especially during winter, and the force is prepared accordingly. "During winter season, our challenges are difing any attempt at infiltration ferent, and we have formulated strategies to foil any infiltration attempt by the enemy. We are patrolling our borders," he said.

"After Operation Sindoor, we have accelerated the introduction of modern technology across defence and paramilitary forces," he said.

"A dedicated School of Drone Warfare has been set up at the BSF Academy in Gwalior, where nessed changes, and aerial troops are being trained to operroutes such as drones are being ate drone squadrons and drone commandos. We will be able to inflict damage on an adversary in ways they may not have even imagined," he said.

## CS for seamless fruit transportation from Kashmir

Directs for exploring rail freight link to major metro markets

SRINAGAR, OCTOBER 10: Chief Secretary, Atal Dulloo, Friday chaired a high-level meeting to review the transportation and smooth movement of fruit consignments from the Valley to markets outside.

The meeting was attended by Divisional Commissioner, Kashmir; Secretary, Transport Department; IG Traffic; Transport Commissioner; Secretary in Agriculture Production Department; MD, HPMC; Regional Officer, NHAI; and other con-

cerned officers. During the meeting, the Chief Secretary took stock of the current status of the Jammu-Srinagar National Highway (NH-44) and its restoration to full operational capacity. He specifically enquired about the movement of fruit-laden trucks from the Valley and the unhindered passage of other essential commodities coming from outside towards Srinagar.

He further directed that no fruit truck should remain stranded on the highway and instructed the concerned departments to ensure safe and priority passage of these vehicles. He also reviewed the situation regarding vehicles stranded on both sides of the NH-44 and directed for their timely clearance.

While reviewing long-distance transportation options, the Chief Secretary advised the Divisional Commissioner, Kashmir, to explore the introduction of rail freight services for transporting horticultural produce to major markets such as Mumbai, Kolkata and Bengaluru. He emphasized the need to engage with fruit growers in this regard and to coordinate with the Divisional Railway Manager (DRM), Jammu, to examine the feasibility of such a service.

The Divisional Commissioner, Kashmir, apprised the Chief Secretary of the availability

and adequacy of transport services for fruit growers, informing that sufficient trucks are presently available at reasonable rates and that growers are not facing any major logistical difficulties.

Secretary, Transport Department, Avny Lavasa, further informed the meeting that in case of any shortage of transport vehicles, the fleet of J&K SRTC trucks would be deployed to facilitate smooth evacuation of fruit from the Valley to outside markets, ensuring full assistance to the fruit growers.

The Chief Secretary reiterated that the administration is fully committed to ensuring seamless transportation of horticultural produce, which forms a key pillar of the Valley's economy, and directed all concerned officers to maintain coordination and take proactive measures to ensure smooth transportation of this crop throughout the ongoing

The meeting was attended by CMO Budgam, STO Kashmir, DTO Budgam, other concerned officials as well as representatives of non-governmental organizations, TB Champions, Nikshay Mitras, and all staff associated with the National TB Elimination Programme (NTEP). The DC took a comprehensive review of TB-related activities across the district.

The Chair was apprised about the progress achieved under

the TB Mukt Bharat Abhiyaan, identified existing gaps in diagnosis, treatment, and follow-up, and deliberated on strategies to enhance service delivery.

The DC Emphasised on improving case detection, treatment adherence, and patient support mechanisms, especially for MDR-

He assured full administrative support for strengthening TB control measures in the district. He highlighted the importance of a holistic approach to TB management, including nutritional support, vocational rehabilitation. and social welfare for patients undergoing long-term treatment.

He commended the efforts of Nikshay Mitras for their active role in providing nutritional assistance and counselling to TB patients,



acknowledging their contribution to patient retention and treatment success. The DC stressed the need for accurate and timely reporting of TB-related data under the NTEP. underlining its critical role in monitoring progress and formulating effective interventions.



## Experts call for action to break stigma, strengthen support

Srinagar Oct 10: Every year, October 10 marks World Mental Health Day, a global observance dedicated to promoting awareness, understanding, and open dialogue around mental well-being.

This year's theme, "Access to Services: Mental Health in Catastrophes and Emergencies", carries profound relevance as communities across the world grapple with wars, disasters, and humanitarian crises that continue to strain psychological resilience.

Mental health professionals say that constant exposure to trauma and uncertainty has created unprecedented emotional stress, particularly in regions facing conflict or prolonged emergencies.

Dr Mansoor Ahmad, Head of the Department of Psychiatry at GMC Anantnag, called for collective action: "It's time we all engage in



open mental health conversations and provide unwavering support to those in need of care. The burden of untreated mental illness is rising due

to stigma, poor infrastructure, and a lack of awareness."

He said it is highly opportune to the current global situation, as the world

news reports countless catastrophes and emergencies. Constant exposure to trauma, coupled with the pressure of extreme and challenging conditions, can place an immense burden on mental well-being, he added. Dr Ahmad said there are gaps in mental health infrastructure, including shortages of psychiatrists, psychologists, and psychiatric beds. He said surveys indicate that only 10-15% of those with mental disorders receive treatment.

"Stigma and negative perceptions about mental illness often prevent individuals from seeking help, which can disrupt daily life, especially amid frequent curfews, shutdowns, and restrictions affecting education and employment," he added.

Dr Mansoor said trauma cumulatively worsens over time because the conflict is long-term, and younger generations are born into this environment, with repeated exposure to trauma."It's time we all engage in indiscriminate mental health conversations and provide unwavering support to those in need of mental healthcare," he said.

Dr Nisar Ahmad Wani, Professor in the Higher Education Department, J&K, said: "Mental health is not just about the absence of illness; it's about finding balance, resilience, and peace in our daily lives. This year's theme encourages us to break the silence, create safe spaces for open conversations, and support one another. Asking for help is not a weakness; it's an act of courage."

He urged people to look out for each other, adding that simple acts of kindness and empathy can transform lives. "A kind word, a listening ear, or a simple check-in can make a world of difference to someone who is struggling," he added

Dr Nizam-ud-Din Dar, a psychiatrist from IVC Bemina, called for compassion, understanding, and prioritising mental well-being for all, including at the time of catastrophes and emergencies.

'Mental health is a fundamental aspect of our overall health, yet stigma and barriers still prevent many from seeking help. Today, let's commit to fostering a more supportive and accepting world where everyone feels safe to share their struggles and access the care they deserve," he said.

## Sharp rise in tax collections Land revenue up by 87%

Srinagar, Oct 10: Jammu and Kashmir's own tax revenue has shown a strong rise over recent years. hinting at a steady improvement in the Union Territory's financial position. The stamp duty and registration fees are witnessing one of the sharpest increases, growing by 57 per cent from Rs 325.54 crore to Rs 512.02 crore. Land revenue has nearly doubled, rising by 87 per cent from Rs 60.57 crore to Rs 113.28 crore.

According to the official data, Jammu and Kashmir's total own tax revenue increased from Rs 8,876.99 crore in 2020–21 to Rs 11,707.28 crore in 2021–22. This has shown a growth of 31.88 per cent in a single year, hinting at higher collections across all tax segments. A senior finance department official told KNO that the increase is due to better compliance and stronger revenue administration. "Post-pandemic recovery has clearly revived trade, transport, and real estate activity. Further, the GST framework has matured in Jammu and Kashmir. With tighter enforcement and improved digital tracking, leakages have reduced significantly." he



Tax (SGST) was the biggest contributor, rising from Rs 4,839.35 crore in 2020-21 to Rs 6,394.31 crore in 2021–22, an increase of over 32 per cent. State Excise collections went up from Rs 1,347.42 crore to Rs 1,782.79 crore, also a 32 per cent jump. Taxes on sales and trade climbed from Rs 1,495.61 crore to Rs 1,906.31 crore.

Stamp duty and registration fees saw one of the sharpest increases, growing by 57 per cent from Rs 325.54 crore to Rs 512.02 crore. Over 86% of households are now connected to the internet, reflecting the remarkable progress under the Digital India initiative. The expanding digital landscape has enabled citizens to access digital services at their fingertips. At the same time, it has also widened the attack surface for cyber

frauds, making cybersecurity a national priority.

Cyber frauds refer to deceptive activities carried out through digital platforms such as unauthorized access, data theft, or online scams, which are often intended to cause financial loss to victims.

The surge in cybersecurity incidents from 10.29 lakh in 2022 to 22.68 lakh in 2024 reflects the growing scale and complexity of digital threats in India. At the same time, the financial toll is becoming more pronounced, with cyber frauds amounting to 36.45 lakh reported on the National Cyber Crime Reporting Portal (NCRP) as of 28 February 2025. While the numbers point to increasing challenges, they also highlight remarkable progress in the nation's detection and reporting mechanisms

#### **Tracing Cyber Fraud Patterns**

The evolving landscape of cyber frauds shows that frauds are not confined to a single method but take diverse forms, often adapting to new technologies and user behaviour. Mapping these patterns is crucial to enable preventive measures. The staggering financial impact across the world is underscoring fraudsters' global reach and the involvement of organized crime, often linked to fraud factories in Southeast Asia.[6]

#### **Emerging Cyber**

sources, are showing up in multiple fraud reports. Likewise, cases of deepfakes leveraging AI (Artificial Intelligence) and phishing, where individuals are lured into revealing sensitive information through deceptive emails or messages, are also on the rise[7]— amplifying the overall impact of scams.

Unified Payments Interface (UPI), India's most preferred digital payment mode, has also been targeted by fraudsters using compromised mobile numbers. To address this issue, the Department of Telecommunications (DoT) launched the Financial Fraud Risk Indicator (FRI), which classifies suspicious numbers as Medium, High, or Very High-risk.[9]

Illicit digital ventures have also emerged in the form of online betting apps, luring users into depositing funds in their online wallet to play such games with fake promises of large returns, generating over 400 crores in criminal

Strengthening India's fight against cyber frauds, the Promotion and Regulation of Online Gaming Bill, 2025 was passed on 21st August 2025. This legislation is designed to encourage e-sports and social online games while imposing a complete ban on online money gaming, including their promotion, advertisements, and financial transactions.[11]

#### **India's Cybersecurity Framework**

The Government of India has implemented strong defence mechanisms aimed at safeguarding its vast online community. Indians are increasingly integrating the internet into their daily lives, relying on it for essential needs such as business transactions, education, financial activities, and accessing government services digitally. Over 1,05,796 police officers are now registered on the CyTrain portal, with more than 82,704 certificates issued, equipping frontline personnel with essential cybercrime investigation skills.[12]

#### Cyber Laws Securing Cyber Space

Recognizing the critical importance of a secure digital environment, India's Cybersecurity framework is underpinned

by key legislations, notably: Information Technology Act, 2000 serves as the bedrock of India's cyber law framework. It addresses offences like identity theft, impersonation, cheating by personation through computer resources, and dissemination of obscene or harmful material. These provisions are vital in prosecuting fraudsters who exploit digital platforms for financial gain, while also empowering authorities to block malicious websites and fraudulent applications.

Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021 ensure accountability of social media intermediaries, digital platforms, and online marketplaces. It addresses emerging misuse of technologies,



Digital Personal Data Protection Act, 2023: requires that all personal data be handled lawfully and with user consent, making India's digital landscape safer and more accountable for everyone. The Act places strict obligations on data fiduciaries to ensure security safeguards, thereby reducing the risks of unauthorised access or misuse.[13] So far, more than 9.42 lakh SIM cards and 2,63,348 IMEIs (International Mobile Equipment Identity) linked to fraudulent activities have been blocked. [14]

#### **Responding to Cyber Incidents**

Techniques like spoofing, where criminals act like trusted issue necessary advisories. Upon identification of incidents and critical infrastructure. Collaboration between academic such as data breaches, phishing campaigns, or malware intrusions, CERT-In disseminates alerts and prescribes remedial measures to affected organisations. This proactive mechanism ensures timely containment of risks and enhances resilience across government, industry, and critical service providers. As of March 2025, CERT-In facilitated 109 cybersecurity mock drills, engaging 1,438 organizations from different states and sectors to assess cyber readiness and build resilience.[16]

#### **Protecting Critical Infrastructure**

National Critical Information Infrastructure Protection Centre (NCIIPC), designated under Section 70A of the Information Technology Act, 2000, is the national nodal agency for the protection of critical information infrastructure in India. It works in close coordination with stakeholders in sectors such as banking, telecom, power, and transportation, which are vital to national security and public safety. Through continuous monitoring, risk assessment, and issuance of sector-specific guidelines, NCIIPC strengthens defensive capabilities and mitigates threats that could otherwise compromise essential services.

#### **Strengthening Law Enforcement Capacity**

The Indian Cybercrime Coordination Centre (I4C), established under the Ministry of Home Affairs, provides a comprehensive framework to enable Law Enforcement Agencies (LEAs) to deal with cybercrimes in an organised and coordinated manner. It supports capacity-building through specialised training programmes, research, and development of technical tools. It also facilitates real-time information sharing and coordinated investigations, enabling effective action against cybercriminal networks, including those engaged in financial frauds and other organised cyber offences.[17] So far, I4C has proactively blocked 3,962 Skype IDs and 83,668 WhatsApp accounts linked to cyber frauds.[18]

#### **Cybersecurity Initiatives: Governance in Action**

In an effort to bolster India's cyber defences, the Union Budget 2025 has allocated 782 crore for cybersecurity projects. This significant move highlights government's heightened focus on cyber threats that pose risk to the national security.[19] Through the Citizen Financial Cyber Fraud Reporting and Management System (CFCFRMS), manner.[26] financial institutions have been able to save more than 5,489 crore in over 17.82 lakh complaints.[20]

#### **National Cyber Crime Reporting Portal**

To strengthen citizen participation in the fight against cybercrime, the Government has operationalised the National Cyber Crime Reporting Portal (www.cybercrime.gov.in). The portal enables citizens to report complaints relating including AI and mandate the removal of unlawful content to various categories of cybercrime, with a special focus on

offences targeting women and children. A dedicated cybercrime helpline number 1930 provides immediate assistance to victims of online financial frauds by facilitating prompt reporting and, where possible, freezing of fraudulent transactions. Together, these initiatives serve as an accessible and esponsive grievance redressal mechanism for citizens.[21]

#### National Mission on Interdisciplinary Cyber-Physical Systems (NM-ICPS)

NM-ICPS plays a pivotal role in combating cyber frauds by promoting advanced research and innovation in cybersecurity, artificial intelligence, etc. By supporting the devel-Indian Computer Emergency Response Team (CERT-In) opment of tools, platforms, and methodologies for threat is the national agency for responding to cybersecurity inci- detection, the mission strengthens India's ability to identify and prevent cyber frauds targeting individuals businesses institutions, industry, and government under NM-ICPS also accelerates solutions to emerging and sophisticated cyber threats, including financial frauds, phishing, and identitybased crimes.[22]

#### **Cyber Crime Prevention Against Women and Children** (CCPWC) Scheme

The CCPWC scheme addresses cyber frauds targeting vulnerable sections, particularly women and children. With financial support of 132.93 crore, the scheme has established cyber forensic-cum-training laboratories across 33 States and Union Territories. These laboratories have trained over 24,600 personnel in cybercrime investigation, digital forensics, and preventive measures. Through enhanced awareness, early detection, and rapid response capabilities, CCPWC strengthens the capacity of law enforcement to prevent online frauds, scams, and exploitation of women and children, ensuring a safer digital environment.[23] **Cyber Crisis Management Plan (CCMP)** 

To strengthen preparedness against cyber-attacks and cyber-terrorism, the Government has initiated CCMP for all government bodies. The plan serves as a strategic framework to ensure coordinated recovery from any cyber crisis. So far, 205 workshops have been conducted across the country to build capacity and awareness under this framework.[24]

#### Samanvaya Platform

The Samanvaya Platform strengthens cyber fraud invesigations by providing analytics-based interstate linkages of criminals and crimes. Its 'Pratibimb' module maps locations of criminals and crime infrastructure, giving officers actionable visibility. So far, it has led to the arrest of 12,987 accused, 1,51,984 criminal linkages, and 70,584 cyber investigation assistance requests, helping dismantle organised cyber fraud networks efficiently.[25]

#### **Sahyog Portal**

Sahyog Portal provides a centralized platform for addressing unlawful online content. It enables the automated issuance of removal notices to intermediaries, ensuring swift action against harmful material circulating in cyberspace. It brings together all authorised agencies across India onto a single interface, thereby strengthening the government's ability to respond effectively to unlawful content in a timely

#### **Cybersecurity Exercises**

The Bharat National Cybersecurity Exercise 2025 was conducted from 21st July to 01st August, reaffirming India's commitment to strengthening its cyber resilience. The exercise brought together over 600 participants, including cybersecurity professionals, regulators, and policymakers. The highlight of this exercise was STRATEX, a simulated national cyber breach designed to test real-time inter-agency

coordination and decision-making.[27] **Cybersecurity in focus at India Mobile Congress 2025** At the 9th India Mobile Congress, Cybersecurity will be one of the key focus areas, highlighting India's efforts to protect digital networks and emerging technologies from cyber threats. IMC 2025, themed "Innovate to Transform" will be inaugurated by Prime Minister Shri Narendra Modi from October 8–11 at Yashobhoomi, New Delhi.

IMC 2025 will feature six global summits, including the Cybersecurity Summit and Bharat 6G Symposium, highlighting India's growing leadership in next-generation digital technologies. Key focus areas include 6G, cybersecurity, satellite communications, AI, IoT, and telecom manufacturing.

The event is expected to draw over 1.5 lakh visitors, 7,000+ international delegates, 400+ exhibitors, and showcase more than 1,600 cutting-edge use cases. With 100+ sessions and 800+ speakers, IMC 2025 will serve as a premier platform for global collaboration and innovation.

As India celebrates its rapid 5G rollout, with 1.2 billion mobile subscribers and 970 million internet users, the focus on secure, inclusive, and scalable digital ecosystems reinforces the country's position as a global hub for trusted and transformative digital infrastructure.

#### Forward Path: Cyber Awareness

#### Conclusion

India is at the crossroads of digital transformation and cyber threats, where it has become both an iron pillar of progress and a magnet for cyber fraudsters. Realising the vision of Digital India, the government's multi-layered cyber response team is facilitating fraud prevention and disrupting thousands of scam operations. Advanced forensics, big data analytics, and indigenous tools have bolstered national cyber resilience. Yet, securing India's cyberspace is a shared responsibility where the government and citizens must act together in this combat against cyber frauds.

SRINAGAR, OCTOBER 10: Minister for Education, Social Welfare, Health and Medical Education, Sakeena Itoo chaired a high level meeting at Civil Secretariat here Friday to review the performance, functioning and progress of various ongoing projects of School Education and Higher Education Departments across Jammu and Kashmir.

During the meeting, Minister Sakeena took a comprehensive evaluation of key developmental initiatives, infrastructure projects, and academic reforms being implemented across J&K in both Higher Education and School Education departments. While reviewing the status of ongoing projects in Higher Education department promising on quality. She called for



under various schemes like Rashtriya Uchchatar Shiksha Abhiyan (RUSA), Pradhan Mantri Uchchatar Shiksha Abhiyan (PM-USHA), and CAPEX budget initiatives, the Minister emphasized on the timely execution of all ongoing works, particularly those related to infrastructure development, digital learning facilities, teacher training programs, and curriculum

enhancement. She directed the officers of executing agencies that college construction projects need to be completed within stipulated deadlines without comstringent monitoring and field-level inspections to address delays and remove bottlenecks in project

implementation. Our government is committed to strengthening the educational ecosystem in J&K. Every project, whether in a remote village or an urban hub, must translate into tangible outcomes for students and teachers. Timeliness and accountability are non-negotiable", Minister Sakeena asserted.

The Minister further asked the Director Colleges to maintain close coordination with Chief Engineers so that the projects which require minor works are completed by the faculty positions in colleges, the Minister called upon the officers of Higher Education department to look out for the feasibility of increasing remuneration in favour of Academic arrangement teachers so that more persons are attracted to it till vacancies are filled on regular basis. She also directed the officers to create posts for all newly established degree colleges for better educational outcomes.

The Minister also underlined the need for research-oriented learning, industry linkages, and innovation-driven curriculum reforms. She urged college heads to encourage student-led projects, entrepreneurship cells, and collaborations with reputed institutions to enhance employability and practical learning outcomes.

Similarly, while reviewing the school education department, Minister Sakeena spoke on the importance of digital transformation in school education, directing the concerned officers to expedite the installation of smart classrooms, ICT labs and e-content access facilities to bridge the learning gap, particularly in rural and far-flung areas. Reiterating the government's commitment to inclusive and equitable education, Minister Sakeena said that special attention is being given to educational infrastructure in remote, border and tribal areas, to ensure every child in J&K has access to quality learning opportunities.

The Minister further called upon all the CEOs to utilise funds under

Samagra Shiksha efficiently so that required infrastructure can be created. She further directed the CEOs to monitor projects in their respective districts on a regular basis and maintain coordination with project executing agencies for their early completion.

Taking stock of Human Resource issues, the Minister asked the officers of School Education department to appoint a Nodal Officer in each district for maintaining coordination with ACB for timely obtaining of Vigilance Clearance certificates in favour of employees. She also directed the CEOs to submit report cards on a monthly basis to respective HoDs highlighting progress of ongoing projects and other achievements in every aspect of this vital sector. She also gave directions for early finalisation of proposals for de-freezing of teacher posts for a timely recruitment process.

Highlighting that students in Government schools are equally talented as that of Private schools, the Minister called upon the officers to create awareness among students, especially in far flung areas, regarding JKSOS and NIOS admissions so that they can qualify the 12th level exams in other modes also.

## Kabul to send diplomats to India

NEW DELHI, OCT 10: Kabul will soon send its diplomats to India as part of "step-by-step" efforts to improve bilateral relations, Afghan Foreign Minister Amir Khan Muttagi said on Friday even as he asserted the Taliban will not allow anyone to use Afghan soil against other countries.

Muttaqi, who landed in New Delhi on Thursday on a six-day trip, is the first senior Taliban minister to visit India after the group seized power four years back. India has not yet recognised the Taliban set up.

In an interaction with a small group of journalists, after holding wide-ranging talks with External Affairs Minister S Jaishankar, the Afghan foreign minister invited Indian businesses to invest in his country's mining, minerals and energy sectors.

Muttagi also pitched for India and Afghanistan joining hands to remove obstacles for development of the Chabahar port in Iran in view of the Trump administration bringing it under sanctions.

The Afghan foreign minister's visit to India assumed greater significance as it came at a time when both India and Afghanistan are having frosty relations with Pakistan over a range of issues including cross-border

Muttagi said Kabul will soon send its diplomats to New Delhi.

"The foreign minister (S Jaishankar) said you can send diplomats to New Delhi now. When we go back, we will

select people and send them," he said. In his meeting with Muttaqi, Iaishankar announced the upgrading of India's technical mission in Kabul to the status of an embassy.

The Afghan foreign minister said his country will not allow its territory to be used to "threaten or harm others" and asserted that there is no presence of any terror group including Jaish-e-Mohammed and Lashkare-Taiba in Afghanistan.

Against the backdrop of US President Donald Trump asking the Taliban to hand over the strategic Bagram airbase to US forces, Muttaqi said Kabul will not accept any foreign military presence in the country.

"Afghanistan has a long history of safeguarding its independence and sovereignty and combating occupations. Afghanistan will not allow military interventions or military presence of anyone," he said.

Muttaqi also criticised Pakistan's approach towards Afghanistan while responding to a question on reports of explosions in Kabul on Thursday night.

The foreign minister said Pakistan had a hand in an attack in the border areas and that it was yet to be ascertained how the explosion took place in Kabul.

Health professionals suggest several simple vet effective steps to maintain emotional well-being. "Engage in at least one physical activity daily, as it helps release endorphins that elevate mood. Seek help from mental health professionals when needed. Avoid negative coping mechanisms such as smoking, self-harm, or social isolation. Also, set emotional and occupational boundaries to prevent burnout," doctors advised.

They added that mental illnesses are closely linked to multiple social and behavioural issues, including suicidal tendencies. "Drug addiction remains a major social menace that needs urgent and compassionate redressal," another expert said.

Experts attribute the higher prevalence of mental health issues in J&K to a combination of turmoil, prolonged stress, and vulnerability due to social and political factors. "The stigma surrounding mental disorders, lack of awareness, and delayed treatmentseeking behaviour make the situation worse. We need a joint, sustained effort to change this," a mental health specialist observed.

Doctors called for creating supportive living conditions and promoting early childhood development as longterm measures to improve community mental health. "Interventions such as preschool psychosocial programs, nutritional support, and early emotional care can lay strong foundations for a healthier society," they said.

Strengthening primary healthcare systems to handle mental health disorders is equally crucial. "Mental health treatment should be available at the grassroots level with affordable diagnostic tests and low-cost therapies,' the experts suggested.

They also called for a soft and empathetic approach towards drug addicts, understanding their struggles and addressing root causes rather than solely resorting to punishment.

Doctors further warned that rapid urbanisation, migration, and climate change are emerging as significant stressors. "Economic and social vulnerabilities increase the risk of depression, anxiety, and alcohol use. Displacements caused by extreme weather events and climate-related distress can have longterm mental health impacts on communities," they said.

Experts agreed that a multi-dimensional approach involving families, schools, community leaders, and healthcare institutions is essential to reverse the rising trend of mental health disorders in Jammu and Kashmir. (KNO)

## EC may roll out all-India SIR in phases beginning with states where polls due next year

New Delhi, Oct 10: The Election Commission is likely to roll out pan-India special intensive revision of voters' list in phases beginning with a group of states, including those where assembly polls are due next year, officials said.

At the same time, it will not hold the electoral roll cleanup exercise in states where local body elections are taking place or are due, as the grass roots poll machinery is busy with it and may not be able to focus on SIR, they said

Assembly elections in Assam, Kerala, Puducherry, Tamil Nadu and West Bengal are due in 2026.

Besides these five states, SIR could be held in a few other states in the

The voters' list cleanup exercise has concluded in Bihar where the final list with nearly 7.42 crore names was published on September 30.

Chief Election Commissioner Gyanesh Kumar on Monday said work is



in progress to launch SIR of electoral rolls in all states and a final decision on its rollout will be taken by the Election Commission. Responding to a question at a press conference to announce the Bihar assembly polls, CEC Kumar had said the EC had announced its plan for a pan-India SIR while rolling out Bihar SIR on

The work is on and the three commissioners will meet to decide on dates for various states to launch

their respective SIRs, he said.

According to officials, the EC top brass had asked the state chief electoral officers (CEOs) at a conference here earlier this month to be ready for SIR roll out in the next 10 to 15 days. But for the sake of greater clarity, September 30 deadline was set for them to be ready for the electoral roll cleanup exercise. The CEOs have been told to keep ready the electoral rolls of their states published after the last SIR.

Several CEOs have already put the

voter list published after their last SIR on their websites.

The website of the Delhi CEO has the 2008 voter list when the last intensive revision took place in the national capital.

In Uttarakhand, the last SIR took place in 2006, and that year's electoral roll is now on the state CEO

The last SIR in states will serve as the cut-off date, just as the 2003 voter list of Bihar was used by the EC for intensive revision.

Most states had the last SIR of the voter list between 2002 and 2004. Most of the states have nearly completed mapping of current electors with the voters according to the last SIR in the state or Union Territory (UT). The primary aim of the SIR is to weed out foreign illegal migrants by checking their place of birth.

The move assumes significance in the wake of a crackdown in various states on illegal foreign migrants, including from Bangladesh and

## SC refuses to entertain plea seeking guidelines on suspension, blocking of social media accounts

New Delhi, Oct 10: The Supreme Court on Friday refused to entertain a plea seeking pan-India guidelines for governing social media intermediaries with respect to suspension and blocking of accounts.

The apex court allowed the two petitioners to withdraw the plea and told them that they were free to seek any other remedy available in law before an appropriate forum. A bench of Justices Vikram Nath and Sandeep Mehta was told by the counsel appearing for the petitioners that their WhatsApp, which they used to communicate with the customers, was blocked.

There are other communication applications, you can use that," the bench observed and asked why WhatsApp of the petitioners was blocked.

The petitioners' counsel said no reason was given to them. "What is your fundamental right to have access to WhatsApp?' the bench. It asked the petitioners why they approached the apex court directly with a petition under Article 32 of the Constitution.

The counsel said the petitioners, who have a clinic and a polydiagnostic centre, were communicating with their clients through WhatsApp and had been using the messaging platform for the last 10-12 years. The bench observed that recently an indigenous messaging app has been

The counsel referred to the prayer made in the plea and said the petitioners have sought pan-India guidelines "for governing the social media intermediaries with respect to suspension and blocking of account, ensuring due process, transpar-

"Is WhatsApp or the intermediary, a state?" the bench asked.

When the counsel said "it is not", the bench observed that even a writ petition might not be maintainable before the high court.

Gaganyaan is India's first human space-flight programme, while Bharatiya Antariksh Station is its planned orbital space station. Both the missions are led by the Indian Space Research Organisation (ÎSRO). Shukla said space proiects are not small dreams but are extremely complex missions that India is going to undertake.

"We try to achieve such complex missions and develop the entire ecosystem to enable such

## 'World's largest oil, gas companies involved in under 1.5 pc renewable energy projects'

New Delhi, Oct 10: The world's largest oil and gas producers could be involved in under 1.5 per cent of renewable energy projects globally, a new study has found. Researchers from the Autonomous

University of Barcelona, Spain, looked at 250 of the largest oil and gas producers -- accounting for 88 per cent of the world's hydrocarbon output -- and their stake in 3,166 wind, solar, hydro, and geothermal projects.

"We find that the largest 250 oil and gas companies only own about 1.42 per cent of the global renewable energy capacity in operation," the authors wrote in the study published in the journal Nature Sustainability. Results also showed that only a fifth

of the 250 companies analysed own a renewable energy project in operation, with renewable energy representing a mere 0.1 per cent of their primary energy The study looked at the largest oil and gas producers in the 'Global Oil and Gas

rights organisation. "Oil and gas companies' renewable deployment is anecdotal at best. Their contribution to the fight against the climate crisis should be judged solely by how

much fossil fuel they leave in the ground," lead author Marcel Llavero-Pasquina, a researcher at the university, said.

A shift towards renewable sources of energy, including solar and wind, is said to be crucial for slashing greenhouse gas emissions -- primary driver of climate change.

The study's findings raise concerns for institutions and organisations that continue engaging with fossil fuel companies under the assumption that they are key players in the energy transition, the researchers said.

"After decades of empty words, it is time for governments, universities and public institutions to recognise that the fossil fuel industry will always be part of the problem, not the solution to the climate crisis," Llavero-Pasquina said.

"Oil and gas companies should not have a seat at the table where the future of climate and energy policy is decided," the lead author added.

### **Suniel Shetty moves HC** against misuse of his photos on social media



Mumbai, Oct 10: Actor Suniel Shetty has moved the Bombay High Court seeking protection of his personality rights, claiming that several social media pages and websites were using his photographs to promote their business without any authorisation.

The actor, in an interim application, sought the court to order all such websites to immediately remove his photographs and restrain them from using the same in future. A Bench of Justice Arif Doctor on Friday briefly heard Mr. Shetty's counsel Birendra Saraf and reserved its order on the plea. Mr. Saraf pointed out that fake images of Mr. Shetty and his grandchild were on some websites. The plea claimed that the actor's photos were being used commercially without any authorisation.

Mr. Saraf submitted that the website of a real agency and a gambling site have displayed the actor's photo even though he is not associated with them.

The actor, in the plea, claimed that he had a right over his personality and photos, and passing them off without authority was damaging his reputation.

## Can a vegetarian diet increase uric acid levels? Here's what science says and how to fix it

New Delhi, Oct 10: Vegetarian diet is now more popular than ever, due to its long list of health benefits, such as a lowered risk of heart disease, diabetes and also certain types of cancer, you name it and a veg diet is the key! A diet full of veggies, legumes is also thought by many to regulate uric acid and prevent gout, an excruciating form of arthritis due to the accumulation of uric acid crystals in the joints. But, the question here is, do vegetarian diets actually increase the levels of uric acid in the body? Or is it just a myth! The answer is not a simple yes or no, and there is emerging research that tells us how different vegetarian foods influence uric acid and what individuals must keep in mind. What is uric acid

Uric acid is a byproduct that forms as the body metabolizes purines, chemicals found in some foods and naturally in the body. In normal circumstances, uric acid dissolves in the blood, travels through the kidneys, and is passed in the urine. When uric acid formation outpaces excretion, or when the kidneys are damaged, uric acid builds up in the blood, known as hyperuricemia.



When uric acid levels in the body increases, they start to crystallise and precipitate, withing the tissues and joint, leading to bodily inflammation, that is the underlying cause of several chronic diseases. Apart from gout, excess uric acid has also been associated with kidney stones and cardiovascular disease risk.

Increased levels of uric acid and a veg diet, what's the link Scientists at the National

Center for Biotechnology Information (NCBI) published a report that summarized the impact of vegetarian diet on serum uric acid levels. The study has established that a lacto-vegetarian diet, food plans consisting of dairy foods and plant foods, is linked with decreased serum



of hyperuricemia and gout. This is mainly because the overall purine content of plant-based foods is lower than foods based on animals like seafood and red meat, which are well-documented stimuli for excessive uric acid.

The Hidden risks within a vegetarian diet

While these diets confer these advantages, vegetarian diets are not necessarily purine-free. Plant foods contain some plant foods like soy products, beans, mushrooms, cauliflower, spinach, and some sea vegetables which are of moderate purine content. Eating very large amounts of these will lead to excess uric acid levels, especially in those with a genetic predisposition or underlying

An exemplary case study in the International Journal of Clinical Biochemistry and Research documents this complication. It documented a middle-aged gentleman, after embracing a vegetarian diet that was high in purine-rich foods such as cauliflower, mushrooms, and beans, who was diagnosed with acute gouty arthritis. This took place in the absence of a previous history of gout, diabetes, or other common risk factors. His familial tendency predisposed him to overproduction of uric acid, although. The case reminds us that, despite vegetarianism, the choice of food does count, particularly in those who are at risk of hyperuricemia.

What vegetarians and those at risk need to remember

Moderation is the key: Consuming a variety of plant-based food items, but in moderation, such as avoiding high purine vegetables such as mushrooms, asparagus, spinach, and legumes if you have high uric acid or gout

Consume dairy products: In case of lacto-vegetarian diet, intake of dairy may be helpful in reducing the level of uric acid.

Hydrate yourself: Intake of water keeps kidney function up

and aids in expulsion of uric acid from the body.

Avoid sugary drinks and alcohol: Sweetened drinks and alcohol, particularly beer, trigger uric acid production and increase gout.

What does it mean for people who are vegetarians Vegetarian diets offer protec-

tion from high uric acid and gout over animal protein-rich diets. Yet, vegetarian foods are not all equal concerning purines, and some vegetables and fruits contain a high amount of purines and raise uric acid if consumed overboard. Those at risk need to be careful of food consumed and in what quantity.

As long as the diet is adopted with a balance, varied vegetarian content that is purine-poor, along with large fluid intakes, and in conjunction with lifestyle changes, healthy uric acid levels can be sustained and the development of gout and gout-related complications prevented. By being aware of these nuances. vegetarians are enabled to benefit from the health-contributing elements of their food choice while ensuring their joint as well as their renal health.

## Israeli Cabinet approves 'outline' of deal to release hostages held by Hamas

Cairo, Oct 10: Israel's Cabinet early Friday approved President Donald Trump's plan for a ceasefire in the Gaza Strip and the release of all the remaining hostages held by Hamas, a key step toward ending a ruinous two-year war that has destabilized the Middle East.

A brief statement from Prime Minister Benjamin Netanyahu's office said the Cabinet approved the "outline" of a deal to release the hostages, without mentioning other aspects of the plan that are more controversial.

The broader ceasefire plan included many unanswered questions, such as whether and how Hamas will disarm and who will govern Gaza. But the sides appeared closer than they have been in months to ending a war that has killed tens of thousands of Palestinians, reduced much of Gaza to rubble, brought famine to parts of the territory and left dozens of hostages, living and dead, in Gaza.

The war, which began with Hamas' deadly attack on Israel on Oct. 7, 2023, has also triggered other conflicts in the region, sparked worldwide protests and led to allegations of genocide that Israel

Some 1,200 people were killed in the Hamas-led assault, and 251 were taken hostage. In Israel's ensuing offensive, more than 67,000 Palestinians have been killed in Gaza and nearly 170,000 wounded. In the



hours leading up to the Israeli Cabinet's vote, Israeli strikes continued. Explosions were seen Thursday in northern Gaza, and a strike on a building in Gaza City killed at least two people and left more than 40 trapped under rubble, according to the Palestinian Civil Defense. At least 11 dead Palestinians and another 49 who were wounded arrived at hospitals over the past 24 hours, Gaza's Health Ministry said.

An Israeli military official who spoke on the condition of anonymity in line with military guidelines said Israel was hitting targets that posed a threat to its troops as they reposition. Hamas blasted Israel over the strike, saying Netanyahu was trying to "shuffle the cards and confuse" efforts by mediators to end the war in Gaza.

A senior Hamas official and lead negotiator made a speech Thursday laying out what he says are the core elements of the ceasefire deal: Israel

releasing around 2,000 Palestinian prisoners, opening the border crossing with Egypt, allowing aid to flow and withdrawing from Gaza.

Khalil Al-Hayya said all women and children held in Israeli jails will also be freed. He did not offer details on the extent of the Israeli withdrawal from Gaza.

Al-Hayya said the Trump administration and mediators had given assurances that the war is over, and that Hamas and other Palestinian factions will now focus on achieving self-determination and establishing a Palestinian state.

"We declare today that we have reached an agreement to end the war and the aggression against our people," Al-Hayya said in a televised speech Thursday evening.

In other developments, US officials announced that they would send about 200 troops to Israel to help support and monitor the ceasefire deal as part of a broader, international team. The officials spoke on condition of anonymity to discuss details not authorized for release

Cautious celebrations

In the southern Gaza city of Khan Younis, reactions to the announcement of a ceasefire were relatively muted and often colored by grief.

"I am happy and unhappy. We have lost a lot of people and lost loved ones, friends and family. We lost our homes," said Mohammad Al-Farra. "Despite our happiness, we cannot help but think of what is to come. ... The areas we are going back to, or intending to return to, are uninhabitable."

In Tel Aviv, families of the remaining hostages popped champagne and cried tears of joy after Trump announced the deal.

In Jerusalem on Thursday, Sharon Canot celebrated with some others.

'We are so excited this morning. We cried all morning," she said. "It's been two years that we are in horror.'

Under the terms, Hamas intends to release all living hostages in a matter of days, while the Israeli military will begin a withdrawal from the majority of Gaza, people familiar with the matter told The Associated Press. They spoke on condition of anonymity to discuss details of an agreement that has not fully been made public. Some 20 of the 48 hostages still in captivity are believed to be alive.

In a short video posted by US Commerce Secretary Howard

Lutnick, Trump was seen speaking by phone to a group of elated hostage families.

They are all coming back on Monday," said Trump, who is expected to visit the region in the coming

Tom Fletcher, the UN humanitarian chief, told reporters Thursday that officials have 170,000 metric tons of medicine, aid and other supplies at ready for transport into Gaza when they are given a green light. How the deal will unfold

The deal, which was expected to be signed in Egypt, will include a list of prisoners to be released and maps for the first phase of an Israeli withdrawal to new positions in Gaza, according to two Egyptian officials briefed on the talks, a Hamas official and another official.

Israel will publish the list of the prisoners, and victims of their attacks will have 24 hours to lodge

The withdrawal could start as soon as Thursday evening, said the officials, who spoke on condition of anonymity because they were not authorized to be publicly named speaking about the negotiations. The hostage and prisoner releases are expected to begin Monday, the officials from Egypt and Hamas said, though the other official said they could occur as early as Sunday night.

Five border crossings would reopen, including the Rafah crossing between Gaza and Egypt, the Egyptian and Hamas officials said.

The Trump plan calls for Israel

to maintain an open-ended military presence inside Gaza, along its border with Israel. An international force, comprised largely of troops from Arab and Muslim countries, would be responsible for security inside Gaza. The US would lead a massive internationally funded reconstruction effort.

The plan also envisions an eventual role for the Palestinian Authority – something Netanyahu has long opposed. But it requires the authority, which administers parts of the West Bank, to undergo a sweeping reform program that could take

"He's much more popular today than he was five days ago," Trump said. "I can tell you right now, people shouldn't run against him. Five days ago, might not have been a bad idea.

#### Trump proposes barring Chinese airlines flying over **Russia on US flights**

Washington, Oct 10: The Trump administration on Thursday proposed banning Chinese airlines from flying over Russia on flights to and from the United States, saying the practice puts American carriers at a disadvantage.

US airlines have long criticized the decision to allow Chinese carriers to fly over Russia on some flights because it which gives them the advantage of decreased flying time and burning less fuel.

The US Transportation Department said on Thursday in its proposed order "this imbalance has become a significant competitive factor." USDOT said it was proposing to bar Chinese overflights "to level this competitive disparity among US and Chinese air carriers.'

The Chinese embassy in Washington did not have an immediate comment.

Russia has barred US airlines and other foreign carriers from flying over its airspace in retaliation for Washington banning Russian flights over the US in March 2022 after the country invaded Ukraine.

The decision could impact some US flights operated by Air China, China Eastern, Xiamen Airlines and China Southern.

#### Spain says 'committed to NATO' after Trump expulsion threat

Madrid, Oct 10: Spain hit back at Donald Trump on Friday after the US President suggested expelling the country from NATO for failing to meet his ramped-up defense spending target.

In June, the 32-nation military alliance agreed to massively boost defense spending to five percent of annual economic output over the next decade under pressure from

But Spain, which was NATO's lowest defense spender in relative terms last year, insisted it would not need to hit the headline figure.

"We had one laggard, it was Spain," Trump told reporters in the Oval Office on Thursday. 'They have no excuse not to do

this, but that's all right. Maybe you should throw them out of NATO, frankly."

Government sources said on Friday that "Spain is a committed and full member of NATO. And it meets its capacity targets as much as the United States."

Socialist Prime Minister Pedro Sanchez has argued that Spain should meet its capacity objectives rather than fixed spending targets, including cybersecurity and the environment in his calculations.

### Asia Cup trophy locked in ACC office, instruction from Naqvi not to move without his approval

Dubai, Oct 10: The Asia Cup trophy, which was not presented to the victorious Indian team after its refusal to accept it from Asian Cricket Council chief Mohsin Naqvi, has been locked away at the ACC's Dubai headquarters with "instructions that it should not be moved or handed over" without the Chairman's approval.

The trophy has been at the ACC office after Naqvi walked away with it from the presentation ceremony following the Indian team's refusal to accept it from him. India beat Pakistan in the Asia Cup final in Dubai on September 28.

Naqvi is also the Pakistan Cricket Board (PCB) Chairman and the Interior Minister of his country and India-Pakistan tensions have hit a peak after the Pahalgam ter-"As of today the trophy is still in ACC offices in Dubai with clear intructions from Naqvi that it should not be moved or handed over to anyone without his approval and in person presence," a source close



to Nagvi told PTI.

"Naqvi has given clear instructions that only he will hand over the trophy in person (whenever that happens) to the Indian team or BCCI," he added. owed by Indo-Pak hostilities. The Indians refused to shake hands with the arch foes throughout the tournament and players from both sides mocked each other with politically

charged gestures. Naqvi too made political state-

ments on his social media pages. The BCCI took strong exception

to his act of walking away with the ter in an ICC meeting next month. It is being widely speculated that a strong move to get Naqvi censured and even removed as Director in the ICC could be made.

## María Corina Machado of Venezuela wins Nobel Peace Prize



Stockholm, Oct 10: The former opposition presidential candidate in Venezuela was lauded for being a "key, unifying figure in a political opposition that was once deeply divided – an opposition that found common ground in the demand for free elections and representative government," said Jørgen Watne Frydnes, chair of the Norwegian Nobel committee.

Experts say the committee typically focuses on the durability of peace motion of international fraternity and the quiet work of institutions that strengthen those goals. There has been persistent speculation ahead of the announcement about the possibility of the prize going to

US President Donald Trump, fueled in part by the president himself, amplified by this week's approval of his plan for a ceasefire in the Gaza Strip. But longtime Nobel watchers say his chances remain remote despite various notable foreign policy interventions for which he has taken personal credit.

Groups cited as possible winners by the Peace Research Institute Oslo include Sudan's Emergency Response Rooms, a community-led network that has become the backbone of the country's humanitarian response to its civil war; the International Court of Justice and the International Criminal Court; and the Committee to Protect Journalists, US-based group that promotes press freedom and compiles a list of journalists killed on duty. Last year's award went to Nihon Hidankyo, a grassroots movement of Japanese atomic bombing survivors who have worked for decades to maintain a taboo around the use of nuclear weapons.

The peace prize is the only one of the Nobel prizes to be awarded in Oslo, Norway.Four of the other prizes have already been awarded in the Swedish capital, Stockholm this week — in medicine on Monday, physics on Tuesday, chemistry on Wednesday and literature on Thursday.

### Thakur to lead Mumbai, Sarfaraz, Rahane included in squad

Mumbai, Oct 10: India all-rounder Shardul Thakur was on Friday appointed Mumbai captain while Sarfaraz Khan and Ajinkya Rahane also were included in their 16-member squad for their Ranji Trophy 2025-26 season opener against Jammu and Kashmir.

Thakur succeeds Rahane as Mumbai skipper after the former left his role ahead of the new season.

The 42-time champions Mumbai will take on Jammu and Kashmir in their first match of the Ranji season at Srinagar's Sher-I-Kashmir Stadium from October 15-18.

Mumbai, who had lost their last match to J&K in the previous season by five wickets here, are placed in Elite Group D along with Himachal Pradesh, Delhi, Hyderabad, Rajasthan,

Chhattisgarh and Pondicherry. The squad includes India batter Sarfaraz who has been out of national reckoning from the Test side, as well as all-rounder Shivam Dube, who mostly features in T20Is for the national team.

Musheer Khan, who had missed majority of the last domestic season 2024-25 after a car accident, finds his place back in the 16-member squad. Mumbai and Chennai Super Kings opener opener Ayush Mhatre, who has also captained India U-19 teams during their recent tours of England and Australia, has been named in the Mumbai

The squad, however, is without Shreyas Iyer who has taken a break from redball cricket due back-related issues, and Prithvi Shaw, who has moved to Maharashtra after losing his spot during the last season.


