Terrorists, their supporters peddled false narratives for decades to whitewash Pakistan's sins: LG Sinha

Vows culprits will be brought to justice | Meets terror victim families at Dardpora, assures help | Says NOKs of 250 sufferers given appointment letters

Kupwara (Dardpora), Oct 15: Assuring full support and assistance to terror victim families, Lieutenant Governor Manoj Sinha on Wednesday said that elements who peddled false narratives for decades at Pakistan's behest will

not be spared. LG Sinha, according to the news agency-Kashmir News Observer (KNO) visited Dardpora in North Kashmir and met the families of civilian martyrs killed by Pakistanbacked terrorists.

While addressing the terror victim families, the Lieutenant Governor said, "The culprit Pakistani terrorists and their support system in the valley ran a false narrative for three decades to absolve terror country Pakistan for its sins."

"Pakistan, the breeding ground of terrorism, is exposed now and those involved

in peddling a fake narrative on behalf of terrorists will be brought to justice," he said.

He assured the terror victim families of proper rehabilitation and strictest punishment to the culprits. "Justice, respect and dignity to family members of civilian martyrs killed by Pakistan-backed terrorists is top priority of the government," he said, adding, "The criminal justice system will ensure perpetrators and elements of the terror ecosystem are punished, providing a sense of justice and closure for victim's family and the

"I have assured the family members that their decadeslong trauma, torment and suffering is over. We will ensure all the support so that they can reclaim their lives," the

Lieutenant Governor said. He also observed that families of civilian martyrs have gone through deep trauma,



suffered various challenges including unemployment and education and felt loss of hope in the past three decades.

"Families of civilians who were killed by Pakistanbacked terrorists also suffered

systemic barriers which stifled their progress. They were denied their rights and access to resources. All obstacles are now removed and we are ensuring justice and dignity for terror victim families," he said.

So far around 250 terror victim families have been provided with government jobs. This mission will continue till justice is done to every affected family. This is the beginning of a new era of justice in Jammu Kashmir."

The Lieutenant Governor paid homage to the civilians who were mercilessly killed by Pakistan sponsored terrorists in Jammu Kashmir. The families of terror victims also narrated their ordeal. "It is difficult to articulate the pain

and suffering of terror victim families due to their profound emotional and psychological trauma and the administration will handle each case with full sensitivity and responsibility.

He said, "So far around 250 terror victim families have been provided with government jobs. This mission will continue till justice is done to every affected family. This is the beginning of a new era of justice in Jammu Kashmir," the Lieutenant Governor said.

Recalling his earlier inter-actions with victims' families in 2024, the LG said many had lost their breadwinners to terrorism, leaving them in deep distress. "Some families received government jobs, but many others continued to struggle. After reviewing their situation with officials, we collectively decided that every district must take responsibility for rehabilitating such families", he added.

The Lieutenant Governor also promised action on pending cases. "If FIRs have not been registered in any circumstances, the FIRs will be registered," he said.

He also spoke on the Memorandum of Understanding signed between the High-range Rural Development Society (HRDS India) and Divisional Commissioner Jammu and Commissioner Divisional Kashmir, under which the houses of terror victims having their own land will be constructed. Under the initiative, the HRDS India and Divisional Commissioners of both the divisions will identify terror victim families whose houses were destroyed by the terrorists.

Reiterating the administration's stand, LG Sinha said the government stands with every innocent victim of terrorism. 'Together we will build a peaceful, prosperous and self-reliant Jammu and | More on P6

Pressure to deliver mounts as Omar-led govt completes one year in office

From comprehensive job package to reinstating free education, people await progress on manifesto vows; opposition slams NC regime for 'failure'

Srinagar, Oct 15: The pressure to deliver on the promises has been mounting for the ruling regime in Jammu and Kashmir as the National Conference (NC) government completed one year in office on Wednesday, while all the promises from one lakh jobs to free units of electricity and 12 gas cylinders remain unfulfilled.

On October 16, 2024, the first government in the Union Territory of Jammu and Kashmir, led by Omar Abdullah, assumed office here after the NC-Congress alliance secured an absolute majority in the Jammu and Kashmir Assembly elections, winning 48 seats. NC carried the alliance to victory by winning 42 seats, while Congress could win only six seats.

According to the news agency-Kashmir News Observer (KNO), the mood across Jammu and Kashmir is a mix of cautious hope and growing impatience.

Riding a wave of optimism, the NC swept to power last year, pledging 12 flagship promises made on the party's manifesto ahead of the 2024 Assembly elections.

Yet, as the government marks its first anniversary, many of those promises remain in the realm of rhetoric.

The ruling regime after taking over has kept its promise so far only on passing the resolution on statehood restoration in the first Assembly Session while the other pledges like free 200 units of electricity, 12 gas cylinders to economically weaker sections,

Rs 5,000 per month to women belonging to EWS, establishing a medical trust to fight against serious diseases like cancer. reinstating free education up to the university level have remained unfulfilled.

The NC had also promised a comprehensive job package for youth, and redrawing the Jammu and Kashmir Reorganisation Act, 2019, and the Transaction of Business of the Government of Union Territory of Jammu and Kashmir Rules, 2019 have also been oversighted so far.






Private schooling costs parents over 'Rs 37,000'

Srinagar, Oct 15: In Jammu and Kashmir, on an average a student of private senior secondary institute bears a cost of over Rs 37,000 on school expenditure during the current academic year.

Besides, the students of government secondary schools also spent over Rs 14,000 on school expenditure during the current academic year.

The official figures reveal that on an average, a senior secondary student in both rural and urban areas of Jammu and Kasmir reported spending of Rs 37,291 on school expenditure during the current academic year. It also states that on an average the student government higher secondary spends at least Rs 14,652 on school expenditure during the current academic year. Earlier



in September, KNO reported that in Jammu and Kashmir, 87 percent of students are paying course fees in schools. However, on the

contrary only 57.1 percent students pay such charges at the national level.

The official figures reveal that at least 87

percent of students reported expenditure on course fees by level of current enrolment for Jammu and Kashmir including 89.3 percent among the male and 84.3 percent among the female students.

It also said that the national percentage of students reported expenditure on course fees by level of current enrollment for each state and UT was 57.1 percent in 2025.

According to the official figures, in the rural areas of Jammu and Kashmir, 85 percent persons including 87.7 percent males and 81.7 percent females enrolled in school reported expenditure on course fees by level of current enrolment.

Likewise, in the urban areas of Jammu and Kashmir at least 96.1 percent persons enrolled in school reported expenditure on course fees by level of current enrolment. This includes 95.9 percent of male and 96.3 percent female students respectively—(KNO)

Jammu, Oct 15: In a move poised to leverage family legacy and voter sympathy, the Bharatiya Janata Party (BJP) on Wednesday officially announced Devyani Rana as its candidate for the high-stakes Nagrota Assembly bypoll, setting the stage for a fiercely contested battle in the Jammu region.

The announcement comes just weeks before the November 11 polling date, with the constituency – a traditional BJP stronghold – having fallen vacant following the untimely death of Devyani's father and senior BJP leader Devender Singh Rana, on October 31, 2024.

Devyani Rana, 32, the daughter of the late MLA and niece of Union Minister Jitendra Singh, expressed unbridled confidence in carrying forward her father's "winning streak" during a media interaction at her residence in Jammu.

Surrounded by jubilant BJP workers and supporters who celebrated the news with traditional dhol beats, she stated, "I would like to continue with my father's winning streak. I have received a lot of love and blessings from the people, especially the youth, and the party. We are confident of winning. The work done over the past year has been appreciated by people. I intend to take history in the 2024 Jammu and

for Nagrota."

Committee (CEC) cleared Devyani's name alongside Aga Syed Mohsin for the Budgam seat in Kashmir, as confirmed in an official release from the party headquarters in New Delhi.

This decision overrides speculation around other contenders like Nand Kishore Sharma and Anil Sharma, banking instead on the sympathy wave generated by Devender Rana's passing.

dynamics since 1996. Meanwhile, Jammu and Kashmir Panthers Party (India) Chairman and former Minister Harsh Dev Singh on the same day issued a fervent appeal to the NC and Congress – allies in the ruling INDIA bloc – to back him as their consensus opposi-

Positioning himself as a viable

alternative to the BJP's "dynastic politics", Singh argued that a united front was essential to counter the ruling party's dominance in Nagrota, a seat where the NC-Congress alliance had faltered in 2024 by fielding separate

In a statement shared via social media and addressed to NC president Farooq Abdullah and Congress leaders, Harsh Dev Singh said, "I make a strong appeal to the National Conference (NC) and Congress to support me as the consensus candidate from the INDIA Alliance in the upcoming Nagrota assembly by-poll elections. The people of Nagrota deserve a united opposition voice against the BJP's machinery, not fragmented efforts that dilute our strength. Let us set aside differences for the greater good of democracy and the aspirations of the youth and marginalized sections in our constituency."

Singh, a two-time former MLA from the Ramnagar (now reserved post-delimitation), highlighted his grassroots connect with people during the tenure as Education Minister in Mufti Sayeed's government during 2002-2006. He cautioned that without unity, the bypoll could reinforce BJP's grip, potentially at the expense of the coalition's broader agenda on statehood restoration and regional equity.

The appeal comes amid act—(KNO)

reported strains within the NC-Congress partnership, which failed to consolidate votes in Nagrota during the last polls – NC's Joginder Singh polled 17,641 votes, while Congress's Balbir Singh managed 5,979.

Neither the NC nor Congress has announced its candidate yet, leaving room for Singh's overture.

Political analysts view this as a tactical bid by the Panthers Party leader to exploit alliance fissures, especially as the bypoll serves as a litmus test for the ruling coalition's cohesion post the 2024

Nagrota, encompassing parts of Jammu district with a diverse voter base including urban professionals, farmers, and ex-servicemen, remains a prestige battleground.

The BJP's 2024 triumph here was pivotal in its Jammu sweep, contrasting with the NC's Valley dominance. With counting slated for November 14, the bypoll – alongside Budgam – is expected to draw national attention, gauging public mood on governance, development, and the push for I&K's full statehood.

As campaigns gear up, Devyani Rana's camp is already mobilizing on themes of continuity and progress, while Harsh Dev Singh's plea underscores the opposition's high-wire

"We have sat together, even when he was a minister. My intention is not to criticize, but to advise. I hope he doesn't take my words otherwise," he added.

On political issues, Choudhary responded to Sajad Lone's alleged remarks targeting another politician.

"He directly accused Rajesh of being with the BJP. My question is: if you're against the BJP, then support the candidate who is contesting against them. Why abstain? Why not take a stand?" he asked.

Calling it a "test of sincerity," the Deputy CM said that this is the time for all leaders and self-proclaimed sympathizers of Jammu and Kashmir to show where they truly stand.

Police arrest 3 accused in Qamarwari axe attack case



Srinagar, Oct 15: Srinagar Police on Wednesday said to have arrested three individuals involved in an axe attack on 18-year-old boy near Haroon Bakery, Qamarwari, on October 14 (Tuesday).

The police said the arrests were made during overnight raids across the city, and the weapon used in the assault has been recovered. A police spokesperson in a statement said that in a swift and effective response to a violent assault in Qamarwari, Srinagar Police have arrested all three accused persons involved in the case during a series of overnight raids conducted across different parts of the city.

The statement reads, the incident occurred on October 14, 2025, near Haroon Bakery at Hilal Abad, Qamarwari, where a youth, Noman Yaqoob Khanday, was attacked with an axe by unidentified

The victim's father, Mohd Yaqoob Khanday, a resident of Bilal Colony, Qamarwari, promptly reported the matter at Police Post Qamarwari.

It reads, upon receipt of the complaint, a case FIR number 100/2025 under relevant sections of the Bharatiya Nyaya Sanhita (BNS) — Sections 126(2), 115(2),

and 109 - was registered at Police Station Parimpora.

"An intensive investigation was immediately launched, which included cordoning off suspected areas, collecting CCTV footage, and verifying vehicle details linked to the incident. The probe led to the identification and subsequent arrest of the following accused individuals: Sahil Yaqoob Grustoo, son of Mohd Yaqoob Grustoo, resident of Boatman Colony; Farooq alias Farhan Ahmad Dar, son of Gh. Nabi Dar, resident of Boatman Colony and Bilal Ahmad Guroo, son of Zahoor Ahmad Guroo, resident of Boatman Colony, Bemina,"it reads.

The statement reads, all three were apprehended during overnight raids, and the weapon of offence has been recovered. Preliminary investigation indicates that the assault stemmed from a personal grudge, though further inquiry is ongoing to determine other possible angles. Multi-pronged strategy needed to combat rising drug abuse among youth

The alarming spread of drug abuse in Jammu and Kashmir has evolved from a law-and-order issue into a full-blown public health crisis. This threatens to derail an entire generation. Collective action is needed; government efforts alone cannot stem this tide. The fight against narcotics demands a societal response that combines enforcement with empathy, and policy with public participation. The statistics are

sobering. From urban centres to remote villages, substance abuse has infiltrated homes, schools, and workplaces, leaving broken families and shattered futures in its wake. What begins as experimentation often spirals into addiction, fueling cycles of crime, poverty, and disease. While the government's initiatives, which include awareness campaigns, treatment facilities, and youth engagement programs like the Red Run Marathon, are

commendable, they represent only one front in this multi-dimensional war. Families must become the first line of defence, recognising behavioural changes and seeking early intervention. Educational institutions should integrate substance abuse prevention into curricula, equipping students with resilience and critical thinking. Religious and community leaders can leverage their moral authority to destigmatise addiction and promote

rehabilitation. Equally crucial is targeting the supply chain. Law enforcement must dismantle trafficking networks with zero tolerance, while financial investigations trace and seize illicit proceeds. The judiciary can ensure speedy trials to deliver deterrence. However, enforcement must be balanced with compassion. Addiction is a disease, not a crime, and rehabilitation should focus on reintegration, not retribution. Counselling,

vocational training, and post-recovery support can empower survivors to rebuild their lives. Jammu and Kashmir stands at a cross-roads. By uniting government agencies, civil society, and citizens in a sustained, multipronged strategy, we can reclaim our youth from the grip of addiction. The time for isolated efforts is over; only through collective resolve can we secure a drug-free future for our society.

The Growing Relevance Of Traditional Medicine

The ancient system can offer sustainable health-care solutions in an era of climate change and lifestyle diseases

The World Health Organization (WHO) reports that traditional medicine is practised in 88% of its member-states — 170 out of 194 countries. For billions, particularly in lowand middle-income nations, it remains the primary form of health care due to accessibility and affordability considerations. Yet, its significance extends beyond treatment, supporting biodiversity conservation, nutrition security, and sustainable livelihoods.

Market projections underscore this growing acceptance. Analysts estimate that the global traditional medicine market will reach \$583 billion by 2025, with annual growth rates of 10%- 20%. China's traditional Chinese medicine sector is valued at \$122.4 billion, Australia's herbal medicine industry at \$3.97 billion, and India's Ayurveda, Yoga and Naturopathy, Unani, Siddha and Homoeopathy (AYUSH) sector at \$43.4

This expansion reflects a fundamental shift in health-care philosophy — from reactive treatment models to proactive, preventive approaches that address root causes rather than symptoms alone.

India's Ayurvedic transformation

India's traditional medicine sector has witnessed remarkable transformation. The AYUSH industry, comprising over 92,000 micro, small and medium enterprises, has expanded nearly eight-fold in less than a decade. Manufacturing sector revenues have grown from 21,697 crore in 2014-15 to over 1.37 lakh crore currently, while the services sector has generated 1.67 lakh crore in revenue.

India now exports AYUSH and herbal products worth \$1.54 billion to more than 150 countries, with Ayurveda gaining formal recognition as a medical system in several



nations. This represents both economic opportunity and soft power projection on the global stage.

The first comprehensive survey on AYUSH by the National Sample Survey Office (2022-23) revealed near-universal awareness — 95% in rural areas and 96% in urban centres. Over half the population reported using AYUSH systems in the preceding year, with Ayurveda emerging as the preferred choice for rejuvenation and preventive care.

Scientific validation, global expansion India has invested significantly in research through institutions including the All India Institute of Ayurveda, the Institute of Teaching and Research in Ayurveda, the

National Institute of Ayurveda, and the Central Council for Research in Ayurvedic Sciences. These institutions focus on clinical validation, drug standardisation and develop-

ing integrative care models that combine

traditional knowledge with modern medical practices.

India's global Ayurveda outreach has achieved unprecedented scale through the Ministry of AYUSH's International Cooperation Scheme. India has signed 25 bilateral agreements and 52 institutional partnerships, established 43 AYUSH Information Cells across 39 countries, and positioned 15 academic chairs in foreign universities.

The establishment of the WHO Global Traditional Medicine Centre in India represents a significant milestone. Supported by the Government of India, the centre aims to harness traditional medicine's potential through modern science, digital health and emerging technologies including artificial intelligence.

WHO's recent publication on AI integration in traditional medicine highlights how advanced technologies can strengthen clinical validation, enable big-data analytics, and enhance predictive care within Ayurveda and related systems.

The theme this year Ayurveda's core philosophy of balance — between body and mind, humans and nature, consumption and conservation — offers relevant solutions for contemporary challenges. As the world grapples with lifestyle diseases and climate change, Ayurveda provides a framework that addresses both personal and planetary health.

As India leads efforts to mainstream traditional medicine globally, the approach emphasises health care that is preventive, affordable, inclusive and sustainable. Ayurveda represents not merely a medical system but a wellness movement that bridges traditional knowledge with contemporary needs.

The convergence of ancient wisdom with modern science and technology positions traditional medicine systems to play an increasingly important role in global health architecture. Ayurveda Day this year serves as a reminder of the potential for traditional knowledge systems to contribute to a more balanced and sustainable future for people and the planet.

How To Train Yourself To Be More Open-Minded

hen we talk about media literacy, the focus is often on skills such as checking sources, spotting logical fallacies, or identifying manipulated images. This approach, sometimes called "prebunking," aims to expose people to common misinformation tactics before they encounter them in the wild. These strategies are valuable, and I've both studied and advocated for them. But our mindset matters too.

Cultivating open-mindedness or intellectual humility can help protect us against polarization and misinformation. Crucially, these mindsets aren't fixed. New research shows we can train ourselves to think more openly, which in turn improves our ability to separate facts from falsehoods.

What the Research Found

Researchers conducted two experiments to test whether people could be "prebunked" against the common pitfalls of closed-minded thinking. Participants received a brief message reminding them that most people agree it's important to weigh evidence carefully (a subtle use of social norms). Then they were warned about five common reasoning traps:



Being overconfident in your position Ignoring alternative viewpoints Believing you understand something until asked to explain it

Only seeking evidence that supports your opinion

Twisting all evidence to fit your view

This short intervention significantly increased Actively Open-Minded Thinking (AOT), which is a cognitive style that involves questioning assumptions, considering alternatives, and avoiding overconfidence. That shift produced measurable ripple effects.

In both studies, this brief intervention increased actively open-minded thinking (AOT) compared to a control group. In Study 1, participants became less likely to believe conspiracy theories and more cautious about what they shared online. The second study replicated the boost in AOT and the indirect reduction in conspiracy beliefs, and additionally found that the intervention directly improved people's ability to discern factual information from falsehoods

Why This Matters

We all have moments when it's easier to double down than to pause and reconsider. This research suggests open-mindedness isn't a fixed trait; it's a trainable mindset. A simple reminder to think carefully can strengthen our defenses against being misled.

How to put it into practice:

Pause before you share. Ask whether the content avoids the five pitfalls above.

Play devil's advocate with yourself. Before committing to a strong opinion, ask: "What would change my mind?" Reflect on why you consider it important and how you came to that conclusion.

Be humble about what you know. Try explaining your view clearly and thoroughly; if you can't, dig deeper. This connects to my "Revise" step on having more productive conversations as well.

Normalize curiosity. Create spaces where questioning, double-checking, and admitting uncertainty are expected. It's easier when you surround yourself with thoughtful, curious people.

The Bigger Picture

Strengthening AOT may protect against many kinds of misleading beliefs, not just political misinformation but also pseudoscience and health myths. In a world where conflict entrepreneurs, charlatans, and attention-driven social media platforms compete for our focus, cultivating open-minded thinking is a simple but powerful habit we can build, train, and cultivate.

Ensure benefits of Govt schemes reach tribal communities: Rana

Calls for multi-pronged strategy to accelerate tribal empowerment

SRINAGAR, OCTOBER 15: Minister for Tribal Affairs, Javed Ahmed Rana Wednesday called for a comprehensive and multi-pronged approach to accelerate the pace of tribal empowerment across Jammu and Kashmir.

The meeting was attended by Member of Legislative Assembly (MLA) Zainpora, Hussain Ganie; Director, Tribal Affairs, Mumtaz Choudhary; Mission Director, Jammu and Kashmir Rural Livelihoods Mission (JKRLM), Dr. Shubhra Sharma; and other senior officers.

Chairing a detailed review meeting on the implementation of Pradhan Mantri Van Dhan Yojana (PMVDY), the Minister underlined the importance of inclusive planning, inter-departmental coordination, and ground-level execution to ensure that the benefits of government schemes effectively reach tribal communities, especially those residing in remote and underserved regions.

Rana urged the officials to intensify efforts to expand market linkages for tribal products at both regional and national levels. He asked departments to identify existing implementation gaps, strengthen interagency collaboration, and submit fresh proposals in areas where interventions are most

Minister highlighted the need for timely and well-planned initiatives to bridge developmental disparities and enhance the reach and relevance of the Van Dhan

Secy S&T chairs TAC to finalise Research Projects

SRINAGAR, OCTOBER 15: The Department of Science and Technology, Government of Jammu and Kashmir, organized a two-day meeting of the **Technical Advisory Committee** (TAC) of the J&K Science, Technology & Innovation Council (JKST&IC) on 14th and 15th October 2025 at the SKICC, Srinagar. The meeting was chaired by Dr. Shahid Iqbal Choudhary, Secretary, Science & Technology, as the Chairperson of the Committee.
The TAC convened to evalu-

ate and finalise research proposals under the Sponsored Research and Extension Programme (SREP)—a flag-ship initiative of the Science & Technology Department aimed at promoting indigenous research and supporting scientists in developing solutions to region-specific socio-economic

and environmental challenges. This year, the Department received 525 project proposals, including 306 from the Kashmir region and 219 from the Jammu region, from a wide range of universities, medical and technical institutions, and research laboratories across the Union Territory. The proposals were reviewed across 20 thematic areas, focusing on climate change, glacier studies, water and energy security, food sufficiency, environmental protection, public health, and natural disasters, among others.

The Committee comprised eminent scientists and academicians, including Dr. Anish Yadav (SKUAST-Jammu), Dr. Parvinder Pal Singh (CSIR-IIIM Jammu), Dr. Mudasir Andrabi (SKUAST-Kashmir), Dr. Aabid Hussain Shalla (IÚST-Kashmir). Dr. Meena Sharma (University of Jammu), Dr. Kumud Ranjan Jha (SMVDU), Dr. Ambika Prasad (IIT Jammu), and Dr. Anil Bhat (SKUAST-Jammu).

Dr. Mushtaq Ahmad Bhat, Additional Director, JKST&IC, served as Member Secretary of the Committee.

In his remarks, Dr. Shahid Choudhary emphasized that novelty, methodology, and societal impact should be central to the evaluation process. He reiterated the Government's resolve to build a strong ecosystem for research, innovation, and technological advancement in Jammu & Kashmir. "The R&D funding policy is designed to provide early-stage support to promising ideas, enabling researchers to transform their innovative concepts into scalable and sustainable solutions," he stated.

SC nod for green firecrackers: BJP says party vindicated, AAP compelled court to enforce ban

New Delhi, Oct 15: The BJP on Wednesday said the Supreme Court allowing the sale and use of green firecrackers in Delhi-NCR has vindicated the party's stand that the former AAP government presented arguments in court that led to the ban on firecrackers.

The Arvind Kejriwal-led AAP government's intentions towards Sanatan Dharma were dishonest, it said.

The Supreme Court on Wednesday relaxed the ban on green firecrackers in the capital with certain conditions.

The court said the sale of green firecrackers will be permitted from October 18 to 21 and their use shall be confined from 6 am to 7 am and from 8 pm to 10 pm on the day before Diwali and on Diwali day.

Delhi BJP chief Virendra Sachdeva said the top court's ruling has vindicated his party's stand

"We have been saying for a long time that former Delhi CM Arvind Kejriwal presented arguments that compelled the Supreme Court to ban firecrackers. The people of Delhi have now chosen the right government. Air pollution has multiple causes and the present government is working to resolve them. This is a victory for Sanatanis," he said.

BJP MP Manoj Tiwari said the court order was possible because of the "positive recommendation" made by the current Delhi government.

"Earlier, the AAP government



used to give negative recommendations to the court and wanted to ban even green firecrackers. The AAP's intentions towards Sanatan Dharma and its festivals were dishonest," he alleged.

Delhi Art and Culture Minister Kapil Mishra described the verdict as "a reflection of change"

"After the change of government, the ban on Hindu festivals has stopped. The last government never went to court to protect the right to celebrate Diwali. We presented people's views and now the festival can be celebrated in the traditional way with green firecrackers," he said.

Echoing similar sentiments, Delhi PWD Minister Parvesh Verma said the decision has "restored the dignity" of Diwali celebrations.

"For years, the people of Delhi were made to feel that

celebrating Diwali was a crime. The order brings back the light, pride and freedom to celebrate our traditions responsibly," he

Relaxing the ban on firecrackers, the bench of Chief Justice of India B R Gavai and Justice K Vinod Chandran said, "We have to take a balanced approach, permitting it in moderation while not compromising with the environment".

AAP leader and former Delhi environment minister Gopal Rai said he hoped that the BJP government would continue working to improve the air quality.

"We tried our best to reduce pollution. With the Supreme Court's decision on allowing green firecrackers during Diwali, we hope that the Delhi government will follow the rules and continue working towards improving air quality during the festival," he said.

'Apple lobbies India to change tax law seen hindering its expansion'

New Delhi, Oct 15: Apple is lobbying India's government to modify its income tax law to ensure the company is not taxed for ownership of highend iPhone machinery it provides to its contract manufacturers, an issue seen as a hurdle to its future expansion, sources

The push coincides with Apple's growing India presence as it diversifies beyond China. Counterpoint Research says iPhone's share in the Indian market has doubled to 8% since 2022. And while China still accounts for 75% of global iPhone shipments, India's share has quadrupled to 25% since 2022.

India is the world's second-largest mobile market. Apple's contract manufacturers Foxconn and Tata have pumped in billions of dollars to open five plants, but millions of those expenses go into acquiring pricey machines for iPhone assembly.

Experts say Apple potentially faces billions of dollars in additional taxes if it changes its business practices without convincing New Delhi to change a 1961 law covering foreign ownership of equipment used in India.

In China, Apple procures the machines used to make iPhones and gives them to its contract manufacturers, and is not subject to tax even though it still owns them.

But that's not possible in India as the Income Tax Act would consider such ownership by Apple as a so-called "business connection", making



the U.S. firm's iPhone profits liable for Indian taxes, said a senior government official and two other industry sources.

Apple executives have held talks with the Indian officials in recent months to tweak the law as it fears the current legislation could hamper its future growth, said the sources.

manufacturers "Contract cannot put up money beyond a point," said the first industry source. "If the legacy law is changed, it will become easy for Apple to expand ... India can become more competitive globally.'

Reuters is first to report Apple's concerns and lobbying efforts on the law.

Apple did not respond to Reuters questions, and neither did India's IT and finance ministries who are involved in the discussions. INDIA **CAUTIOUSLY**

Smartphone manufacturing is a key plank of Prime Minister Narendra Modi's agenda, and India's deputy IT minister last year privately said China and

Vietnam could race ahead as major smartphone export hubs due to their lower tariffs on phone parts.

A senior Indian official said "discussions on taxation rules impacting Apple are ongoing", but New Delhi is cautious as any changes to the law could diminish its sovereign right to tax a foreign company.
"It's a tough call," said the

official, who highlighted that Apple's increased investments are equally important.

"India needs investments. We have to find a solution." Apple has since 2023 opened

a handful of directly-owned retail stores in India, though it also sells it products through online and offline distributors. Foxconn and Tata have over the years invested more than \$5 billion in setting up Apple manufacturing. SPECIALIZED

EQUIPMENT CAN COST BILLIONS

One precedent of Indian law often cited by tax experts involves UK-based Formula One. India's Supreme Court held in 2017 that even though F1 did

not own a circuit near New Delhi, it was liable to pay tax on profits for the days when it exerted full control during its Grand Prix India event.

If Apple were to own machines inside Indian iPhone factories, it would amount to exerting control under current laws, experts said.

"If the activities of Apple constitute a business connection, then the global revenue may be used as a basis to compute the income attributable in India, leading to billions in tax exposure," said Riaz Thingna, a partner at Grant Thornton Bharat LLP.

Taiwan's Foxconn is Apple's largest contract manufacturer in India, having shipped products worth \$7.4 billion this year by August, compared to \$7.5 billion in all of 2024, commercially available customs data shows

The income tax law, however, does not bother Apple's South Korean rival Samsung as almost all of its phones are made in its own Indian factories.

The India Cellular Electronics Association (ICEA), which backs Apple, has in a confidential representation to the government called for changes to the law, saying tax certainty is "paramount for businesses seeking to expand and scale."
"Typical CMs (contract

manufacturers) are unable or unwilling to invest in such large quantities of specialized equipment ... The cost of the equipment can rise to billions of dollars," ICEA said, without naming any company. "In certain cases (it) may also

be supplied ... free of cost.'

Zubeen death: Protesters clash with police, set vehicles on fire outside prison

Guwahati, Oct 15: Assam Police on Wednesday resorted to lathi-charge and fired teargas shells to disperse an agitated mob that attacked and set ablaze some vehicles and hurled stones at the convoy carrying the five accused arrested in cultural icon Zubeen Garg's death case as they were being brought to Baksa District Jail.

Prohibitory orders have been imposed under Section 163 of BNSS in Mushalpur town and adjoining areas of the jail, while internet and mobile data services have been suspended in the entire Baksa district till further

orders, District Commissioner Gautam Das said.

Several people, including police personnel, journalists and local residents were injured and glass panes of vehicles were smashed, a senior officer said.

A large number of protesters gathered outside the prison in Mushalpur area, and as the convoy of vehicles carrying the accused for being lodged in the prison arrived, they started pelting the vehicles with stones, he

Some even demanded that the accused be handed over to the public to ensure "justice for Zubeen".

Although the convoy managed

to enter the jail premises, the protesters scuffled with the policemen deployed at the gates as they attempted to breach the cordon, the officer said.

Despite the requests of the policemen to the protesters to move back, they kept pressing forward, following which the law enforcers resorted to lathicharge to control the situation, he said.

situation, however, The turned worse after a while, with the protesters setting ablaze some vehicles, including those belonging to the police department and television channels with the law enforcers firing tear gas shells to bring the

situation under control. Chief Minister Himanta Biswa Sarma said that the incident at Baksa is "very sad and we are

During the meeting, the Additional Chief Secretary, Mining, gave a detailed presentation on the department's performance, highlighting technological advancements, regulatory reforms, exploration projects, and financial outcomes achieved in recent years.

A major highlight of the review was a presentation and live demonstration of the Integrated Mining Surveillance System (IMSS) a digital initiative developed in collaboration with BISAG (Bhaskaracharya Institute for Space Applications and Geoinformatics). The IMSS portal and mobile application provide realtime monitoring of mining activities through dashboards integrated with e-Challan and e-Market systems. This innovation aims to enhance transparency, accountability, and regulatory compliance in mineral operations across Jammu and Kashmir.

He informed the meeting that over 243 triggers have already been generated for field verification through features such as vehicle tracking, GPS-enabled monitoring, PoS-linked e-challaning (integrated with J&K Bank), and on-the-spot enforcement to curb illegal mining.

While appreciating the initiative, the Chief Minister directed the developers to explore delineating and delegating PoS functions to

expand the use of digital monitoring systems. He also called for integration of the department's existing portal with the IMSS platform to ensure seamless implementation and improved results.

Omar Abdullah further suggested that the

application should allow citizens to register complaints through mobile gadgets to be integrated in the system with satellite imagery or other evidence, strengthening public participation and grievance redressal. The Chief Minister instructed the depart-

ment to categorize active and non-active mineral vendors or suppliers and establish a dedicated monitoring cell at the Directorate level for continuous data tracking and realtime oversight.

 $Reviewing \, ongoing \, reforms \, under \, the \, Special \,$ Assistance to States for Capital Investment (SASCI) 2025-26, the Chief Minister was informed that the department has initiated a series of key measures aimed at strengthening institutional capacity and ensuring greater transparency in the mining sector. These include a shift towards an auction-based system for allocation of mineral blocks, introduction of mine closure and rehabilitation provisions, and the implementation of advanced survey and mapping mechanisms. The department has also operationalized the District Mineral Foundation Trust (DMFT) framework to ensure that mining revenues directly contribute to local area development and welfare initiatives.

Further, the meeting was informed, efforts are underway to revise royalty fee structure and penal provisions to align with current mar-

ket realities while improving compliance. The Mining Department has made the use of GPS-enabled transport and PoS-based transactions mandatory to track mineral movement and prevent leakages. Legal enforcement mechanisms have been reinforced through the requirement of royalty clearance certificates, in line with recent directions from the Hon'ble High Court, thereby tightening regulatory oversight and ensuring responsible mineral extraction practices.

The department also presented the status of major and minor mineral blocks, highlighting progress in auctioning and granting of mining leases across districts. The Chief Minister emphasized that all clearances and NoCs must

be obtained in advance before blocks are allocated through auction to avoid procedural and operational delays faced by successful allotees & bidders who have to run from pillar to post in obtaining environmental and other clearances.

Speaking on the issue of illegal mining, Omar Abdullah underscored the need to eliminate collusion at lower levels of administration, asserting that illegal operations cannot persist without internal complicity.

"In my previous tenure, illegal mining was never a concern. With the technological tools now available, any such activity is only possible if there's collusion at the lower level. The department must use these systems effectively to eliminate that possibility. The more we reduce such collusion, the lesser the chances of illegal mining," the Chief Minister said.

The Chief Minister also reviewed exploration projects currently being carried out by MECL and GSI, covering sapphire, lithium, lignite, and shallow biogenic gas reserves in various districts. He was informed about ongoing exploration of granite, graphite, gypsum, copper, and base metals, supported by detailed geological mapping, drilling, and feasibility assessments.

He stressed on ensuring strict compliance with environmental regulations, particularly in eco-sensitive zones, while expanding mineral development activities in a sustainable manner.

The Chief Minister commended the Mining Department for adopting digital innovation and institutional reforms and urged continued focus on transparency, efficiency, and environmental responsibility in the sector.

Chugh said the people of Jammu and Kashmir demand accountability from the government, as none of the commitments made during the elections have been honoured.

Accusing the NC government of "not fulfilling" its pre-poll promises, People's Democratic Party (PDP) president and former chief minister Mehbooba Mufti, a few days ago, drew parallels with the then Arvind Kejriwal-led Aam Aadmi Party (AAP) government in Delhi, saying the latter focused on developmental works despite governing in a Union Territory.

"It has been one year since the government has been in power here, but they haven't done enough despite promising jobs, free power supply and other incentives. Kejriwal gave free electricity to people, while over here, consumers are being charged heavily. There are even talks of water charges now," Mehbooba said.

Taking a dig at the NC government, Apni Party president and former minister, Syed Altaf Bukhari, said the party has failed to deliver on its promises.

The people have lost faith as NC has failed to fulfil its commitments. There is no visible development, no electricity waiver, no social welfare schemes, no free 200 units of power, no release of jailed youth, and rising unemployment," he said. (KNO)

Small cars to stay relevant in India, will not abandon entry segment: Hyundai **Motor Co chief**

Mumbai, Oct 15: Small cars will continue to have relevance in the Indian market, considering the number of two- and three-wheeler users aspiring to upgrade, and Hyundai will not abandon the entry segment, Hyundai Motor Co President & CEO Jose Munoz

While the company will continue to develop the fast-growing SUV segment in India, it will also use the entry segment to tap customers who will look to upgrade in future.

In an interaction with reporters here, Munoz said, given the population and the expected motorisation in India, there are projections that this market will become "more than 5.6 million" units annually.

"If you look at the number of people who are driving motorcycles or three wheelers, you will see that all these people, sooner or later, their aspiration is going to have a passenger car. So I never see India as one market like many other markets, but as two Indias."

Elaborating further, Munoz said on one side is the Indian market, which is becoming like all global markets that would like to have more SUVs and more off-road vehicles. "And on

the other side, you have all these markets, which are a massive market. where the current users of three-wheelers and motorcycles will move into passenger cars," he

Munoz was respond-ing to a query on how the company saw the role of small cars, which have seen a decline in sales India, as SUVs gained momentum.

He further said, "So we cannot say only one. We need to be involved. Hyundai has been a very, very popular brand."

Asserting that Hyundai's older small cars, which are "humble vehicles", are reliable and solid, offering very low cost of ownership and is "customers resonate with those products".

"So we will develop the SUV market because it's growing, and it is something that we do very well. We've done in other countries very successfully but we are not going to abandon the entry market, which makes it more competitive and allows us to continue to be very

popular," Munoz said. He said it is much easier to upgrade a "consumer who has been driving a very reliable entry Hyundai" to a bigger SUV with higher content and better

Crewed Gaganyaan mission would be possible by 2027: ISRO chief

'New Mars mission is upcoming project'

New Delhi, Oct 15: ISRO chairman V Narayanan on Wednesday said the space agency has set a target of landing Indians on the Moon by 2040, while its maiden human spaceflight mission 'Gaganyaan' is on track for launch in 2027.

Narayanan said a slew of ambitious space projects and sector reforms were currently underway, including a national space station by 2035, and three uncrewed 'Gaganyaan' missions by 2026, with the first one that includes a half-humanoid robot 'Vyommitra', targeted for December 2025.

"Prime Minister Narendra Modi has given a guideline for an indigenous crewed lunar mission by 2040, under which we have to land our own citizens on the moon and bring them back safely. A Venus Orbiter Mission (VOM) has also been approved to study the planet," Narayanan said in an exclusive interview with PTI.

Prime Minister Narendra Modi announced these ambitions on 17 October, 2023, and also asked scientists to work on missions to Venus and Mars. He expressed confidence in India's capabilities and affirmed the nation's commitment to scaling new heights in space exploration.

"Prime minister directed that India should now aim for new and ambitious goals, including setting up 'Bharatiya Antariksha Station'



(Indian Space Station) by 2035 and sending first Indian to the moon by 2040," the government said in a statement on October 2023.

"To realize this vision, the Department of Space will develop a roadmap for moon exploration, it added. The Indian Space Research Organisation (ISRO) chief said the Bharatiya Antriksh Station (BAS) is expected to come up by 2035, and initial modules in space are expected as early as 2027.

He was here to attend the 35th convocation ceremony of Ranchibased Birla Institute of Technology (BIT) Mesra as the chief guest.

'There are a lot of developments in 'Gaganyaan'. We are planning some more experiments. Before the crewed mission, we are planning three uncrewed missions.

'Vyommitra' is going to fly on that in December this year. Two more uncrewed missions will take place next year. Crewed 'Gaganyaan' mission would be possible by 2027 first quarter," Narayanan added.

With Modi defining a clear roadmap and rolling out reforms for the space sector, ISRO is moving with confidence and clarity towards realising the dream of a self-reliant and vibrant space ecosystem, he said.

He said India's upcoming projects include Chandrayaan-4 and Chandrayaan-5, a new Mars mission, and AXOM, a high-priority astronomical observatory mission.

"The Aditya-L1 mission has already yielded over 15 terabits of solar data, with valuable insights into coronal mass ejections and

We are open to international collaborations," he said, emphasising that while India is committed to self-reliance, climate science and space research, which are global concerns, "how and where we collaborate will be debated and decided based on scientific and strategic priorities." Highlighting the role of reforms, Narayanan said the space sector has been transformed through the Indian National Space Promotion and Authorisation Centre (IN-SPACe), which integrates startups and private players into the national ecosystem.

"Just a few years ago, there were barely one or two startups in the space sector. Today, there are over 300 working on satellite manufacturing, launch services, and space-based data analytics," he said.

This shift is seen as crucial to meeting India's rising demand for satellite-based applications in agriculture, disaster management, telecommunication, real-time train and vehicle monitoring, and fisheries," he added. For missions like crewed lunar landing, India needs to enhance its launch capacity and space infrastructure and has already started work to build its space station.

"From launching 35 kg initially to now envisioning 80,000 kg - thatis the scale of transformation we are aiming for," he said.

Talking about Artificial Intelligence (AI), Robotics, and Big Data, he said these are becoming integral to space missions.

"Ĵust like no one imagined the computer revolution 35 years ago, AI and robotics will define the next era of space exploration," the scientist remarked.

He said today India stands as the world's fourth-largest economy, with a burgeoning space sector that is not only matching, but often surpassing global benchmarks.

"From discovering water on the Moon with Chandrayaan-1, to the first soft landing near the lunar south pole with Chandrayaan-3, India has set multiple world records in space. Today, we are No. 1 in nine areas globally," he asserted.

The ISRO chief added that India has become the fourth country to successfully achieve docking and undocking in space with the success of SPADEX mission.

"We also completed the 100th launch from Sriharikota – the GSLV F15/NVS-02 Mission - and received final approval for a third launch pad catering to all launch vehicles, including the next-generation NGLV, at an estimated cost of Rs 4,000 crore," Narayanan said.

On Atomic energy, he said, currently India has 23 nuclear reactors across eight major nuclear plants, including Tarapur and Bhabha Atomic Research Centre.

Narayanan took charge as ISRO Chairman in January 2025. He earlier served as director of the Liquid Propulsion Systems Centre (LPSC), one of ISRO's key facilities.

Several states, entities have encroached upon defence lands; efforts on to evict them: Centre to SC

New Delhi, Oct 15: The Centre on Wednesday told the Supreme Court that several state governments and their entities, besides others, have encroached upon defence lands and efforts are being made to remove them.

A bench of Justices Surya Kant and Joymalya Bagchi asked the high-powered independent committee constituted by the Centre to oversee the steps taken to remove the encroachments on defence lands and

The bench was told by Attorney General R Venkataramani that the panel has been visiting the sites and identifying the encroachments, but facing some resistance, and hence some directions and indulgence of the court were required.

Advocate Prashant Bhushan, appearing for NGO Common Cause -- which filed the PIL in 2014 seeking a probe into alleged encroachment of defence land across the country -- said the panel has to look at the micro level.

He added that the need, as suggested by the Comptroller and Auditor General in its report, was for an independent regulatory body.

The bench told Bhushan that whatever body is set up, it will have to take the help of local revenue authorities and law enforcement.

"Once the interim report is filed, we will see what directions can be issued," the bench said as it posted the matter for further hearing on November 10.

On July 30, the Centre, in its affidavit, informed the court that 2,024 acres out of 75,629 acres of defence land in the country are currently encroached upon by individuals, and 1,575 acres are under unauthorised possession of those who took the land on lease for agricultural purposes.

According to the status report filed



by the Ministry of Defence, nearly 819 acres of land are under the occupation of state and central government departments or their undertakings for various public-utility purposes, such as laying roads, constructing schools, public parks and bus stands, besides for administrative reasons.

"Approximately 75,629 acres of defence land fall under the administrative purview of the Defence Estates Organisation (DEOs), primarily Class A-2, B-3, B-4 and C land. Out of this land, around 52,899 acres lie within cantonments, while 22,730 acres are situated outside cantonments. At nearly 2,024 acres are encroached by individuals," the affidavit has said.

It said additionally, 1,575 acres of land is under the unauthorised possession of former agricultural lessees, "against whom eviction proceedings have been initiated by respective

The Centre said efforts are on to engage with the government authorities concerned with regard to the occupation of defence land so as to explore the possibility of land exchanges, wherein the defence ministry may be allotted equivalent land parcels in lieu of those under the unauthorised occupation of state government organisations.

To augment efforts of encroachment removal, the Directorate General Defence Estates (DGDE) has operationalised an encroachment module under the aforesaid real-time record management (RTRM) system, developed in-house by the DGDE.

"This digital tool enables Defence

Estates Officers and Chief Executive Officers (CEOs) of cantonment boards to report cases of encroachments irectly and transparently to the des ignated estate officers," the Union government has said.

Highlighting the preventive measures, the ministry said steps taken by the defence estates organisation to protect defence land (falling under its management) include raising boundary walls and fencing vulnerable plots.

"In the last 10 years, about 1,715 acres of defence land under the management of the DE Organisation have been removed by the CEOs and DEOs of the defence estates department.

"In the current year itself, with the help of technological advantages of CoE survey and improved support of local administration, encroachment of about 220 acres has been removed from defence land." the defence ministry has said.

It pointed out that the DEO routinely encounters operational impediments in implementing eviction proceedings against unauthorised encroachments, including non-availability of police and magistrates, judicial stays and other infrastructural and procedural issues. These challenges often result in delayed enforcement.

The affidavit highlighted several other measures adopted by the Centre to remove the encroachments and unauthorised occupations and complete the digitisation of records.

China files complaint against India in WTO over EV, battery subsidies



New Delhi, Oct 15: China has filed a complaint against India in the World Trade Organization (WTO) over New Delhi's subsidies for electric vehicles (EVs) and batteries.

Commerce Secretary Rajesh Agrawal said that the ministry will look at the detailed submissions made by China. Confirming the move, an official said that China has also filed similar applications against Turkiye, Canada and the EU. "They have sought con-

sultations with India," the official said. Seeking consultation is the first step of the dispute settlement process as per WTO rules.

If the consultations requested with India do not result in a satisfactory solution, the EU can request that the WTO set up a panel in the case to rule on the issue raised. China is the second-largest trading partner of India.

In the last fiscal, India's exports to China contracted 14.5 per cent to USD 14.25 billion against USD 16.66 billion in 2023-24.

The imports, however, rose by 11.52 per cent in 2024-25 to USD 113.45 billion against USD 101.73 billion in 2023-24.

India's trade deficit with China has widened to USD 99.2 billion during 2024-25.

Markets rebound: Sensex jumps 575 points, Nifty tops 25,300 on global rate cut hopes

Mumbai, Oct 15: Benchmark Sensex spurted by 575 points while Nifty closed above 25,300 on Wednesday on buying in banking and financial shares, driven by a rally in Asian and European markets amid hopes of a rate cut by the US Federal Reserve later this month.

The 30-share BSE Sensex jumped 575.45 points or 0.70 per cent to settle at 82,605.43. During the day, it surged 697.04 points or 0.84 per cent to 82,727.02.

The 50-share NSE Nifty climbed 178.05 points or 0.71 per cent to 25,323.55.

Among Sensex firms, Bajaj Finance and Bajaj Finserv were the biggest gainers. Asian Paints, Larsen & Toubro, Trent, UltraTech Cement, Eternal and Adani Ports were also among the winners. However, Tata Motors, Infosys, Tech



were among the laggards. In Asian markets, South

Korea's Kospi, Japan's Nikkei 225 index, Shanghai's SSE Composite index and Hong Kong's Hang Seng settled sharply higher. Markets in Europe were trading in the positive territory.

US markets ended on a mixed note on Tuesday.

Afghanistan-Pakistan border war flares again, over 12 civilians killed in fierce clashes

Peshawar, Oct 15: Fresh fighting broke out on Wednesday along the volatile Pakistan-Afghanistan border, killing more than a dozen civilians and troops to shatter a fragile peace after weekend clashes that killed dozens.

The weekend fighting was the worst between the neighbours since the Taliban seized power in Kabul in 2021, despite regular clashes between their security forces along the contested 2,600 km (1,600-mile) frontier.

The Afghan Taliban said more than a dozen of its civilians were killed and 100 wounded as Pakistani forces launched attacks in the early hours of Wednesday in the district of Spin Boldak.

Fighting between troops and militants in a second incident in Pakistan's border district of Orakzai killed six Pakistani paramilitary soldiers and wounded six, two security officials told Reuters.

Nine militants were also killed, they said, adding that the violence broke out during a search in the area by troops after a militant attack last week killed 11 Pakistani soldiers.

Once allies, the recent friction between the South Asian nations erupted after Islamabad demanded that the Afghan Taliban administration act against militants who have stepped up attacks in Pakistan, saying they operate from havens in Afghanistan.

The Taliban denies the presence of Pakistani militants in Afghanistan. "Early this morning,



Pakistani forces launched attacks...more than 12 civilians were martyred and over 100 others were wounded," Afghan Taliban spokesperson Zabihullah Mujahid said on X.

The Taliban also said it had killed "a large number of Pakistani soldiers", captured their posts and centres, seized their weapons and tanks, and "destroyed" most of their military facilities.

Pakistani officials blamed the Taliban for the clashes and said four civilians were wounded on their side of the border.

Taliban forces attacked Pakistani post near Chaman (district)," Habib Ullah Bangulzai, the regional administrator in Pakistan's Chaman district, told Reuters. The fighting continued for about five hours in the early hours of the day, he said, adding that Pakistani forces had "repulsed" the attack.

Pakistan army said on

Wednesday that it repulsed multiple attacks by the Afghan Taliban while killing over 40 attackers in separate incidents of border clashes between the two countries.

The Afghan Taliban attacked four locations in the Spin Boldak area of PoK's Balochistan province, which were effectively repulsed by Pakistani Forces, the army said. "While repulsing the attack, 15-20 Afghan Taliban have been killed and many injured," the army said, adding that the situation is still developing as there are "reports of further build up in staging points of Fitna Al Khwarij and Afghan Taliban.'

The term Fitna al-Khawarij is used by Pakistani authorities to refer to militants of the banned Tehreek-e-Taliban Pakistan (TTP).

The attack was orchestrated through divided villages in the area, with the Taliban showing no regard for the civilian

The Afghan Taliban also destroyed Pak-Afghan Friendship Gate on their side that clearly displays the mindset with regard to mutual trade and easement rights of the divided tribes," the army said.

The attack in PoK's Spin Boldak was not an isolated event, as on the night of October 14, Afghan Taliban and Fitna Al Khwarij (TTP) tried to attack Pakistani border posts in Kurram Sector in Khyber Pakhtunkhwa province.

"These attacks were effectively repulsed, causing heavy losses to Afghan Posts, Eight posts, including six tanks, were destroyed in the effective yet proportionate response of Pakistani troops. (and) 25-30 Afghan Taliban and Fitna Al Khwarij fighters were suspected to have been killed," it said. The army rejected the insinuations that Pakistan initiated the attack by calling it "outra-geous and blatant lies, just like the claims of capturing Pakistani posts or equipment"

It further said that the propaganda of the Taliban regime can be debunked with basic fact checks.

Although clashes regularly break out between the countries' security forces along their contested 2,600 km (1,600-mile) frontier, last week's fighting was their worst since the Taliban seized power in Kabul in 2021.

The neighbours have closed several crossings along their border in its aftermath, bringing trade to a halt and leaving scores of loaded goods vehicles stranded

UN's World Food Programme warns donor cuts are pushing millions more into hunger

Geneva, Oct 15: The United Nations' food aid agency said Wednesday that severe funding cuts from its top donors are hurting its operations in six countries and warned that nearly 14 million people could be forced into emergency levels of hunger.

The World Food Programme, traditionally the UN's most-funded agency, said in a new report that its funding this year "has never been more challenged" – largely due to slashed outlays from the US under the Trump administration and other leading Western donors. It warned that that 13.7 mil-

lion of its food aid recipients could be forced into emergency levels of hunger as funding is cut. The countries facing "major disruptions" are Afghanistan, Congo, Haiti, Somalia, South Sudan and Sudan, it said.

"We are watching the lifeline for millions of people disintegrate before our eyes," Executive Director Cindy McCain said. WFP said it expects to

receive 40 percent less funding this year, leading to a projected budget of \$6.4 billion - after receiving some \$10 billion last

year. "This is not just a funding gap - it's a reality gap between what we need to do and what we can afford to do," McCain said. "We are at risk of losing decades of progress in the fight against hunger." The Rome-based agency

says global hunger is already at record levels, with 319 million people facing acute food insecurity – including 44 million at emergency levels. Famine has broken out in Gaza and Sudan.

In Afghanistan, food assistance is reaching less than 10 percent of people who are food insecure - meaning that they don't know where their next meal will come from, the agen-

WFP says it has received about \$1.5 billion from the United States this year, down from nearly \$4.5 billion last year, while other top donors have also

cut funding. Many United Nations organizations, including the migration, health and refugee agencies, have announced sharp aid and staffing cuts this year because of reduced support from traditional big donors. The humanitarian aid community has also been affected by sharp cuts to the US Agency for International Development, or USAID.

It might be last chance for Aussie fans to see Rohit-Virat playing on Australian soil: Cummins

New Delhi, Oct 15: India's highly anticipated tour of Australia, kicking off on October 19, carries added significance as it marks the return of stalwarts Rohit Sharma and Virat Kohli to Australian shores. However, Australian pace spearhead Pat Cummins believes this series could be the final opportunity for home fans to witness the Indian legends in action Down Under.

Kohli and Rohit, who have no retired from Tests and T20Is, will participate in the ODI series, the only international format they are playing, starting on October 19 in Perth. India



are scheduled to play three ODIs and five T20Is on their limited-overs tour of

"Virat and Rohit have been part of almost every Indian side for the last 15 years, so this might be the last chance for the Australian public to see them playing out here. They've obviously been champions of the game for India and are always very well supported. Whenever we play them, the crowd gets loud," Cummins said on JioHotstar.

Cummins, who is continuing his recovery from lumbar bone stress in preparation for the Ashes, will miss the series against India and Mitchell Marsh will lead the ODI side.

India, EU trade pact talks in last leg: Commerce Secy



New Delhi, Oct 15: The negotiations between India and the European Union on the proposed free trade agreement are progressing "very well" and have reached the last leg, a senior government

official said on Wednesday.

The two sides concluded their 14th round of negotiations in Brussels last week, but some Indian officials have stayed back to conclude talks on Rules of Origin (ROO), Commerce Secretary Rajesh

We are in the last leg of negotiations. The last leg is the most arduous leg of negotiations because these are the toughest things that are decided at the end. Progress in the last round has been very positive," he said. The 'Rules of Origin' (ROO) provision prescribes minimal processing that should happen in the FTA (free trade agreement) country so that the final manufactured product may be called originating goods

That (ROO) is one area where a lot of work needs to be done. So we have left the team there. It was planned to have the negotiations for two weeks at a stretch to see that we can make substantial progress," Agrawal said.

He added that the dates for the next round of negotiations have not been finalised yet, but discussions are on as there are some issues for which both sides need to be engaged on a continuous basis. "Instead of waiting for a round, there are engagements that are going between the two sides virtually also," he said adding "negotiations are progressing very well. Chances are that it may get closed by December".

As talks intensify, some officials from the EU are expected to visit New Delhi next month to carry forward the discussions.

Agrawal joined the discussions as the 14th round was winding down. He met Director General (Trade) of the European Commission (EC) Sabine Weyand to assess the progress of talks.

In June 2022, India and the EU bloc res negotiations for a comprehensive FTA, an investment protection agreement and a pact on geographical indications after a gap of over eight years. Talks were stalled in 2013 due to differences on the level of market opening.

FIFA World Cup 2026

England qualifies after routing Latvia Portugal made to wait despite Ronaldo double

London, Oct 15: England became the first country from Europe to qualify for the 2026 World Cup on Tuesday (October 14, 2025) but Cristiano Ronaldo and Portugal will have to wait after conceding a stoppage-time equalizer against Hungary.

England won 5-0 at Latvia, with captain Harry Kane scoring twice in the first half, to assure first place in its group with two matches to spare. The English, who will be appearing at an eighth straight World Cup, haven't conceded a goal in six matches in qualifying so far under German coach Thomas Tuchel. "Sometimes we make it look

easy," said Kane, who already has a total of 21 goals for England and Bayern Munich this season, "but these groups and games can be tough.... We talk about high standards no matter who we play against to keep the momentum, and that showed." Ronaldo's record

Portugal looked set to join England in next year's tournament in North America after two goals from the 40-yearold Ronaldo established a 2-1 lead over Hungary in Lisbon. A win would have guaranteed Portugal a first-place finish but Dominik Szoboszlai made it 2-2 in the first minute of added-on time to leave second-place Hungary five points back with two games left.

Ronaldo at least left the



match with another scoring record. He now has 41 goals in World Cup qualifiers, breaking a tie for 39 he had with Guatemala player Carlos Ruiz.

Italy defeats Israel in politically charged match

Italy, which has failed to qualifv for the last two World Cups, guaranteed itself at least a place in the playoffs after beating Israel 3-0 in a match laced with tension, played amid a hefty police and military presence, and preceded by a pro-Palestinian march attended by an estimated 10,000 people.

The match was placed in the highest risk category despite a breakthrough ceasefire deal that has paused two years of war in Gaza.The second-placed Azzurri moved three points behind Norway, which has a much healthier goal difference. Both teams have two matches left next month, including a game against each other in Italy

in the final round of qualifiers. Spain stayed top of its group, three points clear of Turkey, by beating Bulgaria 4-0 to maintain its 100% start to the qualifying campaign.

Turkey also won, 4-1 at home to Georgia, and at least looks set for the spot in the playoffs. Tuchel impressing with

Tuchel is putting his own stamp on the England team and might potentially be winning over some critics who wanted an English person in charge of the national team.

He has made some big calls, like leaving out high-profile players like Jude Bellingham and Phil Foden from the squad and taking on England's fans for being too quiet in the last match, but is getting some impressive results – albeit against mediocre opposition.

If the 5-0 win in Serbia last month was the statement result in Tuchel's tenure so far, this latest thrashing was another sign of the assuredness and ruthlessness in the team. Anthony Gordon opened the scoring, Kane added two more in the first half, and there was an own-goal as well as a strike from substitute Eberechi Eze after halftime.
