### Modi Govt's tough stand on terror in J&K unmatched: Amit Shah

When terrorists tried to rise again, we launched Op Sindoor

During Congress rule, terrorists played 'Khoon Ki Holi' across India

Srinagar, Oct 17: Asserting that India now responds to terror threats with unprecedented resolve and strength, Union Home Minister Amit Shah on Friday said the PM Modi-led government's action against terrorism in J&K is unlike anything seen in decades.

Addressing a public rally in Taraiya, Bihar, Shah, according to the news agency-Kashmir News Observer (KNO) said, "During the Congress rule, terrorists played 'khoon ki holi' (blood-soaked Holi) across India. Under Prime Minister Narendra Modi, we entered their homes and wiped them out through 'Operation Sindoor.' He said that terrorists in-

volved in the Pahalgam terror attack were brought to justice

under 'Operation Mahadev,' and their handlers were also targeted inside Pakistan. "The way Modi ji responded to terrorism in Jammu and Kashmir, no one did in the past several decades,"

he added. Highlighting

government's achievements, the Home Minister said the abrogation of Article 370 in Jammu and Kashmir was a historic decision that permanently integrated the region with the rest of the country. "From removing Article 370 to fighting terrorism, we have acted on every front. When terrorists tried to rise again, we launched Operation Sindoor and taught them a lesson in their own homes," Shah said.

He said the government ended the practice of triple talaq, giving justice to Muslim women, and after 350 years fulfilled the long-standing promise of building the Ram Temple in Ayodhya.

Shah also accused opposition parties of misleading people with "unrealistic promises" and reviving what he described as the politics of corruption and fear.

He said the regime led by PM Modi remains focussed on development, welfare, and national security.

#### Have asked Congress to field candidate from Nagrota; Budgam to stay with NC: Omar

'All promises will be fulfilled in 5-year tenure'

Anantnag, Oct 17: Chief Minister Omar Abdullah on Friday said the National Conference (NC) has asked its ally, Congress, to field a candidate from the Nagrota Assembly seat in the by-election, slated to be held next month. He added that the alienation with New Delhi will end once the statehood is restored.

Speaking to media persons in Anantnag here, the Chief Minister, as per the news agency-Kashmir News Observer (KNO), said that a year has passed since the elected government took over. "However, a year has elapsed, but we still have four years left. The work is before the people, and we stick to our promises.'

Omar said the people should not judge them for a period of a week, a month



or a year, but they have been given a time of five years, and hopefully they will fulfil their

promises. About the nomination of candidates for the by-election on two Assembly seats in Jammu and Kashmir, the Chief Minister said there are still a few days left. "NC will contest from the Budgam seat while Congress has been asked to field its candidate from the Nagrota seat. We have assured

our complete support to Congress if they want to field their candidate from Nagrota. Congress has sought consent from the high command, and if they get the approval, then they will file the nomination papers from Nagrota and Budgam will be left for NC," he said.

#### All eyes on independents, but no one can see their vote

Opaque voting rules put spotlight on 7 non-party MLAs

Srinagar, Oct 17: The National Conference (NC) and Congress made last-ditch efforts to forge unity ahead of the Rajya Sabha polls, following Congress's public announcement that it would not contest the 'riskier' fourth seat. As a result of negotiations, Congress leaders claim they had nearly agreed to field a candidate for the competitive seat; however, the issue of independents played spoilsport in the final moments of the unity talks. The differences arose from the voting method of independent MLAs, who are not required to show their marked hallots to polling agents-unlike party-affiliated legislators.

As per the news agency-Kashmir News Observer (KNO), with the Rajya Sabha election just a week away, all eyes are on seven independent MLAs-five of whom support the government and two who are aligned with the fragmented bloc of Kashmir-based opposition in the

Among the five supporting the government are Satish Sharma, a minister in the Omar Abdullahled administration; Pyare Lal (MLA, Inderwal); Muzaffar Khan Rajouri); Choudhary Akram (MLA, Surankote); and Dr. Rameshwar Singh (MLA, Bani). These MLAs did not contest the 2024 Assembly elections on the ticket of any recognized or registered party and won as independents. They submitted letters of support to Omar Abdullah when he staked his claim to form the government in October last year.

Kulgam, Oct 17: Chief Minister of Jammu and Kashmir, Omar Abdullah Friday said that his government is making continuous efforts for the restoration of statehood, hoping that more powers (statehood) will be granted soon, which is being delayed for the reasons only known to Bharatiya Janata Party (BJP).

Speaking to reporters in Kulgam, Omar, as per the news agency-Kashmir News Observer (KNO), said that statehood was a promise made to the people of Jammu been fulfilled by now. "We were hoping that the Centre



restore statehood within a year. We don't know why there is a delay - only the BJP knows. But our fight

for it will continue," he said. On revival of bi-annual Darbar Move practice, Omar said, "I have made it clear from day one that in the Union Territory, whatever promises we made, we will fulfill them.

"The Darbar Move was one of the promises we made in our manifesto, and since 2021, it has been restored.'

About reservation, the Chief Minister said that a cabinet sub-committee led by Sakeena Itoo was formed and it has submitted the final report report has been approved. The cabinet memo is being

prepared for circulation and will be sent to the LG for approval," the Chief Minister said. Regarding losses suffered

by farmers, Omar said that the government does not need to wait for the Assembly to address the issue. "Wherever there has been damage to agricultural or horticultural crops, assessments have been completed. Talks with the Centre are underway for a relief package, similar to those given to other states. J&K also deserves such a package," he said.

On the revocation of FIRs registered during COVID-19 restrictions, Omar said, "Law and order is not with the elected government right now. Once we regain those powers, we will fulfill our other promises as well."

#### India to take domestic defence production to 100 pc: Rajnath

Nashik (Maharashtra), Oct 17: India is looking at taking domestic defence production to 100 per cent as dependence on foreign military supplies creates "strategic vulnerability", Defence Minister Rajnath Singh said on Friday.

Singh said this after inaugurating a third production line of Tejas Light Combat Aircraft (LCA)-Mk1A and a second manufacturing facility of trainer jet HTT-40.

With opening of the new facility for Tejas jets, the Hindustan Aeronautics Ltd (HAL) is expected to produce at least 24 LCA aircraft.

"There was a time when



the country was dependent on other countries to meet its defence needs, and almost 65-70 percent of defence equipment was imported," Singh said in his address

## 5.6 mag earthquake hits Afghanistan, tremors felt in J&K

Srinagar, Oct 17: A strong earthquake of magnitude 5.6 struck 47 kilometres north-northwest of Khand d, Afghanistan, at 5:30 AM IST on Friday, according to the European-Mediterranean Seismological Centre (EMSC). The quake, occurring at a depth of 51 kilometres, was also felt in parts of Jammu and Kashmir.

Earlier on the same day, a 4.3-magnitude tremor shook areas 133 kilometres east of Kabul at a depth of 10 kilometres, as reported by the National Center for Seismology.



The German Research Centre for Geosciences (GFZ) confirmed a magnitude 5.66 quake near the Afghanistan-Tajikistan border.

On October 5, a 4.1-magnitude earthquake struck Afghanistan at a depth of 180 km, according to the National Centre for Seismology (NCS). In a post on X, the NCS reported:

"EQ of M: 4.1, On: 06/10/2025 20:12:21 IST, Lat: 36.64 N, Long: 70.88 E, Depth: 180 Km, Location: Afghanistan."

Earlier, on September 28, the region experienced another earthquake measuring 3.9 in magnitude at a shallow depth of 10 km, which makes it more prone to aftershocks. The NCS reported: "EQ of M: 3.9, On: 28/09/2025 04:16:13 IST, Lat: 34.62 N, Long: 70.84 E, Depth: 10 Km, Location: Afghanistan." Shallow earthquakes are generally more dangerous because seismic waves travel a shorter distance to the surface, causing stronger | More on P6

#### Over 27% increase in glacial lake area among 55 glacial lakes in India since 2011: CWC

New Delhi, Oct 17: Water spread area of glacial lakes within India has increased by over 27 per cent between 2011 and July 2025, according to a report that analysed 55 glacial lakes.

The Monthly Monitoring Report of Glacial Lakes and Water Bodies in the Himalayan Region, July 2025 released by the Central Water Commission (CWC) said the total inventory area of glacial lakes within India rose from 1,952 hectares in 2011 to 2,496 hectares in July 2025.

The analysis covered 100 glacial lakes (GLs) located within



India across Ladakh, Jammu and Kashmir, Himachal Pradesh,

Uttarakhand,

Arunachal Pradesh. Of these, 58 glacial lakes showed growth in Sikkim and water spread area in July 2025.

There is a 27.87 per cent increase in area. (Out of 100 GLs, only 55 GLs were considered for this interpretation. The remaining lakes include 40 Supraglacial Debris Cover (SDC) lakes which have no inventory details as well as lakes which were not analysed/have been merged during the month of July, 2025," the report said.

State-wise, the lakes identified for vigorous monitoring include Ladakh (8), Jammu and Kashmir (7), Himachal Pradesh (5), Uttarakhand (6), Sikkim (28) and Arunachal Pradesh (4).

#### **Judicial Academy Sgr organizes** orientation programme

SRINAGAR, OCTOBER 17: The Jammu & Kashmir Judicial Academy, Srinagar, organized a One Day Special Orientation Programme on "Medical Forensics & Medico-Legal Aspects in Trial; Different Dimensions of Cyber Crimes and Electronic Evidence".

The programme was organized under the patronage of Chief Justice, High Court of Jammu & Kashmir and Ladakh (Patron-in-Chief, J&K Judicial Academy), Justice Arun Palli and under the guidance of the Chairperson and Members of the Governing Committee of the Academy, for Judicial Officers of the District Judiciary of Kashmir Province including UT of Ladakh, Public Prosecutors, Additional Public Prosecutors, Assistant Public Prosecutors, and Investigating Officers of Kashmir Province.

The programme commenced with introductory remarks by Director, J&K Judicial Academy, Sonia Gupta, who outlined the objectives of the orientation programme. She emphasized that in the age of digital transformation and advancing forensic technologies, the judiciary and prosecution must stay equipped with evolving scientific, medical, and technological developments that critically shape the administration of criminal justice.

Speaking on the occasion, Senior Assistant Professor, School of Law, University of Kashmir, Dr. Mir Junaid Alam focused on the theme "Demystifying the Information Technology Act, 2000 with Reference to Cyber Crimes viz. Issues, Challenges and Way Forward.

He discussed the legal and procedural complexities arising from cyber offences, data breaches, and online frauds. He also highlighted the gaps between technology and enforcement and emphasized the need for judicial officers and investigators JAMMU & KASHMIR JUDICIAL ACADEM

to enhance their understanding of digital footprints, data preservation, and admissibility of electronic records.

In his address, he also underscored the importance of judicial sensitivity to privacy, digital rights, and due process in cases involving cybercrime.

Senior Assistant Professor, Centre for Distance and Online Education, University of Kashmir, Dr.Aneeda Jan deliberated on "Medical Forensic Law: Constitutional Perspective and Role of Judiciary" and "Impact of Technology on Forensic Evidence. She elaborated on the intricate relationship between law and forensic medicine, underscoring the critical role of medical evidence in the dispensation of justice. Further, she spoke on the constitutional and ethical dimensions of forensic investigation, highlighting the responsibility of courts to ensure the integrity, authenticity, and admissibility of

forensic materials.

Discussing technological advances, she pointed out how digital imaging, DNA analysis, and Al-based diagnostic tools are transforming medico-legal practices and judicial evaluation of evidence. Registrar Vigilance, High Court of J&K and Ladakh, Rajeev Gupta addressed on the topic "Electronic Evidence: Definitions and Characteristics". He outlined the essential requirements for the admissibility of electronic evidence.

He also discussed judicial precedents governing electronic records, the authenticity of digital signatures, and challenges in verifying metadata and data chain integrity. He stressed that the digital age demands a deeper understanding of technological processes to prevent miscarriage of justice due to procedural lapses in electronic documentation and certification.

## 'Initial hour after accident usually decides survival rate of victim'


Srinagar, Oct 17: On the occasion of World Trauma Day, medical experts have highlighted the life-saving potential of early intervention in trauma cases and called for urgent strengthening of trauma care facilities, particularly in peripheral hospitals across lammu and Kashmir

across Jammu and Kashmir.

They said that the "golden hour" - the critical first hour after an accident - often determines whether a patient survives or succumbs to injuries.

Doctors said that trauma remains one of the leading causes of death and disability globally, and timely management can make all the difference. "The first hour after a major accident is crucial. If a patient receives proper medical attention during this period, the chances of survival rise dramatically," said Dr Shabir, a senior surgeon posted in south Kashmir.

He said that most trauma victims in rural or remote areas lose precious time being



transported to tertiary care hospitals like SKIMS or SMHS. "A well-equipped emergency unit at district or sub-district hospitals could handle primary stabilisation — airway management, bleeding control, and fracture immobilisation — before transferring the patient. This can save lives and prevent complications," he said.

Another health expert, Dr Rouf Ahmad Wani Ahmad, said that improving infrastructure in peripheral hospitals would not only save time but also reduce the overwhelming rush at tertiary centres. "Many trauma cases could be managed locally if peripheral facilities had trained trauma teams, emergency operating rooms, and adequate equipment. This would help tertiary hospitals focus on highly complex cases," he said.

Doctors stressed the need for capacity building and training of first responders and paramedical staff in basic trauma life support. "Even a small delay in handling airway obstruction or excessive bleeding can prove fatal. Proper training and timely response

can transform outcomes," they said.

They said the government's focus should be on developing a hub-and-spoke model for trauma care, connecting peripheral hospitals with tertiary centres through a coordinated referral and transport system. "Ambulances must be well-equipped, and real-time communication between hospitals is vital," they said. They added that road traffic accidents, workplace injuries, and falls contribute significantly to trauma cases in Jammu and Kashmir, and the need for well-prepared local hospitals is urgent.

"Strengthening peripheral infrastructure is not just about convenience; it's about saving lives," said Dr Shabir. "If every district hospital can provide immediate life-saving care, countless families will be spared tragedy."

World Trauma Day is observed every year on October 17 to raise awareness about trauma prevention and the importance of timely medical care in reducing deaths and disabilities resulting from injuries—(KNO)

Tarigami and Pirzada Feroz Ahmed, Additional Chief Secretary to CM Dheeraj Gupta, Additional Chief Secretary R&B, Deputy Commissioner Kulgam Athar Amir Ul shafi Khan, heads of departments, and all district officers attended the meeting.

While reviewing winter preparedness, the Chief Minister underscored the importance of



equipping districts, particularly in snow-prone areas, with sufficient 4x4 ambulances to ensure uninterrupted emergency services. "We are working with the concerned departments to make sure that every district has an adequate number of 4x4 ambulances so that people do not face difficulties during heavy snowfall," he said, directing officials to ensure that the ongoing arrangements include appropriate mobility and safety measures.

## Retaining wall collapse on NH disrupts traffic

Srinagar, Oct 17: The damages and destructive effects caused by the landslide are still evident on the Jammu-Srinagar National Highway.

On Thursday evening, a major retaining wall suddenly collapsed in the Dalwas area near Ramban, resulting in the closure of one tube of the highway to traffic

According to reports, a section of about 50 meters of the retaining wall, as well as a large portion of the link road leading to the Saoni Panchayat, suddenly collapsed in the Darwas area of the highway. As a result, a part of the four-lane highway was affected, and vehicle movement in this area has slowed significantly.

It was stated that after the wall collapsed and one tube of the highway was closed, traffic from both sides was diverted to another road. By this evening, hundreds of passenger and freight vehicles had traveled via the highway, while repair work continued at the Dalwas site.

Local residents of Dalwas said that the collapse of the high-way wall also took away a large part of the link road to Saoni Panchayat, severely affecting the movement of the local population.

When contacted, Shubham Yadav, Project Director of the National Highways Authority of India, told KNO that about 40 to 45 meters of the concrete retaining wall in the Darwas

area had collapsed, and since last evening, one tube of the highway has been closed to traffic.

He said that restoration work has begun to make the affected road passable again, and efforts are underway to reopen the closed tube to general traffic as soon as possible.

Meanwhile, after several weeks, passenger vehicles have been allowed to move in both directions on the Jammu-Srinagar National Highway, while freight vehicles are still only allowed to move in one direction.

Police officials told KNO this evening that passenger vehicles have been permitted to travel in both directions since this morning, but freight vehicles are only allowed from Jammu towards Srinagar. Passenger vehicles are permitted to travel from Jammu only between 8 am and 11 am, and vehicles crossing the Banihal Tunnel must do so between 7 am and 10 am; drivers are advised to plan their journeys accordingly.

Officials also said that the condition of the road at several locations on the highway is quite poor, causing slow traffic movement. Furthermore, the continuous movement of freight convoys, the deteriorating condition of the highway, and the daily migration of Gujjar and Bakarwal communities with their livestock from Kashmir to the plains of Jammu continue to impact the flow of traffic on a daily basis—(KNO)

## 'Minibus operators flout rules in Srinagar'

Srinagar, Oct 17: The Srinagar traffic police have raised concerns over unregulated operations by minibus operators, warning that their practices could lead to severe traffic chaos within the city.

Senior Superintendent of Police (SSP) Traffic City, Ajaz Ahmad Bhat said some operators are introducing routes from other districts into city limits without proper authorization. "These operators are running their fleets without any regulation and are often seen switching routes at will," he said.

Meanwhile, officials have asked operators to submit detailed information about their fleets to gauge how many minibuses are operating on each route, but many have failed to comply.

Moreover, they say drivers reportedly keep multiple route boards in stock and frequently change routes, making it difficult even for fleet managers to enforce discipline.

SSP Bhat said risks posed by these unregulated practices and urged operators to follow the rules to ensure smooth traffic flow. A video highlighting the issue has been circulated among officials for reference—(KNO)

#### Serious Action Needed To End National Highway Gridlock

■he Jammu–Srinagar National Highway, especially the Ramban stretch, has become an emblem of commuter distress, time lost, and economic setbacks for the region. Once envisaged as a lifeline connecting Kashmir to the rest of India, this crucial artery now evokes images of endless lines of frustrated travellers, stranded apple-laden trucks, and daily uncertainties for thousands who rely on its timely functioning. Gridlock on this highway has escalated to crisis levels. What should have been

a smooth four-to-five-hour drive has turned into a harrowing ten-hour ordeal for commuters. Many who rely on the highway for work, trade, and family obligations are at a breaking point. Ongoing repair activities, breakdowns of heavy trucks, wrong-lane driving, overtaking violations, and the movement of nomadic flocks all add to the chaos. In particular, the Ramban–Udhampur sector faces severe bottlenecks, with the muchadvertised double-laning often only existing on paper, reducing traffic to single lanes and

compounding delays. Every day, commuters and truck drivers face mounting costs and acute frustration. Exporters, especially apple growers, find their produce at risk as traffic jams threaten both livelihoods and the broader supply chain(see the generated image above). Despite officials' assurances, visible improvements are lacking on the ground. While two-way traffic for light vehicles has been restored in some sectors, congestion and chronic blockages continue, especially from Qazigund through the notorious

Ramban stretch. Repairs, blasting, and maintenance teams help to some extent, but these short-term fixes cannot substitute for systematic solutions. Authorities must recognise that the future of the Kashmir Valley's economic and social well-being runs directly through this highway. There should be a coordinated push to expedite ongoing construction and repair with the utmost urgency while ensuring continuous monitoring and a genuine double-laning of all choke points. Strategic interventions, such as better traffic

regulation, staggered truck movements, preventive maintenance, and clear public advisories, are essential. The seamless movement of goods, produce, and people is not just a matter of convenience but of economic survival and regional stability. The current condition of the Jammu-Srinagar highway is an urgent call for action. Authorities must act decisively to implement sustainable solutions, alleviate daily suffering, and restore trust in this highway as a channel, not a chokepoint, for progress in Kashmir.

## National Consumer Helpline: 'India's Frontline of Consumer Protection'

From resolving grievances and securing refunds to boosting transparency and trust, the NCH's innovative approach is empowering citizens and transforming consumer protection across sectors

These are not just isolated success stories but clear examples of how the National Consumer Helpline acts as a lifeline for ordinary citizens. The National Consumer Helpline is a flagship initiative of the Department of Consumer Affairs to guide consumers, resolve grievances and create awareness about their rights. It operates through the portal consumerhelpline.gov.in, which functions as the Integrated Grievance Redress Mechanism. The platform brings together consumers, government agencies, regulators, ombudsmen, companies and call centres on a single system.

Through this mechanism, consumers can register complaints online and seek resolution at the pre-litigation stage. If they remain unsatisfied, they still have the option to approach the Consumer Commissions. The portal also serves as a knowledge platform to inform citizens about their responsibilities while protecting their rights.

Progress in Consumer Redressal
The reach and efficiency of the helpline
has been significantly enhanced by leveraging technology. Call volumes have grown more than tenfold, rising from 12,553 in December 2015 to 1,55,138 in December 2024. The platform currently receives over one lakh complaints per month reflecting the growing consumer trust. The average number of monthly complaint registrations has increased from 37,062 in 2017 to 1,70,585 in 2025. With the introduction of digital modes, nearly 65% of consumer grievances on the helpline are registered through online and digital channels. Grievance registration via WhatsApp has shown a significant growth from 3% in March 2023 to 20% in March 2025.

Further, In July 2025, the National Consumer Helpline successfully facilitated refunds totalling Rs. 2.72 crore by resolving



7,256 consumer grievances across 27 different sectors which increased from 1079 consumer grievances with total refund of Rs. 62 lakhs in April 2025. The e-commerce sector for July 2025 accounted for the largest number of refund-related complaints, with 3,594 cases resulting in refunds worth 1.34 crore. The Travel and Tourism sector followed, with refunds amounting to 31 lakh.

Under the Convergence initiative, companies partner with the National Consumer Helpline on a voluntary and free-of-charge basis to ensure that customer grievances are resolved quickly and amicably. Complaints are forwarded in real time, and companies are expected to respond within 30 days.

The number of convergence partners has steadily increased from 263 in 2017 to 1,142 companies till Sept,2025, strengthening collaborative mechanisms for timely grievance

National Consumer Helpline Empowers Students in Refund Disputes As of Feb 2025, the Department of

Consumer Affairs has secured refunds worth 1.56 crore for more than 600 students enrolled in Civil Services, Engineering and other courses, after coaching centres failed to honour their refund commitments. The action, enabled through grievances filed on the National Consumer Helpline, ensured timely redressal of issues such as unfulfilled services, cancelled classes and unfair practices, while also mandating coaching institutes to adopt transparent, student-friendly refund policies

NCH Integrated with Next-Gen GST Reforms 2025

The Department of Consumer Affairs has aligned the National Consumer Helpline with the Next-Gen GST Reforms 2025, which were approved at the 56th meeting of the GST Council chaired by the Union Finance Minister in Sep 2025, and are in keeping with the vision outlined by the Prime Minister in his Independence Day 2025 address. To manage the rise in consumer queries and complaints expected after the introduction of revised GST charges, rates and exemptions from 22 September 2025, a dedicated category was created on the INGRAM portal. This category covers major sectors such as automobiles, banking, consumer durables, e-commerce fast moving consumer goods

register GST related complaints.

Since the implementation of the Next-Generation GST Reforms 2025, the National Consumer Helpline has logged 3,981 calls concerning GST issues as of 2nd Oct 2025. Of those, 31% were queries and 69% were formal grievances handled for further action.

Out of the total, 1,992 grievances have been forwarded to the Central Board of Indirect Taxes & Customs (CBIC) for further action, while 761 grievances have been referred in real time to the relevant convergence partner companies for direct resolution.

Several key sectors have emerged where consumers are seeking clarity and action following the GST changes:

A notable share of grievances were related to milk pricing. Many consumers reached NCH believing that milk companies ought to reduce milk prices in light of revised GST rates, but it was clarified that fresh milk is already exempt from GST and UHT milk has now also been exempted.

Another large cluster of complaints involved electronic goods purchased online. Consumers alleged no benefit was passed on despite GST reductions. The investigation highlighted that rate reductions (from 28% to 18%) apply to items like TVs, ACs, monitors and dishwashers, while some items like laptops, refrigerators and washing machines were already taxed at 18%.

Complaints also came in about domestic LPG cylinders. People said prices had not decreased. It was clarified that the GST rate on domestic LPG remains at 5%.

Some complaints involved petrol pricing, where people expected reductions. But petrol sits outside the GST regime altogether.

The first week of GST-related grievance reporting shows that consumers are engaging actively with the redressal system, reflecting growing awareness and confidence in the

Consumer Affairs.

How one Registers his/her Grievance? Consumers can register their grievances with the National Consumer Helpline

through multiple channels: Call the toll-free numbers 1800 11 4000 and speak directly with an agent. Grievances can be registered in 17 languages via toll-free number 1915.

Register on the portal consumerhelpline. gov.in. After a one-time signup and email verification, a user ID and password will be created. With these credentials, consumers can log in, lodge complaints and upload sup-

porting documents. Send an SMS to 8800001915 and the team will get back to the consumer.

## Corn Must Become India's New Crude

For India to become Atma Nirbhar and achieve its ambition of a \$5 trillion economy, the solution to one of its biggest vulnerabilities – dependence on imported petroleum and LNG – is already in front of us

**¬**or India to become Atma Nirbhar and Achieve its ambition of a \$5 trillion economy, the solution to one of its biggest vulnerabilities - dependence on imported petroleum and LNG – is already in front of us. By adopting a focused five-year plan, India can drastically reduce its chronic energy import dependency and accelerate toward energy self-reliance, food security, and decarbonization. India's annual petroleum import bill stands at Rs 24 lakh crore

and is growing at an alarming pace. By 2030, imports of petroleum, LNG, and petrochemical feedstocks are projected to rise steeply, by ending eningthe economy and undermining national security. Nearly 85 per cent of India's petroleum demand is met through imports, a figure that will only climb with GDP growth if corrective action is not taken. Petroleum-fuelled vehicles alone contribute nearly 40 per cent of India's environmental pollution, especially in cities like Delhi, which already ranks

among the most polluted globally. Unless India shifts gears, the dual crisis of import dependency and pollution will derail its growth story. The solution is a corn revolution. India must emulate the Brazilian model, which successfully transitioned to ethanol-based fuels. Brazil has mandated flex-fuel vehicles that run on 100 per cent hydrous ethanol (92 per cent ethanol + 8 p er cent water), reducing pollution and



petroleum dependence for over 30 years. India's demand is clear: 35 million tons/ year of gasoline Growing demand for sustainable aviation fuel (SAF), renewable diesel (RD), and ethylene for petrochemicals This can be fully met by producing 70 million tons of ethanol annually, requiring about 200 million tons of corn. A global comparison shows that while the USA produces 400+ million tons of corn/year; China 300+ million tons/ year, Brazil (with just a seventh of India's population) 150 million tons/year, India produces just 45 million tons/year but with a potential for 200 million tons within 5 years.

With India's 2–3 crop cycles per year, hybrid dent corn seeds, and modern practices, productivity can surpass the US.

The key advantages of corn as the new crude oil are: Energy Security: Reduced reliance on imports that are vulnerable to wars, sanctions, and tariffs. Rural Prosperity: Direct economic gains for farmers and rural India. Economic Savings: Billions saved on imports, fuelling GDP growth. Food & Nutrition Security: Corn by-products include food, animal feed, edible oil, and beverage-grade CO2. Clean Air: Sharp reduction in city pollution - India hosts 10 of the world's most polluted cities. Edible Oil Independence: Corn ethanol production would yield 4 million tons/year of corn oil, cutting palm oil imports (over \$20

billion annually).

Corn can produce not only biofuels (ethanol, methanol, SAF, RD) but also protein meal for livestock; cooking oil (a healthier alternative to palm oil); beverage-grade CO2 and dry ice; ethylene and downstream polymers and green hydrogen (with minimal power input). This makes corn the most versatile and strategic crop for India's energy transition. The Ministry of Petroleum recently approved \$100 billion for petroleum-based ethylene crackers. This is counterproductive.

The same ethylene can be produced from corn ethanol at just 30 to 40 per cent of the capital cost - with cleaner environmental impact and massive rural benefits. It is time we learnt from global successes. In the USA. 200 ethanol plants produce 60 million tons/ year, nearly double India's gasoline demand. In Brazil, flex-fuel cars run on 100 per cent ethanol or blends. California promotes E85 fuel (85 per cent ethanol + 15 per cent gasoline). India's strength is that with short 110-day crop cycles, India can scale up corn production faster than any global competitor.

Past success stories show this is possible. The use of Bt Cotton (2002) turned India from cotton importer to global leader in a decade. The use of GM Brinjal in Bangladesh increased crop productivity dramatically. A similar adoption of fuel-purpose yellow dent corn seeds can transform India's economy. The following actions recommended: Establish mega bio-ethanol plants (1200–1500 KLPD) via oil sector refineries. Build 10 new cornbased green ethylene complexes at a fraction of petroleum cracker costs.

Transition existing petrochemical crackers (IOC, BPCL, GAIL, RIL, Adani) from petroleum/LNG to corn. Declare Corn Production as a National Mission, with priority support equal to the Green Hydrogen Mission. Secure international corn supply agreements (Brazil, Argentina, Ukraine, USA) as a stop-gap until domestic capac-

The health and environmental gains from such a strategy will include reduced PM2.5 pollution and improved urban air quality; Corn oil as a heart-healthy substitute for palm oil and contribution to India's Net Zero 2070 goals. Corn is the new crude oil. It offers not just fuels and petrochemicals but also food, feed, oil, and CO value chains. With the right policies, India can achieve energy security; food security and decarbonization. Declaring Corn Production as a National Mission will make India truly Atma Nirbhar, resilient against oil cartels, and firmly on the path to becoming a Viksit Bharat by 2047.

### DC Doda reviews progress of NHIDCL projects


Stresses on road safety, timeline completion of NH works

New Delhi, Oct 17: The India-Sri Lanka free trade agreement (FTA), signed way back in 1998, "needs to be upgraded", Sri Lankan Prime Minister Harini Amarasuriya said on Friday.

In her address at NDTV World Summit here, she also said that as the island nation rebuilds, its partnership with India has "evolved into a forward-looking, multi-faceted collaboration in every conceivable area".

Amarasuriya is on a three-day

visit to India from October 16-18, her first official tour to the country after assuming office as the prime minister. On Thursday, she visited Hindu College here, where she received a red-carpet welcome, as the college described her return to the campus as a "remarkable homecoming"

of a "distinguished alumna".
While addressing the summit,
she recalled her arrival in Delhi
in the early 1990s as a young
Sri Lankan student, pursuing a
Bachelor's degree in sociology.

"Delhi.. a city that holds some of

my formative memories. Standing here in Delhi, feels like coming full circle. Three decades ago, in the early 1990s, I was a student at Hindu College, a young student from Sri Lanka, navigating a world in flux. Delhi was a city of ideas then, as it is now, reflecting the enduring spirit of India through the centuries," she said.

It was a period of change and economic reforms. "For many of us students, it was our first encounter with the concept of risk, in life, in economics, in politics and in identity". And, returning now, several decades later, "I see an India transformed, a confident, vibrant nation of 1.4 billion people charting its own path," Amarasuriya said.

India today stands among the fastest-growing major economies in the world. Its digital revolution, green transition and infrastructure initiatives are laying the foundation of Viksit Bharat, a vision of a developed and prosperous nation, she said.

"India's journey offers valuable lessons for developing countries, including my own," the Lankan PM said. The members in the audience included many word leaders from different fields.

"Today as Sri Lanka rebuilds, our partnership with India has evolved into a forward-looking, multi-faceted collaboration in every conceivable area, from development cooperation, training and capacity building, connectivity, including grid connectivity, energy security, digitalisation, education and technology, trade and investment, defence, tourism, culture and importantly peopleto-people connectivity," she said.

Advocate General is nowhere, and many organisations should have control of the elected government. In such a situation, there would be alienation," he said.

"As the alienation was ended in the first year of our tenure, we expect it to be ended in the second year," the Chief Minister said. (KNO)

House, Sheikh Khursheed (MLA, Langate) and Shabir Ahmed Kulley are the two independents aligned with the opposition bloc. Kulley contested the last Assembly election as an independent after being denied a party ticket.

Khursheed's Awami Ittehad Party does not exist in the records of the Election Commission of India, and he contested the election as an independent.

Assembly given opaque voting rules for them. According to officials of the Election Commission of India (ECI), open ballot voting applies only in elections to the Rajya Sabha. "Every political party which has members in the Assembly can appoint an authorized agent to verify whom its members have voted for. The authorized agent will be seated inside the polling station in seats provided by the Returning Officer. In the case of MLAs who are members of political parties, after they mark their vote and before inserting the ballot into the box, they are required to show the marked ballot paper to the authorized agent of their party," the officials said.

However, they added that independent MLAs are required to insert the marked ballot paper into the ballot box without showing it to any agent. "If they display their vote to anyone, including the authorized agent of any political party, it is liable to be cancelled," they said.

Among the Indian glacial lakes newly monitored under the Glacial Lake Atlas 2023, the combined water spread area increased by 7.74 per cent, from 11,963 hectares in 2021 to 12,890 hectares in 2025. In the trans-boundary region, the area rose by 5.77 per cent, from 44,409 hectares to 46,971 hectares over the

In July 2025, 471 glacial lakes within India displayed an increase in water spread area. PTI

#### SC voices concern over rising instances of digital arrest, seeks Centre's response

New Delhi, Oct 17: The Supreme Court on Friday took serious note of the digital arrest of a senior citizen couple in Haryana's Ambala on the basis of forged orders of the court and probe agencies by fraudsters to extort Rs 1.05 crore.

A bench of Justices Surya Kant and Joymalya Bagchi flagged the rising number of digital arrest cases across the country and sought the response of the Centre, CBI in a case registered as suo motu after the 73-year-old woman wrote to Chief Justice of India B R Gavai.

The bench said forging apex court, high court orders, signatures of judges to digitally arrest innocent people, including senior citizens, strikes at the bottom of trust and faith of people in judicial institutions.

The fabrication of judicial orders bearing forged signatures of judges strikes at the



very foundation of the public trust in the judicial system besides the rule of law. Such action constituted direct assault on the dignity of the institution," the top court said.

It added that such a grave criminal act cannot be treated as an ordinary or solitary offence of cheating or cyber

"We are also inclined to take judicial notice of the fact that the instance case is not the sole instance. It has been largely reported many times in the media that such crimes have taken place in different parts of the country. We are, therefore, of the view that action and coordinated efforts between the central and state police are required to unearth the full extent of the criminal enterprise involving forging judicial

documents, extortion/robbery

It sought assistance of the Attorney General and directed the Haryana government and Ambala cyber crime depart-ment to file a status report on the probe done so far in the case of senior citizen couple.

The matter was brought to the court's notice by the complainant woman who alleged that scamsters produced a forged court order with stamp and seal for arrest and surveillance of the couple between September 3 and 16 to defraud over Rs 1 crore through multiple bank transactions.

The woman said the court orders were shown through multiple audio and video calls by people impersonating as CBI and ED officers to arrest them.

The top court was informed that two FIRs were lodged with the cyber crime department at Ambala under various provisions of the Bharatiya Nyaya Sanhitya (BNS).

#### Chhattisgarh sees mass surrender of 210 Maoists, CM terms it historic

Jagdalpur, Oct 17: As many as 210 Maoist cadres, including one Central Committee member, surrendered before authorities in Chhattisgarh's Jagdalpur on Friday, making it the largest mass surrender in the history of anti-Naxal operations in the

state, officials said.
With this, a total of 238 Naxalites have quit the path of violence and joined the mainstream in the state in the last three days as 28 others had surrendered on Wednesday.

Hailing the development, Chief Minister Vishnu Deo Sai said it was a historic day not only for Bastar but for Chhattisgarh and the entire nation.

According to officials, Friday's mass surrender - the largest in the history of anti-Naxal operations in the state - marks a decisive turning point in the government's ongoing campaign to eliminate Left-Wing Extremism.

All the cadres, who surrendered before the police and paramilitary officials in Jagdalpur, the headquarters of the Bastar district, were formally welcomed into the mainstream by tribal community leaders and priests who greeted them with red roses, symbolising love, peace and a new beginning.

The surrendered cadres, senior police and paramilitary officials and tribal community leaders lat-

er posed for photographs.
The banner behind the stage, where cadres posed for photograph, read 'Poona Margem -Punarwas se Punarjeevan- Maoist cadres rejoining the mainstream'.

Poona Margem is a rehabilitation initiative launched by Bastar Range police for Naxalites. er, CM Sai said 210 brothers and sisters who were misguided and detached from society rejoined the mainstream today, showing faith in the Constitution, the path of non-violence as shown by Mahatma Gandhi, and the state's rehabilitation policy.

The surrendered cadres include top-rung leaders to lower-rung members, he said, congratulating and wishing them well for their future. The state's Surrender and Rehabilitation policy has multiple provisions, including financial assistance, land benefits, benefits in the new Industrial policy and linking them with employment,

The historic event is seen as a result of the central and state governments' comprehensive anti-Naxal strategy, supported by sustained efforts from the police, security forces, local administration, and the active participation of aware and vigilant communities, he said.

Senior Maoist leaders who surrendered include Rupesh alias Satish, a Central Committee member; Bhaskar alias Rajman Mandavi, Ranita, Raju Salam, Dhannu Vetti alias Santu - all four Dandakaranya Special Zonal Committee (DKSZC) members, and Ratan Elam, a Regional Committee Member, officials said.

The surrendered Maoists handed over 153 weapons, including 19 AK-47 rifles, 17 Self-Loading Rifles, 23 INSAS rifles, an INSAS LMG (light machine gun), thirty six .303 rifle, four Carbine and 11 Barrel Grenade Launcher (BGL), a police official said.

On October 2, as many as 103 Naxalites, 49 of them carrying a collective bounty of more than Rs 1.06 crore, had surrendered in Bijapur district of Bastar region.

Union Home Minister Amit Shah has repeatedly underlined the government's resolve to eradicate Naxalism, largely con-centrated in Chhattisgarh's Bastar region, by March 31, 2026.

On Thursday, Shah declared two worst-hit regions of Chhattisgarh, Abujhmarh and North Bastar, free from Naxal terror and made it clear that those willing to surrender are welcome, but those who continue to wield guns will

Mumbai, Oct 17: Benchmark Sensex spurted by 484 points and Nifty closed above 25,700 on Friday, extending their winning run to the third consecutive day on buying in blue-chip banking and oil shares and foreign fund inflows.

In a volatile session, the 30-share SE Sensex jumped 484.53 points or 0.58 per cent to settle at 83,952.19. During the day, it surged 704.58 points or 0.84 per cent to 84,172.24.

The 50-share NSE Nifty climbed 124.55 points or 0.49 per cent to 25,709.85. Among Sensex firms, Asian Paints jumped the most by 4.18 per cent. Mahindra & Mahindra, Bharti Airtel, ITC, Hindustan Unilever, ICICI Bank and Reliance Industries were also among the gainers.

However, Infosys, HCL Tech, Eternal, Tech Mahindra and Tata Steel were among the laggards.

Foreign Institutional Investors (FIIs) bought equities worth Rs 997.29 crore on Thursday, according to exchange data. Domestic Institu-tional Investors (DIIs) also bought stocks worth Rs 4,076.20 crore in the previous trade.

In Asian markets, South Korea's Kospi settled in the positive territory while Japan's Nikkei 225 index. Shanghai's SSE Composite index and Hong Kong's Hang Seng ended lower. Markets in Europe were trading

#### **US** Chamber of **Commerce challenges** \$100,000 H-1B visa fee, cites legal concerns



Washington, Oct 17: The US Chamber of Commerce has filed a legal challenge to the administration's \$100,000 fee on H-1B visa petitions, an of-ficial release by the Chamber stated on Thursday.

The Chamber's litigation argues that the new fee is unlawful because it overrides provisions of the Immigration and Nationality Act that govern the H-1B program, including the requirement that fees be based on the costs incurred by the government in processing visas.

In announcing today's action, Neil Bradley, Executive Vice President and Chief Policy Officer at the US Chamber,

issued the following statement: "The new \$100,000 visa fee will make it cost-prohibitive for US employers, especially start-ups and small and midsize businesses, to utilize the H-1B program, which was created by Congress expressly to ensure that American businesses of all sizes can access the global talent they need to grow their operations here in

the US," Bradley said, as per an official release by the US Chamber of Commerce. "President Trump has embarked on an ambitious agenda of securing permanent pro-growth tax reforms, unleashing American energy, and unraveling the overregulation that has stifled growth. The Chamber and our members have actively backed these proposals to attract more investment in America. To support this growth, our economy will require more workers, not fewer.

'The president deserves credit for securing our nation's border. With the border secure, we now have a once-in-a-generation opportunity to accomplish targeted legal immigration reforms, and we stand ready to work with Congress and the administration to make that happen. That includes working together on common-sense reforms to improve the visa process for skilled workers. The president has said he wants to educate, attract, and retain the world's best and brightest in the US, and the Chamber shares that goal," the US Chamber of Commerce added.

## Trump to meet Zelensky after announcing Putin summit

Washington, Oct 17: Ukrainian President Volodymyr Zelensky meets Donald Trump at the White House Friday, seeking US-made Tomahawk missiles even as the US president reaches out to Russia's Vladimir Putin for a fresh summit.

Zelensky will be making his third trip to Washington since Trump returned to office, following a disastrous televised shouting match in February and a make-up meeting in August, as the US leader's stance on the war blows hot and cold.

Trump's latest pivot came on the eve of Zelensky's visit. He announced that he would be meeting Putin in Budapest, in a fresh bid to reach a peace deal and end Moscow's invasion launched in 2022.

Ukraine had hoped Zelensky's trip would be more about adding to the pressure on Putin, especially by getting American-made long-range Tomahawk cruise missiles that can strike deep into Russia. But Trump, who once

in Ukraine within 24 hours, appears set on pursuing a new diplomatic breakthrough to follow the Gaza ceasefire deal that he brokered last week. Trump said Thursday he had

said he could end the war

a "very productive" call with Putin and that they would meet in the Hungarian capital within the next two weeks. He added that he hoped to have "separate but equal" meetings with both Putin and Zelensky but did not elaborate. Zelensky said as he arrived Thursday in Washington that he hoped Trump's success with the Gaza deal would bring results to end the war that has left swathes of his own country in ruins. "We expect that the momentum of curbing terror and war that succeeded in the Middle East will help to end Russia's war against Ukraine," Zelen-

sky said on X. Zelensky insisted that the threat of Tomahawks had forced Moscow to negotiate.

Moscow is rushing to resume dialogue as soon as it hears about Tomahawks," Zelensky said, adding that he'll also be meeting US defense companies to discuss additional supplies of air defense systems.

'Didn't like it' Trump however cast doubt on whether Ukraine would ever get the coveted weap-

ons, which have a 1,000-mile

1,600-kilometer) range.

Trump told reporters on Thursday that the United States could not "deplete" its own supply. "We need them too, so I don't know what we can do

about that," he said. The US president said the Russian leader "didn't like it" when he raised the possibility during their call of giving Tomahawks to Ukraine.

The Kremlin said on Thursday it was making immediate preparations for a Budapest summit after what it called the 'extremely frank and trustful" Putin-Trump call.

But Putin told Trump that giving Ukraine Tomaĥawks

"We can already see that would "not change the situation on the battlefield" and would harm "prospects for peaceful resolution," the Russian president's top aide Yuri Ushakov told journalists.

Trump's relations with Putin – a leader for whom he has repeatedly expressed admiration over the years — and Zelensky have swung wildly since he returned to the White House in January. After an initial rapprochement, Trump has shown increasing frustration with Putin, particularly since he came away from meeting the Russian president in Alaska with no end to the war in sight.

Zelensky meanwhile has gone the opposite way, winning back Trump's support after the disastrous Oval Office encounter when the US president and Vice President JD Vance berated him in front of the cameras.

The Ukrainian returned in August — wearing a suit after he was mocked for not wearing one in the first meeting — and accompanied by a host of Western leaders in solidarity.

#### Trump warns US may 'go in and kill Hamas' if attacks continue

New Delhi, Oct 17: US President Donald Trump has warned that the United States may be forced to take military action against Hamas if the group continues targeting civilians in Gaza.

Trump posted on Truth Social, "If Hamas continues to kill people in Gaza, which

was not the Deal, we will have no choice but to go in and kill them." The warning comes a day after Trump addressed the ongoing situation in Gaza, focusing on Hamas' search for the remaining deceased hostages and the broader implications of the US-brokered peace agreement.

Taken together, Wednesday's remarks on hostages and the peace deal help explain Thursday's stark warning, linking humanitarian concerns over civilians and hostages with the possibility of stronger US action if attacks continue.

Describing the grim task in recovering bodies, Trump told reporters in the Oval Office, "It's a gruesome process... They're digging and they're finding a lot of bodies. Then they have to separate the bodies."

He elaborated on the conditions in which some bodies were found, noting, "Some of those bodies have been in there a long time, and some are under rubble. They have to remove rubble. Some are in tunnels... that are way down under the earth.

These comments contextualise the severity of the

humanitarian situation on the ground, which underpins his warning about potential US action. Turning to the issue of weapons, Trump stressed the need for Hamas to comply with the peace agreement, saying, "We want the weapons to be given... They've agreed to do it. Now they have to do it. If they don't do it, we'll do it."

#### Last surviving member of first team to climb Mt Everest passes away

New Delhi, Oct 17: Kanchha Sherpa. the last surviving member of the first successful summit of Mount Everest in 1953, passed away at the age of 89.

Sherpa, who had been unwell for quite some time, died early Kathmandu, said Phur Gelje Sherpa, President of the Nepal Mountaineering Association.

"With his passing, there are no longer any surviving members of

that legendary team of climbers, which is a great loss for the entire mountaineering community," he told IANS.

His last rites are scheduled to be performed on October 20 as per Sherpa tradition.

Sherpa is survived by two sons, two daughters, and their children. team that led Sir Edmund Hillary

of the 8,848.86-metre peak on May He was one of three Sherpas to

and Tenzing Norgay to the summit

#### Apple's iPhone Air sold out in China minutes after its launch

Beijing, Oct 17: Apple's iPhone Air sold out within minutes of its launch in China on Friday, notwithstanding the current tariff war between Washington and Beijing.

The new iPhone instant sale also underscores its popularity among Chinese consumers despite competition from Android devices.

The strong sales followed Apple CEO Tim Cook's visit this week to promote the product in the world's largest smartphone market amid ongoing geopolitical tensions between China

Cook is the chairman of an advisory body at China's Tsinghua University's

During his visit, he also met Chinese Vice-Premier He Lifeng, who heads China's trade delegation, which is currently holding trade talks with the US to resolve tariffs on Chinese exports.

Pre-sales for the iPhone Air, which supports only e-SIM, began at 9 am local time on Friday, more than a month later than most of the world.

Minutes after bookings opened, the model was sold out at all bricks-and-mortar stores in Beijing and Shanghai, as well as in cities like Tianjin, according to Apple's website. Online shipments were delayed by one to two weeks, according to the Hong Kong-based South China

#### Head expects Rohit, Kohli to play 2027 ODI World Cup

Perth, Oct 17: Hard hitting Australian opener Travis Head expects the "great white ball" duo of Virat Kohli and Rohit Sharma to carry on till the 2027 ODI World Cup.

India and Australia play each other frequently across formats and the players of both teams know each other well also because of the IPL. However, Head has never got the chance to speak to Rohit about batting and it is something he hopes to do in the near future.

"It's nice just watching from



afar, as someone who plays the game in a similar way, I think, and having played a lot against him in IPL and a lot of international cricket against him, I feel like he goes the right way about things, he plays the game in the

'But, yeah, I've never really come in contact with him, haven't had the opportunity to play with him anywhere. But, yeah, there might be an opportunity, but like I said, I think he's going to play for a little bit longer and have the opportunity to play in India a few bits, so that opportunity may come," said the southpaw. Head was non-committal when asked whether he would play all eight white ball games against India considering the Ashes is round the corner.

On Cameron Green being ruled out of the India series, Head said it is more of a precautionary measure ahead of

"I'm sure he's (Green) going all right. He's in good hands. I haven't spoken to him just yet, so it's pretty new. So, yeah, work through it. It's like nothing else with some guys, getting some injuries. We've got, obviously, Josh (Hazlewood) in the same position as well.

"So, yeah, work through that. But, unfortunately, we're not going to have him. I don't think it'll have any impact on the Ashes. It's more disappointing that he's not here at the moment for the next three games," said Head.


He expects the series to be highly competitive like it often has been in the past.


"Yeah, always a big series. If you look at the guys playing the series, eight games, it's against highly skilled opposition. So, it's a very exciting start to the summer," he added.
