9-day autumn session of J&K Assembly to begin today

Obituary reference for 6 deceased MLAs listed in day-1 business Opp to corner govt over election promises, reservation, statehood

Srinagar, Oct 22: The nineday autumn session of the Jammu & Kashmir Legislative Assembly is expected to be stormy, with opposition parties gearing up to corner the ruling National Conference (NC)-led government over a range of issues.

The session, comprising six sittings, will begin tomorrow with obituary references for six former legislators who passed away after the last budget session held in Jammu.

The proceedings are expected to be stormy, with the opposition expected to target the government over governance failures, unfulfilled

election manifesto, demands for statehood, and reservation-

related concerns. Talking to news agency-Kashmir News Observer (KNO), Leader of Opposition Sharma said Sunil Bharatiya Janata Party (BJP)

will demand accountability from the NC-led government for what he described as a "betrayal of electoral promises." "The government has failed to deliver on its commitments made during the electionswhether it is the promise of 200 free units of electricity, 12 LPG cylinders per household, or other assurances given to the people," Sharma said.

He further said that the BJP will question the government on its inability to create employment opportunities for the youth. "In the election, the government promised to create one lakh jobs for the youth, but they have done nothing. We will ask them what they have done for the youth in the past year," he added.

Meanwhile, Kashmir-based opposition parties such as the Peoples Democratic Party (PDP), Peoples Conference (PC), and Awami Ittehad Party (AIP) are expected to agitate over issues like statehood | More on P6

Srinagar, Oct 22: Chief Minister Omar Abdullah on Wednesday exuded hope that the National Conference (NC) would emerge victorious in all four seats in the Rajya Sabha elections, slated to be held on October 24. Foundation for 'Op Sindoor' was laid in 2016 after Uri terror attack: Army Chief

'Situation was nothing new to me, had seen it before'

New Delhi, Oct 22: Army Chief General Upendra Dwivedi on Wednesday said that the foundation for 'Operation Sindoor' was laid down in 2016 soon after Pakistan sponsored terrorists attacked an Army camp near Line of Control (LoC) at Uri in North Kashmir's Baramulla District.

Speaking at the unveiling of "Civil Military Fusion as a Metric of National Power and Comprehensive book and of Valour: "Portraits Timeless Military Art" coffee table book by Defence Minister Rajnath Singh, the Army Chief, according to the news agency—Kashmir News Observer (KNO) said, "Higher command course always talks about 'why'. Three things which I picked up from him [Lt Gen Raj Shukla (Retd)] at that point in time...The second thing was the foundation for Operation Sindoor. At that time (in 2016) Uri had happened and he conducted a detailed discussion and various options, how should we go about this situation which comes in

Referring to 'Operation

that launched to avenge April 22 Pahalgam terror attack that left 26 civilians dead, the Army Chief said that when the situation was discussed with him it was Uri attack had happened all the options were discussed to deal with the situations that could arise in future. "So, I must concede very frankly, when this situation came to me, it was a very normal thing for me because I had already seen this earlier."

Pertinently, earlier this month the Army Chief had issued a fierce warning to Pakistan. "If the neighbouring country continues to support terrorism it will lose its geographical presence. If Pakistan wants to retain its place on the map, it must stop statesponsored terrorism,' the Army Chief had said speaking at an Army post in Rajasthan's Anupgarh.

He had maintained that the Indian forces won't show any restraint this time, hinting that a second version of 'Operation Sindoor' wouldn't be far away if Islamabad refuses

to med its ways.

Govt proposes tighter rules for AI-content, deepfakes

Moots labelling, greater onus on platforms

New Delhi, Oct 22: The government on Wednesday proposed changes to IT rules, mandating the clear labelling of AI-generated content and increasing the accountability of large platforms like Facebook and YouTube for verifying and flagging synthetic information to curb user harm from

deepfakes and misinformation. The IT Ministry noted that



deepfake audio, videos and synthetic media going viral on social platforms have demonstrated the potential of generative AI to create "convincing

falsehoods", where such content can be "weaponised" to spread misinformation, damage reputations, manipulate or influence elections, or commit

The proposed amendments to IT rules provide a clear legal basis for labelling, traceability, and accountability related synthetically-generated information.

Apart from clearly defining synthetically generated information, the draft amendment, on which comments from stakeholders have been sought by November 6, 2025, mandates labelling, visibility, and metadata embedding for synthetically generated or modified information to distinguish such content

from authentic media. The stricter rules would

increase the accountability of significant social media intermediaries (those with 50 lakh or more registered users) in verifying and flagging synthetic information through reasonable and appropriate technical measures.

The draft rules mandate platforms to label AI-generated content with prominent markers and identifiers, covering a minimum of 10 per cent of the visual display or the initial 10 per cent of the duration of an audio clip.

It requires significant social media platforms to obtain a user declaration on whether uploaded information | More on P6

The high octane league will see the participation of eight teams for a fortnight while the stadium is expected to remain brimmed with the crowd coming from all across the J&K.

To ensure the smooth conduct of the mega sports event, Divisional Commissioner Kashmir Anshul Garg today chaired a comprehensive meeting of officers from various departments to take first hand appraisal of the preparations to set the stage ready for IHPL.

While reviewing the arrangements for the itinerary of the players, Div Com directed organisers to keep security agencies informed about the arrival, accommodation and movement of all players. The meeting

New Delhi, Oct 22: After several months of a freeze in communication, dialogue between the Ministry of Home Affairs (MHA) and representatives from Ladakh Union Territory resumed on Wednesday.

Reportedly, the discussions focused on four specific demands, including statehood for Ladakh, inclusion under the Sixth Schedule of the Constitution, implementation of reservation measures, and the removal of the National Security Act (NSA) imposed on climate activist Sonam Wangchuk.

The talks lasted close to two hours and included a nine-member delegation comprising leaders from the Leh Apex Body (LAB) and the Kargil Democratic Alliance (KDA), along with Ladakh's Member of Parliament Mohd Haneefa Jan.

This meeting marked a



renewed effort to find common ground after recent unrest in Leh and long-standing demands from the region's civil groups.

According to members present at the meeting, discussions were held on each point raised. On statehood and the Sixth Schedule, the delegation explained that Ladakh required greater control over its resources, land, and administrative mechanisms. They

Member of the Kargil Democratic Alliance (KDA), Sajjad Hussain Kargili, said their demand for the past six vears has been the restoration of democracy in Ladakh, with statehood being the best solution.

He added that the issue could not be resolved in one or two meetings as it required a process, which was already underway.

Fire safety tightened for winter

Srinagar, Oct 22: The Office of the Divisional Commissioner, Kashmir, has issued a circular instructing all Deputy Commissioners (DCs) across the valley to implement strict fire safety measures ahead of the winter season.

The move comes after repeated advisories failed to prevent recurring fire incidents, which have caused significant loss of life and property.

According to the circular, it has been observed with serious concern that, despite awareness campaigns, a substantial number of fire incidents continue to be reported across various districts of the Kashmir Division, particularly during the winter months.

The circular states that these incidents have resulted in significant loss of life and property, primarily due to electrical short circuits, improper handling of heating appliances, and unsafe storage of combustible materials.

"Accordingly, all Deputy Commissioners are hereby requested to undertake and enforcement measures within their respective jurisdictions," it reads.

The circular adds that DCs should formulate and implement a comprehensive District-Level Winter Fire Safety Plan in coordination with the Fire & Emergency Services Department, Power Development Department (PDD), Public Health Engineering (PHE), Health Department, and Municipal & Panchayat authorities. The Department of Fire & Emergency Services shall designate one District-Level Nodal Officer for the purpose. Awareness Campaigns: Launch intensive public awareness drives through electronic, print, and social media platforms to sensitize residents about the safe handling of electrical and heating appliances, LPG usage, and fire prevention measures.

Inspection of Wiring and Electrical Load: Ensure that PDD teams conduct random inspections of residential and commercial wiring, with particular attention to high-risk areas prone to overloading, congested urban centers with wooden structures, and substandard electrical installations.

Fire Safety Audits: Direct Fire & Emergency Services to undertake fire safety audits of congested urban localities, government offices, hospitals, schools, markets, and residential clusters. Ensure that identified deficiencies are rectified within a fixed timeframe.

Combustible Storage Regulation: Take strict action against the improper storage of combustible materials, such as dry grass, firewood, and LPG cylinders, in congested localities or residential premises.

Hamam and Gas Heater Safety: Conduct awareness and inspection drives for hamams and LPG/gas heaters, particularly emphasizing the removal of LPG cylinders from bedrooms during night hours. Coordination with Local Bodies: Direct Municipal Committees, Panchayats, and Urban Local Bodies to ensure unobstructed fire lanes, accessible water points, and readiness of local fire hydrants throughout the winter months. Emergency Preparedness: Review district disaster management preparedness, including the availability of fire tenders, emergency water sources, and quick response teams, especially in snow-bound areas.—(KNO)

Iodised salt combats iodine deficiency: Doctors

Srinagar, Oct 22: "There is a need for consuming iodised salt to prevent iodine deficiency - a silent but serious nu-tritional disorder that continues to affect millions across the globe,' doctors in Kashmir said.

Although awareness about the use of iodised salt has improved significantly in Jammu and Kashmir, experts warn that lapses in its use can still lead to grave health complications, particularly among women and children. Dr Shabir Ahmad Dar from the Directorate of Health Services Kashmir (DHSK) said that iodine is a vital micronutrient required for the production of thyroid hormones, which regulate a paediatrician, said

metabolism, growth, and development.

"When the body does not get enough iodine, the thyroid gland enlarges in an attempt to capture more iodine from the bloodstream, leading to the formation of a goitre – a visible swelling in the neck," he said.

Dr Dar said that iodine deficiency is one of the leading causes of preventable brain damage in children. "In pregnant women, the deficiency can lead to miscarriages, stillbirths, and mental disability in newborns. Children born to iodine-deficient mothers often suffer from developmental delays, stunted growth, and lower IQ levels," he

that despite significant progress under the National Iodine Deficiency Disorders Control Programme (NIDDCP), there is still a need for continuous awareness

and monitoring. "The use of iodised salt is one of the simplest and most effective ways to prevent iodine deficiency. Every household must ensure that the salt they use is adequately iodised," he said.

Recent health surveys, including NFHS-5, have shown encouraging trends, with around 98 per cent of households reportedly using iodised salt. However, officials caution that proper storage and usage are equally important, as iodine can evaporate if the salt is exposed to moisture or heat for prolonged periods. Doctors said that pre-

ventive measures include the iodised salt for daily cooking and ensuring it is stored in an airtight container away from moisture and sunlight, educating communities about the importance of iodine in the diet, conducting regular health check-ups and awareness programs, especially in remote and rural areas and encouraging monitoring of iodine levels in commercially sold salt to ensure compliance with health standards.

They have urged the people to be vigilant and consistent in using iodised salt, stressing that the cost of prevention is negligible compared to the lifelong impact of iodine deficiency disorders.

Garbage disaster looms over Wullar Lake

Bandipora, Oct 22: North Kashmir's Bandipora district is witnessing a growing environmental crisis as another shore of the famous Wullar Lake, located in the Puthshay area, is rapidly transforming into a dumping site.

This follows a similar situation at Zalwan, which locals termed the failure of local authorities to enforce effective solid waste management

A visit to the site revealed heaps of foul-smelling garbage dumped along the lake's edge, causing significant inconvenience to residents and marring the beauty of the area, which is located near the proposed site for the fruit mandi.

The situation is aggravated by stray dogs scavenging through the waste, posing a safety risk to people passing by. "Many people have been bitten by these dogs in recent times," said Muhammad Amin, a local resident. He recalled a time when the area was cleaner, with boats moored along the shore, but lamented how the place has deteriorated over the years. "The garbage has spread everywhere, and while the authorities are responsible, people's careless behaviour is also to blame," he

He also noted that the location's proximity to the Bandipora-Sopore road worsens the problem.

Adding to the environmental degradation, locals said that dead animals are frequently dumped here, further contaminating the area. Saleem Dar, another resident, expressed concern over the government's inaction despite multiple complaints. "The administration is spending large sums of money trying to clean the lake, but people keep polluting it," he said.

He warned that toxic substances from the waste could dissolve into REPRESENTATIONAL IMAGE

the water, posing a severe threat to the lake's ecosystem. Dar urged that proper scientific methods be adopted to manage and treat the waste effectively.

Locals also blamed the general public for contributing to the pollution. "If the people who live here don't protect Wullar Lake, who else will?" questioned a

group of residents.

They called on the administration to impose strict penalties on those responsible for dumping waste, stressing that such action is crucial to prevent further damage to the lake. Residents said the Rural Development Department (RDD) has been involved in cleanup efforts for several weeks, but without public cooperation and stricter enforcement, these efforts are unlikely to bring lasting relief.

An official said that he will look into the matter—(KNO)

Simplify Labour Registration For J&K's Construction Workers

The cumbersome process for registering construction workers in Jammu and Kashmir has become a barrier preventing thousands from accessing the welfare benefits they rightfully deserve. While the government has established welfare boards and schemes aimed at supporting this vulnerable workforce, the complex registration procedures have effectively excluded many genuine labourers from the social security net they helped build through their contributions. The construction industry forms the backbone of J&K's infrastructure

workforce. These workers endure harsh conditions to build our homes, roads, and institutions, yet when it comes to accessing their legal entitlements-whether educational assistance for their children, marriage support, or accident compensation-they face bureaucratic labyrinths that defeat the very purpose of welfare legislation. The current system requires urgent simplification. Registration should be made accessible through mobile units, common service centers, and labour union offices rather than confined

development, employing a substantial portion of our to distant government offices. The documentation requirements need rationalisation, recognising that many workers lack formal education or extensive paperwork. Decentralising the process by authorising medical officers at the district level to issue necessary certificates would save workers both time and resources. Equally important is ensuring that the welfare cess collected from construction projects actually reaches the intended beneficiaries. The pending files across districts regarding educational assistance, marriage support, and compensation

need immediate clearance through special drives. Extending application deadlines during holiday periods demonstrates the flexibility and empathy that should characterise all welfare administration. A streamlined registration system is a moral imperative. When workers can easily access their rights, we not only uphold their dignity but also strengthen the entire social fabric. The government must treat this as a priority, removing unnecessary hurdles and ensuring that those who build Jammu and Kashmir can also share in its prosperity.

Are We True To Our Constitution?



The generation that saw independence witnessed India's transformation from ■ food scarcity to surplus, from 400 million people to 1.4 billion, and from Gandhian simplicity to a politics often driven by privilege and power

It would be pretty interesting for the millennials, or the Generation Z, to interact with the octogenarians, born subjects of the British Empire, but who were fortunate enough to become citizens of free India, and are still active and alert! They learnt the basics of democracy in universities in the late fifties and early sixties of the last century!

These senior citizens have witnessed the great Indian demographic transition from 400 million to 1,400 million, and all of the natural consequences that followed it. They grew up in an environment full of the fragrance of the values and principles preached and practiced during the unique freedom struggle. They could recall how the Prime Minister Lal Bahadur Shastri had to appeal to the nation to "miss a meal every week", as we were short of food grains!

Today, India feeds a hundred crore more, and is also an exporter of foodgrains! This select group of Indians is also, sadly enough, a witness to the erosion of the proudly treasured Gandhian values and democratic principles. It has quietly observed the emergence of an apolitical class, with varied party affiliations, falling prey to perks, privileges and pelf! To them, democracy is just winning elections, getting a position of power, and then using it unashamedly — exceptions apart — for the accumulation of riches. One of the funniest episodes that says it all is that of a former Chief Minister, who was unseated by the Court within forty-eight hours! When he found the environment congenial I need not elaborate — he approached the



Court that he be declared a 'former Chief Minister'! The plea was, however, rejected. Numerous privileges are now legally available 'for life' to the 'ex-benefactors' of the people, in which all of the ex-CMs are included! These were awarded to themselves by the honourable lawmakers, aka, the elected representatives of the people!

One wonders how Mahatma Gandhi would have reacted to such a state of affairs!Think of an Indian delegation addressing the UN General Assembly on "Gandhian Values in Indian Democracy"! It could be led by veteran politician Sharad Pawar, and could comprise Lalu Prasad Yadav, Arvind Kejriwal, Ajit Pawar, A Raja, Partha Chatterji, Madhu Koda, great inheritors like Akhilesh Yadav, MK Stalin, Kanimozhi, Supriya Sule, Tejasvi Yadav, Misa Bharati, Ajay Chautala, and several others. Imagine their presentations on Peace, Non-Violence, Truth, social cohesion, service of man is the service of God! I am

sure some of them would certainly refer to Mahatma Gandhi, Dr. Rajendra Prasad, Lal Bahadur Shastri, Gulzari Lal Nanda, and certainly APJ Abdul Kalam! India's eternal strength is exemplified by the fact that this list still remains long! One is confident that none of the delegates would make any reference to their own meteoric economic rise, including the Swiss bank accounts, etc. When the elected representatives take the oath of allegiance and secrecy, one could just speculate regarding the stirring within! Often people observe the transition of solemn pledges into sheer hypocrisy!

The voter, who knows his five-yearly adulation, is by now well familiar with how the elected representative would get so busy with the matters of family and friends, preparation for the next elections, and preparing his own son or daughter as his successor, that there would be little time and space for the elector! The elector had indeed exercised his autonomy in 1977, when Indira Gandhi was unseated, and within two years, the anger erupted again against the successor government that failed miserably in coming anywhere near the expectations of its electors. In fact, the return of Indira Gandhi - and Sanjay Gandhi, is indeed a great area of research for future researchers. It is said that the entire planning for the historic return was developed and executed by Sanjay Gandhi, who was the most hated person in 1977! There is so much to be learnt from the study of the Indian political scenario during that five-year period: from the imposition of Emergency in June 1975, to the return of Indira Gandhi to power in January 1980!

The voter was alert and executed his own choice. The only other occasion of that level was the 2014 general election, in which voting was not on party lines, but for a person who had proved that in spite of all possible odds, one who works for the people steals their hearts. One had the gracious privilege of interacting for over six decades with young persons, fellow teachers, researchers. and also educational administrators and policymakers. It is but natural to recall the days of unprecedented adulation and admiration for Pandit Nehru, who was the hero of the young of those days. The Chinese invasion shattered his aura, but there were others in the political arena whose honesty, integrity, commitment and purity in public life were reassuring to one and all. During the 1962 and 1965 attacks on India, one participated as a volunteer, mostly serving tea and snacks to the soldiers moving in special trains to their assigned destination. The ideological differences amongst the student wings in universities had coalesced into a dedicated national effort. Everyone was supporting the government, no one was asking for any proof on the claims made by the then government.

The demoralisation of 1962 was gloriously replaced by a newly found confidence

in 1965 and 1971. Everyone was proud of Indian defence forces, our admired heroes, but everyone was giving total credit to the leadership of Indira Gandhi, and this included her staunch detractors in the political arena. All that stands fully forgotten at this stage. Politicians do play their own games, depending upon being in power, or ousted from it. None need assume the authority to challenge the facts and figures presented to the nation by the Indian Army. It is a serious situation that reveals the presence of negative forces, being in collusion with the stooges of the notorious destabilising forces. Negativity, arising out of a bunch of frustrated politicians, is trying its best to overshadow the rising stature of the Indian nation. And this is not unexpected.

This apprehension was so succinctly foreseen by Dr Rajendra Prasad as the President of the Constituent Assembly in his speech delivered on November 26, 1949: "Whatever the Constitution may or may not provide, the welfare of the country will depend on the way in which the country is administered. That will depend upon the men who administer it. It is a trite saying that a country can have only the Government it deserves. If the people who are elected are capable, and men of character and integrity, they will be able to make the best even of a defective Constitution. If they are lacking in these, the Constitution cannot help the country. After all, a constitution, like a machine, is a lifeless thing. Trump dials Modi, extends Diwali greetings



New Delhi, Oct 22: US President Donald Trump extended Diwali greetings in a phone call to Prime Minister Narendra Modi, who said he expected that both India and the US continue to "illuminate" the world with hope and stand united against terrorism.

The phone conversation, initiated by the US president, came days after he claimed that PM Modi told him that India would stop buying Russian crude oil. Following Trump's comments, India suggested that there was no such conversation.

"Thank you, President Trump, for your phone call and warm Diwali greetings. On this festival of lights, may our two great democracies continue to illuminate the world with hope and stand united against terrorism in all its forms," Modi said on X on Wednesday.

It was the third publicly known phone call between Modi and Trump since September 16, amid the continuing strain in India-US relations over Washington slapping 50 per cent tariffs on Indian goods, including a 25 per cent levy for New Delhi's procurement of Russian oil.

On Tuesday night, Trump hosted a Diwali celebration that was attended by Indian Ambassador to the US Vinay Kwatra and several prominent Indian-origin business leaders.

In his remarks at the ceremony, Trump repeated his claim that India will not buy crude oil

The US president described PM Modi as a "great leader" and a "friend", and also referred to his trade-focused diplomacy to de-escalate tensions between India and Pakistan.

The relations between New Delhi and Washington have been reeling under severe stress after Trump imposed 50 per cent tariffs on India.

India described the US action as "unfair, unjustified and unreasonable".

back, US Two weeks Ambassador-designate Sergio Gor met PM Modi in New Delhi. Following the meeting, Gor said the US "values" its relationship with India. Gor also held talks with External Affairs Minister S Jaishankar, National Security Advisor Ajit Doval and Foreign Secretary Vikram Misri.

UN chief calls for 'fight' against climate disinformation

Geneva, Oct 22: UN chief Guterres Wednesday called for a fightback against climate disinformation ahead of next month's COP30 summit after US President Donald Trump branded climate change the "greatest con job ever."

Guterres issued a robust defense of "clear-eyed" climate science and data, without which, he said, the world would never have understood the emergence of the "dangerous and existential threat of climate change.'

"We must fight mis- and disinformation, online harassgreenwashing," ment, and Guterres said at the UN's World Meteorological Organization (WMO) weather and climate agency in Geneva.

"Scientists and researchers should never fear telling the

Guterres's remarks will be

seen in some quarters as a riposte to Trump's speech at the United Nations in New York last month, in which the Republican president championed fossil fuels and derided green technologies.

"Climate change - it's the greatest con job ever perpetrated on the world, in my opinion," said Trump.

The "carbon footprint is a hoax made up by people with evil intentions," he said.

"We're getting rid of the falsely named renewables, by the way: they're a joke, they don't work they're too pensive," he added, about his administration's war on solar and wind power, bolstered by a new law that ends clean energy tax credits.

Planet on the 'brink' But Guterres insisted that in

2024, "almost all new power capacity came from renewables," and investment was surging.

"Renewables are the cheapest, fastest and smartest source of new power. They represent the only credible path to end the relentless destruction of our climate," he insisted.

The WMO is marking its 75 anniversary this year, and is leading the charge for all countries to be covered by extreme weather early warning systems

"Global warming is pushing our planet to the brink," said Guterres.

"Every one of the last 10 years has been the hottest in history. Ocean heat is breaking records while decimating ecosystems. And no country is safe from fires, floods, storms and heatwaves.

"As always, the poorest and most vulnerable countries pay the highest price - particularly small island developing states and the least developed countries.

Labelling of AI-generated a step toward ensuring authenticity in digital content: Experts

New Delhi, Oct 22: The proposed amendments to the IT Rules that would mandate clear labelling of AI-generated content and place greater onus on large social media platforms are a clear step toward ensuring authenticity in digital content, Mahesh Makhija, partner and technology consulting leader at EY India, said on Wednesday.

Labelling AI generated material and embedding non-removable identifiers will help users distinguish real content from synthetic, serving as the foundation for responsible AI adoption.

'...these measures will give businesses the confidence to innovate and scale AI responsibly. The next step should be to establish clear implementation standards and collaborative frameworks between government and industry, to ensure the rules are practical, scalable, and supportive of India's AI leadership ambitions," Makhija added.

According to Makhija, the proposed rules mark a clear step toward ensuring authenticity in digital content.

Akshay Garkel, Partner, Grant Thornton Bharat, believes that the proposed amendment is a timely and necessary move, especially as deepfakes are getting worryingly convincing.

"It's good to see the government and law enforcement taking the issue seriously and acting to curb this menace," Garkel

The IT ministry noted that deepfake audio, videos and synthetic media going viral on social platforms have demonstrated the potential of generative AI to create "convincing falsehoods", where such

content can be "weaponised" to spread misinformation, damage reputations, manipulate or influence elections, or commit financial fraud.

The proposed amendments to IT rules provide a clear legal basis for labelling, traceability, and accountability related synthetically-generated information.

Apart from clearly defining synthetically generated infor-mation, the draft amendment on which comments from stakeholders have been sought by November 6, 2025 - mandates labelling, visibility, and metadata embedding for synthetically generated or modified information to distinguish such content from authentic media.

The stricter rules would increase accountability of significant social media intermediaries (those with 50 lakh or more registered users) in verifying and flagging synthetic information through reasonable and appropriate technical

Jammu court to hear tomorrow Mithun Manhas, others in complaint case

Srinagar, Oct 22: The Judicial Magistrate 1st Class (Sub Judge), Jammu, has issued summons to BCCI president Mithun Manhas and several other officials and media personnel to appear in court in connection with a complaint filed by retired Dy SP Sudershan Mehta.

The complaint, as per the court order has been filed under Sections 356, 45, and 61 of the BNS Act against Manhas, members of the Jammu and Kashmir Cricket Association (JKCA), and some media editors.

The court notice, as per the news agency Kashmir News Observer (KNO), issued on October 18, directs the 'accused' to appear in person or through legal representatives on November 24, 2025.

The list of accused includes Mithun Manhas, Anil Gupta (Retd Brig, Member Administration, JKCA), Majid Dar (Assistant Member, JKCA), and editors from The The Kashmir Horizon, Brighter Kashmir, and The Indian News Service.

As per the court order, no cognizance can be taken without hearing the proposed accused and instructs that copies of the complaint and annexures be sent via registered post.

The case will be taken up for hearing on November 24, 2025. (KNO)

ICJ: Israel must allow UN relief agency to supply Gaza aid

The Hague (Netherlands), Oct 22: The International Court of Justice said on Wednesday that Israel must allow the UN aid agency in Gaza, known as UNRWA, to provide humanitarian assistance to the Palestinian territory.

The Hague-based court was asked last year by the UN General Assembly to determine Israel's legal obligations after the country effectively banned the agency, the main provider of aid to Gaza, from operating there. Israel "is under the obliga-

tion to agree to and facilitate relief schemes provided by the United Nations and its entities, including UNRWA," ICJ President Yuji Iwasawa said.

The advisory opinion from the World Court comes as a fragile US-brokered Gaza ceasefire agreement, which took effect on Oct. 10, continues to hold.

Israel has denied it has violated international law, saying the court's proceedings are biased, and didn't attend hearings in April. However, Israel provided a 38page written submission for the court to consider. UNRWA ban

The UN aid agency in Gaza has been effectively banned from the territory since January. UNRWA has faced criticism from Israeli Prime Minister Benjamin Netanyahu

and his far-right allies, who say

the group is deeply infiltrated

UNRWA rejects that claim, and the ICJ found that Israel hadn't "substantiated the allegations," Iwasawa said. The court also held that the

population of the Gaza Strip had been "inadequately supplied," and that Israel was required to ensure "the basic needs of the local population" are met. During the hearings in April,

Palestinian Ambassador to the Netherlands Ammar Hijazi told the court that Israel was "starving, killing and displacing Palestinians while also targeting and blocking humanitarian organizations trying to save their lives.' In its written submission,

Israel argued that the court should reject the request from the UN General Assembly, because it was too similar to other advisory opinions and the judges lacked the fact-finding abilities to make a determination. Advisory opinion

In an advisory opinion last year, the court said that Israel's

presence in the occupied Palestinian territories is unlawful and called on it to end, and for settlement construction to stop immediately. That ruling fueled moves for unilateral recognition of a Palestinian state.

Israel condemned the decision, saying it failed to address the country's security concerns.

Two decades ago, the court ruled that Israel's West Bank separation barrier was "contrary to international law." Israel boycotted those proceedings, saying they were politically motivated.

Advisory opinions carry significant legal weight, but are described as "nonbinding" as there are no direct penalties attached to ignoring them.

Wednesday opinion is separate from the ongoing proceedings initiated by South Africa, accusing Israel of committing genocide in Gaza. Israel rejects South Africa's claim and accuses it of providing political cover for Hamas.

Arrest warrant for Netanyahu Last year, another Haguebased tribunal, the International Criminal Court, issued arrest warrants for Netanyahu and his former defense minister, Yoav Gallant, alleging that the pair have used "starvation as a method of warfare" by restricting humanitarian aid and have intentionally targeted civilians charges that Israeli officials strongly deny.

The advisory opinion from the ICI noted that Israel "is not to use starvation of the civilian population as a method of warfare.'

The war in Gaza was triggered by Hamas' surprise attack on southern Israel on Oct. 7, 2023, which left 1,200 people, mostly civilians, dead and 250 taken hostage. Israel's retaliatory offensive in the Palestinian territory has killed more than 68,000 people, according to Gaza's Health Ministry.

However, many of these bills are unlikely to be introduced in the House.

Meanwhile, the Business Advisory Committee of the Assembly met today in the Speaker's office to discuss the allocation of time for legislative business during the session.

ies from modifying, suppressing, or removing such labels or identifiers. "In Parliament as well as many forums, there

have been demands that something be done

about deepfakes, which are harming society... people using some prominent person's image, which then affects their personal lives, and privacy...Steps we have taken aim to ensure that users get to know whether something is synthetic or real. It is important that users know what they are seeing," IT Minister Ashwini Vaishnaw said, adding that mandatory labelling and visibility will enable clear distinctions between synthetic and authentic content.

Once rules are finalised, any compliance failure could mean loss of the safe harbour clause enjoyed by large platforms.

With the increasing availability of generative AI tools and the resulting proliferation of synthetically generated information (deepfakes), the potential for misuse of such technologies to cause user harm, spread misinformation, manipulate elections, or impersonate individuals has grown significantly, the IT Ministry said.

Accordingly, the IT Ministry has prepared draft amendments to the IT Rules, 2021, with an aim to strengthen due diligence obligations for intermediaries, particularly significant social media intermediaries (SSMIs), as well as for platforms that enable the creation or modification of synthetically-generated content.

The draft introduces a new clause defining synthetically generated content as information that is artificially or algorithmically created, generated, modified or altered using a computer resource in a manner that appears reasonably authentic or true.

Å note by the IT Ministry said that globally, and in India, policymakers are increasingly concerned about fabricated or synthetic images, videos, and audio clips (deepfakes) that are indistinguishable from real content, and are being blatantly used to produce

non-consensual intimate or obscene imagery mislead the public with fabricated political or news content, commit fraud or impersonation for financial gain.

The latest move assumes significance as India is among the top markets for global social media platforms, such as Facebook, WhatsApp and others.

A senior Meta official said last year that India has become the largest market for Meta AI usage. In August this year, OpenAI CEO Sam Altman had said that India, which is currently the second-largest market for the company, could soon become its largest globally.

Asked if the changed rules would also apply to content generated on OpenAI's Sora or Gemini, sources said in many cases, videos are generated but not circulated, but the obligation is triggered when a video is posted for dissemination. The onus in such a case would be on intermediaries who are displaying the media to the public and users who are hosting media on

the platforms. Over the treatment of AI content on messaging platforms like WhatsApp, sources said that once it is brought to their notice, they will have

to take steps to prevent its virality. India has witnessed an alarming rise in AIgenerated deepfakes, prompting court interventions. Most recent viral cases include misleading ads depicting Sadhguru's fake arrest, which the Delhi High Court ordered US digital giant Google to remove.

Earlier this month, Aishwarya Rai Bachchan and Abhishek Bachchan sued YouTube and Google in a lawsuit that seeks Rs 4 crore in damages over alleged AI deepfake videos.

Gehlot meets Lalu amidst seat-sharing row, says 'all issues will be ironed out'

Patna, Oct 22: Senior Congress leader Ashok Gehlot on Wednesday met RJD president Lalu Prasad, apparently with the mandate to defuse tensions with the ally, which has plunged the INDIA bloc into turmoil in poll-bound Bihar.

Emerging after the meeting, Gehlot said winning Bihar was "extremely important" for the opposition alliance, after having been drubbed in a crucial state like Maharashtra, but evaded a direct reply when asked whether the Congress was ready to declare the RJD supremo's son and heir apparent Tejashwi Yadav as the chief ministerial candidate.

"Why do you want me to make such an announcement?" snapped the former Rajasthan CM when journalists asked him about the Congress' stand on



Yadav, who had recently urged the people to make Rahul Gandhi "the next prime minister".

Gehlot said, "You have seen the chemistry between Rahul and Tejashwi during the Voter Adhikar Yatra two months ago when the two leaders travelled across the state. They will take an appropriate decision at an appropriate time". Speculation

is rife that the Congress' reluctance to back Yadav, who has been campaigning for a "Tejashwi sarkar", has irked its larger regional ally. Of the 243 seats in the assembly, the RJD and Congress are contesting 143 and 61, respectively, but both parties are headed for a "friendly fight" in at least five constituencies.

Congress candidates are also

up against the CPI, another alliance partner, in three other seats. However, Gehlot, who had upon arrival in the city told reporters at the airport "a friendly fight in five or ten seats was no big deal", said after meeting Prasad, "we hope things will be ironed out by the last date for withdrawal of nomination papers tomorrow".

However, five of these seats fall in the first phase, for which the deadline for withdrawal ended on Monday. Gehlot, who was accompanied by Krishna Allavaru, the AICC Bihar in-charge, who is being blamed by a section of party leaders in the state for messing things up, insisted that the Congress was serious about the assembly polls in a state where it has ceased to be a major player.

"It is extremely important for us to win the polls. More so after the alliance of which Congress was a part lost Maharashtra. The Bihar polls will set the tone for national politics. It is essential that the NDA, which has caused divisions in society and messed up the economy, gets a setback. The people of Bihar are wise enough to realise this," Gehlot said. When it was pointed out that the Mahagathbandhan, the name by which Congress, RJD and Left combine have been known since before the INDIA bloc came into existence, was yet to hold a joint press conference in the poll-bound state, Gehlot and Allavaru said in unison, "It will take place tomorrow".

Gehlot alleged that "the turmoil in the NDA is, in fact, greater than it is in our camp. But the media does not highlight that because of bias in favour of the ruling coalition".

Prez Murmu's helicopter wheels sink into newly concreted landing pad

The landing was originally planned at Nilackal near Pamba, but it was changed to Pramadam due to inclement weather. "The concrete had not set completely and therefore, it could not handle the helicopter's weight when it landed and depressions were formed where the wheels touched the

ground," the officer said. Patna, Oct 22: At least eight assembly seats in Bihar, where constituents of the INDIA bloc will fight against each other due to internal discord among the Congress, the RJD and the Left parties over seat-sharing arrangements. The assembly segments, where the opposition alliance partners will contest together, are Narkatiaganj, Vaishali, Rajapakar, Rosera, Bachhwara, Kahalgaon, Biharsharif and Sikandara, RJD and Congress leaders said.

The Congress is contesting 61 seats, nine less than the number of constituencies in which the party had fought five years ago, while the RJD has nominated 143 candidates. The CPI is contesting nine constituencies.

in four seats. The CPI(ML) Liberation, which had the best strike rate in the 'Mahagathbandhan' in 2020, when it contested 19 seats and won 12, has fielded

candidates in 20 assembly seg-

ments this time. Congress' Shaswat Kedar Pandey is contesting against RJD's Deepak Yadav in Narkatiaganj seat, while the fight is between Sanjeev Singh of the

Congress and Ajay Kumar Kushwaha of RJD in Vaishali.

Congress nominee Pratima Kumri is pitted against Mohit Paswan of CPI in Rajapakar, while Congress candidate Shiv Prakash Garib Das is contesting against Abdesh Kumar Rai of CPI in Bachhwara seat.

The fight is between Omair Khan of Congress and Shiv Kumar Yadav of CPI in Biharsharif seat. The 243-member Bihar assembly will go to polls in two phases on November 6 and 11, with results set to be announced on November 14.

Commenting on the situation, RJD state unit spokesperson Mrityunjay Tiwary told PTI, "I am again saying that alliance partners of the INDIA bloc must understand our compulsions. The RJD is the party

which contests only in Bihar and neighbouring states...we don't demand seats in southern or other states from our partners. As we are the biggest party, we deserve to contest the maximum number of seats in Bihar." He appealed to other constituents of the INDIA bloc to withdraw their candidates from the seats where the RJD has already fielded its nominees.

Reacting to it, Bihar Congress spokesperson Asit Tiwary told PTI, "We have always followed coalition 'dharma'...I must say that the RJD and the Left party fielded their candidates after the Congress had already announced the list of its nominees. We are quite hopeful that things will be sorted out in a day or two".

SC seeks Centre's assistance on PIL seeking nationwide ban on online gambling



New Delhi, Oct 22: The Supreme Court has sought the Centre's assistance on a plea seeking directions to prohibit online gambling and betting platforms that allegedly operate under the guise of social and e-sports

A Bench of justices J.B. Pardiwala and K.V. Viswanathan asked the counsel appearing for the petitioner to serve a copy of the PIL to the counsel for the central government.

"We request V.C. Bharathi to look into the petition and assist us on the next date of hearing. List after two weeks," the Bench said

in an order passed on Friday. The Supreme Court was hearing a plea filed by think tank Centre for Accountability and Systemic Change (CASC) seeking directions to the Centre to prohibit online gambling and betting platforms that allegedly operate under the guise of social and e-sports games.

The plea has also sought directions to the RBI, NPCI, and UPI platforms to disallow any monetary transactions involving unregistered gaming applications.

It has sought tax recovery and investigation through Interpol, CBI, and ED against offshore gaming companies, which are estimated to owe over 2 lakh crore in unpaid taxes.

The plea has sought a direction to Union ministries of Electronics and Information Technology, Information and Broadcasting, Finance and Youth Affairs and Sports to do a harmonious interpretation of provisions of the Promotion and Regulation of Online Gaming Act, 2025, and laws made by state legislatures to prohibit online gambling and betting games operating in the guise of social and e-sports games. The Act lays down a comprehensive framework to promote safe digital recreation while prohibiting harmful practices linked to

online money games.

The petition names six respondents, including four Union ministries and the two leading app store operators, Apple Inc. and Google India Pvt. Ltd.

The CASC has urged the Supreme Court to direct down on the proliferation of betting and gambling applications, which they claim are inflicting widespread social and economic harm across the country.

"Betting and gambling are regarded as unlawful activities in the majority of the states in India. Several cases are contested in high courts wherein affidavits were filed by the government and gaming platforms. Upon analysing the same, it is reported that more than 65 crore persons are playing such games, creating an annual business of more than Rs 1.8 lakh crores for these platforms in India," the PIL claimed.

"Around half of the Indian population is involved in playing online games, which are adversely impacting society, economy and national security. The devastating impact of online betting and gambling are endorsed in the objectives of the newly passed Promotion and Regulation of Online Gaming Act, 2025. As per the IT Minister's speech in Parliament, the Bill was introduced to ensure the welfare of society and to prevent the serious evil that is creeping into society," the PIL said. The plea said this unchecked expansion of online gaming has created what they describe as a national crisis, affecting half of India's population and leading to financial ruin, mental health issues and even suicides. The plea has sought a nationwide prohibition on online gambling and betting platforms operating as esports or social games.

In one of the prayers, it has sought blocking orders under Section 69A of the IT Act against all unlawful betting sites and apps.

Warm water with lemon: gen-

tle start for the arteries A glass of warm water with lemon is one of the simplest ways to begin the day. The vitamin C in lemon acts as a natural antioxidant, helping reduce oxidative stress — one of the hidden triggers behind high blood pressure. According to a study published in NIH,, regular intake of vitamin C-rich foods can slightly lower systolic blood pressure. The drink also helps maintain hydration, which is essential for blood vessel elasticity. However, it's important to ensure that the lemon water isn't too sour, as excess acidity might cause discomfort for those with sensitive stomachs.

Beetroot juice: nature's blood pressure regulator

Beetroot juice has earned its place as one of the most studied drinks for hypertension. Rich in dietary nitrates, it helps the body produce nitric oxide – a compound that relaxes blood vessels and promotes smooth blood flow. Freshly made beetroot juice (without added salt or sugar) can be a strong morning ally for those

of hypertension.



Coconut water: hydration with heart benefits

Tender coconut water is not just refreshing — it's loaded with potassium, a mineral that helps balance sodium levels in the body. Excess sodium is one of the key culprits behind high blood pressure. Drinking plain coconut water in moderation can help maintain electrolyte balance and support heart rhythm. However, packaged versions often contain added sugar or sodium - something that should be checked carefully before consumption.

Green tea: mild caffeine, major

antioxidants Green tea offers a light caffeine boost with a heavy dose of catechins – plant compounds linked to improved blood vessel function. A meta-analysis published in The American Journal of Clinical Nutrition (2014) suggested that long-term green tea intake could modestly reduce blood pressure. Unlike black coffee, which may temporarily raise blood pressure due to its caffeine content, green tea's effect is milder and more balanced. For best results, it's advisable to brew it lightly

instead of making it too strong. Amla water or juice: Indian

superfruit for heart health Amla (Indian gooseberry) is a traditional gem with strong scientific backing. It contains high levels of vitamin C, polyphenols, and flavonoids that protect the heart and blood vessels from oxidative damage. Having a small glass of amla water or diluted amla juice in the morning can support cardiovascular health naturally — but it should not be mixed with salt or sugar, as both can affect blood pressure control.

Drinks to avoid: hidden triggers in the morning cup

While some drinks help lower pressure, others can do the opposite. Strong coffee or energy drinks can cause temporary spikes in blood pressure due to caffeine overload. Packaged fruit juices, often marketed as "healthy," can contain high sugar levels, which may lead to insulin resistance and increased blood pressure over time. Salted buttermilk, though refreshing, is not advisable for those monitoring hypertension. Even herbal concoctions with liquorice root should be approached with caution, as glycyrrhizin (a compound in liquorice) can raise blood pressure significantly.

Every sip in the morning has a purpose. When chosen wisely, a simple drink can quietly strengthen the heart, calm the arteries, and bring stability to blood pressure. It's less about complex detoxes and more about mindful hydration - respecting what the body needs after a night's rest.

Trump hosts Diwali celebration at White House, says US-India ties 'very good'

Washington, Oct 22: US President Donald Trump has lauded Prime Minister Narendra Modi and the people of India during a Diwali celebration at the White House, saying the two nations share a "very good relationship" and that the Indian leader wants to see the end of the war between Russia and Ukraine.

Trump also reiterated his claim that India will not be buying "too much" oil from Russia. The event held on Tuesday saw Trump hosting Indian-American business leaders and community figures in the Oval Office, lighting a traditional oil lamp, and extending warm greetings to the people of India and Indian-Americans.

"I just spoke to your prime minister today. We had a great conversation. We talked about trade. We talked about a lot of things, but mostly the world of trade. He's very interested in that," he said, addressing the Indian-American community members gathered for the festivities.

Describing Modi as "a great person", Trump said he has become "a great friend of mine over the years". The president said he had also discussed India-Pakistan relations with the prime minister. "We did talk a little while ago about let's have no wars with Pakistan. The fact that trade was involved, I was able to talk about that. And we have no war with Pakistan and India. That was a very, very good thing,"



he said. Trump has been repeating his claim dozens of times that he "helped settle" the recent military conflict between India and Pakistan. India has consistently maintained that the understanding on cessation of hostilities with Pakistan in May was reached following direct talks between the Directors General of Military Operations (DGMOs) of the two militaries. Later, during a media interaction, Trump reiterated his claim that India will not be buying 'too much" oil from Russia.

The US and India are working together on "some great deals", he said in response to a question.

"I love the people of India... I spoke to Prime Minister Modi today, as I mentioned before, and we just have a very good relationship... He is not going to buy much oil from Russia.

He wants to see the war end as much as I do. He wants to see the war end between Russia and Ukraine," Trump said. "And as you know, they're not going to be buying too much oil, so they've cut it way back, and they're continuing to cut it way back," he claimed. The US has been maintaining that India is helping Putin to finance the war through its purchase of Russian crude oil. The relations between New Delhi and Washington have been reeling under severe stress after Trump doubled tariffs on Indian goods to a whopping 50 per cent, including a 25 per cent additional duty for India's purchase of Russian crude

Trump last week said that India is going to pay "massive tariffs" if it continues

Earlier in his Diwali message, Trump reflected on the festival's symbolism.

"In a few moments, we'll light the diya as a symbol of faith in the victory of light over darkness, knowledge over ignorance, and good over evil. During Diwali, revellers recall ancient stories of enemies defeated, obstacles removed, and captives freed.

The glow of the diva flame reminds us to seek the path of wisdom and to work with diligence and to always give thanks for our many blessings," he said.

FBI director Kash Patel, who was also present at the event, said he is a first-generation Indian-American whose parents "lawfully immigrated" to the US.

"And under your leadership, so many more millions of Americans are living that dream," Patel said, addressing the US president. Meanwhile, Indian Ambassador to the US Vinay Mohan Kwatra in a social media post said he was "deeply honoured" to join Trump at the White House to celebrate Diwali.

"Wished him on behalf of Prime Minister @narendramodi a Happy Diwali and thanked him for this beautiful gesture. Warm Diwali greetings to all celebrating. especially the vibrant 5 million-strong Indian diaspora in the US," he said.

Recognising the contribution of Shankhadhar Sakhwa to the country and people, the government declared him a national luminary in November 1999.

Asia Cup trophy fiasco

BCCI, PCB headed for showdown in next month's ICC meet

Karachi, Oct 22: The BCCI and Pakistan Cricket Board are headed for a showdown at next month's ICC meeting as PCB chairman Mohsin Naqvi is not budging from his stance of personally handing over the Asia Cup trophy to India in his capacity as head of the Asian Cricket Council (ACC).

In the reply sent to the BCCI and other ACC

member nations, Naqvi has insisted that he is willing to organise a ceremony on November 10 in Dubai, where a representative of the BCCI and any available Indian team player can take the trophy from him.

The ACC trophy rightly belongs to the Indian cricket team and is being held in trust till such time that a BCCI office holder along with any available participating player can collect the same from the ACC President," Nagvi wrote in his reply.

Such collection would of course be accompanied with much fanfare and coverage as there should be no deviation from established practices and no precedent should be set which undermines the spirit of the game we all love."

The ICC is headed by former BCCI secretary

Jay Shah. Naqvi's reply came after the BCCI's fresh missive to the ACC on the Asia Cup trophy fiasco, which was backed by boards of Afghanistan and Sri Lanka.

The response clearly indicates the level of mistrust and tensions between the BCCI

"...as regards the remainder of your letter, slanderous as it may be and digressing lighted, the office of the ACC President will not indulge in petty politics that is aimed to



pacify select extremist groups," the reply

"The true state of affairs is that there was never any official communication shared with ACC office or the Tournament Director highlighting any position or concern of the BCCI with respect to prize distribution

"It was only when the Ceremony was about to take place and distinguished guests had taken their place on the stage that the BCCI's representative conveyed that the Indian Cricket Team would not be receiving the Asla Cup Trophy and awards. Efforts were made to find a solution to the impasse which resulted in an inordinate delay."

The ACC president waited along with the distinguished guests for approximately 40 minutes to ensure that the integrity of the presentation ceremony was preserved and was not adversely affected by politics, but in vain," the reply added.

A reliable source in the PCB said that the legal department of the board had already been instructed to prepare a dossier in case the BCCI officials move to have Naqvi censured at the ICC board meeting, an indication of which has already been given by the BCCI if the trophy fiasco is not resolved at the
