
Omar: No politics or regional bias in flood relief distribution

21,573 structures damaged in Jammu, 980 in Kashmir

152 lives lost, over Rs 5,400 lakh paid as compensation so far: Govt

Srinagar, Oct 27: The Jammu and Kashmir Government on Monday revealed that recent floods, cloudbursts, and heavy rains caused widespread destruction across the Union Territory, resulting in loss of lives and extensive damage to both public and private property.

Responding to a question by MLA Nizamuddin Bhat, the Minister for Disaster Management, as per the news agency-Kashmir News Observer (KNO), said that a total of 21,573 structures were damaged in Jammu division, while 980 structures were affected in Kashmir division during the recent weatherrelated disasters.

The government said that 152 people, including 151 in Jammu and one in Kashmir, lost their lives due to rainrelated incidents, flash floods, and cloudbursts that affected several districts, especially in hilly and remote areas. Livestock and standing crops also suffered | More on P6

CIK foils online radicalisation plot, saves two boys from falling into terror trap

Srinagar, Oct 27: The Counter Intelligence Kashmir (CIK) has foiled online radicalisation plot and has prevented two teenage boys from falling into the terror trap.

In a statement issued to the news agency-Kashmir News Observer (KNO), a CIK spokesman said, "Counter Intelligence Kashmir (CIK) has once again demonstrated its exceptional professional competence, cyber intelligence skills, and social outreach capabilities by dismantling a digital radicalization network operating through multiple social media platforms."

"The timely operation not

only neutralized the propaganda machinery of a terrorist outfit but also safeguarded two impressionable young boys from being recruited into terrorism," he added.

"Acting on precise intelligence inputs and sustained cyber surveillance, CIK identified two radical social media handles 'faithful_warrior57' and 'Gurkboru.08' engaged in glorifying terrorism and circulating extremist narratives. These accounts were actively sharing propaganda material, including audio clips and digital content of known terrorists, designed to sow discord, promote secessionist sentiment, and attract vulnerable youth toward violent extremism," the

spokesman said.

The spokesman said that following detailed technical analysis, the operators of these accounts were identified as: Hashim Mashood Lone S/O Mashood Ahmad Lone R/O Khawjabagh, Maloora, aged about 17 years and Mohammad Hazik Ahanger S/O Farooq Ahmad Ahanger R/O Railway Colony, Nowgam, aged about 15 years.

Govt allocates Rs 505 Cr funds during 2025-26 FY: Dy CM



49 existing, 12 new WSSs functional in Lolab AC: Rana

SRINAGAR, OCTOBER 27: Minister for Jal Shakti, Javed Ahmed Rana Monday informed the Legislative Assembly that a total of 49 existing and 12 new water supply schemes are operational in the Lolab Constituency to provide drinking water to the population.

He was responding to the Calling Attention Motion moved by MLA Lolab Qayser Jamshaid Lone, regarding shortage of potable drinking water in Lolab Constituency.

Responding to the motion, the Minister said that there is no acute shortage of potable water in the Lolab constituency.

He informed the house that 49 existing water supply schemes are operational in the Lolab Constituency catering to the needs of 50 villages. He said that additionally 22 new schemes have been taken up under Jal Jeevan Mission and CAPEX to ensure that each and every rural household in Lolab Constituency has a Functional Household Tap Connection (FHTC) within its premises, capable of supplying drinking water in adequate quantity.

He said that out of 22 schemes, 12 are functional and 10 are at various stages of execution. These schemes continue to provide drinking water to the population and are maintained regularly to ensure functionality, he added.

The Minister said that the areas, viz; Lalpora, Khanbutho, Darmohalla, Potshai, Tikkipora, Sogam, Ganaie Mohalla and Lassipora



where schemes are not commissioned yet, also get drinking water

"In such areas, where the water supply schemes are yet to be completed and which face issues especially during dry spell, due to low service level or some uncovered pockets, as an interim arrangement, water is supplied by deployment of requisite number of water tankers," he added. The Minister informed the house that new schemes for these areas under various programmes are at different stages of execution, and once completed, sustainable access to clean drinking water as per the prescribed quality and quantity standards shall be ensured to these areas as well.

Rs 12.28 lakh disbursed as compensation to farmers: Javid Dar

9 lakh apple boxes transported through rail till 23rd October

SRINAGAR, OCTOBER 27: Minister for Agriculture Production, Rural Development and Panchayati Raj, Javid Ahmad Dar Monday informed the Legislative Assembly that

12.28 lakh has been disbursed to the affected farmers as compensation for the losses caused by natural weather vagaries that struck various parts of Jammu and Kashmir during September 2025.

He stated that the total compensation amount calculated for igible losses under the State Disaster Response Fund (SDRF) and National Disaster Response Fund (NDRF) norms stands at 152.37 lakh, out of which 12.28 lakh has already been disbursed.

Minister was responding to the Calling attention motion moved by MLA Hilal Akbar Lone regarding the steps taken by the government for providing compensation to the affected farmers, due to the recent blockade of national highway.

He also informed that despite the temporary disruption of road connectivity along National Highway-44 due to heavy rains and landslides, the government ensured transportation of apple produce from the Kashmir Valley to major markets outside the Union Territory.

"During the road-blocked period, 1,25,376 apple boxes worth 10.03 crore were dispatched by train from Budgam and Anantnag to Jammu and Adarsh Nagar, Delhi. Up to 23rd October 2025, approximately 14,000 metric tonnes (9 lakh boxes) have been transported from various Fruit and Vegetable markets of the Kashmir Valley to destinations outside Jammu and Kashmir Union Territory through rail services," the Minister said.

Regarding the damage caused to farmers by the recent floods and landslides, the minister said that



a comprehensive assessment was carried out by the department that revealed that the floods affected 431.091 hectares of crop area, with losses exceeding 33 percent across Jammu and Kashmir.

He further assured that the government remains committed to supporting the farming community and that all necessary measures are being taken in this regard.

He said that the J&K Government is set to implement a Re-structured Weather Based Crop Insurance Scheme (RWBCIS). Under RWBCIS, Apple, Saffron, Mango, and Litchi crops have been notified to provide cover. The tendering process for selection of insurance company (out of the empanelled insurance companies notified by the GoI) to provide insurance cover to these horticulture crops is in process, he said.

Minister said that Kashmir, predominantly an agrarian economy, is the leading apple-producing region in India, contributing significantly to the national apple output. He said that the current apple production for the 2025 season is estimated at approximately 22.15 Lakh Metric

Minister informed that out of the 22.15 Lakh MT production, it is the

normal trend that around 14.0 Lakh MT is exported to markets outside I&K, while the balance is consumed locally, stored in CA facilities, or lost due to natural perishability and han-

"At the time of the road blockage, only 22,000 MT (about 1%) remained stranded on NH-44 during the period under reference, whereas a larger part of the produce would continue to move out in phases as per the seasonal pattern," he said.

Regarding the alternative measures taken for movement of horticulture produce during the period National Highway remained closed, he said that six-tyre trucks were permitted to use the Mughal Road.

Javid Dar further informed that the Department of Horticulture P&M established a control room at Qazigund for monitoring and coordination of truck movement.

He said that farmers and traders were encouraged to use railway parcel vans, defer harvesting until NH-44 restoration and CA stores were recommended for short-term preservation.

Regarding the disruption in the movement of fruits due to highway blockade, minister said the region's horticultural produce movement was affected due to prolonged closure of National Highway 44 (NH-44), due to natural vagaries resulting in washing of carriageway of the national highway and landslides, which is the primary route for transporting fresh fruits and vegetables to national markets. Heavy rainfall and landslides during August and early September (26th & 27th August and 2nd & 3rd September 2025) led to extensive damage along NH-44, including washing of a road stretch and landslides at various locations, disrupting the supply chain and stranding significant quantities of apple produce.

placed in the tentative seniority lists below those who were lower in the merit to them. creating an anomalous situation which may lead to avoidable litigation. In view of that, it was unanimously decided that the concerned DYSSOs shall submit the service particulars of those PETs whose appointment orders were delayed due to different administrative reasons for grant of notional effect of Date of Appointment; and

Chris Gayle steals show

Stadium transformed into dance floor

Srinagar, Oct 27: The "Universe Boss", Chris Gayle brought Bakhshi Stadium alive on Monday evening as he stepped onto Kashmir's soil to bat for the the ongoing Indian Heaven Premier League (IHPL).

What began as a low-attendance afternoon, soon turned into a festive evening as the crowd swelled and music filled the stands, with Gayle's

Though the turnout was initially modest, with only a few hundred spectators occupying the stands, the atmosphere shifted dramatically when Gayle walked out to bat.

Within minutes, the crowd grew to an estimated 2,000–4,000 as fans poured in, waving sweaters, dancing and shouting his name. With the



music turning crazy, several were seen standing on seats and railings, phones raised high to capture the

Eyewitnesses told KNO the league officials later decided to open the stadium gates to the public, allowing free entry in a bid to fill the stands and ensure the cricketers received

the reception he deserved, while the majority of stands remained empty a patch of stands got filled.

The moment Chris Gayle stepped on the field, the ground erupted,' said a local fan from Srinagar's old city. "We have only watched him on TV, but seeing him live in Kashmir feels unbelievable." As Gayle took

guard, chants of "Gayle! Gayle!" echoed through the air. Every short strike drew thunderous applause and when he hit a six, the "Universe Boss" spread his arms wide, acknowledging the cheering crowd, turning the IHPL into a full-blown

Meanwhile, on yesterday the Secretary, J&K Sports Council, Nuzhat Gul, who was present at the stadium, said Gayle's participation represents a major milestone for sports in Jammu and Kashmir.

"Chris Gayle playing for Pulwama Titans is a proud moment for all of us. It reflects how far sports in J&K has come, from struggling for participation a few years ago to attracting global icons today," Gul told KNO. She said leagues like IHPL are transforming into "community-owned movements" that engage youth pos-itively and promote a healthy sports culture across districts.

"The inclusion of international stars like Gayle is not just about cricket, but it is about confidence, aspiration and showing the world the new face of J&K through sports,"

As the league process, with few matches held, the media present at the stadium expressed concern over poor arrangements. While the spectators cheered, media professionals covering the event expressed frustration over inadequate facilities.

Several journalists told KNO that the management seemed disorganized and failed to provide even basic

"We don't even have a power point or a water bottle. There is no press enclosure or seating arrangement. We are sitting on the marble floor," said a journalist, requesting

He said the lack of coordination made it difficult to report smoothly, with no designated areas for cameras or interviews and even basic facilities for refreshment seemed out of reach for this league.

Notably, despite the glitches, the evening turned into a carnival once Gayle took charge with the bat. Fans were seen dancing to the background music, waving sweaters in the cold autumn breeze and chanting his name in unison.

Children climbed railings to catch a glimpse of the cricket icon, while security personnel struggled to contain the wave of excitement sweeping through the stands.

"It was a moment to remember," said one of the spectators. "Gayle brought warmth to Srinagar's cold evening," he said.

It is important to mention, the match was played between Pulwama Titans and Patnitop Warriors, as part of the ongoing Indian Heaven Premier League (IHPL). Notably, the high-energy encounter saw Patnitop Warriors post a total of 173 for 7 in their allotted 20 overs. Chasing the target, Pulwama Titans were anchored by the West Indies batting legend Chris Gayle, who turned back the clock with his game, including seven boundaries and one six—(KNO)

Over 19,500 Ha forest land encroached

Srinagar, Oct 27: The Jammu and Kashmir Government on Monday revealed that over 19,501 hectares of forest land are under illegal occupation across the Union Territory as of September 30, 2025.

The Minister in charge of the Forest, Ecology, and Environment Department, Javed Rana, informed that a total of 27,712 cases of encroachment have been identified in the Kashmir region alone, covering 5,891.49 hectares of forest land.

The data shared by the government in response to MLA Dr Narinder Singh Raina's query, shows that the highest number of encroachments were reported from the South Circle, including divisions such as Anantnag, Lidder, Shopian, Kulgam, and Awantipora, with 14,902 cases involving 3,268.05 hectares.

Among these divisions, Anantnag tops the list with 7,060 cases covering 1,535.035 hectares, followed by Shopian with 3,872 cases over 1.011.29 hectares, Lidder with 2.336. cases over 314.13 hectares, Kulgam with 1,096 cases across 279.19 hectares, and Awantipora with 560 cases involving 132.10 hectares.

The North Circle reported 6,492 cases covering 1,452.530 hectares. Specifically, Kehmil recorded 1,785 cases over 445.00 hectares, Kamraj



1,268 cases over 261.42 hectares, Langate 2,042 cases over 434.70 hectares, and JV Division 1,397 cases covering 311.41 hectares. In the Srinagar Circle, 6,318 encroachment cases were reported on 1,170.9134 hectares. Pir Panjal recorded 2,959 cases over 623.0939 hectares, Sindh 2,065 cases covering 377.8145 hectares, Bandipora 943 cases over 135,2125 hectares, and Tangmarg 351 cases over 34.7925 hectares. The Urban Division reported no encroachments.

Eviction drives conducted so far have reclaimed about 44.82 hectares of land from 230 cases across several divisions. The government said that multiple measures have been initiated to recover the encroached land, including detailed boundary surveys, issuance of eviction notices under Section 79(A) of the Indian Forest Act, 1927, and regular eviction operations. Once recovered, the land is fenced, restored with indigenous species, and returned to its forest status to prevent re-encroachment.

The department has also intensified vigilance through joint operations by the Forest Protection Force and local territorial staff, the minister said. He added that modern technologies such as GPS and drone-based monitoring are being employed for better protection and mapping of forest land—(KNO)

Govt proposes ambulances for Zakura, Khimber

Srinagar, Oct 27: The Jammu and Kashmir government has projected the demand for ambulances at NTPHC Zakura and NTPHC Khimber under the Pradhan Mantri Jan Vikas Karyakram (PMIVK) Yojana to improve emergency medical transport facilities in these areas, the Health and Medical Education Department has said. In a written reply to MLA Salman Sagar, the department said that while ambulances are presently not available at the two health centres, one ambulance each has been proposed under PMJVK to strengthen emergency response and referral services.

"In the interim, two ambulances from PHC Zadibal are being deployed as and when required to cater to the needs of NTPHC Zakura and NTPHC Khimber, ensuring no centre remains unattended during medical emergencies," the reply reads.

It added that one ambulance is already stationed at NTPHC Fagir Gujri to serve adjoining (108) has been stationed at Darbagh Harwan to cover the entire Block Hazratbal and Zone Harwan, including Harwan New Theed, Faqir Gujri

The department said the arrangement ensures timely and efficient medical evacuation and patient transport during critical health emergencies—(KNO)

Govt preparing G+4 building, revised DPR for CD hospital

Srinagar, Oct 27: The revised Detailed Project Report (DPR) for the construction of a G+4 building for the Chest Disease Hospital in Srinagar is currently being prepared, the Jammu and Kashmir government said on Monday. Once finalised, the next course of action will be initiated, it added.

Responding to a question by MLA Sheikh Mohammad Ahsan, the Minister for Health and Medical Education. Sakeena Itoo said the existing Government Chest Diseases Hospital operates in an old heritage building. However, the department prioritises maintaining the required standards of medical treatment and ensures necessary infrastructure is in place within available budget provisions under various schemes, she said.

The minister said that a DPR for the new G+4 building for the Chest Diseases Hospital, prepared by the Public Works (R&B) Department at a cost of Rs 1993.53 lakhs, has been received for administrative approval. However, upon review, the

DPR was found incomplete in some aspects, and claricy medical transport, the fications have been sought, she said, adding that the revised DPR is awaited, and further action will be taken once it is received.

Regarding the establishment of new medical blocks, Itoo said that proposals for Krailgund and Qalamabad in Langate Constituency are under examination, considering norms, resource availability, and infrastructural feasibility. While public demand is

important, the creation of new health facilities requires a thorough assessment of demographic needs, existing coverage, administrative viability, and budgetary provisions, the Health Minister said. She said that no final decision has been made yet, but the matter remains under active consideration, with future steps to be guided by technical evaluations, interdepartmental consulta-

tions, and approvals. Responding to a question by MLA Salman Sagar, Itoo informed that ambulance services are currently not available at NTPHC Zakoora

and NTPHC Khimber. Recognising cy medical transport, the minister said the government has already projected the need for one ambulance each for these centres under the Pradhan Mantri Jan Vikas Karyakram (PMJVK). Once approved, this will enhance emergency response and patient referral services, she said.

Meanwhile, two ambulances allocated to PHC Zadibal are being temporarily deployed to NTPHC Zakoora and NTPHC Khimber as needed, ensuring patients are transported during emergencies, the government said.

One ambulance is stationed at NTPHC Faqir Gujri to serve the nearby areas, providing timely medical evacuation, the minister said.

"A Critical Care Ambulance (108) is also stationed at Darbagh Harwan under the Zadibal area, catering to the entire Block Hazratbal and Zone Harwan, including Harwan New Theed, Faqir Gujri, and Mulnar, ensuring prompt medical assistance during critical emergencies," she added—(KNO)

RWBCIS in pipeline: Govt

Srinagar, Oct 27: The Jammu and Kashmir Government has said that the process of tendering to provide insurance cover to fruits under the Re-structured Weather-Based Crop Insurance Scheme (RWBCIS) is currently underway, aimed at safeguarding the horticulture sector from weather-induced losses.

Replying to a question of MLA Pulwama Waheed Ur Rehman Para, Minister for Agriculture Javed Ahmad Dar, in a writ-ten reply, said that the Market Intervention Scheme (MIS) was announced by the Government of J&K in the year 2019 for procurement of Apple fruit crop through Government of India's authorized Enterprise, National Agricultural Cooperative Marketing Federation



Ltd. (NAFED) to provide benefit to the farmers by facilitating the timely marketing of farm produce during Covid-19 pandemic

"Under Re-structured Weather Based Crop Insurance scheme (RWBCIS)- apple, saffron, mango and litchi crops have been notified to provide cover," the minister said. He added that the tendering process for the selection of an insurance company (out of the empanelled Insurance companies notified by the Gol) to provide

Insurance cover to these Horticulture crops is in process," he said. Dar said the department is

providing assistance for the establishment of C.A Storage unit in the JKUT. "The estimated requirement for Controlled Atmosphere (CA) & storage is 6.00 LMT (30% of the annual production of fruit crops).

"Currently, Jammu and Kashmir has 2.92 LMT of capacity. The Department is contemplating increasing the C.A Storage capacity in the next five years. Apart from keeping sufficient funds in the Centrally Sponsored Scheme Mission for Integrated Development of Horticulture (MIDH), J&K Government is also providing top-up subsidy from UT Capex," he said. The minister said various initiatives are being undertaken to support this expansion, including awareness programs and seminars in each district to inform youth about incentives for establishing CA infrastructure and post-harvest activities.

Most CA stores are located in the Industrial Growth Centres at Lassipora, Pulwama, and Aglar, Shopian, he said, adding that efforts are also underway with the Industries and Commerce Department to establish sector-specific industrial estates for horticulture and post-harvest management in other districts. Dar said the department has established two fruit and vegetable markets in Pulwama - at Prichoo and Pachhar Rajpora - which are operational. "Infrastructure upgrades are ongoing, with funds of Rs 1.28 crore and Rs 3.68 crore allocated for the improvement of these mandis under NABARD for the year 2025-26," he added—(KNO)

No plans of BPL, AAY beneficiaries re-verification: Govt

Srinagar, Oct 27: The Jammu and Kashmir government has said it does not propose to initiate a fresh re-verification of Below Poverty Line (BPL) and Antyodaya Anna Yojana (AAY) beneficiaries, as the process is already being continuously carried out by the Food, Civil Supplies and Consumer Affairs (FCS&-CA) department.

Ín a written reply to MLA Ghulam Ahmad Mir, the Power Development Department (PDD) clarified that no separate re-verification drive is required to identify genuine power consumers under subsidized categories.

The department said that consumers registered under the BPL category continue to receive subsidized electricity tariffs in line with the tariff order issued by the Joint Electricity Regulatory Commission (JERC) for Jammu and Kashmir, upon production of a valid BPL certificate.

The reply further stated that load categorization and tariff rates are determined on the basis of the electrical load at consumer premises rather than ration card categories, with JERC issuing subsidized rates for eligi-

On infrastructure development, the government clarified that underground power cabling in tourist destinations like Kokernag and Verinag "is not planned at present," and no such proposal is currently under consideration.

The PDD also said that uninterrupted power supply (zero curtailment) is being ensured for fully metered areas with feeder losses below 15 percent, subject to maintenance shutdowns and unavoidable technical constraints—(KNO)

The platform offers linguistically categorized digital resources including text, audio, and visual materialsthat aid academic research, language education, and cultural documentation. These rich and diverse collections provide foundational datasets for emerging AI and natural language processing applications, enabling more inclusive and effective digital tools for low-resource tribal and regional languages.

BharatGen: AI Models for Indian Languages

BharatGen develops advanced text-to-text and textto-speech translation models for all 22 Scheduled Languages. It leverages data from SPPEL and Sanchika to create multilingual AI systems that power applications in governance, education, and healthcare - ensuring that digital content is accessible in every major Indian

BharatGen's multilingual AI systems are designed to enhance digital accessibility and inclusivity across sectors such as governance, education, and healthcare, enabling seamless communication and content delivery in India's diverse linguistic landscape.

GeM and GeMAI: AI-Powered Multilingual Assistant for Government e-Marketplace

The Government e-Marketplace (GeM) is India's digital platform for public procurement, launched on August 9, 2016, by the Ministry of Commerce and Industry. GeM streamlines the purchasing process for government departments and public sector entities, ensuring transparency and efficiency.

To enhance user accessibility and inclusivity, GeM has integrated GeMAI, an AI-powered multilingual assistant. The Minister also informed that various initiatives are undertaken by the Government to support this expansion like Awareness/seminars are being conducted in each District to aware the youth about the incentives available for establishment of C.A. infrastructure and other post-harvest related activities. He added that as most CA stores are located in the Industrial Growth Centre at Lassipora, Pulwama, and the Industrial Estate at Aglar, Shopian, efforts are underway with the Industries and Commerce Department to establish sector-specific industrial estates for horticulture and post-harvest management in

other districts. Regarding the steps being taken for upgradation and improvement of Fruit Mandi at Pulwama and Rajpora, the Minister said that the Department has established two fruit and vegetable Markets in Pulwama district at Prichoo Pulwama and Pachhar Rajpora Pulwama, which have been made functional. He added that the basic infrastructure is available in these mandis. however, up-gradation and improvement of the mandis is a continuous process for which funds to the tune of Rs 1.28 Cr and Rs 3.68 Cr respectively have been earmarked for up-gradation under NABARD for the Year 2025-26.

With respect to measures being taken to revive the Market Intervention Scheme and to use NAFED model to support apple growers, the Minister informed that the Market Intervention Scheme (MIS) was announced by the Government of J&K in the year 2019 for procurement of Apple fruit crop through Government of India's authorized Enterprise, National Agricultural Cooperative Marketing Federation Ltd. (NAFED) to provide benefit to the farmers by facilitating the timely marketing of farm produce during Covid-19 pandemic.

He also added that the possibility of establishing CA storage units in other districts apart from Pulwama is being explored to cater growing demands of horticulturists.

Further, the Minister informed that under the Social Welfare department, one Working Women Hostel is functional at Roop Nagar, Jammu with a capacity of 25 women, which includes dormitories, kitchen, library, washrooms, lawns, lobby, and daycare centre.

She also informed that the Department is in the process of establishing five newly approved Sakhi Niwas in the districts of Srinagar, Baramulla, Anantnag, Kathua, and Rajouri and suitable buildings have been identified and engagement of human resources is under process.

The Minister also added that the Health & Medical Education Department also provides hostel facilities through Nursing, Paramedical, and Girls Hostels for Medical Colleges, besides School Education Department also provides Hostel Facilities for Girls through KGBVs in

Govt assures no shortage of food grains in Keran, Jamgund

OCTOBER Minister of Food, Civil Supplies and Consumer Affairs, Satish Sharma Monday informed Legislative House that there is currently no shortage of food grains in the Keran and Jamgund areas of Kupwara.

He was responding to the Calling Attention Motion moved by MLA Mir Saifullah.

While calling attention motion about the non-availability of food grains, Mir Saifullah said that the far flung areas of Keran and Jumgand remain closed for six months during the winter owing to heavy snowfall and face shortage of food grains.

Responding to the motion, Minister said that the government ensures advance release/ dumping of food grains under all schemes for a period of 8 months i.e., from November to June every session to the inaccessible areas i.e., main borders of Kupwara including Keran and Jamgund well before the onset of winter season/closure of roads.

Elaborating further, he said that in respect of Jamgund, against the requirement of 536.14 quintals of food grains for a period of 08 months, i.e., November 2025 to June 2026, 100% of the quantity has been delivered to the area.

"In respect of Keran, against the requirement of 2774.43 Qtls of food grains for 08 months. i.e., November 2025 to June 2026, 800.00 Qtls have already been transported and received at the respective locations, and 346.80 Otls have already been dumped in advance," he said.

He further said that the remaining quantity shall be ensured to be delivered/stocked by or before 31st of October 2025.

Govt taking pro-active steps to prevent Hepatitis A spread in Bandipora: Sakeena


SRINAGAR, OCTOBER 27: Minister for Health and Medical Education, Sakeena Itoo Monday informed the Legislative Assembly that Health and Family Welfare has taken several prompt and comprehensive measures to control and prevent the spread of Hepatitis A in Arin block of Bandipora.

Responding to the calling attention motion moved by MLA Nizamuddin Bhat, minister said that the situation is being continuously monitored by the Health Department, in coordination with the District Administration and the Jal Shakti Department.

"A surveillance mechanism has been put in place to ensure timely reporting and response to any fresh case," she said.

She informed the House that fter receiving the information of the infectious disease, the field teams and District Surveillance Unit Bandipora visited the affected areas, and it was found that the cases were sporadic in nature with a scattered pattern and no clustering of cases was established from any particular area.

The minister further said



that these areas are being monitored by the field teams preventive measures were set in the form of extensive IEC activities at multiple levels coupled with microbiological water analysis.

She said that District Public Health Lab is completely functional at DH Bandipora and 166 Blood Samples were tested for Viral Henatitis. She also said that 93 water samples were tested from the area of concern and the report was shared with the PHE Department for necessary action.

Minister further said that in coordination with the Jal Shakti Department, all local water sources have been inspected and samples taken for quality testing.

"Public awareness drives have been launched to educate residents about maintaining personal hygiene, boiling drinking water, and avoiding open defecation," the minister said.

Minister further said that medical camps have been organized in the affected and early detection and treatment of new cases. "Adequate stock of medicines and diagnostic kits has been supplied to the local health institutions. Special emphasis has been laid on educating school children and community groups about preventive measures,'

MLAs highlight several issues of public importance Speaker clarifies rules for accepting adjournment motions by members

Srinagar, Oct 27: During the Zero Hour of the ongoing session of the Jammu and Kashmir Legislative Assembly Monday, Members from across party lines raised a range of public interest issues concerning their constituencies and the UT at large, seeking urgent attention and redressal from the Government.

Earlier Sajad Gani Lone, MLA Handwara, raised a procedural point over rejection of his adjournment motion regarding rationalization of reservations through a cabinet sub-committee. Responding, the Speaker clarified that Assembly Rules allow adjournment motions only on matters of recent occurrence and not on issues pending adjudication in courts.

Sajad Shaheen, MLA Banihal, demanded a one-hour discussion in the House over the arrest of MLA Doda, Mehraj Malik. In this regard, Nazir Ahmad khan suggested the constitution of a committee to examine the legality of the PSA invoked against Malik. Supporting procedural clarity, RS Pathania, MLA Udhampur East, observed that imposition of PSA is the prerogative of the District Magistrate Raising infrastructure-relat-

ed issues, Yudhvir Sethi, MLA Jammu East, sought immediate restoration of the Bhagwati Nagar Bridge damaged during recent floods. Shakti Parihar, MLA Doda West, requested rehabilitation of families affected by land sinking in Kastigarh and restoration of the Ramgarh road. Pyarelal Sharma, MLA Inderwal, and Dr Rameshwar Singh, MLA Bani, also urged rehabilitation of flood-affected families and restoration of damaged roads and infrastructure.

S.S. Salathia, MLA Samba, highlighted the agitation of PHE Department daily wagers demanding regularization, noting that the ongoing strike was disrupting regular water supply. He further sought release of long-pending public deposits from the Jammu & Kashmir State Cooperative Agriculture and Rural Development Bank (formerly CLDB). Justice (Retd) Hasnain Masoodi, MLA Pampore, requested deployment of water tankers in Pampore and Kakapora to en-

sure safe drinking water supply. Several MLAs raised issues related to connectivity and road projects. Nizamuddin Bhat, MLA Bandipora, sought



Sumbal-Bandipora-Gurez Sheikh Khursheed Ahmad, MLA Langate, flagged delays in CRF-funded road projects. Choudhary Mohammad Akram, MLA Surankot, urged completion of the Bafliaz road, while Ghulam Mohi-ud-din Mir, MLA Rajpora, pressed for restoration of damaged bridges in his constituency. Mir Saifullah demanded DPR formulation for the proposed Keran tunnel to improve border connectivity.

On developmental fronts, Dr Bashir Ahmad Veeri, MLA Srigufwara-Bijbehara, demanded that the Jablipora Fruit Mandi be developed as per its original DPR to serve as an international fruit terminal, besides seeking introduction of a Market Intervention Scheme for horticulturists. Rafiq Ahmad Naik, MLA Tral, and Abdul Majeed Bhat Larmi, MLA Anantnag West, both sought establishment of Cold Storage and CA stores in their respective areas to aid fruit growers.

Tourism-related issues were prominently raised by Dr. Shafi Ahmad wani MLA Beerwah, who sought reopening of closed tourist destinations including Doodhpathri, Yousmarg, Tosamaidan, and Drang, while Pirzada Farooq Ahmad Shah, MLA Tangmarg, echoed similar concerns, calling for early restoration of tourism activities.

Several members also flagged matters concerning administrative outreach and education. Kuldeep Raj Dubey, MLA Reasi, demanded setting up of an SDM office at Pouni/Arnas for public convenience, while Pawan Gupta, MLA Udhampur, urged restoration of work on the upcoming GMC Udhampur, stalled due to relocation issues with the ITI. Baldev Raj Sharma, MLA Shri Mata Vaishno Devi, pressed for speedy establishment of the IMS Katra project.

humanitarand ian concerns were also voiced during the Zero Hour. Shameem Firdous, MLA HabbaKadal, sought the constitution of a committee comprising retired judges and senior police officers to review cases of Valley youth jailed in prisons outside J&K.

Dr Sajjad Shafi, MLA Uri, highlighted pending relief for families whose houses were damaged during Operation Sindoor, while Zafar Ali Khatana, MLA Kokernag, sought relief measures for nomadic families affected by floods.

Arjun Singh, MLA Ramban, brought to the notice of the House the kidnapping of a person belonging to his constituency in Niger and urged the Government to take up the matter with the Ministry of External Affairs for his early repatriation.

Rafiq Ahmad Naik and Iftikhar Choudhary, along with Saif-ud-Din Bhat, urged that Jal Jeevan Mission (JJM) works be taken up concurrently with ongoing departmental enquiries to avoid disruption in water supply schemes. Aijaz Ahmed Jan, MLA Poonch, called for early release of scholarships for tribal students, and Salman Sagar, MLA Hazratbal, demanded release of pending salaries of Khidmat Centre (CSC) operators.

said. "People working in research, innovation, and manufacturing are silent contributors to national defence.'

Referring to the tensions that followed the April 22 Pahalgam terror attack, Singh said India's response showed that the armed forces were prepared for any eventuality. However, he cautioned that the evolving global situation called for constant vigilance and self-reliance.

"After the Pahalgam attack, when Operation Sindoor was launched, a situation arose where war was knocking at our doors," Singh said. "Our forces are fully prepared to defend the nation in any circumstance, but the level of uncertainty in the world has increased. We must therefore move forward carefully, assessing every situation before taking action."

He said the nature of modern warfare is changing rapidly, with technology, drones, and cyber capabilities becoming central to national security. "To deal with these changes effectively, indigenisation is the only path forward," he said.

Pertinently, 'Operation Sindoor' was launched in May this year as a response to the Pahalgam terror attack that left 26 civilians dead. The operation involved precision strikes by the Indian Armed Forces on multiple terror camps in Pakistan and Pakistan-occupied Kashmir. (KNO)

who conducted that interview also tried to ask me questions around this. I didn't answer them. If I didn't answer her, why do you think I will answer you?" he said.

Abdullah said he was hopeful for the restoration of statehood from the first day. "But the hope is fading with each passing day. Still, I am hopeful of its restoration. The more you make us wait, the less hopeful we will be. Only one year has passed. It would be better if we could have it during this hopefulness," he said.

The CM said the government wanted to talk about the restoration of statehood. However, the speaker didn't allow the discussion as the case is subjudice, he said. "I had no objection if any MLA tried to bring a resolution on statehood. The custodian of the house is the speaker, and only he can decide on the introduction of bills and resolutions.

"I know where I stand in the matter of statehood. I know that if a resolution of statehood comes before the House, then my colleagues and I will vote," he added.

Omar further said the government doesn't make decisions based on religion or area. "These are BJP members who have kept about 15% of the population of this country out of the government. Today, the BJP has not even one Muslim Member Parliament in the Lok Sabha or Rajya Sabha," he said while replying to a query on compensation to the flood-hit people.

The Chief Minister said his government will decide to disburse relief to the people by looking at the loss, not the area or religion. He added that in the area which has suffered loss, the package will be requested from the Centre and distributed among

the people. On hurdles being faced under the Union Territory, Abdullah said that if there were no obstacles, he would not have asked for statehood. "It is obvious that issues are being raised. I have the responsibility, and I will have to answer the House. But the officer doesn't seem to be my choice. There are many other examples and many institutions that should be under the control of the elected government, which are not yet. There are two universities, Cultural Academy, SKIMS, Power Development Corporation. There are many things that should have been transferred to the elected government, which have not been done. With these obstacles, we are fighting that statehood should be returned to us so that all these rights are with us," he said.

About the Business Rules file, Omar said that there has been a conversation with the center for a few hours. "There have been one or two rounds of discussion. Some questions have been raised from there. But we are telling them that the business rules we have sent are completely under the J&K Reorganization Act. We have not tried to work against the Reorganization Act anywhere," he said.

Regarding MLA Handwara, Sajad Gani Lone's statement calling Rajya Sabha elections a 'fixed match' between NC and BJP, the Chief Minister stated that the person who has not taken part in the e should clarify what his helplessness was to help the BJP. "If he wanted to avoid match-fixing, at least he would have used his vote," he said, adding that the people of Handwara did not send him here to remain silent and play double roles. He should openly say whether he is with BJP or not.

"On the day when elections were announced, I had maintained that those who do not take part in this election or abstain are directly helping the BJP. The media had already announced the results, giving us three and the BJP the seat. But, on the ground, we fought and tried to win,"

Regarding the Rajya Sabha results, he said those who have made a deal of their faith should answer to Allah, adding that he would like them to come forward.

He also said that one of the independent MLAs had approached him and admitted that he made a mistake. "The MLA was not allowed to open the dummy voter slip and thus he voted in the wrong place," he

Omar said that on the last seat, four votes went in favour of the BJP, while three deliberately destroyed their votes because they didn't give a first preference; they directly wrote a second preference. Therefore, the BJP clearly made attempts to lure people. On what basis they were lured, whether they were induced or anything else, that only the BJP can answer," he said.

On the discussion over Mehraj Malik's detention, Abduallah said the speaker has given his opinion. I agree that whatever Mehraj Malik did was not worthy of a PSA. If there is any action against him, then the Speaker can do it. He is a member of this House," he said, adding that a disciplinary committee can be formed to look into it, but using PSA against an elected member is completely wrong.

Abdullah said that there was no understanding with BJP. "The only party that is taking on the BJP in Jammu and Kashmir is the National Conference. We are the ones who took them on in the Rajya Sabha elections, nobody else. Congress could have fielded a candidate; they chose not to. In Nagrota, where is PDP's candidate? Congress also, at the last minute, told us they will not fight, so I had to scramble to find a candidate. Otherwise, we were ready to support Congress in Nagrota. We are not those people who have a secret understanding," he added.

The CM said that his attempt is that the central government should maintain relations so that J&K government's work is done properly. "But the relationship between the government, the National Conference, and the BJP has a big difference. There is no relation between the National Conference and the BJP anywhere else. What will happen to my relationship with the central government is another thing," he said.

Omar said any by-election is a challenge for a government. "We are taking this byelection also as a challenge. This challenge is multiplied by the complexities of voter distribution in Budgam. It is also multiplied by some element of internal politics that is playing out. I am hopeful that the people of Budgam will make the right choice," he said. (KNO)

He said immediate restoration work was undertaken to restore power, water supply, and road connectivity to support rehabilitation.

Omar praised Mian Altaf as a seasoned and respected leader whose counsel he valued deeply. He recalled how both his father and Mian Altaf often advised him to measure his words carefully, a suggestion he said, he admired.

"I have great respect for Mian Sahib. My father always tells me to think before I speak, and Mian Sahib says the same. In that way, they are alike," Omar said.

But when asked to comment on MP Ruhullah, Omar drew a sharp contrast, saying that there was a "difference between the earth and the sky" between the two leaders.

He refused to elaborate further, dismissing the question abruptly. "I will not speak about him," he said, his tone firm enough to leave little doubt about his displeasure.

Omar also responded to reports that Ruhullah had refused to join the Budgam bypoll campaign, saying that the party has enough leaders to carry on its political outreach. "No one is being forced to campaign," he said. "We have plenty of people willing to go out and work. Whoever wants to stay away can do so."

Hours later, NC legislator Majeed Larmi added fuel to the fire. Speaking to reporters in Srinagar, Larmi, as per KNO, took direct aim at Ruhullah's criticism of the Chief Minister, suggesting that if the MP truly believed the government has failed, he should resign from his seat and face the people again.

"If he says the Chief Minister has done nothing, then let him resign and contest again," Larmi said. "He won on the party's ticket. If he thinks the leadership failed, he should have the courage to go back to the voters."Larmi said every representative has a right to speak for their people but argued that public criticism of the leadership was damaging to the party's unity.

He pointed out that many decisions affecting daily life, including the installation of smart meters, were taken under the Lieutenant Governor's administration, not by the elected government. "The order for smart meters came from the LG government, not ours. When our government has full control, we will deal with it differently," he added.

He also suggested that major policy decisions could only be made once statehood was restored. "When there is no money and no administrative power in the state's hands, how can anyone promise miracles?" he asked.

By afternoon, it was Ruhullah's turn to respond and he did not hold back.

Speaking at another media interaction, the MP Ruhullah rejected any notion of personal rivalry, saying his concern was about the direction the party had taken since coming to power.

"If the National Conference wants to make this personal, I'm ready to fight,"

"There is no time for personal fights. The real fight is for Kashmir's existence,' he said. "We promised people a battle for their dignity and the restoration of their rights. Where has that fight gone?'

Ruhullah accused the leadership of abandoning key poll promises made during the 2024 elections, including the restoration of Article 370 and the creation of one lakh jobs. "Only 20,000 have been given. Can anyone tell me where the rest are? Can anyone give me their address?" he asked.

He also raised concerns about detained youth in Kashmir, saying thousands remain behind bars without trial. "These are the same people who voted for us. What have we done for them?

Rejecting any focus on himself, Ruhullah said his remarks were driven by accountability, not ego. "Ruhullah is not important. What matters is the trust people placed in us and the promises we made," he said. "If someone wants to make it about ego, they can. But I won't." (KNO)

The bench slammed the other states and UTs for not filing the compliance affidavits, saying its August 22 contained everything. The bench was hearing a suo motu case relating to stray dogs.

The apex court had on August 22 expanded the scope of the stray dogs case beyond the confines of Delhi-National Capital Region (NCR) and directed that all states and Union Territories be made parties in the matter.

Jaishankar meets US state secy Rubio in Kuala Lumpur for trade talks

Doctor warns: These medications, including one for high BP, can drop sodium levels, make you feel weak

New Delhi, Oct 27: When people think of sodium, they usually think of salt, and the advice to "cut down on it." While too much sodium can raise your blood pressure and harm your heart, too little can also be risky. Your body actually needs a small amount of sodium to function properly. It helps balance fluids, supports nerve function, and keeps your muscles, including your heart, working the way they should.

When sodium levels drop too low, a condition called hyponatremia can occur. This can happen if you drink too much water without enough

electrolytes, sweat excessively during workouts, or have certain health conditions that affect how your body handles sodium. Common symptoms include headaches, nausea, confusion, muscle cramps, and fatigue. In more serious cases, it can even lead to seizures or coma — especially if sodium levels fall suddenly.

5 Simple ways to bring down high BP Older adults, athletes, and people taking certain medications (like diuretics for high blood pressure) are more likely to experience low sodium. It's also common in people who are ill and

can't keep food or fluids down. The key is balance. Cutting down on processed foods is great since they're often loaded with sodium, but your body still needs some salt, especially if you're active or sweating a lot.

Eating a balanced diet with natural sources of sodium, like eggs, dairy, and lean meats, helps maintain healthy levels. Another important risk factor for low sodium

is medication. Recently, Dr Sudhir Kumar, popularly known as hyderabaddoctor, has shared about medications. Thiazide Diuretics (e.g., Hydrochlorothiazide,

Commonly used for high blood pressure. They increase sodium loss through urine,



especially in elderly patients, leading to fatigue, confusion, or even seizures if sodium drops too low. SSRIs (e.g., Sertraline, Escitalopram)

Used for depression and anxiety.

These can increase the release of ADH (antidiuretic hormone), causing water retention and dilution of sodium; more likely in older adults or those on other diuretics.

Carbamazepine or Oxcarbazepine

An anti-seizure and mood-stabilizing drug. It enhances ADH action, leading to SIADH (Syndrome of Inappropriate Antidiuretic Hormone secretion), a classic cause of chronic hyponatremia.

Tip: If you're on these medicines and feel unusually tired, dizzy, or confused- get your blood sodium checked," Dr Kumar warns.

US has reached a 'substantial framework' with China to avert tariffs: US Treasury Secretary

Kuala Lumpur, Oct 27: US Treasury Secretary Scott Bessent has said that he believes the US has reached a framework agreement with China to avoid imposing an additional 100 per cent tariff on Chinese imports.

"I think we've reached a substantial framework for the two leaders who will meet next Thursday... that tariffs will be averted," Bessent said on Sunday to ABC News from Kuala Lumpur, Malaysia, where President Donald Trump arrived on Saturday for a weeklong Asia diplomacy tour. Trump is expected to meet with Chinese leader Xi Jinping in South Korea later this week.

Earlier, Chinese International Trade Representative Li Chenggang said the US and China had reached "preliminary consensus" on trade issues during discussions in Malaysia, according to Chinese media.

Bessent did not provide details about the framework but said on NBC News that he anticipates the US would get "some kind of deferral" on rare-earth export controls. The minerals have been



central to trade tensions between the top global economies.

Bessent said the framework sets up Trump and Xi "to have a very productive meeting," adding, "I think it will be fantastic for US citizens, for US farmers, and for our country in general.

Bessent indicated that an escalation in tariffs on China is "effectively off the table" following what he described as "very good" trade talks with his Chinese counterparts. President Trump had threatened an additional 100 per cent tariff on China from November 1 over Beijing's efforts to impose export controls on critical rare earths, ratcheting up tensions between the US and China.

Asked about the status of those tariffs, Bessent told CBS News on Sunday that tariff threat has "gone away" after two days of talks in Malaysia.

"We had a very good two-day meeting. I would believe that the cent from where we are now, and I believe that that is effectively off the table.'

He added, "I would expect that the threat of the 100 per cent has gone away, as has the threat of the immediate imposition of the Chinese initiating a worldwide export control regime."

US and Chinese trade negotiators reached a "basic consensus" on how to address their "respective concerns," Chinese state media said on Sunday, following talks between the two sides over the weekend in Kuala Lumpur.

A delegation led by Chinese Vice Premier He Lifeng met with US officials including Treasury Secretary Scott Bessent and Trade Representative Jameson Greer for the talks, which come days ahead of a highly anticipated meeting between Chinese leader Xi Jinping and US President Donald Trump.

The two leaders are expected to meet on the sidelines of the APEC summit in South Korea, though Beijing, unlike Washington, has yet to confirm the meeting. Earlier on Sunday, Bessent said the two sides had "set ing" with a "very successful framework for the leaders to discuss". "The two sides engaged in candid, in-depth, and constructive exchanges and consultations on major economic and trade issues of mutual concern," the Chinese state media readout said.

It listed out those issues as including US penalties on China's maritime logistics and shipbuilding industry, reciprocal tariffs, fentanyl tariffs, agricultural trade, and export controls a sweeping set of frictions that have set the world's two largest economies at loggerheads. "Two sides reached a basic

consensus on arrangements to address each other's concerns. Both sides agreed to further finalise the specific details and fulfil their respective domestic approval processes," the readout said. Trade and tech tensions between the world's two biggest economies have heightened in recent weeks after the US expanded its export blacklist, hitting China's access to American high-tech, while China ramped up its own export controls on rare earth minerals.

Hopeful of QUAD meeting early next year: Australian PM



Kuala Lumpur, Oct 27: Australian Prime Minister Anthony Albanese hoped that the QUAD alliance will meet in the first quarter of next year, describing the four-nation bloc as an "important forum".

India was set to host the leaders of Australia, the US and Japan for a summit this year, but that now appears unlikely amid political upheavals in Japan and some strain in India-US ties.

Speaking during a press conference on Sunday on the sidelines of the Association of Southeast Asian Nations (ASE-AN) summit here, Albanese said, "The Quad is an important forum and an important vehicle for us to engage Australia, the United States, Japan and India."

"I'm hopeful that there will be a meeting in the first quarter, I would hope, of next year," he said, adding that Prime Minister Narendra Modi is due to host the Quad meeting. Responding to a question about the QUAD's

future and its meeting this year, the Australian prime minister said it was a "busy summit season", with US President Donald Trump having a "busy period".

Trump is on a three-nation Asia visit. He was in Malaysia for the ASEAN summit, from where he left for Japan. From there, he will travel to South Korea, where he is set to meet Chinese President Xi Jinping on the sidelines of the Asia-Pacific Economic Cooperation (APEC) summit.

Earlier in August, media reports claimed that Trump "no longer has plans" to visit India this year for the Quad summit, detailing how relations between the American leader and Prime Minister Modi "unravelled".

The relations between New Delhi and Washington have been reeling under severe strain after Trump imposed 50 per cent tariffs on Indian goods, including a 25 per cent levy for New Delhi's procurement of Russian oil.

India described the US action as "unfair, unjustified and

UN chief calls for end to 'deplorable' violence in Myanmar

Kuala Lumpur, Oct 27: Myanmar's military rulers must put an end to the "deplorable" violence inflicted on the population since 2021 and find a "credible path" back to civilian government, United Nations Secretary-General Antonio Guterres said on Monday.

Speaking at a press conference on the sidelines of the ASEAN summit in Kuala Lumpur, Guterres said the military takeover had not only "piled calamity upon calamity" on Myanmar but also threatened regional stability.

"I reiterate my call for an immediate end to the violence, a genuine commitment to inclusive dialogue and a credible path back to civilian rule," he said.

Since the 2021 coup against the democratically elected government led by has been locked in turmoil, with an armed rebellion seizing control of large swathes of territory.

The military government says it intends to return



Myanmar to democratic rule via a general election at the end of this year, even as the civil war rages, but the credibility of the vote has been questioned and the junta's critics expect it to stay in power through proxies.

Opposition parties have been dissolved for failing to register, rebel groups and a shadow government have refused to join the political fold and junta chief Min Aung Hlaing has admitted that a vote cannot be held nationwide. "The way forward must lead to a restoration of democratic institutions anchored in the rule of law and human rights," Guterres said. Asked about the election, he said: "I don't think anybody believes that those elections will be free and fair.'

Suryas batting form doesn't concern me: Gambhir backs T20I captain

New Delhi, Oct 27: India's head coach Gautam Gambhir is not perturbed by T20I skipper Suryakumar Yadav's poor form as "failures are inevitable" when the team is focussed on playing an ultra-aggressive brand of cricket.

While India won the Asia Cup tournament last month in the UAE under his captaincy, Suryakumar's own form with the bat left a lot to be desired as he managed just 72 runs in seven innings.

However, he has now found backing from the team's head coach.

"Honestly, Surya's batting form doesn't concern me because we have committed to an ultra-aggressive template in our dressembrace this philosophy, failures are inevitable, Gambhir said during a discussion on JioHotstar.

"It would be easy for Surya to score 40 runs



off 30 balls and avoid criticism, but we have collectively decided that it's acceptable to fail while pursuing this approach," he added.

Even as Surya was struggling with the willow, the likes of Abhishek Sharma and Tilak Varma lit up the tournament with their explosive batting.

Gambhir said the focus is not on individuals but on the team as a whole. "Currently, Abhishek Sharma is in good form and has maintained it throughout the Asia Cup. When Surya finds his rhythm, he will shoulder the responsibility accordingly.

"In T20 cricket, our focus isn't on individual runs but on the brand of cricket we want to play. With our aggressive style, batters may fail more often, but impact ultimately matters more than mere runs," Gambhir said.

During the interaction, Gambhir spoke about his vision for building a fearless team culture, and his partnership with Suryakumar.

"Surya is a great human being, and good humans make good leaders. While he speaks highly of me, my role is ly based on my reading of the game. Ultimately, this is his team.

'His free-spirited character perfectly matches T20 cricket's

essence, it's about freedom and expression. Your off-field personality reflects on the field and in the dressing room, and Surya has maintained this atmosphere brilliantly over the past 1.5 years," Gambhir said.

"From our first conversation, we agreed: we will not fear losing. don't aim to be the most successful coach: I want us to be the most fearless team," the head coach said.

Gambhir admitted that his players are bound to make mistakes as they seek to become a fearless outfit.

"In big games like the Asia Cup final, I told the players it's okay to drop a catch, play a bad shot, or bowl a poor delivery. Human beings make mistakes. Only the opinions of those in the dressing room matter

"Surya and I consistently agree: we will never fear mistakes. The bigger the game, the more fearless and aggressive we must be.

Captain Cummins ruled out of Ashes opener, Smith to lead Australia

Canberra, Oct 27: Australia captain Pat Cummins has been ruled out of the first Ashes Test due to a back injury, with Steve Smith set to lead the side in his absence. The Australia captain has been sidelined with a back stress injury since July and had earlier this month said he was 'less than likely" to feature in the first Test against England in Perth starting November 21.

coach Andrew McDonald told reporters in Canberra.

'We sort of flagged this a week or so ago that it would take sort of four plus weeks to get him up and running

Afghan women return to int'l stage in FIFA tournament

London, Oct 27: An Afghan women's refugee team lost 6-1 to Chad in a FIFA-organised tournament in Morocco on Sunday. But for the players the match itself represented a victory after being denied the chance to play the sport they love back home.

Women's sport has been banned in Afghanistan since the Taliban government took over in 2021, prompting players to flee the country fearing persecution.

Prior to the Taliban's takeover, Afghanistan had 25 women players under contract, most of whom

now live in Australia. The women's national team last played an international match in 2021, losing 5-0 to

Qatar, but in May world football's governing body approved the creation of an Afghan women's refugee team, with Pauline Hamill named as coach.

The team chose "Afghan Women United" as its official name following consultations with FIFA ahead of its loss to Chad, its first match of the four-team FIFA Unites: Women's Series tournament, which also features Tunisia and Libya.

'That's all we wanted all these years after trying so hard to get what we truly deserve as a woman. Our right to play and to represent our country," captain Fatima Haidari said in the lead-up

to the match. "We are profoundly grateful that FIFA gave us this opportunity and this privilege to represent what women are capable of."

Afghan Women United opened the scoring through Melbourne-based striker Manozh Noori's penalty on Sunday, sparking wild celebrations among her

team mates and on the sidelines. But Chad, which played its first match in 2019 and competed in qualifying for the 2020 and 2024 Olympics, recovered quickly and went on to record the comfortable win in Berrechid, 40km from Casablanca.

Afghan Women United's next game is against Tunisia on Wednesday before it takes on Libya on Saturday.

The tournament was scheduled to be held in the United Arab Emirates but was moved to Morocco last week.
