HM Shah attacks Congress, says it protected Art-370 for seven decades

>> Modi govt removed provision, >> India no longer bleeds; it eliminates terrorists in their homes

Oct 29: Union Home Minister Amit Shah on Wednesday launched a scathing attack on the Congress party accusing it of "protecting" Article 370 for seven decades in Jammu and Kashmir and allowing terrorism to flourish, while Prime Minister Narendra Modi removed the provision and crushed terrorism.

Speaking at election rallies in Darbhanga and Samastipur, Shah, according to the news agency-Kashmir Observer (KNO) accused the grand old party of sheltering the constitutional provision and linked its removal to a shift in the government's response to terrorism. "Earlier terrorists used bleed India and go unpunished. Now, under Prime Minister Modi India enters into terrorists' homes and eliminates them," he added.

Shah said, "PM Modi initiated the tradition of giving a

strong and befitting response to terrorism.'

Shah said the government had mounted several responses to cross-border threats, naming surgical strikes, air strikes and Operation Sindoor, "Earlier, terrorists would attack India and escape. Today, under PM Modi's rule, India conducts surgical strikes, air strikes, and Operation Sindoor to eliminate threats inside Pakistan," he said. On the issue of the Popular Front of India, Shah said the previous government had not acted and that the PM Modi led government has taken measures. "The Popular Front of India (PFI) was formed here, but the then Congress government had not banned it. PM Modi led regime banned the PFI in a single night. Police conducted raids at more than 100 locations, and put the entire PFI network behind bars," he said.

Shah said, "I promise that as long as there is even one BJP MP, we will not let a single PFI member out of jail.'

Addressing voters Begusarai, Shah raised the issue of illegal migration and said his party would act if elected. "Should Bangladeshi infiltrators be included in the Bihar price payer list?" he asked, and urged voters to support BJP candidates to enable "the work of selecting and removing every infiltrator." | More on P6

Srinagar Oct 29: Chief Minister Omar Abdullah on Wednesday announced a series of key amendments to the Constituency Development Fund (CDF) scheme, expanding the scope of works that legislators can recommend and removing several financial ceilings that previously limited developmental activities.

Omar Chief Minister Abdullah during his address in the Assembly, as per news agency—Kashmir News Observer (KNO), said the government had been reviewing the scheme for the past two months and has now approved a set of changes aimed at giving elected representatives greater flexibility to address local needs.

'We can bring some changes to this. We want to inform the House about the changes



that have been approved by the government." he said.

CM Omar informed that the ceiling under the Power Development Infrastructure category has been withdrawn. MLAs can now

for the varsity," he added.

'17.22 lakh kanals of land encroached in J&K, 14.27 lakh retrieveď

Srinagar, Oct 29: The Jammu and Kashmir government has said that a total of over 17.22 lakh kanals and 15 marlas of land are under encroachment across the Union Territory, while 14.27 lakh kanals and 7.5 marlas have

so far been retrieved. In a written reply to a starred question tabled by MLA Ranbir Singh Pathania, the Revenue Department, as per the news agency—Kashmir News Observer (KNO), said the encroachments include State, forest, custodian and JDA land.

According to the official reply, the encroached State/

Kahcharai land is 17,22,249 kanals and 15 marlas. Out of this, 14,27,841 kanals and 7.5 marlas have been retrieved, while 2,99,407 kanals are yet to be retrieved. About forest land, 19,501.87 hectares are under encroachment as of 30 September 2025, according to the reply.

The department said that removal of encroachments is an ongoing process undertaken by the concerned field functionaries and that notices have been issued to encroachers under provisions of the Indian Forest Act, 1927.

Taking several measures to prevent, mitigate flash floods: Govt

Srinagar, Oct 29: The Jammu and Kashmir government on Wednesday said several structural and non-structural measures are being taken to prevent and mitigate flash floods across the Union Territory, including strengthening infrastructure, early warning systems, and removal of encroachments on water channels.

In a written reply to a question by MLA Dr. Narinder Singh Raina, the Jal Shakti Department, per news agency-Kashmir News Observer (KNO) said that flash floods are generally caused by intense rainfall and cloudbursts, and their prevention

is not possible, but mitigation steps are being taken regularly under various schemes like Capex and NABARD.

The department said that 22 automatic water level sensors have been installed at key locations on the Jhelum River and its tributaries, with real-time data available is through the "Kashmir Flood Watch" website and mobile application.

It added that flood protection works, including the construction of embankments, gabion crates, and spurs, are being carried out at vulnerable spots in Jammu province. The Jhelum Tawi Flood Recovery Project (JTFRP)/ERA is also preparing a detailed report on | More on P6

CS reviews progress on BISAG-N Projects

SRINAGAR, OCTOBER 29: Chief Secretary, Atal Dulloo Wednesday chaired a high-level meeting to review the progress of a series of technology-driven projects being implemented by various departments of the Jammu and Kashmir Government in collaboration with the Bhaskaracharya National Institute for Space Applications and Geo-Informatics (BISAG-N).

The meeting was attended by Additional Chief Secretary, Agriculture Production Department; Additional Chief Secretary, Public Works Department; Principal Secretary, Home; Additional Director General of Police, CID; Commissioner Secretaries of Social Welfare and Industries & Commerce; Spl DG, BISAG-N; Secretary, Education; Secretary, Information Technology; Mission Director, Samagra Shiksha; Director, Employment; CEO, JaKeGA; SIO, NIC, and other senior officers.

The Chief Secretary commended the Department of Information Technology and BISAG-N for the successful rollout of several citizen-centric and administrative digital platforms under the Digital **I&K** initiative.

He observed that projects being implemented in sectors such as Education, Agriculture, and Revenue are pivotal in ushering modern reforms and directed their timely completion to ensure that the envisaged outcomes are achieved within set timelines.

Highlighting the transformative potential of technology, Dulloo emphasized that leveraging AI and audio-visual content for personalized and localized learning would significantly enhance pupil



learning outcomes.

He further noted that timely forecasts, advisories, and capacity-building measures for farmers would contribute to improved productivity and higher income levels.

On the modernization of land records, he remarked that digitization of revenue records forms the cornerstone of broader reforms aimed at creating a transparent and efficient governance system across the UT.

Special DG, BISAG-N, Vinay Thakur assured the Chief Secretary of complete technical and operational support in the development of all IT modules and applications. He called for enhanced synergy and regular coordination between the implementing departments and BISAG-N to expedite progress and remove bottlenecks in mini-

Secretary, Information Technology, Piyush Singla, briefed the meeting on the major achievements and progress made under various projects designed to enhance transparency, efficiency, and revenue realization.

Among the key initiatives

reviewed were Integrated Mining Surveillance System (IMSS). It was divulged that the Phase-I of the satellite imagery-based system has been successfully implemented to detect and prevent illegal mining activities. Over 114 automated triggers have been shared with

field officers and district admin-

istrations for prompt verification through a dedicated mobile application, the meeting was apprised. With respect to the J&K Tourism App with AI Chatbot. It was added that this mobile and web-based application was launched on September 16, 2025 and it provides comprehensive information on destinations, itineraries, and travel assistance. Powered by BISAG-N's

AI resources, the Chatbot enhances

visitor experience and has already

crossed 1,000 downloads. About the AI-Based GST Fraud Detection module the meeting was informed that the High-priority analytical reports have been developed for the Finance Department, identifying potential tax evasion patterns such as GSTR mismatches, sequential invoicing, and discrepancies between invoice values and

e-waybill generation. A mobile application developed by BISAG-N facilitated a comprehensive survey of houseless and landless urban households. As of October 10, 2025, a total of 3.35 lakh households have been successfully surveyed across I&K completing the exercise in a minimum possible timeframe.

Moreover regarding the PM-Gati Shakti Integrations it was given out that dedicated mobile applications for Jal Shakti, PWD (R&B), and Industries & Commerce Departments are in final phases of completion, enabling efficient asset mapping of roads, bridges, water assets, and industrial estates with a Maker-Checker-Approver workflow. Additionally a unified digital platform for the Power Department aims to provide realtime visibility across Generation, Transmission, and Distribution. Wireframes and dashboards for JKSPDC and DISCOMs (KPDCL & IPDCL) have been finalized, along with the API integration structure to make the functioning more efficient and transparent here. It was

further divulged that the Mission

YUVA dashboard has been integrated with an ONDC-compliant seller app platform to promote youth entrepreneurship through a digital marketplace, with seller onboarding already in progress.

On the issue of digitalization of the Education Department the meeting was apprised that multiple platforms are under development, including an Education Management Information System (EMIS) for teacher transfer, school inspection, and staff attendance; a Litigation Management System for case tracking; and a Student Attendance Mobile App to enhance accountability.

A centralized digital system is being developed to streamline the processing and approval of Recruitment Rules (RRs). The Departmental and Administrative Head Dashboard for monitoring proposals are already live with few additions to be done for its early completion.

Towards the modernization of the Revenue Department it was revealed that work is underway to upgrade the Revenue Department's systems, including database migration, Jamabandi visualization, and a Maker-Checker-Approver workflow. The Mutation module is also being enhanced for improved service delivery.

The Chief Secretary reiterated the government's commitment to leveraging advanced digital tools and AI-based solutions for improved public service delivery.

He underlined that sustained collaboration between the IT Department and BISAG-N is vital to realizing the government's vision of an end to end digitization ensuring transparency, and accountability

'Over 15.5 lac fruit plants imported to JK in 2 years'

SRINAGAR, OCTOBER 29: The Minister for Agriculture Production Department Javid Ahmad Dar Wednesday said that a total of 15,51,863 fruit plants were imported by the empanelled agencies to Jammu and Kashmir during the last two years. The Minister said this while replying to a question raised by Legislator Shabir Ahmad Kullay in the Legislative Assembly today.

He said that the majority of imports comprise apple delicious, and their improved strains, besides apple plants, limited quantities of walnut plants, and cherry apple root-stock have also been imported.

The Minister said that the Leaf Minor pest has shown a surge in past two to three years due to recent climatic changes, besides there has been a notable resurgence and increased severity of



parts of Kashmir valley.

He informed that Department of Horticulture, in collaboration with SKUAST, Kashmir, undertakes regular field surveillance, pest monitoring, and Integrated Pest Man-agement (IPM) intervention to effectively control and contain such incidences.

Javid Dar said that, besides, regular awareness and capacity-building programmes are also being conducted ty-based interventions.

He said that nests like minor have a potential for a rapid horizontal spread and warrants integrated pest management approach with strategic incorporation of insecticide and bio control agents, including cultural practices with community participation.

Minister said that the community based IPM approach in the hot spots strategy is in place, including

regard are being provided by the Department of Horticulture in collaboration with SKUAST-K. The Minister said that the incidence of pest outbreaks, such as leaf minor, necessitates coordinated interventions but large scale blanket spraying of insecticides through drones is not recommended by the research institutions due to environmental concerns and issues like fragmented land holdings, harm to non-target organisms, non-availability of ultra-low-volume for mulation for the said pests. Horticulture Departments intend to follow advisories issued by SKUAS-K CITH and ICAR in the matter Javid Dar said that the

Govt improving B&J Jammu Hospital manpower

Srinagar, Oct 29: The Health and Medical Education Department Minister, Sakeena Itoo on Wednesday said that steps are being taken to improve the manpower situation at the Bone and Joint Hospital, Jammu.

Responding to a question posed by MLA Pawan Kumar Gupta, the minister stated in a written reply that the primary objective of the Bone & Joint Hospital in Jammu is to ease the workload on the Government Medical College & Hospital, Jammu, particularly for orthopaedic cases.

She said the hospital aims to provide services such as joint replacement, treatment of multi-fractures, trauma management, and other specialised interventions within the region, thereby reducing the need for patients to travel outside for treatment.

The minister added that efforts are underway to strengthen the staffing at B&J Hospital Jammu.

In this regard, a proposal for the creation of 22 faculty posts, 27 resident/tutor posts, 162 paramedical posts, 6 administrative posts, and 109 other non-gazetted staff positions is currently under examination by the department.

The proposal for the requisite manpower, including faculty positions such as Professors, Associate Professors, and Assistant Professors, is based on the communication from the Principal and Dean of Government Medical College Jammu, vide reference AJH/PBS/111/2021-No. 22/1146-53 dated 30.09.2021, along with subsequent reminders. This staffing plan pertains to the staffing of the newly constructed 180-bedded block at the

Bone & Joint Hospital, Jammu. The proposal, she said, involves creating a total of 326 posts across various categories, with an estimated annual financial implication of Rs 22.41 crore.

Itoo further said that during the initial examination of the

proposal, discrepancies were identified in the nomenclature and pay levels proposed for several non-gazetted posts, which did not fully align with the existing Recruitment Rules.

She said the matter has been taken up with the Principal of GMC Jammu and the President of the Nursing Council for re-examination, to ensure compliance with the existing Recruitment Rules applicable to the respective cadres, standard nomenclature prescribed under Indian Nursing Council (INC) norms, and guidelines issued by the J&K Paramedical Council.

"Further action on the proposal will depend on the receipt of a revised, rule-compliant staffing matrix from the concerned authorities," the minister said.

She added that faculty positions in the Department of Orthopaedics are also being considered for promotion to higher posts periodically, based on vacancy availability and in accordance with existing norms and recruitment rules.

Regarding subordinate staff and broader cadre restructur-ing, the Health Minister said the issue is linked to the proposal for creating additional posts, which is currently under examination.

She said concerns about parity between Bone & Joint specialists in Jammu and their counterparts in Srinagar have been noted and are under departmental review, considering the sanctioned strength, functional requirements, and applicable service rules. The Health Minister assured

that efforts are underway to address discrepancies observed during the preliminary examination of the proposal. "Once these issues are resolved, the department will seek the prior approval of the competent authority and then approach the Finance Department for concurrence on the creation of 326 posts across various categories at BBJ Hospital Jammu, involving a financial implication of Rs 22.41 crore per

Govt completes construction of 29,767 houses

in the house for the first

Srinagar, Oct 29: The Jammu and Kashmir government has said that nearly 40,000 houses has been sanctioned under the Pradhan Awas Yojana–Urban (PMAY-U) scheme across the Union Territory, of which 29,767 units have been completed, while 1,843 remain non-starters.

The Housing and Urban Development Department detailed the district-wise progress and fund utilisation under both PMAY (Urban) phases, before the Legislative Assembly. This was in response to a question by MLA Mir Mohammad Fayaz.

About the construction status, the reply states that out of the 39,153 sanctioned houses, 13,995 are at roof level, 3,405 at lintel and 1,843 are yet to start construction.

Budgam leads the UT with 4,805 sanctioned houses, followed by Jammu (3,558), Kathua (2,456) and Pulwama (1,157). Districts with fewer houses include Kishtwar (554) and Shopian (477).

About the Credit Linked Subsidy Scheme, the reply mentions: "Under the Credit Linked Subsidy Scheme (CLSS), a total of 3,432 beneficiaries have been given subsidies worth rupees 70.82 crore." The

highest disbursement was recorded in Poonch (Rs 18.08 crore), followed by Kupwara (Rs 12.75 crore) and Bandipora (Rs 12.25 crore).

About PMAY-U 2.0 sanctions, the reply states that under the second phase (PMAY-U 2.0), the Ministry of Housing and Urban Affairs has sanctioned 1,250 dwelling units, including 206 in Kupwara, 231 in Kishtwar and 119 in Anantnag.

Additionally, 1,272 flats have been approved under the Affordable Housing in Partnership (AHP) vertical-60 EWS flats at Bhalwal, Jammu and 304 at Chakhar Sundli, and Udhampur, where verification of beneficiaries is underway.

On financial assistance, it states: "Under PMAY-U 1.0, the government has disbursed rupees 518.29 crore in financial aid, benefiting 35,923 beneficiaries so far." However, 3,230 beneficiaries are yet to receive their entitled assistance. Kathua district alone has received rupees 40.13 crore, followed by Jammu (Rs 36.74 crore) and Budgam (Rs 22.51 crore).

The reply added that funds for PMAY-U 2.0 have not yet been released by the Ministry and the first instalment will be disbursed only after construction begins—(KNO)

Govt released Rs 2,281 Cr in two years

'75 seasonal education volunteers engaged'

Srinagar, Oct 29: The Jammu and Kashmir government has informed the Legislative Assembly that funds amounting to over rupees 2,281 crore were released under the Samagra Shiksha Scheme during the last two years, while 75 Seasonal Educational Volunteers were engaged to impart education to children of migratory families.

As per official details tabled in reply to a question by MLA Farooq Ahmad Shah, the School Education Department said that during 2023– 24, Rs 899.20 crore were released by the Finance Department under the Samagra Scheme, while Rs 925.18 crore were released during 2024–25.

The total availability of funds, as per the reply, includes opening balances and accrued interest, stood at rupees 1,228.44 crore in 2023-24, rupees 1,015.34 crore in 2024-25, and rupees 528.28 crore in 2025-26.

It says, out of these allocations, rupees 1,142.88 crore were utilised during 2023–24, followed by rupees 944.79 crore in 2024– 25 and rupees 334.52 crore up to 2025–26, leaving an unspent balance of rupees 193.76 crore.

The government further stated that 75 Seasonal Educational Volunteers were engaged under the scheme to provide education to children of Seasonal Migratory Nomads, which includes 12 such volunteers in the Gulmarg constituency—(KNO)

1381 posts vacant in forest **Deptt**

Srinagar, Oct 29: The Jammu and Kashmir Government on Wednesday said that 1381 vacancies are available in the Forest, Ecology and Environment Department, of which 711 stand referred to recruiting agencies.

Minister Incharge informed the Legislative Assembly that a proposal for the referral of another 282 vacancies, including 130 non-gazetted and 152 Multi-Tasking Staff (MTS) posts, is currently under examination in the department.

În a written reply to a question by legislator Shakti Raj Parihar, the government said a total of 459 candidates were initially engaged under the Rehbar-e-Janglat (ReJ) Scheme, introduced through Government Order No. 155-FST of 2017 dated June 20, 2017.

Of them, 328 are presently working in the department, including 217 in the PCCF wing, 80 in the Forest Protection Force and 31 in the Wildlife division.

The Rehbar-e-Janglat Scheme was launched following Cabinet Decision No. 96/6/2017 to strengthen forest management and expand employment opportunities in the sector—(KNO)

'920 PE degree holders unemployed in J&K'

Srinagar, Oct 29: The Jammu and Kashmir government has said that a total of 920 youth holding professional degrees Physical Education (PE) (B.P.Ed/M.P.Ed) are registered as unemployed in the Union Territory.

In a written reply to a question by MLA Shabir Ahmad Kullay, the Labour & Employment Department informed that the consolidated data was collected

from the Jammu and Kashmir Employment Portal ([www.jakemp.nic.in] (http://www.jakemp.nic. in)), which is integrated with the National Career Service (NCS) portal of the Government of India.

"As per the registered data, 476 candidates holding M.P.Ed and 444 holding B.P.Ed degrees are unemployed. However, registration of

unemployed youth is voluntary and not mandatory," the department stated. The reply further included information from the Youth Services and Sports Department, detailing initiatives for youth engagement, infra-



structure development, and sports promotion

across districts. The government also highlighted ongoing efforts under the Mission Youth Scheme, establishment of Centres of Excellence, and development of indoor stadiums, playfields, and sports infrastructure across the Union Territory—(KNO)

'40 bunkers ready in Uri, 162 more in 4 weeks'

Srinagar, Oct 29: The Jammu and Kashmir government has informed the Legislative Assembly that 40 individual bunkers have been completed so far in the border villages of Uri in north Kashmir's Baramulla district, while 162 more are expected to be completed within the next four weeks. According to a reply to a starred question tabled by MLA Dr. Sajjad Shafi, the Department of Rural Development and Panchayati Raj said that the construction of bunkers is primarily the prerogative of the Home Department.

It says, however, out of 202 sanctioned individual bunkers or overhead protection trenches for border villages of Uri, 40 have been completed. The department said that there is currently no proposal under consideration for the construction of additional bunkers in uncovered villages of the constituency.

It added that a four-week timeline has been fixed for the completion of the remaining 162 bunkers. The cost per bunker has been calculated at Rs 0.55 lakh, with Rs 0.51 lakh funded under the State Disaster Response Fund (SDRF) and rupees 0.04 lakh provided under MGNRE-GA for the labour component.

The reply further mentioned that the work is being carried out in convergence mode between SDRF and MGNREGA schemes—(KNO)

Assembly uproar over BJP MLA's remarks

Srinagar, Oct 29: The Legislative Assembly on Wednesday witnessed uproarious scenes following remarks by BJP MLA Shagun Parihar, who claimed that a road project in her constituency is repeatedly being dropped because Hindus reside there.

What is 'fast' formula and why is it important for stroke detection?

This article presents why World Stroke Day matters in India, explains what a stroke really is, introduces the simple yet powerful acronym "FAST" for spotting warning signs, and offers a fresh perspective on how this knowledge can help in real life.

Every year on 29 October, voices in India and around the world come together for World Stroke Day to raise awareness about a condition that strikes silently. It's easy to think a stroke happens only to others, older people, far away, yet in India, the story is changing. Here is a guide to what a stroke is, why it matters right now, and the simple 'FAST" formula that can make a life-saving

What is a stroke?

A stroke happens when blood flow to part of the brain is interrupted, either by a clot blocking a vessel (ischemic) or by a vessel bursting (haemorrhagic). Without blood, brain cells begin to die, and damage follows.

In India, the burden of stroke is rising. Study published in ICMR suggest the incidence of stroke ranges between about 105 and 152 cases per 100,000 people each year. One review from The Lancet reported that a 51 per cent increase in prevalence in 1990 to 2021.

What makes this especially relevant for India? Many middle-aged adults face rising rates of diabetes, high blood pressure, and sedentary lifestyles. When a stroke hits early or unexpectedly, the human impact is heavy: on work, on family, on dreams.

Why World Stroke Day matters?

World Stroke Day acts as a vital reminder: a stroke is not some far-off problem. For India, where incidence and disability from stroke are rising, awareness matters more

On this day, medical professionals focus on: Recognising stroke early, when treatment can still do a lot.



Encouraging people to take risk factors seriously: blood pressure, sugar levels, smoking, and inactivity.

Breaking the myth that strokes only happen to "old" people. In fact, younger people in India are also affected.

Thinking about one's own life, one's parents, a friend's sibling – that personal framing is powerful. When the message feels close to home, people act faster. The "FAST" formula

To spot a stroke early one of the most trusted tools is the acronym FAST:

Face: Sudden drooping or uneven smile. Arm: Weakness or inability to raise one arm. Speech: Slurred speech, trouble finding words.

any of these happen, time Time:

Why FAST? Research shows people remember the shorter FAST version better

In an Indian context, where emergency response may vary by region and access to specialist care can differ, the sooner a stroke is suspected and acted upon, the better the chances of reducing lasting injury.

Why FAST is more than a mnemonic

Let's bring FAST into a personal frame. Imagine a father in a Delhi suburb who smiles with one side of his face lagging, or a neighbour in Bengaluru who tries to raise a teacup and one arm seems 'lazy'. Recognising these moments is the turning point.

FAST isn't just for health work

crisis. That means children, siblings, neighbours. The power lies in recognising: "That looks odd, something's off" and trusting the

Also, "Time" in FAST isn't a vague term. In stroke care, every minute counts. The phrase "Time is brain" is used to stress how every lost minute means more brain cells dying.

Sharing on this topic, Dr Madhukar Bhardwaj, Director & HOD - Neurology, Aakash Healthcare, said, "Time is brain when it comes to stroke. The four-and-a-half-hour post-symptom window is referred to as the golden window. At this stage, immediate medical treatment, for example, blood clotting drugs or interventional reperfusion, can reintroduce the blood supply to the brain and reduce damage in the long term. " He added, "When this window is closed,

the probability of full recovery reduces drastically. As a matter of fact, almost two million brain cells perish every minute when a stroke is not treated. This is why it is so important that the action should be taken immediately; the symptoms identification and the hospital arrival in time can really be the key to recovery and disability."

What to do if FAST signs appear?

If one of the FAST signs appears: Stay calm but move quickly. Don't assume

the person will "just get better." Call the nearest emergency number or take the person to the nearest hospital that can do stroke care. Mention "suspected stroke" so they can prioritise.

While travelling, note the time when symptoms started, this helps doctors decide treatment options.

Avoid giving food, drink, or medications (unless instructed) because swallowing may be affected and some medications may

After hospital, whether the stroke is mild or more serious, rehabilitation begins anyone who might stand beside someone in early: physical therapy, speech therapy, and

supportive care all matter.

Stroke is often misunderstood as an elderly disease, but Apollo Hospitals neurologist Dr. Sudhir Kumar warns it can affect people in their 30s and 40s. In a post on X, he debunked myths, stressing that 80 to 90 percent of strokes are preventable with life-

Beyond FAST: Prevention and living beyond a stroke

While FAST is about spotting a stroke fast, preventing one is equally critical. Some lesser-spoken but meaningful steps (beyond the usual "exercise and eat well") include:

Monitoring not just blood pressure but also blood sugar and cholesterol regularly. Early detection changes outcomes.

Being mindful of sleep quality. Poor sleep (and sleep apnoea) is gaining attention as a

Thinking about airway health: loud snoring, pauses in breathing during sleep may hint at underlying issues that increase

Reducing exposure to air pollution and toxins. In many Indian cities, ambient air pollution itself is emerging as a stroke risk contributor./.,

Building a "family plan," discuss with family or household members what to do if stroke signs pop up. Having phone numbers, hospital choices, and transport means ready can remove delay.

And for those who have survived a stroke: life doesn't just restart, it pivots. Adaptive mindset, community support, and early rehab make a big difference. The stories of survival often include the quiet work of rebuilding strength, voice, balance, and hope.

Tou can lead teams, solve complex problems, and stay calm under pressure-yet still feel off-balance when it comes to love. Many high-achievers know this paradox well: the same focus and drive that fuel professional success can quietly undermine emotional connection.

Research in relationship psychology shows that individuals driven by excellence often carry unresolved attachment patterns formed early in life. These unhealed experiences can surface as perfectionism, over-responsibility, or difficulty being vulnerable. Over time, they create cycles of burnout, emotional disconnection, and conflict-even in otherwise highfunctioning relationships. Understanding how these dynamics unfold in real life requires more than statistics or theory—it demands noticing what drives you in the moment.

To explore the intersection of love, trauma, and performance—and to gain real-life insight into how lasting change occurs-I spoke with Sanya Bari, a relationship therapist and coach who helps high-achieving individuals break free from recurring emotional patterns in love and connection. Her work highlights that every relationship offers an opportunity to heal what remains unresolved, and even moments of conflict can serve as invitations to release old wounds and reconnect with a deeper sense of self. This shift-from reacting to reflectingcreates space for more authentic connection, compassion, and growth in all areas of life.

Recognizing the Patterns That Keep You Stuck High-achievers—whether in business, the arts, sports, or science—often face the same quiet paradox: they can master complexity everywhere except in their closest relationships. Outwardly, life appears steady; inwardly, something still feels off. Many describe feeling disconnected from loved ones or frustrated by behaviors they can't seem to change, even after being meticulous about making everything else in their world run flawlessly.

Research in attachment and trauma psychology helps explain why. Early disruptions in emotional safety shape how adults connect, care, and cope. One recent study found that maladaptive perfectionism-the belief that love must be earned—mediates the link between childhood trauma and later depression. These early imprints don't disappear with success; they simply find new arenas to replay the same unfinished story.

Bari explains that these repeating dynamics often surface as hidden forces that disguise themselves as love-core blocks that quietly turn connection into something that hurts rather than heals. These core blocks unnoticed patterns of thought, emotion, and behavior-can prevent even high-achieving individuals from experiencing authentic intimacy. "They've solved complex world problems," she says, "but find it far harder to understand why peace feels so out of reach in their most personal relationships."

Recognizing these patterns is where change begins. When individuals pause to notice their recurring reactions—who they become when they feel unseen or unsafe—they begin to uncover the emotional habits that are finally ready to heal.

Healing From Within

Awareness is the first step; integration is the next. Once you begin seeing your patterns clearly, healing becomes less about insight

and more about a sacred, self-honoring practice. Real change doesn't happen through understanding alone; it happens when life tests what you've learned and you choose to return to yourself instead of your old reactions.

Bari explains that emotional growth isn't about perfection or control, but about capacity-the ability to anchor into inner safety rather than collapse into reaction: "If you want to live an extraordinary life, you have to operate from an extraordinary place within vourself." In her sessions, clients learn to translate awareness into action: to lead themselves through defensiveness, to listen from a deeper place that nourishes, and to stay open even when fear wants to close.

Research supports this process of integrating self-awareness into behavioral change. A 2025 study found that individuals who practiced mindful self-regulation-pausing to notice emotional triggers and consciously responding rather than reacting-showed measurable improvements in emotional resilience and interpersonal satisfaction.

This kind of intentional practice gradually rewires how the nervous system responds to stress. By consistently returning to clarity amid chaos, individuals build internal steadiness-a peace that no longer depends on anything outside of them. For high-achievers accustomed to mastering life through effort and control, this shift can feel disorienting at first. However, peace isn't found by doing more; it's created by changing your inner state, by traveling within yourself to something steadier than circumstance.

Practical Steps for Change Lasting transformation doesn't come from doing more-it comes from learning how to come back to yourself when you've lost your

center. Here are some steps you can follow to slow down, reflect, and respond from a place of awareness rather than reaction:

Pause: When tension rises or emotion takes over, take one conscious breath before acting. That brief pause interrupts the autopilot of fear and opens a door back to awareness.

Check for Hidden Forces: Notice whether guilt, role-playing, over-responsibility, or transactional thinking is shaping your response. These forces can make connection feel like labor. Naming them allows you to step back and regain clarity.

Connect to What You Want: Ask yourself: What do I truly want right now? Who do I want to be in this moment? How would I respond if I weren't influenced by these hidden forces? What do I want to create or experience in my life? Reset and take consent with yourself-shift from self-betrayal to selfalignment, building confidence that comes from honoring your own truth.

Forgive and Respond From Love: Forgive yourself for reacting or for not knowing better sooner. Then choose the next step that feels rooted in love, not survival. Forgiveness is not weakness-it's the most radical form of freedom. By releasing what no longer serves you, you stop giving power to what was never meant to guide you. It's less about letting someone off the hook and more about cutting the ball and chain. As Bari says, "It's the badass thing to do."

Each time you move through these steps, you shift from reaction to responsibility, from performance to presence. Over time, the pause becomes your default, and clarity becomes your compass.

The Ripple Effect of Change Transformation rarely happens in grand gestures; it unfolds in quiet, consistent choices. A single pause before reacting, a moment of honest communication, or one act of listening without defense can shift an entire dynamic. Bari teaches that when you change the energy you bring into an interaction, you change the outcome for everyone involved. Over time, these micro-actions ripple outward—strengthening empathy, restoring trust, and creating the kind of love that heals rather than harms.

Bottom Line High-achievers often excel at everything except their own inner world. True growth begins by noticing the patterns that drive your reactions and choosing presence over performance. By releasing guilt, fear, and old roles, you make space for clarity—the foundation of emotional freedom. Change doesn't require doing more; it requires doing differently, from a deeper place within.

Rana said that there is a network of 112 canals, comprising approximately 245 km of main canals and 90 km of distributaries with a command area of about 21,416 acres, benefiting nearly 20,625 households in the Sonawari Constituency.

He further said that twenty-one works also have been executed during the last five years under PRI, DDC, and Capex grants for strengthening the existing irrigation infrastructure in the IFC Division Sumbal.

In addition to this, eight DPRs under NABARD and Pradhan Mantri Jan Vikas Karyakram (PMJVK) Schemes have been prepared and are presently under examination for the modernization and augmentation of various Lift Irrigation and De-watering Schemes in the Sonawari Constituency.

He said that these projects

He said that these projects aim to promote Agricultural Development and ensure the smooth provision of irrigation facilities to the beneficiaries.

However, the project "Construction of LIS Odina"

- has been proposed for funding under RIDF-XXI (NABARD). The scheme is proposed to be executed in two stages, wherein water will be lifted from River Jhelum and discharged into Nallah Amir Khan. "This Nallah, which traverses several villages and supports multiple irrigation schemes, will ensure wider benefits to the farming community" the Minister added.

Centre to be urged on relaxing Anganwadi norms: Sakeena

She also informed the house that currently there is no such proposal for establishment/opening of additional Anganwadi Centres in far flung areas of Jammu and Kashmir. She added that the matter with regard to opening of



Anganwari centers in left out and far flung areas, that fulfill the criteria, shall be taken up with the GOI, Ministry of Women and Child Welfare.

Further, the Minister informed that all necessary steps/measures are being taken to ensure that the benefits of the schemes offered under Poshan 2.0 are reached to the target beneficiaries in all the areas including rural and inaccessible areas. She added that field functionaries have been asked to identify the vulnerable sections of the society so as to ensure inclusion of the left out targeted population.

A core component of the training was a detailed exposition of the legal framework provided by the Jammu & Kashmir Panchayati Raj Act, 1989.

Director Panchayati Raj, J&K, Sham Lal, emphasized the transformative objective of the initiative."This training is a cornerstone of our mission to build financially self-reliant and Atma-Nirbhar Panchayats," he stated.

He said by empowering our grassroots functionaries with the knowledge to augment and strategically utilize their own



revenue, we are fundamentally strengthening the third tier of governance and accelerating local development tailored to community needs.

Thematic experts from the State Resource Panchayat (SPRC), Centre District Panchayat Resource Centres (DPRC), and the School of Excellence for Panchayati Raj (SoEPR) guided participants the specific provithrough sions, including Sections 13 to 23, which detail the properties, taxation powers, and fund management mechanisms available to Halga Panchayats.

Participants received handson training in the practical aspects of OSR management. This included procedures for levying taxes and fees, maintaining meticulous books of records, and the preparation of a separate, Gram Sabha-approved annual budget for OSR funds.

The curriculum also covered the stringent guidelines for incurring expenditure from OSR, emphasizing financial prudence, transparency, and the prohibition of using these funds for private assets or donations.

To inspire innovative thinking, the workshop showcased best practices and successful case studies from other Indian states, such as the remarkable OSR generation model of Mukundapur Patna Gram Panchayat in Odisha.

These examples highlighted diverse revenue streams, from waste-to-wealth initiatives and eco-tourism to leasing Panchayat assets and imposing user charges for local services.



CS reviews welfare measures taken for J&K's migrant populations

Srinagar, Oct 29: Chief Secretary Atal Dulloo on Wednesday reviewed the progress of key milestones for welfare of the migrant population of J&K in a high-level meeting of the Department of Disaster Management, Relief, Rehabilitation & Reconstruction (DMRR&R) here.

The meeting besides ACS, PWD and Principal Secretary DMRR&R was attended by Commissioner Secretary, Commissioner FCS&CA: GAD; Divisional Secretary, Commissioner, Kashmir; Secretary, IT; Secretary, Law; Development Commissioner (Works); Relief Commissioner; CEO, ERA and other concerned officers.

The meeting reviewed the implementation of the Prime Development Minister's (PMDP-2015) and Package measures for improving service delivery to Kashmiri Migrants, Jammu Migrants, and other Displaced Persons (DPs).

The Chief Secretary reviewed the physical and financial progress of Transit Accommodations under construction across the Kashmir Valley. Expressing concern over earlier delays, he directed the Department to ensure strict adherence to



revised timelines for all ongoing projects.

Against the target of 688 flats for the July–September 2025 quarter, 248 units have been completed. The meeting noted that 881 PM Package employees have been handed possession so far, with additional allotments to be made upon completion of critical allied infrastructure such as boundary walls, internal roads, security pickets, and basic amenities.

To optimize utilization, the Department is examining revised allotment criteria to ensure effective use of around 1,600 un-allotted flats at select transit sites. New projects are also being initiated, including a proposed migrant housing cluster at Village Dhar Dharchon, Jammu, where feasibility studies are underway.

A major infrastructure milestone in the shape of construction of the Community Hall at Mini Township Jagti, Jammuis progressing steadily and is expected to be completed by March 31, 2026.

The meeting finalized measures to enhance the welfare ecosystem for registered migrants. This includes integration of approximately 48,000 migrant ration cards with the National Food Security Act (NFSA) database through the SMART PDS Portal, operational since August 22, 2025. Over 4,500 cards have already been integrated, with special camps being organized to expedite the process.

For comprehensive enrollment under Ayushman Bharat Sehat Scheme, the Relief Organization has launched a Pan-India outreach initiative. A successful camp held in the Delhi NCR region (October 12–19) registered more than 400 new families, while further camps are planned in Mumbai, Pune, Bengaluru, and Chandigarh beginning October 24, 2025.

A Technical Appraisal Committee under the General Administration Department (GAD) has been constituted to vet the DPR for a new Integrated Online Services Portal. The platform will digitize migrant and DP records while offering endto-end online services through

the Relief Organisation. Further, a feedback mechanism has been added to the RRCM Portal for migrants to record remarks on property grievance reports submitted by District Magistrates. The Divisional Commissioner, Kashmir, will conduct random verification of at least 50 grievances per district per month to ensure authenticity.

In a governance reform measure, powers for issuing EWS, RBA, and Domicile Registration Certificates have been delegated to ensure prompt service delivery under the J&K Public Service Guarantee Act, 2011.

The employment component of PMDP remains a major priority, with 5,880 appointments (98%) completed against the sanctioned strength of 6,000 posts. The remaining vacancies are under active follow-up with the J&K Services Selection Board (JKSSB) and concerned departments for early advertisement and filling up.

Modi 'tough as hell', says Donald Trump

US President once again claims credit for ending Indo-Pak conflict

Tokyo/Seoul, Oct 29: On the one hand, he praised Prime Minister Narendra Modi as the "nicest looking guy", a "killer" and "tough as hell". But in the same breath, Donald Trump once again waded into India-Pakistan conflict by claiming he stopped their recent military hostilities.

Thunder

A few hours earlier, the US president also claimed that "seven brand new" planes were shot down in the May 7-10 Operation Sindoor.

"Prime Minister Modi is the nicest looking guy ... he looks like you'd like to have your father like... he's a killer... he's tough as hell," Trump said while speaking at the APEC (Asia-Pacific Economic Cooperation) CEO Summit in Gyeongju, South Korea. He landed in South Korea Wednesday morning from Japan as part of three-nation tour of Asia.

While emphasising that he has a "great relationship" with Modi, Trump reiterated that he used trade to resolve the war between India and Pakistan. "I called Prime Minister Modi. I said, we can't make a trade deal with you... (He said) No. no. we must make a trade... I said, No, we can't. You are starting a war with



Pakistan. We're not going to do it," Trump said.

He also praised Pakistan's army chief Field Marshal Asim Munir, calling him "a great fighter" and "a great guy."

Then I called Pakistan. I said, we're not going to do trade with you because you're fighting with India and you know, two nuclear nations. And they said, no, no, no, you should let us fight. They both said that," he added.

Trump claimed that the leaders of both India and Pakistan called him after two days and stopped fighting.

"After literally two days, they called up, they said, we understand, and they stopped fighting. How is that? Isn't that amazing? Now, you think Biden would have done that?" Trump said.

However, hours earlier in Tokyo, Trump had said that he managed to get the war stopped in 24 hours. The US president is known to make inconsistent comments.

In Tokyo, while speaking at a reception and dinner with business leaders on Tuesday, Trump said: "Seven planes were shot down, seven brand



Centre plans Rs 1 trillion bailout for debt-ridden power discoms

Pushes for privatisation

New Delhi, Oct 29: India is considering a bailout exceeding 1 trillion rupees (\$12 billion) for debt-laden state-run power distribution companies.

To receive the bailout funds, the states will be required to privatise their electric utilities and transfer managerial control or keep control but list them on a stock exchange, according to three government officials and a document outlining the plan prepared by the Indian Ministry of Power.

The plan marks Prime Minister Narendra Modi's toughest reform push yet to overhaul the chronically inefficient state-run electricity distribution companies, seen as the weakest link in India's energy chain. The Power Ministry and the Ministry of Finance are discussing the final details of the bailout, with an announcement expected in the February budget, said two of the government sources. The ministries did not immediately respond to Reuters' requests for comments. Under the proposal, at least 20 per cent of the state's total power consumption must be met by private companies and the states must assume part of the retailer's debt, according to the Power Ministry presentation. To do so the states can choose to privatise their distribution operations for access to loans to pay off existing debt under two options.

First, the states can create a new distribution company, divest 51 per cent of the equity, which will enable them to access a 50-year interest-free loan for the privatised company's debt, along with access to low-interest federal loans for five years, the presentation showed.

The second option would let states privatise up to 26 per cent of the equity of an existing stateowned power distribution company in exchange for access to low-interest loans from the federal government for five years, showed.

Alternatively, states that do not decide to transfer managerial control through privatisation must list their utilities on a recognised stock exchange within three years.

States that choose to list would receive low-interest loans from the federal government for infrastructure management, the presentation showed.

Debt and losses

The state power retailers have accumulated losses of 7.08 trillion rupees (\$80.6 billion) and outstanding debt of 7.42 trillion rupees (\$84.4 billion) as of March 2024, the document

Despite three federal bailouts worth billions of dollars over two decades, state-run power distributors remain financially strained, unable to recover costs due to deeply subsidised tariffs.

Private companies such as Adani Power, Reliance Power, Tata Power, CESC and Torrent Power are expected to benefit from the reforms as they are likely to gain stakes in the state companies.

Past efforts to privatise India's state-run power distribution firms have faced resistance from employees and opposition parties, which has stalled reforms. "Privatisation is much needed to improve both financial and operational metrics of many power distribution companies. However, this move could face some resistance and will require strong political will," said Debabrat Ghosh, Head of India,

Aurora Energy.
Only a handful of distribution zones — including national capital Delhi and industrial states like Maharashtra and Gujarat - are privatised.

The government is working on amending the law in the next parliament session to allow private firms to use existing state-

Delhi HC refuses to entertain PIL seeking appointment of non-Muslims, non-Sikhs as minority panel chief

New Delhi, Oct 29: The Delhi High Court on Wednesday refused to entertain a plea seeking the appointment of members of minority communities other than Muslims and Sikhs as chairperson of the National Commission for Minorities (NCM).

A bench of Chief Justice DK Upadhyay and Justice Tushar Rao Gedela granted the petitioner opportunity to approach the government with his plea.

The bench observed that the NCM Act mandates inclusion of members from minority communities in the commission. but does not require the appointment of individuals from any specific community

'Section 3 of the act only provided that the commission shall consist of a

chairperson, vice chairperson, and five members. The act does not provide that the commission shall comprise all the members belonging to minority communities. The only provision is that five members, including the chairperson, shall be among the minority communities. The provision does not provide that the members or the chairperson shall be from a particular minority community," the bench said.

The bench directed the authorities concerned to consider the representation if it was made by the petitioner on the issue.

The petition claimed that out that of the 16 chairpersons appointed so far, 14 have been Muslims and two Sikhs.

It claimed that there has been no representation of the members of other minority communities, such as Christians, Buddhists, Zoroastrians, and Jains.

Stroke is no longer old age problem

Doctor reveals how stress along with these habits raise your risk

New Delhi, Oct 29: This World Stroke Day, I'd like to highlight a conversation that is increasingly taking place in my clinic. Most people's perception of a stroke is an older individual and maybe someone with a long history of high blood pressure or diabetes. But I am noticing a disturbing trend, which is younger patients aged in their 30s and 40s, who are increasingly coming to the emergency department with a "brain attack."

What has changed? Our traditional risk factors of smoking, unhealthy diet, and high blood pressure remain relevant and remain bad for us. Now they are being perilously augmented by one of three probable contemporary trigger factors: chronic stress, more screen time, and a very sedentary lifestyle.

Arms: Can you lift both arms or does one fall? Speech: Is speech slurred? Does it feel Time: It is time to call emergency services

Trump, Xi to meet in S Korea; talks to focus on US-China strategic, long-term issues: Beijing

Beijing, Oct 29: US President Donald Trump and his Chinese counterpart Xi Jinping will meet on Thursday in South Korea and exchange views on strategic and longterm bilateral issues, the Chinese foreign ministry announced on Wednesday.

The two leaders will meet on the sidelines of the Asia-Pacific Economic Cooperation (APEC) summit in Busan.

As agreed between China and the US, President Xi will meet with President Trump to exchange views on bilateral relations and issues of mutual interest, a Chinese foreign ministry spokesperson Gou Jiakun told a media briefing here.

"We are willing to work with the US side to promote this meeting to yield positive results, provide new guidance and to inject new momentum for the stable development of China-US relations," Gou said.

He added that headof-state diplomacy plays an irreplaceable strategic

guiding role in China-US relations, which are currently bogged down over Trump's massive trade tariffs against Chinese exports and Beijing's retaliatory actions.

At the meeting, the two heads of state will have in-depth discussions on strategic and long-term issues concerning China-US relations, as well as major issues of mutual concern.

This is their first meeting after Trump's second term in office and comes in the backdrop of a massive trade war between the world's top two

High on the agenda is the formalisation of an agreement for the sale of China's top social media app TikTok to designated American firms, as well as the resumption of rare-earth metals exports, the much-needed key component of dual-use technologies needed for the manufacturing of various items, from mobile phones to defence equipment, blocked by China.

For its part, Beijing wants Washington to lift the Kong-based South China

restrictions on the exports of semiconductor chips needed for the development and expansion of AI-related technology in China.

Xi and Trump spoke over the phone recently and finalised the contours of a trade deal to normalise trade ties.

Speaking to reporters aboard Air Force One on Wednesday morning, Trump said he expected to discuss with Xi fentanyl flows into the US to address the drug menace and American farm exports to China.

Trump's remarks followed a Wall Street Journal report on Tuesday suggesting that Washington might reduce the 20 per cent fentanyl-related tariffs on Chinese exports by half in exchange for Beijing's crackdown on the export of chemicals used to produce

"I expect to be lowering that because I believe that they're gonna help us with the fentanyl situation," Trump said on Wednesday, the Hong

"They're gonna be doing what they could do." Answering media questions regarding fentanyl, Guo said Beijing had provided help in this regard with positive results and was "open to continuing

cooperation".
"The US should take concrete actions to create the necessary conditions for cooperation," added Guo, calling China's stance on the issue consistent and clear.

When asked about a possible one-year pause in Beijing's rare earth export controls and whether it could lead to further concessions, Trump said: "We haven't talked about the timing yet, but we're gonna work out something." Trump voiced optimism about reaching a "great deal" with China in his talks with Xi as he spoke to business executives on the sidelines of the APEC summit.

Trump said he believed a deal would benefit both the US and China and be "something very exciting for everybody".

Reduced US military presence in Europe an 'adjustment': NATO

Brussel, Oct 29: NATO said Wednesday it had been informed in advance of US plans to reduce some of its troops deployed on the alliance's eastern flank, describing the move as an "adjustment" and nothing "unusual."
Washington's com-

mitment to the alliance remained "clear" and its presence in Europe sizeable, a NATO offi-cial told AFP. "Even with this adjustment, the US force posture in Europe remains larger than it has been for many years, with many more US forces on the continent than before 2022," the official said.

The US has been expected to announce drawdowns in Europe following a review of its military deployments worldwide — but no move has been officially communicated yet.

Romania's defense ministry however previewed the scale-down



Wednesday, saying Washington was to halt the rotation of a brigade that had elements in several NATO countries, including Bulgaria, Romania, Slovakia and

The prospect of a US pullout is fraying the nerves of allies, especially given fears that Russia could look to attack a NATO country within the next few years if the war in Ukraine dies down.

downplayed the significance of the planned US

reduction in personnel. "The US commitment to NATO is clear," the official said.

"NATO has robust defense plans in place and we are working to ensure we maintain the right forces and capabilities to deter potential aggression and provide for our collective defense.'

Rohit Sharma becomes No. 1 ranked ODI batter for first time



Dubai. Oct 29: Former India skipper Rohit Sharma on Wednesday (October 29, 2025) claimed the top spot in the ICC Men's ODI batter rankings for the first time in his distinguished career.

The 38-year-old Rohit created history as he rose two spots on the back of his unbeaten century and final ODI between India and Australia in Sydney, where he led his side to an emphatic nine-wicket triumph in style. The experienced

right-hander was in a damaging mood alongside fellow India legend Virat Kohli (74 not out) as he smashed 13 fours and three massive sixes on his way to scoring his 33rd ODI century for his

Rohit's efforts see him overtake Afghanistan dasher Ibrahim Zadran and India teammate Shubman Gill and claim the top ranking for batters in ODI cricket for the very first time, having always held a spot inside the top 10 for the majority of the last decade.

India condemns 'blinkered' UN report, calls for inclusive political dialogue in Myanmar

United Nations, Oct 29: India has strongly condemned what it described as a "blinkered analysis" made against it in a United Nations report on Myanmar's human rights situation, even as it reiterated its call for an immediate cessation of violence and inclusive political dialogue in the neighbouring country.

Delivering India's statement during the Interactive Dialogue on the human rights situation in Myanmar at the Third Committee of the UN General Assembly on Tuesday, Lok Sabha MP Dilip Saikia said New Delhi continues to support all ing trust and advancing "Myanmar-owned and Myanmar-led path" toward peace, stability, and democracy. "We

position calling for an immediate cessation of violence, release of political prisoners, unhindered delivery of humanitarian assistance and inclusive political dialogue," he

The UN's Third Committee, which deals with human rights and humanitarian issues, was debating the worsening situation in Myanmar following the 2021 military coup and ongoing violence between the junta and resistance forces.

Saikia, who is part of a multi-party delegation led by BJP MP Daggubati Purandeswari to represent India at the 80th United Nations General Assembly, said India has "consistently emphasised a people-centric approach" in its engagement with Myanmar.

Strongly criticising



the remarks made by the **UN Special Rapporteur** against India in its report on Myanmar's human rights situation, he said, "I express serious objections to the baseless and biased observation in the report regarding my country."

Saikia said the claim linking the April 2025 terwith displaced persons from Myanmar has absolutely no factual bearing. "My country rejects such prejudice and blinkered

analysis by the Special Rapporteur," he said.

The parliamentarian stressed that the deteriorating security and humanitarian situation in Myanmar remains a "matter of deep concern" for India, particularly because of its "cross-border implications," including the challenges posed by "transnational crimes such as drug, arms, and human trafficking."

He cautioned that India has observed an

"alarming level of radicalisation" among some displaced persons, leading to "pressure and impact on the law and order

Urging the UN expert not to rely on "unverified and skewed media reports whose sole purpose appears to be maligning" India, Mr. Saikia underscored that the country is home to over 200 million Muslims. which is about 10% of the world's Muslim population, living in harmony

with people of all faiths. Citing recent examples, the BJP MP from Darrang-Údalguri in Assam, noted that following the March 2025 earthquake, India promptly launched patching over 1,000 metric tonnes of relief materials and deploying medical teams as the first responder.

Israel def min warns Hamas leadership will have no immunity

Jerusalem, Oct 29: Israeli Defense Minister Israel Katz warned Hamas leaders on Wednesday that they would have no immunity after a wave of Israeli air strikes on Gaza that followed an attack on its troops.

"There will be no immunity for anyone in the leadership of the terrorist organization Hamas — neither for those in suits nor for those hiding in tunnels," Katz said, referring to several Hamas political leaders residing in Doha.

"Whoever raises a hand against an (Israeli) soldier, his hand will be severed. The (Israeli military) has been instructed to act decisively against every Hamas target and will continue to do so."

Qatar has played a key mediating role in indirect talks between Israel and Hamas since the outbreak of the war in October 2023, and is among the guarantors of the United States and Turkiye.

On September 9, Israel attacked Hamas negotiators in Doha, triggering widespread condemnation and drawing a rebuke from US President Donald Trump.
