

Op Sindoor aimed only at terrorists: Army Chief

'Strikes avoided civilians, focused on destroying Pak-based terror hideouts'

Srinagar, Nov 01: Army Chief General Upendra Dwivedi on Saturday said that India, during Operation Sindoor, targeted only terrorist bases in Pakistan and avoided civilian or military installations.

He said the operation was conducted with precision, guided by the principles that define India's military conduct.

"Operation Sindoor was successful because we fought with the combined strength of our principles and technology. We made it a point that no innocent civilians in Pakistan suffered. We only targeted terrorists and their bosses," General Dwivedi said while speaking to reporters after attending an event at his alma mater, Rewa Sainik School, during the All India Sainik Schools National Games 2025, as per the news agency-Kashmir News Observer (KNO).

He urged citizens to contribute to nation-building and help achieve the goal of a developed India by 2047.

He said the armed forces ensured that no action was carried out during prayer hours. "We attacked only places that had the presence of terrorists. We did not target innocent civilians



defence installations. We achieved our goal in Operation Sindoor and sent a message to Pakistan that we are not like them," he added.

Operation Sindoor was launched on May 7 in response to the April 22 Pahalgam terror attack, which killed several civilians.

The operation targeted terrorist hideouts located in territories under Pakistan's control. The airstrikes and counter-attacks continued for four days before both sides agreed to halt military actions on May 10. General Dwivedi said

Operation Sindoor remains active and will continue until the Army considers its objectives fully met.

'Saffron town sees 90% dip in production'

Srinagar, Nov 01: Kashmir's famed saffron sector is once again staring at a severe crisis, with growers warning that this year's output has plunged by nearly 90 per cent.

Thunder

Farmers in Pampore, known as the "Saffron Bowl of Kashmir" say that production this season is barely 10–15 per cent of normal levels, pushing thousands of families into economic distress.

Growers concern that if corrective measures are not taken immediately, the crop, which has defined Kashmir's identity for centuries may vanish.

"This year the corms haven't sprouted properly at all," said Abdul Majeed Wani, president of the Saffron Growers Associa-

He said, "Production is hardly 15 per cent. It isn't even half of last year's crop, which itself was only about 30 per cent of the normal harvest. Every year it is decreasing, and the government doesn't tor." Wani said the main problem lies in irrigation, and the poor quality of corms



seem serious about safeguarding this sec- repeated long dry spells, lack of effective

The growers have appealed to Chief Minister Omar Abdullah and the Agriculture Minister to personally intervene and take emergency steps. They demanded immediate irrigation facilities, regular monitoring of saffron meadows, measures to stop illegal extraction and selling corms, and availability of quality corms for fresh replantation

The area under saffron cultivation in Kashmir has shrunk from 5,707 hectares in 1996-97 to just 2,387 hectares in 2019-2020 — a reduction of 65 per cent.

Government data shows that production fell from 17.33 metric tonnes in 2021 to 14.87 MT in 2022, and marginally rose to 14.94 MT in 2023. However, last year's output has been reported to be only around 30

per cent of normal production. However, growers argue these figures do not reflect the reality at ground level.

According to them, last year's real output was barely 20 per cent of an average harvest

and this year they expect similar or worse output.

While the National Mission on Saffron (NMS) has revived some fields through sprinkler irrigation systems and farmer awareness programs, experts caution that the impact remains limited. "The siphoning off of corms and poor land management practices continue to negate the gains achieved under the mission," said an agricultural scientist from SKUAST-K.

Pampore's saffron - prized globally for its deep colour, aromatic thread, and medicinal value - has been more than just a crop for the region. It has been a cultural marker and a source of livelihood for thousands of

"Revival of saffron isn't just about saving a crop; it's about preserving a tradition, a culture, and an identity," said a group of distressed growers from Pampore. "If immediate and effective measures aren't taken, by 2030 there may be no saffron left in Pampore."—(KNO)

He added that several bridges and roads, including Sanat Nagar and Qamarwari, remained incomplete for years. "What BJP and PDP couldn't finish in 11 years, we will complete in five years," he said, adding that the present government inherited a "huge backlog" and is working to complete pending works along with new commitments.

The Deputy Chief Minister asked the media to highlight the government's sincerity and development work instead of "propaganda by previous regimes."

Reacting to Lieutenant Governor Manoj Sinha's comments regarding statehood and governance, he said the elected government must be given full authority.

"LG Sahib should not confuse people. If an elected government doesn't even get protocol and officers don't stand with the cabinet, then how can you say we have full powers? Files and administration are still controlled. We do not want confrontation, but constitutional positions should remain non-political," he said. He said Jammu & Kashmir has limited resources as a Union Territory and reiterated the demand for restoration of statehood, land and job safeguards and strengthening democratic institutions.

'One among five suffering from PCOS'

Prof Mohd Ashraf Ganie on Saturday presented a study revealing that nearly one in five women in India is affected by Polycystic Ovary Syndrome (PCOS).

During the "Research Dissemination Meet", he presented findings from a PCOS Task Force study, revealing that approximately 19% of Indian women suffer from this metabolic disorder, which is closely linked to lifestyle diseases such as diabetes, hypertension, and obesity.

SKIMS Soura launched a new monthly feature dedicated to disseminating research findings to promote awareness and share research insights with the community. This initiative began with the results of an ICMR-supported Phase 1 study on PCOS.

and involved 9,824 women aged 18 to 40 across India found that the prevalence of PCOS varied depending on the diagnostic criteria used.

According to the NIH 1990 criteria, the prevalence was 7.2%, while the AE-PCOS 2009 criteria showed a prevalence of 13.6%, and the Rotterdam 2003 criteria indicated a rate of 19.6%. Phenotype C was identified as the most common, accounting for 40.8%

The study also highlighted significant metabolic comorbidities among women with PCOS; 43.2% were obese, 91.9% had dyslipidaemia, 32.9% suffered from non-alcoholic fatty liver disease (NAFLD), and 24.9% had metabolic syndrome. Additionally, 3.4% had diabetes, and 8.3% experienced hypertension.—(KNO)

CM gets annoyed for good governance demands: LoP Sharma

Sharma while talking to reporters said that there should be no excuses for not fulfilling the poll promises made by the ruling National Conference. "The Chief Minister and his government cannot hide behind the rhetoric. You contested elections in the Union Territory. Everyone knows it. You have full authority and the right to work. You should work for the people. Why does it bother you?" Sharma asked. He said that whenever

someone tells the government to do its job, it gets angry and defensive.



"They always get angry. They never respond with an argument or a technical explanation. They just react with anger because they feel exposed. Whenever they are reminded of their promises or duties, it troubles them," Sharma said.

He said that the Chief Minister cannot use the Pahalgam terror attack as an excuse for governance failure. "Those responsible for that barbaric act have been punished. There is no doubt that the situation there is better. But if you are held responsible for making

people suffer due to electricity shortages, rising corruption, or scarcity of gas cylinders, then using the Pahalgam carnage as a cover makes no sense. This does not mean you will do nothing," Sharma said. He added that the securi-

ty forces and agencies have done their job in maintaining peace and deserve full credit for that. "But those responsible for governance are not doing their job. The poor are suffering. I have said this many times. There is no doubt about it," Sharma

CM's advisor urges GoI to restore statehood

Srinagar, Nov 01: Jammu and Kashmir Chief Minister's Advisor, Nasir Aslam Wani, on Saturday said the central government must respect the mandate given by the people of the region to the National Conference (NC) by restoring statehood as promised to them. He accused the successive regimes of ignoring Srinagar for being the "bastion" of the NC.

Addressing a gathering in Srinagar, Wani said, "Earlier, there was an opposition, but now we have a non-elected opposition that claims the government has enough powers to deliver. Wani said Omar Abdullah, after taking over as Chief Minister again last year, reviewed the ongoing and stalled works in Srinagar.

Referring to the Qamarwari

Bridge, he said the project was inaugurated after 14 years. "Similarly, Boulevard Road has been witnessing congestion, which has left the local populace irked. "However, the government is making efforts to decongest the road," he said.

The CM's Advisor further said, "Mere Smart City thinking won't do." He added that the Omar Abdullah-led government, along

with the efforts of Deputy Chief Minister Surinder Kumar Čhoudhary, will ensure developmental

projects in Srinagar. Apparently reacting to the statement of Lieutenant Governor Manoj Sinha, Wani said, "Everybody is out to give sermons to us, but they don't even bother to think about what they have done. Our political opponents fought elections against the BJP and later joined hands with them, which resulted in the abrogation of Articles 370 and 35A, and the snatching of statehood.'

He said the NC has fought elections against "divisive" political parties. "We will always remain away from them and won't join hands with them. We will continue to work

for the people," he said. The CM's Advisor said that development and employment initiatives will continue and the government will fulfil all promises over the next four years. "The people need to be patient. Our major fight is to get statehood back. The people should stand shoulder to shoulder with this government in this fight," he

Let There Be Dark

The greatest ally of the modern tribe of the illusionist — statesmen, politicians — is luminosity. Because light, not dark, helps dazzle the eyes, deflecting attention from this age's injustices.

or a technology that is expected to enslave humanity, the AI algorithm — the elixir of social media platforms — can be touchingly predictable. Each year, around Dashami – the day fell earlier this month – Facebook and Instagram dutifully churn out versions of Gaganendranath Tagore's iconic Visarjan: a little more enterprise and inventiveness — are these traits not supposed to be the algorithm's forte? — could have led the technology to resurrect other vintage artworks exploring a similar theme; The Durga Puja Being Celebrated on the River Hugli, George Gidley Palmer's equally engrossing depiction of a visarjan, perhaps demands a

similar afterlife on social media. The algorithm's dumbness does not deserve commentary. But a shared – fascinating - detail in the paintings of Gaganendranath and Palmer merits introspection. Even a cursory look at the two artworks will reveal the hypnotic appeal of luminescence to the human eye. In each painting, the deity gets transformed, literally and metaphorically, into an orb of light that seems to keep at bay the gathering, inky gloom. The symbolic message is clear: divine light holding out

hope amidst the dark. This positing of light as adversarial to darkness – the supposed realm of all that is evil, sinister; a shadow land that eludes reason and understanding – can, of course, be traced back to a much older evolutionary and theological arc — anxiety — whose imprint remains deeply etched in not only humanity's creative pursuits but also social order. The discomfiture with



Othello and Caliban, the horrors associated with the dark, brooding woods in Gothic fairy tales and with that bloodthirsty Transylvanian Count, Emily Brontë's Heathcliff — his eyes like "black fiends" — Charlotte Brontë's Mrs Rochester, of Creole blood, whose majesty gives way to madness, Goya's depiction of the dark as the sphere of primordial fear and, of course, Charles Marlow's reminiscences of and struggles — physical and spiritual — with the Heart of Darkness find their perfect echoes, on the other side of the cultural sphere, in the Oriental world, in the yakshis and rakshasas of Indian myth as well as in the leyak of Bali's fables, a practitioner of the dark arts that flies with its entrails tailing it - these and many other elements in literature, art and folklore embody an instinctive, collective inclination to demonise darkness.

It would be a travesty to frame the human predisposition towards light — and all that is not dark — as innocent. As Nina Edwards writes in her book, Darkness: A Cultural History, race and gender have been the principal social registers of the prejudice against the constituency of the dark. The stubborn malaise of looking down on those with a dark countenance — be it in a supposedly decolonised East, including India, or in America, where Black people continue to suffer the most egregious forms of social, economic and cultural violence — throws light upon this dark truth.

Given this history, the tendency to view light and darkness as conflicting binaries may appear to be natural and, thus, universal. Yet, the ideas of light and darkness are not always immutable; their supposed animosity has, at times, given way to intriguing alliances, responding to shifts in the intellectual and the cultural milieu. Consider the delicious irony in the shakto tradition of Bengal, where deepavali, the festival of lights to ward

off darkness, has, at its centre, the worship of a fierce, ebony woman. Italy, during the Renaissance, mesmerised the world by developing the artistic technique called chiar-oscuro — light-dark — that enabled artists to create three-dimensional forms by employing sharp contrasts between light and dark.

Indeed, modern scholarship and intellectual thought, responding to questions of racial bigotry, have, in defiance, claimed that the muchreviled trope of darkness, in fact, contains an emancipatory blaze. In a piece for The New York Times Magazine, Teju Cole mentions the reflections on the word, 'opacity', by Édouard Glissant, a French philosopher, one of the canons in Caribbean thought and literature. The opaque, being resistant to illumination, transparency, has linguistic and moral associations with concealment, furtiveness. But Glissant locates in opacity – the state of being unlit, a kind of darkness — the right of the marginalised — Black, Creole, Coloured and perhaps even indentured people — to not be under-

stood, simplified, catalogued, explained. Nina Edwards, too, provides a unique example from mundane, everyday objects of the dark being an embodiment of righteous resistance. The dark tint of the sunglass, integral to fashion and a marker of social status, she writes, serves, for the wearer, a dual function: it protects the user from scrutiny, thereby becoming an appendage to secure anonymity, privacy, in a heavily surveilled world without impeding the user's ability the right — to look back at, confront, scrutinise the world outside. Edwards thus argues that the sunglass is an ally in the wearer's subversive endeavour to be simultaneously

anonymous and confrontational.

There is then darkness's enduring aesthetic appeal — and not just in the world of fashion. Junichiro Tanizaki, a pre-eminent voice in modern Japanese literature, read in Japan's enchantment — entrapment — with illumination its capitulation to a problematic Western modernity and affiliated consumption. He writes, poignantly, about once venturing out to witness the autumnal moonviewing ceremony, only to discover that electric light in five colours had devoured the fainter, but far more beautiful, lunar lustre.

Today, Tanizaki's beloved "pensive shadows" are in retreat all around the world. The World Bank and its partners have even begun to measure night-time light as an actual metric for development, leading to the metamorphosis of artificial light into a proxy for economic enlightenment. Never mind the consequences on worlds natural and human: migratory birds, sea turtles and insects veering off their course, blinded by the light; disruptions in sleep and reproductive cycles of both animals and humans; the crude flooding of the night sky with artifice that bedazzles, leading entire societies to lose their ability to appreciate, aesthetically, a nocturnal sky washed in the mellow light of stars and galaxies.

There is a peril in light continuing to devour the dark. The greatest ally of the modern tribe of the illusionist – statesmen, politicians, Wall Street wizards, Big Tech bosses, to name a few − is luminosity. Because light − not dark helps dazzle the eyes, deflecting attention from this age's great iniquities and injustices.

The PCCF also released two booklets viz. "CAMPA Success stories, The Seeds of Hope" and "Forest Fire Management Plan of JV Forest Division".

Speaking on the occasion, he highlighted the significance of Compensatory Afforestation Management and Funding Agency (CAMPA) in Rehabilitation of degraded forests, Soil and moisture conservation practices, Forest Fire Management, Human Wildlife Conflict management, Conservation of protected areas and Biodiversity projects. PCCF directed the implementing agencies to



prepare APOs as per the CAMPA guidelines.

Chief Conservator Forests (CCF), Kashmir, Irfan Rasool Wani in his address highlighted the achievements made under CAMPA since its inception in the year 2010-11. He inferred that under CAMPA 18000 hectares of degraded forest land has been treated so far with planting of 2.25 crore quality saplings. 71 PMGSY projects completed in Kishtwar, work on 46 in progress

KISHTWAR, NOVEMBER 01: Deputy Commissioner Kishtwar, Pankaj Kumar Sharma Saturday chaired a comprehensive review meeting to assess the progress of road infrastructure projects being executed under the Pradhan Mantri Gram Sadak Yojana (PMGSY) across all subdivisions of the district.

During the meeting, the Executive Engineers (PMGSY) briefed the Deputy Commissioner on the current status, physical achievements and challenges encountered in the execution of various projects. A detailed PowerPoint presentation was also given outlining project-wise progress and timelines.

It was informed that in Division Kishtwar, out of 99 sanctioned projects, 58 have been completed, while work on 41 are in progress. In Marwah Division, 13 out of 21 schemes are complete and work on 5 others is underway.

The DC took a detailed review of the road projects taken up under different phases of PMGSY implementation, including the road projects from Gahan to Chandali, Ikhala to Lopara, Margi to Sukhnai, Cherji to Semna Bhata, Hidyal to Hargadi, Afani to Jar, Shashoo to Sazar, Shiwas to Ongayee, Atholi to Palali and Kandni to Ohli, among others. The progress of bridge projects taken up under the scheme was also reviewed.

The Deputy Commissioner directed the PMGSY engineers to ensure timely completion of all works while maintaining strict quality standards. He directed them to take disciplinary action, including blacklisting against non-performing contractors. He directed the Engineers to submit

the list of contractors who have abandoned or delayed works, so that appropriate action can be initiated against them.

Emphasizing the importance of environmental protection, the DC directed the Executive Engineers to ensure proper disposal of muck at identified locations to avoid any damage to forest areas during the construction.

He strictly directed to safeguard forest land during the execution of works and stressed the need to undertake plantation drives along road alignments to maintain ecological balance.

US urges ASEAN to be firm in countering China in the South China Sea

Kuala Lumpur, Nov 01: US Defense Secretary Pete Hegseth on Saturday urged Southeast Asian nations to stand firm and strengthen their maritime forces to counter China's increasingly "destabilizing" actions in the South China Sea.

Speaking at a meeting in Malaysia with his counterparts from the Association of Southeast Asian Nations, Hegseth reiterated US concern over what he called China's aggression in the disputed waters that intensified in recent months, citing incidents such as ramming of vessels and the use of water cannons.

The South China Sea remains one of Asia's most volatile flashpoints. Beijing claims almost the entire region, while ASEAN members the Philippines, Vietnam, Malaysia and Brunei also claim ownership of coastal areas and features. The Philippines, a key US ally, has had frequent clashes with China's maritime fleet.

Manila has repeatedly urged stronger regional response, but ASEAN has traditionally sought to balance caution with economic ties to Beijing, the region's largest trading partner. Hegseth criticized Beijing's recent declaration of Scarborough Shoal, which China forcefully seized from the Philippines in 2012, as a "nature reserve."

"You don't put platforms on nature reserves," he said, describing China's activities on the uninhabited shoal. He told the meeting it was "yet another attempt to coerce new and expanded territorial and maritime claims at your expense."

Hegseth said China's provocative actions challenged and threatened territorial sovereignty in the region. While stressing that Washington values continued dialogue with Beijing, Hegseth said the US will monitor China's behavior closely.

Navi Mumbai, Nov 01: India women's skipper Harmanpreet Kaur on Saturday welcomed the unusual "pressure" of arranging tickets for their World Cup final against South Africa here, calling it a positive sign for the game's growth.

The demands and requests for players to arrange tickets for matches have been a constant with the men's team, and Harmanpreet said she and her teammates were now experiencing something similar after pulling off a record chase to oust seven-time champions Australia.

"You know how it is. There are rarely a few days when there's pressure for these things," Harmanpreet told the media on the eve of the final here.

"I think it's good that not only (there is pressure related to) cricket but there is pressure for tickets also," she said.

Recalling India's campaign in the 2017 ODI World Cup, when they finished runners-up to England, the skipper said: "The last time when we reached the finals, after coming back we saw a big change in India. Women's cricket has progressed, and we see a lot of girls on the ground now," she said.

"I'm sure that when we win this final, we will see many more changes and cricket will see more improvements, not only on international level but also on domestic level. We are really looking forward to that moment, where women's cricket will get more seriousness and



more viewership." Following the emotional upheaval of the win against Australia in the semifinal, Harmanpreet and other players have largely focussed on recovery and rest.

"The semifinal was a very

high-pressure game and very intense. After that, recovery was something which we all paid more attention to, because the fresher we are mentally, that is more important." Harmanpreet said.

"Skill-wise, we know we have done a lot and now it's only about keeping ourselves fresh for tomorrow and recovery is something which we all talk about, and everybody is really taking that thing very seriously and hopefully tomorrow we will feel even more fresher for the main game," she added.

Referring to recent heavy rains in Srinagar, Abdullah said the city was on the verge of flooding again. "It didn't even rain for two days, and the embankments started giving way. If it had rained 24 hours more, Srinagar would have drowned," he said.

On traffic congestion along the Boulevard stretch near Dal Lake, Omar said the administration was exploring the construction of a tunnel between Dal Gate and Nehru Park. "We will seek central assistance. If tunnels can be built in Jammu, Poonch and Kishtwar, why not in the heart of Srinagar?" he added.

Reiterating his government's commitment to public welfare, he highlighted schemes like free bus rides for women and said his administration does not discriminate on religious or regional grounds. "We work for rights, not religion, caste or community. Our intention is honest, and we will fulfil our promises," he said.

PM expresses grief over deaths in Andhra Pradesh stampede

New Delhi, Nov 01: Prime Minister Narendra Modi on Saturday expressed grief over the loss of lives in a stampede at the Venkateswara Swamy Temple in Andhra Pradesh's Srikakulam. The Prime Minister's Office (PMO) announced an ex gratia of Rs 2 lakh each for the families of those killed. At least 10 people were killed and many others injured in the stampede that occurred around 11:30 AM. Most of the victims were women, according to officials. "Pained by the stampede in Venkateswara Swamy Temple in Srikakulam, Andhra Pradesh. My thoughts are with those who have lost their near and dear ones. I pray that the injured recover soon," Modi said in a post on X. In a statement, the PMO said an ex gratia of Rs 2 lakh each would be given from the

PM National Relief Fund to the next of kin of those who lost their lives in the tragedy. The injured would be given Rs 50,000, the PMO said.

Raipur, Nov 01: Prime Minister Narendra Modi on Saturday said the number of Maoist-affected districts has fallen to three from 125 in the last 11 years, and the "day is not far" when the whole of Chhattisgarh and the country will be freed from the Naxal menace.

Speaking at 'Chhattisgarh Rajat Mahotsav', the 25th anniversary celebration of the formation of Chhattisgarh in Nava Raipur, he hailed the state's growth journey and said the seed sown 25 years ago has grown into a "vat vriksh" (banyan tree) of development. He

was "deeply satisfied" that Chhattisgarh was breaking free from the clutches of Naxal violence which had caused immense suffering to the state for over five decades, the prime minister said.

"For 50 years, the people here suffered unbearable pain (because of Naxalism). Those who show off the Constitution and shed crocodile tears in the name of social justice have committed injustice to you for vested interests," he said. Maoist ideology deprived tribal regions of basic facilities, the PM said. "For years, tribal villages lacked roads, schools and hospitals. The existing ones were blown up with bombs. Doctors and teachers were killed. Those who ruled the country for decades abandoned you while they enjoyed life in their air-conditioned offices," Modi said. He could not just stand by and watch his tribal brothers and sisters being destroyed by violence, he further said.

"I could not (bear to) see mothers crying for their children. In 2014, when you gave us the opportunity, we resolved to free India from Maoist terror. Today the results are before the nation," Modi said.

Eleven years ago, 125 districts across India were affected by Maoist extremism, but today the number has declined to only three,

he said. "I guarantee that the day is not far when every corner of Chhattisgarh and India will be completely free from Maoist terror," the prime minister added. In the past few months, dozens of Maoists, including many carrying rewards of lakhs and crores of rupees on their heads, have surrendered across the country, Modi noted. "In Kanker, more than 20 Naxalites laid down arms recently. Earlier in October, over 200 Maoists surrendered in Bastar. They have now accepted the Indian Constitution and chosen the path of peace," he said. Where once there was the fear of guns and bombs, the situation has changed, the PM said.

Electricity reached Chikapalli village of Bijapur for the first time in 70 years, while a school opened for the first time since Independence at Rekawaya village in Abujhmad region, he said.

Development work was on in full swing at Puvarti village, once known as a terror hub, and the tricolour flies proudly where the red flag (of the Naxals) once stood, the prime minister said.

"Despite facing the challenge of Naxalism for 25 years, Chhattisgarh kept moving forward. Now, with the end of Naxalism, our pace of development will accel-

Trump seeks clarification on funding food aid during shutdown after court ruling

Asks democrats to 'cut this charade'

Washington, Nov 01: US President Donald Trump has instructed his administration's lawyers to seek clarification on how the government can "legally fund" the food stamp benefits during the shutdown after two US federal judges ruled to tap into the emergency funds to cover benefits for November.

Trump argued that the government do not have the 'legal authority" to pay for the Supplemental Nutrition Assistance Program (SNAP). He urged Democrats to "cut the charade" and "reopen the government.

"Our Governme yers do not think we have the legal authority to pay SNAP with certain monies we have available, and now two Courts have issued conflicting opinions on what we can and cannot do. I do NOT want Americans to go hungry just because the Radical



Democrats refuse to do the how we can legally fund right thing and REOPEN THE SNAP as soon as possible. It NT." Trump said

in a post on Truth Social. He further said, even if he receives immediate guidance from the court, there is still not enough time to provide aid for November.

"Therefore. I have instructed our lawyers to ask the Court to clarify

The rulings by judges in Massachusetts and Rhode Island rejected a claim by the US Department of Agriculture (USDA) that it could not access a contingency fund, which currently holds about USD 5.3 billion, to sustain the Supplemental Nutrition Assistance Program (SNAP). The program, which provides food assistance to low-income households, costs between USD 8 billion and USD 9 billion a month. meaning the available contingency funds would only partially meet November's

needs, CNN reported "There is no doubt that

the contingency funds are appropriated funds necessary to carry out the program's operation," said US District Judge John McConnell in Rhode Island. "The shutdown of the government through funding doesn't do away with SNAP, it just does away with the funding of it," he added during a hearing.

Officials warned that despite the rulings, millions of beneficiaries could face delays, as the Depart-ment of Agriculture and state agencies require time to process and distribute payments, which were originally scheduled to begin on November 1

The SNAP program, a key component of America's food security network, has never failed to distribute benefits during a government shutdown in its decades-long history. However, it came under strain during the 2018-2019 deadlock.

'Jungle raj' will return if RJD comes back to power, says Amit Shah



Patna/Gopalganj, Nov 01: Union Home Amit Shah on Saturday raked up the "high-hand-edness" of Sadhu Yadav, former Bihar CM Rabri Devi's estranged brother, to warn people of the pollbound State that "jungle raj" will come back if RJD returned to power.

Shah, who was scheduled to address an election rally in Gopalganj district, spoke virtually as bad weather prevented him from reaching the venue.

This election is an opportunity to decide who should be entrusted with the future of Bihar. On the one hand are those who had ushered in 'jungle raj'. On the other hand is the duo of Prime Minister Narendra Modi and CM Nitish Kumar, who have brought development," he said. "The people of Gopal-

ganj have never voted for the RJD since 2002. I am sure they will keep up the trend... Nobody knows the misdeeds (kaarnaame) of Sadhu Yadav better than the people of Gopalganj,"

Yadav, who had been both the MLA and the MP from Gopalganj, was known to wield tremendous clout while her sister was the Chief Minister of the state.

One of the incidents blamed on him was forcefully driving away with cars from a showroom during Rabri Devi's eldest daughter Misa Bharti's wedding in 1999. The incident was mentioned by PM Modi at a rally earlier this week, even as he did not name anyone.

Another incident in which Mr. Yadav's name had cropped up was the Shilpi Gautam murder case that took place in the same year. It was recently in the news when Jan Suraaj Partv founder Prashant Kishor alleged the complicity of Samrat Choudhary, then an RJD leader who is now with the BJP and currently the deputy Chief Minister of the state, in the case.

The Home Minister also listed the names of the villages in central Bihar which had made headlines during the RJD rule for massacres that took place in an era when several districts of the state were in the throes of a bloody feud between outlawed Naxal groups and private militias of upper caste landlords.


