Govt launches CM's Scheme for introduction of heritage courses

Revival of 7 heritage craft courses proposed in 15 ITIs, polytechnics

Srinagar, Nov 06: The Government of Jammu and Kashmir, led by Chief Minister Omar Abdullah, has approved the "Chief Minister's Scheme for Introduction of Heritage Courses" aimed at preserving and promoting the rich traditional crafts of J&K through structured vocational education.

As per the Government Order issued by the Department of Skill Development, sanction has been accorded for the continuation and revival of seven heritage craft courses across 25 units with a total intake capacity of 500 students—20 students per unit—across 15 Government İTIs and Polytechnics in Jammu and Kashmir.

Under the scheme, students enrolled in these courses will receive a monthly stipend of ₹1,000, while instructors conducting theory and practical classes will be paid a monthly remuneration of ₹15,000 and ₹12,000, respectively.

The initiative, approved by the Council of Ministers in its meeting chaired by Chief Minister Omar Abdullah was held on October 15, 2025. The decision underscores the government's commitment to safeguarding traditional skills, encouraging youth | More on P6

Power demand increases by nearly 400 MWs Kashmir witnesses peak load of season with 1698 MWs

Srinagar, Nov 06: With the onset of winter, the power demand in Kashmir division has increased by nearly 400 megawatts (MW) in the past month.

An official informed the news agency—Kashmir News Observer (KNO) that over the past month, power demand has risen by nearly 400 MW in addition to the regular supply.

He said that in October, there was a requirement of 1,300-1,400 MW of power in Kashmir division. "However, as of now, there is a peak load of 1,698 MW and an average load of 1,264 MW in Kashmir division," he added.

The official further said that, in the Jammu division, the peak load as of 6 November is 1,117 MW.

Pertinently, KNO reported last month that, with the



present and other planned Power Purchase Agreements (PPAs) or a Transmission Service Agreement (TSA), Jammu and Kashmir are likely to be unable to meet and cater to the power demands of consumers over the next nine years.

Majority of J&K's E-buses grounded due to maintenance costs, staff shortage

Over half of Jammu's electric fleet out of service for months Officials in talks with Tata Motors to replace costly compressors

Jammu, Nov 06: A significant portion of Jammu and Kashmir Road Transport Corporation's electric bus fleet has gone off the roads, with officials confirming that more than half of the e-buses operating in Jammu city have been grounded for months due to high maintenance costs and a lack of mechanical staff.

As per the reports obtained by the news agency-Kashmir News Observer (KNO), IKSRTC operates 20 electric buses in

Over ten have been lying

idle in the yard for almost a year. Most have faulty compressors. Some have flat tyres.

According to employees, many of these faults were not attended to on time, which pushed the buses out of service and turned them into

JKSRTC had purchased 40 e-buses from Tata Motors in 2019, with 20 allocated to Jammu and 20 to Srinagar. Six years later, as per the official sources, the fleet in Jammu is facing serious operational problems

Officials said the compressors needed for these buses



must be supplied by Tata Motors. Each compressor costs between five and six lakh

rupees. The corporation is now in talks with Tata Motors to install the newer compressors that are used in the company's latest electric buses. These new compressors cost less than the older models. Officials believe the buses can return to service once the replacements arrive.

A JKRTC employee said the number of running buses has dropped sharply. "Only eight to ten buses are currently operating," he said. "Earlier, these buses covered regular city routes. Now, with many grounded, the frequency has reduced.

Rural routes are also affected. The buses that serve villages are making only one trip a day due to the shortage.

The grounding of these buses contrasts sharply with the government's new plan to expand electric mobility in Jammu and

Kashmir. In September, the administration announced that Jammu and Srinagar would each receive one hundred additional electric buses under a new batch.

At present, the Union Territory runs a fleet of two hundred electric buses, split equally between the two cities. These were introduced in January 2024, when Union Home Minister Amit Shah in-

augurated the fleet. The Jammu administration has submitted a proposal to the Ministry of Housing and Urban Affairs for two hundred more electric | More on P6

436 functional units have been established covering 7,156 kanals of land, with an overall approval rate of 54% in Jammu and 47% in Kashmir divisions.

To enhance awareness and build capacity among target groups, 264 rural credit workshops have been organized across 90 blocks, engaging over 22,000 participants including 3,100 women. These outreach activities were conducted under the themes of 'MAATI', 'Yuva Vani', and 'Karvaan' for women, youth, and vulnerable communities respectively.

Reviewing the progress of JKCIP, it was informed that the project has recorded varying degrees of success across its components. While Area Expansion has achieved 43% of its 16,459 kanal target, other components such as hiring of FPO Development Officers (100%) and Exposure Visits (87%) have performed strongly.

Kashmir wetlands welcome over a million migratory birds

Srinagar, Nov 06: With the arrival of winter, Kashmir's wetlands are once again witnessing a breathtaking transformation, turning into vibrant sanctuaries for thousands of migratory birds escaping the freezing landscapes of Europe, Central Asia, and parts of East Asia.

Tashmir

Every year, as temperatures drop across the northern hemisphere, winged visitors take flight toward the valley's water bodies, which serve as resting and feeding grounds through the colder months.

From Hokersar to Wular, Haigam, and Shalbugh, these wetlands have begun echoing with the calls of species that travel thousands of miles to find temporary refuge in Kashmir.

Officials from the Wildlife Department said that the current migratory season began in late October and will continue till March.



They said the valley's lakes and marshes, still holding sufficient water after autumn rains, have become ideal habitats for these birds. This year's early arrivals include the Black-headed Gull, Tufted Duck, Brahminy Duck, and Northern Pintail — species that signal the full return of the migratory cycle.

According to official records, more than a million birds visited Kashmir's wetlands last year. Initial field assessments suggest similar numbers this season, with bird movements reported from all major conservation zones. The diversity is promising this year, as both local conditions and water levels are favourable," an official said.

"The visiting flocks, some travelling from as far as Siberia, the Philippines, and Japan, enrich the wetlands' ecosystem by maintaining the food chain balance and aiding natural regeneration processes," he said. "Their arrival, however, also brings renewed challenges — particularly the risk of poaching

Wildlife authorities have increased ground surveillance to prevent hunting, a recurring threat to migratory species. Patrol teams have been stationed around vulnerable wetland belts, and awareness drives are being held in nearby villages to

discourage illegal trapping.
"We are keeping strict watch through night patrols and coordination with local police units," another official said.

Beyond their ecological importance, the migratory influx is also a draw for photographers, bird watchers, and environmental students. Many enthusiasts have begun visiting Hokersar and Shalbugh to document rare sightings and behaviour patterns.

The wetlands are expected to host new arrivals in the coming weeks. The final bird census, officials said, will be completed by the end of next week, giving a clearer picture of this year's population trend—(KNO)

MP Ruhullah won't endorse any candidate

Srinagar, Nov 06: As the electoral contest in the Budgam Assembly constituency intensifies, Member of Parliament from Srinagar, Aga Ruhullah Mehdi has decided against endorsing any particular candidate and has left it to the people to make their own decision, sources disclosed.

Sources said that Ruhullah, who holds considerable influence in the segment, has chosen not to endorse or support any candidate.

"He has placed faith in the people to make their own choice(s). He wouldn't ask them to vote for any particular candidate," they said.

Three-time MLA Ruhullah, who has emerged as the most vocal voice for the restoration of Article 370, is at odds with the National Conference over a range of issues and did not campaign for the party.

His latest disagreement with the National Conference centers on the rationalization of



reservation. On October 18, Ruhullah demanded that the cabinet sub-committee's report on reservation be made public, stating that his future decision regarding the Budgam by-polls would be guided by the contents of the report.

The Budgam seat, vacated following Omar Abdullah's resignation, is set to go to polls on November 11. The constituency is witnessing a direct contest between National Conference's Aga Mehmood and Peoples

Police foil terror plot; three accused arrested

Srinagar, Nov 06: In a major success against anti-national activities, Srinagar Police foiled a terror attempt by arresting three individuals and recovering arms and ammunition from their possession, thereby averting a potential attack. During routine vehicle checking near Mamta

Chowk, Konakhan, Dalgate, a Police team from Police Station Khanyar intercepted a black Royal Enfield motorcycle without a registration number. On being signalled to stop, the rider and two pillion passengers attempted to flee but were tactfully apprehended by alert personnel on duty.

The arrested individuals have been identified as Shah Mutayib, S/o Manzoor Ahmad Shah, R/o Koolipora Khanyar, Kamran Hassan Shah, S/o Ghulam Hassan Shah, R/o Koolipora Khanyar and Mohammad Nadeem, S/o Mohammad Yaseen Salmani, R/o Meerut (U.P.), presently residing at Kawa Mohalla, Khanyar. A search of their possession led to the recovery of one country-made pistol (Desi Katta) and nine live rounds.

Preliminary investigation indicates that the accused were planning to carry out a terror-related act in the locality using the recovered weapon and ammunition.

Accordingly, FIR No. 51/2025 has been registered at Police Station Khanyar under sections 3, 7. 25 Arms Act, 20, 23 UAPA, and relevant provisions of the Motor Vehicles Act.

Further investigation is in progress to identify their associates, network, and possible links with other subversive elements.

The swift and professional action of Srinagar Police once again demonstrates its commitment to maintaining peace and public safety in the city.

GMC Handwara students demand hostel facilities

Srinagar, Nov 06: Students of Government Medical College (GMC) Handwara staged a sit-in protest on Thursday, demanding immediate hostel accommodation, accusing the administration of ignoring repeated appeals.

The protesting students, mostly from the second-year batch said they have been forced to live in costly private rentals with poor living conditions.

Terming hostel accommodation a basic necessity, the protesting students carried placards reading "Accommodation for all" and "A room for every dream".

The students said they are living six to a room, facing constant issues with water and electricity. "It was understandable not to have hostels in the initial phase, but we are in the second year now and still without accommodation," a student said. They said repeated pleas to the college administration have gone unheard. "We have been facing these issues for a year. It's winter now and it's difficult to survive without proper facilities," another protester said.



Students also cited an order dated May 21, 2025, which directed officials to arrange a building for hostel purposes. "The order was issued months ago, yet the hostel was allotted to the junior batch while we were left out", the students alleged.

They said the lack of hostels has hit students from economically weaker sections the most. "How can a student from a poor family afford Rs 10,000 per month on rent?" they added.

Meanwhile, MLA Handwara Sajad Lone visited the protesting students and assured them of a solution within two months. "If the administration fails to provide the facility within the time frame, you can come and stay at my home," he told the students.

"It's my promise, if authorities do not act, come straight to my home and reside there.

Human neglect killing Bandipora springs

Bandipora, Nov 06: Once known for its abundant natural water sources, north Kashmir's Bandipora district is witnessing a steady decline in its springs and streams, with many of them now converted into garbage dumping sites or encroached upon by residents.

Bandipora, traditionally associated with Ilm (knowledge), Adab (literature), and Aab (water), is losing one of its defining elements as several freshwater bodies that once sustained communities have dried up or become polluted.

Locals of Arin-Dardpora, Gundpora, Aragam, Kehnusa, Kaloosa, Gamroo, Nadihal, and Guroora said

that water channels have been reduced to waste disposal sites.

They said household garbage, plastic bottles, and other non-biodegradable waste are being dumped directly into these streams, choking their flow and contaminating water that once supplied nearby villages.

residents said a two-century-old stream has turned into a stagnant drain. "We used to drink from it years ago, but now people throw garbage and old items into it," said Mohammad Shafi, a resident.

He added that the plastic waste floats on the surface, blocking the water at several points and leaving it unusable for any purpose.

Locals in several areas said the disappearance of natural springs has made access to clean water difficult. "A spring that existed in our village for over a hundred years has dried up completely. People now

from Gundpora. Javid Ahmad Lone, anoth-In Gundpora village, er resident from Dardpora village, said their spring too has vanished over the past few years. "Earlier, its water was used for drinking and household work. Now it has completely dried, forcing villagers to depend on water supplied through

tankers," he said. Residents blame the situation on poor waste management and official

inaction. They said promises made by the authorities to restore water bodies have not been implemented on the ground. "No proper steps have

been taken to clean the streams or stop the dumping of garbage. The situation worsens with each passing vear," said Irfan Ahmad from Rampora.

Reports from Hajin, Sumbal, Shahgund, and Madwan also reveal similar conditions, with water bodies in these suburban areas facing the same neglect.

Locals across these areas have urged the administration to initiate immediate measures to restore and protect the remaining water sources before they disappear completely—(KNO)

Garg chairs MDC traffic management meeting

Srinagar, Nov 06: Divisional Commissioner Kashmir, Anshul Garg, on Thursday chaired a comprehensive meeting of the Multi-Disciplinary Committee (MDC) on Traffic Management to review and strengthen ongoing measures aimed at streamlining traffic movement and decongesting city roads. The meeting was attended by the Deputy Commissioner Srinagar, Commissioner SMC, RTO Kashmir, Chief Engineer R&B, and officers from Traffic Police and SSCL.

During the meeting, the Divisional Commissioner took a detailed review of the improvements witnessed in downtown areas following the implementation of one-way traffic plans on several routes. It was informed that the



initiative has yielded positive results by significantly reducing traffic congestion. The committee also discussed the

introduction of colour-coded passes for mini-buses to restrict them from operating beyond their designated zones.

Further, the meeting proposed declaring MA Road as a "No E-Rickshaw Zone" from Jahangir Chowk to Dalgate, while allowing their movement only through Residency Road. It was also decided to impose a cap on the number of E-Rickshaws operating on saturated routes to prevent further congestion.

The Divisional Commissioner reviewed the progress on the Smart Parking Management System, being developed at three key locations in the city, as well as the establishment of E-Rickshaw charging stations at Hazratbal, Zoonimar, and Batamaloo.

Discussions were also held on the development of surface parking facilities at JVC, Children's Hospital, Karan Nagar, Sanatnagar, Batamaloo, and Harwan.

Several other issues including HLC matters, SSCL projects, and concerns related to the Regional Transport Authority (RTA) were also deliberated upon. The Divisional Commissioner issued specific directions to concerned departments for timely action and

Red potato cultivation vanishing in Shopian



Shopian, Nov 06: The famous Hirpora Red Potato-locally known as 'Katt-e-Maaz Aalu' because of its unique mutton-like flavour-is now being cultivated by only a handful of households in Hirpora Shopian, even as farmers this year earned good returns from other potato varieties.

Locals from Hirpora and its adjoining areas said that despite being a crop with a legacy value and high market demand, the red Hirpora potato is today limited to barely 2-4 households out of nearly 800 families in the village.

"This potato once represented Hirpora's identity. Traders from different parts of the Valley used to travel to Hirpora only for this red potato. But today it is nearly extinct," said Mohammad

Yousuf, a grower from Hirpora. Farmers said that this year other potato varieties-especially the improved white varieties—gave good



production and good returns due to favourable weather. However, on the red variety, they said the population has been shrinking mainly due to diseases, low yields and the increasing shift towards apple cultivation.

Locals also alleged that the agriculture department this year supplied them with potato seed at Rs 3,500 per quintal with the promise that later the department would procure the produce at the same rate. "We were assured

whatever rate we sell to you at the beginning, same rate we will buy back'. But later they paid us only Rs 2,500 per quintal. This is cheating," said another farmer, Abdul Rehman.

Farmers said this caused distress among many households who had trusted the department's commitment.

"We demand a proper inquiry into this. If there was a subsidy or any scheme component, we should have been told clearly. But changing the rate after its cultivation is totally unjust," they said.

An official told KNO that there was no cheating involved and that farmers were paid Rs 2,500 per quintal + Rs 1,000 subsidy under HADP, making it equivalent to Rs 3,500 per quintal.

"Farmers got Rs 2,500 cash rate and Rs 1,000 subsidy component under HADP (Holistic Agriculture Development Programme). So the total comes to Rs 3,500 per quintal," the official clarified. He said that last year potatoes were procured at Rs 2500 only and farmers got Rs 3700 per quintal plus 1000 for registered farmers and rates are fixed by higher ups. He said that chief agriculture officer Shopian has already written to higher ups in this regard so that growers can get better rates. The official also said that red Hirpora potato is indeed on decline, but multiple revival steps have already been initiated. "Two revival project proposals have been submitted to higher authorities. SKAUST and KVK Balpora are already involved. One farmer has even volunteered his land for a trial plantation. We are procuring seed directly from households still preserving the red potato strain," the official said.

According to experts, uncontrolled use of chemical fertilizers and continuous shift of agricultural land towards orchards are among the biggest reasons for the decline of this indigenous varietv. Farmers also said that during earlier times, the crop used to grow well with natural manure only. "When we used cow dung, we used to get better

quality and better quantity. Fertilizer ruined this delicate breed," said an elderly grower. Hirpora-the last inhabited village before the Hirpora Wildlife Sanctuary on Mughal Road—primarily depended on potato cultivation for decades. Locals say losing this heritage potato will also be a cultural loss.

"This potato is not just a crop, it is our identity. Government should conserve it like they conserve heritage monuments," locals said.

The agriculture department maintained confidence that with cooperation of local growers and scientific intervention in seed purity, disease control and soil assessment, the red potato can still be revived. "We hope to achieve success in bringing Hirpora Red Potato back in production again," the official added.

He added that this year on one canal on trial basis, red potatoes were sown again and it has shown good results and we are hopeful it will be extended to more land in coming year—(KNO)

Friday Brief: 'Pay The Worker Before His Sweat Dries'

In Islam, the rights of labourers and employees are establishing that timely payment of wages is not merenot merely legal considerations but fundamental moral and religious obligations rooted in divine justice. The Quran and Hadith provide a comprehensive ethical framework that elevates the status of workers and mandates their fair treatment, establishing principles that remain profoundly relevant in today's global economy. The Quran repeatedly emphasises justice and fairness in all transactions: "Give full measure and weight in justice" (6:152) and "Do not withhold from the people the things that are their due" (7:85). These verses form the foundation of Islamic labour ethics,

ly an economic transaction but a test of faith and righteousness. Prophet Muhammad (PBUH) was perhaps history's most powerful advocate for workers' rights, declaring: "Give the worker his wages before his sweat dries" (Ibn Majah). This powerful instruction makes timely compensation a religious imperative, recognising the human dignity embedded in labour. The Prophet (PBUH) further emphasised that mistreating workers constitutes grounds for divine opposition, stating that God would be an adversary to three persons on Judgment Day, including "one who employs a

worker and takes full work from him but does not pay him his wages" (Bukhari). Islamic teachings specifically address working conditions, mandating that tasks must be within reasonable capacity and that workers cannot be burdened beyond their strength. The Prophetic tradition establishes that "Your brothers are your responsibility. God has made them under your hands. So whoever has a brother under his hand, let him feed him of what he eats and clothe him of what he wears" (Bukhari), extending employer responsibility beyond mere wages to holistic welfare. Islam prohibits discrimination in employment, recognising that

"God does not look at your appearances or wealth, but at your hearts and deeds" (Muslim). In the contemporary context, these teachings translate to living wages, safe working conditions, reasonable hours, and protection from exploitation. They remind us that economic systems must serve human dignity rather than sacrifice it for profit. By implementing these divine guidelines, we create not just equitable workplaces but societies that truly reflect Islamic justice, where every worker's labour is honoured, their rights protected, and their contribution valued as an act of worship in itself.

Towards Dignified Work: Why India Must Implement Its Labour Codes Now

In era of shifting global supply chains, labour reforms could be India's competitive advantage

India's world of work stands at an inflection point. India's workforce must Lincreasingly find place in formal employment, supported by written contracts, adequate wages, and comprehensive social protection, so that the gains of growth translate into secure and dignified livelihoods for all. The persistence of older regulatory frameworks has, in part, limited the pace of formalisation and the ability of enterprises to generate secure and quality jobs. The four labour codes enacted by Parliament between 2019 and 2020, on Wages, Industrial Relations, Social Security, and Occupational Safety, Health and Working Conditions, represent the long-pending reform envisioned by the Second National Commission on Labour chaired by Ravindra Varma in 2002 with a mission to codify, simplify & modify then existing labour frame work. The Codes offer a comprehensive framework to modernise India's labour landscape and correct structural imbalances. Their uniform implementation across all States has now become an urgent national priority.

The new codes simplify and modernise 29 central labour laws, many dating back to the mid-twentieth century. They seek not merely to merge statutes but to make multiple definitions of workers/workmen employee into simple definition. Each code strengthens the rights and welfare of workers while providing clarity and predictabil-

ity for employers.

Fair wages and dignity of labour The Code on Wages, 2019 marks a historic step towards ensuring that every worker receives a wage that respects the dignity of labour. By introducing universal minimum wages and a national floor wage, it guarantees that no worker, regardless of occupation or location, is left without a basic standard of income. Elimination of schedule of industry pave the road for universal wages.

Timely payment provisions have been strengthened, eliminating delays that once pushed families into debt. Workers can now



claim unpaid wages or bonuses more easily, and the burden of proof in such disputes rests with the employer, creating greater accountability.

At the same time, the Code streamlines compliance for enterprises. Electronic record-keeping, a single registration, and unified returns reduce paperwork, rationalise chances of manipulation.

Extending the social security net

The Code on Social Security, 2020 represents one of the most inclusive expansions of welfare in independent India. By consolidating nine major laws, including the Employees' Provident Fund Act, Employees' State Insurance Act, and Maternity Benefit Act, it establishes a unified system that covers both traditional and future of work.

For the first time, gig workers, platform workers, and those in the unorganised sector are explicitly recognised as part of the national workforce. Every worker is to be registered and issued a unique social security number through the e-Shram portal, enabling direct delivery of benefits such as health insurance, pensions, and maternity support. Central and State Social Security Funds will be created to ensure that workers like app-based delivery partners or construction labourers are no longer left outside the safety net and funds are managed in holistic manner.

The Code also introduces career centres, digital and physical platforms that will provide vocational guidance, counselling, and employment services. This institutional support links welfare with multiple employability, helping workers transition from insecurity to opportunity.

Safety, dignity, and equality at work

The Occupational Safety, Health and Working Conditions Code, 2020 (OSH Code) is a statement of care and responsibility towards those who build the nation. By broadening the definition of "establishment," the Code extends protection to millions previously uncovered by safety legislation

It mandates free annual health check-ups for workers and requires employers to maintain safe, hygienic workplaces without any financial burden on employees. The formation of a National Occupational Safety and Health Advisory Board ensures that safety standards evolve with changing industrial

The OSH Code makes important strides in gender equality. Women workers are permitted to work in all establishments and night shifts, provided adequate facilities and security arrangements exist, empowering more women to join and remain in the labour force. Migrant workers, too, gain recognition through a national registration system, enabling access to welfare schemes and mobility benefits and monitoring legal framework to ensure recent live and livelihood.

Facilities such as canteens and restrooms are now mandatory at lower thresholds, and contract workers are counted for determining such provisions. These measures reflect a shift from minimal compliance to genuine concern for worker welfare.

Dialogue and industrial harmony The Industrial Relations Code, 2020 brings clarity to the relationship between employers and employees, replacing three earlier Acts with a unified framework. It requires establishments with twenty or more workers to set up Grievance Redressal Committees, ensuring that disputes are resolved promptly at the enterprise level rather than festering into strikes or litigation.

Trade unions gain recognition through the concept of a negotiating union or council, strengthening collective bargaining and giving workers an effective voice in shaping their workplace. Workers facing retrenchment are now entitled to 30 days' notice and adequate compensation, a humane reform that respects livelihood security. The establishment of a re-skilling fund for retrenched workers signals a forward-looking approach that values learning and adaptability in a changing economy. The provisions related to strike rights need to be revisited. Upgradation of workers limit for the industry upto 300 to get easier clearance for closure or lock outs should also be reconsidered.

Fixed-term employment, formally recognised by the Code, offers flexibility to industry while guaranteeing parity in wages and other social security provisions including gratuity in tandem with regular employees. It balances the needs of a modern economy with fairness and security for those who work within it.

Why implementation matters now

Evidence from several developing nations shows that labour reforms have played a key role in driving economic growth. In the face of a shifting global economy marked by ris-ing tariffs and changing trade patterns, India must urgently implement its new labour codes. Simplified and transparent laws will attract investment, promote formal employment, and uphold worker dignity. Timely notification will pave the way towards India reaching developed nations tag.

In a time when automation and digitalisation threaten to displace traditional jobs, the codes provide a framework for balanced growth, one that preserves human dignity even as technology advances. Implementation across all States would create uniform standards, reduce ambiguity, and easy access to jobs.

The way forward

The four codes form the backbone of India's ambition for a Viksit Bharat, a developed, self-reliant nation that combines economic dynamism with social justice. They transform inspectors into facilitators, replace outdated and overlapping laws with clear, consistent ones, and place worker welfare at the centre of economic policy.

The spirit of these reforms with some riders lies not merely in consolidation but in compassion, ensuring that every worker, from the factory floor to the digital platform, enjoys dignity, safety, and security. For workers, they promise fairness and opportunity. Implementing these codes swiftly and uniformly is therefore not only a matter of administrative urgency but of national commitment, to build an economy where growth is shared work is respected and every hand that contributes to India's progress is protected and avail ease of living.

Rivers Of Revival: How India's Ancient Waterways **Are Powering A Green Logistics Revolution**

With ₹1.20 per tonne-km versus ₹2.28 by road, the economic case for waterways is overwhelming

magine a future India where goods glide on barges instead of trucks, logistics corridors slide along rivers instead of highways, and the carbon footprint shrinks even as trade expands. That future is not fantasy—it is within reach. For India to be Viksit Bharat and truly Atmanirbhar, Inland Water Transport (IWT) has to be the backbone of a sustainable logistics revolution.

Rivers have carried India's trade for 4,000 years. They connected Lothal to Rome, Bengal to Burma, and Assam to the rest of Southeast Asia. However, roads and railways, with their glitter of speed and steel, pushed rivers into the background. Today, in an age of climate warnings and economic pressures, the tide is turning. Not out of romance, but out of necessity.

Under Prime Minister Narendra Modi's leadership, inland waterways have received unprecedented policy focus. Cargo movement on National Waterways has climbed from 18.1 million metric tonnes in 2013-14 to 145.84 million metric tonnes in 2024-25. Operating costs confirm the logic: 1.20 per tonne-km by water, compared to 1.40 by rail & 2.28 by road. Waterways are economical and fuelefficient. Waterways consume just 0.0048 litres per tonne-km, against 0.0313 litres by road, & 0.0089 litres by rail. This is an eye opener for any supply chain management.

And here's the real clincher: greenhouse gas emissions per tonne-km on rivers are just a fifth of what roads produce. Every barge sailing down the Ganga or Brahmaputra is not only carrying goods but also cleaning up India's carbon conscience.

The Jal Marg Vikas Project on NW-1 approved by Government of India in 2016, is shifting cargo flows in the Ganga-Bhagirathi-Hooghly river system. Multimodal logistics hubs like Varanasi and Sahibganj are being developed in partnership with National Highways Logistics Management Ltd (NHLML), while rail linkages via Indian Port Rail & Ropeway Corporation Ltd. (IPRCL) and Dedicated Freight Corridor Corporation of India Ltd. (DFCCIL) are being built to integrate river, rail and road seamlessly. On NW-2 (the river Brahmaputra), the Jogighopa IWT terminal is being tied to the Multi-Modal Logistics Park (MMLP), which connects via the Indo-Bangladesh Protocol route to Kolkata and Haldia ports.

The potential of IWT is already visible in action. Take the Numaligarh Refinery Limited (NRL) expansion project in Assam, recently inaugurated by the Prime Minister. Heavy equipment for the refinery-including Over Dimensional Cargo (ODC) and Over Weight Cargo (OWC)—was transported via the Indo Bangladesh Protocol (IBP) Route & Brahmaputra river under IWAI's supervision. This included 24 consignments moving efficiently and safely to the NRL jetty, bypassing congested highways and avoiding the complications of road transport for oversized cargo. The operation showcased how river logistics is not just environmentally prudent but fully capable of handling India's most challenging industrial shipments, combining cost-effec-

tiveness, safety, and sustainability.
Of course, for industry, this is not about nostalgia or national pride. It's about margins and markets. Moving freight on water is cheaper, cleaner and increasingly faster as multimodal hubs come online. In a world where global investors assess supply chains not just for efficiency but also for their environmental impact, shifting to river transport offers a strategic advantage. Carbon compliance has become a key factor, making inland waterways a smarter and more sustainable choice for modern logistics. Move freight on water, and you reap the dual dividends of lower costs and better Environment, Social

The social dividend is real. Fewer trucks

means fewer accidents, lower road maintenance pressure, cleaner air, and more resilient rural economies. Many riverine communities once reliant on ferry transport or small-scale trade can find renewed purpose in logistics support, handling, warehousing, and inland port services. This is not charity. This is commerce rediscovering common sense.

Yes, challenges remain. Seasonality affects navigability. Some stretches require constant dredging. Vessel fleets are limited. Institutional coordination across States, Ports, and Ministries is a puzzle. But the Government is tackling these head-on-through end-to-end dredging, expanding multi-modal hubs, putting in place policy instruments like the Inland Vessels Act, enabling private jetties on National Waterways, & more compliant with environmental norms under 'Harit Nauka' to nudge the sector towards cleaner, greener practices. Digital tools like CAR-D (Cargo Data Portal), Jalyan & Navic, Jal Samriddhi, PANI, Naudarshika (National River Traffic and Navigation System) portals and vessel tracking systems streamline operations and reduce friction.

Globally, the template is clear. The Danube and Rhine carry Europe's freight. India, with its rich network of more navigable rivers, is uniquely positioned. As India seriously contemplates to become net-zero by 2070, waterways are not optional. They are central. They tick every box: efficiency, economy, and ecology. The numbers add up, the climate case is unassailable, and the cultural logic is undeniable.

At India Maritime Week 2025 in Mumbai in October, 2025, the Policymakers — both global & local, Logistics majors - bigwigs to aspiring ones, Governments, Investors, Maritime experts, Environmentalists and Enthusiasts would present their ideas to give shape to next logical steps towards this direction. It would showcase the future of cargo-centric river transport—how the Ganga, Brahmaputra, and other waterways can be the skeleton of a greener, more efficient India. Rivers built our civilization. By embracing our rich legacy and integrating global best practices, India is poised to build a sustainable economy through a revitalized and modernized inland water transport system. With momentum on our side, the current is finally flowing in our favour—powering the future of green logistics.

52 tons of paper shipped from Kathua Railway Station to Azara

Jammu, Nov 06: Following the establishment of Jammu Division in Northern Railway, various initiatives are being implemented under the Freight Policy by Divisional Railway Manager Mr. Vivek Kumar and Senior Divisional Commercial Manager Mr. Uchit Singhal. These efforts aim to reduce logistics costs and make freight transportation more accessible to small businesses.

On November 5, 2025, a BCN wagon loaded with 952 bundles of paper and paper rolls, weighing a total of 52 tons, departed from Kathua Railway Station of Jammu Division for Azara Railway Station in Rangiya Division, Guwahati, Assam, on the Northeast Frontier Railway. The freight was transported at a rate of 1.28 lakh, marking a significant milestone in freight

The Jammu Division is actively encouraging local businesses to promote rail freight transportation, which is expected to enhance freight movement, increase railway revenue, and generate new employment opportunities for the community.



Senior Divisional Commercial Manager Mr. Uchit Singhal stated that under the freight policy, the division's freight handling capacity will be expanded to ensure the smooth movement of goods across the country and strengthen railway infrastruc-ture. He also highlighted that earlier, on July 23, 2025, a BCN weighing approximately 46 tons was successfully transported from Kathua Railway Station to Azara Railway Station in Rangiya Division

SC makes written communication of arrest grounds mandatory for all offences

New Delhi, Nov 06: In a landmark verdict, the Supreme Court on Thursday held that every arrested person must be furnished with the grounds of arrest in writing and in a language they understand irrespective of the nature of the offence or statute involved.

In the verdict that strengthens constitutional protection for personal liberty, the top court held that non supply of grounds of arrest in writing to the arrestee prior to or immediately after arrest would not vitiate such arrest if the same is "supplied in writing within a reasonable time and in any case two hours prior to the production of the arrestee before the magistrate for remand proceedings".

A bench comprising Chief Justice B R Gavai and Justice Augustine George Masih delivered the judgment in the Mihir Rajesh Shah vs State of Maharashtra case that arose from the high-profile Mumbai BMW hit-and-run incident of July 2024.

Iustice Masih, writing a 52page judgment for the bench, ruled that the constitutional mandate under Article 22 of

the Constitution, which guarantees that an arrested person must be informed "as soon as may be" of the grounds of arrest, is not a procedural formality but a fundamental safeguard of personal liberty.

"This court is of the opinion that to achieve the intended objective of the constitutional mandate of Article 22 of the Constitution of India, the grounds of arrest must be informed to the arrested person in each and every case without exception and the mode of the communication of such grounds must be in writing in the language he understands," the verdict said.

"The constitutional mandate of informing the arrestee the grounds of arrest is mandatory in all offences under all statutes including offences under IPC 1860 ," it held.

The grounds of arrest must be communicated in writing to the arrestee in the language he/she understands and in case where, the arresting officer/ person is unable to communicate the grounds of arrest in writing on or soon after arrest, it be so done orally. The said grounds be communicated in writing within a reasonable

time and in any case at least two hours prior to production of the arrestee for remand proceedings before the magistrate," it directed.

In case of non-compliance, the arrest and subsequent remand would be rendered illegal and the person will be at liberty to be set free, it said.

The top court directed its registry to send a copy of the judgment to all the registrars general of the high courts and the chief secretaries of all the states and Union territories.

The verdict dealt with two issues and the first one was "whether in each and every case, even arising out of an offence under IPC now Bharatiya Nyaya Sanhita, 2023 would it be necessary to furnish grounds of arrest to an accused either before arrest or forthwith after arrest".

The second issue was whether, even in exceptional cases, where on account of certain exigencies it will not be possible to furnish the grounds of arrest either before arrest or immediately after, the arrest would be vitiated.

Referring to earlier verdicts, it said, "Mere communication

of the grounds in a language not understood by the person arrested does not fulfil the constitutional mandate under Article 22 of the Constitution of India. The failure to supply such grounds in a language understood by the arrestee renders the constitutional safeguards illusory and infringes the personal liberty of the person as guaranteed under Article 21 and 22 of the Constitution."

The objective of the constitutional mandate is to place the person in a position to comprehend the basis of the allegations levelled against him and it can only be realised when the grounds are furnished in a language understood by the person, it added.

The ruling stems from appeals filed by Mihir Rajesh Shah, the accused in the 2024 Mumbai BMW hit-and-run case, who challenged the legality of his arrest on the ground that he was not furnished written reasons for arrest as required by law.

Although the Bombay High Court had acknowledged a procedural lapse, it upheld the arrest citing the gravity of the

Pope Leo receives Palestinian president Abbas at Vatican



Vatican City, Nov 06: Pope Leo XIV held his first meeting with Palestinian president Mahmud Abbas on Thursday, where the Vatican said they discussed the "urgent need" to help the civilian population in Gaza.

The visit comes almost a month into a fragile ceasefire between Hamas and Israel, following two years of war triggered by the Palestinian group's October 7, 2023, attack.

Abbas is the longtime head of the Palestinian Authority, which exerts limited control over parts of the West Bank. His Fatah movement is the rival to Hamas, which took control of Gaza in 2007.

Abbas and Leo spoke by telephone in July but Thursday was their first in-person meeting since the American took over as head of the world's 1.4 billion Catholics in May.

"During the cordial talks, it was recognized that there is an urgent need to provide assistance to the civilian population in Gaza and to end the conflict by pursuing a two-state solution," the Vatican said in a statement afterwards.

It noted that the meeting came 10 years after the Holy See formally recognized the state of Palestine through an agreement signed in 2015.

Abbas met several times with Leo's predecessor, Pope Francis, who died in April.

In the final months of his pontificate, Francis hardened his rhetoric against Israel's assault on Gaza, but his successor has so far adopted a more measured tone.

Leo has expressed his solidarity with Gaza and denounced the forced displacement of Palestinians, but said the Holy See could not describe what was happening as a "genocic

On Wednesday afternoon, Abbas laid flowers at Francis's tomb at the Rome basilica of Santa Maria Maggiore.

"I cannot forget what he did for Palestine and the Palestinian people," Abbas told reporters. In 2014, then-Israeli president

Shimon Peres and Abbas joined a prayer for peace with Pope Francis at the Vatican, planting an olive tree together. Abbas will on Friday meet with Italian Prime Minister Giorgia Meloni.

School children in England to learn about fake news in curriculum

London, Nov 06: In what is being dubbed as the biggest curriculum shake-up in a decade, pupils in England will be taught about identifying fake news and learn more about artificial intelligence as part of a UK government revitalisation drive for schools.

Responding to the recommendations of a 'Curriculum and Assessment Review' by an academic on Wednesday, the Department for Education (DfE) confirmed steps to ensure every young person is equipped with the knowledge and skills required over the next decades.

The review also recommends cutting the overall volume of exams faced by teenagers by 10 per cent, with the current examination levels seen as "excessive".

"From the fundamentals of reading to the present danger of spotting fake news, as part of our Plan for Change. landmark reforms these will help young people step boldly into the future, with the knowledge to achieve and the skills to thrive as the world around us continues to rapidly evolve," said Education Secretary Bridget Phillipson.

"It has been over a decade since the national curriculum was updated, and it's more crucial than ever that young people are equipped to face



the challenges of today, so they can seize the exciting opportunities that life has to

"The path to our country's renewal runs through our schools: they must be an epicentre of the strongest possible foundations of knowledge, and the skills to excel in the modern world,"

According to the DfE, primary school-aged children will be taught how to identify misinformation and disinformation, helping them develop the critical thinking needed to challenge what they see and protect them from online harms. They will also learn more about the fundamentals of money, such as mortgages and debt, and also bring in important changes to strengthen

children's reading. "It is essential that every young person finishes their education with the knowledge

and skills to move successfully into working life," said Jane Gratton, Deputy Director of Public Policy at the British Chambers of Commerce.

"Business will welcome curriculum changes that improve employability - such as team working, oracy, literacy, digital and financial skills. It's crucial that every student can access an appropriate qualification pathway to help keep them engaged - and in education or work," she said.

The new curriculum will be implemented from September 2028, with the government aiming to publish the final revised version by early 2027 to give schools four terms to prepare for the changes.

Other key reforms will include a compulsory citizenship module, including climate education, a new language qualification, and injecting more outdoor and sporting aspects.

World can still return below 1.5 deg C by 2100 with urgent action: Study

NEW DELHI: The world can still bring long-term average global temperature rise back to well below 1.5 degrees Celsius this century but only if countries immediately pursue the "highest possible ambition" in climate action, according to a new analysis published on Thursday.

The study, titled "Rescuing 1.5 degree C: New Evidence on Highest Possible Ambition to Deliver the Paris Agreement", Berlin-headquartered

climate science and policy institute Climate Analytics updates earlier UN climate models to reflect today's higher emissions and finds that transformative action led by rapid electrification, renewable expansion and a fossil fuel phaseout could halt global warming before mid-century.

The report's Possible Ambition" (HPA) scenario shows global warming peaking around 1.7 degrees Celsius around 2040 before falling to about 1.2 degrees Celsius by 2100.

Experts warn of rising obesity, heart attacks among youth, urge 'Blue Zone' lifestyle

NEW DELHI: A new health crisis is silently gripping India's youth, with leading medical experts warning that sedentary lifestyles are rapidly escalating instances of hypertension among teenagers and triggering heart attacks in individuals as young as 25.

India needs world-class banks; in talks with RBI, lenders: FM Sitharaman

Mumbai, Nov 06: Finance Minister Nirmala Sitharaman on Thursday said the country needs big and world-class banks, and discussions are on with the Reserve Bank and lenders in this regard.

Addressing the 12th SBI Banking and Economics Conclave 2025, Sitharaman asked lenders to deepen and widen credit flow to the industry, exuding confidence that GST rate cut-driven demand would unleash a virtuous investment cycle.

She advised that access to finance is absolutely critical and that a system-driven, transparent lending process is essential.

Stressing that India needs a lot of big and world-class banks, she said the "government is looking at this and work has already commenced. We are discussing with the RBI. We are discussing with banks". Before the government takes a call on this, she said, a lot of the work has to be done, including taking inputs from the RBI as to how they want to build larger banks.

"It is not by creating from those which exist today...just by amalgamation that can also be one of the routes, but you need an ecosystem and an environment in which more banks can operate and operate to grow. So, that environment is actually well established in India, but I needed to be more dynamic. So, some work is happening on it," she said.

In a bid to create bigger banks, the government in the past had done two rounds of consolidation. In the biggest consolidation exercise in the banking space, the government, in August 2019, had announced four major mergers of public sector banks, bringing down their total number to



12 from 27 in 2017. Effective April 1, 2020, United Bank of India and Oriental Bank of Commerce were merged with Punjab National Bank; Syndicate Bank was merged with Canara Bank; Allahabad Bank was amalgamated with Indian Bank; and Andhra Bank and Corporation Bank were consolidated with

Union Bank of India. In 2019, Dena Bank and Vijaya Bank were merged with Bank of Baroda, Prior to this, the government had merged five associate banks of SBI and Bharatiya Mahila Bank with the State Bank of India. This was done in April 2017 with the intent to make SBI much bigger.

Besides, as part of the privatisation exercise, the government in January 2019 sold its controlling 51 per cent stake in IDBI Bank to Life Insurance Corporation of India (LIC)

Subsequently, the government and LIC announced plans for the strategic sale of their stake in IDBI Bank.

In October 2022, both shareholders had invited EoI (Expression of Interest) from investors for privatising IDBI Bank by selling a total of 60.72 per cent stake. This includes a 30.48 per cent stake of the government and 30.24 per cent of LIC.

RJD, Cong have soft corner for infiltrators, dislike for Lord Ram because of vote bank, alleges PM

Araria, Nov 06: Prime Minister Narendra Modi on Thursday charged the opposition RJD-Congress combine in Bihar with having a soft corner for infiltrators, but "dislike" for Lord Ram and 'Chhathi Maiya' because of vote bank politics.

Addressing a rally in Araria district, Modi also alleged that the reluctance of opposition leaders to visit Ayodhya to have 'darshan' of shrines dedicated to Nishad Raj, Mata Shabri and Maharshi Valmiki was indicative of their "hatred" for Dalits and backward classes.

"Bihar saw zero development during the 15 years of 'jungle raj'. No highways and bridges were built, nor any centres of higher learning were set up. The NDA under the leadership of Chief Minister Nitish Kumar has worked very hard to bring the state out of that era," he said.

"Today, Bihar has so many expressways, bridges over rivers, as many as four central universities and other centres of higher learning. Only the NDA can ensure that this journey towards growth continues uninterrupted," he added.

On poll day, Bihar Dy CM alleges his convoy attacked by RJD supporters

EC asks DGP to take action

Lakhisarai (Bihar), Nov 06: Bihar Deputy Chief Minister Vijay Kumar Sinha caused a flutter on Thursday, alleging that his convoy had been attacked by workers of the main opposition party, RJD, who were trying to "intimidate" voters in the area.

The senior BJP leader, who is seeking re-election for a fourth consecutive term, expressed dissatisfaction with the response of the local administration, saying he would take up the matter with the Election Commission (EC).

Reacting to the alleged incident. Chief Election Commissioner Gyanesh Kumar directed the state DGP to take "immediate action". "No one will be allowed to take the law into their own hands. Strict action will be taken against the miscreants," an official said, quoting Kumar.

Lakhisarai SP Ajay Kumar said polling was continuing in the area where Sinha alleged that his convoy was attacked by RJD supporters.

"I have received reports

of some protests over broken roads, but I will be able to confirm what actually happened only after visiting the site," the SP said.

Talking to reporters, the Deputy CM said, "Since morning, RJD supporters have been intimidating voters belonging to extremely backward classes. The local SP is a coward. He says there is peace all around, when the fact is that people are not being allowed to vote".

'You can see one of the cars in my cavalcade, which has been damaged by the opposition party goons who hurled stones, slippers and cow dung when our men tried to stop them. One of my workers, Vibhishan Kevat, was beaten up badly. He has been admitted to a hospital, and there has not been a single arrest", Sinha said.

Accusing the RJD of resorting to violence, the deputy chief minister said, "The party has shown what it stands for. When this is their behaviour while out of power, if they win the polls even by fluke, what will ensue will be nothing short of the law of the jungle."

Expressing serious dissatisfaction with the response of the local administration, the Deputy CM said, "The matter will be raised before the Election Commission. The questionable conduct of the official concerned with be reviewed and action

will follow".

RJD spokesperson Shakti Yadav said, "He (Sinha) is a liar. He gets Z+ Security; it's his party that is in power in the state and controls the administration. Still, you are levelling these false allegations? Locals raised questions on a broken drain, and that is what happened.'

Meanwhile, a similar incident was reported from Manjhi assembly constituency of Saran district, where the convoy of Satyendra Yadav, the sitting CPI(ML) Liberation MLA, was attacked by unidentified persons.

According to a statement issued by the Saran police, occupants of the car, including the MLA, had escaped unhurt attack and a search was on for "antisocial elements" in the attack.

Addressing a summit in the national capital, the minister stressed that adoption of SAF (Sustainable Aviation Fuel) demands more innovation, investment and a collective international collaboration.

India aims to have 1 per cent blending of SAF in jet fuel by 2027, 2 per cent blending by 2028 and 5 per cent blending by 2030. SAF can be used as a drop-in fuel in Aviation Turbine Fuel (ATF), which powers aircraft.

The minister said that private players should also be part of SAF pro-

duction besides the oil companies. Globally, the requirement for SAF is estimated at 183 million tonnes by 2040. "From feedstock to fuel, from farmers to flyers, and from frying to flying, who would have actually imagined that (those) frying samosas also can participate in this whole global aviation movement (on SAF)," Naidu said.

India has more than 750 million tonnes of available biomass and nearly 213 million tonnes of surplus agricultural residue.

Naidu said the government will very soon come out with a SAF policy.

Apart from reducing carbon emissions, the minister said SAF can empower farmers by increasing their incomes by 10-15 per cent.

Along with reducing our crude oil import bill by USD 5-7 billion every year, SAF production can also help create over 1 million green jobs across the SAF value chain, Naidu said.

At present, global SAF is very less. Naidu said that the country can produce SAF at highly competitive rates and the fuel can also help address challenge of growth versus sustainability.

India is one of the world's fastest growing civil aviation markets and domestic carriers have placed orders for more than 1,700 planes.

'World can still return below 1.5 deg C by 2100 with urgent action'

New Delhi, Nov 06: The world can still bring long-term average global temperature rise back to well below 1.5 degrees Celsius this century but only if countries immediately pursue the "highest possible ambition" in climate action, according to a new analysis published on Thursday.

The study, titled "Rescuing 1.5 degree C: New Evidence on Highest Possible Ambition to Deliver the Paris Agreement", by Berlin-headquartered climate science and policy institute Climate Analytics updates earlier UN climate models to reflect today's higher emissions and finds that transformative action led by rapid electrification, renewable expansion and a fossil fuel phaseout could halt

global warming before mid-century. The report's "Highest Possible Ambition" (HPA) scenario shows global warming peaking around 1.7 degrees Celsius around 2040 before falling to about 1.2 degrees Celsius by 2100.It projects global carbon dioxide emissions reaching net zero by 2045 and all greenhouse gases by the 2060s -- roughly a decade earlier

than in the latest IPCC pathways. Under the HPA scenario, renewable electricity would supply nearly twothirds of all energy demand by 2050, with wind and solar meeting over 90 per cent of electricity needs. Fossil fuel use peaks immediately

and declines sharply; coal is effectively phased out by the 2040s, gas in the 2050s and oil in the 2060s. Advanced economies would reach a fossil-free energy system by 2050, with the rest of the world following by 2070. Methane emissions would fall 20 per cent by 2030 and 30 per cent by 2035 compared to 2020 levels, driven mainly by cuts in the energy sector. Carbon dioxide removal technologies, including direct air capture and engineered removals, would need to scale up rapidly, capturing over 5 billion tonnes of CO2 annually by 2050. The Paris Agreement, adopted



by nearly 200 countries in 2015, aims to keep global temperature rise well below 2 degrees Celsius and pursue efforts to limit it to 1.5 degrees Celsius. Warming has already crossed 1.3 degrees Celsius and global emissions

continue to rise.

According to the World Meteorological Department, 2024 was the hottest year on record and the first with a global average temperature 1.5 degrees Celsius above pre-industrial levels.

However, a permanent breach of the 1.5-degree Celsius limit specified in the Paris Agreement refers to long-term warming over a 20- or 30-year period.

The Climate Analytics report said the world will very likely reach 1.5 degrees Celsius of warming by the

The global average concentration of carbon dioxide surged by 3.5 parts per million from 2023 to 2024, the largest increase since modern measurements started in 1957.

"Overshoot of 1.5 degrees Celsius is a woeful political failure and will bring increased damages and risk of tipping points that otherwise could have been avoided. But this roadmap shows it is still within our power to bring warming back well below 1.5 degrees Celsius by 2100," said Bill Hare, CEO of Climate Analytics.

"We must do all we can to limit any time we spend above this safety threshold to minimise the risk of

irreversible climate damages and the devastation that could be caused by crossing tipping points.

The analysis warned that a temporary overshoot of 1.5 degrees Celsius, expected to last about four decades, will have significant consequences for vulnerable countries, ecosystems

and global inequality.

But it also finds that swift emissions cuts, combined with a revolution in renewables and batteries, could help reverse that trend before the end of the century.

Grant, Senior Expert at Climate Analytics and lead author, said, "The last five years have cost us precious time in the critical decade of climate action. "However, they have also seen a revolution in renewables and batteries, which have shattered records across the globe. Riding these tailwinds can help turbocharge our clean energy future and catch up on lost time. The window to minimise overshoot is still open, but narrow-

Musk's Starlink to start services in India



New Delhi, Nov 06: India's Maharashtra state, home to financial hub Mumbai, will be the first to roll out Elon Musk's Starlink Internet service in the world's most populous country, the chief minister said.

The launch of Starlink, which provides high-speed Internet to remote locations using low-orbit satellites, has sparked fierce debate in India over issues ranging from predatory pricing to spectrum allocation.

India — projected to have more than 900 million Internet users by year's end — granted Starlink a license in June.

Maharashtra was "poised to become the first Indian state to formally collaborate with Starlink," the state's Chief Minister Devendra Fadnavis said on the Musk-owned platform X late Wednesday.

"This collaboration... will ensure the state leads India in satellite-enabled digital infrastructure.

B'desh approves law prescribing death penalty for perpetrators of enforced disappearance

Dhaka, Nov 06: Bangladesh's interim government on Thursday approved a draft ordinance prescribing the death penalty for perpetrators of "enforced disappearance", amid the ongoing trial of ousted prime minister Sheikh Hasina and 15 serving military officers over crimes against humanity.

"This is a landmark law. It will ensure that enforced disappearances never occur again in the country," press secretary of Chief Adviser Yunus, Shafiqul Alam, said at a press conference after the advisory council, effectively the cabinet, approved the draft.

He said the law criminalises the establishment of secret detention centres such as "so-called Aynaghar" and obligates courts to conduct trials under the proposed law within 120 days of the filing of charges.

After President Mohammad Shahabuddin's assent, the ordinance will likely be enforced in the case of 15 army officers, Hasina and several of her colleagues in the ousted government, including the former police chief.

Bangladesh Internati Crimes Tribunal's chief prosecutor on October 16 sought



premier Sheikh Hasina, alleging that she was the "mastermind and principal architect" behind the crimes against humanity committed during the mass protests last year.

Hasina, 78, faces multiple cases in Bangladesh after being ousted in August last year following the mass student-led agitation in the country. According to a UN rights office report, up to 1,400 people were killed between July 15 and August 15 last year as Hasina's government ordered a security crackdown on protesters.

Hasina is facing the trial in absentia at Bangladesh's International Crimes Tribunal ministers of her government, while 15 serving military the death penalty for deposed officers also appeared on the dock from the cantonment, complying with the tribunal's arrest warrant. The military officers' court appearance on October 22 came amid widespread speculations and unease over their trial in a civil court under a newly amended ICT-BD law instead of a military court under the Army Act.

The ICT-BD prosecutor earlier warned the army of declaring 15 of their officers "fugitives' unless they were produced on the dock on the due date.

The third amendment to the ICT-BD law, originally enacted to try hardened collaborators of Pakistani troops during the 1971 Liberation War, suggested that people charged under the law would be immediately disqualified to hold public offices and government services.

Sheetal Devi breaks new ground, qualifies for India's able-bodied archery team for Asia Cup

Jeddah, Nov 06: New Delhi, Nov 6: Para-archer Sheetal Devi, the world compound champion born without arms, shattered another barrier on Thursday by being picked in the Indian able-bodied junior team for the upcoming Asia Cup Stage 3 in Jeddah. Her selection marks

another historic first for Sheetal — the inclusion of a para-athlete in an Indian team for an able-bodied international competition.

"When I started competing, I had a small dream — to one day compete alongside the able-bodied. I didn't make it at first, but I kept going, learning from every setback. Today, that dream is one step closer," Sheetal wrote on social media after the announcement.

Winner of a bronze medal in the mixed team compound event at the 2024 Paris Paralympics, Sheetal drew inspiration from Turkey's Paris Paralympic champion Oznur



Cure Girdi, who also competes in able-bodied events at the world level. Competing among more than 60 able-bodied archers from across the country under identical conditions, the 18-year-old from Jammu and Kashmir finished third overall in the rigorous four-day national selection trials

held in Sonipat. Sheetal scored 703 points in the qualification rounds — 352 in the first and 351 in the second — matching top qualifier Tejal Salve's total.

In the final rankings, Tejal (15.75 points) and Vaidehi Jadhav (15 points) took the top two spots, while Sheetal secured third place with 11.75 points, narrowly edging out Maharashtra's Dnyaneshwari Gadadhe by 0.25 points.

Trained at the Shri Mata Vaishno Devi Shrine Board Sports Complex in Katra, Sheetal has already carved her name in history by becoming the first female armless world champion in para archery this year.
