# Budgam, Nagrota set for high-stakes by-polls today

## Over 2.2 lakh voters to decide fate of 27 candidates

Jammu/Srinagar, Nov 10: Two politically significant assembly constituencies, Budgam in Central Kashmir and Nagrota in Jammu district are set to witness a high stake by-election on Tuesday with over 2.2 lakh voters to cast their ballots for the second time in 13 months to decide the fate of 27 candidates in the fray.

According to the news agency–Kashmir News Observer (KNO), in Nagrota, polling will take place across 150 booths, where 97,893 registered voters will cast their ballots between 7 AM and 6 PM.

The bye-poll follows the death of sitting BJP MLA Devender Singh Rana in October 2024. His daughter, Devyani Rana, who



serves as the BJP's J&K BJYM Vice-President, is contesting her maiden election to continue her father's political legacy.

Devyani faces a triangular contest against Shamim Begum of the National Conference and Harsh Dev Singh, President of the Jammu and Kashmir National **Panthers** (IKNPP).

Other contestants from the constituency include Joginder Singh of the Aam Aadmi Party (AAP), Bodh Raj of the Apni Party, and several independents like Anil Sharma, a BJP rebel. Nagrota, which includes parts of Jammu city and adjoining rural belts, has traditionally leaned towards the BJP, but this election has drawn unusual attention due to a mix of local and emotional factors.

Security agencies, under the supervision of Superintendent of Police (SSP) Jammu Joginder Singh, have made watertight security arrangements at sensitive polling

### **Crackdown launched against** 'white-collar terror ecosystem

8 accused, including 3 doctors, held

Arms, explosives recovered; terror module linked to JeM, AGuH

Police from J&K, Haryana, UP foil large-scale attack in coordinated operation

Srinagar, Nov 10: In a major crackdown against the "whitecollar terror ecosystem," Jammu and Kashmir Police in coordination with Haryana and Uttar Pradesh Police have arrested eight persons, including 3 doctors, recovering huge quantity of explosives, arms and ammunition from them.

An official told the news agency–Kashmir News Observer (KNO) that the Police have unearthed a transnational terror

module linked to proscribed Jaish-e-Mohammad (JeM) and Ansar Ghazwat-ul-Hind (AGuH). "The crackdown, spanned multiple states. It led to the arrest of eight accused, the seizure of explosives, arms, and encrypted communication tools," the official said.

He said, "The joint operation led to the recovery of around 2,900 kilograms of explosive material, arms, and ammunition from multiple states.'

A senior official said, "The busted network could be one of the most significant terror modules exposed this year, indicating that the group might have been planning a major attack. The recovery, among the largest in recent years, may have averted a serious incident in or near Delhi."

### Health experts urge timely immunisation to protect children from deadly diseases

Say vaccination key to eradicate life-threatening illnesses

Srinagar, Nov 10: Health experts have termed timely immunisation as a vital public health tool to protect infants and children from deadly, preventable diseases.

Immunisation, also called vaccination, is a process in which a person is made immune or resistant to an infectious disease by administering vaccines that stimulate the body's own immune system to fight future infections.

Once a vaccine enters the body, it triggers the production of antibodies. These antibodies remain in the body and help recognise and destroy the disease-causing organism if it attacks later.

Dr Murtaza, a general physician at the Directorate of Health



Services (DHSK), speaking to the news agency-Kashmir News Observer (KNO), said that due to immunisation, diseases like smallpox were completely eradglobally, while others such as polio, measles, diphtheria and tetanus have drastically

"Vaccines save millions of lives every year. A child who receives routine vaccines at the correct schedule gets protection against several fatal illnesses that can otherwise lead to disability or death," he said.

He added that immunisation not only protects the vaccinated individual but also the community by reducing the spread of infections. This is known as herd immunity — meaning when the majority of people are immunised, the remaining unvaccinated population, such as newborns or those with weak immunity, also gets indirect

Another doctor, Dr Javid Ahmad Mir, said that routine immunisation given under the national programmes covers diseases like polio, Hepatitis-B, tuberculosis (BCG), rotavirus, pneumococcal infection, measles-rubella, DPT (diphtheria, pertussis, tetanus) and others.

# **SC** notice to Centre on plea seeking women's reservation in Parliament

NEW DELHI: The Supreme Court on Monday sought the response of the Centre to examine a plea seeking implementation of the 2023 Nari Shakti Vandan Act which reserves one-third seats for women in the Lok Sabha and

the state assemblies. A bench of Justices B V Nagarathna and R Mahadevan issued notice to the Centre while observing that women were the largest minority in the country.

"Our Preamble to the Constitution of India says all citizens are entitled to political and social equality. Who is the largest minority in this country? It is the women. It's almost 48 per cent. This is about the political equality of women," Justice Nagarathna



Appearing for petitioner Jaya Thakur, senior advocate Shobha Gupta said it is unfortunate that women have to move the court for representation after 75 years of inde-

pendence of the country. She submitted that the Act reserves one-third of the total seats in the Lok Sabha and the state legislative assemblies based on data.

# DNA testing must be subject to stringent safeguards to protect dignity of individuals: SC

New Delhi, Nov 10: DNA testing cannot be ordered in a routine manner and must be subject to stringent safeguards to protect the dignity of individuals and the legitimacy of children born during the wedlock, the Supreme Court said on Monday.

A bench of Justices Prashant Kumar Mishra and Vipul Pancholi said the power to direct such tests must be exercised with utmost circumspection and only when the interests of justice imperatively

demand such an intrusive procedure.

The apex court said forcefully subjecting an individual to DNA testing constitutes a grave intrusion upon privacy and personal liberty.

Such an encroachment can be justified only if it satisfies the threefold test of legality, legitimate State aim, and proportionality, it said.

"DNA testing cannot be ordered as a matter of course and must be subject to stringent safeguards to protect the dignity of individuals and the legitimacy of children born



during the wedlock. "Courts must remain vigilant against fishing inquiries masquerading as legitimate

requests for scientific evidence, ensuring the sanctity of family relationships is not compromised by speculative

or exploratory investigations," the bench said.

The observations came on a plea filed by a Tamil Nadubased doctor challenging an order of the Madras High Court which directed him to appear before the Dean, Government Rajaji Hospital, Madurai for collection of blood samples for

DNA profiling. In this case, a Muslim woman from Pattukottai had filed a petition contending that poverty forced her to marry a divorcee from the same locality in 2001.

Her husband was suffering

from a skin ailment and, therefore, he approached the appellant, a doctor, for treatment. The appellant successfully treated his condition, which led him to confide in the doctor regarding his lack of progeny.

The husband requested the doctor to refer his wife to his first wife, who was a gynaecologist, for the necessary treatment. However, instead of referring, the doctor developed physical relations with her, resulting in the birth of a child on March 8, 2007.

It resulted in the petitioner's husband abandoning her.

In the meantime, she gave birth to a girl child. The doctor promised to look after her and the child and told her to stay at his house as a tenant. Accordingly, she gave 3 lakh to the doctor's wife and stayed there for a while.

She subsequently asked the doctor to marry her and make their relationship public. Upon his refusal, a quarrel ensued in 2014. Thereafter, the doctor began avoiding her.

Unable to sustain herself, the woman approached a Tamil TV channel and appeared on a programme | More on P6

### JMC intensifies measures to control air pollution levels

JAMMU, NOVEMBER 10: Jammu Municipal Corporation (JMC) has intensified its efforts to combat air pollution and ensure cleaner, safer air for the city's residents. The Corporation has put in place several on-ground and regulatory measures under the directions of JMC Commissioner Dr. Devansh Yadav to control dust and particulate emissions, particularly from vehicular movement and construction activities.

The initiatives have been taken in view of the rise in Air Quality Index (AQI) levels in Jammu. The AQI is a scientific index that indicates how clean or polluted the air is, along with the potential health risks associated with exposure to polluted air. The AQI level in Jammu has touched 179, which falls in the unhealthy category, making it a

matter of serious concern. Taking note of the situation, Commissioner Dr. Devansh Yadav has issued strict directions to all concerned wings of JMC to implement comprehensive anti-pollution measures. These include nighttime sweeping of main roads with modern mechanical sweeping machines to minimize dust dispersion and daytime water sprinkling across key traffic corridors, market areas and construction zones.

The Corporation is also using vehicles equipped with anti-smog guns to spray water mist, which helps to settle airborne dust particles. In an attempt to further reduce dust from construction and demolition activities, Dr. Yadav has ordered that all construction sites must be properly enclosed using green sheets, jute fabric or plastic covers at least three meters high to prevent dust from escaping into the open air.



# 32% power deficit in November likely

Srinagar, Nov 10: Amid winters, Jammu and Kashmir and Ladakh is likely to witness power deficiency of nearly 32 percent during the peak demand in the ongoing month.

Jammu and Kashmir and Ladakh during the peak demand will likely have a power deficit of 31.8 percent against the available power position.

The updated anticipated power supply position for November-2025 for both the Union Territories reveals that there will be a peak availability of 2490 Megawatts (MWs) against the requirement of 3653 MWs—keeping a loophole of 1163 MWs.

However, the official documents also said that representatives of HP SLDC, Punjab SLDC and J&K SLDC informed that the shortfall would be met through real-time exchanges and Banking arrangements.

Pertinently, in previous week reported that in Jammu and Kashmir, hydel power generation has reduced by nearly 70 percent from the local generation plants. An official had



informed that the power generation from all the power plants owned by Jammu and Kashmir has decreased by page 1970, 200 Morgawatts (MWs)

nearly 800-900 Megawatts (MWs).
The official had also said, "The power generation from across local power plants is currently ranging from 330 MWs to 400 MWs."

It also said, "From one of the plants from Baglihar, the power generation is ranging from 250-380 MWs and in case of another power plant of Baglihar, Kishenpur and New Wanpoh, we are generating a maximum of one MW."

The official further informed that the department is able to generate only 71 MWs from Kashmir based power plants.

About the power load and forced curtailment, the official said that there was a forecast of 1750 MWs for Monday—(KNO)

# Police foil protest in Jammu

Jammu, Nov 10: Police on Monday foiled a protest march by hundreds of daily wage employees of the Jal Shakti Department, who had taken out a rally to gherao the Civil Secretariat here, demanding the regularisation of their services and the release of pending wages.

The protest, which began near Indira Chowk, saw a large gathering of workers from various departments, including the Jal Shakti Department, Power Development Department (PDD), and other civil sector units.

The protesters marched towards the Civil Secretariat but were stopped by police near the main bridge, leading to a brief standoff.

Witnesses said the workers, shouting slogans in support of their demands, blocked parts of the road, causing traffic disruptions in the area. Police had to place barricades to prevent them from proceeding further.

Officials said the protesters were allowed to demonstrate peacefully but were stopped from entering the high-security Civil Secretariat area.

high-security Civil Secretariat area.
As the protest continued, the traffic movement around Indira Chowk and

nearby routes was affected.
Authorities appealed to the protesters to maintain calm and assured that their grievances would be conveyed to the higher authorities.

The daily wagers, however, said they would not call off their agitation until their long-pending demands were met. The protest ended in the evening, with the workers vowing to return if their long-pending demands.

issues remain unresolved. Earlier, speaking to KNO, the Daily



Wagers United Front, Jammu, urged the Chief Minister to table the committee report on the regularisation of daily wagers in the Assembly.

The daily wagers said they had been working for several years, in some cases for decades, but their services have not been regularised.

The workers alleged that despite repeated assurances from successive governments, their demands have not been met. They said the rising cost of living has made it difficult to survive on their current wages.

The water supply to the Chief Minister's house and other VIP areas in Jammu was temporarily shut down by protesting daily wage employees of the Jal Shakti Department but has since been restored.

The employees suspended the supply to draw attention to their demands for the regularization of their jobs and the release of pending wages. They said that disconnected water supply lines to the MLA hostel and the Chief Minister's residence in protest was a symbolic move to highlight their struggle.

Earlier demonstrations were held on October 23 and 27, coinciding with the start of the Assembly session—(KNO)

# Omar-led Govt 'directionless': Mehbooba

Srinagar, Nov 10: Peoples Democratic Party (PDP) president Mehbooba Mufti on Monday launched a blistering attack on Chief Minister Omar Abdullah, accusing him of deceiving the public, failing to fulfil pre-poll promises, and running what she termed as a "directionless government".

Addressing a press conference here, Mehbooba said the National Conference (NC) and its leadership have "nothing to tell the people" after one year of governance.

"Today, they (NC) have nothing to say to the public on the by-poll. Omar Abdullah, who had said he would remove smart meters when he came to power, is now advocating for them. Jammu, Nov 10: Chief Secretary, Atal Dulloo Monday chaired a comprehensive review meeting to assess the progress of the PM Surya Ghar Muft Bijli Yojana across Jammu and Kashmir. The meeting deliberated on the district-wise performance, challenges, and strategies to accelerate the implementation of this flagship rooftop solar (RTS) initiative aimed at promoting sustainable and affordable household energy solutions.

The meeting was attended by Additional Chief Secretary, Power Development Department (PDD), Shailendra Kumar; Principal Secretary, Finance; Commissioner Secretary, Industries & Commerce; Secretary, Science & Technology (S&T); Director General, Budget; Managing Directors of JPDCL, KPDCL, and JAKEDA, besides other senior officers. All Deputy Commissioners joined the meeting through video conferencing.

At the outset, it was informed that 5,413 consumers out of the total 13,579 rooftop solar installations under the scheme have already received zero electricity bills, reflecting tangible progress on the ground. The Chief Secretary underscored the importance of the scheme in transforming

the energy landscape of J&K, noting that as an energy-deficit region, the Union Territory stands to benefit immensely from the adoption of clean and reliable solar power. He called upon the Divisional and District Administrations to ensure smooth and timebound implementation of the scheme in every district.

Emphasizing on public outreach, Sh. Dulloo directed both power distribution companies (DISCOMs) to intensify awareness campaigns to educate citizens about the multiple benefits of the scheme, assist consumers in vendor selection, and facilitate speedy installations. He further stressed on robust monitoring and regular evaluation of district-level progress to achieve the set targets.

gress to achieve the set targets.

During the meeting, the Chief Secretary also took a detailed district-wise appraisal from the Deputy Commissioners, seeking insights on implementation challenges and local innovations. He urged the banks to enhance the rate of loan disbursement under the scheme, enabling better and faster uptake by eligible households.

Speaking on the occasion, ACS PDD, Shailendra Kumar, highlighted the need for enhanced coordination between banks, vendors, and district administrations,

urging financial institutions to actively publicize the lowest interest rates and subsidies available under the scheme. He stressed on maintaining transparency in vendor selection and prompt signing of consumer agreements

sumer agreements.

He also called for stringent monitoring of call centre performance and consumer feedback mechanisms, besides taking corrective action against underperforming vendors. He directed that the ongoing IEC campaign be further intensified across districts to generate awareness about the scheme's economic and environmental benefits.

The MD JPDCL, Gurpal Singh further informed that J&K has set a target of covering 83,500 households under the scheme. He added that as of date, 76,000 applications have been received, of which 37,500 consumers have selected vendors and 17,151 have signed agreements. Additionally, 13,615 rooftop solar systems have been installed, and Central Financial Assistance (CFA) amounting to Rs96.68 Cr has been released in favour of 11,297 beneficiaries.

The Chief Secretary later reviewed the progress made under the solarization of government buildings being undertaken by the Energy Development Agency of the Science & Technology Department and the Model Solar Village initiative. He directed the concerned departments to expedite implementation to ensure timely completion across all 20 districts.

About its implementation the Secretary, Science & Technology, Dr.Shahid lqbal Choudhary, apprised the meeting that J&K has made notable strides in the solarization of government infrastructure, with 6,716 buildings already solarized out of the 22,494 proposed, achieving a total installed capacity of 64.67 MW.

He further informed that under the 70 MW Rooftop Solar (RTS) Project, work orders for 47.45 MW capacity covering 4,338 buildings have been issued. Material delivery has been completed at 2,806 sites (35.88 MW), while 1,987 sites (25.50 MW) have been fully installed. An additional 5 MW capacity is currently in transit and expected to be delivered by November 30.

Concluding the meeting, the Chief Secretary reaffirmed the Administration's commitment to advancing the goals of clean energy transition and self-reliant power generation in Jammu and Kashmir through the effective implementation of the PM Surya Ghar Muft Bijli Yojana.

# Lift at GMC Baramulla out of order

Baramulla, Nov 10: A malfunctioning lift at Government Medical College (GMC) Baramulla on Monday caused severe inconvenience to patients and attendants, prompting outrage after video clips of the scene went viral on social media.

Visuals from the hospital showed attendants struggling to push wheelchairs and carry patients on stretchers up the stairs, drawing sharp criticism from locals and netizens. Netizens expressed strong resentment over the incident at North Kashmir's only tertiary care hospital, calling it a reflection of poor maintenance and weak accountability in the health sector.

"It is unfortunate. Such incidents show how poor maintenance can risk patient safety. Authorities must ensure constant monitoring," a user wrote.

Another user commented, "Every week we hear promises of better healthcare, but on ground, even a lift repair becomes a crisis", adding "If this is the condition of a government medical college, what can we expect from smaller hospitals?"

Meanwhile, despite repeated attempts from KNO, the GMC Principal could not be contacted as the official did not answer phone calls. However, GMC authorities, taking to their social media handle, acknowledged that the lift had gone out of order due to a technical fault and that repair work was underway. "The lift was rendered non-operational because of a technical issue. Repair work has already started and services will be restored soon", it stated. The incident in the meantime has renewed public criticism over poor infrastructure upkeep in major hospitals, with many online users demanded immediate action and a permanent maintenance system to avoid such lapses in the future-(KNO)

# J&K Health Department's Regressive Step

The Jammu and Kashmir Health Department's recent order denying pay and allowances to employees on maternity or paternity leave represents a shocking regression in workers' rights and gender equality. This punitive directive, which claims staff are "not executing their assignment" during legally sanctioned leave, not only violates fundamental ethical principles but also undermines decades of progress in protecting women's rights in the workplace. The order is particularly egregious, coming from the healthcare

sector, an institution meant to champion wellbeing. To suggest that maternity leave is a period of inactivity rather than essential recovery and childcare is both medically ignorant and socially regressive. This move disproportionately affects women doctors, forcing them to choose between financial stability and starting a family, effectively penalising them for motherhood. The department's contradictory stance of granting leave but withholding pay creates a dangerous precedent that could extend to other essential leave types. It reflects

a disturbing mindset that values employees only for their immediate productivity while disregarding their fundamental rights and dignity. As rightly pointed out by doctors, this violates both the spirit of labour laws and constitutional guarantees of gender equality. This decision comes at a time when healthcare systems globally are struggling to retain qualified professionals. Such punitive measures will only accelerate brain drain and demoralise an already overburdened workforce. The Resident Doctors Association's condemnation

highlights how this move threatens the very foundation of doctor welfare and patient care. The administration must immediately withdraw this discriminatory order and reinstate full pay and allowances during maternity leave. A society's progress is measured by how it treats its most vulnerable, including new parents. By reversing this decision, the government can demonstrate that it values both its healthcare workers and the fundamental principles of justice and equality that form the bedrock of our democracy.

# India's Soft Power Needs A Reset

We have still not tapped into the full potential of our tourism opportunities and have remained mired in bureaucratic ineptitude or partisanship, which sullies international perceptions

For long, the civilisational land of culturality and wisdom, India, has invoked its Soft Power. However, that projection got a fillip with the positing of the term "Vishwaguru," implying that the land was the teacher to the world. Packaging of elements like the intellectual–spiritual–philosophical past of the ancient land, along with the global fronting of Yoga and traditions of Ayurveda, were actively presented to suggest its timeless spirit.

Initially, the world was dazzled with the assertion of India as an overdue idea, whose time had come. The results started showing positively in various global indexes, and Delhi became the "must-go" capital for global leaders, conferences, and eyes rolled more welcomingly for India and Indians.

But, did it overplay that underlying Soft Power to lose its sheen of inclusivity, gentility, and humility, to then start looking more patronising, preachy, and even partisan? The murmurs in its neighbourhood (beyond Islamabad and Beijing) started whispering about what they thought was becoming an increasingly intrusive, paternalistic, and exclusivist reflection of the "Big Brother" syndrome. The Indian Government has seemingly read the tea leaves and started recalibrating the apparently condescending term "Vishwaguru" to a friendlier and more accommodating "Vishwamitra" — a friend of the world! It was a telling shift in outlook, as relations for Delhi had started deteriorating with Washington DC, Ottawa, Ankara, Tehran et al.

It became even more urgent to frame the



sovereign moorings towards a more practical and less ideological stance, as Delhi has to trapeze nimbly (often contradictorily) between unlikely powers and multilateral forums. It simply needs to win more friends globally than what is believed to be the truth domestically, but isn't. The inevitable worms of winning in domestic politics have started coming out in the woodwork of global perceptions.

The internationally recognised Henley Passport Index for 2025 has reconfirmed that subtle slide in global perceptions with

the weakened reflection of India's passport strength, as it fell five positions in a year to 85th globally. Tellingly, it was ranked 76th on the same index in 2014.

While calculation of the index is predicated on the verifiable number of countries that a citizen of a country can access without a prior visa, that number for Indians has actually increased from 52 countries in 2014 to 57 countries in 2025 — it simply isn't enough growth. More countries are entering into partnerships with each other than India is warming up to the rest of the world.

The global average of visa-free access has doubled from 58 in 2006 to 109 in 2025, and India has simply not kept pace with global integration and the war of perceptions. Even China, with all its taints of expansionism and belligerence, has rapidly increased visa-free access for its citizens from 50 to 82, all within a decade. Unsurprisingly, China's rank on the Henley Passport Index has moved in the opposite direction — from 94th to 60th within the last ten years.

The same retreating undercurrents are witnessed for US passport holders, as it dropped out of the top ten list for the first time. Its own restrictive policies, entry conditions, and reciprocal reactions by countries have led to a situation where the US passport is now tied with Malaysia at a joint 12th spot!

This shift in global mobility indexes and Soft Power dynamics is indicative of countries that either embrace openness and cooperation or don't. For example, Brazil and Vietnam ended visa-free travel for US citizens, citing a lack of reciprocity. Chickens borne out of Trump's isolationist, unilateral, and discriminatory policies are coming home to roost, as questionable legal barriers, sudden increases in entry fees, or threats of mass deportation are raising several "red flags" across capitals in the world. Collaterally, there has been an inexplicable surge in US citizens seeking alternative global residences or even citizenship options, forsaking the once powerful passport.

Meanwhile, China's charm offensives have included rapid expansion of visa exemptions, especially to many European countries, to drive traffic towards itself. India has

to introspect deeply about its own falling strength of passport beyond the passions of domestic politics that lead to unreasonable suggestions of our perceptions being either too rosy or too dismal in the eyes of the world.

We have still not tapped into the full potential of our tourism opportunities and have remained mired in bureaucratic ineptitude or partisanship, which sullies international perceptions. Goa is losing out increasingly to Sharm El-Sheikh, East Asian spots, and even the Turkish coastline as far more amenable, efficient, and affordable options.

The largest international draw to India, i.e. the Taj Mahal, remains diminished by the authorities for their own partisan reasons. The stranglehold of various local mafias, unbridled exploitation of natural resources, and garish new alternatives pushed as new tourism spots do not make India as attractive as it ought to.

We are perhaps developing too slowly and hence losing out in the battle of global perceptions — the domestic chorus to the contrary notwithstanding. It is imperative that we invoke our embarrassment of riches in culture, diversity, and varied topography, albeit with the befitting dignity, maturity, and confidence that befit a 5,000-year-old civilisation. Thus, the sublime concept of "Vishwamitra" is certainly timely, practical, and transformatory — the recent drop in Indian passport strength is a wake-up call.

# Sometimes It's Good To Be Embarrassed How certain types of embarrassment can fuel moral growth

Nobody likes to feel embarrassed. Indeed, our most painful and vivid memories are often of experiences in which we were humiliated by or in front of others. Embarrassment can lead to shame and self-loathing. It can diminish our confidence, shake us from our sense of certainty, and cause the kind of repression that expresses itself in all types of neuroses. When we feel embarrassed, we want to avoid others and conceal that of which we are ashamed. More than this, we want to escape our embarrassment and ensure that whatever gave rise to it in the first place does not happen again. We tend to view embarrassment as an unqualified evil. To be embarrassed, we think, is a fate that must be avoided at all costs.

And yet, there are times when embarrassment has salutary effects. In some circumstances, feeling embarrassed is not only necessary but good. It helps us to see where we have gone wrong and teaches us to want to do otherwise. It is a corrective for behavior that needs correcting and reminds us of the fact that we are not infallible, but vulnerable, broken creatures who need one another's mercy, forgiveness, and love.

An example from a little-remarkedupon scene in Dostoevsky's The Brothers Karamazov may help to serve the point. Dmitri, the oldest of the Karamazov brothers, is a drunkard and a rogue. He is notorious for throwing lavish parties, typically funded with other people's money, and gorging himself on sweets, champagne, vodka, and women. He flies into fits of anger and lashes out at anyone unfortunate enough to be in his vicinity at the time. He wallows in depravity. His debauched lifestyle knows no limits.

After beating his father and stealing a fistful of the old man's money, he blows every cent of it on a carnivalesque night of partying and excess. In the early hours of the next morning, as he makes plans to run off with one of his mistresses, the police arrive and arrest him for his father's murder. The patriarch of the Karamazov family, it seems, had not simply been beaten but was eventually killed, and Dmitri is the prime suspect.



At first, Dmitri is obstinate, refusing to go along with the investigation. He is proud and even condescending in his own defense. But then the arresting officers ask him to strip so they can search his clothes for clues and weapons, and Dmitri's demeanor undergoes a profound change. He feels disgraced to have to sit undressed in a room full of people wearing clothes and is even more embarrassed when he is asked to remove his socks—"they were not very clean, nor were his underclothes, and now everyone could see it."

How, one might ask, could such a degrading circumstance be considered good? In what way can so humiliating a situation be

beneficial? And yet there is no doubt that

Dmitri benefits from it.

Sitting undressed before the men investigating him for murder reveals his vulnerability. More than that, it shows him how disorderly his life has become. His dirty undergarments attest to the disgraceful way he has been conducting himself. Confronted with his own weakness, mortified by the uncleanliness in which he has chosen to live, Dmitri lets go of his conceit and expresses remorse for his boorish behavior. His embarrassment has helped him to become selfaware and provided him with the opportu-

nity to reform his ways.

The 20th-century rabbi and theologian

Abraham Joshua Heschel had a similar notion of the humility gained through humiliation in mind when he asserted that "What the world needs is a sense of embarrassment." For Heschel, the virtue of embarrassment is that it robs us of our certainty and self-satisfaction. The gravest danger, he argued, is to believe oneself morally justified, especially in a world in which oppression and injustice reign supreme.

"The end of embarrassment," Heschel wrote, "would be the end of humanity." For humanity and humility go hand in hand.

I am afraid of people who are never embarrassed at their own pettiness, prejudices, envy, and conceit, never embarrassed at the profanation of life. A world full of grandeur has been converted into a carnival. There are slums, disease, and starvation all over the world, and we are building more luxurious hotels in Las Vegas. Social dynamics is no substitute for moral responsibility.

According to Heschel, feeling embarrassed not only keeps our worst impulses in check; it also opens us to the wonder of existence by reminding us of how small we are in relation to a life that is always more than we expected. When we become aware of just how mysterious and uncertain life really is, we grow in our appreciation for that which transcends us.

Insisting that embarrassment is a protection "against arrogance, hybris, self-deification," Heschel suggests that humility is the true path to fulfillment. When we learn to feel embarrassed by our shortcomings, we begin to see the world, and ourselves, more clearly. And it is only then that we can live in love and harmony with one another.

Throughout the rest of The Brothers Karamazov, Dmitri is confronted by countless hardships, including being put on trial for a murder he did not commit. And yet, from the time of his arrest on, he remains one of the most honest, faithful characters in the book. His embarrassment has changed him. He has grown in the face of it. Would that we all respond to embarrassment in the same way.

During the field inspection, the Chief Secretary assessed the current status of both the barrage structures and chaired a detailed meeting on site to review project milestones. He was informed that all gates of the Tawi Barrage have been installed and are functional and that the

hydro mechanical works have reached an advanced stage.
The officers also briefed scenned

the Chief Secretary about the ongoing rectification works necessitated by recent flood damages. The flood events had impacted some of the mechanical and civil components, for which restoration and reinforcement activities are presently underway.

The meeting also reviewed the Tawi Riverfront Development Project, which is progressing simultaneously on both the left and right banks of the river. The Chief Secretary stressed adherence to project timelines and emphasised the need for strict monitoring of execution

schedules and quality standards. He directed the concerned departments to expedite works, particularly on the right bank. He reiterated that timely completion of both the barrage and riverfront components is essential for the integrated rejuvena-

tion of the river corridor and

the enhancement of Jammu's

urban landscape.

Officers apprised the Chief Secretary that the twin barrage system, covering both Nikki and Waddi Tawi channels, will enable better regulation of river flow, interception and diversion of multiple nallahs and creation of a controlled water body that will support the beautification and flood management components of the project. The project also aims to strengthen the city's resilience against future flooding while providing recreational and tourism benefits to residents and visitors.

# Study finds patients of chronic fatigue may tend to have abnormal breathing

New Delhi, Nov 10: Researchers have found that people with chronic fatigue syndrome tend to experience shortness of breath, which offers a target for treatment and may bring relief from symptoms.

Chronic fatigue syndrome is marked by exhaustion that persists despite rest and cognitive problems, including brain fog and difficulty concentrating.

The researchers from the US' Icahn School of Medicine at Mount Sinai monitored 57 patients diagnosed with chronic fatigue syndrome while performing physical activity.

Results published in the journal Frontiers in Medicine show dysfunctional breathing can look like a deep sigh while breathing ordinarily, overly rapid breathing or shallow breathing so that lungs are never properly breathing.

A loss in coordination be-

tween chest and abdomen could also prevent the varied muscles that help one breathe from working together, they

"While we know the symptoms generated by hyperventilation, we remain unsure what symptoms may be worse with dysfunctional breathing," author Dr Donna Mancini from the Icahn School of Medicine

"But we are sure patients can have dysfunctional breathing without being aware of it.



Dysfunctional breathing can occur in a resting state," Dr Mancini said.

authors "Dysfunctional breathing and hyperventilation are com-mon in patients with ME/CFS (chronic fatigue syndrome) and could present a new therapeutic target for these patients.

Heart rate and blood pressure of the participants, which also included 25 healthy ones, were measured along with oxygen saturation of blood, while doing cardiopulmonary exercises over two days.

How fast, hard or effectively the participants breathed to get oxygen and patterns in breathing were observed to differentiate hyperventilation and dysfunctional breathing, the researchers said.

While participants having chronic fatigue were seen to take in the same amount of oxygen as the healthy ones, 71 per cent were seen to experience breathing problems either hyperventilation, dysfunctional breathing, or both.

Both dysfunctional breathing and hyperventilation can cause symptoms similar to chronic fatigue, such as dizziness, difficulty focussing, a shortness of breath and exhaustion, the researchers said.

Combining the two -- nine patients of chronic fatigue showed dysfunctional breathing and hyperventilation. It can also cause people to experience heart palpitations, chest pain, fatigue, and anxiety, they

The team suggested that breathing problems could worsen or even directly contribute to post-exertional malaise, in which symptoms of chronic fatigue syndrome get worse following mental or physical exercise.

### Defence of satire by webseries makers not absolute: Wankhede counsel to Delhi HC

New Delhi, Nov 10: The counsel for IRS officer Sameer Wankhede in a defamation suit relating to the series 'The Ba\*ds of Bollywood on Monday told the Delhi High Court that the makers of the web-series were hiding behind a disclaimer, and their defence of satire was not absolute.

Wankhede has filed a defamation suit against Red Chillies and Netflix for allegedly maligning his reputation in their series and sought Rs 2 crore in damages, which he wants donated to the Tata Memorial Cancer Hospital for cancer patients.

On October 8, the high court issued notices and summons to defendants Red Chillies Entertainment Private Limited, Netflix, X Corp (for-merly Twitter), Google LLC, Meta Platforms, RPSG Lifestyle Media Private Limited and John Doe in the defamation suit and asked them to file their replies within seven days.

In the last hearing, Justice Purushaindra Kumar Kaurav had granted time to Wankhede, actor Shah Rukh Khan-owned Red Chillies Entertainment and OTT platform Netflix to file their written submissions.

During the proceedings on Monday, Wankhede's counsel said that the makers of the web series were hiding behind a disclaimer and had taken a "sly approach."

"Disclaimer is of no consequence. The proof of pudding is how people consume it," the advocate said.



"The defence of satire is not absolute. You have taken potshots at me in my professional capacity," he added.

The counsel said that the spoof and innuendos on the officer were because of malice and vendetta.

"This is vendetta passing off as fiction," Wankhede's counsel said. The court then posed ques-

tions about artistic freedom to the production house.

The arguments by Red Chillies will commence on November 17.

In interim relief, Wankhede has sought removal of the alleged defamatory content from several websites.

His plea states that the series disseminates a misleading and negative portrayal of antidrug enforcement agencies, eroding public confidence in law enforcement institutions.

Wankhede said the series has been deliberately conceptualised and executed with the intent to malign his reputation in a colourable and prejudicial manner, especially when the case involving the officer and Shah Rukh Khan's son Aryan Khan is pending and sub judice before the Bombay High Court and the Narcotic Drugs and Psychotropic Substances (NDPS) Special Court in Mumbai.

In Budgam, the bye-poll has evolved into a major political event, widely seen as a referendum on Chief Minister Omar Abdullah's leadership and the NC government's performance since taking office last year.

The seat fell vacant after Omar Abdullah vacated it in 2024, choosing to retain Ganderbal. Seventeen candidates are contesting from Budgam, which has 1,26,025 registered voters

and 173 polling stations. The main contest is between NC's Aga Syed Mehmood and PDP's Aga Syed Muntazir Mehdi. BJP's Aga Syed Mohsin, AIP's Nazir Ahmad Khan and independent candidate Muntazir

Mohiuddin are also in the fray, making the election a multi-cornered battl Budgam has long been considered NC's citadel, having elected the party's candidates in nearly every election since 1962, except in 1972

when the Congress won. Former MLA and now NC MP Aga Ruhullah Mehdi had earlier represented the constituency three times before Omar Abdullah's 2024 victory. However, Ruhullah's public disagreement with the party leadership over the reservation policy and other governance issues led to him distancing himself from the campaign, a setback the NC is trying to offset with its full

organizational machinery. The ruling party deployed top leaders, including Chief Minister Omar Abdullah, Deputy Chief Minister Surinder Singh and MLAs from across Jammu and Kashmir to campaign for Aga Mehmood.

Omar Abdullah personally led roadshows and gatherings over the past three days, urging voters to back his party's candidate.

The opposition, led by the PDP, mounted a sharp attack accusing the government of failing to deliver on key promises such as job creation, 200 units of free electricity, and a fair reservation policy.

The ruling NC has countered these attacks by reviving the issue of Articles 370 and 35-A, with Omar accusing the PDP of enabling the abrogation through its past alliance with the BJP in 2014. With an estimated 30-35% Shia population,

Budgam's voting pattern will likely be shaped by intra-community competition, as both major candidates belong to influential Aga families. Ruhullah's absence complicated the NC's

campaign strategy, but Omar Abdullah's personal involvement may have helped the party to consolidate the support. Election officials said all polling stations in

Budgam are equipped with essential facilities, including power, ramps and drinking water, with CCTV and webcasting in place for monitoring. Polling will begin at 7 am and continue

Analysts are of the opinion that the results in both Budgam and Nagrota will indicate where do the ruling NC government and the opposition BJP stand as on date. (KNO)

Based on his inputs, another accused, Dr. Muzammil Shakeel, a faculty member at Al-Falah University in Faridabad, was arrested.

During a search at his rented accommodation, police recovered 360 kg of suspected ammonium nitrate, arms, and other materials.

Gupta said the recovered items included an assault rifle with three magazines and 83 live rounds, a pistol with eight rounds, 20 electronic timers, 24 remotes, walkie-talkie sets, batteries, electric wires, and several bags containing inflammable chemicals. He clarified that the rifle recovered was not

an AK-47 but a similar assault weapon and that the explosive material was not RDX but inflammable chemicals likely used for making improvised explosive devices (IEDs). A cleric from the locality was also detained

for questioning, and forensic analysis of the recovered materials is underway. The Commissioner said the accused are be-

ing jointly interrogated by J&K Police, Haryana Police, and central agencies. Later in the day, Jammu and Kashmir Police issued a statement confirming the arrests of seven individuals connected to the same The police said the case relates to an FIR reg-

The police statement said the investigation uncovered a "white-collar" terror ecosystem involving radicalised professionals and students linked with handlers based in Pakistan and other countries. The group allegedly used encrypted channels for communication, coordination, and fund transfer under the guise of charitable and academic activities.

Police said the accused were engaged in radicalising individuals, raising funds, and arranging logistics and materials for IED preparation.

During searches across multiple districts, police recovered two pistols (Chinese Star and Beretta models), an AK-56 rifle, an AK Krinkov rifle, and approximately 2,900 kilograms of IED-making material, including explosives, chemicals, electronic circuits, remotes, and metal sheets.

A separate case has been registered under relevant sections of the Unlawful Activities Prevention) Act (UAPA), Arms Act, and the Explosive Substances Act.

Financial investigations are underway to trace the flow of funds and identify additional links within and outside the country.

Officials said further searches and arrests are likely as the investigation continues to determine how such large quantities of explosive material were transported and stored near the national capital without detection. (KNO)

per cent women reservation," it said. The plea further said that the constitutional amendment cannot be put on hold for an uncertain period. In fact, a special session was convened to amend the law for implementing reservations in Parliament as well as in the state legislatures. Both Houses passed this Bill unanimously, the President of India also gave the assent and the Act was notified thereafter on September 28, 2023.

Interestingly, on January 10, the top court refused to examine the pleas challenging the delimitation clause in the 2023 Act.

The top court was not inclined to entertain the petition filed by Jaya Thakur and the National Federation of Indian Women (NFIW) under Article 32 of the Constitution.

The bench pointed out that Jaya Thakur's petition challenged the Bill, which has now become an Act, whereas the NFIW challenged the delimitation clause of the law. While Thakur's plea was dismissed as infruc-

tuous, the court was not inclined to examine

There were efforts to pass the Bill in arliament since 1996 and a last such attempt was made in 2010, when the Rajya Sabha approved a Bill for women's reservation, but it could not be passed in the Lok Sabha.

Data showed women MPs account for nearly 15 per cent of the Lok Sabha strength whereas their representation was below 10 per cent in many state assemblies. PTI

"Scientific procedures, however advanced, cannot be employed as instruments of speculation; they must be anchored in demonstrable relevance to the charge and justified by compelling investigative need," it said.

## 3.7 crore voters to decide electoral fate of 1,302 candidates in 122 seats

Patna, Nov 10: Electoral fortunes of 1,302 candidates, including over half a dozen ministers in the Nitish Kumar government, will be sealed on Tuesday with 3.70 crore voters eligible to exercise their franchise across 122 assembly segments in the second and final phase of the Bihar polls.

The districts going to polls on November 11 include West Champaran, East Champaran, Sitamarhi, Madhubani, Supaul, Araria and Kishanganj, and all these share borders with Nepal.

Security has been beefed up across Bihar for the second phase of the assembly polls with over 4 lakh personnel engaged in election duties, officials said.

Most of these districts fall in the Seemanchal region, which has a high concentration of Muslim population, making it a high-stakes battle for both the INDIA bloc, which banks on the support of the minority community, as well as the ruling NDA, which alleges that the opposition is "protecting infiltrators".

Prominent candidates include Bijendra Prasad Yadav, a veteran JD(U) leader and the most senior member of the state cabinet, who seeks to retain his Supaul seat for a record eighth term. Similar is the case of his cabinet colleague Prem Kumar, who belongs to the BJP and is trying his luck from Gaya Town,



which he has won seven times, on the trot, since 1990

Other ministers whose electoral fates are on stake include BJP's Renu Devi (Bettiah) and Neeraj Kumar Singh "Bablu" (Chhatapur), and [D(U)'s Leshi Singh (Dhamdaha), Sheela Mandal (Phulparas) and Zama Khan (Chainpur).

Another prominent BJP leader who is in the fray is former deputy chief minister Tarkishore Prasad, who seeks to retain the Katihar seat for a fifth consecutive term.

Katihar district is also home to Balrampur and Kadwa assembly seats, where a hat-trick is being aimed at by Mehboob Alam and Shakeel Ahmed Khan, respectively, the legislative party leaders of CPI(ML) Liberation and the Congress.

The second and final phase is also being seen as a veritable test of strength for minor NDA partners Hindustani Awam Morcha,

headed by Union minister Jitan Ram Manjhi, and Rajya Sabha MP Upendra Kushwaha's Rashtriya Lok Morcha, both of which have got six seats each.

All six seats contested by HAM are going to the polls in the second phase. Four of these, Imamganj, Barachatti, Tikari and Sikandra, are currently held by the party, and the sitting MLAs have been given the chance to try

their luck again. Notably, Manjhi held the Imamganj seat till he got elected to the Lok Sabha from Gaya last year, and it was retained, in the ensuing by-poll, by his daughter-in-law Dipa. Barachatti is held by Dipa's mother

Candidates of the RLM, which was floated barely a couple of years ago and has no representation in the state legislature, include Kushwaha's wife Snehlata and his most trusted aide Madhaw Anand, who are making their debut from Sasaram and Madhubani, respectively. Four of the six candidates fielded by the party are going to the polls in the second phase. Another important candidate in the fray is state Congress president Rajesh Kumar, who hopes to retain the reserved seat of Kutumba for a second consecutive term.

Votes will be cast at 45,399 polling stations, of which 40,073 fall in rural areas.

A number of turncoats are also in the fray. These include Mohania MLA Sangita Kumari, who won the seat as an RID candidate in 2020 but is now contesting on a BJP ticket, and Vibha Devi, the MLA from Nawada, who recently quit the opposition

and joined the JD(U).
Similar is the case of Murari Gautam, who was a minister from the Congress quota in the 'Mahagathbandhan' government, crossed over to the NDA when Nitish Kumar realigned with the BIP last year.

He is now in the fray from his sitting seat of Chenari on the ticket of Lok Janshakti Party (Ram Vilas), headed by Union minister Chirag Paswan. Another keenly watched candidate will be Chanakya Prakash Ranjan, whose father is a former state minister and second term JD(U) MP from Banka, who raised many eyebrows by joining the RJD ahead of the assembly polls. He is contesting the Belhar seat on the opposition party's symbol.

Voting, in the second phase, will take place across 45,399 polling stations, of which 40.073 fall in rural areas. More than half of the electorate (2.28 crore) is aged between 30 and 60 years. Only 7.69 lakh are in the 18-19 years age group.

The total number of women voters in the 122 constituencies is 1.75 crore.

The Hisua seat in Nawada district has the largest electorate (3.67 lakh), while Lauria, Chanpatia, Raxaul, Triveniganj, Sugauli and Banmakhi have the most number of candidates (22 each).

### SC seeks Centre's reply on plea for implementation of 2023 women reservation Act

New Delhi, Nov 10: The Supreme Court on Monday sought the response of the Centre to examine a plea seeking implementation of the 2023 Nari Shakti Vandan Act which reserves one-third seats for women in the Lok Sabha and the state assemblies.

A bench of Justices B V Nagarathna and R Mahadevan issued notice to the Centre while observing that women were the largest minority in the country.

"Our Preamble to the Constitution of India says all citizens are entitled to political and social equality. Who is the largest minority in this country? It is the women. It's almost 48 per cent. This is about the political equality of women," Justice Nagarathna said.

Appearing for petitioner Jaya Thakur, senior advocate Shobha Gupta said it is unfortunate that women have to move the court for representation after 75 years of independence of the country.

She submitted that the Act reserves one-third of the total seats in the Lok Sabha and the state legislative assemblies based on data. The bench said enforcement of the law is the prerogative of the executive and no mandamus can be issued in these matters.

"The courts have limitations when interfering with such policy matters,"

# Air quality very poor in Delhi

At 9 am, Delhi's overall Air Quality Index (AQI) stood at 345, CPCB data showed. Visuals from across the city showed a thick layer of haze reducing visibility in several areas. According to the Sameer

app, Bawana recorded 'severe' air quality with an AQI of 411, followed by Wazirpur at 397. Out of 38 monitoring stations, one station (Bawana) reported 'severe' air quality, while 33 others remained in the 'very poor' range.

The city's air quality had deteriorated sharply on Sunday morning, reaching this season's worst level of 391 before slightly improving later in the day. At 4 pm, the overall AQI stood at 370, placing Delhi in the 'red zone', CPCB data showed.

the logic behind using trump card Jasprit Bumrah for three overs in the powerplay during the recent Asia Cup that India won.
"A lot of people relate

to this T20 side as a very aggressive batting lineup. For me I think bowling Jassi 3 in the first six was an even more aggressive option with the ball. We don't want to be a side which is only known as an aggressive batting order, we want to be a side which should be known as an aggressive side overall,"

## **BBC** chairman Samir Shah apologises for 'error of judgment' over Trump speech edit

London, Nov 10 (PTI) The BBC's Indian-origin chairman, Samir Shah, on Monday apologised on behalf of Britain's public broadcaster for an "error of judgment" in the way a speech by US President Donald Trump was edited

for a documentary.
Shah's apology came in a letter addressed to the chair of the UK Parliament's Culture, Media and Sport Committee following days of raging controversy, which led to the resignation of BBC direc-tor-general Tim Davie and BBC News CEO Deborah Turness on

The documentary in question involved an episode of BBC's 'Panorama' programme aired last year, which appeared to show Trump make a direct call to his supporters to storm the Capitol in Washington DC on January 6, 2021.

"The BBC would like to apologise for that error of judgement," said Shah, in his letter addressed to the House of Commons committee. It was a leaked memo written by former adviser Michael Prescott that the splicing together of separate parts of Trump's speech was first criticised.

The BBC confirmed that it has received a letter from Trump threatening legal action against the broadcaster over the issue.

On his Truth Social platform, the US president had reacted to the resignation of Davie and Turness by dubbing them "very dishonest people who tried to step on the scales of a presiden-

"Since the publication of



Prescott's memo, this issue has led to over 500 complaints. These are now being dealt with in the normal way. It has also prompted further reflection by the BBC. The conclusion of that deliberation is that we accept that the way the speech was edited did give the impression of a direct call for violent action," Shah's letter states.

In the same leaked memo, Prescott had also claimed there was an "anti-Israel bias" in BBC Arabic's coverage.

"The board will commit to revisiting each and every item set out in Michael Prescott's note, and take further action where appropriate. We will be transparent about the conclusions we reach and the actions taken," Shah informed Parliament.

"I would like to assure you and the Committee that I am absolutely clear that the BBC must champion impartiality," he said, in the letter addressed to the Committee chair, Conservative Party MP Caroline Dinenage.

"I will personally ensure that the BBC continues to take the necessary actions in the future

trust and confidence of the public we serve. I'd like to conclude by restating the importance of high quality, independent journalism in today's polarised society," he said.

Shah added that he saw the BBC's "sacred job" as meeting an increasing need for the public to be informed in a way that's "impartial, truthful and based on

evidence they can trust".
As Chair, Shah is responsible for the British Broadcasting Corporation (BBC) board upholding and protecting the independence of the broadcaster and making its decisions in the public interest.

He took charge as the first Indian-origin media executive in the 160,000-pounds a year role in March this year for a four-year term.

Born in Aurangabad, Shah came to England in 1960 and has previously been the head of current affairs and political programmes at the BBC. He was honoured with a CBE by Queen Elizabeth II in 2019 for services to television

### Nepal to seek logistic support from India for upcoming general election

Kathmandu, Nov 10: Nepal's electoral body on Monday said that it will approach neighbouring countries, mainly India, to seek logistic support for the upcoming gen-

"The Election Commission has sent its demand list to the government to be handed over to the neighbouring countries, India and China, through diplomatic channels," acting Chief Election Commissioner Ram Prasad Bhandari said talking to PTI During a meeting with government officials and the commission staff, the representatives from the two countries have expressed their willingness to extend logistic support for elections scheduled for March

A couple of weeks ago, there was a meeting between the government and representatives of diplomatic missions and development partners, in which Prime Minister Sushila Kaki had sought their support for the upcoming elections. India had provided 200 vehicles as logistic support to the Nepalese government during the general election in 2022, which were utilised by the Election Commission and the various security agencies.

However, during the September Gen Z movement, nearly 600 government vehicles were either vandalised or burnt, hence, more vehicles are needed this time. It has been estimated that at least 400 vehicles are required to conduct the elections.

# Sourav Ganguly backs fit-again Shami

Says he should play for India across formats

Kolkata, Nov 10: Former India captain Sourav Ganguly wants to see Mohammed Shami back in the Indian team across formats, as he reckons the skillful pacer is 'fit and is bowling exceptionally well'.

The Ajit Agarkar-led selection committee, however, appears to have moved on from the 35-yearold pacer, who has been ignored for the upcoming two-Test series against South Africa and last played in the Champions Trophy in March.

"Shami is bowling exceptionally well. He is fit and we saw in the three Ranji Trophy matches, where he's won Bengal on his own," Ganguly said on Monday after being announced as the global brand ambassador of Kabuni, a UK-based AI-driven sports coaching platform.

Shami has so far claimed 15 wickets to help Bengal to successive wins in their first two Ranji Trophy matches before going wicketless against Tripura. He has bowled 91 overs in three matches this season.

The veteran pacer underwent ankle surgery following the 2023 World Cup, where he finished as the tournament's leading wicket-taker with 24 scalps at an



average of 10.70.

"I'm sure the selectors are watching and there is a communication between Mohammad Shami and the selectors. But if you ask me, in terms of fitness and skill, it's the Mohammad Shami we know of. So, I really don't see any reason why he can't keep playing Test matches, One-day cricket and T20 cricket for India. Because that skill is enormous," Ganguly said.

With no red-ball assignments

for India over the next six months, it remains to be seen if Shami has already played his last Test - the World Test Championship final against Australia at The Oval in June 2023.

In the longer format, Prasidh Krishna and Akash Deep have become an integral part of the pace attack. For the 2027 ODI World Cup still two years away, Shami's recurring injury concerns could influence the
