Sgr records season's coldest night at minus 1.6°C

MeT predicts dry weather, says slight improvement likely after Nov 17

Srinagar, Nov 12: The winter chill has intensified across the valley with Srinagar, the summer capital of Jammu and Kashmir, recording the coldest night of the season at minus 1.6 degrees Celsius.

As per the news agency— Kashmir News Observer (KNO), details shared by the Meteorological (MeT) Department reveal Pahalgam, was the coldest in valley, where the mercury settled at minus 3.8 degrees

Qazigund, a gateway of Kashmir, recorded a low of minus 1.5 degrees Celsius while the mercury settled at minus 2.0 degrees Celsius in Kupwara.

As per the details, Gulmarg, a famous ski resort, has recorded a minimum temperature of minus 1.0 degrees Celsius. Kokernag, however, recorded

a night temperature of 0.8 degrees Celsius.

Unlike the minimum temperature, the day temperature continued to settle above normal except in Gulmarg, where the mercury settled at 8.4 degrees | More on P6

Steady rise in HIV cases in J&K: 117 patients registered in three months Doctors call for regular testing, safe practices, awareness to curb infection spread

Srinagar, Nov 12: The HIV cases in Jammu and Kashmir are showing a steady increase, with 117 positive patients registered for care from April to June 2025.


As per the details available with the news agency - Kashmir News Observer (KNO), from April to June 2025, 117 HIV-positive individuals, including 80 males, 34 females, and three minors, were registered for HIV care.

This information was disclosed through a Right to Information (RTI) file obtained by RTI activist MM Shuja and

accessed by KNO.

According to the data, 361 new cases were registered in 2019-20, with 17 deaths in the same year. In 2020-21, 206 cases were registered and 12 people died; in 2021-22, 272 cases were registered with 19 deaths; in 2022-23, 374 cases with 21 deaths; in 2023-24, 338 cases with 14 deaths; and in 2024-25, 403 cases with 16 deaths.

Meanwhile, health experts in Iammu and Kashmir have urged people to adopt preventive measures and spread awareness to protect themselves and others from Human Immunodeficiency



Virus (HIV), which continues to be a serious public health concern.

Doctors said that despite advancements in treatment and

increased awareness, new cases are still being reported due to a lack of education about safe practices and preventive steps. They said prevention remains the most effective way to combat HIV.

Dr Showkat Ahmad, a senior physician at GMC Srinagar, said, "HIV is preventable if people remain aware and follow basic precautions. Unprotected sexual contact, use of unsterilized syringes, and transfusion of unscreened blood are major routes of transmission. People must be cautious and responsible."

He added that the availability of Antiretroviral Therapy

(ART) has improved the quality of life for those living with HIV, but preventing the infection remains crucial. "Early diagnosis through regular testing can help control the spread and enable timely treatment," he said.

Doctors highlighted the importance of using disposable syringes, ensuring blood safety before transfusion, and promoting safe sexual practices. They said there should be no stigma attached to people living with HIV, as social discrimination often prevents individuals from seeking timely medical help.

Dr Mariya Jan, a health

educator, said, "Awareness at the grassroots level, particularly among youth, is vital. Schools, colleges, and community organisations should participate in educational campaigns so that people understand how the virus spreads and how to stay safe."

Health authorities have urged people to avail of free HIV testing and counselling facilities available at government hospitals and Integrated Counselling and Testing Centres (ICTCs) across the Union Territory.

Reviews functioning of SED in Kashmir

SRINAGAR, NOVEMBER 12: Minister for Education Social Welfare, Health and Medical Education, Sakeena Itoo Wednesday chaired a review meeting at Civil Secretariat here to assess the performance and functioning of the School Education Department across Kashmir division Kashmir division.

The meeting was attended by Director School Education Kashmir, Naseer Ahmad Wani; Joint Directors of School Education department (SED), Chief Education Officers of all districts of Kashmir division and other concerned officers of SED.

During the meeting, the Minister held detailed assessment on key operational areas of school education sector like academic performance of schools, infrastructure development, teacher deployment, timely distribution of school textbooks and other materials, besides issues related unregulated selling of school textbooks by private schools through various agencies on exorbitant rates was also discussed in detail.

Addressing the officers in the meeting, Sakeena Itoo emphasized on the importance of ensuring that all schools across the region receive textbooks and other learning materials before the commencement of academic session. "Timely availability of books and supplies is crucial to maintaining the academic calendar and ensuring that no student is left behind," the Minister said.

She directed officials to streamline the distribution process through improved coordination between the divisional and district education offices, adding that transparency and accountability must be maintained at every level.

While reviewing other issues related to the School Education



sector, the Minister issued strict instructions to CEOs to check unregulated selling of school textbooks by private schools through various agencies at exorbitant rates. "Conduct routine checks on schools as well as book shops and take stringent action against schools and book shops involved in selling textbooks at exorbitant rates, the Education Minister stated.

She also instructed the Director School Education to issue a detailed order regarding curriculum/textbooks to be followed by schools and make each CEO implement that order in letter and spirit. She asked the CEOs to take appropriate action against schools violating this order.

The Minister also called for timely processing of GP funds and directed the CEOs to submit detailed report outlining the number of cases submitted and pending with each CEO.

Regarding coaching centres, the Minister directed the CEOs to conduct regular checks on coaching centres and ensure that they are following safety protocols. She also asked them to take action against unregistered coaching centres.

Highlighting the role of teachers in shaping the future of students, the Minister called for regular capacity-building and training programs to enhance teaching standards. She also stressed the need to strengthen monitoring mechanisms to ensure punctuality, performance, and effective classroom engagement.

The Minister further urged the department to ensure that all pending administrative and academic issues are resolved in a time-bound manner. She assured that the government is committed to improving the quality of education and creating an enabling environment for students and teachers alike.

JAMMU, NOVEMBER 12: Chief Secretary, Atal Dulloo Wednesday chaired a high-level meeting to review the performance of the Cooperative Department and assess the progress achieved in promoting cooperative activities and financial reforms across I&K.

The meeting was attended by Principal Secretary, Finance; Commissioner Secretary, Cooperatives; Regional Director, RBI; Managing Director, J&K Bank; Director General, Budget; Registrar, Cooperative Societies; representatives from NABARD and other banks, besides senior officers of the department.

At the outset, the Chief Secretary emphasized the vital role of cooperative institutions in rural development and directed for transforming Cooperative Societies into Common Service Centres (CSCs) to widen their service base. He called for modelling these societies on sound business lines, enabling them to diversify into various rural business activities such as the sale of seeds, seedlings, cattle and poultry feed, and fisheries supplies.

He further directed the department to explore collaboration with the Ayush Department for vending popular wellness products and securing vending machines for installation at high-footfall locations. He stressed on enhancing credit linkage for cooperative entities and strengthening their financial base through sustainable business

While reviewing the financial status of cooperative banks and

the performance of Super Bazars, the Chief Secretary asked J&K Bank to extend advisory support in matters related to Non-Performing Assets (NPAs) and other financial issues to help Cooperative Banks address them in legally sound and professionally man-

aged ways. He also instructed the department to constitute a panel of retired bankers of high integrity, in consultation with RBI, to assist in the appointment of Managing Directors and professional management bodies, aimed at placing Cooperative Banks on modern, transparent, and performance-driven lines.

Commissioner Secretary, Cooperatives, Babila Rakwal, informed that the UT's cooperative sector is witnessing a major transformation with the adoption of the Multi-Purpose Primary Agricultural Credit Societies (M-PACS) model and a range of reforms for growth and financial stability. She apprised that all 537 PACS have adopted common byelaws to function as M-PACS, allowing diversification into allied sectors such as dairy, fisheries, and horticulture. The computerization of

ly, she added, with all 537 PACS having completed their Dynamic Day-End process, thus functioning as e-PACS. Each PACS is availing a 40-year term loan facility of Rs63,000 for hardware and software upgrades under the digital transformation initiative. Highlighting the integration of

cooperatives with citizen services, it was revealed that 515 PACS are functioning as Common Service Centres (CSCs), generating a monthly transaction value of Rs3.10 lakh, while 154 PACS have been upgraded as Pradhan Mantri Kisan Samman Nidhi Kendras (PMKSKs) to facilitate agricultural services. It was further given out that under the White Revolution 2.0, the cooperative sector has achieved remarkable expansion, forming 2,232 Dairy Cooperative Societies (DCSs), of which 1,692 have been strengthened, benefiting over 1.06 lakh women members. The initiative has resulted in an impressive milk procurement of 3 Lakh Litres Per Day (LLPD) through new and strengthened DCSs.

Additionally, M-PACS are operating medical stores functioning

as Pradhan Mantri Jan Aushadhi Kendras (PMJAKs) contributing to affordable healthcare delivery across the far off areas in the UT. So far, 52 drug licenses and 50 stores have been operationalized, with a monthly transaction value

The J&K State Cooperative Bank has adopted several modern banking practices, including migration to Finacle 10, automation of loan schemes, and promotion of financial literacy among stakeholders.

Meanwhile, the Super Bazar chain has demonstrated encouraging progress, clearing Rs4 Cr in GST dues (FY 2020-21) and settling Rs28 lakh in gratuity and CPF dues of former employees. Presently, 16 PACS have been enrolled as new Super Bazar outlets, with renewed focus on capacity building, marketing push, and expansion into high-demand urban markets.

The Chief Secretary further directed for sustained momentum towards professionalization, digital empowerment, and grassroots financial inclusion through the cooperative movement in Jammu

8 lakh Holland tulip bulbs being imported

Srinagar, Nov 12: While the soil temperature has plum-meted, the preparations for Tulip garden, located on the foothills of Zabarwan Range, here, are in full swing with the officials claiming that the first lot of bulbs is expected to reach from Holland this week.

Imran Ahmad, Assistant Floriculture Officer said that the process of sowing bulbs, already available with the de-partment, has been started at the garden.

"Two lots of the Tulip bulbs are



expected to reach from Holland. The first lot of bulbs will be arriving this week only while the second lot will reach by next month," Ah-mad informed. "We get new varieties every year. 8 lakh bulbs will be im-ported from Holland this year as well," Ahmad said, add-ing that additional 3 lakh bulbs are available with the de-partment. "We are expecting a good Tulip show this year as well with the color variety of 25-30," he said.

'World Pneumonia Day'

Medical experts highlight pneumonia threat for immunocompromised

Srinagar, Nov 12: Immunocompromised individuals. in-cluding those with weakened immune systems due to underlying health conditions, medical treatments, or age, are more vulnerable to pneumonia, doctors said on Wednesday.

"Pneumonia is one of the most common and serious res-piratory infections that inflames the air sacs in one or both lungs. It can be caused by bacteria, viruses, or fungi,' Dr Naveed Nazir Shah, a noted pulmonologist and Head of the Department at Chest Diseases (CD) Hospital Srinagar, explained.

He said pneumonia continues to be the leading infectious cause of death in children under five years of age globally and also poses a serious threat to older adults and im-munocompromised individuals.

The good news is that pneumonia is large-ly preventa-ble," Dr Shah added. "Vaccination plays a crucial role - particularly PCV (Pneumococcal Conjugate Vaccine), Hib, influenza, and COVID-19

vaccines. Maintaining good nu-trition, exclusive breastfeeding in infants, practising hand hygiene, and reduc-ing indoor air pollution are equally vi-tal."

Another pulmonologist, Dr Javid Ahmad, said that im-munocompromised individuals are at higher risk due to weakened immune systems and greater susceptibility to opportunistic infections. "People with conditions like HIV, cancer, or those using immunosuppressant drugs must be extra cautious," he said. "They are strongly ad-vised to receive all recommended vaccines

against pneu-monia-causing

Dr Javid further said that antibiotics are prescribed only for bacterial infections or in certain high-risk viral cases. "Most viral pneumonia cases require only symptomatic treatment or antivirals, not antibiotics," he clarified.

According to doctors, early medical intervention can make a crucial difference. "Persistent cough, high fever, chest pain, and shortness of breath should never be ig-nored," they advised. "Timely evaluation by healthcare professionals can prevent complications and save lives."

Doctors recommended several preventive measures, in-cluding vaccination against pneumonia-causing patho-gens, good hygiene such as regular hand washing, healthy nutrition and exclusive breastfeeding for infants, avoiding exposure to cold air in early morning and evening hours, wearing adequate clothing, especial-

ing a healthy lifestyle. They also cautioned that COVID-19 and flu can mimic pneumonia symptoms,

nose, and managing chronic

conditions while main-tain-

differen-tiate between viral and bacterial infections.

According to experts, modern medical tools have im-proved pneumonia management. They said rapid diag-nostic tests like biomarkers, molecular diagnostics, and point-of-care testing have helped identify the cause of pneumonia more accurately. This ensures targeted thera-py and reduces unnecessary antibiotic use, they said.

World Pneumonia Day is observed every year on No-vember 12 to raise awareness about pneumonia, a pre-ventable yet deadly disease that remains a leading cause of mortality across age groups world-wide. Established in 2009 by the Global Coalition Against Child Pneumonia, the day emphasises global action to prevent and treat pneumonia through awareness, vaccination, and im-proved healthcare access.

This year's theme, "Child Survival", focuses on protecting children - the most vulnerable victims of this disease - and ensuring that no child dies from a prevent-

alleged that they came to know through news reports that the questions of the paper were shared 3 days before the JKPSC exam. They further alleged that the question paper was extreme-ly lengthy and were not able to attempt at least 70 or 80 percent of it. "The paper was 40 pages long and was diffi-cult to attempt in just two hours

Another aspirant said, "As the question paper carries negative marking, we had to attempt limited questions and the majority of time during the exams got wasted in understanding the lengthy paper."

JMC seizes 500 kg of substandard meat

Jammu, Nov 12: The Jammu Municipal Corporation (JMC) has launched a major drive against vendors selling substandard and unhygienic meat in the city, following similar action in the Kashmir

Nearly 500 kilograms of substandard frozen meat were seized and destroyed, and fines amounting to Rs 50,000 were imposed on the offenders.

The campaign was carried out by JMC's veterinary wing under the supervision of Municipal Commissioner Dr. Devesh Yadav and led by Municipal Veterinary Officer Dr. Jaswant Singh. Surprise inspections were conducted across various localities of Jammu city.

During the operation, around 500 kg of unfit meat was seized from several vendors found violating food safety and hygiene norms. The seized meat was destroyed on the spot as per safety protocols to ensure it did not reach the

Several shop owners were served notices for lacking valid licenses, failing to maintain hygiene, and selling un-stamped meat. Apart from the collective fine of Rs 50,000, a separate penalty of ₹7,000 was imposed on shops found selling unhygienic or unverified meat in violation of the Municipal Corporation Act, 2000.

Dr. Jaswant Singh told KNO over phone that the corpora-tion's focus remains on ensuring the sale of safe and clean meat to consumers. "Strict action will continue against those engaged in illegal slaughtering and against vendors operating without a No Objection Certificate from the corporation or registration from the Food Safety Depart-ment," he said.

The JMC has appealed to all meat vendors to comply with hygiene, storage, and licensing regulations. Citizens have been urged to report violations to the corporation for prompt action.

MLA decries poor state of educational institutions

Sopore, Nov 12: Member of Legislative Assembly (MLA) Sopore, Irshad Rasool Kar Wednesday expressed concern over the deteriorating infrastructure and slow pace of development in Sopore's educational institutions, urging immediate utilisation of allocated funds to upgrade facilities and bridge academic gaps.

Speaking to reporters on the sidelines of an event, MLA Kar said that several colleges established after Sopore Degree College in 1951 have now evolved into cluster universities, while Sopore continues to struggle with poor infrastructure and limited academic resources.

"The colleges which were established after Sopore one have become cluster universities, while the infrastructure here is old and in shambles. The faculty strength and

range of courses available are also far from satisfactory. In terms of the education system, Sopore is lagging far behind," Kar said.

The MLA revealed that the government has allocated over Rs 10 crore for Sopore's two colleges this year. He noted that only the science block work has started, while a few development activities are underway at the Boys Degree College. He pressed for faster spending of the sanctioned funds to ensure better progress in the next fiscal year.

Responding to questions about his plan for improving primary and secondary education, Kar said that upgradation processes across the education and health sectors are currently paused. "Once these are reopened, I will take up the matter with experts to ensure proper enhancement of facilities at Girls Higher Secondary, Boys Higher Secondary and both colleges", he said.

The MLA criticized the political approach in establishing educational institutions, saying that it led to scattered resource allocation. "Educational setups have been created based on political considerations. This has weakened the overall education system as resources meant for strengthening existing institutions were divided. As a result, students are now compelled to move outside Jammu and Kashmir for better academic opportunities," Kar added.

Addressing reports of staff shortages in local schools, Kar denied any maior issues at the high school level but acknowledged that higher secondary schools face some vacancies. He assured that these posts will be filled soon to maintain academic continuity.

MLA, however, reiterated his commitment to improving the standard of education in Sopore

This gathering, spearheaded by the Higher Education and Youth Services departments, rightly recognises that the most potent weapon against addiction is not enforcement alone, but education, emotional resilience, and a profound sense of purpose among the youth. The involvement of a global

spiritual leader like Sri Sri Ravi Shankar underscores the importance of addressing the inner vacuum that often leads to substance abuse. His emphasis on mindfulness, meditation, and breathing techniques is not merely spiritual advice but a practical public health intervention. When he calls for a reimagining of education as a path of "love, happiness, and creativity", he highlights a fundamental truth: a curriculum that only builds professional skills but neglects emotional and ethical fortitude is incomplete and even dangerous. The proposal to establish Art of Living

centres in universities, focusing on anxiety management, is a timely and necessary step. However, for this inspiring vision to translate into tangible results, it must be backed by sustained, systemic action. The government's commitment to integrating these programmes is commendable, but it must now ensure they are woven into the very fabric of the academic calendar, not treated as occasional events. Teacher training is paramount; educators must be equipped to become mentors in emotional well-being. The student-led initiatives like the proposed SKY Clubs

can create powerful peer-to-peer networks of support, making the fight against drugs a collective, youth-driven movement. The battle against substance abuse will be won not just in police stations and rehabilitation centres, but in classrooms, campuses, and the hearts of young people. By championing an education that nurtures the mind, body, and spirit, the government and civil society are building the most effective long-term defence against this scourge. This holistic approach offers the hope of a generation that is not just drug-free but truly empowered and fulfilled.

Water At The Heart Of Climate Resilience

UN climate summits like the annual Conference of the Parties (COPs) have historically laid predominant emphasis on reducing carbon emissions, increasing the capacities for renewable energy, and establishing finance mechanisms

UN climate summits like the annual Conference of the Parties (COPs) have historically laid predominant emphasis on reducing carbon emissions, increasing the capacities for renewable energy, and establishing finance mechanisms. But in recent years, there is growing recognition that climate change is experienced primarily through water. This increased acknowledgement of water as a primary issue was seen during the COP 28 in Dubai, United Arab Emirates, which highlighted water as a significant cross-cutting issue. During COP 28, over 50 countries signed the Dubai Water Declaration, endorsing the integration of water and climate policies.

By incorporating water resilience into the official Action Agenda, COP 30 further leverages and consolidates this momentum. The focus on water has grown stronger as the world gets ready for COP 30, the 2025 United Nations Climate Change Conference that will be held in Belém, Brazil. The nexus between water, energy, food, ecosystems, human health, and climate change highlights the fact that water is part of both the climate crisis and the solutions. The critical importance of the water sector is evident and unmistakable. Fundamentally, the efforts to adapt to and mitigate climate change are linked with the hydrological cycle, which is being disrupted by rising temperatures, deforestation, and pollution.

To systematically address water resilience across various geographic, sectoral, and political scales, we need to implement integrated water resource management (IWRM). Climate security without water security is unattainable for any nation and therefore warrants concerted efforts to tackle both issues cohesively. The official COP 30 Action Agenda delineates six major thematic pillars that will help the world accelerate the global response to climate change. The thematic pillars of the COP 30 Action Agenda are designed to create a framework that supports stakeholder mobilisation and accelerates the implementation of agreements reached from the first Global Stocktake (GST-1). They are

- 1. Transitioning Energy, Industry and Transport
- 2. Stewarding Forests, Oceans and



- Biodiversity
- 3. Transforming Agriculture and Food
- 4. Building Resilience for Cities, Infrastructure and Water

Fostering Human and Social Development Unleashing Enablers and Accelerators— Including Financing, Technology and Capacity-Building. The thematic focus on Building Resilience for Cities, Infrastructure and Water acknowledges that the management of water resources, from river basins to urban drainage systems, is crucial for adaptation, biodiversity preservation, and sustainable development. Additionally, water is essential for agriculture, the developing bioeconomy, and the resilience of infrastructure. By taking a cohesive and comprehensive approach, we will potentially transcend the perception of water as a mere victim of climate change but rather see it as a catalyst for change and the cornerstone of a fair transition. Resilience thinking is increasingly becoming a fundamental tenet of the mangement, funding, and governance of water This human aspect emphasises the need for water to remain a key component of climate action. It establishes a connection between global goals and the realities encountered by

communities and ecosystems. This element serves as a reminder to decision-makers that resilience ultimately manifests in lives and livelihoods. Even though problems with water quantity, such as droughts and floods, are often in the news, water pollution is an equally urgent but under-represented dimension of the climate crisis. It is anticipated that COP 30's agenda will integrate pollution within the broader framework of adaptation, linking water quality, public health, and climate resilience. The discussions may focus on: Pollution-driven carbon and methane emissions from degraded water bodies. Nature-based solutions (wetlands, mangroves) for filtering and storing water. International financing for pollution control and wastewater management. While there have been several discourses on flood and drought mitigation, a lot needs to be done on the aspect of water pollution control, especially chemical and micropollutant contamination, which impacts public health the most. In this context, it is crucial to identify solutions and formulate strategies and action plans for tackling both point and non-point sources of pollution, including contaminants of emerging concern (CECs) that encompass a range of substances from pharmaceuticals and personal care products to industrial

chemicals. The next level of systems thinking needs to include these pollutants, which are being found more often in surface and groundwater as well as other parts of the environment, but are not properly controlled, creating complicated risks for human health and the environment. International collaboration can drive knowledge and technology transfer, as in the case of the India-Norway Cooperation Project on Capacity Building for Reducing Plastic and Chemical Pollution in India (INOPOL), which focuses on land-based plastic pollution and Persistent Organic Pollutants (POPs) impacting the marine ecosystem. The fact that COP 30 takes place in Brazil, which holds the majority of the Amazonian rainforests, gives it both symbolic and practical significance. This region is characterised by the critical role of water in sustaining life while simultaneously facing challenges such as floods, droughts, and pollution, which illustrate the pressures of a changing climate. The Amazon rainforest highlights the critical nexus between forests, rainfall, and river systems. Brazil intends to leverage COP 30 to demonstrate Amazon stewardship as a global model for water and climate, integrating indigenous knowledge, scientific advancements, and low-carbon development within the largest watershed on the planet. COP 30 presents an unparalleled opportunity to incorporate water security and water quality into climate finance, planning, and governance frameworks. As negotiators gather in Belém, the message is clear: "There is no climate resilience without water resilience." COP 30 presents an opportunity to transition from acknowledgement to tangible outcomes, moving beyond symbolic pledges to quantifiable, enduring transfor-mations. As Retno L.P. Marsudi, UN Special Envoy on Water, aptly put it, "There's no need to reinvent the wheel, only to get the wheels moving." The goals of the Paris Agreement will remain unattainable without resilient water systems. Water drives mitigation, underpins adaptation, and sustains resilience. There can be no green energy transition, food security, or sustainable cities without it. Belém must become the pivotal moment when the world overcomes fragmentation and achieves integration across sectors, including water pollution control and climate resilience, to function as a unified system. Only then can water move from the margins

system through which every commitment must flow. Climate High-Level Champions are appointed for each COP Presidency to mobilise action beyond governments, linking negotiations with businesses, cities, and civil society to accelerate real-world implementation. The speakers at World Water Week 2025 in Stockholm, Sweden, emphasised that inclusion and justice are central to credibility. Indigenous leaders, in particular, called for their knowledge to guide decisionmaking on water and climate. By the time of the next Global Stocktake in 2028, the goal is for water (pollution control and mitigation) to be fully integrated into national adaptation plans and nationally determined contributions (NDCs). Ensuring that this understanding translates into concrete commitments, from pollution control to monitoring of CECs and watershed restoration, will determine whether COP 30 becomes a true "watershed moment" in global climate diplomacy. There are several action points for India, such as to strengthen water governance through coordinated reforms at both central and state levels, ensuring effective policy alignment and implementation. River-basin management authorities should be empowered to integrate water quantity, quality, and pollution control under one framework. Expanding circular-water use in industries, nature-based wastewater treatment, and rural water-quality surveillance can improve resilience. The Government of India's flagship programmes, such as the Jal Jeevan Mission, Swachh Bharat Mission, AMRUT, Per Drop More Crop, etc., should embed climate adaptation and pollution mitigation targets. Coordination councils that connect central and state authorities, partnerships that link science and policy, and specialised financing mechanisms are essential for enhancing innovation and ensuring accountability. But don't worry, with a little planning and some solid teamwork between parents and schools, kids can stay safe, sharp, and spirited even when the air outside is a foggy mess and classes have gone digital. Here's how parents can turn this challenge into a win.

Make a little learning corner

A small, peaceful space at home can do wonders for focus. Pick a quiet, well-lit corner that's just for study time. Keep essentials — books, pencils, and a water bottle — close by so your child doesn't need

to move around constantly. A clean table, some fresh air, and even a small plant can make the space feel calm and welcoming.

Stay involved, not hovering

Children thrive on encouragement, not constant supervision. Ask gentle, open-ended questions



like, "What did you enjoy learning today?" instead of checking every task. Praise effort, not perfection; this builds confidence and independence, even in an online setup.

Keep tech hassles away

A few quick checks can prevent mid-class meltdowns. Make sure

devices and apps are updated, passwords are stored safely, and internet connections are stable. Teach kids simple fixes, like refreshing the page or reconnecting to Wi-Fi, so they can handle small issues themselves.

Maintaining health

Care for the body and mind, with

limited outdoor play, movement is still essential. Turn up some music for a mini dance session, do a short yoga stretch, or walk around indoors. Keep kids hydrated and offer nourishing snacks; fruits, nuts, and warm turmeric milk are seasonal heroes. Watch for signs of stress or fatigue, and make time for chats, cuddles, or deep breathing to reset their mood.

Keep the air (and home) cleaner

During high-smog hours, keep windows closed and open them briefly at noon for fresh air. Wipe surfaces often and use a damp mop to reduce dust. If you have a purifier, keep it running in the study or bedroom. And when children need to step out, make sure they wear N95 masks, especially those with asthma or allergies.

School-parent communication

Stay Connected with the School. Communication makes everything easier. Keep an eye on school messages and updates, and let teachers know about any tech issues or health concerns. Regular feedback helps schools adjust lessons, and collaboration ensures children continue learning smoothly.

With a proactive mindset, a dash of creativity, and strong collaboration with educators, families can transform their homes into vibrant learning spaces.

Pulwama admin strengthens action against illegal mining

PULWAMA, NOVEMBER 12: On the directions of the Deputy Commissioner Pulwama, Dr. Basharat Qayoom, the Geology and Mining Department Pulwama intensified its enforcement drive to curb illegal mining and unauthorized mineral transportation in the district.

During the past two days, enforcement teams headed by District Mineral Officer, Pulwama, Dr. Mohammad Saleem have seized eight vehicles involved in unlawful extraction and movement of minerals, and a penalty of Rs.1.34 lakh has been imposed on the offenders.

To ensure continuous surveillance and strict monitoring at vulnerable locations, the Deputy Commissioner has directed the department to maintain a daily enforcement roster and keep close liaison with the Revenue and Police Departments for combined and concerted efforts against illegal mining. Moreover, over 20 ramps

connected to the Jhelum and Rambiara rivers have been dismantled over the last three days to prevent illegal extraction and transportation of mineral material. The department has in-

structed all tipper and dumper operators to transport minerals strictly against valid e-challans and permits, warning that any violation will attract strict legal action under the relevant mining laws.

The department has also urged the general public to cooperate with the administration and report any illegal mining activities to the concerned authorities, emphasising the collective responsibility to safeguard the district's natural resources.

Vigilance of civil society, women's movement have kept judiciary accountable: CJI Gavai

New Delhi, Nov 12: Chief Justice of India B R Gavai on Wednesday said that the vigilance of civil society, the persistence of women's movements and the courage of ordinary citizens have together kept the judiciary accountable to the constitutional promise of equality.

Speaking at the 30th Justice Sunanda Bhandare Memorial Lecture, CJI Gavai said over the past 75 years, India has charted an extraordinary journey in advancing the rights of women and shaping the vision of an inclusive society.

He said that from the



early struggles for recognition and equality to the present era of intersectional and participatory justice, the courts have often stood as guardians of equality and human dignity.

"This evolution has not been

vigilance of civil society, the persistence of women's movements and the courage of ordinary citizens have together kept the judiciary accountable to the constitutional promise of equality.

The programme was attended by Delhi High Court chief justice D K Upadhyaya and former apex court judge M B Lokur.

CJI Gavai said, therefore, it is important to acknowledge that progress in gender justice has never been the achievement of courts alone and the collective voice of citizens has ensured that regressive precedents were questioned, debated and ultimately corrected through reform, reinterpretation, or

legislative intervention.

"The dialogue between the courts and the people thus remains one of the most vital sources of India's democratic strength, reminding us that the march toward gender equality is not a destination reached but a commitment constantly renewed," he said.

He, however, said that despite the progress, the journey towards genuine gender equality remains far from complete.

"The task before us is not merely to celebrate symbolic achievements or token representations but to ensure that women have a real and equal share in spaces of power,

decision-making and opportunity. Equality must not be confined to numbers or appearances; it must be reflected in the structures, attitudes, and institutions that shape our public and private lives," he underscored.

CJI Gavai, who is set to demit office on November 23, said, "We must continue to dismantle the invisible barriers (social, cultural and economic) that limit women's freedom and participation. The rights guaranteed by our Constitution must reach every woman, not just those in metropolitan cities or privileged contexts, but also those in small towns, villages, and

marginalised communities who continue to live at the edges of justice.'

He added that true equality demands that the benefits of law, education and opportunity extend to them in full measure.

"At the same time, achieving gender justice is not the responsibility of women alone. It requires an active reimagining of power by men, especially those who occupy positions of authority in our institutions, workplaces and political systems," he said.

Real progress will come only when men recognise that sharing power is not an act of loss but of liberation of society, the CJI said.

J&K Police Hands Over Probe To State **Investigation Agency**

Earlier, Delhi Police Special Cell handed over the probe to the National Investigation Agency, under the Unlawful Activities (Prevention) Act, the Explosive Substances Act, and sections of the Bharatiya Nyaya Sanhita related to murder and conspiracy.

A top official told KNO that Jammu and Kashmir Police have also formally handed over the investigation of the module case to State Investigation Agency (SIA) under overall supervision of Criminal Investigation Department CID. Earlier, Srinagar Police was looking into the case, he said.

DNA Sample Of Dr Umar's Mother Collected Investigators suspect that Dr Umar drove the car in which the explosion took place and to establish the link, authorities today collected the DNA sample of his mother.

An official told KNO that the DNA sample of his mother has been sent to AIIMS forensic laboratory for further investigation and to ascertain whether Dr Umar was inside the car.

Police Trace Another Car Linked To Red Fort

As the ambit of the probe widens, the Delhi police have found an SUV - a red EcoSport car - suspected to be linked to the blast. During investigation it came to fore that this car was also owned by Dr Umar Mohammad, who investigators believe triggered the deadly blast in one of the busiest places in Delhi.

According to details available with KNO, Delhi police earlier today had issued a high alert after a probe revealed that apart from the Hyundai i20, the suspects also had another red

All Delhi police stations, police posts, and border checkpoints were alerted to look out for the red EcoSport car. Hours after the alert, the car, bearing registration number DL10CK0458, was intercepted at a farmhouse in Haryana's Khandavali village.

Investigation has revealed that the SUV is registered in the name of Dr Umar Un Nabi, also known as Umar Mohammad, the prime suspect in the Delhi blast case. Dr Umar is believed to have purchased the car on October 29, and on the same day, it was taken out to get the Pollution Under Control certificate. CCTV footage from that day shows three people were in

Dr Umar was part of the terror module busted by Jammu and Kashmir police and Haryana police last week and was working at the Al-Falah Medical College in Haryana's Faridabad. So far, the investigation has revealed that Dr Umar was driving the car that exploded near the Red Fort on Monday evening, killing 9 people and injuring 20 others.

The probe has further revealed that fearing arrest, Dr Umar triggered the blast in panic after his other accomplices, Dr Muzzamil Shakeel, Dr Adil Ahmad and Dr Shaheen were arrested by the Jammu and Kashmir police and Haryana police.

According to investigating agencies, this module was being handled from abroad. Delhi Police and central agencies are now probing the foreign link in the case.

As investigation is ongoing, a total of 15 arrests have been made so far, while several have been detained for questioning in the Red Fort blast case.

Meanwhile, investigation has also revealed that Dr Muzzamil, Dr Shaheen and Dr Umar staved inside the Al Falah university campus. Dr Muzzamil was staying in the campus for the last 3 years, while Dr Umar was associated with the university for the last 7 years and Dr Shaeena got in touch with them recently, the probe revealed.

It also revealed that another person who works in the HR department of the university is responsible for bringing these doctors from Jammu and Kashmir to Faridabad. He is also being questioned by the Investigators. (KNO)

In a coordinated crackdown on the banned Jamaat-e-Islami (JeI), police conducted extensive raids across multiple locations in Kashmir.

A senior security official said that searches were carried out at the residences and premises of IeI members and their associates as part of efforts to dismantle terror networks and their support structures.

During the operation, police seized incriminating material and digital devices. Several members were also questioned and bound under legal provisions.

In Sopore, police carried out simultaneous searches at more than 25 locations across Sopore, Zaingeer, and Rafiabad areas following credible inputs about attempts by JeI-linked individuals to revive organisational activities under different fronts. Incriminating documents, digital gadgets, and printed material were recovered during the operation, and several persons were questioned.

In Kulgam, police launched one of the largest operations in recent months, raiding over 200 premises linked to JeI members and overground workers. Officials said more than 400 cordon and search operations have been conducted in the last four days, leading to the interrogation of around 500 individuals, several of whom have been bound down or detained under preventive laws.

In Pulwama, multiple police teams assisted by other agencies conducted coordinated searches at identified locations. Electronic devices, documents, and printed literature linked to Jel were seized, and several suspects detained, a police spokesperson said.

In Police District Awantipora, the searches were conducted at the houses and premises of JeI members and their associates as part of ongoing efforts to dismantle the terror ecosystem and its support structures. During the operation incriminating material and digital were recovered, while several JeI members were questioned and bound down under the

Srinagar Police also carried out extensive raids at 150 locations across the city. The searches targeted residences of associates and overground workers linked with proscribed organisations, as part of ongoing investigations under the Unlawful Activities (Prevention) Act

In Ganderbal, the district-wide counter-terror and anti-separatist operation was conducted simultaneously in several areas with the assistance of other security agencies.

The action followed credible intelligence inputs indicating attempts by JeI-linked elements to revive organisational activities through covert channels and front groups. During the raids, a large quantity of incriminating materials, including documents, digital devices, and printed content having direct links with the banned outfit, were recovered and seized for detailed analysis.

Several suspects have been detained for questioning to ascertain their role in unlawful and subversive activities, the spokesperson said.

In Ganderbal, J&K Police carried out extensive searches at multiple locations across the district targeting individuals and premises linked with the banned organisation Jamaate-Islami (JeI), proscribed under the UAPA. All individuals who have remained affiliated with the proscribed group were covered during the operation, the spokesperson added.

Police said these preventive and intelligencedriven operations are aimed at dismantling the terror-separatist ecosystem, disrupting its ideological and logistical networks, and maintaining peace and stability across the region. (KNO)

No. 338 in the name of Mian Abdul Qayoom, has been attached in connection with FIR No. 157/2009 under Sections 120, 120-B, 121, 153-A RPC and Sections 13, 38, 39 of UAPA at Police Station Shaheed Gunj, Srinagar.

As per official documents accessed by KNO the investigation revealed that on December 31, 2009, PS Shaheed Gunj received information that a seminar was organized at Hotel Jehangir, Srinagar, on the death anniversary of Late Ali Mohammad Jinnah by separatist leaders led by Feroz Ahmad Khan, vice-chairman of the Muslim League.

The seminar, as per police, was attended by Aasia Andrabi, Shabir Ahmad Najar, and Mian Abdul Qayoom, among others, where anti-India speeches were allegedly delivered and slogans raised calling for secession of Jammu and Kashmir from India and establishment of Islamic law in the region.

During subsequent investigation, police said incriminating material was recovered from the residence of Mian Abdul Qayoom, including banned literature, a blank letterhead of Hizbul Mujahideen with seal impression, a press note of Hizbul Mujahideen, and a letter from Syed Salahuddin to former US President Bill Clinton, among other materials.

Based on the collected evidence, authorities said the property falls within the ambit of "proceeds of terrorism" under Section 2(g) of the UAPA, and its attachment was approved under Section 25 of the Act.

The order, signed by DG Police Nalin Prabhat, has been sent to SDPO Shaheed Gunj for implementation, with copies marked to ADG CID, IG Kashmir Zone, SSP Srinagar, and AIG CT/INT for necessary action.

Pertinently, Mian Qayoom was arrested in 2020 in connection with a murder case of Advocate Babar Qadri. He was shot dead by assailants, who disguised as clients on September 24, 2020, at his residence at Zahidpora in Srinagar. (KNO)

In Sopore, police appealed to citizens and WhatsApp group administrators to use social

media responsibly and warned that any antinational, communal, or sectarian post, comment, or forward would attract the strictest legal action.

The advisory urged people not to amplify hate or misinformation and to use social media as a tool for connection rather than division.

"It has come to notice that some social media users are posting or reacting insensitively to the recent tragic incident at the Red Fort. Such actions are deeply objectionable and antinational, aimed at spreading hatred and disturbing public harmony," Kupwara Police said, adding that it urges everyone to avoid posting, sharing, or endorsing any content that is antinational, communal, or disrespectful in nature.

"The public is advised to report such content or accounts to the concerned platform or law enforcement authorities instead of engaging with or spreading them," the police said, adding that it is closely monitoring online activity.

Police warned that strict legal action will be taken against anyone found involved in creating or promoting such content.

Meanwhile, in Shopian, police registered an FIR after taking cognisance of a viral video circulated through a Facebook page titled "Voice of Humanity". The video reportedly contained a speech promoting separatist sentiments and activities aimed at disturbing public peace.

Officials said a case under FIR No. 109/2025 has been filed at Police Station Zainapora, and investigations are underway to identify those involved in creating and circulating the content. (KNO)

Faridabad car dealer detained; police issues directions to second-hand car dealers

New Delhi, Nov 12: The Special Cell has detained a Faridabad-based car dealer in connection with the Red Fort blast case and has directed all second-hand car dealers across Delhi and adjoining states to verify and share details of recent vehicle sales, officials said on

Wednesday.
According to police sources, Amit, owner of Royal Car Plaza in Faridabad's Sector 37, was detained late Monday night with the assistance of the Faridabad Police. He allegedly facilitated the

sale of the Hyundai i20 that was used in Monday's powerful explosion near the Red Fort, which killed 12 people and injured many others.

"Amit is being questioned. The investigation team is tracing the entire chain of ownership of the Hyundai i20 and determining how it reached the suspect's hands. We are verifying who brought the vehicle to his showroom

and through whom Dr Umar Nabi came in contact with him," a source said.

The Special Cell is also examining dealership records, transaction logs and CCTV footage to identify intermediaries who might have been involved in the car's sale and transfer.

Dr Umar Nabi, an assistant professor at Al-Falah University in Haryana's Faridabad, is believed to have been behind the wheel when the blast took place near the historic Red Fort.

Following the blast, Del-hi Police has launched an extensive verification drive involving all used-car dealerships operating within and around the national capital.

A senior police officer said all Deputy Commissioners of Police (DCPs) across the 15 districts in Delhi have been instructed to hold meetings with local car dealers and direct their respective Station House Officers (SHOs) to cross-check sale and purchase

"SHOs have been asked to visit car dealerships in their jurisdictions and verify documentation related to recently sold or transferred vehicles. They have also been tasked with collecting details of buyers, especially those from Delhi, Haryana, Uttar Pradesh, Jammu and Kashmir, and identifying any suspicious transactions," the officer said.

Haryana Police and Uttar Pradesh Police have also been roped in to conduct parallel verifications in their respective areas adjoining the national capital, sources said.

The objective is to identify any vehicle purchases that may have been made using fake identities or through cash transactions that bypass standard verification procedures.

Meanwhile, a meeting was held with several car dealers in Delhi to strengthen coordination and ensure compliance with vehicle verification

"Dealers were advised to maintain proper sale-pur-chase records and verify buyer credentials such as Aadhaar, driving licence and address proofs before handing over any vehicle. They were also encouraged to immediately report any suspicious buyers or transactions to the police," said the police officer.

The Special Cell is expected to question more people linked to the transaction chain as the probe into the Red Fort blast widens.

Shoe hurl at CJI: Delhi HC deprecates incident, says appropriate measures needed

New Delhi, Nov 12: The Delhi High Court on Wednesday deprecated the hurling of a shoe by a lawyer at Chief Justice of India B R Gavai and said appropriate measures need to be taken to prevent such incidents in future.

Observing that the incident has hurt not only members of the Bar but everybody, a bench of Chief Justice Devendra Kumar Upadhyaya and Justice Tushar Rao Gedela said it shares the concerns of the petitioner, perhaps with more intensity.

"We share your concern, perhaps with more intensity. It has hurt not only members of the Bar but everybody.

"It is not the question of an individual. Such incidents should not only be deprecated but appropriate measures need to be taken," the bench said. The high court's observations came while hearing a nublic interest litigation (PIL) seeking guidelines to take down videos of the shoe-hurling incident being



circulated on social media. Petitioner Tejaswi Mohan

said the video was still being circulated on social media and they were also seeking directions to ensure that if such incidents happen in future, the identity of the culprit person should be hidden so that they do not get publicity.

Additional Solicitor General (ASG) Chetan Sharma, appearing for the Centre, the pendency of a petition filed by the Supreme Court might also consider passing a John Doe order to prevent Bar Association (SCBA) before such incidents. To this, the

the apex court in which they have prayed for contempt action against the lawyer who threw the shoe at the CJI in the open court.

Sharma said while he shared the petitioner's concerns, it would be appropriate for Mohan to approach the Supreme Court in the pending proceedings.

The ASG also referred to a newspaper report saying that besides issuance of guidelines, the top court

bench said, "As per the news report, the Supreme Court has also said that it will consider passing a John Doe order and issue guidelines to prevent such incidents. And if you intervene there, you may always press for issuance of an order or directions to the Ministry of Information and Broadcasting or the government agencies to frame some guidelines or protocols...

"You may apprise the Supreme Court of this matter being filed and seek intervention there. Otherwise, we will entertain.'

The bench said it was only thinking because of the duplicity of proceedings. The court kept the petition pending before it and asked the petitioner to seek intervention in the pending case before the Supreme Court.

'We can see the Supreme Court intends to enlarge the scope of the matter. Just to avoid duplicity of proceedings... we would be happy to issue directions as prayed,"

Dharmendra discharged from hospital, family opts for home treatment

Mumbai, Nov 12: Veteran actor Dharmendra was discharged from the Breach Candy hospital in south Mumbai on Wednesday morning after the family decided to take him home for treatment, doctor treating him told PTI.

The 89-year-old actor was discharged from the hospital days after he was admitted there for some tests, which were not disclosed by the family and hospital authorities.

"Dharmendra ji was discharged from the hospital around 7:30 am. He will be treated at home as the family has decided to give him home treatment," Dr Pratit Samdani of Breach Candy hospital, under whom the actor was admitted, told PTI.

When asked about the actor's health, Samdani said all he can confirm is that Dharmendra has been discharged from the hospital. An ambulance was

seen leaving the hospital for Dharmendra's elder son Sunny Deol's residence in suburban Juhu.

On Tuesday, several media outlets reported about Dharmendra's death but the family refuted it and urged

Sensex rallies over 770 pts, Nifty tops 25,900 mark on global cues, **US-India trade optimism**

Mumbai, Nov 12: Equity benchmark index Sensex jumped over 770 points while Nifty was trading above the 25,900 level in afternoon trade on Wednesday driven by a flurry of buying by investors across sectors amid a rally in Asian markets.

Besides, traders said optimism over an impending India-US trade deal and progress towards ending a prolonged US government shutdown bolstered investor sentiment.

The 30-share BSE Sensex benchmark zoomed 773.64 points, or 0.92 per cent, to 84,644.96 at 13:20 hours in afternoon trade. On the similar lines, the NSE Nifty rallied by 231.8 points, or 0.90 per cent to 25,926.75.

Buying in blue-chip counters such as Reliance Industries, Infosys and Bharti Airtel further supported the indices, they added.

From the Sensex pack, Tech Mahindra, Tata Consultancy Services, Reliance Industries, Adani Ports, Titan, Eternal, HCL Technologies, Infosys, Bajaj Finserv, Trent, Bharti Airtel, Sun Pharmaceuticals, Bajaj Finance, PowerGrid, State Bank of India and Asian Paints were among the gainers.

On the other hand, newly-listed Tata Motors Commercial Vehicles, Tata Steel, Bharat Electronics Ltd, Tata Motors Passenger Vehicles, Hindustan Unilever and Kotak Mahindra Bank were among the laggards.

Market experts said that investor sentiment was further buoyed after Bihar exit polls indicated a likely victory for the incumbent NDA alliance. In Asian markets, South Korea's Kospi, Japan's Nikkei 225 benchmark ended higher while Shanghai's SSE Composite Index closed lower. Hong Kong's Hang Seng is trading in the positive zone. The US markets closed largely higher on Tuesday. Brent crude, the global oil benchmark, fell 0.37 per cent to USD 64.92 per barrel.

Foreign Institutional Investors (FII) offloaded equities worth Rs 803.22 crore on Tuesday while Domestic Institutional Investors bought stocks worth Rs 2,188.47 crore, according to the exchange data.

What should be ideal heart rate & what is its link with cardiovascular health?

New Delhi, Nov 12: The heart beats around 100,000 times a day, yet most people rarely think about how fast, or how efficiently it's working, according to study published in the US. Heart rate isn't just a number flashing on a smartwatch; it's one of the body's most honest indicators of how well the heart and circulatory system are functioning. A rate that's too high or too low can hint at stress, fatigue, thyroid issues, or even early signs of cardiovascular disease. Understanding what qualifies as an "ideal" heart rate and how it connects to heart health can help catch problems early and even prevent them altogether.

Understanding what heart rate

really means

Heart rate is the number of times the heart beats per minute (bpm). It is one of the easiest indicators of cardiovascular health. Every beat pumps blood and oxygen through the body, so the rhythm, pace, and consistency

of those beats matter deeply. According to the American Heart Association (AHA), a normal resting heart rate for adults ranges between 60 and 100 bpm. In athletes or people who exercise regularly, the resting heart rate can dip as low as 40-50 bpm, showing strong cardiovascular efficiency.

Dr LK Jha, Associate Director & head of unit II, Cardiology, Asian Hospital said, "It is considered that a healthy grown-up person should have a normal resting heart rate of between 60 and 100 beats per minute. Nevertheless, the majority of cardiologists believe that a resting level of 60 70 bpm is an optimal heart rate and cardiovascular fitness. A decreased resting heart rate is usually a sign of a well and

good cardiovascular system that can pump blood out with fewer beats with a high resting rate that remains constant, usually, is a sign of internal stress on the cardiovascular system or an inefficient heart." Why the ideal range isn't the

same for everyone While 60-100 bpm is considered "normal," this range can't be read in isolation. Factors like age, fitness level, stress, thyroid activity, sleep quality, and even medication play roles in shaping individual heart rhythms. For example, a 25-year-old who

works out regularly and has a resting heart rate of 58 bpm is likely in great shape. But if a 60-year-old sedentary person records the same rate and feels dizzy or tired, that could signal bradycardia, or an abnormally slow heart rate. Similarly, a resting heart rate constantly above 90 bpm may suggest tachycardia, linked to dehydration, anxiety, or underlying heart conditions.

How resting heart rate reflects cardiovascular health

Think of resting heart rate as a mirror that reflects how efficiently the cardiovascular system performs. A lower rate usually means the heart pumps more blood with each beat, requiring less effort.

When the heart beats too fast over time, it increases oxygen demand, stiffens the arteries, and can lead to hypertension. On the other hand. a rate too low can limit oxygen delivery to the brain and organs, leading to fatigue, dizziness, or even fainting. What affects your heart rate

beyond exercise

While fitness has a direct effect, heart rate also fluctuates with emotions, caffeine, hormones, and hydration. Chronic stress, for instance, releases adrenaline and cortisol, keeping the heart rate

elevated even at rest. Over time, this can contribute to high blood pressure and arterial damage

Practices like deep breathing, yoga, mindfulness, and adequate sleep slow down the body's stress response and, in turn, stabilise the heart rate.

How to check and track our heart rate right

Checking the pulse regularly, either manually or using a smartwatch, can help catch early warning signs. Measure it first thing in the morning before getting out of bed. Count beats for 30 seconds and double the number to get bpm.

Keeping a record over weeks provides better insight than a single reading. A gradual increase might signal stress, poor sleep, dehydration, or the early stages of an illness, while a steady drop often shows improved cardiovascular conditioning.

When to see a doctor about our heart rate

A resting heart rate consistently below 50 bpm (if not an athlete) or above 100 bpm without a clear reason should not be ignored. These patterns could indicate arrhythmias, thyroid issues, or early heart disease. It's also important to seek help if irregular heartbeats are accompanied by chest pain, breathlessness, or fatigue.

Regular heart rate monitoring, along with blood pressure checks and cholesterol screening, gives a clearer picture of heart health than any single test can.

U.S. has to bring in talent from around the world: Trump on H-1B visa

New York, Nov 12: U.S. President Donald Trump appeared to defend the H-1B visa programme, saying America has to bring in talent from around the world as it does not have "certain talents" in the country.

"I agree but you also do have to bring in talent," Mr. Trump said, responding to a question in an interview with Laura Ingraham on Fox News on whether the H-1B visa issue will not be a big priority for his administration and if one wants to raise wages for American workers, the country cannot be flooded with hundreds of thousands of foreign workers.

When Ms. Ingraham noted that "we have plenty of talent", Mr. Trump said, "No, you don't, no you don't. You don't have certain talents. And people have to learn." "You can't take people off an unemployment line, and say, 'I'm going to put you into a factory, we're going to make missiles'," Mr. Trump added.

tain H-1B petitions filed after September 21, 2025 must be accompanied by an additional USD 100,000 payment as a condition of eligibility.

Last week, the Trump administration launched about 175 investigations into H-1B visa abuse, including lapses such as low wages, work sites that didn't exist and the practice of "benching" employees.

"As part of our mission to protect American Jobs, we've launched 175 investigations into H-1B abuse," the US Department of Labour had said in a post on X.

It added that under the leadership of President Trump and Labour Secretary Lori Chavez-DeRemer, the agency will continue taking action to put American workers first.

Ms. Chavez-DeRemer said in a post on X that the Labour Department "is using every resource at our disposal to put a stop to H-1B abuse and protect American Jobs. Under the leadership of @POTUS, we'll continue to invest in our workforce and ensure high-skilled job opportunities go to American Workers FIRST!

UN food agencies warn of 16 hunger hotspots

4 of top 6 are Middle East countries

Rome, Nov 12: Two UN food agencies warned Wednesday that millions more people around the globe could face famine, with funding shortfalls worsening already dire conditions.

The joint report from the Food and Agriculture Organization and the World Food Programme said conflict and violence were driving acute food insecurity in the majority of the countries identified at risk.

The Rome-based agencies listed Haiti, Mali, Palestine, South Sudan, Sudan and Yemen as the worst, "where populations face an imminent risk of catastrophic hunger." Also classified as a "very high concern" were Afghanistan, the Democratic Republic of the Congo, Myanmar, Nigeria, Somalia and Syria, with Burkina Faso, Chad, Kenya and the situation of the Rohingya refugees in Bangla-


records," he said.
