



Srinagar, Nov 13: Dr Umar Mohammad drove the car - the Hyundai i20 - that exploded near Delhi's historic Red Fort on Monday, claiming nine lives and injuring 20 others, confirmed the DNA test results on Thursday.

Details available news agency-Kashmir News Observer (KNO) revealed that investigators had taken DNA samples of Dr Umar from the

exploded car near the blast site on Monday.

Dr Umar was working as a

senior doctor at the Al Falah University in Faridabad. "His DNA sample matched completely with that of his mother and brother. The DNA sample matched with several body parts of Umar recovered from the exploded car," details revealed.

On Wednesday, investigators had collected DNA samples of Umar's mother and mother after they were detained in Pulwama by the police following the deadly explosion in Delhi.

The blast occurred hours after Jammu and Kashmir police and Faridabad police recovered 2900

kg of explosives from two residential houses in Faridabad on Monday. The revelation about explosives being stored in Faridabad came after police arrested Dr Muzzamil Shakeel and Dr Adeel, both associates of Dr Umar.

Fearing arrest, Dr Umar drove the i20 car - laden with explosives - around Delhi in panic on Monday before reaching the Red Fort area on Monday.

According to details available with KNO, around 50 CCTV cameras have been scanned by the investigators across Delhi, which had captured Dr Umar driving the car at several locations in the national capital including | More on P6

Jammu, Nov 13: Emphasising that the entire population of Jammu and Kashmir cannot be branded as sympathisers of terrorism, Chief Minister Omar Abdullah on Thursday said that Delhi blast perpetrators should be given exemplary punishment.

Talking to the reporters at sidelines of the 19th (Second Special) Convocation of the University of Jammu, the Chief Minister, according to the news agency-Kashmir News Observer (KNO) said, "Only a few elements were responsible



for disturbing peace and harmony in the region and they should be given the strictest should not get caught in it."

He said that words are not enough to condemn the brutal killings of innocent people and no one can justify such an act.

He said, "Every resident of Jammu and Kashmir is not a terrorist. Not every Kashmiri is on the side of terrorists. It is only a handful of people who have tried to disturb the peace and harmony here," he said.

"When we begin to look at every Kashmiri Muslim through the same lens and try to give the impression that every Kashmiri Muslim is a terrorist, it becomes very difficult to keen things on the right track," he said. | More on P6

Police intensify crackdown on terror networks across J&K

Conduct raids, detain terror-linked suspects, search properties targeting JeI, JKNOP links

Srinagar, Nov 13: Jammu & Kashmir Police have intensified crackdown on terror networks across multiple districts of the Union Territory as part of coordinated preventive operations aimed at dismantling the terror ecosystem and strengthening internal security in the region, officials said on Thursday.

In Baramulla, police carried out a series of preventive actions targeting individuals and networks suspected of involvement in subversive activities, a police official said. He said six individuals linked with such networks were detained and bound down under the law, while 22 properties associated with terrorist aides were searched

"As part of the same operation, 20 terror associates were bound down, and two were sent to jail under preventive detention laws," he said. "Two individuals booked under the Unlawful Activities (Prevention) Act (UAPA), who are currently on bail, were examined, and one was bound down under preventive law."

Police identified eight other UAPA-accused for bail cancellation, with two cases already submitted to the competent

Friday Brief: The Destructive Fire Of Greed

n an era defined by materialism and the relentless pursuit of wealth, Islam's teachings on greed offer a powerful antidote to the spiritual emptiness of consumerism. The Quran and Hadith repeatedly warn against the destructive nature of excessive desire for worldly possessions, presenting greed not merely as a personal failing but as a spiritual disease that corrodes faith and fractures communities. The Quran explicitly condemns the hoarding of wealth, stating: "And those who hoard gold and silver and spend it not in the way of Allah - give them tidings of a painful punishment" (9:34). This stark warning underscores that wealth is a trust

from God, not an end in itself. The relentless pursuit of more - more money, more property, more status - is characterised as a distraction from our true purpose: "The competition for more [worldly gain] diverts you until you visit the graves" (102:1-2). Prophet Muhammad (PBUH) perfectly embodied contentment and warned against greed's insidious nature. He stated: "If the son of Adam had a valley of gold, he would desire another. Nothing fills his mouth except dust, and Allah forgives those who repent" (Bukhari). This profound insight reveals greed as a bottomless pit—the more one acquires, the more one desires, leading only to

spiritual suffocation. The Islamic economic system is designed to counteract greed through practical mechanisms. Zakat (obligatory charity) forcibly redistributes wealth, while the prohibition of interest (riba) prevents exploitative accumulation. The Prophet (PBUH) emphasised that true wealth lies not in abundance but in contentment: "Richness is not having many possessions, but richness is the richness of the soul" (Bukhari). Greed manifests not only in material accumulation but in envy, jealousy, and the constant comparison with others' blessings. Islam teaches gratitude (shukr) as the antidote, recognising that what we have is

sufficient and divinely ordained. In today's world, where success is measured by net worth and happiness is commodified, Islam's timeless wisdom reminds us that peace comes not from acquiring more, but from needing less. By curbing greed through voluntary charity, gratitude, and detachment from worldly attachments, we protect our hearts from becoming slaves to desire and rediscover the freedom that comes with spiritual fulfilment. The path to true contentment lies not in expanding our possessions, but in simplifying our wants and remembering that we take nothing to our graves except our deeds.

Unlocking India's Green Hydrogen Production Potential

India's energy transition is entering a decisive phase, as the country reduces its dependence on fossil fuels and increases domestic clean energy production. This is in line with its vision of becoming a developed nation by 2047 and achieving Net Zero by 2070. In this transition, Green hydrogen, has emerged as a clean, scalable fuel alternative that can decarbonize hard-to-abate sectors, reduce import dependence on fossil fuels, and support India's goals for energy security and industrial growth.

The Indian government launched the National Green Hydrogen Mission (NGHM) in 2023, as an umbrella programme that aims to establish a Green Hydrogen ecosystem and catalyse a systemic response to the opportunities and challenges in this sector.

Objectives

The Mission represents more than an energy initiative; it is a strategic pathway toward industrial competitiveness, import reduction, and long-term energy security—linking sustainability with self-reliance.

What is Green Hydrogen?

Green Hydrogen is Hydrogen produced using renewable energy, such as solar or wind power, instead of fossil fuels. In this process water is split into hydrogen and oxygen through electrolysis, using electricity from solar panels or wind turbines. According to standards notified by Govt of India, Hydrogen made this way is considered "green" if the total emissions from the process are very low, not more than 2 kg of CO equivalent for every 1 kg of Hydrogen produced. Green Hydrogen can also be produced by converting biomass (like agricultural waste) into hydrogen, as long as emissions remain below the same limit.

The National Green Hydrogen Mission (NGHM) aims to build the capacity and ecosystem required to position India as a global leader in clean hydrogen. By 2030, the Mission will be supported by about 125 GW of new renewable energy capacity dedicated to green hydrogen production, along with investments exceeding

8 lakh crore. The Mission is expected to create over 6 lakh jobs, reduce fossil fuel imports by more than 1 lakh crore, and avoid nearly 50 MMT of greenhouse gas emissions every year by 2030.

As of May 2025, 19 companies have been allocated a cumulative annual production capacity of 862,000 tonnes of Green Hydrogen every year and 15 firms have been awarded a 3,000 MW annual electrolyzer manufacturing capacity. India has also launched pilot project in steel, mobility and shipping sectors.


Sectoral Innovation & Implementation Under NGHM

Launched in January 2023, the National Green Hydrogen Mission has an initial outlay of 19,744 crore till Financial Year 2029-30. This includes 17,490 crore for the Strategic Interventions for Green Hydrogen Transition (SIGHT) programme, 1,466 crore for pilot projects,

400 crore for research and development (R&D), and 388 crore towards other Mission components.

The Mission focuses on four key pillars, including policy and regulatory framework, demand creation, research and development & innovation, and enabling infrastructure and ecosystem development — aimed at positioning India as a global hub for green hydrogen production, use, and export.

To augment the Mission's vision, the government has also launched multiple

(i) Strategic Interventions for Green Hydrogen Transition (SIGHT) Scheme: A financial incentive mechanism with an outlay of 17,490 crore up to 2029-30 provides incentives for the manufacturing of electrolysers that are used for production of green hydrogen.

(ii) Development of Green Hydrogen Hubs: In October 2025, the Ministry of New and Renewable Energy (MNRE) has announced the recognition of three major ports Deendayal Port Authority (Gujarat), V.O. Chidambaranar Port Authority (Tamil Nadu), and Paradip Port Authority (Odisha) as Green Hydrogen Hubs under the NGHM. These coastal gateways will serve as integrated centres for production, consumption, and future export.

(iii) Standards, Certification and Safety: Launched in April 2025, the Green Hydrogen Certification Scheme of India (GHCI) provides a national framework to certify hydrogen as "green" by assessing its greenhouse gas emissions across the entire production cycle. The scheme ensures that only hydrogen produced using renewable energy, and within the prescribed emission limits, can be officially labeled as Green Hydrogen. It provides

transparency, traceability, and credibility for producers, buyers, and export markets. Under the GHCI, obtaining a 'Final Certificate' is mandatory for any green hydrogen production facility in India that (a) receives subsidies or incentives from the

(iv) Strategic Hydrogen Innovation Partnership (SHIP): The Mission fosters public-private partnerships for R&D through the Strategic Hydrogen Innovation Partnership (SHIP). It is designed to support the development of advanced, globally competitive hydrogen technologies through collaborative research involving Government institutions, industry, and academic organisations. The programme includes the creation of a dedicated R&D fund with contributions from both the Government and industry. Under SHIP, consortium-based research will be encouraged to leverage the strengths of national scientific institutions such as BARC, ISRO, CSIR, IITs, IISc, and other partners. The objective is to drive innovation across the Green Hydrogen value chain and support domestic manufacturing capability.

A dedicated 400 crore R&D scheme under the Mission is already powering 23

cutting-edge projects across areas such as hydrogen production, safety systems, storage, and industrial applications. In addition, a 100 crore Call for Proposals has been launched to support start-ups working on innovative technologies for hydrogen production, storage, transport and utilisation, with funding of up to 5 crore per project. These initiatives are aimed at developing globally competitive technologies and reducing costs across the hydrogen value chain.

The second round of R&D proposals, launched in July 2025 focuses on collaborative research and industry participation, with over 30 joint proposals internationally submitted under the EU–India Trade and Technology Council.

Pathways For Adoption

The roadmap is not just limited to forming policies and providing subsidies, but green hydrogen is also being introduced in key sectors to reduce emissions, supporting domestic manufacturing, and replacing fossil-based hydrogen and feedstock. The NGHM is facilitating applications across industry, mobility, and infrastructure.

Industrial

Fertilizers: Replacing fossil-fuel-based feedstocks with Green Ammonia. A recent auction for a long-term supply of green ammonia to fertilizer units, with an aggregate procurement capacity of 7.24 lakh metric tonnes per annum, at a price of 55.75 per kg

55.75 per kg.
Petroleum Refining: The Mission is seamlessly facilitating the replacement of fossil-based hydrogen with green hydrogen in refineries, directly reducing the carbon footprint of this essential industry.

Steel: Five pilot projects have been initiated in collaboration with public and private steel producers to evaluate the use of Green Hydrogen for iron reduction and other process applications. These pilots are designed to assess the technical feasibility, economic viability and safety of hydrogen-based steelmaking in Indian operating conditions.

Mobility and Transport

Road Transport: In March, five major pilot projects were initiated involving 37 hydrogen vehicle (buses and trucks), and 9 refueling stations across 10 different routes. The vehicles to be deployed for the trial include 15 hydrogen fuel cell-based vehicles and 22 hydrogen internal combustion engine-based vehicles. The financial support for the project would be around Rs. 208 crore.

Shipping: India's first port-based Green

Hydrogen Pilot Projectwas commissioned at V.O. Chidambaranar Port in September 2025. The 25 crore, 10 Nm³/hr facility will produce green hydrogen for local applications, including street lighting and an EV charging station. A 42 crore, 750 m³ Green Methanol Bunkering and Refuelling Facility is also being developed to support cleaner maritime operations and enable a Coastal Green Shipping Corridor between Kandla and Tuticorin.

High-Altitude Mobility: NTPC in

High-Altitude Mobility: NTPC in November 2024was commissioned the world's highest altitude (3,650 m) Green Hydrogen Mobility Project in Leh, which includes 5 hydrogen intra-city buses and a fuelling station proving the fuel's reliability in extreme conditions. This station shall mitigate the carbon emissions of approx. 350 MT/year and contribute 230 MT/year of pure oxygen into the atmosphere which is equal to planting of approx. 13000 trees.

Enabling Framework:

Beyond direct incentives, a comprehensive enabling framework is being established to de-risk investments and accelerate development.

Policy Framework: To facilitate the delivery of low-cost renewable energy for hydrogen production, the government has provided a waiver of Interstate transmission charges and ensured a time-bound grant of Open Access.

Skill Development: A coordinated skill development programme is being implemented, which has already led to the certification of more than 5,600 trainees in hydrogen-related qualifications, building a future-ready workforce.

Building Global Partnerships

In 2024, India made its debut in the international hydrogen community at the World Hydrogen Summit in Rotterdam with the inauguration of its first India Pavilion. This positions India as a prime partner for global investment, and key partner in the emerging global hydrogen economy.

EU-India Collaboration: Under the EU-India Trade and Technology Council, collaboration is expanding, with over 30 joint proposals received on hydrogen production from waste.

India-UK Partnership: A dedicated Standards Partnership Workshop in February 2025was held to strengthen cooperation on hydrogen standardization, focusing on safe, scalable, and globally harmonized Regulations, Codes and Standards (RCS) to enhance trade.

Partnership with H2Global: In November 2024, Solar Energy Corporation of India (SECI) signed an MoU with Germany's H2Global Stiftung to collaborate on market-based mechanisms and joint tender designs, facilitating the export of Indian green hydrogen to international markets.

Singapore: In October 2025, Sembcorp Industries signed MoUs with V.O. Chidambaranar and Paradip Port Authorities to develop integrated greenhydrogen and ammonia hubs for production, storage and exports.

Conclusion: A Legacy of Clean Growth

Green hydrogen stands at the center of India's clean energy strategy, driving the shift toward a low-carbon and self-reliant economy. Building on one of the world's most competitive renewable energy bases, the National Green Hydrogen Mission is expanding domestic production, scaling innovation, and opening global markets for green hydrogen and its derivatives. The Mission reduces dependence on fossil fuels, accelerates industrial transformation, and positions India to lead with credibility in the global clean energy transition—advancing a future that is sustainable, secure, and self-sustained.

Budgam, Nagrota vote count today



Srinagar/Jammu, Nov 13: As political parties and voters await the outcome with bated breath, counting of votes for the Budgam and Nagrota Assembly constituencies will take place on Thursday.

The Election Commission of India has made elaborate arrangements for the smooth conduct of the counting process for the Budgam and Nagrota Assembly seats, where voting was held on November 11.

According to details available, the process of counting will begin at 8 a.m. with postal ballots, while the counting of Electronic Voting Machines (EVMs) will start at 8:30 a.m. Returning Officer for the Budgam Assembly segment, Afroza Bano, said that 15 rounds of counting will be conducted for the seat. However, Returning Officer for the Nagrota constituency, Rajesh Kumar, declined to share details about the counting process, stating that he was busy.

A total of 27 candidates are in the frav for these two constituencies, which were previously won by the National Conference and the BIP, respectively.

Field reports suggest that the outcome of the Budgam Assembly segment is likely to be decided by a narrow margin between National Conference's Aga Mehmood and PDP's Muntazir Mehdi. In Nagrota, BJP's Devyani is reported to have the upper hand in the contest for the seat, which fell vacant following the demise of her father, Devinder Singh Rana.

As per the Election Commission of India, the Budgam Assembly constituency recorded a turnout of 50.01%, while the 77-Nagrota Assembly constituency registered 74.82%—(KNO)

Outrage over child's death at SKIMS Soura

Srinagar, Nov 13: A case of alleged medical negligence at SKIMS Soura has sparked outrage after a Srinagar couple accused doctors and staff of apathy leading to the death of their one-year-old son on October 18, 2025. The incident detailed in a

Facebook post by the child's mother, Sumaira, has drawn widespread attention and prompted SKIMS authorities to issue a clarification that the investigation in this regard is at a final stage.

According to Sumaira's account, the ordeal began on Friday, October 17, when her son, Ahmad Nayeem, developed fever, vomiting, and flu-like symptoms. After struggling to find a paediatrician in the morning, the family visited Noora Hospital upon learning that paediatrician Dr Tanveer Bashir was available. However, upon reaching the hospital around noon, they reportedly waited for hours before the doctor arrived around 2:45 pm.

"The doctor didn't check my baby physically; not even his chest, fever, or basic vitals," the mother alleged. "He wrote a prescription without examining him, even when I mentioned that my child seemed dehvdrated.

Later that night, as Ahmad's condition



gency Department. There, Sumaira said, they faced an "unresponsive and negligent attitude" from the on-duty medical staff.

"When we entered the paediatric ER, there was only one doctor, identified as Dr Tahir, and no nurse was present," she wrote. 'The nurse appeared after 15 minutes and pricked my baby eight times before successfully drawing blood. Throughout the night, the doctor and nurse were sleeping in the ER, and we had to wake them up multiple times as our baby's condition deteriorated."

The mother alleged that despite repeated pleas, her son was neither examined properly nor admitted promptly. "When his lips turned blue and his oxygen dropped to 64, we begged them to check him, but they dismissed it, saying the machine wasn't working," she wrote. "It was

worsened, the family rushed only after I raised my voice came to see him. By then, it was too late.'

According to the family, Ahmad was shifted to the NICU in critical condition, where doctors declared him dead shortly after 10 a.m. on October 18.

"We walked out of the NICU in silence, not wanting to disturb other patients," Sumaira wrote. "But we have received no call or assurance from the authorities or the doctors' association since then. We are still waiting for justice."

Sumaira, along with her family, has demanded a proper investigation in this regard and action against

the involved doctors. Following the viral post. FAIMA Doctors Association, led by Dr Mohammad Momin Khan, called for a thorough and impartial probe, urging the Director of SKIMS to take urgent action "if any negligence is found".

In response, SKIMS

Medical Superintendent issued a statement confirming that the institution had received a formal complaint from the bereaved parents on October 18. "Following the complaint, SKIMS constituted a committee to examine the matter in detail. The Head of the concerned Department has already attached the involved doctors with the Convenor of the Committee interim measure," the statement read.

"The committee is in the final stages of its inquiry and is awaiting the parents' version to ensure a fair, transparent, and comprehensive investigation," it added. "The SKIMS administration assures that justice will be delivered, and strict action will be taken if anyone is found guilty. There is zero tolerance for any casual or negligent approach by doctors, nurses, or paramedical staff while dealing with patients."

The incident has reignited debate about medical accountability and patient care standards in major healthcare institutions in Kashmir, Locals and social media users have expressed solidarity with the bereaved family, demanding a time-bound inquiry and stricter regulations to prevent such tragedies in the future—(KNO)

Addressing a press conference at his office, SSP Ajaz Ahmad said traffic pressure in Srinagar has grown sharply in recent weeks as schools and offices now open around the same time particularly along M.A. Road and Residency Road, the city's busiest corridors.

The shorter autumn daylight window, he said, has further narrowed the time available to regulate peakhour movement.

The SSP said that despite the Darbar Move offices shifted to Jammu, traffic complaints have increased.

"Earlier, school timings were 8



es start at 10 AM. As everyone leaves and returns together, the traffic load converges on key routes," he said, adding that the situation worsens in the evening when people finish work between 3 and 4 PM.

He said additional personnel are being deployed at critical junctions and appealed for citizen cooperation.

"We understand the public's inconvenience, but people must avoid roadside parking and prefer shared or public transport. Only collective effort can ease the gridlock," he said.

The SSP also urged citizens to opt for public transport instead of private vehicles. "We are doing our best to ensure convenience for the public. Wherever we observe increased congestion, we deploy additional manpower. However, during winter, people tend to leave home late and return early, and with school timings and examinations overlapping, we understand the difficulties

On Rambagh-Natipora stretch, identified as a persistent bottleneck, SSP Ajaz said vehicles are being diverted via Doodhganga to reduce pressure. "We have raised the issue of traffic interception near Rambagh with civil authorities. Once the under-Barzulla Bridge route is completed, it will significantly improve flow in the area," he

Baramulla police intensifies action against terror network

Gund Darvesh residents demand toxic shed cleanup

Shopian Nov 13: What was once envisioned as a model waste management facility has now become a source of distress for residents of Gund Darvesh. Amerbugh, and adjoining areas in South Kashmir's Shopian district.

The segregation shed, set up to promote scientific waste management, has instead turned into a dumping site for household garbage and animal carcasses, posing seri-

ous health and environmental hazards. Locals say that the facility, which was meant to improve sanitation, has now become a "nuisance" for residents and commuters alike. "People from nearby villages have converted the segregation shed into an open dumping ground. Every day, heaps of garbage and even carcasses of dead animals are thrown here, spreading unbearable stench throughout the area,"

said Gulzar Ahmad Wani, a resident of Gund Darvesh.

He added that the situation has worsened over recent months due to poor supervision by authorities.

"The shed is situated close to the main road. The smell is so strong that it's difficult for people to pass by. The air is polluted, and we constantly fear the outbreak of diseases," said another resident, Zameer Ahmad. He said the foul smell has made life miserable for those living nearby. "School-going children and pedestrians suffer the most. The stench is intolerable, and sometimes we even see animal carcasses lying in the open. This is not just about inconvenience — it's a pub-

lic health crisis," he said. Children who pass through the area on their way to school said they feel unsafe due to the presence of stray dogs that gather around the waste pile. "Dogs are



always present there, and we are scared to cross the area. They could attack us anytime," said a group of students.

They said that site was cleared several times but later the process of dumping waste here continued as vehicles hired by the RDD department are throwing all waste here.

Residents say they have repeatedly brought the issue to the attention of concerned authorities, but no substantial action has been taken so far. "Officials visit occasionally, click a few photos, and leave — but nothing changes on the ground. We urge the district administration to either relocate the segregation shed or ensure proper management of the waste," said Sara Begum, another local.

Environmental experts have also sounded the alarm, warning that unscientific waste disposal can lead to the spread of infectious diseases, attract stray animals, and contaminate nearby water sources.

They stressed the need for regular waste collection, proper segregation, and treatment measures to safeguard public health and the environment.

Residents have appealed to the district administration Shopian and BDO concerned to intervene immediately and ensure that the segregation shed is either properly maintained or shifted away from the residential area to prevent further suffering—(KNO)

If goods or services purchased for profit then purchaser is not consumer: SC

New Delhi, Nov 13: In a significant verdict, the Supreme Court on Thursday held that if any purchase of goods or services is for profit generation, then the purchaser cannot be held to be a consumer and consequently cannot pursue cases under the Consumer Protection Act.

A bench of Justices JB Pardiwala and Manoj Misra, delivering the judgement in an appeal filed by M/s Poly

Medicure Ltd, affirmed the findings of the State and National Consumer Disputes Redressal Commissions that the complaint filed by the company was not maintainable under the Act.

It held that a company purchasing software to automate its business processes cannot be regarded as a "consumer" under the Consumer Protection Act, 1986, as such a transaction is for a "commercial purpose". Authoring the verdict, Justice

Manoj Misra referred to various iudgements and said. "the transaction of purchase of goods/ services (i.e., software) had a nexus with generation of profits and, therefore, qua that transaction the appellant cannot be considered a consumer as defined in Section 2(1)(d) of the 1986 Act."

If the transaction has a nexus with generation of profits, it would be treated as one for a commercial purpose, it said while dismissing the appeal of the firm.

A top official told KNO that J&K police were investigating into a routine incident after posters - linked to Jaish-e-Mohammad - were put up in Bunpora area of Nowgam on the intervening night of October 16 and 17 this year.

He said that the investigation led the police to Dr Adeel, who is believed to have been captured in a CCTV footage while putting up posters in the Nowgam area. "As the investigation intensified J&K police

traced Dr Adeel in Uttar Pradesh's Saharanpur. He was then arrested by the police on October 27. Following his arrest the lid was blown off he major terror plot that led to arrest of Adeel's other associates Dr Muzzamil and Dr Shaheen and subsequently led to the recovery of 2900 kg of explosives from Faridabad," he said.

Delhi Blast Link Traces To Dubai Probe into the Delhi car blast has now extended to Dubai as Dr Adeel's brother Muzzafar Rather, who is currently in Dubai is now a key

focus of investigators. Sources told KNO that Muzzafar went to Pakistan before travelling to Dubai two months ago. "Inputs suggest that Muzzafar has direct links with Jaish-e-Mohammad and investigators suspect his Dubai visit may have been to arrange terror funding.

They said that investigators are tracking whom he met in Pakistan before leaving for Dubai. "Dr Adil is also being questioned about any foreign travel and his links with his brother regarding the terror module," they added.

Home Minister Vows Strictest Punishment To Perpetrators

Home Minister Amit Shah on Thursday chaired high-level meeting at his residence today morning that lasted for over an hour over the Delhi blast case.

Per details, the meeting was attended by Home Secretary, Director of the Enforcement Directorate, Intelligence Bureau chief and other senior officials. Meanwhile, Amit Shah on Thursday said that

perpetrators of the Delhi blast will face strictest punishment and that it will be a message to the world that such attacks in India won't go unpunished.

He said that the government is determined to ensure that perpetrators of the Delhi terror incident are brought to justice. "PM Modi is committed to delivering strict punishment to those involved in the attack." he said.

Doctor Module Had Planned Blasts On Babri Masjid Demolition Anniversary

Investigators probing the Delhi blast case have uncovered chilling details: the terror module involving doctors had planned blasts at six locations in the National Capital Region on December 6, the Babri Masjid demolition anniversary.

Those arrested in connection with the blast have revealed the date was chosen because they wanted to "avenge the Babri Masjid demolition".

According to investigators, the members of the module have said during interrogation that they had prepared a phase-wise plan to carry out serial blasts in Delhi-NCR. (KNO)

Kanpur cardiologist detained by ATS; links with arrested lady doctor under scanner

Kanpur (UP), Nov 13: The Uttar Pradesh Anti-Terrorism Squad has detained a medical student from Kanpur as part of its investigation into the recent Delhi blast, officials said on Thursday.

Dr Mohammad Arif (32), a first-year Doctor of Medicine (Cardiology) student at the staterun Ganesh Shankar Vidyarthi Memorial (GSVM) Medical College, was taken into custody from an undisclosed location, a senior official told PTI.

An Anti-Terrorism Squad (ATS) team searched his rented accommodation at Ashok Nagar in Nazirabad, seized his mobile phone and laptop for forensic examination, and took him to

Delhi for questioning.
"He is likely to be confronted with those already arrested in the case," the official added.

Arif, a native of Anantnag in Jammu and Kashmir, came under the ATS radar following disclosures made during the interrogation of former GSVM



professor Dr Shaheen Sayeed, who had earlier been arrested in the same case. Investigators suspect that Arif was in regular contact with Dr Shaheen and her brother Dr Parvez, both of whom have been questioned extensively.

Sources said that on the day of the explosion near Delhi's Red Fort, Arif was in telephonic contact with individuals allegedly linked to Dr Shaheen's network. He had also visited Jammu and Kashmir recently, which raised further suspicion. When ATS personnel reached his residence, he allegedly attempted to delete data from his phone but officials seized the device in time.

Preliminary analysis of his call records and chats is said to have indicated communication with the alleged mastermind and other suspects. Investigators believe the group used a shared e-mail ID to exchange draft messages, a method often employed by terror outfits to avoid electronic

The development has caused unease among doctors and students at GSVM Medical College, particularly in the Cardiology Department, where Arif had joined only three months ago.

Confirming this, Chief Medical Superintendent (Cardiology) Dr Gyanendra said, "Dr Arif joined here three months ago through All India counselling. He was on duty on Wednesday afternoon and later went to his accommodation outside campus. Around 7 pm, we were informed that he has been taken for questioning. He was from Kashmir and lived off-campus. He used to come, work quietly and leave."

Dr Gyanendra said that the screening of all first, second and third-year cardiology students has been initiated as a precautionary measure.

Arif's landlord Kanhaiya Lal said he has been staying on rent for about a month with another doctor, Abhishek, on the second floor of his house. "Around 7.30 pm, a four-member team came

straight to his room. They already had the keys, searched the entire portion, locked it again, and left quietly," Lal told reporters.

He said Arif had submitted his ID before renting the room but he never noticed any suspicious activity or unusual visitors.

A top police official, requesting anonymity, confirmed that Arif was detained in Kanpur and later handed over to central investigating agencies for further interrogation. Kanpur Police Commissioner Raghubir Lal told PTI that he has received information about the detention and has sent a team to verify the reports.

"We are checking the facts. I will comment only after confirmation," he said, neither confirming nor denying the detention.

Meanwhile, ATS and National Investigation Agency teams are continuing operations in Kanpur to trace any additional links to Dr Shaheen's network.

Al-Falah University gets show-cause from NAAC over 'false accreditation claims'

New Delhi, Nov 13: The National Assessment and **Accreditation Council** (NAAC) has issued a showcause notice to Al-Falah University, which is under scanner in connection with the Delhi blast probe, for displaying false accreditation on its website, officials said on Thursday.

In the show-cause notice, the NAAC said it has noted that the Al-Falah University, which is neither accredited nor applied for accreditation by NAAC", has publicly displayed on its website that "Al-Falah University is an endeavour of Al-Falah

Charitable Trust, which has been running three colleges on the campus, namely Al Falah School of Engineering and Technology (since 1997, Graded A by NAAC), Brown Hill College of Engineering and Technology (since 2008), and Al-Falah School of Education and Training (since 2006, Graded A by NAAC)."

"This is absolutely wrong and misleading the public, especially the parents, students and stakeholders," the show-cause notice read.

The NAAC has sought an explanation and directed the university to remove the NAAC accreditation details from its website and any other publicly available or

distributed documents. On Monday, a high-intensity blast ripped through a car near Red Fort in Delhi, killing 13 people and injuring several others, hours after the

'Tiger Zinda Hai': JD(U) celebrates Nitish **Kumar day before** poll results

Patna, Nov 13: A poster dedicated by former Bihar Minister Ranjit Sinha, outside the Janata Dal (United) office in Patna. has bestowed Chief Minister Nitish Kumar with the title of a 'Tiger who still has the power (Tiger Zinda hai)', describing the latter as the "protector" of all the communities, including those on the margins of society.

The poster reflects the desire of party workers to see Nitish Kumar become the Chief Minister of Bihar for the fourth time. The 2025 Bihar assembly polls have witnessed strong and constant criticism from the opposition Mahagathbandhan over the delay in declaring a Chief Ministerial candidate with certainty. Citing Union Minister Amit Shah's previous statements, Rashtriya Janata Dal (RJD) leader and opposition's CM face Tejashwi Yadav has time and again claimed that Nitish Kumar will not be the CM if NDA comes to power.

On October 15, Tejashwi also claimed that JD(U) is not controlled by Nitish Kumar but by leaders "brought by the BJP".

However, multiple NDA leaders, including those in the Bharatiya Janata Party (BJP), have attempted to clear the air by declaring Nitish Kumar as their leader. Prime Minister

Narendra Modi, while campaigning in Bihar, backed Nitish Kumar as the leader of the ruling NDA. Amit Shah also assured that there was no vacancy for the CM post in Bihar, implying that Kumar remains crucial to retain power.

Recently, Union Minister and Bihar BJP in-charge Dharmendra Pradhan on Monday firmly stated that there was no confusion about JD(U) chief Nitish Kumar being the Chief Ministerial face of the NDA.

"Prime Minister (Narendra Modi) has been very clear. He has already said that we do not have a vacancy. Why should we name the person (who is the sitting CM)? The name is Nitish Kumar. Where is the confusion? We don't have any confusion. Our (CM) face is Nitish Kumar," Pradhan told ANI in an interview. Votes will be counted on November 14.

In 2020, polling took place in three phases. The National Democratic Alliance (NDA) secured 125 seats, while the opposition Mahagathbandhan (MGB) won 110. Among the major parties, the Janata Dal (United) secured 43 seats, the BJP secured 74, the RJD secured 75 seats, and the Congress secured 19. The JD(U) contested 115 constituencies, and the BJP 110, whereas the RJD contested 144 seats and the Congress 70.

SC bans mining activities within one km radius of national parks, wildlife sanctuaries A bench comprising Chief

New Delhi, Nov 13: The Supreme Court on Thursday within an area of one km from national parks and wildlife sanctuaries, noting that such activities will be hazardous to the wildlife.

Justice of India BR Gavai and Justice K Vinod Chandran was considering pleas on issues banned mining activities related to the notification of areas under Saranda Wildlife Sanctuary (SWL) and the Sasangdaburu Conservation Reserve (SCR) as a conservation reserve in Jharkhand.

"It has been the consistent view of this court that mining activities within one km of the protected area will be hazardous to the wildlife. Though in the case of Goa Foundation, the said directions were issued with respect to the State of Goa, we find that such directions

need to be issued on a pan-India basis," the bench said.

"We direct that mining within national parks and wildlife sanctuaries and within an area of one km from boundary of such national park or wildlife sanctuary shall not be permissible," the

Symbolic handover of 8 cheetahs to Prez Murmu at Botswana's nature reserve

Gaborone (Botswana), Nov 13: President Droupadi Murmu on Thursday was symbolically handed over eight cheetahs by her Botswana counterpart Duma Gideon Boko at a nature reserve near here on the last day of her state visit.

The two heads of state reached the Mokolodi Nature Reserve, about 10 kms south of capital Gaborone, earlier in the morning and took a safari vehicle to witness the event of two captured big cats being released into a quarantine pen.

Wildlife officials from India and Botswana also briefed Murmu and Boko about the procedure.

Officials said all the eight cheetahs are in the reserve and only two were released for quarantine in the presence of the heads of state as a symbolic gesture of handing over them to India by Botswana.

The cheetahs, a mix of adult and sub-adult males and females, have been brought to the nature reserve from the Ghanzi town located in the Kalahari desert, that forms 70 per cent of the landmass of this southern Africa located country.

The Mokolodi reserve, spread over 3,700 hectares, is a private notfor-profit game reserve It is inhabited by rhinoceros, giraffes and a variety of indigenous African bird

and reptile species, some of which are rare and vulnerable to the threat of extinction, as per official information.

All eight cheetahs are expected to reach India in the next few weeks after completion of their quarantine process here.

Murmu is on a threeday state visit to Botswana which concludes on Thursday.

The translocation of the cheetahs from Botswana to India as part of the Project Cheetah was announced by the two presidents on Wednesday during a press briefing after holding delegation level talks at Boko's office here.

Murmu thanked the African nation for the endeavour in wildlife conservation and assured that India will take "good care" of the cheetahs.

Boko said his country's move to donate the cheetahs will assist regeneration of the population of the big cat in India. India's cheetah re-in-

troduction story began on September 17, 2022 when Prime Minister Narendra Modi released eight cheetahs brought from Namibia into a special enclosure at Kuno National Park in Madhya Pradesh, marking the world's first intercontinental relocation of a large wild carnivore species. India later imported 12 more cheetahs from South Africa in February 2023.

Bihar: Women outgun men by over 14 pc points in voter turnout in 7 districts



Patna, Nov 13: Women outdid men by 14 percentage points and more in voter turnout in seven districts of Bihar, where assembly elections were recently held, as per the Election Commission.

In 10 other districts, the gap was over 10 percentage points. Patna, however, was the only district in the state to have recorded more turnout of men than women. A total of 57.88 per cent of the women voters in the district exercised their franchise, while 60.05 per cent of the men voted in the polls.

Bihar's 243 assembly seats went to the polls in two phases on November 6 and 11. Results will be declared on November 14.

Bihar registered a historic voter turnout of 67.13 per cent, the highest-ever in the state. Women's voter turnout was 71.78 per cent, while polling percentage among men was 62.98, as per an EC statement. EC's latest gender-wise data regarding voter turnout in

all 38 districts showed that Supaul recorded the biggest gap at 20.71 percentage points, as 83.69 per cent of the women exercised their franchise, while 62.98 per cent of the men voted in the polls.

A wide gap in favour of women was also recorded in Kishanganj (19.5 per cent), Madhubani (18.4), Gopalganj (17.72), Araria (14.43), Darbhanga (14.41) and Madhepura (14.24). Districts where wom-

en's voter turnout was over 10 percentage points more than that of men were Siwan (13.83), Purnea (13.36), Sheohar (12.48), Sitamarhi (12.43), Saharsa (12.37), Purvi Champaran (11.13), Paschim Champaran (11.03), Khagaria (10.66), Samastipur (10.64) and Banka (10.53). In the first phase of polling on November 6 in 121 assembly seats, women's voter turnout was 69.04 per cent, while polling percentage among men was 61.56. In the second phase of polling, women's voter turnout was 74.56 per cent, whereas it was 64.41 per cent

Trump signs deal to end longest US govt shutdown in history

Washington, Nov 13: President Donald Trump on Wednesday signed legislation ending the longest government shutdown in US history, roughly two hours after the House of Representatives voted to restart disrupted food assistance, pay hundreds of thousands of federal workers and revive a hobbled air-traffic control system.

The Republican-controlled chamber passed the package by a vote of 222-209, with Trump's support largely keeping his party together in the face of vehement opposition from House Democrats, who are angry that a long standoff launched by their Senate colleagues failed to secure a deal to extend federal health insurance

Trump's signature on



the bill, which cleared the Senate earlier in the week, will bring federal workers idled by the 43-day shutdown back to their jobs starting as early as Thursday, although just how quickly full government services and operations will resume is unclear.

It would extend funding through January 30,

leaving the federal government on a path to keep adding about \$1.8 trillion a year to its \$38

trillion in debt.
"I feel like I just lived a Seinfeld episode. We just spent 40 days and I still don't know what the plotline was," said Republican Representative David Schweikert of Arizona,

dling of the shutdown to the misadventures in a popular 1990s US sitcom.

"I really thought this would be like 48 hours: people will have their piece, they'll get a moment to have a temper tantrum, and we'll get back to work."

He added: "What's happened now when rage is policy?"

The shutdown's end offers some hope that services crucial to air travel in particular would have some time to recover with the critical Thanksgiving holiday travel wave just two weeks away. Restoration of food aid to millions of families may also make room in household budgets for spending as the Christmas shopping season moves into high gear.

It also means the restoration in coming days of the flow of data on the US economy from key statistical agencies. The absence of data had left investors, policymakers and households largely in the dark about the health of the job market, the trajectory of inflation and the pace of consumer spending and economic growth overall.

Some data gaps are likely to be permanent, however, with the White House saying employment and Consumer Price Index reports covering the month of October might never be released.

By many economists' estimates, the shutdown was shaving more than a tenth of a percentage point from gross domestic product over each of the roughly six weeks of the outage, although most of that lost output is expected to be recouped in the months ahead.

Special Bangladeshi tribunal to deliver verdict against Hasina on Nov 17

Dhaka, Nov 13: Bangladesh's International Crimes Tribunal (ICT-BD) on Thursday announced it would deliver the verdict against deposed prime minister Sheikh Hasina on November 17 after her trial in absentia on charges of crimes against humanity.

"The three-judge tribunal set November 17 for delivering the verdict," a journalist attending the tightly secured special court in the capital told PTI.

Hasina, her home minister in the ousted Awami League government, Asaduzzaman Khan Kamal and then inspector general of police (IGP) or police chief Chowdhury Abdullah Al-Mamun were tried in the tribunal. The ex-premier and Kamal were tried in absentia, with the court declaring them



fugitives. ICT-BD Chief Prosecutor Mohammad Tajul Islam earlier demanded the death penalty for the accused.

Mamun faced the trial in person but emerged as an approver or state witness.

The former police chief appeared on the dock as the ICT-BD chair Justice Mohammad Golam Mortuza Majumder fixed the date.

The tribunal on October 23 concluded the hearing on the case after over 28 working days, when 54 witnesses testified before the court describing how efforts were made to tame last year's student-led movement called July Uprising that toppled Hasina's now disbanded Awami League government on August 5, 2024.

The Bangladesh capital on Thursday woke up to a heightened security vigil over the "Dhaka lockdown" call by the Awami League, coinciding with a tribunal's announcement of the verdict date.

Authorities called up army troops, paramilitary Border Guard Bangladesh (BGB) and police in riot gear to spread a security blanket in and around the International Crimes Tribunal (ICT-BD) complex at central Dhaka.

PCB reworks schedule of tri-series against Zimbabwe, SL amid security concerns

Lahore, Nov 13: The Pakistan Cricket Board has rescheduled the opening of a T20l tri-series against Sri Lanka and Zimbabwe from November 17 to November 18 besides making Rawalpindi the sole venue for the tournament amid security concerns in the wake of a suicide attack in Islamabad.

The second game of the seven-match rubber has also been postponed by a day to November 20. Earlier, Lahore was scheduled to host five games of the event, including the final on November 29 but the three boards have agreed to hold the proceedings exclusively in Rawalpindi now.

"The decision to revise the schedule was made in consultation with Sri Lanka Cricket (SLC) and Zimbabwe Cricket (ZC), following mutual discussions to accommodate operational and match requirements," the PCB said in a statement after a night of hectic negotiations to ensure that the Lankan players do not leave an ongoing ODI series midway.

The Zimbabwe cricket team reached Islamabad early Thursday morning amid tight security for what is being described as an "important preparatory platform ahead of the 2026 ICC T20 World Cup", by the PCB.

Each team will feature in four matches, with the top two sides qualifying for the final. The Sri Lankan cricket team will also continue with its bilateral tour of Pakistan and no player or official is planning to return home, according to its team manager, Mahinda Halangoda.

G7 diplomats publicly show support for Ukraine but avoid contentious issues like trade

Niagara-On-The-Lake (Ontario), Nov 13: Top diplomats from the Group of Seven industrialized democracies publicly showed their consensus on Ukraine and Sudan on Wednesday, but stayed away from contentious issues like the US military strikes on boats in the Caribbean and trade.

The foreign ministers of the G7 met with Ukraine's foreign minister on Wednesday as Kyiv tries to fend off Russian aerial attacks that have brought rolling blackouts across the country. Andriy Sybiha said Ukraine needs the support of its partners to survive what will be a "very difficult, very tough winter."

"We have to move forward to pressure Russia, to raise the price for the aggression, for Russia, for (Russian President Vladimir) Putin, to end this war," Sybiha said.

The G7 ministers said in a joint statement at the conclusion of the two-day gathering that



they are increasing the economic costs to Russia and exploring measures against those who finance Russia's war efforts.

Canada announced more sanctions against Russia, including targeting those involved in the development and deployment of drones, and Britain, a day earlier, pledged money for Ukraine's energy infrastructure

US Secretary of State Marco Rubio made no immediate announcements about new US initiatives but said on social media that the meeting delved into ways "to strengthen Ukraine's

defense and find an end to this bloody conflict."

"We are doing whatever is necessary to support Ukraine," Canadian Foreign Minister Anita Anand said. The meeting in Niaga-

ra-on-the-Lake, near the US border, followed US President Donald Trump's decision to end trade talks with Canada after the Ontario provincial government ran an anti-tariff advertisement in the US, which upset him. That followed a spring of acrimony, since abated, over the president's insistence that Canada should become the 51st US state.



the trade issue. US military strikes also 'didn't come up'

The Trump administration says the US military has killed at least 75 people in 19 known strikes against what it says are drug-smuggling vessels in the Caribbean Sea and eastern Pacific Ocean since early September. The administration has been under pressure from Congress to provide more information about who is being targeted and the legal justification for the strikes.

Rubio told reporters that questions about the military campaign and intelligence sharing in support of the operations were not raised with him at all by any of his G7 or other counterparts on Wednesday.

US decision of G20 summit boycott 'their loss': SA president



Cape Town, Nov 13: US President Donald Trump's decision that the United States government boycott the Group of 20 summit next weekend in South Africa is "their loss," South Africa's leader said Wednesday.

South African President Cyril Ramaphosa added that "the United States needs to think again whether boycott politics actually works, because in my experience it doesn't work."

Trump announced last week on social media that no US government official would attend the Nov. 22-23 meeting of leaders from 19 of the world's richest and leading developing economies in Johannesburg, citing his widely rejected claims that members of a white minority group in South Africa are being violently persecuted and having their land taken from them because of their race. The US president has for months targeted South Africa's Black-led government for criticism over that and a range of other issues, including its decision to accuse US ally Israel of genocide against Palestinians in Gaza in an ongoing and highly contentious case at the United Nations' top court.

"It is unfortunate that the United States decided not to attend the G20," Ramaphosa told reporters outside the South African Parliament.

Ashes 2025-26: Smith says England speed kings could struggle in Australia

Sydney, Nov 13: Steve Smith believes England may have picked the wrong bowlers for the Ashes, suggesting Australian wickets will be better suited to seam and swing than an all-out pace attack.

The tourist is heavily relying on speed merchants led by Jofra Archer and Mark Wood for the five-Test showdown, with Gus Atkinson, Brydon Carse, Matthew Potts and Josh Tongue also in the squad.

Almost all of them can deliver rockets in excess of 145 kph (90 mph), but none are seen as traditional seamers.

Smith, who will captain Australia at the first Test at Perth next week with Pat Cummins injured, said the wickets could better suit bowlers like James Anderson and Stuart Broad.

Both those prolific stalwarts, who excelled with swing and seam, are now retired.

England left out Chris Woakes, a bowler in a similar vein. Smith's assessment came after playing Sheffield Shield matches at the Gabba in Brisbane and Sydney Cricket Ground, where he was in fine

touch with the bat.
"It's different on the wickets now, I think," Smith told
Australian media late on
Wednesday after hitting 57
and 56 not out against Victoria to go with his 118 against



Queensland.

"I mean, those sort of nibblers (seamers) can be quite tricky. So they might have got things the wrong way around, if that makes sense, in terms of the pace, from previous years.

"Obviously, they've got those guys at their disposal now. They probably weren't fit and ready, or old enough, maybe, a few years back.

"Sometimes the slower guys are almost harder to play on those wickets where you have to make the pace, but yeah, we'll wait and see, won't we?"

Smith shapes as a pivotal player for Australia, and has hit the ground running after a sixweek break where he did not pick up a bat.

"It was nice to just be able to

"It was nice to just be able to spend some time in the middle, get some rhythm and feel in a good place," he said of his early season form.

The first Test gets under way in Perth on November 21 before a day-night clash in Brisbane, with both wickets expected to be quick and bouncy.

The series then moves to Adelaide, Melbourne and Svdney.
