Srinagar, Nov 15: Nine persons were killed, including a Naib Tehsildar, State Investigating Agency Officer, and a tailor, while 32 others were injured after a high-intensity blast ripped through Nowgam police station



in Srinagar late last night, officials said

An official told news agency-Kashmir News Observer (KNO) that the blast occurred when a stockpile of explosives, confiscated from an alleged doctors' terror module busted by Jammu Kashmir in Haryana's Faridabad last week, accidentally went off inside the police station late last night.

The blast created panic among the local residents with its intensity such that houses as far as 300-500 meters away

- suffered extensive damage.

Addressing a press conference in Srinagar, Director General of Jammu and Kashmir Police Nalin Prabhat said that during investigation of a case, a huge cache of explosives, chemicals and reagents were recovered from Faridabad on November 9 and 10.

He said that the recovery was transported to Kashmir and kept securely in an open area of the Nowgam police station. "As part of the prescribed procedure, samples of the recovery

forensic and chemical examination. On account of the voluminous nature of the recovery, this procedure was going on since yesterday," he said.

He further said that due to the unstable and sensitive nature of the recovery, it was being handled with utmost caution. "However, unfortunately at 11:20 pm accidental explosion took place,"

The DGP also ruled out any terror angle into the incident, stating that any other speculation into the cause of this incident is unnecessary. "In the incident 9 people were killed, including a State Investigating Agency officer, 3 FSL members, 2 photographers, 2 revenue officials and a tailor. In addition, 27 cops, 2 revenue officials and 3 civilians were injured. The injured were immediately evacuated to the hospital," he added.

Instead, he was inside Nowgam Police Station, not as an accused or an officer, but as a tailor called in for a brief stitching job.

Shafi, a resident of the adjoining locality, was known across Nowgam for his modest tailoring shop along the

Wanabal–Nowgam road, small space where school students and shopkeepers often stopped to get their uniforms or trousers altered.

"He was honest and humble. Always busy, always smiling," said a neighbour, standing outside his shuttered shop on Saturday morning, while speaking to the news agency-Kashmir News Observer (KNO).

Kangan youth among dead in Red Fort blast

Worked as cart-puller; family member to travel Delhi for DNA test

Ganderbal, Nov 15: A youth from Babanagri Wangath, Kangan, is among the victims killed in the car explosion near Delhi's Red Fort on November 10 evening, which left more than 10 people dead and over 20 injured.

The 32-year Bilal Ahmad Sangoo son of Ghulam Hassan Sangoo had been working as cart-puller in Delhi for the past six years.

Elder brother of the deceased Farooq Ahmad while talking to the news agency-Kashmir News Observer (KNO) over phone said, "Police have told us that verification is on. His picture is circulating on the social media and we have recognized him. He is my brother."

Farooq said that they lost contact with him soon after the explosion. "His phone has remained switched off since."



SSP Ganderbal Khalil Ahmad Poswal told KNO that police received a report from the family that Bilal was indeed working in Delhi at the time of the blast. "A family member will have to travel to Delhi for a DNA test, and the body will be handed over only after a positive DNA match," the SSP added.

According to the reports, Bilal's cart was destroyed in the Red Fort blast.

'If goodness had a face, it was his': Senior cop's death leaves Kupwara village numb with grief Family shattered as Asrar leaves behind wife, three children, ageing parents

Kupwara, Nov 15: Grief spread through this small Kupwara village on Saturday as residents gathered outside their homes and along the narrow lanes to mourn State Investigation Agency (SIA) Inspector of J&K Police, Asrar Ahmad, who was among nine people killed in the accidental blast at Nowgam Police Station on Friday night.

Muqam-e-Shahwali, a vil-lage in Kupwara located about 82 km from Srinagar and 7 km from the district headquarters, came to a standstill on Saturday

as hundreds assembled for Inspector Asrar Ahmad's last

Many struggled to absorb the sudden loss of a man widely regarded as one of the most respected figures in the area.

People moved in groups, speaking in hushed voices, stopping occasionally to wipe their eyes. "There is a strange stillness here," said Shabir Ahmad, a resident, while speaking to the news agency—Kashmir News Observer (KNO).

"It feels as if the breath of this whole village has been taken away with Asrar Sahab," Ahmad



said, trying to steady his voice. For many in this close-knit settlement, Inspector Asrar was not just a government officer;



he was a son of the soil, someone who carried the warmth of the village into his uniform. "He

Pulwama, Nov 15: In a tragic incident that has plunged an entire Pulwama village into mourning, Javaid Ahmad Rather, popularly known as Mubashir, a photographer with the Jammu & Kashmir Crime Branch, lost his life in the Nowgam Police Station blast last night. Javaid, son of Mansoor Ahmad

Rather and a resident of Hari Parigam in Tral, was among the officials present at the police station when the explosion occurred. The sudden loss of the 32-year-old has left his family and community shattered.

Married just a few years ago, Javaid leaves behind his wife, his elderly parents, and a three-year-old daughter, who, villagers say, was the centre of

Locals remembered Javaid as "a soft-spoken, honest, and hardworking man who carried out his duties with dedication".

"He was extremely sober and hum-ble. Everyone here respected him for his nature and sincerity," said a neighbour in Hari Parigam, struggling to hold back tears. The news of his death sent a wave of grief across the area, with people from neighbouring villages gathering to express solidarity with the bereaved

Senior officials, including the Deputy Commissioner (DC) Pulwama, SSP Awantipora, and several other officers, visited the village and attended the funeral.

Javaid was laid to rest amid heart-rending scenes, with emotional relatives and villagers participating in the last rites.

The air echoed with sobs as his coffin was lowered into the grave, marking a painful farewell to a young man whose life was cut cruelly short.

Elderly locals said that they have been witnessing killings and other things for the last 40 years and now want to see "full-time peace" without killings before their death—(KNO)

Incident site becomes 'media epicenter'

Srinagar, Nov 15: The morning after the deadly explosion inside Nowgam Police Station turned the usually quiet Wanbal stretch into a makeshift newsroom, a blur of cameras, tripods and satellite vans lined bumper to bumper as journalists waited through the cold morning for official word and a glimpse of inside from behind sealed cordons.

The blast site remained completely out of bounds, fortified

by multiple layers of police barricades. All lanes leading toward the Nowgam Police Station stayed shut through the day, forcing reporters and photojournalists to set up camp hundreds of meters away, near the main Wanbal junction. By noon, the scene, resembled a full-fledged outdoor newsroom: reporters live-streaming from roadside spots, photographers climbing embankments for distant visuals and stringers pacing between parked OB vans, chasing every the continuation of a sleepless assignment that had begun the



previous night. Several media teams had been on the ground from Friday midnight, when the powerful blast ripped through the Nowgam Police Station, working through the freezing night, filing updates and visuals until 3 AM, before returning early in the morning to resume coverage.

camera against a tripod near the

barricade. "The lanes are sealed; we can only report from this stretch. Still, we can't leave, every small movement matters.'

Another senior journalist said he had been working on the Nowgam story till late night and sent his copy to the office around 1:30 1:30 in the night and early in had tored everyone in entire Nowthe morning I had to file another

story. My head was literally spinning, I had to take a 'paracetamol' before I could return to the site again," he told KNO with a smile while his eyes were full of sleep.

Officials present at Nowgam, said the access to the Nowgam Police Station remained restricted as police, CRPF and forensic teams continued examination and collection of evidence throughout the day.

As evening fell, the glow of camera lights and OB van flood-lamps still lit up the Wanbal road, reflecting the fatigue and persistence of field journalists.

The area turned chaotic again when the lifeless body of deceased tailor Mohammad Shafi Parry reached Nowgam, drawing hundreds of locals, mourners and reporters rushing to capture the emotional scenes.

When the body entered Wanbal lane, it was met with cries, grief and a surge of cameras. Locals, relatives and journalists surrounded the coffin, some climbing walls and rooftops to cover the gam locality–(KNO)

Academic session 2024-25 short by **over 30%**

Srinagar, Nov 15: In the recently concluded academic session, Jammu and Kashmir has recorded deficit academic days by more than 30 percent. An official informed

that in the academic year 2024-25, Jammu and Kashmir has recorded below 150 working academic days against the mandated 220 days.

It also said that there shall be a minimum of at least 180 academic days in a year. "In one academic year, at least 180 working academic days are considered fairly good but unfortunately, there were less than 150 academic days due to the inclement weather, flood like situation and extended summer vacations.

"Although, almost all the government schools complete their syllabi but there were time constraints that burdened the kids," the official said.

In September, Education Minister Sakina Itoo had said that 'students studies got badly affected, initially due to a war-like situation, heatwave and then a flood-like situation in Jammu and Kashmir.'

In view of the situation. the Jammu and Kashmir Board of School Education (BOSE) had announced syllabus relaxation of 15 percent for 10th, 11th and 12th standard examination.

BOSE in a notification had said that the decision was taken upon the recommendations received from the DSEK and DSEJ and pleas received from other stakeholders regarding reduction in syllabus due to delayed commencement of academic session this year coupled with disruptions in academic calendar due to heat wave, torrential rains, cloudbursts and floods-(KNO)

Ruhullah MP because of NC: Dr Farooq

Budgam for the first time. defeating the National Conference candidate by a margin of 4,478 votes. The Budgam seat, long considered a stronghold of NC, slipped from the party's grip in the by-election held after Chief Minister Omar Abdullah vacated the constituency to retain Ganderbal.

Meanwhile, speaking about the massive blast in Nowgam Police Station, Abdullah said: "This is our mistake; those who understand this explosive better should have been consulted first about how to deal with it instead of trying to handle it ourselves. It has resulted in the loss of 9 lives, besides causing extensive damage to the houses nearby," he

He added that such a situation is being witnessed at a time when the people have not come out of the crisis in Delhi where fingers are being pointed at every Kashmiri. "When will that day come when they will accept that we are Indians and we are not responsible for this? Ask those who are responsible why these doctors had to take this path? What was the reason? There is a need for a thorough study and investigation," he added-(KNO)

See Budgam by-poll result in wider context: Speaker Rather

Srinagar, Nov 15: Jammu & Kashmir Legislative Assembly Speaker and senior National Conference (NC) leader Abdul Rahim Rather on Saturday said the party's defeat in the Budgam by-election should not be viewed in isolation, but in a broader political context. Mamdani's Big Bet

The United States is transforming from a two-party political system into one comprising establishment Republicans, establishment Democrats, alt-right populists, and democratic socialists. In confronting all those who will try to derail him, New York's mayor-elect will need to keep this big picture in mind.

Emancipatory movements around the world rightly rejoiced at Zohran Mamdani's victory in the New York City mayoral race. Clearly, today's populist right has no monopoly on the ability to mobilize crowds and attract new or disillusioned voters. Democratic socialists can do it, too.

But as Mamdani well knows, his victory will be met by attempts at economic and financial sabotage. The US political establishment – both the Republican and Democratic "deep state" - has a fundamental interest in seeing his mayoralty become a fiasco. US President Donald Trump himself appealed to New Yorkers to vote for Mamdani's leading challenger, the former Democratic governor of New York, Andrew Cuomo. With Mamdani in power, Trumpian populists and mainstream Democrats will suddenly be speaking the same language. They will do everything they can to make Mamdani appear a failure. In Trump's case, that may even involve another "emergency" declaration to justify sending in the National Guard.

For the left, then, this is not only a moment to act, but also a time to think about the bigger picture. The United States is transforming from a two-party political system into one comprising establishment Republicans, establishment Democrats, altright populists, and democratic socialists. One can already see the makings of new coalitions stretching across the old party lines. Back in 2020, Joe Biden hinted that he might nominate a moderate Republican as vice president, while Steve Bannon, Trump's former chief strategist, urged supporters of Bernie Sanders, the independent democratic socialist US senator from Vermont, to vote for Trump after the Democratic Party nominated Biden.

The big difference is that while Trump's brand of populism easily achieved hegemony over the Republican establishment (clear proof, if any were needed, that his



concern for ordinary workers was a sham), the split within the Democratic party is getting stronger and stronger. Indeed, the struggle between the Democratic establishment and the Sanders wing is the only true political battle in the United States today. As The Guardian's Emma Brockes put it: "Mamdani's biggest threat is not Donald Trump, it's the Democratic old guard."

We are dealing with two antagonisms ("contradictions"): one between Trump and the liberal establishment, and the other between the Sanders wing of the Democratic Party and all other political forces. The impeachment proceedings against Trump during his first term were desperate attempts by the establishment to reclaim moral leadership and credibility; but it all amounted to a comic exercise in hypocrisy, since the establishment's own deficiencies have also been laid bare. Trump's open obscenity

simply brought out what was already there. The Sanders camp sees this clearly. It knows there is no way back, that American political life must be radically reinvented. Mamdani won because he did for the left what Trump did for the right. He clearly articulated his radical position without worrying about losing the center.

But the four forces that now exist within US politics are not at the same level. The two dying parties (the old mainstream Republicans and the Democrats) are trapped by inertia, lacking any serious vision for the country, while the Trumpian populists and the democratic socialists represent actual political movements. In this context, the only truly meaningful election would be one between Trump and a democratic socialist.

So, should democratic socialists officially split from the Democratic Party? I

would advise a principled pragmatism: focus on the central goals that concern your survival, and then permit everything that shows promise in advancing those goals. That means embracing electoral democracy when electoral democracy works, but also popular mobilization or even more radical methods when circumstances demand.

To see what I mean, consider a recent example. In July, after dramatically falling out with Trump, Elon Musk announced that he would be launching the "America Party." Musk, who was not born in the US and thus cannot run for president, tried to outperform Trump, prioritizing techno-feudalism over populism. Ultimately, the project never got off the ground.

By contrast, Zarah Sultana and Jeremy Corbyn's new leftist party in the United Kingdom does show promise, with some polls showing that around one-third of

young people and Labour voters are ready to transfer their allegiance to it. Uncertainty remains, though, and as befits a leftist party, the two leaders immediately ended up in a public feud.

A truly meaningful election in the UK, then, would be between Nigel Farage's farright Reform UK and the new left, with an inert Labour Party joining the eccentrically moribund Conservatives on the margins. True, one could safely predict that in such a direct confrontation, Farage would win, just as Boris Johnson prevailed over Corbyn in 2019. Nonetheless, Corbyn did succeed in taking control of Labour for a time, making the entire establishment tremble.

Ultimately, there is no principled answer when it comes to deciding on the best strategy. Sometimes, one should try to take over a big leading party; sometimes, a split is necessary. I think Mamdani was right to remain within the Democratic Party for the time being, since that allowed him to mobilize its popular base against the establishment. Had he tried taking on the three other political forces alone, he would have lost.

Now that he has won, Mamdani should move firmly and deliberately to take over the New York State Democratic Party, while also establishing a network of links with democratic socialists around the US and following Sanders's advice – subtly appealing to disappointed lower-income workers and farmers who voted for Trump. The future of the project Mamdani embodies lies in peeling away disappointed Trump voters, not winning the inert center. Only a radical leftist can win over working-class Trumpians – a constituency whose distrust of the establishment remains entirely justified.

Why Emerging Economies Are Embracing AI

Emerging-economy populations are more optimistic about the technology than their developed-economy counterparts. All can support and accelerate the acquisition of knowledge and skills, such as through digital learning assistants

uring a recent trip to Kazakhstan, I was struck by people's enthusiasm for artificial intelligence. Virtually everyone I encountered — including academics, policymakers and entrepreneurs — seemed convinced that the technology will help solve thorny challenges, from diversifying the economy away from dependence on natural resources to expanding access to critical services, particularly for remote populations. I had expected the diffusion of knowledge about AI to be slower, but perhaps their positivity should not have surprised me. After all, the rapid development of AI implies important opportunities for emerging economies.

As the latest UN Human Development Report showed, emerging-economy populations are not only well aware of these opportunities but are also more optimistic about the technology than their developed-economy counterparts. In advanced economies, conversations about AI tend to turn immediately to fears of excessive automation, job losses and labor market disruption. Emerging-economy populations also worry that AI will bring a wave of automation, but they anticipate even more augmentation and human-machine collaboration.

One might be tempted to highlight the risk of an "AI digital divide," with high-income countries benefiting disproportionately from the technology and low- and middle-income countries falling further behind. But such concerns focus on one dimension of the AI revolution: the development of an expanding set of powerful tools to be deployed, say, to advance scientific discovery, increase productivity, generate new products and services or automate (via agents) complex tasks that



involve planning, sequencing and integration of steps. Since few countries can fulfill the associated requirements regarding scale, investment and infrastructure, such activities are currently taking place largely in the US and China.

But model-building is not the only game in town. The AI revolution also entails the querying, adaptation, fine-tuning and deployment of existing tools to solve context-specific problems and accelerate learning. The costs of these activities are much lower and, with

the expansion of open-source models — many developed in China — they will continue to decline. As a result, the field is wide open for innovation across a broad range of countries. While this dimension of the AI revolution

is far more accessible, it does require some basic infrastructure, especially a reliable electricity supply and mobile internet connectivity. Accessibility is key: you need fast internet and affordable data plans, not least to ensure that you are generating the data that fuels many of the most significant AI applications and use cases. To make a difference, this data must be mobile and shared, so well-designed regulatory structures, which allow for secure data mobility (subject to individual permission or control), are also essential. India's Unified Payments Interface, which facilitates secure payments and financial data exchanges, offers a useful model.

Once these conditions are in place — and, in many emerging economies, they already are — the possibilities for implementing digital and Al-powered solutions are virtually endless. Such solutions include, for starters, financial services for previously underserved people and businesses.

For people with limited assets, virtually no

For people with limited assets, virtually no accessible financial or commercial track record and, in some cases, limited documentation, accessing financing through traditional channels is prohibitively expensive or simply impossible. But digital tools now offer affordable means to close these information gaps. As the cash economy gives way to digital payment systems and households and small businesses acquire bank accounts and wallets, the accumulation of data, if well-managed, will solve the anonymity problem.

Al-driven credit assessment can then underpin sustainable, scalable and profitable versions of microcredit, enabling businesses to grow and hire more people. Meanwhile, e-commerce platforms give small businesses access to a larger and, with the help of Al, more addressable market, thereby supporting yet more growth, dynamism and, potentially, innovation.

Such opportunities are not limited to finance and commerce. In healthcare and education, digital applications, many powered by AI, are used to expand access to services, particularly for those who do not live in or near high-density service areas.

Al can also support and accelerate the acquisition of knowledge and skills — the basis of human capital — such as through digital learning assistants. Sustained improvement in human capital is a key ingredient in all successful development stories. Not everyone can access a classroom or tutor but, with the right infrastructure, anyone can talk to a generative AI model that has read and, on some level, understood the vast digital literature that exists in every field and language. This would have direct effects on productivity, growth and development.

Moreover, in certain workplaces, Al can cut down on training time and increase worker productivity. Consider customer service: Al assistants can deliver curated guidance, based on accumulated experience, to inexperienced human agents, thereby accelerating the learning process and enabling agents to deliver better support earlier. This effect can be achieved in a wide range of jobs and sectors, from nursing to software development.

Emerging economies might not lead the way in building AI models but they can use the technology to advance their economic and social development goals. Fortunately, this is not lost on them. It is exactly what they intend to do

Narco smuggler's property demolished

UDHAMPUR, NOVEMBER 15: In a major crackdown on narco-criminals, the District Administration Udhampur, in close coordination with District Police Saturday demolished illegally raised properties worth crores belonging to notorious drug peddler Makhan Din, son of Hakim Din, resident of Narsoo, Tehsil Chenani.

A joint team of the Revenue Department and Police carried out the demolition drive, targeting structures allegedly constructed on government land. The action comes as part of the district's intensified efforts to curb drug trafficking and dismantle the financial networks of habitual offenders.

Makhan Din, a habitual offender, has been found involved in FIR No. 188/2024 registered at Police Station Rehambal. Owing to his persistent involvement in drug trafficking, he was also detained under the PIT NDPS Act and is currently lodged at Central Jail Kot Bhalwal, Jammu.

During the investigation, the Investigating Officer established that the accused had illegally encroached upon state land and constructed five commercial properties and one residential property worth crores along NH-44 at Narsoo, Chenani. These structures, raised through proceeds of the narco trade, were demolished as part of the ongoing district-wide campaign against drug peddlers.



PM hails tribal community's contribution to freedom struggle; accuses Congress of neglecting them

Dediapada (Gujarat), Nov 15: Prime Minister Narendra Modi on Saturday said the tribal community's contribution to the country's freedom struggle was significant, but the Congress did not acknowledge the same and neglected the community during its 60-year rule.

The contribution of tribal freedom fighters was ignored so that the credit could be given to a "few families", he said, speaking at a large gathering at Dediapada town in Gujarat's Narmada district to mark the birth anniversary of tribal icon Bhagwan Birsa Munda on Janjatiya Gaurav Divas.

Before his speech, the prime minister inaugurated or laid the foundation stone of infrastructure and development projects costing more than Rs 9,700 crore.

"Whenever the nation's honor, self-respect and freedom were concerned, our tribal community stood at the forefront. Our freedom struggle is the greatest example of this. Numerous freedom fighters emerged from the tribal community and they carried forward the torch of freedom," Modi said.

Citing the tribal freedom fighters such as Govind Guru,

Rupsingh Nayak and Motilal Tejawat from Gujarat, the PM said countless chapters of the freedom struggle are filled with examples of manifestation of tribal pride and bravery.

The tribal community shed its blood for freedom, but its contribution was "ignored" so that the credit could be given to a "few families", Modi claimed.

"We cannot forget the contribution of tribal communities in the freedom movement, and this work (of recognising the same) should have been done after Independence. But in the pursuit of giving credit for independence to a few families, the sacrifices and dedication of my tribal brothers and sisters were ignored," he said.

Due to this attitude, no one remembered Bhagwan Birsa Munda before 2014, Modi added. Family members of Birsa Munda were with him on stage, and he was the first prime minister to visit Munda's house, he

informed.

The celebration of Janjatiya Gaurav Divas provides an opportunity to remember the "injustice done to tribal brothers and sisters", Modi further said.

"The Congress party, which ruled the country for six decades, left the tribals to their fate. Though the tribals were



facing several issues such as malnutrition and lack of healthcare, education and connectivity, the Congress governments remained idle," he alleged.

"Tribals are also associated with Lord Ram. They come from that era. But those who ruled for six decades did not realize that something was needed to be done for the development of such a large tribal community. Tribal welfare has been the BJP's top priority, and we have resolved to end this injustice," the PM added.

It was former prime minister and late BJP stalwart Atal Bihari

Vajpayee who established a separate ministry for the tribal com-

munity at the Centre, Modi said.
"But, when Congress came back to power after Vajpayee, they neglected the tribal community for the next 10 years and completely forgot about it," he

Referring to acclaimed sportspersons like Mary Kom, Dutee Chand and Baichung Bhutia, the PM said tribal youths have made a significant contribution to bringing glory for India on the global stage.

"Similarly, new players from tribal areas are emerging in every major competition. Recently, India's cricket team won the Women's World Cup, and a daughter from our tribal community played a key role in that. Our government is continuously working to discover new talent in tribal areas and encourage them to progress," said the PM.

His government works with the vision of providing equal opportunities to the underprivileged, Modi said, adding that in the last five years, the Union government has spent more than Rs 18,000 crore on building model tribal schools in the country.

"Essential facilities have been provided to the students. As a result, the number of tribal children enrolled in these schools has increased by 60 per cent," he said.

Earlier, the PM inaugurated or laid the foundation stones of multiple development projects aimed at uplifting tribal communities and improving infrastructure in rural and remote areas of the region.

He also witnessed the `Grih Pravesh' ceremony (marking a family taking possession of a new dwelling) for 1,00,000 houses built under the Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM-JANMAN) and Dharti Aaba Janjatiya Gram Utkarsh Abhiyan (DA-JAGUA).

The prime minister also inaugurated 42 Eklavya Model Residential Schools (EMRS) for tribal students, built at a cost of around Rs 1,900 crore; 228 Multi-Purpose Centres to act as hubs for community-led activities; Centre of Competence in Assam Medical College, Dibrugarh, and Tribal Research Institute building in Imphal, Manipur for the preservation of tribal culture and heritage.

In addition, the PM flagged off 250 buses for 14 tribal districts of Gujarat, laid the foundation stone for 748 km of new roads in tribal areas and 14 Tribal Multi-Marketing Centres under DA-JAGUA to serve as community hubs.

He also laid the foundation stone of 50 new Eklavya Model Residential Schools, to be built at a cost of over Rs 2,320 crore.

Earlier in the day, Modi offered prayers to Pandori Mata, a deity of the tribal community, at a temple in Devmogra village of Gujarat's tribal-dominated Narmada district.

The nation stands shoulder to shoulder with them in this difficult hour."

The LG arrived in Srinagar this afternoon from Jammu following the incident that claimed nine lives, including a State Investigation Agency (SIA) officer, a Naib Tehsildar and a civilian tailor, while 31 others were wounded after a stockpile of explosives seized from a terror module in Faridabad went off accidentally inside the police station.

Meanwhile, Divisional Commissioner

Kashmir Anshul Garg and Deputy Commissioner Srinagar Akshay Labroo also visited SMHS Hospital and Ujala Hospital to enquire about the well-being of the injured.

During the visit, the medical officers briefed them about the treatment and recovery progress. The Divisional Commissioner directed hospital administrations to provide quality healthcare, timely medication, and all necessary facilities to the victims. Moreover, both officers interacted with the patients and assured them that the district administration will extend every possible support for their recovery.

It is worth mentioning that officials said the blast occurred while a forensic team was handling a cache of 'ammonium nitrate-based material' seized earlier this month from Faridabad and stored in the Nowgam Police Station yard. Police have stated that the explosion was accidental and took place during the inspection process. (KNO)

Piles of concrete chunks, twisted tin sheets and scattered belongings, including burnt documents and torn shoes, lay strewn around the compound as shown in videos accessed by

Locals said the force of the explosion was so intense that it sent debris flying several hundred meters away from the police station. Eyewitnesses from nearby localities said fragments of the blast reached areas close to the main Nowgam bridge, nearly 500–600 meters from the police station.

"We saw blood marks and debris even near the bridge walls," said a resident, pointing to stains that locals believe were from those caught in the blast's impact radius.

Throughout Saturday, all approach lanes and inner bylanes leading to the Nowgam Police Station remained sealed. Police and security forces erected multiple barricades, with media personnel and civilians stopped at a considerable distance.

Only forensic experts and senior officers were allowed inside the restricted zone, as the search for evidence and possible traces of explosives continued.

"The whole area is under technical examination. Entry has been prohibited for safety reasons," an officer monitoring the entry told KNO. The footage and spot visuals show that several vehicles, including motorbikes and cars parked in and around the police station, were completely gutted.

A water storage tank within the premises was ripped open, while parts of the boundary wall were blown off, exposing the inner compound. The windows and glasses of the nearby houses also got broken with the impact of the explosion.

A resident living across the road described the terrifying moments of the blast: "We thought it was an earthquake. Our walls shook violently and windows rattled. The sound was deafening as it felt like the ground was lifted for a moment," he said.

The explosion, which occurred around 11:20 pm on Friday, was heard several kilometres away, jolting residents awake across Nowgam, Natipora, Lal Chowk, Barzullla and adjacent localities.

By morning, top officials, including DGP J&K Nalin Prabhat, IGP Kashmir VK Birdi, and IG CRPF Pawan Kumar and other senior officials visited the spot to take stock of the situation firsthand and oversee the ongoing investigation.

The officials have launched a detailed probe into the cause of the detonation and handling of the recovered material. The area will remain sealed until forensic and technical teams complete their examination. (KNO)

Govt announces

Rs 1 lakh to every injured individual. Speaking to reporters after visiting the injured at Ujala Hospital, she said the tragic incident claimed nine lives last night, while around 30 others sustained injuries.

"Some injured were admitted at SMHS and have been discharged, while around 20 are still under treatment at Ujala Hospital. Thank God their condition is improving. One or two remain in the ICU, but all are stable," she said.

Itoo praised the medical teams for their swift response. "The Ujala Hospital team has done a tremendous job. All doctors, including those from CMO and SMHS, reached immediately and worked throughout the night. Their timely efforts ensured proper treatment for all injured."

She added that she also visited the homes of several deceased victims. "On the instructions of the Chief Minister, Rs 10 lakh ex-gratia will be given to the families of the deceased and Rs 1 lakh to each injured person," she said. (KNO)

Peoples Democratic Party (PDP) Chief, Mehbooba Mufti wrote, "Deeply anguished by the tragic accidental blast at Nowgam Police Station that claimed 9 precious lives and left many injured. The blast, which killed nine people including police officials, forensic experts and revenue officers, was described by police as "accidental."

Officials said it occurred during the inspection of a cache of seized explosives, suspected to be 'ammonium nitrate' brought from Faridabad, Haryana earlier this month.

"The explosion happened during sampling of the seized material," said DGP Nalin Prabhat, confirming the blast was accidental.

The explosion's intensity shattered windows across Nowgam and sent debris flying hundreds of meters. Locals described scenes of panic and disbelief. "We saw smoke rising from the police station and heard cries for help. The sound was louder than anything we have ever heard," said one resident who rushed to the spot minutes after the blast.

At Shafi's home, grief hung heavy. His two sons and daughter sat quietly beside their mother as relatives and neighbours offered condolences. The verandah of their modest home had turned into a mourning space.

"He was a simple man earning a simple living," said one of his relatives. "He had nothing to do with explosives or police work. He was just doing his job."

As investigations continue into how a routine forensic process turned deadly, Shafi's unfinished stitching job remains folded on his wooden table at "Parray Tailors" a silent reminder of a man who went to mend fabric and instead, lost his life to a blast that tore through the city's calm. (KNO)

Locals described him as someone who was always the first to stand with the needy. Bihar polls: All 25 ministers in fray won except one

Patna, Nov 15: As the ruling NDA decimated the Mahagathbandhan in Bihar to retain power, all but one of the 25 state ministers in the fray won their respective seats. Deputy Chief Ministers Samrat Choudhary and Vijay Kumar Sinha, both from the BJP, won Tarapur and Lakhisarai assembly seats.

Thunder

Chief Minister Nitish Kumar, who has been a member of the legislative council (MLC), did not contest the assembly elections.

Altogether 15 ministers from the BJP had contested the polls and emerged victorious.

Agriculture minister Prem Kumar, a BJP veteran, retained Gaya Town for an eighth consecutive term, a record equalled by his ID(U) cabinet colleague Bijendra Yadav (Supaul).

Another minister Raju Kumar Singh, who had been elected from Sahebganj in 2020 on a ticket of Vikassheel Insan Party and



later defected to the BJP, retained the seat.

He contested the assembly segment this time on a saffron party's ticket.

Sanjay Saraogi (Darbhanga) and Nitin Nabin (Bankipur) retained their seats for a fifth consecutive term. Other BIP ministers, who emerged victorious, were Renu Devi (Bettiah), Nitish Mishra (Jhanjharpur), Neer-aj Kumar Singh 'Bablu' (Chhatapur), Kedar Prasad Gupta (Kurhani), Jibesh Kumar (Jale), Krishnanandan Paswan (Harsidhi), Vijay Kumar Mandal and Krishna Kumar Mantoo (Amnour) and Sunil Kumar (Bihar Sharif).

However, Sumit Kumar Singh, who had been elected in 2020 as an independent candidate and inducted into the state cabinet, failed to retain the Chakai assembly seat when he sought reelection on a JD(U) ticket. Singh lost by a margin of nearly 13,000 votes to RJD candidate Savitri Devi, whom he had defeated five years ago from Chakai in Jamui district. Son of late Narendra Singh, a former state minister and a close aide of Chief Minister Nitish Kumar, Sumit had held the science, technology and technical education

The massive scale of the victory of the National Democratic Alliance (NDA) can be gauged from the fact that its two main constituents--BJP and JD(U) -- clocked a nearly 85 per cent strike rate in 101 seats each they had contested.

The alliance secured a "200 paar" win for a threefourths majority in the 243-member Bihar assembly with the BJP emerging as the single largest party.

Instructions on using Aadhaar as proof of identity, not citizenship, already issued: EC to SC

New Delhi, Nov 15: The Commission of India has told the Supreme Court that it had already issued instructions for using the Aadhaar card as proof of identity and not of citizenship, for inclusion or exclusion in the revised voter list of Bihar.

In a reply filed in the top court, the poll panel said that the court on September 8 had already clarified the usage of Aadhaar for updating the voter list.

It said the court had stated that the Aadhaar card was to be used for the purpose of establishing identity in view of Section 23(4) of the Representation of the People Act (RPA), 1950.

Section 23 of the RPA deals with the inclusion of names in electoral rolls.

The poll panel said the Unique Identification Authority of India (UIDAI), in an office memorandum (OM) in August 2023, had clarified that Aadhaar was not proof of citizenship, res-

SC to hear plea for mechanism to ensure no PG medical seats remain vacant

New Delhi, Nov 15: The Supreme Court is scheduled to hear on Monday a plea seeking direction to the National Medical Commission to devise a mechanism so that no postgraduate seats go vacant in pre-clinical and para-clinical branches across medical colleges in India. The petition has also sought a direction to the commission to produce data of how many seats have remained vacant in the last five years in the postgraduate pre-clinical and para-clinical branches.

The plea would be heard by a bench comprising Chief Justice B R Gavai and Justices K Vinod Chandran and N V Anjaria.

While hearing a separate plea in January this year, the apex court had observed that seats in medical courses cannot remain vacant. It had asked the Centre to hold a meeting with relevant stakeholders, including the states, to address the issue.

In April 2023, the top court flagged the issue of super-speciality seats in medical courses remaining unfilled. The Centre had then proposed to appoint a committee, consisting of all the stakeholders including representatives of states and private medical colleges, under the chairmanship of the director general of health services to resolve

India says 'all possibilities on table' as Canada FTA talks wait for reset

New Delhi, Nov 15: Commerce and Industry Minister Piyush Goyal has said all possibilities are on the table regarding the resumption of free trade agreement (FTA) negotiations with Canada.

Goval said he has held two rounds of discussions with Canada's Minister of Export Promotion, International Trade and Economic Development Maninder Sidhu and both are exploring ways to strengthen bilateral cooperation and the strategic

partnership. "All possibilities are on the table. We have had two rounds of discussions now - we met in Delhi for a high-level ministerial meeting. We met (here) briefly to discuss the way forward to strengthen bilateral cooperation and strategic partnership," Goyal said here.

He was replying to a question whether there are any expectations of resumption of FTA talks between the two countries in the coming days in the wake of increasing engagements. Sidhu was here



to participate in the CII Partnership Summit 2025.

Both the ministers co-chaired the India-Canada Ministerial Dialogue on Trade and Investment (MDTI) meeting in New Delhi this week.

In that meeting, both held discussions on ways to promote bilateral trade and investments besides advancing collaborations in areas, including supply chain resilience, and health sectors.

These deliberations are important as in 2023, Canada had paused negotiations for a free trade agreement with

The India-Canada relations hit rock bottom following then Prime Minister Justin Trudeau's allegations in 2023 of a potential Indian link to the killing of Hardeep Singh Nijjar. India had dismissed Trudeau's accusation as "absurd".

In March 2022, the two countries had re-launched negotiations for an interim agreement, officially dubbed as Early Progress Trade Agreement (EPTA). Over half a dozen rounds of talks have been held on the trade pact so far.

Normally in a trade

agreement, two countries significantly reduce or eliminate mum number of goods traded between them. They also liberalise norms for promoting trade in services and attract investments.

India's exports to Canada rose 9.8 per cent to USD 4.22 billion in 2024-25 from USD 3.84 billion in 2023-24. Imports, however, dipped 2.33 per cent to USD 4.44 billion in the last fiscal year from USD 4.55 billion in 2023-24.

The renewed vibrancy in ties between the two countries followed Prime Minister Narendra Modi's talks with his Canadian counterpart Mark Carney on the margins of the G7 summit at Canada's Kananaskis in June.

Bilateral trade in goods and services between India and Canada stood at USD 18.38 billion in 2023.

There are about 2.9 million Indian diaspora and over 427,000 Indian students in Canada.

The two ministers also held talks in October this year.

Adopt AI, or get replaced by it: Nara Lokesh highlights Andhra Pradesh's AI upcoming framework

Visakhapatnam, Nov 15: Nara Lokesh, Minister for Human Resources Development; IT Electronics and Communication, Andhra Pradesh, has asserted that people must either embrace AI or risk being replaced by it. He made this remark during the session titled "AI and the Future of Jobs: Turning Disruption into Opportunity" at the 30th Partnership Summit being held in Visakhapatnam.

The Andhra Pradesh Minister emphasised that on the employment front, the need of the hour is to reskill, redefine and reimagine.

He mentioned that the state government is in the process of releasing a framework in which conversational AI is used to assess skill levels of the workforce,



across all levels, from carpenters to highskilled AI engineers for the purpose of enhancing skills.

The Minister also urged that creativity should not be outsourced to AI.

Debjani Ghosh, Distinguished Fellow, NITI Aayog and Chief Architect, NITI Frontier Tech Hub, in a virtual address, replied to the fundamental question of whether AI is going to take away jobs or create it. "Job disruption is only half the story,

and jobs of repetitive nature, and areas like software, data entry are likely to be replaced", she noted. However, a new universe of new jobs will be created, including highly specialised jobs like AI engineers, AI architects, etc.

Work will change, workers will change and the workforce pyramid will change -hyper-specialised jobs are the future with deeply specialised jobs on the frontier, she opined. Presenting a global perspective, Joe Depa, Global Chief Innovation Officer, Ernst & Young, USA said that the world needs India to be successful on the AI front. He said that India, as prospective AI powerhouse is 'ripe', with young workforce, digital infrastructure and AI usage base.

Have seen that last ball at least 1000 times: Harmanpreet on life after World Cup

New Delhi, Nov 15: It's a moment that changed her life and the trajectory of Indian women's cricket for the foreseeable future. Little wonder then that Harmanpreet Kaur has viewed her full-length diving catch of Nadine de Klerk in the World Cup final at least a 1000 times so far.

The catch by the skipper sealed India's 52-run victory over the South African Women's team for a historic first ever World Cup trophy.

"My life has completely changed. I have seen that last ball at least a thousand times, not only me, our team had been waiting for this moment for many years. I feel like watching that moment



again and again," the 36-year-old history-maker said in an exclusive interview during her visit to the PTI headquarters here. "I really don't know what I was thinking when I was taking that last catch. It is hard to express in words, it means the world to me because I always dreamt of winning the World Cup, and finally we did that and now it has been two weeks and it is very special feeling and hard to express," she added. Harmanpreet deserved a long break after the World Cup victory, which was a result of years of hard work. However, her off-the-field schedule has been busier than ever and she has not even got the time to go back home since she took that winning catch in the final.

The campaign itself had its fair share of ups and downs and perhaps the biggest challenge was the three consecutive losses that the team endured in the league stage, triggering a social media backlash that bordered on misogyny.

Harmanpreet made light of the offensive online comments, saying the harsh criticism showed that better

was expected from her team.

"We took all the criticism in a positive way. People were criticising us because we could have played well. Fans were expecting a lot from us. We had a meeting... our head coach (Amol Muzumdar) talked to us... he said, 'we are better than this'," she recollected.

'If people were trolling us, it was because we were not playing cricket at the level we could, we could do better than this....We had another meeting after reaching Mumbai that now we only have one way that is to win all the matches.

"It was not to prove the critics wrong but we were also feeling that we were not playing our best cricket, and our best was yet to come," she

Left alliance accuses Yunus of driving Bangladesh towards crisis

Dhaka, Nov 15: As political conflict continues to mount in Bangladesh, the Democratic Left Alliance (LDA) accused the interim government's Chief Advisor Muhammad Yunus of pushing the nation towards a longterm crisis in an attempt to appease the Bangladesh Nationalist Party (BNP), radical Islamist party Jamaat-e-Islami and National Citizen Party (NCP), local media reported.

The remarks came after Yunus, in a recent address to the nation, announced that national elections and a referendum would be held simultaneously in the first half of February 2026. In a statement, the LDA-an alliance of six leftist parties -alleged that Yunus' announcement regarding the implementation order of the July Charter, the referendum, and the Constitution Reform Council was "one-sided and unconstitutional".

"There is no provision in the constitution for issuing such an order [July charter order] or holding a referendum. The president can only issue ordinances," Bangladesh's leading newspaper, The Daily Star quoted the LDA as saying. The alliance said Yunus' speech also failed to mention the parties' notes of dissent and argued that his claim of consensus among all political parties on 30 out of 48 proposals related to the constitution during dialogues



with the consensus commission was inaccurate.

"There are no more than 11 proposals on which all political parties have reached consensus. If consensus among BNP, Jamaat, and NCP is considered as consensus of all, then the entire series of meetings of the consensus commission becomes questionable," the LDA stated.

According to the statement, such an order issued in the name of the country's President falls outside the mandate and authority of an interim government. Meanwhile, Jatiya Samajtantrik Dal (JSD) President ASM Abdur Rab warned that any fresh political crisis over the implementation of the July charter could plunge Bangladesh into disaster. "At this critical juncture for the nation, political divisions, antagonism, and rivalries must be avoided. For the sake of national security and stability, a balance of constitutional political, and social safeguards must be established through dialogue and understanding," the JSD leader stated.

UN reacts after heavy rains flood displaced families in Gaza

New York, Nov 15: Humanitarians are working to provide shelter support and have deployed rapid response teams after heavy rains flooded thousands of dis-placed families in Gaza, said the UN Office for the Coordination of Humanitarian Affairs (OCHA).

The rains had a harsh impact on people across the Gaza Strip, with damage to personal belongings and thousands of displaced families left fully exposed to the harsh weather, increasing health and protection concerns, especially for older people, those with disabilities and other vulnerable groups, said OCHA.

Partners reported that proper flood prevention requires equipment that is not available in Gaza, including tools to drain water away from tents and to clear solid waste and rubble. Millions of urgently needed shelter items remain stuck in Jordan, Egypt and Israel, awaiting approvals to enter Gaza, the office said.

OCHA said that since the October 10 ceasefire, the Israeli authorities have rejected 23 requests from nine partners to bring into Gaza nearly 4,000



pallets of critical supplies, including tents, sealing and framing kits, bedding, kitchen sets and blankets, Xinhua news agency reported.

Shelter partners said that the main barrier remains restrictive registration rules for non-governmental organizations. In all but two of the 23 rejections, the reason given was that the submitting organizations were not authorized to deliver humanitarian aid into Gaza.

OCHA said that about 1,000 tents were distributed to families in Deir al-Balah and Khan Younis on Thursday. Between Sunday and Wednesday, partners provided about 7,000 blankets to more than 1,800 households, some 15,000 tarpaulins to more than 3,700 households, and winter clothing to more than 500 households. "The dire living conditions

are also increasing people's exposure to explosive ordnance, with children among those most at risk," the humanitarian office said.

"Some people have been injured while collecting firewood; others are having to pitch tents near areas suspected of containing unexploded remnants simply because they have no safer options," it said.

Trump's support for H-1B reignites debate over skilled-worker visas



Washington, Nov 15: Days after US President Donald Trump defended the H-1B visa programme, leading Republican and conservative leaders have opposed it, calling for its scrapping. However, leading researchers and lawyers argue that the crackdown would only hurt the US economy and its interests.

On Friday, Republican Congresswoman Marjorie Taylor Greene posted on X, reiterating her plans to introduce a bill to "ban H1B visas in all sectors" except the medical profession.

"Ending H1B visas will also help the housing market. Ending H1B visas mean more jobs available for Americans and more homes available for Americans...When Americans have good paying jobs they will be able to buy homes as long as they don't have to compete with legally imported labor on visas and rich powerful asset management companies," she added. In a video post on Thursday, Greene announced her bill proposals, allowing only 10,000 visas annually, down from the

current 85,000 cap.
She asserted that even the carve-out could be phased out over the next decade. Her bill would also take away from the citizenship path, forcing visa holders to return home.

"These visas were intended to fill a speciality occupational need at a given time. People should not be allowed to come and live here forever. We thank them for their expertise, but we also wish them well so they may return to their own country," she said in the video.

Another Republican House member, Andy Ogles, also posted on X on Friday, "No more it done." The developments come days after US President

Donald Trump defended the programme, saying it's needed to import talent.

In an interview with Fox News' Laura Ingraham on Tuesday, Trump was asked if his administration planned to deprioritise H-1B visas. He replied, "You do have to bring in talent."

When Ingraham countered, "we have plenty of talent," Trump responded, "No you

"You don't have certain talents....And people have to learn, you can't take people off an unemployment line and say, I'm going to put you into a factory. We're going to make missiles,' he added.

Laura Ingraham, posted on X on Friday, responding to a CNN debate over the issue.

ICC launches eight-team Women's **Emerging Nations Trophy**



Dubai, Nov 15: Following the resounding success of the Women's World Cup in India, the ICC on Saturday launched a new eight-team global tournament to "promote and expand women's cricket around the world".

The inaugural edition, to be held in Bangkok from November 20 till 30, will be called the ICC Women's Emerging Nations Trophy and will be part of a new threetier development pathway designed to offer high-performance exposure to upcoming cricketing nations.

The eight competing teams are: Thailand, the Netherlands, Papua New Guinea, the United Arab Emirates, Scotland, Namibia, Tanzania, and Uganda.

The Women's ODI World Cup, which concluded recently with India lifting its maiden trophy by defeating South African in the final

set a new benchmark in women's cricket with the tournament reaching more than 500 million viewers across the country and a significant growth in viewership across the globe.

"Nearly 300,000 fans attended matches across India and (co-host) Sri Lanka, and the event concluded with India becoming the first Asian team to lift the Women's Cricket World Cup, a watershed moment in the evolution of the sport and the socio-cultural context of gender roles," ICC said in a statement.

"Building on the extraordinary impetus provided by the marquee event, the ICC continues to invest in creating a sustainable future for women's cricket. The Women's Emerging Nations Trophy is part of a new three-tier development pathway designed to offer high-performance exposure to emerging nations," it added. ICC Chief Executive,

Sanjog Gupta said the new tournament will provide emerging nations more opportunities to play at the highest level.

'It is the ICC and the Chair's vision to sustainably expand cricket's footprint across the world and grow the women's game. Providing elite athletes from emerging nations more opportunities to play at the highest level is aimed at fast-tracking their development and improving the competitiveness of their

"It also drives the visibility of the sport in participant nations, serving as a driver of girls' involvement in the sport and inspires women from other nations to stay committed to the development pathways," said Gupta.

The tournament will begin with hosts Thailand taking on the Netherlands and Papua New Guinea playing against UAE.
