New Delhi, Nov 17: In a strong message, Union Home Minister, Amit Shah on Monday said that the government will hunt down the culprits of the Delhi bomb blast even from the depths of the netherworld and ensure they receive the strictest possible punishment.

At least 15 people were killed and 20 others injured after a blast ripped through a car near the iconic Red Fort in Delhi last week. The suicide bomber, later identified as Dr Umar Mohammad, also died in the explosion. The investigators believe Dr Umar triggered the

Haryana's Faridabad today. He also paid tributes to those who lost their lives in the bomb and the explosion at Nowgam Police Station in Jammu and Kashmir, while two minutes

Nine persons were killed, including a Naib Tehsildar, State Investigating Agency Officer, and a tailor, while 32 others were injured after a high-intensity blast ripped through the Nowgam police station in Srinagar late Friday night.

The blast occurred when a

stockpile of explosives, confiscated from an alleged doctors' terror module busted by Jammu and Kashmir in Haryana's Faridabad, accidentally went off inside the police station.

# Kashmir peak power demand crosses 1,900 MW mark

'Local generation reduces by nearly 75%'

Srinagar, Nov 17: As the mercury plummets to sub-zero, peak power demand in Kashmir has crossed 1,900 Megawatts mark while the power generation from local plants has reduced by nearly 75 percent.

Officials informed news agency-Kashmir News Observer (KNO) that in the past 24 hours, there was a peak power load of 1,925 MWs in the

Kashmir division. "However. there was an average power load of 1,566 MWs during these 24 hours.'

It also said that in the Jammu division, there was a peak power load of 1,119 MWs and 885 MWs on an average.

About the power generation from the local power plants of Jammu and Kashmir, the official said that the generation was ranging from 280MWs to 350-380 MWs. | More on P6

# DST awards 37 research projects under JKSTIC's SREP

## **Secretary reviews Kashmir Province Projects**

SRINAGAR, NOVEMBER 17: Dr. Shahid Igbal Choudhary, Secretary, Department of Science & Technology, Monday chaired a workshop with 37 Principal Investigators from leading academic and research institutions of Kashmir Province at Srinagar.

The meeting featured detailed presentations by selected Project Investigators under Round 1 of the Sponsored Research and Extension Programme (SREP) 2025, implemented by the Jammu & Kashmir Science, Technology & Innovation Council (JKSTIC).

The 37 approved projects for Kashmir Province, representing an investment of more than ₹515.00 lakhs, span five strategic research clusters designed to address critical challenges facing the region while improving public service delivery. Principal Investigators from 16 premier institutions presented their research methodologies, pilot demonstration strategies, and anticipated community impact to the Secretary.

Participating institutions from Kashmir Province included Islamic University of Science & Technology Awantipora (IUST) with 6 projects, Sher-e-Kashmir University of Agricultural Sciences & Technology-Kashmir (SKUAST-K) with 8 projects, National Institute of Technology Srinagar (NIT) with 5 projects, Central University of Kashmir (CUK), Kashmir University (KU), NIELIT Srinagar, Sher-i-Kashmir Institute of Medical Sciences (SKIMS), Government Medical College Srinagar (GMC-S), ICAR-Central Institute of Temperate Horticulture (CITH), Indian Grassland & Fodder Research Institute (IGFRI), Cluster University Srinagar, Government College for Women Srinagar, Islamia College of Science & Commerce Srinagar, and JKSTIC itself, besides the government departments.

Smart Agriculture & Food Security emerged as the largest cluster with 9 projects. Researchers presented innovations in climate-resilient indigenous rice varieties through photosynthetic and biochemical modeling (CUK), smart blueberry farming establishment (SKUAST-K), stress-priming kits for climate-smart vegetable production, paprika and colored capsicum production systems for local seed self-reliance, tomato genetic interventions for water-deficit stress mitigation, Al-powered research data banks for sustainable agriculture, integrated forage production strategies for fodder security (IGFRI), and AI-enabled IoT weather stations for precision horticulture (JKSTIC), collectively benefiting over 200,000 farmers and supporting Kashmir's ₹4,000+

crore horticulture economy. Under Healthcare Innovation & Public Health (7 projects), Principal Investigators presented cutting-edge research including IoT-enabled smart IV infusion systems for patient safety in resource-constrained district hospitals (IUST), genomic analysis of hypertrophic cardiomyopathy and sudden cardiac death prevalent in Kashmir's population (SKIMS), longitudinal studies on opioid dependence mortality addressing the addiction crisis (SKIMS), Delphi-derived organophosphate poisoning severity scales for improved toxicology management GMC-Srinagar), exploration of anti-breast cancer compounds from indigenous Himalayan flora Lagotis cashmeriana (CUK), biodegradable hydrogel wound dressing materials from Himalayan flora (ICSC), and isolation of exosomes from subclinical mastitis for novel veterinary diagnostics (Cluster University).

The Food Safety & Quality cluster (4 projects) featured presentations on groundbreaking consumer protection research: quantitative assessment of microplastic contamination in packaged food products with migration dynamics simulation (IUST), UV-C LED treatment combined with AI-driven risk modeling for microbial safety of fresh produce (IUST), AI-based geographical discrimination of honey to protect 30,000+ marginal bee farmers in the sub-Himalayan region (IUST), and deep learning-powered Kashmiri saffron adulteration detection systems safeguarding the ₹300+ crore GI-tagged saffron industry (NIELIT Srinagar).

Sustainable Infrastructure & Climate Action presentations (8 projects) covered technology-enabled corrosion monitoring for water supply pipelines preventing ₹100+ crore annual losses (NIT), WEAP-CORDEX ensemble and machine learning approaches for assessing climate change effects on J&K's 3,500+ MW hydropower potential (NIT), Al-driven optimization of hydro-solar power integration for weak grid regions (NIT), solar-driven hydrogen-based heating systems for sustainable housing in Kashmir Valley (NIT), integrated driver risk profiling using VBOX and physiological monitoring for road safety addressing 400+ annual traffic fatalities (NIT), hydrogel-based eco-innovations for reviving Dal Lake's water quality (KU), geospatial real-time monitoring of construction activities around Dal-Nageen-Khushalsar-Brarinambal water bodies (IUST), and standardization of hazelnut propagation techniques under temperate conditions (CITH).

Srinagar, Nov 17: Hundreds of teaching and non-teaching posts continue to lie vacant in government schools across Jammu and Kashmir, crippling the education system and leaving students to bear the consequences of official apathy.

Scores of primary, middle, high and higher secondary schools are functioning without adequate staff, depriving students of the attention and guidance that parents expect when they send their children to school.

period. The absence of administrative heads has weakened school supervision, planning, and day-to-day management, directly affecting teaching quality and student performance.

At the higher secondary level, the crisis runs deeper. Out of 26 higher secondary schools, four continue to operate without permanent principals. Institutions like Government Higher Secondary School D.H. Pora and others remain headless, making it difficult to maintain discipline or ensure smooth academic functioning.

The situation is no better in the high schools, many of which have been without headmasters for years. The absence of headmasters has hit both academic and administrative aspects of these schools, lowering teaching standards and hampering student progress.

Adding to the crisis, over 313 non-teaching posts, including clerks and support staff, remain unfilled across the district. The shortage has disrupted vital functions such as cleanliness, record-keeping, examination preparation, and maintenance of laboratories and libraries.

Educationists and parents alike express concern over the prolonged neglect, warning that if the vacancies are not filled urgently, Kulgam's entire education system could face a serious breakdown. "These are not just numbers but reflect the future of our children. The government must address this on a priority basis," a local teacher told KNO.

Officials from the education department have so far maintained that efforts are underway to streamline staffing, but the ground reality continues to show otherwise. With each passing year, students in government schools, particularly those from poor families, face the brunt of this administrative vacuum with their education, discipline and future prospects hanging in the balance—(KNO)

# GMC Jammu records 9,427 cancer cases since 2020

Srinagar, Nov 17: Government Medical College (GMC) Jammu has registered 9,427 cancer cases over the last five years (2020–2024), revealing a worrying rise in cancer incidence across the region.

The data paints a concerning picture, particularly about late-stage diagnoses and the prevalence of certain cancers in specific demographics.
Of the total 9,427 cases

reported at GMC Jammu, 3,671 patients were from Jammu district, the highest among all districts; 943 hailed from Udhampur, 855 from Kathua, 694 from Doda,580 from Samba, 532 from Reasi, 424 from Poonch, 292 from Kishtwar, 222 from Ramban and 539 belonged to other regions.

Of the total patients, 5,351 were males while 4,076 were



females, indicating a higher

burden among men. According to the data, lung cancer is the most prevalent cancer reported at GMC Jammu, followed by: Head and neck cancers, Breast cancer, hepatobiliary cancers, genito-urinary cancers, oesophageal cancers, oral cancers, cervical cancers and intestinal cancers.

Gender-wise trends show a clear difference in cancer patterns, as among men, the most common cancers are: lung, head and neck, genito-urinary, oral and haematological cancers and among women, the leading cancers include breast, cervix, hepatobiliary, ovarian and lung cancer

The data raises significant concern regarding late detection. Of all diagnosed cases, 7% were detected at Stage 1, 21% at Stage 2, 29% at Stage 3 and a staggering

43% at Stage 4.

Doctors say this trend highlights the urgent need for increased screening, awareness, and timely medical intervention, as latestage cancers are often more difficult to treat and result in poorer outcomes.

Health experts believe that the rising number of cases, along with the high percentage of late-stage diagnoses, underscores the need for strengthening preventive measures, early diagnosis, and better healthcare accessibility across the Jammu division. They also emphasise lifestyle factors, such as tobacco use, air pollution, poor diet, and lack of regular screenings, that significantly contribute to rising cancer numbers-(KNO)

# J&K panel flags gaps in town planning Act-1963

Srinagar, Nov 17: A committee constituted by the Jammu & Kashmir Government has pointed out that the Jammu & Kashmir Town Planning Act 1963 lacks key provisions for the formulation of Town Planning Schemes (TPS).

The committee, headed by Divisional Commissioner Kashmir and comprising senior officials from the administration, Housing & Urban Development Department, and Law, Justice & Parliamentary Affairs Department, has observed that the J&K Town Planning Act is deficient in terms of critical provisions necessary for formulation and implementation of Town Planning Schemes.

"The Jammu & Kashmir Town Planning Act, 1963 and the Rules framed thereunder in 1974 is the only legislation governing the formulation and implementation of TP Schemes in Jammu & Kashmir. The legislation is deficient in terms of critical provisions necessary for formulation and implementation of TP Schemes," reads the report.

The committee, headed by

Divisional Commissioner Kashmir, comprised the Commissioner, Srinagar Municipal Corporation; Deputy Commissioner, Srinagar; Vice Chairman, Srinagar Development Authority; Vice Chairman, J&K Lakes Conservation & Management Authority; Chief Town Planner, Town Planning Organisation; and Representative of the Department

of Law, Justice & Parliamentary Affairs. The committee, constituted on June 17 this year, was mandated to undertake a short term review of Master Plan Srinagar 2035. Its terms of reference include examination of the feasibility of TPS areas and identifying any TPS area(s), if necessary, for removal of the precondition with respect to issuing of building permissions in such area(s).

In its report, the committee observed that the J&K Town Planning Act 1963 propagates the formulation of Town Planning Schemes through compulsory land acquisition instead of land pooling, which is against the essence of TPS. "Land pooling is the cornerstone of a TP Scheme," reads the report.

The committee recommended that the Government may review the existing Town Planning legislation to incorporate missing legal provisions necessary for the formulation of Town Planning Schemes in J&K. It also recommended removal of a pre condition prohibiting the grant of individual construction permission in areas earmarked for Town Planning Schemes.

"The committee is of the opinion that while planned expansion of urban areas is in the interests of the city, however, holding building permissions in these areas arbitrarily amounts to unjust public inconvenience, discouragement to genuine building permission seekers, and loss to the public exchequer. It has been observed that due to poor enforcement, a lot of unauthorized constructions have come up in these areas, making implementation of Town Planning Schemes more challenging," reads the report.

The report states that, on account of an inadequate legal framework and lack of professional manpower in Srinagar Development Authority and Srinagar Municipal Corporation, the agencies couldn't take up Town Planning Schemes for execution till date—(KNO)

# **Sanat Nagar flyover misses** another deadline

Srinagar, Nov 17: The much-delayed Sanat Nagar flyover project in Srinagar has missed yet another completion deadline, with officials indicating that the timeline is likely to be extended by about a week to allow finishing works to be completed.

Officials said that the government officers heading the project and overseeing the inauguration are currently in Delhi, while another cause of delay was the Nowgam blast.

"A brief extension of around a week has been sought to wrap up the pending work. Officials have also conveyed that this should be the final one," an official said.

The latest delay has, however, prompted discussions within the administration about possible action in case of further lapses. "A detailed review might be held once the officials return, and all aspects, including accountability, will be looked into," the official added.

Earlier, in August, Deputy Chief Minister Surinder Kumar Choudhary had cautioned that the contractor would face strict action, including possible blacklisting, if the project was not completed by Novem-ber 15. He had also ordered a "probe into Rs 23 crore" in payments reportedly cleared despite incomplete work on the ground.

Sanctioned at Rs 29 crore under the National Highways Authority of India's (NHAI) decongestion plan, the Sanat Nagar flyover was originally scheduled for completion in June 2024.

Officials said most of the structural work has been completed, with only finish-

ing and safety checks pending. Locals, meanwhile, hope this will finally be the last extension. "We just want to see it open for the public now," said Javid Ahmad, a commuter from Hyderpora—(KNO)

# J&K Police face high operational risks: LoP Sharma

The Government of India notified the Digital Personal Data Protection (DPDP) Rules, 2025 on 14 November 2025. This marks the full operationalisation of the Digital Personal Data Protection Act, 2023 (DPDP Act). Together, the Act and the Rules form a clear and citizen-centred framework for the responsible use of digital personal data. They place equal weight on individual rights and lawful data processing.

The Ministry of Electronics and Information Technology invited public comments on the draft Rules before finalising them. Consultations were held in Delhi, Mumbai, Guwahati, Kolkata, Hyderabad, Bengaluru and Chennai. A wide range of participants took part in these discussions. Startups, MSMEs, industry bodies, civil society groups and government departments all offered detailed suggestions. Citizens also shared their views. In total, 6,915 inputs were received during the consultation process. These contributions played a key role in shaping the final Rules.

With the notification of the Rules, India now has a practical and innovation-friendly system for data protection. It supports ease of understanding, encourages compliance and strengthens trust in the country's growing digital ecosystem.

## Understanding the Digital Personal Data Protection Act, 2023

Parliament enacted the Digital Personal Data Protection Act on 11 August 2023. The law creates a full framework for the protection of digital personal data in India plains what organisations must do when they collect or use such data. The Act follows the SARAL approach. This means it is Simple, Accessible, Rational and Actionable. The text uses plain language and clear illustrations so that people and businesses can understand the rules without difficulty.

#### **Key Terms Under the DPDP Act, 2023**

Data Fiduciary: An entity that decides why and how personal data is processed, either alone or with others.

Data Principal: The individual to whom the personal data relates. In the case of a child, this includes a parent or lawful guardian. For a person with a disability who cannot act independently, this includes the lawful guardian acting on their behalf.

Data Processor: Any entity that processes personal data on behalf of a Data Fiduciary. Consent Manager: An entity that provides a single, transparent and interoperable platform through which a Data Principal may give, manage, review or withdraw consent.

Appellate Tribunal: The Telecom Disputes Settlement and Appellate Tribunal (TDSAT), which hears appeals against decisions of the Data Protection Board.

The law rests on seven core principles. These include consent and transparency, purpose limitation, data minimisation, accuracy, storage limitation, security safeguards and accountability. These principles guide every stage of data processing. They also ensure that personal data is used only for lawful and specific purposes.

A central feature of the Act is the creation of the Data Protection Board of India. The Board functions as an independent body that oversees compliance, inquires into breaches and ensures that corrective measures are taken. It plays a key role in enforcing the rights granted under the Act and maintaining trust in the system.

#### Penalties Under the DPDP Act, 2023

The DPDP Act imposes substantial financial penalties for non-compliance by Data Fiduciaries. The highest penalty up to 250



crore applies to failure of a Data Fiduciary to maintain reasonable security safeguards. Not notifying the Board or affected individuals of a personal data breach as well as violations of obligations relating to children can each attract penalties of up to 200 crore. Any other violation of the Act or Rules by a Data Fiduciary may attract penalties up to

The Act places clear responsibilities on Data Fiduciaries to keep personal data safe and to stay accountable for its use. It also gives Data Principals the right to know how their data is handled and the right to seek correction or removal when needed.

Together, the Act and the Rules create a strong and balanced system. They strengthen privacy, build public trust and support responsible innovation. They also help India's digital economy grow in a secure and globally competitive way.

#### Overview of the Digital Personal Data **Protection Rules, 2025**

The Digital Personal Data Protection Rules, 2025 give full effect to the DPDP Act, 2023. They build a clear and practical system to protect personal data in a fast-expanding digital environment. The Rules focus on the rights of citizens and on responsible data use by organisations. The Rules aim to curb unauthorized commercial use of data, reduce digital harms and create a safe space for innovation. They will also help India maintain a strong and trusted digital economy.

In carrying this vision forward, the Rules outline several core provisions that follow:

#### **Phased and Practical Implementation**

The Rules introduce an eighteen-month period for phased compliance. This gives organisations enough time to adjust their systems and adopt responsible data practices. Every Data Fiduciary must issue a separate consent notice that is clear and easy to understand. The notice must explain the specific purpose for which personal data is collected and used. Consent Managers, who help people manage their permissions, must be companies based in India

#### **Clear Protocols for Personal Data Breach Notification**

The Rules set out a simple and timely process for reporting personal data breaches. When a breach takes place, the Data Fiduciary must inform all affected individuals without delay. The message must be in plain language and must explain what happened, the possible impact and the steps taken to address the issue. It must also include contact details for help.

#### **Transparency and Accountability** Measures

The Rules require every Data Fiduciary to display clear contact information for queries related to personal data. This may be the contact of a designated officer or a Data Protection Officer. Significant Data Fiduciaries face stronger duties. They must conduct independent audits and carry out impact assessments. They must also follow stricter checks while using new or sensitive technologies. In some cases, they must follow government directions on restricted categories of data, including local storage where needed.

#### **Strengthening Rights of Data Principals**

The Rules reinforce the rights already provided under the Act. Individuals can ask to access their personal data or seek corrections and updates. They may also request the removal of data in certain situations. They can choose someone else to exercise these rights on their behalf. Data Fiduciaries must respond to such requests within ninety

#### **Digital-First Data Protection Board**

The Rules establish a fully digital Data Protection Board of India, which will consist of four members. Citizens will be able to file complaints online and track their cases through a dedicated portal and mobile application. This digital system supports quicker decisions and simplifies grievance redressal. Appeals against the Board's decisions will be heard by the Appellate Tribunal, TDSAT.

#### How the DPDP Rules Empower Individuals

The DPDP framework places the individual at the centre of India's data protection system. It aims to give every citizen clear control over personal data and confidence that it is being handled with care. The rules are written in plain language so that people can understand their rights without difficulty. They also ensure that organisations act responsibly and remain accountable for how they use personal data.

#### Rights and protections for citizens include:

#### **Right to Give or Refuse Consent**

Every person has the choice to allow or deny the use of their personal data. Consent must be clear, informed and easy to understand. Individuals may withdraw their consent at any time.

#### Right to Know How Data is Used

Citizens can seek information on what personal data has been collected, why it has been collected and how it is being used. Organisations must provide this information in a simple form.

#### **Right to Access Personal Data**

Individuals can ask for a copy of their personal data that is held by a Data Fiduciary.

#### **Right to Correct Personal Data**

People may request corrections to personal data that is inaccurate or incomplete.

### **Right to Update Personal Data**

Citizens can ask for changes when their details have altered, such as a new address or updated contact number.

#### **Right to Erase Personal Data**

Individuals may request the removal of personal data in certain situations. The Data Fiduciary must consider and act on this request within the permitted time.

#### **Right to Nominate Another Person**

Every individual can appoint someone to exercise their data rights on their behalf. This is helpful in cases of illness or other limitations.

#### **Mandatory Response within Ninety Days**

Data Fiduciaries are required to address all requests related to access, correction, updating or erasure within a maximum of ninety days, ensuring timely action and accountability.

#### **Protection During Personal Data Breaches**

If a breach takes place, citizens must be informed at the earliest. The message must explain what happened and what steps they can take. This helps people act quickly to re-

#### **Clear Contact for Queries and Complaints**

Data Fiduciaries must provide a point of contact for questions relating to personal data. This may be a designated officer or a Data Protection Officer.

#### **Special Protection for Children**

When a child's personal data is involved, verifiable consent from a parent or guardian is required. This consent is needed unless the processing relates to essential services such as healthcare, education or real-time

#### **Special Protection for Persons with**

If a person with a disability cannot make legal decisions even with support, their lawful guardian must give consent. This guardian must be verified under the relevant laws.

#### **How DPDP Aligns with the RTI Act**

Since the DPDP Act and the DPDP Rules expand citizens' privacy rights, they also clarify how these rights work alongside the access to information guaranteed by the

Right to Information (RTI) Act. The changes introduced through the DPDP Act revise Section 8(1)(j) of the RTI Act in a way that respects both rights without diminishing either. The amendment reflects the Supreme Court's affirmation of privacy as a fundamental right in the Puttaswamy judgment. It brings the law in line with the reasoning already followed by courts, which have long applied reasonable restrictions to safeguard personal information. By codifying this approach, the amendment prevents uncertainty and avoids any conflict between the transparency regime of the RTI Act and the privacy safeguards introduced under the DPDP framework.

The revision does not prevent the disclosure of personal information. It simply requires that such information be assessed with care and shared only after considering the privacy interests involved. At the same time Section 8(2) of the RTI Act remains fully operative. This provision allows a public authority to release information when the public interest in disclosure is strong enough to outweigh any possible harm. This ensures that the essence of the RTI Act, which is to promote openness and accountability in public life, continues to guide decision making.

#### Conclusion

The Digital Personal Data Protection Act and the DPDP Rules mark an important step in building a trustworthy and future-ready digital environment for the country. They bring clarity to how personal data must be handled, strengthen the rights of individuals and create firm responsibilities for organisations. The framework is practical in design and backed by wide public consultation, which makes it both inclusive and responsive to real needs. It supports the growth of India's digital economy while ensuring that privacy remains central to its progress. With these measures now in place, India moves towards a safer, more transparent and innovation-friendly data ecosystem that serves citizens and strengthens public confidence in digital governance.

# **DDC Budgam reviews progress** Exhorts for timely completion of all works

**NOVEMBER** 17: District Development Commissioner (DDC) Budgam, Dr. Bilal Mohi-ud-Din Bhat Monday chaired a comprehensive review meeting to assess the physical and financial progress of developmental works being executed under the District Capex Budget 2025-26, Centrally Sponsored Schemes (CSS) and the UT Sector.

The meeting, held in the Conference Hall of the DC Office Complex, was attended by senior officers, sectoral heads and engineers of all departments.

During the meeting, detailed sector-wise progress was presented. The R&B sector informed that 100 ongoing works had been taken up, out of which 94 have been completed, while 80 new works stand approved, 76 tendered, 70 allotted, and 57 started with 50 already completed.

Financially, more than ₹1574 lakh has been released for execution across multiple heads.

The Hydraulic (Jal Shakti) Circle Budgam informed that all 8 ongoing works have been completed. Under new works, 21 projects have been approved, all are tendered, 20 allotted, and 13 started. An expenditure of over ₹26 lakh has been incurred on new works, while nearly ₹15 lakh has been utilised under ongoing

The Rural Development Department highlighted one of the highest workloads in the district with 2694 works



approved under District Capex. It was informed that out of these, 2586 have been tendered, 2264 allotted, 2070 works have started, and 1591 stand completed, supported by financial releases exceeding 2455 lakh.

Similarly, a block-wise review across Beerwah, BK Pora, Budgam, Chadoora, Charare-Sharief, Khag, Khansahib, Nagam, Narbal, Pakherpora, Parnewa, Rathsun, SK Pora, Soibugh, Sukhnag, Surasyar and Waterhail revealed that 1780 ongoing works had been undertaken and 1772 completed, with expenditure surpassing ₹506 lakh out of ₹646 lakh released.

While reviewing the overall progress, the DDC emphasised that the pace of work must be further accelerated.

He said that timely execution is critical for ensuring service delivery at the grassroots level, and delays must be avoided at all stages.

The DDC stressed that both physical and financial targets must be met within the stipulated timelines, particularly in view of the current working

He said that all departments should maintain strict coordination, ensure quality adherence, and resolve bottlenecks without delay. It was further directed that officers must ensure optimum utilisation of funds released under District Capex, CSS and UT Sector schemes.

He insisted that regular field monitoring, prompt reporting, and timely tendering/allotment remain essential for improving overall developmental outcomes in the district The DDC also remarked that

departments must maintain transparency and accountability in every stage of project execution, adding that citizens expect efficient delivery of infrastructural and public welfare works.

He also directed officers to keep him regularly updated regarding progress and ensure that pendency is removed through focused intervention.

Besides JD planning budgam SE Hydraulics circle budgam SE Ř&B Budgam, ACD/ACP budgam, CEO MC budgam, all District officers, all BDOs, EOs of all MCs were present in the meeting.

# DC Bandipora reviews **ODOP with Deptts**

The DC underscored that coordination between all concerned departments would be crucial for ensuring meaningful value addition and sustainable livelihood opportunities. Among others, the meet-

"For the past five decades, almost every state in India has been affected by Maoist terror. Unfortunately, the Congress chose to nurture those who do not believe in the Indian Constitution," he said.

The prime minister said the Congress went on to embed 'Urban Naxals' within major institutions.

"The Urban Naxal-Maoist ecosystem that had taken root in the Congress 10-15 years ago has now transformed into the 'Muslimleegi Maowadi Congress (MMC)'. And today, I say with full responsibility that the MMC has sidelined national interest for its own political gain," Modi

The prime minister said be it the central government or state governments led by regional parties, the primary focus should be development.

"The results of the Bihar elections have once again taught a lesson on the high aspirations and ambitions of the people of India. The people of India today trust those political parties who have good intentions and fulfil the aspirations of the people prioritise development,



Modi said.

Modi said the BJP wins elections because it is committed to the development and welfare of the people 24x7.

He said crores of BJP workers have nurtured the party with their sweat, and they continue to do so even today.

"In states like Kerala, Bengal and Jammu and Kashmir, hundreds of our workers have also nurtured the party with their blood. # **India committed to best** interests of people of Bangladesh: MEA on Hasina verdict

New Delhi, Nov 17 Hours after a special tribunal in Bangladesh sentenced ousted prime minister Sheikh Hasina to death, India on Monday said it noted the verdict and that it will engage constructively with all stakeholders considering peace, democracy and sta-bility in the neighbouring country.

The Ministry of External Affairs (MEA) said India remains committed to the best interests of people of Bangladesh. Hasina was found guilty of

crimes against humanity by the country's International Crimes Tribunal (ICT) and it sentenced her to death. Hasina's aide and former home minister Asaduzzaman Khan Kamal was also given a death sentence on similar charges.

Hasina, the Awami
League leader, has been liv-

ing in India since she fled Bangladesh on August 5 last year in the face of the mas-

"India has noted the verdict announced by the 'International Crimes Tribunal of Bangladesh' concerning former prime minister Sheikh Hasina," the MEA said.

"As a close neighbour, India remains committed to the best interests of the people of Bangladesh, including in peace, democracy, inclusion and stability in that country," it said. "We will always engage

constructively with all stakeholders to that end," the MEA added. However, it did not com-

ment on Dhaka's call to extradite Hasina. Following the verdict, Bangladesh's foreign min-

istry demanded that Hasina be immediately handed over under an extradition treaty in view of her sentencing.

"This is also a duty for India, as per the extradition treaty existing between the two countries," it said.

Bomber's Aide

Meanwhile, the National Investigation Agency (NIA) on Monday was granted a 10-custody of the Delhi blast suicide bomber's aide. Amir Rashid Ali by the special anti-terror agency court in Delhi.

Amir, according to the anti-terror agency, was arrested for conspiring with the suicide bomber - Dr Umar - to carry out the terror attack which claimed 10 lives and left 32 others injured near Delhi's historic Red Fort.

It added the accused was found involved in terrorist related activities and was found to have visited the safe house arranged by Dr Umar. "Amir will now be brought to the Kashmir Valley to probe further links into the Delhi blast case".

Amir had come to Delhi to facilitate the purchase of the car which was eventually used as a vehicle-borne Improvised Explosive Device (IED) to trigger the blast, the NIA had said on Sunday.

One More Key Associate Of Suicide Bomber

Continuing with its probe in the Red Fort blast, case, the Anti-Terror Agency today said that it has arrested another key associate of the terrorist involved in the blast. He has been identified as Jasir Bilal Wani alias Danish of

It said that investigations have revealed that Jasir had allegedly provided technical support

for carrying out terror attacks by modifying drones and attempting to make rockets ahead of the deadly blast.

The NIA said that he was an active co-conspirator behind the attack and had worked closely with the terrorist, Umar un Nabi, to plan the terror carnage.

"The NIA continues to explore various angles to unravel the conspiracy behind the bombing. Several teams of the anti-terror agency are pursuing multiple leads, and are conducting searches across states to identify every person involved in the terror attack," it said. (KNO)

# 45 Umrah pilgrims from Hyderabad killed in Saudi Arabia bus accident

Hyderabad, Nov 17: At least 45 people, most of them from Hyderabad, were killed in a bus accident in Saudi Arabia, the city police chief said on Monday, citing preliminary information.

Addressing reporters here, Hyderabad police commissioner VC Sajjanar said a total of 54 people travelled to Jeddah from here on November 9. They were scheduled to return on November 23.

Of the 54, four people travelled separately by car to Madina on Sunday, while another four stayed back in Mecca, he said.

Taking to X, Prime Minister Narendra Modi said he was "deeply saddened" by the accident in Madinah involving Indian nationals.

The PM also said Indian officials are in close contact with Saudi Arabian authorities.

According to the police commissioner, 46 people were travelling in the bus, which collided with an oil tanker about 25 km from Madina.

Only one person survived the accident and is currently undergoing treatment at a hospital. "We are getting information that 45 people died. They were supposed to return to Hyderabad on 23rd



(of November)," he added.

Citing information received by him, Telangana Minorities Welfare Minister Mohammad Azharuddin said the toll is said to be about 47-48 people.

The bodies are understood to be charred beyond recognition. The pilgrims used the services of four different travel agents, he said.

He said the state government has pledged to help the family members of the victims travel to Saudi Arabia, including facilitating passports and visas.

One person from each family would be sent, the minister said. Speaking to PTI Videos, Mufti Asif, a resident of

Hyderabad, said seven members of his family travelled to Saudi Arabia to perform Umrah. He confirmed receiving photos of the accident and urged the Telangana government to facilitate his travel to Saudi Arabia to take care of his family members.

Mohammad Salman, another city resident, whose six family members were in the bus, said his last contact with them indicated that they two hours away from Madinah before all communication ceased. According to Mohammad Burhan, another city resident, the sole survivor, Shoaib managed to escape by

Patna, Nov 17: The swearing-in ceremony of the new govern-ment in Bihar is likely to take place in Patna on November 20, official sources said on Monday.

Prime Minister Narendra Modi and several other top leaders of the NDA, including union ministers, are expected to take part in the oath-taking event, they said.

Earlier in the day, Bihar BJP president Dilip Jaiswal told reporters that the newly elected

legislators will meet on Tuesday to elect their legislature party leader.

oath-taking ceremony of the new government will take place either on November 20 or November 21, he said.

Preparations are underway at Patna's Gandhi Maidan for the swearing-in event.

Meanwhile, the last cabinet meeting of the outgoing NDA government in Bihar on Monday authorised Chief Minister Nitish Kumar to recommend dissolution of the

assembly, a state minister said. The CM met Governor Arif Mohammad Khan soon after the meeting to apprise him about the decision of the cabinet. The cabinet in its meeting, passed a resolution to recommend the dissolution of the assembly on November 19, he said. In the recent assembly polls, the NDA bagged more than 200 seats in the 243-member House, with the BJP winning the maximum number of 89 seats, followed by the JD(U)'s tally of 85.

## **SC** issues notice to Rajasthan govt on plea challenging validity of anti-conversion law

New Delhi, Nov 17: The Supreme Court on Monday sought response from the Rajasthan government and others on a petition challenging the validity of the Rajasthan Prohibition of Unlawful Conversion of Religion Act, 2025. A bench of Justices Vikram Nath and Sandeep Mehta issued notice to the state and others, seeking their replies on the plea filed by the Jaipur Catholic Welfare Society.

We have raised competence as well as excessiveness in terms of constitutional limitations," senior advocate Rajeev Dhavan, appearing for the petitioner, said.

The bench observed that petitions raising similar issue were pending consideration before the top court.

"We have raised an entirely different question," Dhavan said.

"We will issue notice and call the other side and then we will hear you,"

Justice Nath said, as the bench issued notice on the plea and posted the matter for hearing after four

It also tagged the plea with the pending petitions raising similar issue.

On November 3, the top court agreed to hear two petitions challenging the validity of several provisions of the law against illegal religious conversions that came into force in Rajasthan.

It issued notice to the Rajasthan government seeking its response with in four weeks on the pleas against the 2025 Act that was passed by the state Assembly in September.

Also in September, another bench of the apex court sought the stand of several states on separate pleas seeking a stay on their respective anti-conversion laws.

The top court had then made it clear that it would consider the prayer for staying the operation of such laws once the replies were filed.

Patna, Nov 17: RJD leader Tejashwi Yadav is likely to hold a meeting with the newly elected MLAs of his party on Monday to discuss the future course of action for the party following its drubbing in the recent Bihar assembly elections, sources said.

They said he will "discuss the poor performance of the INDÎA bloc in the 2025 Bihar polls" and decide on the future course of action for the party" after the formation of the new NDA government.

The INDIA bloc faced a crushing defeat at the hands of the NDA in the Bihar polls which managed to secure 202 seats in the 243-member assembly. The RJD, which won merely 25 of the 143 seats it contested, is also witnessing a family feud in the residence of its founder Lalu Prasad.

Claiming that she was "cursed at" for donating a "dirty kidney" to her father Lalu Prasad in exchange for money and a party ticket, Rohini Acharya on Sunday said "she has been made an orphan", and advised all married women to refrain from saving "your God-like father



if he has a son". In an emotional outburst, 47-year-old Acharya, in a series of posts on X, said that "may no household give birth

to a girl with a fate like that

of Rohini". The posts came a day after her announcement that she was quitting the party and disowning her family, while putting the blame for the RID's debacle in the recent Bihar polls on her brother Tejashwi Yadav's close aides - RJD's MP Sanjay Yadav, who hails from Haryana, and Rameez, who is from a polit-

ical family in Uttar Pradesh. NDA leaders on Monday condemned RID's Tejashwi Yadav for "disrespecting the female members" of his

family, and questioned the credibility of his claims to build a better Bihar.

Speaking to reporters here, Bihar JD(U) chief Umesh Kushwaha said. "This is a family matter and I wish they could live united. But you see, recently, the daughter-inlaw of that family came out in public as well. If a person wants to rule Bihar but cannot maintain the respect of female members of his family, it is before the people to judge." He was ostensibly referring to Aishwarya Rai, the estranged wife of Lalu Prasad's elder son Tej Pratap, who accused the Yadav family of inflicting physical and

# **Anil Ambani skips ED summons in** Fema case

Says ready to depose virtually



New Delhi, Nov 17: Reliance Group Chairman Anil Ambani refused to appear before the Enforcement Directorate in a Foreign Exchange Management Act (Fema) case for the second time on Monday.

The businessman said he was ready to depose before the federal probe agency via "virtual appearance/recorded video", a statement he made when he skipped the summons the first time on November 14.

The ED had rejected Ambani's offer and issued him a fresh summons for Monday. It was not clear if the agency would issue a third summons now.

Proceedings under the Fema are civil in nature, as against the criminal processes under the anti-money laundering law.

In a statement, a spokesperson of the 66-year-old businessman said, "Mr Anil D. Ambani has offered to make himself available for the recording of his statement, at any date and time suitable to ED, via virtual appearance/ recorded video."

According to sources, the agency had asked Ambani to appear before it in person on Friday and record his statement under the Fema.

The investigation pertains to the Jaipur-Reengus highway project. In an earlier statement, the ED said that after recently attaching assets worth Rs 7,500 crore belonging to Ambani and his companies under the anti-money laundering law, a search carried out against Reli-

ance Infrastructure Ltd.

was allegedly "siphoned"

"Funds moved through Surat-based shell companies to Dubai. The trail has unearthed a wider international hawala network exceeding Rs 600 crore." the agency said.

The ED has recorded the statement of various persons, including some alleged hawala dealers, following which they decided to summon Ambani, the sources said.

Hawala denotes illegal movement of funds, largely in cash.

'The matter (Fema case) is 15 years old, dates to 2010. It concerns issues associated with a road contractor," the statement said.

In 2010, Reliance Infrastructure Ltd. awarded an EPC (engineering, procurement and construction) contract to build the JR Toll Road (Jaipur-Reengus high-way), it said. "This was a purely domestic contract with no foreign exchange component involved whatsoever. The JR Toll Road has been fully completed and, from 2021 onwards, has been with the National Highways Authority of India," the statement said.

Ambani is not a member of the Board of Reliance Infrastructure.

"He served the company for about 15 years, from April 2007 to March 2022, only as a non-executive director, and was never involved in day-today management of the company," it said.

The businessman has been questioned once by the ED in a money laundering case linked to an alleged Rs 17,000-crore bank fraud against his group companies.

# Top doctor reveals 6 signs you have high amount of cortisol & what should one do

New Delhi, Nov 17: Cortisol, known as the stress hormone, in small quantities, prepares our body for the 'fight or flight' response. However, when there is too much cortisol in the body, it can lead to various health issues and inflammation. Not many know that chronic stress can affect each and every part of your body, including stomach, skin, even the heart and the brain! Dr Kunal Sood, a Double Board Certified MD, reveals 6 signs of high cortisol, followed by some tips on what can you can do to manage it...

#### Weight gain around the abdomen, face, and neck

While weight gain in general is a cause of concern, weight gain on the face, belly, and the back of the neck, often means cortisol, says Dr Sood. Weight gain, in that spot looks different from overall weight gain, because the arms and the legs stay mostly the same. High cortisol shows this pattern in people who have long-term stress, or who have 'Cushing syndrome', a condition where cortisol is too high. High cortisol can also cause a condition called 'moon face' and a fat lump on the neck, called a 'buffalo hump'. This storage is usually a sign of excess cortisol, that can lead to blood pressure and blood sugar problems.

#### Skin issues

The skin can show symptoms of high cortisol as well. This occurs because high cortisol levels break down proteins in the skin, which makes the skin thin and fragile. The thin skin bruises easily, and heals slowly. Not only that, high cortisol raises oil production in the skin, that can make acne worse. High cortisol can also cause red stretch marks, where fat builds up such as the abdomen or thighs, along with eczema, psoriasis or rosacea flare up. Stress can also speed up ageing, which can lead to dryness and

#### Digestive problems

Your stomach is one of the first organs that gets affected by stress. High cortisol, over time, can make the gut leakier, that can cause bloating and discomfort. Not only that, the brain-gut connection also



messes up the balance of bacteria in the tract. When the balance of bacteria is off, the brain-gut connection can bring on problems such as irregular bowel syndrome (IBS), or irregular digestion. This occurs because higher inflammation that comes from cortisol, hurts gut health, by changing gut motility and gut secretion.

#### Muscle and joint pain

Cortisol breaks down muscle tissue for energy, when the body is stressed. Over time, cortisol can

leave muscles feeling weak, and the joints vulnerable to aches, according to Dr Sood. This occurs because high cortisol reduces bone density, and muscle mass. This reduced bone density and reduced muscle mass cause muscle pain, fatigue or even osteoporosis, if left unchecked. A lot of people think that fatigue and pain is a natural part of ageing, but chronic fatigue should never be Frequent colds or infections

Cortisol is tied to the strength of the immune system, and while short bursts of inflammation help the body fight off infections, when cortisol stays high for a long time, it can lower the system defenses. A weak immune system lets colds and other infections get in easily, and the immune system recovers slowly. High cortisol hurts T-cell activity, and also cuts down the production of cytokines, this leaving the body open to viruses and bacteria.

Irregular menstrual periods in women In women, cortisol has an adverse effect on hormones too, says Dr Sood. When cortisol stays

high for a long time, it can disrupt

the signals from the brain to the ovaries. This break can cause periods that are irregular, missed or absent completely. The reason is that stress hormones such as cortisol, lower the production of estrogen and other sex hormone, leading to a drop in libido. To lower cortisol naturally:

• Put sleep first. Poor sleep keeps the cortisol high. Try to get seven to nine hours of sleep each night. Regular exercise helps low-

overboard, as excessive exercise can increase cortisol as well. Skip the processed foods/ high-sugar foods, that can raise cor-

er the stress. However, do not go

tisol. Instead, focus on wholesome foods, and enough protein. • Practice relaxation by doing breathing, yoga or mindfulness meditation, since they directly low-

er stress symptoms. • Try to limit caffeine and alcohol. Both can increase stress hormones if consumed excessively.

• Build meaningful relationships: Supportive relationships keep stress down and cortisol low, over time.

# **Ousted Bangladesh** PM Hasina sentenced to death for 'crimes against humanity'

Dhaka, Nov 17: Bangladesh's deposed prime minister Sheikh Hasina was on Monday sentenced to death in absentia by a special tribunal for "crimes against humanity" over her government's brutal crackdown on student-led protests last year.

In its verdict that followed a months-long trial, the country's International Crimes Tribunal (ICT) described the 78-year-old Awami League leader as the "mas-termind and principal architect" of the violent repression that killed hundreds of protesters.

Hasina has been living in India since she fled Bangladesh on August 5 last year in the face of the massive protests. She was earlier declared a fugitive by the court. In her reaction, Hasina said the judgement has been made by a "rigged tribunal established and presided over by an unelected government with no democratic mandate." "They are biased and politically motivated. In their distasteful call for the death penalty, they reveal the brazen and murderous intent of extremist figures



within the interim government to remove Bangladesh's last elected prime minister, and to nullify the Awami League as a political force," she said in a statement.

Hasina said she was not afraid to face her "accusers" in a proper tribunal where the evidence can be weighed and tested fairly.

"That is why I have repeatedly challenged the interim government to bring these charges before the International Criminal Court (ICC) in the Hague.'

The verdict comes months before parliamentary elections in Bangladesh. Hasina's Awami

League party has been barred from contesting the elections scheduled to be held in February.

Reading out the judgment before a heavily guarded court-room in Dhaka, the ICT said the prosecution proved beyond a reasonable doubt that Hasina was behind the deadly crackdown on student-led protests in July-August last year.

A UN rights office report had earlier estimated that up to 1,400 people were killed during the month-long agitation, known as the July Uprising.

Hasina was handed the death

deadly force against unarmed protesters, making inflammatory statements and authorising operations that led to the killing of several students in Dhaka and surrounding areas.

In recent media interviews, Hasina described the ICT as a 'kangaroo court" run by her

The ICT, originally set up to try hardened collaborators of Pakistani forces during the 1971 Liberation War, was amended by the current administration to bring leaders of the past regime, including Hasina, under its urisdiction.

Most Awami League leaders have either been arrested or have fled the country since the collapse of the Hasina regime.

By inciting violence through provocative statements and taking no punitive measures against the perpetrators who attacked protesting students, Hasina committed crimes against humanity, the ICT said.

# US flights to return to normal after restrictions lifted

Washington, Nov 17: US flights will return to normal schedules on Monday after reductions imposed during a government shutdown were lifted, the Federal Aviation Administration said.

The FAA said Sunday evening that restrictions would be lifted and "normal operations can resume" across the country from 6:00 a.m. Washington time (1100 GMT) on Monday.

Thousands of flights were canceled due to understaffing during the shutdown, which stretched into a record 43 days.

Ten percent of domestic flights were cut at 40 of the busiest US airports due to a shortage of control tower staff, who were asked to work without pay as the budget stalemate dragged on. The aviation industry was further strained after President Donald Trump threatened to dock pay for air traffic controllers who called



in sick during the shutdown, accusing them of being unpatri-otic. Flights were still reduced by three percent over the weekend despite the shutdown ending on Wednesday, though the FAA said some airlines had not complied with the restrictions.

"Now we can refocus our efforts on surging controller hiring and building the brand new, state of the art air traffic control system," Transport Secretary Sean Duffy said in a statement.

The easing of restrictions comes days before a surge in passengers traveling around the upcoming Thanksgiving holiday on November 27.

# 'Nothing to hide': Trump says Republicans should vote to release Epstein files

Washington, Nov 17: US President Donald Trump has urged House Republicans to vote in favour of releasing the Jeffrey Epstein files, calling the controversy a "Democrat hoax" and accusing his opponents of using the case to distract from Republican policies.

In an elaborate statement on his social media platform, Truth Social, Trump said that Republicans "have nothing to hide" and should move ahead with the vote expected this week.

"As I said on Friday night aboard Air Force One to the Fake News Media, House Republicans should vote to release the Epstein files, because we have nothing to hide, and it's time to move on from this Democrat Hoax perpetrated by Radical Left Lunatics in order to deflect from the Great Success of the Republican Party, including our recent Victory on the Democrat "Shutdown."

This marks a sharp shift, as Trump had earlier criticised calls, including from some Republicans, to release all case documents related to Epstein, the convicted sex offender who died in prison in 2019.

Trump said the Department of Justice had already released "tens of thousands" of pages linked to Epstein and argued that Democrats were trying to target Republican leaders while ignoring figures such as Bill Clinton and others

He urged his party to refocus on issues like inflation, immigration and the economy instead

The US House of Representatives is expected to vote in the coming days on whether to release additional sealed files and investigative documents related to Epstein's network, CNN

The vote follows months of delays and disagreements within the Republican Party, with some members demanding full transparency and others cautioning against releasing sensitive information.

Meanwhile, survivors of Epstein's abuse have launched a last-minute, emotional campaign urging lawmakers to release the files.

A public service announcement created by the advocacy group World Without Exploitation was released on Sunday, featuring survivors holding photos of themselves as teenagers, the age at which they say Epstein first targeted them.

#### Japan seeks to calm escalating row with China over Taiwan **REUTERS**

Tokyo/Beijing, Nov 17: Japan on Monday moved to tamp down an escalating row with China over Tai-wan that has prompted Beijing to urge its citizens to stay away from its East Asian neighbor.

The dispute erupted after Prime Minister Sanae Takaichi told Japa-nese lawmakers earlier this month that a Chinese attack on Taiwan threatening Japan's survival could trigger a military response, a scenario previous administrations have avoided discussing in public to avoid provoking Beijing, which claims the self-ruled island.

Masaaki Kanai, the director general of the Japanese Foreign Ministry's Asia and Oceania bureau, will meet his Chinese counterpart, Liu Jinsong, in Beijing this week, Japanese media reported on Monday. Kanai is expected to explain that Takaichi's comment does not signal a shift in Japan's security policy and urge China to refrain from actions that further damage ties, they said.

# They've completely destroyed Test cricket': Harbhajan Singh on underprepared home pitches

New Delhi, Nov 17: Calling it "the destruction of Test cricket", former India spinner Harbhajan Singh says underprepared and excessively bowler-friendly surfaces like the one used at Eden Gardens, prevent the genuine development of players.

India slipped to a 30-run defeat while chasing 124 in the first Test against South Africa as the game ended inside three days. "They have completely destroyed Test cricket. Rest in peace Test cricket," Singh, said on his YouTube channel.

# Norway beats Italy to qualify for first FIFA World Cup since 1998

Milan, Nov 17: Norway qualified for the FIFA World Cup 2026 on Sunday after a 4-1 win away to Italy in its final qualifying match, condemning the host, which has missed out on the last two editions of the tournament, to the playoffs.

Norway ended the qualifying campaign with a perfect record of eight wins, finishing six points ahead of four-time World Cup winner Italy, which will compete in the playoffs for the third consecutive occasion.

Needing a nine-goal win because of Norway's superior goal difference, the Italians came out full of aggression and made the early breakthrough just after the 10-minute mark, as Francesco Pio Esposito swept

in a close-range finish. The host was dominant until


Haaland then wrapped up the match with a second goal a minute later, taking his tally for the campaign to 16.
