Srinagar, Nov 17: The National Investigation Agency (NIA) on Tuesday was granted a 10-custody of the Delhi blast suicide bomber's another aide, Jasir Bilal Wani by the special antiterror agency court in Delhi.

According to details available with news agency-Kashmir News Observer (KNO), Jasir alias Danish was produced in the Patiala House Court in Delhi by the Anti-Terror Agency today afternoon. Jasir, a resident of Qazigund in Jammu and Kashmir, was arrested by the NIA on Monday in the Delhi blast case.

The court granted 10-day custody of Jasir, another key aide of Delhi suicide bomber

-Dr Umar Mohammad - to the Anti-Terror Agency. At least 15 people were killed and several others were injured after a high-intensity blast ripped through a car near Delhi's iconic Red Fort last week.

On Sunday, the NIA made the first breakthrough in the Delhi blast case by arresting the suicide bomber's key aide - Amir Ali.

"The NIA investigations have revealed that Jasir had allegedly provided technical support for carrying out terror attacks by modifying drones and attempting to make rockets ahead of the deadly blast," the NIA said on Monday.

SKIMS gives new life to 18-yr-old girl after spinal cord surgery

Srinagar, Nov 18: In a remarkable medical feat, doctors at the Sher-i-Kashmir Institute of Medical Sciences (SKIMS) have successfully performed a marathon 11-hour surgery to remove a rare holocord intramedullary spinal cord tumour in an 18-year-old girl, one of the most complex spinal surgeries ever performed in the region.

The entire procedure was carried out free of cost, a statement issued to the news agency-Kashmir News Observer (KNO).



17-level laminoplasty followed by the delicate removal of a tumour from within the spinal cord (intramedullary), a technically demanding procedure rarely attempted even in leading neurosurgical centres.

The operation was led by Dr. Abrar Ahad Wani, Professor & Head of Unit, Department of Neurosurgery, along with his dedicated surgical team.

The Anaesthesia team, headed by Dr. Zulfikar Ali, provided continuous high-risk neuroanaesthesia support throughout the 11-hour procedure, ensuring complete physiological stability of the young patient during the complex surgery.

Budgam must set example by breaking drug supply chain: Dr Bilal

Chairs 41st NCORD meeting, urges community-driven fight

BUDGAM, **NOVEMBER** 18: The 41st District-Level NCORD (Narco Coordination) Committee Meeting was today convened at the DC Office Budgam under the chairmanship of Deputy Commissioner (DC) Dr. Bilal Mohi-Ud-Din Bhat, along with SSP Budgam Nikhil Borkar, to review ongoing measures against drug abuse and to formulate fresh strategies for a drug-free Budgam.

The meeting was attended by ADC Budgam, all SDMs, ACD, CMO, DSWO, Medical Superintendent DH Budgam, Principals of all Government Degree Colleges, EOs of Municipal Committees, and other concerned officers.

At the outset, action taken on previous NCORD decisions was reviewed. It was informed that wild cannabis spread over 77 kanals and 18 marlas of land has been destroyed across the district during the past month, while 55 cases have been registered and 38 challenged for illicit cultivation.

The DC said that drug abuse is not only a law enforcement challenge but a serious social problem affecting families and communities. He emphasised that the fight against drugs must remain strict and uncompromising toward peddlers, traffickers, and cultivators, while being supportive and compassionate toward victims who require treatment and rehabilitation.

ti-pronged approach involving deterrence, enforcement, treatment, and mass awareness is essential. It was stressed that all line departments need to intensify efforts to curb narcotics cultivation and peddling. It was further stated that roads, embankments, and Panchayat areas must be kept free from cannabis and poppy cultivation through coordinated efforts.

Regarding drug regula-tion, the DC underlined the importance of 100% CCTV coverage and Computerized Billing Systems (CBS) in all chemist shops. It was informed that Budgam has 630 retail and 225 wholesale chemist outlets, all under strict monitoring. He said that frequent inspections



action be taken for any violations.

He also said that the Drug Inspector shall ensure wide publicity about actions taken, including cancellation of licenses and other violations, to increase transparency.

It was given out that 117 calls have been received on the Tele-MANAS mental health helpline, indicating its increasing role in providing psychological support. The DC said that such services must be further publicised so that people can seek help

The DC said that the Addiction Treatment Facility (ATF) at District Hospital Budgam must remain functional round-the-clock. It was further informed that the Drug De-Addiction Centre is now fully ready for intake of patients requiring treatment.

The DC also said that all Degree Colleges in Budgam shall ensure installation of CCTV cameras within their campuses to strengthen preventive monitoring.

Reiterating the zero-tolerance stance, the DC said that the administration shall continue to act firmly against drug peddlers, cultivators, and traffickers, while extending full support to victims of addiction. He said that this campaign requires collective participation of government departments, civil society, community elders, teachers, parents, and religious scholars.

50% surge in power demand likely

RIYAZ BHAT

Srinagar, Nov 18: While the power sector continues to function with 'decades old infrastructure', Jammu and Kashmir is likely to witness growth in power demand by nearly 50 percent in a decade.

According to the official documents, authorities have projected that Jammu and Kashmir will likely have an extra power demand by 49.42 percent by the year

The official further clarified that the peak demand will be more than the average growth saying that the region may likely witness an increase in power demand by 6 percent each year from 2025-26 to



Stating the year wise growth rate in power demand, authorities have said that in the year Jammu and Kashmir will likely have a five percent extra demand in the year 2025-26 followed by four percent in the year 2026-27, four percent in 2027-28, three percent in

It also said that in the year 2029-30, the region may experience growth rate in power demand by five percent followed by four percent in 2030-31, four percent in 2031-32, three percent in 2032-33, five percent in 2033-34 and four percent in the year 2034-35 respectively.

It also said that according to the data provided by J&K, an additional 392 MW of Coal (Shakti Scheme), 620 MW of solar and 1206 MW of hydro is planned till 2030.—(KNO)

Mehbooba rejects collective punishment for Delhi blast

Bukhari flags concern over 'educated youth radicalisation'

Srinagar, Nov 18: Apni Party President and former minister, Syed Mohammad Altaf Bukhari on Tuesday voiced serious concern over the growing trend of educated youth being drawn towards radicalisation and terror-related activities, calling it an "alarming development" that warrants urgent and honest introspection.

"Authorities must investigate why even well-educated youth are being influenced to join terrorist activities," Bukhari said.

He said this trend poses a serious challenge and requires a comprehensive evaluation by all stakeholders.

Bukhari reiterated his party's firm opposition to all forms of violence, saying that those found guilty must face the law, but also cautioned that "innocent individuals should not be harassed in the name of counterterrorism measures.'

Expressing sorrow over the 'accidental blast at Nowgam Police Station' near Srinagar, the Apni Party chief urged the government to provide proper compensation to the families of the deceased and to



those whose homes and properties were damaged in the explosion.

"We convey our heartfelt sympathies to the families who lost their loved ones in the Nowgam incident. The victims whose properties were affected must be adequately compensated," he said.

Reading a detailed resolution passed in the party's day-long working committee meeting held at the party office in Srinagar, the Apni Party president said the party expressed deep concern over the recent Delhi car blast and the alleged involvement of well-educated individuals in the incident.

Terming the attack "highly

condemnable," the party demanded the toughest possible punishment for those responsible while urging the central government to explore and address the root causes of "white-collar radicalisation."

"While dealing with terrorism firmly is essential, it is equally important to reach out and win the hearts and minds of people," the party said in a resolution passed unanimously during the meeting chaired by Bukhari. "The causes leading educated individuals towards radicalisation must be investigated and effectively

The party also observed a two-minute silence to honour the victims of both the Delhi and Nowgam blasts. Apni Party further stressed the need to bridge the "deficit of trust" between New Delhi and the people of Jammu and Kashmir, calling for meaningful public outreach and dialogue to ensure lasting peace and stability in the

The mistrust between New Delhi and the people of J&K must be addressed. Such gaps only create space for violent tendencies to grow," the statement said, urging the government to fulfil its outreach commitments made by the Prime Minister and Home Minister.

The meeting also discussed pressing public issues including rising unemployment and inflation in the Union Territory, noting that economic distress was feeding into social and security challenges.

Highlighting the party's policy roadmap, the Apni Party leadership underscored its focus on improving governance, reviving traditional economic sectors like horticulture, handicrafts, agriculture, and tourism, and ensuring participatory governance that delivers results on the ground.

The party demanded immediate holding of Panchayat and ULB polls, regularisation of daily wagers, reforms in the reservation system, and the launch of an employment drive for J&K's educated youth.

'Jammu and Kashmir is at a delicate point of transition, politically, economically and socially," the statement said. "What is needed now is sincere, farsighted, and dedicated leadership. We, in Apni Party, will continue our efforts with honesty and commitment to serve the people of J&K."—(KNO)

Doctors issue advisory on unvented gas heaters

fessionals in Kashmir have isthe use of unvented gas heaters in closed and poorly ventilated rooms, cautioning that such devices can lead to severe health complications and even death due to carbon monoxide (CO) poisoning. Dr Zahoor Wani, a senior doc-

tor at the Directorate of Health Services Kashmir (DHSK), said that unvented heaters burn fuel inside the room without a chimney or outlet for harmful gases. This results in the gradual accumulation of toxic substances-particularly carbon monoxide.

"Unvented gas heaters release combustion byproducts directly into the room. When carbon monoxide builds up beyond a certain level, individuals are at high risk of CO poisoning, especially while sleeping," he

safest solution is to avoid these Srinagar, Nov 18: Health pro- heaters altogether and opt for emissions outside the home.

> Dr Wani warned that if residents continue using unvented heaters, they must avoid operating them in bedrooms, bathrooms, or any confined area. "Such heaters should only be used in spaces with sufficient airflow. Using them at night in closed rooms is extremely dangerous," he said.

> The doctor described carbon monoxide as particularly dangerous because it gives no warning signs. "You cannot smell it, see it, or taste it. It renders a person helpless without them realising it," he said. "Most victims lose consciousness quietly during sleep, making it especially deadly.'

He noted that children, elderly individuals, pregnant women, and people with chronic illnesses are more

explained. He stressed that the susceptible to poisoning even monoxide, he pointed out at lower concentrations.

The experts reiterated that awareness and caution are critical as winter intensifies. "Preventable tragedies can be avoided if people understand the risks and adopt safe heating practices," they said—(KNO)

Dengue declining in J&K

Srinagar, Nov 18: After weeks of rising dengue infections across Jammu and Kashmir, health authorities have reported the first signs of decline. However, with 3,248 confirmed cases recorded so far, officials have cautioned that the situation still demands strict preventive efforts from the public.

According to official data, the Jammu division remains at the forefront of the outbreak, reporting 1,384 cases, followed by Kathua with 862, Samba with 459, and Udhampur with 172. Smaller but notable numbers have emerged from Reasi (70), Rajouri (69), Poonch (28), Doda (74), Ramban (43) and Kishtwar (15).

In Kashmir, 31 cases have been confirmed, while 41 infections were detected in individuals from outside the UT.

Health officials told KNO that 26,980 dengue tests have been conducted across Jammu and Kashmir to date. "Only 49 patients required hospital admission, and 46 have been discharged, which is a positive sign," an official said, adding that one J&K resident died at DMC Ludhiana due to complications linked to the infection. Experts reiterated that dengue

remains a preventable but poten-

tially serious disease, stressing

that no specialised vaccine or antiviral medication is currently "The only effective way to break the transmission chain is to ensure mosquitoes do not breed. Stagnant

water anywhere, even in small amounts, becomes a breeding ground," an official said. Medical professionals explained that the Aedes aegypti mosquito thrives in everyday

household objects. "Even a little clean water collected in pots, tyres, buckets, lids, bottles or tubs is enough for mosquitoes to multiply," they said. They advised people to use

mosquito repellents regularly, wear long-sleeved clothing, keep water tanks and containers tightly sealed, and install window screens or mosquito nets even during daytime hours when dengue mosquitoes are most active.

"These mosquitoes bite mostly early in the morning and late

in the afternoon, so precautions during these hours are particularly important," they said. Doctors said people should

seek immediate medical attention if they notice danger signs, such as persistent vomiting, abdominal pain, bleeding from the nose or gums, blood in vomit or stools, extreme fatigue, or unexplained restlessness, all of which may indicate severe dengue.

Notably, dengue was almost unheard of in the region a decade ago, with just two infections reported in 2009 and zero cases

With the disease still circulating, officials have once again urged the public to maintain strict preventive measures. "People should regularly inspect their homes, shops, and surroundings. Eliminating stagnant water is the most powerful tool we have against dengue," they said.

The authorities said that collective efforts from neighbourhoods, community groups, institutions, and local bodies will be crucial in bringing down the case numbers further—(KNO)

KU's e-Gov portal online after 270 days

Srinagar, Nov 18: Days after the news agency-Kashmir News Observer (KNO), highlighted the prolonged shutdown of the University of Kashmir's e-Governance portal, dubbed by students as "Digital Hell", the portal has finally been restored, bringing an end to nearly "nine months (around 270 days)" of frustration and offline workarounds.

Students confirmed to the news agency-Kashmir News Observer (KNO) that the portal (https://egov.uok.edu.in/ eConduct/) was now accessible publicly, marking the first time since early February that services such as registration, admit card downloads and fee payments could be done

"It is finally working! We had lost hope after months of inconvenience. The KNO report did what the frequent complaints couldn't," said a relieved B.Tech student.

Last week, KNO had reported that the University's e-Gov portal, intended to streamline access to vital academic services had remained locked behind the University's internal Intranet, forcing thousands of students to physically visit college IT cells for routine tasks.

The report, which triggered a wave of student reactions across social media, appears to have prompted quick action from the University's IT division.

As of Tuesday evening, students confirmed that the website was functioning smoothly, although some minor lags were reported during logins.

University officials were unavailable for immediate comment. However, students expressed cautious optimism, saying the University must ensure consistent uptime and transparency in digital services. "After 270 days of blackout, this restoration should be the start of accountability, not a temporary patch-up," a student shared—(KNO)

Contaminated water crisis hits Dardpora

Srinagar, Nov 18: Despite the government's repeated assurances of providing safe drinking water across Jammu and Kashmir, the remote hamlet of Dardpora Lolab in north Kashmir continues to grapple with acute water scarcity and contaminated supplies, placing its vulnerable population-including the elderly and children-at serious health risk.

Local residents said that, despite the establishment of a vital water supply project under the Jal Jeevan Mission (JJM), their village remains deprived of clean water. "We have approached the concerned offices on multiple occasions, but our grievances continue to fall on deaf ears," the inhabitants lamented.

Bihar's Verdict And The Emerging Grammar Of Indian Politics

Bihar's voters have signalled that they expect a politics grounded in governance, seriousness and respect for national cohesion

The people of Bihar have delivered a mandate whose weight goes well beyond the arithmetic of seats. The National Democratic Alliance has won 202 of the 243 seats in the Legislative Assembly, while the Bharatiya Janata Party alone has secured 89 seats, its best ever performance in the state. The Mahagathbandhan has fallen to just 34 seats after having dominated Bihar's politics for decades in various combinations. A turnout of 67.13 per cent out of more than 7.4 crore registered voters makes this one of the most intensely contested elections in the state's recent history and gives the result real democratic depth.

For years, much of the commentary on Bihar treated the state as if it were frozen in time. Elections were read as exercises in caste arithmetic, with social demography assumed to translate mechanically into political outcomes. Under Prime Minister Narendra Modi's leadership, the grammar of Indian politics has shifted decisively towards development, inclusion and state capacity, and Bihar's electorate has responded to that shift with unusual clarity. The 2025 result reveals a more demanding voter, one who has looked at the contrast between the Bihar of insecurity and paralysis and the Bihar of improved governance. Many citizens have

also expressed, in conversations and turnout patterns, that this election carried a sense of responsibility after the lower-than-expected mobilisation in the 2024 general election. They have drawn their own conclusions about where they want Bihar to stand in the country's wider journey.

Governance delivery has anchored this transformation. Over the last decade, Bihar has seen more than 55,000 kilometres of rural roads built or upgraded, linking villages to markets, schools and health centres. Millions of households have received electricity, drinking water and social security through a combination of central schemes and state programmes. Under Saubhagya and related initiatives, over 35 lakh households in Bihar were electrified, taking the state close to universal household connectivity. Under the Pradhan Mantri Awas Yojana, more than 57 lakh pucca houses have been sanctioned for Bihar, many registered in the names of women. Such figures speak to concrete change that people can see and touch: an all weather road, a light that stays on, a tap that works, a home that provides dignity.

As these public goods spread, old labels lose some of their hold. Bihar's society remains diverse and layered, yet those layers no longer behave like watertight containers in electoral terms. Women from different communities now share expectations about safety, mobility and opportunity. Young people from families that once stood at opposite ends of the social hierarchy now find themselves in the same coaching classes and labour markets. Their daily experiences

draw them into a shared space of aspiration. In that space, the questions they ask of politics concern jobs, infrastructure, stability and fairness

The verdict has also delivered a clear message on dynasty centred politics. Parties that relied on family charisma and inherited networks have seen their legislative space contract sharply. Bihar has observed such formations at close quarters for several decades and understands their limits. The 2025 result suggests that voters are looking at how leaders conduct themselves in government, how they respond in crises, how they engage with institutions and how they use public resources. Where family backgrounds exist within the wider National Democratic Alliance, they are increasingly filtered through demands for hard work, organisational ability and a record of service.

The behaviour of younger voters sits at the heart of this shift. Bihar has one of India's youngest demographic profiles, and millions of citizens born after 2000 voted in this election. They have grown up in an India where expressways, digital payments, competitive federalism and ambitious welfare schemes shape expectations. They compare states, track announcements and judge leaders on the speed with which promises turn into visible change. For them, the difference between a road laid on time and a road that never leaves the file is not an abstract matter. They experience that difference every day when they commute to colleges, coaching centres or workplaces and when they see families back home benefit from connectivity and welfare.

This generation also brings a sharp instinct for national coherence. Young voters are alert to rhetoric that undermines institutions, flirts with separatist sentiment or trivialises national security. They engage critically with policy debates, including on unemployment and inequality, yet they draw a line between criticism that aims to improve the republic and narratives that appear indifferent to its cohesion. Bihar's verdict reflects this distinction. Voters have responded to a political formation that speaks the language of both development and national purpose with unusual clarity.

Law and order provide another layer of explanation. Bihar's elections were once associated with booth capturing and violence. Over recent years, and especially in this electoral cycle, those images have largely receded. Insurgency affected pockets have been pushed back through the combined weight of firm security measures and economic development. Traders now keep their shops open longer, students travel with greater confidence, and families experience public life with less anxiety. An electorate that has seen this improvement does not ignore it when choosing its representatives.

The response of parts of the opposition to these developments has been revealing. Rather than reflecting on the reasons for their loss of support, some leaders have preferred to cast doubt on the Election Commission, on voter lists or on the fairness of the process itself. This posture does little justice to the intelligence and agency of Bihar's voters. It also ignores the fact that the

same institutional framework has produced outcomes favourable to the opposition in other states. The electorate expects a more serious engagement with its concerns than blanket denunciations of the system that it has just used so enthusiastically.

Placed in a wider national and global context, Bihar's verdict strengthens an emerging pattern. At a time when several democracies grapple with polarisation, economic drift and institutional fatigue, India continues to register high participation, stable leadership and a policy trajectory centred on growth, inclusion and national strength. The Bihar result adds another layer of democratic endorsement to that trajectory. It suggests that voters in one of India's most politically conscious states see their own progress intertwined with the country's larger journey towards a developed and confident Bharat by 2047

For the National Democratic Alliance, this mandate is both encouragement and instruction. It validates the emphasis on infrastructure, welfare delivery and security, yet it also raises expectations for faster job creation, deeper reforms and continual institutional improvement. For the opposition, the verdict poses serious questions about strategy, leadership and programme. Bihar's voters have signalled that they expect a politics grounded in governance, seriousness and respect for national cohesion. Those expectations are likely to frame the grammar of Indian politics for years to come.

The Sound Of Truth In A Noisy World

vividly recall receiving a call many years ago from a musician friend who, after seeing a WhatsApp message, wanted to confirm whether the legendary singer Lata Mangeshkar had passed away. The news, coming early in the morning from someone in the field of music, came as a shock. After all, reports at the time had only mentioned that Lata ji had been admitted to hospital for a minor ailment. Yet, within less than an hour, social media platforms - including Facebook, WhatsApp groups, and Twitter - were flooded with tributes, photos, and condolence messages. I immediately contacted legendary singer Suresh Wadkar ji, who quickly reassured me that Lata ji was doing well. Indeed, she continued to grace the world with her presence for many more years before peacefully passing away at the age of 92 on 6 February 2022.

A similar (viral) episode unfolded recently, on 10 and 11 November 2025. Social media platforms and even certain news outlets prematurely announced the death of Bollywood's "He-Man," Dharmendra, who was undergoing treatment at Mumbai's Breach Candy Hospital and has been discharged as I am penning this down. Several prominent personalities also took to the social media platforms to express their grief, only to later delete their posts after his wife, Hema Malini, firmly dismissed rumours and clarified that her husband was responding to treatment and showing improvement. These instances raise a crucial question: how has news, once a pillar of trust and verification, become so vulnerable to distortion in the digital age?

It is with this concern that I reflected on Public Service Broadcasting Day, observed every year on November 12 to commemorate Mahatma Gandhi's historic radio address from Broadcasting House, New Delhi,



in 1947. The day reminds us of radio's transformative potential and Gandhi's vision of truth-based communication, a vision that stands in stark contrast to today's epidemic of misinformation. Speaking from the All India Radio studio (now preserved as the "Bapu Studio"), Mahatma Gandhi addressed millions during a deeply distressing period following Partition. His compassionate Diwali message sought to comfort refugees and inspire unity among a divided people.

The broadcast, arranged at the request of industrialist and Gandhiji's close associate Ghanshyam Das Birla, transformed the studio into a prayer space, reflecting Gandhi's sincerity and spiritual approach to communication. The Hindustan Times described Gandhi's speech the next day as an event that demonstrated the "miraculous power" of radio to unite hearts and minds. Gandhi recognized radio as a revolutionary tool that could transcend barriers of literacy, geography, and class. Yet, he consistently emphasized that such power must be exercised with restraint and moral responsibility. Journalism, he said, should "educate the public mind" and "fearlessly express the truth."

The day of November 12 has gone by as another calendar date. Fast forward to today, and we are all aware that the media landscape has changed beyond recognition. The emergence of digital platforms has democratized access to information. But it has also given rise to an unprecedented crisis of credibility. Fake news, defined as false or misleading information disseminated under the guise of legitimate journalism, has become one of the gravest challenges of the 21st century. The World Economic Forum has repeatedly listed misinforma-tion among the top global risks to democracy and social cohesion. In India, where over 820 million people use the internet, misinformation spreads rapidly through social media algorithms that prioritize en-

gagement over accuracy.

False reports, morphed videos, and unverified "breaking news" can provoke panic, damage reputations, and even incite violence. It has done so in the past. While the government and independent organizations have established fact-checking portals and awareness campaigns to combat fake news, real progress depends on media literacy and

a revival of the Gandhian ethics of responsibility in journalism. Gandhi's principles – verification, context, and service to truth – offer enduring guidance amid this digital turbulence. Gandhi had warned against sensationalism and distortion, believing that the press should "restrain itself from running after momentary excitement" and instead "serve the cause of truth and justice."

His approach to communication was patient, reflective, and profoundly ethical qualities that need to be harnessed. Unlike Gandhi's time, when news travelled slowly and was often scrutinized closely, today's information ecosystem enables the instantaneous spread of falsehoods, making fact-checking and responsible journalism vitally important. In Gandhi's time, the radio was a miraculous medium of connection – a voice that could travel across invisible waves to reach even the most remote corners of the nation. Over the decades, All India Radio (AIR), now operating under Prasar Bharati, has carried forward that spirit of public service.

Established in 1936 and renamed Akashvani in 1957, AIR emerged as India's first large-scale medium for national integration, education, and cultural exchange, serving as the cornerstone of Public Service Broadcasting. Radio brought India together in times of joy and crisis - broadcasting independence celebrations, weather warnings, agricultural advice, and music that reflected the nation's diversity. Gandhi's own recorded prayer meetings from Birla House, preserved in the Prasar Bharati Archives, stand as a testament to the medium's historic legacy. Even in the digital era, radio continues to be one of the most reliable and accessible media forms. The Prime Minister's "Mann Ki Baat" – broadcast from the same "Bapu Studio" - illustrates how radio remains a bridge between the government and the people and the unifying power of sound.

The media landscape has evolved remarkably with the rise of FM radio stations such as Radio Mirchi (98.3 FM), Red FM (93.5), Radio City (91.1), and Big FM (92.7), which have transformed mass communication in India over the past two decades. These private channels introduced localized, youth-centric, and engaging content – music, humour, news, and talk shows in Hindi and regional languages – making radio lively and inclusive. By bridging barriers of class, age, and literacy, FM radio democratized communication and turned "listening" into a shared cultural experience.

From national broadcasts to community stations, radio continues to unite diverse audiences while remaining one of India's most affordable and powerful media platforms. Entertainment has always been radio's strength, but in Gandhi's vision, even entertainment must uplift – it must elevate, not degrade. His engagement with journalism was never driven by profit but by a profound moral duty. For Gandhi, the press was not a business venture but a public trust – an instrument to advance truth (Satya), non-violence (Ahimsa), and the welfare of all (Sarvodaya).

Through journals like Indian Opinion, Young India, Navjivan, and Harijan, he transformed media into a vehicle for moral and social awakening. Seventy-eight years after his voice first echoed across India's airwaves, Gandhi's message remains as vital as ever. In an age marked by misinformation, polarization, and declining media trust, Mahatma Gandhi's ethics of journalism – grounded in truth, humility, and service – offer a timeless moral compass for responsible journalism and re affirm the transformative power of media in shaping a more enlightened and compassionate society.

Jammu, Nov 18: Chief Secretary, Atal Dulloo on Tuesday chaired a high-level meeting to thoroughly assess the multi-departmental efforts and progress under the Nasha Mukt Bharat Abhiyan (NMBA) across the districts of Jammu and Kashmir. The meeting concluded with several critical directives aimed at intensifying the campaign, streamlining coordination, and establishing a robust mechanism for the rehabilitation of addiction-affected individuals.

Highlighting the urgency of tackling the drug menace, the Chief Secretary issued a slew of instructions including constitution of a dedicated Task Force under the Chairmanship of the Principal Secretary, Home, with Administrative Heads from the Information, Social Welfare, and Skill Development Departments as members. This force will focus on formulating comprehensive, age-group-wise rehabilitation proposals for treated individuals.

Chief Secretary under-scored the vital need for training counsellors for every Panchayat, Health Center, High/Higher Secondary School, and College across J&K. He asked for training of Master Trainers at IMHANS Srinagar/ Jammu, who will then be utilized to conduct decentralized training sessions in their respective districts. Videography of these training sessions was suggested for clarity and wider dissemination across tehsils and blocks.



agency for coordinating the NMBA activities across all departments and was directed to explore the possibility of seeking financial assistance from the Department of Revenue (DoR), Government of India, under the National Fund for Control of Drug Abuse (NFCDA).

All departments were instructed to meticulously dovetail their NMBA-related activities and ensure their coordinated upload onto the single reporting portal managed by the Department of Information and Public Relations (DIPR).

Commissioner Secretary, Social Welfare, Sarmad Hafeez, presented a detailed overview of the achievements under the Abhiyan, showcasing widespread outreach and collective departmental efforts:

The Information Department played a crucial role in awareness generation by conducting 5,361 events, reaching 3,83,259 persons. The Rural Development Department (RDD) also contributed significantly with 4,881 outreach events, engaging 3,08,841

Alongside events by Urban Bodies, the Health & Medical Education Department has focused on intervention and rehabilitation, registering 33,205 patients for treatment. Supplementing this, Drug Deaddiction Centres across the UT have provided substantial support by holding 1,12,884 counselling sessions.

On the strategy for the days ahead, the meeting emphasized awareness generation, rehabilitation of victims, imparting vocational training, education, and sustainable livelihoods as key tasks to combat the addiction menace.

The Health Department apprised the meeting that the training of Master Trainers would commence immediately at both GMC Srinagar and Jammu, with an initial batch of 30 from each district. The process is slated to continue for the next six months, aiming to create a comprehensive pool of approximately 4,000 counsellors covering every Panchayat, school, and health center.

The Chief Secretary concluded the meeting by administering a pledge to all participants, committing them to help achieve a drug-free India by abstaining from and preventing the use of narcotic substances.

CS for giving push to green energy, innovations, research across J&K

Jammu, Nov 18: Chief Secretary, Atal Dulloo on Tuesday reviewed the functioning of the Science & Technology Department and called for accelerated efforts to advance J&K's transition to green energy, expand renewable infrastructure, and strengthen science education and research among students.

The meeting was attended by Secretary S&T, Dr Shahid Iqbal Choudhary, CEO JAKEDA P.N. Dhar, and senior departmental officers.

The Chief Secretary assessed the progress on small and mini hydropower projects and reviewed key renewable initiatives including the solarization of government buildings and the implementation of the PM-KUSUM scheme along with dozens of other initiatives taken by the department to promote clean energy and innovation across

The Secretary S&T, Dr Shahid Iqbal Choudhary informed that JAKEDA is working toward solarizing more than 8,000 government buildings with a cumulative capacity of 245 MW. It includes 70 MW under CAPEX across 30 departments and 175 MW under the RESCO model. He added that work orders for 1,300 buildings have been issued, while completed installations include the 10 kW system at TRC Kupwara and the 3 MW plant at the University of Kashmir.

On agricultural empowerment through PM-KUSUM, the Chief Secretary was informed that the scheme has recorded

near-total success with all 4,224 applications allotted and 3,586 solar pumps installed, achieving an 85% completion rate. The intervention has enhanced irrigation reliability, replaced nearly 8.5 million litres of diesel annually, and enabled savings of Rs 20,000–Rs 30,000 per farmer per year.

With respect to the Small/ Mini hydro initiative the Secretary apprised the meeting that the department is also expanding the initiative rapidly, with 35.25 MW operational in IPP mode and a total portfolio of 188.75 MW. The same includes 153.5 MW under development across 81 projects.

Upcoming projects include 4.65 MW scheduled for commissioning in 2026 and 49.70 MW in 2027-28. At full capacity, the hydro portfolio is expected to generate more than Rs110 Cr annually in revenue and create over 1,200 direct and indirect jobs.

The Department is further advancing decentralized renewable solutions, including 15,000 biomass cook stoves, 25,000 solar streetlights, a 100 kW floating solar pilot, and EV charging stations.

Moreover a strict 120-day roadmap has been formulated to retender the remaining 152.75 MW RESCO capacity across 6,700 buildings and to complete installation of the remaining 638 pumps under PM-KUSUM to achieve 100% saturation.

Reviewing the functioning of the Jammu & Kashmir Science, Technology & Innovation Council (JKSTIC), the Chief Secretary was briefed on major initiatives to strengthen the research ecosystem and scientific infrastructure.

The Jammu & Kashmir Medical Council had already cancelled the registrations of Dr. Ahmad, Dr. Rather, and Dr. Shakeel based on evidence shared by investigating agencies.

Dr. Saeed, registered with the Uttar Pradesh Medical Council, was removed through a separate NMC order. The removal followed FIR No 162/2025, lodged at Nowgam Police Station in Srinagar on October 19, under multiple sections of the UAPA, including provisions relating to unlawful activities, terrorist acts, raising funds, recruitment, and harbouring.

The NMC said the conduct of the doctors was "prima facie inconsistent with the standards of ethical propriety, integrity and public trust" required under the Indian Medical Council (Professional Conduct, Etiquette and Ethics) Regulations, 2002.

The order states that the four individuals "shall cease to practice medicine or hold any medical appointment till further orders". All State Medical Councils have been instructed to enforce the directive. (KNO)

CIK detains couple

to public order and national security.

The CIK earlier today conducted coordinated searches at four locations in Srinagar, Kulgam and Anantnag in connection with a case FIR No. 05/2025 under Sections 196, 152, 351(2) of the Bharatiya Nyaya Sanhita (BNS) and Section 13 of the Unlawful Activities (Prevention) Act,

Police Station CIK. It said that the searches are part of an ongoing crackdown against social media abusers operating in connivance with handlers across the border, who have been deliberately engaged in furthering terrorist, secessionist, and separatist agendas.

It further said that by leveraging their professional status and societal standing, the involved individuals were allegedly using social media platforms to spread disinformation, radicalise youth, incite violence and disturb public order, posing a serious threat to the peace and sovereignty of the Union of India.

"During the operation, two accused: Shahzada Akhtar and her husband Dr Umer were detained. Multiple digital devices and incriminating material having direct relevance to the investigation were also seized. The recoveries include fiver mobile phones, five SIM cards, a tablet device, and additional digital and documentary evidence and literature," it said.

The CIK said that during the course of the investigation, it has also emerged that the detained individuals were misusing their positions and social standing to mask unlawful activities.

"The female suspect, Shahzada Akhtar, in particular, is alleged to have been involved in radicalising local women through curated online and offline engagements, pushing divisive narratives, and influencing vulnerable groups under the pretext of community interaction,"

It stated that her affiliation with banned terrorist organisation 'Dukhtaran-e-Milat', is currently under investigation. "This dimension of the case highlights a concerning trend of the exploitation of social roles and professional facades to advance disruptive agendas".

It said that all recovered devices are undergoing detailed forensic analysis, which is expected to unravel a broader digital network linked to organised propaganda efforts. "Early leads indicate the possibility of a wider ecosystem of collaborators and sympathisers, whose activities were aimed at amplifying extremist content and manipulating public perception,"

Multiple courts, CRPF schools in Delhi receive bomb threat; all found to be hoax

New Delhi, Nov 18: Multiple courts in Delhi, Saket, Dwarka and Patiala House, along with two CRPF-run schools, received bomb threats on Tuesday morning, prompting large-scale security checks across the national capital, officials said.

Police said an email warning of explosives planted on court premises was received early morning, following which security teams were alerted to inspect the premises of these district courts. Nothing suspicious was found after the security checks.

Around the same time, an unidentified man called the Police Control Room (PCR) around 9 am, claiming that bombs had been placed inside CRPF schools located in Prashant Vihar and Dwarka. The threat triggered immediate mobilisation of local police, bomb disposal squads and the Delhi Fire Services at all

Navneet Panwar, vice president of the New Delhi Bar Association in Patiala House courts, confirmed that a bomb threat had been received by email, following which a sanitisation exercise was conducted.

"The court proceedings are on. There was only a brief halt," Panwar said.

Meanwhile, there was heavy security in Patiala House courts as Jasir Bilal Wani, NIA's second arrest in the Red Fort bomb blast probe, was to be produced here.

These hoax calls come in the wake of the recent Red Fort blast.

A car carrying an improvised explosive device exploded near the historical monument on November 10, claiming 15 lives and injuring several others.

Investigators have found the alleged links of the incident with the terror module security agencies busted in Faridabad, Haryana, before the blast.

Treat water as a sacred, finite resource: President Murmu

New Delhi, Nov 18: President Droupadi Murmu on Tuesday urged the private persons and public bodies to treat water as a sacred and finite national resource, as she conferred the sixth National Water Awards.

She said sustainable management and community participation were essential to ensure long-term water security, as she cautioned that India faces growing stress on its limited freshwater reserves.
"Thousands of years ago,

our forefathers said in the Rig Veda, apsu antah amritam, the president said, according to a statement. "Water is life. A person can live a few days without food, but not without water. We must remember that we are using a very valuable resource," she said. She urged citizens, institutions and governments to treat water as a "sacred and finite national resource.'

The president congratulated the 46 awardees across 10 categories for their work in conservation, innovation, and efficient water use. "I congratulate all the

individuals and organisations who have received this award today. You are working hard for water, and your efforts are crucial for our nation," she said. Murmu said climate change is disrupting the water cycle, intensifying pressure on already limited water

"In such a situation, the government and the people should work together to ensure water availability and water security," she said, and underlined the need to preserve groundwater,

promote a circular water economy, and strengthen reuse and recycling across industries.

Murmu cited the Jal Jeevan Mission's expansion of household tap water connections as a major shift in India's water landscape.

"In 2019, less than 17 per cent of homes had tap water. Today, that number has increased to 81 per cent. Women and girls have benefited the most, with nearly 9 crore women relieved from the daily burden of fetching water,"

Serious issue: SC on cases of missing children

New Delhi, Nov 18: The Supreme Court on Tuesday voiced concern over a news report that claimed that every eight minutes, a child goes missing in the country, and described it as a serious issue. A bench of Justices B V Nagar-

athna and R Mahadevan said the adoption process in the country is complicated and asked the Centre to streamline the mechanism. "I have read in a newspaper


that every eight minutes, a child goes missing in the country. I don't know if this is true or not. But this is a serious issue," Justice Nagarathna observed orally. The top court remarked that

as the adoption process is rigorous, it is bound to be flouted and people go for illegal means to have children.

During the hearing, Additional Solicitor General Aishwarya Bhati, appearing for the Centre, sought six weeks time for appointing a nodal officer to andle cases of missing children.

The apex court, however, refused to grant six weeks and asked the ASG to complete the process by December 9.

On October 14, the bench had directed the Union government to instruct all States and Union territories to depute a nodal officer to handle cases of missing children and to provide their names and contact details



Vatsalya portal operated by the Ministry of Women and Child Development.

It had directed that whenever a complaint regarding a missing child is received on the portal, the information should be simultaneously shared with the respective nodal officers.

The top court had earlier sked the Centre to create. dedicated online portal under the aegis of the home ministry to trace missing children and investigate such cases.

It had underlined the lack of coordination among police authorities entrusted with the job of tracing missing children in States and Union territories in the country.

The court had said the portal

for publication on the Mission could have a dedicated officer from each state who could be the in-charge of missing complaints besides disseminate information.

NGO Guria Swayam Sevi Sansthan had moved the top court and highlighted unresolved cases of kidnapping or missing children besides the actions required to be taken on the basis of information available with the Khoya/Paya portal monitored by the government of India.

The petition illustrated its argument with five cases registered in Uttar Pradesh last year in which minor boys and girls were kidnapped and trafficked through a network of middlemen to states like Jharkhand, Madhya Pradesh and Rajasthan.

ED raids against Al Falah University, linked persons in **Red Fort blast case**

New Delhi, Nov 18: The Enforcement Directorate on Tuesday conducted simultaneous searches in Delhi-NCR against the trustees and promoters of Al Falah University of Faridabad, the varsity central to the Red Fort area car blast case, officials said.

Multiple teams of the federal probe agency raided at least 25 premises of the Al Falah trust and University establishment since 5:15 am, they said.

Teams of the agency raided an office location in Delhi's Okhla area with a security cordon being provided by the police and paramilitary forces.

Fifteen persons have been killed in the blast that took place on November 10 near the iconic monument in Delhi and the role of a number of doctors linked to the University and in Kashmir is under the scanner of the anti-terror probe agencies.

"The operation forms part of an ongoing investigation into financial irregularities, use of shell companies, accommodation entities and money laundering. The role of Al-Falah Trust and related entities is under investigation." an ED official said

The official said "key" personnel overseeing finance and administration of the trust and the University have also been covered in the raids.

The agency has taken cognisance of the first information reports filed by the NIA and the Delhi Police in the case. Till now. the NIA has arrested two persons, stated to be the alleged close aides of "suicide bomber" Dr Umar Nabi.

At least nine shell (dummy) companies



linked to the group, all registered at a single address, are under the examination of the ED, according to the officials.

Preliminary findings point to multiple "risk" indicators consistent with shell-company behaviour like no physical presence or meaningful utility consumption at declared places of business and common mobile number and email across various companies and accounts.

The ED investigators have also found absence of EPFO/ESIC filings inconsistent with reported scale of operations and overlapping of directors/signatories and weak KYC trails across entities.

Instances of minimal salary disbursal prough banking channels and absence of HR (human resource) records part from synchronised incorporation patterns and common contact coordinates across firms have been detected at the varsity, the offi-

In addition, prima facie discrepancies have been noted in claims regarding UGC and NAAC recognition which indicate alleged non-compliance to norms established for educational institutions, the officials said.

SC notices to Centre, CBI, ED, Anil Ambani on PIL alleging massive banking, corporate fraud

New Delhi, Nov 18: The Supreme Court on Tuesday issued notices to the Centre, CBI, ED, Anil Ambani and others on a PIL seeking a court-monitored probe into alleged massive banking and corporate fraud involving Reliance Communications (RCOM), its group companies and their promoter.

A bench comprising Chief Justice B R Gavai and Justice K Vinod Chandran took note of the submissions of lawver Prashant Bhushan, appearing for PIL petitioner and former Union secretary E A S Sarma, and sought the replies within three weeks.

The bench has now posted the PIL for further hearing after three weeks.

Bhushan alleged that the probe agencies are not investigating the alleged complicity of banks and their officials in the huge banking fraud.

He sought a direction to the CBI and the ED to file respective status reports

with regard to the probe against banks and their officials in the case.

'Issue notice returnable in three weeks. Let them file their replies,' the CJI said. The PIL alleged sys-

tematic diversion of public funds, fabrication of financial statements and institutional complicity across multiple entities of the Anil Ambani led Reliance ADA Group.

It said the FIR registered by the CBI on August 21, along with connected **Enforcement Directorate** (ED) proceedings, addresses merely a small segment of the alleged fraud.

Despite detailed forensic audits flagging serious irregularities, the petition claims that neither agency is probing the role of bank officials, auditors or regulators, which he calls a "critical failure".

The plea also said the findings of systematic fraud and diversion of funds have been judicially "recognised" in a decision of the Bombay High Court.

IAF, French Air Force launch Exercise Garuda-25 to boost joint op capabilities

Mont de Marsan, (France), Nov 18: The Indian Air Force (IAF) announced the beginning of Exercise Garuda-25, a bilateral air exercise with the French Air and Space Force (FASF), marking another step in the growing defence partnership between the two nations. IAF wrote on Monday on X, "#ExerciseGaruda25 takes off. Indian Air Force Su-30MKI and French Air and Space Force Rafale aircraft soared into the skies, commencing coordinated missions as part of the bilateral air exercise. The engagement reinforces strong interoperability and deep defence cooperation between the two Air Forces," said the Indian Air Force.

The 8th edition of Exercise Garuda is being held at Mont-de-Marsan, France, from November 16 to 27, as confirmed by the Ministry of Defence in an official statement. The airlift support provided by the C-17 Globemaster III, for the induction and de-induction phases of the exercise, while the IL-78 air-to-air refuelling tankers are utilised for extending the range and endurance of the participating fighters.

According to the ministry, the exercise features the IAF's



Su-30MKI fighters operating alongside French multirole aircraft in complex simulated air combat scenarios. The missions focus on air-to-air engagements, air defence operations and coordinated strike missions. This exercise aims to refine tactics and procedures in a realistic operational environment, enabling mutual learning and fostering interoperability between the IAF and the FASF.

Exercise Garuda 25 also provides an opportunity for professional interaction, exchange of operational knowledge and sharing of best practices between the two Air Forces. Participation in this exercise underscores the lAF's commitment to engage constructively with friendly foreign Air Forces through multi-lateral exercises, promoting mutual

understanding and cooperation in the field of air operations, the statement added.

India and France have tra-

ditionally enjoyed close and friendly relations, sharing a deep and enduring Strategic Partnership (SP) that encompasses all aspects of bilateral cooperation, with a strategic component. Launched on January 26, 1998, India's first-ever Strategic Partnership embodied the core vision of both countries to enhance their respective strategic independence by drawing upon a strong and enhanced bilateral cooperation. Defence and security, civil nuclear matters and space constitute the principal pillars of the strategic cooperation between India and France, which now includes a strong Indo-Pacific component.

'Depression, inflammation due to chronic pain increases risk of high blood pressure'

New Delhi, Nov 17: Depression and inflammation resulting from chronic pain, persisting for longer than three months, could increase the chances of high blood pressure in adults, according to an analysis.

The study, published in the Hypertension journal, reviewed data of over two lakh adults from the UK Biobank. Nearly 10 per cent of the individuals were found to have developed a high blood pressure after an average follow-up period of 13.5 years.

People with widespread chronic pain had the highest risk of developing high blood pressure -- a 75 per cent increased risk compared to those without pain. Short-term pain was associated

with a 10 per cent higher risk and localised chronic pain was linked with a 20 per cent higher risk, the study said. 'The more widespread their pain,

the higher their risk of developing high blood pressure," lead author Jill Pell, professor of public health at the University of Glasgow, UK, said.

According to Pell, part of the explanation for this finding was that chronic pain made people more likely to suffer from depression, and having depression made people more likely to develop high blood pressure.

"This suggests that early detection



and treatment of depression, among people with pain, may help to reduce their risk of developing high blood pressure," Pell said.

Over 35 per cent of the participants reported experiencing chronic musculo-skeletal pain, 62.2 per cent reported chronic pain at one site of the body, while 34.9 per cent reported chronic pain at two to three musculo-skeletal

"Over a median follow-up of 13.5 years, 19,911 (9.62 per cent) participants developed hypertension. Compared with no pain, those with short-term pain, chronic localised pain, and chronic widespread pain had an increased risk of hypertension," the study read.

While inflammation and depression are both known to raise the risk of high blood pressure, no prior studies have looked at the extent to which these factors mediate the link between pain and high blood pressure, Pell said.

"Together, depression (11.3 per cent) and inflammation (0.4 per cent), as

US warned others to avoid loans from Chinese state banks, but it's biggest recipient of all

Washington, Nov 18: For years, Washington has been warning others not to trust loans from Chinese state banks fuelling its rise as a superpower. But a new report reveals an ironic twist: The United States is the biggest recipient of all - by far. And the security and technology implications have yet to be fully understood.

China's state lenders have funnelled \$200 billion into US businesses for a quarter of a century, but many of the loans have been kept secret because the money was first routed through shell companies in the Cayman Islands, Bermuda, Delaware and elsewhere that helped obscure their origins, according to AidData, a research lab at the College of William & Mary in Virginia.

More alarming, much of the lending was to help Chinese companies buy stakes in US businesses, many tied to critical technology and national security, including a robotics maker, a semiconductor company and a biotech firm.

The report found a far more widespread and sophisticated lending network than previously thought - a web of financial obligations extending beyond developing countries to rich ones, including the UK, Germany, Australia, the Netherlands and other US allies.

"China was playing chess while the rest of us were playing checkers," said former White House investment adviser William Henagan, who worries the hidden lending has given China a chokehold on technologies. "Wars will be won or lost based on whether you can control products critical to running an economy."

While the US still welcomes most foreign investment — and President Donald Trump has courted it — money from China has drawn particular scrutiny as the world's two biggest economies with opposing ideologies battle for global supremacy.

Deals financed by China's stateowned banks, the ones studied in the AidData report, are especially problematic.

The lenders are controlled by China's central government and the Communist Party's Central Financial Commission, and they are directed to advance China's strategic goals.

In total, the AidData report found China lent more than \$2 trillion from 2000 through 2023 around the world, double the highest previous estimates and a surprise to even

longtime analysts of China's rise.
And much of the lending to wealthy countries was focused on critical minerals and high-tech assets rare earths and semiconductors needed for fighter jets, submarines, radar systems, precision-guided missiles and telecom networks.

"The US, under both (former President Joe) Biden and Trump, have been beating this drum for more than a decade that Beijing is a predatory lender," said Brad Parks, executive director of AidData. "The irony is very rich.'

Until now, a full accounting of China's state lending has never been published because much of the financing is buried beneath layers of secrecy, masked by Western-sounding shell companies and mislabelled



by international databases as ordinary private financing.

"There is a complete lack of transparency that speaks to the lengths to which China goes, whether through shell companies or confidentiality agreements or redactions, to make it extremely difficult to come up with this full picture," said Scott Nathan, the former head of the US International Development Finance Corp, an agency set up in the first Trump term to invest in foreign projects deemed in the US national interest.

Since the report's last documented loan in 2023, US scrutiny has gotten better. Screening mechanisms, such as the interagency Committee on Foreign Investment in the US, got beefed up in 2020 to protect sensitive sectors in the economy.

But China has gotten better, too. in part by setting up banks and branches overseas — more than 100 in recent years — that then lend to offshore entities, further clouding the origins of the money.

"In places where there are more cops on the beat," Parks said, "it has found ways to work around barriers to entry." Chinese state bank financing has touched projects across the US, particularly in the Northeast, the Great Lakes region, the West Coast and along the Gulf of Mexico, which Trump has renamed the Gulf of America. Many loans targeted critical high-tech industries, according to the report.

– In 2015, for instance, Chinese state-owned banks lent \$1.2 billion to a private Chinese business to buy an 80% stake in Ironshore, a US insurer whose clients included the Central Intelligence Agency and Federal Bureau of Investigation officials and undercover agents who might need help paying legal bills in case they got

into trouble in their jobs.

US regulators were unaware of the Chinese government involvement because the financing was funnelled through a Cayman Island business with no obvious ties to China, accord-

ing to the report.
US officials later realised the Chinese government could access information and ordered the Chinese buyer to divest. - That same year, the Chinese government published "Made in China 2025," a list of 10 high-tech areas, such as semiconductors, biotechnology and robotics, where it wanted to reach 70% self-sufficiency within a decade. The next year, in 2016, the Export-Import Bank of China, a policy bank, provided \$150 million in loans to help a Chinese company buy a robotics equipment company in Michigan.

After China's adoption of the manufacturing master plan, the percentage of projects targeting sensitive sectors such as robotics, defence, quantum computing and biotechnology rose from 46% to 88% of China's portfolio for cross-border acquisition lending, according to AidData. – In 2017, a Delaware private equity firm using a Cayman Islands company tried to buy a US chip maker; the deal was blocked when investigators discovered both companies were owned by a Chinese state-owned enterprise.

That same Delaware company successfully bought a UK semiconductor maker that had to be divested when British authorities found out.

- And in 2022, the UK forced a Chinese company to divest another sensitive British firm in the industry, a designer of chips in Apple phones but potentially adaptable for military systems. The Chinese company had bought it through a company in the Netherlands that they owned.

That Dutch firm is now accused of withholding semiconductors vital to automakers in the US-China trade war. To trace China's hidden lending, AidData dug through regulatory filings, private contracts and stock exchange disclosures in more than 200 countries written in multiple

The effort to track China's state loans and investment started more than a decade ago when Beijing launched its Belt & Road Initiative to build infrastructure in developing

The project expanded sharply three years ago when the AidData team, which eventually grew to 140 researchers, realised many of the loans were landing in advanced economies such as the US, Australia, the Netherlands and Portugal, where acquisitions could allow it to access technology that Beijing considers essential to its global rise.

The report says the findings show a shift in the use of state credit from promoting economic development and social welfare to gaining geo-economic advantages.

"There's global concern that this is part of a concerted effort to gain control over economic chokepoints and use this leverage," said Brad Setser, an adviser to the US Trade Representative in the Biden administration. "It's important that we understand what they're doing, and they don't make it easy."

UN Security Council adopts US resolution on Gaza peace plan

Hamas rejects approval of international force

Washington, Nov 18: The UN Security Council on Monday (November 17, 2025) voted to adopt a US-drafted resolution endorsing US President Donald Trump's plan to end the war in Gaza and authorising an international stabilisation force for the Palestinian enclave.

Israel and the Palestinian militant group Hamas agreed ast month to the first phase of Trump's 20-point plan for Gaza a ceasefire in their two-year war and a hostage-release deal – but the UN resolution is seen as vital to legitimising a transitional governance body and reassuring countries that are considering sending troops to Gaza.

The text of the resolution says member states can take part in the Board of Peace envisioned as a transitional authority that would oversee reconstruction



and economic recovery of Gaza. It also authorises the international stabilisation force, which would ensure a process of demilitarising Gaza, including by decommissioning weapons and destroying military infrastructure.

Trump's 20-point plan is included as an annex to the resolution.

Gill not to travel with team to Guwahati, doubtful for second Test

Kolkata, Nov 18: Indian skipper Shubman Gill is unlikely to feature in the second Test against South Africa, with Cricket Association of Bengal sources confirming that he is not travelling to Guwahati with the team on Wednesday. The team will have an optional training

session on Tuesday.

"He has acute neck pain, and we're not owed to further go to injury. He has to keep continuing wearing the neck collar," the source said.

"He has been advised three to four days of rest and not to take flight. In this situation, he is not advised to travel to Guwahati. But we are monitoring his progress on a daily basis and the picture will be clearer by Tuesday," the sources added.

The Indian team is scheduled to travel to Guwahati on Wednesday for the second and final Test, starting Saturday.

Head coach Gautam Gambhir said at the post-match press conference that Gill



was "still being assessed", with another round of evaluations to be carried out by the physio and medical staff.

Bangladesh's interim govt warns media against publishing statements of 'fugitive' Sheikh Hasina

New Delhi/Dhaka, Nov 18: Bangladesh's interim government has warned all print, electronic and online media outlets to refrain from reporting statements issued by "convicted and fugitive" deposed prime minister Sheikh Hasina, citing concerns over national security and public order. The National Cyber Security Agency (NCSA) in a press release issued on Monday claimed that Ms. Hasina's statements may contain directives or calls capable of inciting "violence, disorder and criminal activities" and disrupting social harmony, The Daily Star newspaper reported.

'We urge the media to act responsibly in the nterest of national security" the release said

The agency said it was "deeply concerned" that some media organisations were broadcasting and publishing remarks attributed to "convicted" and "fugitive" Hasina. 'We'll engage with all stakeholders' in Bangladesh, says India after Sheikh Hasina verdict Noting that airing or publishing statements from individuals who are both convicted and fugitive violates provisions of the Cyber Security Ordinance, the agency warned that authorities are empowered to "remove or block content that threatens national integrity, security or public order, promotes ethnic or religious hatred, or directly incites violence".

WPL 2026 could start from early Jan, final call on venues to come soon'

New Delhi, Nov 18: The 2026 season of the Women's Premier League (WPL) is likely to begin in early January, with a final decision on venues set to come soon, sources close to the development said to IANS on Monday. Lucknow, Bengaluru, Vadodara, and Mumbai hosted WPL 2025, which was won by Harmanpreet Kaur-led Mumbai Indians (MI) for the second time at the Brabourne Stadium earlier this year.

For WPL 2026, IANS understands that the start date of the competition could be January 7, with January 6 and 8 also in discussion. The final could be held in the February 1-3 window, and will be firmed up once the dates of the 2026 Men's T20 World Cup are out.

It is understood that the WPL 2026 final date will be fixed five days before the men's global event in the shortest format begins in India and Sri Lanka. This will be the first time WPL
