
Opp slams ruling party; govt terms it 'unfair', 'ill-timed', vows to oppose

Srinagar, Nov 21: As the Jammu & Kashmir Government came under fierce criticism from opposition parties over the Kashmir Power Development Corporation Limited's (KPDCL) proposal to levy a 20 percent surcharge on power consumption during peak hours, the National Conference-led government on Friday said it will not allow the people of J&K to be burdened with any such "unfair" and "ill-timed" proposal.

In a post on X (formerly Twitter), as per news agency Kashmir News Observer (KNO), NC leader and MLA Zadibal Tanvir Sadiq said the Omar Abdullah-led government has already taken a clear stand against the proposed 20% peak-hour surcharge. "In a harsh Kashmiri winter, power is a necessity, not a luxury. The Omar Abdullah-led government will not allow the people of J&K to be burdened with any such unfair and ill-timed proposal," he

The NC spokesman clarified the government's stand on the



proposal submitted by KPDCL-a DISCOM-to the Joint Electricity facing criticism from several opposition parties.

Apni Party president Syed Altaf Bukhari described the proposal as a "grave injustice" to the people of Kashmir. "KPDCL's proposal to impose a 20% surcharge on power tariffs during peak hours is a grave injustice to people who are already struggling to survive an economic crisis. #### **Police intensify inspections** of shops, vehicles, hospitals

'Chemical shops, car dealers, hospitals inspected to prevent anti-national activities'

Srinagar, Nov 21: Jammu and Kashmir Police on Firday carried out coordinated inspections across Srinagar city targeting chemical and fertiliser shops, car dealerships, and hospital facilities, officials said.

Last week, Srinagar Police uncovered a sophisticated "whitecollar terror module" linked to terrorist organisations. The network involved doctors from Kashmir, Faridabad and Uttar Pradesh who stored explosives. The module was connected to a deadly blast near Delhi's Red Fort and prompted widespread inspections of hospitals across

Upgraded ILS system

#### Dir Sgr airport assures no flight cancellations this winter

Srinagar, Nov 21: Director, Srinagar International Airport, Javid Anjum, on Friday said the flight cancellations due to weather are 'unlikely this winter' as the airport has been equipped with an upgraded Instrument Landing System (ILS) Category-II.

Speaking to the news agencv-Kashmir News Observer (KNO), the Director said the upgraded system ensures safer and more reliable landings even under low-visibility conditions.

Anjum said that Srinagar usually records around 1,000 metres of visibility during winters, which allows for

comfortable landings. "Earlier, the threshold was 1.200 meters, but now the system is much improved. This year, we expect no flight cancellations," he said, adding that the upgraded ILS now allows landings with visibility as low as 400 metres.

The Director said the ILS upgrade was already functional last year and that no cancellations occurred due to weather conditions, marking a major improvement in airport reliability during foggy and snowy months.



## Winter plates go modern

Srinagar, Nov 21: As winter wraps the Valley in its chill, Srinagar's markets are witnessing a quiet shift. Once a must-have in every Kashmiri kitchen, Hogaad (dried fish), Hokh Suen (dried vegetables) and other traditional delicacies are seeing dwindling demand.

Vendors who once struggled to meet crowds now find their stalls nearly empty.

"Earlier, people would stock up weeks before the first snowfall. Now, many youngsters don't even know how to cook these traditional items," says Abdul Majeed, a ven-

dor at Srinagar's Mahraj Bazaar. He adds that the decline reflects broader changes in Kashmiri eating habits.

'The younger generation prefers fresh vegetables or ready-to-cook items. The culture of preserved winter foods is slowly fading," said

another vendor nearby.

Traditionally, these foods were prepared to last through harsh winters when fresh produce was scarce. Families would soak, sun-dry and preserve vegetables to create meals that were both nutritious and long-lasting. Today, with supermarkets and year-round availability of fresh produce, that necessity has all but disappeared.

## MP Ruhullah hits back at NC critics

## **Security forces** bust hideout along LoC

## 'Illegal fishing tightly controlled in Wular'

Srinagar, Nov 21: Fisheries Department on Friday said the illegal fishing in Wular Lake is now limited to a few cases and remains tightly controlled through regular enforcement.

The department is committed to protecting the livelihoods of local fishermen and cracking down on illegal fishing across the region," Assistant Director of Fisheries, Baramulla, Showkat Ahmed, said on World Fisheries Day.

Showkat said that in the Sopore stretch of Wular Lake and the Jehlum river running through Sopore, no cases of illegal electric fishing have been reported this year. The credit goes to vigilant field officials and proactive enforcement, he said.

The officer, however, acknowledged that in the Bandipora sector of Wular Lake, a few cases of unauthorised electric fishing were detected. Field teams responded swiftly, confiscating the material linked to these illegal activities, he said.

The Assistant Director said that patrols of sensitive zones remain frequent to ensure compliance and deter future violations. He said enforcement teams remain on high alert and the department is strengthening patrols in hotspot zones, especially around Wular Lake.

Anjuman called for regular awareness programmes with fishing communities to educate them about sustainable fishing, legal tools and how illicit methods jeopardise both fish populations and long-term livelihoods.

The Wular Lake, as per the government data, contributes around 60 per cent of the total fish consumed in the Kashmir Valley, while it supports thousands of fishermen.

## Moving vehicle loudspeakers banned in Zainapora

Zainapora, Nov 21: Sub-Divisional Magistrate (SDM) Zainapora, Bilal Ahmad has issued a stringent public order banning the use of mikes and megaphones on moving vehicles across the sub-division.

The move comes in response to a rising number of complaints about noise pollution caused by vendors using loudspeakers while selling fruits and other consumables.

Officials informed that the administration had been flooded with complaints from residents during public outreach programmes, including the recent Block Diwas held on November 19, where locals highlighted the "unbearable disturbance" caused by frequent loud announcements by mobile vendors.

## Startling gap in Lok Adalat's list

Bandipora, Nov 21: A day ahead of the Special Lok Adalat, the District Legal Services Authority (DLSA) has identified a startling lapse of not a single compoundable criminal case been listed for settlement in the Lok Adalat.

The lapse has prompted a swift directive from the DLSA, pulling up judicial officers and ordering an urgent iden-tification of all eligible matters before tomorrow's proceedings.

In a communication, issued by ADR Centre of DLSA Bandipora, Chairman and Additional District and Sessions Judge Bandipora, Mir Wajahat has expressed concern over the issue and directed all the judicial officers to identify compoundable criminal cases and refer the same to the Lok Adalat tomorrow.

He has also warned the judicial officers about such administrative lapses in future. "All compoundable criminal matters listed in tomorrow's regular cause list are to be taken up with 'due seriousness' with efforts to explore reconciliation during the court proceedings," he remarked.

## Defence Atmanirbharta: Record Production And Exports

ndia's indigenous defence production hit a record 1,27,434 crore in FY 2023-24, a **▲** 174% surge from 46,429 crore in 2014-15, fueled by Prime Minister Shri Narendra Modi's Atmanirbharta policies. The upward trajectory in defence production is the result of continued government support over the past decade in the form of huge allocation and policy level support extended to India s military industrial base. The rise in the defence budget, from 2.53 lakh crore in 2013-14 to 6.81 lakh crore in 2025-26, underlines the government s determination to strengthen country s military infrastructure. In order to reduce dependency on foreign countries, both public and private segments of the industry have demonstrated consistent yearon-year growth, attributed to far-reaching policy reforms, enhanced ease of doing business, and a strategic focus on indigenisation over the past decade. India now exports to over 100 nations, including to United States, France and Armenia. Defence Public Sector Undertakings (DPSUs) and other PSUs accounted for approx. 77% of total production, while the private sector contributed 23%. The share of the private sector, which increased from 21% in FY 2023-24 to 23% in FY 2024-25, reflects the sector's growing role in the defence ecosystem of the country. As a result, exports too saw a growth of Rs 2,539 crore or 12.04% over the exports figures of FY 2023-24. The government aims to achieve defence manufacturing worth Rs. 3 lakh crore and 50,000 crore in defence exports by 2029, reinforcing India's role as a global defence manufacturing hub while boosting economic growth. Therefore, India's defence production sector is poised for continued acceleration in the years ahead, making the

country Atmanirbhar. Challenges Before Policy Reforms

Prior to the policy reforms initiated un-der the government of Prime Minister Shri Narendra Modi during the last decade, India s defence sector faced significant bottlenecks. Procurement processes were slow, resulting in critical canability gans Dependence or imports was high, straining foreign exchange reserves and exposing vulnerabilities during global disruptions. Earlier, private sector participation was limited due to restrictive policies, dominance of defence PSUs, and lack of technology access. Defence exports were not that high, valued at only 686 crore in FY 2013 14, positioning India primarily as an importer rather than a producer in the global defence market. To meet these challenges, the Ministry of Defence s draft Defence Production & Export Promotion Policy (DPEPP) sets the compass for making India a top global defence manufacturer by encouraging R&D, rewarding innovation and IP creation, promoting industry-academia linkages, supporting MSMEs and setting export ambitions. The policy stitches together production, technology, and market access into one roadmap.

#### Objectives of Reforms

Anchored in the vision of Aatmanirbhar Bharat, the Government launched a series of reforms to build a self-reliant, globally competitive defence industry. The key objectives include:

Faster procurement through streamlined Defence Acquisition Procedures (DAP), followed by DAC (Defence Acquisition Council), giving nod for acquisitions.

Indian First Approach: The policy gives top priority to the Buy {Indian-IDDM (Indigenously Designed, Developed and Manufactured)} category, promoting systems designed, developed, and manufactured indigenously, thereby making the country self-reliant.

Speed with Transparency: Simplified approval processes and digital integration have accelerated procurement timelines while enhancing accountability.

Technology of Tomorrow: The DAP 2020 includes dedicated provisions for acquiring cutting-edge technologies like AI, robotics, cyber, space, and advanced warfare system to enable multi-domain operations.

Industry as Partner: It promotes a collaborative ecosystem involving private sector companies, start-ups, and MSMEs through initiatives such as Innovations for Defence Excellence (iDEX) and relaxed licensing norms.

Ease of Approvals: Procedural bottlenecks have been removed through streamlined frameworks and empowered acquisition wings, ensuring timely decision-making.

#### DPM 2025: Streamlining Revenue Procurement

Building upon the DAP framework, the Defence Procurement Manual (DPM) 2025 was launched by Raksha Mantri Shri Rajnath Singh on October 2025, representing a major leap towards simplifying the procedures, bring uniformity in functioning. It will be helpful in providing goods and services required by the Armed Forces for operational preparedness, worth approximately 1 lakh crore. Effective, 1 November 2025, DPM 2025 introduces industry-friendly reforms aimed at ensuring fairness, transparency, accountability in procurement and participation from domestic enterprises.

Key highlights include: Ease of Doing Business, which entails standardized procedures across all Armed Forces and MoD organizations to reduce delays; Support for Innovation and Indigenisation, fostering collaboration with industry and academia; Industry-friendly provisions, such as lower liquidated damages (0.1% per week for indigenisation projects), guaranteed orders for indigenous products for up to five years, and the removal of the outdated No Objection Certificate from erstwhile Ordnance Factory Board; and Digital Integration and Transparency, which have led to improved e-procurement systems and data-driven monitoring, ensuring accountability and efficiency in procurement processes.

#### 4. Opening New Horizons - Investment Opportunities:

India has emerged as one of the most attractive destinations for defence investment. With 788 industrial licenses issued to 462 companies, the participation of Indian industry in defence manufacturing is growing rapidly. The Department of Defence Production has streamlined business through a fully digital portal for export authorizations, leading to 1,762 approvals in FY 2024 25, compared to 1,507 in FY 2023-24, marking a 16.92% year-on-year growth and a 17.4% increase in the number of exporters. Combined with liberalized FDI norms, the PLI scheme, and modern defence corridors, India offers a compelling opportunity for both domestic innovators and global investors.

In 2024-25, the Ministry of Defence signed a record 193 contracts valued at 2,09,050 crore, marking the highest ever in a single financial year. Of these, 177 contracts, worth

1,68,922 crore, were awarded to the domestic industry, reflecting a decisive shift toward Indian manufacturers and a strengthened indigenous defence ecosystem. This emphasis on local procurement has also spurred employment generation and technological innovation across the sector.

India s approach ensures that every procurement strengthens national industry, reduces import dependency, and enhances operational preparedness.

#### Rising Acquisition Budget and Decadal Growth

The Defence Acquisition Council (DAC), chaired by the Raksha Mantri, has approved record volumes of indigenous procurements in recent years. Modernisation and indigenization of the Armed Forces remain a key priority of the Government. In the Union Budget 2024-25, an allocation of 1.72 lakh crore has been made under the Capital Head for the Defence Services, reflecting a 20.33% increase over the actual expenditure of FY 2022-23 and a 9.40% compared to the Revised Estimates of FY 2023-24.

In March 2025, the DAC approved eight capital acquisition proposals worth over 54,000 crore, including the 1,350 HP engines for T-90 tanks and indigenously developed Varunastra torpedoes and Airborne

In July 2025, the DAC cleared 10 capital acquisition proposals valued at approximately 1.05 lakh crore including Armoured Recovery Vehicles, Electronic Warfare System, Integrated Common Inventory Management System for the Tri-Services, Surface-to-Air Missiles, Moored Mines, Mine Counter Measure Vessels, Super Rapid Gun Mount, and Submersible Autonomous Vessels. All items approved are indigenous under the Buy (Indian-IDDM) category, emphasizing indigenously designed, developed,

and manufactured systems.

In August 2025, the DAC approved proposals worth 67,000 crore to enhance the operational capabilities of the Armed Forces. Key approvals included Thermal Imagerbased Night Sights for BMPs for the Army, Compact Autonomous Surface Craft, BrahMos Fire Control Systems, and BARAK-1 upgrades for the Navy, and Mountain Radars along with SAKSHAM/SPYDER upgrades for the Air Force. The DAC also cleared indigenous Medium Altitude Long Endurance (MALE) RPAs for all three Services, and maintenance support for C-17, C-130J, and S-400 systems.

Continuing the momentum, in October 2025, the DAC approved procurement proposals worth approximately 79,000 crore for the Army, Navy, and Air Force, reinforcing the Government s sustained commitment to capability enhancement and self-reliance across all domains of national defence. A key indigenous highlight being the Advanced Light Weight Torpedoes (ALWT) developed by DRDO's Naval Science & Technological Laboratory for the Navy. The other approvals include the Nag Missile System (Tracked) Mk-II (NAMIS), Ground Based Mobile ELINT System (GBMES) and High Mobility Vehicles (HMVs) for the Army; Landing Platform Docks, and 30mm Naval Surface Guns for the Navy; and the Collaborative Long Range Target Saturation/ Destruction System for the Air Force.

#### A New Export Story: Numbers That Speak

What was once a trickle is now a steady stream: India's defence exports reached a record 23,622 crore in FY 2024 25 registering a 12.04% growth over FY 2023 24 s 21,083 crore. Private sector exports contributed

15,233 crore, while DPSUs accounted for 8,389 crore, whereas the corresponding figures for FY 2023-24 were Rs 15,209 crore and Rs 5,874 crore respectively. In a major boost to defence exports, India has supplied a wide spectrum of products - including ammunition, arms, sub-systems, complete systems, and critical components - to around 80 countries during the 2024-25, reaffirming its role as a reliable partner in the global defence supply chain. The Defence Public Sector Undertakings (DPSUs) have shown a

significant increase of 42.85% in their exports in the FY 2024-25 reflecting the growing acceptability of Indian products in the global market and the ability of the Indian defence industry to be a part of the global supply chain.

India s expanding export basket, supplied to friendly countries, is an instrument of outreach, seen in defence cooperation, logistics support, training and spares packages that accompany sales. The widening list of importers signals growing global confidence in Indian platforms.

#### Successful Indigenous Platforms & the Export Basket

India s exports today are broad and practical, from bulletproof jackets, patrol boats and helicopters, to radars and lightweight torpedoes, showcasing the depth and diversity of India s defence manufacturing. While combat aircraft programmes like Tejas continue on the path to operational maturity and export discussions, India s current strength lies in a wide range of proven, operational systems and components.

#### Conclusion

India s strategic collaborations and bold policy initiatives are not just reforms; they represent the foundation of a new era in defence self-reliance and technological sovereignty. With domestic production and exports poised for remarkable growth, and cutting-edge technologies steadily integrating into the industrial ecosystem, the vision of India as a global defence manufacturing hub is no longer a distant aspiration, it is unfolding before us.

India has achieved the highest-ever growth in indigenous defence production in value terms, reflecting the success of government initiatives such as the Atmanirbhar Bharat Abhiyan, positive indigenisation lists, and strategic partnerships with the private sector. The emphasis on Make in India and the creation of a robust R&D and start-up ecosystem have further accelerated this transformation.

From the establishment of Defence Industrial Corridors to the expansion of export facilitation, every measure underscore India s commitment to reducing import dependency and promoting indigenous capabilities. #### Bandipora admin intensifies crackdown on illegal mining

BANDIPORA, NOVEMBER 21: The district administration Bandipora, in coordination with Police and the Mining Department, has tightened enforcement against illegal mining and unauthorized mineral transportation across the district, resulting in multiple seizures and strict legal action.

Johannesburg, Nov 21: Prime Minister Narendra Modi arrived in Johannesburg on Friday to attend the G20 Leaders' Summit being held under South Africa's Presidency.

Modi arrived at Waterkloof Air Force Base (AFB) in Gauteng, where he was accorded a traditional welcome. He was greeted by artists who performed cultural song and dances.

"Landed in Johannesburg for the G20 Summit related engagements. Look forward to productive discussions with world leaders on key global issues. Our focus will be on strengthening cooperation, advancing development priorities and ensuring a better future for all," Modi said in a social media post.

This is the first G20 Summit being held in Africa. The African Union became a member of the G20 during India's presidency in

On the margins of the summit, the prime minister is expected to hold bilateral meetings with some of the leaders present in Johannesburg. He will also attend the 6th summit of IBSA - a trilateral grouping of India, Brazil and South Africa.

"Will be attending the G20 Summit in Johannesburg, South Africa. This is a particularly special Summit as it is being held in Africa. Various global issues



will be discussed there. Will be meeting various world leaders during the Summit," Modi posted on social media before departure.

<sup>"</sup>I will present India's perspective at the Summit in line with our vision of 'Vasudhaiva Kutumbakam' and 'One earth, One Family and One Future," Modi said.

The Summit will be an opportunity to discuss key global issues. The theme of this year's G20 has been 'Solidarity, Equality and Sustainability', by which South Africa has carried forward the outcomes from the previous Summits held in New

Delhi and Rio de Janeiro, Brazil, he added.

"I look forward to my interactions with leaders of the partner countries, and participation in the 6th IBSA Summit scheduled on the sidelines of the Summit," Modi said.

"During the visit, I also look forward to my interaction with the Indian diaspora in South Africa, which is one of the largest outside India," he added.

Prime Minister Modi is expected to speak in all three sessions of the G20 Summit.

The three sessions of the Summit include "Inclusive and Sustainable Economic Growth Leaving No One Behind: Building our economies, the role of trade, financing for development and the debt burden".

The other two sessions are "A Resilient World – the G20's Contribution: Disaster Risk Reduction, Climate Change, Just Energy Transitions, Food Systems"; and "A Fair and a Just Future for All: Critical Minerals, Decent Work, Artificial Intelligence".

This will be the fourth consecutive summit of the grouping that will be held in the Global South. US President Donald Trump and Chinese President Xi Jinping are not attending the summit.

#### Overwhelmed CJI Gavai bids adieu, says he is leaving SC with full sense of satisfaction

New Delhi, Nov Overwhelmed by rich tributes on his last working day, Chief Justice of India Bhushan Ramkrishna Gavai on Friday said he was leaving the institution "with a full sense of satisfaction and contentment" and as a "student of justice" on concluding four decades of journey as a lawyer and a judge.

In another farewell function held by the Supreme Court Bar Association (SCBA) in the evening, the 52nd CJI recalled the ire that he faced from his own community for one of his judgments in which it was held that the creamy layers among the Scheduled Castes (SCs) can also be denied the reservation benefits in admissions and jobs.

"Being an ardent student of the Constitution, the virtues of equality, justice, liberty and fraternity were always close to my heart," he said.

The CJI, who would demit office on November 23, a Sunday, justified his recent landmark verdict quashing key provisions of the 2021 Tribunals Reforms law saying independence of the judiciary is the basic structure of the Constitution and freedom of tribunals cannot be compromised.

Recalling his journey from a humble background and lesserknown place at Amravati to the top court, CJI Gavai, the first Buddhist and second Dalit head of the Indian judiciary after K G Balakrishnan said that the Constitution and the values of his parents made it possible.

"I am very satisfied with the journey which started 40 years ago," the CJI said, while recalling the incidents and cases which he dealt with in his career.

"I made an example of how a son of a senior IAS officer studying in Delhi at a premier school can be made to compete with the son of an agriculturist. My law clerk, whose father is a senior IAS officer, said from now on he will not take any benefit given to the Scheduled Castes. That young boy understood what politicians fail to understand for reasons best known to him," he said.

CJI-designate Justice Surya Kant will succeed Justice Gavai on November 24.

Justice Surya Kant was effusive in his praise for the outgoing CJI and termed him "more than a colleague" and "brother".

"He was more than a colleague... he was my brother and a confidant, and a man of immense integrity," Justice Surya Kant said in the forenoon in the proceedings of the ceremonial bench.

"He handled cases with patience and dignity. He encouraged young lawyers. His firmness was always laced with humour... Not a single day went by when he didn't threaten an insistent lawyer with costs but he never imposed one," he said.

During the farewell proceedings in the forenoon before the ceremonial bench that also comprised CJI-designate Surya Kant and Justice K Vinod Chandran, the CJI said, "After listening to all of you, and particularly the poems of Attorney General (R Venkataramani) and Kapil Sibal and the warm sentiments expressed by all of you, my voice is choking with emotions."

"When I leave this courtroom for the last time..., I leave this court all with full sense of satisfaction, the full sense of contentment that I have done whatever which I could have done for this country... Thank you. Thank you very much," a visibly emotional Gavai said in the courtroom packed with law officers, senior advocates and young lawyers.

The proceedings saw colleagues reminiscing the imprint Justice Gavai, the second Dalit after K G Balakrishnan and the first Buddhist CJI, left on the judiciary.

"I always believe that everybody, every judge, every lawyer, is governed by the principles on which our Constitution works that is equality, justice, liberty and fraternity and I tried to discharge my duties within the four corners of the Constitution that is so dear to all of us," he said.

Justice Gavai, who was sworn in on May 14 for over a sixmonth tenure as the CII, would demit office on November 23, a Sunday, and Friday was his last working day.

## Delhi blast: LG Saxena issues slew of directions

Cops to maintain record of ammonium nitrate buyers, sellers

New Delhi, Nov 21: Delhi LG V K Saxena has directed police to maintain a digital record of entities purchasing and selling ammonium nitrate beyond a certain limit and to undertake rigorous security audits of busy markets and ISBTs, days after a blast near the Red Fort claimed 15 lives.

The directions, which were issued in separate written communications to the police commissioner and the chief secretary on November 19, are part of a slew of "precautionary and preventive" measures ordered by the Lt Governor.

Saxena asked the police to maintain a digital record of entities purchasing and selling ammonium nitrate beyond a certain threshold.

The record should include photographs of buyers and sellers, apart from other relevant details.

Police have also been instructed to hold a consultation exercise with heads of social media platforms, including Meta and X, for a scientific tracking of radicalised content aimed a brainwashing citizens.

"The police commissioner has also been asked to strengthen human and technical intelligence with a focus on vulnerable areas prone to radicalisation.



citizen engagement should also be enhanced for more robust preventive policing," a Raj Niwas official said, citing the communications.

Saxena also directed police to conduct a rigorous security audit of busy markets and ISBTs to track CCTV camera coverage and deployment of security personnel.

The administration has been asked to create a central data repository, containing records of doctors and para-medical staff engaged by hospitals, especially private facilities, medical degrees.

"In cases where medical professionals have secured degrees from foreign countries, information should also be shared with the police department for secondary background checks," the official said.

They have also been asked to hold a consultation exercise with all digital platforms and financiers engaged in sale and purchase of vehicles, especially second-hand vehicles.

"Clear directions should be given that under no

## Nearly 30 pc women in India subject to intimate partner violence during lifetime: WHO

New Delhi, Nov 21: Over a fifth of women in India aged 15-49 were subjected to intimate partner violence in 2023, while nearly 30 per cent have been affected during their lifetime, according to a new global report by the World Health Organisation.

Nearly one in three around the world, or 840 million, have suffered partner or sexual violence during their lifetime a figure that has barely changed since 2000, it said. Estimates also suggest that around the world, 8.4 per cent of women aged 15-49 have been subjected to sexual violence from

In India, about four per cent of women aged 15 and above are estimated to have suffered sexual violence from a non-partner.

"Violence against women is one of humanity's oldest and most pervasive injustices, yet still one of the least acted upon," said Dr Tedros Adhanom Ghebreyesus,

WHO Director-General. "No society can call itself fair, safe or healthy while half its population lives in fear. Ending this violence is not only a matter of policy; it is a matter of dignity, equality and human rights. Behind every statistic is a woman or girl whose life has been forever altered," Adhanom Ghebreyesus said. He also noted that empowering women and girls is not optional, it's a prerequisite for peace, development and health. A safer world for women is a better



world for everyone.

'The estimates presented in this report demonstrate unequivocally that violence against women remains pervasive globally, affecting women across all countries and regions," authors said in the report published ahead of the "International day for the elimination of violence against women and girls" observed on 25 November. Progress is too slow and achieving the Sustainable Development Goal of eliminating all forms of violence against women and girls by 2030 "remains elusive", they said. Looking at 168 countries, the report is a "comprehensive review of prevalence data from surveys and studies conducted between 2000 and 2023". It updates the 2018 estimates released in 2021.

The report also noted a decline in funds allocated for initiatives aimed to prevent violence against

women, at a time when humanitarian crises and environmental disasters such as extreme weather events are increasing risks of vio-

lence against women. For instance, in 2022, only 0.2 per cent of the global development aid was allocated to programmes focused on the prevention of violence against women, and funding has further fallen in 2025, it said.

The authors urged the world to accelerate progress and deliver a meaningful change through decisive government action and funding. They called for a scaleup of evidence-based prevention programmes and strengthening of survivor-centred health, legal and social services.

The team also suggested an investment in data systems to track progress and reach the most at-risk groups, and enforcing laws and policies that empower women

#### SC seeks EC's response on fresh pleas challenging SIR exercise in Kerala, other states



New Delhi, Nov 21: The Supreme Court on Friday agreed to hear a batch of pleas challenging the Election Commission's decision to conduct Special Intensive Revision (ŜIR) exercise in Kerala, Uttar Pradesh and other states.

A bench of Justices Surya Kant, SVN Bhatti and Joymalya Bagchi issued notice to the Election Commission on all the fresh petitions filed by different political leaders, challenging SIR exercises in differ-

ent states on different grounds. Senior advocate Kapil Sibal, appearing for a petitioner challenging SIR exercise in Kerala, submitted that local body elections are also scheduled to be

held in the state and, therefore, there is some urgency involved in the matter.

The bench directed the pleas challenging SIR exercise in Kerala will be listed on November 26 and rest of the petitions challenging electoral roll revision exercise in other states will be taken up for hearing in the first or second week of December. The top court is already hearing a batch of pleas challenging the validity of the Election Commission's decision to conduct pan-India SIR exercise. On November 11, the top court sought separate responses of the poll panel on pleas filed by DMK, CPI(M), West Bengal Congress and Trinamool Congress leaders challenging the SIR of the electoral rolls in Tamil Nadu and West Bengal respectively.

The minister is here to hold bilateral trade talks with his Israeli counterpart Nir Barkat. Goyal is leading a 60-member business delegation here.

New deep-sea 'Octopus

Squid' discovered in

**Arabian Sea** 

tral Marine Fisheries Research Institute (CM-FRI) have discovered a new species of deep-sea squid from the Arabian Sea.

This marks the second confirmed species of the globally rare genus Taningia.

The species, scientifically named Taningia silasii (Indian octopus squid), has been formally described in the international journal Marine Biodiversity, a CMFRI statement said here on Friday.

The specimen was collected from nearly 390 metres depth off the Kollam coast. Measuring 45 cm in length (dorsal mantle

length), the squid belongs to the family Octopoteuthidae, whose adults are known for their distinctive absence of tentacles, though they are true deep-sea squids, it said.

The research was led by Dr Geetha Sasikumar, Principal Scientist and Dr Sajikumar K K, Tech-

"We have been studying cephalopods in the Arabian Sea for more than a decade, and this 'octopus squid' was something we had never encountered," said Dr Geetha Sasikumar.

Until now, Taningia danae—found in Atlantic waters—was the only known species in this genus. "Previously, squids of the genus Taningia were

considered monotypic. DNA barcoding showed more than 11% genetic divergence from the Atlantic species, confirming the specimen as a distinct species", she added.

Explaining the unusual features of this genus, Dr Sajikumar said, although called the 'octopus squid', it is in fact a squid that possesses only eight arms and lacks the two long tentacles typically seen in other squid species.

"Members of this family can also attain large sizes, with the Atlantic species growing up to 2.3 metres (7.5 feet) in length and weighing approximately 61.4 kg," he said.

The species has been named in honour of legendary marine biologist Dr E G Silas, former Director of CMFRI and former Vice Chancellor of Kerala Agriculture University and a pioneer of cephalopod research in India, the statement

The research scholars, Dr Shijin Ameri and Toji Thomas of CMFRI, were also part of the team.

Nearly 400 different species of squids have been described worldwide, inhabiting a wide range of oceanic environments—from shallow coastal regions to deep-sea trenches, the state-

New Delhi, Nov 21: A stroke occurs when oxygen supply to the brain is partially blocked. Death or paralysis can occur in minutes, if medical help is not provided, which is why strokes are a medical emergency, that require immediate attention. However, while some strokes strike out of the blue, most of them build up over a period of months, and come with some warning symptoms. Early detection of these warning signs enables patients to receive preventive treatment for stroke development, and prevent paralysis, or even death. Here are 5 warning signs that can occur a month or months before a stroke...

#### Severe and persistent headaches

The first indicator of stroke development, includes unusual headaches which differ from your typical headaches. These headaches will either appear without warning, or will become more severe and longer-lasting, than your typical headaches. The headaches persist beyond standard



pain medication treatment, while patients experience dizziness, nausea and even vision problems. This occurs because the brain shows signs of pressure changes and bleeding, which need immediate medical intervention.

When you experience headaches that differ from your previous experiences (or are new headaches), and they persist for extended periods of time, you should seek immediate medical help. Your brain sends these headaches as warning signals which indicate potential stroke risk, when left untreated. Research indicates that stroke patients frequently experience headaches during the time period leading up to their stroke occurrence.

Sudden weakness or numbness that affects one side of the body A warning sign that requires

immediate attention is when you experience weakness or numbness in your face, arms or legs which affects only one side of your body. The weakness in your body may start slowly, or it may appear and disappear at random times. This occurs because the brain area responsible for movement and sensation experiences decreased blood flow, which results in this condition. The weakness symptoms might be so faint that you fail to recognise their severity.

Speech difficulties Stroke patients experience speech difficulties and word comprehension problems, as their first signs before the actual stroke occurs. Your speech becomes unclear while you struggle to choose words, and you experience difficulty understanding basic sentences. This occurs because the brain area which handles language functions, does not receive

sufficient oxygen supply. Sudden vision problems or

complete vision loss The occurrence of sudden vision problems including blurred vision, double vision and partial vision loss indicates a possible stroke. This occurs because the brain area which controls vision, becomes affected when a stroke occurs. Sometimes you might see flashing lights, lose part of your visual field, or have difficulty focusing with one or both eyes.

Any unexplained vision changes that persist for more than a few hours or days, require you to seek medical help immediately. The symptoms you are experiencing might be related to transient ischemic attacks (TIAs) or ministrokes, which occur before a full stroke. Research indicates that vision problems serve as a frequent early indicator of stroke.

**Dizziness and loss of balance** Brain problems that occur before a stroke will cause dizziness, balance issues and walking difficulties. The brain regions which control balance and coordination, experience reduced blood flow and small blockages that produce these symptoms. Your body becomes unstable while you experience vertigo, and your foot movement becomes difficult during walking. **Prevention tips for stroke** 

The prevention of many strokes depends on basic health maintenance practices. Keeping your Blood Pressure in control, stands as the primary prevention measure, because regular medical check-ups and prescribed medications work to reduce your chances of getting a stroke. Your heart and brain stay protected through the consumption of healthy foods, which include fruits, vegetables, fish and whole grains, that are low in salt and fats. Your blood vessels will become healthier when you exercise for at least 30 minutes daily. and stop smoking, and reduce your alcohol consumption.

## S Africa says not to hand over G20 baton to 'junior official' amid spat with US

Johannesburg, Nov 21: South Africa has decided not to hand over the annual G20 Presidency to a "junior" US official at the end of the leaders' summit, even as a White House official cautions Cyril Ramaphosa over "running his mouth" against the US and President Donald Trump.

South African President Ramaphosa adopted a reconciliatory approach on Thursday evening after the US requested accreditation for an eight-member team led by US chargé d'affaires, Marc Dillard, to receive the baton on Sunday.

However, late on Thursday evening, Ramaphosa's spokes-man, Vincent Magwenya, posted a message on social media, saying the president will not hand over the G20 Presidency to a junior official. "The President will not hand over to a chargé d'affaires. It's a breach of established



government anywhere in the world would do it," Magwenya told local media.

There was also anger in South Africa about remarks by White House Press Secretary Karoline Leavitt, which analysts said was a breach of protocol in insulting the President.

"I saw the South African president running his mouth a little bit against the United States and Donald Trump earlier today, and that language is not appreciated by the

itt said in a media briefing on Thursday after Ramaphosa had taken a hard line at the US absence without naming

Trump directly. There is also dissatisfaction in South Africa about Trump continuing his claims of alleged genocide against white farmers in South Africa, which have been disproved by both the South African government

and local white leaders. "I'm not going to South Africa for the G20 because

I think their policies on the extermination of people are unacceptable. So I'm not going. South Africa has behaved extremely badly,' Trump said after a meeting with Crown Prince and Prime Minister Mohammed bin Salman of Saudi Arabia at the White House on Tuesday.

Leavitt confirmed in her briefing on Thursday that the delegation would be present only to receive the G20 Presidency from South Africa at the end of the summit. She also reaffirmed that the US would not be participating in the deliberations at the G20.

But the South African view now is that the US is trying to save face to avoid Ramaphosa's earlier suggestion that, in the absence of any US representative, he would hand over the Presidency to an empty chair.

Many world leaders have started arriving in South Africa since yesterday to attend the two-day Summit.

## Singapore imposes sanctions, entry bans on four Israeli **West Bank settlers**

Singapore, Nov 21: Singapore will impose financial sanctions on four Israelis and bar them from entering the city-state, its foreign affairs ministry announced on Friday, accusing them of "egregious acts of extreme violence" against Pales-tinians in the West Bank.

The ministry said actions committed in the West Bank by Meir Mordechai Ettinger, Elisha Yered, Ben-Zion Gopstein and Baruch Marzel were unlawful and had jeopardized the prospects for a two-state solution in Palestine. "As a firm supporter of international law and the two-state solution, Singapore opposes any unilateral attempts to change facts on the ground through acts which are illegal under international law," it said.

All four individuals have been previously sanctioned by the European Union.

He also chided Israeli politicians who had spoken about annexing parts of the West Bank or Gaza, the two Israeli-occupied Palestini-an territories, and said the so-called E1 settlement project would fragment the West Bank. Apart from imposing sanctions, Balakrishnan said Singapore would also recognize a Palestine state under the right national community considers Israeli settlements in the West Bank illegal under international law. Israel disputes this, citing historical and biblical ties to the area and saying the settlements provide security.

While Singapore and Israel have shared close diplomatic and military ties since the former gained independence in 1965, the city-state in 2024 voted in favor of numerous resolutions expressing support for the UN recognition of a Palestinian state.

#### Death toll in Bangladesh earthquake rises to 6



Dhaka, Nov 21: At least six people were killed and several injured as a massive earthquake of magnitude 5.7 jolted Dhaka and parts of the country on Friday, damaging buildings, causing fires at several places and sending panic among residents.

Three people were killed in Dhaka, while the fourth died in the suburban river port town of Narayangani, officials said, as local media reported injuries to at least 50 people across the country.

The other two deaths w reported from Narsingdi, where the epicentre was located some 10 kilometres beneath the surface.

The epicentre of the quake that struck at 10:38 am (local time) was at Narsigndi on the

northeastern outskirts of Dhaka at a depth of 10 kilometres, Bangladesh's meteorology department said. The place is around 13 kilometres east of the seismic centre in Dhaka's Agargaon area. Dhaka's deputy police commissioner Mallik Ahsan Uddin Sami said, quoting the fire service, that at least three people were killed after a railing, bamboo scaffolding and debris of a five-storey building fell on them at Old Dhaka's Armanitola area.

A bystander was critically wounded at the scene in the crowded neighbourhood, he said.

Sami confirmed that one of the deceased was a medical student who was there to buy meat along with his mother. She is critically wounded, requiring an emergency surgery, he added.

## **BCCI** invites application for head of education post at COE

New Delhi, Nov 21: The BCCI on Friday invited applications for the post of head of cricket education at the board's Centre of Excellence (COE) in Bengaluru after former India opener Sujith Somasunder relinquished the position to contest in the Karnataka State Cricket Association (KSCA) polls.

The full-time position is central to BCCI's long-term vision of developing a world-class cricket education system that supports coaches, athletes, state academies and high-performance programs across the country. The head of cricket education will oversee the design, delivery and continuous advancement of cricket and sports-science education at the COE.

Somasunder, who was holding the same position at the erstwhile National Cricket Academy (NCA) since his recently to contest in the upcoming KSCA elections as part of the faction led by former Îndia seamer Venkatesh Prasad.

Both Prasad and Somasunder



were earlier part of the KSCA administration when the legendary Anil Kumble and Javagal Srinath had served as president and secretary.

The head of cricket education is responsible for administering all aspects of coach education, accreditation and curriculum development at the COE, including planning, implementing and reviewing all coaching courses, including Level A, B and C programmes, and conducting and coordinating nationwide refresher courses for coaches.

The role will also involve sing modern performance-analysis tools such as athlete-management systems, video analytics, GPS and wearable technology to derive actionable game insights, collaborating with the head of cricket, COE on online education initiatives and the development of advanced coaching modules.

It also entails managing the re-accreditation process for coaches and ensuring worldclass documentation of coaching content, working with BCCI's umpires panel and head curator on educational seminars, exami-nations and specialised training interventions.

The new appointee will also be responsible for supporting coach-intake processes for COF Zonal Cricket Academies and specialist camps, assessing suspect bowling actions referred to the COE and presenting findings to relevant committees.

#### **Security Council recommends** army deployment during general polls in Nepal



Kathmandu, Nov 21: The National Security Council of Nepal has recommended mobilising army personnel to ensure security during the general election scheduled for March 5, 2026.

The National Security Council (NSC) reviewed the country's security situation on Thursday and advised the Cabinet to deploy the army under the provisions of Nepal's Constitution.

Recommendations were made with an aim to conduct the upcoming election in a "free, fair and fearless manner," according to a statement by Defence Secretary Suman Raj Aryal, who is also a member secretary of the NSC.

The Ministry of Home Affairs

has already approved an integrated security plan for the elections and circulated it to all 77 district administration offices for implementation.

Under the plan, each district will prepare its own security strategy, deploying personnel from the Nepal Army, Nepal Police, Armed Police Force, National Investigation Department and temporary police at every polling location.

The elections have been necessitated following the ouster of prime minister K P Sharma Oli on September 9, after demonstrations by Gen Z protesting corruption and demanding lifting of a ban on social media turned violent, leading to the death of 76 people in two days.

## **One-off Test 'not best** scenario' for captaincy: Pant

Guwahati, Nov 21: Rishabh Pant admitted that leading India in a one-off Test is "not the best scenario", but the wicketkeeper-batter said he does not want to "overthink" the challenge and instead focus on combining conventional captaincy with "out-of-the-box" ideas as he prepares to debut as India's 38th Test skipper in the second match against South Africa starting here on Saturday.

Pant will lead the side after regular captain Shubman Gill was ruled out with a neck injury.

"Definitely, one-off match is not the best scenario as a captain. But at the same time, I'm really proud that BCCI has given me this opportunity. You know, whenever you're leading your country, it's the proudest moment," he said at the pre-match press conference.

As the discussion turned to his leadership style, the player from Roorkee said he wants a mix of the old and the new. "I think being conventional also helps. And also adding that outside (out-of) the box thinking definitely works out. So, you're going to find, for me, it's all about finding that balance between a conventional and outof-the-box thinking," Pant said as he braced for a tough battle against the Proteas, who already hold an unassailable 2-0 lead in

A key task, he said, would be giving players the freedom to express



themselves. "To generalise, I want to be someone who gives that freedom and I want people and players to learn around and make the right decision for the team eventually," he explained. "That's the real goal and obviously whatever my knowledge is, that's going to help them on the field."Asked whether he could retain his free-spirited nature while taking big decisions, Pant said it was not particularly

"And for the free spirit part of the thing, see, I personally don't think about that. I just want to give my 100 per cent in whatever I'm doing and enjoy the game," he said emphatically.

Pant revealed that he was officially asked to take over the captaincy on Thursday night. When asked if he had spoken to Gill, he responded with a trademark cheeky line, "I speak to Gill every day," he laughed. Comebacks

Pant conceded that bouncing back in a two-match series is difficult.

"It is always good to have more matches because you can come back from it. When you have a twomatch series, it's harder because the pressure is all the more if you lose the first match. But at the same time, you know, these are the things which we can't control as a

Captaincy, Pant agreed, is never a bed of roses. He faced probing questions about his tactical calls on the third day of the first Test when he stood in for an injured Gill. On a deteriorating pitch with variable bounce, he did not use Mohammed Siraj and Jasprit Bumrah early on, opting instead for spinners — a phase in which Temba Bavuma scored a crucial fifty and South Africa added significant runs.




