Srinagar, Nov 25: Three recently elected Rajva Sabha members from National Conference will take oath on December 1, the opening day of the Winter Session of the Parliament.

According to the details available with the news agency—Kashmir News Observer (KNO) three MPs, Shammi Oberoi, Sajjad Ahmad Kichloo, and Chowdhary Mohammad Ramzan will be administered the oath by Vice-President and Rajya Sabha Chairman C P Radhakrishnan.

The oath ceremony would mark the return of Rajya Sabha representation for Jammu and Kashmir after a gap of nearly five years. The leaders were elected last

month in the maiden Rajya Sabha



polls in the Union Territory since the reorganization of the erstwhile state and the abrogation of Article 370 in 2019.

The polls were held for four seats of which NC won three, while the BJP secured one seat, with its candidate Sat Sharma having already taken the oath.

Ramzan is a former minister and MLA who has served multiple terms in the Jammu and Kashmir Assembly

Sajjad Ahmad Kichloo is also a former minister from Kishtwar, and Shammi Oberoi, the party treasurer, will join the Upper House representing

The previous Rajya Sabha members from Jammu and Kashmir completed their sixyear terms on February 2, 2021. These members included Ghulam Nabi Azad (INC), Nazir Ahmad Laway (PDP), Fayaz Ahmad Mir (PDP), and Shamsher Singh Manhas (BJP).

Their seats remained vacant as Jammu and Kashmir did not have an elected legislative assembly, which is required under Article 80 of the Constitution and the Representation of the People Act, 1951 for conducting biennial elections to the Upper House.

The elections and oath-taking mark the significant step in restoring Jammu and Kashmir's representation in Parliament following the changes to its political structure.

Custodial violence and death a blot on system, country will not tolerate this: Supreme Court

New Delhi. Nov 25: The Supreme Court on Tuesday said custodial violence and death is a "blot "on the system, and the country will not tolerate this.

While hearing a suo motu case concerning lack of functional CCTVs in police stations, a bench of Justices Vikram Nath and Sandeep Mehta referred to its order passed in the matter and said 11 deaths were reported in police custody in eight months in Rajasthan.

"Now this country will not tolerate this. This is a blot on the system. You can't have deaths in custody," the bench said.

Solicitor General Tushar Mehta said nobody can even justify or attempt to justify custodial deaths. The bench also questioned the Centre as to why it has not filed compliance affidavit in the matter.

"The Union is taking this court very lightly.Why?" Justice

Nath asked. Mehta said he was not appearing in the suo motu matter but nobody can take the court

He said the Centre would file the compliance affidavit within



three weeks.

In September, the apex court had taken suo motu cognisance of a media report which stated that 11 lives were lost in police custody in Rajasthan in the first eight months of 2025, of which seven incidents occurred in the Udaipur division.

In a separate matter, the apex court had in 2018 ordered installation of CCTV cameras in police stations to check human rights abuses.

During the hearing on Tuesday, the bench also heard the submissions of senior advocate Siddhartha Dave, who is assisting the apex court as an amicus curiae in a separate matter in which the top court had passed an order in December 2020.

CS for accountability, speed to achieve power sector reforms

Reviews pace, progress of loss reduction, smart metering works

JAMMU, NOVEMBER 25: Chief Secretary, Atal Dulloo Tuesday undertook an in-depth review of the reforms being implemented by the Power Development Department (PDD) across Jammu and Kashmir with a focus on enhancing operational efficiency, strengthening infrastructure and substantially reducing power losses under the Re-vamped Distribution Sector Scheme

The review meeting was attended by Additional Chief Secretary, PDD; Managing Director, JPDCL/KPDCL; Chief Engineers of the Corporations; representatives of NTPC and PESL, besides other senior officers.

Emphasising the need for strict adherence to timelines, the Chief Secretary directed that all ongoing reform works aimed at loss reduction must be completed within the sunset period prescribed under RDSS by the Government of India.

He stressed on fixing daily and weekly targets for all components of loss reduction works, including LT cable replacement, augmentation and replacement of the distribution system, HT line cabling, replacement of HT conductors, feeder segregation

and installation of electric poles. He further underlined the importance of improving feeder-wise billing and revenue collection efficiency and called for stringent action against officials found negligent or lax in discharging their responsibilities. The Chief Secretary instructed the Divisional Commissioners of Jammu and Kashmir to conduct monthly reviews and identify field-level staff failing to perform responsibly.

To prevent delays during the harsh winter season, especially in snowbound and remote areas, the Chief Secretary underscored the need for advance dumping of essential material in difficult terrains to ensure uninterrupted execution of works despite road closures.

He also directed senior officers and Deputy Commissioners to maintain continuous oversight for timely resolution of bottlenecks and to keep the pace of implementation up to the mark.

The ACS PDD, Shailendra Kumar urged all Project Implementing Agencies (PIAs) to submit comprehensive action plans for accelerating progress on the ground. He encouraged parallel execution of multiple components immediately after the erection of electric poles and sought detailed information on transportation and delivery of materials to remote areas like Marwah, Wadwan, Gurez and Tanghdar.He also emphasised the need for immediate regularisation of illegal connections to augment government revenue and provide uninterrupted supply to consumers.

Sensitising PESL and NTPC, he called upon them to significantly accelerate their execution pace, assuring them of proportionate funding support once received by the Department from the Ministry of Power. He urged the agencies to clearly define milestones and adhere strictly to committed timelines. MD IPDCL. Gurpal Singh, in his detailed presentation, outlined the progress of loss reduction, modernisation and smart metering initiatives under Phase-I of RDSS. He informed that works worth

4.709 Cr under loss reduction and 1,053 Cr under smart metering are targeted for completion in this phase

He explained that works have been divided into multiple packages and awarded to four PIAs including JPDCL, KPDCL, PESL and NTPC for their com-

pletion within stipulated deadlines. The PIA-wise progress in Loss Reduction and IT/OT works stood at 74% for JPDCL, 73% for KPDCL, 57% and 33% for PESL in Kashmir and Jammu respectively, and 72% and 31% for NTPC in these divisions

The meeting was further informed that AT&C losses have already been reduced from 58% in 2022 to around 32% at present, with a target to bring them down to 12% by 2028. Similarly, the ACS-ARR gap has been reduced from 3.11 to 1.29, while billing efficiency has improved from 56% to 69% and collection efficiency from 75% to 94%, reflecting significant strides towards financial sustainability and operational efficiency in the power sector.

Regarding smart metering, it was disclosed that out of 7,62,872 meters to be installed by JPDCL, 1,87,894 have been installed so far, while KPDCL has installed 1,93,777 meters out of the targeted 7,27,855, marking steady progress towards a transparent and consumer-friendly power distribution mechanism across the districts of I&K

DC Budgam chairs meeting on SC rulings over stray dog menace

Directs strict safety measures in all educational, health institutions

NOVEMBER BUDGAM, 24: Deputy Commissioner (DC) Budgam, Dr. Bilal Mohi-Ud-Din Bhat, Tuesday convened a detailed review meeting of the District Level Committee (DLC), to assess the implementation of the directions issued by the Supreme Court of India regarding stray dog menace in educational and health institutions here in the New Conference Hall of DC Office Budgam.

As per the directives of the Supreme Court, the

Court has expressed grave that no delay, negligence, or concern over the threat posed by stray dogs to school children and has issued explicit directions to ensure the safety of students and staff within all educational premises.

During the meeting, the DC underscored that compliance with the Court's directions must be ensured in letter and spirit and emphasized that the safety and welfare of children is an absolute administrative priority. He remarked that matters under direct judicial monitoring require strict accountability and

procedural lapse would be tolerated. The DC reviewed the preparedness of all departments and directed that immediate administrative measures be taken across government and recognized private educational institutions.

Chief Education Officer was directed to nominate a Nodal Officer responsible for the sanitation, upkeep, and cleanliness of the institution.

The DC directed the CEO to ensure that no stray dogs enter or remain within school campuses and

must coordinate with local authorities wherever interventions are required.

During the meeting, the DC also issued a series of specific instructions to further strengthen the district-wide response to stray dog management. He directed the Municipal Committees of Budgam for construction of separate shelter sheds and quarantine centres for dogs and instructed immediate identification of suitable land parcels within one week. ensuring that the locations remain away from populat-

In case of middle classes upto 8th standard, Sharma said that the vacations shall be observed from December-01 to February-28.

It also said that the winter break for 9th to 12th standard shall commence from December-11 to February-22. SED also said that all Teaching faculty shall remain available for any academic activity during the vacation period.

'The Teaching staff shall report back to their respective schools on February-20-2026 for making arrangements regarding opening of schools," reads the order. SED

Dy CM advises MP Ruhullah to avoid street politics

Replying to a query on Ruhullah's resignation, Choudhary said if he has tendered the resignation, let him show the copy of his resignation. "If he (Ruhullah) wants to serve the people then he should meet the honourable Chief Minister to discuss the issues, rather than speaking on the streets," he added.

Pertinently, the estranged National Conference Lok Sabha MP Aga Syed Ruhullah Mehdi has asked his party-led government in Jammu and Kashmir to resolve the reservation issue before the winter session of Parliament ends, saying he will join the quota protests if no action is taken.

Moreover, Choudhary stated that there are no plans to increase the electricity tariff, saying that the rumours are media creation and far from the truth.

The Deputy Chief Minister while reacting to the controversy over the enrolment of Muslim community students in SMVDU, said, "The education must be kept away from politics, religion and other things. Students must get admissions on the basis of merit irrespective of the caste and religion."—(KNO)

SMC issues advisory on animal welfare

Srinagar, Nov 25: The Srinagar Municipal Corporation (SMC) on Tuesday issued a public advisory, urging residents and community representatives to ensure the humane feeding and care of street and community animals across the city, in line with the revised Animal Birth Control (ABC) Rules, 2023 notified by the Ministry of Fisheries, Animal Husbandry & Dairying. According to the notice, issued by the Municipal Veterinary Officer, the duty of arranging feeding spots and schedules now rests with Resident Welfare Associations, Mohalla Committees, Apartment Associations and recognized ani-

mal welfare activists. The notice states the civic body said such spots must be designated through mutual understanding and kept away from areas frequented by children or senior citizens, such as playgrounds, staircases and main entry or exit points.

The notice further reads that feeders must ensure no littering occurs at feeding locations and all activity should remain in conformity with guidelines framed by local committees.

Moreover, the designated feeders have been permitted to assist SMC teams in vaccination drives, animal catching and release operations under the Animal Birth Control programme. Calling upon citizens to extend voluntary support, the notice also said feeding community animals should be seen as "an act of compassion and shared civic responsibility."—(KNO)

Row over medical seats pits BJP against J&K minister

Jammu, Nov 25: Amid the controversy over admissions to the first MBBS batch at Mata Vaishno Devi Medical College, Jammu and Kashmir unit of Bharatiya Janata Party (BJP) President and newly elected Rajya Sabha member, Sat Sharma Tuesday said those supporting the Shrine Board should get seats, while the Health and Education Minister Sakina Itoo said that Muslim students face no restrictions and doctors treat all patients regardless of religion. Sharma said the BJP believes that those who contribute to Hinduism through donations to the Shrine Board should be considered for admissions.

"The institute is being run on the donations and contribution of the Shrine Board. Therefore, those having faith in the religion should get admission there," Sharma said. Sharma added that mistakes may have occurred in the admissions process but discussions with officials are ongoing. "Through Sunil ji, I also spoke to LG sir. This issue has come to his attention and I believe that soon a decision will be made so that the problems that our common people, our common society is facing, we can get rid of," he said. On the religious aspect



of the college, Sharma said, 'The people who have faith in their mind, because that institution is a symbol of faith, the people who come there for the darshan of Mata Vaishno Devi, majority are those people from Hindu religion who have faith in Mata Vaishno Devi. Similarly, people should get admission in this."

The controversy erupted after the first MBBS batch admissions allocated 42 of 50 seats to Muslim students purely based on merit.

Hindu groups have demanded minority status for the Shrine Board-run college, arguing that most donations come from Hindu pilgrims and should be reflected in seat allocation.

The administration has not yet announced any formal response regarding the demand for minority status or any revision of admission procedures. Meanwhile, Kashmir-based politicians strongly opposed the move, saying that admissions should not be based on religion. CS adds J&K's maiden digital Land Bank to PMGS platform

JAMMU, NOVEMBER 25: Chief Secretary, Atal Dulloo Tuesday launched the Land Bank layer on the PM Gati Shakti (PMGS) portal in presence of Commissioner Secretary, Forests; Principal Chief Conservator of Forests (PCCF); Secretary, Information Technology and other Heads of Departments of the Forest Department.

The Deputy Commissioners of all districts participated in the programme through video conferencing from their respective offices.

This pioneering initiative marks the first such exercise in the UT, wherein land parcels exclusively defined as 'State Land' were jointly surveyed by the Forest and Revenue Departments. Only those parcels verified to be free from all encumbrances have been mapped and integrated into the PM Gati Shakti portal, ensuring accuracy and reliability in land identification for developmental purposes.

Terming the initiative as a highly useful and forward-looking exercise, the Chief Secretary said that the availability of clearly identified and geotagged land on a single digital platform would significantly smoothen and expedite the development process across the

districts. He urged the Deputy Commissioners to take proactive measures to safeguard these identified patches from any encroachment and misuse.

The Chief Secretary further directed the Remote Sensing Wing of the Forest Department to institutionalize a mechanism for continuous and regular monitoring of these land parcels. He emphasized that any change in occupancy status should be immediately detected and acted upon to maintain the integrity of the land bank.

He also asked for capacitybuilding sessions to be organized with district administrations to ensure comprehensive understanding and effective utilisation of the system on the PMGS portal for varied administrative and planning purposes. Additionally, he impressed upon the DCs to identify and add any left-out 'State Land' parcels, making the portal a one-stop solution for meeting land requirements for key developmental projects.

Speaking on the occasion, Commissioner Secretary, Forests, Sheetal Nanda highlighted that the Forest Department was tasked with GIS mapping of identified land parcels in close coordination with the Revenue Department to ensure precision and efficiency.

She informed that a joint ground-truthing exercise was conducted by officers of both departments to validate the suitability of land and confirm that all selected parcels were free from encumbrances before being included in the land bank.

free from encumbrances before being included in the land bank. Elaborating on the details of the land bank, PCCF Suresh Kumar Gupta informed that an initial scrutiny of 668 land parcels, covering an area of 6,221.30 hectares, was conducted to assess any overlap with forest lands including GairMumkinJangal, Jhar, Berune line forests, etc. Following rigorous verification and ground-truthing, 462 land parcels measuring 2,406 hectares were found encumbrance-free and suitable for the creation of critical government infrastructure, he added.

Providing the district-wise breakup, he stated that the parcels uploaded on the portal includes 10 from Anantnagtotaling an area of 12.43 hactares of land, Baramulla 7 parcels (74.44 ha), Budgam 15 (28.99 ha), Doda44 (332.52 ha), Ganderbal26 (30.45 ha), Jammu3 (4.55 ha), Kathua 154 (750.47 ha), Kishtwar 45 (513.90 ha), Kulgam10 (17.44 ha), Kupwara15 (74.24 ha), Poonch60 (135.35 ha), Pulwama 1 (4.10 ha), Rajouri 12 (55 ha), Ramban 16 (56 ha), Reasi 20 (150 ha), Samba 5 (12.85

ha), Shopian 1 (2.02 ha) and Udhampur 18 parcels with 152.08 hactares of land stands markedand added to the portal.

The meeting was also briefed on the systematic, multi-departmental process adopted for creation of this comprehensive digital inventory. It was divulged that initially the Divisional Commissioners compiled information on various categories of revenue lands by seeking inputs from all Deputy Commissioners. This was followed by joint verification on the ground by Forest and Revenue officials to confirm feasibility and ensure that the lands were free from any legal or physical encumbrances.

Subsequently, KML files of the finalized land parcels were prepared and submitted to the Department of Environment and Remote Sensing, which completed the digitization process as per prescribed protocols. The validated data was then uploaded on the PM Gati Shakti portal, integrating it into the national framework for coordinated and data-driven infrastructure planning.

The launch of the Land Bank Layer is expected to significantly enhance evidence-based decision-making, inter-departmental coordination and efficient utilization of state land for development projects across Jammu and Kashmir.

Volcanic ash plumes impact flight services; Air India cancels flights, inspects aircraft

New Delhi, Nov 25: Flight operations were impacted on Tuesday, with at least seven international flight cancellations and nearly a dozen overseas services getting delayed due to the ash plumes from the volcanic eruption in Ethiopia.

Air India cancelled 13 flights since Monday as seven of its aircraft that had flown through regions affected by the volcanic ash plumes were subject to precautionary checks. These planes were cleared for operations on Tuesday, according to a source.

Ash clouds from the recent eruption of the Hayli Gubbi volcano in Ethiopia impacted flight operations and the India Meteorological (IMD) on Tuesday said the ash plumes are drifting towards China and will move away from India.

An official said seven international flights, including arrivals and departures, were cancelled and 12 international flights were delayed at the Delhi airport due to the impact of the volcanic ash plumes.

Gandhi Indira International Airport in the national capital is the country's largest airport, handling over 1,500 flight movements daily.



In the afternoon, the Ministry of Civil Aviation (MoCA) said there was no cause for concern at the moment and that the situation is being monitored closely.

"Following the 23 Nov volcanic eruption in Ethiopia and the eastward movement of the ash cloud, MoCA -- along with ATC, IMD, airlines and international aviation agencies -- is ensuring seamless coordination.

"AAI has issued the necessary NOTAM and all affected flights have been kept informed. Operations across India remain smooth, with only a few flights rerouted or descended as a precaution," the ministry said in a post on X.

AAI refers to the Airports Authority of India and NOTAM is Notice to Airmen.

On Tuesday, Air India said it has cancelled 13 flights since Monday and was carrying out precautionary checks on those planes that had flown over locations that had ash plumes due to the volcanic activity in Ethiopia. Air India said it has cancelled

four flights on Tuesday -- AI 2822 (Chennai-Mumbai), Al 2466 (Hyderabad-Delhi), Al 2444 2445 (Mumbai-Hyderabad-Mumbai) and AI 2471/2472 (Mumbai-Kolkata-Mumbai).

On Monday, it had cancelled seven international flights, including AI 106 (Newark-Delhi), AI 102 (New York (JFK)-Delhi) and AI 2204 (Dubai-Hyderabad) and AI 2290 (Doha-Mumbai).

Mrutyunjay Mohapatra, Director General of Meteorology at the IMD, said the impact was

"The volcanic ash is being seen only in the upper troposphere and it is affecting flight operations. It has no impact on air quality or weather. The ash cloud is drifting towards China and will move away from Indian skies by 7.30 pm," Mohapatra

Volcanic ash reached the skies over Gujarat, Delhi-NCR, Rajasthan, Punjab, and Haryana on Tuesday.

The Directorate General of Civil Aviation (DGCA) on Monday asked airlines to strictly avoid published volcanic ash affected areas and flight levels, adjust flight planning, routing, and fuel considerations based on the latest advisories.

In a detailed advisory, the regulator had also asked airlines to immediately report any suspected ash encounter, including engine performance anomalies or cabin smoke/odour.

If volcanic ash affects airport operations, then the operator concerned must immediately inspect runways, taxiways, and aprons. Depending on the contamination, the operations may be restricted, and cleaning procedures have to be completed before resuming movements, the watchdog had said.

Profits from cricket betting constitute proceeds of crime under PMLA: Delhi HC

New Delhi, Nov 25: The Delhi High Court has held that profits from cricket betting would constitute "proceeds of crime" under the anti-money laundering law.

The high court said this is because the taint attached to the property at its very inception, originated from a criminal activity relatable to a scheduled offence, persists throughout its subsequent

A bench of justices Anil Kshetarpal and Harish Vaidyanathan Shankar said even if cricket betting is not a separate predicate offence, non-availability of the Super Master IDs, which was a culmination of a series of criminal activities related to a scheduled offence, would have made the international cricket betting racket non-functional.

"For instance, if a person acquires any immovable property through acts of forgery, cheating and criminal conspiracy and thereafter utilises such property for a downstream activity, such as conducting an unlicensed real-estate business which is not a scheduled offence, the proceeds generated from the latter activity nonetheless constitute 'proceeds of crime' under the PMLA," the court said in its judgement passed on Monday.

The high court passed the verdict dismissing a batch of petitions filed by several persons in an alleged Rs 2,400 crore international cricket betting racket from 2015, challenging the provisional attachment orders (PAOs) made over a decade ago by the Enforcement Directorate (ED).

In September 2015, ED issued a PAO, attaching moveable and immovable properties valued at approximately Rs 20 crore of the accused, and also issued a show-cause notice in October 2015 for money laundering under the Prevention of Money Laundering Act (PMLA).

The petitioners challenged the PAO orders as well as show cause notice before the high court.

The action was initiated by the ED against the petitioners in connection with large scale hawala transactions and illegal international cricket betting operations conducted through a UK-based website Betfair.com.

Dave flagged that there was no budgetary allocation done for installation of CCTVs for three central agencies.

"We find that only 11 states have filed their compliance affidavits in the suo motu writ petition. The remaining states and Union territories have not filed their compliance affidavits which includes the Union of India also," the bench noted in its order.

It granted three weeks time to the states and UTs, which have not yet filed their compliance affidavits, to do so and posted the matter for hearing on December 16.

The bench said if by the said date, the compliance affidavits are not filed by the remaining states and UTs, their principal secretary in the department of home will remain present before the court along with their respective explanations for not complying with the

Mehta said the Union home secretary is not involved in the entire process as no police station is under his control.

The bench said the apex court's earlier direction was for the central probe agencies.

It said if the compliance affidavits will not be filed, then the respective directors of the central probe agencies may have to come to the

The bench said Dave would assist it as amicus in the suo motu case also.

On September 15, the apex court flagged the issue of oversight and said it was thinking of having a control room without any human intervention for monitoring of feeds of CCTV cameras installed at police stations.

In December 2020, the top court had said states and UTs should ensure CCTV cameras were installed at each police station, at all entry and exit points, main gate, lock-ups, corridors, lobby and reception as also areas outside the lock-up rooms so that no part was left uncovered.

PM Modi hoists saffron flag atop Ayodhya Ram temple, says centuries-old wounds healing today

Ayodhya (UP), Nov 25: Prime Minister Narendra Modi on Tuesday said the "wounds and pain" of centuries are healing as a 500-year-old resolve is finally being fulfilled with the formal completion of the Ram temple here.

Modi made the remarks after ceremonially hoisting a saffron flag atop the Ram temple in Ayodhya, an event marking the official completion of the shrine.

He was joined by RSS chief Mohan Bhagwat, Uttar Pradesh Governor Anandiben Patel and Chief Minister Yogi Adityanath.

Calling the moment "epochal," the prime minister said Ayodhya was witnessing another historic milestone and added that "the entire country and the world are immersed

Modi said the sacred flag would stand



as a testament that "truth ultimately triumphs over falsehood," and congratulated Ram 'bhakts' along with all those who contributed to the construction of the temple.

According to officials, the flag hoisting marked the formal completion of the Ram temple complex, nearly six years after the Supreme Court's landmark 2019 verdict that allotted the entire 2.77-acre disputed site for the Ram Mandir.

According to an official statement, the saffron flag measuring 22 feet x 11 feet is made of parachute-grade cloth with a thick nylon hoisting rope, and is mounted atop a 161-foot spire.

The flag bears symbols of the Sun, representing Lord Ram's Surya Vansh, Om, and the Kovidara tree, described as the state tree of

Temple officials said the idol of Ram Lalla

is located in the 'Garbhagriha' on the ground floor, a climb of 32 steps from the Singh Dwar on the eastern side.

The complex includes five mandaps - Nritya, Rang, Sabha, Prarthana and Kirtan – and features restored heritage structures such as the ancient Shiv Mandir at Kuber Tila and the historic Sita Koop.

The Ram temple project began after the Supreme Court's unanimous judgment dated November 9, 2019.

Following the ruling, the Centre constituted the Shri Ram Janmabhoomi Teerth Kshetra Trust, announced by Prime Minister Modi on February 5, 2020.

The foundation stone for the temple was laid on August 5, 2020, and the 'Pran Pratishtha' of the Ram Lalla idol took place on January 22, 2022.

The Ram Darbar was opened to devotees on June 14, 2025.

'Those who sacrificed must be in peace today': RSS chief

Ayodhya, Nov 25: RSS chief Mohan Bhagwat on Tuesday said those who sacrificed their life for the Ram Temple in Ayodhya must be in peace today as the hoisting of the saffron flag atop the shrine marked the formal completion of its construction.

Prime Minister Narendra Modi ceremonially hoisted the saffron flag atop the Ram temple in Ayodhya.

Speaking at the flag-hoisting ceremony at the temple, Bhagwat said a flag is always a symbol, and the installation of



such a towering flag at the temple had taken considerable time, just as the construction of the temple did.

He noted that many people had dreamt of this day and several sacrificed their lives for it. "Their souls must have found peace today," Bhagwat said, recalling the names of some.

"Those who worked in the background everyday also dreamt of Ram Mandir, now today that the ritualistic completion is over: the flag of 'Ram Rajya' has been hoisted," he added.

"It has taken long to hoist such a tall flag. You all know how long it took to build the temple - even if we leave aside 500 years, it took 30 years," he said.

He added that through this flag, certain fundamental values had been elevated.

"These are the values that will guide the world - from individual life to family life and the life of the entire creation. Dharma is what ensures well-being for all," Bhagwat said.

He said the saffron colour of the flag represents dharma and is therefore referred to as the 'dharma dhwaj'. The flag also bears the symbol of the Raghu dynasty -the kovidar (mandar) tree, he added.

Indian economy to cross USD 4 trillion in FY26: Nageswaran

New Delhi, Nov 25: Chief Economic Advisor V Anantha Nageswaran on Tuesday said the size of Indian economy is expected to cross USD 4 trillion in current fiscal.

He said with the geopolitics in a "huge state of flux", economic growth is very vital prerequisite to maintain India's standing and leverage in the global scheme of things.

India currently is the fifth largest economy in the world with a GDP of around USD 3.9 trillion.

Speaking at the IVCA Green Returns Summit 2025, Nageswaran said the Indian economy is already sort of crossing the USD 4 trillion mark, in the course of the current financial year, from USD 3.9 trillion at the end of March 2025. "So, whatever we do with respect to greening the economy, energy transition, environment, dealing with climate change and climate volatility have to be aligned with our priorities, both in the near term and the medium term," he said.



Nageswaran said the country is well aware of the potential consequences of global warming and climate change and more generally for agriculture environment, and coastlines, etc.

"That is why we as a country are committed to achieving net zero by 2070," Nageswaran said.

Not just a headache: 5 signs of early brain cancer that go unnoticed

New Delhi, Nov 25: The initial symptoms of brain cancer develop as mild signs, which patients frequently identify as ordinary health problems. The combination of headaches with additional warning signs, appears before headaches become the primary symptom of brain tumors. The identification of these warning signs at their onset leads to better treatment results. Here are some early signs of brain cancer that extend or can be accompanied by a headache, though they can occur due to other reasons as well...

Nausea and vomiting

The growing tumor inside your skull creates pressure that disrupts brain operations, and produces multiple symptoms. The first indicators of brain tumors include headaches, together with nausea, vomiting, fatigue and vision problems that cause blurred or double vision. The tumor creates these symptoms by

areas, which control these body functions. Medical professionals fail to identify these symptoms, because they resemble typical health problems, which results in delayed diagnosis. Research indicates that brain tumor patients experience headaches together with nausea and vision problems, which should lead them

The first few indicators of brain cancer, include memory problems, concentration issues, mood changes and irritability. This occurs because the tumor creates these cognitive changes by pressing against brain areas which control thinking, and emotional processes. The brain shows signs of confusion, while patients

experience word-finding difficulties, and their behavior becomes unrecognisable. People tend to ignore these minor changes, and attribute them to stress and ageing, because they develop slowly. How-ever, research indicates that brain tumor patients develop cognitive changes before their neurological symptoms become apparent, which makes these changes vital for early tumor detection.

Seizures and unexplained muscle weakness

Adults who never experienced seizures before, should seek immediate medical help when they develop new seizure activity because it indicates brain tumor activity. A tumor located in motor areas of the brain will cause unexplained weakness or numbness, to appear in specific body parts. Medical staff will conduct urgent tests to detect tumors, after patients show these symptoms. Medical experts state that brain tumor patients should receive immediate medical tests when they experience either seizures, or muscle weakness.

Sudden appearance of vision problems

The brain's visual processing centers and optic nerves become affected by tumors, which result in vision problems including blurred vision, double vision, flashing lights and peripheral vision loss. These symptoms differ from typical eve strain, because they progress or appear without any apparent reason. Research shows that brain cancer patients who experience vision problems, together with neurological symptoms need immediate medical evaluation.

Unusual fatique and balance issues

The exhaustion experienced by cancer patients exceeds typical fatigue, because it persists strongly and does not respond to rest. People with brain tumors experience extreme tiredness which makes it hard to perform daily activities and stay awake. The brain's ability to control movement becomes disrupted when patients experience balance and coordination issues. Research shows that brain tumor patients experience two underreported symptoms, which include fatigue and balance problems, that need medical evaluation.

These warning signs frequently emerge before or together with headaches, which however, do not reliably indicate brain tumors. Research indicates that doctors should identify multiple symptoms at their onset, because this approach leads to better treatment results. Medical help should be sought immediately when you or someone you know, shows these warning signs.

President Trump has 'nuanced, commonsense opinion' on H-1B visas: White House

New York/Washington, Nov 25: U.S. President Donald Trump has a "very nuanced and commonsense opinion" on the issue of H-1B visas and does not support American workers being replaced, White House Press Secretary Karoline Leavitt said.

To a question on American workers being replaced with H-1B visa holders and Mr. Trump's position on it, Ms. Leavitt said the President's stance on the issue has been mischaracterized.

On the H-1B visa issue, Ms. Leavitt said Mr. Trump "has a very nuanced and commonsense opinion on this issue. He wants to see if foreign companies are investing trillions of dollars in the United States of America, and they're bringing foreign workers with them to create very niche things like batteries, he wants to see that at the beginning to get those manufacturing facilities and those factories up and running."

She said that ultimately, Mr. Trump always wants to see American workers in those jobs, and he's told foreign companies investing in the country that they "better be hiring my people if you're going to be doing business in the United States. So there's been a lot of misunderstanding of the President's position." Ms. Leavitt added that the President wants to see the American manufacturing industry revitalised better than ever before. "That's part of what he's doing with his effective use of tariffs and cutting good trade deals around the



world. That's why he's recruited trillions and trillions of dollars in investments into our country. Those are creating good-paying American jobs right here at home," she said.

Amid backlash over the H-1B visas by Mr. Trump's MAGA (Make America Great Again) supporters, the President has said that he would "welcome" skilled immigrants into the country who will then "teach" American workers to develop complex products like chips and missiles, acknowledging that he may take a "little heat" over this from his base which supports restrictions on immigration.

Mr. Trump has said that a large number of plants, including "extremely complex" ones, are being built in the U.S. now that will contribute significantly to the country's economic growth. He added that given the complex nature of products that will be manufactured in these plants, companies will have to bring in skilled workers from abroad who can then share their knowledge and teach American workers.

"But if you have to bring people to get those plants opened, we want you to do that, and we want those people to teach our people how to make computer chips and how to make other things," Mr. Trump has said. Mr. Trump explained that the companies, which are building massive com-puter chip factories for billions of dollars, can't just "hire people off an unemployment line to run it." "They're going to have to bring thousands of people with them, and I'm going to welcome those people," Mr. Trump added.

Mr. Trump has said that a company cannot open up a big computer chip plant "with people that don't even know what a chip looks like." He had defended the H-1B visa programme, saying America has to bring in talent from around the world as it does not have "certain talents" in the country.

Companies use visas such as H-1B and L1 to hire skilled foreign workers for speciality occupations in the U.S. The Trump administration has launched an intense crackdown on illegal immigration, and the President's supporters have also called for cracking down on H-1B visas, citing widespread abuse and fraud in the programme amid allegations that H-1B visa holders are rendering Americans unemployed.

'US pressed Ukraine to accept deal at Geneva talks'

Kyiv, Nov 25: The United States pressed Ukraine to accept its proposals to end the war with Russia during talks in Geneva on Sunday, a senior official told AFP, despite Kyiv protests that the plan conceded too much to Moscow.

The official, speaking on condition of anonymity, said Washington did not directly threaten to cut off aid if Kyiv rejected its proposals, but that Ukraine understood this was a distinct possibility.

The US plan, originally made up of 28 points, would see Ukraine effectively cede its eastern Donetsk and Lugansk regions to Russia and slash the size of its army — demands that Kyiv has decried as unacceptable.

Ukrainian, US and European officials met in Switzerland on Sunday to draft an "updated" version of the plan, but the Kremlin said Monday that it would not accept European amendments. Although US pressure on Ukraine eased during the meeting in Geneva, "over-all pressure" remained, a senior official briefed on the talks said.

The source said they did not understand why Washington was hurrying toward a deal, but that "everyone" was for an end to the war if there was a real opportunity to do so.

Russia launched its full-scale invasion of Ukraine in February 2022. Kyiv and its European allies say the war, the largest and deadliest on European soil since World War II, is an unprovoked and illegal land grab that has resulted in a tidal wave of violence and destruction. Tens of thousands of civilians and military personnel have been



killed since the invasion began, while millions of Ukrainians have been forced to leave their homes. - 'Critical moment' -

US President Donald Trump initially gave Ukrainian President Volodymyr Zelensky until Thursday to respond to the first version of the plan.

But German Chancellor Friedrich Merz threw doubt on Trump's deadline, saying at an EU-Africa summit in Angola that discussions would be a "lengthy, long-lasting process."

A new version of a draft worked on in Geneva has not been published but all sides agreed that any deal must "uphold Ukraine's sovereignty."

Countries supporting Kyiv part of the "coalition of the willing" - are due to hold a video call Tuesday following the Geneva talks.

Zelensky said Monday his country was at a "critical moment," after last week warning Ukraine risked losing either its "dignity" or Washington as an ally. Russian President Vladimir Putin had welcomed the original US plan, saying it could be a basis for a deal.

But in Ukraine's southern city of Zaporizhzhia, residents balked at the idea of ceding land to Russia. "We cannot give up any territory. What did our soldiers give their lives for? How will we look their families in the eye?" asked Tetiana, a worker at a local metal firm. "I understand that it is very difficult for our boys, but give them an inch and they will take a mile."

As talks continued, the war ground on. A Russian strike on the northeastern city of Kharkiv late Sunday killed four people, local officials said.

- Trump optimistic -In Washington, Trump

appeared hopeful of a reakthrough.

"Don't believe it until you see it, but something good just may be happening," Trump said on social media. In Geneva on Sunday, the Ukrainian delegation said a new draft of the plan "already reflects most of Jkraine's key priorities."

US Secretary of State Marco Rubio said "tremendous" progress had been made at the talks. "I honestly believe we'll get there,' Rubio said, adding: "Obviously, the Russians get a vote."

Moscow has captured and occupies large swathes of southern and eastern Ukraine, since it invaded claiming to have annexed five Ukrainian regions, including Crimea which it seized

Raina backs Gambhir, says India's failures not coach's fault

New Delhi, Nov 25: Former India batter Suresh Raina has backed under-fire national head coach Gautam Gambhir, saying the team's recent poor run in home Tests cannot be attributed to the support staff as players must shoulder responsibility for the results.

India, after being ingly whitewashed at home by New Zealand last year, are staring at another disastrous outcome in the ongoing series against South Africa, having lost the opening game of the two-match series.

"Gauti bhaiya (Gautam Gambhir) has worked really hard and he is not at all at fault. The players have to work really hard and play well. Under him we have been doing great in the white-ball format where we just won the ICC Champions Trophy and Asia Cup in Dubai earlier this year," Raina told 'PTI Videos'.

"The players have to score, the coach can only guide, advise and give support to the players," he said on the sidelines of the Indian Softball Cricket League's jersey launch here. He was unveiled as the event's brand ambassador

Raina dismissed suggestions that Gambhir's future as head coach is at risk due to the recent poor home Test

"If they (the players) are facing any issues, they must be communicating to the coach that this is the issue. If



the players do well then the coach will be also applauded. But if the team is not doing well, it should not be that the coach should be sacked from his post," he said.

bhaiya, he loves Indian cricket team, he loves cricket, I have played and won the World Cup with him. So, he has done really well for the country and it is the players' responsibility to do well," he On the criticism of India's

selection calls in the ongoing series, Raina said performances in domestic cket should remain the benchmark.

"They should play domestic cricket regularly and do well there, if they do well that will automatically reflect in their performances at the international level," he said.

He also highlighted the challenges of modern cricket, including three different formats and hectic scheduling, which affect performance.

Trump says he will visit China in April after 'very good' call with Xi Jinping

Washington, Nov 25: US President Donald Trump said that he will travel to China in April at the invitation of Chinese President Xi Jinping, announcing the visit in a social media post, following a "very good" phone conversation between the two leaders earlier in the day.

Social, Trump said on Monday, that the call covered Ukraine, Russia, fentanyl, soybeans and "other farm products," adding that the two sides had "done a good, and very important, deal for our Great Farmers - and it will only get

He said the conversation followed their "highly



successful" meeting in South Korea three weeks earlier and that both sides had made "significant progress" in keeping recent agreements "current and accurate." Trump also announced that he would host the Chinese leader for a state visit in the United

States later next year. Chinese news agency Xinhua also confirmed the call and said Xi used the conversation to outline Beijing's "principled position" on Taiwan, emphasising that Taiwan's return to China is "an integral part of the post-war international order." It stated that Xi under-

lined that "China and the US fought side by side against fascism and militarism" and "should jointly safeguard the victorious outcomes of World War II."

China is currently engaged in an escalating diplomatic row with Japan following comments by Japanese Prime Miniser Sanae Takaichi on the Taiwan Strait. According to the statement, Xi and Trump also discussed the war in Ukraine. Xi reiterated China's support for "all efforts conducive to peace" and expressed hope that parties involved in the conflict would narrow differences and work toward a "fair, lasting and binding peace agreement."

Man United loses to Everton at home for first time in 12 years

Manchester, Nov 25: Everton enjoyed its first Premier League win at Manchester United in 12 years despite playing the entire game virtually with 10 men after midfielder Idrissa Gueye was sent off for slapping his own teammate, Michael Keane, on Monday.

Kiernan Dewsbury-Hall's superb first-half goal sealed a 1-0 win for the visiting side, which shrugged off the 13th-minute incident that had Gueye and Keane square up. United, which could have moved up to fifth with a win, dominated possession, especially in the second half, but Everton defended superbly to repel the host, which looked blunt in attack.

Everton goalkeeper Jordan Pickford made several fine saves to preserve his side's lead, the pick of them to claw away a Joshua Zirkzee header with 10 minutes remaining.

A second away win of the season lifted Everton above city rival and champion Liverpool into 11th place, level on 18 points with United, which is above it on goal



Everton manager David Moyes had failed to win in 17 previous Premier League matches as an opposition manager at Old Trafford, and Everton's most recent win there, in 2013, came when Moyes was in the home dugout during his brief United reign. That miserable run had looked like continuing as Everton made a horrible start when defender Seamus Coleman was forced off with

Worse was to follow shortly after in a bizarre incident. After Bruno Fernandes's shot flashed just wide after a misunderstanding in the Everton defence, a heated argument flared up between

Gueye and Keane. After Keane shoved his teammate, Gueye responded with a slap to the face of the defender, prompting referee Tony Harrington to show him a straight red card, the decision being checked and verified by VAR.

It was the first time a Premier League player had been sent off for an altercation with a teammate since Stoke City's Ricardo Fuller was dismissed for slapping Andy Griffin during a match at West Ham United in 2008.

At that stage, the omens looked bleak for Everton, with United never having lost a Premier League game at Old Trafford against opponents who had a player sent off.

Everton responded with the right kind of fight, though, and took the lead in stunning fashion with Dewsbury-Hall cutting in to send a powerful shot from the edge of the penalty area past the dive of the slow-to-react Senne Lammens in the 29th minute. United struggled to make its numerical supremacy count and, except for a Fernandes' longrange effort that was saved by Pickford, it offered little in attack before half-time.

The host cranked up the pressure after the break as Everton retreated, and Bryan Mbeumo was denied by Pickford before Mason Mount flashed a low shot just wide.
