New Delhi, Nov 27: Stating that the 'Operation Sindoor' demonstrated India's military strength as well as its moral clarity in acting firmly against terror, President Droupadi Murmu on Thursday said that world has recognised India's capability to respond decisively while upholding its commitment to security and stability.

Addressing at the inaugural session of the third edition of the Indian Army's seminar, 'Chanakya Defence Dialogue-2025,' here, President Murmu, according to the news agency—Kashmir News Observer (KNO) said, "The success of Operation Sindoor represented a defining moment in India's counter-terror and deterrence strategy. It demonstrated



the nation's military strength as well as its moral clarity in acting firmly yet responsibly to

maintain peace.' 'The world has recognized India's capability to respond decisively while upholding its commitment to security and stability," she added.

Praising the Indian armed forces for their exemplified professionalism and dedication in safeguarding the country's sovereignty, the President said,

"Across conventional, counterinsurgency, and humanitarian operations, the forces have shown remarkable adaptability and resolve. Beyond operational roles, the armed forces also contribute to national development by improving border infrastructure, enhancing connectivity, promoting tourism, and supporting education initiatives in frontier areas."

The President said that rapid technological advancements, competing power centres, and shifting alliances are rewriting international relations. Emerging domains such as cyber, space, information, and cognitive warfare are increasingly blurring the lines between peace and conflict.

Says we're living in turbulent times; outlines roadmap to transform the force

New Delhi, Nov 27: Army Chief General Upendra Dwivedi on Thursday described Prime Minister Narendra Modi's 5Ss approach — 'Samman, Samvad, Sayog, Samridhi, and Suraksha', as a roadmap to guide India through the 'Amrit Kal' towards a Viksit Bharat.

Addressing the inaugural session of the third edition of Chanakya Defence Dialogue, a key conclave hosted by the Army here, General Dwivedi, according to the news agency-Kashmir News Observer (KNO) said, "The world has moved from the Cold War's bipolarity through a brief unipolar moment into an uncertain and fractured order."

He underlined that the long piece is declining and compre-

hensive conflicts are on the rise. The Army Chief outlined a "set of springboards" that would drive the years of transformation ahead for the force, so as to remain decisive and

future-ready in this rapidly-

evolving global landscape. "We are living in an increasingly multipolar world, where major powers are continu-

ously jostling and competing. The world has moved from the Cold War's bipolarity through a brief unipolar moment, into an uncertain and fractured order. The long piece is declining, and comprehensive conflicts are on the rise," Gen Dwivedi said.

He underlined that with over 50 ongoing conflicts world over, to say "we live in turbulent times, may actually be an understatement".

So, if the globe is swivelling towards national security,

deterrence and war-fighting, it inevitably "raises a fundamental question for us — how must the Indian military transform to remain decisive and ready in this rapidly-evolving global landscape," the Army chief said.

Kashmir parts record coldest Nov temp since 2007; mercury falls

Srinagar, Oazigund, Kupwara, other areas break records; next 10 days mostly dry: MeT

Srinagar, Nov 27: Kashmir witnessed a severe drop in night temperatures on Thursday, with Srinagar, Qazigund and Kupwara registering their coldest November minimum temperatures in more than a decade, signalling an early peak of winter conditions in the Valley.

Meteorological data shared with the news agency-Kashmir News Observer (KNO) by weather expert Faizan Arif shows that several stations recorded their lowest November night temperatures since 2007 and 2009, accompanied by widespread sub-zero readings across the region.

According to the figures, Srinagar recorded a minimum temperature of -4.4°C,



marking its coldest November night since 2007, when -4.8°C was recorded on November 28. The lowest ever November minimum in Srinagar remains -7.8°C, registered on November

Qazigund also recorded its

coldest November temperature since 2007, touching -4.0°C. The town last saw a similar minimum of -5.5°C on November 28, 2007. Its lowest-ever November reading stands at –8.2°C, recorded on November

Kupwara dipped to -4.4°C, the lowest November minimum in the district since 2009. when -4.6°C was recorded on November 19. The all-time lowest November temperature for Kupwara remains -5.5°C, measured on November 29, 2007.

The cold wave extended across South and North Kashmir, with most stations witnessing sharp falls in night temperatures.

Ganderbal, Nov 27: National Conference (NC) Member of Parliament (MP), Aga Syed Ruhullah Mehdi on Thursday said he has neither distanced himself from the party nor planned to form a new one. He, however, criticised the NC for failing to advance key agendas, including Article 370, the Waqf Bill, and reservations.

"The party should not adopt the language of the BJP," Ruhullah said while speaking to reporters during his visit to central Kashmir's Ganderbal district, where he interacted with locals to discuss their issues.

Mehdi reiterated his disagreement with the NC on the reservation issue and promises made during the 2024 Assembly elections. "We made promises to the people that we will fight for the return of protections linked to Article 370. We received votes on that. We cannot switch to a different language after getting that mandate," he said. "I have neither distanced myself from any party nor planned to form any new party. My disagreements with the National Conference are because we have to work on the political agendas for which we sought votes."

The MP Srinagar added, "We cannot speak the language of the BJP. More than a year has passed, but we have not worked on our agenda, have not worked in the name of Article 370, have not worked on the Waqf Bill, have not worked on the issue of reservations.'

About the NC's Working Committee meeting, Ruhullah said he was unaware of it.



"I don't know which meeting is going on. I'm a permanent member of the Working Committee. This is the first time since 2002 that I have not been invited," he said.

Replying to a query on reports of him flouting a political party, the senior NC leader said he has not distanced himself to build a separate political platform. "I have not kept a distance from any party, nor have I spoken to anyone to form another party," he said. On the reservation issue, Ruhullah said students are losing opportunities due to delays. "More than a year has passed. If this matter remains unresolved after a month, I will again sit with the students until the issue is settled," he said.

He further said that the failure of mainstream parties to honour public trust would damage the entire political system. "If the party does not follow its own manifesto, it will lose people's trust, and losing trust is the biggest loss," he said.

Mehdi said his political stance is driven by principles and not

Ruhullah not invited to CWC meet: CM's advisor

Srinagar, Nov 27: Chief Minister's Advisor and senior National Conference (NC) leader, Nasir Aslam Wani on Thursday said that Member Parliament Aga Syed Ruhullah Mehdi was 'not invited' to the ongoing Central Working Committee (CWC) meeting of the party in Srinagar. Talking to reporters after the day one of the meeting, Wani

said the two-day working committee session was still underway, with deliberations continuing on several key issues and resolutions expected to be framed after discussions conclude.

"It is too early to say anything right now. The working committee session is still going on for two days and discussions are in progress. We have a large number of members and so far, around 19–20 members have spoken," Wani said adding the session will continue tomorrow as well, after which resolutions will be framed," he said.

Asked whether Srinagar MP Aga Syed Ruhullah Mehdi was invited to the meeting, Wani replied briefly, "No, he was not invited." MLA Hazratbal, Salman Sagar said the meeting will strengthen both the party as well as government. "The Chief Minister sought firsthand feedback from MLAs and assured that all the issues would be addressed. The idea is to ensure better coordination between the party and the people so that people at the grassroots level ultimately are benefited. This meeting will strengthen both the party and governance structure," he said—(KNO)

Delhi Court permits Jailed Er Rashid to attend Parliament

New Delhi, Nov 27 (KNO): A Delhi court on Thursday permitted Bar-amulla Member Parliament (MP), Abdul Rashid Sheikh, also known as Engineer Rashid, to attend the sixth session of the 18th Lok Sabha while remaining in custody.

According to details, the court said that the permission is subject to conditions imposed previously.

Additional Sessions Judge Prashant Sharma clarified that the cost of travel for Rashid would depend on the outcome of an ongoing appeal in the Delhi High Court.

Rashid has been lodged in Tihar jail since 2019 in connection with a terror funding case registered in 2017. He is represented by a team of advocates, including Vikhyat Oberoi, Nishita Gupta, Shivam Prakash, and Ravi Sharma.

On November 7, a division bench of the Delhi High Court delivered a split verdict regarding Rashid's plea to waive the cost of his security and travel arrangements while attending Parliament. The bench comprised Justices Vivek Chaudhary and Anup Bhambhani. Justice Chaudhary concluded that Rashid does not have any entitlement to attend parliamentary proceedings while in lawful custody. Justice Bhambhani,

in contrast, ruled that Rashid is only required to cover the expenses of transportation from jail to Parliament and back. including the costs of the

jail van and escort vehicle. The police had estimated the total per-day cost for Rashid's attendance at approximately Rs 1.45 lakh, including charges for accompanying officers.

Justice Bhambhani stated that the state's demand for Rashid to pay for police personnel accompanying him is not justified.

Rashid was formally charged by a special NIA court in Delhi in March 2022 after the case was lodged in 2017.

Earlier in March 2025. the Delhi High Court allowed him to attend the Lok Sabha during the Budget session, subject to the condition that expenses related to his travel and other arrangements would be borne by him while he remained in state custody.

The court's decision ensures that Rashid can participate in parliamentary proceedings without being released from custody, while clarifying the financial obligations associated with his attendance—(KNO)

JK Govt to take up 'extortion' issue with Punjab

Srinagar, Nov 27: Days after the Kashmir Wholesale Mutton Dealers Association warned of a "fresh price hike" over alleged extortion and harassment at Puniah checkpoints, the Jammu and Kashmir Government on Thursday assured swift action with a joint high-level committee scheduled to take up the matter with Punjab authorities after the December 2.

Mehraj-ud-Din Ganai, General Secretary of the Association said that the delegation recently met senior, NC leaders and government officials who assured them of "immediate intervention."

They assured us that a high-level committee will be formed and on December 2 (Tuesday), a delegation including Nasir Aslam Wani, the concerned Minister, Satish Sharma and an MLA, along with members of the mutton dealers' association, will proceed towards Punjab to hold talks with the Government there to resolve the issue," Mehraj said.

He said, they are hopeful the delegation will meet Punjab Government officials and the issue will be resolved.

Notably, the developmen comes after weeks of tension, with dealers alleging "extortion" of Rs 10,000-15,000 per truck at Shambhu and Madhopur checkpoints. The association had earlier set November 27 as the deadline for government intervention. warning that mutton prices could soar to Rs 800 per kg if the issue persisted.

Earlier this year, similar harassment led to the suspension of livestock imports and the death of over 50 sheep due to delays

and heat stress. With the government now stepping in, the dealers have expressed "cautious optimism" but also warned that unless ground-level extortion stops, they will be forced to pass on the losses to consumers—(KNO)

DSEK's enrolment drive hits reality of poor infra

Srinagar, Nov 27: As the school education department is conducting enrolment drives in Kashmir to attract more and more students towards government schools, several institutions in Tral sub-division of south Kashmir's Pulwama district are grappling with staff shortage and poor infrastructure.

As per the details, many government schools in Tral continue to reel under severe infrastructure deficiencies and acute staff shortages, leaving hundreds of students, mostly from economically weaker families, struggling for basic educational facilities.

Aggrieved parents and locals have urged the Education Minister to personally intervene and address what they describe as "years of neglect".

They said that despite multiple requests to authorities, several schools in Tral are functioning under extremely difficult conditions, with children studying in tin sheds, overcrowded classrooms, and buildings lacking even basic amenities.

At Middle School Tral-e-Bala, more than 70 students are forced



to attend classes in tin sheds, exposed to extreme heat in summer and freezing temperatures in winter. "It becomes unbearable for our children during harsh summers and even worse in the cold months," said Abdul Rashid, a concerned parent. "If the government can provide other facilities across the district, why can't they give our kids proper classrooms?" Teachers also expressed helplessness, saying that teaching in such conditions directly affects learning outcomes.

The situation is similar at Government Middle School Lanzgund Branpathri, where around 70 students from nine different classes are taught by only five teachers in just four rooms. "How can nine classes run in four rooms? Students end up disturbing each other because different subjects are taught in the same space," said Shabir Ahmad, a local. "Our children deserve better than this." At Government Middle School

Gurtoo, 140 students are cramped into only three functional rooms. Parents said the shortage of both classrooms and staff has severely impacted the quality of education "Our kids are bright, but how can they learn properly when they are squeezed into overcrowded rooms?" said Rafiqa Begum, a mother of two. "The government should at least provide additional classrooms and appoint teachers where needed."

Schools in Satoora and Zarihad also face similar issues. GMS Satoora has around 150 students but is functioning with just six rooms. Locals said the infrastructure has not been upgraded for years. "It's the same story every year. Promises are made, but nothing changes," said Manzoor Ahmad, a resident of Satoora. "We urge the department to take our children's future seriously."

The most alarming condition has been reported from Gojer Basti Showjan Panzoo, where the school, functioning from nursery to class 8th in four rooms, has no

toilet facility whatsoever. "This is the only government school in the area without a toilet," said Ghulam Nabi, a local elder. "Girls especially suffer the most. How can a school run without something as basic as a washroom?"

Parents warn that the absence of a toilet not only affects hygic but also discourages students, especially girls, from attending regularly. Parents across these villag-

es have appealed for immediate intervention by the Education Minister to ensure proper infrastructure, adequate staffing, and basic amenities. "We are not demanding anything extraordinary-just the fundamentals of a dignified education system," said Mohammad Yousuf, a parent. "We are poor people. The government schools are our only hope."

Locals said that unless urgent action is taken, the educational future of hundreds of children in Tral will continue to hang in the balance. They questioned the government's enrollment drives: "On what basis can they lure students when there is poor infrastructure and staff shortages?"-(KNO)

Shopian slaughterhouse delay angers residents

Shopian, Nov 27: Residents of Shopian town have voiced strong resentment over the failure of authorities to commission the long-awaited slaughterhouse, despite its construction being completed months ago.

Locals said that the delay has caused inconvenience, health concerns, and raised questions about administrative inefficiency.

According to residents, the slaughterhouse project, taken up by the Municipal Council Shopian, was completed well within the stipulated timeframe yet it remains non-functional, forcing butchers to continue slaughtering animals in open or

makeshift spaces.

Abdul Majid, a local from Jamia Market, expressed frustration over the unexplained delay. "We were told the slaughterhouse would start functioning immediately after completion. Months have passed, but the building is lying ocked. If everything is ready, what is stopping the authorities from commissioning it?" he said.

Residents said the non-commissioning has not only defeated the very purpose of the project but also affected hygiene standards in the town. Shabir Ahmad, who runs a shop near the main market, said the delay has created more problems than solutions. "Animals are still being slaughtered in the open. Waste is dumped wherever

possible. The whole point of constructing a modern slaughterhouse was to maintain hygiene, but nothing has changed on the ground," he

Locals argue that the absence of a functional, regulated facility poses risks to public health, especially with rising concerns about sanitation in urban areas.

Several residents also questioned the lack of communication from the concerned departments. Abdul Hamid, a local,

said: "We appreciate that the structure was completed whether administrative, techniquickly, but what is the use if it is not commissioned? Authorities

must come forward and explain what is causing the delay.'

The residents urged the district administration and the Municipal Council to remove all hurdles,

ACB files DA case against director SMG

Srinagar, Nov 27: The Jammu & Kashmir Anti-Corruption Bureau (ACB) has registered a major Disproportionate Assets (DA) case against director for State Motor Garages (SMG) Malik Tahir Gani, following a secret verification that reportedly uncovered massive properties, bank holdings, and commercial assets allegedly far exceeding his known sources of income. In a statement, the official said that based on a specific input, a secret verification was conducted by Anti-Corruption Bureau into the allegations of possession of huge disproportionate assets by Malik Tahir Gani, S/O Abdul Gani Malik, R/O H. No. 185-A, Sanat Nagar, Srinagar A/P Q. No.55-C Gandhi Nagar, Jammu presently posted as Director, State Motor Garages, J&K.

The verification revealed that the suspect while posted in different places/departments like ARTO Anantnag, Pulwama and Director State Motor Garages J&K has raised huge assets in the shape of plots, houses, shops, shopping complexes, bank accounts etc in his name as

well as in the name of his family members/ relatives which were found highly disproportionate to his known sources of income. On the basis of the verification conducted, a prima facie case of criminal misconduct was found made out against the accused Malik Tahir Gani, Director State Motor Garages, J&K under offences punishable U/S 13(1)(b) r/w section 13 (2) of PC Act 1988. Accordingly, a formal case FIR No. 11/2025 was registered at P/S ACB Central for investigation. uring the course of investigation, search warrants were obtained for conducting searches from the Hon'ble court of Special Judge Anti-Corruption Jammu. Thereafter, searches were conducted by the ACB teams at 04 different locations which include his residential houses at Sanat Nagar Srinagar, residential house at Hyderpora Srinagar, residential quarter at 55-C Gandhi Nagar, Jammu and official premises at New Plot, Jammu. During the course of search incriminating material was recovered and seized as evidence in the instant case.

Friday Brief: Gheebah - Eating The Flesh Of A Dead Brother

f all the moral failings that can corrode a community, backbiting, known in Arabic as Gheebah, is one of the most insidiously common. It is the social poison we often indulge in while considering it a harmless pastime. Yet, the Quran and Hadith present a starkly different and profoundly sobering perspective on this act, defining it in the most vivid terms to jolt the believer into awareness. The Quran delivers one of

the most powerful analogies for backbiting in Surah Al-Hujuraat: "And do not backbite one another. Would one of you like to eat the flesh of his dead brother? You would detest it" (49:12). This imagery is intentionally shocking. To speak ill of an absent person is spiritually equivalent to consuming their dead flesh - a notion that is universally revolting. This comparison strips away the casual veneer of gossip, revealing it as a vile and parasitic act

that preys on the honour and dignity of another human being. The Prophet Muhammad (Peace Be Upon Him) further elaborated on its gravity. He was once asked, "O Messenger of Allah! What is backbiting?" He replied, "It is to mention about your brother something that he would dislike." When asked if the fault must be real to constitute backbiting, he clarified, "If what you say about him is true, then you have backbitten him. If it

is not true, then you have slandered him," which is an even greater sin. This Prophetic definition is profoundly comprehensive. It is not about the truth of the statement, but about the violation of a person's right to their reputation and privacy. It is a betrayal of trust that fractures the bonds of brotherhood and sows seeds of enmity and suspicion within the community. In a world saturated with social media and instant communication,

the temptation to engage in Gheebah is ever-present. The divine guidance, however, remains our moral compass. Guarding our tongues from backbiting is an active affirmation of faith, a protection of communal harmony, and a fulfilment of the rights we owe to one another as members of a single, dignified humanity. It is a direct command to embody the respect for human dignity that Islam so emphatically champions.

Asian Youth Games 2025: A Record-Breaking Run For India's Young Athletes

Origins and Evolution of the Asian Youth Games

The Asian Youth Games (AYG) created under the aegis of the Olympic Council of Asia (OCA), nurtures the next generation of Asian sporting talent to help them compete internationally and also provide a stepping stone towards larger events. Born from Singapore's ambitious bid to host the 2010 Summer Youth Olympics, the Games were envisioned as more than just a sporting competition, they were designed as a comprehensive platform for youth development, cultural exchange, and sporting excellence.

In 2008, the OCA's Executive Board unanimously approved Singapore's hosting of the inaugural edition, with all 45 member nations endorsing the decision on April 6, 2008.[1] This marked the beginning of the multi-sport event, specifically targeting athletes aged 14 to 18 years.[2]

For India, the Asian Youth Games represent far more than a continental sporting competition, they symbolise our nation's commitment to nurturing young talent and building a robust pipeline for future Olympic champions.

Tracing India's Progress in the Asian Youth

India's journey across the three editions of these Games tells a compelling story of systematic improvement, enhanced support structures, and the transformative impact of government initiatives in grassroots sports development.

Asian Youth Games: Singapore 2009 (June 29 - July 7, 2009)

The inaugural edition in Singapore brought together young athletes from across Asia in what was described as a celebration of youth, sports, and learning. According to the Olympic Council of Asia, the Games featured 1,321 athletes across 9 sports in over 90 sporting events.[3]

India's debut at the Asian Youth Games in Singapore yielded 11 medals- five gold, three silver, and three bronze, this performance placed India 11th in the overall standings, a respectable showing that established the nation's presence on the youth sporting stage.

Asian Youth Games: Nanjing, China 2013 (August 16- August 24, 2013)

The second edition in Nanjing, China, marked a significant expansion of the event's scope and scale. The Games featured 2,314 athletes competing across 16 sports in 122 events.[4]

At the second Asian Youth Games, India made a strong impression with a well-rounded performance across multiple disciplines.
Indian athletes bagged 14 medals- three

Gold, four Silver, and seven Bronze, securing 10th place in the overall standings. The 2013 Games highlighted India's expanding and increasingly diverse talent

panding and increasingly diverse talent base, as young athletes ventured into new disciplines and performed more competitively on the Asian stage.

Asian Youth Games: Manama, Bahrain 2025 (October 22- October 31, 2025)

After more than a decade the Asian Youth

After more than a decade, the Asian Youth Games returned in a spectacular fashion. The event brought together over 4,000 young athletes from all 45 Asian nations competing across 26 sports.

Marking a historic milestone, India delivered its best-ever performance at the Asian Youth Games 2025, winning 48 medals — 13 Gold, 18 Silver, and 17 Bronze — to finish 6th overall

The Indian contingent of 229 athletes (107 men and 122 women), supported by 90 officials, showcased the nation's growing inclusivity in youth sports.

India delivered exceptional performanc-

es across multiple disciplines at the Asian Youth Games 2025.

The nation topped the medal tally in Beach Wrestling with three Gold and two Silver, while Wrestling added three Gold, two Silver, and two Bronze to the overall count.

Boxing emerged as India's most successful discipline in terms of gold medals, contributing four Gold, two Silver, and one Bronze.

In Kabaddi, both the boys' and girls' teams remained unbeaten throughout the tournament, clinching gold medals in the sport's debut appearance at the Games.

Overall, India's 48-medal haul was more than four times the 2009 tally and over three times the 2013 count, cementing the nation's place among Asia's top sporting powers and making Manama 2025 a defining chapter in India's youth sports journey.

Asian Youth Games 2025: Gender Parity and Participation

A remarkable highlight of India's participation at this year's Asian Youth Games was the strong gender balance within the team. Of the 229 athletes, 122 were female and 107 male, marking a notable instance where women outnumbered men in a major multi-sport international event. This highlighted the increasing inclusivity and

empowerment of young female athletes in the country.

In the category of medals, girls won 9 gold, 11 silver, and 6 bronze medals, totaling 26 medals, which accounts for 54.17% of the total medals. Boys secured 4 gold, 7 silver, and 8 bronze medals, making a total of 19 medals, representing 39.58%. The mixed category did not have any gold or silver medals but won 3 bronze medals, totaling

3 medals, which is 6.25% of the total medals. Female athletes accounted for over half of India's total medals and an even higher share of gold medals (69.23%). This remarkable trend underscores the growing strength of India's women athletes, nurtured through consistent opportunities and structured support at the grassroots levels.

NOTE: Out of 77 medal winning athletes, 46 were female, 31 were male.

Official Recognition and Support India's historic performance this year

received widespread recognition from the highest offices.

Prime Minister Narendra Modi congratulated the contingent, stating: "Our young athletes have scripted history at the Asian Youth Games 2025 with their best-ever performance, winning an impressive 48 medals. Congrats to the contingent. Their passion, determination and hard work are clearly visible. My best wishes for their future endeavours."[5]

Conclusion India recorded its best-ever performance at the 2025 Asian Youth Games winning 48 medals, surpassing previous tallies from 2009 and 2013. This represents more than statistical growth—it reflects systematic transformation in youth sports infrastructure, coaching quality, athlete support systems, and competitive mindset.

With the next Asian Youth Games scheduled for 2029 in Uzbekistan, India's trajectory suggests continued improvement is not just possible but probable. The foundation laid through comprehensive government support via the Ministry of Youth Affairs and Sports, Sports Authority of India programs including Khelo India and Target Olympic Podium Scheme (TOPS) Development, and the involvement of National Sports Federations has created an ecosystem conducive to sustained excellence.

Ending reliance on oil, coal, and gas, and embracing technologies that will only improve and become cheaper over time, is not just smart climate policy. It is the best way to improve economic competitiveness and human prosperity for decades to come.

Try putting yourself in Bill Gates's shoes. You could spend your days on what made you one of the world's richest people while also deploying your wealth to do the most good. You could invest in for-profit ventures pursuing things like clean-energy breakthroughs, or in effecting changes in policy. And to mark your 70th birthday, you could publish an essay that would quickly become a global news story.

Gates has done it all. His essay, "Three Tough Truths About Climate," sent a shockwave through the climate movement on the eve of this year's United Nations Climate Change Conference (COP30) in Belém, Brazil. But the essay is less blueprint than Rorschach test, because anyone can selectively quote from its 5,000 words to support a wide variety of viewpoints.

Like many such documents, this one begins with a strawman. In a move more typical of the Breakthrough Institute, a California-based group founded on the premise that environmentalism harms the climate cause, Gates rejects the "doomsday" argument that "nothing matters more than limiting the rise in temperature." Little does – but Gates chose to go with "nothing," a much stronger word.

He then argues that climate change, though a "serious" problem, "will not be the end of civilization." But supercharged storms and other climate-driven disasters are already upending lives and livelihoods. Of the five recorded storms severe enough to warrant the proposed "category 6" classification, all have happened in the past 15 years.

Moreover, we are not dealing only with massive, headline-grabbing extremes and global tipping points (irreversible



planetary changes). There are also the pernicious, often hidden "slow burn" effects, like the 0.04% loss in annual payroll for one additional day above 32°C (90°F) in any given year. Such costs add up quickly. To point out that we can still live with average global warming below 3°C is hardly reassuring, especially for the poor and vulnerable who already suffer the most

Gates's reasoning on this socioeconomic dimension is understandable. His second and third tough truths focus on human suffering and prosperity, and these are indeed the criteria against which climate progress should be measured. Annual greenhouse-gas emissions, their atmospheric concentrations, the resulting warming, and effects like rising seas and

more devastating storms are all ultimately proxies for lives that will be disrupted or even ended prematurely.

Climate change kills. Economists can now calculate the mortality cost of carbon. Each ton of CO2 emitted today kills around 0.0002 people. Again, such costs can add up quickly. The lifetime emissions generated by every 3.5 Americans today will kill one person by the end of the century.

True, many people already die from other preventable causes. Gates himself has called out US President Donald Trump's administration for cutting aid funding in ways that will kill children in some of the poorest parts of the world. In an effort to make up for some of the shortfall with his own foundation and personal wealth,

Gates has reduced his giving for climate programs and investments, both in the US and globally.

and globally.

No one doubts that there are only so many philanthropic dollars to go around. But climate finance goes well beyond charity, as Gates shows by his own actions. His own total public health and climate funding have increased over time. "Funding," in this case, includes support for Breakthrough Energy (which has no relation to the Institute), which has invested in more than 150 companies that need help scaling up climate technologies by driving down the "green premium" (the added costs of low-carbon technologies relative to high-carbon ones that pay nothing for their negative externalities)

Reducing this premium is necessary for many early-stage startups that have yet to climb the learning curve and benefit from economies of scale. Fortunately, there are plenty of other climate technologies that are already in the money. Solar power's rapid growth over the past half-decade is the result of economics, not benevolence. The same goes for battery prices, which have fallen by about 50% since 2010.

While other low-carbon technologies still command a green premium, most are trending toward profitability. Still, we need creative thinking to help them get there. Co-production helps. A company focused on a single product might lose against incumbents, but spreading the green premium across two or more products can cut costs significantly. The Gates-funded company Brimstone, for example, focuses both on producing lower-carbon cement and on making money from the alumina extracted in the production process. Sublime, a rival cement startup, is pursuing a similar strategy. (I recently co-authored a study with

Brimstone's CEO, Cody Finke, and a half-dozen colleagues, including an employee of another Gates-funded venture, on precisely this point.)

Patience helps, too. Back when Canadian Prime Minister Mark Carney was the governor of the Bank of England, he poignantly described the climate as a "tragedy of the horizon." Too many businesses feel compelled to focus on short-term earnings, just as political leaders are unable to think beyond election cycles. But some of Gates's climate investments, like those in the next-generation nuclear company TerraPower, and especially his investments in Commonwealth Fusion, are deliberately structured to yield returns years or even decades from now.

Supportive policies help, such as the explicit carbon prices and decarbonization targets in the European Union, or the subsidies that are more prominent in the United States. The key, in each case, is to provide long-term investment certainty. This is an area where Gates's essay is especially weak. While Gates fully recognizes the importance of policy, he has created an opening for those, like Trump, who put their personal, short-term gain first.

But make no mistake: the benefits of shifting away from fossil fuels far outweigh the costs. Gates clearly understands that. Clean energy is about sovereignty, energy security, equity, and, yes, future competitiveness. Ending reliance on oil, coal, and gas, and embracing technologies that will only become better and cheaper over time, is not just smart climate policy. It is the best way to improve economic competitiveness and human prosperity

for decades to come.

KU team completes first Kashmiri translation of Constitution of India

Srinagar, Nov 27: On the eve of the Constitution Day, the President of India, Droupadi Murmu, released translated versions of the Constitution in nine Indian languages— Malayalam, Marathi, Nepali, Punjabi, Bodo, Kashmiri, Telugu, Odia and Assamese at Samvidhan Sadan, New Delhi.

Among these, Constitution of India has been translated into the Kashmiri language for the first time, marking a historic moment for the region and its linguistic heritage.

The Kashmiri translation, as per a statement issued on Thursday, has been carried out by a team from the University of Kashmir (KU) under the Ministry of Law, Government of India, and executed through the Central Institute of Indian Languages (CIIL), Mysore.

Why accident insurance cover only for those purchasing tickets online, SC asks railways

New Delhi, Nov 27: The Supreme Court has asked the Indian Railways to apprise it why an accident insurance cover is provided only to passengers purchasing tickets online and not to those booking tickets offline.

A bench of Justices Ahsanuddin Amanullah and K Vinod Chandran was told that the insurance cover is provided only to passengers purchasing tickets online to cover accidents.

Additional Solicitor General (ASG) Vikramjit Banerjee appeared in the court for the railways in the matter. "In addition, the amicus has pointed out that an insurance cover is provided to passengers purchasing tickets online to cover accidents,

which is not available to those who purchase tickets offline. Mr Banerjee is required to take instructions as to the reason for this distinction between the two modes of procurement of tickets," the bench said in its order passed on November 25. The top court was hearing a matter concerning the Indian Railways.

The bench perused a report submitted by the national transporter and said at the initial stage, the focus should be on the safety of tracks and railway crossings, from which other aspects would emerge. It said the railways should continue carrying out its overall plan for the improvement of the system in its entirety. The court, which posted the matter for hearing on January 13, asked the railways to respond with regard to the insurance issue.

Worsening AQI in Mumbai: BMC says it has issued 53 stop-work notices to construction sites

Mumbai, Nov 27: The Brihanmumbai Municipal Corporation on Thursday said it has issued stop-work notices to 53 construction sites for contributing to air pollution, as the city is grappling with deteriorating Air Quality Index (AQI).

The civic body also directed that the air pollution guidelines laid down by it should be followed strictly. These include installing sensors to monitor AQI that remain operational all the time

Ashwini Joshi, Additional Municipal Commissioner (city), warned of strict action if AQI sensors were found to be non-operational.

Earlier in the day, the Bombay High Court said the authorities cannot blame ash clouds from the volcanic eruption in Ethiopia for the air pollution in India's financial capital as the AQI has been poor for long.

A bench of Chief Justice Shree Chandrashekhar and Justice Gautam Ankhad was urged to take up hearing of a bunch of pleas from 2023 on the issue of air pollution in the city. Senior counsels Darius Khambata and Janak Dwarkadas, appearing for the petitioners, said the AQI in the city has been consistently poor and above 300 this month.

Additional government pleader Jyoti Chavan said air pollution has worsened due to the volcanic eruption in Ethiopia two days back.

The court, however, did not entertain the argument.

"Even before this eruption, if one stepped out visibility was poor beyond 500 metres," the court said.

Referring to the situation in Delhi which is witnessing alarming levels of AQI, the HC asked what effective measures can be taken to address the issue.

"We are all seeing what is happening in Delhi. What is the effect of that," the bench questioned, posting the matter for hearing on Friday.

Hayli Gubbi, a shield volcano in Ethiopia's Afar region, erupted on Sunday, producing a large ash plume that rose to around 14 km in the sky. The plume spread eastward across the Red Sea, and towards the Arabian Peninsula and the Indian subcontinent.

Shiv Sena MP Milind Deora wrote to the BMC Commissioner Bhushan Gagrani, urging him to take immediate and extraordinary action, including temporary halt to all digging and

construction sites until the air quality improves.

"Mumbai's air pollution crisis in no longer a seasonal issue --it is a public health emergency. India needs a nationwide war and a national consensus against air pollution," Deora said.

Shiv Sena (UBT) leader Aaditya Thackeray said even as the AQI of Mumbai gets worse every day and Mumbai competes with Delhi on this score, the governments from top to bottom, currently controlled by the BJP and its allies, conveniently ignore the plight of the people.

"In Mumbai, builders and

contractors are a priority for the BJP government, while apart from the construction and demolition works, tree felling in the name of development is the new mantra of the BJP," he alleged.

On its part, the civic body said various steps are being undertaken to address air pollution which includes forcing bakeries and crematoriums to use cleaner fuels, introducing electric buses, managing construction debris scientifically, and using machines for sprinkling water on roads to control dust.

In October last year, the BMC had issued 28 guidelines which include installing metal

fencing and green cloth covering around construction sites to control dust, carrying out water sprinkling, properly storing and transporting debris, installing air quality monitoring devices and setting up smoke absorption systems, among others measures.

To ensure compliances of these guidelines, flying squads have been formed, the civic body said.

The BMC added that as of November 26, it has issued 53 stop-work notices to construction sites contributing to air pollution. These included 17 in Siddharth Nagar (G-South ward), five in Mazgaon (E ward) and 31 in Malad West (P-North ward).

The meeting assessed the department's overall activities carried out under the mandates of the Food Safety and Standards Act (FSSA), highlighting significant progress in surveillance, inspections and legal action against violators.

Commissioner, Food & Drug Administration, SmethaSethi informed the meeting that the department has substantially intensified its surveillance operations. Against an annual target of 7,080 samples, the department has already lifted 10,620 surveillance samples, achieving over 150% of the target, reflecting a strong commitment toward consumer safety.

In terms of enforcement, Food Safety Officers conducted 1,423 Risk-Based Inspections and 13,944 Routine Inspections across the Union Territory. To ensure infrastructure and hygiene compliance, 943 Improvement Notices were issued to Food Business Operators (FBOs) under Section 32 of the FSS Act, surpassing the target of 625 notices.

The Chief Secretary was apprised that strict legal action is being taken against violators. Under the civil adjudication process (Section 30), a total of 718 prosecutions have been launched, of which 671 cases have already been decided, resulting in penalties amounting to Rs 84.33 lakhs. Additionally, 21 criminal cases pertaining to unsafe food have been filed, with convictions secured in 10 cases involving fines and imprisonment.

The meeting also reviewed the outcomes of special enforcement drives conducted during November. A dedicated drive on Ghee led to the seizure of 80.78 kg of stock. Of the 41 samples tested, 12 failed to meet quality standards. Consequently, Prohibition Orders have been issued against the manufacturers of the failed products and the information has been shared with FSSAI and concerned States including Uttar Pradesh, Haryana and Gujarat for

action at the source.
Similarly, a drive on Poly Pack Milk saw 95

samples tested, out of which only 2 failed, indicating high compliance levels. Meanwhile, 32 samples of Packaged Drinking Water were collected and their test reports are awaited.

The meeting further reviewed the department's roadmap for strengthening the food safety ecosystem in the UT. Key strategic decisions included upgrading laboratory infrastructure to enhance testing capabilities. The FSSAI-NABL integrated assessment for the State Food Testing Laboratory (SFTL), Jammu is scheduled within one month, while the upgradation of laboratories in Jammu and Srinagar for advanced antibiotic and microbiological testing is targeted for completion within three months.

Regarding expansion of infrastructure, proposals have been submitted for establishing two additional state-of-the-art food testing laboratories and procuring 10 more 'Food Safety on Wheels' mobile vans to enhance outreach and surveillance in remote and rural

To enhance consumer awareness and promote responsible food practices, the department will roll out "Eat Right Initiatives" and structured training programmes for street food vendors across all districts within the next

quarter.

The Chief Secretary directed the concerned officers to maintain strict vigil on the market, especially with regard to high-risk commodities, and expedite rationalisation and strengthening of enforcement staff to bridge manpower gaps. He emphasized that sustained vigilance, strong enforcement and public participation are essential to ensuring a safe and healthy food ecosystem in Jammu and Kashmir.

Srinagar Police said the searches were conducted strictly in accordance with legal procedures and in the presence of independent witnesses as mandated. Incriminating materials relevant to the ongoing investigation were seized from several locations and will undergo further examination.

Officials said the exercise is part of sustained efforts to prevent unlawful activities and ensure a secure atmosphere for the residents of Srinagar. Police added that further investigation is underway, and legal action will follow based on the findings.

Authorities urged the public to cooperate with law enforcement agencies and report any information or activity that could threaten public order.

In Awantipora, police conducted searches at multiple residential premises belonging to Jel members. Incriminating material and digital devices were recovered, and several individuals were questioned and bound down under the law. In Handwara, acting on credible intelligence,

police carried out a raid at Jamia Islamia Institute, Waripora. Electronic devices seized from the institute are being examined to verify their usage and probe suspected links with the banned organisation.

In Anantnag, police teams searched multiple houses and premises associated with Jel-linked individuals as part of efforts to dismantle suspected support structures. The operation continued through the day, with searches forming part of preventive action against revival attempts of the organisation.

In Budgam, raids were conducted in Chadoora, Soibugh and Beerwah, targeting residences and institutes allegedly linked to Jel. Documents and electronic devices were seized for further examination. Police teams conducting the searches included lady personnel and local witnesses.

In Kulgam, police launched coordinated searches across the district, recovering electronic gadgets, literature and documents suspected to be relevant to ongoing investigations. All material has been taken into custody for scrutiny, police said.

In Pulwama, early-morning searches were conducted at multiple locations linked with Jel members. No incriminating material was recovered during the operation, which was conducted in the presence of an Executive Magistrate and other witnesses.

In Shopian, police carried out wide-scale raids targeting individuals with past or present affiliations to Jel. Electronic gadgets, documents and other materials suspected of supporting clandestine activities were seized and sent for forensic and technical examination.

Police said the operations are part of sustained preventive action across Jammu and Kashmir to counter attempts to revive networks of the proscribed organisation and to curb radicalization. (KNO)

In his address, the PM highlighted the government's 'historic' space reforms and said that opening up the space sector to private players has resulted in Skyroot and others coming up with such innovations.

The PM said that today in India's space ecosystem, private sector was emerging with flying colours. Over 300 space startups were giving new hopes to the sector.

The Infinity Campus is a reflection of India's new thought, innovation and the bigger youth power. Youth's innovation, risk taking-ability and entrepreneurship are touching new heights," the PM noted.

Today, the country's space sector was becoming attractive for global investors. India's private space talent was making its own identity across the globe.

"India's private space talent is making its own identity in the world. Today, India's space sector is becoming an attractive destination for global investors. Today, the demand for small satellites is increasing rapidly in the world," Modi said.

He traced the journey of the Indian space programme from its nascent stages-- where rocket parts were moved in a bicycle, to building the "most trusted launch vehicle."

The journey might have started with limited resources but the growth proved determination decides dreams,

In these changing times, space sector is expanding so much, covering the areas of communication, weather prediction, urban planning and national security, among others.

"So that is why we have made



historic reforms in space sector, opened it up to the private sector, made new space policy. Startups and industry were linked with innovation, set up In-Space," he said.

He further said plans were there to open up the nuclear sector also to private players.

Skyroot's state-of-the-art facility will have around two lakh sq.ft. workspace for designing, developing, integrating and testing multiple launch vehicles, with a capacity to build one orbital rocket every month.

Skyroot is India's leading private space company, founded by Pawan Chandana and Bharath Dhaka, both IIT alumni and former scientists of ISRO.

In November 2022, Skyroot launched its sub-orbital rocket, Vikram-S, becoming the first Indian private company to do so.

The rapid rise of private space enterprises is a testament to the success of the transformative reforms carried out by the NDA Government in the last few years, reinforcing India's leadership as a confident and capable global space power, an official release had earlier said.

In his address, Modi recalled that India's space journey started with limited resources, but its ambitions were never limited. For decades, ISRO has given new wings to the country's space journey, he said, and stressed that credibility, capacity, and value have established India's distinct identity in the sector.

The space agency's facilities and technologies were made available to the startups, he said, pointing out that India's space sector has been transformed into an open, cooperative and innovation-driven eco-system in the last six-seven years.

He said India's youth always place national interest above all and make the best use of every opportunity. Modi said when the government opened the space sector, the country's youth, especially the Gen-Z generation, came forward to take full advantage of it.

"Today, over 300 Indian space startups are giving new hopes to India's space future. Most of these space startups began with small teamssometimes two people, sometimes five, sometimes in a small rented room-with limited resources but with determination to reach new heights. I had the opportunity to meet them," he said, adding this spirit gave birth to the private space revolution in India. The Prime Minister said today, Gen Z engineers, Gen Z designers, Gen Z coders and Gen Z scientists are

creating new technologies.

Be it the propulsion system, composite materials, rocket stages, satellite platforms, India's youth are working in areas that were unimaginable a few years ago, he said.

India possesses space sector capabilities that only a few countries in the world have, the Prime Minister said emphasising that its space capability is both cost-effective and reliable, which is why the world has high expectations from the country. He remarked that global compa-

nies want to manufacture satellites in India, avail launch services and seek technology partnerships, and stressed that the nation must make the most of this opportunity.

decade, a new wave of startups has emerged across diverse sectors such as FinTech, AgriTech, HealthTech, ClimateTech, EduTech and DefenseTech, with India's youth, particularly the Gen-Z generation, providing innovative solutions in every field.

Modi further said that more than 10,000 Atal Tinkering Labs have already been set up to instill a spirit of research and innovation among students, and added that work is underway to establish 50,000 new labs in the coming days.

SC asks Centre to mull stringent law to deal with derogatory remarks against disabled



New Delhi, Nov 27: Highlighting the need for a stringent law to protect the dignity of the disabled, the Supreme Court on Thursday asked the Centre to consider framing a statute to make derogatory remarks ridiculing persons with disabilities and rare genetic disorders a penal offence on the lines of the SC-ST Act.

The Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 criminalises casteist slur, acts of discrimination, humiliation, and violence against the members of SCs and STs and makes offences non-bailable.

"Why can't you bring a stringent law on the lines of the SC-ST Act which criminalises casteist remarks - there is punishment if you demean them," a bench comprising Chief Justice Surya Kant and Justice Joymalya Bagchi said. Solicitor General Tushar Mehta

appearing for the Centre, appreciated the observation and said humour cannot be at the cost of someone's dignity.

The bench also said that there was a need for a "neutral, independent and autonomous" body to regulate obscene, offensive or illegal content in online

On the issue of framing guidelines or putting in place a mechanism to deal with derogatory remarks and ridicule against persons with disabilities (PwD). the bench was informed by the Ministry of Broadcasting that certain guidelines are in the process of making.

The bench asked the ministry to bring the guidelines in public domain for discussion and listed the matter after four

The top court was hearing a petition filed by M/s SMA Cure Foundation, which works for individuals affected by rare Spinal Muscular Atrophy disease. The plea flagged jokes made by "India's Got Latent" host Samay Raina and other social media influencers, Vipun Goyal, Balraj Paramjeet Singh Ghai, Sonali Thakkar, and Nishant Jagdish Tanwar.

They have been asked to do so as a reparation for their insensitive jokes about the disabled.

CJI Kant said the influencers can invite specially-abled persons on their platforms to promote the cause of generating funds to provide timely treatment to those suffering from rare diseases such as SMA.

The bench refused to consider the plea for recall of the direction on the ground that they are not hosting shows that regularly.

"This is a social burden we are putting on you," it said.

Children in climate vulnerable districts of India 25 pc more likely to be underweight: Study

New Delhi, Nov 27: Children in India districts that are highly vulnerable to climate change could be 25 per cent more likely to be underweight, compared to those in less vulnerable districts, indicating how climate vulnerability can impact public health outcomes, a study has found.

Districts highly vulnerable to climate change consistently underperform on achieving health targets, such as stunting and problems accessing healthcare, compared to less vulnerable districts, the study published in the journal PLOS one said. Researchers from Delhi's Institute of

Economic Growth said that with 80 per cent of India's population living in areas highly vulnerable to extreme weather events such as cyclones, floods and heatwaves, risks due to climate change could undermine the country's progress on several Sustainable Development Goals

Member states of the United Nations adopted the 2030 Agenda for Sustainable Development in 2015, a blueprint for ensuring peace and prosperity for people and the planet by 2030. Seventeen SDGs have been described which include ending poverty, achieving gender equality and improving access to clean water and sanitation.

Low and middle-income countries are projected to experience the worst effects of climate change owing to geographical location, such as tropical regions, and a limited capacity to adapt.

The researchers analysed data from the National Family Health Survey-Round 5 and 'Central Research Institute for Dryland Agriculture' (CRIDA), which provides information on a district's climate vulnerability. The study also found a 38 per cent higher likelihood of a non-institutional delivery -- birth occurring outside a healthcare facility -- in districts highly vulnerable to climate change.

"The chance of children being underweight and that of women having non-institutional deliveries, is (25 per cent and 38 per cent) higher, respectively, in districts that are highly vulnerable to climate change than districts that are less vulnerable," the authors wrote.

Bangladesh court sentences Sheikh Hasina to 21 years in jail in corruption cases

Dhaka, Nov 27: A Bangladesh court on Thursday sentenced deposed Prime Minister Sheikh Hasina to 21 years in jail in three corruption cases related to irregularities in allocations of land in a government housing project.

Judge Mohammad Abdullah Al Mamun of Dhaka Special Judge Court-5 sentenced 78-year-old former premier to seven years each in three cases of corruption in the Rajuk New Town Project in Purbachal, totalling 21 years. The judge said Hasina would serve them consecutively.

The judge also fined Hasina Taka one lakh in each case, or 18 months more in prison if she failed to submit the amount.

Judge Mamun also sentenced Hasina's son Sajib Wajed Joy and daughter Saima Wazed Putul to five years imprisonment each in the cases filed against them in the housing project near the capital. Joy and Putul were fined Taka one lakh each, or one month more in case of default.

"The plot was allotted to Sheikh Hasina without any application



and in a manner that exceeded the legally authorised jurisdiction," Judge Mamun said while delivering the judgment.

The judgement came 10 days after Hasina was sentenced to death in absentia by a special tribunal for "crimes against humanity" over her government's brutal crackdown on student-led protests last year.

Hasina maintains the charges against her are "biased and politically motivated".

Hasina has been living in India since she fled Bangladesh on

The man, who was acquitted, is a junior officer of the Ministry. Only one of the accused faced the trial in person, and he was sentenced to three years.

The Anti-Corruption Commission filed six cases between January 12 and 14 and submitted charge-sheets in all of them on

On July 31, the court framed charges in the three cases and issued arrest warrants against the accused. A total of 29 witnesses testified in the cases.

A day earlier, Foreign Affairs Adviser M Touhid Hossain said Bangladesh expects a response from New Delhi to its earlier request seeking the extradition of Hasina, as the "situation is different now" with the judicial process completed and the former premier convicted. India on Wednesday said it is examining the interim government's request to extradite Hasina and asserted that it is committed to ensuring the best interests of the people of that country.

Most Awami League leaders have either been arrested or have fled the country since the collapse of the Hasina regime.

South Africa will NOT be receiving an invitation to 2026 G20: Trump

Washington, Nov 27: US President Donald Trump has said that South Africa will not be invited to the 2026 G20 Summit in Miami, announcing the decision while sharply criticising the South African government over what he described as "horrific Human Rights abuses."

In a post on his social media handle "Truth Social," Trump wrote, "the United States did not attend the G20 in South Africa because the South African Government refuses to acknowledge or address the horrific Human rights abuses endured by Afrikaners and other descendants of Dutch, French, and German settlers."

"To put it more bluntly, they are killing white people and randomly allowing their farms to be taken from them," he

Trump also criticised major US media outlets for not reporting on the issue. "Perhaps, worst of all, the soon to be out of business New York Times and the Fake News Media won't issue a word against this genocide. That's why all the Liars and Pretenders of the Radical Left Media are going out of



business!" he said.

"At the conclusion of the G20, South Africa refused to hand off the G20 Presidency to a Senior Representative from our US Embassy, who attended the Closing Ceremony. Therefore, at my direction, South Africa will NOT be receiving an invitation to the 2026 G20, which will be hosted in the Great City of Miami, Florida, next year," he

Announcing further steps, Trump added that the US would halt financial contributions to South Africa. "South Africa has demonstrated to the world that

they are not a country worthy of membership anywhere, and we are going to stop all payments and subsidies to them, effective immediately," he said.

Trump suspended aid to South Africa in February, alleging discrimination against White farmers. It is unclear what further "payments and subsidies" are being halted, according to CNN.

The US boycotted the 2025 meeting in South Africa amid unfounded accusations that the government there is committing genocide against White South Africans, CNN reported.

Washington, Nov 27: Ukraine will not amend its Constitution as part of any potential peace deal, local media reported, citing a member of the Ukrainian delegation involved in talks with the United States, other partners and Russia.

We have stated that Ukraine will not accept any form of recognition and Ukraine will not make any changes to the Constitution — these are red lines," said Oleksandr Bevz, an advisor to the head of Ukraine's presidential office, on Wednesday (local time).

He said territorial issues should be addressed on two principles: the current contact line should serve as the basis tion with the US side. for talks, and such questions must be handled at the level of national leaders, reports Xinhua news agency, quoting local media outlet Interfax-Ukraine.

According to the head of the presidential office, Andriy Yermak, Ukrainian and US negotiators have reached an agreement in principle on most elements of Washington's proposed peace plan, though it has been significantly revised from the original 28 points.

On Tuesday, President Volodymyr Zelensky said the updated plan could evolve into "deeper agreements."

Zelensky said he had dis-

cussed the plan with Ukraine's negotiating team. "The principles in this document can be developed into deeper agreements. And it is in our shared interest that security is real," he said. He also voiced hope for continued active coopera-

Ukrainian and US ators reached an agreement in principle on most aspects of the US-proposed peace plan, Andriy Yermak, head of



Ukraine's presidential office, said earlier in the day. But the plan was significantly modified from the original 28 points, he

Zelensky hopes to discuss territorial issues directly with Trump, Yermak said.

Ahmedabad could consider nearby venues like Vadodara for cricket in 2030 CWG: IOA CEO Iyer

New Delhi, Nov 27: Ahmedabad's neighbouring city of Vadodara could be in contention to co-host cricket matches during the 2030 Commonwealth Games, Indian Olympic Association (IOA) CEO Raghuram Iyer told PTI on Thursday but also insisted that the organisers would be aiming to conduct a "compact" event

Ahmedabad was on Wednesday formally awarded hosting rights of the Games during the Commonwealth Sport general assembly in Glasgow. The multi-sport event will return to India after two decades, bolstering the country's plan of becoming an Olympic host in 2036. Most of the events are expected to be conducted in the twin cities of Ahmedabad and Gandhinagar as spelt out by Gujarat Principal Secretary for Sports Ashwani Kumar during the press conference on Wednesday.

But since dsiciplines like cricket could require more venues for multiple matches, the organisers could be looking for stadia at nearby cities. Cricket in T20 format is set to be one of the events in the 2030 CWG.

Women's T20 cricket was included in the 2022 Birmingham CWG, but it is still not known whether the men's event will also be added in the 2030

"Nothing is finalised as yet but the organisers would be looking



for venues near Ahmedabad like Vadodara. But it is just in the consideration stage," Iyer told PTI in a telephonic interaction. Vadodara is just over a 100km

away from Ahmedabad. Iyer was among the Indian officials, led by IOA chief PT Usha and Gujarat deputy Chief Minister Harsh Sanghavi, who were in
