He recalled an anecdote involving Mahatma Gandhi and Sardar Patel during their time in Yerawada Jail. "Gandhiji once asked Sardar Patel what post he would like to hold after Independence. Patel replied he would become a sadhu. Yet it was he who ensured the merger of 562 princely states, reshaping

Bharat's map," LG Sinha said.
He emphasized that only Sardar Patel possessed the "guts and willpower" to unite a newly independent country. "Had Patel not been there, India's map would not have been the same. Whether it was Hyderabad or Jammu and Kashmir, Patel wrote a new history," the LG said, adding that Patel played a crucial role in ensuring J&K

acceded to India despite not being directly assigned the state's responsibility.

LG Sinha noted that Patel was never in favour of taking the Kashmir issue to the United Nations, a move that, he said, was steered by Jawaharlal Nehru and Gopalaswami Ayyangar.

"Had the J&K issue been handled by Sardar Patel, India's map would have been different

today," he added. "Sardar Vallabhbhai Patel would have ensured complete and irreversible integration of Jammu Kashmir if he had handled its affairs directly. History of J&K would have been different if Sardar Patel had been given full responsibility for its integration in 1947," LG said.

Army's BrahMos unit executes long range precision strike mission

Srinagar, Dec 01: The Indian Army on Monday successfully carried out a combat missile launch of the BrahMos Supersonic Cruise Missile from a test range in the Bay of Bengal.

According to a statement, issued to news agency-Kashmir News Observer (KNO), the launch was executed in a precisely coordinated mission involving a BrahMos unit of Southern Command and elements of the Tri-Services Andaman & Nicobar Command.



Srinagar, Dec 01: Once considered a low-prevalence region, Iammu and Kashmir is witnessing a slow but steady rise in HIV cases, with health professionals calling for urgent awareness, wider testing, and a decisive push to end stigma. As per details obtained by the

news agency-Kashmir News Observer (KNO), 2,071 new HIV cases and 66 AIDS-related deaths have been recorded in the Union Territory since 2019. Although the overall adult

prevalence in J&K remains among the lowest in the country, hovering between 0.03% and 0.06% in recent years, the



numbers reflect that infections continue to occur, especially among high-risk groups such as people who inject drugs.

Doctors said the new figures

underline a pattern they have been observing quietly for years. "J&K is not a high-burden state, but the upward trend is undeniable. Each new infection is preventable, and each delay in testing has consequences," said a senior physician, requesting anonymity. infectious-disease Another

expert at a government medical college in Srinagar said that late diagnosis remains common. Many patients, he said, walk in only when their immunity is severely compromised. The reason is stigma and misinformation, he said. "If people felt safe coming forward, we would catch infections early and prevent most AIDS-related deaths.'

(Human Immunodeficiency Virus) weakens the body's immune system. Without treatment, it can progress to AIDS, a stage where the

immune system becomes unable to fight common infections.

It mainly occurs due to unprotected sexual contact, sharing needles or syringes, mother-tochild transmission during pregnancy, childbirth, or breastfeeding, and rarely, contaminated blood transfusion where proper screening is absent.

According to doctors, modern antiretroviral therapy (ART) allows people with HIV to live long, healthy lives, and those who take ART regularly and achieve viral suppression cannot transmit the virus sexually.

Health workers said the most vulnerable group in J&K is people who inject drugs (PWID). "Sharing needles | More on P6

CS chairs meeting to review traffic management in Jammu, Srinagar

JAMMU, DECEMBER 01: Secretary, Atal Dulloo Monday presided over a meeting of the Multi-Disciplinary Committee (MDC) on Traffic Management Systems for Jammu and Srinagar, to take a comprehensive look at the measures already undertaken and those proposed for easing congestion, strengthening road safety, and improving overall urban mobility in both cities.

The meeting, as per an official statement, witnessed participation of senior administrative and police officials, including ACS, PWD, Principal Secretary, Home; Commissioner Secretary, H&UDD; Divisional Commissioner, Jammu/Kashmir; IGP, Traffic; Secretary, Transport; DIG, Traffic, Jammu/Kashmir; SSPs Traffic, Srinagar/ Jammu; Commissioner, Municipal Corporation, Jammu/Srinagar; VC, LCMA; Vice-Chairman, JDA/SDA, besides officers from other concerned departments.

During the deliberations, the Chief Secretary underscored that Jammu and Srinagar, being the face of the UT and receiving a continuous flow of tourists and visitors, require swift and focused interventions to enhance commuter experience.

He stressed the need for timely execution of traffic management plans and called for the early operationalisation of Intelligent Traffic Management Systems (ITMS) and Integrated Traffic Light Systems (ITLS). He directed the Divisional Commissioners to monitor

the implementation rigorously. He also stressed on resolving other bottlenecks after incorporating feedback from citizens and stakeholders.

Briefing the meeting on the current status of traffic improvement initiatives, the Divisional Commissioners outlined the steps taken in both cities, such as introducing diversions where required, setting up new roundabouts, installing traffic signals at strategic points, augmenting parking facilities, identifying no-parking stretches, earmarking dedicated bus stops, enforcing one-way traffic on congested routes and adjusting school and college timings. They further informed that dedicated corridors for eastern and western minibuses have been planned, honking zones are being regulated, and additional charging points for Smart City electric buses are also going to be established here.

traffic violations, particularly those related to lane discipline, the Chief Secretary called for strict enforcement. He reviewed action taken against the 9,204 repeat offenders identified so far through e-challans. The Transport Commissioner informed that 600 driving licences had already been suspended and that the remaining cases were being examined for appropriate action based on the seriousness of the

violations. The IG Traffic appraised the meeting about the efforts made to decongest city roads, including zoning of e-rickshaws, implementation of one-way traffic

regimes in selected areas, and installation of road dividers wherever necessary.

The Commissioners of the Jammu and Srinagar Municipal Corporations briefed the Chief Secretary about steps taken to streamline urban spaces, which include establishing designated hawker zones, relocating street vendors, rehabilitating them through kiosk allotment, and ensuring that commercial establishments develop adequate parking facilities.

The Chief Secretary instructed all departments to furnish detailed, location-specific accounts of measures implemented on the ground. Emphasising traffic management in areas with heavy tourist movement, the meeting discussed the necessity of designated parking areas and the use of small-capacity vehicles to prevent congestion caused by larger

Departments also presented updates on initiatives aimed at expanding road capacity through elevated corridors and flyovers, constructing multi-level parking structures, and removing encroachments that obstruct smooth traffic flow.

Road safety measures were also reviewed, including the establishment of no-honking and no-parking zones, construction of medians and dividers, closure of unsafe openings, and rectification of identified black snots in coordination with construction agencies.

The Chief Secretary also enquired about the operational status of the newly procured bus fleet intended

to enhance the city's public transportation network. The Vice-Chairmen of JDA and SDA, along with representatives from Urban Local Bodies, detailed the infrastructural and planning initiatives in progress.

Other aspects discussed in the meeting included pro-curement of enforcement equipment by traffic police such as alcohol meters, breath analysers, speed detection devices and body cameras. The manpower-related concerns within traffic police; safety audits of school buses; improvements in parking and transport planning in urban centres; better management of shikara and water transport; and clearing footpaths and roadways of encroachments were discussed in detail in the meeting.

Secretary Trans-port informed the Chief Secretary about capacity-building efforts initiated with the support of national-level institutions to train various stakeholders involved in urban mobility and transport management.

Reiterating the importance of coordinated functioning among all departments, the Chief Secretary observed that improved logistics and mobility planning is essential for sustainable urban development.

He reviewed progress being tracked through the e-Samiksha portal and urged all departments to maintain focus on implesolutions that can bring about visible and lasting improvements in traffic conditions in both the cities of Jammu and Srinagar.

DC Srinagar, SMC Commissioner inspect work on Nawab Bazar-Darish Kadal corridor

SRINAGAR, DECEMBER 01: Deputy Commissioner (DC) Srinagar, Akshay Labroo along with Commission-er Srinagar Municipal Corporation Faz Lul Haseeb, SSP Traffic City Ai-jaz, Principal GMC Srinagar Dr Iffat on Monday conducted an on-site inspection of the initiation of work on NawaBazar- Darish Kadal alternate route for traffic decongestion and management measures in the critical medical zone surrounding Shri Maharaja Hari Singh(SMHS) Hospital, Super Specialty Hospital and Dental College.

The project, as per an official statement is a part of the broader mobility improvement and traffic regulation plan along the Nawab Bazar-Kaksaraie-Darish Kadal Corridor aimed

at streamlining vehicular movement by distributing traffic through the Suner Kul route. During the visit, the DC and SMC Commissioner along with senior Officers and engineers, carried out an onsite assessment of the works initiated to develop this alternate road for improving mobility and decongesting the critical Medical Area around Super Specialty Hospital, SMHS and Dental College. The project shall allow for alternate vehicular movement through a specialised route. An on-site assessment of establishing a dedicated parking facility around the high-priority hospital zone encompassing SMHS Hospital, Dental Hospital and the Super Specialty Hospital to prevent roadside congestion and facilitate smooth access for patients, attendants and emergency

vehicles was also deliberated upon. The Nawab Bazar-Kak

Saraie-Darish Kadal corridor via the Suner Kul bund link, is aimed at ensuring smooth mobility and decongested vehicular movement.

The DC directed the concerned executing agencies to ensure that the pace of work on the approved decongestion project is maintained at a fast rate so as to ensure timely completion of the project, emphasizing the need to prioritize interventions that guarantee swift patient movement and timely ambulance access, while minimizing inconvenience to local residents, traders, and commuters. He noted that the proposed corridor would help redistribute traffic load, reduce bottlenecks in densely populated market stretches and streamline the approach roads leading to the major hospitals of Srinagar City.

CS chairs APD review meeting

Jammu, Dec 01: Chief Secretary, Atal Dulloo Monday chaired a detailed review meeting of the Agriculture Production Department (APD) to examine the modalities of a comprehensive plan aimed at significantly enhancing milk production, processing, and value-addition across Jammu & Kashmir.

The meeting was attended by Additional Chief Secretary, APD; Principal Secretary, Finance; Commissioner Secretary, Cooperatives; Secretary, RDD; Managing Director, HADP; Representative from NABARD and other senior officers of the Department.

During the meeting, the Chief Secretary took an in-depth appraisal of the proposed roadmap prepared by the Department to give a major boost to dairy development in the UT. He stressed the need to study the outcomes of dairy sector interventions already being implemented under HADP and build upon their strengths while designing the new plan.

He observed that a well-structured strategy, supported by robust infrastructure and efficient value chains, would help achieve substantial progress in the



sector and ensure maximum benefits to dairy farmers across J&K.

Thunder

The Chief Secretary also directed the Department to study successful models from other states to identify best practices suitable for local conditions. He further emphasised close coordination with the National Dairy Development Board (NDDB) to integrate its expertise and ongoing programmes for optimised results in J&K's dairy ecosystem.

Highlighting the scope of growth in the sector, ACS APD, Shailendra Kumar informed that J&K presently ranks 8th in the country in milk production, with per capita availability standing at 577 grams per day. Despite producing around 80 lakh litres per day (LLPD), only about 4 LLPD is currently being processed, he noted.

He added that dairy development is among the most promising sectors in J&K, capable of achieving surplus production in the coming years. Citing a projected growth rate of 6.55% CAGR, he stated that milk production is expected to reach approximately 50.74 MT by 2031-32. He also briefed the meeting about the ongoing interventions to boost pro-

duction, processing, and

value-addition. Providing details of the newly proposed initiative, the MD HADP, Sandeep Kumar informed that the plan is designed for implementation over a seven-year period from 2026-27 to 2033-34. The scheme aims to integrate more than five lakh dairy farmers through an organised, technology-driven value chain.

The plan focuses on two

major, mutually reinforcing components comprising of the establishment of modern, automated milk processing plants across production zones; and creation of an extensive, decentralized network of milk collection, chilling, and allied infrastructure to support the processing facilities.

It was further Informed that the scheme adopts a farmer-centric model aimed at decentralising power and profits. It was elucidated that the implementation will be carried out primarily through farmer-owned organisations, including Cooperatives, Farmer Producer Organisations (FPOs/ FPCs), and Self-Help Group (SHG) cluster federations. Technical and administrative support will be provided by NDDB and the Animal Husbandry Department of J&K.

Officials also apprised that the plan ensures balanced geographical development by propos-ing a milk processing plant in every major production area. Each plant will be established with significant initial processing capacity, expandable up to 1 lakh litres per day (LLPD), based on future growth and coverage of at least 20% of the production through this network here.

The project also envisions the formation and strengthening of Dairy Cooperative Societies to build a direct link between dairy farmers and the newly proposed processing facilities, thereby ensuring better remuneration, transparency, and long-term sustainability for the dairy sector in J&K.

Uptick in temperature post snowfall in high reaches

Srinagar, Dec 01: Following the fresh snowfall in higher reaches, Kashmir valley witnessed a slight reprieve from the bitter cold on Monday as the region witnessed a rise in minimum temperatures, officials said.

According to meteorological sources, "A light snowfall was reported in Minimarg region near Zojila Pass along the Srinagar-Kargil route The overnight cloud cover across the valley contributed to an increase in temperatures compared to the previous night, they added."

Srinagar recorded a min-imum of minus 1.9 degrees Celsius on Sunday night up from minus 4.4 degrees Celsius, officials said. North Kashmir's Baramulla recorded the lowest temperature in the valley at minus 4.7 degrees Celsius.

Qazigund registered a minimum of minus 1.0 degrees Celsius, while Kupwara recorded minus 3.2 degrees Celsius, officials

South Kashmir's Kokernag area reported a low of 0.2 degrees Celsius, and the Pahalgam recorded minus 0.4 degrees Celsius, showing an increase of over five degrees compared to the previous night.

Gulmarg recorded 0.3 degrees Celsius, a rise of two degrees from the previous day. Officials said the weather pattern

stable over the next few days due to the continued presence of cloud cover and light precipitation in some areas.

They added that the snowfall at higher reaches may affect road conditions along Srinagar-Kargil and other connecting routes-advising travelers to take precautions.

The officials also said that residents of low-lying areas experienced slight relief from cold wave conditions due to the increase in night temperatures.



The meteorological department said similar weather conditions are expected to continue in coming days with intermittent cloud cover and occasional light snowfall at higher altitudes.

Officials urged people to remain cautious while traveling to hilly and mountainous

Sharma said, "The government has not fulfilled its responsibility of rehabilitating families affected by landslides, floods and land subsidence in the Chenab region and other areas."

He said, "As many as 5000 houses for disaster-hit families were being built in the Union Territory through an NGO from Tamil Nadu and not with government funding. "A saint from South India has taken the



responsibility of constructing houses where the government could not do so," Sharma said.

On the ongoing demolition encroachment-related actions, Sharma said the BJP fundamentally opposes encroachment on any land, including state or private property. However, he said genuine landless families must be identified and supported under the Pradhan Mantri Awas Yojana.

Sharma said, "Prime Minister Narendra Modi had already laid down norms for providing land assistance to landless and houseless beneficiaries."

He said daily wagers, SPOs, contractual workers, need-based workers and other low-income

employees should be covered under government welfare Sharma said a review was

> needed to define the ir threshold that determines eligibility for government benefits.

Solving traffic snarls needs public support: SSP traffic

Srinagar, Dec 01: Senior Superintendent of Police (Traffic City), Ajaz Ahmad Bhat Monday said traffic gridlocks cannot be completely eradicated due to structural limitations but citizen discipline can prevent the congestion.

The SSP said that the Traffic Department is intensifying enforcement and regulation measures in Srinagar while the long-term decongestion depends on coordinated infrastructural interventions by the

Speaking to media persons in Srinagar, the SSP said that the department's role is limited to regulation and enforcement. "The infrastructure upgrades such as road widening, alternate routes and parking facilities fall under the purview of the administration."

"We can regulate and act against vioators, but creating infrastructure is the administration's responsibility. The district administration regularly takes our suggestions and if the suggestions are implemented effectively, these steps can significantly ease the congestion," he said.

The SSP said the city's key stretches, including areas around SMHS and Super Specialty Hospitals, face severe congestion due to the flow of vehicles of patients and other vehicular movement, street vendors and narrow road space.

"Some areas require exclusion zones or alternate routes. We are working with the administration to identify such points," the

He said that the department will intensify



action through smart enforcement and contactless challan systems against the violators under the new Integrated Traffic Management System (ITMS).

"The contactless challan mechanism will ensure transparency. People will receive automated challans for the violations. The violators who won't change their pattern of driving will face penalties," he shared.

He added that "The traffic jams cannot be completely eradicated due to structural limitations, smart regulation but the citizen discipline can prevent gridlocks that will help in ensuring smoother mobility."-KNO)

Scientific mobility plan to ease traffic congestion: DC Sgr

Srinagar, Dec 01: Deputy Commissioner (DC) Srinagar Akshay Labroo on Monday said the administration has rolled out a coordinated and technology-supported plan to tackle the traffic congestion in a systematic way across the district.

Speaking during a field inspection of the Sonarkol Road project near the Super Speciality Hospital and Government Dental College, DC Labroo said that a series of mobility-focused projects, ranging from new link roads to improved traffic enforcement are being executed to ease daily movement through the city's most congested zones.

He said the Sonarkol link road that is currently under construction will connect Nawa Bazar with Safa Kadal and provide an alternate route for ambulances and commuters.

He said the district administration, Srinagar Smart City, R&B, Traffic Police and other departments are working in close coordination under a multidisciplinary committee chaired by the Chief Secretary and Divisional Commissioner.

He said that the recent infrastructural upgrades such as the Sanatnagar flyover and Noor Jahan Bridge have already provided partial



relief. "The ongoing scientific mobility plan will be implemented in phases to ensure lasting impact."
The DC further added that "The

administration is focused on creating a long-term system that offers infrastructure expansion, smart traffic solutions and disciplined driving behaviour so that Srinagar moves not just faster, but smarter.'

Meanwhile, a statement issued by administration as accessed by KNO reads, Deputy Commissioner (DC) Srinagar, Akshay Labroo along with Commissioner Srinagar Municipal Corporation Faz Lul Haseeb, SSP

Traffic City Aijaz , Principal GMC Srinagar Dr Iffat conducted an on-site inspection of the initiation of work on NawaBazar-Darish Kadal alternate route for traffic decongestion and management measures in the critical medical zone surrounding Shri Maharaja Hari Singh(SMHS) Hospital, Super Specialty Hospital and Dental College.

The statement reads, the project is a part of the broader mobility improvement and traffic regulation plan along the Nawab Bazar-Kaksaraie-Darish Kadal Corridor aimed at streamlining vehicular movement by distributing traffic through the Suner Kul route.

During the visit, the DC and SMC Commissioner along with senior Officers and engineers, carried out an onsite assessment of the works initiated to develop this alternate road for improving mobility and decongesting the critical Medical Area around Super Specialty Hospital, SMHS and Dental College.

It said that the project will allow alternate vehicular movement through a specialised route. An on-site assessment of establishing a dedicated parking facility around the high-priority hospital zone encompassing SMHS Hospital, Dental Hospital and the Super Specialty

Hospital to prevent roadside congestion and facilitate smooth access for patients, attendants and emergency vehicles was also deliberated upon.

"The Nawab Bazar-Kak Saraie-Darish Kadal corridor via the Suner Kul bund link, is aimed at ensuring smooth mobility and decongested vehicular movement,"

The DC directed the concerned executing agencies to ensure that the pace of work on the approved decongestion project is maintained at a fast rate so as to ensure timely completion of the project, emphasizing the need to prioritize interventions that guarantee swift patient movement and timely ambulance access, while minimizing inconvenience to local residents, traders, and commuters.

He noted that the proposed corridor would help redistribute traffic load, reduce bottlenecks in densely populated market stretches and streamline the approach roads leading to the major hospitals of Srinagar City.

The DC further highlighted that all measures are being implemented in close coordination with SMC, Traffic Police, local stakeholders, and health authorities to ensure smooth execution with minimal disruption—(KNO)

PM's Timely Call For Police Reform

Prime Minister Narendra Modi's address to the nation's top police leadership in Raipur strikes at the heart of a long-standing challenge: the widening trust deficit between the police and the public. His directive to urgently transform public perception, particularly among the youth, by enhancing "professionalism, sensitivity, and responsiveness" is not just a platitude but a critical imperative for a 21st-century democracy. While the conference's focus on

leveraging technology like AI and the NATGRID database for intelligence and island security is forward-looking, it is this human-centric call for image overhaul that forms the most significant and difficult takeaway. For decades, the common citizen's interface with the police has been marred by perceptions of indifference, corruption, and opaque functioning. The youth, especially, often view the force as an instrument of control rather than a service for protection. This erodes cooper-

ation, hampers intelligence gathering, and ultimately weakens the entire justice delivery system. Technology, while a powerful enabler, cannot alone bridge this gap. A sophisticated AI-driven intelligence grid is of limited value if the constable on the street is perceived as unapproachable or biased. Therefore, the PM's emphasis on sensitivity and responsiveness must translate into concrete, ground-level reforms. It requires a systemic shift - from custodial attitudes to service-oriented conduct.

from opacity to transparency, and from brute force to measured, lawful authority. Investing in continuous training in soft skills, human rights, and community policing is as vital as investing in new software. Decentralising authority and establishing swift, fair grievance redressal mechanisms can rebuild bridges of trust. The parallel focus on holistic development in the affected areas underscores a key insight: security is inseparable from civic progress and social justice. A police force

perceived as a partner in development, rather than just a punitive presence, will naturally garner greater public cooperation. The annual DGPs' conference has rightly set its sights on high-tech frontiers. But its most enduring success will be judged by a simpler metric: when a citizen, particularly a young one, views a police uniform not with apprehension, but with a sense of security and hope. That transformation is the true foundation of a safe and secure nation.


Transforming India's Labour Landscape: Labour Codes For A Vikshit Bharat

Implementation of four labour codes marks a major step towards simplified regulations, enhanced worker welfare, and economic growth, while addressing media misconceptions

n a landmark development, Government of India has implemented four Labour Codes with effect from 21st November 2025, bringing labour reforms enacted by the Parliament into reality. Following this, different views and news articles have surfaced in media on its impact, driving the debates and discussions on this pertinent issue. This piece is aimed to clear some of the confusions being created on the efficacy of the Codes. The Government has consistently strived to uphold the dignity of labour through various labour laws and strong social security framework. However, in order to bring about economic transformation among the labour class, availability of meaningful employment opportunities is a prerequisite and, in a labour,-surplus economy like India, it is unrealistic for Government to generate employment for all. This is where the private sector plays a crucial role provided enabling sociolegal framework and progressive, forwardlooking labour laws are in place that reflect the aspirations of a 21st-century India.

For decades, India's labour ecosystem was governed by 29 central laws-many of which date back to the pre-independence era. To overcome the challenges of multiplicity, complexity and outdated provisions and in line with the recommendations of the Second National Commission on Labour (2002), the Government of India initiated one of the most far-reaching reforms in the country's labour history by enacting four comprehensive Labour Codes—the Code on Wages, 2019, the Code on Social Security, 2020, the Industrial Relations Code, 2020, and the Occupational Safety, Health and Working Conditions Code, 2020. Remarkably, these reforms mark a major milestone with right sequencing after the 1991 liberalisation and structural adjustment en framework for progressive labour ecosystem and industrial growth.



The Labour Reform: Through rationalisation and modernisation of previous labour laws, the four Labour Codes have significantly streamlined the regulatory framework. The number of sections has been reduced from 1,228 under the previous 29 Acts to just 480, while the number of rules has come down from 1,436 to 351, forms from 181 to 73 and registers from 84 to merely 8. This significant consolidation and harmonisation will enhance both ease of living for workers and ease of doing business for employers across the country.

One of the most notable reforms under the Code on Wages is the universalisation of minimum wages, making them applicable to all employees across both the organised and unorganised sectors, which was restricted to

specific 'scheduled employments' under the previous Acts. The 'floor wage' to be determined by the Central Government will reduce the regional imbalance as the states can't set the minimum wage below the nationally defined threshold. Another progressive change is the replacement of the traditional labour 'inspector' with the 'inspector-cum-facilitator' with the mandate to guide and create awareness, marking a clear shift away from the rigid and often criticised "inspector raj". Furthermore, all four Codes have decriminalised minor offences and introduced compounding provisions for first-time violations, signalling a move from a punitive to a corrective and trust-based regulatory approac

The Industrial Relations (IR) Code introduces the concept of Fixed Term Employment

(FTE), ensuring that fixed-term workers receive the same benefits as permanent employees, including gratuity after one year of service. This reform provides industries with much-needed flexibility to hire according to operational requirements while safeguarding the rights and welfare of workers. This will reduce contractualisation. The 14-day notice period before strikes and lockouts by the workers will promote industrial peace and harmony, which under the previous law was applicable only to public utility services. This change will encourage the resolution of disputes through dialogue and negotiation rather than disruption. Additionally, the Code provides statutory recognition to trade unions, something missed out in the media analysis, through the 'Negotiating Union' or 'Negotiating Council', thereby strengthening collective bargaining mechanisms and promoting labour welfare. The Code also revises the threshold for prior government approval in cases of retrenchment, lay-offs, and closures from the existing 100 workers to 300 workers in factories, mines, and plantations.

The most ambitious reform carried out in this process is through the Code on Social Security, that formally recognises the gig and platform workers for the first time. With this, India becomes one of the first countries in the world to extend legal and social protection to this emerging work force. It also provides for the creation of a Social Security Fund with multiple financing mechanism to support unorganized including the gig and platform workers through various welfare schemes, thereby taking a major step toward inclusive and equitable labour welfare.

Likewise, the OSH code that governs the provisions related to workplace safety, welfare, and working conditions of the workers introduces single registration, single license and single return—a major step toward ease of doing business in the country with license validity for five years. Importantly, it promotes gender equality by allowing women

to work in all sectors and during night shifts, with their consent and adequate safety measures. It also mandates free annual health check-ups for workers and the issuance of appointment letters to all employees leading the way to formalization. Additionally, the Code raises the applicability thresholds, thereby reducing the compliance burden on smaller establishments. For instance, for the applicability of contract labour; the threshold increased from 20 to 50, for applicability of factory provisions, from 10 to 20 workers and 20 to 40 workers (with and without power respectively). These changes collectively create a more streamlined, worker-friendly and business-conducive regulatory environment.

Towards a Vikshit Bharat: The four labour codes collectively seek to strike a balance between the welfare of workers and the flexibility of the industry and employers. By streamlining definitions, digitizing compliance, and promoting gender neutrality, the four labour codes are designed to usher into an equitable labour eco-system, matching the country's aspiration of a Vikshit Bharat by 2047. The Institute for Studies in Industrial Development's (ISID) India Industrial Development Report 2024-25 suggests that, there is significant manufacturing opportunity available in India with the Government of India's policies of 'Making-for-India and Making-for-the-World' which are labour, skill and resource intensive. The country has potential to more than double the manufacturing value added (MVA) from US\$ 717 billion in 2024 to \$1.45 trillion by 2030, out of the \$7.5 trillion GDP, therefore, eventually creating millions of decent jobs both direct and indirect. Implementation of the four Labour Codes will complement the effort to provide the industries, much needed flexibility and deregulation with mandates of universal labour welfare and social security for our workforce.

During the past 45 years in my psychotherapy office, I've heard countless people lament how unappreciated they feel.

Humans thrive when we feel genuinely valued. Those who claim not to need validation may actually pursue it in indirect, less-than-effective ways—struggling to gain people's respect and admiration through power, wealth, or status. Such "achievements" may offer a bounty of empty calories, temporarily inflating the ego without truly satisfying the deeper longing to be appreciated for who we really are.

Do We Really Need Appreciation?

We might reasonably question whether the desire for appreciation is a fool's errand—launching us on a search for something we have no control over. It's a legitimate concern. As Buddhist psychology suggests, the effort to reach for something outside of ourselves to fill an inner void is a

setup for suffering.

Having said that, it's hard to deny that something in us perks up and feels enlivened in a unique way when we're seen and valued. Being touched by appreciation offers:

A way to feel a sense of connection with

Noting and valuing features of our personality that have been helpful to them,
such as our kindness, generosity, or capacity

to listen well

Is It an Ego Trip or Something More Soulful?

We might reduce the longing for validation to a mere ego trip—a desire to steady a wavering self-image. This is a legitimate concern. If you find yourself craving appreciation or complaining about how little you

get, you might consider your motivation.

Perhaps what you crave externally is something you need to offer yourself internally. If there's a part of you that feels worthless, inadequate, or less than others, you might find yourself on an endless search for something you really need to internalize. Perhaps the longing for validation contains a quiet message that you need to offer acceptance, appreciation, and recognition to the parts of you that feel unseen, lonely, or

Having said that, no one is an island. There's nothing wrong with wanting appreciation, as long as we don't get so attached to it that we neglect giving it to ourselves. Self-acceptance and self-care are what we have the most control over. Yet relying more on ourselves doesn't mean closing ourselves off to others' appreciation—or ignoring it when it drifts our way.

Can We Let It In?

Something to consider: Are you noticing the appreciation that you do get? If we've grown accustomed to not being appreciated, we may fail to see it when it comes. Becoming more mindful of when someone thanks us for a well-prepared meal or kind action might buoy our spirits. Appreciation might also come in softer varieties easily overlooked, such as a warm glance or kind smile.

As expressed in my recent book, The Power of Gentle Presence: Insights for Inner Peace and Deeper Relationships:

"The next time someone offers a gift, a kind word, or gesture of recognition, take a breath and allow the good feeling to register throughout your entire body and being. Notice if a sense of gratitude and appreciation well up inside you—and experiment with allowing a friendly smile or words of gratitude to bubble up from this deeper wellspring of your being."

How to Garner More AppreciationA good way to gather more appreciation

from others is to offer it to others. How often do you convey kindness and gratitude toward the people in your life who you appreciate? Are you awake to fleeting moments when someone does or says something kind? Can you find words to convey your appreciation?

If you'd like to garner more recognition from others, look for opportunities to spread yours around more generously. What goes around truly does tend to come around. Try it and see.

Appreciation isn't something we need to chase; it tends to arise unassisted as we embody a gentle presence with ourselves and others. When we let appreciation touch us—and extend it to others who may need it just as much—we create a more loving space within us and between us.

KPDCL commissions 33/11 KV Kanzalwan Receiving Station

Commits to strengthen power infra, implementation of RDSS works across Gurez

SRINAGAR, DECEMBER 01: Kashmir Power Distribution Corporation Limited (KPDCL) has achieved a major milestone in strengthening the power infrastructure of the remote Gurez region with the commissioning of the 33/11 kV, 6.3 MVA Kanzalwan Receiving Station.

According to an official statement issued on Monday, the achievement follows the directives issued during a recent review visit to Gurez by the Managing Director, KPDCL, alongside the Chief Engineer Distribution and senior officials.

The visit, aimed at assessing winter preparedness, resulted in firm instructions to prioritize the commissioning of the Kanzalwan Receiving Station, complete grid connectivity for all habitations, ensure adequate High-Speed Diesel (HSD) dumping, and expedite Smart Metering for improved load management.

These measures were considered essential for maintaining uninterrupted power, especially when the region switches to standalone mode due to intermittent snapping of grid connectivity with Grid Station Bandipora.

Acting swiftly and efficiently within the limited working season, the Executive Engineer ED Bandipora and Executive Engineer STD Ganderbal mobilized resources on a war footing and completed target Korangbal (62.5 kVA), and Kanzalwan (320 kVA). To further secure unin-

terrupted power availability through the harsh winter, KPDCL has stocked 4,68,000 liters of HSD, sufficient to meet regional requirements until May 2026.

In parallel, under the Revamped Distribution Sector Scheme (RDSS), KPDCL is concurrently progressing with advanced infrastructure and technological upgrades across Gurez. As part of the initial phase, 300 Smart Meters have been installed on the Dawar and Wanpora feeders, significantly enhancing operational efficiency, improving consumer-side load management, and reducing Aggregate Technical & Commercial (AT&C) losses.

KPDCL reiterates its commitment to strengthening power infrastructure, accelerating RDSS implementation, and ensuring a resilient and reliable electricity supply across the remote and challenging terrains of Gurez.

SRINAGAR, DECEMBER 01: A review meeting regarding the creation of Out-Village infrastructure for Rural Piped Water Supply Schemes (RPWSS) was held Monday under the chairmanship of the Mission Director, Jal Jeevan Mission, Jammu & Kashmir.

The meeting, as per an official statement, was attended by Chief Engineers, Jal Shakti Department, Superintending Engineers (Hydraulic) of all circles, Technical Officers with Chief Engineer, PHE Jammu/ Kashmir and officers of Mission Directorate, Jal Jeevan Mission.

The meeting focused on accelerating the preparation and uploading of infrastructure details required for the Out-Village component of RPWSS, as mandated under the Jal Jeevan Mission digital framework.

During the meeting, the Mission Director emphasized the need for timely and accurate configuration of scheme architecture, ensuring complete mapping of existing and proposed water infrastructure, including sources, reservoirs, treatment systems, pumping systems, and transmission networks.



To streamline the process, the technical team presented step-by-step guidance for RPWSS creation, based on an illustrated flow framework which included Identification and merging or demerging of schemes for RPWSS ID creation, Selection of villages benefiting from the scheme and associated habitations, Mapping of water sources, including newly added sources where required, Incorporation of raw water reservoirs followed by Raw water transmission mains, Valves and hydraulic control components. Entry of Water Treatment Plants (WTPs) associated with the scheme, Addition of Clear Water Transmission (CWT) mains and valves, Mapping of pump houses (non-gravity systems), Integration of MBR/ **ZBR** units and Overhead Tanks

(OHTs), Entry of Feeder Mains up to distribution point.

The Mission Director reiterated that all divisions must ensure complete, verified, and field-reflective documentation before uploading the final structure into the system to avoid discrepancies during validation and implementation.

He urged the circles to provide information of these mother-child schemes so that single ID's are created for these schemes as directed by the Ministry of Jal Shakti, National Jal Jeevan Mission.

The MD directed the Superintending Engineers to complete the process on war footing basis which will ensure assured funding in future for these schemes. The meeting was informed that technical sessions regarding creation of RPWSS ID's will be held with divisions in coming days for handholding of divisional staff, so that the whole process is completed within the set timelines.

The MD also reviewed cle-wise mapping of the pipeline laid under PM Gati Shakti. He directed the concerned SE's to speed up the process of pipeline mapping and uploading on the PM Gati Shakti.

These training centres, as per an official statement, are functional in Srinagar, Pulwama, Shopian, Kulgam, Baramulla, Ganderbal, Anantnag Bandipora districts.

Sharing details in a press statement issued here Monday, a spokesman of the Department stated that the modern spinning

charkhas designed by SKUAST Kashmir provide a healthy posture to the spinners, who earlier had to sit on haunches to hand-spin the Pashmina wool, an arduous task known only to the famed artisans of Kashmir. "The modern charkha also increases daily yield at least three times, thereby increasing the financial income of the artisans," he added.

Highlighting the salient features, the spokesman further stated that these paddle-driven charkhas contribute to enhance uniformity in the Pashmina yarn count. "The modern charkha is also easy to operate and offers a comfort zone to the spinners, contrary to the much tiring experience on the traditional charkhas earlier." he added.

Rly's Jammu Div generates ₹57 lakh revenue from ticket checking during Nov

Jammu, Dec 01: Under the guidance of Divisional Railway Manager, Vivek Kumar and the leadership of Senior Divisional Commercial Manager, Uchit Singhal, the ticket checking staff of the Jammu Division of Northern Railway are conducting special ticket checking drives every month at stations and trains to curb ticketless and irregular travel, ensuring comfortable travel and better services for all genuine rail passengers.

These drives are conducted at various railway stations Jammu, including Pathankot Cantt, Pathankot City, Srinagar, etc. During the ticket checking drive in November 2025, the divisional checking staff and Chief Ticket Inspectors apprehended 9,346 passengers for irregular travel, resulting in a fine of approxi-

mately ₹57 lakh. The Division officials also conduct regular surprise ticket checking drives to prevent unauthorized entry of passengers onto trains and stations, ensuring passengers travel with valid tickets.



Regular checks are conducted to maintain cleanliness at all railway stations in the division and to prevent public littering. During this check, in November 2025, approximately 17,000 rupees in fines were collected from 53 passengers for littering within the station premises.

Regarding the monthly

ticket checking drive conducted in the division, Uchit Singhal, said that ticket checking drives will continue to curb ticketless and irregular travel. "Such drives will increase railway revenue. The aim of this drive is to ensure transparency in the ticketing system while providing convenience to passengers," he added.

RBI governor releases five-year national financial inclusion strategy

Mumbai, Dec 01: Reserve Bank Governor Sanjay Malhotra on Monday released a national strategy aimed to deepen financial inclusion over the next five years.

The 'National Strategy for Financial Inclusion (NSFI): 2025-30 emphasises a synergistic ecosystem approach, improving the quality and consistency of last-mile access and effective usage of financial services.

The strategy lists out five objectives called 'Panch-Jyoti' that are aimed at elevating the state of financial inclusion in the country and 47 action points to achieve.

These include adopting a gender-sensitive approach for women-led financial inclusion and differentiated strategies for improving the financial resilience of households, especially for the underserved and vulnerable segments, as per an official statement.

Efforts are also centred around improving the availability and use of an equitable, responsible, suitable, and affordable bouquet of financial services to achieve financial safety and financial security for households and micro enterprises, the RBI said.

The Panch-Jyoti strategy is also focusing on synergising livelihood, skill development and support ecosystem and its linkages with financial inclusion, the central bank said. In his foreword, Malhotra said that the earlier five-year strategy ending in 2024 has achieved its objectives.

Efforts will also be made to leverage financial education as a tool for promoting financial

discipline, and strengthen the quality and reliability of customer protection and grievance redressal measures.

The five-year strategy has been framed under the aegis of Technical Group on Financial Inclusion and Financial Literacy (TGFIFL) following country-wide discussions with various stakeholders by the RBI and consultations involving the Department of Economic Affairs and Department of Financial Services, Ministry of Finance, Securities and Exchange Board of India, Insurance Regulatory and Development Authority of India, Pension Fund Regulatory Development Authority, National Bank for Agriculture and Rural Development, National Skill Development Corporation. and National Centre for Financial

Anil Ambani moves SC against SBI classification of his account as fraud

Delhi, Dec 01: Industrialist Anil Ambani has moved the Supreme Court challenging an order of the Bombay High Court which upheld the State Bank of India's (SBI) decision classifying his and Reliance Communications' accounts as fraud.

The matter is yet to be

listed for hearing.

The High Court had on October 3 dismissed Ambani's plea challenging the SBI decision and said there was no merit in the

The SBI had last year classified the accounts as fraud, alleging misappropriation

transactions that violated the terms of loans extended

Ambani moved the HC, arguing that the bank had not followed the principles of natural justice as it did not grant him a hearing.

Certain documents, based on which the classification orders were passed, were not provided to him initially and were furnished only after six months, the petition claimed.

The bank this year lodged a complaint with the Central Bureau of Investigation which searched premises linked to Reliance Communications Ambani's residence.

Bitcoin dips below USD 85 000 in cryptocurrency rout

New York, Dec 01: Bitcoin and companies tied to cryptocurrencies extended a nearly two-month swoon Monday, tracking with a broader market sell-off in technology companies that many see as overvalued. Bitcoin, which soared to a record USD 126,210.50 on October 6 according to crypto trading platform Coinbase, slid 11.8 per cent to below USD 85,000. That's a decline of about 33 per cent in just eight weeks.

Stocks across the crypto industry tumbled, with Coinbase Global sinking 5.1 per cent and online trading platform Robinhood Markets losing 5.2 per cent. Bitcoin mining company Riot Platforms dropped 5.4 per cent.

Strategy, the biggest of the socalled crypto treasury companies

that raises money just to buy bitcoin, tumbled 10.3 per cent. The company has reported holding 649,870 bitcoin. As of 11 am ET Monday they were worth about USD 55 billion.

American Bitcoin, in which President Donald Trump's sons Eric Trump and Donald Trump Jr. hold a stake, fell 7.2% and is now down more than 41 per cent since September 30.

Other Trump-related crypto ventures have seen declines as well. The

"Drones seen across the border are primarily reconnaissance or surveillance drones. We are monitoring every movement with upgraded night-vision and radar integration systems," he said.

He said the BSF's new surveillance devices, upgraded night-ops systems, and AI-assisted thermal imagers have strengthened the force's ability to detect infiltration or aerial movement even in difficult weather and terrain.

Experts outline five pillars of HIV prevention, all of which need strengthening in J&K: early testing and linkage to ART, safe sexual practices, harm reduction for PWID (such as needle-syringe programmes and opioid substitution therapy, which are proven to reduce transmission but remain limited in reach), testing pregnant women and providing timely ART to protect newborns, and community outreach and awareness

"People still fear being judged more than they fear the disease itself," said a psychiatrist involved in HIV counselling. "Stigma pushes the virus underground. It stops people from getting tested, hides cases within families, and delays treatment."

He added, "Many people wrongly believe HIV spreads through casual contact - sharing food, shaking hands, or sitting together. These myths isolate patients and damage public health."

Health experts said that HIV is now a treatable medical condition, not a moral issue, and must be approached with empathy. "If we want to reverse the trend, we must normalise HIV testing," said one ART consultant. "Make it as routine as checking blood pressure, and we will catch cases before complications begin."

Despite the rise in numbers, doctors said that J&K can prevent a larger outbreak if it acts now. "We have the medical tools — ART, testing, prevention programmes. What we lack is openness," said a senior physician. "The message must be simple: HIV is not something to hide from. It is something to treat." (KNO)

Power consumption dips to 123.4 billion units in Nov

New Delhi, Dec 1: Aviation Turbine Fuel (ATF) prices were raised by 5.4 per cent on Monday, while commercial LPG rates were cut by Rs 10 per cylinder as stateowned oil companies announced their monthly price revision in line with global trends.

ATF prices in Delhi increased by Rs 5,133.75 per kilolitre to Rs 99,676.77 per kl, marking the third consecutive monthly hike, according to state-owned fuel retailers.

Rates had risen by about 1 per cent on November 1 and by 3.3 per cent on October 1. The latest increase is expected to add pressure on airlines, for which fuel accounts for nearly 40 per cent of operating costs.

No immediate comments could be obtained from the airlines on the impact of the price change.

In Mumbai, ATF was revised to Rs 93,281.04 per kl, while prices in Chennai and Kolkata were raised to Rs 1,03,301.80 and Rs 1,02,371.02 per kl, respectively.

Fuel prices vary across cities due to local taxes. Alongside, the price of a 19-kg commercial LPG cylinder used by hotels and restaurants was cut to Rs 1,580.50 in Delhi. This is the second reduction in a row, offsetting the Rs 15.50 increase implemented in October (rates had been cut by Rs 5 per cylinder on November 1). Since April, six earlier cuts have reduced commercial LPG prices by a total of Rs 223 per cylinder.

Domestic LPG prices remained unchanged at Rs 853 per 14.2-kg cylinder, following a Rs 50 hike in April.

Indian Oil Corporation, Bharat Petroleum and Hindustan Petroleum revise ATF and LPG prices on the first day of every month based on international benchmarks and the exchange rate.

New Delhi, Dec 1: Power consumption in the country fell marginally by 0.31 per cent to 123.4 billion units (BU) in November from 123.79 BU a year ago, due to frugal use of cooling appliances.

According to the government data, power consumption had declined by 5.8 per cent year-on-year in October this year to 131.07 BU.

Power consumption had risen to 145.66 BU in September from 140.61 BU in the same month a year ago.

Experts said October also

Experts said October also saw unseasonal rains in

various parts of the country which reduced the need of cooling appliance and with onset of winter in November, the usage reduced to almost nil.

They also stated that though the winter season has begun, the need for using heating appliances like geysers and blowers was not felt by many people during November.

However, the peak power demand met or the highest supply during November rose to 215.54 GW from 207.44 GW recorded in November 2024.

The peak power demand had touched an all-time

high of about 250 GW in May 2024. The previous all-time high peak power demand of 243.27 GW was recorded in September 2023.

However, this summer (April onwards), the record peak power demand was 242.77 GW in June.

According to government estimates, peak power demand was expected to touch 277 GW in the summer of 2025.

The experts said the power consumption as well as demand would be more steady December onwards with rise in use of heating appliances as mercury drops further.

Need framework to deal with challenge of biological weapons: Jaishankar

New Delhi, Dec 1: India on Monday pitched for a global mechanism to check any possible misuse of biological weapons in view of the uncertain international security environment.

External Affairs Minister S Jaishankar said "misuse" of biological weapons by non-state actors is no longer a distant possibility and international cooperation is needed to combat such a challenge.

He was speaking at a conference on 50 years of the Biological Weapons Convention (BWC).

"Bioterrorism is a serious concern that the international community has to be adequately prepared for. Yet the BWC still lacks basic institutional structures," he said. "It has no



compliance system, it has no permanent technical body and no mechanism to track new scientific developments. These gaps must be bridged in order to strengthen confidence," he added. India, the minister said, has consistently called for stronger compliance measures within BWC, includ-

Court sends Al Falah university founder to 14-day judicial custody

New Delhi, Dec 1: A Delhi court on Monday sent Al Falah University founder Jawad Ahmed Siddiqui to 14-day judicial custody in a terror-linked money laundering case.

dering case.
Siddiqui had been sent to the Enforcement Directorate (ED) custody for 13 days on November 19.

On Monday, he was produced before Additional Sessions Judge Sheetal Chaudhary Pradhan, who sent him to judicial custody till December 15.

During the hearing, the ED counsel briefly argued that it was premature to produce him before the court since the 13-day custody would end at 1 am on Tuesday, technically making Monday the 12th day of his custody.

Meanwhile, an application was moved by Siddiqui's counsel seeking access to prescribed medication and spectacles during the custody period. The judge allowed the request. ED officials handed over Siddiqui's

ED officials handed over Siddiqui's medical prescription to the court, which directed jail authorities to ensure that he continued to receive the prescribed treatment.

The agency had earlier alleged that Al Falah University falsely claimed UGC



recognition and misrepresented its NAAC accreditation status to students. It said the institution generated Rs 415.10 crore in revenue between 2018 and 2025, witnessing a "meteoric rise" in earnings despite financial records not matching the assets accumulated by the group.

The ED told the court that student fees and funds raised from the public were being diverted for personal and private use, and that Siddiqui exercised de facto control over the Al Falah Charitable Trust, the managing trustee, and related entities.

Searches at 19 locations in Delhi-NCR on the day of his arrest yielded around Rs 48 lakh in cash, officials had said.

The matter will be taken up next on December 15, following the end of Siddiqui's judicial custody.

Sitharaman introduces 2 bills in LS to levy excise duty on tobacco, cess on pan masala

New Delhi, Dec 1: Finance Minister Nirmala Sitharaman on Monday moved two new bills in the Lok Sabha that look to repurpose levies on 'sin goods' such as tobacco, pan masala and related products ahead of the scheduled phaseout of the GST compensation cess levied on them.

The Central Excise (Amendment) Bill seeks to levy excise duty on tobacco and related products, while 'The Health Security se National Security Cess Bill, 2025' would be applicable on manufacturing of pan masala and other goods that the government may notify.

The bills, introduced amid din in the Lok Sabha as Opposition members protested demanding a discussion on the Special Intensive Revision (SIR) of electoral rolls, may be taken up for discussion in the House on Tuesday.

TMC member Saugata Ray opposed introduction of the two bills saying that tobacco is harmful but the Central Excise (Amendment) Bill does not mention that. With regard to the Health Security

se National Security Cess Bill, 2025, Ray said that since cess proceeds are not shared with states he opposes the bill.

While the revenues from levy of excise on tobacco would be part of the divisible pool of tax revenues, the collection from the health and national security cess would go towards funding public health initiatives and national security while maintaining high taxation on 'sin goods'.

The Central Excise (Amendment) Bill provides for a new central excise duty on tobacco products like cigarette, chewing tobacco, cigars, hookahs, zarda, and scented tobacco, replacing the existing compensation cess.

The bill seeks to levy excise duty on cigars / cheroots / cigarettes in the range of Rs 5,000-11,000 per 1,000 sticks depending on the length. Also, it proposes levy of 60-70 per cent on unmanufactured tobacco and 100 per cent on nicotine and inhalation products.

This will be over and above the 40 per cent GST rate that would be applicable on sin goods.

Study finds low blood choline as possible factor in obesity-related Alzheimer's risk

New Delhi, Dec 1: Low blood levels of choline, crucial for liver function and controlling inflammation, could be among the various ways through which obesity can speed up cognitive decline and increase the risk of Alzheimer's disease, according to a study.

Studies have found that high blood pressure is a risk factor for mild cognitive impairment, which usually precedes Alzheimer's disease, in which speech and thought processes steadily decline with age.

The researchers from Arizona State University said conditions such as obesity, high blood pressure and insulin resistance can strain the body's blood vessels and

metabolic systems, with stress building up over time speeding up cognitive decline and one's risk of Alzheimer's disease. The study, published in the journal Aging and Disease, looked at 30 young adults --half with obesity and half of healthy weight -- aged in their 20s and 30s.

Fasting blood samples were collected for measuring circulating choline, inflammatory cytokines, insulin and glucose levels, liver-related enzymes, other metabolic measures, and neurofilament light chain (NfL) -- a protein released when a nerve cell is damaged.

The participants were seen to have unusually low blood levels of choline, a key nutrient and organic compound crucial for liver function, inflammation control and long-term brain health. The authors



"found that obese participants showed reduced circulating choline, correlating with higher body fat, liver dysfunction markers, increased (insulin resistance), and elevated inflammatory cytokines." The NfL

levels were higher in obese participants and negatively correlated with circulating choline levels, findings that the researchers said were consistent with those observed in patients with mild cognitive impairment and Alzheimer's disease.

The findings reveal links between obesity, low choline, insulin resistance, systemic inflammation and NfL -- key risk markers for Alzheimer's disease, the authors said.

"This research adds to the growing evidence that choline is a valuable marker of metabolic and brain dysfunction—and reinforces the importance of sufficient daily intake, as it is essential for human health," lead researcher Ramon Velazquez, from the Arizona State University's Banner Neurodegenerative Disease Research Center, said. "Several new reports

published this month further link reduced blood choline levels to behavioural changes, including anxiety and memory impairment, as well as (a) broader metabolic dysfunction," Velazquez said.

Monitoring such markers in early adulthood may be useful for assessing future Alzheimer's risk in individuals prone to obesity, the researchers said.

They added that the study's sample size was modest, and that a larger, more diverse cohort may have captured broader population trends.

The study also did not include cognitive assessments, though higher NfL levels were observed and has been associated with cognitive decline in non-demented adults in previous research, the team added.

Moscow, Dec 1: Diplomats face an uphill battle to reconcile Russian and Ukrainian "red lines" as a renewed US-led push to end the war gathers steam, with Ukrainian officials attending talks in the US over the weekend and Washington officials expected in Moscow early this week.

US President Donald Trump's peace plan became public last month, sparking alarm that it was too favourable to Moscow. It was revised some following talks in Geneva between the US and Ukraine a week ago

Ukraine's President Volodymyr Zelenskyy has said the revised plan could be "workable." Russian President Vladimir Putin called it a possible "basis" for a future peace agreement. Trump said Sunday "there's a good chance we can

make a deal."
Still, officials on both sides indicated a long road ahead as key sticking points - over whether Kyiv should cede land to Moscow and how to ensure Ukraine's future security appear unresolved.

A look at where things stand and what to expect this week: US holds talks with Kyiv then

Trump representatives met the Ukrainian officials over the weekend and plan to meet with the Russians this week.

Ukraine's national security council head Rustem Umerov, the head of Ukraine's armed forces Andrii Hnatov, presidential adviser Oleksandr Bevz and others met with US officials for about four hours on Sunday. US Secretary of State Marco Rubio said the session was productive but more work remains. Umerov praised the US for its support but offered no details.

Zelenskyy's former chief of staff and former lead negotiator



resigned Friday amid a corruption scandal and is no longer part of the negotiating team. It was only a week ago that Rubio met with Yermak in Geneva, resulting in a revised peace plan.

Trump said last week that he would send his envoy Steve Witkoff to Russia. Kremlin spokesman Dmitry Peskov confirmed Putin will host Witkoff for talks "in the first half" of the week.

Trump suggested he could eventually meet with Putin and Zelenskyy, but not until there has been more progress.

Witkoff's role in the peace efforts came under scrutiny last week following a report that he coached Yuri Ushakov, Putin's foreign affairs adviser, on how Russia's leader should pitch Trump on the Ukraine peace plan. Both Moscow and Washington downplayed the significance of the revelations.

Where the two sides stand Eager to please Trump, Kyiv and Moscow have ostensibly welcomed the peace plan and the push to end the war. But Russia has continued attacking Ukraine and reiterated its maximalist demands, indicating a

deal is still a ways off. Putin implied last week that Trump directly. Yermak then told The Atlantic in an interview on Thursday that Zelenskyy would not sign over the land.

Zelenskyy also maintains that NATO membership is the cheapest way to guarantee Ukraine's security, and NATO's 32 member countries said last year that Ukraine is on an "irreversible" path to membership. Since he took office, Trump has made it clear that NATO membership is off the table.

Moscow, in turn, has bristled at any suggestion of a Western peacekeeping force on the ground in Ukraine, and stressed that keeping Ukraine out of NATO and NATO out of Ukraine was one of the core goals of the war.

Zelenskyy, meanwhile, has been under pressure at home. Yermak's resignation was a major blow for Zelenskyy, although neither the president

nor Yermak have been accused

of wrongdoing by investigators. "Russia really wants Ukraine to make mistakes. There won't be mistakes on our side," Zelenskyy said. "Our work continues, our struggle continues. We don't have a right not to push it to the end."

An activist with Ukraine's nongovernmental Anti-Corruption Center, Valeriia Radchenko, said letting go of Yermak was the right decision and would open a "window of opportunity for reform."

Putin, meanwhile, seeks to project confidence, boasting of Russia's advances on the battlefield.

The Russian leader "feels more confident than ever about the battlefield situation and is convinced that he can wait until Kyiv finally accepts that it cannot win and must negotiate on Tatiana Stanovaya of the Carnegie Russia and Eurasia Center wrote on X. "If the Americans can help move things in that direction — fine. If not, he knows how to proceed anyway. That is the current Kremlin logic.'

Europe's conundrum NATO and the EU are holding several meetings this week focused on Ukraine. NATO Secretary-General Mark Rutte is hosting Ukrainian Defense Minister Denys Shmyhal for talks in Brussels on Monday, and EU defense and foreign ministers are gathering to discuss European military support for Ukraine and Europe's defense readiness.

The main issue for the EU right now is what to do with the frozen Russian assets in Belgium that the Trump peace plan in its initial version sought to use for post-war investment in Ukraine.

Those funds are central to **European Commission President** Ursula von der Leyen's strategy to ensure continued help for Ukraine while also maintaining pressure on Russia. But Belgium's prime minister is holding out, worried about the legal implications of tapping the frozen assets for Ukraine, the impact that could have on the euro – and of Russian retaliation.

The diplomacy set in motion by Trump's peace plan "painfully exposed" Europe's weakness, Nigel Gould-Davies of the International Institute for Strategic Studies wrote in a recent commentary.

"Despite being the main source of Ukraine's economic and military support, it is marginal to the diplomacy of the war and has done little more than offer amendments to America's draft peace plan," Gould-Davies

B'desh court sentences Hasina to 5-yr jail, UK lawmaker niece to 2 years in land scam



Dhaka, Dec 1: A Bangladesh court on Monday convicted and sentenced deposed prime minister Sheikh Hasina to five years of imprisonment and her niece, British parliamentarian Tulip Siddig, to a two-year jail term in a land scam case.

Judge Md Rabiul Alam of the Special Judge's Court-4 of Dhaka also handed down a seven-year jail term to Hasina's sister, Sheikh Rehana, in the corruption case lodged against 17 people, the state-run BSS news agency reported.

The 14 other accused were jailed for five years each.

The court also imposed a fine of Tk 1 lakh each on all 17 convicts, including Hasina, Rehana, and Siddiq, failing which they will have to serve an additional six months in jail.

This is the fourth verdict involving 78-year-old Hasina in graft cases filed by the Anti-Corruption Commission (ACC), The Daily Star newspaper reported.

Siddiq, a British-Bangladeshi Labour Party politician, is Rehana's daughter and has been the Member of Parliament for Hampstead and Highgate since 2015.

The interim government in April issued an arrest warrant for Siddiq, 43, as part of investigations into corruption during Hasina's premiership.

The ACC filed the land scam case on January 13 against 15 people, including Hasina, Reha-na and Siddiq, over allegations that they unlawfully obtained plot allocations during the former premier's tenure.

The Investigating Officer later submitted a charge sheet against 17 accused on March 10.

According to The Dhaka Tribune, the ACC filed six separate cases between January 12 and 14 with its Dhaka Integrated District Office-1 over alleged irregularities in the allocation of plots under the Purbachal New Town project.

The anti-graft body alleged that Hasina, in collusion with senior Rajuk officials, unlawfully secured six plots, each measuring 10 kathas (7,200 square feet), in the diplomatic zone of Sector 27 of the Purbachal New Town project for herself, her son Sajeeb Wazed Joy, daughter Saima Wazed Putul, sister Rehana, niece Siddique, and several other relatives, despite their ineligibility under existing regulations.

Rajdhani Unnayan Kartripakkha (Rajuk) is the state-run agency responsible for monitoring compliance from planning to construction of government-aided buildings in Bangladesh.

"But again, I don't think anything changes from a mindset thing. He had an incredible day out that afternoon ... whatever we're pre-

sented with, we'll stick to our plans." England is looking to hit back after its
