# Whether Pahalgam or Crocus, roots are same: PM Modi

'Terrorism assault on humanity; New Delhi, Moscow will continue to intensify joint counterterrorism efforts'

New Delhi, Dec 05: Prime Minister Narendra Modi and Russian President Vladimir Putin on Friday asserted that both the countries are determined to fight terror and its sponsors, and dismantle their ecosystem.

During summit-level talks with Russian President Vladimir Putin at New Delhi, PM Modi, according to the news agency-Kashmir News Observer (KNO) said both nations have "stood shoulder-to-shoulder" in countering terrorism and share the belief that the roots of attacks



whether in Pahalgam or at Moscow's Crocus City Hall, stem from the same ecosystem of violence that must be dismantled collectively.

While referring to the April 22 Pahalgam terror attack, which left 26 people dead, PM Modi said, "The attack reinforced the urgency of global solidarity against the menace." Putting security cooperation at the centre of the India-Russia strategic partnership, PM Modi stressed that terrorism remains "a direct assault on the values of humanity" and called for deeper coordination against groups and networks that threaten global peace.

He said New Delhi and Moscow will continue to intensify joint counter-terrorism efforts and intelligence exchanges, reaffirming that unity among like-minded countries is the strongest defence against extremists and their sponsors.

Against this backdrop of heightened security concerns, the two leaders unveiled a renewed blueprint to expand bilateral trade and economic ties.

#### **5-YEAR ECONOMIC COOPERATION PLAN FINALIZED**

After delegation-level talks, PM Modi and President Putin finalised a five-year economic cooperation plan ending in 2030, aimed at imparting fresh momentum to a relationship that spans over eight decades.

Agreements were also signed in key sectors including health, mobility and people-to-people exchanges.

#### IndiGo breakdown hits flyers in Srinagar, Jammu Endless waits, no clarity on refunds leaves passengers furning

Srinagar, Dec 05: Chaos and frustration continued to grip air travellers on Friday as IndiGo Airlines faced large-scale operational disruptions, forcing mass cancellations and long delays at both Srinagar and Jammu airports.

According to the details available with the news agency-Kashmir News Observer (KNO) the day saw scenes of confusion at both airports, with passengers travelling for medical emergencies, weddings, official work and more left stranded for hours without clear communication from the airline.

Officials said that 41 flights were cancelled across J&K, 11 in Jammu and 30 in Kashmir, including 39 of IndiGo and two of



other airlines.

International At Srinagar Airport alone, 28 scheduled IndiGo flights were cancelled, leaving hundreds of passengers stranded for hours. The remaining flights operated with minor

have been receiving repeated calls regarding IndiGo operations. Over 30 flights scheduled for today have been cancelled, of which 28 were IndiGo and two of

other airlines," an official from Srinagar airport said.

Rafiq Ahmad, a passenger at Srinagar airport who was scheduled to fly to Delhi, said he had been waiting since early morning with no clear update. "First they said the flight is delayed, then cancelled. There's no proper announcement or assistance people are just sitting helplessly," he told KNO.

SRINAGAR, DECEMBER 05: The Government Medical College (GMC) Srinagar and its associated hospitals (SMHS/SSH) and other partner facilities have successfully maintained uninterrupted diagnostic services over the past two days despite the scheduled shutdown of the MRÎ unit at Shireen Bagh.

During the 48 hour period, a total of 67 MRI scans and 220 CT scans were completed across the network, ensuring that patients who required imaging continued

to receive care without delay.

The MRI, as per an official statement issued on Friday, at Shireen Bagh was taken offline on 4 December 2025 for an urgent de-icing and repair procedure. A routine inspection had revealed ice buildup in the magnet's venting system, which could have led to a helium leak and posed a safety risk to patients and staff. Prompt maintenance is essential to restore the unit to optimal performance and guarantee long-term safety.

Logistic support, including patient transport and technical staff, was mobilised to move individuals whose scans were scheduled at Shireen Bagh to other GMC Srinagar facilities, allowing the workflow to continue smoothly.

The hospital administration thanks patients, staff, and partner institutions for their cooperation and reaffirms its commitment to maintaining seamless diagnostic services throughout the maintenance period and beyond.

# CS reviews RS 1,000 Cr PM-ABHIM health projects

Jammu, Dec 05: Chief Secretary, Atal Dulloo Friday held a meeting to conduct a comprehensive review of several key projects underway in the Health and Medical Education (H&ME) Department. The review covered the progress of Critical Care Blocks (CCBs) being established across districts under the Pradhan Mantri-Ayushman Bharat Health Infrastructure Mission (PM-AB-HIM), developments made under the Emergency COVID Response Package-II (ECRP-II), expansion of IHIP, adherence to IPHS standards, and the status of NCDC lab-oratories and VRDL facilities across J&K.

The meeting was attended by the Secretary, H&ME; Mission Director, NHM; Principals of Government Medical Colleges; Managing Director, HSCC; Director Health, Kashmir/Jammu and other senior officers of the department.

During the meeting, the Chief Secretary undertook project-wise appraisal of all ongoing works, particularly the CCBs, and directed HSCC to significantly scale up manpower and machinery by at least three times to ensure timely completion within the scheme deadline.

He underscored that the release of funds under these Centrally Sponsored Schemes is directly linked



to the submission of Utilization Certificates, stressing the importance of full fund utilisation before the closure of the schemes.

Reviewing the physical and financial progress, availability of skilled and unskilled manpower, and the improvement recorded since the last review in June 2025, the Chief Secretary instructed the MD, HSCC to intensify on-ground monitoring and

He highlighted that projects amounting to over Rs 800 Cr under PM-ABHIM and Rs 166 Cr under ECRP-II must be completed within stipulated timelines for the funds of such a magnitude can't be arranged later for completion of these projects here.

He further called for enhancement of IPHS scores across health facilities, noting that higher certification reflects improved service quality and public trust. Stressing the importance of

strengthening disease surveillance and diagnostics, he directed expedited efforts for establishing NCDC laboratories in Jammu and Srinagar.

Updating on the infrastructure progress, the Secretary, H&ME informed that procurement processes for equipment are being contemplated out to ensure immediate operationalisation of facilities post-completion. Under PM-ABHIM, he revealed that two 100-bedded CCBs are under construction at GMC Jammu and District Hospital Budgam, while seven 50-bedded CCBs are coming up at GMC Kathua, GMC Rajouri, GMC Doda, GMC Anantnag, SKIMS Medical College Bemina, and District

Hospital Kulgam. Additionally, 20 District Integrated Public Health Labs (DIPHLs) and 287 Block Public Health Units (BPHUs) are being set up across the UT. He also gave our that under

ECRP-II. work is underway on seven more 50-bedded CCBs at GMC Udhampur and the District Hospitals of Reasi, Pulwama, Kupwara, Poonch,

Shopian, and Ganderbal.
The MD, NHM, Baseer-ul-Haq Choudhary, presented a detailed status report, highlighting location-wise progress of CCBs and DIPHLs, along with comparative improvements since the previous review.

He informed that regular assessments and field inspections are being conducted to accelerate execution.

The meeting also reviewed the establishment of 79 Urban Ayushman Arogya Mandirs (UAAMs), of which 53 have been completed with efforts underway to achieve completion by March 2025 itself. The SNO, NHM, Dr. Harjeet Rai, presented progress on the Integrated Health Information Platform (IHIP), a digital surveillance system Family Welfare.

He informed that J&K ranks among the top five States/UTs at the national level, with 3,796 health facilities mapped on the platform, enabling real-time monitoring of syndromic, presumptive, and laboratory-confirmed cases.

He added that over the past year, 133 outbreaks affecting 3,250 individuals and resulting in 8 deaths were reported through IHIP. The platform also tracks dog bite, snake bite, and dengue cases on a real-time basis.

The progress on estab-lishing NCDC laboratories at Kot Bhalwal (Jammu) and Srinagar was also reviewed. Regarding IPHS compliance, it was informed that 3,526 out of 3,533 health facilities have undergone assessment, with 1,992 facilities scoring between 50-69%, 198 between 70-79%, and 160 facilities scoring above 80%, the highest category under the standards.

The Chief Secretary also reviewed the functioning of Viral Research and Diagnostic Laboratories (VRDLs) at the Government Medical Colleges of Jammu and Srinagar, including their expanding portfolio of diagnostic investigations and ongoing research projects on viruses such as Influenza and Rotavirus for the benefit of people of the UT.

The official figures shared by the Union Ministry of Law and Justice in the Lok Sabha states that J&K has recorded a notable increase in disposing of cases registered under POCSO Act in 2025 in comparison to previous years.

As per the National Judicial Data Grid (NJDG), J&K registered 42 POCSO



cases in 2025, while 23 cases were dis-

posed of during the year. In previous years, official figures reveal that the region witnessed lower disposal trends with 7 cases disposed off in 2021, ten in 2022, four in 2023 and six cases were disposed off in the

The Ministry also provided a

decade-long overview of pendency.

About the infrastructure for speedy trials, the union government said four Fast Track Special Courts (FTSCs) are currently functional in J&K, including

two exclusive POCSO courts. These courts established under the Centrally Sponsored Scheme have so far disposed of 338 cases since its inception. "494 cases remain pending as of September

The Ministry further informed the House that the FTSC Scheme has been extended till March 2026, with a focus on strengthening exclusive POCSO courts to ensure time-bound disposal—(KNO)

#### Bridging The Gap In J&K's Border Areas

he launch of a major infrastructural overhaul in Jammu & Kashmir's border areas under the Vibrant Villages Programme – Phase II (VVP-II) is a policy shift of profound significance. For decades, these remote habitations have symbolised a stark paradox. They are our territorial sentinels, yet they have often remained on the margins of development. Chief Secretary's review meeting, focusing on saturating 124 strategic villages with roads, electricity, telecom, and television connectivity, finally

acknowledges that national security is inextricably linked to human security and dignity. Underdeveloped border regions create a sense of alienation and vulnerability. More than building infrastructure, the step is about building trust. When a household in Tulail Valley gets reliable electricity, or a village in Kupwara gains 4G connectivity, it represents

The programme's three-pronged strategy of saturating existing schemes, strengthening infrastructure, and generating sustainable livelihoods is commendably holistic. Roads and telecom enable access to markets, education, and healthcare. Tourism initiatives and cultural preservation, as highlighted in the plan, can unlock economic potential rooted in local

heritage. The difficult terrain of districts like Kupwara and Bandipora has historically defied easy solutions. The success of VVP-II will hinge on relentless execution, adaptive governance, and meticulous monitoring. The appointment of nodal officers, the use of geo-tagging, and the operational Digital VVP Portal are steps in the right direction. Crucially, this must be a collaborative, "whole-of-government" endeavour, as the Chief Secretary said, with seamless coordination between departments and agen-

cies. This initiative is a long-term investment in the nation's territorial and social fabric. By ensuring that the glow of development reaches our farthest frontiers, we fortify the very idea of India. The vibrant village of the future will be one where a child can stream educational content, a farmer can check market prices, and a family feels connected to the country's heartbeat. That is the ultimate goal, and it is a mission worthy of the resources and resolve now being marshalled.

# Nari Shakti To Vikas: Focus Must Shift To Women-Led Progress

ender equality and women's empowerment is the organising idea for our brighter todays and our transformed tomorrows. In this age of acceleration, we cannot afford to wait another century to achieve gender parity. The cardinal concept of nari shakti (women's power) and of women as devis (goddesses), which is India's civilisational gift to the world, must now move from symbolic reverence to practical power and take our virasat (tradition) of respect for women into a vikas (development) pathway of women-led sustainable development.

When the freedoms and life chances of half of humanity expand, societies are rewired. Gender equality is an ideal in its own right and also a powerful force multiplier of social, economic, political, technological and environmental progress. The 2015 McKinsey Global Institute report, the 2024 analysis using National Family Health Survey data, and EY's India@100 work, together make a compelling economic case: Closing gender gaps can add 20 to 30% to GDP and is indispensable for India to become a \$28-trillion economy by 2047.

India is living through a demographic moment. Our young population will yield a dividend only if it becomes a female dividend. Fertility is declining and the ambitions of girls and young women are rising; India now has near parity in higher education and around 43% of STEM students are women. After years in which women's work was pushed into informality and invisibility.



female labour force participation has begun to climb again and must translate into better quality, formal and future-ready jobs. A defining feature of Prime Minister

A defining feature of Prime Minister Narendra Modi's government has been targeted flagship programmes in which women are the principal labharthi (beneficiaries), combined with transversal programmes in infrastructure, health, education and social protection that are gender responsive. Scholarships, hostels and reserved seats have lifted women's presence in higher and technical education and opened pathways into the knowledge, health, green and care economies. Digital missions and rural

programmes have trained tens of millions of women and put smartphones with affordable data and Jan Dhan accounts in their hands, giving direct access to information, markets and services.

Flagship schemes such as Pradhan Mantri Ujjwala Yojana, PM MUDRA, Swachh Bharat and PM Awas have put clean energy, access to credit, sanitation and secure housing in crores of women's names, while schemes such as the Sukanya Samriddhi and Lakhpati Didi have enabled direct benefit transfers into their bank accounts and rising incomes. The next level must move them decisively from labharthi to adhikar pati, from recipients of entitlements to full rights holders and decision makers in the economy and society. That is the essence of achieving SDG 5 on gender equality by 2030.

Intersectionality in India means that many women face multiple layers of dis-advantage through poverty, caste, tribe, religion, disability or location. The abolition of instant triple talaq has strengthened Muslim women's rights in marriage. The election of Droupadi Murmu, a woman from an Adivasi background, as President of India embodies how far a marginalised woman can rise in a republic, deepening its commitment to gender and social justice. The tomorrow we must build is one in which such trajectories are systemic and widespread rather than exceptional.

Freedom from violence remains the nonnegotiable foundation of a gender equal society. Ending violence against women and girls in all its forms, from domestic abuse and trafficking to work-place harassment and online hate, must stay at the top of the agenda, together with sustained investment in women's health and in sexual and reproductive rights that guarantee autonomy and dignity.

Political voice and leadership multiply the impact of every other intervention and give women the power to shape tomorrow's rules. At the grassroots, 33% to 50% reservations in panchayats and urban local bodies have created 1.5 million women leaders. The Nari Shakti Vandan Adhiniyam, reserving one third of seats in the Lok Sabha and all state assemblies for women, is a historic step towards real parity in lawmaking and governance. Women are reshaping electoral outcomes, as seen recently in Bihar, as conscious voters rewarding governments that deliver on safety, mobility, education, health and livelihoods.

Culture is an infrastructure of meaning through which societies understand themselves and imagine their future. For centuries it was built from a male vantage of patriarchy, even in civilisations that worshipped the feminine divine. Today, women across the creative industries, from media and literature to cinema, music, sport and digital content, are rewriting that script and reclaiming the Devi idea so that reverence is expressed as equal rights, equal respect and shared responsibility in the home, the economy and the public sphere.

The next level of transformation must now be led as much from offices, board rooms, laboratories and digital platforms as from parliaments. Every institution, from government departments and political parties to universities, research councils, startups and large corporations, must build gender parity into its DNA. This means gender equal education to jobs value chains, where girls move from classrooms into careers in science, technology and artificial intelligence across the wider Industry 4.0 ecosystem. It means corporate leaders and chief executives committing to parity in recruitment, retention, re-entry and promotion, and to many more women in senior management and on boards. It also means a research and innovation system and a start-up culture where women founders, scientists and creators can access credit, mentorship and markets on equal terms.

During its G20 presidency, India placed women-led development at the centre of the agenda, securing commitments on bridging the digital gender gap, raising women's labour force participation, and expanding women's entrepreneurship and leadership. Empowered women are the great transformers of our age. As transformed women who transform their families, communities, countries and the world, they unlock demographic advantage and enable women and girls to live lives of freedom, choice and dignity. If India sustains and amplifies this movement, its civilisational second coming as a leading power will be fast forwarded by a journey to Viksit Bharat (developed India) by 2047 that is lit and led by Nari Shakti.

#### How fostering your artistic capacities can help you nurture your inner child

ver the past year, we have been working closely with colleagues here at Boston College to develop a psychologically rich, humanities-informed Creative Writing Master's Program oriented toward professionals and clinicians who want to hone their craft as writers while deepening their understanding of the human psyche. The idea behind this undertaking is simple: Great writing and great thinking go hand in hand, and creative writing is a fundamentally psychological endeavor.

Indeed, authors often speak of the therapeutic nature of writing and see the practice as essential to their mental health. Why this is the case, however, is rarely theorized, with writers insisting that they can't not write but not fully understanding why. A little commented upon essay by Freud, delivered before an audience of laypersons in 1907, may shed some light on the subject.

In "Creative Writing and Day-Dreaming," Freud likens the exertions of an author toward his craft to the efforts of a child at play. Noting that "The opposite of play is not what is serious but what is real," he insists that the creative writer is doing something akin to the child in creating a fantasy world, one he takes seriously and invests himself in even though he recognizes it as at odds with reality.

with reality.

For Freud, of course, the word "fantasy" does not carry the pejorative connotation that it often does for us. Our fantasies are an important part of our mental life and we neglect or disavow them at our peril. It is better, Freud thinks, to cultivate our fantasies—recognizing them always as such and yet nevertheless taking them seriously—in order to do something productive with them. This allows us to nurture our inner child—an aspect of ourselves that needs to be nurtured—while at the same time



holding fast to the important distinction between the fictions we play at and the lives we live.

By Freud's telling, creative writers—and artists of all stripes—provide incredible examples of how to healthfully convert one's wishes and illusions into something beneficial. What is more, the fantasies of artists enrich not only their own lives but the lives of others as well. Like the child who invents a game that attracts the attention and delight of his playmates, "the writer's imaginative world ... can become a source of pleasure for the hearers and spectators at

the performance of the writer's work."

That's all well and good for creative writers, one might object, but what about the rest of us who lack the capacity or inclination to express ourselves through art? What about we who have "ceased to play" and have been "labouring for decades to envisage the realities of life with proper seriousness"? Is there no opportunity for us to "throw off the too heavy burden imposed on [us] by life and win the high yield of pleasure afforded" by playfully creating fictive worlds and entertaining unrealities?

notes that "a piece of creative writing, like a day-dream, is a continuation of, and a substitute for, what was once the play of childhood." Said differently, we all fantasize like the writer. We all build dream worlds in which our deepest wishes and fears can be explored and played out in the safety of our own imaginations. The only difference is that artists and children do so openly while the rest of us guard our creations from the

eyes of others:

all creative writers in some sense. Like

Nietzsche, who insists that each of us be-

comes an artist when we dream, Freud

People's phantasies are less easy to observe than the play of children. The child, it is true, plays by himself or forms a closed psychical system with other children for the purposes of a game; but even though he may not play his game in front of grown-ups, he does not, on the other hand, conceal it from them. The adult, on the contrary, is ashamed of his phantasies and hides them from other people. He cherishes his phantasies as his most intimate possessions, and as a rule he would rather confess his misdeeds than tell anyone his phantasies.

Such shame stifles one's creativity, or at the very least prevents one from experiencing it with the freedom and enjoyment of a child at play. And yet, it is the child within us that is most in need of the release that playful imagining provides. It is the artist that exists in all of us that is begging to come out when we flee the "too heavy burden" of our daily reality and instead choose to imagine life otherwise—better, more prosperous, more just

Would that we all could nurture this deeply human need. Would that we all could allow our inner child to play. Perhaps, if we learn to see ourselves not as serious adults but serious artists—creative writers ever imagining life anew—we will be better

# Forest Minister, CM's Advisor assure support as CCIK pushes tourism, eco protection

SRINAGAR, DECEMBER 05: The Chamber of Commerce and Industries Kashmir (CCIK) Friday held its executive meeting in Srinagar.

Minister for Forest, Ecology & Environment and Tribal Affairs, Javed Ahmed Rana and Advisor to the Chief Minister, Nasir Aslam Wani attended the meeting.

The meeting, as per an official statement focused on strengthening Kashmir's tourism ecosystem, protecting fragile environmental assets and improving the public utilities essential for sustainable development.

The CCIK presented key issues impacting the tourism and hospitality sector including provision of timber for houseboat repairs, a long standing demand crucial for preserving Kashmir's heritage tourism.

The Chamber emphasised the need to diversify Kashmir's tourism offerings through ecotourism, adventure tourism and development of eco-friendly resorts and luxury camping facilities in forest zones. It urged the government to streamline the single-window clearance



system for Pollution Control Committee approvals.

The CCIK highlighted that the existing multi-tiered approval processes have become a major bottleneck in execution of tourism, hospitality and infrastructure projects. It observed that a simplified and time-bound mechanism would significantly improve the compliance and enhance the investment climate.

Addressing the public utility challenges, the CCIK drew attention to the irregular water supply faced by the hoteliers in Pahalgam, compounded by limited tanker services. They appealed the Jal Shakti Minister to intervene and ensure reliable

water availability across key tourist destinations, particularly during peak seasons.

Environmental conservation dominated the discussions, with CCIK expressing serious concern over the deteriorating condition of Dal, Nigeen, Wular, Anchar and other wetlands.

The Chamber called for a comprehensive cleanup drive and strict, encroachment-free protection measures, while requesting formal inclusion in all government-led consultations on water resource management. The Chamber demanded immediate restoration and long term conservation action on the worsening state of Babademb

To enhance Kashmir's tourism appeal, the CCIK proposed branding the region as a premier wedding destination, leveraging its natural beauty and cultural heritage. The Chamber also sought a review of entry fee structures at Aru and other tourist sites to ensure that pricing remains competitive and visitor-friendly.

Responding to the extensive submissions, Minister Javed Ahmed Rana and Advisor Nasir Aslam Wani assured the business community that all their genuine concerns would be addressed in a time-bound and priority-driven manner.

They assured complete support from the present

dispensation towards promoting sustainable tourism, safeguarding ecological assets and strengthening public service delivery to guarantee a safe and enriching experience for the visitors.

The Minister reiterated that the government would take every possible measure to upgrade tourism facilities, bolster environmental protection efforts and improve the overall service ecosystem in Kashmir.

The meeting was chaired by CCIK President Tariq Ghani and attended by office bearers and key members including Hussan Khan, Dr. Imran, Aatif Khan, Aijaz Khan, Ashiq Bhat, Zubair and Umar Jan Wani.

Sector-specific concerns were raised by the representatives from the houseboat, travel, hospitality and handicraft sectors.

Industry leaders Manoor Paktoo (Houseboats), Wahid Malik (SKAL), Akram Siah (Travel Trade), Baber Chowdary (JKHARA) and Mudasir (Handicraft Sector) also participated in the deliberations

# India not neutral, it's on side of peace: PM Modi to Putin on Ukraine conflict

New Delhi, Dec 05: Prime Minister Narendra Modi on Friday strongly backed the latest efforts to end the war in Ukraine and conveyed to Russian President Vladimir Putin that India will stand shoulder-to-shoulder in all peace efforts to find an amicable solution to the conflict.

The Ukraine issue figured prominently at the annual summit talks between the two leaders that is aimed at further shoring up a nearly eight-decade bilateral partnership that remained in firm footing notwithstanding fractious geopolitical environment and tensions.

In his televised opening remarks at the summit, Modi said India is not neutral as it is on the side of peace to end the Ukraine conflict.

'We have been holding discussions following the start of the Ukraine conflict. As a close friend, you have been regularly apprising us on the situation. I think trust is a major strength," Modi said.

"We all should find the path

of peace. I am aware of the latest efforts and I am confident that the world will turn to peace," he said.

"I have always said that India is not neutral; India has a side and that side is peace. We support all peace efforts and we are standing shoulder-to-shoulder in all peace efforts," he said.

On his part, the Russian president said Moscow is working towards a peaceful solution to the conflict.

Putin was accorded a red carpet welcome on Thursday evening on his first visit to India in four years. It is also his first trip to India since the start of the war in Ukraine in February 2022.

PM Modi personally received the Russian leader with a hug at the Palam airport before travelling together in a white SUV to the prime minister's official residence for a private dinner.

The conversation between the two leaders over dinner is known to have set the tone for the 23rd India-Russia summit talks that is expected to produce a number of tangible outcomes to further broadbase the time-tested relationship.

Boosting defence ties, insulating India-Russia trade from external pressure and exploring cooperation in small modular reactors are set to be the focus of the summit.

The Russian leader's visit to New Delhi has assumed greater significance as it is taking place against the backdrop of rapid downturn in India-US relations.

Following the Modi-Putin talks, the two sides are expected to ink a plethora of agreements, including one on facilitating the movement of Indian workers to Russia, and another on logistical support under a broader framework of defence cooperation.

It is learnt that under the trade basket, Indian exports to Russia are expected to significantly increase in areas of pharma, agriculture, food products and consumer goods.

The move comes amid concerns in New Delhi over a ballooning trade deficit in favour of Russia. India's annual procurement of goods and services from Russia amounts to around USD 65 billion, while Russia's imports from India stand at around USD 5 billion.

friendship as "steadfast like a pole star" and said that the world has witnessed upheavals over the decades but ties between New Delhi and Moscow have remained resilient.

The 2030 roadmap, he said, reflected a "common priority" to elevate economic engagement and widen cooperation in critical sectors.

PM Modi also underlined the importance of concluding a free trade agreement with the Eurasian Economic Union at the earliest, noting that it would significantly boost trade volumes despite global tariff and sanctions pressures.

#### RUSSIA READY TO ENSURE UNINTERRUPTED **FUEL SUPPLIES TO INDIA**

Putin, in his remarks, expressed confidence that bilateral trade can reach USD 100 billion annually, and said Russia was ready to ensure uninterrupted fuel supplies to India.

The Russian president said cooperation in energy including nuclear remains a key pillar of the strategic partnership.

He highlighted prospects for collaboration on small modular nuclear reactors and floating nuclear power plants, areas that Moscow is keen to explore with India.

PM Modi said cooperation in critical minerals between the two countries will strengthen supply chain security worldwide. Both leaders reiterated that India and Russia,

along with other like-minded partners, continue to work for a just, multipolar and balanced global order. (KNO)

Covering the districts of Udhampur, Reasi, Ramban, Srinagar, Anantnag, Pulwama, Budgam and Baramulla, the USBRL project is among the most challenging railway projects undertaken post-independence, owing to the fragile Himalayan terrain.

The project includes the world's highest railway bridge-the Chenab Bridge in Reasiwhich stands 359 metres above the riverbed with an arch span of 467 metres. It also features Indian Railways' first cable-stayed bridge over Anji Khad, with a deck 331 metres above the riverbed.

As part of its socio-economic impact, more than 215 km of approach roads, a tunnel, and over 320 small bridges were constructed, improving connectivity for local communities.

Following the commissioning of the valley section, four Vande Bharat services have been introduced between Shri Mata Vaishno Devi Katra and Srinagar, in addition to DEMU/MEMU services operating on the Qazigund-Srinagar and Srinagar-Baramulla stretches.

"We are not asking for 24×7 power. All we want is a fixed schedule so we can plan our day and manage the needs of elderly and sick family members," said Suhail Lone, a local

Families with infants and elderly people said the outages during early mornings and late evenings—when temperatures drop sharply are the hardest to deal with. Many households have shifted to firewood and gas heaters, adding to expenses and safety worries.

Several areas reported that the voltage drops sharply even when power is restored.

"Most of our appliances have either burnt or developed faults. Low voltage is as big a problem as the outage itself," said residents of Kulgam's Yaripora hamlet

People urged the Power Development Department (PDD) to issue a clear and realistic load-shedding schedule and ensure it is followed on the ground.

"We aren't against curtailment, but the cuts should be announced and managed properly. The current situation is chaotic," said Shabnum Ian from Anantnag.

Local residents have appealed to the administration to intervene, especially to safeguard households with medical emergencies.

"If the government can't ensure uninterrupted power, at least they should provide scheduled supply so that oxygen-dependent patients won't suffer," said another resident.

Meanwhile, officials from the Power Department said they are aware of the issues but attributed the curtailments to an increased winter load and said that they are trying level best to provide scheduled supply. (KNO)

Apple, Google, Samsung resist India's plan for permanent location tracking on devices

New Delhi, Dec 05: India's government is reviewing a telecom industry proposal to force smartphone firms to enable satellite location tracking that is always activated for better surveillance, a move opposed by Apple, Google and Samsung due to privacy concerns, according to documents, emails and five sources.

A fierce privacy debate erupted in India this week after Prime Minister Narendra Modi's government was forced to rescind an order requiring smartphone makers to preload a state-run cyber safety app on all devices after activists and politicians raised concerns about potential snooping.

For years, the Modi administration has been concerned its agencies do not get precise locations when legal requests are made to telecom firms during investigations. Under the current system, the firms are limited to using cellular tower data that can only provide an estimated area location, which can be off by several meters.

The Cellular Operators Association of India (COAI), which represents Reliance's Jio and Bharti Airtel, has proposed that precise user locations should only be provided if the government orders smartphone makers to activate A-GPS technology - which uses satellite signals and cellular data - according to a June internal federal IT ministry email.

#### RBI trims policy interest rate by 25bps to 5.25%, loans to get cheaper



Mumbai, Dec 05: Shrugging off concerns over the depreciation of rupee, the RBI has cut interest rate by 25 basis points to 5.25 per cent in a bid to further bolster economic growth, which rose to a six-quarter high of 8.2 per cent in the second quarter of the current financial year.

The development is expected to make advances, including housing, auto and commercial loans cheaper

Announcing the fifth bi-monthly monetary policy for the current fiscal, RBI Governor Sanjay Malhotra said the Monetary Policy Committee (MPC) has unanimously decided to cut the short-term lending rate or repo rate by 25 basis points to 5.25 per cent with a neutral stance.

The rate cut comes on the back of the consumer price index (CPI) based headline retail inflation ruling below the 2 per cent lower band mandated by the government for the last three months.

in October 2025, marking the lowest level since the Consumer Price Index (CPI) series was introduced. Besides, the Indian economy has clocked better-than-expected GDP growth of 8.2 per cent in the second quarter. However, the rupee declined to historic low and crossed 90 against a dollar earlier this week making imports costlier, raising fears of rise in inflation. Rupee has depreciated by about 5 per cent so far this year.

The RBI has sharply raised growth projection to 7.3 per cent from earlier 6.8 per cent for the current financial year.

The central bank has been tasked by the government to ensure that CPI- based retail inflation remains at 4 per cent with a margin of 2 per cent on either side.

Based on the recommendation of the MPC, the RBI reduced the repo rate by 25 bps each in February and April, and 50 basis points in June amidst easing retail inflation. The retail inflation is trending below 4 per cent since February this year.

#### Drop 'Lord' title for British rulers from textbooks, official records: BJP MP in RS

New Delhi, Dec 05: BJP leader Suieeth Kumar on Friday urged the Centre to remove the title 'Lord' when referring to British Viceroys and Governor Generals in school textbooks, NCERT publications, government documents and official websites, saying the practice perpetuates a "colonial mindset" even 75 years after independence.

Raising the issue during Zero Hour in the Rajya Sabha, Kumar highlighted the widespread use of the title across educational and official materials. "I did a random check of all these websites, documents, and school textbooks, and this is what I found," he said.

The BJP MP pointed out that NCERT history textbooks for Classes 8 and 12 contain numerous references to Lord Curzon, Lord Mountbatten, Lord Dalhousie and Lord Leighton, among others.

Similarly, he claimed that official websites of the Ministry of Culture, Press Information Bureau (PIB), Archaeological Survey of India (ASI) and even the Raj Bhavan, now renamed 'Lok Bhavan' of Bihar, continue to use the title for British colonial administrators

"During British rule, the colonial rulers used and abused the power to give titles for their imperialistic designs and to promote this false narrative of racial superiority. This was a title given by the British to the British for the British needs." Kumar said.

He questioned why India should



continue placing British officials "on a demigod-like pedestal" by calling them Lords, especially when many committed "horrendous and barbaric crimes" against Indians, while the country's own freedom fighters are not accorded similar reverence.

"A vibrant democracy like ours, which also is the largest and oldest democracy on earth, should not continue this practice as it perpetuates a colonial mindset, goes against the spirit of social equality, and also goes against the letter and spirit of our own constitution," the BJP leader added.

Kumar drew parallels with Prime Minister Narendra Modi's decision to rename Rajpath as Kartavya Path, describing it as more than ceremonial symbolism.

"This change reflects a shift from the colonial attitude to a more

duty-oriented name. It reflects a shift away from colonial symbols and towards civic responsibility, towards our national pride," he said

The MP also referenced the Prime Minister's speech on the 76th Independence Day from the Red Fort. where Modi outlined the Panch Pran (five resolves) for the Amrit Kal -- the 25 years leading up to India's centenary of independence in 2047. The second resolve, Kumar noted, emphasizes liberating the nation from any trace of the "slavery mindset."

"In no part of our existence, not even in the deepest corners of our mind or habits, should there be any ounce of slavery. We have to liberate ourselves from the slavery mindset, which is visible in innumerable things within and around us," Kumar said.

#### It eased to historic low in October, aided relationship even without attaining by an easing of food prices and favourable dropped to a historic low of 0.25 per cent marriageable age: Rajasthan HC

Jaipur, Dec 05: The Rajasthan High Court has ruled that two consenting adults are entitled to be in a livein relationship even if they have not yet reached the legal age for marriage, underscoring that constitutional rights cannot be curtailed on that ground.

Justice Anoop Dhand delivered the judgement while hearing a plea for protection filed by an 18-year-old woman told the court that they were living together out of free will.

The couple told the court that they had executed a live-in agreement on October 27, 2025.

The petitioners alleged that the woman's family opposed the relationship and had threatened to kill them. and that their complaint to the Kota police went unaddressed.

Opposing the petition, public prosecutor Vivek Choudhary argued that because the man had not attained

for marriage for men -- he should not be permitted to be in a live-in arrangement

The court dismissed the argument, saying the right to life and personal liberty under Article 21 of the Constitution cannot be denied merely because the petitioners are not of marriageable age. "The state has a constitutional obligation to safeguard the life and liberty of every individual," the judge observed, adding that live-in relationships are not prohibited or criminalised

## New Trump strategy vows shift from global role to regional

Washington, Dec 05: President Donald Trump's administration said in a long-awaited new strategy document Friday that the United States will shift from its historic global role toward increasing dominance in Latin America and vigorously fighting migration.

The national security paper, meant to flesh out Trump's norms-shattering "America First" worldview, signals a sharp reorientation from longstanding US calls to refocus on Asia, although it still identifies China as a top competitor.

The strategy also brutally criticized allies in Europe and said that the United States will champion opponents to European Union-led values, including on immigration.

Breaking with decades of attempts to be the sole superpower, the strategy said that the "United States rejects the ill-fated concept of global domination for itself.'

It said that the United States would also prevent other powers from dominating but added: "This does not mean wasting blood and treasure to curtail the influence of all the world's great and middle powers.

The strategy called for a "readjustment of our global military presence to address urgent threats in our Hemisphere, and away from theaters whose relative import to American national security has declined in recent decades or years.

The strategy speaks in bold terms of pressing US dominance in Latin America, where the Trump administration has been striking alleged drug traffickers at sea, intervening



to bring down leftist leaders including in Venezuela, and loudly seeking to take charge of key resources such as the Panama Canal.

The strategy cast Trump as modernizing the two-century-old Monroe Doctrine, in which the then young United States declared Latin America off-limits to rival powers, then from Europe.

"We will assert and enforce a 'Trump Corollary' to the Monroe Doctrine," it said.

 Championing Europe 'resistance' -Trump has sharply reversed many longstanding US principles since returning to office in January.

He rose to political prominence demanding sweeping curbs on immigration to the United States, fanning fears that the white majority was losing its status, and since taking office has ordered drastic and high-profile raids to deport undocumented people. "The era of mass migration must end. Border security is the primary element of national security," the strategy said.

The strategy made clear that the United States under Trump would aggressively pursue similar objectives in Europe, in line with far-right parties that have made strong gains in much of the continent.

In extraordinary language in speaking of close allies, the strategy said: "Cultivating resistance to Europe's current trajectory within European nations."

Germany quickly hit back, saying that it does not need "outside advice." The strategy pointed to Europe's lower share of the global economy – which is the result largely of the rise of China and other emerging powers — and said: "This economic decline is eclipsed by the real and more stark prospect of civilizational erasure.

"Should present trends continue,

the continent will be unrecognizable in 20 years or less.

As Trump seeks an end to the Ukraine war that would likely favor Russia gaining territory, the strategy accused Europeans of weakness and said the United States should focus on "ending the perception, and preventing the reality, of NATO as a perpetually expanding alliance."

- Less on Middle East and Africa -The strategy paid comparatively little attention to the Middle East, which has long consumed Washington.

Pointing to US efforts to increase energy supply at home and not in the oil-rich Gulf, the strategy said: "America's historic reason for focusing on the Middle East will recede.'

The paper said it was a US priority for Israel to be secure, but stopped short of the fulsome language on Israel used even in the first Trump administration. On China, the strategy repeated calls for a "free and open" Asia-Pacific region but focused more on the nation as an economic competitor.

After much speculation on whether Trump would budge on Taiwan, the self-ruling democracy claimed by Beijing, the strategy made clear that the United States supports the decades-old status quo, but called on allies Japan and South Korea to contribute more to ensure Taiwan's defense from China.

The strategy predictably puts little focus on Africa, saying the United States should transition away from "liberal ideology" and an "aid-fo-cused relationship" and emphasize goals such as securing critical

# Lebanon urges UNSC delegation to press Israel to respect ceasefire

Beirut, Dec 05: Lebanese President Joseph Aoun urged a United Nations Security Council delegation on Friday to pressure Israel to respect a year-old ceasefire and to support his army's efforts to disarm Hezbollah.

Despite a November 2024 ceasefire that was supposed to end more than a year of hostilities between Israel and the Iran-backed militant group, Israel has kept up strikes on Lebanon and has also maintained troops in five south Lebanon areas it deems strategic.

Aoun "stressed the need to pressure the Israeli side to implement the ceasefire and withdraw, and expressed his hope for pressure from the delegation," according to a statement

from the presidency. He also noted "Lebanon's commitment to implementing international resolutions" and asked the envoys to support the Lebanese army's efforts to disarm non-government groups. The Lebanese government ordered its military to fully disarm Hezbollah in August, and the army expects to complete the first phase of its



plan by the end of the year. The UN delegation visit-

ed Damascus on Thursday and after its meeting with Aoun was due to inspect the border area in southern Lebanon on Saturday, accompanied by US envoy Morgan Ortagus.

The visit comes as Lebanese and Israeli civilian representatives held their first direct talks in decades.

On Thursday, Information Minister Paul Morcos quoted Aoun calling the initial negotiations "positive" and stressing "the need for the language of negotiation – not the language of war – to prevail." That same day, Israel struck four southern Lebanese towns, saying it was targeting Hezbollah infrastructure including weapons depots to stop the group from rearming.

UN peacekeepers called the strikes "clear violations of Security Council resolution 1701," which ended the 2006 war between Hezbollah and Israel. The peacekeepers also said their vehicles were fired on by six men on three mopeds near Bint Jbeil on Thursday. There were no injuries in the incident.

"Attacks on peacekeepers are unacceptable and serious violations of resolution 1701," the international force added. Hezbollah refuses to disarm but has not responded to Israeli attacks since the ceasefire. It has, however, promised a response to the killing of its military chief in a strike on Beirut's southern suburbs last month.

#### EU regulators hit Musk's X with 120 million euro fine

London, Dec 05: European Union regulators on Friday fined Elon Musk's social media platform X 120 million euros (\$140 million) for failing to comply with the bloc's digital regulations.


The European Commission issued its

decision following an investigation it opened two years ago into X under the 27-nation bloc's Digital Services Act. Also known as the DSA, its a sweeping rulebook that requires platforms to take more responsibility for protecting European users and cleaning up harmful or illegal cou tent and products on their sites, under threat of hefty fines. The Commission said it was punishing X, previously known as

Twitter, because of three different breaches of the DSA's transpar-requirements for its ad database and giving

### Messi vs Muller — Two FIFA World Cup winners lock horns in MLS Cup final

Mexico City, Dec 05: Inter Miami and the Vancouver Whitecaps step into an unprecedented Major League Soccer (MLS) Cup final on Saturday, each chasing its first Philip F. Anschutz trophy in a spectacle fuelled by the renewed rivalry between Lionel Messi and Thomas Muller.

With ticket prices at record highs, the free global broadcast will reach more than 100 countries, while the MLS is rolling out its most ambitious production yet for a final featuring two of Europe's stars. At 38, Messi produced the season Inter Miami had hoped for when it brought the eight-time Ballon d'Or winner to Florida, with him steering the club to its first MLS Cup final and setting an all-time assist record of 405 along the way. The Argentine captain had 29 goals and 19 assists in the regular campaign, plus six goals and seven assists in the postseason.

Longtime Bayern Munich talisman Muller, who arrived in Vancouver in August, was instrumental in driving the campaign of the CONCACAF Champions Cup runner-up, delivering seven goals and three assists across seven regular-season matches.

The head-to-head between the two veterans tilts the contest towards the German, with him




winning seven of their 10 meetings, including two Bayern thrashings of Barcelona in the Champions League in 2013 and 2020 and Argentina's painful defeat in the 2014 World Cup final. "Perhaps they rely on him a little more than this team relies on me," the 36-year-old Muller said of Messi and Inter Miami after Vancouver beat San Diego in the Western Conference final. "This is a final I wanted. The good thing is not only playing against the best player who has ever played our sport and who continues to do so, but I think when you have a match like this, more people see you. "If you play with these great players and names, then it's a little more exciting for more people around

the world. It's a perfect situation for everyone involved.'

As Muller suggested, the matchup's profile has lifted the entire event, driving record demand and the most ambitious broadcast MLS has ever assembled. According to marketplace TickPick, this year's final is the most expensive MLS Cup on record, with an average ticket purchase price of USD 565, surpassing the previous USD 501 high from 2022.

MLS and Apple have matched that demand with their largest production ever, promising "the most immersive broadcast yet" with more than 30 cameras, drones, robotic goal units, referee cams and isolated feeds on players and coaches around
