Kashmir: Prevailing dry spell hits natural water supply sources

Srinagar, Dec 06: The prevailing dry spell has led to sharp decline in discharge levels of water supply sources across

Chief Engineer Jal Shakti Kashmir, Er. Rakesh Kumar Gupta, while talking to the news agency—Kashmir News Observer (KNO), said, "The persistent dry weather has affected most natural sources feeding the supply lines." "Due to the dry spell, our water sources have been af-Once the rainfall occurs or weather patterns change, these sources will be recharged," Gupta said.

He said while some areas are facing reduced water flow, the department has intensified its response to maintain supply. "The drinking water supply has got affected a bit, but we are coping with the demand through tanker services."

Er Gupta also said, the department is in continuous touch with the DCs and Divisional Administration and wherever there is a need, tankers are being provided. "There is no major shortage or crisis situation as of now," he said.

IndiGo disruptions continue

21 flights cancelled across J&K airports on Saturday

- ◆ 14 IndiGo, 4 other airline cancellations in Sgr, 3 in Jammu
- Passengers advised to reconfirm flight status before travel

Srinagar, Dec 06: Flight disruptions continued for the second consecutive day at Srinagar and Jammu airports on Saturday, with IndiGo operations again hit by widespread cancellations and delays.

Officials said that out of 64 scheduled flights for the day, 18 were cancelled, 14 operated by IndiGo and four by other carriers, including SpiceJet, while 10 other IndiGo flights experienced delays.

At Jammu airport, three flights were cancelled during the day due to the same operational disruptions affecting



IndiGo's nationwide network, taking the total number of cancellations across the Union Territory to 21 for the day.

An airport official told the news agency-Kashmir News Observer (KNO) that Saturday's schedule at Srinagar airport comprised 64 flight movements with 32 arrivals and 32 departures.

"Of these, IndiGo had 36 flights for the day with 18 arrivals and 18 departures. Fourteen IndiGo flights, seven arrivals and seven departures were cancelled, and 10 others, five arrivals and five departures reported delays," the official said. He added that four Spicele flights - two arrivals and two departures - were also cancelled due to reasons known to the airline, while the remaining four flights scheduled for later in the evening operated normally.

"Passengers are advised to confirm their flight timings and reach the airport well in advance to avoid inconvenience," an airport authority official said. At Jammu airport, officials confirmed | More on P6

Worsening winter air quality in Kashmir raises health concerns Doctors warn of rising respiratory, cardiac ailments; experts call for sustainable measures

Srinagar, Dec 06: As winter sets in and temperatures continue to dip, Kashmir is witnessing a steady deterioration in air quality, raising serious public health concerns.

Environmental experts and doctors said that prolonged dry weather, increased traffic emissions, biomass burning, and industrial pollutants have pushed pollution levels up, particularly in urban pockets

Residents have reported a visible layer of haze over many parts of the Valley, while air quality monitors have repeatedly recorded PM2.5 and PM10 levels above safe limits in recent

The pollution levels remained high with PM10 ranging between 136 and 243 micrograms per cubic metre and PM2.5 between 86 and 167 micrograms per cubic metre, both far above



the World Health Organization's safe limits.

Speaking to the news agency -Kashmir News Observer (KNO), Dr Javid Ahmad Bhat, said that the worsening air quality is directly impacting public health. "Outpatient departments in hospitals have begun to see a surge in patients complaining of cough, breathlessness, chest

tightness, burning eyes, and throat irritation," he said.

"The number of patients with respiratory issues, especially chronic obstructive pulmonary disease (COPD) and asthma, has notably increased over the past few weeks," he added.

The doctor said that poor air quality aggravates existing conditions and triggers fresh

episodes of respiratory distress. Children, elderly, and people with pre-existing lung or heart conditions are especially vulnerable, he added.

Doctors warned that the impact is not limited to respiratory ailments

A cardiologist working at GMC Srinagar said that prolonged exposure to polluted air increases the risk of heart attacks, high blood pressure, cardiac arrhythmias, and stroke. "Fine particulate matter enters the bloodstream and can cause inflammation, which puts additional strain on the heart," he said.

Studies have also linked poor air quality to fatigue, headaches, decreased immunity, anxiety, and disrupted sleep cycles.

Environmental officials attribute the worsening air quality to a combination of factors that include the lack of rainfall, which helps settle dust and pollutants, increased vehicular emissions due to traffic congestion, burning of waste, including plastic and biomass, use of coal bukharis and wood for heating and dust generated from construction sites. An official said the Valley

needs stricter monitoring and long-term planning. "Without sustainable urban management and reduced emissions, we will continue to face worsening air quality each winter," he said.

Doctors have urged the public to take preventive measures to reduce exposure and avoid health complications by limiting outdoor exposure, avoiding morning and evening outdoor activities

when pollution levels peak. They advised keeping windows closed on hazy days, wearing N95 or KN95 masks while outdoors to filter harmful particles, drinking plenty of water to help flush toxins from the body, using air purifiers indoors,

CS leads inter-departmental drive to unlock MAP sector in J&K

JAMMU, DECEMBER 06: Chief Secretary, Atal Dulloo Saturday chaired a joint meeting of the Forest and Agriculture Production Departments along with the CSIR-Indian Institute of Integrative Medicine (IIIM), Jammu, to evolve a comprehensive roadmap for commercial cultivation, conservation and large-scale promotion of medicinal and aromatic plants (MAPs) across Jammu and Kashmir.

The meeting, as per an official statement, was attended by the Additional Chief Secretary, Agriculture Production Department; Commissioner Secretary, Forest Department; Director, CSIR-IIIM Jammu; senior officers of the Forest Department, SKUAST, and other concerned stakeholders.

During the deliberations, the Chief Secretary observed that Jammu and Kashmir is currently generating barely Rs 12 Cr annually from the MAP sector, which is significantly low compared to its immense potential estimated at nearly Rs 10,000 Cr at the national level and about Rs 2 lakh Cr globally. He emphasised the urgent need for a structured, scientifically driven and commercially viable strategy to unlock the sector's economic and livelihood potential, particularly for enhanc-

ing farmers' incomes. Stressing inter-departmental coordination, the Chief Secretary directed the three key stakeholders of Forest Department, Agriculture Production Department, and agricultural research institutions to work with clearly defined roles and responsibilities. He underlined that the Forest Department must focus



on propagation of planting material in natural habitats through its nursery network, provide hands-on training to farmers, and develop replicable cultivation models.

The Agriculture Production Department was asked to identify the most commercially viable species from among over 1,100 MAP species found in the region. The department was also directed to undertake agro-climatic zonation for species-specific cultivation, develop scientifically validated packages of practices, strengthen extension services, and focus on value addition and market

CSIR-IIIM Jammu and SKUAST were advised to provide technical expertise, facilitate technology transfer, and support knowledge dissemination for MAP cultivation. The research institutions were further encouraged to establish Centres of Excellence in Medicinal and Aromatic Plants and develop scientifically robust germplasm banks for preservation and research.

The Additional Chief Secretary, Agriculture Production Department, Shailendra Kumar, emphasized that the roadmap should be long-term and sustainability-oriented. He said the focus should be on creating a self-sustaining ecosystem that ensures attractive returns for farmers, with government support limited to initial handholding through inputs, capacity building and assured market linkages.

Commissioner Secretary, Forest Department, Sheetal Nanda assured full departmental support and highlighted efforts to make regulations more farmer-friendly. She informed that Forest Department nurseries would serve as key support hubs by supplying quality planting material and providing skill training to ensure successful implementation of the initiative.

Managing Director, HADP, Sandeep Kumar briefed the meeting on initiatives already undertaken under the Holistic Agriculture Development Programme (HADP). He informed that 28 MAP clusters involving nearly 1,400 farmers have been established, with cultivation of species such as Lavender, Harad, Wild Marigold

and Rosemary. He added that over 5,300 farmers have been trained during the past two years through field demonstrations, skill development programmes and marketing interventions. The meeting was also apprised about high-demand MAP species suitable for J&K, with market prices ranging from 100 to 1,00,000 per kg.

Director, CSIR-JIIM Jammu,

Dr. Zabeer Ahmad highlighted the phytopharmaceutical and nutraceutical potential of medicinal plants found in J&K and outlined IIIM's role in translating research leads into market-oriented products. He also briefed the meeting on various CSIR Missions in bio-resources, medicinal and aromatic plants, floriculture, and smart agriculture aimed at improving soil and plant health. He informed that IIIM has developed and commercially released several MAP varieties and main-

tains extensive germplasm banks. Dr Ahmad further stated that CSIR-IIIM envisions positioning Jammu and Kashmir as India's leading hub for a MAP-driven bio-economy, focusing on

high-value cultivation, processing and export promotion. Being a recognised biodiversity hotspot, J&K hosts more than 1,100 native MAP species, including around 25 high-value crops with strong global demand. With the global MAP market projected to exceed USD 650 billion by 2030 and India currently holding less than 10 per cent share, the region holds vast untapped potential.

The proposed transformation strategy includes land zonation and optimisation using degraded forest patches, fire lines and marginal government land; establishment of aroma and phyto-pharma clusters across Jammu, Kashmir and the Chen-ab Valley; and fostering strong community-institution-industry

The meeting also discussed the need for suitable amendments to the J&K Minor Forest Produce Policy-2022 to encourage farmer participation, facilitate species identification and niche area development, strengthen R&D infrastructure, and improve market linkages across the Union Territory.

Horticulture Dept warns against undercover auctions in markets

The Department is committed to safeguarding farmer interests, maintaining fair trade practices, and promoting transparency in the marketing system across all regulated markets of Jammu & Kashmir.

Officials said that the Tourism Department is likely to frame a development plan focusing on eco-tourism, village stays, trekking routes, and adventure-based activities. "With proper planning, these destinations can attract nature lovers, trekkers, and families looking for peaceful retreats," an official said.

'Wandering' bear trapped, hunt ends after 11-days

EOW charges duo in Rs 34.7 lakh Dubai export fraud

Srinagar, Dec 06: The Economic Offences Wing (EOW) of Crime Branch Kashmir has filed a chargesheet in a high-value export fraud case against two accused persons, including alleged habitual offender Zahid Bashir Sofi alias Shagoo, before the Court of the City Judge, Srinagar.

In a statement, it said that the chargesheet in FIR No. 31/2023 under Sections 420 and 120-B RPC has been submitted in absentia under Section 512 CrPC, as both accused continue to remain

According to the EOW, Shagoo and co-accused Javeed Ahmad Shah allegedly induced

the complainant to invest in a purported export business involving mutton, rice and other goods to Dubai.

The probe found that the complainant was taken to Punjab to sign a forged agreement with "Mahabir Rice Mill, Mahabir Solvent, Rice Market GT Road Karnal" and later to Dubai to create false credibility around the venture, leading to an investment of rupees 34.74 lakh, which was alleg-

edly misappropriated. The Crime Branch said the case involved forged documents, fabricated agreements and deliberate inducement, establishing offences punishable under Sections 420 and

120-B RPC. It also said that Zahid Bashir Shagoo and his wife are already named in earlier fraud cases — FIR No. 21/2022 and FIR No. 13/2018 - related to allegedly extracting money on the pretext of providing gas agencies. Those chargesheets too were filed under Section 512 CrPC after the accused evaded arrest, it added.

The agency said Shagoo's repeated involvement in multiple fraud cases reflects a pattern of persistent criminal conduct and his continued evasion remains a serious concern.

The Crime Branch has appealed to the public to share any information regarding the whereabouts of the absconding accused, assuring confidentiality of informants—(KNO)

Govt reports over 230 enforcement drives on tainted fertilizer

Srinagar, Dec 05: In a crackdown on malpractices in fertilizer supply, authorities in Jammu and Kashmir have taken more than 230 enforcement actions against black marketing, hoarding, and the supply of substandard products during the current Kharif season, Union Ministry informed in the Lok Sabha. As per the data submitted by J&K to the Centre, the Union Territory conducted 3,694 inspections between April 1 and November 28, 2025, to check irregularities in the supply of urea, DAP and other fertilizers.

During this period, authorities issued 142 show-cause notices, cancelled 44 licences, and registered two FIRs for black marketing-related violations in the UT

Under hoarding-related enforcement, the UT served

31 notices, cancelled two licences, and reported no FIRs. "J&K issued 55 showcause notices for substandard quality cases, while eight notices were served in diversion-related checks, though no FIRs were lodged under these categories.'

The Ministry further said that fertilizer availability across the country, including I&K has remained adequate during the ongoing Rabi 2025-26 season. "Any complaint received at the central level is forwarded to the concerned State/UT for action under the Essential Commodities Act and Fertilizer Control Order.'

The Centre also informed that the fertilizer movement is continuously being monitored through the Integrated Fertilizer Monitoring System (IFMS) and States, UTs are advised to coordinate with manufacturers and importers to ensure timely supply—(KNO)

India's banking system facilitates investment and individual financial needs and therefore, plays a crucial role in the country's economic development.

India's banking sector has indeed undergone a remarkable transformation, evolving from a paper-based, branch-centric system to a leading digital landscape driven by key technological and policy milestones. It has transformed from traditional banking and initial computerisation to biometric identity system - Aadhaar and brought millions of unbanked people into the formal financial system through Pradhan Mantri Jan Dhan Yojana. Such initiatives of the government have been instrumental in promoting financial inclusion by bridging the gap between urban and rural populations and bringing formal banking services to millions.

stone legislations that continue to define its

financial architecture. The Reserve Bank of India is the central bank of the country. The Reserve Bank of India Act, 1934 (II of 1934) establishes the legal foundation for the Bank's operations. It was constituted to primarily regulate the issue of banknotes, maintain reserves in order to secure monetary stability and operate the credit and currency system of the country. In order to strengthen the nation's financial infrastructure, the bank also played a key role in the establishment of organizations

such as the Unit Trust of India, the Industrial Development Bank of India, the National Bank of Agriculture and Rural Development

The Banking Regulation Act, 1949 followed soon after independence, consolidating control over banking activities under a uniform legal structure. It is one of the most significant legislative frameworks in India, regulating the banking sector to ensure stability, security, and growth.

The State Bank of India Act, 1955 marked the formal establishment of the State Bank of India (SBI), transforming the undertaking of the Imperial Bank of India, with a mandate to expand banking facilities on a large scale, more particularly in the rural and semi-urban areas, and for diverse other public

In order to better serve the needs of development of the economy in conformity with the national policy objectives, 14 significant Indian Scheduled Commercial Banks with deposits over Rs 50 crores were nationalized in 1969. Further, a fresh Ordinance was issued which was later replaced by the Banking Companies (Acquisition and Transfer of Undertakings) Act, 1970. To promote the welfare of the people, The Banking Companies (Acquisition and Transfer of Undertakings) Act, 1980 was passed to provide for the acquisition and transfer of the undertakings of certain banking companies.

In addition to these, several important amendments to the RBI Act such as the Banking Regulation (Amendment) Act, 1994, the Banking Companies (Acquisition and Transfer of Undertakings) Amendment Act, 1994 and the Banking Regulation (Amendment) Act, 2007, the Banking Laws (Amendment) Act, 2012 relating to governance, capital flexibility, Statutory Liquidity Ratio (SLR) or Cash Reserve Ratio (CRR) based liquidity management were introduced, reforming India's banking framework.

Poll Reforms In India: **Ensuring Democratic Integrity**

This article reflects on over 50 years of India's electoral history, highlighting the resilience of the election process amid challenges, the innovations introduced by the Election Commission, and the need for ongoing reforms to uphold democracy

ore than 50 years ago, a venerable British scholar of Indian politics wryly observed that elections are one of those things "Indians do rather well." Coming in the backdrop of fears—not entirely illegitimate—of India's democracy being put on permanent hold or becoming 'guided', the sanctity of the electoral process was perceived as a redeeming feature of public life. This basic pillar of democracy secured its ultimate endorsement in 1977 when, despite the shadow of the Emergency, India's electorate voted out an

authoritarian regime.
The ability of the Election Commission (ECI) to ensure that popular will is reflected in the legislatures has been tested over and over in the past seven decades of Independence. Although there have been instances of derailment—the West Bengal Assembly election of 1972 and the Jammu and Kashmir election of 1987 being two notable examples-India's overall experience with elections has helped maintain the legitimacy of the political system.

As happens in a first-past-the-past that exaggerates legislative majorities, there have also been instances of incredulous losers whose anecdotal experiences of the campaign didn't quite correspond with the outcome. In 1971, a defeated side insisted that the use of Soviet-made 'invisible ink' helped Indira Gandhi win handsomely. Similar incredible claims of satellite manipulation of EVMs were heard after the



2009 general election.

What was once the prerogative of conspiracy theorists has become less of a fringe preoccupation in the past year. Encouraged by number-crunchers in his party whose predictions were at variance with the popular mood, the Leader of Opposition has challenged the veracity of the electoral rolls. There have been loud assertions that the ECI is contemplating using the Special Intensive Revision of the electoral rolls to exclude minority voters on the ground that they may not be Indian. The controversy has become a subject of jousting between the political parties in West Bengal and this may spill over to Assam and other North-eastern states.

Since Article 321 of the Constitution and the Representation of People's Act gives the ECI 'exclusive jurisdiction' over the conduct of elections, the electoral process has been kept out of political interference. Over the decades the ECI has introduced many innovations to ensure the fairness of elections. Among the most important are the Model Code of Conduct that imposes curbs on untoward political behaviour and the EVMs which have made manipulation of votes more difficult—although not impossible. There are now norms guiding the deployment of police and paramilitary forces at polling booths. Additionally, with

the spread of technology, the ECI is insisting on CCTV cameras in polling booths to ensure that decorum is maintained, and officials and voters aren't subjected to intimidation.

It is, of course, true that none of these innovations are foolproof. Crude muscle power often prevails at the local level, including at counting centres, and these have potentially perverted outcomes. Anecdotal evidence of manipulation by Returning Officers cannot be disbelieved entirely. When Parliament discusses electoral reforms in the Winter Session it is possible that the country may hear of many more deviations from exemplary democratic conduct that need to be addressed by the ECI. As an important stakeholder in the democratic project, Parliament needs to collate its vast experience of elections for the public good. However, the larger cause of good politics is not served if the political executive issues crude threats, including bodily harm, against the ECI and prevents lesser government officials—on whose decorous conduct the system is completely dependent-from carrying out their Constitutional obligations. The conduct of the ruling party in West Bengal over the ongoing SIR is shameful.

It goes without saying that the existence of accurate voter lists is a basic precondition of democracy. There is an understandable outcry if members of underprivileged communities are coerced into staying away from the polling stations. Unfortunately, the outrage is significantly less when

large numbers are either not included in the rolls or there are duplicate and triplicate entries that could potentially distort the outcome. The ECI has tried to address the issue of. Impersonation through Voter Identity cards and photographs. However, the cheats have also found ways to shortcircuit the system by voting on behalf of people who are either dead or have relocated permanently. In eastern India there is the additional problem of the voter rolls having been padded by individuals who are ineligible to vote in Indian elections.

The ongoing SIR exercise isn't the first time the ECI is undertaking a thorough voter inventory. Although there is no stipulated time schedule, say once in 10 years or so, for this large-scale exercise, it is well recognised that unless this periodic audit is undertaken, the outcome of elections will not accurately reflect the popular will.

In the early decades of the 20th century it used to said, in the context of Ireland, that people were advised to 'vote early and vote often.' An enterprising scholar may find it worthwhile to document how innovative practices such as dead men voting or the votes of one candidate being effortlessly transferred to the tally of his rival are prevalent in parts of India. SIR won't turn all these examples of creative politics into history, but it will add some more conviction to the global belief that India does its elections well. The programme was organized under the guidance and support of Mission Director National Health Mission J&K Baseerul Haq Chaudhary and overall supervision of Director Health Services Jammu Dr. Abdul Hamid Zargar.

The programme, as per an official statement, was conducted under the One Health Approach to strengthen intersectoral coordination across Human health, Animal health and Municipal administration.

Addressing the participating medicos, State Epidemiologist / State Surveillance Officer IDSP Jammu Division Dr Harjeet Rai emphasized the importance of robust rabies surveillance, timely case management and coordinated multisectoral response. He highlighted India's

BJP never compromised on its ideology: Nadda

Deoghar (Jharkhand), Dec 06: BJP President J P Nadda on Saturday claimed that the party has never compromised on its ideology.

Addressing party workers at Deoghar, he exhorted them to work hard to make the lotus bloom in Jharkhand.

"All parties have become dynastic, but the BJP is untouched by it. Even among dynastic politics, there are family feuds. However, I can proudly say we are the only party that operates purely on ideology," said Nadda in his first visit to the state after the 2024 assembly polls. "I was not born in 1952. But

there were people in this country who shared the idea that there will not be two flags, two constitutions, two heads in one country. That leader was Shyama Prasad Mukherjee, who became the first president of the Ian Sangh. From 1952 to 2019, approximately four to five generations passed. But we didn't give up on our idea," added Nadda.

"We remained focused on our goal. The day the people of India empowered us, Prime Minister Narendra Modi's willpower and Amit Shah's strategy demolished

Article 370 and, in the process, established one nation, one constitution, and one leader. We were able to do this because we are connected by our ideas," claimed Nadda.

Further elaborating on the party standing firm on the ideology, Nadda said, "We resolved in 1989 during our executive committee at Palampur (Himachal Pradesh) to pave the way for Ram Mandir. Three generations have passed, and the Congress party mocked us. We didn't lose heart. You all know that Prime Minister Narendra Modi handed over the grand Ram Temple to us in January 2024. The flag was also hoisted there just a week ago."

He also credited the leadership of Prime Minister Narendra Modi for abolishing triple talaq and claimed that it liberated Muslim

"We are a party with ideals; we are made for the country. We work for the development of all, for the progress of all, and this has made us (BJP) the largest mass-based party and the largest party in the world. Today we have 240 MPs, 103 Rajya Sabha MPs, 1,654 MLAs across the country," said Nadda.

He also said that the party has

hundreds of mayors, deputy mayors and thousands of councillors.

"BJP and the NDA rule in 20 states. BJP alone holds the government in 13 states. Soon, this number will reach 14 and 15. When Jharkhand's turn comes, our workers will make the lotus bloom here too," stressed Nadda. Coming down heavily on the Hemant Soren-led JMM-

roeconomic signal. It is a message that India is becoming the growth driver of the global economy," Global growth is around 3 per cent while G7

economies are growing at an average of about 1.5 per cent, he pointed out. "At such a time, India is a model of high growth and low inflation." Modi said. There was a time when people, especially economists in our country, used to express con-

cern over high inflation but the same people now talk of inflation being low, he said in his address. India's achievements are not ordinary, it is not about numbers but about fundamental change brought about in the last decade, Modi asserted.

Echoing the concern, Wahid Ahmed, another Srinagar-based travel agent, said the sudden hike has left passengers "frustrated and helpless," especially those with medical or urgent travel needs. "The airfare has abruptly gone up to over Rs 7,000–8,000 on multiple routes," he added.

Meanwhile, Rouf Tramboo, President of the Travel Agents Association of Kashmir (TAAK), told KNO that the situation underscores the need for stronger airline contingency planning. "Such disruptions hit tourism and passenger confidence hard. Authorities and airlines must coordinate to prevent a repeat," he said.

He added that the disruption has also led to cancellations of other pre-booked flights and tourist arrivals. "The surge in airfares has forced many visitors to cancel or reschedule their winter bookings," he said, expressing hope that the issue is resolved at the earliest. Meanwhile, airport officials maintained that

the remaining operations were running on schedule but urged passengers to verify flight timings before heading towards the airport. (KNO)



Circular economy to boost dairy farmers' income by 20 pc in 5 years: Amit Shah



Sanadar (Gujarat), Dec 06: Union Home and Cooperation Minister Amit Shah on Saturday expressed confidence that implementation of the circular economy model across the country will increase dairy farmers' income by 20 per cent in the next five years.

Shah was addressing cattle rearers associated with Banas Dairy at an event held at Sanadar village in Gujarat's Vav-Tharad district to mark the inauguration of the dairy's bio-CNG and fertiliser plant and ground-breaking of its

milk powder plant.
He praised Banas Dairy's management for successfully developing a model for a circular economy in the dairy sector, which includes generating extra income for farmers through various means, such as converting cattle dung into biogas and bio-fertiliser.

Shah informed the audience that he has brought several members of Parliament to Banaskantha to understand the circular economy model of Banas

"So far, our cooperative dairies have received huge success in procuring milk from farmers and giving

back the income generated from selling milk products. Now, the time has come to focus on the circular economy. You will get your share from the income generated by the dairy by selling biogas and fertiliser produced from cattle dung procured from farmers," he said.

A concrete plan for the implementation of this circular economy model across the country will emerge from the meeting of MPs in Banaskantha in the evening, the minister said.

Shah also informed the gathering that chairpersons and managing directors of all the major cooperative dairies will visit Banas Dairy in January 2026 to understand more about the initiatives taken by the dairy, considered Asia's largest dairy with a turnover of Rs 24,000 crore.

"Apart from the usual milk products like paneer and curd, there are many products that are in demand across the globe, but they are not produced in India. If we focus on those products, dairy farmers can earn extra income," he said.

Shah said Prime Minister Narendra Modi has created a system wherein dairies will get the required finance and technology to

omy model, which also includes leather production from the hide harvested from the cattle that died naturally.

"Our government has created three cooperatives for the agriculture sector and three for the dairy sector. I want to assure you that the circular economy will increase dairy farmers' income by 20 per cent in the next five years," he said.

Murmu also appreciated Putin's support and personal commitment to the India-Russia special and privileged strategic partnership.

The Congress on Friday said that the leaders of the opposition, Mallikarjun Kharge and Rahul Gandhi, were not invited to the banquet, and took a swipe at Tharoor for accepting the invite.

The party's media and publicity department head, Pawan Khera, accused the government of breaking protocols daily and not believing in democratic principles. "There is no invite to both the LoPs, Mr (Mallikarjun) Kharge and Mr (Rahul) Gandhi. This comes as a surprise, but I don't think we should be surprised. This government is known to be breaching all protocols. What else to say, ask the government," Khera said on Friday.

Asked about Tharoor accepting the invite for the banquet, Khera said, "Ask Mr Tharoor. All of us who are in the party, if our leaders don't get invited and we get invited, we need to question our own conscience and listen to our conscience. Politics has been played in inviting or not inviting people, which in itself is questionable, and those who accept such an invite are also questionable." "We would have listened to our voice of conscience," he added. Earlier, Tharoor had said that there was a time when the chairman of the external affairs committee was routinely invited, but that practice seems to have stopped some years ago. On Thursday, Congress leader Rahul Gandhi alleged that the government tells visiting foreign dignitaries not to meet the leader of opposition due to its "insecurity". His remarks came hours ahead of Putin's two-day visit to India.

Low water intake not only reason behind kidney stones Nephrologist reveals hidden causes

New Delhi, Dec 06: Kidney stones cause sharp pain in the back or side, blood in urine, and nausea when they block urine flow. Many people blame low water intake, but stones form from a mix of metabolic, dietary, genetic, and medical factors. Low water does concentrate urine and raise risk, but recurrent stones need a full check with 24-hour urine tests to find the real causes

When it comes to kidney stones, the most common perception is that they are caused by insufficient water consumption, however, that is not always the case. Dr Arjun Sabharwal, MBBS and nephrologist, recently posted an IG video in which he highlighted that kidney stones are not just caused by low water intake, but a host of other reasons. He said,

"Kidney stones are not caused by low water intake alone. They form due to a combination of metabolic, dietary, genetic, and medical factors-this has been clearly shown in multiple large studies published in The New England Journal of Medicine (NEJM), American Journal of Kidney Diseases (AJKD), and Nature Reviews Nephrology.



Treating the root fixes the problem better than water alone. Let's examine reasons highlighted by Dr Sabharwal...

High urine calcium

High urine calcium, or hypercalciuria, affects 30-60% of stone formers. It happens when kidneys leak calcium, or the body absorbs too much from food. This leads to calcium oxalate or phosphate crystals, that grow into stones. Studies show these imbalances cause supersaturation in urine, even with good hydration. A 24-hour urine test spots it, and drugs like thiazides lower calcium output. Oxalate overload from diet

and gut High oxalate in urine comes

from foods like spinach, nuts, chocolate, or excess vitamin C supplements. It binds calcium to form sharp oxalate stones, the most common type. Gut issues like low Oxalobacter formigenes bacteria, and boost absorption by 10-50%. Even though primary hyperoxaluria is genetic and rare, but severe. Even normal eaters get hit if urine volume drops, or calcium is low. To tackle this. limit high-oxalate foods, and pair with calcium-rich meals to bind it in the gut.

Low citrate lets stones form

easily Citrate acts as a natural blocker, by binding calcium and raising urine pH to dissolve crystals. Low urine citrate, or hypocitraturia, hits 20-60% of patients. Causes include chronic diarrhea, high animal protein, potassium lack, or infections. Without it, calcium stones grow fast. Acidic urine from exercise or drugs worsens this. Large studies link low citrate to recurrence even in hydrated people.

Uric acid and excess protein High uric acid forms acidic stones in 5-10% of cases, often from red meat, seafood, or gout. It lowers urine pH and seeds calcium oxalate stones too. Metabolic syndrome boosts this, via insulin resistance. High animal protein adds acid load, dropping citrate. Obesity and diabetes double odds. NEJM reviews show purine-rich diets raise risk 2-3 times. To counter this, reduce meat consumption, and add veggies for balance.

Salt, low calcium, and hidden diet traps

High salt intake pulls calcium into urine; over 6g daily doubles stone risk. Low dietary calcium fails to bind oxalate in the gut, raising absorption. To prevent this, get 1,000-1,200mg from dairy or greens, and not supplements, since excess vitamin C turns to oxalate. Studies confirm these dietary shifts cause stones beyond dehydration. Track sodium under 2,300mg, and eat calcium with meals

Medical conditions and genetics play big roles

Obesity, diabetes, gout, thyroid issues, IBD, and UTIs change urine chemistry, while family history raises odds 2.5 times, via genes like those for hypercalciuria. Drugs like diuretics, topiramate, or calcium antacids too, can lead to kidney stones.

FIFA awards first-ever peace prize to US President Trump ahead of World Cup draw

New York, Dec 06: FIFA, the global governing body for international football, on Friday named American President Donald Trump as the first winner of the newly-created FIFA Peace Prize, during the draw ceremony for next year's FIFA Men's World Cup to be jointly hosted by the United States, Canada, and Mexico.

Trump proclaimed that "the world is a safer place now" as he received the award at the draw for the 2026 World Cup in Washington, DC. FIFA will be distributing the teams. Gianni Infantino, the Fifa president and one of Trump's closest sporting allies, presented the honour onstage at the Kennedy Centre for the Performing Arts on Friday, saying Trump had been selected "in recognition of his exceptional and extraordinary actions to promote peace and unity around the world".

Trump, who has been openly campaigning for the Nobel Peace Prize but has not been nominated this year, was heavily favoured to receive the newly created award because of Infantino's support.

The certificate that Infantino handed Trump recognises the U.S. president for his actions to



"promote peace and unity around the world." FIFA says the prize is for "individuals who help unite people in peace through unwavering commitment and special actions".

"This is what we want from a leader — a leader that cares about the people," Infantino said about Trump, who wore a gold medal around his neck and was presented with a gold trophy with his name on it that depicts hands holding up the world, as it does in the FIFA World Cup. In his bid to win the

Nobel Peace Prize, Trump has laid claim to various peace initiatives, including brokering peace between Israel and Palestine and India and Pakistan when they engaged in an arms exchange after India launched Operation Sindoor to destroy terror infrastructure across the border in Pakistan following a terror attack in Pahalgam in Jammu & Kashmir.

India has repeatedly denied that a ceasefire during Operation Sindoor was agreed because of American

Pope says won't be 'bystander' to human rights abuses

Vatican City, Dec 06: Pope Leo XIV told new ambassadors to the Holy See on Saturday that the Vatican would not be a "silent bystander" to human rights abuses around the world.

The comments are one of the clearest yet in revealing the philosophy of the US pope, who was elected head of the world's Catholics in May following the death of Pope Francis.

"I wish to reaffirm that the Holy See will not be a silent bystander to the grave disparities, injustices and fundamental human rights violations in our global community, which is increasingly more fractured and conflict-prone," he told the group of 13 ambassadors.

The Holy See is the governing body of the Church led by the pope, who has spiritual authority over 1.4 billion Catholics.

The diplomacy of the Holy See, the pontiff said, was "consistently directed toward serving the good of humanity, especially by appealing to consciences and by remaining attentive to the voices of those who are poor, in vulnerable situations or pushed to the margins of society.'

With his focus on inequality, Leo is building on the priorities of his predecessor Francis, who championed the rights of migrants and other vulnerable populations during his pontificate.

Leo – who spent nearly 20 years as a missionary in Peru – has spoken up against the treatment of migrants in the United States under President Donald Trump, last month calling it "extremely disrespectful.

The new ambassadors accredited on Saturday, and welcomed with an audience within the Vatican, were from Uzbekistan, Moldova, Bahrain, Sri Lanka, Pakistan, Liberia, Thailand, Lesotho, South Africa, Fiji, Micronesia, Latvia and Finland.

Israeli defence firm says it plans to supply first batch of LMGs to India early next year



Jerusalem, Dec 06: A leading Israeli defence firm has said it intends to supply the first batch of 40,000 light machine guns (LMGs) to India starting early next year, while it is in the final stages of signing a contract to supply nearly 1,70,000 new-age carbines. Shuki Schwartz, CEO of Israel

Weapon Industries (IWI), also said that his firm is currently collaborating with various agencies within India's Ministry of Home Affairs to market their products, including pistols, rifles, and machine guns.

"We're now involved in three significant programmes. First is the contract for 40,000 light machine guns, which was signed last year. We have completed all tests, trials,

and government checks, and we have received the license for production. We intend to supply the first batch at the beginning of the year," Schwartz told PTI in an interview.

"LMGs supply is for five years. We can do it faster, but the first supply will be at the beginning of the year," he said when asked about the time-

line of the supply.

Schwartz said the second programme involves the CQB (Close Quarters Battle) carbines tender, where the firm was the second bidder. Bharat Forge is the primary bidder. "We intend to supply 40 per cent of the contract. We are in the stage of pre-signing of the contract, and I believe it will be finalised by the end of this year or the beginning of next

In reply, Tanmay Agarwal cracked 11 fours and a six to make 67 not out off 42 balls as Hyderabad responded with 134 for three in 12.5 overs.

Shubman Gill cleared by CoE to play 1st T20I



Cuttack, Dec 06: India's T20I vice-captain Shubman Gill has been cleared by the Sports Science team of the BCCI's Centre of Excellence to play the opening T20I against South Africa after successfully completing his rehabilitation from a neck injury sustained during the Kolkata Test.

Gill was selected in the squad subject to fitness and had to undergo all rehabilitation and skill-training protocols required for Return To Play (RTP).

"Shubman Gill has successfully completed his rehabilitation at CoE and has met the requisite criteria to be declared fit for all formats of the game," a communication from the CoE has gone to the team management's Sports Science and Medicine (SSM) team, comprising physio Kamlesh Jain, strength and conditioning coach Adrian Le Roux and

sports doctor Dr Charles. Gill had suffered a whiplash on the second day of the Kolkata Test and had to be hospitalised for a couple days and administered injection.

He missed the ongoing ODI series but all doubts over his availability for the T20 leg were dispelled as he completed his rehabilitation and also performed his skills training - batting and fielding - in a match simulation at CoE.
