Sub-zero nights grip Kashmir, dry spell likely to continue

Srinagar, Dec 08: With the Meteorological Department forecasting dry weather over the next ten days, minimum temperatures continued to dip across Jammu & Kashmir and Ladakh on Monday, with several places in the Kashmir Valley and Ladakh recording sub-zero readings, officials said.

As per the news agency—ashmir News Observer Kashmir (KNO), in the Kashmir region, Shopian recorded the coldest night at minus 4.2°C, followed by Srinagar Airport at minus 3.2°C, Budgam, Baramulla, and Pulwama at minus 3.1°C each.

Srinagar city registered a low of minus 2.4°C, while Bandipora recorded minus 2.2°C and Ganderbal minus 2.3°C. Other areas saw Kokernag at 0.1°C, Kulgam at 0.8°C, and Pahalgam at minus 0.4°C.

MoEFCC panel to decide on 260-MW Dulhasti stage-II hydropower project in Dec

NHPC to execute project on BOOT mode

Srinagar, Dec 08: The Union Ministry of Environment, Forest and Climate Change (MoEFCC)'s Expert Appraisal Committee (EAC) is set to decide on the environmental clearance of the 260-MW Dulhasti Stage-II hydroelectric project later this month.

The run-of-the-river project will be reviewed by the panel during its meeting scheduled for December 19, 2025, in New Delhi.

As per the agenda of the 45th EAC meeting accessed by news agency—Kashmir News Observer (KNO), the project will be taken up as agenda item 45.2 between 12:00 PM and 01:30 PM for appraisal by the panel.

During the meeting, the panel will scrutinize

the Environmental Impact Assessment (EIA), public hearing proceedings, queries subsequently raised by the ministry, and any court matters or orders related to the project.

The project, coming up in Kishtwar district of the Valley, is being executed by the National Hydroelectric Power Corporation (NHPC) on a Build, Own, Operate & Transfer (BOOT) basis.

On January 03, 2021, NHPC Limited signed a Memorandum of Understanding with the Government of Jammu and Kashmir for execution of the project on BOOT mode for a period of 40 years.



'Forest fires claim 438 Sq Km from **Nov-23 to Jun-24'**



Srinagar, Dec 08: The Ministry of Environment, Forest & Climate Change has said Jammu and Kashmir is one of the major hotspots of forest fires with the region losing over 438 square Kilometers of land to blazes between November 2023 and June 2024.

The data placed before the Lok Sabha by the Ministry said that satellite-based monitoring by the Forest Survey of India (FSI) indicates significant forest fire impact in several Indian states, including J&K.

The burnt area assessment for November 2023 to June 2024 shows that it has damaged over 438 Sq Km in J&K—thus placing it among the affected hill regions where dry conditions and rising temperatures continue to fuel vulnerability to wildfires.

The Ministry further said that the forest protection is primarily the responsibility of State and UT administrations, but the FSI provides pre-fire alerts, real-time

The official data placed before the Lok Sabha, the Centre has sanctioned two projects for Ladakh under Swadesh Darshan 2.0 and one additional project under CBDD, collectively focusing on biodiversity, border tourism, eco-tourism and community-based livelihood development.

The official figures reveal that under Swadesh Darshan 2.0, Ladakh has received Rs 23.17 crore for 'Julley Leh Biodiversity Park' that is aimed to enhance eco-tourism experiences. Besides, the Rs 11.91 crore has been received under 'Exploring LoC and Hundarman Vil-

lage Experience, Kargil'. Additionally, under the CBDD sub-scheme, the Ministry has sanctioned 'Advancing Mushkoh as a Sustainable Tourism Hub' with Rs 9.82 crore.

The Ministry noted that Swadesh Darshan 2.0 focuses on developing sustainable and responsible tourism destinations, including lesser-known regions and eco-tourism circuits, with an emphasis on enhancing local amenities, capacity building, and digital infrastructure.

Chinese national detained in Sgr

Hotels, homestays booked for skipping Form-C

Srinagar, Dec 08: Jammu and Kashmir Police on Monday detained a Chinese national and booked several hotels, homestays and houseboats in Srinagar for violating mandatory Form-C reporting norms under the Immigration and Foreigners Act.

An official said that five First Information Reports have been registered across different police stations following routine checking of accommodation facilities in Raibagh, Khanyar, Lal Bazar, Nishat and Ram Munshi Bagh areas.

In Rajbagh, Hotel Blossoms, Hotel Grand MS and Hotel Golden Forest were found to have accommodated foreign nationals without submitting Form-C to the Foreigners Registration Office, leading to the registration of FIR No. 65/2025 under Sections 8 and 23-B of the Act at Police Station Rajbagh, the official said.

Hotel Khyber in the Khanyar area also faced action for non-submission of Form-C despite repeated reminders, resulting in FIR No. 57/2025 at Police Station Khanyar. In Lal Bazar, a homestay identified as IMY Home Stay in Nowabagh Bagwanpora was booked for concealing the stay of a foreign national from Israel and failing to file mandatory online Form-C information. FIR No. 60/2025 under the same Act was registered in Police Station Lal Bazar. Police said an FIR was also filed in Nishat (FIR No. 101/2025) against a house owner from Vakeel Colony, Brein, for non-compliance with reporting obligations.

In Ram Munshi Bagh, four

houseboats Floating Castle, Best View, Crystal Palace and Lake Palace were booked for similar violations relating to guests from Taiwan, Russia, Romania and Spain. FIR No. 94/2025 under Sections 7, 14 and 16 of the Immigration and Foreigners Act was registered at Police Station Ram Munshi Bagh.

The spokesperson said investiga-tions are underway to determine whether there are forward or backward linkages to the violations. Operators of hotels, homestays, guest houses and houseboats were advised to strictly comply with for eign guest reporting norms, with police warning that non-compliance constitutes a serious offence under law. Meanwhile, probe agencies have sent the mobile phone of Chinese national Hu Congtai for forensic examination after he was detained in Srinagar over alleged visa violations, officials said.

Hu, 29, had arrived in India on a tourist visa that permitted travel to select Buddhist pilgrimage sites but had toured Ladakh and parts of Kashmir, including locations of strategic interest, they said.

His browsing data indicated searches related to security deployments and Article 370, prompting investigators to examine the device to ensure no data was erased prior to detention, according to officials.

Hu arrived in Delhi on November 19 and travelled to Leh the next day without registering at the Foreigners Regional Registration Office counter at the airport. He later arrived in Srinagar and stayed at an unregistered guest house, officials said—(KNO)

Winter fires decline in Srinagar, but risk stays high: F&ES

Srinagar, Dec 08: Despite a decline in fire incidents across Srinagar this year, the Fire and Emergency Services (F&ES) Department has cautioned residents to remain vigilant during the winter months, when the use of heating and cooking gadgets significantly raises fire risks.

Agib Hussain Mir, Assistant Director F&ES, Kashmir, said that while awareness campaigns have helped reduce the overall number of incidents, winter remains a "critical period" for fire hazards.

"Last year, Srinagar recorded around 720 fire incidents, whereas this year the number stands at 468 so far. On average, monthly cases have dropped from 60 to 42, which is a positive trend," Dr Mir said. "This reduction is mainly due to awareness campaigns launched under the direction of our Director."

He said that despite the decline, winter still witnesses a spike in fires compared to summer due to the excessive use of electrical and LPG-based heating gadgets.

"People should ensure that all gadgets, whether electrical heaters, LPG bukharis, or geysers, are SI-marked and tested before use. Equipment stored for months must be checked and serviced before operating," he said, adding that substandard or overloaded devices often lead to short circuits and fires.

According to Mir, two major causes dominate Kashmir's fire incidents: electrical short circuits and LPG leaks. "We have seen that most cases stem from these two sources. Faulty wiring, overloading of sockets, or the use of non-standard circuit breakers are common triggers. On the LPG front, leaks inside confined rooms can turn fatal," he said. The Assistant Director advised residents using LPG-based heating systems to always maintain proper ventilation, as the combustion process consumes oxygen and can lead to suffocation or explosions if gas accumulates

Mir also stressed the importance of fire preparedness at the household level. "People should keep a dry chemical powder-type fire extinguisher at home, ideally 5 or 6 kg, with proper BIS certification. A small extinguisher, costing between 3,000 and 10,000 rupees, can prevent a minor spark from turning into a major blaze," he said.

He said the concept of the "golden hour" in firefighting - the crucial initial moments when timely action can save both life and property. "Our response time depends on how quickly the call is made and whether access routes are clear. Wrong parking often delays our movement. Cooperation from the public can drastically improve outcomes," he added. Addressing allegations of delayed response by the department, Dr Mir clarified that "there is no intentional delay from Fire and Emergency Services". "Our teams are highly trained and respond promptly. Delays mostly happen due to access blockages or congestion on roads," he said.

He urged citizens to adopt firesafe practices such as keeping combustible materials away from living areas, turning off heating gadgets before sleeping or leaving home, and ensuring periodic electrical audits of homes. "If people follow these simple safety guidelines and cooperate with fire services, the number of incidents and the loss of life and property can be significantly minimised," Mir said—(KNO)

India Hosts UNESCO's 20th ICH Session A landmark moment in safeguarding living heritage

he Government of India will host the 20th session of the UNESCO Intergovernmental Committee for Safeguarding of the Intangible Cultural Heritage from 8 to 13 December 2025 in New Delhi. The historic Red Fort complex, a UNESCO World Heritage Site, has been chosen as the venue, symbolising the convergence of India's tangible and intangible heritage under one roof.

This will be the first time that India hosts the ICH Committee session, and the meeting will be chaired by H.E. Vishal V. Sharma, India's permanent delegate to UNESCO. The event coincides with the twentieth anniversary of India's ratification of the 2003 Convention for Safeguarding of the Intangible Cultural Heritage in 2005, underscoring India's sustained commitment to preserving living cultural traditions.

Intangible cultural heritage, as UNESCO defines it, include the practices, knowledge, expressions, objects, and spaces that communities see as part of their cultural identity. Passed down over generations, this heritage evolves, strengthening cultural identity and appreciation of diversity.

Historical Background

For the Safeguarding of Intangible Cultural Heritage, UNESCO adopted the 2003 Convention on 17thOctober 2003 during its 32nd General Conference in Paris. The Convention responded to global concerns that living cultural traditions, oral practices, performing arts, social customs, rituals, knowledge systems, and craftsmanship were increasingly threatened by globalisation, social change, and limited resources.

The Convention placed communities, espe cially indigenous communities, groups, and individual practitioners, at the heart of safeguarding efforts, acknowledging their vital role in creating, maintaining and transmitting cultural heritage. It underscored the interdependence between tangible and intangible heritage, the need for global cooperation, and the importance of raising awareness among younger generations. With a shared global commitment to protecting humanity's living heritage, the Convention formally established mechanisms for international cooperation, support, and recognition, laying the foundation for UNESCO's Intangible Cultural Heritage lists and the subsequent work of the Intergovernmental Committee.

The purposes of this Convention are

To safeguard the intangible cultural heritage; To ensure respect for the intangible cultural heritage of the communities, groups and individuals concerned;

To raise awareness at the local, national and international levels of the importance of the intangible cultural heritage, and ensuring mutual appreciation thereof;

To provide for global cooperation and assistance.

Functions of the Intergovernmental Committee

Intergovernmental Committee for Safeguarding of the Intangible Cultural Heritage advances the objectives of the 2003 Convention and ensures their effective implementation across Member States. In fulfilling this mandate, the committee:

Promotes and monitors the objectives and implementation of the 2003 Convention. Provides guidance on best practices and rec-

ommends measures for safeguarding intangible cultural heritage. Prepares and submits to the General

Assembly the draft plan for the use of the Intangible Cultural Heritage Fund.

Mobilises additional resources for the Fund in accordance with the Convention's provisions. Drafts and proposes operational directives

for the implementation of the Convention. Examines periodic reports submitted by States Parties and compiles summaries for the

General Assembly. Evaluates requests from States Parties and

India And The Gulf States Could Reshape Global Trade

In an increasingly multipolar world, India and the Gulf states are no longer merely trading partners but strategic actors in their own right. Together, they are advancing a model of cooperation that values autonomy, transparency, and mutual gain over coercion and dependence on great powers.

The recent Middle East Investment Forum in Sharjah underscored the deepening economic relationship between India and the Gulf states. As US President Donald Trump's tariffs erode the competitiveness of Indian exports, Indian firms are increasingly turning to the United Arab Emirates as a bridge to American markets, strengthening cross-

regional ties. As a result, what was once a relationship based on the exchange of oil for labor has evolved into a partnership spanning technology, finance, and security. The Gulf and India are no longer merely trading partners; together, they are spearheading a geoeconomic realignment and

redrawing the map of global trade. The relationship between India and the Gulf has deep historical roots. For centuries, caravans and merchant ships, carrying spices and textiles, established enduring cultural and commercial ties between the two regions. Moreover, under the British Raj, much of the Gulf was administered from New Delhi.

In the decades following India's independence, ties became largely transactional: oil flowed one way, labor the other, and wealth moved in both directions. Only recently have India and the Gulf states rediscovered the strategic value of their historic partnership and begun to reimagine it for the 21st century.

By the mid-2010s, the two sides' strategic priorities began to align. In 2015, Indian Prime Minister Narendra Modi visited the UAE – the first such visit in 34 years – as Gulf leaders like UAE President Mohamed bin Zayed Al Nahyan and Saudi Crown Prince Mohammed bin Salman launched ambitious plans to diversify their economies beyond hydrocarbons.

This convergence was driven by domestic shifts. The Gulf states recognized the risks of fossil-fuel dependence and began channeling resources into renewables, tech, and tourism. Meanwhile, India – racing to industrialize and digitize - found eager partners in the Gulf with the necessary capital and ambition. India sought investment and expertise, and the Gulf sought scale and new avenues for growth.

What followed was a period of intense economic and diplomatic engagement, from the establishment of the I2U2 partnership - which includes India, Israel, the UAE, and the United States – to Gulf leaders honored at India's national celebrations. The numbers speak for themselves: India-UAE trade has risen to \$100 billion this year, while India-Saudi trade reached \$43 billion in 2023-24.

Equally important is where that capital is flowing. Sovereign wealth funds like Abu Dhabi's Mubadala and Saudi Arabia's Public Investment Fund have invested heavily in Indian startups, infrastructure, and green-energy projects. These are not one-off transactions but long-term bets on the future of the geopolitical alliance. Building on this momentum, the re-

vitalized India-Gulf axis is now looking outward. The proposed India-Middle East-Europe Economic Corridor promises to reshape global trade routes, linking Indian ports to the Mediterranean through Gulf rail networks and establishing modern, resilient supply chains alongside the Suez Canal.

In this sense, the partnership represents a modern-day equivalent to the old spice routes. But the spices have been replaced by advanced technologies, and the caravans have given way to container ships, fiber-optic cables, and digital payments. India's Unified Payments Interface is crossing borders, while undersea power cables and green-hydrogen projects are laying the groundwork for a shared energy and digital ecosystem.

The fledgling partnership is now expanding into Africa. The UAE has pledged over \$100 billion in investments across the continent, while Saudi Arabia has announced \$41 billion in development initiatives. India, for its part, brings decades' worth of goodwill – built through peacekeeping missions, development projects, and a vibrant diaspora network - that complements Gulf capital and amplifies the bloc's influence.

Emerging trilateral ventures, with Emirati capital financing infrastructure built by Indian firms in Africa, represent a compelling alternative to the great powers' projects on the continent, which often lead to debt traps and come with political strings attached. For mediumsized economies wary of being caught in the middle of the US-China rivalry, the India-Gulf alliance offers infrastructure without unsustainable debt, technology partnerships without hidden agendas, and security cooperation without foreign

interference. The India-Gulf partnership also shows how digital tools can drive development. By combining India's affordable, opensource digital architecture with Gulf capital, the partnership is delivering modern

infrastructure, inclusive digital IDs, and climate-conscious ventures that generate well-paid local jobs.

But this is not non-alignment 2.0. Instead, the India-Gulf story is one of multi-alignment – a pragmatic geopolitical strategy rooted in shared interests,

mutual benefit, and autonomy. To be sure, the alliance faces powerful headwinds: regional rivalries, domestic frictions, and global volatility. Yet the confidence is unmistakable: no longer bound by others' strategies, India and the Gulf states are charting their own

If their partnership endures, it will be more than a bilateral success. The India-Gulf nexus could become a new center of gravity in an increasingly multipolar world – and a template for other emerging economies seeking open-source technology, resilient trade, and broad-based

Earlier, Chairperson, J&K RERA, Satish Chandra, briefed the meeting on the mandate and functioning of the Authority, which was established under an Act of Parliament in 2016. He informed that JKRERA exercises jurisdiction over all residential and commercial real estate projects in the Union Territory, including plotted developments exceeding 500 square metres or eight apartments, as envisaged under Section 3 of the Act.

He further stated that registration of eligible real estate projects and real estate agents with JKRERA is mandatory, and no promoter is permitted to advertise, market or sell any project without such registration.

per cent of the project cost and imprisonment for promoters in cases of violations such as non-registration of projects and failure to comply with the orders of the Authority or the Appellate Tribunal.

The Authority also high-

The Authority also highlighted the awareness programmes being conducted to sensitise stakeholders about the provisions of the Act, buyer safeguards and regulatory obligations. A summary of enforcement actions undertaken and complaints disposed of was also presented during the meeting.

The key issues discussed in the meeting includes lack of clarity regarding layout approvals for colonies in rural areas, delays due to multiple departmental approvals, and the need for enhanced inter-departmental coordination.

To address these challenges,

JKRERA proposed clearer delineation of approval authorities in rural areas, establishment of a Single Window System for integrated approvals and registrations, and constitution of district-level enforcement cells under the Deputy Commissioners to strengthen monitoring, reporting and enforcement of RERA violations. These measures, it was emphasised, would ensure transparent, regulated and planned development of the real estate sector across I&K.

Woman dies after C-section in Anantnag, family alleges medical negligence

Inquiry committee constituted, to submit report withing 14 days

Anantnag, Dec 08: A 25-yearold woman from Anantnag died under mysterious circumstances last night, with her family accusing doctors at the Maternity and Child Care Hospital (MCCH) Anantnag of medical negligence.

The family has sought a high-level investigation and stringent action against those responsible.

Family members said that the woman, Khusboo, a resident of Pushwara area of Anantnag, underwent a C-section surgery on Saturday evening. However, soon after the procedure, her condition started deteriorating rapidly.

"We were told the delivery went fine, but within a short time, we saw her health collapsing," said a relative of the deceased. "Doctors later told us she needed another surgery to remove her uterus. We believe they only said this because they had failed to control her bleeding."

The family claims that the decision to remove her uterus was taken hastily and without

proper explanation. They allege that despite the procedure, her condition continued to worsen.

"She was completely fine before going into labour. What happened inside that labour room only the doctors know," said another relative "After the second surgery, they shifted her to GMC Anantnag's main hospital at Janglat Mandi, where doctors told us she was already '90 per cent dead' on arrival. How can a patient deteriorate so fast unless something seriously went wrong?"

Doctors at GMC Anantnag made efforts to revive her, but she was declared dead soon after. "We don't only want an investigation. We want this case to reach its logical conclusion. Whoever is responsible must face the music so that no other family suffers like us," the family demanded.

The relatives vowed that they will not rest until the truth is revealed.

"This is not just about Khusboo," said another relative. "This is about every woman who goes to a hospital, trusting the system. We want answers, not empty assurances."

Reacting to the allegations, an official of GMC Anantnag said the hospital has already constituted a five-member inquiry committee to look into the incident.

"A fair and transparent investigation is underway," he said. "If any negligence is found at any level, action will be taken strictly as per the law."

Prof (Dr) Iffat Hassan Shah, Principal GMC Srinagar, has been appointed as inquiry officer to conduct a detailed investigation into the incident, according to a government order. She will be assisted by Dr Mushtaq Ahmad, Medical Officer, GMC Anantnag.

"The Inquiry Officer shall submit a detailed report, along with her recommendations withing 14 days positively," the order states.

Meanwhile, MLA West, Advocate Abdul Majeed Larmi, visited the bereaved family and expressed solidarity with them.

"This is heartbreaking," Larmi said. "I assure the family that the matter will be followed to its end. Justice will be delivered, and if anyone is found guilty, they will be held accountable."

MY Tarigami chairs Environment Committee meeting

Jammu, Dec 08: A meeting of the Committee on Environment, Jammu and Kashmir Legislative Assembly, was held on Monday to discuss malignant Brain Tumors linked with the Pesticides exposure among the Orchard workers and farmers in Kashmir Valley.

The meeting presided over by the Chairman of Environment Committee, MLA Mohammad Yousuf Tarigami and attended by members Dr. Sajjad Shafi; Peerzada Feroze Ahmad; Zafar Ali Khatana; Mushtaq Guroo and Darshan Kumar.

The meeting had detailed discussion on the alarming rise of primary malignant brain tumors among the orchard workers and farmers in Kashmir Valley, reportedly linked to pesticide exposure. The SKIMS data (2005-2008) highlighted the issue, sparking concerns about the health and well-being of those living and working in the

region's orchards. Key questions were raised about annual screening programs for neurological illnesses and cholinesterase levels, and the proposed steps for initiating mass health surveillance.

Other issues discussed included issuance of departmental advisory to the public regarding safe pesticide use and health hazards, steps being taken to introduce safe pesticide alternatives and biological agents, conduct of awareness

programs for the farmers, existing rehabilitation or medical assistance schemes for the pesticide-affected families and orchard workers besides status of mechanism for periodic reassessment of pesticide safety on neurological health.

Secretary, Health & Medical Education, Dr Abid Rasheed Shah, Director SKIMS, Srinagar and other senior health authorities briefed the Committee about the issues highlighted in the meeting.

The ministry said that under MGNREGA, Jammu and Kashmir generated Rs 4.07 crore person-days in 2020–21, Rs 4.06 crore in 2021–22, Rs 3.09 crore in 2022–23, Rs 3.75 crore in 2023–24, and Rs 4.09 crore persondays in 2024–25. "The current financial year (as on November 2025) stands at 2.23 crore person-days."

Ladakh, that participates in MGNREGA separately as a UT, generated Rs 0.21 crore persondays in 2020–21, Rs 0.19 crore in 2021–22, Rs 0.20 crore in 2022–23, Rs 0.20 crore in 2023–24, Rs 0.22 crore in 2024–25, and Rs 0.14 crore person-days so far in 2025–26.

PM Modi slams Congress for overruling Mahatma Gandhi's wishes on Vande Matram

Cites appeasement politics

New Delhi, Dec 08: Prime Minister Narendra Modi on Monday accused the Congress of breaking into pieces national song Vande Mataram under the guise of social harmony, and said it was still following the politics of appeasement.

He also targeted former prime minister Jawaharlal Nehru for agreeing with the suggestion that Vande Mataram could antagonise

Speaking in the Lok Sabha during a discussion on Vande Mataram, Modi cited a letter written by Nehru to Subhash Chandra Bose claiming that the background of Vande Mataram could antagonise Muslims. He said the letter was written following a protest by Mohammad Ali Jinnah in Lucknow. Quoting the letter, Modi said,

Nehru had written that he had read the background of the song and it could spark anger amongst Muslims. Modi said later Congress convened a session in "Bankim Chandra Chatterjee's Bengal" to review the use of Vande Mataram.

"But, on October 26, Congress compromised on Vande Mataram. They broke it into pieces under the mask of social harmony, but history is witness .. This was Congress' attempt at politics of appeasement. Under pressure of politics of appeasement, Congress agreed to divide Vande Mataram.. this is the



reason Congress also bowed to the demand for partition..," Modi alleged. The prime minister said history is a testament to the fact that Congress knelt before the Muslim League and did this under pressure.

"This is an instance of the politics of appeasement of the Congress. Because it bowed to the division of Vande Mataram, it bowed to the division of India later on.

"Congress has maintained the same politics of appeasement even today," he asserted amid thumping of desks by treasury benches.

The prime minister recalled that Mahatma Gandhi wrote in 1905 that Vande Mataram has become so popular that it has emerged as national anthem and wondered that why was injustice meted out to it. "If Vande Mataram was so popular, why was injustice meted out to it, why was it betrayed in the last century.What were those forces that were so powerful to overrule

the wishes of Mahatma Gandhi on Vande Mataram," he said. Modi lamented that the Constitution was "throttled" and the nation chained by the Emergency when national song Vande Mataram completed 100 years.

The prime minister also noted that Vande Mataram stood like a rock and inspired unity despite British oppression.

"When Vande Mataram completed 100 years, the nation was chained by the Emergency. At that time, the Constitution was throttled and those who lived and died for patriotism were pushed behind bars," he said. "The Emergency was a dark chapter in our history. Now we have the opportunity to restore the greatness of Vande Mataram. And I believe this opportunity should not be allowed to pass," Modi said.

Modi noted that the mantra of Vande Mataram gave power and inspiration to the entire country during freedom struggle.

'The mantra energised and inspired India's freedom movement and showed the path of courage and determination. Remembering that sacred Vande Mataram today is a great privilege for all of us in this House.

"It is a matter of pride for us that we are witnessing the historic occasion of Vande Mataram completing 150 years," he said.

The prime minister recalled that the British were forced to ban Vande Mataram even though they brought in laws to prevent printing and propagation of the poem.

"Vande Mataram was written at a time when, after the uprising of 1857, the British government was alarmed and unleashing various forms of oppression. A campaign was underway to push the British national anthem 'God Save the Queen' into every household.

"Through Vande Mataram, Bankim Chandra Chattopadhyay responded to this challenge with great strength and resolve. British divided Bengal in 1905, but Vande Mataram stood like a rock and inspired unity," he said.

SC refuses urgent hearing of plea on flight cancellations by IndiGo

Says govt has taken steps

New Delhi. Dec 08: The Supreme Court on Monday refused to accord urgent hearing to a plea seeking judicial intervention into cancellation of hundreds of flights by IndiGo, saying the Centre has taken note of the situation and has taken steps to address it.

The top of was cognizant of the fact that lakhs of people are stranded at various airports. "It is a serious matter. Lakhs of people are stranded at the airports. We know that the government of India has taken timely action and cognizance of the issue. We know people may have health issues and other important issues etc.," Chief Justice Surya Kant, who was heading a bench comprising Justice

Joymalya Bagchi, said. A lawyer mentioned the issue and said there have been a lot of flight cancellations by Indi-Go over the last few days and passengers are

suffering.

'The cancellations are not informed to the fly-ers," he said, adding that around 2,500 flights are delayed and customers are suffering at 95 air-

Over 250 IndiGo flights from Delhi and Bengaluru airports were cancelled on Monday as the disruptions of the airline's flight operations entered the seventh day, sources told PTI.

At the Delhi airport, 134 flights were cancelled -- 75 departures and 59 arrivals -- while at the Bengaluru airport, the carrier cancelled 117 services -- 65 arrivals and 62 departures.

Par Panel calls for close coordination between states, developers to push renewables schemes

New Delhi, Dec 08: A parliamentary panel has called for a close coordination between states and project developers for identifying and resolving issues related to slow progress of solar-related schemes under Ministry of New and Renewable Energy.

The committee also noted that in respect of bids issued by the four Renewable Energy Implementing Agencies (SECI, NHPC, SJVN and NTPC agreement has not been signed for around 44 GW (as on June 30, 2025).

According to a report of Parliamentary Standing Committee on Energy tabled in Parliament on Monday, there has been slow progress under most of the schemes /programmes viz. Pradhan Mantri Surya Ghar: Muft Bijli Yojana (PMSG:MBY), PM-KUSUM and the scheme related to the development of solar parks.

The Muft Bijli Yojana aims to establish rooftop solar



for one crore households and outreach programmes committee noted that as per information furnished by the ministry, till June 2025, around 16 lakh installations have been made.

This means that around 84 lakh installations i.e. 84 per cent of the installations are yet to be made in just two years of 2025-2027. The panel has identified lack of awareness as the major cause for slow adoption of the scheme.

Though the Ministry has been undertaking awareness through print sion as well as social media, the committee said they are of the view that unless states and their discoms come fully onboard, the widespread progress would be difficult

to come by. The committee therefore, desires that the ministry engage closely with states/ discoms to design awareness campaigns that suit the distinctive features of the state concerned, the report said.

This may build trust among states and their consumers, thereby paving way for capital investment and providing space for installation of solar panels at the anticipated scale, it suggested.

The committee noted that PM-KUSUM, which is aimed at solarization of the agriculture sector through its three components, has seen extensive delays.

In particular, under Component-A and Component-C, the progress has been 6.4 per cent and 16.9 per cent respectively, (as on June 30, the progress has been comparatively better at 60 per cent. The panel noted that the scheme is set to expire in March 2026.

"Till then, the committee expects the Ministry to closely monitor its implementation in states and make timely interventions, where needed, to ensure that at least the projects which can be completed within the given timeline is not unnecessarily delayed," the report said.

Fire tragedy: Goa govt steps up action against club chain; 2 properties sealed



Panaji, Dec 08: The Goa government has intensified its crackdown on the controversial Romeo Lane club chain after a deadly fire at one of its outlets claimed 25

lives, officials said on Monday.

Two other properties of the hospitality company in Goa have been sealed, they said. A state police team also left for Delhi on Sunday to search for the property promoters -- Saurabh Luthra and Gaurav Luthra -- against whom a First Information Report

(FIR) has been registered, they said. Birch by Romeo Lane, a nightclub at Arpora in North Goa, caught fire late Saturday night, killing 25 persons, the majority of whom were their staffers, they said.

The Anjuna police in Goa have arrested the club's chief general manager, Rajiv Modak, general manager Vivek Singh, bar manager Rajiv Singhania, and gate manager Riyanshu Thakur.

The North Goa district administration has sealed a beach shack and another club, both part of the Romeo Lane chain, located at Vagator and Assagao, respectively, an official said.

Action has been initiated against both properties as they were involved in disputes, the official said.

Chief Minister Pramod Sawant on Sunday said that a team of state police had left for Delhi in search of the Luthras.

Both the promoters would be arrested as an FIR has been registered against them in connection with the blaze, he added.

Fireworks emerged as the likely cause of the blaze at 'Birch by Romeo Lane' nightclub at Arpora, located 25 km from Panaji, officials said on Sunday, adding that the facility allegedly did not possess even a fire department NOC.

The deceased included 20 employees of the nightclub and five tourists, including four from Delhi.

Most of the deaths were caused by suffocation, as the victims got trapped on the ground floor and in the kitchen, said a fire brigade official.

As per initial information, the nightclub had not adhered to fire safety norms, CM Sawant said on Sunday.

A preliminary inquiry indicated that "electric firecrackers" were set off inside, which started the blaze at 11.45 pm on Saturday, Sawant said.

The CM has directed Chief Secretary V Candavelou and DGP Alok Kumar to identify and act against the government officials who allowed the club to operate even though it violated safety rules.

Heart health: Why women's heart attacks are harder to spot, explains cardiologist

New Delhi, Dec 08: In women, heart attacks may not present with the obvious chest pain commonly associated with men. Instead, cardiologists highlight that symptoms such as unusual fatigue, shortness of breath. or digestive discomfort are often dismissed.

When we think of a heart attack, most of us picture someone clutching their chest in severe pain. But here's the truth that often gets overlooked: for many women, heart attacks don't look anything like that. Instead of the classic crushing chest pain, women may feel something as simple as unexplained fatigue, indigestion, breathlessness, or discomfort in the jaw or back. These signs can be so subtle and confusing that they're easy to brush off as stress, acidity, or just "not sleeping well."

Because women's symptoms are different and less obvious, heart attacks in women are more likely to go unnoticed or misdiagnosed, sometimes with tragic consequences. And to make things tougher, women often put their own health last while managing work, home, and family, ignoring warning signals

That's why it's crucial for women to understand what silent heart attack symptoms look like and learn to speak up when something feels "off", says Dr Ravindranath Reddy D R, HOD & Sr Consultant- Interventional Cardiology, Gleneagles BGS Hospital, Kengeri,

Why are women more likely to experience silent or less obvious heart attack symptoms than men?

Dr Ravindranath Reddy: In women. heart attacks often present differently than the "classic" chest pain we associate with men. This difference is partly biological and partly due to how women's heart disease has historically been under-recognized. In women, heart disease often involves the smaller blood vessels rather than the larger arteries, a condition referred to as microvascular disease. Because of this, the symptoms

tend to be more subtle and widespread, making them harder to recognize. Hormones also play a role—estrogen offers some protection before menopause, but as its levels drop afterward, a woman's risk of developing heart disease rises. Additionally, many women juggle multiple roles and tend to attribute symptoms like fatigue, indigestion, or breathlessness to stress or routine exhaustion rather than a possible cardiac issue. Unfortunately, because their symptoms are less dramatic, women are more likely to delay seeking help, which leads to worse outcomes compared to men. Heart health: Why women's heart

What are the most common "silent" symptoms women should watch forbut often ignore?

Dr Ravindranath Reddy: The warning signs of heart attacks in women can be surprisingly subtle. Most women don't get the kind of severe chest pain we often see in movies. What they experience instead may be more subtle, such

out obvious cause. Because these symptoms don't scream "heart attack," women may dismiss them as stress, gastritis, or even aging. But if these issues appear suddenly, are severe, or feel different from

How can women advocate for them-

Dr Ravindranath Reddy: The most important step is to trust your instincts. If a woman feels that something is not right—whether it's breathlessness, fatigue, or unusual discomfort-she should not downplay it. When seeking medical help, t helps to clearly describe what feels "different" rather than using vague words. For example, saying, "I feel breathless after walking just a few steps, which is new for me," gives doctors a clearer picture. Women should also be firm about requesting appropriate tests like an ECG or troponin levels if there's a suspicion of heart trouble, rather than accepting a generic explanation of stress or acidity. Mentioning a family history of heart disease, or risk factors like diabetes, high blood pressure, or smoking, is just as important. Above all, self-advocacy means asking questions without hesitation, seeking a second opinion if necessary, and making sure one's concerns

are heard and taken seriously. What screenings or lifestyle steps can women take to reduce their risk of a silent heart attack?

Dr Ravindranath Reddy: Prevention is the strongest defense. Women should undergo regular health checks-blood pressure, blood sugar, cholesterol, and body weight monitoring-especially after the age of 35 or earlier if there's a family history of heart disease. Tests like ECG, echocardiogram, or treadmill studies are usually suggested for women who carry a higher risk. Just as important are everyday choiceseating more fruits, vegetables, and lean proteins while cutting back on processed foods lays a strong base for heart health. Adding at least half an hour of moderate exercise on most days, keeping weight under control, avoiding tobacco, and limiting alcohol intake all support heart health. Managing stress is equally essential, as long-term stress quietly increases cardiac strain. Women after menopause should be especially cautious, since their heart risk rises considerably. Together, regular screening and healthy daily habits can go a long way in lowering the chances of a silent or late-detected heart attack.

US defence policy bill stresses broadening engagement with India, including via Quad

New York/Washington, Dec 08: The annual defence policy bill of the US has highlighted broadening America's engagement with India, including through the Quad, to advance the shared objective of a free and open Indo-Pacific region and address the challenge posed by China.

The National Defence Authorisation Act for Fiscal Year 2026, released by Congressional leaders Sunday, outlines the 'sense of Congress on Defence Alliances and Partnerships in the Indo-Pacific region'.

It states that the Secretary of Defence should continue efforts that strengthen US defence alliances and partnerships in the Indo-Pacific region to further the "comparative advantage of the US in strategic competition" with China.

Among other things, these efforts comprise "broadening US engagement with India, including through the Quadrilateral Security Dialogue to advance the shared objective of a free and open Indo-Pacific region through bilateral and multilateral engagements and participation in military exercises, expanded defence trade, and collaboration on humanitarian aid and disaster response".It also



includes enabling greater cooperation on maritime security with

The Quad or Quadrilateral Security Dialogue, comprising India, the US, Japan and Australia, was set up in 2017 to counter China's aggressive behaviour in the Indo-Pacific region.

The defence policy bill also states that the Secretary of Defence, in coordination with the Secretary of State, shall establish and maintain a security initiative to strengthen cooperation among the defence industrial bases of the US and allied and partner countries in the Indo-Pacific region.

This, it said, would strengthen the collective defence industrial base by expanding capability, capacity, and workforce, including enhanced supply chain security, interoperability, and resilience among

participating countries. The two Secretaries shall establish a process to determine which allies and partners of the US (including Australia, Japan, the Republic of Korea, India, the Philippines, and New Zealand) shall be invited to participate as member countries of the security initiative, it said.

In a section titled 'Joint Assessment Between The United States And India On Nuclear Liability Rules', the draft calls on the Secretary of State to establish and maintain within the US-India Strategic Security Dialogue a joint consultative mechanism with the Indian government.

This mechanism would convene regularly to "assess the implementation of the Agreement for Cooperation between the US Government and Government of India Concerning Peaceful Uses of Nuclear Energy, signed in Washington in 2008,"

The focus of this mechanism is to discuss opportunities for India "to align domestic nuclear liability rules with international norms; and to develop a strategy for the United States and the Republic of India to pursue bilateral and multilateral diplomatic engagements related to analysing and implementing those opportunities.

The bill states that the Secretary of State shall submit a report describing the joint assessment about this not later than 180 days after the date of the enactment of the Act, and annually thereafter for five years. In another section, the bill states that an "ally or partner nation" means the government of any country that is a member of the Organisation for Economic Cooperation and Development; "the Government of the Republic of India", and the Government of any country designated as an ally or partner nation by the Secretary of State for purposes of this section.

Mamdani tells immigrant New Yorkers about their right not to comply with ICE

New York, Dec 08: New York City Mayor-elect Zohran Mamdani posted a video to social media on Sunday explaining immigrants' right to refuse to speak to or comply with agents from US Immigration and Customs Enforcement, days after federal agents carried out a raid in Manhattan.

In the video, Mamdani vowed to protect the city's 3 million immigrants, saying, "We can all stand up to ICE if you know your rights.'

He explained that people in the US can chose not to speak to federal immigration agents, film them without interfering and refuse their requests to enter private spaces. ICE agents cannot enter spaces like a home, school or private area of a workplace without a judicial warrant signed by a judge, Mamdani said. "ICE is legally allowed to lie to you, but you have the right to remain silent. If you're

being detained, you may always ask, 'Am I free to go?' repeatedly until they answer you," said Mamdani, who will be sworn in as mayor on Jan 1.

His comments came a week after demonstrators gathered as ICE attempted to detain people on Canal Street near New York's Chinatown. A similar immigration sweep in the same neighborhood last October was also met with protests.

"New York will always

welcome immigrants, and I will fight each and every day to protect, support, and celebrate our immigrant brothers and sisters," Mamdani said in Sunday's video.

Weeks earlier, Mamdani had a surprisingly cordial Oval Office meeting with President Donald Trump, whose administration is carrying out federal immigration enforcement operations in several US cities, most recently in New Orleans.

Ukraine president to meet European allies after Trump criticism

London, Dec 08: Ukrainian leader Volodymyr Zelensky was due to meet with European allies in London on Monday, after President Donald Trump accused him of not reading the US proposal to end the war with Russia.

It comes after days of talks between Ukrainian and US officials in Miami ended on Saturday with no apparent breakthrough, with Zelensky committing to further negotiations.

The Ukrainian president will be received in London by British Prime Minister Keir Starmer, along with the German chancellor and French president to discuss the negotiations.

British Foreign Secretary Yvette Cooper is meanwhile expected in Washington on Monday where she will meet her American counter-

"The UK and US will reaffirm their commitment to reaching a peace deal in Ukraine," the Foreign Office in London said, announcing Cooper's visit. Moscow has

meanwhile continued to strike its neighbor, wounding at least nine people overnight Sunday to Monday, according to Ukrainian officials.

'Disappointed'

Zelensky said he joined his negotiators for a "very substantive and constructive" call with US envoys Steve Witkoff and Jared Kushner during the Miami negotiations.

"Ukraine is committed to continuing to work honestly with the American side to bring about real peace," Zelensky said on Telegram, adding that the parties agreed "on the next steps and the format of the talks with America."

But Trump criticized his Ukrainian counterpart on Sunday, telling reporters "I have to say that I'm a little bit disappointed that President Zelensky hasn't vet read the proposal, that was as of a few hours ago.'

Witkoff and Kushner had met Russian President Vladimir Putin at the Kremlin last week, with Moscow rejecting parts of the US proposal.

Earlier on Sunday, India sent about 1000 tonnes of additional aid comprising essential food items and clothes to Cyclone Ditwah-hit Sri Lanka under Operation Sagar Bandhu, contributed by the people of Tamil Nadu.

Gill, Hardik return as India begin official T20I WC build-up vs South Africa

Cuttack, Dec 08: The return of Shubman Gill and Hardik Pandya will lend fresh sheen and much-needed completeness to reigning world champions India when they begin their offi-cial march towards the home T20 World Cup with the opening match of a five-game series against South Africa, here on Tuesday.

This series marks the start of India's formal build-up to the February showpiece, where they will play 10 T20Is—five against South Africa followed by another five against New Zealand—before opening their title defence against the USA at the Wankhede on February 7.

The defending champions will look to enter this phase with clarity of intent as they refine roles, streamline combinations and settle the XI that will carry the weight of expectations in front of home crowds.

India have been a formidable T20I unit post their World Cup triumph in the format last year, where they won eight matches in a row to lift the title. Since then, they have extend-

ed their tally to 26 wins with only four losses, including a seven-match streak during their Asia Cup victory

They have not lost a T20I series in this period, and with only minor tweaks needed, they will be hoping to sharpen the edges against the side they defeated in the T20 World Cup final. Gill's



return comes after he missed almost a month of cricket owing to a neck spasm suffered while attempting a slog sweep during the opening Test against the Proteas. Having played non-stop cricket since the last IPL and with India facing a packed season ahead, his workload management will be closely monitored.

But for Gill, who has 837 runs from 33 T20Is at an average of 29.89, this series also doubles up as vital preparation heading into the ICC event.

His reunion with Abhishek Sharma brings back a high-impact opening pair that marries brute force with clean, classical strokeplay.

Abhishek, fresh from a standout tour of Australia where he topped India's scoring charts with 163 runs in the 2-1 victory, has been in monstrous domestic touch. In the Syed Mushtaq Ali T20s, the

Punjab left-hander hammered 304 runs at an average of 50.66 and a staggering strike rate of 249-plus, including a breathtaking 52-ball 148 against Bengal as Punjab posted 310/5.

Pandya comeback Hardik Pandya's comeback is equally significant.

Out for more than two months after a quadricep injury during the Asia Cup, the all-rounder marked his return in style with a 42-ball 77 not out for Baroda in the SMAT before bowling four overs at full tilt for 1/52.

He arrived here a day ahead of the squad, trained solo at the Barabati Stadium, bowled for 20 minutes and went through an extended phys-
