



Rajnath Singh cautions against rising threat of 'white collar terrorism'

Defence Minister says professional degrees alone cannot prevent terror



Srinagar, Jan 02: Asserting that terrorism is no longer confined to the uneducated, Defence Minister Rajnath Singh on Friday cautioned against the rising threat of "white-collar terrorism" in the country.

Speaking at the 104th foundation day of Bhupal Nobles' University in Udaipur, Singh, according to the news agency-Kashmir News Observer (KNO), referred to the Nov 10, 2025 blast in Delhi. "Terrorism should not be viewed as a problem limited to the uneducated. In the Red Fort blast individuals having professional degrees were involved," Singh said.

The Defence Minister said, "Those involved in the incident were doctors. The case has shown that education without values and character can have serious consequences for the society."

Singh said the purpose of education should not be confined



to professional achievement alone but should include the development of morality, ethics and a sense of responsibility.

He added that knowledge must be accompanied by wisdom to ensure it was used in a constructive manner.

Rajnath Singh said India was moving steadily towards achieving self-reliance in defence production and would be capable of meeting its weapons requirements domestically

within the next 15 to 20 years.

Singh said the emergence of startups in the defence sector had strengthened indigenous innovation and reduced dependence on imports.

He said many of these enterprises were developing technologies based on practical requirements while aligning with international benchmarks.

The defence minister said India's innovation landscape had undergone a shift in recent

years. He noted that the country had improved its position in the Global Innovation Index, rising from 76th in 2014 to 39th in 2024. He added that the digital economy now contributed a larger share to national income and that India had become the world's third-largest startup ecosystem.

Singh said rapid technological change required society to remain informed and adaptable. He stressed that the availability of data and information was no longer a challenge, but the ability to apply knowledge responsibly remained a concern.

The Defence Minister also spoke about India's growing presence on the global stage, saying the country's views were receiving greater attention at international platforms.

He said India should aim to become a developed nation by 2047, with progress measured not only by economic indicators but also by social responsibility.

Weather to remain dry for 3 days; fog to become dense in Jammu

Srinagar, Jan 02: Jammu and Kashmir is likely to witness generally dry weather from January 3 to 5, with partly cloudy skies expected between January 7 and 15.

According to the details available with the news agency-Kashmir News Observer (KNO) dense to very dense fog is likely at a few places over the plains of the Jammu division during the next three days.

The Indian Meteorological Centre in Srinagar stated that daytime maximum temperatures across the Kashmir

division remained below normal on Friday, while night temperatures were close to seasonal averages.

Srinagar recorded a maximum of 0.1°C against a normal of 7.7°C and a minimum of -2.4°C, indicating a departure of 2.5°C below normal. Pahalgam recorded a low of -6.2°C, while Gulmarg experienced -7.0°C overnight, with snow depth at 5 cm, reflecting lingering winter conditions in higher altitudes.

In the Jammu division, Jammu city reported a maximum of 6.0°C and a minimum of 7.2°C, slightly below seasonal norms. Bani, Batote, Katra, and Kathua reported minimum temperatures ranging between -3.0°C and 6.1°C.

Over 340 killed in 2,356 accidents on Jammu-Srinagar Highway in two years

SSP describes 2025 as challenging year for traffic management on NH-44



Ramban, Jan 02: More than 340 people lost their lives in about 2,300 road accidents on the Jammu-Srinagar National Highway over the past two years, officials said on Friday.

Senior Superintendent of Police (SSP) Traffic, National Highway, Raja Adil Hamid Ganie while talking to the news agency-Kashmir News Observer (KNO) said, "As many as 1,056 road accidents were reported on the highway in 2025, claiming 170 lives. In comparison, 1,300 accidents occurred in 2024, resulting in 173 fatalities."

Sharing the enforcement data for 2025, the SSP said that a total of 88,700 challans were issued during the year, imposing fines amounting to Rs 10.61 crore, of which around Rs 3 crore was realised.

He said 497 vehicles without valid documents were



seized, while five FIRs were registered against habitual traffic violators.

He said that special enforcement drives were conducted throughout the year to curb traffic violations. "As many as 153 special drives were carried out across the highway jurisdiction, focusing mainly on visible offences such as the use of pressure

horns, overloading and non-use of seat belts," he said.

Referring to the challenges faced by the Traffic Police in the year 2025, the SSP said, "The year proved to be challenging for traffic management on the highway, especially as heavy monsoon rains caused extensive damage at multiple locations, including Ramban and [More on P6](#)

Kashmir's only cancer centre faces criticism over lack of advanced diagnostic tests

Patients, doctors demand modern molecular, genetic, cytogenetic facilities at SKIMS

Srinagar, Jan 02: Sher-i-Kashmir Institute of Medical Sciences (SKIMS), Soura – the only tertiary care cancer treatment centre in Kashmir – is facing serious criticism from patients and healthcare professionals over the non-availability of several crucial and advanced diagnostic tests required for accurate detection, staging, and monitoring of cancers.

Despite catering to



thousands of cancer patients from across the Valley and adjoining regions, SKIMS currently lacks access to a wide range of essential investigations that are considered standard of care in modern oncology. As a result, a majority of patients

are being compelled to travel to hospitals outside Jammu and Kashmir, mainly in Delhi, Chandigarh, Mumbai and other metropolitan cities, for both diagnosis and treatment.

Kashmir's rooftops turn power producers, hit 40 MW by year-end

Srinagar, Jan 02: In Kashmir valley, more than ten thousand households have installed rooftop solar systems in 2025 under the Pradhan Mantri Surya Ghar Muft Bijli Yojana.

The officials informed the news agency-Kashmir News Observer (KNO), that the current installed capacity stands at 39-40 Megawatts (MWs).

Till the month of February, there was a total installed capacity of 2-3 MWs but the local implementing agency, Kashmir Power Development Corporation Limited (KPDCL)

had installed rooftop solar systems with capacity of nearly 40 MWs till the December

end," the official said.

It also said at least 40-50 feeders in Kashmir valley are enjoying the electricity supply round the clock.

"Almost all of the areas having AT&C losses of less than 20 percent are receiving the 24 hours power supply," the official added.

The official further informed that more than 6.52 lakh smart meters have been installed in Jammu and Kashmir till the month of November.

It includes installation of 2.81 lakh smart meters in the past two years under the Revamped Distribution Sector Scheme (RDSS) and Prime Minister's Development Package. [More on P6](#)

Baramulla, Jan 02: The body of an elderly woman, missing for nearly two months, was recovered on Friday in Kreeri area of North Kashmir's Baramulla district, ending an anxious search that began in early November.

An official told news agency-Kashmir News Observer (KNO), that the deceased identified as Atiqa Begum, of Kreeri, had gone missing from her home on November 5, 2025. Her family had filed a missing report at Police Station Kreeri the same day after she failed to return home.

Kashmir's endangered Hangul population rises to 323 at Tral breeding centre

» Steady increase since 2008 offers hope for species' recovery » Experts call for continued habitat protection, conservation efforts

Pulwama, Jan 02: In a positive development for wildlife conservation in Jammu and Kashmir, the population of the endangered Kashmiri Hangul (*Cervus hanglu hanglu*) at the Tral Conservation Breeding Centre has increased to 323 in 2025, up from just 127 in 2008, according to the latest census data compiled by the Wildlife Protection Department.

Officials told the news agency-Kashmir News Observer

(KNO) that the increase, though modest, is significant given the sharp and alarming decline the species has witnessed over the last century. Historical records indicate that the Hangul population stood at around 5,000 individuals nearly 118 years ago.

Continuous habitat loss, human disturbance, poaching, and ecological degradation reduced their numbers drastically, eventually leading to the species being declared critically endangered.



Wildlife Warden South Kashmir, Suhail Ahmad, said that sustained and scientific conservation efforts at the Hangul Conservation Breeding Centre in Shikargah, Tral, have played a crucial role in stabilising and gradually increasing the population.

The Hangul conservation breeding centre at Shikargah Tral, spread over 2.5 hectares, has been made fully functional. The entire area has been properly fenced with a power fence to minimise threats and

prevent intrusion," Ahmad said.

He added that the improved infrastructure has significantly reduced risks from predators, stray animals, and human interference, creating a safer and more controlled environment for the endangered species.

Experts point out that Hangul populations in natural forest areas continue to face serious challenges. Rapid urbanisation, encroachment into forest land, grazing pressure, and disturbance due to

tourism and infrastructure projects have fragmented their habitat, making survival increasingly difficult.

"Hangul is a critically endangered animal, and their numbers in natural forests are very low due to continuous disturbance and other ecological issues," Ahmad explained. "To overcome this, the government established the breeding centre to increase their population under controlled conditions."

Meanwhile, local residents and tourism operators say Sarfaraz embodies the heart of Kashmiri hospitality and grace that continues


to define the Valley's tourism culture. Many hailed him as an inspiration for the younger generation who sustain their families through honest work in the tourism sector.

Gol restores financial powers of Ladakh LG

Srinagar, Jan 02: In a significant development, the Union Finance Ministry has restored the financial powers of the Lieutenant Governor of Ladakh. The Ministry has delegated authority for appraisal and approval of projects up to Rs 100 crore to the administrators/LGs of Ladakh, Andaman & Nicobar Islands, Chandigarh, Dadra & Nagar Haveli and Daman & Diu, and Lakshadweep.

According to a communique, these powers have been granted under the Delegation of Financial Powers Rules (DFPRs), 2024.

As per the conditions laid down by the Ministry, the Administrators must exercise these powers in consultation with the respective UT's Secretary (Finance) or Financial Advisor and approvals can only be



given after ensuring adequate budgetary provisions. The letter states that the delegated powers cannot be further re-delegated. It further states that details of all proposals sanctioned under these powers must be submitted quarterly to the Department of Expenditure through the Ministry of Home Affairs by the end of July, October, January, and April. As per the communique, the powers of administrators and

LGs to sanction expenditure from in-principle approval to final approval, including appraisal, will continue under Rule 16 of DFPRs, 2024, but only after schemes are duly appraised and approved by the competent authorities. This decision holds particular significance for Ladakh, where political and non-political groups had objected to the Union Government's earlier move to withdraw the LG's authority to approve projects up to Rs 100 crore – (KNO)

Margan, Sinthan Top trekking, camping banned for safety

Anantnag, Jan 02: The authorities in Anantnag district have banned trekking, camping, hiking and other similar outdoor activities in Margan Top, Chauhar Nag and Sinthan Top areas, citing security and public safety concerns.

According to an order, the Sub-Divisional Magistrate Kokernag said that inputs from police and security agencies indicated security vulnerabilities in certain high-altitude and forested areas falling under Sub-Division Kokernag.

He also mentioned the recent incidents in which some individuals attempted to cross police checkpoints during late night hours, raising serious safety concerns.

He said that unrestricted movement and outdoor activities in these sensitive areas could adversely affect public safety and security. The order will remain valid for two months unless withdrawn or extended. The Station House Officer Larnoo has been directed to ensure strict implementation of the order and regulate movement at all check-points, while general public has been strictly advised to comply, with authorities warning that any violation will invite action under law – (KNO)

Cardiologist urges winter heart attack precautions


Srinagar, Jan 02: Senior Critical Care Specialist Dr Showkat Shah on Friday urged people to take precautions during the winter season for preventing heart attacks and strokes.

Dr Shah said, "People should keep themselves warm by dressing in layers and using hats, gloves and warm socks to prevent rapid heat loss."

He advised avoiding sudden physical exertion in cold conditions, such as heavy shovelling, and recommended indoor exercise or proper warm-up before any activity.

Highlighting the importance of hydration, Dr Shah said that dehydration during winter can thicken the blood, increasing the risk of clot formation. "People should drink adequate warm fluids and eat a healthy diet," he added.

Dr Shah advised the people to eat fruits, vegetables, legumes, whole grains, lean meats and fish, low-fat dairy products, and healthy fats like olive oil and avocado.



He recommended following dietary patterns such as the DASH or Mediterranean diets.

Dr Shah cautioned against excessive consumption of salt, sugar, sweetened beverages, refined carbohydrates, alcohol, processed foods, saturated fats and trans fats, which are known to raise blood pressure and cholesterol levels.

Emphasising lifestyle changes, he strongly advised quitting smoking, calling it one of the most preventable causes of heart disease and a major risk factor for heart attacks. He also recommended sound sleep of seven to eight hours daily and effective stress management through meditation, deep breathing or engaging in hobbies. Dr Shah urged patients with hypertension, diabetes or high cholesterol to take their prescribed medications regularly and not neglect heart medicines during winter.

He appealed to the public to remain alert to warning signs such as chest pain, shortness of breath, dizziness or nausea, and to seek immediate medical attention if such symptoms appear, stating that early diagnosis and timely treatment can save lives – (KNO)

Baramulla-Uri highway hit by landslide, traffic snarled

Baramulla, Jan 02: Vehicular traffic on the Baramulla-Uri road remained suspended for several hours on Friday after landslides struck the highway amid ongoing road-widening works, triggering panic among commuters and bringing movement on both sides to a halt.

Officials confirmed that no injuries or vehicle damage occurred, but recurrent incidents during earth-cutting have heightened fears of worse incidents in winter.

"Clearance operations were taken up immediately after the landslide occurred," an official said.

"Fortunately, no one was hurt, and efforts were made on priority to remove debris and restore the road," said an on-duty police official, adding that traffic was gradually allowed from both sides after clearance.

The project site in-charge said the slide



occurred during ongoing excavation work. "Such incidents sometimes happen during construction, but our teams acted swiftly to clear the road and ensure the safety of commuters. We diverted Uri-bound traffic via Khadriy while allowing Baramulla-bound vehicles after one-way clearance," he said.

Deputy Commissioner (DC) Baramulla, Minga Sherpa, said the landslide was a result of ongoing

construction activities and that mitigation measures are being taken to prevent future occurrences.

"We are adopting scientific methods of earth-cutting to avert such incidents. Any illegal activities contributing to instability will be dealt with strictly. Earlier, a mining work near Drangbal was stopped after it triggered a major slide and posed a risk to lives," the DC said.

CBK chargesheets 108 in Sumbal corruption scam

Srinagar, Jan 02: The Economic Offences Wing (EOW) of Crime Branch Kashmir (CBK) on Friday said to have filed a chargesheet against 108 accused persons in a massive embezzlement and fake appointment case linked to the Electric Division Sumbal.

The accused include senior engineers, accounts officers, bank officials and fake appointees, allegedly involved in siphoning off crores of

rupees in government funds. According to a statement, Mega Corruption Racket Bust Act before the Court of Special Judge, Anti-Corruption, Baramulla. It reads, the accused include 15 Executive Engineers, 06 Assistant Accounts Officers, 01 Accounts Officers, 06 Head Assistants, 04 Senior Assistants (including the kingpin Mushtaq Ahmad Malik S/o Sonaullah Malik R/o Aragam, Bandipora), 04 Junior Assistants and 01 Orderly, all of whom were posted in Electric Division Sumbal. The charge-sheet also names 25 officers and officials of J&K Bank, Branch Sumbal Sonawari, besides 46 fake employees who were illegally appointed.

Decline In Road Accidents Shows Power Of Multi-Pronged Approach

The reported 15% decline in road accidents and a more significant 22% drop in fatalities across rural Kashmir in 2025 is a hard-won victory for public safety and a testament to the power of coordinated civic action. Each percentage point represents lives saved, families spared from unimaginable grief, and communities made more secure. This positive trend, announced by the Traffic Police, deserves recognition and serves as a vital model for sustained road safety

campaigns everywhere. This success stems from a commendably holistic strategy that moved beyond mere punitive enforcement. The key has been the integration of awareness, engineering, and community partnership. While strict enforcement laid down the law, the parallel focus on behavioural change, evidenced by rising seatbelt and helmet compliance, struck at the root cause of recklessness. Furthermore, the collaboration with engineering authorities to

rectify accident-prone 'black spots' addressed critical infrastructure deficits that passively contribute to tragedies. This multi-pronged approach acknowledges that road safety is a shared responsibility, not a police mandate alone. The involvement of educational institutions, NGOs, and student volunteers has been particularly impactful. By embedding road discipline into civic consciousness from a young age, these campaigns foster a culture of responsibility that

outlasts any single drive. The acknowledgement of the media's role also highlights how consistent public messaging can shape social norms for the better. However, this milestone must be a foundation, not a finish line. The goal must be to institutionalise these gains and push for zero preventable deaths. The proposed plan for 2026, focusing on technology-based monitoring and smarter surveillance, is a logical next step. Yet, continuous investment in road engineering,

especially in treacherous hilly stretches, and relentless public engagement remain irreplaceable. Kashmir's rural roads have shown that a systematic, empathetic, and collective effort can bend the curve of tragedy downward. This progress lights the way forward, proving that with sustained commitment from authorities and citizens alike, every journey can be safer. Let this success in 2025 fuel the resolve to make 2026 even safer.

The World Order After 2025

While the term "polycrisis" can be useful in describing the tangle of threats the world currently faces, it fails to capture our role in creating – or finding a way out of – our current situation. While profound disruption carries acute risks, it also provides a rare opening for far-reaching transformation.

For a mathematician, 2025 might stand out for being a "perfect square": 45 multiplied by 45, a rare symmetry. But its significance goes far beyond numerical elegance – it marks the year the postwar global order expired, and a new one was about to be born.

Eighty years ago, as the world emerged from World War II, the victorious Western Allies designed a system intended to prevent another catastrophic conflict. The result was a global order based on three intertwined promises: geopolitical stability anchored by American leadership, industrial progress that would steadily raise living standards, and globalization that would spread prosperity through trade and integration.

That postwar order delivered real achievements. In the West, a burgeoning middle class enjoyed political freedom and economic prosperity. Globally, hundreds of millions of people were lifted out of poverty. For a time, the direction of history seemed clear, and, particularly after the end of the Cold War, even inevitable.

But, with hindsight, we can see that the postwar order carried the seeds of its demise. Authority was concentrated within Western-led institutions that claimed to speak for the world. US hegemony often led to overreach and hubris: a generation of wars in the Middle East proved costly, and confidence in the US model's superiority obscured the reality of domestic decay.

Globalization entrenched a lopsided bargain. Low-cost manufacturing in poor countries allowed consumers in rich countries to buy abundantly, but at a global environmental cost. As firms in America and Europe moved their production overseas, local communities lost jobs and vitality. At the same time, financialization made it easier to accumulate wealth simply through speculation



and stock-price inflation, further enriching the richest without delivering social value.

The 2008 financial crisis was an early warning. US policymakers stabilized the system but did not repair it. Inequality rose and politics grew angrier. By the time Donald Trump was re-elected to the US presidency, his political rise was no longer an aberration. It was the bill coming due.

The accumulated stress became impossible to ignore in 2025, particularly in the former ruling powers. Transatlantic alliances once thought permanent were ruptured. Trade wars and protectionist industrial policy signaled the end of frictionless trade. Populism in democracies revealed a deeper loss of trust in elite institutions, and immigrants became an easy scapegoat.

Add the worsening impact of climate change and it is little wonder that Western

leaders and thinkers have been feeling overwhelmed by the "polycrisis."

The term rightly describes the tangle of global dangers. But it fails to diagnose their root causes, validating fear but obscuring responsibility. It also frames Western shocks as global threats, while overlooking the agency of the rest of the world, also known as the global majority.

Rather than simply naming the death of the old, we must ask what might replace it. After all, while profound disruption carries acute risks, it also provides a rare opening for deep transformation. That is why we should view this moment not as a polycrisis, but as a "polytunity" – a generational opening for global transformation from the margins.

Some contours of the new world order – three in particular – are already visible. Geopolitically, it will be characterized by

multipolarity, with the US and China as the two largest powers but neither as a single hegemon. Such a diffusion of power need not lead to chaos if non-dominant countries take more responsibility for delivering global public goods and find creative means to collaborate.

Moreover, AI will transform how humans live and work. Depending on how it is regulated and used, AI could lead to a greater concentration of power and wealth, but it could also lower barriers to knowledge and productivity – for example, through translation, tutoring, and rapid problem-solving – especially for communities long excluded from elite networks.

Lastly, globalization will not disappear, but its form will change. Long, fragile supply chains optimized purely for efficiency are giving way to shorter, more resilient ones.

Today's developing countries can no longer count on exporting to rich markets to generate growth; instead, they must also cooperate with their neighbors and dismantle regional barriers to trade.

Whether the world seizes the polytunity or succumbs to the polycrisis depends fundamentally on mindset. Even as Western political and economic dominance wanes, Western narratives of disruption as despair continue to dominate. Yet nowhere is a mindset shift more urgent than among the global majority, which has more potential for agency today than it ever did before.

Such a mindset must be adaptive, inclusive, and moral – what I call AIM. To be adaptive is to discover and enable possibilities, not just control risks. To be inclusive is to eschew one-size-fits-all models in favor of bespoke solutions that harness indigenous knowledge and capabilities. And to be moral is to question how asymmetrical power has shaped dominant ideas and voices, while amplifying those that have historically been marginalized.

An earlier "perfect square" year was 1600, heralding the Age of Enlightenment that would transform Europe and, eventually, the world. The Enlightenment championed reason and freedom, but it also justified empire and domination – not only of the West over the rest, but also of humans over nature. We have a chance to do better: to build a more plural, more equal, and more ecologically grounded world order.

But the future that emerges after 2025 depends crucially on the worldview we choose. Lamenting the polycrisis reinforces paralysis, whereas embracing the polytunity encourages change.

When Our New Year Resolutions Fail

Every year, many of us bravely announce our resolutions for the new year. A glass of champagne on New Year's Eve might add to our confidence in our ability to do better in the coming year and save more, spend less, eat better, work out more, or binge-watch less.

Every year, many of us bravely announce our resolutions for the new year. A glass of champagne on New Year's Eve might add to our confidence in our ability to do better in the coming year and save more, spend less, eat better, work out more, or binge-watch less. But most of our resolutions fail. Even within the first weeks after New Year's Eve, the majority of people have given up on them.

Yet, not all tales of failure are the same, because the way you talk about the failure matters for your own motivation and other people's confidence in your ability to try again. So what can we do after we've given up on our resolution? We've announced our good intentions to friends and family and now must admit failure. Research has shown the way you word your failed resolution can affect how people view it. And understanding the reasons most resolutions don't work out can help us see it through the future. Indeed, you can talk about your resolutions in a way that will make your failure more understandable and will sustain your motivation to keep going.

A constructive way to discuss your failed resolution is to focus on the controllability of the failure. Research shows that most resolutions will require some investment of time and of money. For example, getting in shape takes time for exercise and also normally requires money for a gym membership



or for workout equipment. Because both of these resources are essential for pursuing our goals, many failed resolutions are due to the lack of either time or money, or both. When talking about a failed resolution in the past, I've shown in my own research that we should focus on how lack of money contributed to this failure, rather than lack of time. In my 2024 study, people read about fictional as well as real panel participants who failed either due to lack of money or lack of time.

Most participants felt the person whose failure was caused by lack of money would have more self-control going forward and was going to be more reliable at pursuing

their goals. This effect occurred because lack of money is seen as something that cannot be controlled very easily, so if this caused the failure, there wasn't very much the person who failed could have done about it. In this research, most of the failed resolutions were related to weight loss, better eating, or working out in the gym. Participants felt the same whether the person who failed was a man or a woman, presumably because it's plausible that everyone needs some time and some money to pursue various goals regardless of gender or the specific resolution. The role of controllability takes a different form when it comes to thinking about how

we can do better next time.

Research also shows the way we view time matters when it comes to failure. For the past, it's better to think about things outside of our control that can help to take the negativity out of failure and bolster the belief that we can do better. This can mean, for example, to consider how our failure was due to lack of money or other resources outside of our control. For the future, however, take an active perspective on time. Look at your schedule and make active decisions how to allocate time to your goal pursuit, by scheduling gym sessions or blocking time to prepare healthy meals. This can help to give us the motivation to try again because we're not victims of our busy schedules.

A study published in October 2025 that focused on how a lack of time contributed to failures showed that people can get back a sense of control by talking about "making time", instead of "having time". People who discussed their failures as an issue of not having made the time felt like they could do things differently in the future, and were more motivated to do so. This is because "making time" suggests active control over one's time and schedule, instead of "having time" that leaves us passive. For example, if you say you didn't make the time to work out, that means you can make the time in the future if you choose to do so.

In contrast, if you say you didn't have time to work out, it feels like this lack of time is outside of your control and could happen

again, preventing you from pursuing your exercise goals. Another reason so many people struggle to keep to their new year resolution may be because they were too ambitious, or they neglected that joy and pleasure keep us going. We need not only to have a goal in mind. Finding joy in the journey and belief in the ability to change is also important. For example, someone might want to get in better shape and work out more, but when they actually try to go to the gym, they lack the confidence to sign up for a class. Without some fun, it's hard to follow through on a resolution even if we really want to pursue the goal.

So, try to think of ways you can make the goal more enjoyable to work on and remind yourself you are capable. The trend for new year resolutions isn't a bad thing in itself. Although it might seem a bit paradoxical to start virtuous habits right after a big night with alcohol and overeating, research shows that we can indeed benefit from the "fresh-start" effect in which a new beginning in the calendar can provide a clean slate to start better habits. But we don't have to wait for the calendar to give us a fresh start. We can choose to make our own resolution (maybe a Valentine's or Easter resolution?) to boost the motivation to pursue our goals.

Govt approves liquidation of J&K SCARD bank, assures depositor protection

JAMMU, JANUARY 02: The Jammu & Kashmir State Cooperative Agriculture and Rural Development (SCARD) Bank Ltd. has, over a period of time, been experiencing persistent operational and financial challenges. These challenges have primarily arisen due to deficiencies in governance and internal control systems, weak loan recovery performance, and constraints in accessing refinancing support from the National Bank for Agriculture and Rural Development (NABARD). As per an official statement issued on Friday, taken together, these factors have adversely impacted the financial health and normal functioning of the Bank.

The issues relating to the Bank have been examined in depth by the Cooperative

Department in close consultation with NABARD. Based on its supervisory assessments, NABARD has advised a regulated, closely monitored, and structured course of action, with the primary objective of safeguarding the interests of depositors and other stakeholders, while ensuring an orderly, transparent, and legally compliant process. In pursuance of these recommendations, the Cooperative Department has undertaken and completed a special Know Your Customer (KYC) verification exercise covering all account holders, including depositors and loanees, across all branches of the Bank, including the Head Office and Regional Office. This exercise was aimed at verifying the authenticity of account holders and ensuring that the interests of genuine depositors are duly

identified and protected in any future course of action.

It is further informed that the Government has approved the proposal relating to the liquidation of the J&K State Cooperative Agriculture and Rural Development (SCARD) Bank Ltd., with specific directions that the Cooperative Department shall work out a clear proposal for safeguarding the interests of the depositors. Accordingly, the Department has formulated a practical, phased, and legally compliant line of action strictly in accordance with the provisions of the Jammu and Kashmir Cooperative Societies Act, 1989, with due care to ensure minimal inconvenience to depositors. The Department is presently awaiting the requisite prior sanction in writing from NABARD as mandated

under section 74(4) of the J&K Cooperative Societies Act, 1989 to proceed further, which is expected shortly.

The Cooperative Department fully acknowledges the concerns and anxieties of depositors and assures them that protection of their interests remains its foremost priority. All actions are being taken with due diligence, transparency, and appropriate regulatory oversight to ensure that depositor claims are addressed in a fair, systematic, and orderly manner.

The Cooperative Department remains in close coordination with the concerned departments of Jammu and Kashmir and regulatory institutions and reiterates its commitment to act responsibly, lawfully, and in a depositor-centric manner, in the larger public interest.

Husband's financial dominance in matrimonial discord does not amount to cruelty: SC

New Delhi, Jan 02: Financial dominance of a husband over his estranged wife in a soured marital relationship is not an act of cruelty, the Supreme Court has said while highlighting that a criminal litigation cannot become a "gateway to settle scores and pursue personal vendettas".

A bench of Justices B V Nagarathna and R Mahadevan made the observation while quashing a criminal case lodged against an estranged husband by his wife, alleging cruelty and dowry harassment.

Setting aside a Telangana High Court verdict that had refused to quash the FIR, Justice Nagarathna said, "The monetary and financial dominance of the accused-appellant, as alleged by the complainant-respondent No.2, cannot qualify as an instance of cruelty, especially in the absence of any tangible mental or physical harm caused. 'The said situation is a mirror reflection of the Indian society, where men of the households



often try to dominate and take charge of the finances of the women, but criminal litigation cannot become a gateway or a tool to settle scores and pursue personal vendettas."

Justice Nagarathna, who authored the judgment on behalf of the bench, refused to consider the act of seeking details of expenses of the money sent by the estranged husband as an act of cruelty.

"Courts have to be extremely careful and cautious in dealing

cruelty under section 498 (subjecting a married woman to cruelty by her husband or his relatives) of the Indian Penal Code.

The bench said after a careful consideration of an earlier judicial dictum, none of the offences alleged against the accused husband is made out.

"In fact, we find that the allegations of cruelty, mental harassment and voluntarily causing hurt against the accused-appellant herein have been made with a mala-fide intent with vague and general allegations," the court said in its December 19 order.

The verdict came on an appeal filed by the husband against the April 27, 2023 order of the high court refusing to quash the FIR against him and his family members.

The apex court clarified that the observations made in the verdict shall not come in the way of any matrimonial or other proceedings pending between the parties, which shall be decided on their own merits and in accordance with law.

Delhi HC upholds 2014 acquittal order, underlines principle of double innocence

New Delhi, Jan 02: The Delhi High Court has upheld a trial court's order acquitting an accused in a robbery case, saying it could only interfere with the verdict if the findings were "perverse".

Justice Manoj Kumar Ohri, hearing an appeal filed by the prosecution against the November 2014 order of a sessions court acquitting the accused, underlined the principle of "double presumption of innocence" and said the trial court's order was

well-reasoned.

In an order dated December 17, the court said, "It is trite law that an appellate court must be slow to interfere in an appeal against acquittal unless the findings of the trial court are shown to be perverse."

"The principle of double presumption of innocence, which operates in favour of an accused after acquittal, is well-settled," it added.

The legal principle of double presumption of innocence operates at two levels. One, under the fundamental

principle of criminal jurisprudence that every person shall be presumed innocent unless proven guilty in a court of law, and two, the accused having secured an acquittal, the presumption of innocence is further reinforced, the judge pointed out.

Concurring with the trial court's observation that the Delhi Police was unable to establish the accused's guilt beyond a reasonable doubt, the high court said the order of acquittal was "plausible, well-reasoned and supported by the evidence".

Wife's interim maintenance cannot be determined with mathematical precision: HC

New Delhi, Jan 02: The Delhi High Court, while enhancing a woman's interim maintenance, has said the amount cannot be determined with mathematical precision. Justice Amit Mahajan has also said that "mere earning in foreign currency" does not entitle the wife to claim maintenance by "mechanically converting the husband's foreign income into Indian currency".

The court was hearing revision petitions filed by the woman and her husband against a May 2023 order of a family court awarding Rs 50,000 as monthly interim maintenance. The wife had sought an enhancement of the amount, while the husband had contested the award order.

In an order dated December 23, the court said, "The determination of interim maintenance is not an exercise capable of mathematical precision."

"More often than not, particularly in cases where one of the spouses is employed abroad and has failed to place a complete and candid disclosure of income before



the court, the assessment necessarily involves a degree of estimation and informed guesswork," it added.

The court said it could not embark upon a roving or final inquiry at the interim stage and was required to arrive at a reasonable figure on the basis of available material, surrounding circumstances, lifestyle indicators and the admitted earning capacity of the earning spouse.

"It stands admitted that the husband is gainfully employed with Amazon.com Services LLC as a software engineer and he has also not denied that he is residing in the US.

"It is also admitted that the wife is unemployed, and the wife had specifically asserted that her husband has been earning approximately Rs 1.76 crore per annum," the court pointed out.

It noted that the wife had submitted an affidavit regarding the husband's income in US dollars and the conversion rates prevailing at the relevant time.

"In the present case, it is undisputed that the husband is earning in foreign currency and is residing in the US. Consequently, he is also required to incur expenses in foreign currency, and the standard as well as the cost of living in the US cannot be equated with that prevailing in Delhi," the court observed.

It, however, said the entirety of the husband's income could not be equalised or proportionately mirrored in the amount of maintenance.

"Mere earning in foreign currency does not, by itself, entitle the wife to claim maintenance by mechanically converting the husband's foreign income into Indian currency and applying the formulae evolved by Indian courts without due regard to the attendant circumstances," the court said.

It then enhanced the interim maintenance amount to Rs 1 lakh per month based on a broad, reasonable and rounded-off assessment.

Conservationists believe that with consistent efforts, scientific management, and public cooperation, the species can be pulled back from the brink of extinction.

For now, the rising numbers at Tral offer a rare note of hope in Kashmir's fragile conservation landscape. (KNO)

Social media should take responsibility of content they publish: Vaishnaw

New Delhi, Jan 02: Social media firms should take responsibility for content they publish and a standing committee has already recommended a tough law to fix accountability of platforms, Union minister Ashwini Vaishnaw said on Friday.

The Centre has earlier this week warned online platforms -- mainly social media firms -- of legal consequences if they fail to act on obscene, vulgar, pornographic, paedophilic and other forms of unlawful content.

"Social media should be responsible for the content they publish. Intervention is required," Vaishnaw said here on the sidelines of a Ministry of Electronics and IT (Meity) event.

He was replying to a question on AI app Grok generating indecent and vulgar images of women.

Rajya Sabha member Priyanka Chaturvedi has also written to the minister seeking urgent intervention on increasing incidents of AI apps being misused to create vulgar photos of women and post them on social media.

"The standing committee has recommended that there is a need to come up with a tough law to make social media



accountable for content they publish," Vaishnaw said.

The Parliamentary Standing Committee on the Ministry of Information and Broadcasting has recommended that the government make social media and intermediary platforms more accountable with respect to peddling fake content and news.

The committee has endorsed the view of stakeholders, such as enforcing transparency in algorithms, introducing stricter fines, and penalties for repeat offenders, establishing an independent regulatory body, and using technological tools like AI to curb the spread of misinformation, etc.

On December 29, Meity asked

social media firms to immediately review their compliance framework and act against obscene and unlawful content on their platform, failing which they may face prosecution under the law of the land.

The advisory followed Meity noticing that social media platforms have not been strictly acting on obscene, vulgar, inappropriate, and unlawful content.

Public policy firm IGAP, Partner, Dhruv Garg, said Meity's advisory to intermediaries does not establish any fresh legal obligations, it rather reiterates that safe harbour protection hinges entirely on strict adherence to due diligence requirements laid

out in the IT Rules, 2021.

"Significant social media intermediaries are subject to stricter due diligence benchmarks. They must also deploy automated content moderation tools. The advisory signals that in light of widespread obscene content circulation, reactive content takedowns are inadequate, and platforms must actively fulfil their legal responsibilities or they may face criminal prosecution," he said.

Luthra and Luthra Law Offices India, Senior Partner, Sanjeev Kumar, said Meity's advisory unequivocally states that non-compliance with the IT Act and the IT Rules, 2021 may result in legal consequences, including prosecution under the IT Act, the Bharatiya Nyaya Sanhita, 2023 (BNS), and other applicable criminal laws, and such consequences may extend to intermediaries, platforms, and their users.

"This operates alongside the potential loss of safe-harbour protection under Section 79, exposing non-compliant entities to direct liability. The cumulative impact of these provisions heightens legal, financial, and reputational risk, making adherence not only a statutory duty but a business imperative," he said.



China military drills near Taiwan 'unnecessarily' raise tensions: US

Washington, Jan 02: Chinese war games around Taiwan "unnecessarily" spiked tensions in the region, the US State Department said Thursday, calling on Beijing to "cease its military pressure."

"China's military activities and rhetoric toward Taiwan and others in the region increase tensions unnecessarily. We urge Beijing to exercise restraint, cease its military pressure against Taiwan, and instead engage in meaningful dialogue," State Department spokesman Tommy Pigott said in a statement.

Beijing launched missiles and deployed dozens of fighter jets, navy ships and coast guard vessels on Monday and Tuesday to encircle Taiwan, saying the drills simulated a blockade of the self-ruled island's main ports.

Taipei condemned the exercises as "highly provocative."

China claims that democratic Taiwan is part of its territory and has refused to rule out using force to annex it.

"The United States supports peace and stability across the Taiwan Strait and opposes unilateral changes to the status quo, including by force or coercion," Pigott said. China again defended the drills as "legitimate" on Friday, and warned countries to "stop stirring up trouble on



the Taiwan Strait issue."

"We urge relevant countries and institutions to strictly abide by the one-China principle," a Chinese defense ministry spokesman said in a statement responding to calls for restraint, including from the United States.

US President Donald Trump said Monday he was not concerned about China's live-fire drills, appearing to brush aside the possibility of counterpart Xi Jinping ordering an invasion.

"I have a great relationship with President Xi. And he hasn't told me anything about it," Trump told reporters when

asked about the exercises.

"I don't believe he's going to be doing it," Trump said in apparent reference to an invasion. Beijing's show of force came after the Trump administration approved an \$11 billion arms package for Taiwan.

The United States has been committed for decades to ensuring Taiwan's self-defense, while staying ambiguous on whether the US military would intervene in an invasion.

China's latest exercises were the sixth major round of maneuvers since 2022 when a visit to Taiwan by then-US House Speaker Nancy Pelosi enraged Beijing.

China launches new 'upgraded' missile destroyer

Beijing, Jan 02: The Chinese navy has commissioned a new "upgraded" missile destroyer as it's expanding its fleet at a breakneck speed to catch up with the US naval strength.

The Chinese People's Liberation Army (PLA) Navy has commissioned a new Type 052D guided missile destroyer named Loudi, which features upgraded radar, weapon and network systems, official media here reported on Friday.

Zhang Shengwei, a crew member of the Loudi, was quoted by state-run Global Times as saying that the new-type warship adopts new system and architecture, giving it enhanced combat capabilities in air defence, sea attack and task force command.

The Loudi can not only conduct long-range assault and strike missions against its targets, but also defend friendly ships in defensive missions, Zhang said.

Observers say the new ship's addition highlights the

feverish pitch at which the Chinese navy is expanding its fleet, adding a ship a month.

According to a recent BBC report, the Chinese navy has emerged as the world's largest, operating 234 warships compared to the US Navy's 219 ships.

Between 2019 and 2023, China's four largest shipyards - Dalian, Guangzhou, Jiangnan and Hudong-Zhonghua - produced 39 warships with a combined displacement of 550,000 tonnes, according to a study by the Centre for Strategic and International Studies (CSIS).

With the addition of Loudi, the Chinese navy has added 11 combat vessels, including the aircraft carrier Fujian, in 2025. In addition to building its own fleet, China is supplying modern naval ships and submarines to its all-weather ally Pakistan. Last month, China launched a fourth Hangor-class submarine, named Ghazi, for Pakistan. It is the second Pakistani submarine to be named after Ghazi. The first one was blown up near the Visakhapatnam port during the 1971 war with India.

Was told I'll never play for Australia: Khawaja on racial stereotypes, criticism from media, former players

Melbourne, Jan 02: Usman Khawaja said he hoped his long Test career, which will come to an end with his retirement after the fifth Ashes clash, inspires youngsters who are "different" that playing cricket for Australia is possible.

The top-order batter, who turned 39 last month, announced on Friday that he would be retiring from international cricket after his 88th Test, which will start at Sydney Cricket Ground on Sunday.

Khawaja made his Test debut at the same ground in the final match of the 2010-11 Ashes series and has since scored 6,206 runs at an average of 43.39, including 16 centuries.

More than his runs, however, Khawaja was a standard-bearer for diversity in Australian cricket, given he was born in Pakistan before being raised in Sydney from the age of five.

"I hope I've inspired many children along the way, particularly those who feel that they are different, those who feel that they don't belong, or those others tell that they will never make it," Khawaja told reporters at a press conference.

"I felt all these things growing up and trying to be an Australian cricketer, but seeing is believing? And I'm here to tell you that you can do whatever you want. Just got to keep trying. 'I'm a proud Muslim



coloured boy from Pakistan who was told that he would never play for the Australian cricket team. Look at me now. You can do the same."

Khawaja batted for most of his Test career at the top of the middle-order but lost his spot in the side for the 2021-22 Ashes series to Marnus Labuschagne.

He was, however, called up at the last minute when Travis Head contracted COVID-19 ahead of the Sydney Test and revived his career with centuries in both innings.

After that, Khawaja moved up to form a successful opening partnership with David

Warner, who retired from Test cricket after the SCG Test two years ago.

In this Ashes series, he injured his back in the opener in Perth and missed the second Test before initially being dropped from the team for the third in Adelaide. He was again

recalled at the eleventh hour after Steve Smith suffered a bout of vertigo and, batting at number four rather than opening, scored 82 and 40 as Australia won by 82 runs to clinch the series and retain the urn.

Khawaja said his treatment by the media after the back injury in Perth was proof that he was still treated differently from other players because of his background.

"The way the media and the past players came out and attacked me... I copped it for about five days straight," he recalled.

"It was quite personal in terms of things like, 'He's not committed to the team. He was only worried about himself. He played this golf comp the day before. 'He's selfish. He doesn't train hard enough. He didn't train the day before the game. He's lazy. These are the same racial stereotypes I've grown up with my whole life."

Mamdani thanks family from 'Kampala to Dilli' vows to govern 'audaciously'

New York, Jan 02: Indian-origin politician Zohran Mamdani vowed to govern "expansively and audaciously" and deliver an agenda of affordability for New Yorkers as he thanked his family from "Kampala to Dilli" after being sworn-in as the 112th Mayor of New York City.

Mamdani was administered the oath of office by Senator Bernie Sanders of Vermont at a ceremonial inauguration outside City Hall on Thursday, the seat of New York City government, on New Year's day.

He was formally sworn-in as New York City's 112th Mayor by New York Attorney General Letitia James at a private ceremony held at the turn of the new year on December 31 in an old subway station here.

He became the first South Asian and Muslim elected to helm the largest city in the US.

In his nearly 25-minute speech to New Yorkers after taking the oath of office Thursday,



Mamdani said that "beginning today, we will govern expansively and audaciously. We may not always succeed. But never will we be accused of lacking the courage to try."

He vowed that under his administration, City Hall will "deliver an agenda of safety, affordability, and abundance, where government looks and lives like the people it represents, never flinches in the fight against corporate greed, and refuses to cower before challenges that others have deemed too complicated."

Indian descent Mamdani is the son of renowned filmmaker

Mira Nair and Columbia University professor Mahmood Mamdani. He was born and raised in Kampala, Uganda and moved to New York City with his family when he was 7. Mamdani became a naturalized US citizen only recently in 2018.

Mamdani thanked his parents, who were present for the swearing-in ceremony, as well as his wife Rama Duwaji for their support. He also expressed gratitude to his family from Uganda to India.

"Thank you to my parents, Mama and Baba, for raising me, for teaching me how to be in this world, and for having brought me to this city. Thank you to

my family, from Kampala to Dilli. And thank you to my wife, Rama, for being my best friend, and for always showing me the beauty in everyday things," he said.

Thousands of Mamdani's supporters, from youth to the elderly, braved freezing temperatures on January 1 and stood for hours outside and near City Hall, cheering him and celebrating his victory and inauguration at a block party organized on the occasion.

"They said the New Year was ushering in an era of hope and promise as the new Mamdani administration begins its term in the city.

India to tour Bangladesh for 3-match ODI, T20I series in Sep

Dhaka, Jan 02: The Bangladesh Cricket Board on Friday announced it will host India for a three-match ODI as well as T20I series to be played in September this year.

However, it is not clear if BCCI will agree to travel to Bangladesh in prevailing conditions with no stable government in place.

According to a media release by the BCB, the three ODIs will be played on September 1, 3 and 6, while the T20Is will be played on September 9, 12 and 13.

The Indian team will reach Bangladesh on August 28 for their limited-overs affair.

In July last year, India's tour of Bangladesh was called off indefinitely and the six-match white-ball tour was deferred for more than one year. "The



Bangladesh Cricket Board (BCB) and the Board of Control for Cricket in India (BCCI) have mutually agreed to defer the white-ball series, three ODIs and three Twenty20 Internationals, between Bangladesh and India in August 2025 to September 2026," the BCCI had said in a statement last July.

"This decision has been reached following discussions between the two Boards, taking into account the international cricketing commitments and scheduling convenience of both teams."

"The BCB looks forward to welcoming India in September 2026 for this eagerly anticipated series. Revised dates and fixtures for the tour will be announced in due course," it added.
