Amritsar, Jan 09: Welcoming the suspension of the Indus Water Treaty (IWT), Jammu and Kashmir Chief Minister Omar Abdullah on Friday said the agreement had caused long-term harm to the region and limited its rightful use of water resources.

Addressing a press conference here, CM Omar, according to the news agency—Kashmir News Observer (KNO), said he had opposed the IWT

Navigation Barrage. "With this project, the water level in Wular Lake will increase, which in turn will improve water flow in the Jhelum. This will enhance electricity generation and also make the river navigable," he said.

He added that utilising Chenab river water for Jammu would end water scarcity in the region for the next 30 years. "Suspension of the IWT will also allow us to desilt our rivers, which was not possible earlier," he said.

Omar Abdullah said Jammu and Kashmir had paid a heavy price under the treaty, while Punjab received rights over rivers flowing through its territory. "We faced the brunt of dams constructed in Punjab. Several areas in J&K were submerged, yet we never complained and maintained cordial relations with Punjab," he said.

On the political changes after the abrogation of Article 370, the Chief Minister said while change had taken place, the claims made earlier had not been fulfilled. "We were told that removing Article 370 would end terrorism, unemployment and violence. All these claims proved to be a hoax," he said. | [More on P6](#)

from the very beginning, "The Indus Water Treaty has greatly harmed us. It is good that it has been suspended. Now measures must be taken so that we are able to use that water for ourselves," he said.

Pertinently, Prime Minister Narendra Modi led government suspended the Indus Water Treaty with Pakistan in April 2025 after the Pulwama terror attack that left 26 persons, mostly tourists dead.

The Chief Minister said the J&K government has already proposed two major projects to the Centre to utilise river waters effectively. One of them is the Tulbul Navigation Barrage, also known as the Jhelum

New Delhi, Jan 09: Union Home Minister Amit Shah on Friday said that National IED Data Management System (NIDMS) will prove to be extremely important in the coming days for the investigation of all types of terrorist incidents occurring in the country and for the analysis of their various aspects.

As per news agency—Kashmir News Observer (KNO), Shah today inaugurated the National IED Data Management System (NIDMS) of the National Security Guard (NSG) in New Delhi through video conferencing. The event was attended by the Union Home Secretary, the Director of the Intelligence Bureau (IB), and the Director General of NSG, the Director Generals of



Central Armed Police Forces, and the Director Generals of Police of various states.

Speaking on the occasion, Shah said that NIDMS will become the next-generation security shield against terrorism.

"The Ministry of Home Affairs has generated various

types of data in the past years, but until now they were in silos, i.e., separate from each other. Now, we are making efforts to connect all these data sources with one another and to develop an advanced Artificial Intelligence-based software for their analysis," he said. | [More on P6](#)

Srinagar freezes at -6°C, records season's coldest night

Srinagar, Jan 09: A severe cold wave continued to prevail across Jammu and Kashmir and Ladakh on Friday, with several places recording a further drop in minimum temperatures compared to the previous day.

According to the details available with the news agency—Kashmir News Observer (KNO), Srinagar, J&K's winter capital, recorded a seasonal low of minus 6.0 degrees Celsius, down from minus 5.1 degrees a day earlier, while the minimum temperature at Srinagar airport fell to minus 7.4 degrees from minus 6.8 degrees.

Qazigund, the gateway of Kashmir registered minus 6.2 degrees against Thursday's minus 5.4, and Anantnag saw a dip to minus 7.1 degrees from minus 6.3 degrees.

Hydel power generation falls by 77 pc in J&K

Srinagar, Jan 09: In Jammu and Kashmir, hydel power generation has reduced by nearly 77 percent.

An official informed the news agency—Kashmir News Observer (KNO) that the Power Development Department is able to generate only 277 Megawatts (MW) of power out of the total generation capacity of 1197 MW.

The official further said that on Friday, the 900 MWs power projects in Baghlar were able to generate only 129 MWs of power.

Two army porters, soldier lose lives in separate falls in Baramulla

Porters slip into Nallah in Gulmarg, soldier falls during night patrol in Sheeri

Baramulla, Jan 09: Two army porters and a soldier lost their lives after falling from a height in separate incidents in north Kashmir's Baramulla district.

Officials told the news agency—Kashmir News Observer (KNO) that the bodies of two porters, identified as Layakat Ahmad Deedard and Ishfaq Ahmad Khatana, both residents of Chandoosa, were recovered following an



extensive search operation.

The duo, officials said, had slipped into a nallah on Thursday evening while heading towards

the forward Anita Post in Gulmarg heights.

Following the incident, rescue teams launched an overnight operation and retrieved the bodies after sustained efforts.

Meanwhile, in another incident, an Army soldier identified as Hira Lal, a resident of Haryana, posted at the Fathagard Sheeri Camp, died after slipping and falling from a height during night patrol duty in Sheeri area of the district. | [More on P6](#)

CS reviews progress of major health infrastructure projects across J&K

Stresses timely completion of healthcare infrastructure works

JAMMU, JANUARY 09: Chief Secretary, Atal Dulloo, Friday chaired a high-level review meeting to assess the progress of ongoing and proposed health infrastructure projects across the UT, reiterating that strengthening healthcare facilities remains a top public service priority of the government.

The meeting, as per an official statement, was attended by the Additional Chief Secretary, Public Works Department; Secretary, Health & Medical Education; Director, SKIMS; Managing Director, NHM; Principals of Government Medical Colleges; Director, Health Services, Kashmir/Jammu; Managing Director, HSCC; Chief Engineers of R&B, and other senior officers.

The review covered a wide spectrum of projects being executed by the Health & Medical Education Department, including works related to Government Medical Colleges, SKIMS, Dental Colleges, Health Services, SASCI projects and flagship centrally sponsored schemes such as PM-ABHIM and ECPR-II.

Taking a comprehensive project-wise review, the Chief Secretary examined physical and financial progress, utilisation of funds and issues hampering timely execution. He issued clear directions for expediting approvals, resolving inter-departmental bottlenecks, particularly those related to land and utilities, and ensuring strict adherence to timelines and quality standards.

He took this occasion to emphasise that delays in healthcare projects have a



direct bearing on public welfare, he cautioned that such lapses would be reviewed seriously at the highest level and stressed the need to avoid cost overruns through efficient use of resources.

Additional Chief Secretary, PWD, Anil Kumar Singh took note of project-wise deadlines and issued on-the-spot directions to Chief Engineers to resolve site-specific bottlenecks so that works progress without interruption.

Secretary, Health & Medical Education, Dr Syed Abid Rashid Shah presented an overview of the progress achieved since the last review meeting and outlined

the department's mechanism for regular monitoring of works.

During this meeting a detailed review was conducted of major infrastructure projects at GMC Jammu, GMC Srinagar and their associated hospitals, including the construction of the Bone and Joint Hospital, Jammu, and expansion of tertiary care facilities. The progress of works at Indira Gandhi Government Dental College & Hospital, Jammu was also reviewed, with emphasis on augmenting dental education and patient care infrastructure.

The Chief Secretary also reviewed the status of these projects will

of new Government Medical Colleges at Anantnag, Doda, Kathua, Udhampur and Handwara, directing the executing agencies to strictly adhere to approved timelines.

At GMC Anantnag, the construction of a 249-bedded Mother and Child Care Hospital at MMABM Associated Hospital was discussed. It was informed that the project will now be funded under UT Capex, with a revised DPR incorporating furniture and furnishing requirements too.

At GMC Udhampur, issues related to space constraints for a sanctioned 50-bedded Critical Care Block under ECPR-II were reviewed, and directions were issued for early completion of NOC formalities for transfer of ITI land and buildings to facilitate hospital expansion. Infrastructure works at GMC Rajouri, including parking facilities, retaining walls, strengthening of electrical systems and hostels for resident doctors, were also reviewed. Critical tertiary care infrastructure projects at SKIMS Soura and SKIMS Medical College Bemina were also discussed, with the Chief Secretary directing that these high-value projects be executed seamlessly to support advanced healthcare delivery in the Valley.

Under Health Services, major works including

the 100-bedded Mother and Child Care Hospital at Lambri (Rajouri), upgradation of SDH Billawar to 100 beds, 50-bedded Hospital at Sunderbani, upgradation of the 100-bedded Hospital at Nowshera, and the 125-bedded District Hospital at Reshipora, Budgam were reviewed. It was noted that these projects will

significantly strengthen secondary and district-level healthcare services across J&K.

Reviewing projects under the Special Assistance to States for Capital Investment (SASCI), the Chief Secretary was informed that 23 works have received financial approval, of which 13 are under execution. During the current financial year 2025-26, an amount of 34.98 Cr has been released under Capex and SASCI, with works worth over 20 Cr already executed.

He directed the department to rationalise non-starter and slow-moving projects, drop unviable works after due approval and re-propose them under appropriate funding windows to prevent blockage of funds.

A detailed presentation was also made by HSCC on the Pradhan Mantri Ayushman Bharat Health Infrastructure Mission (PM-ABHIM) and ECPR-II, wherein it was informed that most of these critical care projects are going to be substantially completed by March, 2026 giving physical progress and expected date of completion in each project. Under ECPR-II, works amounting to 178.32 Cr were reviewed, with the Chief Secretary directing that physical progress be accelerated to match financial outlays.

The Chief Secretary concluded the meeting by reiterating that timely completion of health infrastructure projects is crucial for improving service delivery and directed all stakeholders to maintain close coordination to ensure tangible outcomes on the ground meeting deadlines without any delay.

Eco-tourism blooms at Shallabugh wetland

Ganderbal, Jan 09: Shallabugh Wetland Conservation Reserve here in Central Kashmir is fast emerging as a major eco-tourism hotspot. The wetland spread over 1,675 hectares across Srinagar and Ganderbal districts was designated as a Ramsar site on June 8, 2022. Since then it has gained global recognition for playing a crucial role in preserving biodiversity.

Notably, this protected wetland is home to a diverse array of bird species, including the Pintail, Common Teal, Wigeon, Gadwall, Mallard, and the rare Pallas's Fish Eagle.

Additionally, Steppe Eagles, Eastern Imperial Eagles, and Yellow-eyed Pigeons, among others, contribute to its status as



an avian paradise. An annual bird census, held on February 23 and 24, provides valuable data to track and monitor these bird populations.

Ghulam Rasool, a local while talking to KNO said, "The wetland is one of Asia's largest and home to lakhs of birds. With better support and more staff, it can be managed and protected even more effectively."

Wildlife Department officials said that the wetlands are important for migratory birds. "Every year huge number of birds flock to the site. We are committed to safeguarding these birds, especially during peak migration seasons. We urge hunters to respect the wildlife and refrain from any harmful activities," the officials said. They said that February, in

particular, is expected to see an influx of additional migratory birds.

Currently, the bird population is estimated to be between 2 to 2.5 lakh. To aid during the winter months, the department provides grains to feed the birds and ensures their well-being amid freezing temperatures. "Compared to last year, the number of birds has notably increased," officials said.

Pertinently, the Shallabugh Wetland stands as an exemplary model of community-driven conservation. Local residents, non-governmental organizations (NGOs), and government bodies are working hand in hand to preserve the ecological balance.

Tested egg samples in Srinagar meet FSSAI safety standards

Srinagar, Jan 09: The first batch of egg samples collected from various parts of Srinagar has been found safe for consumption and compliant with the standards of the Food Safety and Standards Authority of India (FSSAI), officials said on Friday.

Assistant Commissioner of Food Safety, Srinagar, Yameen ul Nabi said that eight samples collected from supermarkets and wholesalers in the city were found to be of standard quality.

"The results came late last evening, and all samples have been declared fit for human consumption," he said.

The officer said that both loose and packaged eggs were taken during routine surveillance drives aimed at ensuring the safety of food items sold in local markets. "The tests confirm that eggs available in Srinagar meet FSSAI standards," he added.

Meanwhile, a senior official from Food and Drug Administration (FDA), Kashmir, told KNO that a total of 49 egg samples were collected from across Jammu and Kashmir. "This is the first batch of reports received, which have come safely," she said, adding that three to four more batches



are still pending.

The official further said that the samples were collected as part of a wider quality assurance initiative launched after misleading social media posts claimed that eggs contained cancer-causing substances.

KNO had earlier reported that the FSSAI had categorically dismissed claims linking eggs to cancer, stating that eggs available in the country are scientifically safe and compliant with national standards.

In its clarification issued last month, the FSSAI had described the viral claims as "misleading, scientifically unsupported and capable of creating unnecessary public alarm". The regulator

reaffirmed that the use of nitrofurans is prohibited in poultry and egg production and that trace residues below detection limits do not pose any health risk.

Officials said the ongoing testing and surveillance are aimed at reinforcing public confidence in food safety and preventing the spread of misinformation.

"We appeal to the public and media to share only verified updates and avoid amplifying unverified content," Nabi said. "Such drives will continue to safeguard public health and ensure that the food available in markets remains safe and of standard quality."—(KNO)

Participants were sensitized on their role and responsibilities, monitoring and reporting mechanisms and the importance of community


participation through Panchayati Raj Institutions. Interactive sessions were held to address operational challenges and share best practices for effective implementation at the grassroots level.

Time For Govt-Bank-Industry Coordination To Secure J&K's Economy

The Federation of Chambers of Industries of Kashmir (FCIK) has sought a moratorium on coercive bank actions under the SARFAESI Act. At a moment when the government is reviewing its industrial policy with the stated aim of revival and rehabilitation, aggressive asset seizure against MSMEs is a contradictory and self-defeating strategy that risks inflicting irreversible damage on the Union Territory's fragile industrial base and shattering the confidence of its youth. The core of the issue is timing and approach. MSMEs in J&K are not willful defaulters but

enterprises that have endured unparalleled shocks, which include decades of instability, floods, prolonged shutdowns, and the pandemic. A purely mechanical enforcement of recovery, especially one that targets residential property, does not protect public funds; it destroys the very capital, both financial and human, required for future repayment and growth. It extinguishes livelihoods, erodes the dignity of families, and sends a chilling message to aspiring entrepreneurs: that the system offers no safety net for failure, only punitive ruin. The government must heed this call

for a pragmatic pause. An immediate, time-bound moratorium on such disposessive actions is essential until a structured resolution framework is operational. This period must be used to swiftly finalise and implement the proposed One-Time Settlement (OTS) scheme and, more innovatively, to establish an Asset Reconstruction Company (ARC) mechanism. An ARC can professionally manage stressed assets, separating viable units for revival from non-viable ones for orderly closure, thus freeing banks from protracted litigation and offering entrepreneurs a dignified resolution.

This is not about forgiving debt but about intelligent recovery that balances fiscal responsibility with economic revival. The government's vision for a vibrant, job-creating industrial sector cannot be realised by dismantling its existing foundation. Coordination, not confrontation, between the administration, banks, and industry is the only path forward. A compassionate, calibrated response now can preserve livelihoods, restore entrepreneurial faith, and secure the future of J&K's economy. The choice is between salvaging an ecosystem or presiding over its collapse.

Digitalizing India's Dairy Sector

Building A Smarter, Transparent, And Farmer-Centric Ecosystem

India is the world's largest producer of milk, accounting for 25% of global output. As the sector continues to expand, digital tools are playing an increasingly crucial role in improving productivity, transparency, and farmer welfare. The National Dairy Development Board (NDB) has been at the forefront of this transformation, developing digital platforms that connect farmers, cooperatives, and stakeholders across the dairy value chain. These initiatives aim to modernise operations, reduce inefficiencies, and enhance traceability, ultimately strengthening the world's largest dairy ecosystem.

National Digital Livestock Mission (NDLM)

The National Digital Livestock Mission (NDLM), implemented by NDB in collaboration with the Department of Animal Husbandry and Dairying (DAHD), represents a major step toward a unified digital livestock ecosystem called "Bharat Pashudhan."

To enhance data-driven livestock management, the Bharat Pashudhan database records field activities such as breeding, artificial insemination, health services, vaccination, and treatment, with over 84 crore transactions logged. Field personnel, including veterinarians and extension workers, assist farmers in accessing this system.

The NDLM uses digital tools such as unique animal identification, data integration, and mobile applications to empower farmers and improve productivity. It aims to ensure every animal in India has a digital identity, linking it to health records and productivity data. NDB provides both technical and financial support to implement this mission across states.

In line with the international practices a unique 12-digit bar coded Tag ID in the form of ear tag is being issued to all livestock animals. This unique code has been named as "Pashu Aadhar", and it acts as a primary key for registering all types of transactions done on the animals such as Vaccination, Breeding, Treatment, etc. All these transactions can be viewed at a single place against the Tag ID and shall be visible to the farmer as well as to the field veterinarians and workers for respective animals/area. Till November 2025, over 35.68 Crore Pashu Aadhaar has been generated.


Under the National Digital Livestock Mission, the 1962 App provides authenticated information on best practices and government schemes. Besides, the toll-free number 1962 is available to the farmers to get the veterinary services through Mobile Veterinary Units at their doorstep.

Automatic Milk Collection System

At the heart of India's cooperative dairy model is the daily milk collection from millions of farmers. To make this process transparent, efficient, and farmer-friendly, the National Dairy Development Board (NDB) has developed the Automatic Milk Collection System (AMCS), a robust, integrated software platform for managing every aspect of operations at Dairy Cooperative Societies (DCS).

AMCS automates milk collection by digitally recording each transaction, including quantity, quality, and fat content, and instantly transferring payments to farmers' bank accounts. Using open-source technology, the system ensures traceability, eliminates manual errors, and promotes transparency at every level. Farmers receive real-time SMS updates on their daily sales and payments, while cooperatives gain access to data-driven insights for better procurement and production planning.

The system is integrated at Union,

To help cooperatives adopt this technology widely, NDB has developed a web-based dynamic route planning software that enables fleet and route optimisation in a structured, scientific, and user-friendly manner. Available free of cost to dairy cooperatives, this tool allows real-time route planning and supports better operational control. By integrating technology with cooperative efficiency, NDB's route optimisation initiative is setting a benchmark for sustainable and cost-effective milk transport in India's dairy sector.

NDERP includes all major functional modules such as Finance and Accounts, Purchase, Inventory, Sales and Marketing, Manufacturing, HR and Payroll, each integrated with advanced workflows and maker-checker features to ensure greater transparency and control. The system also features dashboards and analytical tools that support data-driven decision-making across management levels.

Crucially, NDERP is integrated with the Automatic Milk Collection System (AMCS) to create an end-to-end digital solution, from cow to consumer, covering milk collection, processing, and distribution. To enhance efficiency, the platform incorporates a mass-balancing technique in the production module, helping dairies minimize processing losses.

Semen Station Management System (SSMS)

The Semen Station Management System (SSMS) is a comprehensive digital platform designed to streamline the production of Frozen Semen Doses (FSD) and ensure adherence to the Minimum Standard Protocols (MSP) and Standard Operating Procedures (SOPs) set by the Government of India. The system covers all core operations of semen stations, including bull lifecycle management, semen production, quality control, biosecurity, farm and fodder management, and sales tracking. It integrates with laboratory equipment and RFID bull tags for accurate, efficient, and traceable operations, ensuring every stage, from production to distribution, is digitally monitored.

SSMS is connected to the Information Network for Semen Production and Resource Management (INSPRIM), a national portal that enables real-time data sharing between semen stations and field-level systems like INAPAH (Information Network for Animal Productivity and Health). This integration allows complete traceability of semen doses supplied across the country and supports coordinated monitoring through a central database.

Developed under the National Dairy Plan I (NDPI), a World Bank-funded initiative implemented by NDB, the system has modernized semen stations nationwide, strengthening India's artificial

insemination network and contributing to enhanced dairy productivity. Currently, 38 graded semen stations across India are using SSMS to ensure quality, transparency, and standardization in semen production.

INAPAH

Information Network for Animal Productivity & Health (INAPAH) is an application that facilitates capturing of real-time reliable data on Breeding, Nutrition and Health Services delivered at Farmer's Doorstep. It helps to assess and monitor progress of the projects.

Internet-based Dairy Information System

Efficient data management is central to evidence-based planning and informed decision-making in the dairy sector. The Internet-based Dairy Information System (i-DIS) developed by the National Dairy Development Board (NDB) provides a unified digital platform for dairy cooperatives, milk unions, federations, and other allied units to systematically collect, share, and analyse data. The system enables participants to track performance indicators such as milk procurement and sales, product manufacturing and distribution, and the supply of technical inputs, while allowing each organisation to benchmark its performance against others.

Currently, around 198 milk unions, 29 marketing dairies, 54 cattle-feed plants, and 15 federations across the country are part of i-DIS, contributing to the creation of a reliable and comprehensive National Cooperative Dairy Industry Database. This data-driven ecosystem supports strategic decision-making and policy formulation within the dairy sector. NDB also conducts regular refresher workshops for Management Information System (MIS) officials from participating unions to strengthen their ability to use i-DIS effectively and ensure its optimal utilisation for planning and operations.

Reviews progress on referral of posts in GMCs, Health Department across J&K

Jammu, Jan 9 Minister for Health and Medical Education, Social Welfare and Education, Sakeena Itoo Friday emphasised on the need for timely referral of vacant posts to address shortages of doctors, paramedics and other support staff in healthcare institutions across Jammu and Kashmir.

The meeting was attended by Secretary Health and Medical Education, Dr Syed Abid Rasheed Shah; Principals of all GMCs (Srinagar, Jammu, Anantnag, Baramulla, Rajouri, Kathua, Doda, Udhampur and Handwara), Principal SKIMS Medical College, Director Health Services Jammu/Kashmir and other senior officers of the department, either in person or through video conferencing.

The meeting was held with an objective of review assessing the existing manpower gaps and expediting recruitment process to strengthen healthcare delivery at all levels.

During the meeting, the



Minister emphasized on the need for timely referral of vacant posts to address shortages of doctors, paramedics and other support staff in healthcare institutions across Jammu and Kashmir.

She further asked all Principals of GMCs and Directors to ascertain the requirement of doctors and specialists in their respective medical institutions and make a proper plan for posting of required staff at these places. She also stressed on both Directors for rationalisation of staff in order to fill necessary manpower gaps of specialists in far flung areas.

The Minister also directed the Principals for timely finalisation of Recruitment rules for all categories of posts so that the process of recruitment is expedited and the vacant posts are filled timely.

Minister Sakeena directed the officers.

different aspects of health sector, Minister Sakeena also laid special emphasis on adopting a proactive and compassionate approach towards victims of drug abuse. She highlighted the need to strengthen de-addiction and rehabilitation services, ensure early identification of substance abuse cases and provide comprehensive medical, psychological and social support to affected individuals.

DLSA Srinagar, Budgam inspect Central Jail to strengthen legal aid mechanisms

SRINAGAR, JANUARY 09: District Legal Services Authority, Srinagar and Budgam, Friday conducted an inspection of Central Jail, Srinagar as part of the ongoing efforts to ensure effective implementation of legal aid mechanisms.

The objective of the inspection, as per an official statement, was safeguarding the legal and constitutional rights of prisoners, particularly untried inmates.

During the visit, the Secretary DLSA along with officials of both the districts inspected various sections of the jail with special emphasis on women jail inmates and foreigners jail inmates and reviewed the functioning of the Prison Legal Aid Clinic.

Emphasis was laid on ensuring unhindered access to legal aid for inmates, timely production of untried before courts, and identification of prisoners eligible for legal assistance, remission, parole, furlough, or premature release under the applicable rules and policies.

Secretary DLSA, interacted with jail authorities and legal aid functionaries to assess the effectiveness of the legal services being provided within the prison premises.

The inspection also involved a thorough review of statutory and logistical arrangements, including maintenance of prisoner's records, coordination with courts, availability of legal aid counsel, and the role of Para Legal Volunteers in facilitating communication between inmates and legal institutions.

The Secretary DLSA, stressed the need for strict adherence to the Model Prison Inspection Format and reiterated that any systemic or procedural gaps affecting prisoner's rights must be promptly addressed.

Jail authorities were directed to ensure that complete and updated data of eligible convicts and untried prisoners, is maintained in the prescribed format to facilitate effective verification and timely legal intervention.

The visit reaffirmed the commitment of the District Legal Services Authority to uphold access to justice for all prisoners and to strengthen institutional mechanisms within correctional facilities.

The inspection concluded with an assurance of continued coordination between the jail administration and the District Legal Services Authority to ensure compliance with legal mandates and protection of prisoner's rights in letter and spirit.

DC Pulwama reviews NRLM performance Stresses timely credit linkages for SHGs

PULWAMA, JANUARY 09: Deputy Commissioner Pulwama, Dr Basharat Qayoom, Friday chaired a comprehensive review meeting to assess the implementation and overall progress of the National Rural Livelihoods Mission (NRLM) in the district.

During the meeting, the Deputy Commissioner, as per an official statement, reviewed NRLM interventions across various Community Development (CD) Blocks, with particular emphasis on institutional strengthening of Self Help Groups (SHGs), livelihood promotion, credit linkages, capacity building, and convergence with allied departments.

The District Programme Manager (DPM), NRLM, presented a detailed performance overview through detailed presentation, highlighting the profile, coverage and overall scenario of NRLM implementation in the district.

The chair was apprised that the mission has covered 37,973 rural households across 11 CD Blocks, with an institutional framework comprising 4,474 Self Help Groups (SHGs), 298 Village Organisations (VOs), and 24 Cluster Level Federations (CLFs).

Dr. Qayoom sought a detailed block-wise assessment of bank linkage progress, status of credit flow to SHGs, physical achievements, identification of potential Lakhpati Didis, establishment of Agri-Nutri Gardens, and formation of Producer Groups. He



directed the concerned officers to bridge gaps in capitalisation and ensure timely and adequate credit flow to all eligible SHGs.

While reviewing progress achieved under non-farm livelihood enterprises, including service-oriented ventures promoted through SHGs, the Deputy Commissioner stressed the need for sustained handholding, monitoring and market linkage support to emerging entrepreneurs to ensure viability and scalability of enterprises.

The DC also reviewed pending issues at various banks and directed bank authorities to resolve the same on priority. He instructed the concerned Cluster Head of the bank to nominate an officer to address these pendencies and monitor NRLM-related cases fortnightly while NRLM functionaries were directed to intensify coordination with financial institutions to facilitate smooth credit access for SHGs and entrepreneurs, reiterating that seamless credit flow is essential for strengthening

rural enterprises. Referring to the security situation, Omar Abdullah said last year began with the Pahalgam tourist attack and ended with blasts in Delhi. "This clearly shows the difference between what was promised and what is actually happening," he said.

He said the government made sincere efforts to revive tourism after the Pahalgam attack but ensured that the tragedy was not measured in financial terms. "Precious human lives were lost. Tourism figures should not be exaggerated, as it can turn tourists into targets," he added, while noting that recent snowfall has improved tourist footfall.

RENAMING MGNREGA WRONG MOVE

Criticising the Centre, Omar Abdullah said renaming MGNREGA was wrong as Mahatma Gandhi's name was removed, and accused the Centre of shifting the financial burden of the scheme onto states.

On the Chatisinghpura killings of Sikhs, he said the CBI probe had identified the perpetrators, some of whom have died, while efforts are ongoing to bring the remaining accused to justice.

Asked about speculations that Jammu may be granted separate statehood, Chief Minister Omar Abdullah said that Ladakh had already been "ruined" after being given Union Territory status and warned against repeating the same experiment. "If they want to ruin Jammu, they are free to do so," he said.

He remarked that even the establishment of a single medical college was not tolerated. "If this is the approach, what will they do with Jammu?" he asked.

CM Omar said Jammu's economy had largely depended on the Darbar Move and it too was already done away with but the regime led by him restored it.

"In other parts of the country, people struggle to get medical colleges, but here sweets are distributed as if something extraordinary has been achieved," he said, adding that if the intention is to create a separate state, "they should go ahead and ruin it completely."

He also acknowledged the drug problem in J&K, saying it exists and the government is fighting it firmly. "We share borders with the neighbouring country and every possible effort is being put to ensure that drugs don't enter J&K. The government is also working hard to end drug abuse in the region."

Asked about minorities being targeted in Bangladesh, Chief Minister Omar Abdullah said that it is the responsibility of every nation to protect its minorities. "While lessons are being offered to Bangladesh, the same principles must be implemented at home as well. Here, if minorities get admission in a medical college, the college itself is shut down," he said. (KNO)

NIDMS will become

He said that today's launch of NIDMS will accelerate this process and prove to be an important milestone in the direction of making the country safe from terrorism.

Shah said that with the NIDMS being launched today, a two-way comprehensive, integrated and online data platform will become available to NIA, Anti-Terrorism Squads (ATS) across the country, state police forces and all Central Armed Police Forces (CAPFs). He said that data related to any explosion or IED incidents occurring at any location can be included

in this system.

"By utilising this data, necessary guidance can be obtained during investigations in every state. He said that NIDMS will prove extremely important in investigating terrorist activities, understanding trends in explosions, and formulating effective strategies against them," he said.

Union Home Minister said that the database available with NSG contains data related to all bomb explosions from 1999 till now.

He said that through NIDMS, this data will now be made available to police forces across the country and relevant agencies.

"NIDMS will become a robust platform for accurately analysing the patterns of bomb explosions that have occurred in the country so far, the modus operandi (MO), and the explosives used," he said.

He said that it will provide significant help in establishing inter-linkages between incidents-based on MO and circuit methods-as well as in understanding overall trends and insights.

The Home Minister said that through 'One Nation, One Data Repository', the data scattered across different departments will now become available to every police unit as a national asset.

Shah said that NSG is a strong pillar of our country's internal security. Due to the valour, unique skills and unwavering dedication of NSG personnel, our citizens are able to sleep peacefully.

Union Home Minister said that the NSG is a world-class and zero-error force of India. The NSG was established in 1984, and since then, irrespective of the nature of any incident, it has continuously analyzed terrorist incidents across the world and has kept itself fully prepared to deal with every type of situation.

He said that counter-terrorism operations, anti-aircraft hijacking missions, advanced systems for bomb disposal, and now the creation of a platform to share its data with all agencies are all important responsibilities being carried out by the NSG. The Home Minister said that for their valour, NSG officers and commandos have been honoured many times at various levels. These include three Ashok Chakras, two Kirti Chakras, three Shaurya Chakras, 10 Police Medals, and 44 Sena Medals.

Union Home Minister said that nearly 100 per cent of the country's police stations-around 17,741-are connected to CCTNS, making their online data available. ICJS-2 is emerging as a next-generation data-sharing system based on the concept of 'One Data-One Entry'. He said that, in addition to data from about 22,000 courts, records of approximately 2 crore 20 lakh prisoners through e-Prisons, data of 2 crore prosecutions through e-Prosecution, results of 31 lakh samples through e-Forensics, and records of 1 crore 21 lakh fingerprints through NAFIS are now available at the click of a button. NIDMS will also be added to this system. The Home Minister said that with the help of AI, NIDMS will connect with other data sources to create a strong security grid in the country. (KNO)

Water pipe leakage turns Tral's Lurow Jagir playground into marsh

Locals, athletes accuse Jal Shakti Dept of apathy

Pulwama, Jan 09: The continuous water pipeline leakage at the only playground in Lurow Jagir area of Tral in south Kashmir's Pulwama district has created serious difficulties for local athletes and residents, who have strongly criticised the Jal Shakti Department for failing to address the issue despite repeated appeals.

Local youth, who regularly gather at the ground for football and cricket practice, told the news agency-Kashmir News Observer (KNO) that for several weeks, a damaged water supply pipe running through the playground has been leaking continuously, flooding large portions of the ground.

They said the constant flow of water has turned the playing surface into slush, making it impossible for children and young athletes to use the facility for sports and physical activities.

"The situation has brought sporting activities in the village to a complete halt. This playground is the only space available to us for sports, but due to the leakage, it has become unusable," said Nazir Ahmad, a cricketer.

"We have approached the concerned officials many times, yet no concrete action has been taken. Such negligence is discouraging young players and damaging the sports environment in our area," Ahmad added.

Residents have also raised serious concerns over the massive wastage of drinking water

caused by the unattended leakage. They said thousands of litres of clean water are being lost daily, even as several areas in Tral continue to face intermittent water supply.

"It is heartbreaking to see potable water being wasted like this when many villages are struggling to get a regular supply," said Mohammad Abdullah, a senior resident of Lurow Jagir. "The authorities must be held responsible. Allowing such a major leakage to continue for weeks reflects poor governance and a lack of accountability."

Locals further alleged that officials from the Jal Shakti Department had visited the site on earlier occasions but left without repairing the damaged pipeline, reportedly citing technical issues. The residents said they fail to understand the delay, especially given the importance of the playground for the physical and mental well-being of the youth.

"We are not asking for any special favour," said Mohammad Yaseen, another resident. "Our only demand is that the damaged pipe be repaired at the earliest so that children and youngsters can resume playing. If the leakage continues, the ground will be permanently ruined."

The residents and athletes have once again urged the concerned department to intervene immediately and restore the playground before further damage is caused. (KNO)

Jammu, Jan 09: Prof B. N. Tripathi, Vice Chancellor, SKUAST-Jammu and other delegations called on Lieutenant Governor Manoj Sinha at Lok Bhawan on Friday.

The VC SKUAST-J briefed the Lieutenant Governor on the progress achieved by the University in the areas of education, research, and extension, including major initiatives undertaken under the Holistic Agriculture Development Programme (HADP) and the J&K Climate Innovation Programme (JKCIP).

Prof Tripathi informed that SKUAST-Jammu has been designated as a Centre/Regional Outreach Unit of the Commission for Agricultural Costs and Prices (CACP) for Jammu. The Centre will facilitate the collection of region-specific data on crop costs, prices, and farmers' issues, thereby strengthening evidence-based Minimum Support Price (MSP) recommendations and farmer-centric policy planning.

The Vice Chancellor also apprised about the sanction of an ANRF-PAIR IIT Bombay Hub project under the Partnership for Accelerated Innovation and Research (PAIR) for the development of an AI-driven agriculture system aimed at

enhancing farmer market linkages and operational efficiency, with a focus on traditional products, involving an outlay of over Rs 6 crore.

In addition, an ICAR-NASF project for genome analysis amounting to Rs 2 crore has been sanctioned. He further informed that the establishment of an AICRP Centre for Poultry Breeding at SKUAST-Jammu is at an advanced stage of approval, while regular centres for beekeeping and mushroom cultivation are under active consideration by ICAR. At present, the University is implementing externally funded projects worth approximately Rs 100 crore.

Meanwhile, Anayatullah Rather, Member, District Development Council, Kisalgam, called on LG Sinha.

Rahul Sahai, Chairman, Indian Chamber of Commerce, Jammu Chapter, also called on the Lieutenant Governor and put forth several key issues pertaining to the trade, commerce and industry sector.

Dr Bandh called for long-term adaptation measures, saying: "Strategic water management practices, promotion of drought-resistant

and climate-resilient agricultural techniques are essential to mitigate the impact of prolonged dry spells on Kashmir's horticulture sector."

Meanwhile, Dr Umar Mushtaq, a scientist at Sher-e-Kashmir University of Agricultural Sciences and Technology (SKUAST), highlighted the uncertainty surrounding the impact of the current winter on the next farming season. "At this stage, it is difficult to precisely predict how the present dry conditions will affect next year's crops," he said.

Dr Mushtaq said that if sufficient precipitation occurs in the remaining winter days, the situation may still improve. However, he cautioned that a largely dry winter could have implications for fruit quality in the coming year.

"If the entire winter remains dry, there are chances of fruit quality issues next season, depending on other climatic and agronomic factors," he said.

Experts warn that the consequences of a snow-deficient winter go beyond agriculture. Reduced snowfall, they said, can lead to declining spring discharge in rivers, streams and springs, affecting drinking water schemes, hydropower generation and overall ecological balance in the Valley. (KNO)


He also said that the Constitution and its Eighth Schedule reflect India's ancient wisdom by recognising and celebrating linguistic diversity, affirming that national unity rests not on uniformity but on mutual respect.

Democracy, he said, flourishes when every citizen can express themselves in their own language.

Radhakrishnan made these remarks in his inaugural address of the third International Conference on Indian Languages in New Delhi.

Sharing his experience from his first session of Parliament as Chair of the Rajya Sabha, the vice president noted that an increasing number of Members of Parliament are now speaking in their respective mother tongues.

He also recalled that the copy of the translation of Constitution was recently released in the



Santhali language by President Droupadi Murmu, describing it as a significant step towards linguistic inclusion and democratic respect for all speech communities.

Highlighting contemporary challenges, he cautioned that many indigenous languages across the world are endangered.

Language conferences, he said, play a vital role in strengthening research, international academic collaboration and the preservation of ancient scripts

and manuscripts, particularly of endangered languages. He underlined that every Indian language has contributed profoundly to philosophy, medicine, science, governance and spirituality. Calling for technology to become an ally in language preservation, the vice president advocated the use of digital archives, AI-based translation tools and multi-lingual platforms to ensure that Indian languages thrive in the present and shape the future.

Two more held in Turkman Gate stone-pelting incident 13 arrests so far

New Delhi, Jan 09: The Delhi Police on Friday arrested two more persons accused in the Turkman Gate stone-pelting incident, taking the total number of arrests in the case to 13, while security personnel deployed in the area remained on high alert in view of Friday prayers, officials said.

"On Friday, we have arrested two people. So far, we have arrested 13 people. Further investigation is underway. Tight security measures will be maintained in the area," Additional Commissioner of Police (Central) Nidhin Valsan told PTI.

The Delhi Police have so far arrested 13 people, identified as, Mohd Arif (25), Mohd Kashif (25), Mohd Kaif (23), Mohd Adnan (37), Sameer Hussain (40), Mohd Athar (20), Shahnawaz Alam (55), Mohd Imran (28), Mohd Imran alias Raju (36), Mohd Aftab (20), Mohd Adil (20), Mohd Aamir Hamza (22) and Mohd Ubaidullah (26).

Police sources said at least 30 people offered Friday prayers at the same mosque. A large number of police and paramilitary personnel have been deployed in sensitive pockets to maintain law and order, while senior officers are supervising arrangements on the ground.

According to police, additional forces have been stationed near mosques and adjoining lanes, with pickets set up at strategic points to regulate movement and prevent any untoward incident.

Police are also conducting drone surveillance and extensive CCTV monitoring to keep a tight vigil in the area, officials



said, adding that the situation is peaceful and under control.

Clarifying concerns related to Friday prayers, the ACP said no restrictions were imposed on any mosque.

"We have not put any restrictions on Friday prayers in any mosque. We have also checked the structural safety of the demolition site," he said, adding that prohibitory restrictions imposed earlier would be removed soon after normalcy is restored.

Another senior police officer said the security measures were purely precautionary.

"We have made adequate arrangements in view of Friday prayers. Our teams are maintaining strict vigil and are in constant touch with local community members to ensure peace. We have not even restricted the number of visitors to the mosque," the officer said.

As part of the investigation, police have identified 10 social media influencers for allegedly circulating misleading or unverified information related to the incident. Officials said one social media influencer, Aimen Rizvi, is yet to join the investigation despite being summoned.

Stray dogs case

SC refuses to go into allegation of harassment of women dog feeders

New Delhi, Jan 09: The Supreme Court on Friday said it would not go into the allegations of harassment of women dog feeders and caregivers by purported anti-feeder vigilantes since it was a law and order issue and the aggrieved persons could lodge FIRs about it.

Hearing arguments in the stray dogs case, the apex court also refused to go into the claims about certain derogatory remarks being made about women in the issue.

A three-judge special bench comprising Justices Vikram Nath, Sandeep Mehta and N V Anjaria observed that some of the arguments made before it were "far from reality" and there were a number of videos of stray dogs attacking children and the elderly.

The top court was hearing arguments on pleas, including the ones filed by dog lovers, seeking modification of its earlier orders and those for stringent compliance with the directives.

Senior advocate Mahalakshmi Pavani highlighted the plight of women dog feeders and caregivers and said anti-feeder vigilantes have assumed the role of enforcing the apex court's order passed earlier in the matter. "Under the garb of this, they are harassing women, they are molesting women, and they are beating women," she said.

Justice Nath observed, "Lodge

an FIR against them. Who stops you?" The bench said that if anyone was harassing or molesting women, it was a crime, and the aggrieved person could set the criminal law in motion by lodging an FIR.

When Pavani referred to an incident where a dog feeder was attacked in her house, the bench said, "All this is a criminal offence. You lodge an FIR against that."

"We can't take up these individual cases where something is going wrong somewhere. This court is not going to monitor that. That is a law-and-order problem," Justice Nath observed.

Pavani said that in Haryana, certain societies hired bouncers to remove dog feeders, and a woman was slapped in Ghaziabad, but no FIR was lodged.

"We are not going to accept this. If a criminal offence is



committed, an FIR will be registered. There are procedures available to you, remedies available, and how to get it registered," the bench said.

The senior advocate flagged the issue of unregulated breeding and exotic imports.

"Again, this has nothing to do with the stray dogs issue. There are remedies in the Act and the rules. Don't make this a platform for other objects. You address us on the issues which we are dealing with in this matter," the bench said.

It said the import of the top court's order was very clear, and it was restricted to stray dogs only.

"Tomorrow, you will say why Cheetahs have been imported to Kuno (national park). Why not take care of the local breeds? This is too much. Sorry," Justice Mehta said.

Stock markets take downturn for 5th day; Sensex, Nifty tank nearly 1 pc

Mumbai, Jan 09: Benchmark indices Sensex and Nifty buckled under selling pressure for the fifth straight session on Friday, falling nearly 1 per cent, as investors turned cautious due to growing concerns over potential US tariff hikes amid lingering geopolitical worries.

The relentless foreign capital flight from Indian equities also affected the market sentiment, traders said.

After a brief rebound in early trade, the 30-share BSE Sensex failed to carry forward the momentum and tumbled 604.72 points, or 0.72 per cent, to sink below the 84,000-level and settle at 83,576.24. During the day, it dropped 778.68 points, or 0.92 per cent, to 83,402.28.

A total of 3,104 stocks declined, while 1,062 advanced and 176 remained unchanged on the BSE.

The 50-share NSE Nifty dropped 193.55 points or 0.75 per cent to 25,683.30.

In the past five trading days, the BSE benchmark declined 2,185.77 points, or 2.54 per cent, and the Nifty tumbled 645.25 points, or 2.45 per cent.

"Market sentiment stayed subdued amid elevated geopolitical and global trade-related concerns, particularly renewed uncertainty around potential US tariff actions and related Supreme Court developments. Persistent foreign institutional selling and weakness across broader risk assets further compounded the negative bias, while heavyweights also added to the downside pressure," Ajit Mishra - SVP, Research, Religare Broking Ltd, said.

From the Sensex pack, NTPC, ICICI Bank, Adani Ports, Bharti Airtel, Sun Pharma and Bajaj Finance were among the biggest laggards.

In contrast, Asian Paints, HCL Tech, Bharat Electronics and Reliance Industries were among the gainers.

"On the macro front, market participants remained cautious ahead of the domestic inflation data for December, scheduled to be released on Monday.

"On the global front, market participants stayed on the sidelines amid caution ahead of a US Supreme Court decision on the validity of American tariffs. Sentiment was further dented after US Commerce Secretary Howard Lutnick indicated on Friday that the India-US trade agreement had been delayed," Ashika Institutional Equities said in a note.

The BSE smallcap gauge tanked 1.74 per cent, and the midcap index dropped 0.90 per cent.

Among sectoral indices, realty tumbled 2.22 per cent, services (1.84 per cent), utilities (1.82 per cent), power (1.79 per cent), telecommunication (1.41 per cent), auto (1.22 per cent), consumer discretionary (1.14 per cent) and financial services (1.09 per cent).

BSE Energy, IT, PSU bank, oil & gas, and BSE Focused IT were the winners.

On Thursday, the Sensex fell 780.18 points or 0.92 per cent to settle at 84,180.96. The Nifty tumbled 263.90 points or 1.01 per cent to 25,876.85.

Domestic markets remained in a risk-off mode amid persistent uncertainty over US-India tariff talks and escalating geopolitical tensions, especially concerns over potential US trade measures linked to Russia-related sanctions, according to Bajaj Broking Research.



Opt for low-fat versions to balance calories, and include it 3-4 times weekly. The Indian population benefits from paneer because it solves the dual problem of protein deficiency and B12 deficiency which exists in this country. The bone-strengthening properties of calcium in this

food help protect against osteoporosis, which occurs when people depend on dairy products for their nutrition. Grill or steam to retain nutrients fully.

Fortified Cereals (sugar-free)

The B12 vitamins found in breakfast cereals contain 1.0-2.5 micrograms of this nutrient per serving. Research shows that food fortification provides people with B12 that matches the amount which can be found in animal products. The manufacturing process of processed foods keeps its ingredients at stable levels throughout its complete production cycle. The selected option provides suitable results for individuals who select their meals carefully, and for senior citizens who have difficulty processing dairy substances. In deficiency-prone India, fortified grains cut anemia rates by 15-20% in trials. Select low-sugar varieties to avoid blood sugar spikes.

Dubai, Jan 09: Iran's supreme leader signalled Friday that security forces would crack down on protesters, directly challenging US President Donald Trump's pledge to support those peacefully demonstrating.

Supreme Leader Ayatollah Ali Khamenei dismissed Trump as having hands "stained with the blood of Iranians" as supporters shouted "Death to America!" in footage aired by Iranian state television.

State media later repeatedly referred to demonstrators as "terrorists," setting the stage for a violent crackdown like those that have followed other nationwide protests in recent years.

Protesters are "ruining their own streets ... in order to please the president of the United States," Khamenei said to a crowd at his compound in Tehran. "Because he said that he would come to their aid. He should pay attention to the state of his own country instead."

Iran's judiciary chief Gholamhossein Mohseni-Ejei separately vowed that punishment for protesters "will be decisive, maximum and without any legal leniency." There was



no immediate response from Washington, though Trump has repeated his pledge to strike Iran if protesters are killed, a threat that's taken on greater significance after the US military raid that seized Venezuela's Nicolás Maduro.

Internet cut off

Despite Iran's theocracy cutting off the nation from the internet and international telephone calls, short online videos shared by activists purported to show protesters chanting against Iran's government around bonfires as debris littered the streets in the capital, Tehran, and other

areas into Friday morning. Iranian state media alleged "terrorist agents" of the US and Israel set fires and sparked violence. It also said there were "casualties," without elaborating.

The full scope of the demonstrations couldn't be immediately determined due to the communications blackout, though it represented yet another escalation in protests that began over Iran's ailing economy and that has morphed into the most significant challenge to the government in several years. The protests have intensified steadily

since beginning December 28.

The protests also represented the first test of whether the Iranian public could be swayed by Crown Prince Reza Pahlavi, whose fatally ill father fled Iran just before the country's 1979 Islamic Revolution. Pahlavi, who called for the protests Thursday night, similarly has called for demonstrations at 8 pm Friday.

Demonstrations have included cries in support of the shah, something that could bring a death sentence in the past but now underlines the anger fuelling the protests that began over Iran's ailing economy.

So far, violence around the demonstrations has killed at least 42 people while more than 2,270 others have been detained, said the US-based Human Rights Activists News Agency.

"What turned the tide of the protests was former Crown Prince Reza Pahlavi's calls for Iranians to take to the streets at 8 pm on Thursday and Friday," said Holly Dagres, a senior fellow at the Washington Institute for Near East Policy. "Per social media posts, it became clear that Iranians had delivered and were taking the call seriously to protest in order to oust the Islamic Republic."

Pope Leo warns of 'shrinking' freedom of expression in Western countries

Vatican City, Jan 09: Pope Leo warned on Friday that freedom of expression is "rapidly shrinking" in Western countries, and urged the right to conscientious objection for people who refuse military service or for doctors who refuse to perform abortions or euthanasia.

"It is painful to see how, especially in the West, the space for genuine freedom of expression is rapidly shrinking," the pope said in an address to diplomats accredited to the Vatican.

"A new Orwellian-style language is developing which, in an attempt to be increasingly inclusive, ends up excluding those who do not conform to the ideologies that are fueling it," said Leo, the first US pope.

'China, Russia, South Africa to hold naval exercise'

Beijing, Jan 09: China will hold naval and air exercises with Russia, South Africa and other BRICS countries off South Africa's coast in early to mid January, China's defense ministry said in a statement released on Friday.

The ministry called the exercises "joint operations to safeguard vital shipping lanes and economic activities." Strikes on maritime targets and counter-terrorism rescues will be part of the drills, it said.

Originally formed by Brazil, Russia, India and China, the BRICS group later added South Africa



and recently expanded to include other developing nations including Indonesia, Iran and Saudi Arabia.

The Chinese defense ministry did not specify how many BRICS nations will participate in the exercises.

Sindhu advances to Malaysia Open semifinals; Satwik-Chirag bow out

Kuala Lumpur, Jan 09: Two-time Olympic medalist P V Sindhu advanced to the semifinals of Malaysia Open after her opponent Akane Yamaguchi of Japan retired due to injury, while India's ace men's doubles pair of Satwik and Chirag bowed out of the Super 1000 badminton tournament in the quarterfinals here on Friday. Pitted against third-seed Yamaguchi in the quarterfinals, Sindhu took the opening game 21-11 before the three-time world champion from Japan, who was wearing a knee brace, decided to pull out of the match.

The win took world No. 18 Sindhu's head-to-head record to 15-12 against Yamaguchi.

Sindhu, who is competing in her first tournament after returning from a prolonged injury lay-off, will face second seed Wang Zhiyi of China in the semifinals.

Wang defeated sixth seeded Indonesian Putri Kusuma Wardani 21-17, 21-18. Satwik-Chirag lost. Later in the day,

South Korea's ex-Prez Yoon faces potential death sentence request in trial

Seoul, Jan 09: South Korea's special prosecutor is expected to make a sentencing request for former president Yoon Suk Yeol on charges of insurrection over his brief imposition of martial law in 2024, as a lower court trial convened on Friday for its final session. Yoon, who is accused of masterminding an insurrection, could face the death penalty or life in prison under South Korean law if found guilty. South Korea has followed an unofficial moratorium for nearly 30 years and has not executed a death-row inmate since 1997.

In hearings at the Seoul Central District Court, prosecutors have alleged Yoon and then-defense minister, Kim Yong-hyun, began devising a scheme as far back as October 2023 to suspend parliament and take over legislative powers.

Prosecutors allege Yoon



sought to brand political opponents — including then-opposition leader Lee Jae Myung — as "anti-state forces" and detain them. The then president and Kim also tried to manufacture a pretext for martial law by escalating tensions with North Korea through a covert drone operation, prosecutors have said.

While the botched bid to impose martial law lasted only about six hours, it sent shockwaves through Asia's fourth-largest economy, a key US security ally and long considered one of Asia's most resilient democracies.

Yoon, 65, has denied the charges. The conservative

has argued it was within his powers as president to declare martial law and that the action was aimed at sounding the alarm over opposition parties' obstruction of government.




