Jammu, Feb 02: Lieutenant Governor Manoj Sinha on Monday said his government remains committed to addressing the challenges of unemployment, infrastructure gaps, and social welfare in Jammu & Kashmir.

Srinagar, Feb 02: Leader of Opposition Sunil Sharma on Monday termed the Lieutenant Governor's address, which he said reflected the ruling NC government's policies and vision, as "disappointing."

(KNO) while talking to the reporters said, "The document prepared by the NC government and read by the Lieutenant Governor lacked vision, roadmap and commitment towards key issues, particularly unemployment in Jammu and Kashmir."

He said the LG's address and the documents he read reflected the ruling government's policies and vision but offers "nothing substantial" for the common people.

"The budget for J&K is disappointing for every section of society, especially the unemployed youth," he said.

NC-Cong meeting, meant to counter opposition, exposes rift between allies

5 Congress MLAs stay away; Nizamuddin attends, questions coalition dharma, Centre-related strategy; ruling party hits back

Srinagar, Feb 02: The differences between ruling alliance partners, the National Conference (NC) and the Congress, came out in the open during a joint meeting of the alliance to chalk out a strategy to counter the opposition during the budget session, which began on Monday.

The meeting, called at Chief Minister Omar Abdullah's Jammu residence, turned literally into a verbal duel between the alliance partners.

In a move aimed at sending out a message to its alliance partner that all is not well, the

Congress decided to send only its chief whip Nizamuddin Bhat. Another five of its MLAs, including PCC president Tariq Hamid Karra and senior leader Ghulam Ahmad Mir, chose not to participate in the meeting.

Sources disclosed to news agency—Kashmir News Observer (KNO) that Bhat told NC leaders during the meeting-attended by Dr. Farooq Abdullah, Chief Minister Omar Abdullah, all NC MLAs, and their non-Congress allies—that the party is not comfortable with the post-poll working arrangement.

He reportedly told NC leaders that they were not serious

about the statehood demand. Bhat also pointed out that there was no coordination between the allies in the Rajya Sabha polls as well as over Centre-related strategy of the government.

Bhat's remarks angered NC leaders, who told him that they have to maintain better Centre-State relations to run the State.

"Politics and government are two different. We have to ensure that Centre-State relations are better for running the State (UT)," Bhat was reportedly told by the Chief Minister.

Srinagar, Feb 02: Students of Abhinandan Home, Solina Srinagar, run under the Department of Social Welfare, Kashmir, have delivered an encouraging performance in the Class 11 Annual Examination 2025, proving once again that physical or intellectual challenges are no barrier to academic excellence when given the right support.

As per the news

agency—Kashmir News Observer (KNO), all appearing students, classified as CWNS (Children With Special Needs), passed the examination, with a large number securing distinctions and first divisions, reflecting the sustained efforts of both students and teachers at the institution.

Principal Mudasar Ahmad attributed the success to collective dedication and perseverance. "These results are a reflection of the tireless hard work put in by our students and teachers. Despite challenges, our children showed determination, discipline and confidence. We are proud of each one of them," he said.

He said 17 students appeared



in the examination, and among them, 14 secured distinction.

The result, the Principal said, was 100 per cent.

Those who secured distinction include Muntaha Muneer - 449, Sahil Mehraj - 435, Sadiya Parveez - 430, Subee Ashraf - 416, Nayilah Jaan - 415, Mehak Jaan - 410, Sheikh Adnan Mehraj 409, Mohammad Sameer - 394, Abdul Wajid Sheikh - 391, Salim Khan - 386, Ahsanullah - 384, Suhaib Amin - 380, Simran Shafi (375), AteeB Bashir - 374, Usman Bashir - 366, Ulfat Jaan - 351 and Mehvish Khazir - 338.

While celebrating their success, students raised a collective demand for better educational infrastructure for the specially-abled persons.

Muntaha Muneer, the topper, said the journey was not easy. "We study with focus and hope,

but travelling long distances after school becomes difficult for students like us. If schools are available at the tehsil level and colleges at the district level, many more specially-abled students will continue their education," she said.

Echoing similar concerns, Sahil Mehraj said accessibility remains a major challenge. "Our teachers motivate us every day, but higher education facilities are limited. Many students drop out because colleges are far and transport is not friendly for persons with disabilities," he said.

Another student, who also secured a distinction, stressed the need for inclusive planning. "We don't want sympathy, we want

equal opportunities. Separate and well-equipped institutions at local levels will help us become independent and confident citizens," he said.

Students urged the government to establish special schools for CWNS at the tehsil level and dedicated colleges at the district level, saying such steps would significantly reduce hardship and dropout rates among specially-abled students.

Parents and staff members also appreciated the role of the Department of Social Welfare for supporting the institution, while urging authorities to strengthen infrastructure, ensure trained staff, and build more such schools. (KNO)

Div Com Kashmir reviews IWAI's river Jhelum water transport project

SRINAGAR, FEBRUARY 2: Divisional Commissioner Kashmir, Anshul Garg, along with Secretary Transport, Avny Lavasa Monday chaired a meeting to review the removal of bottlenecks for water transport of the Inland Waterways Authority of India's (IWAI) envisaged project of River Jhelum.

The meeting, as per an official statement was participated in by Deputy Commissioners of Srinagar,

Budgam, Baramulla and Ganderbal; RTO Kashmir; Chief Engineers KPDCL & PWD; engineer from I&FC and PWD departments; and the IWAI Coordinator.

At the outset, the IWAI Coordinator gave a detailed presentation on the bottlenecks of the project and highlighted the required interventions.

Addressing the meeting, the Divisional Commissioner directed IWAI to take possession of land at two identified locations and to conduct a joint inspection to identify

land for the third location. It was informed that out of eight proposed locations, four have already been taken over by IWAI.

Regarding issues related to HT and LT power lines, the Divisional Commissioner instructed IWAI to share a detailed list of site-specific issues with the Chief Engineer, KPDCL, for preparation of removal estimates.

Similarly, the PWD was directed to assess removal of cofferdams under bridges and to facilitate necessary clearances.

Div Com, Dir Sericulture unveil 'Silk Kash' quarterly journal

High-value Kashmir nut crops get Budget push

Srinagar, Feb 02: The Union Budget announcement by Finance Minister Nir-mala Sitharaman to extend support for high-value nut crops, including walnuts, has sparked fresh optimism in Jammu and Kashmir's walnut sector, which sustains the livelihoods of nearly seven lakh people across the region.

The announcement has come as a much-needed morale booster for growers and traders, who have endured years of declining returns, outdated farming practices and stiff international competition.

Many said that while walnut prices were relatively better this season, the long-term future of the trade remained uncertain—until now.

“Rates were fine this year, but sustainability was always a concern,” said Bashir Ahmad Dar, a walnut trader from Kupwara. “This announcement gives us hope that better days are ahead, especially if modern cultivation methods are actually implemented on the ground.”

Jammu and Kashmir produces more than 90

per cent of India's walnuts, spread across over 86,000 hectares. Despite this dominance, the sector has been under severe stress for the past decade due to ageing orchards, low productivity, lack of processing infrastructure and shrinking competitiveness in domestic and export markets.

Mushtaq Ahmad Ganie, a known walnut trader, said that the traditional cultivation methods had reached a dead end. “In Kashmir walnut trees are huge and difficult to manage. Harvesting them is risky, and every year farmers suffer injuries while climbing,” he said.

“On top of that, the traditional varieties have very hard shells. During cracking, the kernel often gets damaged, which lowers the market value,” he added.

Local growers said, “This has allowed soft-shelled walnuts from countries like California and Chile to dominate Indian markets, pushing Kashmiri produce to the margins despite its superior taste.”

“The imported walnuts look uniform, crack easily and are better packaged. Buyers prefer them,” said Zahid Sabir a grower from Budgam. “We were losing



our space even in our own country,” he added.

The Finance Minister's emphasis on high-density plantations is being viewed as a potential turning point. Unlike traditional trees, high-density walnut plants are shorter, safer to harvest and offer higher, more uniform yields—qualities essential for competing globally.

“This is a very positive step,” he said. “High-density cultivation will modernise our orchards and help us match international standards. It can revive the entire walnut economy of

Kashmir.”

The decline of the sector has also been linked to poor infrastructure and outdated processing facilities. Several walnut processing units have shut down in recent years due to lack of modern machinery and proper packaging, plunging thousands of farming families into economic distress.

“Many of us survived only because walnut prices improved slightly this year,” said Waqar Ahmad, a trader from Shopian. “But without reforms, one good season is not enough. We need structural support.”

According to data from the Agriculture and Processed Food Products Export Development Authority (APEDA), Jammu and Kashmir accounts for the largest share of walnut cultivation and production in India. Other producing states such as Uttarakhand, Himachal Pradesh and Arunachal Pradesh together contribute only 3 to 6 per cent of the country's total walnut output, estimated at around three lakh metric tonnes in 2024.

Export figures show that over 2,134 metric tonnes of walnuts, valued at approximately 7.8 million dollars, were shipped from India to countries including the UAE, Turkey, Iraq, Singapore, Algeria, Qatar, Bhutan, Kuwait, Seychelles and Nigeria.

For growers who say they have been “fighting for survival” for years, the budget announcement has rekindled confidence.

“If the policy is implemented honestly, our future will be secure,” said a grower from south Kashmir. “For the first time in years, we feel the hard shell around our problems may finally be cracking.”—(KNO)

Dy CM urges centre for statehood, 'special package'

Srinagar, Feb 02: Urging the Centre to announce a “special, State-like package” for the Union Territory, Deputy Chief Minister Surinder Choudhary on Monday said Jammu & Kashmir's developmental requirements are urgent.

He added that these needs are “as large as those of any full-fledged state”.

Speaking to reporters on the opening day of the Budget session, the Dy CM said J&K faces unique challenges, including rising unemployment, repeated flood losses and tourism setbacks, which demand targeted fiscal support beyond the standard UT framework.

“Even as a Union Territory, our needs are equal to a state. The Union Budget must recognise our special circumstances and provide a matching package,” Choudhary said.

He said unemployment has sharply risen over the last decade, while natural disasters and other disturbances have repeatedly hit tourism and livelihoods,” he said. “A robust financial intervention is essential for recovery and growth.”

Choudhary also called for the demand for restoration of statehood, reminding the BJP of its 2024 election pledge.

“The BJP had promised that statehood would be restored after elections. Their MLAs must now explain what happened to that commitment,” he said, adding that “people of J&K expect clarity once the Budget is presented.”

Responding to a question about the Chief Minister's recent meeting with Union Home Minister, Amit Shah, he



declined to comment, citing confidentiality. “Discussions held during such meetings remain confidential,” he said.

Pakistan's boycott and sports politics Reacting to Pakistan's announcement to boycott its ICC T20 World Cup match against India, the Deputy CM said the move “makes no difference” to India.

“If Pakistan doesn't play, it is their choice. India is a big country and their decisions do not affect us,” he said, stressing that politics should never intrude into sports.

He added that mixing politics with sports “has historically harmed the spirit of the game” and advised all nations to keep the two spheres separate.

Darbar Move, NLU row and governance focus

The Deputy CM accused the BJP and the Leader of Opposition (Lo) Sunil Sharma of creating uproar over the demand for a National Law University (NLU) instead of focusing on broader governance issues.

Prioritize tourism in Budget to fight unemployment: MLA Gulmarg

Srinagar, Feb 02: Calling tourism the “life-line” of Jammu and Kashmir's economy, Member of Legislative Assembly (MLA) Gulmarg Farooq Ahmad Shah on Monday urged the Centre to give the sector ‘a central place’ in the upcoming Budget 2026–27.

He said a genuine revival of tourism and horticulture can tackle unemployment and create sustainable livelihoods for thousands across the Union Territory.

Speaking to reporters on the sidelines of the Budget Session in Jammu, Shah said the region has unmatched potential but continues to face chronic underfunding. “Tourism is our economic key,” he said, urging the government to treat the sector as a national priority to address unemployment.

Shah said tourism, if given serious policy attention, can power jobs, self-employment and infrastructure growth across the region.

The MLA said there has been a decade-long delay in the release of funds under the Prime Minister's Development Package (PMDP). “In 2014, the Prime Minister announced Rs 2,000 crore for the tourism sector. Sadly, only Rs 400 crore has been released so far, while Rs 1,600 crore remains pending. That delay has held back vital projects in Gulmarg, Pahalgam, Sonamarg and other destinations that could have transformed our tourism economy,” he said. Highlighting the link between tourism and youth employment, Farooq Shah said that Kashmir's hospitality industry, adventure tourism and handicrafts could absorb thousands of unemployed youth if given financial and institutional support. “We



have the human resource, we have natural beauty and what we need is vision-backed funding,” he said.

He also drew attention to the horticulture

sector, calling it “the other half” of Kashmir's economic base. “Our agro-based products face post-harvest issues every year. Under the Holistic Agriculture Development Programme (HADP), we must focus on cold storage, processing units and marketing channels. The government should also consider KCC loan waivers for small orchardists,” he added. The MLA Gulmarg further said that despite multiple challenges, the people of Jammu and Kashmir continue to show resilience. “Our youth want opportunities, not handouts. Tourism and horticulture can provide those opportunities if the right budgetary decisions are taken this time,” he said.

Shah also raised concerns about the rising unemployment and unfilled vacancies in government departments. “Thousands of posts remain vacant. Daily wagers and SPOs

are worried about their future. The upcoming Budget should send a message of hope, not hesitation,” he said.

Calling the present administration “promising and responsive,” the MLA added that the leadership must now translate intent into action. “Our Chief Minister has a vision and a mission to address the people's hardships. The team must work in unison to fulfil public expectations. This government is of the people, by the people, and for the people,” Shah said.

He further said that Kashmir's true prosperity lies not just in infrastructure or statistics but in empowering its people through sustainable sectors. “Tourism is not merely a pleasure, but it is a livelihood. If we treat it that way, this Budget could mark a new beginning for Jammu and Kashmir's economy,” the MLA said—(KNO)

83% qualify 11th class exams

Srinagar, Feb 02: The Jammu and Kashmir Board of School Education (JKBOSE) Monday announced annual regular results of 11th standard with at least 83 percent qualifying the exams.

JKBOSE officials informed that 83 percent students qualify the exams.

The board official also said that the pass percentage of girls is 86 percent and 81 percent among the male students.

BOSE said that a total of 81,573 candidates were enrolled for the exams out of which 67,932 successfully qualified it.

In the exams, a total of 37,997 students have registered distinctions, 25,694 secured first

divisions, 4216 bagged second division and 25 candidates registered third division.

BOSE further said that in the examination, 608 students couldn't qualify the exams while 13,032 have been asked to reappear in the exams.

Pertinently, BOSE had announced syllabus relaxation of 15 percent for 10th, 11th and 12th standard examination.

Director Academics of BOSE in a notification said that the decision was taken upon the recommendations received from the DSEK and DSEJ and pleas received from other stakeholders regarding reduction in syllabus due to delayed commencement of academic session this year coupled with disruptions in academic calendar due

to heat wave, torrential rains, cloudbursts and floods.

“As approved by the competent authority, it is notified that the prospective eligible students appearing in class 10th, 11th and 12th in the ensuing annual regular, 2025 examination in Kashmir Division and winter zone areas of Jammu Division including UT of Ladakh, shall attempt 85 percent marks which will correspond to 100 percent marks, availing thus 15 percent relaxation in syllabus,” reads the notification.

Pertinently, on January-14, JKBOSE declared results of both 10th and 12th standard on the same day with at least 84 percent qualifying the exam of 12th standard and 85 percent in 10th standard respectively—(KNO)

The agreement between the world's second- and fourth-largest economies is among the biggest trade deals ever signed. In fact, it is far more than a trade deal. It represents a comprehensive partnership that fosters co-operation in critical sectors such as artificial intelligence, defence, and semiconductors. The FTA will benefit every region and citizen of India, particularly the poorer sections.

The FTA ensures rules-based trade and stability in economic policies, making India even more attractive for domestic and foreign investment. This will create numerous opportunities for small businesses, startups, and workers.

The world has applauded PM Modi's announcement, calling it the "mother of all deals". It reinforces stability at a time of global uncertainty. The agreement positions India and the European Union as trusted partners committed to open markets, predictability, and inclusive growth.

India has secured unprecedented market access for more than 99 per cent of its exports to the EU by trade value, strongly bolstering the Make in India initiative. The FTA gives a decisive boost to labour-intensive sectors such as textiles, apparel, leather, footwear, marine products, gems and jewellery, handicrafts, engineering goods, and automobiles.

It will eliminate tariffs of up to 10 per cent on nearly \$33 billion worth of Indian exports. The agreement also empowers workers, artisans, women, youth, and MSMEs, while integrating Indian businesses more deeply into global value chains and reinforcing India's role as a key supplier in global



trade.

The deal also eases mobility for businesspersons and professionals and opens new opportunities in services such as education, information technology, financial services, and computers. These commitments unlock high-value employment opportunities and further strengthen India's position as a global hub for talent, innovation, and sustainable economic growth.

Trade agreements are part of the Modi government's broader strategy to improve the lives of the poor — first by strengthening the economy through path-breaking reforms and prudent fiscal management, and then by negotiating with developed and complementary economies with the

objective of a win-win deal. This approach enables India to leverage its comparative advantages access markets which are key for growing its labour-intensive sectors while safeguarding sensitive sectors such as agriculture and dairy.

Trade agreements with developed countries expose Indian industry to healthy competition and provide consumers with world-class products. Moreover, there is no evidence that the UPA government conducted meaningful consultations with stakeholders before signing trade agreements. In contrast, the Modi government has signed FTAs only after rigorous consultations with economists, industry bodies, experts, and multiple government departments and ministries. As a result, every FTA signed by the Modi government has received widespread appreciation from industry. Every FTA concluded by the Modi government has created new opportunities for both sides and expanded global opportunities for India's labour-intensive sectors. These agreements have accelerated India's journey towards becoming a developed country by 2047.

During the UPA's tenure, developed countries, including the European Union, had lost interest in India as economic growth slowed, inflation remained high, and business sentiment was pessimistic. PRAGATI@50: Why Delivery, Not Intent, Defines Governance

PRAGATI is both a record of leadership-driven delivery and a blueprint for governing complexity. The Global attention and applause that it is receiving are proof of this.

Two path-breaking interventions by the Government have had a great impact on planning, execution and monitoring of large projects - PM Gati Shakti and PRAGATI. We look at the latter in this piece.

The 50th high-level review under the PRAGATI (Pro-Active Governance and Timely Implementation) framework marks a fundamental shift in how the Indian State approaches governance, moving from intent to delivery, procedural compliance to outcomes, and fragmented authority to coordinated, timely execution. PRAGATI is thus not merely an administrative innovation; it represents a deliberate re-engineering of governance architecture. How did this model of governance deliver results when others have failed?

The Need For PRAGATI
Delays in public projects have become almost axiomatic. Yet they rarely stem from a lack of policy clarity or financial sanction. They arise because governance systems are fragmented. Ministries function vertically; States and the Centre act sequentially; and disputes circulate without a forum empowered to impose resolution. Accountability diffuses even as activity multiplies. The core problem is weak coordination and silo-based review mechanisms.

As a result, the broader objective of project

delivery is often lost. Many projects remained stalled for years due to land issues, environmental or forest clearances, regulatory approvals, contractual disputes, or inter-State coordination challenges. In a multi-ministry and multi-State political economy where each entity lords over the domain it controls, it is difficult for anyone to convince the other.

When several States and Ministries have to contribute to project completion the old approach of having meetings, discussions, field visits, constituting committees, and endless correspondence is ineffective. This was an approach in which discussion was mistaken for decision, activity for work, movement for progress and mere intent for achievement.

Enter PRAGATI
PRAGATI addresses these persistent structural failures by redesigning how decisions are taken, synchronised, and enforced. Functioning as a system integrator, it brings decision-makers across Ministries, States, and districts onto a single institutional and digital platform. It collapses delays caused by file movement, jurisdictional ambiguity, and inter-departmental correspondence. Most importantly, it restores a bird's-eye view of execution, allowing leadership to identify where the system is constrained rather than where a file is pending.

The Hon'ble Prime Minister's role in chairing

PRAGATI reviews is central to its effectiveness. His direct engagement sends an unambiguous signal that delivery is a national priority and that execution failures will receive attention at the highest level. It facilitates decisive action and transforms review into a binding framework for results. Decisions taken during these reviews are final, time-bound, and digitally recorded, ensuring accountability is clear and enforceable.

Technology acts as a critical enabler. Real-time data, geo-spatial visualisation, and live interaction with field authorities eliminate information asymmetry between stakeholders and ensure that decision-making is grounded in evidence. Importantly, technology strengthens administrative judgment rather than replacing it, reinforcing leadership responsibility within the system.

What distinguishes PRAGATI from earlier review mechanisms is its insistence on closure. Issues remain live until resolved and are continuously tracked by the Cabinet Secretariat and the Prime Minister's Office. Explanations no longer substitute outcomes. Over time, this discipline has reshaped administrative behaviour, encouraging Ministries and States to anticipate and resolve problems before escalation becomes necessary.

The Results

The outcomes are clearly visible and measurable. Projects worth over 85 lakh crore

have seen accelerated progress. In recent years, ten projects of the Ministry of Ports, Shipping and Waterways (MoPSW) were reviewed under PRAGATI, enabling early resolution of bottlenecks and faster execution. I will use two projects as examples.

The National Maritime Heritage Complex at Lothal is a massive project involving many Ministries at the Centre like Culture, Defence, External Affairs, Railways and Highways as well as the Government of Gujarat. Also, since several coastal State pavilions are to be set up, the concerned States are also part of the project. Bringing the NMHC project onto the PRAGATI agenda last year immediately spurred action at multiple levels. Usually, the agenda is notified a few months before it is taken up for review by the Hon'ble Prime Minister, providing an opportunity for different stakeholders to address issues with a sense of urgency. The result is that most issues that can be sorted at an official/ministerial level are already sorted out and only intractable residual items requiring guidance or direction are taken up during the actual review.

Similarly, the Jal Marg Vikas project, which is being implemented on NW-1 that passes through Uttar Pradesh, Bihar, Jharkhand, and West Bengal was reviewed under PRAGATI twice. This project is now at completion stage with most pending issues resolved.

PRAGATI underscores a critical truth: public value is created not merely by announcing schemes, but by ensuring that sanctioned investments translate into outcomes. Stalled projects have progressed not because policies were rewritten, but because execution pathways were simplified and accountability enforced. Equally significant is PRAGATI's contribution to cooperative federalism. By placing Chief Secretaries and Union Secretaries on a single real-time platform, it replaces fragmented responsibility with shared ownership of results.

PRAGATI@50 stands as evidence that governance outcomes are a function of institutional design. Dismantling silos, restoring a bird's-eye view of execution, and prioritising closure, PRAGATI demonstrates that effective governance is not just about doing more, but also about doing what is already sanctioned, faster, better, and together. Timely execution accelerates access to services, boosts the economy, reduces regional disparities, and strengthens public confidence in the State's capacity to govern.

JKERA CEO reviews progress of Lal Ded hospital expansion project

SRINAGAR, FEBRUARY 02: Chief Executive Officer, J&K Economic Reconstruction Agency (ERA) /JTFRP, Shreya Singhal, Monday inspected the progress of work on the construction of the state-of-the-art 108-bed additional block for specialised Infertility and Gynaecology at Lal Ded Hospital, Srinagar.

The project, as per an official statement is being executed under the World Bank funded Jhelum Tawi Flood Recovery Project (JTFRP) implemented by PWD (R&B), which is being constructed at an estimated cost of Rs 118 crore using seismic-resistant base isolation technology.

During the inspection, the concerned officers briefed the Chief Executive Officer about the salient features of the project, highlighting that the building is being constructed as per modern hospital architectural standards being adopted nationally



and internationally. The G+5 structure with attic and stilt parking will house specialised zones including modular operation theatres, ICUs, High Dependency Units (HDUs), LDR suites, pre- and post-natal care wards, recovery wards and dedicated patient waiting lounges, with a total built-up area of 11,640 square metres.

The CEO was informed that foundation works of the building have been completed and that the project is entering a crucial phase, with planning and design nearing

completion and prefabricated structural components being manufactured off-site and expected to reach the project location shortly.

Emphasising the importance of timely completion of this critical healthcare infrastructure, the CEO directed that the project be expedited and completed well before 31st August, with multiple activities taken up in parallel to avoid any time overruns. She instructed the Project Implementation Unit (R&B) and Project Management Support (PMS) teams to

conduct weekly site visits to closely monitor progress and ensure adherence to timelines.

The CEO further stressed the need for streamlined co-ordination with key stakeholder departments, particularly the Health Department, to ensure seamless execution of works and timely integration of services.

Additionally, the CEO instructed the PIU to expedite procurement of medical, electrical and mechanical equipment, so that installation can proceed in sync with civil works as part of the integrated health sector project.

Senior officers including the Chief Engineer, PWD (R&B) (Central) Superintending Engineer, PWD (R&B) Central, Project Manager J&KERA Kashmir, Executive Engineer PWD (R&B) Central, Deputy Project Manager J&KERA Kashmir and other officials from PWD (R&B) and J&KERA accompanied the CEO during the site inspection.

DLTFC approves 30 JKREGP projects in Rajouri

RAJOURI, FEBRUARY 02: The District Level Task Force Committee meeting under Jammu Kashmir Rural Employment Generation Programme (JKREGP), was Monday convened by the J&K Khadi & Village Industries Board Rajouri at its office for selection of the candidates who have applied for financial assistance to establish different types of Micro Industrial units under Manufacturing, Service & trading sector.

The meeting, as per an official statement, was chaired by Additional District Development Commissioner Malikzada Shaerazul Haq and attended by District Officer KVIB Sameer Ahmed, Lead District Manager J&K Bank, Cluster Head JKB, Director JKB RSETI, representatives from DIC and Area Manager JKGB.

The Additional District Development Commissioner emphasized adherence to the parameters and laid down norms of the Scheme while screening the applicants. "Only projects having good potentiality and viability with area specific approach shall be considered under the schemes," he stressed.

The District officer KVIB placed a list of 64 candidates before the Committee. Each candidate was interviewed by the committee to assess the experience, technical know-how and viability of the projects.

"The Committee after considering all related aspects of the scheme, selected 30 proposals, involving project cost of Rs.235.00 Lakh with the margin money component of Rs.82.25 Lakh. The proposed projects are expected to generate employment opportunities for about 180 persons.

Director Agriculture dedicates Mobile AC van to boost farmers' market access in Kashmir

SRINAGAR, FEBRUARY 02: In a significant step towards strengthening post-harvest infrastructure and supporting farmers in the Kashmir Valley, Director Agriculture Kashmir, Sartaj Ahmad Shah, on Monday dedicated a fully equipped Mobile Air-Conditioned Van to the farming community.

The van is specifically designed for the safe and efficient transportation of perishable agricultural produce within the valley and to markets outside the region.

The vehicle, as per an official statement, procured under the Holistic Agriculture Development Programme (HADP)- a flagship initiative of the Agriculture Production Department, Government of Jammu & Kashmir-addresses key challenges faced by farmers, including spoilage during transit, limited access to refrigerated transport, and fluctuating market prices due to quality degradation.

Speaking on the occasion, the Director emphasized the government's commitment to farmer welfare and modernization of agriculture in Kashmir. "This mobile air-conditioned van is a practical intervention under HADP to reduce post-harvest losses, preserve the freshness and quality of our farmers' produce such as fruits,

DC Budgam Reviews RGSA, SBM-G progress, stresses timely completion

BUDGAM, FEBRUARY 02: A meeting on the implementation of Rashtriya Gram Swaraj Abhiyan (RGSA) and Swachh Bharat Mission Gramin (SBM-G) was held Monday under the chairmanship of District Development Commissioner Budgam, Dr. Bilal Mohi-ud-Din Bhat.

The meeting, as per an official statement, was convened by the Assistant Commissioner Panchayat Budgam, who briefed the meeting about the agenda and overall status of implementation.

The meeting was held to review physical and financial progress, assess infrastructure development, sanitation coverage, solid and liquid waste management components, and to identify constraints affecting the implementation of the Annual Implementation Plan (AIP) 2025-26.

Under RGSA, a detailed review was conducted on the progress of Panchayat Ghars for the financial years 2023-24 and 2024-25. The status of construction, completion, and operationalisation of Panchayat Ghars was assessed.

On the occasion, the DC emphasised that timely completion of Panchayat Ghars is essential for strengthening the institutional infrastructure of Panchayati Raj Institutions (PRIs) and for improving grassroots governance.

The DC reviewed the status of Co-location of Common Service Centres (CSCs) in Panchayat Ghars. He highlighted the importance of ensuring functional CSCs at Panchayat level for delivery of citizen-centric digital services and directions were issued to strengthen coordination for effective co-location.

The DC stressed the need for timely resolution of bottlenecks to ensure smooth execution of approved works.

Under SBM-G, comprehensive review was undertaken of all sanitation and waste management components.

The status of Individual Household Latrines (IHHLs) was reviewed, with emphasis on coverage, functionality, and sustainability to ensure continued usage and universal sanitation. The progress of Community Sanitary Complexes was also reviewed.

The DC directed to



ensure their timely completion and proper maintenance for public convenience.

While reviewing the status of Segregation Sheds, the DC underscored importance of segregation at source and establishment of proper segregation infrastructure.

The progress of Community Compost Pits was reviewed to strengthen biodegradable waste management at village level. The status of Community Soak Pits

was reviewed, with emphasis on improving liquid waste and grey water management.

The progress of Decentralized Wastewater Treatment Systems (DEWATS) was reviewed in detail. The DC emphasised the establishment of DEWATS as an important component for decentralized treatment of wastewater and for improving overall village sanitation and environmental sustainability.

The status of Plastic Waste Management Units (PWMUs) was reviewed. The establishment and operationalisation of PWMUs was emphasized as a key requirement for scientific handling and processing of plastic waste in the district.

The status of Faecal Sludge Treatment Plants (FSTPs) was also reviewed in detail. The importance of FSTPs for safe treatment and disposal of faecal sludge was highlighted by DC as a critical sanitation

infrastructure component.

The meeting discussed in detail the constraints affecting implementation of the Annual Implementation Plan (AIP) 2025-26. The DC emphasized that all concerned departments and field functionaries must adopt a proactive, coordinated, and result-oriented approach to resolve land-related and legal issues at the earliest so that implementation of RGSA and SBM-G is not adversely

impacted.

He stressed that focused efforts must be made to accelerate execution of approved works, ensure adherence to timelines, and maintain quality standards. The need for regular monitoring, timely reporting, and close supervision at field level was reiterated.

The DC further emphasized strengthening sanitation infrastructure, solid and liquid waste management systems, and institutional capacity of Panchayati Raj Institutions across the district. It was stressed that transparency, accountability, and effective implementation must be ensured to achieve the intended objectives of the flagship schemes.

The DC issued directions to all concerned officers to take immediate follow-up action on the identified constraints and to ensure that targets under Rashtriya Gram Swaraj Abhiyan and Swachh Bharat Mission-Gramin are achieved in a timely, effective, and sustainable manner.

Besides, GM DIC budgam, CPO budgam, SDM Beerwah, ACD budgam, ACP budgam, Exen REW, all BDOs, all Tehsildars and other concerned officers were present in the meeting.

PIB Srinagar media tour to Kerala begins with visit to Kochi Water Metro

Sustainable, climate-resilient urban mobility showcased to J&K media delegation

Srinagar, Feb 02: The media tour organised by Press Information Bureau (PIB), Srinagar to Kerala commenced on Monday with a visit to Kochi Metro Rail Limited (KMRL), where the press delegation was briefed on the Kochi Water Metro Project, a pioneering urban mobility initiative.

On the first day of the tour, the PIB Srinagar press delegation visited the office of Kochi Metro Rail Limited, Kochi, to gain first-hand insights into the planning, implementation and operational framework of the Kochi Water Metro. The delegation interacted with senior officials of KMRL and Kochi Water Metro Project.

The media delegation met Loknath Behera, Managing Director, KMRL, Dr. M.P. Ram Navas, Director (Projects), KMRL;

Shaji Janardanan, Chief General Manager, KMRL; Sajan John, Chief Operating Officer, Kochi Water Metro and K.K. Jayakumar, Head (PR & Social Media), KMRL. Behera described the Water Metro as a time-saving and integrated mobility concept, enabling seamless cross-platform ticketing between water and rail metro services. He emphasised that human interface, attention to detail, cleanliness, efficient ticketing systems and creation of a viable ecosystem are key to the success of any public transport system.

Sajan John, COO, Kochi Water Metro, briefed the delegation on the objectives and vision of the Kochi Water Metro, highlighting its role as a climate-resilient, sustainable and inclusive transport system. He informed that the project provides a seamless transport option with universal and equitable access, improved

safety standards and a shift towards green, low-polluting mobility solutions. He informed that the Water Metro is presently operating with 20 battery-operated boats and 12 terminals, providing connectivity and transport services to thousands of commuters from around 10 surrounding islands.

Operational aspects of the project were explained by Shaji Janardanan, CGM, KMRL, who elaborated on terminal accessibility, safety measures including deployment of rescue boats, and the use of battery-operated vessels with dedicated charging docks, resulting in minimal carbon footprint.

The Kochi Water Metro was inaugurated by Prime Minister of India Narendra Modi on April 25, 2023. Officials informed that feasibility studies for similar water metro systems have been

conducted in 15 cities across the country, including Srinagar, with Mumbai identified as the next potential location. The project, a Government of India initiative jointly implemented by the Government of Kerala and Kochi Metro, has received several national and international recognitions.

Shamila K Y Media & Communication Officer, PIB Kochi also accompanied the delegation during the visit. At the outset of the meeting, Majid Pandit, Media & Communication Officer, PIB Srinagar and Conducting Officer of the tour, introduced the media delegation.

As part of the programme, the media delegation was provided a hands-on experience of the project through a ferry ride on the Kochi Water Metro, offering practical exposure to its operations and passenger facilities.

Planning at grassroots defines development outcomes: Aijaz Asad

Jammu, Feb 02: Secretary, Rural Development Department and Panchayati Raj, Mohammad Aijaz Asad, on Monday said that democracy finds its most authentic expression at the level of the Gram Panchayat, emphasizing that meaningful and inclusive development is possible only through sound, participatory, and evidence-based planning at the grassroots.

He was speaking at the inauguration of a three-day Regional Workshop on Capacity Building and Handholding Support for the Formulation of Quality Gram Panchayat Development Plans (GPDs) at IMPARD, J&K, being organized in collaboration with the National Institute of Rural Development and Panchayati Raj (NIRDPR), Hyderabad.

The event was attended by Director General, IMPARD, Rehana Batul; Director, Panchayati Raj, J&K, Sham Lal; Project Head, NIRDPR, Dr. A. K. Banja; experts from NIRDPR; Master Trainers; and senior officers of the department. Panchayat Secretaries, Account Assistants, and other field functionaries are participating in the workshop.

The Secretary said the initiative aims to facilitate the formulation of quality GPDs in 285 Gram Panchayats—one from each Block of the Union Territory which will serve as model plans for replication



across other Panchayats. He described the partnership with NIRDPR as a significant milestone and expressed confidence that it would usher in a new era of participatory, data-driven, and outcome-oriented planning in line with the vision of the Ministry of Panchayati Raj, Government of India.

Highlighting the importance of quality planning, Aijaz Asad said a well-formulated GPD strengthens local governance by addressing social, economic, and infrastructural needs in a balanced manner. He underlined the pivotal role of the Gram Sabha, stressing that meaningful public participation is essential to ensure plans truly reflect community aspirations. He emphasized that GPDs must be scientific, evidence-based, and oriented towards long-term, sustainable development.

He appreciated the efforts of the Director Panchayati Raj and directed that

similar capacity-building programmes be organized across districts to bring tangible improvements in GPD formulation and implementation.

Director General, IMPARD, Rehana Batul, highlighted the role of GPDs in holistic rural development and emphasized the need for structured capacity-building initiatives to strengthen planning and execution at the Panchayat level.

Director Panchayati Raj, Sham Lal, said that innovative initiatives and large-scale capacity-building programmes are transforming rural governance in Jammu & Kashmir. He stated that the project would result in 285 Model GPDs, supported through mentoring and handholding, and serve as valuable templates for the entire UT. Emphasizing the role of Master Trainers, he said empowered Panchayats lead to empowered people and a more self-reliant rural Jammu & Kashmir.

of the need for sustained and focused efforts to ensure balanced, inclusive, and environmentally sustainable development," he said.

The LG said good governance continues to be the cornerstone of the Government's development strategy in Jammu and Kashmir.

"Sustained transparency, reforms, accountability in digital governance, and citizen-centric service delivery have significantly strengthened public trust and institutional efficiency," he said.

The LG said the past year marks a significant milestone in the democratic journey of Jammu and Kashmir with the formation of an elected Government after a gap of several years.

"This transition to popular governance has strengthened public faith in democratic institutions. My Government has focused on restoring participatory governance, rebuilding public confidence, and ensuring that the voice of every region and community finds expression in policymaking," he said.

He said his Government remains firmly committed to further strengthening democratic institutions.

"Timely conduct of elections to local bodies, continued enhancement of grievance redressal mechanisms, and deeper integration of digital governance will reinforce transparency, accountability, and governance," he said.

The LG said the Government has ensured livelihoods for families impacted by tragedy and violence.

"During the year, 910 compassionate appointments were made, including 464 appointments to the Next of Kin of terror-affected families, thereby ensuring dignified livelihoods for families impacted by tragedy and violence," he said.

Talking about the economic growth of the Union Territory, the LG said, "Jammu & Kashmir is one of the fastest-growing States/UTs in the country. GST revenue collection has shown steady growth from Rs 8064 crore in 2023-24 to Rs 8586 crore in 2024-25. The tariff from electric power has witnessed a substantial increase of 16 per cent in 2024-25."

He said the economy of Jammu and Kashmir has demonstrated encouraging momentum in recent years.

"The Union Territory is presently recording an annual nominal growth rate of around 11 per cent (2024-25), reflecting the positive outcomes of sustained policy reforms, enhanced infrastructure development, and proactive investment facilitation. The Government remains committed to consolidating this growth trajectory through strengthened fiscal discipline and by creating diversified and sustainable employment opportunities, with particular emphasis on youth and women," he said.

He said the Special Assistance to States for Capital Infusion (SASCI) for interest-free loans for capital investments has been extended to J&K from the current financial year.

"Under SASCI, Rs 1431 crore has been sanctioned for 222 projects and Rs 210 crore as matching share for 12 centrally sponsored schemes. The first instalment of Rs 1083 crore

(66% of the sanctioned amount) has been received," he said.

The LG also spoke in detail about infrastructure development in the UT, saying it remains a critical driver of economic transformation.

"The road sector in the Union Territory has witnessed unprecedented investment amounting to Rs 61528 crore, encompassing expressways, National Highways, ring roads, and tunnels, significantly enhancing regional and inter-regional connectivity. Three major tunnels, including the Sonamarg Tunnel, have been completed, while eight others, including the strategic Zojila Tunnel, are at advanced stages of completion. The Narbal-Shopian-Surankote road has been declared a National Highway, further strengthening all-weather connectivity across the Pir Panjal region," he said.

He said 19 new National Highway projects with an estimated cost of Rs 10637 crore have been sanctioned for 2025-26, which include key infrastructure works such as the Pir Ki Gali Tunnel and the Sadhna Tunnel.

"My Government places on record its deep appreciation to the Government of India for the launch of PMGSY-IV, which will ensure road connectivity to 2400 unconnected habitations. Under Phase-I of this programme, 316 projects involving an investment of Rs 4224 crore have already been sanctioned, covering a total road length of 1,781 kilometres," he said.

He said the Kashmir Valley has been connected with the rest of the country through the railway network, opening new avenues for trade, tourism, and economic progress.

"A full-fledged Railway Division has also been sanctioned for Jammu & Kashmir, and expansion and modernization of Jammu Tawi Railway Station is under progress," he said.

He said the power sector has been one of the priority sectors of his Government, which is witnessing structural transformation.

"Major Hydropower Projects-Pakal Dul, Kiru, Kwar, and Ratle-with a combined capacity of 3014 MW are under active execution. Over the past five years, a record 5,708 MVA has been added to the distribution sector and 4239 MVA to the transmission sector. Installation of smart prepaid meters is underway in mission mode, with 10.44 lakh smart meters already installed, and 100% coverage targeted by 2026-27. As a result, losses have been reduced by 9%, while revenue realization has increased by 16%," he said.

He said the Government of India has accorded approval to a project for providing 200 free units of electricity to 2.23 lakh AAY families of Jammu and Kashmir under the PM Surya Ghar Muft Bijli Yojna—Utility Led Aggregation (ULA) model.

He added that implementation of the project is going to start soon.

The LG said tourism continues to be a vital pillar of the economy of Jammu and Kashmir.

"Despite challenges arising from security-related incidents and natural calamities, the Union Territory recorded 1.78 crore tourist visits in 2025," he said.

The LG said tourism has been accorded industry status to attract investment and

generate employment.

"Recognizing tourism as a lifeline of Jammu and Kashmir's economy, the Government undertook confidence-building measures, facilitation, and improved coordination with stakeholders. Special efforts were made to revive pilgrim tourism in Jammu, adventure tourism in Kashmir, and eco-tourism in tribal and border areas, ensuring equitable regional growth," he said. (KNO)

Jaishankar embarks on 3-day visit to US

Jaishankar's visit assumes significance as it is being seen as an opportunity to address the sharp downturn in the relations between the two strategic partners. It is expected that the minister will hold bilateral talks with US Secretary of State Marco Rubio and other senior officials of the Trump administration. "External Affairs Minister S Jaishankar will visit the United States from February 2 to 5 to participate in the Critical Minerals Ministerial convened by US Secretary of State Marco Rubio," the external



affairs ministry said in a statement.

It said the ministerial will focus on supply chain resilience, clean energy transitions, and strategic cooperation in critical minerals.

"During the visit, the external affairs minister will also hold meetings with senior members of the US administration," it said.

India-US ties have been reeling under severe stress after Trump doubled tariffs on Indian goods to a whopping 50 per cent, including a 25 per cent additional duties, for India's purchase of Russian crude oil.

Apart from the tariff issue, the relations witnessed a downturn on a number of other issues that included Trump's claim of ending the India-Pakistan conflict in May last year and Washington's new immigration policy.

Row in Lok Sabha as Rahul seeks to quote from 'memoir' of Gen Naravane

New Delhi, Feb 02: A row erupted in the Lok Sabha on Monday after the Leader of the Opposition, Rahul Gandhi, sought to quote from what he said was the memoir of former Army chief M M Naravane, with Defence Minister Rajnath Singh and Home Minister Amit Shah objecting on the grounds that the book has not yet been published.

As Gandhi rose to speak on the Motion of Thanks to the president's address

and began quoting from the book, Singh asked him to clarify whether the book had been published or not.

The Congress leader insisted that the document was authenticated and he could quote from it. He said he never wanted to speak on the particular issue, but decided to do so after BJP's Tejasvi Surya questioned the patriotism of the Congress party.

Singh, however, maintained that the book had not been published.

Speaker Om Birla cited rules, saying no book or

newspaper clipping can be quoted on a matter not related to the proceedings of the House.

Initiating the debate from the opposition's side on the Motion of Thanks, Gandhi then said he was quoting from a magazine article to put forth his views.

The defence minister accused Gandhi of "misleading the House".

Samajwadi Party leader Akhilesh Yadav supported Gandhi and urged the Speaker to allow the Congress leader to speak.

Rahul defied speaker's ruling, wasted House's time: Rijiju

By prioritising capex, MSMEs, skills and future-facing industries, the government has laid the foundation for a more formal, skilled and geographically distributed talent ecosystem," said CIEL HR MD and CEO Aditya Narayan Mishra.

He said, from an HR perspective, this is exactly what the market needs, a move away from reactive hiring to proactive workforce capacity building.

Sachin Alug, CEO, NLB Services said the Union Budget 2026-27 sends a clear signal that India's next phase of growth will be powered by AI-led digital capabilities, large-scale skill transformation, and globally competitive technology services.

The proposed Education to Employment and Enterprise framework is a timely intervention to bridge the curriculum-industry gap, particularly in emerging areas such as AI, data engineering, and digital platforms, where demand is outpacing talent readiness, he said.

Kartik Narayan, CEO - Jobs Marketplace, Apna.co, stated that the government's textile roadmap, from Mega Parks in challenge mode to the Mahatma Gandhi Gram Samaj initiative, is a well-thought-through intervention in India's labour economy. "It recognises

Third edition of tri-services future warfare course in Delhi till Feb 25

New Delhi, Feb 02: The third edition of the tri-services future warfare course featuring an enhanced curriculum which covers specialised subjects and domain-specific warfare developments in military operations will be held here from February 2-25, officials said on Monday.

Additionally, this course features experts on subjects like critical and rare earth elements, supply chain vulnerabilities and regional and global geopolitics impinging on operations in the future, expanding the number of subjects that will need to be studied and analysed by the defence forces in order to plan and conduct operations in the future, they said.

The course is being hosted under the aegis of Headquarters Integrated Defence Staff (HQ IDS) in partnership with the Centre for Joint Warfare Studies (CENJOWS).

Building on the success of the inaugural course held in September 2024, this expanded three-week programme aims to realise the vision of Chief of the Defence Staff Gen Anil Chauhan to prepare officers for the complex challenges of modern warfare, they said.

The course, to be held at the Manekshaw Centre at Delhi Cantonment, focuses on developing an erudite understanding on how war fighting is being impacted by technology, necessitating a relook at our thinking, concepts, doctrines, strategies and techniques, and Tactics, Techniques and Procedures (TTPs), the defence ministry said.

"It also caters for deeper exploration of critical topics, practical demonstrations of emerging technologies and visits to institutions of critical importance to the capabilities of the defence forces," the ministry said in a statement.

It said this edition features an enhanced curriculum covering specialised subjects and domain-specific warfare developments in military operations.

The course comprises participants from the three services, as well as representatives from the defence industry including startups, micro, small and medium enterprises (MSMEs), Defence Public Sector Undertakings (DPSUs) and the private industry.

Among the services' participants, senior officers with ranks varying from majors to major generals (and their equivalents) will be part of it, with the junior officers bringing their technical flair and expertise and the senior officers their operational experience and strategic knowledge, it said.

The future warfare course will align operational priorities of the armed forces with the capabilities of the indigenous defence industry and enable a free-flowing discussion on the various facets of modern and futuristic war-fighting, the ministry said. A diverse range of experts including veterans, serving officers, former ambassadors, industry experts and academic professionals will ensure that a holistic analysis of India's security challenges is debated in a threadbare and professional manner, officials said.

India's wealthy embrace a new luxury symbol: water

New Delhi, Feb 02: At an Indian gourmet food store, Avanti Mehta is organizing a blind tasting of drinks sourced from France, Italy and India. No, this isn't wine, it's water. Participants use tiny shot glasses to check the minerality, carbonation and salinity in samples of Evian from the French Alps, Perrier from southern France, San Pellegrino from Italy and India's Aava from the foothills of the Aravalli mountains.

"They will all taste different ... you should be choosing a water that can give you some sort of nutritional value," said Mehta, who is 32 and calls herself India's youngest water sommelier, a term usually associated with premium wine. Her family owns the Aava mineral water brand. Premium water is a \$400 million business in the world's most populous nation and is growing bigger as its wealthy see it as a new status symbol that fits in with a spreading wellness craze.

Premium Indian mineral water costs around \$1 for a one-liter bottle, while imported brands are upwards of \$3, or 15 times the price of the country's lowest-priced basic bottled water.

Clean water is a privilege in the country of 1.4 billion people where researchers say 70 percent of the groundwater is contaminated. Tap water remains unfit to drink, and 16 people died in Indore city after consuming contaminated tap water in December.

Many in India see bottled water as a necessity and standard 20 US-cent bottles are available widely at convenience stores, restaurants and hotels. The market is worth nearly \$5 billion annually and is set to grow 24 percent a year — among the fastest in the world. Bottled water

demand in United States or China is driven by convenience, making it a \$30 billion-plus market in each country which will grow just 4-5 percent each year, Euromonitor says.

In India, the premium water segment is leading the surge in demand, accounting for 8 percent of the bottled water market last year compared to just 1 percent in

2021, Euromonitor said. "Distrust of municipal water in some areas has escalated the demand for bottled water. Now, people understand how mineral water has more health benefits. It's expensive, but the category will boom," said Amulya Pandit, a senior consultant at Euromonitor specializing in the drinks market. Among its consumers are

New Delhi-based real estate developer B.S. Batra, who says his family uses only premium water at home to get more minerals and safeguard health.

"You feel different, more energetic during the day," said Batra, 49, an avid badminton player.

"I consume mineral water even with whisky at home, and kids use it for their smoothies."

Water lures Bollywood star, wealthy The popular 20-cent plastic bottled water is mainly made by Pepsi, Coca-Cola and Indian market leader Bisleri. In addition, Indians who can afford it, install purifiers in their homes which clean the water but also remove most minerals.

Imported and local premium waters are luring wealthy consumers and businesses alike. Bollywood star Bhumi Pednekar and her sister have launched Backbay — selling 750 ml cartons of mineral water for \$2.2; Indian conglomerate Tata is expanding its premium water portfolio, and retailers and businesses are reporting higher sales.

Tata Consumer Products, also Starbucks' partner in India, sells 20-cent bottled water, but premium water is its priority as it sees affluent, health-focused consumers willing to spend on the drink without worrying about the price, CEO Sunil D'Souza said in an interview.

"I don't have to push water uphill...I see a long, long, long runway for the business," he said. Tata's premium "Himalayan" mineral water factory — which a Reuters photographer visited — is located in the foothills of the Himalayan range in Himachal Pradesh state. Workers there largely keep a hands-free watch on machines filling plastic and glass bottles with water sourced from a natural

underground aquifer.

Looking for springs

Most Indians prefer still water, and the sparkling variant remains niche. Tata said it plans to launch a sparkling Himalayan water, and is also scouting for natural springs for expanding its other offerings. At three Foodstories Indian gourmet stores, sales of premium waters tripled in 2025. Customer demand prompted the chain to import "light and creamy" Saratoga Spring Water from New York, which costs 799 rupees (\$9) for a 355-milliliter (12-fluid-ounce) bottle, and stocks sold out within days, said co-founder Avni Biyani.

Indian mineral water brand Aava's sales touched a record 805 million rupees (\$9 million) last year, growing 40 percent a year since 2021. Tata said its basic and premium water portfolio will grow 30 percent a year, after growing tenfold to \$65 million in six years. Imported waters, which attract an over 30 percent tax, are pricier than Indian brands. Nestle's Perrier and San Pellegrino, and Danone's Evian retail for over 300 rupees, or \$3.20, for a 750 ml bottle.

Nestle declined to comment, while Danone said the Indian bottled water market was growing at a "robust" pace but imported waters "tend to be niche and boutique."

"When you open your tap, you're not getting an Aava, Evian ... And that is what you're essentially paying for," said water sommelier Mehta.

At the water tasting session, some participants said they enjoyed the experience but many found the price hard to swallow.

"To be honest, it is kind of expensive," said executive Hoshini Vallabhaneni, one of 14 people at the event. "For everyday use — it will burn a hole in the pocket."

ICC right to pull up Pakistan for boycotting Indo-Pak fixture: Shukla

New Delhi, Feb 02: BCCI vice-president Rajeev Shukla on Monday said the International Cricket Council (ICC) was right in warning Pakistan of severe repercussions for its selective pullout from the high-profile T20 World Cup contest against India in Colombo on February 15.

Pakistan's decision, conveyed through an official government statement, is being seen as a political protest linked to Bangladesh's removal from the tournament after the world body declined its request to shift matches from India to Sri Lanka on security grounds.

The ICC has already warned Pakistan Cricket Board that a boycott of the marquee fixture could lead to punitive sanctions and said



that the decision is not in the interest of the game in general.

"The ICC has issued a big statement on this subject. It has highlighted element of sportsmanship. We completely agree with the ICC. BCCI will not make any comment until we speak to the ICC," Shukla told reporters

here.

The raging controversy was sparked by Bangladesh pacer's Mustafizur Rahman's ouster from the IPL on instructions of the BCCI for unspecified reasons. Bangladesh refused to travel to India after that citing security concerns.

ICC should take action: Gavaskar, Harbhajan

New Delhi, Feb 02: Former India captain Sunil Gavaskar foresees Pakistan making a "U-turn" but regardless of that, he called on the ICC to take legal action against the country for boycotting its T20 World Cup match against India on February 15.

Pakistan's government decided against granting permission to its cricket team to play the high-profile game in Colombo and though no official reason has been given, it is being widely construed as a gesture of solidarity with Bangladesh.

Bangladesh were ousted from the World Cup after refusing to play their matches in India, citing security concerns.

Former Bangladesh PM Hasina, relatives sentenced to prison terms after trial in absentia

Dhaka, Feb 02: A Bangladesh court on Monday sentenced deposed Prime Minister Sheikh Hasina to 10 years in jail in two separate corruption cases related to alleged irregularities in allocations of land in a government housing project.

Dhaka's Special Judge's Court Handed 79-year-old Hasina 10 years of rigorous imprisonment for using her official influence in allocating residential plots to others, including her niece, UK Labour MP and former British minister Tulip Siddiq, under the Rajuk New Town Project in Purbachol on the outskirts of the capital.

Judge Robiul Alam simultaneously handed down Hasina's two nieces and a nephew, to different prison terms.

Siddiq's younger sister, Azaman Siddiq and brother Radwan Mujib Siddiq Bobby were sentenced to seven years rigorous



imprisonment, while the deposed premier and her relatives were handed down the prison terms after trial in absentia.

Only one of the 16 accused, a senior official of Rajuk, which allocates the plots, Khurshid Alam, was tried in person and was present at the court as the verdict was delivered.

The other accused in the case were sentenced to five years' imprisonment, including a former junior minister for housing, a former secretary of the ministry, a former Rajuk chairman and officials of the state-run entity.

UK ex-ambassador quits Labour over new reports of Epstein links

London, Feb 02: Former British ambassador to Washington Peter Mandelson quit the Labour Party Sunday, seeking to avoid causing it "further embarrassment" after newly released US documents revived scrutiny of his connection to late sex offender Jeffrey Epstein.

Mandelson, 72, who was sacked as Britain's ambassador to the United States last year over his ties to Epstein, allegedly received several payments from Epstein in the early 2000s, according to documents released on Friday by the US Department of Justice and reported in British media

Sunday.

"Allegations which I believe to be false that he made financial payments to me 20 years ago, and of which I have no record or recollection, need investigating by me," Mandelson wrote in a letter to Labour general secretary Hollie Ridley. "While doing this I do not wish to cause further embarrassment to the Labour Party and I am therefore stepping down from membership of the party," he added, saying he felt "regretful and sorry about this."

Bank records released by the US Justice Department suggest Epstein transferred a total of \$75,000 (\$55,000 pounds) in three payments to bank

accounts linked to Mandelson between 2003 and 2004.

Speaking earlier Sunday on the BBC, Mandelson said he had no memory of the transfers and did not know whether the documents were authentic.

Mandelson also appears in newly released, undated photographs, wearing a T-shirt and underwear beside a woman whose face has been redacted by US authorities.

He told the BBC he "cannot place the location or the woman and I cannot think what the circumstances were."

Other documents suggest Epstein sent 10,000 pounds in 2009 to Reinaldo Avila da Silva, Mandelson's partner, at a time when Mandelson was serving as a government minister.

The former ambassador was removed from his post in September after being appointed by Prime Minister Keir Starmer in late 2024. Mandelson apologized in January for maintaining his friendship with Epstein, having initially refused to do so on the grounds that he was not complicit.

Former prince Andrew, stripped of his royal titles last year over his ties to Epstein, was also named in the files released on Friday.

A second woman alleged Sunday that Epstein sent her to Britain in 2010 for a sexual encounter with Andrew, her lawyer told the BBC.
