

Fresh snowfall in higher reaches, rain in plains

Temps rise across J&K; IMD predicts largely dry weather till Feb 20

Srinagar, Feb 10: Fresh snowfall was reported in the higher reaches of the Kashmir Valley on Tuesday, while several areas in the plains received rainfall, even as temperatures showed a marginal improvement across Jammu and Kashmir, officials said.

Day temperatures also showed an upward trend, with Srinagar recording a maximum of 10.6 degrees Celsius, while Jammu touched 22.4 degrees Celsius.

Light snowfall occurred in the middle and upper reaches of the Valley, including tourist destinations such as Gulmarg, Sonamarg, Doodhpathri, Tangmarg and Pahalgam, besides Gurez, Sadhna Pass, Dubjan-Herpora, Peer Ki Gali and the Daksum-Sinhan top areas.

Parts of the Kashmir plains witnessed intermittent rainfall during the afternoon, officials told the news agency-Kashmir News Observer (KNO).

The Meteorological Department said light rain or snow is likely at most places on Wednesday. From February 11 to 20, the weather is expected to remain largely dry, with brief spells of light snowfall over a few higher reaches on February 14 and 17.

Temperatures improved noticeably across the Union Territory on Tuesday. Srinagar recorded a minimum temperature of 3.3 degrees Celsius, while Jammu city registered 12.3 degrees Celsius.

The Meteorological Department has issued an advisory asking travellers and transporters to check the status of highways with the concerned authorities and strictly follow official advisories.

India-US trade deal could hit J&K's core sectors, says CM Omar

Says duty-free imports threaten horti, dairy, dry fruits, deal benefits others, not UT

Jammu, Feb 10: Chief Minister Omar Abdullah on Tuesday warned that the proposed India-US trade deal could have serious repercussions for Jammu and Kashmir's traditional economy, particularly its horticulture and dry fruit sectors, asserting that the Union Territory stood to lose far more than it would gain from the agreement.

Addressing reporters outside the Jammu and Kashmir Assembly after proceedings were adjourned amid disruptions, CM Abdullah, as reported



by the news agency-Kashmir News Observer (KNO), said duty-free imports of American

agricultural products would directly hurt local growers who depend almost entirely on horticulture-related livelihoods.

Referring to the sectors reportedly covered under the interim trade understanding, the Chief Minister said items such as tree nuts, dry fruits, fresh fruits and dairy products were central to J&K's economy. Unlike coastal regions, he said, the Union Territory does not have a marine or seafood industry to fall back on.

"Our strength is horticulture — almonds, walnuts, saffron, apples, kiwis and similar produce. If these goods start

coming in duty-free from the United States, Jammu and Kashmir is bound to suffer losses," Omar said, adding that this was the reason behind public concern over the deal.

He maintained that while the agreement might be beneficial for other parts of the country, it did not serve the interests of J&K. "As the chief minister, it is my responsibility to speak for my people. From what we see, there is no benefit for us in this trade deal, only potential damage," he said.

Process of regularising daily wagers to begin this year: Omar

'SASCI criticism devoid of merit; provided relief to poorest of poor'

Jammu, Feb 10: Stating that the budget is meant to heal wounds and provide relief to the poorest of the poor, Chief Minister Omar Abdullah on Tuesday said the government will begin the process of regularising daily wagers this year.

Winding up the discussion on the budget in the J&K Assembly, the CM, as per news agency-Kashmir News Observer (KNO), said the government will start the process of regularisation of daily wagers this year.

The CM said that criticism of SASCI is devoid of merit, adding, "Those who are unable to understand the scheme are the ones commenting on it."

"Jammu & Kashmir will receive an interest-free loan for 50 years. My young colleague accused us of pushing Jammu & Kashmir into a debt trap. If a loan of Rs 3000 crore were to become Rs 30000 crore 50 years down the line, it would indeed be irresponsible. But you should compare the value of the rupee today with its value 50 years from now. We did the calculations ourselves, and if we take Rs 3000 crore while keeping inflation figures in view, it will amount to only Rs 97 crore 50 years down the line. It will not even be Rs 100 crore then," he said.

The CM said they have tried to heal wounds and provide relief to the poorest sections of society.

BJP leaders protest, seek apology

Jammu, Feb 10: Chief Minister Omar Abdullah's remarks in the Jammu & Kashmir Assembly on Tuesday triggered protests from opposition BJP legislators, who demanded an apology for what they termed "objectionable words."

Winding up the discussion in the Legislative Assembly on the budget, as per news agency-Kashmir News Observer (KNO), Chief Minister Omar Abdullah said the Indo-US trade deal was



nutritious to the interests of the people of J&K.

"Here, a few of my friends talked about the Indo-US trade deal, although it is not part of the budget. I am

unable to understand how it is beneficial to the people of J&K. You may have protected seafood from Kerala and some other products. You have allowed the entry of tree

nuts-walnuts and almonds—which are products of Jammu & Kashmir, at zero duty. You have also put dry fruit on the list at zero duty. You have told America to send fruit at zero duty, and we will purchase it. You made a deal on walnuts and almonds, but you should have at least protected apples," the CM said.

The Leader of Opposition objected to the remarks, triggering an exchange of heated arguments between the two sides.

The CM said, "They themselves call it the Indo-US trade deal. If you translate it, 'deal' means 'souda'."

Directs intensified market inspections ahead of Ramadhan

SRINAGAR, FEBRUARY 10: In view of the forthcoming holy month of Ramadhan, Divisional Commissioner Kashmir, Anshul Garg, on Tuesday chaired a high-level meeting to review arrangements aimed at facilitating smooth observance of the fasting month across the Kashmir Division.

The meeting, as per an official statement, was attended by Deputy Commissioners, Senior Superintendents of Police, Chief Engineers of KPCL, PHE and R&B, along with officers from the Food Safety Department, Srinagar Municipal Corporation (SMC), Urban Local Bodies (ULB), Food, Civil Supplies & Consumer Affairs (FCS&CA), and Imams of prominent mosques.

Addressing the meeting, the Divisional Commissioner stressed the need for coordinated and comprehensive measures to ensure public convenience throughout the holy month. He directed Deputy Commissioners to ensure all the arrangements in their respective districts.

Chief Engineer, KPCL, was instructed to ensure uninterrupted electricity supply across the division during peak hours of Sehri and Iftar.

To ensure the availability of safe and quality food items in the market, the Divisional Commissioner directed the Food Safety Department to carry out intensive and regular market inspection drives across all districts. He also emphasized strict action against traders involved in illegal profiteering.



Srinagar Municipal Corporation was asked to undertake regular sanitization drives at mosques and shrines. Meanwhile, the General Manager, SRTC, was directed to augment public transport services, especially around the Hazratbal area during evening and Taraweeh prayer hours. Deputy Commissioners were also urged to ensure adequate availability of public transport during evening hours.

FCS&CA Department was directed to ensure timely and adequate distribution of ration to meet

increased demand during the holy month.

CE, R&B was instructed to repair the damaged roads leading to mosques and shrines while CE PHE was asked to supply tap water during the peak hours especially at Sehri. He was also urged to mobilize water tankers to provide drinking water to the areas facing shortages.

The Divisional Commissioner reiterated that all departments must work in close coordination to ensure hassle-free observance of Ramadhan by the public.

DC Budgam leads Safer Internet Day programme

Stresses cyber hygiene, responsible AI use

BUDGAM, FEBRUARY 10: Deputy Commissioner Budgam, Dr. Bilal Mohi-ud-din Bhat, Tuesday presided over a district-level awareness programme to mark Safer Internet Day 2026, organised under the aegis of the Information Security Education and Awareness (ISEA) Project of the Ministry of Electronics and Information Technology (MeitY), in collaboration with NIC and other stakeholder departments.

The programme, as per an official statement, was organised as part of the nationwide campaign being observed across the country on the second Tuesday of February, with the theme "Smart Tech, Safe Choices", focusing on promoting safe and responsible use of the internet and Artificial Intelligence (AI).

The event also served as a national-level precursor to the upcoming AI Impact Summit 2026 scheduled to be held in New Delhi from February 15th to 20th.

While addressing the



participants, the DC highlighted the growing importance of digital safety in Tuesday's technology-driven world and stressed the need for creating widespread awareness among students, government employees, and the general public regarding cyber threats and safe online practices.

He underscored that with the increasing use of digital platforms and AI-based tools, citizens must be equipped with the right knowledge to protect themselves from cyber frauds, misinformation, and data breaches.

The DC emphasised that responsible and

ethical use of AI is essential for ensuring inclusive and people-centric development. He also stressed the role of AI in key sectors such as healthcare, agriculture, education, and governance, while cautioning against its misuse for scams, deepfakes, and misinformation.

During the programme, detailed presentations were made on key aspects including safe internet usage, cyber hygiene practices, common cyber threats such as phishing, OTP and UPI frauds, fake customer care scams, malware, deepfake and AI voice scams, online shopping frauds, and digital

arrest scams. Participants were sensitised on mechanisms for reporting cybercrimes through the National Cyber Crime Reporting Portal and the helpline number 1930.

The participants were also educated on best practices such as use of strong passwords, enabling two-factor authentication, avoiding suspicious links, securing UPI and card transactions, and protecting personal identifiable information. Awareness resources including www.staysafeonline.in and www.infosecawareness.in were also highlighted.

An online pledge for safe and responsible use of AI was administered, and participants were encouraged to enrol in ISEA e-learning courses and download the ISEA Cyber Hygiene mobile application to further strengthen their understanding of cyber safety.

Besides, DIO Informatics, the programme witnessed active participation from officials, students, teachers, Representatives from Revenue, RDD and other stakeholders

He reviewed block wise performance under ABHA ID generation and scan & share service. The Deputy Commissioner directed underperforming medical

blocks to improve performance through intensified enrolment drive. He emphasized coordinated efforts by Health, ICDS and Common service centres to improve performance in the 0-5-year age category.

It was informed that individuals can also self-enrol under ABDM to generate their Health ID through the link (<https://healthid.nhm.gov.in>).

The DC also reviewed the advancement of telemedicine services across the district, designed to enhance

specialist healthcare accessibility, particularly in remote and border regions.

Dr. Zaffar Akbar, Chief Medical Officer, Kupwara briefed block-wise progress under E-Sanjeevani OPD and E-Sanjeevani AB-HWC. It was informed that the E-Sanjeevani is being operated through 11 functional hubs, 5 functional hubs cum spokes and 130 functional spokes, enabling doctor-to-patient and doctor-to-doctor consultations to reinforce healthcare delivery.

Rs 10,155 Cr boost for J&K rural roads

Srinagar, Feb 10: The Government of India on Tuesday informed the Parliament that Jammu and Kashmir received Rs 10,155 crore in central assistance under the Pradhan Mantri Gram Sadak Yojana (PMGSY) over the past ten years and the current financial year.

Replies to an unstarred question in the Lok Sabha, the Ministry of Rural Development said that Jammu and Kashmir has received one of the highest financial allocations in recent years to strengthen rural road connectivity.

"J&K received ₹488 crore in 2015-16, ₹755.61 crore in 2016-17, ₹1,400 crore in 2017-18, ₹590.77 crore in 2018-19, ₹695.50 crore in 2019-20, ₹1,727.30 crore in 2020-21, ₹1,328.34 crore in 2021-22, ₹717 crore in 2022-23, ₹1,304.17 crore in 2023-24, ₹1,028.25 crore in 2024-25, and ₹121.17 crore so far in 2025-26," the reply stated. The Ministry



said that under various PMGSY interventions, thousands of kilometres of rural roads and bridges have been constructed across the country to improve last-mile connectivity, particularly in hilly, border and remote areas such as Jammu and Kashmir.

It is said that under PMGSY-IV, the government is prioritising habitations with population thresholds of 250+ in hilly States and UTs, including J&K,

with special focus on tribal, SC-dominated and aspirational areas to ensure inclusive access to all-weather roads.

The Rural Development Ministry maintained that PMGSY continues to be implemented as an area development programme, with habitations as the unit of planning, to ensure equitable rural connectivity in geographically challenging regions like Jammu and Kashmir—(KNO)

'Panchayats non-functional in J&K, Ladakh'

Srinagar, Feb 10: The Government of India on Monday informed the Lok Sabha that Panchayat elections have not been held in both Jammu & Kashmir and Ladakh after the expiry of their respective tenures, leaving grassroots democratic institutions non-functional in both the Union Territories.

In a written reply, the Ministry of Panchayati Raj said that J&K currently has 276 elected representatives, including 95 women. "The tenure of Gram Panchayats and Block Panchayats ended in January 2024 and fresh elections are yet to be held," it said.

Regarding Ladakh, the Centre informed that there are no elected Panchayat representatives at present, as the tenure of Panchayats ended in January 2024, and elections have not been held so far.

The Ministry clarified that the data shared pertains to elected representatives functioning in Gram Panchayats, Intermediate Panchayats and District Panchayats, as reported by States and Union Territories from time to time.

The Centre further stated that it does not maintain caste-based data, including information related to Scheduled Caste and Scheduled Tribe elected representatives.

J&K records few crimes against SCs in 3 years

Srinagar, Feb 10: Jammu and Kashmir has reported a limited number of cases related to crimes against Scheduled Castes (SCs) during the last three years, according to official data tabled in the Lok Sabha.

The information was shared by the Ministry of Social Justice and Empowerment in response to an unstarred question raised by Lok Sabha member Anita Nagarsingh Chouhan.

According to the data, 13 cases were registered in J&K in 2021, 11 cases in 2022 and 26 cases in 2023, showing a marginal rise during the last year. Of the cases registered in 2023, 10 were charge-sheeted, indicating initiation of legal proceedings by the investigating agencies.

A district-wise breakup shows that incidents were reported from only a few districts, while most districts across Jammu and Kashmir recorded no such cases.



During 2023, two cases were registered in Doda, one each in Kathua, Rajouri, Reasi, Samba and Poonch. Udhampur recorded 3 cases.

In 2022, cases were mainly reported from Jammu (11), Udhampur (4), Kishtwar (3), Kathua (1), Rajouri (1) and Reasi (1), while in 2021, cases were recorded in Udhampur (6), Kathua (4), Reasi (1) and Kishtwar (1).

All other districts, including Srinagar, Anantnag, Baramulla,

Srinagar, Feb 10: The Centre on Tuesday informed Parliament that Jammu and Kashmir has two agricultural universities, both functioning under the Sher-e-Kashmir University of Agricultural Sciences and Technology (SKUAST) system — SKUAST-Jammu and SKUAST-Kashmir (Srinagar).


Replies to an unstarred question in the Lok Sabha, the Ministry of Agriculture and Farmers' Welfare said that under the ICAR scheme "Strengthening and Development of Higher Agricultural Education in India," Jammu and Kashmir received Rs 35.63 crore during the last three years and the current financial year for upgradation and strengthening of agricultural universities. The year-wise

assistance to J&K stood at ₹8.12 crore in 2022-23, ₹4.72 crore in 2023-24, ₹19.30 crore in 2024-25, and ₹3.49 crore so far in 2025-26, the ministry said.

It informed the House that across the country, nearly 47 percent faculty positions in agricultural universities are vacant, affecting teaching and research activities. However, creation and filling of posts in State Agricultural Universities, including those in J&K, remains the responsibility of the respective State and UT administrations.

The government said ICAR continues to provide need-based financial support to accredited universities to modernise infrastructure, improve teaching facilities, support student research and strengthen higher agricultural education in J&K and other States—(KNO)

Govt mulls 5 Marla land allotment to Bagra flood victims: Dy CM

Jammu, Feb 10: Deputy Chief Minister Surinder Choudhary on Tuesday said that the government is considering allotment of 5 marla land plots to the eligible families hit by flash floods at village Bagra in Kathua district on the intervening night of 16th and 17th August 2025. The Deputy Chief Minister was replying on behalf of Chief Minister Omar Abdullah to a question raised by Legislator Dr. Bharat Bushan in the Legislative Assembly today.

He said that per SDRF norms, a compensation of Rs. 4 lakh each was released in favour of the Next of Kin (NOK) of the deceased and additional Rs. 2 lakh each was also released through the Chief Minister's Relief Fund. He added that Chairman, Red Cross Society Kathua (Deputy Commissioner Kathua) also released Rs. 50,000 compensation each to the NOKs of the deceased.

The Deputy Chief Minister said that heavy flash floods triggered by flash rains and landslides occurred in several areas of Village Bagra, which resulted in unfortunate loss of two persons and damages to various private and public properties.

He informed the House that seven houses fully damaged during the flash floods were duly compensated as per SDRF guidelines. He added that temporary restoration measures have been taken by the district

administration while the line departments are taking further necessary action for permanent restoration. He said that during this period, the affected families were shifted to safe lodgement centres, where all basic amenities like food, water, medicines and blankets were provided to them.

The Deputy CM added that the link road in Bagra has been damaged to a length of 1.20 km and some temporarily restored stretches will be fully reinstated by August 2026.

He said that during the recent spell of heavy rainfall/flash floods, certain low-lying areas of Kathua Town were affected, resulting in damage to residential houses and property, particularly in areas located near natural drainage channels and Kathua Khad. He said that due to sudden heavy discharge of rainwater, Kathua Khad experienced overflow at several vulnerable locations, causing erosion of embankments.

The Deputy Chief Minister said that heavy flash floods triggered by flash rains and landslides occurred in several areas of Village Bagra, which resulted in unfortunate loss of two persons and damages to various private and public properties.

No transport fee for hired vehicles during vacations: FFRC

Srinagar, Feb 10: The Fee Fixation and Regulation Committee (FFRC) has ordered the private schools not to charge any transport fee for the outsourced or hired vehicles during summer and winter vacation period.

Besides, the Committee has asked the private schools to charge only 50 percent of the transport fee for their own buses.

FFRC chairman Justice (Retd) Sunil Hali in a circular has said that the committee has received some complaints that certain schools are charging transport fees during the vacations in light of the order issued by the FFRC who do not own their transports.

"Those schools who do not have their own transport facilities but have outsourced or hired the same from third parties, operated under a contractual arrangement are also charging 50 percent of the transport fee," it reads.

The committee said that any fee collected by the private school in this behalf shall be refunded to the parents forthwith. "Failing which appropriate action under law shall be taken against the school, including imposition of a penalty of one percent of the total revenue and also de-affiliation of the school."—(KNO)

SKIMS infra work shifts to PWD post reorganisation: Govt

Srinagar, Feb 10: After the reorganisation of Jammu & Kashmir in 2019, the engineering wing of the Sher-i-Kashmir Institute of Medical Sciences (SKIMS), Soura, which previously handled its own infrastructure and maintenance, was wound up and its functions transferred to the Public Works (R&B) Division, Soura, the government said on Tuesday.

From Cultural Preservation to Cultural Participation

India's cultural heritage and linguistic diversity shape its social identity and shared knowledge systems. From manuscripts, monuments, performing arts and crafts to oral traditions, folklore and indigenous knowledge, culture in India is created and passed on through many languages, scripts and spoken forms.

According to Census 2011, India's linguistic landscape includes 22 Scheduled languages and 99 Non-Scheduled languages, spread across multiple language families, along with thousands of mother tongues and tribal languages [1]. The Government of India has undertaken sustained institutional, educational and digital initiatives to preserve and promote our linguistic heritage and the rich traditional knowledge that it holds.

At the core of this effort is the emphasis on leveraging emerging technology including AI, to preserve cultural resources and traditional knowledge, and make it available to people in the language and formats that they are familiar and comfortable with. This calls for democratisation of technology. AI has emerged as a key enabler in this process. By supporting the digitisation and discovery of cultural assets, enabling multilingual and voice-based access, and facilitating engagement at scale, AI helps bridge gaps between heritage and people, tradition and technology. This approach reflects the vision of using AI as technology for humanity, aligned with the goal of "Welfare for All and Happiness for All".

Building Language as Digital Public Infrastructure

To expand access to culture, knowledge and public services, the Government of India is taking an infrastructure-based approach.

Key pillars of this language infrastructure include:

National Language Translation Mission (NLTM) - BHASHINI

Launched in 2022 under the National Language Translation Mission, BHASHINI was developed to respond to India's wide linguistic diversity in the digital space. The initiative focuses on building language and voice capabilities directly into digital systems. This allows public platforms to function effectively across the many languages used in the country.

BHASHINI addresses three key barriers together:

Language barrier - systems that do not understand local languages or accents

Digital barrier - complex interfaces that discourage use

Literacy barrier - dependence on reading and typing

At a system level, BHASHINI is building multilingual AI as national digital public infrastructure. It provides language services such as translation, speech-to-text, text-to-speech, transliteration and document understanding across Indian languages, allowing platforms to add language and voice features without building them from scratch.

BHASHINI is already operating at scale: Supports voice in 22 languages and text services in 36 languages

Hosts 350+ AI models and datasets

Has completed over 4 billion language inferences so far

Its strength lies in collaboration. Research institutions, language experts, startups, state governments and industry partners jointly contribute to the platform, ensuring that language models improve through real-world use and local participation.

As a foundational language layer, BHASHINI turns linguistic diversity into practical digital access, enabling people to engage with information, culture and public services in languages and formats they understand.

Key examples of use of Bhashini

Real-Time Speech Translation at Kashi Tamil Sangamam 2.0:

At the Kashi Tamil Sangamam event in Varanasi, Prime Minister Narendra Modi



used the BHASHINI AI platform during his address. His Hindi speech was translated in real time into Tamil so that Tamil-speaking attendees could understand the address directly in their language, demonstrating BHASHINI's real-time translation capability in a live cultural exchange context.

Multilingual Support at Maha Kumbh 2025:

BHASHINI powered the Kumbh SahAl'yak chatbot, a multilingual, voice-enabled assistant used at Maha Kumbh 2025 to provide navigation and event information to pilgrims in 11 languages (Hindi, English and nine others). It also supported features like a digital Lost & Found solution with real-time text and voice translation to make the event more accessible for attendees from diverse linguistic backgrounds.

As foundational language infrastructure, BHASHINI translates diversity into access, helping people engage with information, culture and public services in their own languages and formats - a critical step toward inclusive participation and empowerment.

Technology Development for Indian Languages (TDIL)

TDIL is a long-standing Government of India programme that laid the foundational technology base for Indian language computing, covering scripts, speech and text across multiple Indian languages.

It focuses on the development and standardisation of core language technologies, including:

machine translation
optical character recognition (OCR) for Indian scripts
speech-to-text and text-to-speech systems
handwriting recognition and transliteration tools

TDIL enables practical use by: creating shared linguistic resources, datasets and standards that can be reused across platforms

supporting cross-lingual access, allowing users to retrieve and interact with information in their own languages

ensuring consistent digital representation of Indian languages across systems and devices

TDIL-supported systems, such as Indian

language machine translation tools, demonstrated early real-world applications of multilingual access in governance, education and information dissemination.

As a foundational language technology programme, TDIL enabled India's transition from language research to scalable language infrastructure, eventually directly supporting platforms such as BHASHINI and strengthening inclusive access to digital, cultural and knowledge ecosystems.

Anuvadini (AICTE)

Anuvadini is an AI-based multilingual translation platform developed by the All India Council for Technical Education (AICTE) to enable large-scale translation of academic, technical and knowledge content into Indian languages.

It supports practical language access through:

AI-enabled translation of textbooks, reference material and learning resources

Multimodal capabilities, including text, document and speech-based translation

Integration with national repositories such as e-KUMBH, enabling access to translated content at scale

Anuvadini enables practical use cases such as:

supporting skilling and capacity building by making learning resources available in local languages

strengthening Indian languages as mediums of knowledge, not only communication

As an AI-driven language access platform, Anuvadini expands access to knowledge and skills in Indian languages. By enabling participation in education, skilling and cultural knowledge systems, it contributes to social empowerment and livelihood opportunities.

The resource person also elaborated on the growing misuse of AI technologies, privacy concerns, misinformation and deepfakes, while emphasizing practical mitigation strategies, verification techniques, and best security practices for digital users. The workshop further highlighted the positive and people-centric applications of AI in sectors like governance, healthcare, education, agriculture and financial security, while underlining the need for ethical, inclusive and responsible adoption of emerging technologies.

On the occasion, participants were encouraged to take the online pledge for Safe and Responsible Use of AI and actively disseminate key learnings within their respective departments to ensure protection of data and promotion of a secure digital environment in the district.



He emphasized that such individuals should be monitored for several years post-treatment and provided opportunities in livelihood generation, skill development, self-employment or education based on individual rehabilitation needs.

Highlighting the importance of institutional support, the Chief Secretary called for dovetailing resources and manpower of multiple departments to ensure comprehensive support to individuals at every stage of recovery. He observed that while family and societal support remains crucial, long-term reintegration into mainstream society largely depends on strong institutional mechanisms.

The Chief Secretary noted that motivating victims to undergo treatment is only the first step and must be complemented by

regular follow-up, counselling and livelihood support to prevent relapse. He underscored the need for an end-to-end mechanism covering awareness generation through IEC campaigns, treatment, counselling, rehabilitation and post-rehabilitation engagement of affected youth.

To ensure accountability and effectiveness, he directed the creation of a district-level monitoring framework under senior officers, supported by dedicated teams to identify gaps and ensure lifetime rehabilitation outcomes. He further instructed development of an integrated online platform with clearly defined departmental roles and unique identification for each beneficiary to enable real-time tracking and case management.

During the meeting, Commissioner Secretary, Social

Welfare Department, Sarmad Hafeez, made a detailed presentation outlining the proposed inter-departmental coordination mechanism and post-rehabilitation framework. He informed that under the ongoing Nasha Mukt Bharat Abhiyan, a dedicated Task Force has been constituted under the chairmanship of Principal Secretary, Home Department, with the mandate to plan, coordinate and monitor rehabilitation and reintegration interventions across departments.

The meeting was informed that the Task Force will focus on multi-departmental coordination, standardized screening and referral mechanisms, availability of trained psychiatrists in hospitals, strengthening law enforcement for supply reduction and enhancement of rehabilitation processes.

It was further highlighted that the rehabilitation framework envisages standardized rehabilitation protocols and counselling units across J&K. The importance of integrating skill development programmes, livelihood support, start-up credit linkages, self-employment assistance and private sector partnerships was also emphasized to ensure sustainable recovery of rehabilitated individuals.

The meeting also underscored the need for school-based preventive programmes, community engagement initiatives, post-care monitoring systems and strengthening of infrastructure and capacity building. The roles and responsibilities of departments including School Education, Higher Education, Rural Development, Skill Development, Labour & Employment, Health, Home and Social Welfare were clearly delineated to achieve the long-term objective of a drug-free Jammu and Kashmir.

Reaffirming the government's commitment, the Chief Secretary stressed that addressing drug abuse requires a whole-of-government and whole-of-society approach to safeguard the future of youth and build a healthier society.



Srinagar, Feb 10: A meeting of District Level Committee on Narcotic Control Centre (NCORD) was Tuesday held under the chairmanship of Deputy Commissioner (DC) Srinagar, Akshay Labroo here at the Meeting Hall of the DC Office to review the ongoing anti-drug measures and efforts to curb drug abuse and drug trafficking in the district. Senior Superintendent of Police (SSP), Sandeep Chakravarthy was also present in the meeting.

Subsequently, representatives of Shopkeepers Association Multi-Tier Parking General Bus Stand Jammu headed by Vishal Mahajan, and a delegation of Shakti Udgash Foundation led by its Convenor Preeti Choudhary also called on the Lieutenant Governor.

At the outset, the meeting conducted a comprehensive review of inter-agency coordination to combat drug abuse, including identification of drug hotspots, confiscation of

vehicles under NDPS and ongoing anti-drug IEC activities, particularly in educational institutions to sensitise youth about the illicit effects of narcotics.

The meeting was informed that, as per the directions of the NCORD Committee, the District Administration in coordination with the Police and other stakeholder departments, has launched a massive crackdown on drug peddlers and drug trafficking.

Acting firmly against offenders, the driving licences of 73 accused involved in narcotics cases have been disqualified. In addition, 56 vehicles have been blacklisted by the Regional Transport Office, Kashmir under the NDPS Act.

Addressing the meeting, the DC appreciated the Transport Department and other stakeholders for strengthening administrative controls by suspending licences and blacklisting vehicles involved in NDPS cases, thereby disrupting the logistical support of drug peddlers. He reiterated that driving licences and vehicle registrations are privileges not rights and that anyone found misusing them for drug-related offences will face strict action without any leniency.

The DC emphasized that such measures will continue across to curb the drug menace in the district and break the supply chain of narcotics trade. He underlined the administration's firm resolve to protect

society, especially the youth, from the devastating impact of drugs.

SSP Srinagar, in his remarks, stated that the action against drugs shall continue and the message of zero tolerance against drug crimes is loud and clear. He stated that drug peddlers will face criminal prosecution, disqualification of licences, blacklisting of vehicles and other punishments as warranted under law.

On the occasion, the meeting decided to further strengthen coordination among stakeholder departments and continue focused enforcement, preventive awareness, and rehabilitation measures to effectively combat the drug menace in Srinagar district.

CM thanks members for valuable suggestions

Responding to the three-day-long debate, Chief Minister Omar Abdullah, who is also the Leader of the House, expressed gratitude to all legislators who participated in the discussion.

"For the last three days, I have been standing here to respond to the debate about the Budget. I thank all the honourable MLAs who took part. They gave valuable suggestions and we will try to implement many of them in the future," he said.

He noted that the Budget was widely discussed not only inside the House but also outside, and that people have largely responded positively.

"Generally, people were satisfied with the Budget. They understand that it is not easy to propel Jammu and Kashmir forward in these circumstances, but through this Budget, a roadmap has been laid out to take J&K out of the present challenges," he remarked.

Budget covers all sectors, focuses on weaker sections

The Chief Minister underlined that the Government's foremost responsibility is towards the poorest and most vulnerable sections of society.

"The first responsibility of every government is to help the weakest and the poorest. Through this Budget, we have tried to provide comfort to those who need it the most," he said.

Rejecting criticism over not announcing certain populist measures, he stated firmly that the Government's priority remains social justice and targeted welfare.

Free LPG cylinders to be funded through J&K's own resources

Clarifying a major welfare promise, CM Omar Abdullah announced that the Government will provide free LPG cylinders from its own budgetary resources, without depending on any central scheme.

"I want to put it on record that we will give these cylinders with our own money and resources. We do not need to take money from the central government for this," he said.

New welfare measures beyond Central Schemes

Responding to allegations that the Budget contains only centrally-sponsored schemes, the Chief Minister highlighted several unique initiatives funded directly through the J&K Budget.

He announced monthly assistance for orphans and vulnerable families:

"We have said that those who have lost both parents, or who have lost the sole breadwinner, will be declared orphans. If they are not covered under any other scheme, they will receive Rs 4000 per month," he said.

Similarly, scholarships for tribal children and poor students have been introduced where no other coverage exists.

He also recalled the success of free bus ridership for women announced last year.

"This was not a Government of India scheme. We introduced it through our own Budget, and it has been very successful," he said.

This year, the Government has extended free ridership relief to persons with disabilities.

EV Buses and balanced economic growth

The Chief Minister also spoke about expanding environmentally-friendly EV bus service while ensuring balanced growth for other transport sectors.

"If we can make EV buses reach more areas, autos and taxis will also run. By closing one thing, we cannot increase the economy," he said.

Budget expenditure and economic strength

Refuting claims that the Budget is shrinking, CM Omar Abdullah clarified expenditure figures and said misleading comparisons were being drawn.

"It is wrong to say we have spent only 12 per cent. If we look only at capital expenditure, it has reached 36 per cent, and by March 31 we will bring it close to last year's level," he informed.

He explained that last year's revenue expenditure was higher due to settlement of expensive loans, which is not the case this year.

"To say that we are shrinking our economy is not true at all. We have put our money where it is most needed," he asserted.

protests from BJP legislators, who objected to some of his comments and demanded an apology. The situation escalated into a ruckus, forcing Speaker Abdul Rahim Rather to adjourn the House for the day while Abdullah was winding up a discussion on the Union Territory's Budget presented on February 6.

Responding to the BJP's demand for an apology, the Chief Minister said there was no question of apologising now, as he was not allowed to clarify or withdraw his words during the disruptions.

"Had they allowed me even a moment to speak, I was prepared to withdraw my words and make the same point differently. But since I was not allowed to speak, what has been said is already on record," he said.

Omar also questioned whom he was expected to apologise to, alleging that some of those lecturing others on nationalism and the Constitution had themselves failed to uphold decorum. Without naming individuals initially, he said certain leaders who frequently invoke patriotism could not even sit through the entire Republic Day.

Later, he referred specifically to the Leader of Opposition (LoP), alleging that he had left the Republic Day function midway. "People who cannot remain present for national events should not lecture others on nationalism," the Chief Minister said.

Abdullah further claimed that BJP members were upset not because of the language used, but because he had placed uncomfortable economic realities before the public. "What benefits the rest of the country does not automatically benefit Jammu and Kashmir. My job is to protect the interests of the people here," he said.

The Chief Minister said his remarks on the trade deal were based on economic facts and the structure of J&K's economy, asserting that raising these concerns was part of his constitutional duty.

On a separate issue, Omar rejected suggestions that the administration facilitates the annual Amarnath Yatra under pressure. He said Kashmiris had historically played a central role in ensuring the success of the pilgrimage. "The Yatra is not possible without the people of Kashmir. They have always supported it and will continue to do so," he said.

Responding to a question on a proposed cricket match involving Pakistan, the J&K CM remarked that threats should not be issued lightly. "Those who do not have the strength to stand behind a threat should not make one. Let them come and play, and whatever happens will happen on the field," he said. (KNO)

"I want to put it on record that we will provide cylinders from our own funds. They will neither be given under any scheme nor will any help be sought from the Centre. This will be provided from the J&K budget," the Chief Minister said.

He added that gold and silver prices fluctuate within a broader range as markets move into a consolidation phase in the near term.



At a panel discussion during the Internet Safety Summit in Delhi, policy-makers said the central education board is working on developing digital safety content for middle school students and rolling out modules for training teachers.

However, they said there is a major gap in understanding how many children are active online due to the lack of data.



Stressing the need for tech companies to share anonymised usage statistics, Himanshu Gupta, secretary, Central Board of Secondary Education, said, "There are millions of students across the country. We don't know how many students are active on digital media platforms. Each platform collects data, but there's no unified

framework to compare or consolidate it."

He added that CBSE is focusing on digital media safety content for students from classes six to eight and creating annual awareness calendars for parents.

"Teachers are the ones working on the ground level. They, too, become victims of online fraud and misinformation. We

are also in the process of giving them digital safety training," Gupta shared.



Social media 'addicting brains of children,' plaintiff's lawyer argues in landmark trial

Los Angeles, Feb 10: Comparing social media platforms to casinos and addictive drugs, lawyer Mark Lanier delivered opening statements on Monday in a landmark trial in Los Angeles that seeks to hold Instagram owner Meta and Google's YouTube responsible for harms to children who use their products.

Instagram's parent company, Meta and Google's YouTube face claims that their platforms addict children through deliberate design choices that keep kids glued to their screens. TikTok and Snap, which were originally named in the lawsuit, settled for undisclosed sums.

Jurors got their first glimpse into what will be a lengthy trial characterised by duelling narratives from the plaintiffs and the two remaining defendants.

Meta lawyer Paul Schmidt spoke of the disagreement within the scientific community over social media addiction, with some researchers believing it doesn't exist or that addiction is not the most appropriate way to describe heavy social media use. Lawyers representing YouTube will begin their opening statement on Tuesday.

Adding the brains of children' Lanier, the plaintiff's lawyer, delivered lively first remarks where he said the case will be as "easy as ABC" – which stands for "addicting the brains of children." He said Meta and Google, "two of the richest



corporations in history," have "engineered addiction in children's brains."

He presented jurors with a slew of internal emails, documents and studies conducted by Meta and YouTube, as well as YouTube's parent company, Google. He emphasised the findings of a study Meta conducted called "Project Myst", in which they surveyed 1,000 teens and their parents about their social media use. The two major findings, Lanier said, were that Meta knew children who experienced "adverse events" like trauma and stress were particularly vulnerable to addiction; and that parental supervision and controls made little impact.

He also highlighted internal Google documents that likened some company products to a casino, and

internal communication between Meta employees in which one person said Instagram is "like a drug" and they are "basically pushers."

At the core of the Los Angeles case is a 20-year-old identified only by the initials "KGM," whose case could determine how thousands of other, similar lawsuits against social media companies will play out. She and two other plaintiffs have been selected for bellwether trials – essentially test cases for both sides to see how their arguments play out before a jury.

Plaintiff grew up using YouTube and Instagram

KGM made a brief appearance after a break during Lanier's statement, and she will return to testify later in the trial. Lanier spent time describing KGM's childhood, focusing

particularly on what her personality was like before she began using social media. She started using YouTube at age 6 and Instagram at age 9, Lanier said. Before she graduated from elementary school, she had posted 284 videos on YouTube.

The outcome of the trial could have profound effects on the companies' businesses and how they will handle children using their platforms.

Lanier said the companies' lawyers will "try to blame the little girl and her parents for the trap they built," referencing the plaintiff. She was a minor when she said she became addicted to social media, which she claims had a detrimental impact on her mental health.

Lanier said that despite the public position of Meta and YouTube being that they work to protect children, their internal documents show an entirely different position, with explicit references to young children from interpersonal conflicts and relationships. He painted a picture – with KGM's own text messages and testimony pointing to a volatile home life – of a particularly troubled relationship with her mother.

The attorney also drew comparisons between the social media companies and tobacco firms, citing internal communication between Meta employees who were concerned about the company's lack of proactive action about the potential harm their platforms can have on children and teens.

"For a teenager, social validation is survival," Lanier said. The defendants "engineered a feature that caters to minor's craving for social validation," he added, speaking about "like" buttons and similar features.

Meta pushes back

In his opening statement representing Meta, Schmidt said the core question in the case is whether the platforms were a substantial factor in KGM's mental health struggles. He spent much of his time going through the plaintiff's health records, emphasising that she had experienced many difficult circumstances in her childhood, including emotional abuse, body image issues and bullying.

Schmidt presented a clip from a video deposition from one of KGM's mental health providers, Dr Thomas Suberman, who said social media was "not the through-line of what I recall being her main issues," adding that her struggles seemed to largely stem from interpersonal conflicts and relationships. He painted a picture – with KGM's own text messages and testimony pointing to a volatile home life – of a particularly troubled relationship with her mother.

Schmidt acknowledged that many mental health professionals do believe social media addiction can exist, but said three of KGM's providers – all of whom believe in the form of addiction – have never diagnosed her with it, or treated her for it.

Schmidt emphasised to the jurors that the case is not about whether social media is a good thing or whether teens spend too much time on their phones or whether the jurors like or dislike Meta, but whether social media was a substantial factor in KGM's mental health struggles. A reckoning for social media and

youth harms

A slew of trials beginning this year seek to hold social media companies responsible for harming children's mental well-being. Executives, including Meta CEO Mark Zuckerberg, are expected to testify at the Los Angeles trial, which will last six to eight weeks. Experts have drawn similarities to the Big Tobacco trials that led to a 1998 settlement requiring cigarette companies to pay billions in health care costs and restrict marketing targeting minors.

A separate trial in New Mexico, meanwhile, also kicked off with opening statements on Monday. In that trial, Meta is accused of failing to protect young users from sexual exploitation, following an undercover investigation. Attorney General Raul Torrez in late 2023 sued Meta and Zuckerberg, who was later dropped from the suit.

A federal bellwether trial beginning in June in Oakland, California, will be the first to represent school districts that have sued social media platforms over harms to children.

In addition, more than 40 state attorneys general have filed lawsuits against Meta, claiming it is harming young people and contributing to the youth mental health crisis by deliberately designing features on Instagram and Facebook that addict children to its platforms. The majority of cases filed their lawsuits in federal court, but some sued in their respective states.

TikTok also faces similar lawsuits in more than a dozen states.

NZ openers Seifert, Allen blow UAE away with record-breaking stand in T20 WC

Chennai, Feb 10: The New Zealand opening pair of Tim Seifert and Finn Allen went on a rampage against the UAE bowling attack to make short work of the 174-run target, firing the Blacks Caps to a 10-wicket win in the T20 World Cup here on Tuesday.

The UAE did well to post 173 for six, their highest total in tournament history following fine fifties captain Muhammad Waseem (66 not out off 45) and Alishan Sharafu (55 off 4) at the top of the order.

However, the destructive duo of Allen (84 not out off 50) and Seifert (89 not out off 42) ran riot on a red soil pitch to fashion a 10-wicket victory for their team. Their 175-run stand off 92



balls was the highest for any wicket in tournament history as New Zealand coasted to the win in 15.2 overs.

It was the first game of the tournament for UAE who would need to go back to the drawing board after the hammering at Chepauk. New

Zealand, eliminated early in the previous edition, have fired warning shots to rival teams with two emphatic wins in as many games.

Barring left-arm spinner Haider Ali, none of the UAE bowlers were able to contain Seifert and Allen who scored boundaries at will.

The game was as good as done when New Zealand raced to 119 for no loss in 10 overs.

The standout shots of Seifert's innings were the reverse sweeps off Haider in the 11th over, fetching him a six and four.

Allen tore into medium pacer Junaid Siddique early on the innings as he shuffled across the stumps to scoop him for a six over fine leg.

'Concessions given to PCB by ICC for ending boycott will be made public post T20WC'

Karachi, Feb 10: The ICC has promised a few concessions to the Pakistan Cricket Board (PCB) for ending its boycott of the India game but those will only be announced after the conclusion of the T20 World Cup, a source said on Tuesday.

"Whatever concessions the PCB has got from the ICC on ending their boycott will only be made public after the end of T20 World Cup," a PCB source told PTI on Tuesday.

The ICC has already announced that Bangladesh Cricket Board will not face any sanctions from the global body and will also be given an ICC event in the 2028-2031 cycle (preferably U19 men's World Cup).

Pakistan Prime Minister Shehbaz Sharif announced that

the national would boycott the T20 World Cup group league match against India in Colombo on February 15 in solidarity with Bangladesh Cricket Board (BCB), who were replaced after refusing to play their matches in India citing security reasons.

After hectic parleys and back-channel talks which also included intervention from Sri Lankan President Anura Kumara Dissanayake and the Bangladesh Cricket Board, which requested Shahbaz Sharif to change their stance keeping broader interests in mind, the boycott did end on Monday night.

"The call from Sri Lankan President Anura Kumara Dissanayake played a big part in ending the boycott as did a briefing from some top people in the government/establishment who have been closely

following the developments," another source informed.

The PCB has now also been given clearance to play India if both countries have to face off again in the latter stages of the World Cup.

Another source said that the Prime Minister who is also patron in chief of the PCB was in fact briefed on what Pakistan could achieve if the government issued a notification for not playing against India.

"The ICC now has a clear understanding with Naqvi that no further details of the discussions that took place with PCB, Bangladesh Cricket Board and some other boards would be made public," the source said.

While ICC in its statement on Monday confirmed that Bangladesh would not be sanctioned for their stance, it had no mention of what would PCB stand to gain from ending the impasse.

There have been speculations about Naqvi pushing for an increase in the share of revenues the PCB gets from the ICC but another insider confirmed this would only be after approval from the ICC board for the next financial cycle.

He said during discussions Naqvi had made the point that there was no reason for Pakistan and India not to play home and away matches in the ICC World Test Championship at neutral venues as they were already playing in other ICC white ball events.

Lavrov accuses US of trying to prevent India and others from buying Russian oil

Moscow, Feb 10: Russia has accused the US of attempting to prevent India and other countries from buying Russian oil, saying Washington is using a wide range of "coercive" measures, including tariffs, sanctions and direct prohibitions, to fulfil its objective of global economic dominance.

Foreign Minister Sergey Lavrov also accused the US of using "unfair methods" to suppress competitors by imposing sanctions on Russian oil companies.

"(The US) is attempting to control our trade, investment cooperation, and strategic-technical ties with major strategic partners, such as India and other BRICS members," Lavrov said in an interview with TV BRICS on Monday.



He said that the West is reluctant to relinquish its formerly dominant positions. "With the arrival of the (US President Donald) Trump administration, this struggle to suppress competitors became particularly pronounced and open," he said.

Lavrov said that Russia accepted America's proposal on Ukraine during the Alaska talks between President Vladimir Putin and his US counterpart Trump last year.

"We were told that the Ukrainian

issue must be resolved. In Anchorage, we accepted the United States' proposal. To put it straightforwardly, they proposed, and we agreed - the problem should be solved," he said.

"Having accepted their proposals, we essentially fulfilled the task of resolving the Ukrainian issue and moving toward comprehensive, broad, mutually beneficial cooperation," he added.

"In practice, however, the opposite occurs: new sanctions are imposed, attacks on tankers are staged in international waters in violation of the UN Convention on the Law of the Sea, and India and other partners are discouraged from purchasing affordable Russian energy, while Europe has long prohibited such purchases, forcing them to buy American liquefied natural gas at significantly higher prices.
